It has been a year since the Listing of Peiport Holdings Ltd.. During the year, our overall business have been developing steadily "without great ups and downs". As stated in the Prospectus, we are stepping forward with the predetermined plans and procedures. Among the three business segments, including: (i) thermal imaging products and services, (ii) self-stabilised imaging products and services, and (iii) general aviation products and services, general aviation products and services business segment performed brilliantly. I, on behalf of the board (the "Board") of directors (the "Directors") of the Company hereby, present the annual report of the Company ("Annual Report") for 2019 and the outlook for 2020.

### **PERFORMANCE REVIEW IN 2019**

The China-US trade tensions in 2019 and the social campaigns in Hong Kong affected the economic development of Hong Kong, therefore the three business segments of the Company also faced severe challenges. Fortunately, due to the introduction of supportive policies in the People's Republic of China (the "PRC" or "Mainland China") to develop the general aviation manufacturing industry, many suppliers which build aircraft and sports and ultralight aircraft were attracted to set up factories in Mainland China. At the same time, overseas production lines are introduced. Hence, the demand for aircraft power systems has increased significantly.

In 2019, we have been focusing on the talent acquisition and the formation of research and development teams. In November 2019, we officially settled in the Hong Kong Science Park and established Peiport's research and development centre in Hong Kong. The new research and development centre helps improve the quality of our existing self-owned products and enhances the development of new products, thus strengthens our competitiveness and further expands the market, especially in Hong Kong and the Southeast Asia.

The revenue for the year 2019 increased by approximately HK\$13.3 million to approximately HK\$275.4 million, as compared with the revenue of approximately HK\$262.1 million for 2018, with a slight increase of approximately 5.1% compared to 2018. Similar to 2018, the performance of the general aviation products and services business segment in 2019 was better than the other two business segments.

### **BUSINESS OUTLOOK FOR 2020**

Looking forward to 2020, the economic development of Mainland China is still challenging. However, our Group will continue to work on its three business segments.

### 二零一九年業績回顧

二零一九年的中美貿易磨擦以及香港的社會運動影響香港的經濟發展,公司的三大業務板塊也因此面對嚴峻的挑戰。所幸的是由於中華人民共和國(「中國」或「中國內地」)出台不少鼓勵性政策發展國內通用航空製造業,吸引不少飛行器和運動型及超輕型飛機的製造商在國內設廠並同時引入國外的生產線,故使對飛行器動力系統的需求有較大升幅。

二零一九年我們在人材的引進以及研發團隊的 建設方面做了不少工作。二零一九年十一月我 們正式進駐香港科學園,建立彼岸於香港的研 發中心。新研發中心有助提升我們現有自主產 品的質量以及強化新產品的開發工作,繼而增 強我們的競爭力和進一步拓展市場,尤其是香 港及東南亞市場。

二零一九年年度收益約為275.4百萬港元,相比二零一八年年度收益約為262.1百萬港元增加約13.3百萬港元,較二零一八年有約5.1%的微小增長。與二零一八年相似,二零一九年通用航空產品及服務板塊的業務表現優於其他兩大業務板塊。

### 二零二零年業務展望

展望二零二零年,中國內地的經濟發展仍然是 不容樂觀,然而本集團會在自己的三大業務板 塊上繼續努力。

### **BUSINESS OUTLOOK FOR 2020 (Continued)**

In terms of thermal imaging products and services, the demand for instruments to detect fever and abnormal body temperature will continue to increase with the outbreak of the coronavirus disease 2019 ("COVID-19"). We will continue to improve our self-owned products while conducting secondary development of our other products. Since such products are highly competitive in the domestic market in Mainland China, thus in terms of the domestic market in Mainland China, we will continuously focus on the powerlines inspection and security surveillance, which we are relatively familiar with, as well as the infrared temperature detection system in Hong Kong.

In terms of self-stabilised imaging products and services, there are "Peiport" equipment installed in the helicopters for power line inspection and airborne security monitoring in Mainland China, as well as marine patrol, fire fighting and rescue vessels in Hong Kong, the related equipment will continue to be installed on such moving platforms. We expect that there will be moderate growth for the performance of this business segment. In addition, the "upgrading and transformation" of our self-stabilised imaging gyroscope monitoring system will also be carried out in the research and development centre in the Hong Kong Science Park, in order to further expand our product portfolio.

In terms of general aviation products and services, with the development of the domestic market of general aviation in Mainland China, it is predicted that the demand in the market for small aircraft piston engines will remain strong in 2020. We will also invest more manpower in research and development, production, pre-sales and after-sales services to improve our product quality and service standards. In 2020, we expect that our performance in the general aviation business segment will be enhanced to the next level.

### 二零二零年業務展望(續)

熱成像產品及服務方面,2019冠狀病毒病(「COVID-19」)仍然在擴散蔓延,偵測發燒及體溫異常的儀器需求則有增無減。我們將繼續改進我們的自主產品的同時,對其他產品進行二次開發。由於此類產品在國內市場競爭非常激烈,因此在國內市場方面,我們仍然會把主要的精力放在相對熟悉的電力檢測和保安監控,而香港則繼續專注紅外體溫檢測系統。

自穩定成像產品及服務方面,中國國內部分進 行電力線路巡檢和空中保安監控系統的直升機 以及香港部分進行海上巡邏、消防及救援的船 隻已經安裝「彼岸」的設備,相關設備並繼續 會在此類移動平台上安裝。我們預期此業務板 塊業績將有溫和的增長。另外,我們的自穩定 成像陀螺監測系統的「升級轉型」也將在香港 科學園的研發中心展開研發工作,進一步擴闊 我們的產品組合。

通用航空產品及服務方面,隨著通用航空國內市場的發展,預測二零二零年市場仍然對小型活塞式航空發動機有熱切的需求。因此,我們也將在研發、生產、售前售後服務上投入更多人手,以提升產品質量和服務水準。我們預期二零二零年通用航空業務板塊將會是更上一層樓。

### **BUSINESS REVIEW AND OUTLOOK**

The Group is principally engaged in the provision of thermal imaging products and services, self-stabilised imaging products and services, and general aviation products and services in the PRC and Hong Kong.

Looking back at the global economy for 2019, the economy of Mainland China was lagging caused by the prolonged trade friction with the United States ("US"). The gross domestic product of the PRC rose 6.1% only on a year-to-year basis compared with the 6.6% growth in 2018. The European economy remained ambiguous with the uncertainties of Brexit. In the Middle East, tensions escalated between the US and Iran. In Hong Kong, the ongoing social unrest posed an unpredictably negative impact on the social and economic environment. The global economy overall show a deceleration and hindered the business confidence.

The Group has still maintained stable development with a moderate increase in revenue overall amidst these volatile market conditions. During the year ended 31 December 2019, the revenue of the Group increased by approximately 5.1% on a year-to-year basis to HK\$275.4 million, while the gross profit decreased by approximately 1.1% on a year-to-year basis to HK\$93.1 million.

In 2019, the Group had set up a new research and development centre in Hong Kong, dedicated to serve our customers in Hong Kong and Macau. The new research and development centre, which has a total floor area of approximately 182 square metres ("sq.m."), has provided the Group additional capabilities to develop infrared body temperature screening systems and self-stabilised imaging products for vessels. Besides, the relocation of research and development centre in Guangzhou is still in progress. It is expected that the completion of these new research and development centres would enable us to provide more tailor-made products and robust services to our customers.

### 業務回顧及展望

本集團主要於中國及香港從事提供熱成像產品 及服務、自穩定成像產品及服務以及通用航空 產品及服務。

回顧二零一九年的全球經濟,由於與美利堅合眾國(「美國」)的長期貿易摩擦,拖累中國內地經濟發展。中國的國內生產總值同年比只增長6.1%,而二零一八年的增長為6.6%。歐洲經濟仍因英國脱歐的不穩定因素而維持不明朗。在中東,美國和伊朗之間的緊張局勢升級。在香港,持續的社會動盪對社會及經濟環境帶來不可預測的負面影響。全球經濟總體呈減速趨勢,並削減商業信心。

在瞬息萬變的市場環境中,本集團仍保持穩定發展,整體收益呈溫和增長。於截至二零一九年十二月三十一日止年度,本集團的收益同年比增長約5.1%至275.4百萬港元,而毛利同年比則下降約1.1%至93.1百萬港元。

於二零一九年,本集團在香港成立新研發中心,致力為香港及澳門的客戶提供服務。新研發中心總建築面積約為182平方米(「平方米」),為本集團提供額外開發紅外體溫檢測系統及船舶自穩定成像產品的能力。此外,廣州研發中心的搬遷計劃亦繼續進行中。預計該等新研發中心的落成將使我們為客戶提供更多量身定制的產品及強大的服務。

A summary of revenue from different segments of the Group is set out below:

以下是本集團不同分部的收益摘要:

### (1) Sale of thermal imaging products and provision of services

Our products and services in this segment can broadly be divided into three categories: (i) products under our own brand name, PTi; (ii) products of other brands; and (iii) thermal imaging inspection services. Our products are widely used in general consumption, commercial and industrial fields.

Revenue for provision of thermal imaging products and services showed a slight decline by 2.6% on a year-toyear basis due to decrease in demand from our customers for nano-positioning systems.

Throughout the years, the Group had provided advanced products, mainly for the provision of the infrared body temperature screening systems at various border control points in Hong Kong, including Hong Kong International Airport, Lo Wu Immigration Control Point, Hong Kong-Zhuhai-Macao Bridge, West Kowloon Terminal Building, etc.

The Group will endeavor to provide quality products and services with a primary focus on the products specified for use in detect heat abnormalities in electricity substation and overhead powerlines, infrared body temperature screening systems and surveillance systems.

Revenue from this segment during the year ended 31 December 2019 was approximately HK\$156.6 million (2018: HK\$160.7 million). It accounted for approximately 56.8% (2018: 61.3%) of the Group's revenue during the year ended 31 December 2019.

### (1) 銷售熱成像產品及提供服務

我們在該分部的產品和服務大致可分為 三類:(i)我們自有品牌PTi的產品;(ii)其 他品牌的產品;及(iii)熱成像監測服務。 我們的產品廣泛應用於一般消費、商業 及工業行業。

由於我們客戶對納米定位系統的需求減 少,提供熱成像產品及服務的收益同年 比略降2.6%。

多年來,本集團提供先進產品,主要為 香港各邊境管制站提供紅外體溫檢測系 統,包括香港國際機場、羅湖入境管制 站、港珠澳大橋、西九龍航站樓等。

本集團將努力提供優質的產品及服務, 主要專注在指定用於檢測變電站及架空 輸電線熱異常、紅外體溫檢查系統及監 視系統的產品。

截至二零一九年十二月三十一日止年 度,來自該分部的收益約為156.6百萬港 元(二零一八年:160.7百萬港元)。截至 二零一九年十二月三十一日止年度,該 業務約佔本集團收益的56.8%(二零一八 年:61.3%)。

# (2) Sale of self-stabilised imaging products and provision of services

# The products in this segment are designed to be mounted on moving platforms such as aircraft, helicopters, vessels and ships. The Group deploys a self-stabilisation technology whereby the imaging products are mounted on a multiple-axis gimbal structure and achieve maximum stabilisation. The products are traded under own brand name, SkyEye, SeaVision and PGs. We also rent our self-stabilised imaging products for aircraft to our customers for a fixed period at a rental fee.

Affected by the economic condition, revenue of this segment declined by 20.5% on a year-to-year basis, as a result of reduction in demand for self-stabilised imaging products and rendering of maintenance services and equipment rental to the state-owned electric power grid companies. However, the Group has been working towards expanding the product portfolio of this segment. With the new research and development centre in Hong Kong, we expect that the Group will be able to further enriching its product line for self-stabilised imaging products and gain larger market share with rising utilisation for this segment.

Revenue from this segment during the year ended 31 December 2019 was approximately HK\$34.6 million (2018: HK\$43.5 million). It accounted for approximately 12.6% (2018: 16.6%) of the Group's revenue during the year ended 31 December 2019.

### (2) 銷售自穩定成像產品及提供服務

該分部的產品是專為裝置於移動平台(例如飛機、直升機、船艇等)上而設計。本集團運用自穩定技術,將成像產品裝置在多軸吊載架構上,以達致最大限度的穩定性。產品乃以我們自有品牌(SkyEye、SeaVision及PGs)交易。我們偶爾亦會按固定租期出租機載自穩定成像產品予客戶及收取租賃費用。

受經濟形勢的影響,國有電網公司對自穩定成像產品及提供維修服務及設備租賃的需求減少,該分部的收益同年比下降20.5%。然而,本集團一直致力於擴大該分部的產品組合。通過香港新研發中心,我們預計本集團將能夠進一步豐富其自穩定成像產品的產品線,並隨著該分部利用率的提高而獲得更大的市場份額。

截至二零一九年十二月三十一日止年度,來自該分部的收益約為34.6百萬港元(二零一八年:43.5百萬港元)。截至二零一九年十二月三十一日止年度,該業務約佔本集團收益的12.6%(二零一八年:16.6%)。

# (3) Sale of general aviation products and provision of services

# (3) 銷售通用航空產品及提供服務

The services and products in this segment can be broadly divided into three categories, namely (i) light and ultra-light aircraft engines and related components distribution; (ii) maintenance training courses; and (iii) maintenance and support services. Our maintenance training courses and maintenance and support services are mainly carried out in our maintenance centre with a gross floor area of approximately 1,200 sq.m. which is located in Zhuhai City, Guangdong Province. Our customers in this segment include light and ultra-light aircraft manufacturers, flight schools, flying entertainment clubs, light aircraft research institutions and private flight owners.

該分部的服務及產品大致可分為三類,即(i)輕型及超輕型航空發動機及相關部件分銷:(ii)維修保養培訓課程:及(iii)維修及支援服務。我們的維修培訓課程:及及維修及支援服務主要於廣東省珠海以及維修及支援服務主要於廣東省珠海市的維修中心經營,其總建築面積約以下之一。該分部的客戶包括輕型和及超輕型航空器製造商、飛行學校、飛機類有人。

In 2019, the total general aviation flight time in the PRC was 1.125 million hours, representing an increase of 13.8% on a year-to-year basis. And according to "Report on the Work of the Government 2019" made by Chinese Premier Li Keqiang, the PRC would boost infrastructure investment for intercity transportation, logistics, utilities, disaster prevention and mitigation, and civil and general aviation. During the year, the Group had continued to offer comprehensive one-stop general aviation agency services to our customers. The Group believes that there is enormous potential for our products to infuse into the market and would continue to focus on the development of the general aviation value chain in the PRC.

於二零一九年,中國通用航空總飛行時間為1.125百萬小時,同年比增長13.8%。根據中國國務院總理李克強發表的《二零一九年政府工作報告》,中國將加大促進城市間交通、物流、公用事業、防災災以及民用及通用航空的基礎設施投資。於本年度,本集團繼續向客戶提供全面一站式通用航空代理服務。本集團相信,我們的產品具有滲透市場的巨大潛力,並將繼續專注於中國通用航空價值鏈的發展。

Revenue from this segment during the year ended 31 December 2019 was approximately HK\$84.2 million (2018: HK\$57.9 million). It accounted for approximately 30.6% (2018: 22.1%) of the Group's revenue during the year ended 31 December 2019.

### **PROSPECT**

Taking into account the macro economic environment that has become more challenging, the Group expects global trade conflicts and the spread of COVID-19 would continue to have a material impact on the Group's operating environment and the demand of our products. The management would continue to oversee the effects and accommodate the disruptions ahead.

The Group has long been focusing on the research and development in order to maintain its competitive edges. We believe that the new research and development centres in the PRC and Hong Kong would enable us to keep pace with the latest technologies and development of new products and services, which brings extra value to our customers and may eventually expand the Group's market share.

In addition, our thermal imaging products, which could be installed in the infrared body temperature screening systems, could provide the first line of defense for the infection prevention and epidemic control. We believe that with the outbreak of the COVID-19, the demand could remain high with the step-up of detection measures in border control points.

In view of the outbreak of COVID-19, we are currently taking necessary precautions to safeguard our employees and we still remain positive about the Group's prospects amidst the volatile economic environment. Due to the dynamic nature of these circumstances, our Group will continue to monitor and evaluate the impact of COVID-19. In addition, we believe that we could capture many opportunities in the general aviation market, especially the supportive government policies enacted in the PRC. The Group is well positioned to seize these opportunities to create value to the shareholders of the Company.

### 前景

考慮到日益嚴峻的宏觀經濟環境,本集團預計 全球貿易衝突及COVID-19的爆發將繼續對本 集團的經營環境及我們產品的需求產生重大影 響。管理層將繼續監督該等影響並適應未來的 干擾。

本集團長期專注於研發,以保持競爭優勢。我們相信,在中國及香港的新研發中心將使我們能夠與最新技術以及新產品及服務的發展保持同步,這將為我們的客戶帶來額外價值,並最終可能擴大本集團的市場份額。

此外,我們的熱成像產品可安裝在紅外體溫檢查系統,可以為預防感染及控制流行病提供第一道防線。我們認為,隨著COVID-19的爆發,邊境控制點檢測措施進一步加強,需求可能維持高企。

鑑於COVID-19的爆發,我們目前正採取必要的預防措施以保護我們的僱員,且在動盪的經濟環境中,我們仍對本集團的前景保持樂觀。由於此等情況會不斷變化,本集團將繼續監察及評估COVID-19的影響。此外,我們相信我們可以在通用航空市場中抓緊很多機會,尤其是善用中國已頒布的支持性政府政策。本集團具備有利條件把握該等機遇為本公司的股東創造價值。

### Revenue

The revenue of the Group was derived from business consisting of: (i) thermal imaging products and services; (ii) self-stabilised imaging products and services; and (iii) general aviation products and services. For the year ended 31 December 2019, the total revenue of the Group increased by approximately HK\$13.3 million, or 5.1% from approximately HK\$262.1 million for the year ended 31 December 2018 to approximately HK\$275.4 million. The increase was primarily attributable to the following reasons:

### (i) Thermal imaging products and services

Revenue derived from thermal imaging products and services decreased by approximately HK\$4.1 million, or 2.6%, from approximately HK\$160.7 million for the year ended 31 December 2018 to approximately HK\$156.6 million for the year ended 31 December 2019. The decrease was primarily attributable to the decrease in sales of nano-positioning systems, which was mainly attributable to the decrease in demand from our existing customers.

### (ii) Self-stabilised imaging products and services

Revenue derived from self-stabilised imaging products and services decreased by approximately HK\$8.9 million, or 20.5%, from approximately HK\$43.5 million for the year ended 31 December 2018 to approximately HK\$34.6 million for the year ended 31 December 2019. The decrease was mainly attributable to (i) the decrease in sales of our self-stabilised imaging products for aircraft as a result of the decrease in demand for self-stabilised imaging products for aircraft from a state-owned electric power grid company; and (ii) the decrease in revenue from rendering of maintenance services and equipment rental to a state-owned electric power grid company.

熱成像產品及服務產生的收益由截至二零一八年十二月三十一日止年度的約160.7百萬港元減少約4.1百萬港元或2.6%至截至二零一九年十二月三十一日止年度的約156.6百萬港元。減少乃主要由於納米定位系統的銷售減少,此乃主要由於我們現有客戶的需求減少。

### (ii) 自穩定成像產品及服務

自穩定成像產品及服務產生的收益由截至二零一八年十二月三十一日止年度的約43.5百萬港元減少約8.9百萬港元或20.5%至截至二零一九年十二月三十一日止年度的約34.6百萬港元。減少乃主要由於(i)一間國有電網公司對飛機和穩定成像產品的需求減少,導致我們飛過日穩定成像產品的銷售減少;及(ii)向一間國有電網公司提供維修服務及設備租賃產生的收益減少。

### (iii) General aviation products and services

Revenue derived from general aviation products and services increased by approximately HK\$26.3 million, or 45.4%, from approximately HK\$57.9 million for the year ended 31 December 2018 to approximately HK\$84.2 million for the year ended 31 December 2019. The increase was mainly attributable to our new customers in the general aviation industry and the increase in demand from our existing customers as a result of an increase in market demand for light and ultra-light aircraft engine.

### **Gross Profit and Gross Profit Margin**

Gross profit for the Group decreased from approximately HK\$94.1 million for the year ended 31 December 2018 to approximately HK\$93.1 million for the year ended 31 December 2019, and the gross profit margin decreased by approximately 2.1% from approximately 35.9% for the year ended 31 December 2018 to approximately 33.8% for the year ended 31 December 2019.

# (i) Gross profit margin of thermal imaging products and services

The gross profit margin of thermal imaging products and services remained relatively stable at approximately 30.6% and 30.1% for the years ended 31 December 2018 and 2019, respectively.

# (ii) Gross profit margin of self-stabilised imaging products and services

The gross profit margin of self-stabilised imaging products and services decreased by approximately 3.0% from approximately 56.3% for the year ended 31 December 2018 to approximately 53.3% for the year ended 31 December 2019. The decrease in our gross profit margin was primarily attributable to the decrease in rendering of maintenance services and equipment rental, which had a relatively higher gross profit margin.

### (iii) 通用航空產品及服務

通用航空產品及服務產生的收益由截至 二零一八年十二月三十一日止年度的約 57.9百萬港元增加約26.3百萬港元或 45.4%至截至二零一九年十二月三十一 日止年度的約84.2百萬港元。增加乃主 要由於市場對輕型及超輕型航空發動機 的需求增加使我們獲得通用航空行業的 新客戶以及現有客戶的需求增加。

### 毛利及毛利率

本集團的毛利由截至二零一八年十二月三十一日止年度的約94.1百萬港元減少至截至二零一九年十二月三十一日止年度的約93.1百萬港元,而毛利率由截至二零一八年十二月三十一日止年度的約35.9%減少約2.1%至截至二零一九年十二月三十一日止年度的約33.8%。

### (i) 熱成像產品及服務的毛利率

熱成像產品及服務的毛利率於二零一八年及二零一九年十二月三十一日止年度維持相對穩定,分別約為30.6%及30.1%。

### (ii) 自穩定成像產品及服務的毛利率

自穩定成像產品及服務的毛利率由截至 二零一八年十二月三十一日止年度的約 56.3%減少約3.0%至截至二零一九年 十二月三十一日止年度的約53.3%。毛 利率減少乃主要由於毛利率相對較高的 提供維修服務及設備租賃減少。

# (iii) Gross profit margin of general aviation products and services

The gross profit margin of general aviation products and services decreased by approximately 2.4% from approximately 35.2% for the year ended 31 December 2018 to approximately 32.8% for the year ended 31 December 2019. The decrease in our gross profit margin was primarily attributable to decrease in average selling price of certain series of 4-stroke engine products, which was mainly attributable to the provision of discount to our existing customers as a result of their bulk purchases.

### Other Income and Gains, Net

The Group's other income and gains increased by approximately HK\$0.5 million, or 27.8%, from approximately HK\$1.8 million for the year ended 31 December 2018 to approximately HK\$2.3 million for the year ended 31 December 2019. The increase was mainly attributable to an increase in bank interest income of approximately HK\$0.6 million and the recognition of recovery of written-off trade receivables of approximately HK\$1.4 million. The effect was partially offset by a decrease in reversal of doubtful receivables, net of approximately HK\$1.5 million.

### Selling and Distribution Expenses

The Group's selling and distribution expenses increased by approximately HK\$4.5 million, or 18.5%, from approximately HK\$24.3 million for the year ended 31 December 2018 to approximately HK\$28.8 million for the year ended 31 December 2019. The increase was mainly attributable to an increase in staff costs of our sales and marketing personnel resulting from the increase in sales commission along with the increase in our overall revenue for the year ended 31 December 2019.

### (iii) 通用航空產品及服務的毛利率

通用航空產品及服務的毛利率由截至二零一八年十二月三十一日止年度的約35.2%減少約2.4%至截至二零一九年十二月三十一日止年度的約32.8%。毛利率減少乃主要由於四行程發動機產品的平均售價下降,此乃主要由於我們因現有客戶批量購買而向其提供折扣。

### 其他收入及收益淨額

本集團的其他收入及收益由截至二零一八年十二月三十一日止年度的約1.8百萬港元增加約0.5百萬港元或27.8%至截至二零一九年十二月三十一日止年度的約2.3百萬港元。增加乃主要由於銀行利息收入增加約0.6百萬港元及確認收回已撇銷貿易應收款項約1.4百萬港元。該影響部分被應收款項呆賬撥回淨額減少約1.5百萬港元所抵銷。

### 銷售及分銷開支

本集團的銷售及分銷開支由截至二零一八年十二月三十一日止年度的約24.3百萬港元增加約4.5百萬港元或18.5%至截至二零一九年十二月三十一日止年度的約28.8百萬港元。增加乃主要因隨著我們截至二零一九年十二月三十一日止年度的整體收益增加,增加了銷售佣金,致使我們銷售及營銷人員的員工成本有所增加。

### **Administrative Expenses**

The Group's administrative expenses decreased by approximately HK\$16.2 million, or by 36.7%, from approximately HK\$44.1 million for the year ended 31 December 2018 to approximately HK\$27.9 million for the year ended 31 December 2019, which was primarily attributable to the listing expenses of approximately HK\$21.8 million incurred during the year ended 31 December 2018 and were non-recurring in nature. The effect was partially offset by the depreciation of right-of-use assets of approximately HK\$5.3 million during the year ended 31 December 2019 as a result of the adoption of Hong Kong Financial Reporting Standard ("HKFRS") 16 Leases issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") from 1 January 2019. Details of HKFRS 16 are set out in the section headed "Notes to Financial Statements" in this Annual Report.

### **Other Expenses**

The Group's other expenses decreased by approximately HK\$5.7 million, or 75.0%, from approximately HK\$7.6 million for the year ended 31 December 2018 to approximately HK\$1.9 million for the year ended 31 December 2019. The decrease in other expenses was primarily attributable to the decrease in foreign exchange loss.

### **Finance Costs**

According to the adoption of the HKFRS 16 *Leases*, at the commencement date of a lease, a lessee is required to recognise a liability of lease payment (i.e. the lease liability) and an asset representing the right to use the underlying asset during the lease term (i.e. the right-of-use asset). As a result, finance costs of approximately HK\$0.5 million for the year ended 31 December 2019 were recognised.

### 財務成本

### **Income Tax Expense**

The Group's income tax expense decreased by approximately HK\$2.3 million, or 27.7%, from approximately HK\$8.3 million for the year ended 31 December 2018 to approximately HK\$6.0 million for the year ended 31 December 2019, which was primarily resulting from a decrease in taxable profits during the year ended 31 December 2019. The Group's effective tax rates decreased from approximately 41.7% for the year ended 31 December 2018 to approximately 16.5% for the year ended 31 December 2019, which was primarily attributable to the absence of non-deductible listing expenses recognised for the year ended 31 December 2019.

# Profit for the Year Attributable to Owners of the Parent

As a result of the cumulative effect of the above factors, the Group's profit for the year attributable to the owners of the parent increased by approximately HK\$18.8 million, or 163.5%, from approximately HK\$11.5 million for the year ended 31 December 2018 to approximately HK\$30.3 million for the year ended 31 December 2019.

### LIQUIDITY AND FINANCIAL RESOURCES

During the year, the Group maintained a healthy liquidity position, with working capital financed mainly by internal resources. As at 31 December 2019, the Group reported net current assets of approximately HK\$302.5 million, as compared with approximately HK\$172.6 million as at 31 December 2018.

As at 31 December 2019, the Group's cash and bank balances was approximately HK\$177.1 million, representing an increase of approximately HK\$124.2 million as compared to HK\$52.9 million as at 31 December 2018.

For the year ended 31 December 2019, the net cash generated from operating activities was approximately HK\$33.6 million (2018: HK\$4.5 million). The cash generated from operating activities was mainly from the profits during the year ended 31 December 2019. The net cash used in investing activities was approximately HK\$3.3 million (2018: net cash generated from investing activities of approximately HK\$46.9 million). The net cash generated from financing activities was approximately HK\$94.6 million (2018: net cash used in financing activities was approximately HK\$37.3 million).

The net cash used in investing activities was mainly attributable to the acquisition of property, plant and equipment and intangible assets during the year. The net cash generated from financing activities was mainly arising from the net proceeds from the Listing.

The Company has not fully utilised the net proceeds from the Listing. As at the date of this Annual Report, the amount unutilised from the Listing was approximately HK\$68.6 million and there has been no change to the intended use of proceeds as previously disclosed in the Prospectus. In view of the slowdown in growth of the global economy for the year 2019, the Company has been taking a more prudent approach in the utilisation of proceeds for establishing new research and development centres in the PRC and Hong Kong and enhancing the recognition and qualification of our products. The Company intends to continue to apply the net proceeds according to the plan set out in the Prospectus. Going forward in 2020, the Directors will monitor the outbreak of COVID-19 and its impact to the global economy to evaluate our business objective and to apply unutilised proceeds from the Listing according to the changing market condition to create greater value for the shareholders. The unutilised proceeds have been placed in a licensed bank in Hong Kong.

### **CHAIRMAN AND CHIEF EXECUTIVE OFFICER**

Mr. YEUNG Lun Ching ("Mr. YEUNG"), being the chairman of the Board (the "Chairman"), provides leadership and is responsible for the effective functioning and leadership of the Board. Ms. WONG Kwan Lik ("Ms. WONG"), being the chief executive officer, focuses on the Company's business development and the daily management and operations. The segregation of roles of the Chairman and the chief executive officer of the Company aligns with the requirement pursuant to the code provision A.2.1 of the CG Code.

# APPOINTMENT AND RE-ELECTION OF THE DIRECTORS

Pursuant to the CG Code, it stipulates that non-executive Directors should be appointed for a specific term, subject to re-election and all Directors appointed to fill a casual vacancy should be subject to election by shareholders at the first general meeting after appointment. The Company has complied with the requirements of the CG Code that all Directors are appointed for a term of three years. Such appointment may be terminated earlier by either party giving to the other not less than three months' notice in writing.

Pursuant to the Company's articles of association (the "Articles of Association"), at each AGM one-third of the Directors for the time being (or, if their number is not a multiple of three, the number nearest to but not less than one-third) shall retire from office by rotation provided that every Director shall be subject to retirement at an annual general meeting at least one every three years. Accordingly, Mr. YEUNG Chun Tai and Mr. HOU Min, will retire by rotation at the forthcoming AGM of the Company and, being eligible, offers themselves for re-election.

### **INDEPENDENT NON-EXECUTIVE DIRECTORS**

The Board at all times met the requirements of the Listing Rules relating to the appointment of at least three independent non-executive Directors representing more than one-third of the Board with one of whom possessing appropriate professional qualifications or accounting or related financial management expertise.

The Company has received from each of the independent non-executive Directors a written annual confirmation in respect of his/her independence pursuant to Rule 3.13 of the Listing Rules. The Company is of the view that all independent non-executive Directors are independent.

Each of the independent non-executive Directors has signed a letter of appointment with the Company for an initial term of three years unless terminated by not less than three months' notice in writing served by each independent non-executive Director concerned or our Company expiring at the end of the initial term or at any time thereafter.

### **BOARD COMMITTEES**

The Board has established three Board committees, namely, the audit committee (the "Audit Committee"), the remuneration committee (the "Remuneration Committee") and the nomination committee (the "Nomination Committee"), to oversee particular aspects of the Company's affairs. All Board committees are provided sufficient resources to perform its duties and, if necessary, to seek independent professional advice at the expense of the Company to fulfill their responsibilities. They are also required to report to the Board after each meeting on their decisions or recommendations.

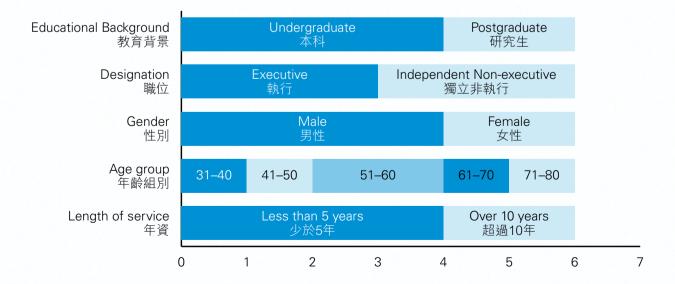

- (3) Commitment in respect of sufficient time and attention to the Company's business;
- (4) Diversity in all aspects, including but not limited to gender, age, cultural/educational and professional background, skills, knowledge and experience;
- (5) The ability to assist and support management and make significant contributions to the Company's success;

The appointment of any proposed candidate to the Board or re-appointment of any existing member(s) of the Board shall be made in accordance with the Articles of Association and other applicable rules and regulations.

#### **Nomination Procedures**

In general, the Board shall have the ultimate responsibility for all matters relating to the selection, appointment and reappointment of Directors.

- (1) The secretary of the Nomination Committee shall convene a meeting and invite nominations of candidates from Board members (if any), for consideration by the Nomination Committee. The Nomination Committee may also nominate candidates for its consideration.
- (2) In the context of appointment of any proposed candidate to the Board, the Nomination Committee shall undertake adequate due diligence in respect of such individual and make recommendations for the Board's consideration and approval.
- (3) In the context of re-appointment of any existing member(s) of the Board, the Nomination Committee shall make recommendations to the Board for its consideration and recommendation, for the proposed candidates to stand for re-election at a general meeting.

The Nomination Committee will review the Nomination Policy, as appropriate, to ensure the effectiveness of the Nomination Policy. The Nomination Committee will discuss any revisions that may be required and recommend any such revisions to the Board for consideration and approval.

#### **DIVIDEND POLICY**

The Group adopted a dividend policy (the "Dividend Policy") on 22 February 2019. A summary of this policy is disclosed as below.

The Group is committed to maintaining sufficient resources and flexibility to meet the Group's financial and operational requirements. At the same time, the Company continually seeks ways to enhance shareholders' value to ensure sustainable long-term yields for shareholders.

Under the Dividend Policy, the Company gives priority to distributing dividend in cash and shares its profits with its shareholders. The dividend payout ratio shall be determined or recommended, as appropriate, by the Board at its absolute discretion after taking into account the Group's financial results, future prospects and other factors, and subject to:

- (1) the Articles of Association;
- (2) the applicable restrictions and requirements under the laws of the Cayman Islands;
- (3) any banking or other funding covenants by which the Company is bound from time to time;
- (4) the investment and operating requirements of the Group; and
- (5) any other factors that have material impact on the Company.

The Board shall have the right to review the Dividend Policy from time to time as it deems fit according to the financial and business development requirements of the Group.

#### **CORPORATE GOVERNANCE FUNCTION**

The Board is responsible for performing the functions set out in code provision D.3.1 of the CG Code.

The Board would review the Company's corporate governance policies and practices, training and continuous professional development of the Directors and senior management, the Company's policies and practices on compliance with legal and regulatory requirements, the code of conduct applicable to employees and Directors, and the Company's compliance with the CG Code and disclosure in this Corporate Governance Report.

#### **BOARD MEETINGS**

Code provision A.1.1 of the CG Code stipulates that Board meetings should be held at least four times a year at approximately quarterly intervals with active participation of the majority of the Directors, either in person or through electronic means of communications.

# RISK MANAGEMENT AND INTERNAL CONTROLS

The Board has undertaken the overall responsibility for overseeing the Group's risk management and internal control systems on an on-going basis and reviewing their effectiveness at least annually in order to safeguard the interests of the shareholders and the assets of the Group.

The Board acknowledges its responsibility for evaluating and determining the nature and extent of the risks it is willing to take in achieving the Group's strategic objectives and ensuring that the Group has established and maintained appropriate and effective risk management and internal control systems. The systems are designed to manage rather than eliminate the risk of failure to achieve business objectives and can only provide reasonable and not absolute assurance against material misstatement or loss.

The Board has delegated to the Audit Committee to review the effectiveness of the risk management and internal controls of the Group. Based on its review, the Audit Committee advises the Board on the effectiveness of the Group's risk management and internal control systems, including the identification and monitoring of the risks, the adequacy of resources, staff qualifications and experience, training programmes and the Company's accounting and financial reporting functions. The management has also been delegated to design, implement and maintain the appropriate and effective risk management and internal control systems of the Group.

Risk management is curial to promote good corporate governance. Our risk management process includes risk identification, risk evaluation, risk control and review. The management is entrusted with duties to identify, evaluate, respond, monitor and communicate risks to the head of the respective business units or department to enforce the remediation. Risks are assessed by our management and reviewed by the Audit Committee and the Board based on (i) the probability that the risk will occur; and (ii) the severity of the impact on the Group. According to the likelihood of occurrence and the impact of the risk, our Group implement the risk management strategies by avoiding the risk, sharing or transferring the risk, mitigating the risk, and accepting the risk.

To further strengthen the risk management and internal control of the Group, the Company appointed external advisers to undertake the internal audit function and perform an annual review of the internal control systems of the Group. The external advisers evaluate the Group's risk management and internal control systems by reviewing the material controls, including financial, operation and compliance. The rotation basis would be applied to operations with similar risk associated so as to enhance the efficiency and effectiveness of the internal audit function. Review results and the recommendations in the form of written report are submitted to the Audit Committee for discussion and review. Follow up actions will be taken up by the management of the Group to ensure all significant control activities are properly in place within the Group and findings previously identified have been properly resolved.

The Company has conducted annual review on the effectiveness and efficiency of the Groups risk management and internal control systems for the year ended 31 December 2019 and the management has confirmed that there is no significant deficiency and weakness on the internal control system has been identified by the external advisers. During the year under review, both the Board and the Audit Committee satisfied and confirmed that the Group's risk management and internal control systems were effective and adequate.

Mr. YEUNG, Ms. WONG and Peiport Alpha Ltd. ("Peiport Alpha"), each being the controlling shareholder (as defined under the Listing Rules) of the Company (the "Controlling Shareholder(s)"), have entered into a deed of non-competition dated 18 December 2018 (in favour of the Company (the "Deed of Non-Competition"). Details of the Deed of Non-Competition was set out in the section headed "Relationship with Controlling Shareholders" of the Prospectus. The Company has received confirmations from Mr. YEUNG, Ms. WONG and Peiport Alpha of their compliance with the terms of the Deed of Non-Competition. Mr. YEUNG, Ms. WONG and Peiport Alpha declared that they have fully complied with the Deed of Non-Competition for the year ended 31 December 2019.

The independent non-executive Directors of the Company have reviewed the confirmations from the Controlling Shareholders and confirmed that up to the date of this Annual Report, all the undertakings under the Deed of Non-Competition have been complied with by Mr. YEUNG, Ms. WONG and Peiport Alpha.

- (1) any full-time or part-time employees, executives or officers of our Company or any of its subsidiaries;
- (2) any directors (including executive, non-executive Directors and independent non-executive Directors) of our Company or any of its subsidiaries;
- (3) any advisers (professional or otherwise), consultants, suppliers, customers and agents to our Company or any of its subsidiaries; and
- (4) related entities who, in the sole opinion of the Board, will contribute or have contributed to our Company or any of its subsidiaries.

The Share Option Scheme became effective on the Listing Date and, unless otherwise cancelled or amended, will remain in force for 10 years from the date of adoption of the Share Option Scheme (i.e. 17 December 2028).

The maximum number of shares issuable under share options granted to each eligible participant in the Share Option Scheme (including both exercised and outstanding options) within any 12-month period is limited to 1% of the shares of the Company in issue. Any grant or further grant of share options in excess of this limit is subject to shareholders' approval in a general meeting. A grant of share options under the Share Option Scheme to a director, chief executive or substantial shareholder of the Company, or to any of their associates, is subject to approval in advance by the independent non-executive Directors (excluding any independent non-executive Director who is the grantee of the option). In addition, any grant of share options to a substantial shareholder or an independent non-executive Director of the Company, or to any of their associates, which would result in the shares issued and to be issued, upon exercise of all options already granted and to be granted (including options exercised, cancelled and outstanding), to such person in the 12-month period up to and including the date of the grant in excess of 0.1% of the shares of the Company in issue and with an aggregate value (based on the closing price of the Company's shares at the date of grant) in excess of HK\$5 million, are subject to shareholders' approval in advance in a general meeting.

The exercise period of the share options granted is determined by the Board in its absolute discretion, save that such a period shall not be more than 10 years from the date of offer of the share options and subject to the provisions for early termination as set out in the Share Option Scheme. There is no minimum period for which an option must be held before it can be exercised. The exercise price of the share options shall be not less than the highest of (i) the Stock Exchange closing price of the Company's shares on the date of offer of the share options, which must be a date on which the Stock Exchange is open for business of dealing in securities; (ii) the average Stock Exchange closing price of the Company's shares for the five trading days immediately before the date of offer; and (iii) the nominal value of the Company's share as at the date of offer.

The Share Option Scheme is a share incentive scheme and is established to recognise and acknowledge the contributions Eligible Participants had or may have made to the Group. The Share Option Scheme will provide Eligible Participants an opportunity to have a personal stake in our Company with the view to achieving the following objectives: (i) motivate Eligible Participants to optimise their performance efficiency for the benefit of the Group; and (ii) attract and retain or otherwise maintain on-going business relationship with Eligible Participants whose contributions are or will be beneficial to the long-term growth of the Group.

No options had been granted or agreed to be granted under the Share Option Scheme during the year and up to the date of this Annual Report. The Company did not have any outstanding share options, warrants and convertible instruments into shares as at 31 December 2019 and up to the date of this Annual Report.

As at 31 December 2019, the Group had trade and bills receivables of HK\$106,637,000, after making a provision of HK\$1,076,000. The Group applies the simplified approach to provide impairment for expected credit losses ("ECLs") under HKFRS 9, which permits the use of the lifetime ECLs for all trade and bills receivables. To measure the ECLs, trade and bills receivables are grouped based on shared credit risk characteristics and the days past due and the calculation of ECLs are based on the historical observable default rates and forward-looking information. The ECLs of trade and bills receivables were HK\$1,076,000 as at 31 December 2019.

#### 1. CORPORATE AND GROUP INFORMATION

Peiport Holdings Ltd. (the "Company") was incorporated as an exempted company with limited liability in the Cayman Islands under the Companies Law (as consolidated and revised) of the Cayman Islands on 19 December 2017. The registered office address of the Company is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman, KY1-1111, Cayman Islands.

The shares of the Company were listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") on 11 January 2019 (the "Listing Date").

The Company is an investment holding company. During the year, the Company and its subsidiaries (collectively the "Group") were principally engaged in the provision of (i) thermal imaging products and services; (ii) self-stabilised imaging products and services; and (iii) general aviation products and services.

In the opinion of the directors, the ultimate holding company of the Group is Peiport Alpha Ltd., which was incorporated in the British Virgin Islands ("BVI") with limited liability and is controlled by Mr. YEUNG Lun Ching ("Mr. YEUNG") and Ms. WONG Kwan Lik ("Ms. WONG").

Pursuant to the reorganisation of the Company in connection with the listing of the shares of the Company on the Stock Exchange (the "Reorganisation"), the Company became the holding company of the companies now comprising the Group. Details of the Reorganisation are set out in the section headed "History, Reorganisation and Corporate Structure" in the prospectus of the Company dated 31 December 2018 (the "Prospectus").

本公司為一間投資控股公司。年內本公司及其附屬公司(統稱「本集團」)主要從事提供(i)熱成像產品及服務;(ii)自穩定成像產品及服務;及(iii)通用航空產品及服務。

董事認為,本集團的最終控股公司為彼 岸阿爾法有限公司,其為一間於英屬維 爾京群島(「英屬維爾京群島」)註冊成立 的有限公司,並受楊倫楨先生(「楊先 生」)及王群力女士(「王女士」)控制。

#### 2.1 BASIS OF PREPARATION

The financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") (which include all HKFRSs, Hong Kong Accounting Standards ("HKASs") and Interpretations) issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention. The financial statements are presented in Hong Kong dollars ("HK\$") and all values are rounded to the nearest thousand except when otherwise indicated.

#### **Basis of consolidation**

Pursuant to the Reorganisation as set out in the section headed "History, Reorganisation and Corporate Structure" in the Prospectus, the Company became the holding company of its subsidiaries now comprising the Group. The consolidated financial statements of the Group have been prepared as if the Group had always been in existence throughout both years presented; or since the respective dates of incorporation or establishment of the group companies, rather than from the date when the Company became the holding company pursuant to the Reorganisation.

A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

#### 2.1 編製基準

附屬公司為本公司直接或間接控制的實體(包括結構性實體)。當本集團對參與投資對象業務的浮動回報承擔風險或享有權利以及能透過對投資對象的權力(即本集團獲賦予現有能力以主導投資對象相關活動的既存權利)影響該等回報時,即取得控制權。

倘本公司直接或間接擁有少於投資對象 大多數投票或類似權利的權利,則本集 團於評估其是否擁有對投資對象的權力 時會考慮一切相關事實及情況,包括:

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets (including goodwill) and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interest and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained and (iii) any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

Other than as further explained below regarding the impact of HKFRS 16 Leases, the adoption of the above new and revised HKFRSs do not have material impact on the consolidated financial statements of the Group.

### **HKFRS 16 Leases**

HKFRS 16 replaces HKAS 17 Leases, HK(IFRIC)-Int 4 Determining whether an Arrangement contains a Lease, HK(SIC)-Int 15 Operating Leases — Incentives and HK(SIC)-Int 27 Evaluating the Substance of Transactions Involving the Legal Form of a Lease. The standard sets out the principles for the recognition, measurement, presentation and disclosure of leases and requires lessees to account for all leases under a single on-balance sheet model to recognise and measure right-of-use assets and lease liabilities, except for certain recognition exemptions. Lessor accounting under HKFRS 16 is substantially unchanged from HKAS 17. Lessors continue to classify leases as either operating or finance leases using similar principles as in HKAS 17.

HKFRS 16 did not have any significant impact on leases where the Group is the lessor.

The Group has adopted HKFRS 16 using the modified retrospective method with the date of initial application of 1 January 2019. Under this method, the standard has been applied retrospectively with the cumulative effect of initial adoption recognised as an adjustment to the opening balance of retained profits at 1 January 2019, and the comparative information for 2018 was not restated and continued to be reported under HKAS 17 and related interpretations.

#### New definition of a lease

Under HKFRS 16, a contract is, or contains, a lease if the contract conveys a right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to obtain substantially all of the economic benefits from use of the identified asset and the right to direct the use of the identified asset. The Group elected to use the transition practical expedient allowing the standard to be applied only to contracts that were previously identified as leases applying HKAS 17 and HK(IFRIC)-Int 4 at the date of initial application. Contracts that were not identified as leases under HKAS 17 and HK(IFRIC)-Int 4 were not reassessed. Therefore, the definition of a lease under HKFRS 16 has been applied only to contracts entered into or changed on or after 1 January 2019.

### Nature of the effect of adoption of HKFRS 16

The Group has lease contracts for several warehouses, system integration and service centres, office properties (collectively the "Office Properties") and a car parking space. As a lessee, the Group previously classified leases as either finance leases or operating leases based on the assessment of whether the lease transferred substantially all the rewards and risks of ownership of assets to the Group. Under HKFRS 16, the Group applies a single approach to recognise and measure right-of-use assets and lease liabilities for all leases, except for two elective exemptions for leases of low-value assets (elected on a lease-by-lease basis) and leases with a lease term of 12 months or less ("short-term leases") (elected by class of underlying asset). Instead of recognising rental expenses under operating leases on a straight-line basis over the lease term commencing from 1 January 2019, the Group recognises depreciation (and impairment, if any) of the right-of-use assets and interest accrued on the outstanding lease liabilities (as finance costs).

#### Impacts on transition

Lease liabilities at 1 January 2019 were recognised based on the present value of the remaining lease payments, discounted using the incremental borrowing rate at 1 January 2019. The right-of-use assets were measured at the amount of the lease liabilities, adjusted by the amount of any prepaid or accrued lease payments relating to the lease recognised in the consolidated statement of financial position immediately before 1 January 2019.

#### Fair value measurement

The Group measures its available-for-sale investments at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

### Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, deferred tax assets and financial assets), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to profit or loss in the period in which it arises.

In that case, the Group also recognises an associated liability. Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

#### Impairment of financial assets

The Group recognises an allowance for expected credit losses ("ECLs") for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

The Group considers a financial asset in default when contractual payments are 1 year past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

#### Simplified approach

For trade and bills receivables that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

#### Financial liabilities

#### Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as payables.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

The Group's financial liabilities include trade payables, financial liabilities included in other payables and accruals and lease liabilities.

#### Financial liabilities at amortised cost

After initial recognition, trade payables, financial liabilities included in other payables and accruals and lease liabilities are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in the statement of profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in the statement of profit or loss.

#### **Derecognition of financial liabilities**

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in the statement of profit or loss.

#### **Inventories**

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the special identification basis and, in the case of semi-finished products and finished products, comprises direct materials, direct labour and an appropriate proportion of overheads. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to completion and disposal.

#### Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the consolidated statement of financial position, cash and cash equivalents comprise cash on hand and at banks, including term deposits, and assets similar in nature to cash, which are not restricted as to use.

#### **Provisions**

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in the statement of profit or loss.

#### Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

- in respect of deductible temporary differences associated with investments in subsidiaries, deferred tax assets are only recognised to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised.

Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax assets and deferred tax liabilities are offset if a legally enforceable right exists to set off current tax assets against current tax liabilities and the deferred taxes relate to the same taxable entity and the same taxation authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

#### Revenue recognition

#### Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15.

#### (a) Sales of products

Revenue from the sales of products is recognised at the point in time when control of the asset is transferred to the customer, generally on delivery of the products.

#### (b) Provision of maintenance services

Revenue from the provision of maintenance services is recognised over the scheduled period on a straight-line basis because the customer simultaneously receives and consumes the benefits provided by the Group.

#### Revenue from other sources

Equipment rental income is recognised on a time proportion basis over the lease terms. Variable lease payments that do not depend on an index or a rate are recognised as income in the accounting period in which they are incurred.

#### Other income

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

#### **Contract liabilities**

A contract liability is recognised when a payment is received or the a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

#### **Employee benefits**

#### **Pension schemes**

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance for those employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries and are charged to profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

The employees of the Group's subsidiaries which operate in Mainland China are required to participate in a central pension scheme operated by the local municipal government. These subsidiaries are required to contribute a certain percentage of their payroll costs to the central pension scheme. The contributions are charged to profit or loss as they become payable in accordance with the rules of the central pension scheme.

#### **Borrowing costs**

Borrowing costs are expensed in the period in which they are incurred.

#### **Dividends**

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting.

Interim dividends are simultaneously proposed and declared, because the Company's memorandum and articles of association grant the directors the authority to declare interim dividends. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared.

#### Foreign currencies

The financial statements are presented in Hong Kong dollars, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

#### Foreign currencies (Continued)

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

The functional currencies of certain subsidiaries are currencies other than the Hong Kong dollar. As at the end of the reporting period, the assets and liabilities of these entities are translated into Hong Kong dollars at the exchange rates prevailing at the end of the reporting period and their statements of profit or loss are translated into Hong Kong dollars at the weighted average exchange rates for the year.

The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve. On disposal of a foreign operation, the component of other comprehensive income relating to that particular foreign operation is recognised in the statement of profit or loss.

For the purpose of the consolidated statement of cash flows, the cash flows of certain subsidiaries are translated into Hong Kong dollars at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of overseas subsidiaries which arise throughout the year are translated into Hong Kong dollars at the weighted average exchange rates for the year.

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

#### **Judgements**

In the process of applying the Group's accounting policies, management has made the following judgements, apart from those involving estimations, which have the most significant effect on the amounts recognised in the financial statements:

## Significant judgement in determining the lease term of contracts with renewal options

The Group has several lease contracts that include extension and termination options. The Group applies judgement in evaluating whether or not to exercise the option to renew or terminate the lease. That is, it considers all relevant factors that create an economic incentive for it to exercise either the renewal or termination. After the commencement date, the Group reassesses the lease term if there is a significant event or change in circumstances that is within its control and affects its ability to exercise or not to exercise the option to renew or to terminate the lease (e.g., construction of significant leasehold improvements or significant customisation to the leased asset).

The Group includes the renewal period as part of the lease term for leases of Office Properties and a car parking space due to the significance of these assets to its operations. These leases have a short non-cancellable period (i.e., three to five years) and there will be a significant negative effect on production if a replacement is not readily available.

## Withholding taxes arising from the distribution of dividends

The Group's determination as to whether to accrue for withholding taxes arising from the distribution of dividends from subsidiaries according to the relevant tax jurisdictions is subject to judgement on the timing of the payment of the dividends. Management considered that it is not probable that the Group's subsidiaries in Mainland China will distribute retained profits as at the end of each of the reporting periods in the foreseeable future, and accordingly no provision for withholding tax was made. Where the final outcome of these matters is different from the amounts originally rewarded, the difference will impact the deferred tax provision in the period in which the difference arises.

#### **Estimation uncertainty**

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

#### **Deferred tax assets**

Deferred tax assets are recognised for certain deductible temporary differences and unpaid expenses to the extent that it is probable that future taxable profit will be available against which the deductible temporary differences or unused tax losses can be utilised. Significant management judgement is required to determine the amount of deferred tax assets that can be recognised, based upon the likely timing and level of future taxable profits together with future tax planning strategies. Further details are contained in note 23 to the financial statements.

## Provision for expected credit losses on trade and bills receivables

The Group makes allowances on receivables based on assumptions about risk of default and expected loss rates. The Group used judgement in making these assumptions and selecting the inputs to the impairment calculation, based on the Group's past history, existing market conditions as well as forward looking estimates at the end of the reporting period.

Where the expectation is different from the original estimate, such difference will impact the carrying amount of trade and bills receivables and doubtful debt expenses in the periods in which such estimate has been changed. Further details of the trade and bills receivables are given in note 17 to the financial statements.

## Leases — Estimating the incremental borrowing rate

The Group cannot readily determine the interest rate implicit in a lease, and therefore, it uses an incremental borrowing rate ("IBR") to measure lease liabilities. The IBR is the rate of interest that the Group would have to pay to borrow over a similar term, and with a similar security, the funds necessary to obtain an asset of a similar value to the right-of-use asset in a similar economic environment. The IBR therefore reflects what the Group "would have to pay", which requires estimation when no observable rates are available (such as for subsidiaries that do not enter into financing transactions) or when it needs to be adjusted to reflect the terms and conditions of the lease (for example, when leases are not in the subsidiary's functional currency). The Group estimates the IBR using observable inputs (such as market interest rates) when available and is required to make certain entity-specific estimates (such as the subsidiary's stand-alone credit rating).

#### 10. INCOME TAX EXPENSE

The Group is subject to income tax on an entity basis on profits arising in or derived from the jurisdictions in which subsidiaries of the Group are domiciled and operate. Pursuant to the rules and regulations of the Cayman Islands, the Company is not subject to any income tax.

Hong Kong profits tax has been provided at the rate of 16.5% (2018: 16.5%) on the estimated assessable profits arising in Hong Kong during the year, except for one subsidiary of the Group, which is a qualifying entity under the two-tiered profits tax rates regime effective from the year of assessment 2018/2019. The first HK\$2,000,000 (2018: Nil) of assessable profits of this subsidiary is taxed at 8.25% and the remaining assessable profits are taxed at 16.5%.

Pursuant to the PRC Income Tax Law and the respective regulations, corporate income tax ("CIT") has been provided at the rate of 25% (2018: 25%) on the taxable income of the subsidiaries operating in Mainland China during the year, except for certain subsidiaries of the Group, which are qualified small and micro-sized enterprises ("SMEs") under Caishui [2019] No.13. According to Caishui [2019] No.13 effective from 1 January 2019 to 31 December 2021, qualified SMEs refer to enterprises that do not engage in any restricted or prohibited industries in the PRC and meet the criteria of (i) number of staff not exceeding 300; (ii) total assets not exceeding RMB50,000,000; and (iii) annual taxable income not exceeding RMB3,000,000. Qualified SMEs are eligible for a reduced CIT rate of 20%, 75% reduction of taxable income for the first RMB1,000,000 taxable income and 50% reduction of taxable income for the remaining taxable income.

Pursuant to the PRC Corporate Income Tax Law, a 10% (or a lower rate if there is a tax treaty between Mainland China and the jurisdiction of the foreign investors) withholding tax is levied on dividends declared to foreign investors from the foreign investment enterprises established in Mainland China. The requirement is effective from 1 January 2008 and applies to earnings after 31 December 2007. The Group is therefore liable for withholding taxes on dividends distributed by those subsidiaries established in Mainland China in respect of earnings generated from 1 January 2008.

As at 31 December 2019, no deferred tax has been recognised for withholding taxes that would be payable on the unremitted earnings that are subject to withholding taxes of the Group's subsidiaries established in Mainland China. In the opinion of the directors, the Group's earnings will be retained in Mainland China, so it is not probable that these subsidiaries will distribute such earnings in the foreseeable future. As at 31 December 2019, the aggregate amounts of temporary differences associated with investments in subsidiaries in Mainland China was approximately HK\$3,396,000 (2018: HK\$2,981,000).

The Group also has tax losses arising in Mainland China of HK\$109,000 (2018: HK\$210,000) that will expire in four years (2018: one to five years) for offsetting against future taxable profits of the companies in which the losses arose.

Deferred tax assets have not been recognised in respect of these losses as they have arisen in subsidiaries that have been loss-making for some time and it is not considered probable that taxable profits will be available against which the tax losses can be utilised.
