Note A: As disclosed in the monthly returns of November 2019 and February 2020, a total of 5,774,621 options were exercised in November 2019 and February 2020 (pursuant to which 5,774,621 shares would have been issued if all option holders had elected to pay the exercise price in full to receive shares in satisfaction of the exercise of such options).

Since certain options holders opted for either net cash settlement or net share settlement method in lieu of paying in full the exercise price for the number of shares over which the option was exercised, only a net total of 212,994 shares were issued by the Company on 4 May 2020 in satisfaction of the 5,774,621 options so exercised in November 2019 and February 2020.
