

COMPANY INTRODUCTION

The Group is a high-tech enterprise specialising in the field of railway transportation, integrating investment and financing, technology R&D, and intelligent railway transportation construction, operation and maintenance. The Company was listed on the Growth Enterprise Market (GEM) of the Stock Exchange on 16 May 2012 and transferred to Main Board of the Stock Exchange on 6 December 2013, with the stock code of 1522.

The Group, which concentrates on railway transportation industry for more than a decade, focuses on two core businesses, namely:



MARKET STRATEGY


The Group adheres to its market strategy of "relying on Beijing and Hong Kong, radiating across the country, and making presence in international markets", has been making remarkable results in market expansion.

As for overseas market, it has expanded into 9 cities overseas in 15 countries and regions, where it provided intelligent railway transportation-related (PIS) products and services.


Areas covered by the our businesses in China Beijing

CHAIRMAN'S STATEMENT



Dear valued shareholders and friends,

On behalf of the Board of the Company, I am pleased to present the annual results of the Group for FY 2020.

During the unprecedented year of 2020, faced with COVID-19, we rose to the challenge to fight against the pandemic bravely and developed at a steady pace. Meanwhile, 2020 is also a crucial year for the Group to implement its development strategy of "New Journey and Remodelling 2021". It is the last year of the 13th Five-Year Plan (FYP) period and a year to formulate the proposals for formulating the 14th FYP. In 2020, we

insisted on its strategies and fought against the pandemic intelligently to resume work and production. The top priority was still given to our primary businesses in 2020, with remarkable results made in market expansion. In 2020, we strengthened collaborative innovation and achieved win-win results through the development of our investment control platform. We updated our intelligentisation-led approach and the product system was becoming mature in 2020. We focused on risk prevention and control, achieving significant results in cutting cost and increasing efficiency in 2020. We strengthened the foundation and laid a solid foundation for steady development in 2020.

RESULTS

The Group recorded revenue of approximately HK\$1,550.0 million in FY 2020, an increase of approximately HK\$356.1 million or 29.8% from FY 2019. Profit attributable to equity shareholders in FY 2020 amounted to approximately HK\$168.4 million, a year-on-year rise of approximately HK\$71.5 million or 73.8%, marking a growth for the fifth consecutive year. This has laid a solid foundation for the Group to achieve its future strategic development goals.

DIVIDENDS

As a token of gratitude to our Shareholders for their continuing support, the Board proposed payment of a dividend of HK\$0.025 per share for FY 2020. The total amount of dividends will be approximately HK\$52,428,668, with the dividend payout ratio of 31%, subject to the approval of the Shareholders at the 2021 AGM. The Company has declared cash dividends for four consecutive years, which hits a 4-year high and is also a reflection of the implementation of its medium to long-term dividend policy.

STRATEGIC RESULTS AND SUSTAINED GROWTH

The Group further clarified its development orientation of "becoming China's leading intelligent railway transportation system service provider by focusing on integrated innovation". It concentrated on developing its primary businesses, set up an investment control platform via collaborative innovation and established a standard intelligent product system, aiming to increase its financial results steadily. It is committed to growing into "the world's top-class intelligent railway transportation leader".

The Group continued focusing on the primary businesses and deepened market expansion.

The Group had orders on hand of approximately HK\$2.06 billion as of the end of 2020, demonstrating its great business development and strong development potential. The Group has further deepened its market strategy of "relying on Beijing and Hong Kong, stepping up presence nationwide, and exploring international markets" while it successfully promoted "Beijing products + Beijing services".

The Group achieved remarkable results in business expansion in 2020. Its business in Beijing saw solid development as it participated in the construction of subway, suburban railway and other projects in the capital. The Group offered all-round services for the construction of intelligent subway in Beijing, facilitated the development of railway transportation and made the capital's railway transportation and infrastructure more digitised, network-based and intelligent. The business across the country saw growth. The Group has successively secured railway transportation projects in many other cities, with the proportion of projects outside Beijing rising year by year. A regional business hub has been gradually established, and the brand engineering effect has gradually emerged. The Group continued developing its overseas business and won the bidding of several overseas projects in Mexico, Brazil, Bulgaria, Romania, etc., which enhanced its international influence. The Group operated its business in 47 cities (including Hong Kong) in 26 provinces, municipalities, autonomous regions and special administrative regions in China as of the end of 2020. Its business covered approximately 75% of the cities where railway transportation services are available. Besides, Its foreign footprint has been expanded to 15 cities in 9 foreign countries. Market expansion is fruitful.

It improved technology R&D level via innovation and set up a standard system.

In FY 2020, the proportion of its investment in technology research and development ("R&D") to the total revenue remained at a high level, so is the proportion of the number of R&D personnel. It took actions to meet its scientific research goal of "promoting industrial upgrading with scientific and technological innovation and enhancing core competitiveness through R&D innovation".

Chairman's Statement (continued)

The Group laid down the Plan on Product and Technology System of Intelligent Railway Transportation in 2020, in order to fully serve the upgrading needs of owners and continuously enrich the railway transportation product system. Based on "one big data platform and five business platforms", the Group established many kinds of intelligent products and systems to adapt to the future through intelligent construction management, intelligent technology and equipment, intelligent operation and scheduling management, intelligent passenger service, intelligent operation and maintenance management. Via constant integrated innovation, it is devoted to providing solutions covering the whole life cycle of the intelligent railway transportation industry. Meanwhile, China's first clearing centre system designed on a microservices architecture was applied in Taiyuan's ACC project. The intelligent passenger prediction system was used in Zhengzhou Metro, which enables the Group to make decisions based on data. Many scientific research achievements have been transformed in a high level and at a high speed. Their demonstration effects have gradually emerged.

It coordinated strategic investment control to promote industrial upgrading

In 2020, the Group actively explored and attempted in the intelligent subway-centric new media business sector. The Group continued enriching the industries it invests and guaranteed the efficient operation of its investment platforms. At the same time, it also strengthened the scientific control and industrial coordination of the companies it holds a share or controls. The empowered and menu-like management and control model was adopted to accurately match resources. With remarkable results achieved in post-investment management, its overall core competitiveness was further improved.

SOCIAL RESPONSIBILITY

The Group fulfilled its social responsibility and actively advocated sustainable development in 2020.

Build a green railway transportation and constantly give back to society. The Group continuously built its strength in technology R&D, promoted the transformation of scientific research achievements and applied them in many projects. Efforts were made to reduce train operation energy consumption, improve train transportation efficiency, provide passengers with better mobility experience, upgrade services to ensure passenger safety, and facilitate railway transportation intelligentisation, in a bid to build a harmonious, green and safe railway transportation environment. Its intelligent community control platform was upgraded in an innovative way amid the pandemic. Informationbased measures were taken some communities in Beijing to battle the pandemic efficiently. The Group continuously paid attention to the physical and mental health of employees, attached importance to the cultivation of outstanding talents by organising "super new stars" activity to select talents, improved employee benefits, and advocated a green and healthy office model. It actively devoted to charity activities and helped impoverished students strive to give back to the society.

High-standard corporate governance and strict requirements for internal control management. The Group is well aware that strict and standardised corporate governance is the cornerstone of its longevity. It strictly followed the Listing Rules and relevant guidances, and discussed the second and third newsletters from the Stock Exchange of Hong Kong at the Board meetings. In terms of internal control, it completed the centralised revision of its systems, including the Rules of Procedure for the Board and Foreign Investment Management System, in hope of reaching a higher corporate governance level.

The Group will keep improving its social responsibility system, changing means to fulfil responsibilities and enriching practices to fulfil responsibilities in the future to share the same breath and destiny with the government and the society and contribute to the sustainable development of mankind.

PROSPECTS

As chairman of the Board, I will guide the Group to concentrate on its primary businesses. Investment plus innovation will lead the intelligentisation. The Group will seize the opportunities arising from the digital transformation and upgrading of railway transportation, the market needs of the rapid development of Beijing's intelligent subway, and new business formats and new opportunities in the railway transportation industry amid the pandemic to strengthen the productisation and service level. Cutting-edge technologies will be deeply integrated into its development. The purpose is to promote industrial upgrading via technological upgrading and achieve high-quality business development.

The size of China's railway transportation industry will remain at a high level in 2021. In the meantime, driven by the rapid development of smart cities and fast popularisation of artificial intelligence technology, the railway transportation industry will enter a new era of intelligentisation. Facing both opportunities and challenges in the future, the Group will always adhere to its technology-driven strategy, continuously deepen innovation-driven moves, increase efforts on service assurance, and promote the modernisation of corporate governance level and governance capability. Efforts will be made in various dimensions, such as brand building, product development, technological innovation, quality improvement, system building, and ecological integration, to achieve rapid development and guality improvement during changes. It will strive to stabilise the operation of the railway transportation system, make mobility convenient for passengers, build green, smart cities, and create returns and values for Shareholders.

In 2021, the Group will maintain high standards of pandemic prevention and control under the normalisation of pandemic prevention and control. It will conduct operation management in an orderly manner and tighten controls to reduce costs and enhance efficiency, in a bid to minimise the impact of the pandemic on businesses. Hereby, I would like to express my admiration and gratitude to the Company's every "hero in harm's way" who has been at the forefront of the fight against the pandemic.

In addition, the Group received a letter of possible privatisation from BII HK, its controlling shareholder, in the last quarter of 2020. The Group will promptly disclose the progress of the matter in accordance with the Listing Rules and other relevant requirements.



MANAGEMENT DISCUSSION AND ANALYSIS



MARKET AND BUSINESS ENVIRONMENT

In 2020, despite the impact of the COVID-19 pandemic, the railway transportation industry has still achieved a steady growth. According to the data from the China Association of Metros, the length of newly-added urban railway transportation lines in operation exceeded 1,241.99 kilometers ("km") in 2020. As of 31 December 2020, 45 cities in Mainland China have opened up railway transportation operating lines with a total mileage of over 7,978,19 km. During the 13th Five-Year Plan period, a total of 4,360 km of new urban railway transportation lines were put into operation in Mainland China, with an average of 872 km of newly opened lines per year. That means in the five years, the length of newly added urban railway transportation lines exceeded the total length of urban railway transportation lines before the 13th Five-Year Plan period. As at the end of 2020, the total railway lines and total fixed-asset investments in China's railway transportation accounted for 146,000 km and RMB815 billion, respectively. Major new lines that have opened include Chengdu-Kunming Railway, the Hefei-Huzhou section of Shangqiu-Hefei-Hangzhou High-speed Railway, and Kazuo-Chifeng High-speed Railway. Railway investments remained at a high level.

In 2020, Beijing's railway transportation network had a total passenger volume of approximately 2,294 million, and the average daily passenger volume had reached approximately 6.2678 million. With the opening of 3 lines, namely the middle section of Beijing Subway Line 16, the northern extension of Fangshan Line and Yizhuang Tram Line T1, Beijing's railway transportation operating mileage reached 727 km, with 24 lines and 428 stations in operation as of the end of 2020.

Management Discussion and Analysis (continued)

Under the guidance and support of government policies, the railway and urban railway transportation sector in Mainland China will maintain rapid development, thereby driving the rapid development of the entire industry chain involving investment, construction, operation, and maintenance. Under this industry environment, the Group has well achieved its strategic goals of 2020 by virtue of its own advantages and its research and judgement on development opportunities. At the same time, it integrated internal systems and gained momentum to lay the foundation for the future of sustainable growth in future.

BUSINESS REVIEW

Overview

In 2020, due to the impact of the COVID-19 epidemic, the progress of implementation and market expansion of many of the Group's projects under construction had slowed down significantly in the first quarter. However, with the gradual stabilisation of the situation of COVID-19 epidemic prevention and control in China, the Group was able to refocus on its three-year (2019-2021) development strategy of "one body, one platform and one centre" since the second quarter of 2020, safely resumed projects under construction, caught up with the project progress with remarkable results, while continuously increasing market development, to reduce costs and increase efficiency. Our two major businesses, namely the intelligent railway transportation business and the infrastructure information business, have continued to develop with positive results.

The year 2020 is an unusual year with the prevention and control of the COVID-19 pandemic as top priority. The Group held a total of 23 relevant meetings, conveyed over hundred internal messages and released nearly 30 notices and memoranda on COVID-19 pandemic prevention and control, the Company achieved zero infection for nearly 900 employees. Meanwhile, the Group actively support the social pandemic prevention and control work by donating RMB1 million to Wuhan and setting up an intelligent safety control system targeting the comings and goings of individuals for 26 communities in Chaoyang District, Beijing, to fight against epidemic intelligently and provide innovative services.

The Group's operating results increased significantly with continuous improvement of operating quality in 2020, with sales revenue increased approximately 29.8% from the previous year to approximately HK\$1,550.0 million. The proportion of the sales revenue from the intelligent railway transportation business to its total revenue increased to approximately 86.5%, as sales revenue from this segment increased approximately 32.9% from the previous year to approximately HK\$1,340.6 million. The growth is mainly attributed to the expansion of projects outside Beijing. Sales revenue from the infrastructure information business reached approximately HK\$209.4 million, representing a year-on-year increase of approximately 39.7% in FY 2020 complementing the growth in sales revenue, representing a huge boost in profitability. The profit attributable to equity shareholders was approximately HK\$168.4 million, representing an increase of 73.8% as compared to that of the previous year, and dividend per share increased to 2.5 HK\$ cents (FY 2019: 2.0 HK\$ cents).

The Group adhered to its market strategy of "relying on Beijing and Hong Kong, stepping up presence nationwide, and exploring international markets", and it made great progress in market expansion. The Group participated in some suburban railway projects in Beijing, including Huairou-Miyun Line, and built Beijing Subway Line 11 as a benchmark of intelligent subway. It expanded its businesses to 8 Mainland cities, including Taiyuan, Shaoxing, Harbin, Jiaxing, Handan and Zhuzhou. Moreover, it tapped into four foreign countries, Mexico, Brazil, Romania and Bulgaria. As of the end of 2020, the Group's businesses covered a total of 47 Chinese cities (including Hong Kong) and 15 cities in 9 overseas countries. The Group's aggregate contract amount of orders in hand are approximately HK\$2.06 billion as of the end of 2020, which maintained an increase over the same period of last year.

Management Discussion and Analysis (continued)

While focusing on the development of its main businesses, the Group has also actively explored innovation in railway transportation, and the investment on technology research and development ("R&D") has reached approximately HK\$135.3 million, which represented a high level of approximately 8.7% of the total revenue in FY 2020. This investment effectively promoted the transformation of scientific and technological achievements, enhanced the Group's future profitability, and continued to solidify the foundation for upgrading the Group's intelligent railway transportation business. The Group valued intellectual property rights and has obtained 10 new patents (85 in aggregate as of the end of 2020) and 53 software copyright certificates (344 in aggregate as of the end of 2020) in FY 2020, which have been fully applied in a number of projects to maintain a strong level of R&D innovation, and to enhance quality and efficiency for the sustainable development of the Group.

In 2020, Huaqi Intelligent continues to improve its main business and make continuous efforts in marketing, research and development, branding and other aspects, with remarkable synergy effect. Reference is made to the circular of the Company dated 31 January 2019 in relation to, among other things, the acquisition of 95% equity interest in Huaqi Intelligent (the "**VSA Circular**"). The Board is pleased to announce that the actual net profit of Huaqi Intelligent in 2020 (as defined in the VSA Circular) exceeds more than 90% but less than 100% of the committed net profit in 2020 (as defined in the VSA Circular), and the committed net profit in 2020 shall be deemed as to be completed in accordance with the terms of the Acquisition Agreement (as defined in the VSA Circular).

BUSINESS ANALYSIS BY SEGMENT

Intelligent railway transportation business: Development and consolidation

The Group's intelligent railway transportation business mainly involves PIS, AFC, ACC and TCC. The Group continues to expand its main business which focuses on intelligent railway transportation system. It recorded sales revenue of approximately HK\$1,340.6 million in 2020, representing a year-on-year increase of approximately HK\$332.0 million or 32.9%. The increase in revenue was mainly due to the contribution from a number of key projects such as Zhengzhou Metro Line 4, Taiyuan Metro Line 2, Suzhou Metro Line 5, and Urumqi Metro Line 1.

According to market statistics, market shares of the Group's on-board PIS in high-speed rail, subway and intercity railways accounts for approximately 41%, 28% and 87%, respectively, making it the overall leader for 5 consecutive years, and consolidating its leading position in the on-board PIS industry, with the synergy effect gradually emerging. As for AFC/ACC service, the Group's industry ranking jumped to the third place with a market share of approximately 14.4% in subway in 2020, representing an increase compared to 6.0% in 2019. It successfully moved into the industry's first tier.

Business in Beijing saw stable development. The main projects the Group participated in include Beijing Subway Line 11's AFC, PIS and communication and signalling system projects, Beijing-Chengde Railway, western extension of the sub-centre line, a loop line in northeast Beijing, Huairou-Miyun Line, AFC project of Changping Line's southern extension, Beijing Subway Line 16's PIS project and the Enterprise Resource Planning (ERP) software platform for Pingxifu overhaul factory. It further solidified its leading position in the capital city. Closely following its overall strategy, the Group will actively participate in the construction of the third-phase platform for the intelligent subway and network in Beijing, with the purpose of becoming a major service provider for the subway intelligentisation and upgrading in Beijing. It spared no efforts to increase its market share in Beijing by enriching the existing product lines, building an intelligent subway product system and growing its core AFC, PIS and TCC businesses.

Business in nationwide maintained growth. Contracts signed during 2020 include the on-board PIS projects of Changsha Metro Line 5, Hangzhou Metro Line 4 and Line 6's phase 2 project, Ji'nan Metro Line R3, Shaoxing Metro Line 1, Xiamen Metro Line 3, Fuzhou Metro Lines 5 and 6, and AFC projects of Zhengzhou Metro Line 4, Chengdu Metro's Coordination and Command Centre (COCC) project, Suzhou Metro's NCC project, and the connection of Zhengzhou Metro Line 3's AFC system to ANCC. Breakthroughs were achieved in several projects. In Zhengzhou, a key city where it increased its presence, the Group secured Zhengzhou Metro Line 4's AFC project, another representative project after the ANCC project and the big data cloud platform project. The city has become a key regional hub of its business in Mainland China outside Beijing. The Group offered an on– and off-board integrated intelligent system for the PIS projects of Guangzhou's new metro lines built during the 13th Five-Year Plan Period, through which it has accumulated experience in intelligent urban railway transportation projects. Drawing experience from the mature model of "Beijing products + Beijing services", the Group took actions based on the actual local conditions to better expand the market in Mainland China outside Beijing more widely and deeply.

Steady development in overseas markets. Due to the continuing impact of the global epidemic, the Group's overseas business was hindered in 2020 and the pace of market expansion was slowed down. However, due to its competitive advantages in technology and project management, the Group still won some projects in foreign countries, including the hinged vehicle project in Mexico, the cloud rail project in Salvador, Brazil, and the on-board PIS projects in Bulgaria and Romania.

Scientific and technology R&D achievements emerged. Focusing on integrated innovation, the Group is devoted to providing integrated solutions of products and services for the intelligent railway transportation industry. It laid down the Plan on Product and Technology System of Intelligent Railway Transportation and established an intelligent passenger service system covering the entire mobility chain. The Group took part in some scientific research of national demonstration projects and provided great support for the establishment of Beijing Collaborative Innovation Research Institute of Railway Transportation. Meanwhile, R&D innovation achievements have been implemented into several projects. The ACC project in Taiyuan is China's first clearing centre system designed on a microservices architecture. Zhengzhou Metro's intelligent passenger prediction system based on multi-source data can fully integrate the internal production, operation and management data. The unified railway transportation data access platform is the core component of its data middle platform of railway transportation. The platform has been successfully applied in projects in Beijing, Zhengzhou, Chengdu, Nanjing, etc.. In addition, a series of intelligent devices offering intelligent passenger services, such as pantograph intelligent analysis equipment, car density analysis system and 5G network video storage equipment, have come into demonstration.

Infrastructure information business: Innovation and changes

The Group's infrastructure information business mainly consists of transmission services for subway civil communications and construction of underground utility tunnel's intelligent management system, which are mainly concentrated in Beijing. As for subway civil communications, the Group's revenue model is by charging fees from providing of its civil communication transmission services to China's three major telecom operators, and by gaining shared revenue from mobile data traffic. Meanwhile, in terms of underground utility tunnel's intelligent management system, the Group gained revenue by offering system construction, operation and maintenance services.

In 2020, sales revenue derived from the infrastructure information business was approximately HK\$209.4 million, representing a year-on-year increase of approximately HK\$24.0 million or 13.0%. The growth in revenue of this segment is mainly due to the addition of 4G 100-gigabit port transmission business for civil communications.

Management Discussion and Analysis (continued)

As an important part of the infrastructure information segment, the Group refined the operation of its existing civil communications business in 2020, to increase the value of civil communications assets. It explored new markets and approached new customers and created new revenue by expanding the business of innovative valued-added products and services. As of the end of 2020, the Group's civil communications service covered 22 metro lines and 212 metro stations in Beijing. Besides, the number of 4G 100-gigabit resources used by the three major telecom operators increased by more than 170. Its self-built civil communications transmission system of Fangshan Line's northern extension was put into operation along with the line at the end of 2020. The rebuilding, operation and maintenance of existing railways were carried out in an orderly manner. Moreover, the Group continues to explore value-added businesses such as fiber optic transmission and server room rental.

Utility tunnel and intelligence+ businesses saw rapid development. The Group continued to make efforts in the field of utility tunnel. It built a leading Chinese, self-developed and patented intelligent utility tunnel management platform. Actions were taken to steadily push forward with key projects, including Beijing 2022 Winter Olympics, Beijing New Airport Line, eastern extension of Beijing Subway Line 7 and Future City of Science. Relying on the existing platform and combining converged communications, facial recognition and other independent core technologies, the Group has created an intelligent site management system in relation to personnel and material positioning, video surveillance, labour service of utility tunnel, environmental monitoring, material management and personnel communications, and integrating background software and end-user equipment. The system has been used in the intelligent site construction of projects, including Beijing Subway Line 11 and Pinggu line, which has enhanced the intelligent construction level for infrastructure. As far as intelligent communities is concerned, the Group rides on its R&D capabilities to set up an intelligent safety control system targeting the comings and goings of individuals in and out of communities, in order to improve its guarantine efficiency and safety to fight against the pandemic. A statistical reporting system was released, which promoted collective prevention and control and improve the effectiveness of pandemic prevention. Moreover, the Group actively collaborated with governmental departments to facilitate the construction of an integrated hub in the sub-centre of Beijing, an important fulcrum of the "Beijing-Tianjin-Hebei region on railway" and the largest Asian underground transportation hub. Joint efforts were made to develop a safety control platform system featuring risk detection, identification and elimination. This has lifted its intelligent control to a higher level in an all-round manner. The Group's infrastructure information business, representing one of the major application scenarios in smart cities, will have broad market development potential in the long run.

Investments and joint ventures: Coordination and upgrading

In 2020, with the moves to promote the rapid development of its main businesses and accelerate the expansion of new businesses, the Group closely followed the development trend of railway transportation intelligentisation to seek and maintain potential investment projects according to business synergy, company size and other screening conditions, expand backup resources, and conduct regular review and follow-up of key projects. It will optimise the strategic investment and industrial investment to upgrade industries and enhance industrial competitive edge. The management of the Group and the companies it invested in will be integrated from all dimensions, so as to further strengthen post-investment management and control, and promote business synergy and capital appreciation. At the same time, the Group has also actively explored in the new media business of Smart Metro.

The Group also strengthened the control and coordination of the companies it invested in and controlled, adopted differentiated management, optimised and integrated resources, and realised synergic effect:

- Due to the pandemic, the Beijing Subway Capital Airport Express operated by Beijing Metro, a joint venture of the Group, transported 4.5665 million passengers in 2020, or 12,500 passengers a day on average, representing a decrease of 64% from 2019. Beijing Metro actively responded to the negative impact through various means, such as putting new lines into operation, reducing costs and increasing efficiency, and seeking for policy support.
- Metro Science and Technology, a joint venture of the Group, consolidated its main business of AFC operation and maintenance. At the same time, it intensified efforts to develop intelligent operation and maintenance and information security assessment services, and set up a big data platform. However, both its revenue and profit went down year on year in 2020 due to delay of its integration project, adjustment to the cooperation model in Mainland China (other than Beijing).
- The registered users of "Yitongxing" APP developed by the Group's joint venture reached 25 million and has been extended to pay most public transport fares during the year. Currently, the service has been expanded to Shanghai, Hohhot and other provinces and cities, which enables interprovincial and intercity connection. The joint venture turned for profitability.
- Meanwhile, the Group has actively explored new potential businesses and joint-venture projects via Cornerstone Lianying. It carefully selected investment targets, incubated high-quality companies, and identified new partners for the Group's future business collaboration.

BUSINESS PROSPECTS

Industry momentum remains strong and steady

China's railway transportation industry will maintain a high-speed development in 2021. As mentioned in the "Outline of Building China into a Country with Strong Transportation Network", China will continuously turn itself into a country with strong transportation network in two stages from 2021 to midcentury. The China railway transportation network estimated that a total of 69 railway transportation lines in 35 cities, including Jinhua, Hefei, Guangzhou and Beijing, will commence operation in 2021, with a total mileage of approximately 1,700.69 km, 993 stations and a total investment of RMB1.1468 trillion. Meanwhile, the construction of 39 urban railway transportation lines in 25 cities, including Jinhua, Chongqing and Ji'nan, is expected to begin this year. The length of the railway transportation lines will reach 1,043.77 km, with 440 stations to be built. The investment will cost a total of RMB517.214 billion. China is expected to build its strength in transportation by 2035, which it will take one hour to commute in urban areas, two hours to reach urban agglomerations, and three hours to cover major cities in China. In addition, China will vigorously develop intelligent railway transportation by promoting the in-depth integration of big data, internet, artificial intelligence and other new technologies with the transportation industry, and set up an integrated traffic big data centre system. Investments in China's urban railway transportation market tend to rise steadily in the coming years.

The Group's revenue mainly derived from the provision of PIS, AFC and other information based systems used in the construction of new railway lines and urban railway transportation lines. The market demand was closely related to the total length of the new metro lines. Moreover, as a growing number of metro lines has been put into operation, the railway transportation in many first tier and second tier cities showed a new trend of network-based operation and management. Therefore, new network-level systems, including ACC, TCC and big data centre, should be urgently established for unified scheduling and management in these cities. The new fast growing demands have brought new business opportunities for the Group.

Policy environment is continuously optimised

In recent years, with the implementation of "Made in China 2025 development outline", "the construction outline of a strong transportation country", "China's urban rail transportation smart urban rail development outline" and a series of rail transportation related high precision industry policies, the policy environment of the rail transportation industry continues to be optimised. In the "Made in China 2025 development outline", the advanced railway transportation equipment field is listed as one of the top 10 key fields. China will push forward with equipment and technology upgrading, and accelerate the elimination of outdated technologies and energy intensive and inefficient transportation equipment. With a mission of focusing on urban rail to build national strength in transportation, a blueprint for the development of smart urban rail is gradually built. In the meantime, according to proposals for the 14th Five-Year Plan, China will take self-reliance and self-improvement in science and technology as the strategic focus of country's development, and uphold the core position of innovation in its modernisation drive. Moreover, the total investment in intercity high-speed rail and railway transportation sectors, as a major force in the seven fields of "new infrastructure", is expected to reach the highest level at RMB34,400 trillion from 2020 to 2025.

Accordingly, taking "science and technology plus innovation" as the core strategic target, the Company will integrate into the development of big data, cloud platforms, artificial intelligence and other cutting-edge technologies. It will give a priority to the business in the key parts of the railway transportation industry to create complete solutions of intelligent railway transportation, with forward-looking product planning and research as the starting point, and with collaborative innovation as the purpose.

The Group will focus on developing primary businesses and ride on investment and innovation to achieve steady and sustained growth

The Group, an enterprise specialising in the field of railway transportation, integrating investment and financing, technology R&D, and intelligent rail transport construction, operation and maintenance, will insist on the strategy of "one body, one platform, and one centre". Driven by technological innovation and management innovation, it will promote scientific and technological empowerment and high-quality development to ensure steady and sustained development.

It will enrich the product system of intelligent railway transportation via integrated innovation and service upgrading

With the progress in railway transportation informatisation in network communication technology, cloud computing, big data, artificial intelligence and other aspects, the Group will continuously make railway transportation cloudbased, digital and intelligent after satisfying the basic needs of organisation and management operations and security service guarantee. Efforts will be made to reduce the number of tiers of the technology architecture, the integration of business directions, and the intellectualisation of professional systems. Finally, an architecture with management in the cloud and service in the terminal will take shape. To this end, the Group will pay close attention to the intelligent development trend of railway transportation, build a new generation of intelligent railway transportation technology architecture and create an overall product system of "1+5+N" through integrated innovation. The focus will be on upgrading passenger service products, strengthening operation scheduling products, and adding operation and maintenance management products and train equipment products. It is committed to providing solutions covering the whole life cycle of railway transportation systems for owners. To this end, the Group will continue to maintain a high standard of R&D investment and make a good reserve for technological innovation.

It will build a professional investment control platform to focus on its main business while developing other businesses

The Group will keep focusing on the development of network-level traffic control centre and line-level core systems of the intelligent railway transportation. It will improve information systems integration and facilitate the implementation of large projects, in order to gradually develop stable integrated technology + product solutions. The proportion of its self-developed products in key parts will be increased to further improve its gross margin. In addition, the Group will primarily take on a controlling role, if not a minority investor, in businesses that are crucial in providing railway transportation solutions. Targeted investment and merger and acquisition of outstanding companies will help the Group enhance its ability to operate businesses, extend the scope of businesses, and lift the businesses to a higher level. It will set up an alliance of business ecosystem and team up with quality partners in technologies, products, scenarios, etc.. Furthermore, the empowered and menu-like management and control model will be adopted to accurately match resources, so as to improve strategic match and achieve coordinated development.

It will step up its presence in the existing markets and tap into new markets, and remain steadfast in its market expansion strategies

As the number of cities where railway transportation lines have come into service and the length of railway transportation lines are on the rise, the Group will insist on its market strategy of "relying on Beijing and Hong Kong, stepping up presence nationwide, and exploring international markets", consolidate the position of Beijing as the stronghold of its businesses, and increase the coverage and market share of its businesses in the city. It will strive to offer "Beijing products" and "Beijing services" to serve the construction of four railway transportation lines in the capital, with a view to boosting the new development of Beijing's railway transportation industry. Actions will be taken to establish a nationwide market network, speed up efforts to build regional hubs, and strengthen development in key regions such as the Beijing-Tianjin-Hebei region, the Yangtze River Delta, the Guangdong-Hong Kong-Macao Greater Bay Area, and the Chengdu-Chongqing region. Taking root in Hong Kong, under the premise of controllable risks and mature models, the Group will actively tap into overseas markets and open up new markets by assisting, undertaking and participating in construction, etc. and adopting the strategy of "going out together".

Continuous efforts will be made on pandemic prevention and control

In 2021, the Group will maintain high standards of pandemic prevention and control and implement policies under the normalisation of pandemic prevention and control. Efforts will be made to overcome the adverse effects of the pandemic, clarify the plan to work on priorities and intensify market expansion. It will build quality projects that can "promote transformation, increase functionality and benefit long-term", and expand and strengthen its core primary businesses. With targeted investment, it will actively seek new growth points to ensure stable and sustained development. Meanwhile, the Group's current asset-liability ratio is relatively reasonable and the cash on book remains sufficient. The COVID-19 pandemic will not affect the Group's sustainability. Overall, the current COVID-19 pandemic has limited impact on the Group's operating performance.

In the future, the Group will keep up with industry development trends and remain steadfast in its strategies. The focus will still fall on its core businesses. Deepening scientific and technological innovation, and it will strive to create a flagship brand based on "rail+technology".

FINANCIAL REVIEW

Revenue

The Group recorded revenue of approximately HK\$1,550.0 million in FY 2020, representing an increase of approximately HK\$356.1 million or 29.8% from the year ended 31 December 2019. Revenue from intelligent railway transportation services and infrastructure informatisation services accounted for approximately 86.5% and 13.5% of the total revenue, respectively.

The Group mainly operates its businesses in Mainland China and Hong Kong. For FY 2020, the Group recorded revenue of approximately HK\$1,508.5 million in Mainland China, representing an increase of approximately HK\$384.5 million as compared to FY 2019. The significant growth in revenue in Mainland China was mainly attributed to: (1) the expansion of the projects of Zhengzhou Metro Line 4, Hebei Jingche Railway Transportation Vehicle Equipment, Taiyuan Metro Line 2, Fuzhou Metro Line 6, Urumqi Metro Line 1, etc., and the first-time revenue recognition; and (2) the consolidation of the revenue from the acquisition of the Huaqi Intelligent and Litmus in March and December 2019 respectively into its total full-year revenue.

Cost of sales

The Group's cost of sales was approximately HK\$934.7 million in FY 2020, representing an increase of approximately HK\$165.5 million or 21.5% from FY 2019. The increase in cost of sales was mainly due to the increase in the cost in line with the increased revenue.

Gross profit

The Group's gross profit was approximately HK\$615.3 million in FY 2020, representing an increase of approximately HK\$190.5 million or 44.8% from FY 2019. The increase in gross profit was mainly due to a rise in its business volume.

Investment income

The Group recorded a negative investment income of approximately HK\$108.2 million in FY 2020. The decrease in investment income was mainly due to a decline in passenger flow of the Group's joint venture, Beijing Metro, which led to a decrease in ticket revenue and the postponement of some projects of the Group's joint venture, Metro Science and Technology.

Selling, general and administrative expenses

The Group's selling, general and administrative expenses were approximately HK\$257.9 million in FY 2020, representing an increase of approximately HK\$30.7 million or 13.5% from FY 2019. The increase was mainly due to the increase in the Group's business volume, which led to an increase in sales and management expenses, and Huaqi Intelligent and Litmus acquired in March and December 2019 were incorporated into their annual sales, general and administrative expenses during this year.

Profit attributable to equity shareholders of the Company

The profit attributable to equity shareholders of the Company was approximately HK\$168.4 million in FY 2020, representing a year-on-year increase of approximately 73.8%. Earnings per share were HK\$0.08, representing a year-on-year increase of 73.9%.

Liquidity, financial and capital resources

Capital structure

As at 31 December 2020, the Group's issued share capital consisted of 2,097,146,727 ordinary shares of HK\$0.01 each (31 December 2019: 2,100,126,727 ordinary shares of HK\$0.01 each).

Cash position

As at 31 December 2020, the Group's cash on hand and in bank was approximately HK\$983.8 million (31 December 2019: approximately HK\$850.9 million).

Borrowings and pledged assets of the Group

As at 31 December 2020, the Group's borrowings were approximately HK\$571.4 million (2019: approximately HK\$559.9 million), of which HK\$500 million was derived from the borrowing from a subsidiary of the Company's ultimate holding company, BII, and the remaining was bank borrowings amounted to approximately HK\$71.4 million.

Working capital and gearing ratio

As at 31 December 2020, the Group had current assets of approximately HK\$2,828.9 million (31 December 2019: approximately HK\$2,505.4 million), while its current liabilities were approximately HK\$1,654.5 million (31 December 2019: approximately HK\$986.9 million), resulting in net current assets of approximately HK\$1,174.4 million (31 December 2019: approximately HK\$1,518.5 million). As at 31 December 2020, the current ratio, calculated based on current assets divided by current liabilities, was approximately 1.7 (31 December 2019: approximately 2.5).

Gearing ratio is calculated based on total debts at the end of a period divided by total assets at the end of such period multiplied by 100%. As at 31 December 2020, the Group's gearing ratio was 40.6% (31 December 2019: 43.7%).

Foreign exchange exposure

The Group has six main operating subsidiaries, one was incorporated in Hong Kong and the other five were established in Mainland China. All of these subsidiaries earn revenue and incur cost in their local currencies. The Directors consider that the impact of foreign exchange exposure on the Group is minimal.

Contingent liabilities

SIGNIFICANT INVESTMENTS HELD AND FUTURE PLANS

Beijing Metro was established on 15 February 2016, and its equity interest was held by the Company and Beijing Subway Operation as to 49% and 51%, respectively. Its registered capital was RMB500 million of which RMB245.0 million was contributed by the Company and RMB255.0 million was contributed by Beijing Subway Operation which is an independent third party. Beijing Metro is principally engaged in investing, constructing, operating, managing subway lines, operating value-added services and related property development, including managing the Operating Income Rights of Beijing Subway Airport Express, Dongzhimen Terminal and new lines of the Beijing Subway.

Beijing Metro is a private company whose quoted market price is not available. As of 31 December 2020, the carrying amounts of Beijing Metro in the Group's consolidated financial statements by using equity method is HK\$211,558,000, accounting for approximately 4.92% of the Group's total assets as at 31 December 2020. The Company did not receive any realised and unrealised gain or loss or any dividends from Beijing Metro. In the future, the Group will implement investment strategies based on the actual funding and operation needs of Beijing Metro.

Save as disclosed, there were no other significant investments held, material acquisitions or disposals of subsidiaries and affiliated companies, and other plans for material investments or capital assets during FY 2020.

EMPLOYEES AND REMUNERATION POLICIES

As at 31 December 2020, the Group employed a total of 892 employees (including the Executive Directors) (31 December 2019: 889). The total staff costs, including Directors' remuneration, were approximately HK\$304 million (FY 2019: approximately HK\$242 million).

The Group reviews remuneration package annually with reference to the prevailing market conditions and staff's working performance, qualification and experience. In addition to basic remuneration, the Group also pays bonus based on its performance and staff's contribution to the Group. Other benefits include share options, contribution to social insurance scheme in China, contribution to the MPF Scheme and insurances in Hong Kong. The Group also organised professional and vocational trainings for its employees.

FINAL DIVIDEND

In view of the business growth of the Group and in response to the long term support of the Shareholders, the Board recommended the declaration of a final dividend of HK\$0.025 per share for 2020 financial year (FY2019: HK\$0.02 per share). The proposed final dividend will be payable to shareholders of the Company whose names appear on the register of members of the Company on Friday, 4 June 2021, subject to the approval of the shareholders of the Company at the 2021 annual general meeting ("2021 AGM"). It is expected that the final dividend will be paid on or before Tuesday, 31 August 2021.

MATTERS SUBSEQUENT TO THE REPORTING PERIOD

There were no other significant events arising subsequent to FY 2020 as at the date of this annual report.

PERORATION

We have gone through an extraordinary 2020 together hand in hand. I am very grateful to our customers, partners and investors for their support and trust, and to all of our staff who have worked hard in their respective positions and on the front line of the fight against the epidemic throughout the year. It is your unremitting efforts that have contributed to the steady growth of the Company's performance. Looking forward to 2021, with the gradual stability of the national economic and social order, in respect of the Company's operation and development, it will duly perform its own epidemic prevention and control work. Meanwhile, I will devote more time to the improvement of the business quality, stabilisation of the market position, creation of excellent projects and realisation of collaborative innovation. • RISK FACTOR ANALYSIS

The Group is faced with risks, including risks arising from changes in national strategies and macro economy and industrial policies, risks related to its businesses, as well as changes in regulatory rules on listed companies that will have an impact on the Group. Therefore, the Group will be committed to building a more scientific and systematic risk control system to address these risks. On the basis of its increasingly perfect internal control system, it will closely monitor and prevent various risks from risk assessment, financial control, internal audit and legal risk control.

RISKS FROM MACRO ECONOMY

In terms of the macro environment, the global outbreak of COVID-19 had a serious impact on China's economic development and the global economic pattern in 2020. According to data from the National Bureau of Statistics, China's GDP topped RMB100 trillion for the first time in 2020, a year-on-year increase of 2.3%. The growth slowed down sharply. Moreover, due to the spread of the global pandemic and the changing world pattern, China's foreign trade growth slowed. Coupled with the readjustment of the global industrial and supply chains and the trade protectionism, the economy was under rising downward pressure. As the evolution of the pandemic is highly uncertain and the pace of the global economic recovery and policy shift remains unclear in 2021, the Chinese economy is under heavy downward pressure, according to a report on the analysis and forecast of Chinese macroeconomic situation. In response to the above risks, the Group will proactively adapt to the new normal in economic development. It will further optimise its business structure, accelerate transformation and upgrading, continuously develop businesses with stable cash flows, such as civil communications and railway transportation operation and maintenance, and promote collaborative innovation and development.

RISKS FROM PANDEMIC SPREAD

It has been more than one year since the outbreak in early 2020. Experts predicted that the impact brought forth by the pandemic will continue well into 2021. Therefore, China will still take targeted, effective anti-pandemic measures. Despite a short-lived COVID-19 rebound in several regions in the country, the pandemic will have a smaller impact in 2021 than that in the previous year. As far as the Company's businesses concerned, limited by local anti-pandemic policies, the procedures for employees to go on business trips and return to Beijing are complicated, which hinders the project progress to some extent. As the changes of the pandemic outside China are unclear, and some countries and regions still report an increase in confirmed cases and a rebound trend, the Company's international business are restricted severely. However, in the long run, pandemic prevention and control will be improved with the gradual popularisation of vaccines in the world. Therefore, the Group, which will actively respond to the call of the central and local governments, will gradually arrange the project schedule, take full advantage of technologies, including control informatisation for projects and networked mobile officing, to provide services for customers while ensuring employees' physical health. It will actively fulfil social responsibility, optimise internal process management and step up efforts on the study of cutting-edge technologies, such as intelligentisation and informatisation of railway transportation, in order to reduce the impact of the pandemic as much as possible.

RISKS FROM INDUSTRY FLUCTUATIONS

In recent years, China's macro economy maintained sustained and stable growth, urbanisation sped up and infrastructure planning accelerated, which provided a favourable environment for industry development. However, if regulations on the macro economy, the international political situation and the spread of the pandemic lead to slow development of the railway transportation sector, railway transportation owners in various regions will have a growing need for reducing costs and increasing efficiency due to fewer financial funds allocated. They will be more sensitive to costs while expecting better service quality. All these may cause adverse effects on the Group's development. So the Group will increase efforts to study industrial policies, development directions and industrial development laws to address the risks. It will improve its core technologies and develop its own core products. The number of orders on hand will be increased, and production and management cost optimisation will be performed to enhance its core competitiveness. The Group will also integrate various advantageous resources, work together with its partners to build an industrial ecosystem, and improve the ability to resist risks arising from industry fluctuations.

INTERNAL MANAGEMENT RISKS

With continuous investment and merger and acquisition, the Group is faced with risks from incomplete management systems of its investees and failure of the systems to function normally or effectively integrate with its own systems to produce synergic effect. It will lay down practicable integration and control measures for business management, corporate governance and so forth before investing in the companies, in a bid to curb the above risks. After the investment, the Group will not only take its integration and control measures, but also gain an insight into the investees and participate in the latter's business management. It will give full play to the coordination of post-investment management at the group level on the basis of risk control to guarantee the coordinative development of its businesses.

From 2005 to 2010, Mr. Cao was an executive director and vice president of Beijing Enterprises. Mr. Cao has over 20 years of experience in the management technology and communications industry and has developed strong business relationship and networks in the industry. Mr. Cao also had been a director of Great Legend, Beijing City Railway and ERG (HK) (each a subsidiary of the Company). Mr. Cao now serves as the director of Innovation Holding Co., Ltd., CCRTT Investment and BII Zhuoyue (each a subsidiary of the Group) and has served as the director of Beijing Metro and Metro Science and Technology (each a joint venture of the Group) since February 2016. Mr. Cao is the sole director of More Legend, a substantial shareholder of the Company, and indirectly holds the shares of the Company through his 100% equity interest in More Legend. More Legend holds as to approximately 11.66% of the issued share capital of the Company. Mr. Cao also directly holds approximately 0.04% of the issued share capital of the Company as at the date of this annual report.

XUAN Jing (宣晶), Ms. Xuan, aged 47, was appointed as an executive Director on 27 June 2014 and appointed as Chief Executive Officer on 28 February 2017. Ms. Xuan graduated from Tianjin University in the PRC in July 1995 with a bachelor's degree in engineering majoring in engineering management and obtained a master's degree in business administration from Nankai University in March 2001. PRINCIPAL ACTIVITIES

The principal activity of the Company is investment holding. Details of the principal activities and other particulars of material subsidiaries are set out in Note 14 to the consolidated financial statements. None of the subsidiaries of the Company has issued debt securities.

In accordance with the Companies Act, Chapter 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands, the share premium account is distributable to the Shareholders provided that immediately following the date on which the dividend is proposed to be distributed, the Company will be able to pay its debts as they fall due in the ordinary course of business. As at 31 December 2020, the Company's reserves available for distribution amounted to approximately HK\$1,771.2 million (31 December 2019: HK\$1,813.2 million). Such amount includes the Company's share premium.

PROPERTY, PLANT AND EQUIPMENT

Details of the movements in the property, plant and equipment of the Group for FY 2020 are set out in Note 11 to the consolidated financial statements.

PRE-EMPTIVE RIGHTS

There is no provision for pre-emptive rights under the Company's articles of association (the "**Articles**") or the laws of the Cayman Islands, being the jurisdiction in which the Company was incorporated, which would oblige the Company to offer new shares on a pro-rata basis to the existing Shareholders.

FINANCIAL SUMMARY

Employees are the Group's most valuable assets. The Group actively improves the human resources system and corporate culture construction, protects the rights and interests of employees, pays attention to the reasonable demands of employees, builds a comprehensive salary system, provides high-quality training and career development opportunities, and organises various activities for employees. The Group has established good relationship with its employees throughout the year.

REMUNERATION OF SENIOR MANAGEMENT

The remuneration payable to the senior management of the Company for FY 2020 is within the range of HK\$1,000,001 to HK\$2,500,000.

SHARE OPTION SCHEME

The Share Option Scheme was approved for adoption pursuant to a written resolution of all of the Shareholders passed on 8 December 2011 for the purpose to provide the Company with a flexible means of giving incentive to, rewarding, remunerating, compensating and/or providing benefits to eligible participants and for such other purposes as the Board approves from time to time.

The Share Option Scheme was revised on 24 September 2013. It would remain in force for a period of 10 years commencing from 16 May 2012 unless terminated by the Company. As at the date of this annual report, the Share Option Scheme had a remaining life of approximately one year.

The share options granted under the Share Option Scheme must be taken up from the date on which the options are granted to such date as the Board may determine and specify in the offer letter. Upon acceptance of the option, the grantee shall pay HK\$1 to the Company as consideration for the grant.

Unless otherwise determined by the Directors or stated in the offer of the grant of options to an eligible participant, there is no minimum period required under the Share Option Scheme for the holding of an option before it can be exercised.

The exercise price of the options granted under the Share Option Scheme may be determined by the Board at its absolution discretion but in any event should be at least the highest of: (i) the closing price of the shares of the Company as stated in the Stock Exchange's daily quotation sheet on the date of offer, which must be a business day; (ii) the average closing price of the shares of the Company as stated in the Stock Exchange the Company as stated in the Stock Exchange's daily quotation sheet on the Stock Exchange's daily quotation sheet for the five business days immediately preceding the date of offer; and (iii) the nominal value of the shares of the Company.

Subject to the terms of the Share Option Scheme, the Board may, at its absolute discretion, grant or invite any person belonging to any of the following classes to take up options to subscribe for shares: (a) any employee, supplier, service provider, customer, partner or joint-venture partner of the Group (including any director, whether executive or non-executive and whether independent or not, of the Group) who is in full-time or part-time employment with the Company or any subsidiaries; and (b) any person who have contributed or may contribute to the Group. During FY 2020, no options were granted.

The maximum number of shares which may be issued upon exercise of all outstanding options granted under the Share Option Scheme and any other share option schemes of the Company must not exceed 30% of the total number of shares of the Company in issue from time to time.

The total number of shares of the Company to be issued upon exercise of all options granted and to be granted (including both exercised and outstanding options) in any 12-month period to any eligible participant shall not exceed 1% of the total issued shares of the Company unless (i) a circular is despatched to the Shareholders; (ii) the Shareholders approve the grant of the options in excess of the 1% limit referred to in this paragraph; and (iii) the relevant eligible participant and its associates abstain from voting on such resolution.

Where any grant of options to a substantial Shareholder or an independent non-executive Director (or any of their respective close associates) will result in the total number of Shares issued and to be issued upon exercise of all options already granted and to be granted to such person under the Share Option Scheme and any other share option schemes of the Company (including options exercised, cancelled and outstanding) in any 12-month period up to and including the date of such grant:

- (i) representing in aggregate over 0.1% of the Shares in issue; and
- (ii) having an aggregate value, based on the closing price of the Shares at the date of each grant, in excess of HK\$5 million,

such further grant of options must be approved by the Shareholders. The Company must send a circular to the Shareholders. The grantee, his/her associates and all core connected persons of the Company must abstain from voting in favour at such general meeting.

As of 5 December 2019, the share options granted by the Company had all lapsed.

As at 31 December 2020, there were no outstanding share options under the Share Option Scheme.

1. Framework agreement entered into between the Company and BII

Reference is made to the announcement of the Company dated 2 August 2019 and the circular of the Company dated 30 August 2019, the Company entered into the BII Framework Agreement ("**BII Framework Agreement**") with BII on 2 August 2019 for a period commencing from 1 July 2019 and ending on 31 December 2021 (both days inclusive).

As at 2 August 2019, BII held approximately 55.12% of the Shares through its wholly-owned subsidiary, namely BII HK, thus BII is the ultimate holding company of the Company and is therefore a connected person of the Company under the Listing Rules. Thus, the transactions contemplated under the BII Framework Agreement would constitute continuing connected transactions for the Company under Chapter 14A of the Listing Rules.

Pursuant to the BII Framework Agreement, the Group agrees to provide to BII, its subsidiaries and/or its associates with the consultation and technical support services, information technology support services, technology services, technology development, software development, software procurement, hardware design and development, hardware procurement, system integration, system procurement, operations and maintenance, construction of projects and other types of ancillary services to be agreed by parties in writing from time to time (collectively, the "**BII Framework Services**") during the term of the BII Framework Agreement provided that (i) the member of the Group is awarded with the relevant contract in accordance with the stipulated procedures under the relevant PRC laws and regulations (if required); and (ii) the parties thereto negotiate at arm's length regarding the commercial terms to be set out in the individual agreements for the BII Framework Services.

Pursuant to the BII Framework Agreement, the Group and BII, its subsidiaries and/or its associates will enter into individual agreements for the provision of the BII Framework Services. Pursuant to the BII Framework Agreement, the terms (including the service fees) of the individual agreements to be entered into will be negotiated by the parties at arm's length and will be determined by the parties from time to time on normal commercial terms in the ordinary course of business. The price of the transactions contemplated under the BII Framework Agreement will be determined by government-prescribed price, or government-guided price, or tender process, or the market price, or the agreed price (as the case may be) depending on the methods as set out in the circular of the Company dated 30 August 2019. Further details regarding the BII Framework Agreement and related continuing connected transactions were set out in the announcement and the circular of the Company dated 2 August 2019 and 30 August 2019, respectively.

As (i) BII has been the ultimate controlling Shareholder of the Company; and (ii) there has been a long-standing business relationship between BII, its subsidiaries and/or its associate and the Group, the Directors consider BII, its subsidiaries and/or its associate are reliable business partners and further business cooperation will be beneficial to and provide a steady income stream to the Group.

For FY 2020, the total transaction amount carried out under the BII Framework Agreement amounted to approximately RMB137.0 million.

2. TENANCY AGREEMENTS IN RELATION TO LEASING OF PROPERTIES ENTERED INTO WITH BEIJING METRO NETWORK FOR THE YEAR ENDED 31 DECEMBER 2020

On 23 December 2019, Beijing Metro Network entered into a Tenancy Agreement (collectively, the "2020 **Metro Network Tenancy Agreements**") with BII Zhuoyue and ERG BJ (collectively, the "2020 Tenants") respectively, whereby the 2020 Tenants agreed to lease certain properties from Beijing Metro Network for a term of one year from 1 January 2020 to 31 December 2020.

The annual cap in respect of the transactions contemplated under the 2020 Metro Network Tenancy Agreements for the year ended 31 December 2020 is RMB5,924,808 (equivalent to approximately HK\$6,754,281.12), which is calculated with reference to the annual gross rent payable by the 2020 Tenants to Beijing Metro Network pursuant to the 2020 Metro Network Tenancy Agreements. The terms of the 2020 Metro Network Tenancy Agreements (together with the consideration) were determined after arm's length negotiations between the parties and after making reference to the prevailing market rates. The Directors are of the view that the transactions contemplated under the 2020 Metro Network Tenancy Agreements represent a rare opportunity for the Group to continue its constant and established operation in Beijing in prime business locations without substantial costs incurred in acquiring properties for office use. Details of the transactions contemplated under the 2020 Metro Agreements are set out in the announcement of the Company dated 23 December 2019.

As at 23 December 2019, BII HK held 1,157,634,900 shares in the Company, representing approximately 55.12% of the then existing issued share capital of the Company. BII HK is a controlling shareholder of the Company and hence a connected person of the Company. BII is the sole beneficial shareholder of BII HK and Beijing Metro Network. Accordingly, Beijing Metro Network is an associate of BII and BII HK, and therefore it is a connected person of the Company under Chapter 14A of the Listing Rules. Accordingly, the transactions contemplated under the 2020 Metro Network Tenancy Agreement constitute continuing connected transactions for the Company under the Listing Rules.

The amount of the transactions under the 2020 Metro Network Tenancy Agreements in the financial year 2020 is RMB3.3 million.

3. TENANCY AGREEMENT IN RELATION TO LEASING OF PROPERTY ENTERED INTO WITH BII TECHNICAL FOR THE YEAR ENDED 31 DECEMBER 2020

Reference is made to the announcement of the Company dated 21 September 2020 that on 21 September 2020, the tenancy agreement entered into between BII Zhuoyue and BII Technical on 18 September 2019 (the "2019 Technical Tenancy Agreement") will expire on 30 September 2020, and BII Zhuoyue and BII Technical entered into a new tenancy agreement (the "2020 Technical Tenancy Agreement"). Accordingly, BII Zhuoyue agreed to continue leasing the property from BII Technical for a term of one year from 1 October 2020 to 30 September 2021. The annual cap in respect of the transactions contemplated under the 2020 Technical Tenancy Agreement is RMB237,728.15 (equivalent to approximately HK\$271,010.09), which is the annual rent payable by BII Zhuoyue to BII Technical. The rental payment will be paid in cash quarterly after signing of the Tenancy Agreement. The Directors are of the opinion that the 2020 Technical Tenancy Agreement is beneficial for the Group to continue strengthening the cooperation with BII Technical and is entered into in the ordinary and usual course of business of the Group. The 2020 Technical Tenancy Agreement (together with the rental payment) has been entered into on normal commercial terms after arm's length negotiations between the parties, and the terms of the transactions contemplated under the 2020 Technical Tenancy Agreement (together with the rental payment) are fair and reasonable and in the interests of the Company and its shareholders as a whole. Details of the transactions contemplated under the 2020 Technical Tenancy Agreement are set out in the announcement of the Company dated 21 September 2020.

As at 21 September 2020, BII HK held 1,157,634,900 shares in the Company, representing approximately 55.12% of the then existing issued share capital of the Company. BII HK is a controlling shareholder of the Company and hence a connected person of the Company. BII is the sole beneficial shareholder of BII HK and BII Technical. Accordingly, BII Technical is an associate of BII and BII HK, and therefore it is a connected person of the Listing Rules. Accordingly, the transactions contemplated under the 2020 Technical Tenancy Agreement constitute continuing connected transactions for the Company under the Listing Rules.

The amount of the transactions under the 2019 Technical Tenancy Agreement and the 2020 Technical Tenancy Agreement in the financial year 2020 is approximately RMB191,800.

4. Tenancy agreements with Beijing Metro Network in relation to leasing of properties for the year ended 31 December 2021

On 24 December 2020, Beijing Metro Network entered into a property tenancy agreement with Litmus, whereby Litmus agreed to lease the property from Beijing Metro Network for a term of one year from 1 January 2021 to 31 December 2021.

On 25 January 2021, Beijing Metro Network entered into a property tenancy agreement with ERG BJ and BII Zhuoyue respectively, whereby each of ERG BJ and BII Zhuoyue agreed to lease a property from Beijing Metro Network, respectively, for a term from 25 January 2021 to 30 September 2021.On 25 January 2021, Beijing Metro Network entered into a property tenancy agreement with Litmus, whereby Litmus agreed to lease the property from Beijing Metro Network for a term from 1 February 2021 to 31 December 2021.

The annual cap in respect of the transactions contemplated under the tenancy agreements entered into with Beijing Metro Network in 2021 (collectively, the "**2021 Metro Network Tenancy Agreements**") for the year ended 31 December 2021 is RMB5,334,342.01 (equivalent to approximately HK\$6,356,757.37), which is calculated with reference to the annual gross rent payable by the tenants to Beijing Metro Network pursuant to the 2020 Metro Network Tenancy Agreements.

The terms of the Tenancy Agreements entered into with Beijing Metro Network (together with the consideration) in 2021 were determined after arm's length negotiations between the parties and after making reference to the prevailing market rates. The Directors are of the view that the transactions contemplated under the Tenancy Agreements entered into with Beijing Metro Network in 2021 represent a good opportunity for the Group to continue its constant and established operation in Beijing in prime business locations without substantial costs incurred in acquiring properties for office use. Details of the transactions contemplated under the Tenancy Agreements entered into with Beijing Metro Network in 2021 are set out in the announcements of the Company dated 24 December 2020 and 25 January 2021 respectively.

As at the date of the above announcements, BII HK held 1,157,634,900 shares in the Company, representing approximately 55.20% of the issued share capital of the Company at that time. BII HK is a controlling shareholder of the Company and hence a connected person of the Company. BII is the sole beneficial shareholder of BII HK and Beijing Metro Network. Accordingly, Beijing Metro Network is an associate of BII and BII HK, and therefore it is a connected person of the Company under Chapter 14A.07 of the Listing Rules. Accordingly, the transactions contemplated under the 2021 Metro Network Tenancy Agreements constitute continuing connected transactions for the Company under Chapter 14A of the Listing Rules.

The Company's auditor was engaged to report on the Group's continuing connected transactions in accordance with Hong Kong Standard on Assurance Engagement 3000 (Revised), *Assurance Engagements other than Audits or Reviews of Historical Financial Information* and with reference to Practice Note 740, *Auditor's Letter on Continuing Connected Transactions under the Hong Kong Listing Rules*, issued by Hong Kong Institute of Certified Public Accountants. The auditor has issued their unqualified letter containing the auditor's findings and conclusions in respect of the continuing connected transactions disclosed by the Group in accordance with the Listing Rules 14A.56. A copy of the auditor's letter has been provided by the Company to the Stock Exchange.

The independent non-executive Directors have confirmed that the continuing connected transactions are in accordance with Rule 14A.55 of the Listing Rules. Specifically, the independent non-executive Directors confirmed that the continuing connected transactions entered into by the Group were in the ordinary and usual course of its business, on normal commercial terms or on terms no less favourable than those available to or from independent third parties, and in accordance with the terms of the agreement governing such transactions that are fair and reasonable and in the interests of the Shareholders as a whole.

The Board confirms that the Company has complied with the applicable disclosure requirements in accordance with Chapter 14A of the Listing Rules in respect of each of the connected transactions set out above.

Details of material related party transactions entered into by the Group are set out in Note 31 to the consolidated financial statements. Except for those described under the paragraphs headed "Continuing connected transactions" above, in respect of which the disclosure requirements in accordance with Chapter 14A of the Listing Rules have been complied with, none of those related party transactions constitutes a discloseable connected transaction as defined under the Listing Rules.

EVENTS AFTER THE REPORTING PERIOD

Save for the events described under the paragraphs headed "Significant investments held and future plans" and "Final dividend" in this annual report, there is no other material events after the reporting period as at the date of this report.

SUFFICIENCY OF PUBLIC FLOAT

Based on the information that is publicly available to the Company and within the knowledge of the Directors, during FY 2020 and until the date of this annual report, there is sufficient public float of more than 25% of the Company's issued shares as required under the Listing Rules.

TAX RELIEF AND EXEMPTION

The Directors are not aware of any tax relief and exemption available to the Shareholders by reason of their holding of the Company's listed securities.

DONATIONS

During FY 2020, the donation of the Group was approximately HK\$1,198,600 (FY 2019: HK\$34,100).

EQUITY-LINKED AGREEMENTS

Save for the Share Option Scheme as disclosed on pages 36 to 37 of this annual report, no equity-linked agreements were entered into by the Company, or existed during FY 2020.

DIRECTORS' PERMITTED INDEMNITY PROVISION

Under the Articles, every Director or other officer of the Company shall be entitled to be indemnified out of the assets of the Company against all losses or liabilities incurred or sustained by him as a Director or other officer of the Company in defending any proceedings, whether civil or criminal, in which judgment is given in his favour, or in which he is acquitted.

The Company has arranged appropriate directors' and officers' liability insurance coverage for the Directors and officers of the Group.

ENVIRONMENTAL, SOCIAL AND GOVERNANCE

The Group recognises its responsibility to protect the environment when conducting its business activities. The Group continually seeks to identify and manage environmental impacts attributable to its operational activities in order to minimise these impacts if possible. The Board is pleased to present the Corporate Governance Report for FY2020.

CORPORATE GOVERNANCE PRACTICES

The Board believes that maintaining high standard of corporate governance practices is crucial to safeguarding shareholders' and stakeholders' interests, formulating business strategies and policies as well as enhancing corporate value, transparency and accountability.

The Company has in place a corporate governance framework and has established a set of policies and procedures based on the Corporate Governance Code contained in Appendix 14 of the Listing Rules (the "**CG Code**"). Such policies and procedures provide the infrastructure for enhancing the Board's ability to implement governance and exercise proper oversight on business conduct and affairs of the Company.

The Company has adopted the principles and code provisions of the CG Code as the basis of the Company's corporate governance practices and has devised its own code of corporate governance based on the major principles and practices as set out in the CG Code. For FY 2020, the Company was in compliance with all the CG Code.

BOARD OF DIRECTORS

The Company is headed by an effective Board which oversees the Group's businesses, strategic decisions and performance and takes decisions objectively in the best interests of the Company.

The Board should regularly review the contribution required from a Director to perform his/her responsibilities to the Company, and whether the Director is spending sufficient time performing them.

Board Composition

The Board currently has nine Directors, comprising two executive Directors, four non-executive Directors and three independent non-executive Directors. Details of the Board composition are set out below:

The biographical information of the Directors are set out in the section headed "Biographical details of Directors and senior management" on pages 26 to 31 of this annual report. None of the members of the Board is related to one another.

Chairman and Chief Executive Officer

The roles of the Chairman and Chief Executive Officer are segregated and held by Mr. Zhang Yanyou and Ms. Xuan Jing, respectively, to ensure their respective independence, accountability and responsibility. The Chairman provides leadership and is responsible for the Group's strategic planning and the management of the operations of the Board, while the Chief Executive Officer is responsible for carrying out the policies of the Board, takes the lead in the Group's operations and business development, and focuses on the daily management and operations generally. There is a clear division of responsibilities between the Chairman and Chief Executive Officer which provides a balance of power and authority.

Independent non-executive Directors

The Board consists of at least three independent non-executive Directors representing one-third of the Board with at least one independent non-executive Director possessing appropriate professional qualifications, or accounting or related financial management expertise at all times during FY 2020.

The Company has received written annual confirmation from each independent non-executive Director in respect of his independence in accordance with the independence guidelines set out in Rule 3.13 of the Listing Rules. The Company considers that all independent non-executive Directors are independent.

Appointment and re-election of Directors

Each of the executive Directors has entered into a service agreement with the Company for a term of three years which can be terminated by either party by giving to the other not less than one month's prior written notice. Each of the non-executive Directors (including independent non-executive Directors) has entered into a letter of appointment with the Company for a fixed term of three years which can be terminated by the Company by not less than three months' prior written notice.

According to Article 16.2 of the Articles, the Board shall have power from time to time and at any time to appoint any person as a Director either to fill a casual vacancy or as an addition to the Board. Any Director so appointed shall hold office only until the next following annual general meeting of the Company and shall then be eligible for re-election at that meeting.

According to Article 16.3 of the Articles, the Company may from time to time increase or reduce the number of Directors in general meeting by ordinary resolution but so that the number of Directors shall not be less than two. Subject to the provisions of these Articles and the Companies Act Cap. 22 of the Cayman Islands, the Company may by ordinary resolution elect any person to be a Director either to fill a casual vacancy or as an addition to the existing Directors. Any Director so appointed shall hold office only until the next following annual general meeting of the Company and shall then be eligible for re-election thereat.

According to Article 16.18 of the Articles, at every annual general meeting of the Company, one-third of the Directors for the time being, or, if their number is not three or a multiple of three, then the number nearest to but not less than one-third, shall retire from office by rotation provided that every Director (including those appointed for a specific term) shall be subject to retirement by rotation at least once every three years. Any Director appointed pursuant to Article 16.2 or 16.3 of the Articles shall not be taken into account in determining which Directors are to retire by rotation. A retiring Director shall retain office until the close of the meeting at which he retires and shall be eligible for re-election thereat.

RESPONSIBILITIES, ACCOUNTABILITIES AND CONTRIBUTIONS OF THE BOARD AND MANAGEMENT

The Board has overall responsibility for the leadership and control of the Group, including the responsibilities for the formulation of long-term strategies, and appointing and supervising senior management to ensure that the operation of the Company is conducted in accordance with the objective of the Group; and is collectively responsible for directing and supervising the Group's affairs.

The Board directly, and indirectly through its committees, monitors the Group's operational and financial performance, and ensures that sound internal control and risk management systems are in place.

The Board reserves for its decision all major matters relating to policy matters, strategies and budgets, internal control and risk management, material transactions (in particular those that may involve conflict of interests), financial information, appointment of directors and other significant operational matters of the Group. Responsibilities relating to implementing decisions of the Board, directing and co-ordinating the daily operation and management of the Group are delegated to the management.

The independent non-executive Directors are responsible for ensuring a high standard of regulatory reporting of the Company and providing a balance in the Board for bringing effective independent judgement on corporate actions and operations.

All Directors, including non-executive Directors and independent non-executive Directors, have brought a wide spectrum of valuable business experience, knowledge and professionalism to the Board for its efficient and effective functioning.

All Directors may, upon request, seek independent professional advice in appropriate circumstances at the Company's expenses for discharging their duties to the Company.

The Directors shall disclose to the Company details of other offices held by them and the Board regularly reviews the contribution required from each Director to perform his/her responsibilities to the Company.

BOARD MEETINGS

The Board meets regularly (at least four times a year) to discuss and approve the overall strategies and policies, monitor the financial and operational performance, review corporate governance practices, consider and approve the financial results as well as other significant matters of the Group. Additional meetings are convened as and when the Board considers necessary. In case where conflict of interest arises involving a substantial shareholder or a Director, such matter will not be dealt with by written resolutions. Independent non-executive Directors with no conflict of interest will deal with such issues involving conflict of interest.

A tentative schedule for regular Board meetings for each year is provided to Directors at the beginning of each calendar year. Notice of at least 14 days will be given to all Directors for all regular Board meetings and the Directors can include matters for discussion in the agenda if necessary. Agenda and accompanying Board papers in respect of regular Board meetings are sent out in full to all Directors within 7 days and at least 3 days before the meeting. Draft minutes of all Board meetings are circulated to Directors for comment within a reasonable time prior to confirmation.

All Directors have access to Board papers and related materials, and are provided with adequate information on a timely manner, which enable the Board to make an informed decision on matters placed before it.

On 25 December 2018, the Board adopted the further revised written terms of reference which became effective on the same date. The written terms of reference of the Audit Committee were adopted in compliance with code provisions C.3.3 and C.3.7 of the CG Code.

The primary duties of the Audit Committee, among other things, are (i) to make recommendations to the Board on the scope of audit and appointment, re-appointment and removal of external auditor; (ii) review the financial statements and material advice in respect of financial reporting; (iii) oversee internal control and risk management systems of the Company; and (iv) review the effectiveness of the internal audit function and arrangements to enable employees of the Company to raise concerns about possible improprieties in financial reporting, internal control or other matters of the Company.

The Company recognises and embraces the benefits of having a diverse Board and sees increasing diversity at the Board level as an essential element in maintaining the Company's competitive advantage.

Pursuant to the Board Diversity Policy, the Nomination Committee will review annually the structure, size and composition of the Board and where appropriate, make recommendations on changes to the Board to complement the Company's corporate strategy and to ensure that the Board maintains a balanced diverse profile. In relation to reviewing and assessing the Board composition, the Nomination Committee is committed to maintaining diversity at all levels and will consider the measurable objectives, including but not limited to gender, age, cultural and educational background, professional qualifications, skills, knowledge and industry and regional experience.

The Company aims to maintain an appropriate balance of diversity perspectives of the Board that are relevant to the Company's business growth and is also committed to ensuring that selection and nomination of Board positions are appropriately structured so that a diverse range of candidates are considered.

The Board will consider setting measurable objectives to implement the Board Diversity Policy and review such objectives from time to time to ensure their appropriateness and ascertain the progress made towards achieving those objectives.

At present, the Nomination Committee considered an appropriate balance of diversity perspectives of the Board is maintained and has achieved the measurable objectives in implementing the Board Diversity Policy.

The Nomination Committee will review the Board Diversity Policy, as appropriate and on a regular basis, to ensure its continued effectiveness.

DIRECTOR NOMINATION POLICY

The Board has delegated its responsibilities and authority for selection and appointment of Directors to the Nomination Committee of the Company. Without prejudice to the authority and duties of the Nomination Committee as set out in its terms of reference, the ultimate responsibility for selection and appointment of Directors of the Company rests with the entire Board.

The Company has adopted a director nomination policy ("**Director Nomination Policy**") which sets out the selection criteria and process and the Board succession planning considerations in relation to nomination and appointment of Directors of the Company and aims to ensure that the Board has a balance of skills, experience and diversity of perspectives appropriate to the Company and the continuity of the Board and appropriate leadership at Board level.

The Director Nomination Policy sets out the factors for assessing the suitability and the potential contribution to the Board of a proposed candidate, including but not limited to the following:

- Character and integrity;
- Qualifications including professional qualifications, skills, knowledge and experience that are relevant to the Company's business and corporate strategy;
- Diversity aspects under the Board Diversity Policy, including but not limited to gender, age, cultural and educational background, professional qualifications, skills, knowledge and industry and regional experience;
- Requirements of independent non-executive Directors on the Board and independence of the proposed independent non-executive Directors in accordance with the Listing Rules; and
- Commitment in respect of available time and relevant interest to discharge duties as a member of the Board and/ or Board committee of the Company.

The Director Nomination Policy also sets out the procedures for the selection and appointment of new Directors and re-election of Directors at general meetings and the recommendations to be made by the Nomination Committee and the Board in these respects. During FY 2020, there was no change in the composition of the Board.

The Nomination Committee will conduct regular review on the Director Nomination Policy, as appropriate, to ensure its effectiveness.

CORPORATE GOVERNANCE FUNCTIONS

The Board is responsible for performing the functions set out in code provision D.3.1 of the CG Code.

The Board determines the Company's corporate governance policies and performs corporate governance duties set out in the CG Code. Its corporate governance duties include, among others, (i) to develop and review the Company's policies and practices on corporate governance; (ii) to review and monitor the training and continuous professional development of Directors and senior management; (iii) to review and monitor the Company's policies and practices on compliance with legal or regulatory requirements; and (iv) to review the Company's compliance with the CG Code and disclosure in the Corporate Governance Report.

DIRECTORS' SECURITIES TRANSACTIONS

The Company has devised the Securities Dealing Code on terms no less exacting than the required standard of dealings set out in the Model Code. The Company customarily issues notices to its Directors reminding them of the general prohibition on dealing in the Company's listed securities during the blackout periods before the publication of announcements of financial results. Having made specific enquiry of the Directors, all the Directors confirmed that they have complied with the required standards set out in the Securities Dealing Code and the Model Code throughout FY 2020. The Securities Dealing Code also applies to employees to whom the Securities Dealing Code was given. The Company was not aware of any non-compliance of the Model Code for FY 2020.

DIRECTORS' AND OFFICERS' LIABILITIES

The Company has arranged for appropriate insurance covering the liabilities of the Directors and officers in respect of any legal actions taken against the Directors and officers that may arise out of the corporate activities. The insurance coverage will be reviewed on an annual basis.

CONTINUOUS PROFESSIONAL DEVELOPMENT OF DIRECTORS

Directors shall keep abreast of regulatory developments and changes in order to effectively perform their responsibilities and to ensure that their contribution to the Board remains informed and relevant.

Induction materials and relevant guideline materials regarding the duties and responsibilities of being a director, the relevant laws and regulations applicable to directors, duty of disclosure of interests and business in the Group will be provided to newly appointed Directors shortly upon their appointment as Directors to ensure appropriate understanding of the business and operations of the Group and full awareness of director's responsibilities and obligations under the Listing Rules and relevant statutory requirements. Continuing briefings and professional development to Directors will be arranged when necessary. All Directors are encouraged to attend relevant training courses at the Company's expenses.

During FY 2020, the Company organised two training sessions for all the Directors on the Listing Rules and the relevant guidances. All Directors attended the trainings.

RISK MANAGEMENT AND INTERNAL CONTROLS

The Board acknowledges its responsibility for the risk management and internal control systems and reviewing their effectiveness in order to safeguard the interests of the Shareholders and the assets of the Company against unauthorised use or disposition, ensuring maintenance of proper books and records for the provision of reliable financial information, and ensuring compliance with the relevant rules and regulations. Such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

The Board has the overall responsibility for evaluating and determining the nature and extent of the risks it is willing to take in achieving the Company's strategic objectives, and establishing and maintaining appropriate and effective risk management and internal control systems.

The Audit Committee assists the Board in leading the management and overseeing the design, implementation and monitoring of the risk management and internal control systems.

The Company has developed and adopted various risk management procedures and guidelines with defined authority for implementation by key business processes and office functions, including project management, sales and leasing, financial reporting, human resources and information technology.

The Company's risk management and internal control systems have been developed with the following principles, features and processes:

In compliance with the requirement of CG Code, the Company has established relevant risk management and internal control systems, covering corporate governance and system, business and financial processes. The systems served as a reasonable guarantee of the legal compliance of the operation and management of the Company, its asset security and truthfulness and completeness of its financial reports and relevant information and increased the operational efficiency and performance of the Company, which provided strong guarantee for the implementation of the Company's development strategies.

In order to further regulate the internal control management of the Company and effectively prevent internal risks, the "Internal Control Handbook of BII Railway Transportation Technology Holdings Company Limited" was prepared according to the "Guidelines for Corporate Internal Control", which was jointly issued by five ministries and commissions including the Ministry of Finance as well as the relevant regulatory requirements of the Stock Exchange and the actual management situation of the Company. The internal control system of the Company regulates the internal management procedure of the Company by fifteen controlling aspects, namely organisational structure, fund management, financial reporting, procuring business, outsourcing business, sales business, research and development management, project management, contract management, information system, human resources, budget management, financing management, equity investment management and fixed assets management. It identifies the risks in the internal management of the Company and provides relevant control measures to prevent the risks. The Company performs annual reviews on these systems in order to monitor its operational situation in a timely manner, and revises or abolishes some regulations in accordance with relevant national laws and regulations and actual conditions of the Company.

Corporate Governance Report (continued)

All departments conducted internal control assessment regularly to identify risks that potentially impact the business of the Group and various aspects including key operational and financial processes, regulatory compliance and information security. Self-evaluation has been conducted annually to ensure that control policies are properly complied with by each department.

The Company has set up departments dedicated to daily examination and supervision of internal control, and designated internal control examination and supervision personnel according to the relevant requirements and conditions of the Company to inspect and monitor the regular test on internal control procedures of all functional departments of the Company and all subsidiaries. The Company mainly reviews the compliance of internal control procedures that have higher risk, such as setting up of project, tendering, project budget review and procurement to ensure the compliance of business activities. The Company makes improvement recommendations in respect of audit's findings and requests the relevant management of the Company to confirm the rectification plan, methods and the timing. The Company regularly follows up the status of the implementation of the audit recommendations to ensure the execution of such improvement plans. At the same time, the Company reviews and assesses the truthfulness, accuracy, compliance and effectiveness of the project financial activities of the Company and information of financial expenses as well as the Company's funds, management and usage of assets, and strictly monitors the annual budget and expenditure.

The management of the Company provides enough resources for the accounting, internal review and financial reporting functions, hires financial personnel with sufficient qualifications and provides various financial control and project risk control training to the staff. The management, in coordination with all department heads, assesses the likelihood of risk occurrence and provides response plans, and monitors the risk management procedures, and reports to the Audit Committee and the Board on all findings and the effectiveness of the system. Internal legal and audit department is responsible for reviewing the adequacy and effectiveness of risk management and internal control system independently, investigates key matters related to accounting practice and all significant control issues, and reports its finding and suggestions for improvement to the Audit Committee.

On the basis of its established internal control system, the Company regularly reviewed and sorted out the overall operation of the internal control system in accordance with the Basic Standard for Enterprise Internal Control and supporting guidelines, its Internal Control Management Handbook and relevant rules, and compiled the Internal Control System Evaluation Report. The Company identified and sorted out risks and deficiencies during the operation of the internal control system in a timely manner through ways such as individual interviews, system reviews, data inspections, and walk-through tests and put forward corresponding rectification suggestions. It formulated the Internal Control System Evaluation Results and Rectification Plan, and followed up and supervised related divisions' rectifications.

The management has confirmed to the Board and the Audit Committee on the effectiveness of the risk management and internal control systems for FY 2020.

The Board, as supported by the Audit Committee and with the management report and the internal audit findings, reviewed the risk management and internal control systems including the financial, operational and compliance controls for FY 2020, and considered that such systems are effective and adequate. The annual review also covered the financial reporting and internal audit function and staff qualifications, experiences and relevant resources of the Company.



Whistleblowing procedures are in place to facilitate employees of the Company to raise, in confidence, concerns about possible improprieties in financial reporting, internal control or other matters of the Company.

The Company has developed its disclosure policy which provides a general guide to the Directors, the Company's officers, senior management and relevant employees in handling confidential information, monitoring information disclosure and responding to enquiries. Control procedures have been implemented to ensure that unauthorised access and use of inside information are strictly prohibited.

DIRECTORS' RESPONSIBILITY FOR THE FINANCIAL STATEMENTS

The Directors acknowledge their responsibilities for the preparation of the financial statements of the Company for FY 2020 and ensure that the financial statements are prepared in accordance with applicable statutory requirements and financial reporting standards. Appropriate accounting policies have been used and applied consistently, and reasonable and prudent judgements and estimates have been made.

Having made appropriate enquiries, the Board is not aware of any material uncertainties relating to events or conditions which may cast significant doubt over the Company's ability to continue as a going concern. Accordingly, the Board has continued to adopt the going concern basis in preparing the financial statements.

The statement of the external auditors of the Company regarding their reporting responsibilities on the financial statements of the Group is set out in the Independent Auditor's Report on pages 65 to 74 of this annual report.

Independent Auditor's Report



Independent auditor's report to the Shareholders of BII Railway Transportation Technology Holdings Company Limited (Incorporated in the Cayman Islands with limited liability)

OPINION

We have audited the consolidated financial statements of BII Railway Transportation Technology Holdings Company Limited (the "Company") and its subsidiaries (the "Group") set out on pages 75 to 156, which comprise the consolidated statement of financial position as at 31 December 2020, the consolidated statement of profit or loss, the consolidated statement of profit or loss and other comprehensive income, the consolidated statement of changes in equity and the consolidated cash flow statement for the year then ended and notes to the consolidated financial statements, including a summary of significant accounting policies.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 December 2020 and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with International Financial Reporting Standards ("IFRSs") issued by the International Accounting Standards Board (the "IASB") and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

BASIS FOR OPINION

We conducted our audit in accordance with Hong Kong Standards on Auditing ("HKSAs") issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA"). Our responsibilities under those standards are further described in the *Auditor's responsibilities for the audit of the consolidated financial statements* section of our report. We are independent of the Group in accordance with the HKICPA's *Code of Ethics for Professional Accountants* (the "Code") together with any ethical requirements that are relevant to our audit of the consolidated financial statements in the Cayman Islands, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

KEY AUDIT MATTERS

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

Recognition of contract revenue

Refer to Note 4 to the consolidated financial statements and the accounting policies in Note 2(u)(i).

The Key Audit Matter

The Group's business involves entering into contractual O relationships with customers to provide a range of reservices, including provision of design, production, implementation and sale, and maintenance of application solutions for the networking and controlling systems of public transport and other companies, the provision of civil communication transmission services, and design, implementation and sale of related software, hardware and spare parts in utility tunnel areas.

A significant proportion of the Group's revenue and profits is derived from long term contracts, most of which are fixed price contracts.

The recognition of revenue on long term contracts is based on the stage of completion of work performed on a contract at the reporting date. The recognition of revenue for an incomplete project is dependent on estimating the total outcome of the contract as well as the work performed to date.

Forecasting the outcome of a contract involves the exercise of significant management judgement. Errors in contract forecasts could result in a material variance in the amount of profit or loss recognised to date and therefore also in the current period.

How the matter was addressed in our audit

Our audit procedures to assess the recognition of contract revenue included the following:

- obtaining an understanding of and assessing the design, implementation and operating effectiveness of key internal controls over the recognition of contract revenue, including the controls over recording work done, invoicing and cash receipts;
- selecting a sample of contracts, using a variety of quantitative and qualitative criteria, and performing the following procedures for each contract selected:

Recognition of contract revenue (continued)

The Key Audit Matter

We identified the recognition of contract revenue as a key audit matter because contract revenue accounts for a significant proportion of the Group's revenue and because the recognition of contract revenue involves a significant degree of management judgement in assessing factors which can be inherently uncertain and may be subject to management bias.

How the matter was addressed in our audit

- challenging the underlying judgements of senior operational and financial management personnel in their estimations of total estimated contract costs and estimated costs to complete the contract where it was still in progress at the reporting date by comparing their estimates with relevant underlying documentation, including suppliers' quotations and agreed contracts;
- comparing items recorded as contract costs during the year with suppliers' contracts, goods receipt notes and other relevant underlying documentation;
- agreeing total contract revenue to the contracted terms;
- recalculating the percentage of completion based on contract costs occurred up to the reporting date and estimated total contract costs; and
- recalculating revenue recognised to date, based on total contract revenue and the percentage of completion.
- on a sample basis, comparing management's estimated costs to complete selected contracts at the end of the previous financial year with actual costs incurred during the current year and enquiring of the management about any significant variances identified; and
- performing site visits to a sample of major contracts in progress at the reporting date and discussing with site project managers and engineers the stage of completion, services provided and goods delivered.

We identified assessing loss allowances for trade • receivables and contract assets as a key audit matter because of the significance of the balances of trade receivables and contract assets to the consolidated financial statements and because of the significant management judgement required in estimating the loss allowances at the reporting date, which can be inherently uncertain.

How the matter was addressed in our audit

The Group's operations gave rise to significant trade Our audit procedures to assess the loss allowances

- obtaining an understanding of and assessing the design, implementation and operating effectiveness of key internal controls relating to credit control, debt collection and estimating loss allowances for trade receivables and contract assets:
- comparing, on a sample basis, the categorisation of trade receivables and contract assets in the ageing report with invoices issued, contract terms, contract progress reports and other relevant underlying documentation;
- obtaining an understanding on the key data and assumptions of the expected credit loss model adopted by the management, including the basis of the segmentation of the accounts receivable based on credit risk characteristics, the historical default data, and the assumptions involved in management's estimated loss rate;
- assessing the reasonableness of management's loss allowance estimates by examining the information used by management to form such judgements, including testing the accuracy of the historical default data and evaluating whether the historical loss rates are appropriately adjusted based on current economic conditions and forward-looking information; and
- inspecting cash receipts, on a sample basis, from customers subsequent to the financial year end relating to trade receivables and contract assets balances as at 31 December 2020.

Assessing potential impairment of goodwill and intangible assets

- evaluating management's identification of CGUs and the amounts of goodwill and intangible assets allocated to those CGUs;
- evaluating the methodology used by management in its preparation of the discounted cash flow forecasts with reference to the requirements of the prevailing accounting standards;
- evaluating the discount rates applied in the discounted cash flow forecasts by assessing whether they were within the range of those adopted by other companies in the same industry;
- assessing and challenging the key assumptions adopted by management in its discounted cash flow forecasts, which included the value of contracts still to be delivered to customers, the expected timetable for those contracts, contract prices and estimated costs, with reference to historical profit margins of the individual CGUs, the financial budgets approved by the directors and our expectations based on our knowledge of the industry in which the Group operates;

The Key Audit Matter

The value-in-use was determined by preparing • discounted cash flow forecasts of the relevant CGUs. This involves a significant degree of management judgement, particularly in determining the key assumptions adopted, which include the value of contracts still to be delivered to customers, the expected timetable for those contracts, contract prices, estimated costs and the discount rates • applied.

We identified assessing potential impairment of goodwill and intangible assets as a key audit matter because the impairment assessment of these assets involves a significant degree of management judgement in relation to the key assumptions adopted in the impairment assessment models some of which are inherently uncertain and may be subject to management bias.

How the matter was addressed in our audit

- performing a retrospective review of the prior year's discounted cash flow forecasts and comparing the forecast revenue and profit with the current year's actual results to assess the reliability of management's forecasting process;
- obtaining from management sensitivity analyses of the key assumptions, which include the value of contracts still to be delivered to customers, the expected timetable for those contracts, contract prices, estimated costs and the discount rates applied, adopted in the discounted cash flow forecasts and assessing the impact on the conclusion of the impairment assessment, the impairment charge for the year, and whether there were any indicators of management bias; and

We identified valuation of contingent considerations and cash-settled share-based transaction as a key audit matter because the valuation of the liability involves a significant degree of management judgement in relation to the key assumptions adopted in the valuation models some of which are inherently uncertain and may be subject to management bias.

How the matter was addressed in our audit

As at 31 December 2020, the fair value of contingent Our audit procedures to assess the valuation of contingent considerations payable and liability arising from the cashsettled share-based transaction included the following:

- evaluating the methodology used by management in its preparation of the valuation with reference to the requirements of the prevailing accounting standards;
- assessing and challenging the key assumptions and inputs adopted by management in its valuation model as at 31 December 2020; and
- considering the disclosures in the consolidated financial statements in respect of the fair value measurement of the contingent considerations and put-options in connection with cash-settled sharebased transaction with reference to the requirements of the prevailing accounting standards.

1 CORPORATE INFORMATION

BII Railway Transportation Technology Holdings Company Limited (the "Company") was incorporated in the Cayman Islands on 7 January 2011 as an exempted company with limited liability under the Companies Law (2011 Revision), Chapter 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands. The shares of the Company were listed on the Growth Enterprise Market (the "GEM") of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") on 16 May 2012. The listing of the Company's shares was transferred from the GEM to the Main Board of the Stock Exchange on 6 December 2013. The consolidated financial statements of the Company as at and for the year ended 31 December 2020 comprise the Company and its subsidiaries (collectively referred to as the "Group") and the Group's interests in joint ventures and associates. The principal activities of the Group are the design, production, implementation and sale, and maintenance of application solutions for the networking and controlling systems of public transport and other companies, the provision of civil communication transmission services, as well as design, implementation and sale of related software, hardware and spare part in utility tunnel areas, and the investment in the railway transportation areas and infrastructure areas through investing in equity.

2 SIGNIFICANT ACCOUNTING POLICIES

(a) Statement of compliance

These financial statements have been prepared in accordance with all applicable International Financial Reporting Standards ("IFRSs"), which collective term includes all applicable individual International Financial Reporting Standards, International Accounting Standards ("IASs") and Interpretations issued by the International Accounting Standards Board (the "IASB") and the applicable disclosure requirements of the Hong Kong Companies Ordinance. These financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on the Stock Exchange (the "Listing Rules"). Significant accounting policies adopted by the Group are disclosed below.

The IASB has issued certain new and revised IFRSs that are first effective or available for early adoption for the current accounting period of the Group. Note 2(c) provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current accounting period reflected in these financial statements.

(b) Basis of preparation of the financial statements

The consolidated financial statements for the year ended 31 December 2020 comprise the Group and the Group's interests in joint ventures and associates.

The measurement basis used in the preparation of the financial statements is the historical cost basis except that the following assets are stated at their fair value as explained in the accounting policies set out below:

- investments in debt investments (see Note 2(i));
- contingent considerations, and
- options

2 SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

(b) Basis of preparation of the financial statements (continued)

The preparation of financial statements in conformity with IFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgements made by management in the application of IFRSs that have significant effect on the financial statements and major sources of estimation uncertainty are discussed in Note 3.

(c) Changes in accounting policies

The Group has applied the following amendments to IFRSs issued by the IASB to these financial statements for the current accounting period:

- Amendments to IFRS 3, Definition of a Business
- Amendments to IFRS 9, IAS 39 and IFRS 7, Interest Rate Benchmark Reform
- Amendments to IAS 1 and IAS 8, Definition of material
- Amendment to IFRS 16, Covid-19-Related Rent Concessions

Other than the amendment to IFRS 16, the Group has not applied any new standard or interpretation that is not yet effective for the current accounting period.

None of these developments have had a material effect on how the Group's results and financial position for the current or prior periods have been prepared or presented.

(d) Subsidiaries and non-controlling interests

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power, only substantive rights (held by the Group and other parties) are considered.

An investment in a subsidiary is consolidated into the consolidated financial statements from the date that control commences until the date that control ceases. Intra-group balances, transactions and cash flows and any unrealised profits arising from intra-group transactions are eliminated in full in preparing the consolidated financial statements. Unrealised losses resulting from intra-group transactions are eliminated in the same way as unrealised gains but only to the extent that there is no evidence of impairment.

Non-controlling interests represent the equity in a subsidiary not attributable directly or indirectly to the Company, and in respect of which the Group has not agreed any additional terms with the holders of those equity interests which would result in the Group as a whole having a contractual obligation in respect of those equity interests that meets the definition of a financial liability. For each business combination, the Group can elect to measure any non-controlling interests either at fair value or at their proportionate share of the subsidiary's net identifiable assets.

Non-controlling interests are presented in the consolidated statement of financial position within equity, separately from equity attributable to the equity shareholders of the Company. Non-controlling interests in the results of the Group are presented on the face of the consolidated statement of profit or loss and the consolidated statement of profit or loss and other comprehensive income as an allocation of the total profit or loss and total comprehensive income for the year between non-controlling interests and the equity shareholders of the Company.

Changes in the Group's interests in a subsidiary that do not result in a loss of control are accounted for as equity transactions, whereby adjustments are made to the amounts of controlling and non-controlling interests within consolidated equity to reflect the change in relative interests, but no adjustments are made to goodwill and no gain or loss is recognised.

When the Group loses control of a subsidiary, it is accounted for as a disposal of the entire equity interest in that subsidiary, with a resulting gain or loss being recognised in profit or loss. Any equity interest retained in that former subsidiary at the date when control is lost is recognised at fair value and this amount is regarded as the fair value on initial recognition of a financial asset or, when appropriate, the cost on initial recognition of an investment in an associate or joint venture (see Note 2(e)).

In the Company's statement of financial position, an investment in a subsidiary is stated at cost less impairment losses (see Note 2(k)(ii)), unless the investment is classified as held for sale.

2 SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

(e) Associates and joint ventures

An associate is an entity in which the Group or the Company has significant influence, but not control or joint control, over its management, including participation in the financial and operating policy decisions.

A joint venture is an arrangement whereby the Group or the Company and other parties contractually agree to share control of the arrangement, and have rights to the net assets of the arrangement.

An investment in an associate or a joint venture is accounted for in the consolidated financial statements under the equity method, unless it is classified as held for sale. Under the equity method, the investment is initially recorded at cost, adjusted for any excess of the Group's share of the acquisition-date fair values of the investee's identifiable net assets over the cost of the investment (if any). The cost of the investment includes purchase price, other costs directly attributable to the acquisition of the investment, and any direct investment into the associate or joint venture that forms part of the Group's equity investment. Thereafter, the investment is adjusted for the post acquisition change in the Group's share of the investee's net assets over cost, the Group's share of the post-acquisition, post-tax results of the investees and any impairment losses for the year are recognised in the consolidated statement of profit or loss, whereas the Group's share of the post-acquisition post-tax items of the investees' other comprehensive income is recognised in the consolidated statement of profit or loss.

When the Group's share of losses exceeds its interest in the associate or joint venture, the Group's interest is reduced to nil and recognition of further losses is discontinued except to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the investee. For this purpose, the Group's interest is the carrying amount of the investment under the equity method together with any other long-term interests that in substance form part of the Group's net investment in the associate or joint ventures (after applying the expected credited losses ("ECLs") model to such other long-term interests where applicable).

Unrealised profits and losses resulting from transactions between the Group and its associates and joint ventures are eliminated to the extent of the Group's interests in the investees, except where unrealised losses provide evidence of an impairment of the asset transferred, in which case they are recognised immediately in profit or loss.

If an investment in an associate becomes an investment in a joint venture or vice versa, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method.

In all other cases, when the Group ceases to significant influence over an associate or joint control over a joint venture, it is accounted for as a disposal of the entire interest in that investee, with a resulting gain or loss being recognised in profit or loss. Any interest retained in that former investee at the date when joint control is lost is recognised at fair value and this amount is regarded as the fair value on initial recognition of a financial asset.

In the Company's statement of financial position, investment in associates and joint venture are stated at cost less impairment losses (see Note 2(k)(ii)), unless classified as held for sale.

(f) Goodwill

Goodwill represents the excess of:

- (i) the aggregate of the fair value of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value of the Group's previously held equity interests in the acquiree; over
- (ii) the net fair value of the acquiree's identifiable assets and liabilities measured as at the acquisition date.

When (ii) is greater than (i), then this excess is recognised immediately in profit or loss as a gain on a bargain purchase.

Goodwill is stated at cost less accumulated impairment losses (see Note 2(k)(ii)). Goodwill arising on a business combination is allocated to each cash-generating unit, or groups of cash generating units, that is expected to benefit from the synergies of the combination and is tested annually for impairment (see Note 2(k)(ii)).

On disposal of a cash generating unit during the year, any attributable amount of purchased goodwill is included in the calculation of the profit or loss on disposal.

(g) Property, plant and equipment

The following items of property, plant and equipment are stated in the statement of financial position at cost less accumulated depreciation and impairment losses (see Note 2(k)(ii)).

- right-of-use assets arising from leases over leasehold properties where the Group is not the registered owner of the property interest; and
- items of plant and equipment, including right-of-use assets arising from leases of underlying plant and equipment (see Note 2(j)).

Gains or losses arising from the retirement or disposal of an item of property, plant and equipment are determined as the difference between the net disposal proceeds and the carrying amount of the item and are recognised in profit or loss on the date of retirement or disposal.

The cost of replacing part of an item of property, plant and equipment is recognised in the carrying amount of the item if it is probable that the future economic benefits embodied within the part will flow to the Group and its cost can be measured reliably. The costs of the day-to-day servicing of property, plant and equipment are recognised in profit or loss as incurred.

2 SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

(g) Property, plant and equipment (continued)

Depreciation is calculated to write off the cost of items of property, plant and equipment, less their estimated residual values, if any, using the straight line method over their estimated useful lives as follows:

Where parts of an item of property, plant and equipment have different useful lives, the cost of the item is allocated on a reasonable basis between the parts and each part is depreciated separately. Both the estimated useful life of an asset and its residual value, if any, are reviewed annually.

(h) Intangible assets (other than goodwill)

Expenditure on research activities is recognised as an expense in the period in which it is incurred. Expenditure on development activities is capitalised if the product or process is technically and commercially feasible and the Group has sufficient resources and the intention to complete development. The expenditure capitalised includes the costs of materials, direct labour, and an appropriate proportion of overheads and borrowing costs, where applicable (see Note 2(w)). Capitalised development costs are stated at cost less accumulated amortisation and impairment losses (see Note 2(k)(ii)). Other development expenditure is recognised as an expense in the period in which it is incurred.

Intangible assets acquired by the Group are stated at cost less accumulated amortisation (where the estimated useful life is finite) and impairment losses (see Note 2(k)(ii)).

Amortisation of intangible assets with finite useful lives is charged to profit or loss on a straight-line basis over the assets' estimated useful lives. These intangible assets with finite useful lives are amortised from the date they are available for use as follows:

Both the period and method of amortisation are reviewed annually.

Intangible assets are not amortised while their useful lives are assessed to be indefinite. Any conclusion that the useful life of an intangible asset is indefinite is reviewed annually to determine whether events and circumstances continue to support the indefinite useful life assessment for that asset. If they do not, the change in the useful life assessment from indefinite to finite is accounted for prospectively from the date of change and in accordance with the policy for amortisation of intangible assets with finite lives as set out above. The Group treats trademark as intangible asset with indefinite useful life and reviews annually.

(i) Other investments in debt securities

Investments in debt securities are recognised/derecognised on the date the Group commits to purchase/sell the investment. The investments are initially stated at fair value, directly attributable transaction costs are recognised directly in profit or loss. For an explanation of how the Group determines fair value of financial instruments, see Note 30(e).

Non-equity investments held by the Group are classified into one of the following measurement categories:

- amortised cost, if the investment is held for the collection of contractual cash flows which represent solely payments of principal and interest. Interest income from the investment is calculated using the effective interest method (see Note 2(u)(iv)). Changes in the fair value of the investment (including interest) are recognised in profit or loss.
- fair value through other comprehensive income (FVOCI) recycling, if the contractual cash flows of the investment comprise solely payments of principal and interest and the investment is held within a business model whose objective is achieved by both the collection of contractual cash flows and sale. Changes in fair value are recognised in other comprehensive income, except for the recognition in profit or loss of expected credit losses, interest income (calculated using the effective interest method) and foreign exchange gains and losses. When the investment is derecognised, the amount accumulated in other comprehensive income is recycled from equity to profit or loss.
- fair value at profit or loss (FVPL) if the investment does not meet the criteria for being measured at amortised cost or FVOCI (recycling). Changes in the fair value of the investment (including interest) are recognised in profit or loss.

2 SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

(j) Leased assets

At inception of a contract, the Group assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

(I) AS A LESSEE

Where the contract contains lease component(s) and non-lease component(s), the Group has elected not to separate non-lease components and accounts for each lease component and any associated non-lease components as a single lease component for all leases.

At the lease commencement date, the Group recognises a right-of-use asset and a lease liability, except for short-term leases that have a lease term of 12 months or less and leases of low-value assets. When the Group enters into a lease in respect of a low-value asset, the Group decides whether to capitalise the lease on a lease-by-lease basis. The lease payments associated with those leases which are not capitalised are recognised as an expense on a systematic basis over the lease term.

Where the lease is capitalised, the lease liability is initially recognised at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. After initial recognition, the lease liability is measured at amortised cost and interest expense is calculated using the effective interest method. Variable lease payments that do not depend on an index or rate are not included in the measurement of the lease liability and hence are charged to profit or loss in the accounting period in which they are incurred.

The right-of-use asset recognised when a lease is capitalised is initially measured at cost, which comprises the initial amount of the lease liability plus any lease payments made at or before the commencement date, and any initial direct costs incurred. Where applicable, the cost of the right-of-use assets also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, discounted to their present value, less any lease incentives received. The right-of-use asset is subsequently stated at cost less accumulated depreciation and impairment losses (see Notes 2(g) and 2(k)(ii)).

The lease liability is remeasured when there is a change in future lease payments arising from a change in an index or rate, or there is a change in the Group's estimate of the amount expected to be payable under a residual value guarantee, or there is a change arising from the reassessment of whether the Group will be reasonably certain to exercise a purchase, extension or termination option. When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the right-of-use asset, or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

The Group presents right-of-use assets in 'Property, plant and equipment' and presents lease liabilities separately in the statement of financial position.

2 SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

(j) Leased assets (continued)

(II) AS A LESSOR

When the Group acts as a lessor, it determines at lease inception whether each lease is a finance lease or an operating lease. A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to the ownership of an underlying assets to the lessee. If this is not the case, the lease is classified as an operating lease.

When the Group is an intermediate lessor, the sub-leases are classified as a finance lease or as an operating lease with reference to the right-of-use asset arising from the head lease. If the head lease is a short-term lease to which the Group applies the exemption described in Note 2(j)(i), then the Group classifies the sub-lease as an operating lease.

(k) Credit losses and impairment of assets

(I) CREDIT LOSSES FROM FINANCIAL INSTRUMENTS AND CONTRACT ASSETS

The Group recognises a loss allowance for ECL on the following items:

- financial assets measured at amortised cost (including cash and cash equivalents, trade and other receivables and loans to an associate);
- contract assets as defined in IFRS 15 (see Note 2(m)).

Other financial assets measured at fair value, including debt investments measured at FVPL are not subject to the ECL assessment.

Measurement of ECLs

ECLs are a probability-weighted estimate of credit losses. Credit losses are measured as the present value of all expected cash shortfalls (i.e. the difference between the cash flows due to the Group in accordance with the contract and the cash flows that the Group expects to receive).

The expected cash shortfalls are discounted using the following discount rates where the effect of discounting is material:

- fixed-rate financial assets, trade and other receivables and contract assets: effective interest rate determined at initial recognition or an approximation thereof;
- variable-rate financial assets: current effective interest rate;

The maximum period considered when estimating ECLs is the maximum contractual period over which the Group is exposed to credit risk.

In measuring ECLs, the Group takes into account reasonable and supportable information that is available without undue cost or effort. This includes information about past events, current conditions and forecasts of future economic conditions.

2 SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

(k) Credit losses and impairment of assets (continued)

- (I) CREDIT LOSSES FROM FINANCIAL INSTRUMENTS AND CONTRACT ASSETS (CONTINUED) Measurement of ECLs (continued) ECLs are measured on either of the following bases:
 - 12-month ECLs: these are losses that are expected to result from possible default events within the 12 months after the reporting date; and
 - lifetime ECLs: these are losses that are expected to result from all possible default events over the expected lives of the items to which the ECL model applies.

Loss allowances for trade and other receivables and contract assets are always measured at an amount equal to lifetime ECLs. ECLs on these financial assets are estimated using a provision matrix based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors and an assessment of both the current and forecast general economic conditions at the reporting date.

For all other financial instruments, the Group recognises a loss allowance equal to 12-month ECLs unless there has been a significant increase in credit risk of the financial instrument since initial recognition, in which case the loss allowance is measured at an amount equal to lifetime ECLs.

Significant increases in credit risk

In assessing whether the credit risk of a financial instrument has increased significantly since initial recognition, the Group compares the risk of default occurring on the financial instrument assessed at the reporting date with that assessed at the date of initial recognition. In making this reassessment, the Group considers that a default event occurs when (i) the borrower is unlikely to pay its credit obligations to the Group in full, without recourse by the Group to actions such as realising security (if any is held); or (ii) the financial asset is 90 days past due. The Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

- (k) Credit losses and impairment of assets (continued)
 - (I) CREDIT LOSSES FROM FINANCIAL INSTRUMENTS AND CONTRACT ASSETS (CONTINUED) Significant increases in credit risk (continued) In particular, the following information is taken into account when assessing whether credit risk has increased significantly since initial recognition:
 - failure to make payments of principal or interest on their contractually due dates;
 - an actual or expected significant deterioration in a financial instrument's external or internal credit rating (if available);
 - an actual or expected significant deterioration in the operating results of the debtor; and
 - existing or forecast changes in the market, economic or legal environment that have a significant adverse effect on the debtor's ability to meet its obligation to the Group.

Depending on the nature of the financial instruments, the assessment of a significant increase in credit risk is performed on either an individual basis or a collective basis. When the assessment is performed on a collective basis, the financial instruments are grouped based on shared credit risk characteristics, such as past due status and credit risk ratings.

ECLs are remeasured at each reporting date to reflect changes in the financial instrument's credit risk since initial recognition. Any change in the ECL amount is recognised as an impairment gain or loss in profit or loss. The Group recognises an impairment gain or loss for all financial instruments with a corresponding adjustment to their carrying amount through a loss allowance account, except for investments in debt securities that are measured at FVOCI (recycling), for which the loss allowance is recognised in other comprehensive income and accumulated in the fair value reserve (recycling).

Basis of calculation of interest income

Interest income recognised in accordance with Note 2(u)(iv) is calculated based on the gross carrying amount of the financial asset unless the financial asset is credit-impaired, in which case interest income is calculated based on the amortised cost (i.e. the gross carrying amount less loss allowance) of the financial asset.

At each reporting date, the Group assesses whether a financial asset is credit-impaired. A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of the financial asset have occurred.

2 SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

(k) Credit losses and impairment of assets (continued)

(I) CREDIT LOSSES FROM FINANCIAL INSTRUMENTS AND CONTRACT ASSETS (CONTINUED) Basis of calculation of interest income (continued) Evidence that a financial asset is credit-impaired includes the following observable events:

- significant financial difficulties of the debtor;
- a breach of contract, such as a default or past due event;
- it becoming probable that the borrower will enter into bankruptcy or other financial reorganisation;
- significant changes in the market, economic or legal environment that have an adverse effect on the debtor; or
- the disappearance of an active market for a security because of financial difficulties of the issuer.

Write-off policy

The gross carrying amount of a financial asset or contract asset is written off (either partially or in full) to the extent that there is no realistic prospect of recovery. This is generally the case when the Group determines that the customer does not have assets or sources of income that could generate sufficient cash flows to repay the amounts subject to the write-off.

Subsequent recoveries of an asset that was previously written off are recognised as a reversal of impairment in profit or loss in the period in which the recovery occurs.

(II) IMPAIRMENT OF OTHER NON-CURRENT ASSETS

Internal and external sources of information are reviewed at the end of each reporting period to identify indications that the following assets may be impaired or, except in the case of goodwill, an impairment loss previously recognised no longer exists or may have decreased:

- property, plant and equipment, including right-of-use assets;
- intangible assets;
- goodwill;
- investments in joint ventures and associates; and
- investments in subsidiaries in the Company's statement of financial position.

(k) Credit losses and impairment of assets (continued)

(II) IMPAIRMENT OF OTHER NON-CURRENT ASSETS (CONTINUED)

If any such indication exists, the asset's recoverable amount is estimated. In addition, for goodwill and intangible assets that have indefinite useful lives, the recoverable amount is estimated annually whether or not there is any indication of impairment.

- Calculation of recoverable amount

The recoverable amount of an asset is the greater of its fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. Where an asset does not generate cash inflows largely independent of those from other assets, the recoverable amount is determined for the smallest group of assets that generates cash inflows independently (i.e. a cash-generating unit).

- Recognition of impairment losses

An impairment loss is recognised in profit or loss if the carrying amount of an asset, or the cash-generating unit to which it belongs, exceeds its recoverable amount. Impairment losses recognised in respect of cash-generating units are allocated first to reduce the carrying amount of any goodwill allocated to the cash generating unit (or group of units) and then, to reduce the carrying amount of the other assets in the unit (or group of units) on a pro rata basis, except that the carrying value of an asset will not be reduced below its individual fair value less costs of disposal (if measurable) or value in use (if determinable).

- Reversals of impairment losses

In respect of assets other than goodwill, an impairment loss is reversed if there has been a favourable change in the estimates used to determine the recoverable amount. An impairment loss in respect of goodwill is not reversed.

A reversal of an impairment loss is limited to the asset's carrying amount that would have been determined had no impairment loss been recognised in prior years. Reversals of impairment losses are credited to profit or loss in the year in which the reversals are recognised.

(III) INTERIM FINANCIAL REPORTING AND IMPAIRMENT

Under the Listing Rules, the Group is required to prepare interim financial reports in compliance with IAS 34, *Interim financial reporting*, in respect of the first six months of the financial year. At the end of the interim period, the Group applies the same impairment testing, recognition, and reversal criteria as it would at the end of the financial year (see Note 2(k)). Impairment losses recognised in an interim period in respect of goodwill are not reversed in a subsequent period. This is the case even if no loss, or a smaller loss, would have been recognised had the impairment been assessed only at the end of the financial year to which the interim period relates.

(I) Inventories and other contract costs

(I) INVENTORIES

Inventories are assets which are held for sale in the ordinary course of business, in the process of production for such sale or in the form of materials or supplies to be consumed in the production process or in the rendering of services.

Inventories are carried at the lower of cost and net realisable value.

Cost comprises all costs of purchase and other costs incurred in bringing the inventories to their present location and condition.

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs necessary to make the sale.

When inventories are sold, the carrying amount of those inventories is recognised as an expense in the period in which the related revenue is recognised.

The amount of any write-down of inventories to net realisable value and all losses of inventories are recognised as an expense in the period the write-down or loss occurs. The amount of any reversal of any write-down of inventories is recognised as a reduction in the amount of inventories recognised as an expense in the period in which the reversal occurs.

(II) OTHER CONTRACT COSTS

Other contract costs are either the incremental costs of obtaining a contract with a customer or the costs to fulfil a contract with a customer which are not capitalised as inventory (see Note 2(l)(i)), property, plant and equipment (see Note 2(g)) or intangible assets (see Note 2(h)).

Incremental costs of obtaining a contract are those costs that the Group incurs to obtain a contract with a customer that it would not have incurred if the contract had not been obtained. Incremental costs of obtaining a contract are capitalised when incurred if the costs relate to revenue which will be recognised in a future reporting period and the costs are expected to be recovered. Other costs of obtaining a contract are expensed when incurred.

Costs to fulfil a contract are capitalised if the costs relate directly to an existing contract or to a specifically identifiable anticipated contract; generate or enhance resources that will be used to provide goods or services in the future; and are expected to be recovered. Costs that relate directly to an existing contract or to a specifically identifiable anticipated contract may include direct labour, direct materials, allocations of costs, costs that are explicitly chargeable to the customer and other costs that are incurred only because the Group entered into the contract (for example, payments to subcontractors). Other costs of fulfilling a contract, which are not capitalised as inventory, property, plant and equipment or intangible assets, are expensed as incurred.

(I) Inventories and other contract costs (continued)

(II) OTHER CONTRACT COSTS (CONTINUED)

Capitalised contract costs are stated at cost less accumulated amortisation and impairment losses. Impairment losses are recognised to the extent that the carrying amount of the contract cost asset exceeds the net of (i) remaining amount of consideration that the Group expects to receive in exchange for the goods or services to which the asset relates, less (ii) any costs that relate directly to providing those goods or services that have not yet been recognised as expenses.

Amortisation of capitalised contract costs is charged to profit or loss when the revenue to which the asset relates is recognised. The accounting policy for revenue recognition is set out in Note 2(u).

(m) Contract assets and contract liabilities

A contract asset is recognised when the Group recognises revenue (see Note 2(u)) before being unconditionally entitled to the consideration under the payment terms set out in the contract. Contract assets are assessed for ECL in accordance with the policy set out in Note 2(k)(i) and are reclassified to receivables when the right to the consideration has become unconditional (see Note 2(n)).

A contract liability is recognised when the customer pays non-refundable consideration before the Group recognises the related revenue (see Note 2(u)). A contract liability would also be recognised if the Group has an unconditional right to receive non-refundable consideration before the Group recognises the related revenue. In such cases, a corresponding receivable would also be recognised (see Note 2(n)).

For a single contract with the customer, either a net contract asset or a net contract liability is presented. For multiple contracts, contract assets and contract liabilities of unrelated contracts are not presented on a net basis.

When the contract includes a significant financing component, the contract balance includes interest accrued under the effective interest method (see Note 2(u)).

(n) Trade and other receivables

A receivable is recognised when the Group has an unconditional right to receive consideration. A right to receive consideration is unconditional if only the passage of time is required before payment of that consideration is due. If revenue has been recognised before the Group has an unconditional right to receive consideration, the amount is presented as a contract asset (see Note 2(m)).

Receivables are stated at amortised cost using the effective interest method, less allowance for credit losses (see Note 2(k)(i)).

2 SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

(o) Trade and other payables

Trade and other payables are initially recognised at fair value and are subsequently stated at amortised cost using the effective interest method unless the effect of discounting would be immaterial, in which case they are stated at cost.

(p) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Cash and cash equivalents are assessed for ECL in accordance with the policy set out in Note 2(k)(i).

(q) Interest-bearing borrowings

Interest-bearing borrowings are measured initially at fair value less transaction costs. Subsequent to initial recognition, interest-bearing borrowings are stated at amortised cost using the effective interest method. Interest expense is recognised in accordance with the Group's accounting policy for borrowing costs (see Note 2(w)).

(r) Employee benefits

(I) SHORT-TERM EMPLOYEE BENEFITS AND CONTRIBUTIONS TO DEFINED CONTRIBUTION RETIREMENT PLANS

Salaries, annual bonuses, paid annual leave, contributions to defined contribution retirement plans and the cost of non-monetary benefits are accrued in the year in which the associated services are rendered by employees of the Group. Where payment or settlement is deferred and the effect would be material, these amounts are stated at their present values.

(II) SHARE-BASED PAYMENTS

The fair value of share options granted to employees is recognised as an employee cost with a corresponding increase in capital reserve within equity. The fair value is measured at grant date using the Black-Scholes Model, taking into account the terms and conditions upon which the share options were granted. Where the employees have to meet vesting conditions before becoming unconditionally entitled to the share options, the total estimated fair value of the share options is spread over the vesting period, taking into account the probability that the share options will vest.

During the vesting period, the number of share options that is expected to vest is reviewed. Any resulting adjustment to the cumulative fair value recognised in prior years is charged/credited to profit or loss for the year of the review, unless the original employee expenses qualify for recognition as an asset, with a corresponding adjustment to the capital reserve. On vesting date, the amount recognised as an expense is adjusted to reflect the actual number of share options that vest (with a corresponding adjustment to the capital reserve) except where forfeiture is only due to not achieving vesting conditions that relate to the market price of the Company's shares. The equity amount is recognised in the reserve until either the share option is exercised (when it is included in the amount recognised in share capital for the shares issued).

(r) Employee benefits (continued)

(III) TERMINATION BENEFITS

Termination benefits are recognised at the earlier of when the Group can no longer withdraw the offer of those benefits and when it recognises restructuring costs involving the payment of termination benefits.

(s) Income tax

Income tax for the year comprises current tax and movements in deferred tax assets and liabilities. Current tax and movements in deferred tax assets and liabilities are recognised in profit or loss except to the extent that they relate to business combinations, or items recognised in other comprehensive income or directly in equity, in which case the relevant amounts of tax are recognised in other comprehensive income or directly in equity, respectively.

Current tax is the expected tax payable on the taxable income for the year, using tax rates enacted or substantively enacted at the end of the reporting period, and any adjustment to tax payable in respect of previous years.

Deferred tax assets and liabilities arise from deductible and taxable temporary differences respectively, being the differences between the carrying amounts of assets and liabilities for financial reporting purposes and their tax bases. Deferred tax assets also arise from unused tax losses and unused tax credits.

Apart from certain limited exceptions, all deferred tax liabilities, and all deferred tax assets to the extent that it is probable that future taxable profits will be available against which the asset can be utilised, are recognised. Future taxable profits that may support the recognition of deferred tax assets arising from deductible temporary differences include those that will arise from the reversal of existing taxable temporary differences, provided those differences relate to the same taxation authority and the same taxable entity, and are expected to reverse either in the same period as the expected reversal of the deductible temporary differences or in periods into which a tax loss arising from the deferred tax asset can be carried back or forward. The same criteria are adopted when determining whether existing taxable temporary differences support the recognition of deferred tax assets arising from unused tax losses and credits, that is, those differences are taken into account if they relate to the same taxation authority and the same taxable entity, and are expected to reverse in a period, or periods, in which the tax loss or credit can be utilised.

The limited exceptions to recognition of deferred tax assets and liabilities are those temporary differences arising from goodwill not deductible for tax purposes, the initial recognition of assets or liabilities that affect neither accounting nor taxable profit (provided they are not part of a business combination), and temporary differences relating to investments in subsidiaries to the extent that, in the case of taxable differences, the Group controls the timing of the reversal and it is probable that the differences will not reverse in the foreseeable future, or in the case of deductible differences, unless it is probable that they will reverse in the future.

2 SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

(s) Income tax (continued)

The amount of deferred tax recognised is measured based on the expected manner of realisation or settlement of the carrying amount of the assets and liabilities, using tax rates enacted or substantively enacted at the end of the reporting period. Deferred tax assets and liabilities are not discounted.

The carrying amount of a deferred tax asset is reviewed at the end of each reporting period and is reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow the related tax benefit to be utilised. Any such reduction is reversed to the extent that it becomes probable that sufficient taxable profits will be available.

Current tax balances and deferred tax balances, and movements therein, are presented separately from each other and are not offset. Current tax assets are offset against current tax liabilities, and deferred tax assets against deferred tax liabilities, if the Group or the Company has the legally enforceable right to set off current tax assets against current tax liabilities and the following additional conditions are met:

- in the case of current tax assets and liabilities, the Group or the Company intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously; or
- in the case of deferred tax assets and liabilities, if they relate to income taxes levied by the same taxation authority on either:
 - the same taxable entity; or
 - different taxable entities, which, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered, intend to realise the current tax assets and settle the current tax liabilities on a net basis or realise and settle simultaneously.

(t) Provisions, contingent liabilities and onerous contracts

(I) PROVISIONS AND CONTINGENT LIABILITIES

Provisions are recognised when the Group has a legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

(II) ONEROUS CONTRACTS

An onerous contract exists when the Group has a contract under which the unavoidable costs of meeting the obligations under the contract exceed the economic benefits expected to be received from the contract. Provisions for onerous contracts are measured at the present value of the lower of the expected cost of terminating the contract and the net cost of continuing with the contract.

(u) Revenue and other income

Income is classified by the Group as revenue when it arises from the sale of goods, the provision of services or the use by others of the Group's assets under leases in the ordinary course of the Group's business.

Revenue is recognised when control over a product or service is transferred to the customer, or the lessee has the right to use the asset, at the amount of promised consideration to which the Group is expected to be entitled, excluding those amounts collected on behalf of third parties. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts.

Further details of the Group's revenue and other income recognition policies are as follows:

(I) SERVICE CONTRACT

When the outcome of a service contract can be reasonably measured, revenue from the contract is recognised progressively over time using the cost-to-cost method, i.e. based on the proportion of the actual costs incurred relative to date to the estimated total costs.

The likelihood of the Group earning contractual bonuses for early completion or suffering contractual penalties for late completion are taken into account in making these estimates, such that revenue is only recognised to the extent that it is highly probable that a significant reversal in the amount of cumulative revenue recognised will not occur.

When the outcome of the contract cannot be reasonably measured, revenue is recognised only to the extent of contract costs incurred that are expected to be recovered.

If at any time the costs to complete the contract are estimated to exceed the remaining amount of the consideration under the contract, then a provision is recognised in accordance with the policy set out in Note 2(t)(ii).

(II) SALE OF GOODS

Revenue is recognised when the customer takes possession of and accepts the products. If the products are a partial fulfilment of a contract covering other goods and/or services, then the amount of revenue recognised is an appropriate proportion of the total transaction price under the contract, allocated between all the goods and services promised under the contract on a relative stand-alone selling price basis.

(III) DIVIDENDS

- Dividend income from unlisted investments is recognised when the shareholder's right to receive payment is established.
- Dividend income from listed investments is recognised when the share price of the investment goes ex-dividend.

2 SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

(u) Revenue and other income (continued)

(IV) INTEREST INCOME

Interest income is recognised as it accrues under the effective interest method using the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the gross carrying amount of the financial asset. For financial assets measured at amortised cost or FVOCI (recycling) that are not credit-impaired, the effective interest rate is applied to the gross carrying amount of the asset. For credit-impaired financial assets, the effective interest rate is applied to the amortised cost (i.e. gross carrying amount net of loss allowance) of the asset (see Note 2(k)(i)).

(V) GOVERNMENT GRANTS

Government grants are recognised in the statement of financial position initially when there is reasonable assurance that they will be received and that the Group will comply with the conditions attaching to them. Grants that compensate the Group for expenses incurred are recognised as revenue in profit or loss on a systematic basis in the same periods in which the expenses are incurred. Grants that compensate the Group for the cost of an asset are recognised as deferred income and consequently recognised in profit or loss over the useful life of the related asset.

(v) Translation of foreign currencies

Foreign currency transactions during the period are translated into the functional currency of the entity to which they relate at the foreign exchange rates ruling at the transaction dates. Monetary assets and liabilities denominated in foreign currencies are translated into the functional currency of the entity to which they relate at the foreign exchange rates ruling at the end of the reporting period. Exchange gains and losses are recognised in profit or loss.

Non-monetary assets and liabilities that are measured in terms of historical cost in a foreign currency are translated into the functional currency of the entity to which they relate using the foreign exchange rates ruling at the transaction dates. The transaction date is the date on which the Company initially recognises such non-monetary assets or liabilities.

The results of foreign operations are translated into Hong Kong dollars, the Group's presentation currency, at the exchange rates approximating the foreign exchange rates ruling at the dates of the transactions. Statement of financial position items, including goodwill arising on consolidation of foreign operations acquired, are translated into Hong Kong dollars at the closing foreign exchange rates at the end of the reporting period. The resulting exchange differences are recognised in other comprehensive income and accumulated separately in equity in the exchange reserve.

On disposal of a foreign operation, the cumulative amount of the exchange differences relating to that foreign operation is reclassified from equity to profit or loss when the profit or loss on disposal is recognised.

(w) Borrowing costs

Borrowing costs that are directly attributable to the acquisition, construction or production of an asset which necessarily takes a substantial period of time to get ready for its intended use or sale are capitalised as part of the cost of that asset. Other borrowing costs are expensed in the period in which they are incurred. Notes to the Consolidated Financial Statements (continued)

(x) Related parties

- (a) A person, or a close member of that person's family, is related to the Group if that person:
 - (i) has control or joint control over the Group;
 - (ii) has significant influence over the Group; or
 - (iii) is a member of the key management personnel of the Group or the Group's parent.
- (b) An entity is related to the Group if any of the following conditions applies:
 - (i) The entity and the Group are members of the same group (which means that each parent, subsidiary and fellow subsidiary is related to the others).
 - (ii) One entity is an associate or joint venture of the other entity (or an associate or joint venture of a member of a group of which the other entity is a member).
 - (iii) Both entities are joint ventures of the same third party.
 - (iv) One entity is a joint venture of a third entity and the other entity is an associate of the third entity.
 - (v) The entity is a post-employment benefit plan for the benefit of employees of either the Group or an entity related to the Group.
 - (vi) The entity is controlled or jointly controlled by a person identified in (a).
 - (vii) A person identified in (a)(i) has significant influence over the entity or is a member of the key management personnel of the entity (or of a parent of the entity).
 - (viii) The entity, or any member of a group of which it is a part, provides key management personnel services to the Group or to the Group's parent.

Close members of the family of a person are those family members who may be expected to influence, or be influenced by, that person in their dealings with the entity.

(y) Segment reporting

Operating segments, and the amounts of each segment item reported in the financial statements, are identified from the financial information provided regularly to the Group's most senior executive management for the purpose of allocating resources to, and assessing the performance of, the Group's various lines of business and geographical locations.

Individually material operating segments are not aggregated for financial reporting purposes unless the segments have similar economic characteristics and are similar in respect of the nature of products and services, the nature of production processes, the type or class of customers, the methods used to distribute the products or provide the services, and the nature of the regulatory environment. Operating segments which are not individually material may be aggregated if they share a majority of these criteria.

3 ACCOUNTING JUDGEMENTS AND ESTIMATES

Notes 13, 25, 26, 27 and 30 contain information about the assumptions and their risk factors relating to goodwill impairment, fair value of contingent considerations, estimation of provision for warranties, fair value of cash-settled share-based transaction and financial instruments. Other key sources of estimation uncertainty are as follows:

(a) Revenue recognition

As explained in Note 2(u)(i), revenue from service contracts are recognised over time. Such revenue and profit recognition on uncompleted projects is dependent on estimating the total outcome of the contract, as well as the work done to date. Based on the Group's recent experience and the nature of the manufacturing and construction activities undertaken by the Group, the Group has made estimates of the point at which it considered the work was sufficiently advanced such that the outcome of the contract can be reasonably measured. In addition, actual outcomes in terms of total cost or revenue may be higher or lower than estimated at the end of the reporting period, which would affect the revenue and profit recognised in future years as an adjustment to the amounts recorded to date.

(b) Impairment of trade receivables and contract assets

The impairment provisions for trade receivables and contract assets are based on assumptions about the expected loss rates. The Group uses judgement in making these assumptions and selecting the inputs to the impairment calculation, based on the Group's past history, existing market conditions as well as forward looking estimates at the end of each reporting period. For details of the key assumptions and inputs used, see Note 30(a). Changes in these assumptions and estimated could materially affect the result of the assessment and it may be necessary to make additional impairment charge to the profit or loss.

3 ACCOUNTING JUDGEMENTS AND ESTIMATES (CONTINUED)

(c) Impairment of tangible and intangible assets

If circumstances indicate that the carrying amount of tangible or intangible asset may not be recoverable, the asset may be considered "impaired", and an impairment loss may be recognised in accordance with accounting policy for impairment of tangible and intangible assets as described in Note 2(k)(ii). These assets are tested for impairment periodically or whenever the events or changes in circumstances indicate that their recorded carrying amounts may not be recoverable. When such a decline has occurred, the carrying amount is reduced to recoverable amount. The recoverable amount is the greater of the fair value less costs of disposal and value in use. In determining the value in use, expected future cash flows generated by the asset are discounted to their present value, which requires significant judgement relating to the level of revenue and amount of operating costs. The Group uses all readily available information in determining an amount that is a reasonable approximation of the recoverable amount, including estimates based on reasonable and supportable assumptions and projections of the level of revenue and amount of operating costs. Changes in these estimates could have a significant impact on the recoverable amount of the assets and could result in additional impairment charge or reversal of impairment in future years, where applicable.

(d) Deferred tax

Deferred tax assets are recognised for unused tax losses and deductible temporary differences to the extent that it is probable that future taxable profits will be available against which the deferred tax assets can be utilised. In determining the amount of deferred tax assets to be recognised, significant judgement is required relating to the timing and level of future taxable profits, after taking into account future tax planning strategies. The amount of deferred tax assets recognised at future dates are adjusted if there are significant changes from these estimates.

4 REVENUE AND SEGMENT REPORTING

(a) Revenue

The principal activities of the Group are the design, production, implementation and sale, and maintenance, of application solutions for the networking and controlling systems of public transport and other companies, the provision of civil communication transmission services, as well as design, implementation and sale of related software, hardware and spare parts in utility tunnel areas, and the investment in the railway transportation areas and infrastructure areas through investing in equity. Further details regarding the Group's principal activities are disclosed in Note 4(b).

(II) CAPITAL RESERVE

The capital reserve represents (i) the difference between the carrying values of the controlling equity interests in subsidiaries acquired and the considerations paid under the reorganisation took place in 2011; (ii) the portion of the grant date fair value of unexercised share options granted to directors and equity shareholder of the Company and employees of the Group that has been recognised in accordance with the accounting policy adopted for share-based payments in Note 2(r)(ii); and (iii) the share of the investee's net assets changes, other than profit or loss or other comprehensive income and distributions received.

(III) STATUTORY RESERVES

In accordance with the articles of association of the subsidiaries of the Group established in the PRC (excluding Hong Kong), these subsidiaries were required to set up certain statutory reserves, which were non-distributable. The transfers to these reserves are governed by the articles of association of the respective subsidiaries. The statutory reserves can only be utilised for predetermined means upon approval by the relevant authority.

(IV) EXCHANGE RESERVE

The exchange reserve comprises foreign exchange differences arising from the translation of the financial statements of companies outside Hong Kong into the presentation currency. The reserve is dealt with in accordance with the accounting policy set out in Note 2(v).

(e) Capital management

The Group's primary objectives when managing capital are to safeguard the Group's ability to continue as a going concern, so that it can continue to provide returns for equity shareholders and benefits for other stakeholders, by pricing products and services commensurately with the level of risk and by securing access to finance at a reasonable cost.

The capital structure of the Group consists of net debt including borrowings, net of cash and cash equivalents and equity attributable to owners of the Company comprising issued equity, retained profits and other reserves.

The directors of the Company review the capital structure on a semi-annual basis. As part of this review, the directors consider the cost of capital and the risks associated with each class of capital. The Group will balance its overall capital structure through the payment of dividends as well as the issue of new debt or the redemption of existing debt.

30 FINANCIAL RISK MANAGEMENT AND FAIR VALUES OF FINANCIAL INSTRUMENTS

Exposure to credit, liquidity, interest rate and currency risks arises in the normal course of the Group's business. The Group's exposure to these risks and the financial risk management policies and practices used by the Group to manage these risks are described below.

(a) Credit risk

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in a financial loss to the Group. The Group's credit risk is primarily attributable to trade receivables and contract assets. The Group's exposure to credit risk arising from cash and cash equivalents, bill receivables and debt investments is limited because the counterparties are mainly banks and financial institutions with sound credit standing, for which the Group considers to have low credit risk.

TRADE RECEIVABLES AND CONTRACT ASSETS

The Group's exposure to credit risk is influenced mainly by the individual characteristics of each customer rather than the industry in which the customers operate and therefore significant concentrations of credit risk primarily arise when the Group has significant exposure to individual customers. At 31 December 2020, 6% (2019: 8%) of the trade receivables and contract assets were due from the Group's largest debtor, and 25% (2019: 32%) of the trade receivables and contract assets were due from the Group's five largest debtors.

Individual credit evaluations are performed on all customers requiring credit over a certain amount. These evaluations focus on the customer's past history of making payments when due and current ability to pay, and take into account information specific to the customer as well as pertaining to the economic environment in which the customer operates. Normally, the Group does not obtain collateral from customers.

The Group does not provide any other guarantees which would expose the Group to credit risk.

The Group measures loss allowances for trade receivables and contract assets at an amount equal to lifetime ECLs, which is calculated using a provision matrix.

The ultimate holding company of the Company, 北京市基礎設施投資有限公司 ("Beijing Infrastructure Investment Co., Ltd.") ("BII"), is a state-controlled enterprise controlled by the PRC government. Apart from transactions with BII and its affiliates which were disclosed in Note 31(a) above, the Group also has transactions with other state-controlled entities, included but not limited to the following:

- provision of design, implementation and sale of application solution services;
- maintenance of application solution services;
- infrastructure information related services;
- bank deposits;
- bank loans; and
- purchase of other financial assets.

(g) Applicability of the Listing Rules relating to connected transactions

For the year ended 31 December 2020, the above related party transactions in respect of the provision of design, implementation and sale of application solution services, the provision of maintenance of application solution services and leases, with affiliates of equity shareholders of the Company where applicable, constitute connected transactions or continuing connected transactions as defined in Chapter 14A of the Listing Rules. The disclosures required by Chapter 14A of the Listing Rules are provided in section "Continuing connected transactions" of the Directors' Report.

33 IMPACTS OF COVID-19 PANDEMIC

The COVID-19 Pandemic since early 2020 has brought about additional uncertainties in the Group's operating environment and has impact the Group's operations and financial position.

Since early 2020, the Group has commenced to put in place various contingency measures. These contingency measures included but not limited to maintaining regular communication with customers and suppliers through online and remote working model to ensure the normal operation of business, steadily promoting resumption of work and operation and taking various measures to reduce the cost and increase efficiency.

As far as the Group's businesses are concerned, if COVID-19 Pandemic situation evolves, the impact on the Group's financial position and financial performance may be as follows:

(a) Significant judgements and estimation uncertainty

COVID-19 Pandemic would impact the entire business operation environment and result in increase in credit risk of customers and decrease in both selling price and financial performance. If COVID-19 Pandemic situation evolves, more uncertainties would be brought into consideration in following judgements and estimations:

- Expected credit losses
- Net realisable value of inventories
- Recoverable amounts of non-financial assets and goodwill

(b) Fair value measurement

Measurement of fair value of contingent considerations are mainly determined by the excepted cash flows of consideration to be paid (Notes 25 and 30(e)), which are based on the financial performance of Huaqi Intelligent in future periods. If the future financial performance of Huaqi Intelligent were significantly impacted by evolving COVID-19 Pandemic situation, the fair value measurement of contingent considerations will be adjusted accordingly.

(c) Investment in a joint venture

A joint venture of the Group is mainly engaged in operating Beijing Subway Capital Airport Express. Given both airlines and public transportation business were significantly impacted by COVID-19 Pandemic, the Group recorded a share of loss of the joint venture in the interim period. If COVID-19 Pandemic situation evolves, the landscape of both airlines and public transportation business may be re-shaped in a long run. The Group will monitor the operation of the joint venture closely and re-visit all available measures to safeguard the investment in the joint venture.

34 IMMEDIATE AND ULTIMATE HOLDING COMPANY

At 31 December 2020, the directors of the Company consider the immediate and ultimate controlling party of the Company to be Beijing Infrastructure Investment (Hong Kong) Limited, a company incorporated in Hong Kong, and BII, a company established in the PRC, respectively. Neither of these companies produces financial statements available for public use.
