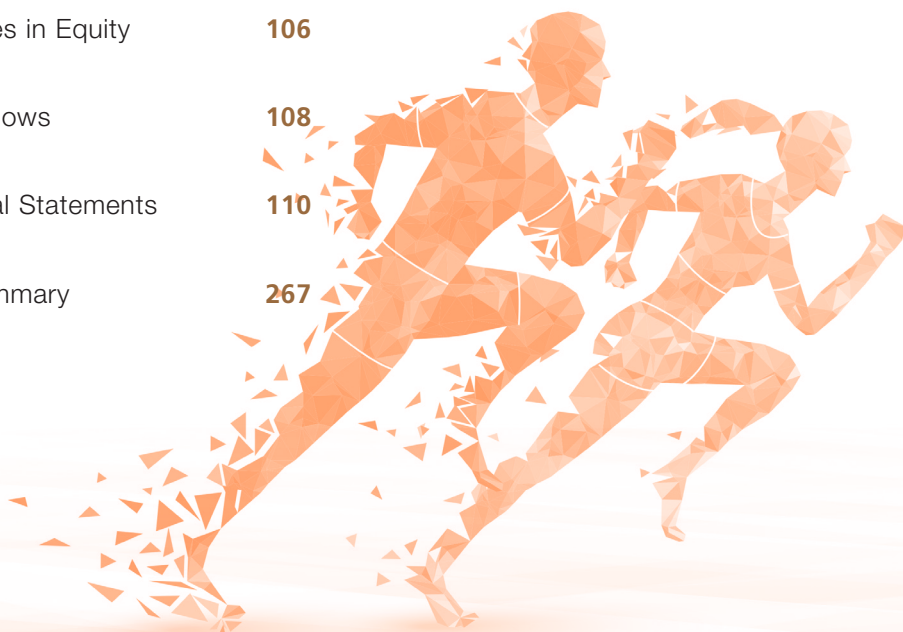

On behalf of the board (the “**Board**”) of directors (the “**Directors**”) of Best Pacific International Holdings Limited (the “**Company**” or “**Best Pacific**”, together with its subsidiaries, collectively, the “**Group**” or “**we**”), I am pleased to present the annual results of the Group for the year ended 31 December 2020.

Following the declaration of 2019 novel coronavirus disease (“**COVID-19**”) epidemic an international public health emergency in January 2020, and subsequently a global pandemic in March 2020, most countries in the world had been experiencing unprecedented challenges for most time of 2020. As part of the countermeasures to the global pandemic, governments around the world paused both manufacturing and social activities at different points in time throughout the year, which had led to far-reaching economic and social consequences around the globe. Inevitably, the textile and garment industry had to face the same challenges and coupled with the continuous political and trade tensions between the People's Republic of China (the “**PRC**”) and the United States of America (the “**U.S.**”), many companies within the space were actually battling for survival.

隨著二零一九年新型冠狀病毒疾病（「**COVID-19**」）疫情於二零二零年一月被宣佈為國際關注的突發公共衛生事件，且其後於二零二零年三月被宣佈為全球性流行病，全球多數國家在二零二零年均面臨前所未見的挑戰。於二零二零年，各國政府在不同時間點暫停製造及社會活動以作為應對全球性流行病的一部分措施，對全球經濟和社會的影響深遠。不可避免地，紡織品及服裝業亦須面對同樣的挑戰，再加上中華人民共和國（「中國」）與美利堅合眾國（「美國」）之間持續的政治和貿易緊張局勢，許多受影響的公司都為此掙扎求存。

## CHAIRMAN'S STATEMENT

### 主席報告

With the serious disruption to industrial and commercial activities and the associated changes and shifts in consumer demands and spending patterns, the global gross domestic product (“GDP”) in 2020 was projected to be around US\$130 trillion according to the International Monetary Fund, which was almost US\$9.6 trillion less, as compared to that in 2019.

Despite the difficult business environment and operating conditions in 2020, the Group had made tremendous efforts to stabilize its production and operations. Our long-term strategy to improve agility and resilience and efforts in building an international manufacturing footprint had received overwhelming applause and appreciation from both existing and new customers. The Group was helpful to our customers by shifting their production among our different manufacturing plants across the world during times of lockdown at a specific production site. On the other hand, the team had continued to seize the enormous potentials of the sportswear and apparel markets and the Group had achieved an encouraging growth of approximately 36.0% in its sales of elastic fabric for sportswear and apparel use during the year ended 31 December 2020. The achievement of such has further reinstated Best Pacific's ambition to be a leading textile player and to sustain its long term strategy to develop this specific market segment.

由於工商活動嚴重中斷及消費者需求和消費模式出現相關變化和轉變，國際貨幣基金組織預計二零二零年全球國內生產總值（「GDP」）約為130萬億美元，相較於二零一九年減少近9.6萬億美元。

儘管二零二零年商業環境和營運條件艱難，本集團仍為穩定其生產和營運作出了巨大努力。我們提升靈活性和彈性及努力建立國際生產足跡的長期戰略，獲得現有及新客戶的不斷好評和讚賞。在特定生產基地停工期間，本集團將客戶的生產轉移至我們全球各地的生產廠房，從而對客戶提供協助。另一方面，團隊繼續緊抓運動服裝及服裝市場的龐大潛力，於截至二零二零年十二月三十一日止年度，本集團於運動服裝及服裝彈性織物面料的銷售額錄得了約36.0%的鼓舞性增長。這樣的成就進一步強化了超盈國際成為領先紡織業從業者並維持其發展特定市場分部長期戰略的雄心。

## CHAIRMAN'S STATEMENT

Despite the exceptionally difficult time in 2020, the Group had successfully secured a new syndication loan facility amounting to HK\$1.8 billion in June 2020, which had contributed to the financial and risk management of the Group. The management will continue to deploy resources to the future development of the Group and we will continue to work with our customers and business partners, striving to deliver a promising return to our shareholders in the long run.

### BUSINESS REVIEW

The invasion of COVID-19 around the world in 2020 had led to a serious disruption to economic and social activities in many countries. Temporary suspension of operations at the Group's different manufacturing sites had been mandated by the local authority at different points in time since the first quarter of 2020. Alongside with the adoption of various emergency public health measures, the rapid and continuing spread of the virus since the second quarter in 2020 had compelled other countries including the U.S. and Europe to announce nationwide lockdowns. According to the U.S. Bureau of Economic Analysis, the real GDP of the U.S. decreased by around 3.5% in 2020, compared with an increase of GDP growth of around 2.2% in 2019. These countermeasures and together with the mixed uncertainties had caused businesses to refrain from making investment decisions and individuals to control their spending, which then resulted in increased inventory levels at retailers and a consequent weak demand for textile and apparel products. The unfavourable impact on global consumer markets inevitably posted an adverse impact on our financial performance, especially in the first half of 2020.

Despite the rather difficult business environment in 2020, our farsighted internationalization plan had given the Group the ability in adjusting its operations to cope with the challenges brought about by both COVID-19 and U.S.-PRC trade tensions. With an aim to cater to the best interests of our clients, which included the reduction in production lead time as well as other trade and tariff considerations, production orders had been strategically assigned and processed at the specific manufacturing site within the Group, in the PRC, the Socialist Republic of Vietnam (“**Vietnam**”) and the Democratic Socialist Republic of Sri Lanka (“**Sri Lanka**”).

### 業務回顧

二零二零年COVID-19入侵全球，導致許多國家的經濟和社會活動被嚴重中斷。自二零二零年第一季度起，地方當局於不同時間點下令暫停本集團不同生產基地的運營。除了採取多項緊急公共衛生措施外，自二零二零年第二季度以來，病毒的持續迅速擴散迫使包括美國和歐洲在內的其他國家宣佈在全國範圍內實施封鎖。根據美國經濟分析局(U.S. Bureau of Economic Analysis)的數據，美國的實際GDP在二零二零年下降了約3.5%，而二零一九年的GDP為增長約2.2%。這些對策加上各種不確定性因素，導致企業的投資意欲受到壓抑，個人控制支出，從而致使零售商的存貨水平增加以及對紡織品及服裝產品的需求疲軟。全球消費市場的不景況必然對我們的財務表現產生不利影響，特別是在二零二零年上半年。

儘管二零二零年的業務環境相當艱難，但我們具有遠見的國際化計劃使本集團能夠調整其營運方式，以應對COVID-19和中美貿易緊張局勢帶來的挑戰。為了滿足我們客戶的最佳利益，包括縮短生產交付期以及其他貿易和關稅方面的考量，生產訂單已策略性地分配於本集團位於中國、越南社會主義共和國（「**越南**」）及斯里蘭卡民主社會主義共和國（「**斯里蘭卡**」）的特定生產基地進行生產。

### Operation in Vietnam

According to the General Statistics Office of Vietnam, Vietnam was one of the few countries recording positive growth in GDP in 2020. As compared to 2019, the GDP of Vietnam in 2020 was reported to grow by around 2.9%. Subsequent to the successful launch of Phase I and Phase II at our Vietnam manufacturing base by the second half of 2020, customers have shown their keen interests on the relevant capacities.

Looking forward, with Vietnam being perceived as one of the key beneficiaries of the Sino-U.S. trade tension and in order to meet the foreseeable upsurge in market demands for innovation textile products, we will continue exploring the feasibility of further capacity expansion into the region.

### Operations in Sri Lanka

Throughout 2020, the sporadic temporary closure of the operations in Sri Lanka as a result of the pandemic and other human resource matters had caused some disruptions to the operations of the two joint ventures (the “JVs”). However, leveraging on the strategic partnership with the two reputable apparel and textile manufacturing leaders, namely MAS Holdings (Private) Limited (“MAS”), and Brandix Lanka Limited (“Brandix”) and their related groups, we believe the JVs will facilitate the Group in gaining market share in the longer run.

### 越南業務

根據越南統計總局，越南是少數於二零二零年GDP錄得正增長的國家之一。相較於二零一九年，越南二零二零年的GDP錄得增長約2.9%。我們於二零二零年下半年成功啟用第一期及第二期越南製造基地後，客戶對我們的相關產能表現出濃厚興趣。

展望未來，由於越南被視為中美貿易緊張局勢中的主要受益者之一，且為了滿足可預見的創新紡織產品市場需求激增，我們將繼續探索進一步擴大該地區產能的可行性。

### 斯里蘭卡業務

二零二零年，由於疫情及其他人力資源問題導致斯里蘭卡業務出現零星暫時停業，對兩家合營企業的營運造成些許干擾。然而，憑藉我們與兩家著名服裝及紡織品製造業領袖（即MAS Holdings (Private) Limited (「MAS」)、Brandix Lanka Limited (「Brandix」) 以及他們的所屬集團) 的戰略合作關係，長遠來看，我們相信合營企業將促使本集團提升市場份額。

In response to the above-mentioned uncertainties during the financial year 2020, the Group had executed various control measures to save costs in areas including human resources, sales and marketing as well as administrative functions. Starting from the third quarter of 2020, Central governments around the globe had been taking a proactive stimulus policy approach to promote consumer spending and economic growth. The general public also seemed to have learnt to live with the virus and the retail stores of most lingerie and sportswear and apparel brands had reopened, subsequent to the relaxation of certain control measures in different jurisdictions. Online shopping had also become a new norm and the global consumer markets had gradually opened up with demand for apparel products observing sequential improvements. Thanks to the growing health consciousness of the general public, the market demand for comfortable and innovative apparel is always on the rise and the athleisure trend has grown in popularity around the world. Our devotion to the manufacturing of comfortable and highly functional sports-related products had contributed to our significant sales growth in the related product segment. Our sales revenue of sportswear and apparel fabric materials segment increased to approximately HK\$1,696.0 million for the year ended 31 December 2020, representing a year-on-year growth of approximately 36.0%.

為應對上述有關二零二零年財政年度的不確定因素，本集團已採取各種控制措施，以節省人力資源、銷售及營業以及行政職能等領域的成本。自二零二零年第三季度開始，世界各國中央政府都在採取積極的刺激政策措施，以促進消費支出及經濟增長。公眾亦學習與病毒共存，在不同司法管轄權區放鬆若干管制措施後，大多數女性內衣及運動服裝以及服裝品牌的零售商店都已重新開業。線上購物也已成爲一種新常態，在全球消費市場逐步開放的同時，對服裝產品的需求亦隨之持續改善。由於公眾對健康日益重視，市場對舒適及創新服裝的需求無疑正在攀升，而運動休閒趨勢已在世界各地蔚爲風潮。我們致力於生產舒適及高功能性的運動相關產品爲我們在相關產品分部顯著的銷售增長作出貢獻。截至二零二零年十二月三十一日止年度，我們於運動服裝及服裝面料物料分部的銷售收入同比增長約36.0%至約1,696.0百萬港元。

In order to cope with the adversity as brought about by COVID-19, Best Pacific had reacted proactively by taking various actions and measures, which included the continuous capacities automation, optimisation of human resource structure and further enhancement on production efficiencies. Coupled with a relatively strong rebound in market demands in general in the second half of 2020, we observed the following improvements in the Group's financials, with (i) revenue increased by approximately 48.4% from approximately HK\$1,406.7 million in the first half of 2020 to approximately HK\$2,087.6 million in the second half of 2020; and (ii) an improved net profit margin of approximately 8.2% for the six months ended 31 December 2020.

為克服COVID-19帶來的逆境，超盈國際通過採取不同行動及措施積極應對，包括持續的產能自動化、優化人力資源結構以及進一步提升生產效率。加上於二零二零年下半年市場整體需求的反彈相對強勁，我們觀察到本集團的財務狀況出現以下改善：(i)收入由二零二零年上半年的約1,406.7百萬港元增加約48.4%至二零二零年下半年的約2,087.6百萬港元；及(ii)截至二零二零年十二月三十一日止六個月的淨利潤率上升至8.2%。

### FINANCIAL REVIEW

#### Revenue

The Group's revenue is primarily derived from the sales of its major products, which include elastic fabric, lace and elastic webbing.

For the year ended 31 December 2020, revenue amounted to approximately HK\$3,494.3 million, representing a decrease of approximately HK\$143.5 million, or approximately 3.9%, from approximately HK\$3,637.8 million for the year ended 31 December 2019. The decrease in overall revenue during the year was mainly attributable to the decrease in the volume of lingerie materials sold, as a result of less orders from customers during the pandemic time of COVID-19.

A comparison of the Group's revenue for the years ended 31 December 2020 and 2019 by product categories is as follows:

#### 財務回顧

#### 收入

本集團的收入主要源自銷售其主要產品，包括彈性織物面料、蕾絲及彈性織帶。

截至二零二零年十二月三十一日止年度，收入為約3,494.3百萬港元，較截至二零一九年十二月三十一日止年度的收入約3,637.8百萬港元減少約143.5百萬港元或約3.9%。於年內，整體收入減少主要由於COVID-19疫情期間的客戶訂單減少導致女性內衣物料銷售量減少所致。

For the year ended 31 December 2020, revenue from sales of elastic fabric amounted to approximately HK\$2,660.9 million, representing an increase of approximately HK\$19.9 million, or approximately 0.8%, as compared to the year ended 31 December 2019. In particular, our sales revenue of lingerie fabric materials decreased from approximately HK\$1,394.0 million for the year ended 31 December 2019 to approximately HK\$965.0 million for the year ended 31 December 2020, representing a year-on-year decline of approximately 30.8%. It was mainly due to the general stagnant consumer markets as impacted by COVID-19 and the forced operational restructuring of some key lingerie retailers during the year. Nevertheless, leveraging on the Group's high product quality, strong innovation and research and development capabilities, the Group had successfully entered into certain core programmes with some new partnering brands in the sportswear and apparel segment. Despite the adverse impacts as brought by COVID-19, the Group had recorded a year-on-year growth of approximately 36.0% in sales revenue of sportswear and apparel fabric materials.

With the overall lukewarm lingerie market, sales from elastic webbing and lace was on the decline, revenue from sales of elastic webbing amounted to approximately HK\$749.0 million for the year ended 31 December 2020, representing a decrease of approximately HK\$161.1 million, or approximately 17.7%, as compared to the year ended 31 December 2019. We had started supplying elastic webbing products to several face mask manufacturers during the pandemic time. The relevant income, amounted approximately HK\$39.5 million, which partly offset the decrease in sales volume of other elastic webbing products during the year ended 31 December 2020.

Revenue from sales of lace decreased from approximately HK\$86.5 million for the year ended 31 December 2019 to approximately HK\$84.3 million for the year ended 31 December 2020. The year-on-year decrease of revenue from sales of lace by approximately 2.5% was mainly due to the decrease in sales volume of lace in the year ended 31 December 2020, as compared to the year ended 31 December 2019.

### Cost of sales

The Group's cost of sales mainly comprises costs of raw materials, manufacturing overheads, and direct labour costs.

截至二零二零年十二月三十一日止年度，銷售彈性織物面料的收入為約2,660.9百萬港元，較截至二零一九年十二月三十一日止年度增加約19.9百萬港元或約0.8%。我們的女性內衣面料物料的銷售收入由截至二零一九年十二月三十一日止年度的約1,394.0百萬港元減少至截至二零二零年十二月三十一日止年度的約965.0百萬港元，同比下降約30.8%，主要受影響於COVID-19導致消費市場普遍停滯及部分主要女性內衣零售商在年內被迫進行業務重組所致。然而，憑藉優秀的產品質量、強大的創新及研發能力，本集團已成功打入運動服裝及服裝分部的新合作品牌之若干核心計劃。儘管COVID-19帶來不利影響，本集團仍錄得運動服裝及服裝面料物料的銷售收入同比增長約36.0%。

由於女性內衣市場整體冷淡，彈性織帶及蕾絲的銷售也出現下跌。截至二零二零年十二月三十一日止年度，銷售彈性織帶的收入為約749.0百萬港元，較截至二零一九年十二月三十一日止年度減少約161.1百萬港元或約17.7%。於疫情期間，我們已經開始向一些口罩製造商供應彈性織帶產品。相關收益總額約為39.5百萬港元，部分抵銷其他彈性織帶產品於截至二零二零年十二月三十一日止年度銷量減少所帶來的影響。

蕾絲銷售的收入由截至二零一九年十二月三十一日止年度的約86.5百萬港元減少至截至二零二零年十二月三十一日止年度的約84.3百萬港元。蕾絲銷售的收入同比減少約2.5%，主要是由於截至二零二零年十二月三十一日止年度的蕾絲銷量較截至二零一九年十二月三十一日止年度減少所致。

The Group's cost of sales for the year ended 31 December 2020 amounted to approximately HK\$2,650.9 million, representing a decrease of approximately HK\$114.0 million, or approximately 4.1%, as compared to the year ended 31 December 2019.

As a response to the pandemic, the Group had adopted various cost-saving measures in the year so as to curb with the adverse impact brought by COVID-19. In addition, our raw materials purchase costs had slightly declined for most time during the year ended 31 December 2020. It had offset part of the adverse impact from the diseconomies of scale caused by the decrease in sales volume of lingerie materials, as well as some of the costing pressure from the appreciation of Renminbi.

Following the expansion of our overseas manufacturing bases in Vietnam and Sri Lanka and the associated increased headcount, the direct labour cost for the year ended 31 December 2020 increased by approximately 10.7% when compared to the year ended 31 December 2019.

為了應對疫情，本集團於年內採取各種節省成本的措施，以遏制COVID-19帶來的不利影響。此外，截至二零二零年十二月三十一日止年度，我們的原材料採購成本在大部分時間略為下降。因而部分抵銷女性內衣物料銷量減少造成規模不經濟產生的不利影響，以及人民幣升值帶來的成本壓力。

隨著我們在越南及斯里蘭卡的海外生產基地擴展以及相關的員工人數增加，截至二零二零年十二月三十一日止年度的直接人工成本較截至二零一九年十二月三十一日止年度增加約10.7%。

For the year ended 31 December 2020, the cost of sales of elastic fabric as a percentage of the total cost of sales increased by approximately 2.7 percentage points year-on-year while the cost of sales of elastic webbing as a percentage of the total cost of sales decreased by approximately 3.0 percentage points. It was mainly due to the promising growth in sales volume of sportswear and apparel fabric materials and the decrease in sales volume of elastic webbing in respect of the lukewarm lingerie market during the year ended 31 December 2020.

The Group had maintained a comparable profitability level as compared to last year with the overall gross profit decreasing from approximately HK\$872.8 million for the year ended 31 December 2019 to approximately HK\$843.4 million for the year ended 31 December 2020.

Net profit of the Group for the year ended 31 December 2020 amounted to approximately HK\$249.2 million, representing a decrease of approximately 16.7% as compared to approximately HK\$299.1 million for the year ended 31 December 2019. The Group recorded a net profit margin of approximately 7.1% for the year ended 31 December 2020, representing a decrease of approximately 1.1 percentage point, as compared to the year ended 31 December 2019. The decrease in net profit margin for the year ended 31 December 2020 was mainly due to (i) the net foreign exchange loss as a result of the general appreciation of RMB during the year ended 31 December 2020; and (ii) the slower than expected ramp up at our new expansions, as adversely impacted by COVID-19.

本集團維持與去年相當的盈利能力水平，整體毛利由截至二零一九年十二月三十一日止年度約872.8百萬港元減少至截至二零二零年十二月三十一日止年度約843.4百萬港元。

本集團截至二零二零年十二月三十一日止年度的淨利潤為約249.2百萬港元，較截至二零一九年十二月三十一日止年度約299.1百萬港元減少約16.7%。截至二零二零年十二月三十一日止年度，本集團錄得淨利潤率約7.1%，較截至二零一九年十二月三十一日止年度減少約1.1個百分點。截至二零二零年十二月三十一日止年度淨利潤率下降主要是由於(i)截至二零二零年十二月三十一日止年度因人民幣整體升值而產生的匯兌虧損淨額；及(ii)受COVID-19不利影響，我們的新擴張計劃的提升慢於預期。

The increase in other income by approximately 36.3%, from approximately HK\$32.1 million for the year ended 31 December 2019 to approximately HK\$43.8 million for the year ended 31 December 2020, was mainly due to the increase in government grants and compensation income received.

### Net remeasurement of credit loss allowance for trade receivables

Net remeasurement of credit loss allowance for trade receivables represented the result of impairment assessment under expected credit loss model on trade receivables. For the year ended 31 December 2020, the net remeasurement of credit loss allowance for trade receivables amounted to approximately HK\$6.3 million, representing an increase of approximately HK\$4.0 million from approximately HK\$2.3 million for the year ended 31 December 2019. Such increase was mainly the results of the temporary delay in settlement of payments by certain customers as caused by their deteriorating financial position during the year ended 31 December 2020.

### 貿易應收款項信貸虧損撥備重新計量淨額

### Selling and distribution expenses

Selling and distribution expenses primarily consist of employee benefit expenses, transportation, marketing and promotional expenses and other selling and distribution expenses. For the years ended 31 December 2019 and 2020, the Group's selling and distribution expenses represented approximately 4.7% and 4.5% of its total revenue, respectively.

### Administrative expenses

Administrative expenses primarily consist of employee benefit expenses, depreciation, motor vehicle expenses, bank charges and other administrative expenses. For the years ended 31 December 2019 and 2020, the Group's administrative expenses represented approximately 6.1% and 7.3% of its total revenue, respectively. The increase in ratio of administrative expenses against total revenue was mainly due to the slower than expected ramp up at our new expansions, as adversely impacted by COVID-19.

### Research and development costs

The Group is dedicated to cater to the changing market preferences by introducing innovative lingerie, sportswear and apparel materials. For the years ended 31 December 2019 and 2020, the Group's research and development costs represented approximately 2.7% and 2.3% of its total revenue, respectively. The decrease in research and development costs was mainly due to the integration of research and development projects and other cost-saving measures launched during the pandemic time in the year ended 31 December 2020.

### 銷售及分銷開支

銷售及分銷開支主要包括僱員福利開支、運輸、市場推廣及宣傳開支以及其他銷售及分銷開支。截至二零一九年及二零二零年十二月三十一日止年度，本集團的銷售及分銷開支分別佔總收入的約4.7%及4.5%。

### 行政開支

行政開支主要包括僱員福利開支、折舊、汽車開支、銀行費用及其他行政開支。本集團於截至二零一九年及二零二零年十二月三十一日止年度的行政開支分別佔總收入的約6.1%及7.3%。行政開支佔總收入的比例增加，主要是由於受COVID-19不利影響，我們的新擴張計劃的提升慢於預期所致。

### 研發費用

本集團致力於引入創新的女性內衣、運動服裝及服裝物料，藉以迎合不斷變化的市場喜好。截至二零一九年及二零二零年十二月三十一日止年度，本集團的研發費用分別佔總收入約2.7%及2.3%。研發費用減少主要由於我們於截至二零二零年十二月三十一日止年度疫情期間將研發專案整合及推出的其他節省成本措施所致。

### Finance costs

The Group's finance costs mainly represent interest expenses for bank borrowings and lease liabilities. The finance costs decreased by approximately 16.6% from approximately HK\$90.8 million for the year ended 31 December 2019 to approximately HK\$75.7 million for the year ended 31 December 2020. The decrease in finance costs was primarily due to the overall decrease in average borrowings balance of the Group as well as market interest rate during the year ended 31 December 2020.

### Income tax expense

Under the two-tiered profits tax rates regime passed by the Hong Kong Legislative Council in March 2018, the first HK\$2 million of profits of the qualifying group entity will be taxed at 8.25%, and profits above HK\$2 million will be taxed at 16.5%. The profits of group entities not qualifying for the two-tiered profits tax rates regime will continue to be taxed at a flat rate of 16.5%. The two-tiered profits tax rates regime is applicable to any year of assessment commencing on or after 1 April 2018.

Accordingly, the Hong Kong Profits Tax for the qualifying group entity had been calculated at 8.25% on the first HK\$2 million of the estimated assessable profits and at 16.5% on the estimated assessable profits above HK\$2 million.

Under the Law of the PRC on Enterprise Income Tax (the "EIT Law") and Implementation Regulation of the EIT Law, the tax rate of the PRC companies is 25% for both years ended 31 December 2019 and 2020, unless there is any applicable preferential tax treatment.

The Company's subsidiaries, Dongguan Best Pacific Textile Company Limited ("**Dongguan BPT**") and Dongguan New Horizon Elastic Fabric Company Limited ("**Dongguan NHE**"), had obtained the qualification as high and new technology enterprises since 2010 and 2016, respectively, which were renewed for an additional three years from the year ended 31 December 2019. Hence, Dongguan BPT and Dongguan NHE had been subject to the preferential tax treatment and the applicable tax rate for the years ended 31 December 2019 and 2020 was 15%.

### 融資成本

本集團的融資成本主要指銀行借款及租賃負債的利息開支。融資成本由截至二零一九年十二月三十一日止年度約90.8百萬港元減少約16.6%至截至二零二零年十二月三十一日止年度約75.7百萬港元。融資成本的減少乃主要由於截至二零二零年十二月三十一日止年度的本集團平均借款結餘及市場利率整體減少所致。

### 所得稅開支

根據香港立法會於二零一八年三月通過的利得稅兩級制，合資格集團實體的首2百萬港元溢利將按8.25%的稅率徵稅，而超過2百萬港元的溢利將按16.5%的稅率徵稅。不符合該利得稅兩級制資格的集團實體之溢利將繼續按16.5%之劃一稅率徵稅。利得稅兩級制將適用於自二零一八年四月一日或之後起計的任何評估年度。

因此，合資格集團實體之香港利得稅已按首2百萬港元之估計應課稅溢利的8.25%及超過2百萬港元之估計應課稅溢利的16.5%計算。

根據中國企業所得稅法及企業所得稅法的實施細則，除非有任何其他適用優惠稅率待遇，否則中國公司於截至二零一九年及二零二零年十二月三十一日止兩個年度的稅率為25%。

本公司的附屬公司東莞超盈紡織有限公司（「東莞超盈」）及東莞潤信彈性織物有限公司（「東莞潤信」）分別自二零一零年及二零一六年起獲得高新技術企業資格，有效期已自截至二零一九年十二月三十一日止年度額外延長三年。因此，東莞超盈及東莞潤信享有優惠稅率待遇，於截至二零一九年及二零二零年十二月三十一日止年度的適用稅率為15%。

Withholding tax on dividends was calculated at 5% of the estimated dividend to be received from the subsidiaries in the PRC during the year.

Pursuant to the relevant Vietnam Enterprises Income Tax rules and regulations, the applicable tax rate for the subsidiary operating in Vietnam is 20%. The subsidiary in Vietnam is eligible for tax holiday for two financial years since the first financial year of taxable profit and tax concession at a tax rate of 10% for the following four financial years. With the new incentive in place during the year ended 31 December 2018 and by fulfilling certain stated requirements as set by the Ministry of Industry and Trade, the subsidiary in Vietnam had been eligible for tax holiday for four financial years since 2018, tax concession at a tax rate of 5% for the following nine financial years and tax concession at a tax rate of 10% for the next following two financial years.

Pursuant to the Inland Revenue Act, No. 24 of 2017 in Sri Lanka, the applicable tax rate for the subsidiaries operating in Sri Lanka is 28%. By fulfilling certain export requirements as set by the Board of Investment of Sri Lanka, the subsidiaries of the Group in Sri Lanka had enjoyed a preferential tax rate of 14% for the years ended 31 December 2019 and 2020. In addition, one of these subsidiaries is currently eligible for tax holiday till the year ending 31 December 2024.

Taxation arising in any other jurisdiction is calculated at the rate prevailing in the relevant jurisdiction.

The effective tax rate was approximately 14.1% (for the year ended 31 December 2019: 11.2%) for the year ended 31 December 2020. The increase in effective tax rate was mainly due to the increase in withholding tax being recognised as more dividends are expected to be distributed from subsidiaries.

根據相關越南企業所得稅規則及規例，於越南營運之附屬公司的適用稅率為20%。越南附屬公司於首個錄得應課稅溢利的財政年度起合資格享有兩個財政年度的稅項豁免，及於其後四個財政年度享有稅率10%的稅務優惠。於截至二零一八年十二月三十一日止年度獲授新的激勵並滿足若干自工貿部的規定要求後，越南附屬公司自二零一八年起合資格享有四個財政年度的稅項豁免，及於其後九個財政年度享有稅率5%的稅務優惠，以及於接下來的兩個財政年度享有稅率10%的稅務優惠。

根據斯里蘭卡國內稅收法（二零一七年第24號），於斯里蘭卡營運之附屬公司的適用稅率為28%。本集團於斯里蘭卡的附屬公司藉由滿足斯里蘭卡投資局制定的若干出口要求而於截至二零一九年及二零二零年十二月三十一日止年度享有14%的優惠稅率。此外，其中一間附屬公司現享有稅項豁免直至截至二零二四年十二月三十一日止年度為止。

其他司法權區之稅項乃按有關司法權區當時之稅率計算。

截至二零二零年十二月三十一日止年度的實際稅率約為14.1%（截至二零一九年十二月三十一日止年度：11.2%）。實際稅率上升主要是由於預期將自附屬公司分派更多股息導致確認預扣稅增加所致。

### Liquidity, financial resources and bank borrowings

As at 31 December 2020, net working capital (calculated as current assets less current liabilities) was approximately HK\$794.3 million, representing an increase of approximately HK\$787.3 million as compared with 31 December 2019. The current ratio (calculated as current assets/current liabilities) is at 1.4 times as at 31 December 2020 as compared to 1.0 time as at 31 December 2019.

For the year ended 31 December 2020, net cash generated from operating activities increased from approximately HK\$407.8 million for the year ended 31 December 2019 to approximately HK\$754.2 million for the year ended 31 December 2020, which was mainly due to the Group's better management on its inventories level.

Net cash used in investing activities amounted to approximately HK\$212.7 million for the year ended 31 December 2020, as compared to net cash used in investing activities amounting to approximately HK\$512.7 million for the year ended 31 December 2019. As impacted by the pandemic, the decrease in net cash used in investing activities was mainly due to less investments being made during the year ended 31 December 2020.

During the year ended 31 December 2020, net cash used in financing activities amounted to approximately HK\$47.8 million, as compared to net cash from financing activities of approximately HK\$210.2 million for the year ended 31 December 2019. The increase in net cash used in financing activities for the year ended 31 December 2020 was mainly due to the overall stronger cash positions and less reliance on bank borrowings of the Group through out the year ended 31 December 2020.

### 流動資金、財務資源及銀行借款

於二零二零年十二月三十一日，營運資金淨額（按流動資產減流動負債計算）為約794.3百萬港元，較二零一九年十二月三十一日增加約787.3百萬港元。流動比率（按流動資產除流動負債計算）於二零二零年十二月三十一日為1.4倍，而於二零一九年十二月三十一日則為1.0倍。

截至二零二零年十二月三十一日止年度，經營活動所得現金淨額由截至二零一九年十二月三十一日止年度約407.8百萬港元增加至截至二零二零年十二月三十一日止年度約754.2百萬港元，乃主要由於本集團採取更好的存貨水平管理所致。

截至二零二零年十二月三十一日止年度，投資活動所用現金淨額為約212.7百萬港元，而截至二零一九年十二月三十一日止年度的投資活動所用現金淨額為約512.7百萬港元。受疫情影響，截至二零二零年十二月三十一日止年度的投資活動所用現金淨額減少乃主要由於所作出的投資較少所致。

截至二零二零年十二月三十一日止年度的融資活動所用現金淨額為約47.8百萬港元，而截至二零一九年十二月三十一日止年度的融資活動所得現金淨額為約210.2百萬港元。截至二零二零年十二月三十一日止年度的融資活動所用現金淨額增加乃主要由於本集團截至二零二零年十二月三十一日止年度全年的整體現金狀況較強健且對銀行借款的依賴減少所致。

As at 31 December 2020, the Group's net gearing ratio was 36.7% (as at 31 December 2019: 59.1%), which was calculated on the basis of the amount of net debt position (sum of bank deposits and bank balances and cash, less total bank and other borrowings) as a percentage of total equity. Details of bank borrowings are set out in Note 27 to the consolidated financial statements. The Group was in a net debt position of approximately HK\$1,107.4 million as at 31 December 2020, as compared to a net debt position of approximately HK\$1,546.7 million as at 31 December 2019.

The increase in trade and bills receivables turnover days for the year ended 31 December 2020 by approximately 7.3 days was primarily due to the temporary delay in settlement of payments by some customers whose businesses were adversely impacted by COVID-19.

### Capital expenditure

The capital expenditure in 2020 primarily represented payments for expansion contracted for in prior years. The Group's total addition to property, plant and equipment decreased from approximately HK\$522.4 million for the year ended 31 December 2019 to approximately HK\$290.9 million for the year ended 31 December 2020, which was mainly attributable to the relatively conservative investment appetite of the Group during the pandemic time in 2020.

### Pledge of assets

As at 31 December 2020, the Group pledged certain bank deposits, amounting to approximately HK\$77.9 million (as at 31 December 2019: approximately HK\$76.8 million), to secure the bills payables issued by the Group.

### Contingent liabilities

As at 31 December 2020, the Group did not have any significant contingent liabilities.

### Events after the reporting period

Save as disclosed in this annual report, the Group has no other significant events after the reporting period and up to the date of this annual report.

### Foreign exchange risk

A substantial portion of the Group's revenue is denominated in US\$ and HK\$ and a portion of its purchases and expenses are denominated in RMB, Vietnam Dong and Sri Lanka Rupee. The Group manages its foreign exchange risk by performing regular reviews and monitoring on its foreign exchange exposure. Our finance department monitors our foreign exchange risk on a continuous basis by analysing our domestic and overseas sales orders on hand, expected domestic and overseas orders from customers and estimated foreign currency payments for our purchases and expenses. ### Employees and remuneration policies

As at 31 December 2020, the Group employed a total of 7,825 full-time employees (as at 31 December 2019: 7,437). The increase in the number of employees was mainly due to the overseas expansion during the year.

The remuneration committee of the Company (the “**Remuneration Committee**”) was set up for reviewing the Group’s remuneration policy and structure for all remuneration of the Directors and employees of the Group, having regard to factors including but not limited to salaries paid by comparable companies, time commitment and responsibilities of the Directors/employees, employment conditions elsewhere in the Group, and whether the remuneration is commensurate with performance.

There has been no significant change in the Group’s remuneration policy, and the Group will continue to provide regular training and competitive remuneration packages to its staff. The Group’s remuneration packages include salary, bonuses, allowances and retirement benefits based on employee’s performance, skills and knowledge. The Group also provides additional benefits to its employees that include subsidised accommodation, meals, accident and medical insurance and share options granted to eligible employees under the share option scheme of the Company from time to time.

The Board intends to maintain a long term, stable dividend payout ratio of not less than 20% of the Group's distributable profit for the year, providing shareholders with an equitable return.

The Board has resolved to declare a final dividend of HK7.4 cents per ordinary share in respect of the year ended 31 December 2020 (the **"Final Dividend"**) (for the year ended 31 December 2019: HK5.8 cents). The Final Dividend is expected to be paid on or about 30 July 2021 to shareholders whose names appear on the register of members of the Company on 8 June 2021, subject to the approval by the shareholders at the forthcoming annual general meeting of the Company on 28 May 2021 (the **"AGM"**).

The Board has resolved not to declare any interim dividend for the six months ended 30 June 2020 (for the six months ended 30 June 2019: nil).

### FUTURE STRATEGIES AND PROSPECTS

The global future economy is still under the shadow by uncertainties stemming from the Sino – U.S. trade war and COVID-19. Nevertheless, we have seen a strong sales rebound since the second half of 2020. With mass COVID-19 vaccination by the general public around the world, the pandemic situation is expected to be stabilised and the pace of market recovery is anticipated to accelerate in 2021. In recent months, the market sentiment has continued to improve and we have seen healthy business development with both our sportswear and lingerie customers.

Best Pacific will continue to differentiate itself from its market peers and we are set to uphold our core value “Built on Innovation and Technology” to cater for the rising market demand for innovative apparel products, especially amid the current popular athleisure trend. This growing health consciousness will continue in the coming future and the sales revenue from our sportswear and apparel fabric materials segment is expected to remain as one of our growth drivers in the near future. While keeping a close eye on both domestic and international markets, the retail markets in the PRC is perceived to recover the fastest in 2021. The Group has prepared to seize more business opportunities from the newly developed sportswear and apparel clients in the PRC market.

As at 31 December 2020, the overall annual designed production capacities of elastic fabric, elastic webbing and lace of the Group were approximately 226.2 million meters, 1,872.2 million meters and 45.0 million meters, respectively. In order to cope with the growing market demands, the Group will continue its capacity expansion, both domestically and in overseas, at a moderate pace in the coming years. Being one of the pioneer market player to establish manufacturing facilities in Vietnam, we are optimistic about the industrial and economic development in the country. We will continue to explore the feasibility of further capacity expansion in Vietnam, with an eminent focus on maximizing the relevant investment returns. As expected, COVID-19 pandemic has delayed, to a certain extent, our 2020 expansion plan in Sri Lanka and we will revisit the relevant plan and strive to improve the manufacturing efficiencies at our Sri Lanka operations as soon as we can.

Because of the rebound of crude oil price, as well as the relatively low level of petroleum refinery activities, the market prices of many oil by-products and chemical raw materials had soared since the fourth quarter of 2020. Nevertheless, the tension in employment market in the PRC and Vietnam will also continue to add weight to our staff costs in the near future. We are trying hard to digest these pressures, including but not limited to further optimisation of production efficiencies, benefits from economies of scale alongside the market recovery, as well as exploring the possibilities of price adjustments on our products with our customers and partnering brands.

Best Pacific will continue to grasp the vast opportunities arising from the sportswear and apparel sector. We strongly believe that, through our continual expansion, it will underpin Best Pacific's long-term sustainability and ensure its ability to deliver value for its shareholders in the long run.

## ENVIRONMENTAL POLICIES AND PERFORMANCE

The Group has been committed to operating in compliance with applicable environmental laws and regulations and has taken steps to ensure that any waste and by-products produced as a result of its operations are properly treated and discharged so as to minimise the adverse effects to the environment. With the relevant ISO certification issued by renown notified body on the main manufacturing sites, we are regarded to have exercised quality environmental and energy management throughout the manufacturing process. At present, the Group has its on-site sewage treatment plants that treat sewage generated from its production process, in particular, dyeing and printing processes, by chemical and biological treatments. Processed sewage is required to meet certain chemical standards prescribed by the environmental protection department before it is discharged to the municipal sewage treatment network. The environmental protection department has also set up monitoring equipment at the Group's sewage treatment plants to ensure the processed sewage meets the prescribed standard before discharge. As the operating scale of the Group has expanded, the use of resources, the levels of gas emissions and waste disposal increased proportionally but all were under control during the year under review. We will continue to closely monitor the resources consumed and the levels of gas emissions and waste disposal and will take appropriate measures with a view to minimising the impact of the Group's operations to the environment.

Further details on the Group's environmental policies and performance (including the relevant key performance indicators) will be disclosed in the Group's Environmental, Social and Governance Report 2020 to be separately published by the Company in due course.

Pursuant to which, the term that the total amount of bonus together with the total salary and benefits to be paid to all the executive Directors of the Company in each year ending December 31 be less than 10% of the audited consolidated net profit after taxation but before extraordinary items of the Group for the relevant financial year (and before deducting such discretionary bonus, salary and benefits) was repealed. On the other hand, the Group has introduced additional incentive schemes with salary payments not exceeding 10% of the basic salaries to be paid monthly to employees if the Group accomplishes the monthly key performance indicators set. Such incentive scheme also applies to all executive Directors and the relevant service agreements have been revised accordingly.

The principal terms of the Pre-IPO Share Option Scheme are substantially the same as the terms of the Share Option Scheme which has also been conditionally adopted by the Company pursuant to the aforesaid resolution, except that:

- (a) The subscription price is, subject to certain adjustments set out in the Pre-IPO Share Option Scheme, equivalent to 50% discount to the offer price under the IPO.
- (b) The maximum number of shares of the Company which may be issued upon exercise of all options granted under the Pre-IPO Share Option Scheme is 30,000,000 shares, representing approximately 2.89% of the issued share capital of the Company as at the date of this annual report (i.e. 1,039,808,000 shares).

On 19 May 2014, the Company has conditionally granted options to subscribe for a total of 26,470,000 shares of the Company to certain directors and employees of the Group under the Pre-IPO Share Option Scheme.

As at 31 December 2020, there was no outstanding option under the Pre-IPO Share Option Scheme.

### (b) Share Option Scheme

The principal terms of the Share Option Scheme, which shall be valid and effective for 10 years from its adoption date, are summarised below:

#### Purpose

The purpose of the Share Option Scheme is to reward the eligible participants who have contributed to the Group and to encourage them to work towards enhancing the value of the Company and its shareholders.

Subject to the following paragraph, the maximum number of shares which may be issued upon exercise of all options to be granted under the Share Option Scheme and any other share option schemes of the Company must not, in aggregate, exceed 10% of the number of shares of the Company in issue on the Listing Date (not taking into account any shares which may be allotted and issued pursuant to the over-allotment option under the IPO) (the “**Scheme Mandate Limit**”). Options lapsed in accordance with the terms of the Share Option Scheme and (as the case may be) such other share option schemes of the Company will not be counted for the purpose of calculating the Scheme Mandate Limit.

The Company may, from time to time, refresh the Scheme Mandate Limit by obtaining the approval of the shareholders in general meeting, provided that the total number of shares which may be issued upon exercise of all options to be granted under the Share Option Scheme and any other share option schemes of the Company under the limit as refreshed must not exceed 10% of the shares of the Company in issue as at the date of the shareholders’ approval of the refreshed limit.

**a. Memorandum of Understanding in relation to the proposed acquisition of assets to be acquired from Textprint Lanka (Private) Limited**

On 8 January 2020, Trischel Fabric (Private) Limited (“**Trischel**”) (a non-wholly owned subsidiary of the Company) entered into the legally binding memorandum of understanding (the “**MOU**”) with Textprint Lanka (Private) Limited (“**Textprint**”), pursuant to which Trischel has conditionally agreed to purchase and Textprint has conditionally agreed to sell the assets which mainly consist of printing machines, washing machines, boilers, steamers, fabric inspection machines, dryers and other equipment for printing synthetic fabrics and the associated finishing processes (the “**Assets**”) at a consideration of no more than US\$4 million (equivalent to approximately HK\$31.2 million).

Textprint is an indirect wholly-owned subsidiary of MAS, which indirectly holds 49% of the issued share capital of Trischel. Accordingly, Textprint is a connected person of the Company at the subsidiary level under Rule 14A.06(9) of the Listing Rules. One or more of the applicable percentage ratios in respect of the transaction contemplated under the MOU exceeds 1% but all of them are less than 5%. Accordingly, the transaction contemplated under the MOU is subject to the reporting and announcement requirements but exempt from the independent shareholders' approval requirement under Chapter 14A of the Listing Rules.

Further details of the MOU were disclosed in the Company's announcement dated 8 January 2020.

Subsequently, on 29 January 2021, Trischel and Textprint entered into an assets sale and purchase agreement for acquisitions of the Assets. Further details of the acquisition were disclosed in the Company's announcement dated 29 January 2021.

### b. Renewal of leases of certain premises for the use of production plant and dormitories in Humen Town and Houjie Town

As disclosed in the Prospectus, on 1 January 2014, the Humen branch of Dongguan NHE, an indirect wholly-owned subsidiary of the Company, as lessee and Mr. Lu, as lessor, the Chairman and controlling shareholder of the Company, entered into a lease contract in relation to the lease of certain buildings with a gross floor area of approximately 5,835 square meters in Humen Town, Dongguan City, Guangdong Province, China (the "**Humen Lease Contract**"), for the use as a production plant and dormitories for the staff of the Group for a term of three years from 1 January 2014 to 31 December 2016. Besides, Dongguan NHE as lessee and Mr. Lu as lessor entered into two lease contracts in relation to the lease of certain buildings with a total gross floor area of approximately 17,370 square meters in Houjie Town, Dongguan City, Guangdong Province, China (the "**Houjie Lease Contracts**"), for the use as administrative offices, a production plant and dormitories for the staff of the Group for a term of three years from 1 January 2014 to 31 December 2016.

誠如招股章程所披露，於二零一四年一月一日，東莞潤信虎門分行（本公司一間間接全資附屬公司，作為承租人）與本公司主席兼控股股東盧先生（作為出租人）就租賃中國廣東省東莞市虎門鎮總建築面積約5,835平方米的若干樓宇訂立一份租賃合同（「**虎門租賃合同**」），將其用作本集團的生產廠房及員工宿舍，租期自二零一四年一月一日至二零一六年十二月三十一日止為期三年。此外，於二零一四年一月一日，東莞潤信（作為承租人）與盧先生（作為出租人）就租賃中國廣東省東莞市厚街鎮總建築面積約17,370平方米的若干樓宇訂立兩份租賃合同（「**厚街租賃合同**」），將其用作本集團的行政辦公室、生產廠房及員工宿舍，租期自二零一四年一月一日至二零一六年十二月三十一日止為期三年。

To ensure the continuous use of those buildings, each of the Humen Lease Contract and the Houjie Lease Contracts was renewed for a term of three years commencing from 1 April 2017 to 31 March 2020. Further details were disclosed by the Company in its announcement dated 31 March 2017.

On 31 March 2020, the above lease contracts were again renewed for a term of three years commencing from 1 April 2020 to 31 March 2023. The terms under the renewed lease contracts are substantially the same as those of the original agreements, save for the monthly rents.

The rental so charged by Mr. Lu under the lease contracts is determined with reference to the historical rents and the prevailing market rents for similar premises in the same or nearby areas or similar locations in the PRC.

The terms under the Renewed Humen Lease Contract are substantially the same as those under the Humen Lease Contract, save that the maximum monthly rental payable for the financial year ended 31 December 2020 should be RMB116,525. The rental so charged by Mr. Lu is determined by reference to the historical rents of those buildings, the prevailing market rents for similar premises in the same or nearby areas or similar locations in China, the terms and conditions of the Renewed Humen Lease Contract, the historical trend and the expected increase in the rents in the PRC property market and inflation. Further details of the Renewed Humen Lease Contract were disclosed by the Company in its announcement dated 31 March 2017.

The rental so charged by Mr. Lu is determined by reference to the historical rents of those buildings, the prevailing market rents for similar premises in the same or nearby areas or similar locations in China, the terms and conditions of the Renewed Houjie Lease Contracts, the historical trend and the expected increase in the rents in the PRC property market and inflation. Further details of the Renewed Houjie Lease Contracts were disclosed by the Company in its announcement dated 31 March 2017.

During the year ended 31 December 2020, rental paid to Mr. Lu by the Group under the Renewed Houjie Lease Contracts amounted to RMB945,798 (equivalent to approximately HK\$1,051,446).

On 25 September 2015, Dongguan BPT, an indirect wholly-owned subsidiary of the Company, as lessee, and Dongguan Quality Clothing Company Limited (“**Dongguan Clothing**”) as lessor entered into a lease agreement (the “**Machong Lease Agreement**”) in relation to the lease of a property with a total leasing area of approximately 21,868 square meters in Machong Town, Dongguan City, Guangdong Province, China for the Group's daily production and operational use at a monthly rental of RMB328,020. The lease was for a term of three years from 1 October 2015 to 30 September 2018, and was terminable by mutual agreement.

To ensure the continuous use of the property, on 28 September 2018, Dongguan BPT and Dongguan Clothing entered into a lease agreement (the “**Renewed Machong Lease Agreement**”) for renewal of the above lease agreement for a term of three years commencing from 1 October 2018 to 30 September 2021. The terms under the Renewed Machong Lease Agreement are substantially the same as those under the above lease agreement, save that the monthly rental payable under the Renewed Machong Lease Agreement for the first year of the lease (i.e. from 1 October 2018 to 31 December 2018) shall be RMB393,624 and the maximum annual rent for the second year and third year of the lease shall not exceed RMB5,195,837 and RMB5,715,420 respectively. The rental so charged by Dongguan Clothing is determined by reference to (i) the historical rents of the property; (ii) the prevailing market rents of similar properties in the same or nearby areas or similar locations in the PRC; (iii) the conditions of the property, including but not limited to the location of the property as well as the facilities associated with the property; and (iv) the historical trend and the expected increase in the

On 3 May 2019, Dongguan BPT and Dongguan NHE (as suppliers) entered into a sales agreement (the “**Renewed Sales Agreement**”) with Dongguan Clothing (as purchaser) in relation to the sale of elastic fabric, elastic webbing, lace, printing and embroidery for a term of three years commencing from 4 May 2019 to 3 May 2022. Pursuant to the Renewed Sales Agreement, the selling prices for elastic fabric shall be between the price range of RMB5 to RMB200 per meter (tax inclusive); the selling prices for lace shall be between the price range of RMB0.5 to RMB80 per meter (tax inclusive); the selling prices for printing and embroidery shall be between the price range of RMB5 to RMB40 per meter (tax inclusive) or the price range of RMB0.5 to RMB15 per piece (tax inclusive); and the selling prices for elastic webbing shall be between the price range of RMB0.5 to RMB2 per meter (tax inclusive). The selling price ranges for the goods under the Renewed Sales Agreement were determined after arm’s length negotiation between the parties thereto and with reference to (i) the historical and prevailing market price of the same and similar goods in the area, (ii) the historical and prevailing selling prices of Dongguan BPT and Dongguan NHE for the goods, and (iii) the credit worthiness and potential business growth of Dongguan Clothing. ### e. Sales of synthetic fabric and webbing to the Brandix Group

On 6 November 2017, Best Pacific Textile Holdings Limited (“BPTHL”), a wholly-owned subsidiary of the Company, entered into a framework agreement (the “**Brandix Framework Agreement**”) with Brandix for a term of three years commencing from 6 November 2017. Further details of the Brandix Framework Agreement were disclosed in the Company’s announcement dated 6 November 2017.

The annual cap for the transaction amounts under the Brandix Framework Agreement for the period from 1 January 2020 to 5 November 2020 was US\$64 million. From 1 January 2020 to 5 November 2020, sales to Brandix under the Brandix Framework Agreement amounted to approximately USD10,404,445 (equivalent to approximately HK\$81,154,671).

On 6 November 2020, BPTHL and its affiliates (collectively, the “**BPTHL Group**”) (as seller) and Brandix and its affiliates (collectively, the “**Brandix Group**”) (as purchaser) entered into a sales framework agreement (the “**Renewed Brandix Framework Agreement**”) relating to the sale and purchase of the synthetic fabric and webbing (or any other products as may be agreed between the parties) from time to time on normal commercial terms and subject to and upon the terms and conditions to be agreed between the relevant members of the BPTHL Group and the Brandix Group, setting out, among other things, the products to be supplied, specifications, quantity, price, delivery method and payment arrangement.

The annual caps for the transaction amounts under the Renewed Brandix Framework Agreement for the period from 6 November 2020 to 31 December 2020 was US\$7 million and for the financial years ending 31 December 2021, 2022 and 2023 shall be US\$43 million, US\$63 million and US\$64 million respectively. During the period from 6 November 2020 to 31 December 2020, the sales to the Brandix Group by the BPTHL Group under the Renewed Brandix Framework Agreement amounted to approximately US\$2,424,821 (equivalent to approximately HK\$18,913,604). Further details of the Renewed Brandix Framework Agreement were disclosed in the Company's announcement dated 6 November 2020.

As at 6 November 2020 and the date of this annual report, BPTL, a non-wholly owned subsidiary of the Company, is owned as to 75% by the Company, via Best Pacific International Sri Lanka (Pannala) Limited, and 25% by Brandix. Accordingly, Brandix, as a substantial shareholder of BPTL, is a connected person of the Company at the subsidiary level under Rule 14A.06(9) of the Listing Rules.

**f. Sub-lease of a land for the use of production plant by MAS Fabric Park**

On 22 December 2006, Trischel, a non-wholly owned subsidiary of the Company since completion of the acquisition on 1 August 2018, entered into an agreement (the “**Sub-Lease Agreement**”) with MAS Fabric Park (Private) Limited (“**MAS Fabric Park**”), an indirect wholly-owned subsidiary of MAS and a substantial shareholder of Trischel, for sub-leasing a piece of land, situated in Nangalla and Thuhiriya Villages in the District of Kegalle, Sabaragamuwa Province, Sri Lanka, with an approximate area of 3.37818 hectares, to Trischel for a term of 98 years and 7 months commencing on 22 December 2006 and ending on 29 July 2105.

Pursuant to the Sub-Lease Agreement, the initial ground rent was US\$29,218 per annum as at signing of the Sub-Lease Agreement, which shall be adjusted annually in line with the ground rent charged or chargeable at other industrial zones as published by Board of Investment of Sri Lanka (“**BOI**”), a governmental authority in Sri Lanka, and shall be paid on or before 22 December each year.

The annual caps for the transaction amounts under the Sub-Lease Agreement for the financial year ended 31 December 2020 was US\$68,000 and for the financial years ending 31 December 2021 and 2022 shall be US\$81,000 and US\$97,000 respectively. During the year ended 31 December 2020, the ground rent paid to MAS Fabric Park by Trischel under the Sub-Lease Agreement amounted to approximately US\$34,831 (equivalent to approximately HK\$271,682). Further details of the Sub-Lease Agreement were disclosed in the Company’s announcement dated 4 December 2017.

Since completion of the acquisition on 1 August 2018, Trischel has become a non-wholly owned subsidiary of the Company in which 51% is indirectly owned by the Company, via Best Pacific International Sri Lanka (Thulhiriya) Limited, and 49% is owned by MAS Capital (Private) Limited (“**MAS Capital**”), which is a wholly-owned subsidiary of MAS. Accordingly, MAS Fabric Park, as an indirect wholly-owned subsidiary of MAS, has become a connected person of the Company at the subsidiary level under Rule 14A.06(9) of the Listing Rules since 1 August 2018.

根據分租協議，於簽訂分租協議時之最初地租為每年29,218美元，可每年按斯里蘭卡投資局（「**投資局**」，一個於斯里蘭卡的政府機關）所公佈在其他工業區內收取或應收的地租水平予以調整，並應於每年十二月二十二日或之前支付。

分租協議項下載至二零二零年十二月三十一日止財政年度、截至二零二一年及二零二二年十二月三十一日止財政年度的交易金額年度上限分別為68,000美元、81,000美元及97,000美元。截至二零二零年十二月三十一日止年度，Trischel根據分租協議向MAS Fabric Park支付的地租為約34,831美元（相當於約271,682港元）。有關分租協議的進一步詳情已於本公司日期為二零一七年十二月四日之公告中披露。

自收購事項於二零一八年八月一日完成後，Trischel已成為本公司非全資附屬公司，由本公司通過Best Pacific International Sri Lanka (Thulhiriya) Limited間接擁有51%股權及由MAS全資附屬公司MAS Capital (Private) Limited（「**MAS Capital**」）擁有49%股權。因此，根據上市規則第14A.06(9)條，MAS間接全資附屬公司MAS Fabric Park自二零一八年八月一日起已成為本公司在附屬公司層級之關連人士。



**g. Utilities services provided by MAS Fabric Park**

On 22 December 2006, Trischel also entered into a services agreement (the “**Services Agreement**”) with MAS Fabric Park, pursuant to which MAS Fabric Park shall provide Trischel with electricity, steam, water, effluent discharge and fire hydrant water supply. The Services Agreement shall come into force and will be valid so long as the Sub-Lease Agreement remains valid and effective.

The initial monthly base service charge payable by Trischel to MAS Fabric Park was US\$5,000 as at signing of the Services Agreement which shall be adjusted annually with reference to the London Interbank Offered Rate (“**LIBOR**”). In addition to the monthly base service charge, Trischel shall also pay to MAS Fabric Park the utilities fees in amounts calculated with reference to the actual number of units or volume of use.

The annual caps for the transaction amounts under the Services Agreement for the financial year ended 31 December 2020 was US\$3,495,000 and for the financial years ending 31 December 2021 and 2022 shall be US\$8,093,000 and US\$9,462,000 respectively. During the year ended 31 December 2020, the total service charge paid to MAS Fabric Park by Trischel under the Services Agreement amounted to approximately US\$2,893,481 (equivalent to approximately HK\$22,569,152). Further details of the Services Agreement were disclosed in the Company’s announcement dated 4 December 2017.

**g. MAS Fabric Park提供公用設施服務**

於二零零六年十二月二十二日，Trischel亦與MAS Fabric Park訂立服務協議（「**服務協議**」），據此，MAS Fabric Park須向Trischel提供電力、蒸汽、用水、污水排放及消防栓供水系統。凡分租協議仍屬有效及具效力，服務協議將生效及有效。

服務協議項下截至二零二零年十二月三十一日止財政年度、截至二零二一年及二零二二年十二月三十一日止財政年度的交易金額年度上限分別為3,495,000美元、8,093,000美元及9,462,000美元。截至二零二零年十二月三十一日止年度，Trischel根據服務協議向MAS Fabric Park支付的服務費總額為約2,893,481美元（相當於約22,569,152港元）。有關服務協議的進一步詳情已於本公司日期為二零一七年十二月四日之公告中披露。

### **h. Installation, maintenance and operation services in relation to a biomass thermic oil heater provided by MAS Fabric Park**

On 15 July 2016, Trischel entered into a MOU with MAS Fabric Park in relation to provision by MAS Fabric Park to Trischel of installation, maintenance and operation services in relation to a biomass thermic oil heater for a term of 10 years commencing from 15 July 2016 and ending on 14 July 2026. MAS Fabric Park shall bear the total cost of investment on purchasing and installation of the said heater pursuant to the MOU.

MAS Fabric Park shall charge Trischel at a rate determined according to the MOU for the energy consumed subject to review (and agreement between the parties to the MOU) annually in line with the percentage change in firewood prices and costs of labour, maintenance and electricity relating to the operation of the oil heater. MAS Fabric Park shall in addition to the above costs, charge a minimal administrative charge.

The annual caps for the transaction amounts under the MOU for the financial year ended 31 December 2020 was US\$1,127,000 and for the financial years ending 31 December 2021 and 2022 shall be US\$2,321,000 and US\$2,715,000 respectively. During the year ended 31 December 2020, the total service charge paid to MAS Fabric Park by Trischel under the MOU amounted to approximately US\$495,015 (equivalent to approximately HK\$3,861,117). Further details of the MOU were disclosed in the Company's announcement dated 4 December 2017.

### **h. MAS Fabric Park提供有關生物質導熱油加熱器之安裝、維護及營運服務**

於二零一六年七月十五日，Trischel與MAS Fabric Park訂立諒解備忘錄，內容有關MAS Fabric Park向Trischel提供生物質導熱油加熱器之安裝、維護及營運相關服務，為期10年，自二零一六年七月十五日起至二零二六年七月十四日止。根據諒解備忘錄，MAS Fabric Park應承擔購買及安裝上述加熱器之總投資成本。

MAS Fabric Park將按根據諒解備忘錄所載的收費率，就所耗用的能源向Trischel收取費用，並可每年參照木柴價格及勞工、有關營運導熱油加熱器之維護及電力的成本之變動百分比率作檢討（及由諒解備忘錄訂約方之間協商）。除上述費用外，MAS Fabric Park將收取最小的行政費用。

i. **Sales of synthetic textiles and textile related products to the MAS Group**

On 4 December 2017, BPTHL, a wholly-owned subsidiary of the Company, entered into a framework agreement (the “**MAS Framework Agreement**”) with MAS Capital for a term of three years commencing on the date on which the completion of the acquisition takes place, i.e. 1 August 2018.

On 31 December 2019, BPTHL and MAS Capital entered into a supplemental agreement (the “**MAS Supplemental Agreement**”) to revise the annual cap for the financial year ended 31 December 2019 and for the financial year ending 31 December 2020, and to decide the annual cap for the financial year ending 31 December 2021. Save for the annual caps as amended and decided under the MAS Supplemental Agreement as abovementioned, all other terms of the MAS Framework Agreement remain unchanged.

Pursuant to the MAS Framework Agreement (as amended by the MAS Supplemental Agreement), the BPTHL Group (as seller) has agreed to sell synthetic textiles and textile related products including synthetic fabrics to MAS Capital and its affiliates (collectively, the “**MAS Group**”) (as purchaser) from time to time on normal commercial terms and subject to and upon the terms and conditions contained in the purchase orders to be agreed between the relevant members of the BPTHL Group and the MAS Group, setting out, among other things, the products to be supplied, specifications, quantity, price, delivery method and payment arrangement.

i. **銷售合成紡織品及紡織相關產品予MAS集團**

於二零一七年十二月四日，本公司之全資附屬公司超盈紡織控股與MAS Capital訂立框架協議（「**MAS框架協議**」），自收購事項完成日期（即二零一八年八月一日）起計為期三年。

於二零一九年十二月三十一日，超盈紡織控股與MAS Capital訂立補充協議（「**MAS補充協議**」），修訂截至二零一九年十二月三十一日止及截至二零二零年十二月三十一日止財政年度的年度上限，並釐定截至二零二一年十二月三十一日止財政年度的年度上限。除上述根據MAS補充協議修訂及釐定的年度上限外，MAS框架協議之所有其他條款保持不變。

### j. Shared services from MAS Capital

On 1 August 2018, Trischel, a non-wholly owned subsidiary of the Company since completion of the acquisition on 1 August 2018, entered into a framework agreement (the “**MAS Capital Framework Agreement**”) with MAS Capital for a term of three years commencing from 1 August 2018 to 31 July 2021.

The service fees to be charged by MAS Capital in respect of the services under the MAS Capital Framework Agreement shall be determined either at the standard charging rate of MAS Capital (if any), or if no such rate, at a service fee to be determined with reference to the costs incurred by MAS Capital plus a percentage mark-up, which shall be negotiated between the parties at arm’s length basis.

The annual caps for the transaction amounts under the MAS Capital Framework Agreement for the year ended 31 December 2020 was US\$646,000 and for the financial year ending 31 December 2021 shall be US\$441,000. During the year ended 31 December 2020, the total service fee paid by Trischel to MAS Capital under the MAS Capital Framework Agreement amounted to approximately US\$337,121 (equivalent to approximately HK\$2,629,544).

Further details of the MAS Capital Framework Agreement were disclosed in the Company’s announcement dated 1 August 2018.

The service fees to be charged by MAS Legato in respect of the services under the MAS Legato Framework Agreement shall be determined either at the standard charging rate of MAS Legato (if any), or if no such rate, at a service fee to be determined with reference to the costs incurred by MAS Legato plus a percentage mark-up, which shall be negotiated between the parties at arm's length basis.

The annual caps for the transaction amounts under the MAS Legato Framework Agreement for the year ended 31 December 2020 was US\$66,000 and for the financial year ending 31 December 2021 shall be US\$45,000. During the year ended 31 December 2020, the total service fee paid by Trischel to MAS Legato under the MAS Legato Framework Agreement amounted to approximately US\$30,912 (equivalent to approximately HK\$241,114).

### k. 由MAS Legato提供的共享服務

### Review by the Company's auditor

Pursuant to Rule 14A.56 of the Listing Rules, the Company's auditor was engaged to report on the Group's continuing connected transactions in accordance with Hong Kong Standard on Assurance Engagements 3000 (Revised) "Assurance Engagements Other Than Audits or Reviews of Historical Financial Information" and with reference to Practice Note 740 "Auditor's Letter on Continuing Connected Transactions under the Hong Kong Listing Rules" issued by the Hong Kong Institute of Certified Public Accountants. Our auditor has issued its unmodified independent assurance report on continuing connected transactions of the Group for the year ended 31 December 2020 on pages 52 to 67 of this annual report in accordance with Rule 14A.56 of the Listing Rules. A copy of the independent assurance report has been provided by the Company to the Stock Exchange.

### AUDIT COMMITTEE

An audit committee (the "**Audit Committee**") was established by the Board with written terms of reference in compliance with the Corporate Governance Code (the "**CG Code**") contained in Appendix 14 to the Listing Rules. The Audit Committee comprises three independent non-executive Directors, namely Mr. Sai, Mr. Cheung Yat Ming and Mr. Ding. Mr. Sai is the chairman of the Audit Committee.

Principal corporate governance practices adopted by the Company are set out in the Corporate Governance Report from pages 80 to 95 of this annual report.

### SUFFICIENCY OF PUBLIC FLOAT

Based on information that is publicly available to the Company and within the knowledge of the Directors, at least 25% of the Company's total issued share capital was held by the public as at the latest practicable date prior to the issue of this report.

### DISCLOSURE PURSUANT TO RULE 13.21 OF THE LISTING RULES

As disclosed in the Company's announcement dated 15 June 2020, the Company (as guarantor) and its six wholly-owned subsidiaries (as borrowers) entered into a facility agreement (the "**Facility Agreement**") with certain banks in Hong Kong for a syndicated loan comprising HK\$1.8 billion equivalent multicurrency term loan and revolving credit facilities, with a maturity of 42 months from the date of first drawdown of the term loan facility. The Facility Agreement contains specific performance obligations on Mr. Lu, the controlling shareholder of the Company, requiring that he shall at all times:

- (i) maintain, directly or indirectly, at least 30% of the issued share capital of the Company and that such issued share capital shall remain unencumbered;
- (ii) be the single largest shareholder of the Company;
- (iii) be the Chairman of the Board of the Company; and
- (iv) maintain control over the management and business of the borrowers, the Company and the material subsidiaries.

As of the date of this annual report, Mr. Lu is an executive Director and the Chairman of the Board as well as the controlling shareholder of the Company, holding direct and indirect interests in 640,500,000 shares of the Company, representing approximately 61.59% of the issued share capital of the Company as at the date of this report, and is treated as the single largest shareholder of the Company.

The company was subsequently struck off from the register on 31 December 2013.

Starting from July 2000, Mr. Ding also worked as the chief economist and the deputy general manager of Guangzhou Automobile Industry Group Company Limited (廣州汽車工業集團有限公司), managing various departments until October 2007. Starting from 2008, he was the general manager of Beijing Shengshi Huaxuan Investment Company Limited (北京盛世華軒投資有限公司) until June 2015. From May 2011 to November 2017, he was an independent director of Qinghai Huading Industrial Company Limited (青海華鼎實業有限公司), a company listed on the Shanghai Stock Exchange (Stock Code: 600243). Mr. Ding has also taken up the position as the chairman and an executive director of Pizu Group Holdings Limited, a company listed on the Stock Exchange (Stock Code: 8053) since December 2012, and subsequently resigned as the chairman on 15 November 2016, and later resigned as the executive director on 9 January 2019. With effect from 30 March 2015, Mr. Ding has been an independent director of Shanxi Guoxin Energy Corporation Limited (山西省國新能源股份有限公司), a company listed on the Shanghai Stock Exchange (Stock code: 600617). Mr. Ding graduated from the Beijing Iron and Steel Institute (北京鋼鐵學院) with a bachelor degree in mining machinery in July 1985. In June 1988, Mr. Ding completed a master degree in engineering at Beijing University of Science and Technology (北京科技大學) in the PRC. Mr. Ding graduated from China Social Science Institute (中國社會科學院) with a doctorate degree in economics in July 1991.

Mr. Sai has been the managing partner of CCS & Company, Certified Public Accountants since March 2008. Since March 2012, Mr. Sai has been an independent non-executive director of China Gem Holdings Limited (formerly known as Yueshou Environmental Holdings Limited), a company listed on the Stock Exchange (Stock Code: 1191) and resigned from such position with effect from 10 October 2014. Since 29 April 2020, Mr. Sai has been an independent non-executive director of Pak Wing Group (Holdings) Limited, a company listed on GEM of the Stock Exchange (Stock Code: 8316) and resigned from such position with effect from 10 February 2021. In February 2006, Mr. Sai was admitted as a member of the Association of Chartered Certified Accountants. In September 2007, Mr. Sai became a certified public accountant of the Hong Kong Institute of Certified Public Accountants and was later registered as a certified public accountant (practising) in February 2008 with the same institute. Mr. Sai graduated from the Chinese University of Hong Kong with a bachelor degree in business administration in December 2002.

### CORPORATE GOVERNANCE PRACTICES

The Company is committed to maintaining high standard of corporate governance which is essential to the sustainable development and growth of the Company. The Board is of the view that the Company has met all the applicable code provisions set out in the CG Code throughout the year ended 31 December 2020 (the “Reporting Period”).

### MODEL CODE FOR SECURITIES TRANSACTIONS

The Company has adopted the Model Code as set out in Appendix 10 to the Listing Rules.

Specific enquiry has been made to all the Directors of the Company and the Directors have confirmed that they have complied with the Model Code throughout the Reporting Period.

The Company has also established a code no less exacting than the Model Code for securities transactions by senior management who are likely to be in possession of unpublished price-sensitive or inside information of the Company.

### BOARD OF DIRECTORS

As at the end of the Reporting Period, the Board comprises seven members, consisting of four executive Directors, namely Mr. Lu (Chairman of the Board), Mr. Zhang (Chief Executive Officer), Mr. Wu and Ms. Zheng (Chief Operating Officer), and three independent non-executive Directors, namely Mr. Cheung Yat Ming, Mr. Ding and Mr. Sai. On 10 February 2021, the Company appointed two executive Directors, namely Mr. Chan (Chief Financial Officer and Company Secretary) and Mr. Lu Libin (Chief Strategy Officer).

The biographical information of the Directors as well as the relationships between the members of the Board are set out on pages 71 to 79 of this annual report.

### 企業管治常規

本公司致力維持高水平的企業管治，此對本公司之可持續發展及增長尤為重要。董事會認為，本公司已於截至二零二零年十二月三十一日止年度整個期間（「報告期間」）符合企業管治守則所載的所有適用守則條文。

### 進行證券交易的標準守則

本公司已採用上市規則附錄十中載列的標準守則。

經向本公司全體董事作出具體查詢，董事已確認彼等於報告期間一直遵守標準守則。

本公司亦制訂不遜於標準守則的守則，以作為可能擁有本公司未公開的股價敏感資料或內幕消息的高級管理層進行證券交易的守則。

### 董事會

於報告期間結束時，董事會由七名成員組成，包括四名執行董事（即盧先生（董事會主席）、張先生（行政總裁）、吳先生及鄭女士（首席運營官），以及三名獨立非執行董事（即張一鳴先生、丁先生及余先生）。於二零二一年二月十日，本公司委任兩名執行董事，包括陳先生（首席財務官兼公司秘書）及盧立彬先生（首席戰略官）。

董事的履歷資料以及董事會成員之間的關係載列於本年報第71頁至第79頁。



### Chairman and Chief Executive Officer

The positions of Chairman and Chief Executive Officer are held by Mr. Lu and Mr. Zhang respectively. The Chairman provides leadership and is responsible for the effective functioning and leadership of the Board. The Chief Executive Officer focuses on the Company's business development and daily management and operations generally. Their respective responsibilities are clearly defined and set out in writing.

### Independent non-executive Directors

During the Reporting Period, the Board at all times met the requirements of the Listing Rules relating to the appointment of at least three independent non-executive Directors representing more than one-third of the Board with one of whom possessing appropriate professional qualifications or accounting or related financial management expertise.

The Company has received written confirmation from each of the independent non-executive Directors in respect of his independence in accordance with the independence guidelines set out in Rule 3.13 of the Listing Rules. The Company is of the view that all independent non-executive Directors are independent.

### Directors' Appointment, Re-election and Retirement

A person may be appointed as a member of the Board at any time either by the Shareholders in general meeting or by the Board upon recommendation by the Nomination Committee.

According to the Articles, the Board has the power from time to time and at any time to appoint any person as a Director either to fill a casual vacancy on the Board or as an addition to the existing Board. Any Director appointed by the Board to fill a casual vacancy shall hold office until the first general meeting of shareholders after his/her appointment and be subject to re-election at such meeting and any Director appointed by the Board as an addition to the existing Board shall hold office only until the next following annual general meeting of the Company and shall then be eligible for re-election. Besides, at each annual general meeting, one-third of the Directors for the time being (or, if their number is not a multiple of three, the number nearest to but not less than one-third) shall retire from office by rotation provided that every Director shall be subject to retirement at an annual general meeting at least once every three years.

### 主席及行政總裁

主席及行政總裁的職位分別由盧先生及張先生擔任。主席專責領導並負責董事會的有效運作。行政總裁專責本公司的業務發展、日常管理及運營。彼等各自的責任以書面形式清楚界定。

### 獨立非執行董事

於報告期間內，董事會一直符合上市規則有關委任至少三名獨立非執行董事（佔董事會超過三分之一），且其中至少一名獨立非執行董事須具有適當的專業資格或會計或相關財務管理專業知識的規定。

根據上市規則第3.13條載列的獨立性指引規定，本公司已接獲各獨立非執行董事關於其獨立性的書面確認。本公司認為，所有獨立非執行董事均屬獨立人士。

### 董事委任、重選及退任

經提名委員會推薦後，任何人士均可隨時由股東於股東大會上或由董事會委任為董事會成員。

根據細則，董事會有權不時及於任何時候委任任何人士擔任董事以填補董事會臨時空缺或增加現有董事會的成員。董事會為填補臨時空缺而委任的任何董事須擔任其職務直至其獲委任後的首次股東週年大會召開為止，並可於有關大會上獲重選；董事會為增加現有董事會成員而委任的任何董事僅須擔任其職務至本公司下一屆股東週年大會為止，屆時有資格獲重選。此外，於各屆股東週年大會上，當時三分之一的董事（或倘其數目並非三的倍數，則為最接近但不少於三分之一的數目）須輪席退任，惟各董事至少須每三年於股東週年大會上退任一次。

Each of the executive Directors has entered into a service contract with the Company, and each of the independent non-executive Directors has signed a letter of appointment with the Company. All Directors are appointed for a specific term of three years, subject to retirement by rotation and re-election in accordance with the Articles.

Pursuant to the aforesaid provisions in the Articles, Mr. Chan and Mr. Lu Libin, being appointed by the Board on 10 February 2021, shall hold office until the forthcoming AGM while Ms. Zheng, Mr. Ding and Mr. Sai will retire by rotation at the forthcoming AGM. All the above Directors, being eligible, will offer themselves for re-election at the AGM.

### Responsibilities, Accountabilities and Contributions of the Board and Management

The Board is responsible for leadership and control of the Company and oversees the Group's businesses, strategic decisions and performance and is collectively responsible for promoting the success of the Company by directing and supervising its affairs. Directors of the Board take decisions objectively in the interests of the Company.

All Directors, including independent non-executive Directors, have brought a wide spectrum of valuable business experience, knowledge and professionalism to the Board for its efficient and effective functioning.

All Directors have full and timely access to all the information of the Company as well as the services and advice from the company secretary and senior management. The Directors may, upon request, seek independent professional advice in appropriate circumstances, at the Company's expenses for discharging their duties to the Company.

The Directors shall disclose to the Company details of other offices held by them and the Board regularly reviews the contribution required from each Director to perform his responsibilities to the Company.

根據前述細則條文，陳先生及盧立彬先生（於二零二一年二月十日獲董事會委任）將任職直至應屆股東週年大會，而鄭女士、丁先生及余先生將於應屆股東週年大會輪席退任。所有上述董事均合資格並願意於股東週年大會上膺選連任。

### 董事會及管理層的責任、問責及貢獻

全體董事可全面、及時地取得本公司的所有資料以及公司秘書及高級管理層的服務及建議。於適當情況下，董事於履行彼等於本公司的職務時可要求尋求獨立專業意見，費用由本公司承擔。

董事須向本公司披露其擔任的其他職務詳情，董事會定期檢討各董事履行其對本公司的責任所需做出的貢獻。

The Board reserves for its decision all major matters relating to policy matters, strategies and budgets, internal control and risk management, material transactions (in particular those that may involve conflict of interests), financial information, appointment of Directors and other significant operational matters of the Company. Responsibilities relating to implementing decisions of the Board, directing and co-ordinating the daily operation and management of the Company are delegated to the management.

#### Continuous Professional Development of Directors

Pursuant to the code provision A.6.5 of the CG Code, all Directors should participate in continuous professional development to develop and refresh their knowledge and skills. This is to ensure that their contribution to the Board remains informed and relevant. The Company should be responsible for arranging and funding suitable training, placing an appropriate emphasis on the roles, functions and duties of a listed company director. The Company updates Directors on the latest development regarding the Listing Rules and other applicable regulatory requirements from time to time, in order to ensure compliance and enhance their awareness of good corporate governance practices. The Company is also arranging suitable professional development seminars and courses for the Directors. For instance, every newly appointed Director will receive induction on the first occasion of his/her appointment to ensure appropriate understanding of the business and operations of the Company and full awareness of Directors' responsibilities and obligations under the Listing Rules and relevant statutory requirements.

The Directors informed the Company that they had received sufficient and relevant training and continuous professional development during the Reporting Period.

At least 14 days' notice for all regular Board meetings will be given to all Directors and all Directors must be given the opportunity to include items or businesses for discussion in the agenda. For all other Board meetings, reasonable notice will be given. Relevant agenda and accompanying Board papers will be sent to all Directors at least three working days in advance of every regular Board meeting.

The Board has established three committees, namely, the Audit Committee, the Remuneration Committee and the Nomination Committee, for overseeing particular aspects of the Company's affairs. All Board committees of the Company are established with defined written terms of reference. The terms of reference of the Board committees are posted on the Company's website and the Stock Exchange's website and are available to shareholders upon request.

The majority of the members of each Board committee are independent non-executive Directors and the list of the chairman and members of each Board committee is set out under "Corporate Information" on page 2 of this annual report.

### Audit Committee

The Company established the Audit Committee on 8 May 2014 in compliance with Rules 3.21 and 3.22 of the Listing Rules and code provision C.3.3 of the CG Code. The Audit Committee has three members, namely Mr. Sai, Mr. Cheung Yat Ming and Mr. Ding and is chaired by Mr. Sai.

The main duties of the Audit Committee are to assist the Board in reviewing the financial information and reporting process, risk management and internal control systems and procedures, audit plan and relationship with external auditors, and arrangements to enable employees of the Company to raise, in confidence, concerns about possible improprieties in financial reporting, internal control or other matters of the Company.

The full terms of reference of the Audit Committee are available on the Stock Exchange's website and the Company's website.

During the Reporting Period, the Audit Committee held three meetings to review annual results of the Group for the year ended 31 December 2019, the interim results of the Group for the six months ended 30 June 2020 and significant issues on the financial reporting and compliance procedures, risk management and internal control systems, effectiveness of the Company's internal audit function, and arrangements for employees to raise concerns about possible improprieties.

The external auditors attended all the above meetings to discuss with the Audit Committee on issues arising from the audit and financial reporting matters.

### Remuneration Committee

The Company established the Remuneration Committee on 8 May 2014 in compliance with Rules 3.25 and 3.26 of the Listing Rules and code provision B.1.2 of the CG Code. The Remuneration Committee has three members, namely Mr. Ding, Mr. Zhang and Mr. Cheung Yat Ming and is chaired by Mr. Ding.

The primary functions of the Remuneration Committee include reviewing and making recommendations to the Board on the remuneration packages of individual executive Directors and senior management, the remuneration policy and structure for all Directors and senior management, and establishing transparent procedures for developing such remuneration policy and structure to ensure that no Director or any of his associates will participate in deciding his own remuneration.

The full terms of reference of the Remuneration Committee are available on the Stock Exchange's website and the Company's website.

### AUDITOR'S REMUNERATION

It is the Company's general practice that the Chairman of the Board as well as chairmen of the Audit Committee, the Nomination Committee and the Remuneration Committee, or in their absence, their duly appointed delegates, who are members of the relevant committees, will be available to answer questions at the general meetings of the Company. In addition, the Company will invite representatives of the auditor to attend its annual general meeting to answer shareholders' questions about the conduct of the audit, the preparation and content of the auditor's report, the accounting policies and the independence of the auditor.

### SHAREHOLDERS' RIGHTS

To safeguard shareholders' interests and rights, separate resolutions are proposed at shareholders' meetings on each substantial issue, including the election of individual Director, for shareholders' consideration and voting. The Company's shareholders may convene an extraordinary general meeting (the "EGM") or put forward proposals at shareholders' meetings as follows:

- (1) Shareholder(s) holding at the date of deposit of the requisition not less than one-tenth of the paid-up capital of the Company may request the Board to convene an EGM pursuant to Article 58 of the Articles by sending a written requisition to the Board or the Company Secretary at the Company's principal place of business in Hong Kong. The purpose of requiring such general meeting must be stated in the written requisition.

- (2) If a shareholder wishes to propose a person other than a retiring Director for election as a Director of the Company at a general meeting, pursuant to Article 85 of the Articles, the shareholder (other than the person to be proposed) duly qualified to attend and vote at the general meeting shall send a written notice, duly signed by the shareholder, of his/her intention to propose such person for election and also a notice signed by the person to be proposed of his/her willingness to be elected. These notices should be lodged at the Company's principal place of business in Hong Kong, or the office of the Company's branch share registrar. The period for lodgement of such notices shall commence on the day after the despatch of the notice of such general meeting and end no later than 7 days prior to the date of such general meeting.

For the avoidance of doubt, shareholder(s) must provide their full name(s), contact details and identification, in the originally signed written requisition, notice or statement (as the case may be), in order to give effect thereto. Information of shareholder(s) may be disclosed as required by law. Shareholders may refer to the Articles for further details of the rights of shareholders.

All resolutions put forward at shareholders' meetings of the Company shall be voted by poll except where the chairman decides to allow a resolution relating to a procedural or administrative matter to be voted on by a show of hands pursuant to the Listing Rules and the Articles. The poll results shall be posted on the websites of the Stock Exchange and the Company after each shareholders' meeting.

### CONSTITUTIONAL DOCUMENTS

During the Reporting Period, there was no significant change in the Articles of the Company.

本核數師(以下簡稱「**我們**»)已審計列載於第103至266頁的超盈國際控股有限公司(以下簡稱「**貴公司**»)及其附屬公司(以下統稱「**貴集團**»)的綜合財務報表,此財務報表包括於二零二零年十二月三十一日的綜合財務狀況表與截至該日止年度的綜合損益及其他全面收益表、綜合權益變動表和綜合現金流量表,以及綜合財務報表附註,包括主要會計政策概要。

我們認為,該等綜合財務報表已根據由香港會計師公會(「**香港會計師公會**»)頒佈的香港財務報告準則(「**香港財務報告準則**»)真實而中肯地反映了 貴集團於二零二零年十二月三十一日的綜合財務狀況及截至該日止年度的綜合財務表現及綜合現金流量,並已按照香港公司條例披露規定妥為編製。

#### 意見的基礎

我們已根據香港會計師公會頒佈的香港審計準則(「**香港審計準則**»)進行審計。我們在該等準則下承擔的責任已在本報告「核數師就審計綜合財務報表承擔的責任」部分中作進一步闡述。根據香港會計師公會頒佈的專業會計師道德守則(「**守則**»),我們獨立於 貴集團,並已履行守則中的其他專業道德責任。我們相信,我們所獲得的審計憑證能充足及適當地為我們的審計意見提供基礎。

## KEY AUDIT MATTERS

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

### Impairment assessment of trade receivables

#### Key audit matter

We identified impairment assessment of trade receivables as a key audit matter due to the significance of trade receivables to the Group's consolidated financial position and the involvement of subjective judgement and management estimates in evaluating the expected credit losses ("ECL") of the Group's trade receivables at the end of the reporting period.

As at 31 December 2020, the Group's net trade receivables amounting to approximately HK\$793.5 million, which represented approximately 12.5% of total assets of the Group and out of these trade receivables of approximately HK\$72.2 million were past due.

As disclosed in note 4 to the consolidated financial statements, the management of the Group identifies trade receivables that are credit-impaired under HKFRS 9 and assesses their ECL individually. The management of the Group estimates the amount of lifetime ECL of the remaining trade receivables based on provision matrix through grouping of various debtors that have similar loss pattern, after considering internal credit ratings of trade debtors and/or past due status of respective trade receivables. The credit loss allowance amount is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows. The assessment of credit risk of trade receivables involves high degree of estimation uncertainty.

As disclosed in note 38 to the consolidated financial statements, the Group's lifetime ECL on trade receivables as at 31 December 2020 amounting to approximately HK\$12.7 million.

## 關鍵審計事項

關鍵審計事項是根據我們的專業判斷，認為對本期綜合財務報表的審計最為重要的事項。這些事項是在我們審計整體綜合財務報表及出具意見時進行處理的。我們不會對這些事項提供單獨的意見。

### 貿易應收款項之減值評估

#### 關鍵審計事項

我們將貿易應收款項之減值評估列為關鍵審計事項，乃由於貿易應收款項對貴集團的綜合財務狀況實屬重大，且於評估報告期間結束時貴集團貿易應收款項的預期信貸虧損（「預期信貸虧損」）時涉及主觀判斷及管理層估計。

於二零二零年十二月三十一日，貴集團的貿易應收款項淨額為約793.5百萬港元，約佔貴集團總資產的12.5%，於該等貿易應收款項中，約72.2百萬港元已逾期。

誠如綜合財務報表附註4所披露，貴集團管理層識別根據香港財務報告準則第9號發生信貸減值之貿易應收款項並個別評估其預期信貸虧損。貴集團管理層經考慮貿易應收賬款之內部信貸評級及／或個別貿易應收款項的逾期狀態後，根據具有類似虧損模式的多個債務人組別的撥備矩陣估計餘下貿易應收款項之全期預期信貸虧損金額。信貸虧損撥備金額按資產賬面值及估計現金流量現值之間的差額計量。評估貿易應收款項的信貸風險涉及高度估計不確定性。

誠如綜合財務報表附註38所披露，貴集團於二零二零年十二月三十一日的貿易應收款項全期預期信貸虧損為約12.7百萬港元。

##### How our audit address the key audit matter

Our procedures in relation to impairment assessment of trade receivables included:

- Understanding key controls on how the management estimates the credit loss allowance for trade receivables;
- Testing the accuracy of information used by the management to develop the provision matrix, including trade receivables ageing analysis as at 31 December 2020, on a sample basis, by comparing individual items in the analysis with the relevant sales invoices and monthly statement for sales;
- Challenging management's basis and judgement in determining credit loss allowance on trade receivables as at 31 December 2020, including their identification of credit impaired trade receivables which are assessed for ECL individually, the reasonableness of management's grouping of the remaining trade debtors into different categories in the provision matrix by internal credit ratings of trade debtors and/or past due status of respective trade receivables, and the basis of estimated loss rates applied in each category in the provision matrix; and
- Testing subsequent settlements of trade receivables, on a sample basis, by inspecting supporting documents in relation to cash receipt from trade debtors subsequent to the end of the current reporting period.

我們有關貿易應收款項之減值評估的程序，包括：

- 了解管理層在估計貿易應收款項之信貸虧損撥備時的主要控制措施；
- 透過將分析中的獨立項目與相關銷售發票及銷售月結單比較，對管理層建立撥備矩陣所使用的資料，包括於二零二零年十二月三十一日之貿易應收款項賬齡分析的準確性進行抽樣測試；
- 查詢管理層在釐定於二零二零年十二月三十一日之貿易應收款項信貸虧損撥備時所採用的基準及判斷，包括其對發生信貸減值及就預期信貸虧損進行個別評估之貿易應收款項的識別、管理層於撥備矩陣中按貿易應收賬款之內部信貸評級及／或個別貿易應收款項的逾期狀態將餘下貿易應收賬款分組至不同類別的合理性，以及應用於撥備矩陣各類別的預期虧損率基準；及
- 透過檢查於本報告期間結束後有關來自貿易應收賬款之現金收款的證明文件，對貿易應收款項的後續結算進行抽樣測試。

### 1. GENERAL INFORMATION

Best Pacific International Holdings Limited (the “**Company**”) is a public company incorporated as an exempted company and registered in the Cayman Islands with limited liability under the Companies Law Chapter 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands on 14 June 2013. Its immediate and ultimate holding company is Grandview Capital Investment Limited, which is incorporated in the British Virgin Islands (“**BVI**”) and is wholly owned by Mr. Lu Yuguang (“**Mr. Lu**”), who is the Chairman and executive director of the Company. The Company’s shares have been listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) since 23 May 2014. The address of the Company’s registered office and principal place of business are disclosed in the corporate information section to the annual report.

The principal activities of the Company and its subsidiaries (the “**Group**”) are manufacturing and trading of elastic fabric, lace and elastic webbing. Details of the principal activities of the subsidiaries are set out in Note 40.

The functional currency of the Company is Hong Kong dollar (“**HK\$**”), which is the same as the presentation currency of the consolidated financial statements.

### 1. 一般資料

超盈國際控股有限公司（「**本公司**」）為一間於二零一三年六月十四日根據開曼群島法例第22章公司法（一九六一年第三號法案，經綜合及修訂）在開曼群島註冊成立為獲豁免有限公司的公眾公司。其直接及最終控股公司 Grandview Capital Investment Limited 為於英屬處女群島（「**英屬處女群島**」）註冊成立並由本公司主席兼執行董事盧煜光先生（「**盧先生**」）全資擁有的公司。本公司股份已自二零一四年五月二十三日起在香港聯合交易所有限公司（「**聯交所**」）主板上市。本公司註冊辦事處及主要營業地點的地址披露於本年報公司資料一節。

本公司及其附屬公司（「**本集團**」）的主要活動為製造及買賣彈性織物面料、蕾絲及彈性織帶。附屬公司的主要活動詳情載於附註40。

本公司的功能貨幣為港元（「**港元**」），亦為綜合財務報表的呈列貨幣。

The gross assets under assessment exclude cash and cash equivalents, deferred tax assets, and goodwill resulting from the effects of deferred tax liabilities. The election on whether to apply the optional concentration test is available on transaction-by-transaction basis.

The amendments had no impact on the consolidated financial statements of the Group but may impact future periods should the Group make any acquisition.

#### 3.1 Basis of preparation of consolidated financial statements

The consolidated financial statements have been prepared in accordance with HKFRSs issued by the HKICPA. For the purpose of preparation of the consolidated financial statements, information is considered material if such information is reasonably expected to influence decision made by primary users. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (“**Listing Rules**”) and by the Hong Kong Companies Ordinance.

The directors of the Company have, at the time of approving the consolidated financial statements, a reasonable expectation that the Group has adequate resources to continue in operational existence for the foreseeable future. Thus they continue to adopt the going concern basis of accounting in preparing the consolidated financial statements.

The consolidated financial statements have been prepared on the historical cost basis except for certain financial instruments that are measured at fair values at the end of each reporting period, as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 *Share-based Payment*, leasing transactions that are accounted for in accordance with HKFRS 16, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 *Inventories* or value in use in HKAS 36 *Impairment of Assets*.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

For financial instruments which are transacted at fair value and a valuation technique that unobservable inputs is to be used to measure fair value in subsequent periods, the valuation technique is calibrated so that at initial recognition the results of the valuation technique equals the transaction price.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

##### Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

Non-controlling interests in subsidiaries are presented separately from the Group's equity therein, which represent present ownership interests entitling their holders to a proportionate share of net assets of the relevant subsidiaries upon liquidation.

##### Business combinations

Acquisitions of businesses are accounted for using the acquisition method. The consideration transferred in a business combination is measured at fair value, which is calculated as the sum of the acquisition-date fair values of the assets transferred by the Group, liabilities incurred by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. Acquisition-related costs are generally recognised in profit or loss as incurred.

At the acquisition date, the identifiable assets acquired and the liabilities assumed are recognised at their fair value, except that:

- deferred tax assets or liabilities, and assets or liabilities related to employee benefit arrangements are recognised and measured in accordance with HKAS 12 *Income Taxes* and HKAS 19 *Employee Benefits* respectively;

If, after re-assessment, the net amount of the identifiable assets acquired and liabilities assumed exceeds the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value of the acquirer's previously held interest in the acquiree (if any), the excess is recognised immediately in profit or loss as a bargain purchase gain.

Non-controlling interests that are present ownership interests and entitle their holders to a proportionate share of the relevant subsidiary's net assets in the event of liquidation are initially measured at the non-controlling interests' proportionate share of the recognised amounts of the acquiree's identifiable net assets or at fair value. The choice of measurement basis is made on a transaction-by-transaction basis.

##### Investments in joint ventures

A joint venture is a joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint arrangement. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require unanimous consent of the parties sharing control.

The results and assets and liabilities of joint ventures are incorporated in these consolidated financial statements using the equity method of accounting. The financial statements of joint ventures used for equity accounting purposes are prepared using uniform accounting policies as those of the Group for like transactions and events in similar circumstances. Under the equity method, an investment in a joint venture is initially recognised in the consolidated statement of financial position at cost and adjusted thereafter to recognise the Group's share of the profit or loss and other comprehensive income of the joint venture. Changes in net assets of the joint venture other than profit or loss and other comprehensive income are not accounted for unless such changes resulted in changes in ownership interest held by the Group. When the Group's share of losses of joint venture exceeds the Group's interest in that joint venture (which includes any long-term interests that, in substance, form part of the Group's net investment in the joint venture), the Group discontinues recognising its share of further losses. Additional losses are recognised only to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the joint venture.

An investment in a joint venture is accounted for using the equity method from the date on which the investee becomes a joint venture. On acquisition of the investment in a joint venture or acquisition of additional interest in a joint venture, any excess of the cost of the investment over the Group's share of the net fair value of the identifiable assets and liabilities of the investee is recognised as goodwill, which is included within the carrying amount of the investment. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of the investment, after reassessment, is recognised immediately in profit or loss in the period in which the investment is acquired.

The Group assesses whether there is an objective evidence that the interest in a joint venture may be impaired. When any objective evidence exists, the entire carrying amount of the investment (including goodwill) is tested for impairment in accordance with HKAS 36 *Impairment of Assets* as a single asset by comparing its recoverable amount (higher of value in use and fair value less costs of disposal) with its carrying amount. Any impairment loss recognised is not allocated to any asset, including goodwill that forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with HKAS 36 to the extent that the recoverable amount of the investment subsequently increases.

The Group recognises revenue when (or as) a performance obligation is satisfied, i.e. when "control" of the goods or services underlying the particular performance obligation is transferred to the customer.

A performance obligation represents a good or service (or a bundle of goods or services) that is distinct or a series of distinct goods or services that are substantially the same.

A contract liability represents the Group's obligation to transfer goods or services to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer.

##### Government grants

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received.

Government grants are recognised in profit or loss on a systematic basis over the periods in which the Group recognises as expenses the related costs for which the grants are intended to compensate. Specifically, government grants whose primary condition is that the Group should purchase, construct or otherwise acquire non-current assets are recognised as deferred income in the consolidated statement of financial position and transferred to profit or loss on a systematic basis over the useful lives of the related assets.

Government grants related to income that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss (as other income) in the period in which they become receivable.

An internally-generated intangible asset arising from development activities (or from the development phase of an internal project) is recognised if, and only if, all of the following have been demonstrated:

- the technical feasibility of completing the intangible asset so that it will be available for use or sale;
- the intention to complete the intangible asset and use or sell it;
- the ability to use or sell the intangible asset;
- how the intangible asset will generate probable future economic benefits;
- the availability of adequate technical, financial and other resources to complete the development and to use or sell the intangible asset; and
- the ability to measure reliably the expenditure attributable to the intangible asset during its development.

The amount initially recognised for internally-generated intangible asset is the sum of the expenditure incurred from the date when the intangible asset first meets the recognition criteria listed above. Where no internally-generated intangible asset can be recognised, development expenditure is recognised in profit or loss in the period in which it is incurred.

Properties in the course of construction for production, supply or administrative purposes are carried at cost, less recognised impairment loss. Costs include any costs directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management and, for qualifying assets, borrowing costs capitalised in accordance with the Group's accounting policy. Such properties are classified to the appropriate categories of property, plant and equipment when completed and ready for their intended use. Depreciation of these assets, on the same basis as other property assets, commences when the assets are ready for their intended use.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

To the extent the allocation of the relevant payments can be made reliably, interest in leasehold land that is accounted for as an operating lease is presented as “right-of-use assets” in the consolidated statement of financial position. When the consideration cannot be allocated reliably between non-lease building element and undivided interest in the underlying leasehold land, the entire properties are classified as property, plant and equipment.

If any such indication exists, the recoverable amount of the relevant asset is estimated in order to determine the extent of the impairment loss (if any).

The recoverable amount of property, plant and equipment and right-of-use assets are estimated individually. When it is not possible to estimate the recoverable amount individually, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs.

In addition, the Group assesses whether there is indication that corporate assets may be impaired. If such indication exists, corporate assets are also allocated to individual cash-generating units, when a reasonable and consistent basis of allocation can be identified, or otherwise they are allocated to the smallest group of cash-generating units for which a reasonable and consistent allocation basis can be identified.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. Hong Kong dollars) at the rate of exchange prevailing at the end of the reporting period, and their income and expenses are translated at the average exchange rates for the year, unless exchange rates fluctuate significantly during the period, in which case, the exchange rates prevailing at the dates of transactions are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of translation reserve (attributed to non-controlling interests as appropriate).

Payments to defined contribution retirement benefit plans (such as state-managed retirement benefit schemes, the Mandatory Provident Fund Scheme and the State Social Insurance Fund) are recognised as an expense when employees have rendered service entitling them to the contributions.

For defined benefit retirement benefit plans, the cost of providing benefits is determined using the projected unit credit method, with actuarial valuations being carried out at the end of each annual reporting period. Remeasurement, comprising actuarial gains and losses, the effect of the changes to the asset ceiling (if applicable) and the return on plan assets (excluding interest), is reflected immediately in the consolidated statement of financial position with a charge or credit recognised in other comprehensive income in the period in which they occur. Remeasurement recognised in other comprehensive income is reflected immediately in retained profits and will not be reclassified to profit or loss.

Past service cost is recognised in profit or loss in the period of a plan amendment or curtailment and a gain or loss on settlement is recognised when settlement occurs. Net interest is calculated by applying the discount rate at the beginning of the period to the net defined benefit liability or asset. Discretionary contributions made by employees or third parties reduce service cost upon payment of these contributions to the plan.

When the formal terms of the plans specify that there will be contributions from employees or third parties, the accounting depends on whether the contributions are linked to service, as follows:

- If the contributions are not linked to services (for example contributions are required to reduce a deficit arising from losses on plan assets or from actuarial losses), they are reflected in the remeasurement of the net defined benefit liability or asset.
- If contributions are linked to services, they reduce service costs. For the amount of contribution that is dependent on the number of years of service, the entity reduces service cost by attributing the contributions to periods of service using the attribution method required by HKAS 19 paragraph 70 for the gross benefits. For the amount of contribution that is independent of the number of years of service, the entity reduces service cost in the period in which the related service is rendered.

##### Termination benefits

A liability for a termination benefit is recognised at the earlier of when the Group entity can no longer withdraw the offer of the termination benefit and when it recognises any related restructuring costs.

Any specific borrowing that remain outstanding after the related asset is ready for its intended use or sale is included in the general borrowing pool for calculation of capitalisation rate on general borrowings. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from “profit before taxation” as reported in the consolidated statement of profit or loss and other comprehensive income because of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group’s liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax base used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary difference to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries and interest in joint venture, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments and interests are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

##### Impairment of financial assets

The Group performs impairment assessment under expected credit loss (“ECL”) model on financial assets (including trade and bills receivables, other receivables and deposits, pledged bank deposits, short term bank deposits, bank balances) which are subject to impairment assessment under HKFRS 9. The amount of ECL is updated at each reporting date to reflect changes in credit risk since initial recognition.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of the relevant instrument. In contrast, 12-month ECL (“12m ECL”) represents the portion of lifetime ECL that is expected to result from default events that are possible within 12 months after the reporting date. Assessment are done based on the Group’s historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current conditions at the reporting date as well as the forecast of future conditions.

The Group always recognises lifetime ECL for trade receivables. Trade receivables that are credit-impaired are assessed for ECL individually. The ECL on the remaining trade receivables are assessed collectively using a provision matrix with appropriate groupings.

For all other financial assets at amortised cost, the Group measures the credit loss allowance equal to 12m ECL, unless when there has been a significant increase in credit risk since initial recognition, in which case the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increases in the likelihood or risk of a default occurring since initial recognition.

(i) Significant increase in credit risk

In assessing whether the credit risk has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

In the application of the Group's accounting policies, which are described in Note 3, the management of the Group is required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

The followings are the key sources of estimation uncertainty at the end of the reporting period, that has a significant risk of causing a material adjustment to the carrying amounts of assets within the next financial year.

#### Impairment assessment of trade receivables

The management of the Group identifies trade receivables that are credit-impaired and assesses their ECL individually. The management of the Group estimates the amount of lifetime ECL of the remaining trade receivables based on provision matrix through grouping of various debtors that have similar loss pattern, after considering internal credit ratings of trade debtors and/or past due status of respective trade receivables. The credit loss allowance amount is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows. The assessment of credit risk of trade receivables involves high degree of estimation uncertainty. When the actual future cash flows are less than expected or more than expected, a material impairment loss or a material reversal of impairment loss may arise accordingly in future periods.

The provision of ECL is sensitive to changes in estimates. Due to greater financial uncertainty triggered by the COVID-19 pandemic, the Group has increased the expected loss rates in the current year as there is higher risk that a prolonged pandemic could led to increased credit default rates. The information about the ECL and the Group's trade receivables are disclosed in Notes 20 and 38.

The carrying amount of trade receivables is HK\$793,497,000 (2019: HK\$720,048,000) as at 31 December 2020.

##### Allowance for inventories

Management of the Group reviews the inventory ageing analysis at the end of the reporting period and identifies the slow-moving or obsolete inventory items that are no longer suitable for use in production or sales. Management estimates the net realisable value for such inventories based primarily on the latest invoice prices, estimated costs of completion and current market conditions. In addition, the Group carries out regular inventory review with reference to inventory ageing analysis, management experience and judgement on the expected future saleability of goods and provides necessary allowance if the net realisable value is estimated to be below the cost.

There is no further allowance nor any reversal of allowance for slow-moving inventories of HK\$24,288,000 (2019: nil) charged to profit or loss during the year ended 31 December 2020. The carrying amount of inventories is HK\$922,301,000 (2019: HK\$1,065,160,000) as at 31 December 2020.

##### Useful life of property, plant and equipment

Property, plant and equipment are depreciated on a straight-line basis over the estimated useful lives of the relevant assets, after taking into account their estimated residual values, if any. The Group reviews the estimated useful lives of the assets annually in order to determine the amount of depreciation expenses to be recorded during the year. The useful lives are based on the Group's historical experience with similar assets taking into account anticipated technological changes.

The depreciation expense for future periods is adjusted if there are significant changes from previous estimates. During the year ended 31 December 2020, the Group determined that there is no change to the estimated useful lives of the property, plant and equipment. The carrying amount of property, plant and equipment is HK\$2,970,302,000 as at 31 December 2020 (2019: HK\$2,893,902,000).

#### (ii) Performance obligations for contracts with customers

The Group manufactures and trades the elastic fabric, lace and elastic webbing to the wholesale market.

For manufacturing and trading of elastic fabric, lace and elastic webbing, revenue is recognised when control of the goods has been transferred, being the point in time when the goods have been shipped to the customer's specific location (delivery).

Following the delivery, the customer has full discretion over further processing, the manner of distribution and sales price of the goods and has the primary responsibility when selling the goods and bears the risks of obsolescence and loss in relation to the goods. The normal credit term is 30 to 90 days from the date of issuance of a monthly statement for sale delivered in that month.

The Group applies the practical expedient of HKFRS 15 which allows the Group not to disclose the information of the transaction price allocated to the remaining performance obligation for contract with customers, as the original expected duration of the performance obligation arising from the manufacturing and trading of elastic fabric, lace and elastic webbing are all within one year.

Under the two-tiered profits tax rates regime passed by the Hong Kong Legislative Council in March 2018, the first HK\$2 million of profits of the qualifying group entity will be taxed at 8.25%, and profits above HK\$2 million will be taxed at 16.5%. Accordingly, the Hong Kong Profits Tax for the qualifying group entity had been calculated at 8.25% on the first HK\$2 million of the estimated assessable profits and at 16.5% on the estimated assessable profits above HK\$2 million.

Under the Law of the PRC on Enterprise Income Tax (the “**EIT Law**”) and Implementation Regulation of the EIT Law, the tax rate of the PRC companies is 25% for both years ended 31 December 2020 and 2019, unless there is any applicable preferential tax treatment.

The Company's subsidiaries, Dongguan Best Pacific Textile Company Limited (“**Dongguan BPT**”) and Dongguan New Horizon Elastic Fabric Company Limited (“**Dongguan NHE**”), had obtained the qualification as high and new technology enterprises since 2010 and 2016, respectively, which were renewed for an additional three years from the year ended 31 December 2019. Hence, Dongguan BPT and Dongguan NHE had been subject to the preferential tax treatment and the applicable tax rate for the years ended 31 December 2020 and 2019 was 15%.

Withholding tax on dividends was calculated at 5% of the estimated dividend to be received from the subsidiaries in the PRC during the year.

Pursuant to the relevant Vietnam Enterprises Income Tax rules and regulations, the applicable tax rate for the subsidiary operating in Vietnam is 20%. The subsidiary in Vietnam is eligible for tax holiday for two financial years since the first financial year of taxable profit and tax concession at a tax rate of 10% for the following four financial years. With the new incentive in place during the year ended 31 December 2018 and by fulfilling certain stated requirements as set by the Ministry of Industry and Trade, the subsidiary in Vietnam had been eligible for tax holiday for four financial years since 2018, tax concession at a tax rate of 5% for the following nine financial years and tax concession at a tax rate of 10% for the next following two financial years.

Pursuant to the Inland Revenue Act, No. 24 of 2017 in Sri Lanka, the applicable tax rate for the subsidiaries operating in Sri Lanka is 28%. By fulfilling certain export requirements as set by the Board of Investment of Sri Lanka, the subsidiaries of the Group in Sri Lanka had enjoyed a preferential tax rate of 14% for the years ended 31 December 2020 and 2019. In addition, one of these subsidiaries is currently eligible for tax holiday till the year ending 31 December 2024.

Taxation arising in any other jurisdiction is calculated at the rate prevailing in the relevant jurisdiction.

Note: On 4 November 2015, the Group acquired 40% equity interest in Charming Elastic from an independent third party at a cash consideration of HK\$10,000,000. Charming Elastic also owns 100% equity interest in Jiangxi Charming Elastic Mfg. Co. Ltd, which is engaged in manufacturing of elastic webbing in the PRC.

Pursuant to the shareholders' agreement entered into among a wholly owned subsidiary of the Company, the other shareholder of Charming Elastic who by then held 60% equity interest in Charming Elastic and Charming Elastic on the same date (the "**Charming Elastic Shareholders' Agreement**"), the shareholder who holds more than 50% equity interest in Charming Elastic (the "**Majority Shareholder**") and the Group were entitled to appoint or remove three and two directors out of the five directors at the board of directors of Charming Elastic respectively.

The shareholders of Charming Elastic (the Majority Shareholder and the Group) had also contractually agreed sharing control over Charming Elastic, as certain decisions about the relevant activities, including but not limited to business, financial and operational matters of Charming Elastic, require unanimous consents from at least two directors appointed by the Majority Shareholder and one director appointed by the Group. Accordingly, the Group has joint control over Charming Elastic and the investment in equity interest in Charming Elastic is accounted for as an interest in a joint venture.

The Charming Elastic Shareholders' Agreement also involves terms that granted rights to the Group to purchase additional equity interest in Charming Elastic and rights to the other shareholder of Charming Elastic to exercise to sell equity interest of Charming Elastic to the Group, accordingly, the Group recognised derivative financial assets and liabilities since the date of acquisition of Charming Elastic at the consolidated statement of financial position (details as set out in Note 29).

During the year ended 31 December 2020, the Group entered into a new facility agreement for an unsecured syndicated loan (“**2020 Syndicated Loan**”), which is repayable by installments, from 31 December 2021 to 31 December 2023 and with an interest rate at HIBOR plus 2.2% per annum for HK\$ loan tranche and LIBOR plus 2.2% per annum for US\$ loan tranche. Certain proceeds from the 2020 Syndicated Loan were used to fully repay the 2017 Syndicated Loan. The 2017 Syndicated Loan and 2020 Syndicated Loan were guaranteed by the Company.

#### Defined contribution plans

The Group operates a Mandatory Provident Fund Scheme (“**MPF Scheme**”) under the rules and regulations of the Mandatory Provident Fund Schemes Ordinance for all qualifying employees in Hong Kong. Contributions are made based on a percentage of the employees’ salaries with a cap of HK\$1,500 per month per employee and are charged to the consolidated statement of profit or loss and other comprehensive income as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. No forfeited contribution is available to reduce the contribution payable in the future years as at 31 December 2020 and 2019.

The Company’s PRC subsidiaries are required to make contributions to the state-managed retirement schemes operated by the local governments based on certain percentage of the monthly salaries of their current employees to fund the benefits.

Eligible employees in Vietnam currently participate in State Social Insurance Fund, which is a defined contribution pension scheme operated by the local municipal government. The calculation of contributions is based on certain percentage of employee’s payroll.

The only obligations of the Group with respect to the above defined contribution retirement benefits schemes are to make the required contributions under the respective schemes.

During the year ended 31 December 2020, the total costs charged to profit or loss are HK\$31,532,000 (2019: HK\$44,377,000), representing contributions paid/payable to the above defined contribution retirement benefits schemes.

###### Interest rate risk

The Group is mainly exposed to cash flow interest rate risk in relation to variable-rate bank and other borrowings and bank balances, and fair value interest rate risk in relation to fixed-rate pledged bank deposits, short term bank deposits and lease liabilities.

The Group currently does not have interest rate hedging policy. However, management closely monitors its exposure to future cash flow risk as a result of change on market interest rate and will consider hedging changes in market interest rates should the need arise.

The Group's exposures to interest rates on financial liabilities are detailed in the liquidity risk section of this note. The Group's cash flow interest rate risk is mainly concentrated on the fluctuation of HIBOR or LIBOR arising from the Group's variable-rate bank and other borrowings.

###### Sensitivity analysis

The sensitivity analysis below has been determined based on the exposure to interest rate risk on bank borrowings. The sensitivity analysis is prepared assuming the bank and other borrowings outstanding at the end of the reporting period were outstanding for the whole year. No sensitivity analysis is presented on bank balances as the management of the Group considers that the interest rate fluctuation on bank balances is minimal.

A 50 basis point increase or decrease is used in the sensitivity analysis, which represents management's assessment of the reasonably possible change in interest rates. ###### Trade receivables arising from contracts with customers

In order to minimise the credit risk, the management of the Group has delegated a team responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In addition, the Group identifies trade receivables that are credit impaired and assesses their ECL individually, and performs impairment assessment under ECL model on the remaining trade balances based on provision matrix. The estimated loss rates are estimated based on historical observed default rates over the expected life of the debtors and are adjusted for forward-looking information (for example, the current and forecasted default rates in Asia-Pacific, North America and Europe as published by international credit agency, which reflect the general credit risk of the major debtors and the geographical market that they operate) that is available without undue cost or effort. Such forward-looking information is used by the management of the Group to assess both the current as well as the forecast direction of conditions at the reporting date. #### Liquidity risk

In the management of liquidity risk, the Group monitors and maintains a level of cash and cash equivalents deemed adequate by the management to finance the operations and mitigate the effects of fluctuations in cash flows. The Group relies on bank and other borrowings as a significant source of liquidity. As at 31 December 2020, the Group has unutilised banking facilities of HK\$2,620,485,000 (2019: HK\$2,866,000,000). The management monitors the utilisation of borrowings and ensures compliance with loan covenants.

The following tables detail the Group's remaining contractual maturity for its non-derivative financial liabilities and lease liabilities. The tables have been drawn up based on the undiscounted cash flows of financial liabilities and lease liabilities based on the earliest date on which the Group can be required to pay. Specifically, bank borrowings with a repayment on demand clause are included in the earliest time band regardless of the probability of the banks or financial institutions choosing to exercise their rights. The table includes both interest and principal cash flows.

To the extent that interest flows are floating rate, the undiscounted amount is derived from the interest rate at the end of the reporting period.

On 29 January 2021, Trischel (a non-wholly owned subsidiary of the Company) entered into an Assets Sale and Purchase Agreement (“**Assets Sale and Purchase Agreement**”) with Textprint Lanka (Private) Limited (“**Textprint**”) (an indirect wholly-owned subsidiary of MAS Holdings (Private) Limited, being the non-controlling shareholder of Trischel) in relation to the sales and purchase of assets which consisted of (i) fixed assets which mainly included printing machines, washing machines, boilers, steamers, fabric inspection machines, dryers and other equipment for printing synthetic fabrics and the associated finishing processes currently used at the manufacturing plant of Textprint (the “**Plant**”), as well as (ii) inventory of Textprint for printing business as recorded in the management accounts of Textprint as at 31 January 2021. Pursuant to the Assets Sale and Purchase Agreement, Textprint shall transfer up to 252 of its employees to Trischel.

The consideration for the transactions contemplated under the Assets Sale and Purchase Agreement is estimated to be no more than US\$4,000,000 (equivalent to approximately HK\$31,200,000). The consideration shall also be subject to deduction on account of unpaid utility bills relating to the Plant, outstanding staff related costs, wages and/or existing or pending claims of the transferring employees. Pursuant to the Assets Sale and Purchase Agreement, Trischel shall pay US\$2,199,650.33 (equivalent to approximately HK\$17,157,000) to Textprint on the date of completion.

Completion of this transaction had taken place on 1 February 2021. Details of this transaction were disclosed in the Company's announcement dated 29 January 2021. The directors of the Company are in the process of assessing the financial impact of such transaction to the consolidated financial statements in the next reporting period.
