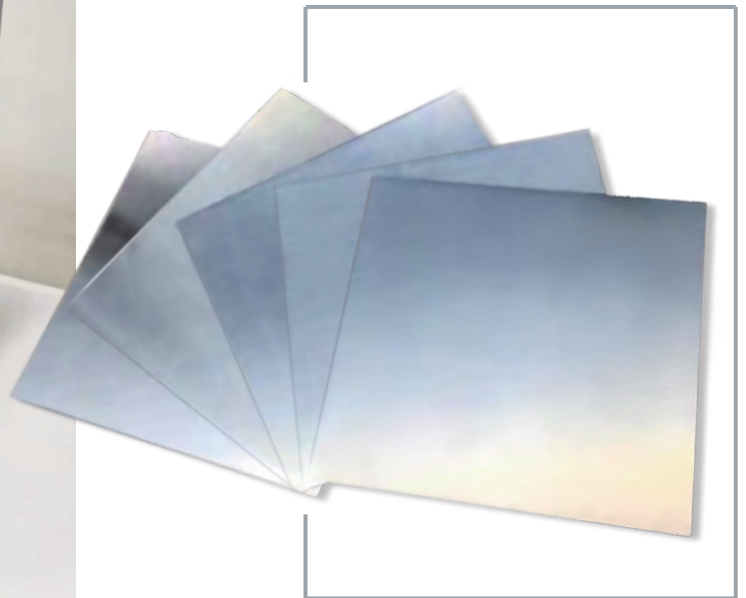
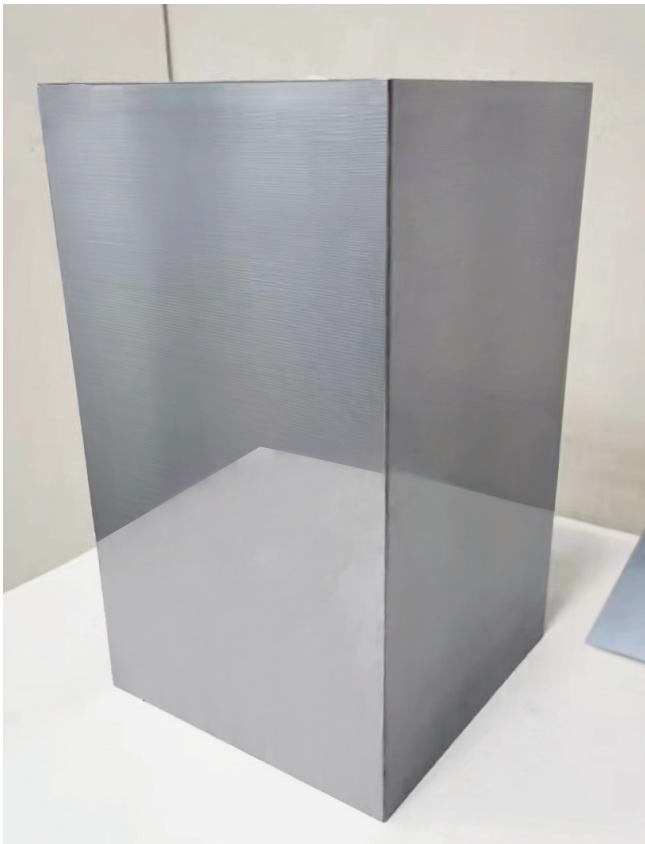

# Chairman's Statement

## 主席報告書



Dear Shareholders,

On behalf of the board (the "Board") of directors (the "Directors") of Baofeng Modern International Holdings Company Limited ("Baofeng Modern" or the "Company"), I am pleased to present the financial report of the Company and its subsidiaries (collectively, the "Group") for the year ended 31 December 2020.

The outbreak of the novel coronavirus ("COVID-19") epidemic in 2020 had an adverse impact on global economies, particularly in the retail market. Although the production of the Group has fully resumed in the first half of the year, the lockdowns and social distancing measures have severely affected the consumer demand and the quantity ordered, resulting in a decline in the sales of the Group, especially for the Original Equipment Manufacturer ("OEM") business, for the current year. During 2020, the Group recorded a decrease in revenue of approximately RMB57.8 million or 34.1% to approximately RMB111.9 million. Due to the contraction in the consumer demand, some major customers of the OEM Business asked for price cut, the Group was forced to reduce its gross profit margin to retain existing customers. Therefore, the gross profit margin of the Group during the year was dropped to approximately 16.1%.

Looking ahead to 2021, the global outbreak of the COVID-19 epidemic is expected to continue to have a negative impact on the global retail market. However, it is expected that the retail market will recover from the shock as many countries started the COVID-19 vaccinations and plan to ease the restrictive measures. The Group expects the delayed orders of OEM customers will resume in 2021. Besides, consumers purchasing habit was forced to change due to the COVID-19 epidemic and even after epidemic was under control in the People's Republic of China ("PRC"), consumers may perpetually maintain the same or perhaps higher levels of online purchasing. Hence, the Group would focus on online sales in the PRC and the design and sales of indoor slippers in 2021.

各位尊敬的股東：

本人謹代表寶峰時尚國際控股有限公司（「寶峰時尚」或「本公司」）董事（「董事」）會（「董事會」）提呈本公司及其附屬公司（統稱「本集團」）截至二零二零年十二月三十一日止年度的財務報告。

二零二零年爆發新型冠狀病毒（「COVID-19」）疫情對全球經濟，尤其是零售市場，造成不利影響。儘管本集團於上半年已全面恢復正常生產，封鎖及社交距離措施嚴重影響消費者需求及訂貨量，導致本集團全年的銷售（尤其是原設備製造商（「OEM」）業務）有所下降。於二零二零年，本集團錄得收益減少約人民幣57,800,000元或34.1%至約人民幣111,900,000元。由於消費者需求收縮，若干OEM業務的主要客戶要求減價，本集團被迫降低其毛利率以挽留現有客戶。因此，本集團於年內的毛利率下降至約16.1%。

展望二零二一年，全球爆發COVID-19疫情預期將繼續對全球零售市場產生負面影響。然而，隨著多個國家開始接種COVID-19疫苗及計劃放寬限制措施，預計零售市場將從衝擊中復甦。本集團預期延遲的OEM客戶訂單將於二零二一年恢復。此外，由於COVID-19疫情，消費者購物習慣被迫改變，儘管在中華人民共和國（「中國」）疫情已受控，消費者可能永久保持相同甚至更頻繁的網購。因此，本集團將於二零二一年專注中國的線上銷售以及室內拖鞋設計及銷售。





# Chairman's Statement

## 主席報告書

The Group continuously endeavored to transform itself from a traditional manufacturing company to a materials science company in 2020. Besides the gradual progress in the development of air sterilizers and carbon-based energy storage batteries, the Group officially entered into the photovoltaic industry this year, with a plan to manufacture and sell cast monocrystalline silicon (“Cast-mono”) wafers and Cast-mono heterojunction (“HJT”) solar cells developed based on the proprietary materials science technology of the Group.

In view of the rising expectations of the global community for renewable energy, and China's goal of achieving carbon neutrality by 2060, the Group has established the strategic goal of accelerating the transformation of the photovoltaic industry with its materials science expertise. In 2020, the Group conducted technological collaboration with several leading companies in the photovoltaic industry, and leveraged the materials science expertise accumulated by the Group over the years to successfully develop Cast-mono wafers that effectively reduce wafer costs, and further realized the production of high efficiency HJT solar cells produced with Cast-mono wafers through cooperation with strategic partners. Going forward, the Group will focus on mass production of the above Cast-mono wafers and Cast-mono HJT solar cells, and thus contributes to the realisation of the carbon neutrality goal.

Last but not the least, on behalf of the Board, I would like to thank our management and all staff for their dedication and contribution to the development of the Group. I would also like to take this opportunity to express my sincere gratitude to our customers, suppliers, business partners and shareholders for their continuous commitment and support.

本集團於二零二零年仍繼續致力於從傳統製造企業轉型為材料科技公司。除了在空氣殺菌器及碳基儲能電池的開發逐步有進展以外，本集團於本年度正式跨入光伏產業，計劃生產及銷售基於本集團的獨家材料科技開發出的單晶鑄錠（「單鑄」）硅片及單鑄異質結（「HJT」）太陽能電池。

有鑒於全球社會對可再生能源的期盼不斷上升，以及中國爭取二零六零年前實現碳中和目標，本集團確立了以其材料科技專業加速光伏行業進行轉型的戰略目標。本集團在二零二零年度與數個光伏行業領先企業進行技術合作，成功運用本集團多年累積的材料科技專長成功開發了有效降低硅片成本的單鑄硅片，並進一步與戰略合作夥伴合作實現以單鑄硅片製作高效HJT太陽能電池。未來，本集團將致力於量產上述單鑄硅片及單鑄HJT太陽能電池，為實現碳中和目標貢獻。

最後，本人謹代表董事會，向本集團管理層及全體僱員致謝，感謝各位為本集團發展作出的努力和貢獻。本人亦謹此對本集團客戶、供應商、業務夥伴及股東的鼎力支持致以衷心的感謝。

Although the production of the Group have fully resumed in the first half of the year, the global outbreak of the COVID-19 epidemic and the associated lockdowns and social distancing measures have severely affected the consumer demand and the quantity ordered, resulting in a decline in the sales of the Group, especially for the OEM business, for the current year. During the year, the Group recorded a decrease in revenue of approximately RMB57.8 million or 34.1% for approximately RMB111.9 million (2019: RMB169.7 million).

Due to the contraction in the consumer demand, some major customers of the OEM Business asked for price cut, the Group was forced to reduce its gross profit margin to retain existing customers. Therefore, the gross profit margin of the Group during the year was dropped to approximately 16.1% (2019: 17.7%).

During the year, the Group recorded a net loss of approximately RMB108.8 million, as compared with the net loss of approximately RMB314.4 million of last year. Such decrease in net loss was mainly attributable to (i) decrease in amortisation of intangible assets of approximately RMB40.4 million; (ii) decrease in impairment loss on intangible assets of approximately RMB169.5 million; (iii) fair value gain on investment properties of approximately RMB14.1 million (2019: Nil); net-off by (iv) increase in share-based payment expenses of approximately RMB10.6 million.

Due to the outbreak of the COVID-19 epidemic, the formal launch of the new generation of do-it-yourself (“DIY”) automated vending system was delayed to October 2020. Besides, as the epidemic has bolstered the growing trend of customers staying at home and shopping online, the Group would allocate more resources and focused on online sales in the PRC. As the management of the Company made a more prudent estimation on the future quantity and the speed of installation of the DIY automated vending system in the financial model, impairment loss of approximately RMB51.3 million and approximately RMB13.5 million on the technology know-how and Online-to-Offline (“O2O”) distribution system was recognised during the year.

儘管本集團於上半年已全面恢復正常生產，COVID-19疫情的全球爆發及相關的封鎖及社交距離措施嚴重影響消費者需求及訂貨量，導致本集團全年的銷售（尤其是OEM業務）有所下降。於本年度，本集團錄得收益減少約人民幣57,800,000元或34.1%至約人民幣111,900,000元（二零一九年：人民幣169,700,000元）。

由於消費者需求收縮，OEM業務的若干主要客戶要求減價，本集團被迫降低其毛利率以挽留現有客戶。因此，本集團於年內的毛利率減少至約16.1%（二零一九年：17.7%）。

本集團於年內錄得淨虧損約人民幣108,800,000元，而去年之淨虧損約為人民幣314,400,000元。有關淨虧損減少主要是由於(i)無形資產攤銷減少約人民幣40,400,000元；(ii)無形資產減值虧損減少約人民幣169,500,000元；(iii)投資物業之公平值收益約人民幣14,100,000元；及(iv)以股份為基礎付款開支增加約人民幣10,600,000元互相抵銷所致。

由於COVID-19疫情爆發，新一代自助（「DIY」）自動售貨系統延至二零二零年十月正式推出。此外，由於疫情促進客戶居家及線上購物的增長趨勢，故本集團分配更多資源並將重點放至中國線上銷售。由於本集團管理層在財務模式中對未來新一代DIY自動售貨系統數量及安裝速度之估計較為審慎，故於年內就技術知識及線上線下（「O2O」）分銷售貨系統確認減值虧損約人民幣51,300,000元及約人民幣13,500,000元。

#### Boree Products

As the Group focused on the promotion of the newly launched indoor graphene-based sterilizing slippers "Graphener" during the year, online sales of Boree products declined and revenue from Boree Products decreased by 25.6% to approximately RMB2.0 million during the year (2019: RMB2.7 million).

#### Graphene-based Products

Revenue of the Graphene-based Products amounted to approximately RMB4.2 million (2019: RMB4.0 million) during the year. Due to the outbreak of the COVID-19 epidemic, the formal launch of the new generation of DIY automated vending system was delayed to October 2020. However, as the epidemic has bolstered the growing trend of customers staying at home and shopping online, the Group allocated more resources on online sales in the PRC and focused on the design and sales of indoor slippers. During the first half of the year, the newly launched indoor graphene-based sterilizing slippers "Graphener" were favored by consumers and the sales kept growing in the second half of the year. As a result, revenue of Graphene-based Products slightly increased during the year.

For other graphene application products, the Group has launched three models of air sterilizers "Graphenix" and has sent samples to an overseas well-known producer of air conditioning system for testing and recognition. Graphenix is specially designed to kill viruses and bacteria that cause allergies and respiratory system discomfort and different models are designed for household and for places with strict requirements on air quality, such as workplace, studio, and other demanding indoor environment. The feedback from this customer is positive and a first order of small quantity was completed during the year.

#### 寶人牌產品

由於本集團於年內專注於推廣新推出的室內石墨烯殺菌拖鞋「烯元鞋」，寶人牌產品的網上銷售下降以及寶人牌產品的收益於年內減少25.6%至約人民幣2,000,000元（二零一九年：人民幣2,700,000元）。

#### 石墨烯產品

年內，石墨烯產品的收益約人民幣4,200,000元（二零一九年：人民幣4,000,000元）。由於COVID-19疫情的爆發，新一代DIY自動售貨系統延至二零二零年十月正式推出。然而，由於疫情促進客戶居家及線上購物的增長趨勢，故本集團分配更多資源至中國線上銷售，並專注於室內拖鞋設計及銷售。於上半年新推出的室內石墨烯殺菌拖鞋「烯元鞋」受消費者青睞，下半年的銷售保持增長。因此，年內石墨烯產品的收益輕微上升。

就其他石墨烯應用產品而言，本集團已推出三款型號的空氣殺菌器「Graphenix」，並將樣品送交一家國外知名空調系統製造商進行測試及認可。Graphenix專門設計用於殺死引起過敏和呼吸系統不適的病毒及細菌，且針對家庭及對空氣質量有嚴格要求的場所（如工作場所、工作室及其他嚴格要求的室內環境）設計不同型號。該客戶的反饋正面，且本集團於年內已完成第一筆小額訂單。

#### OEM Business

Due to the global outbreak of the COVID-19 epidemic and the associated lockdowns and social distancing measures, the consumer demand for non-essential retail goods was severely affected. Although the delayed customers orders in the first half of this year were gradually resumed in the second half of the year, some orders near the end of the year could not be completed in time during the year, the shipment had to be postponed to the first quarter of 2021. The contraction in the customer demand resulting in a substantial decrease of approximately RMB57.2 million revenue from OEM business to approximately RMB105.7 million during the year (2019: RMB162.9 million).

#### Selling and Distribution Expenses

During the year, selling and distribution expenses decreased by 28.6% to approximately RMB7.9 million as compared with that of last year (2019: RMB11.1 million), which accounted for 7.1% (2019: 6.5%) of the Group's revenue. The decrease was mainly attributable to the decline in sales during the year.

#### General and Administrative Expenses

General and administrative expenses recorded an increase of approximately RMB15.2 million or 34.1% during the year as compared with that of last year (2019: RMB44.5 million), which was mainly attributable to (i) increase in share-based payment expenses of approximately RMB10.6 million in relation to the share options granted by the Company on 22 October 2020; and (ii) increase in research and development cost of approximately RMB3.4 million during the year.

#### Liquidity and Financial Resources

During the year, net cash outflow from operating activities of the Group amounted to approximately RMB2.6 million (2019: RMB8.3 million). As at 31 December 2020, cash and bank balances were approximately RMB0.6 million, representing a decrease of 84.8% as compared with the cash and bank balances as at the end of last year (2019: RMB4.1 million). As at 31 December 2020, around 61.4% and 30.6% of the Group's cash and bank balances were denominated in Hong Kong dollars and Renminbi respectively. As at 31 December 2020, the short term borrowings of the Group were approximately RMB130.1 million (2019: RMB114.2 million). All loans were denominated in Renminbi, with fixed interest rates and repayable within one year.

#### OEM業務

由於全球爆發COVID-19疫情及相關的封鎖及社交距離措施，消費者對非必需零售商品的需求受到嚴重影響。儘管本年度上半年的延遲客戶訂單於下半年逐漸恢復，一些臨近年底的訂單無法於年內及時完成，貨運已推遲至二零二一年第一季度。消費者需求收縮導致OEM業務的收益大幅減少約人民幣57,200,000元至約人民幣105,700,000元（二零一九年：人民幣162,900,000元）。

#### 銷售及分銷開支

年內，銷售及分銷開支與去年相比下降28.6%至約人民幣7,900,000元（二零一九年：人民幣11,100,000元），佔本集團收益的7.1%（二零一九年：6.5%）。下降主要是由於年內銷售下降所致。

#### 一般及行政開支

年內，一般及行政開支與去年相比錄得約人民幣15,200,000元或34.1%的升幅（二零一九年：人民幣44,500,000元），主要是由於(i)本公司於二零二零年十月二十二日授出購股權之以股份支付的開支上升約人民幣10,600,000元；及(ii)研發成本於年內增加約人民幣3,400,000元所致。

#### 流動資金及財務資源

年內，本集團經營活動之現金流出淨額約為人民幣2,600,000元（二零一九年：人民幣8,300,000元）。於二零二零年十二月三十一日，現金及銀行結餘約為人民幣600,000元，較去年末的現金及銀行結餘下降84.8%（二零一九年：人民幣4,100,000元）。於二零二零年十二月三十一日，本集團的現金及銀行結餘約61.4%及30.6%分別以港元及人民幣計值。於二零二零年十二月三十一日，本集團短期借貸約為人民幣130,100,000元（二零一九年：人民幣114,200,000元）。所有貸款均以人民幣計值，利率固定及須於一年內償還。

#### Liquidity and Financial Resources (continued)

As at 31 December 2020, the gearing ratio of the Group was -523.8% (2019: 466.4%). Gearing ratio was calculated as total debt divided by the total equity. Total debt refers to the total liability minus the sum of tax payable, dividend payable and deferred tax liability.

#### Capital Structure

As at 1 January 2020 and 31 December 2020, the Company had 1,486,859,608 shares in issue and a paid-up capital of approximately RMB99,310,000.

#### Significant Investments, Material Acquisitions and Disposals

During the year, the Group did not have any other significant investments, material acquisitions and disposals.

#### Pledge of Assets

As at 31 December 2020, the bills payables were secured by a pledge of the Group's time deposits amounting to approximately RMB3.8 million (2019: RMB3.9 million). As at 31 December 2020, the bank borrowings of the Group were secured by a pledge of the Group's buildings with carrying amount of approximately RMB3.6 million (2019: RMB6.1 million), leasehold land and the land of investment properties with carrying amounts of approximately RMB4.2 million (2019: right-of-use assets of RMB26.2 million) and approximately RMB31.2 million (2019: Nil) respectively.

The building of investment properties with carrying amount of approximately RMB28.8 million was pledged to an independent third party for a loan facility of RMB20 million. The loan was not yet utilized as at 31 December 2020.

#### Contingent Liabilities

During the year of 2020, a supplier had filed lawsuit against the overdue payment of Quanzhou Baofeng Shoes Co., Ltd. (“Quanzhou Baofeng”), an indirect wholly-owned subsidiary of the Company, with total amount of approximately RMB0.5 million (the “Amount in Question”) and the first trial held that Quanzhou Baofeng shall repay the Amount in Question plus interest.

Based on the best estimation of the management of the Company, Quanzhou Baofeng has valid ground in opposing the Amount in Question in the judgement of the above said case. As the lawsuit is in the process of appeal, the corresponding legal fee and interest are uncertain. Accordingly, no provision has been made in the consolidated financial statement.

Except as described above, there was no material contingent liabilities as at 31 December 2020 and 2019.

#### Foreign Exchange Risk

During the year, the revenue of the Group were mainly denominated in US dollars and Renminbi. The cost of sales and operating expenses were mainly denominated in Renminbi. Management of the Group monitors the foreign exchange risk and will consider hedging significant foreign currency risk exposure if necessary.

#### Human Resources

As at 31 December 2020, the Group had a total of approximately 600 employees (2019: 740 employees), with total staff costs for the year ended 31 December 2020, including directors' remuneration, amounted to approximately RMB64,616,000 (2019: RMB62,951,000). The Group's emolument policies are based on the merit, qualifications and competence of individual employee and are reviewed by the remuneration committee periodically. The emoluments of the Directors are recommended by the remuneration committee and are decided by the Board, having regard to the Group's operating results, individual performance and comparable market statistics. The Company also adopted a share option scheme (the "Share Option Scheme") on 8 January 2011 to motivate and reward its Directors and eligible employees.

#### Use of Net Proceeds from the Subscription of New Shares in 2018

As disclosed in the Company's announcements dated 9 November 2018, 12 November 2018, 8 March 2019 and 29 May 2019, Venus Capital Fund and Mr. Chiu Hsin-Wang ("Mr. Chiu"), the two independent subscribers, subscribed for a total of 182,800,000 new ordinary shares of the Company (the "Shares") of US\$0.01 each at a subscription price of HK\$0.27 per subscription share which were completed on 8 March 2019 (the "2018 Subscription"). The closing market price was HK\$0.33 per Share on the date on which the terms of the 2018 Subscription were fixed. The gross proceeds from the 2018 Subscription was approximately HK\$49,356,000 (equivalent to approximately RMB43,175,000), and the net proceeds (after deducting the relevant expenses incurred in the 2018 Subscription) were approximately HK\$49,136,000 (equivalent to approximately RMB42,982,000). The net subscription price, after deducting relevant expenses, was approximately HK\$0.27 per subscription share.

The Directors considered that the 2018 Subscription represented an opportunity to raise additional funding for research and development of carbon-based energy storage batteries in order to develop new markets and new business, and provide working capital to the Group to meet any financial obligations of the Group.

### FUTURE PROSPECTS

#### Existing Business

The global outbreak of the COVID-19 epidemic is expected to continue to have a negative impact on the global retail market in 2021. However, it is expected that the retail market will recover from the shock as many countries started the COVID-19 vaccinations and plan to ease the restrictive measures. The Group expects the delayed orders of OEM customers in last year will resume in 2021.

China's most recent ecommerce boom did not decelerate even after the COVID-19 epidemic was under control, the consumers do not lose interest in online purchasing and will likely maintain the same or perhaps higher levels of online purchasing forevermore. Hence, the Group would focus on online sales in the PRC and the design and sales of indoor slippers in 2021.

For other graphene application products, the Group is still negotiating with a potential customer on the sales terms of air sterilizers. For the carbon-based energy storage batteries, the Group has sent samples to our cooperative parties for joint production for testing and met all the required standards. As the Group would focus and allocate more resources on the manufacturing of large size Cast-mono wafers and high efficiency HJT solar cells in 2021, the mass production schedule of carbon-based energy storage batteries would be delayed.

#### 未來前景

##### 現有業務

預計全球爆發COVID-19疫情將繼續對二零二一年的全球零售市場產生負面影響。然而，隨著多個國家開始進行COVID-19疫苗接種及計劃放寬限制措施，預期零售市場將從衝擊中復甦。本集團預期去年OEM客戶延遲的訂單將於二零二一年恢復。

儘管於中國COVID-19疫情已受控，但近期電子商務的繁榮景象但並未放緩，消費者並未對網購失去意慾，且有可能永久保持相同甚至更頻繁的網購。因此，本集團將於二零二一年專注中國的線上銷售以及室內拖鞋設計及銷售。

就其他石墨烯應用產品而言，本集團正與一位潛在客戶磋商空氣殺菌器的銷售條款。至於碳基儲能電池，本集團已將樣品送交聯合生產的合作方以進行測試，並達致所有規定標準。由於本集團將於二零二一年專注並分配更多資源於製造大尺寸單鑄硅片及高效HJT太陽能電池，因此碳基儲能電池的批量生產計劃將予推遲。

#### New Business

As disclosed in the Company's announcements dated 25 January, 29 January and 11 March 2021, the Group successfully utilized casting technology to produce Cast-mono wafers, which was then used to manufacture HJT solar cells with an energy conversion efficiency exceeding 24.0% in September 2020. Besides, the Group entered into a casting silicon furnaces purchase agreement with the subsidiary of GCL-Poly Energy Holdings Limited on 29 January 2021, and entered into a license letter of intent with GS-Solar (Fujian) Company Limited and its subsidiary in relation to the patents and process techniques of HJT solar cells, together with a lease framework agreement in respect of the lease of production equipment for 500MW high efficiency HJT solar cells and a plant located in Fujian Province on 11 March 2021. The challenges in the photovoltaic industry are often substantial capital intensity and rapid technological obsolescence, resulting in difficult investment payback. Through the above arrangements, the Group adopts an asset-light business model as it transitions to new businesses in Cast-mono wafers and Cast-mono HJT solar cells.

HJT has increasingly been discussed in the solar market and is believed to have an energy conversion efficiency higher than that of the passivated emitter and rear cell technology ("PERC"). The Group believes that achieving similar or even lower manufacturing costs than PERC would be key to a successful transition from PERC to HJT in the solar industry. As the cost of silicon wafers generally accounts for more than half of total manufacturing cost of HJT solar cells, it is common for manufacturers to attempt reducing silicon wafers cost by continuously boosting production capacity, in order to benefit from economies of scale. Leveraging on its many years of investments in research and development of materials science, the Group has successfully developed a new technology which utilizes the lower cost casting technology to manufacture Cast-mono wafers with performances that are very similar to regular wafers produced with monocrystalline silicon using the Czochralski method ("CZ-mono").

#### 新業務

誠如本公司日期為二零二一年一月二十五日、一月二十九日及三月十一日之公佈所披露，於二零二零年九月，本集團成功以鑄錠技術製造單鑄硅片，然後利用該單鑄硅片生產HJT太陽能電池並達到大於24.0%的能源轉換效率。此外，本集團於二零二一年一月二十九日與保利協鑫能源控股有限公司的附屬公司訂立鑄錠爐購買協議，並於二零二一年三月十一日與福建鈞石能源有限公司及其附屬公司訂立有關HJT太陽能電池的專利及工藝技術的授權意向書，及有關租賃其在福建省的500兆瓦高效HJT太陽能電池生產設備及廠房之租賃框架協議。光伏行業經常遇到的挑戰就是高度資本密集以及技術迅速被淘汰，導致投資回收困難。透過上述安排，本集團採用輕資產商業模式轉型至單鑄硅片以及單鑄HJT太陽能電池的新業務。

在太陽能市場HJT越來越受到關注，並被相信其能源轉換效率比鈍化發射極和背面電池技術（「PERC」）更高。本集團認為將製造成本降至與PERC相近或更低是太陽能產業從PERC成功轉型至HJT的關鍵。由於硅片成本一般佔HJT太陽能電池總製造成本超過一半，製造商通常試圖通過不斷提高產能來降低硅片成本，以期從規模經濟中得益。本集團透過其在材料科技研發的多年投入成功開發一項新技術，利用成本較低的鑄錠技術來制作的單鑄硅片其性能與一般以提拉法制成的單晶「提拉單晶」硅片相近。

#### New Business (continued)

##### 1. Cast-mono Wafers

According to the 2019-2020 China Photovoltaic Industry Annual Report, Cast-mono wafers accounted for less than 3% market share of photovoltaic industry in 2019 in the PRC, while CZ-mono wafers accounted for more than 60%. In recent years, the latter has benefited from advancing manufacturing process and rising energy conversion efficiency. On the other hand, traditional casting method suffered from excessive impurities found in the wafers, which in turn results in a lower yield (often around 60%) of usable wafers. With its new proprietary technology and process know-how, the Group has managed to reduce such impurities, with a goal to raising its yield to over 90%, effectively lowering production costs.

##### 2. Cast-mono HJT Solar Cells

Recently, a few suppliers have started utilizing Cast-mono in PERC cells in order to benefit from lower manufacturing cost and energy conversion efficiency similar to that of CZ-mono PERC cells. The Group believes that higher energy conversion efficiency of leading HJT coupled with our innovative Cast-mono wafer technology could well position the next-generation Cast-mono HJT solar cells to compete with the mainstream CZ-mono PERC cells.

##### 3. Near-term Goals

The Group has recently procured 290 sets of casting silicon furnaces and its maximum production capacity is expected to be over 7 gigawatts located in Xuzhou City, Jiangsu Province. Modification work on the casting silicon furnaces would be commenced to incorporate our proprietary Cast-mono wafer technology to produce Cast-mono wafers. The Group plans to use such wafers to produce Cast-mono HJT solar cells in the plant in Putian City, Fujian Province, under the aforementioned lease and technology license collaboration with GS-Solar Group. In the case that demand for HJT solar modules arises from potential customers in the midst of the Group's promotion of HJT, the Group currently plans to outsource the production of HJT solar modules to external module manufacturers using HJT solar cells produced by the Group. In addition, the Group will actively collaborate with players in the photovoltaic industry to promote the applications of Cast-mono HJT globally.

#### 新業務 (續)

##### 1. 單鑄硅片

根據二零一九至二零二零年中國光伏產業年度報告，單鑄硅片佔二零一九年中國光伏市場少於3%，而提拉單晶硅片則佔超過60%。近年來，後者受益於進步的製造工藝和提升的能源轉換效率。另一方面，傳統鑄錠方法受制於其生產的硅片有過多的雜質，從而導致硅片的良率較低（通常約60%）。憑藉新的獨家技術和工藝知識，本集團成功減少該雜質，目標是將良率提高至90%以上，並有效地降低生產成本。

##### 2. 單鑄HJT太陽能電池

近期，有些供應商開始以單鑄硅片應用於PERC電池以受益於較低製造成本及接近提拉單晶PERC電池的能源轉換效率。本集團相信以更高能源轉換效率的領先HJT結合我們的創新單鑄硅片技術將可使新一代單鑄HJT太陽能電池與主流提拉單晶PERC電池競爭。

##### 3. 近期目標

本集團近期已購買位於江蘇省徐州市的290台鑄錠爐，其最大產能預期將超過7,000兆瓦。用於製造單鑄硅片的本集團獨家單鑄硅片技術的鑄錠爐改造即將進行。本集團計劃利用該硅片並透過上述與鈞石集團的租賃及技術授權合作於福建省莆田市廠房生產單鑄HJT太陽能電池。若在本集團推廣HJT的過程中潛在客戶有HJT太陽能組件需求，本集團計劃將本集團製造之HJT太陽能電池委託外部組件製造商製成HJT太陽能組件。此外，本集團將積極與光伏業界人士商談合作以推廣單鑄HJT在全球的應用。

To the best knowledge of the Company, there is no financial, business, family or other material/relevant relationship among the members of the Board. All of them are free to exercise their independent judgement.

The Board is responsible for establishing the overall strategic development and direction, setting business objectives and development plans, monitoring the performance of the business and senior management and making major investments and funding decisions of the Group.

The daily business operations and administrative functions of the Group are delegated to the management with department heads responsible for different aspects of the business and functions of the Group.

The Board meets regularly throughout the year to formulate overall strategy of the Group, monitor its financial performance and maintain effective oversight over the management. Sufficient notice of meetings is given to Directors prior to a regular board meeting, and each director is able to request inclusion of matters in the agenda for board meeting. Full minutes are prepared after the meetings.

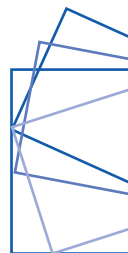

### CHAIRMAN AND CHIEF EXECUTIVE OFFICER

Code Provision A.2.1 stipulates that the roles of the Chairman and Chief Executive Officer should be separated and should not be performed by the same individual. The Company deviates from this provision because Mr. Zheng Jingdong has been performing both the roles of Chairman and Chief Executive Officer throughout the year ended 31 December 2020. Since 26 February 2021, Mr. Leung Tsz Chung has been appointed as Chairman of the Board and the Chief Executive Officer of the Group. The Directors consider that vesting two roles in the same person provides the Group with strong and consistent leadership in the development and execution of the Group's business strategies and is beneficial to the Group. The balance of power and authorities is ensured by the operation of the senior management and the Board, which comprise experienced and high caliber individuals. The Board currently comprises 3 executive Directors, 1 non-executive Director and 3 independent non-executive Directors and therefore has a strong independence element in its composition.

### INDEPENDENT NON-EXECUTIVE DIRECTORS

Independent non-executive Directors have played a significant role in the Board by bringing their independent judgment at the Board meetings and scrutinising the Group's performance. Their views carry significant weight in the Board's decision, in particular, they bring an impartial view to bear on issues of the Group's strategy, performance and control.

All independent non-executive Directors possess extensive academic, professional and industry expertise and management experience and have provided their professional advices to the Board.

The independent non-executive Directors provide independent advice on the Group's business strategy, results and management so that all interests of shareholders can be taken into account, and the interests of the Company and its shareholders can be protected.

As at 31 December 2020, the Board has three independent non-executive Directors, Professor Zhao Jinbao, Mr. Chen Shaohua and Ms. An Na. Among them, Mr. Chen Shaohua possesses appropriate professional accounting qualifications and financial management expertise in compliance with the requirements set out in Rules 3.10(1) and (2) of the Listing Rules.

### 主席及行政總裁

守則條文第A.2.1條規定，主席與行政總裁的職能應予以區分，不應由同一人士兼任。本公司就本條文有所偏離，因鄭景東先生於截至二零二零年十二月三十一日止整個年度兼任主席及行政總裁職位。自二零二一年二月二十六日起，梁子冲先生獲委任為董事會主席及本集團行政總裁。董事相信，一人兼任兩個職位可為本集團提供強大一致的領導，方便本集團業務策略的發展及執行，對本集團有利。職權平衡由高級管理層及董事會（由資深且富有才幹的人士組成）運作而保證，董事會現時包括3名執行董事、1名非執行董事及3名獨立非執行董事，因此其構成具有較強的獨立元素。

### 獨立非執行董事

獨立非執行董事在董事會擔當重任，負責在董事會會議提出獨立意見及監督本集團的表現。彼等的意見對董事會的決定舉足輕重，尤其是關於本集團策略、表現及監控事務的公正見解。

全體獨立非執行董事均具備豐富的學術、專業及行業背景及管理經驗，為董事會提供專業意見。

獨立非執行董事為本集團的業務策略、業績及管理提供獨立意見，確保充份考慮股東的一切權益，保障本公司和股東的利益。

於二零二零年十二月三十一日，董事會有三名獨立非執行董事，分別為趙金保教授、陳少華先生及安娜女士，當中陳少華先生具備符合上市規則第3.10(1)及(2)條規定的合適專業會計資格及財務管理經驗。



The Company has received from each of its independent non-executive Directors an annual confirmation of his/her independence pursuant to Rule 3.13 of the Listing Rules, and the Company considers the independent non-executive Directors to be independent.

### TERMS OF APPOINTMENT OF NON-EXECUTIVE DIRECTORS

Each of the non-executive Directors (including independent non-executive Directors) has entered into a service contract with the Company for an initial term of 3 years, which will continue thereafter until terminated by not less than three-month notice in writing served by either party on the other.

All independent non-executive Directors and non-executive Directors are subject to re-election on retirement by rotation in accordance with the Articles.

### APPOINTMENTS, RE-ELECTION AND REMOVAL OF DIRECTORS

Each of the executive Directors, non-executive Directors and independent non-executive Directors of the Company has entered into a service contract with the Company for a specific term. Such term is subject to retirement by rotation and re-election at an AGM at least once every three years in accordance with the Articles. The Articles provide that any Director appointed by the Board to fill a casual vacancy in the Board shall hold office until the first general meeting of the Company after his/her appointment and be subject to re-election at such meeting, and any Director appointed by the Board as an addition to the existing Board shall hold office only until the next AGM of the Company and shall then be eligible for re-election.

### BOARD COMMITTEES

The Company currently has three committees, namely, the audit committee, the remuneration committee and the nomination committee (collectively, the "Board Committees"), for overseeing particular aspects of the Company's affairs. Terms of reference of all Board Committees are in line with the Code Provision and are available on the Stock Exchange website and the Company's website at [www.baofengmodern.com](http://www.baofengmodern.com). The Board Committees are provided with sufficient resources to discharge their duties and, upon reasonable request, are able to seek independent professional advice in appropriate circumstances, at the Company's expenses.

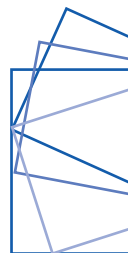

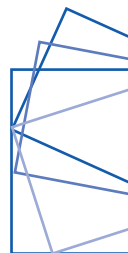

### Measurable objectives

Selection of candidates of the Board members will be based on a range of diversity perspectives, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service and any other factors that the Board may consider relevant and applicable from time to time. The ultimate decision will be based on merit and contribution that the selected candidates will bring to the Board, having due regard to the benefits of diversity on the Board and also the needs of the Board without focusing on a single diversity aspect.

The nomination committee will review the Board Diversity Policy from time to time to ensure its continued effectiveness.

### NOMINATION POLICY

The nomination committee shall consider certain factors, which are not exhaustive and the Board has discretion if it considers appropriate, in assessing the suitability of the proposed candidate regarding the appointment of directors or re-appointment of any existing Board member(s).

In assessing the suitability of a proposed candidate, the nomination committee shall make reference to certain criteria including reputation for integrity; accomplishment, experience and reputation in the business and industry; commitment in respect of sufficient time, interest and attention to the businesses of the Group; diversity policy of the Company; in case of independent non-executive director, the independence as prescribed under Rule 3.13 of the Listing Rules; and any other relevant factors as may be determined by the nomination committee or the Board from time to time as appropriate.

- (i) The nomination committee may select candidates for directorship from various channels, including but not limited to internal promotion, re-designation, referral by other member of the management and external recruitment agents, and should, upon receipt of the proposal on appointment of new director and the biographical information (or relevant details) of the candidate, evaluate such candidate based on the criteria as set out above to determine whether such candidate is qualified for directorship. If an independent non-executive director is to be appointed, the nomination committee will also assess and consider whether the candidate can satisfy the independence requirements as set out in the Listing Rules.
- (ii) If the process yields one or more desirable candidates, the nomination committee should rank them by order of preference based on the needs of the Company and reference check of each candidate (where applicable).
- (iii) The nomination committee should then recommend to the Board to appoint the appropriate candidate for directorship, as applicable. Where the Board proposes a resolution to elect an individual as an independent non-executive director at the general meeting, it should set out in the circular to shareholders and/or explanatory statement accompanying the notice of the relevant general meeting:
- the process used for identifying the individual and why the Board believes the individual should be elected and the reasons why it considers the individual to be independent;
  - if the proposed independent non-executive director will be holding their seventh (or more) listed company directorship, why the Board believes the individual would still be able to devote sufficient time to the Board;

- (iv) For any person that is nominated by a shareholder for election as a director at the general meeting of the Company, the nomination committee should evaluate such candidate based on the criteria as set out above to determine whether such candidate is qualified for directorship.

Where appropriate, the nomination committee should make recommendation to shareholders in respect of the proposed election of director at the general meeting.

- b) Re-election of director at general meeting
- (i) The nomination committee should review the overall contribution and service to the Company of the retiring director and his/her level of participation and performance on the Board.
- (ii) The nomination committee should also review and determine whether the retiring director continues to meet the criteria as set out above. If an independent non-executive director is subject to the re-election, the nomination committee will also assess and consider whether the independent non-executive director will continue to satisfy the independence requirements as set out in the Listing Rules.

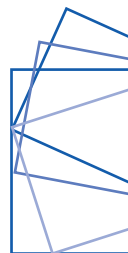

## DIRECTORS' RESPONSIBILITY FOR THE FINANCIAL STATEMENTS

### Directors' Responsibilities for Financial Reporting in respect of Financial Statements

The Directors acknowledge their responsibility for preparing the financial statements for the year ended 31 December 2020 which give a true and fair view of the affairs of the Company and the Group and of the Group's results and cash flows.

The management has provided to the Board such explanation and information as are necessary to enable the Board to carry out an informed assessment of the Company's financial statements, which are put to the Board for approval. The Company provides all members of the Board with updates from time to time on the Company's performance, positions and prospects.

The Directors have been aware of the capital deficiency of the Company that may cast significant issue on the going concern and the Directors had considered all available source of funding. The Directors have made an assessment on the liquidity position of the Group as to whether the Group is able to continue as a going concern for at least twelve months from the end of the reporting period. On 24 March 2021, the Company entered into a share subscription agreement ("2021 Subscription Agreement") with an independent third party, in relation to the subscription for 20,000,000 new Shares at HK\$4 per share (the "2021 Subscription"). The net proceeds from the 2021 Subscription will amount to HK\$79,700,000. On the same day, the Company entered into a placing agreement ("Placing Agreement") with a placing agent, pursuant to which the Company has agreed to place through the placing agent, on a best effort basis, up to 100,000,000 new Shares at HK\$4 per share (the "Placing"). The maximum net proceeds from the Placing will amount to HK\$397,860,000. On 26 March 2021, share subscription deposit in the sum of HK\$80,000,000 had been received. In the opinion of the Directors, the 2021 Subscription and Placing Agreement are expected to be completed in April 2021. The Directors are in the opinion that it is appropriate to prepare the consolidated financial statement on a going concern basis.

董事已知悉資金不足可能對持續經營造成重大問題且董事已考慮所有可用資金來源。董事已基於本集團的流動資金狀況評估本集團能否於報告期末起計至少十二個月持續經營。於二零二一年三月二十四日,本公司與一名獨立第三方訂立股份認購協議(「二零二一年認購協議」),內容有關按每股4港元認購20,000,000股新股份(「二零二一年認購事項」)。二零二一年認購事項之所得款項淨額將為79,700,000港元。於同日,本公司與一名配售代理訂立配售協議(「配售協議」),據此,本公司已同意通過配售代理以每股股份4港元盡力配售最多100,000,000股新股份(「配售事項」)。配售事項所得款項淨額最高將為397,860,000港元。於二零二一年三月二十六日,股份認購按金80,000,000港元已收取。董事認為,二零二一年認購事項及配售協議預期於二零二一年四月完成。董事認為,按持續經營基準編製綜合財務報表屬適當。

The Directors are responsible for the preparation of the financial statements which give a true and fair view of the state of affairs of the Group, and in accordance with International Financial Reporting Standards issued by the International Accounting Standards Board and the disclosure requirements of the Hong Kong Companies Ordinance. The statement by the auditors of the Company about their responsibilities for the financial statements is set out in the independent auditor's report contained in this annual report.

### RISK MANAGEMENT AND INTERNAL CONTROL

The Board has the responsibility to maintain an effective risk management and internal control system in order to protect the Group's assets and shareholders' interests. The Group has an internal audit function. The Board and audit committee also conduct periodic reviews to ensure the effectiveness of the Group's risk management and internal control systems. The risk management and internal control systems include a well-established corporate structure and organisation with clearly defined lines of responsibility and authority. Each department is responsible for its daily operations, and is also required to implement and monitor the strategies and policies adopted by the Board and effective employment of the resources of the Company, in order to avoid misappropriation of resources and damages made to the Company's assets, and prevent against errors and fraud.

During the financial year ended 31 December 2020, the Board and audit committee conducted a review and assessment of the effectiveness of the internal control system and procedures based on information derived from discussions with the management of the Company and its external auditor. The Board and audit committee believe that the existing risk management and internal control systems are adequate and effective. The review covered all material controls, including financial, operational and compliance controls and risk management functions as well as the adequacy of resources, qualifications and experience of staff of the Company's accounting, internal audit and financial reporting function, and their training programmes and budget.

The Board has established a clearly defined scope of activities, responsibility and authority for each department and its management staff within the Group. The Group has a defined goal for each department to accomplish. These goals were discussed in the Board meeting and pass on to the management through the executive Directors, and will be implemented and closely monitored by the executive Directors who shall review the operational and financial results from time to time, and take any necessary actions for the improvement of business activities.

### AUDITOR'S REMUNERATION

During the year, the remuneration in respect of audit services provided by the Company's auditor, Confucius International CPA Limited was RMB1,511,000.

### DIVIDEND POLICY

The Board adopted a dividend policy on 20 February 2019. The Board has the discretion to declare and distribute dividends to the shareholders of the Company. Any declaration of final dividends for the year will be subject to the approval of the Company's shareholders. In proposing any dividend pay-out, the Board shall take into account the following factors:

- the Group's actual and expected financial performance;
- the Group's expected working capital requirements, capital expenditure requirements and future expansion plans;
- retained earnings and distributable reserves of the Company and each of the members of the Group;
- the Group's liquidity position;
- general economic conditions and other internal or external factors that may have impact on the business or financial performance and position of the Group; and
- any other factors that the Board deems relevant.

#### Convening an EGM and Putting Forward Proposals at Shareholders' Meetings

Pursuant to Article 58 of the Articles, any one or more members of the Company holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Board or the company secretary of the Company, to require an EGM to be called by the Board for the transaction of any business specified in such requisition; and such meeting shall be held within two months after the deposit of such requisition. If within twenty-one days of such deposit the Board fails to proceed to convene such meeting the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

The same requirements and procedures also apply to any proposal to be tabled at shareholders' meetings for adoption.

#### Directors' and Officers' Liabilities Insurance

Appropriate insurance coverage for Directors' and officers' liabilities in respect of legal actions against the Directors and officers of the Group arising out of corporate activities of the Group has been arranged by the Company.

This Report is prepared in accordance with the ESG Reporting Guide set out in Appendix 27 to the Listing Rules on the Stock Exchange. This Report mainly summarises the environment and social performance of the Group during the period from 1 January 2020 to 31 December 2020. The scope of the information disclosed in this Report and the statistical methods are consistent with the previous year.

The Company strives to safeguard and balance the interests of each stakeholder and follows the operating principle of “taste of life, happy production”. Facing the changes and challenges of business environment, the Group never forget to commit corporate social responsibility while pursuing growth. In respect of the respective area of product safety, product quality, energy saving and environmental protection, social welfare and employee care, the Group will ensure that the business operations can create value for the social, human and natural capital, and actively fulfill corporate social responsibility.

The Board is responsible for determining the ESG risks of the Group, formulating ESG strategies, ensuring the establishment and maintenance of an effective internal control system on ESG and conducting regular analysis and independent assessment on the adequacy and effectiveness of the aforementioned system through internal audit functions. The Board have identified the material ESG issues from the annual materiality assessment exercise that involved both the key employees and external stakeholders. ### A. ENVIRONMENTAL ASPECTS

The Group always pays attention to environmental protection. In respect of environmental management, the ISO14001 environmental management system has been established and implemented since 2006, with annual review supervised by third-party certification institutions and regulatory authorities. The Group formulates appropriate environmental management operation control procedures, commits to environmental protection through continuous enhancement on production technology and product quality, introduction and promotion of energy conservation, waste reduction, clean production, improvement on pollution prevention and control technology, and material recycling and reuse. In 2020, the Group invested a total of approximately RMB172,000 for energy saving, environmental protection, and emission and waste reduction. The Group adheres to green and low-carbon development principle,

### A. 環境方面

Climate-change issues do not have significant impact on the Group's business activities.

To the best of the Group's knowledge, there were no material non-compliances concerning environmental laws and regulations during the reporting period.

### A.1 Emissions Management

The Group strives to carry out clean production, abides by the “Environmental Protection Law of the People’s Republic of China” and other relevant laws and regulations, and reduces the environmental impact of emissions generated from the production and operation process. The Group ensures that the emissions generated from production and operation activities are in compliance with national standards and the requirements of local environmental protection authorities of the PRC. In the meantime, the Group formulates and implements daily inspection of pollution treatment facilities, and formulates monthly, quarterly and annual maintenance plans to ensure emission treatment facilities are under normal operation, so as to reduce the impact of emissions on the environment.

As summarised in Table 1 below, the Group’s emissions during the reporting period included: greenhouse gas (“GHG”) and waste water.

### A.1 排放物管理

本集團致力於清潔生產，遵守《中華人民共和國環境保護法》等其他相關法律法規的規定，減少在生產和運營過程中產生的排放物所帶來的環境影響。本集團確保生產經營業務排放之排放物均符合中國國家標準與當地環保部門的規定。同時，本集團制訂及實行每日檢查污染處理設施並制定月度、季度及年度保養計劃，以確保排污處理設備運行正常，以減少排放物對於環境的影響。

於報告期內，本集團的排放物包含：溫室氣體（「溫室氣體」）和廢水。概述於下表一。

### GHG Emission

GHG included carbon dioxide, methane and nitrous oxide, which were mainly from externally-purchased electricity and fuel. The Group is in compliance with the "Law of the People's Republic of China on the Prevention and Control of Atmospheric Pollution" and other relevant laws and regulations, recycling certain particles generated during the production process to minimize exhaust gas emission to the greatest extent. The Group uses clean natural gas and has installed exhaust gas treatment equipment on production boilers to effectively control exhaust gas and soot generated during the combustion of boilers and ensure the emission concentration meets the standard stipulated in the "Emission Standard of Air Pollutants for Boiler".

### 溫室氣體排放

溫室氣體包括二氧化碳、甲烷和氧化亞氮，主要源自外購電力及燃料。本集團遵守《中華人民共和國大氣污染防治法》等其他相關法律法規的要求，對生產過程中產生的部分顆粒物進行回收，最大程度地減少廢氣的排放量。本集團生產用鍋爐使用清潔能源天然氣並安裝廢氣處理裝置，對鍋爐燃燒時產生的廢氣和煙塵進行有效的控制，並確保排放濃度達到《鍋爐大氣污染物排放標準》中限定的標準。



### **Wastewater Discharge**

Wastewater generated from the production process and daily domestic sewage from employees will be collected for further processing. No sewage is untreated or illegally released to external waters. The related procedures are in compliance with the “Law of the People’s Republic of China on the Prevention and Control of Water Pollution”.

### **Solid Wastes Generation**

The main solid wastes produced during the production process are remaining materials and scrap materials of finished products produced by the Group. To minimize the amount of solid waste generated during the production process, the Group strictly abides by the principles of recycling and reuse, as well as the provisions of the “Law of the People’s Republic of China on the Prevention and Control of Environmental Pollution by Solid Waste”. The Group carries out hazard elimination treatment, classification and recycling on solid wastes pursuant to the “Solid Waste Management Operations Guide” of the Group, including (i) recycling and reuse of grinding powder, scrap; (ii) selling of cardboard boxes, paper products to other paper mills for recycling and reuse; and (iii) unified recycling of domestic wastes for hazard elimination treatment, etc.

### **Noise Control**

The source of noise is mainly from the noise generated by mechanical operations during the production process. The equipments with larger noise are all placed indoor, while noise reduction, sound insulation, shock absorption and other measures are adopted in order to comply with the relevant provisions of the “Emission Standard for Industrial Enterprises Noise at Boundary”.

### **廢水排放**

生產過程中產生的污水和來自員工的每日生活污水會被收集作進一步處理。概無污水未經處理或非法排放到外部水域。相關處理符合《中華人民共和國水污染防治法》。

### **產生固體廢物**

生產過程中，本集團產生的主要固體廢物為剩餘物料及制成品的邊角料。為盡量減少生產過程中產生的固體廢物，本集團嚴格遵守回收及再利用原則，以及《中華人民共和國固體廢物污染環境防治法》的規定。依據本集團的《固體廢棄物管理作業指導書》對固體廢物進行無害化處理和分類回收，包括(i)磨底粉、邊角料回收利用；(ii)紙箱、紙品賣到其他紙箱造紙廠回收利用；及(iii)生活垃圾統一回收後進行無害化處理等。

### **噪音監控**

噪音源主要為生產過程中機械運轉產生的噪音。對噪音比較大的設備均置於室內，並進行消聲、隔聲、減震等措施，以符合《工業企業廠界環境噪聲排放標準》中的相關規定。

The Group has implemented “Green Procurement” policy to actively encourage suppliers to establish production management system with environmental protection and energy saving, purchase environmentally friendly raw materials in higher priority through procurement mechanism and supply chain management, so as to facilitate suppliers to reduce waste of resources and pollution.

The Group also regularly inspects and reviews energy consumption, through internal policies and advanced technologies to prevent wastage so as to conserve energy and resources. Specific measures include: (i) reduction of natural gas consumption through the installation of boiler thermal oil recycling pipeline for heat recycling and reuse; (ii) reduction of hydraulic oil consumption by the use of hydraulic oil precipitation; and (iii) reduction of raw material input by recycling the grinding powder of grinding workshop and the scrap of cutting and clipping workshop. Other actively advocated routine resource conservation measures include: (i) replacing high energy-consumption equipment with the more energy-saving one; (ii) turning off unnecessary equipment, lighting and air conditioning not in use; (iii) strengthening inspection and maintenance of faucets, water pipes and water storage facilities and other water supply systems to avoid any leakage; and (iv) announcing company information in electronic form (such as e-mail or electronic bulletin) if possible and reducing paper use with double-sided printing.

To meet the energy-saving and emission reduction targets of the government, the Group reports and evaluates energy-saving new technologies and emission reduction, and develops energy performance indicators to strictly control energy consumption, improve and enhance energy management.

In addition, the Group encourages employees to submit energy-saving proposals actively, reduces power consumption, promotes continuous energy management training, etc. in order to enhance the knowledge on energy conservation and environmental protection policies and energy saving awareness among employees, so that the resources can be used more efficiently.

本集團實行「綠色採購」政策，積極鼓勵供應商建立環保節能的生產管理體系，通過採購機制及供應鏈管理，優先採購環保原材料，以促使供應商減少資源浪費、降低污染。

本集團亦定期查核及檢視能源耗用情況，透過內部政策及先進技術防止浪費以節約能源及資源，具體措施包括：(i)通過設置鍋爐導熱油循環利用管道進行熱量回收利用，可減少天然氣損耗；(ii)對液壓油進行沉澱再利用，減少液壓油耗用；及(iii)對磨底車間的磨底粉、切片沖裁車間的邊角料進行回收，減少原材料投入。其他積極提倡的日常節約資源措施包括：(i)以較節能設備替換耗能設備；(ii)關掉無須使用的設備、照明及空調；(iii)加強巡查及維修水龍頭、水管及蓄水設備等供水系統，避免出現任何滲漏；及(iv)盡量以電子形式（如電郵或電子公布）發布公司資訊、雙面打印等以期減少用紙。

為承接政府節能減排目標，本集團對節能新技術、節能減排進行申報評估，亦制定能源類績效考核目標，對能源耗用量實施嚴格控制，實現能源管理精進與提升。

除此以外，本集團鼓勵員工積極提交節能提案，降低能源耗用量，持續推行能源管理培訓等，以加強員工對節能環保政策的認知，提升節能意識，致使資源能更有效地使用。



### A3. The Environment and Natural Resources

The main environmental impact of the production business is the use of boiler and electricity in its manufacturing process. The operation of the boiler and the use of electricity generate both direct and indirect GHG emissions. To minimise the impact, the production and operation sites of the Group have been evaluated during the initial planning period in respect of the relevant industrial land environment and related regulations and the selected production sites are located in the areas permitted by the local government. During the production and operation process, collection and treatment facilities are installed for proper treatment of pollutants and emissions in order to ensure meeting the standard required by local regulations before discharge. The Group also assesses the feasibility of environmental protection facilities from time to time, adopts effective environmental protection measures and programs, including the prevention and control of pollution and exhaust gas emission, sustainable use of resources and ecological and environmental protection, more active support and promotion of social and environmental sustainable development.

## B. SOCIAL ASPECTS

### 1. Employment and Labour Practices

As a responsible employer, the Group is fully in compliance with the relevant national laws and regulations in respect of remuneration, compensation and dismissal, recruitment and promotion, working hours, holidays, equal opportunities, diversification, anti-discrimination and other employee benefits and welfare. The Group also regards employees as its most valuable asset and strives to provide the competitive salaries, welfare and working environment for them.

### A3. 環境及天然資源

生產業務對環境的主要影響為製造過程中使用鍋爐和電力。鍋爐的運行以及使用電力會以直接或間接的方式釋放溫室氣體。為了盡量減少這些影響，本集團的生產經營場地，在規劃前期即已針對相關工業用地環境與相關法規進行多方評估，所選擇生產基地均座落在當地政府允許區域內。在生產營運過程中，設置污染排放物的收集與處理設施，務求妥善處理至符合當地法規要求標準後方行排放。本集團亦不時評估環保設施可行性，採取有效環保措施及方案，包括廢氣排放、污染防治、可持續的資源運用方式及生態環境保護等，更積極地支持和推動社會及環境持續發展。

### B1. Employment

The Group adheres to fair, impartial and open employment principles, providing all employees equal opportunities and fair treatment. The Group strictly abides by the relevant provisions of the "Labour Law of the People's Republic of China" and the "The Labour Contract Law of the People's Republic of China". No arbitrary dismissal of an employee is allowed; the rights and obligations of both parties to the employment contract are clearly stated, the legitimate rights of employees are protected, in order to establish a harmonious and stable employment relationship.

#### *Employee Benefits*

The Group recruits personnel in line with its strategic requirements through various channels like campus interview, social recruitment, network recruitment in a fair and impartial way. The Group provides employees with comprehensive social security benefits, including basic salary, pensions, incentive bonuses, medical insurance, injury insurance, maternity insurance and housing provident fund. The Group will also provide other employee benefits depending on job nature, including meals, uniforms and fully equipped accommodation. The human resources department of the Group conducts regular reviews and updates on the relevant company policies from time to time pursuant to the latest laws and regulations. Employee performance appraisal, management position promotion, and other company policies are implemented to provide career development path to employees like internal promotions, on the job training. To attract high-quality talents and retain outstanding employees, the Group launches Share Option Scheme and timely conducts reviews on salary with reference to market standards, formulates competitive salary and bonus system, and provides competitive and fair remuneration and benefits based on personal performance, professional qualifications, and experience.

### B2. Health and Safety

The Group attaches great importance to the health and safety of employees and has obtained OHSAS 18001:2007 Occupational Health and Safety Management System certification, Work Safety Standardisation certification. The Group has set up an occupational health and safety management organisation and a safety production committee and strictly abides by the relevant standards of "Occupation Health and Safety Management System" and "Basic Standard for Work Safety Standardisation". The Group also adheres to the principles of safety production management and formulates the regulatory system of safety production management and operation rules for all positions. The safety and health of employees are effectively protected by the implementation of various job safety management systems and the clarification and definition of safe production responsibilities of all positions.

### B2. 健康與安全

本集團高度重視員工健康及安全，已經通過OHSAS 18001:2007職業健康安全管理体系認證、安全生產標準化認證。本集團已設立職業健康安全管理体系機構、安全生產委員會，並嚴格按照《職業健康安全管理体系》、《安全生產標準化基本規範》等相關標準執行，本集團堅持安全生產的管理原則，制訂安全生產管理規章制度和崗位操作規程，通過執行各項崗位安全管理制度與明晰定義各崗位安全生產職責，切實保障員工安全與健康。

### Occupational Health and Safety

To provide and maintain a safe and healthy working environment at all times, the Group regularly provides various kinds of work protective gears to employees in accordance with working requirements of each position and supervises and educates them to wear and utilize correctly; appoints responsible staff for the safe production of each department and implements various safety education; installs dust removal and waste discharging devices on facilities generating dust and exhaust gas; controls noise transmission of machinery exceeding the noise limit or provides protective gears to employees. Fire safety inspection, training, and drills are regularly organized to improve safety awareness and self-protection of employees.

The Group also strictly abides by the “Law of the People’s Republic of China on Work Safety”, “Rule for Storage of Chemical Dangers”, “Special Equipment Safety Law of the People’s Republic of China” and other relevant laws and regulations, to build a safe working environment.

### 職業健康及安全

為提供及時刻保持安全健康的工作環境，本集團根據各崗位的工作需要，定期向員工發放各種保護裝置用品，並監督及教育其正確佩戴和使用；指派部門安全生產責任人，落實各項安全教育；對產生粉塵和廢氣的設備安裝除塵排氣裝置；對噪音超標的設備加以控制其噪音傳播，或為員工提供防護用品。定期組織消防安全的檢查、培訓和演練，提高員工的安全防范意識及自我保護能力。

本集團亦嚴格遵守《中華人民共和國安全生產法》、《常用化學危險品貯存通則》、《中華人民共和國特種設備安全法》等其他相關法律法規，致力構建安全的工作環境。

### **Other Health and Safety Measures**

Since the outbreak of the COVID-19 epidemic in early 2020, the Group is highly conscious of the potential health and safety impacts that it may bring to its employees and customers. During the outbreak of the epidemic, the Group have established an Epidemic Prevention Working Group and formulated various safe management measures against COVID-19 epidemic, displayed notices in workplace area, provided employees with sufficient epidemic prevention supplies, and taught employees the correct personal protection means, so as to prevent the virus from spreading in the workplace. Also, regular disinfection was carried out to provide a virus free working environment to safeguard employee's health.

### **B3. Development and Training**

In respect of human resources training, the Group provides employees with induction and continuous training to promote their career development. For newly-recruited employees, the Group provides comprehensive orientation training of corporate culture, operation processes, work health and safety, management policies and business development. The Group also encourages employees to participate in on the job training and provides appropriate subsidies to eligible employees. Based on job nature, the Group offers trainings of different types and levels to newly recruited employees, junior supervisors, senior supervisors and key personnel, like management and production project training, aiming at constantly improving the overall quality of employees, so as to maintain sustainable business development in the future.

### **其他健康及安全措施**

自2020年初爆發COVID-19疫情以來，本集團極其重視對其僱員以及客戶帶來的潛在健康及安全影響。在疫情爆發期間，本集團針對COVID-19疫情成立防疫工作小組及制定各種安全管理措施，在工作場所範圍張貼通告、提供足夠的防疫用品予僱員，以及教導僱員正確的個人防護方法，避免病毒在工作場所擴散。同時，我們定時進行消毒以提供不受病毒入侵的工作環境，保障僱員的健康。

### B4. Labour Standards

#### *Prevention of Child Labour and Forced Labour*

To prevent illegal employment of child labour, underage and forced labour, the Group has established a well-developed mechanism. The employee manual stipulates that selected candidates must meet the legal age. Before confirming the employment, the human resources department of the Group will require applicants to provide valid identity documents to ensure that they are legally employed and fully in compliance with the latest relevant laws and regulations prohibiting child labour and forced labour. The Group also conducts regular inspection and review of the implementation of human resources policies to eliminate child labour and forced labour.

The Group strictly abides by the relevant provisions of the “Labour Law of the People’s Republic of China” and the “The Labour Contract Law of the People’s Republic of China”, and set reasonable working hours and leaves for employees pursuant to local employment ordinances and employment contracts with employees. The Group has installed a human resources computerized attendance system for effective management of staff working hours and vacation dates. If overtime work is required, employees may obtain appropriate overtime payment or compensatory leave under the relevant employment contract or labour legislation. To prevent forced overtime work, overtime must be agreed by employees voluntarily. During office hours, employees are allowed to move freely within the factory or office area (except prohibited special areas), and it is not mandatory for employees to live in the factory quarters.

### B4. 勞工準則

#### 防止童工及強迫勞動

為防止非法僱用童工、未成年員工及強迫勞動，本集團已訂立良好機制，《員工手冊》規定錄用員工需達到法定年齡。在確認僱用前，本集團的人力資源部會要求申請人提供有效的身份證明文件，確保申請人合法受僱並全面遵守最新相關法律法規以禁止童工和強迫勞動。本集團亦會定期檢查及檢討人力資源政策的執行情況，以杜絕使用童工和強迫勞動。

本集團嚴格遵守《中華人民共和國勞動法》及《中華人民共和國勞動合同法》相關法律規定，並按照本地僱傭法例及與僱員的僱傭合約，為僱員釐定合理的工時及休假。本集團已安裝人力資源電腦考勤系統，有效管理員工勞動時間及休假日期。若因工作需要加班，員工可根據有關僱傭合約或勞工法例條文獲得適當的加班費或補假，加班工作亦必須由員工同意自願參加，以防止強迫加班之事情發生。上班時間內，除特殊區域須進行管制外，員工可在廠區或辦公室範圍內自由行動，也不強制要求員工須住在工廠宿舍內。

### 2. Operating Practices

#### B5. Supply Chain Management

The Group attaches great importance to sustainable and reliable supply chain to ensure sustainable enterprise development. The Group has formulated and implemented supplier management system. Regarding supplier selection, the Group conducts qualification inspection, factory visit and other assessment processes on potential suppliers with the principles of fairness, impartiality, openness and honesty. Inspection areas include the production capacity, product quality, service quality, environmental protection, occupational health and safety of the supplier.

In order to avoid issues such as varied quality of products and non-standardisation of materials, the goods and materials provided by suppliers are detected by the internal department of the Group or third-party testing organisations, so as to select qualified suppliers. Besides, the relevant departments conduct annual re-evaluation and assessment on the qualified suppliers for the supervision of product quality. At the same time, the Group closely monitors procurement process to ensure that the procured products meet the requirements of production technology and product quality.

As at 31 December 2020, the Group has a total of 296 suppliers (2019: 357 suppliers). Among them, 287 suppliers (2019: 345 suppliers) are from the PRC (excluding Hong Kong, Macau and Taiwan), and the remaining 9 (2019: 12) are from overseas.

The Group does not include environmental and social factors as assessment criteria of our suppliers. Nevertheless, we will review and terminate the business relationship with the suppliers should there be press and media coverage on the negative environmental and social impacts caused by them, such as excessive pollutions and discharges to the environment, unfair treatment, exploitation of workers and product safety incidents.

### 2. 營運慣例

#### B5. 供應鏈管理

為確保企業可持續發展，本集團非常重視可持續及可靠的供應鏈，本集團制定及實施供應商管理制度，在供應商篩選方面，以公平、公正、公開、誠實的原則對潛在供應商進行資質審查及訪廠等評估流程，調查內容包括供應商的生產能力、產品質量、服務質量、環保、職業健康與安全等方面。

為了避免產品質量參差不齊、用料標準不統一等問題，由本集團內部或第三方檢測機構對供應商提供的貨物和材料進行檢測，進而選出合格供應商。另外，相關部門對合格供應商進行每年復檢評價，對產品質量進行監督。同時本集團對採購過程進行嚴謹監控，確保採購的產品符合生產技術和產品質量的要求。

於二零二零年十二月三十一日，本集團共有296名供應商（二零一九年：357名供應商），當中287名供應商（二零一九年：345名供應商）來自中國（香港、澳門及台灣除外），其餘9名（二零一九年：12名）則來自海外。

本集團不會將環境及社會因素計入評估我們供應商的準則。然而，倘有報章及媒體對彼等對環境和社會造成的負面影響作出報導，如過度污染及排放、不公平待遇、對工人剝削及產品安全事故，我們將審查並終止與該等供應商的業務關係。



### B6. Product Responsibility

#### *Quality Management*

The Group attaches great importance to product quality and safety, strictly abides by the “Product Quality Law of the People’s Republic of China” and “Law of the People’s Republic of China on the Protection of Consumer Rights and Interests”, formulates and implements quality policies to ensure product quality. The Group has obtained ISO9001 quality management system certification in 2003. During the process of mass production, quality control personnel performs sampling tests on raw materials, semi-finished goods and finished goods for tracking and identification of any potentially inferior products and preventing problematic material misuse in production. All finished products must be specifically checked before packaging to ensure they are qualified.

For the year ended 31 December 2020, the Group did not receive any complaints from regulatory authorities or consumers regarding product safety and did not recover any products due to product safety and health reasons. The Group is not aware of any material non-compliance with relevant laws and regulations on health and safety, advertising, labelling and privacy matters related to products sold during the year.

### B6. 產品責任

#### *質量管理*

本集團十分注重產品質量和安全，嚴格遵守《中華人民共和國產品質量法》及《中華人民共和國消費者權益保護法》，制定並實施質量政策，以保證產品質量。本集團於2003年已通過ISO9001質量管理體系認證。在產品量產過程中，全程由質量監控人員對原材料、半成品和製成品執行抽樣測試，追蹤及偵測任何潛在不良產品及防止有問題的材料被誤用於生產。所有成品包裝前皆須經過專人的檢查，以確認產品合格。

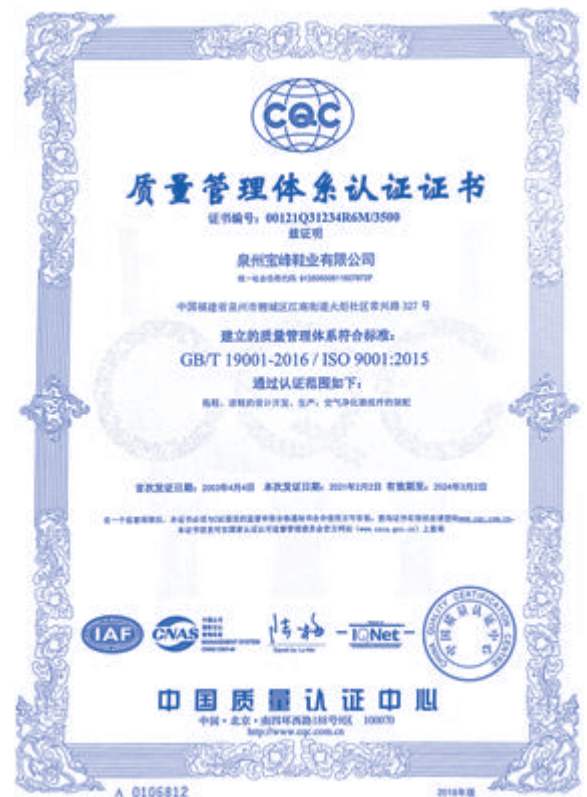

### Data Privacy and Intellectual Property Protection

The Group maintains close and good business relationships with product distributors, highly protects the privacy and business secrets of distributors and strives to ensure timely response to the feedback of customers and instant response to product inquiries. Unless prior approval is obtained, employees shall not disclose any price-sensitive information relating to the customers, product distributors, intangible assets, business secrets of the Group which may come to their knowledge during their employment or after termination of their employment.

The promotion activities of the Group's products are carried out by advertising agencies in accordance with the Group's policy of privacy, its business strategy, and the "Contract Law of the People's Republic of China", the "Anti-Unfair Competition Law of the People's Republic of China" and the "Criminal Law of the People's Republic of China".

### 資料私隱及知識產權保護

本集團與產品經銷商保持密切及良好的業務合作關係，高度保障經銷商的隱私與商業機密，並盡力確保及時地回應客戶的反饋及即時回覆產品的查詢。除非提前獲得批准，否則僱員不得披露於僱傭期間或終止僱傭後可了解到的任何有關本集團的客戶、經銷商、無形資產、商業機密的股價敏感性資料。

The Group strictly abides by the “Trademark Law of the People’s Republic of China”, “Patent Law of the People’s Republic of China”, and other relevant laws and regulations relating to intellectual property protection. Apart from manufacturing customers’ products, the Group has also established its own brands. The Group has implemented internal policies to eliminate the risk of infringing customers’ and third parties’ intellectual property in its design, research, development and manufacturing processes as well as protecting its own rights. The Group’s design and development team shall ensure their designs are not identical and do not bear a close resemblance to the products of any other customers or those in the public market. In addition, measures have been adopted to facilitate the management and protection of intellectual property, for example, using password-protected computers to store products’ information, encrypting files in the transmission process and prohibiting employees from taking out product prototypes and samples without permission.

### B7. Anti-corruption

The Group adheres to the core value of integrity and strictly abides by the provisions of the “Company Law of the People’s Republic of China”, the “Anti-Money Laundering Law of the People’s Republic of China” and the “Interim Provisions on Banning of Commercial Bribery” and other relevant laws and regulations. The Group has formulated “Baofeng Personnel Management Regulations” and other related systems to standardise various business activities. An internal monitoring system is set up for strengthening anti-fraud, anti-extortion, anti-corruption, anti-money laundering and bribery supervision, while a whistle-blowing mechanism and a reward and punishment committee are also set up to strengthen management and promote compliance, so as to prevent and eliminate fraud, extortion, bribery and corruptions on various aspects of operation and management. The Group prohibits any acts of fraud, extortion, corruption and bribery, prohibits employees from taking advantages of their powers and duties

for corruption, embezzlement, encroachment of corporate property, acceptance of bribes and kickbacks, etc. Through various measures like training and promotion, the Group strengthens the communication with employees in respect of internal control and anti-fraud, anti-extortion, anti-corruption, anti-commercial bribery, so as to enhance their awareness in this regard.

The Group has formulated supplier relationship guidelines and government authority relationship guidelines. Standard professional code of ethics and conduct is formulated for the communication with business partners, suppliers, customers, etc. and employees are required to follow strictly.

When there is any alleged case in violation of laws, regulations or Group's policies, the Group will investigate and impose disciplinary actions upon offenders after verification.

During the year, the Group did not notice any non-compliance of the applicable laws and regulations relating to anti-corruption and did not face any disciplinary action with respect to corruption issues.

### 3. Community

#### B8. Community Investment

The Group strives to implement corporate social responsibility and actively participates in public welfare activities. No formal policy on community investment has been established. Nevertheless, the Group contributed to the charity and public welfare undertakings through organising blood donation, and continuously encourages its employees to participate in charitable events during the year.

Mr. Leung holds a degree of bachelor of arts in Business Studies from the Hong Kong Polytechnic University and a degree of master in Business Administration from the University of New South Wales. He has 30 years of extensive experience in business administration in domestic and overseas markets. Mr. Leung joined 2D Material Technology Company Limited, a wholly owned subsidiary of the Company, as the chief executive officer in November 2014.

#### Mr. Zheng Jingdong

Mr. Zheng Jingdong, aged 55, is an executive Director of the Company. Before the re-designation on 26 February 2021, Mr. Zheng had been appointed as a Director since 21 July 2008, and had been appointed as the Chairman of the Board, the Chief Executive Officer of the Group, an executive Director and the authorised representative under the Listing Rules since 10 May 2013. Mr. Zheng has more than 20 years of experience in the slipper business in the PRC. He has been appointed as a director of Quanzhou Baofeng since 28 March 2007 and as a director of BAOF International Limited since 21 July 2008.

Dr. Xu Zhi, aged 54, has been appointed as the executive Director of the Board and Chief Technology Officer of the Group with effect from 26 February 2021. He is an expert in the areas of semiconductor equipment and processing, and solar technology. Dr. Xu obtained a Doctor of Philosophy in Materials Science and Engineering from The Leland Stanford Junior University in June 1998. Prior to joining the Group, Dr. Xu had worked in Applied Materials, Inc. for more than a decade with his last positions as senior manager and senior member of technical staff and participated in the research and development of plasma-enhanced chemical vapor deposition and low pressure chemical vapor deposition system. He subsequently worked for the position of senior manager and senior member of technical staff at the branch office of Applied Materials, Inc. in China. He then became a distinguished professor and doctoral tutor in Hunan University and was elected as a State Specially Recruited Expert and engaged in the relevant research on graphene and nanomaterial and developed a series of graphene related products. Dr. Xu joined the Group as a technical consultant in December 2015 and has been the technical director of Xinfeng 2D (Fujian) Material Technology Company Limited (福建新峰二維材料科技有限公司), an indirect wholly-owned subsidiary of the Company, since September 2017. He is responsible for leading the research and development team of the Group in the research and development of material technology and applications.

### Opinion

We have audited the consolidated financial statements of Baofeng Modern International Holdings Company Limited (the "Company") and its subsidiaries (together the "Group") set out on pages 88 to 212, which comprise the consolidated statement of financial position as at 31 December 2020, the consolidated statement of profit or loss and other comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including a summary of significant accounting policies.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 December 2020 and of its consolidated financial performance and consolidated cash flows for the year then ended in accordance with International Financial Reporting Standards ("IFRSs") issued by the International Accounting Standards Board (the "IASB") and the consolidated financial statements have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

### Basis for opinion

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

### Material uncertainty in relation to going concern

We draw attention to note 3 to the consolidated financial statements which indicates that the Group incurred a net loss of approximately RMB108,756,000 for the year ended 31 December 2020 and, as of that date, the Group's current liabilities exceeded its current assets by approximately RMB132,103,000 and total liabilities exceeds its total assets by approximately RMB44,889,000. These conditions indicate that a material uncertainty exists that may cast significant doubt on the Group's ability to continue as a going concern. As explained in "Going Concern" section of note 3 to the consolidated financial statements. The Group carried out certain alternatives to improve financial position. As a result, our opinion is not modified in respect of this matter.

### Key Audit Matters

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

### Impairment assessment of trade receivables

At 31 December 2020, the net carrying amount of the Group's trade receivables amounted to approximately RMB44,454,000, net of allowance for credit losses of approximately RMB1,179,000, which was material to the Group's consolidated financial statements. The allowance was assessed based on the expected credit loss model. The assessment of expected credit losses of trade receivables involved significant management judgement and estimation including their assessment of customers' current financial position and forward-looking information.

In determining the allowance for trade receivables, the management considers the credit history including default or delay in payments, settlement records, subsequent settlements and aging analysis of the trade receivables.

Details of the trade receivables are set out in note 20 to the consolidated financial statements.

### 有關持續經營的重大不確定性

我們提請注意綜合財務報表附註3，當中顯示，截至二零二零年十二月三十一日止年度，貴集團產生虧損淨額約人民幣108,756,000元，且截至該日，貴集團的流動負債超過其流動資產約人民幣132,103,000元及總負債超過其總資產約人民幣44,889,000元。該等狀況表明存在重大不確定性，或會對貴集團持續經營之能力產生重大疑問。如綜合財務報表附註3「持續經營」一節所解釋，貴集團已採取若干措施以改善財務狀況。因此，我們並未就該事宜發表保留意見。

### 關鍵審計事項

關鍵審計事項是根據我們的專業判斷，認為對本期綜合財務報表的審計最為重要的事項。該等事項是在我們審計整體綜合財務報表及出具意見時進行處理的。我們不會對該等事項提供單獨意見。

### 應收貿易賬款減值評估

於二零二零年十二月三十一日，本集團應收貿易賬款的賬面淨值約人民幣44,454,000元，扣除信貸虧損撥備約人民幣1,179,000元，對本集團綜合財務報表屬重大。撥備按預期信貸虧損模式評估。應收貿易賬款之預期信貸虧損評估涉及重大管理層判斷及估計，包括其對客戶當前財務狀況及前瞻性資料之評估。

於釐定應收貿易賬款撥備時，管理層會考慮信貸歷史，包括拖欠或延遲付款、結算記錄、後續結算及應收貿易賬款的賬齡分析。

應收貿易賬款的詳情載於綜合財務報表附註20。

Our audit procedures in relation to impairment assessment of trade receivables included:

- obtaining an understanding of the Group's procedures on setting of credit limits and credit periods given to customers with the management;

- checking the accuracy of preparation of the aging analysis of trade receivables by customers by tracing the data back to the source documents;
- checking on a sampling basis, the debtors' historical payment pattern and the bank receipts for the payments received subsequent to the reporting period;
- checking on a sampling basis, the evidence including correspondence with the debtors for the latest progress of the outstanding amounts; and
- assessing the expected credit loss provisioning methodology, examining the key data inputs on a sampling basis and reviewing the key assumptions used to determine the expected credit losses, including both historical and forward-looking information.

We found that the estimation and judgement made by management in respect of the recoverability of trade receivables were supportable by credible evidence.

### Impairment assessment of intangible assets

As set out in note 18 to the consolidated financial statements at 31 December 2020, the Group had intangible assets amounting to approximately RMB154,000 comprising (i) technology know-how of approximately RMB0; (ii) O2O distribution vending system of approximately RMB0 and (iii) capitalisation of deferred development costs and patents in relation to the research and development of manufacturing and application technology of graphene material on sterilizing chips, energy storage materials for batteries and pressure sensitive lighting devices for shoes of approximately RMB154,000. During the year, impairment loss on intangible assets of approximately RMB64,842,000 was recognised in profit or loss.

Management is required to carry out an impairment assessment on these intangible assets at least annually. Independent external valuations were obtained in order to support management estimates. These assessments of the recoverable amounts involved significant management's assessment and judgement on the key assumptions used in cash flow projections and profit forecasts based on financial budgets approved by management, which is judgemental and based on a number of assumptions.

### How our audit addressed the Key Audit Matters

Our procedures in relation to impairment assessment of intangible assets included:

- evaluating the independent external valuers' competence, capabilities and objectivity;
- assessing the valuation methodologies adopted by management which are disclosed in note 18 to the consolidated financial statements;
- evaluating the reasonableness of key assumptions used in the valuations based on our knowledge of the business and industry including profit forecasts, cash flow projections, discount rates, budgeted sales and gross margin through assessing the cash generating unit's past performance, management's expectation of the market development and future 5 years' financial budget approved by the management;
- evaluating the potential impact of value-in-use based on the reasonably possible change of the key assumptions;
- discussing with the management and the independent valuers engaged by the management to understand the assumptions they used in building up the cash flow projections;

如二零二零年十二月三十一日之綜合財務報表附註18所載，貴集團擁有無形資產約人民幣154,000元，包括(i)技術知識約人民幣零元；(ii)O2O分銷售貨系統約人民幣零元及(iii)資本化研發石墨烯材料於殺菌芯片、電池儲能材料及鞋履壓敏照明裝置的生產及應用技術相關的遞延開發成本及專利約人民幣154,000元。年內，無形資產減值虧損約人民幣64,842,000元於損益內確認。

管理層每年須至少對該等無形資產進行一次減值評估。管理層已獲得獨立外部估值，以支持其估計。該等可收回款項之評估涉及管理層對根據管理層批准之財務預算作出之現金流量預測及溢利預測(其中涉及作出判斷及基於多項假設)所用之主要假設作出重大評估及判斷。

Based on our procedures described, we found the impairment assessment on intangible assets to be reasonable.

### Valuation of investment properties

As set out in note 16 to the consolidated financial statements at 31 December 2020, the Group had investment properties held by a subsidiary of approximately RMB\$60,029,000 and for which a gain arising on change in fair value of approximately RMB\$14,073,000 was recognised and presented as "Fair value gain on investment properties" in the consolidated statement of profit or loss and other comprehensive income. The fair value was determined by management with reference to the valuations performed by independent professional property valuer (the "Valuer") engaged by the Group.

The valuation of investment properties was considered as a key audit matter due to the significance of the balance to the consolidated financial statements as a whole, combined with the significant judgements involved in determining the inputs used in the valuation.

### How our audit addressed the Key Audit Matters

Our procedures in relation to the valuation of investment properties included:

- evaluating the competence, capabilities, independence and objectivity of the Valuers;

### 1. CORPORATE INFORMATION

Baofeng Modern International Holdings Company Limited (the “Company”) is a limited liability company incorporated in the Cayman Islands. The registered office address and principal place of business of the Company are disclosed in the “Corporate Information” section of the annual report. The shares of the Company were listed on the Main Board of the Stock Exchange of Hong Kong Limited (the “Stock Exchange”) on 28 January 2011 (the “Listing Date”).

The principal activity of the Company is investment holding. Details of the principal activities of its subsidiaries are set out in note 45 to the consolidated financial statements. There were no significant changes in the nature of principal activities of the Company and its subsidiaries (collectively, the “Group”) during the year.

The consolidated financial statements are presented in Renminbi (“RMB”), which is the same as the functional currency of the Company.

In the opinion of the directors of the Company, the immediate holding company and the ultimate holding company of the Company is Best Mark International Limited (“Best Mark”), which was incorporated in the British Virgin Islands (“BVI”). Its ultimate controlling party is Mr. Sze Ching Bor.

### 1. 公司資料

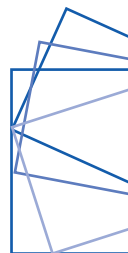

### 3. SIGNIFICANT ACCOUNTING POLICIES

#### Statement of compliance

The consolidated financial statements have been prepared in accordance with all the applicable individual IFRSs which includes all applicable individual IFRSs, IASs and Interpretations issued by the IASB. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities (“Listing Rules”) on the Stock Exchange and the Hong Kong Companies Ordinance.

#### Basis of preparation

The consolidated financial statements have been prepared on the historical cost basis except for investment properties and provision for contingent consideration which are measured at fair value at the end of each reporting period, as explained in the accounting policy set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction in the market at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of IFRS 2, leasing transactions that are accounted with IFRS 16, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in IAS 2 or value in use in IAS 36.

A fair value measurement of a non-financial asset takes into account a market participant’s ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

### 3. 主要會計政策

For investment properties which are transacted at fair value and a valuation technique that unobservable inputs is to be used to measure fair value in subsequent periods, the valuation technique is calibrated so that at initial recognition the results of the valuation technique equals the transaction price.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;

Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and

Level 3 inputs are unobservable inputs for the asset or liability.

#### Going concern

As at 31 December 2020, the Group's current liabilities exceeded its current assets by approximately RMB132,103,000 and its total liabilities exceeded total assets by approximately RMB44,889,000. The Group incurred a loss for the year of approximately RMB108,756,000 for the year ended 31 December 2020. These conditions indicate the existence of a material uncertainty which may cast significant doubt on the Group's ability to continue as a going concern and therefore, the Group may not be able to realise its assets and discharge its liabilities in the normal course of business.

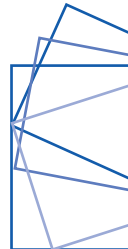
#### 持續經營

於二零二零年十二月三十一日，本集團的流動負債超出其流動資產約人民幣132,103,000元及其總負債超出總資產約人民幣44,889,000元。截至二零二零年十二月三十一日止年度，本集團產生了約人民幣108,756,000元的年內虧損。這些狀況表明存在重大不確定性，可能對本集團持續經營的能力產生重大疑問，因此，本集團可能無法於日常業務中變現其資產及清償其負債。

In view of such circumstances, the directors of the Company have given careful consideration to future liquidity and performance of the Group and its available sources of financing in assessing whether the Group will be able to finance its future working capital and finance requirements. Certain measures have been taken to manage its liquidity needs and to improve its financial position which include, but are not limited to, the following:

1. The secured bank loans amounting to RMB97,500,000 are annual by renewable revolving loan. The secured bank loans are granted to a People's Republic of China ("PRC") subsidiary for its working capital requirements. The renewable revolving loans are secured by a pledge of the Group's buildings with carrying amount of approximately RMB3,575,000, leasehold land of right-of-use assets and the land of investment properties with carrying amounts of approximately RMB4,194,000 and approximately RMB31,189,000 respectively. Based on the latest estimation of the banks, the estimated marketable value of these securities amounted to approximately RMB107,870,000. The bank loans are also secured by the corporate guarantee of independent third party for RMB75,100,000 and personal guarantee of a director of the Company for RMB133,600,000 and properties owned by a son of a director of the Company for RMB1,370,000 respectively. The PRC subsidiary is a profitable operation and has net operating cash inflow, and there is no serious deterioration in the performance of the subsidiary. In the opinion of the directors of the Company and based on past experience with the banks, the Group will be able to roll over or refinance the bank borrowings upon maturity;
2. The Group has obtained a credit facility amounting to RMB40,000,000 in total from an independent third party, in which part of the facility amounting to RMB5,000,000 would expire on 30 July 2021 and the remaining facility amounting to RMB35,000,000 would expire on 31 December 2021. The credit facility utilised amounted to RMB32,640,000 as at 31 December 2020. The unutilised facility would be utilised as the working capital and for financing the ongoing business of the Group;

鑒於該等情況，在評估本集團是否有能力滿足未來營運資金及財務需要時，本公司董事已審慎考慮本集團的未來流動資金及表現以及其可用融資來源。已採取若干措施管理其流動資金需要及改善其財務狀況，包括但不限於以下各項：

1. 有抵押銀行貸款人民幣97,500,000元屬年度可續期循環貸款。有抵押銀行貸款授予一家中華人民共和國(「中國」)附屬公司以滿足其營運資金需求。可續期循環貸款由質押本集團賬面值約人民幣3,575,000元的樓宇、賬面值分別約人民幣4,194,000元及約人民幣31,189,000元的使用權資產中的租賃土地及投資物業中的土地作抵押。根據銀行的最新估計，該等抵押品的估計市值約人民幣107,870,000元。銀行貸款亦分別由獨立第三方的公司擔保人民幣75,100,000元、一位本公司董事個人擔保人民幣133,600,000元以及一位本公司董事的兒子擁有的物業人民幣1,370,000元作抵押。中國附屬公司有盈利的業務且擁有淨經營現金流入，而該附屬公司的表現並無嚴重惡化。本公司董事認為，根據與銀行的過往經驗，本集團可於到期時將銀行借款延長或再融資；

3. The Group has obtained a loan facility from that independent third party in amount of RMB20,000,000, yet undrawn with a maturity date on 25 March 2022 secured by the Group's property. The facility would be utilised as the working capital and for financing the ongoing business of the Group;
4. The Group will implement operational plans to control costs and generate adequate cash flows from the Group's operations; and
5. As disclosed in the Company's announcement dated 24 March 2021, the Company entered into a share subscription agreement ("2021 Subscription Agreement") with an independent third party, in relation to the subscription for 20,000,000 new ordinary shares of the Company ("Shares") at HK\$4 per share (the "2021 Subscription") and a placing agreement ("Placing Agreement") with a placing agent on 24 March 2021, pursuant to which the Company has agreed to place through the placing agent, on a best effort basis, up to 100,000,000 new Shares at HK\$4 per share (the "Placing").

The directors of the Company have reviewed the Group's cash flow projections prepared by management. The cash flow projections cover a period of not less than fifteen months from the date of the annual report. The directors of the Company are of the opinion that, taking into account the foregoing, the Group would have sufficient working capital to finance its operations and to meet its financial obligations as and when they fall due within the next fifteen months from the date of the annual report. Accordingly, the directors of the Company are of the opinion that it is appropriate to prepare the consolidated financial statements for the year ended 31 December 2020 on a going concern basis.

Should the Group and the Company be unable to continue to operate as a going concern, adjustments would have to be made to write down the value of assets to their recoverable amounts, to provide for further liabilities which might arise and to reclassify non-current assets and non-current liabilities as current assets and current liabilities respectively. The effect of these adjustments has not been reflected in the consolidated financial statements.

#### **Basis of consolidation**

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

#### Investments in subsidiaries

Investments in subsidiaries are stated on the statement of financial position of the Company at cost less any identified impairment loss. The results of the subsidiaries are accounted for by the Company as the basis of dividend received and receivable.

#### Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-makers (“CODM”). The CODM, who are responsible for allocating resources and assessing performance of the operating segments, have been identified as the executive directors that make strategic decisions.

#### Revenue from contracts with customers

The Group recognises revenue when (or as) a performance obligation is satisfied, i.e. when “control” of the goods or services underlying the particular performance obligation is transferred to the customer.

A performance obligation represents a good or service (or a bundle of goods or services) that is distinct or a series of distinct goods or services that are substantially the same.

Control is transferred over time and revenue is recognised over time by reference to the progress towards complete satisfaction of the relevant performance obligation if one of the following criteria is met:

- the customer simultaneously receives and consumes the benefits provided by the Group’s performance as the Group performs;
- the Group’s performance creates or enhances an asset that the customer controls as the Group performs; or
- the Group’s performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

Otherwise, revenue is recognised at a point in time when the customer obtains control of the distinct good or service.

A contract asset represents the Group's right to consideration in exchange for goods or services that the Group has transferred to a customer that is not yet unconditional. It is assessed for impairment in accordance with IFRS 9. In contrast, a receivable represents the Group's unconditional right to consideration, i.e. only the passage of time is required before payment of that consideration is due.

A contract liability represents the Group's obligation to transfer goods or services to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer.

A contract asset and a contract liability relating to a contract are accounted for and presented on a net basis.

#### Leases

##### Definition of a lease

A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

For contracts entered into or modified or arising from business combinations on or after the date of initial application, the Group assesses whether a contract is or contains a lease based on the definition under IFRS 16 at inception, modification date or acquisition date, as appropriate. Such contract will not be reassessed unless the terms and conditions of the contract are subsequently changed.

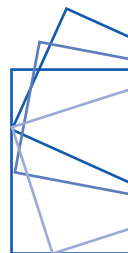

*Allocation of consideration to components of a contract*

For a contract that contains a lease component and one or more additional lease or non-lease components, the Group allocates the consideration in the contract to each lease component on the basis of the relative stand-alone price of the lease component and the aggregate stand-alone price of the non-lease components.

#### *Short-term leases and leases of low-value assets*

The Group applies the short-term lease recognition exemption to leases of office equipment or properties that have a lease term of 12 months or less from the commencement date and do not contain a purchase option. It also applies the recognition exemption for lease of low-value assets. Lease payments on short-term leases and leases of low-value assets are recognised as expense on a straight-line basis or another systematic basis over the lease term.

#### *Right-of-use assets*

The cost of right-of-use asset includes:

- the amount of the initial measurement of the lease liability;
- any lease payments made at or before the commencement date, less any lease incentives received;
- any initial direct costs incurred by the Group; and

Except for those that are classified as investment properties and measured under fair value model, right-of-use assets are measured at cost, less any accumulated depreciation and impairment losses, and adjusted for any remeasurement of lease liabilities other than adjustments to lease liabilities resulting from Covid-19-related rent concessions in which the Group applied the practical expedient.

Right-of-use assets in which the Group is reasonably certain to obtain ownership of the underlying leased assets at the end of the lease term are depreciated from commencement date to the end of the useful life. 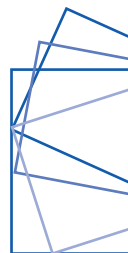

*Refundable rental deposits*

Refundable rental deposits paid are accounted for under IFRS 9 Financial Instruments and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments and included in the cost of right-of-use assets.

*Lease liabilities*

At the commencement date of a lease, the Group recognises and measures the lease liability at the present value of lease payments that are unpaid at that date. In calculating the present value of lease payments, the Group uses the incremental borrowing rate at the lease commencement date if the interest rate implicit in the lease is not readily determinable.

The lease payments include:

- fixed payments (including in-substance fixed payments) less any lease incentives receivable;

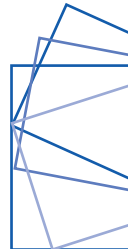

#### **Covid-19-related rent concessions**

Whenever the terms of the lease transfer substantially all the risks and rewards incidental to ownership of an underlying asset to the lessee, the contract is classified as a finance lease. All other leases are classified as operating leases.

Amounts due from lessees under finance leases are recognised as receivables at commencement date at amounts equal to net investments in the leases, measured using the interest rate implicit in the respective leases. Initial direct costs (other than those incurred by manufacturer or dealer lessors) are included in the initial measurement of the net investments in the leases. Interest income is allocated to accounting periods so as to reflect a constant periodic rate of return on the Group's net investment outstanding in respect of the leases.

Rental income from operating leases is recognised in profit or loss on a straight-line basis over the term of the relevant lease. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset, and such costs are recognised as an expense on a straight-line basis over the lease term except for investment properties measured under fair value model. Variable lease payments for operating leases that depend on an index or a rate are estimated and included in the total lease payments to be recognised on a straight-line basis over the lease term. Variable lease payments that do not depend on an index or a rate are recognised as income when they arise.

##### *Allocation of consideration to components of a contract*

When a contract includes both leases and non-lease components, the Group applies IFRS 15 to allocate consideration in a contract to lease and non-lease components. Non-lease components are separated from lease component on the basis of their relative stand-alone selling prices.

#### **本集團作為出租人**

##### *租賃之分類及計量*

本集團為出租人之租賃乃分類為融資或經營租賃。當租賃條款將相關資產擁有權附帶的絕大部分風險及回報轉移至承租人時，該合約乃分類為融資租賃。所有其他租賃乃分類為經營租賃。

根據融資租賃應收承租人的款項於開始日期確認為應收款項，其金額等於租賃淨投資，並使用各個租賃中隱含的利率計量。初始直接成本(製造商或銷售商出租人所產生的費用除外)計入租賃淨投資的初始計量中。利息收入於各會計期間內分配，以反映本集團有關租賃的未償還淨投資的固定定期收益率。

經營租賃的租金收入在相關租賃期限內按照直線基準於損益內確認。磋商及安排經營租賃時產生的初始直接成本計入租賃資產的賬面值，有關成本於租賃期內按直線基準確認為開支，惟投資物業按公平值模式計量。視乎指數或比率而定的經營租賃可變租賃付款已作估算，並計入於租賃期內將以直線法確認的租賃付款總額中。並非視乎指數或比率而定的可變租賃付款於產生時確認為收入。

##### *分配代價至合約之組成部分*

倘合約包括租賃及非租賃組成部分，本集團應用國際財務報告準則第15號，將合約代價分攤至租賃及非租賃組成部分。非租賃組成部分根據其相對獨立售價與租賃組成部分分開。

**The Group as a lessor** (continued)

*Refundable rental deposits*

Refundable rental deposits received are accounted for under IFRS 9 and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments from lessees.

**Sublease**

When the Group is an intermediate lessor, it accounts for the head lease and the sublease as two separate contracts. The sublease is classified as a finance or operating lease by reference to the right-of-use asset arising from the head lease, not with reference to the underlying asset.

*Lease modification*

The Group accounts for a modification to an operating lease as a new lease from the effective date of the modification, considering any prepaid or accrued lease payments relating to the original lease as part of the lease payments for the new lease.

**Borrowing costs**

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets until such time as the assets are substantially ready for their intended use or sale.

All borrowing costs are recognised in profit or loss in the period in which they are incurred.

**本集團作為出租人(續)**

*可退回租賃按金*

已收取可退回租賃按金根據香港財務報告準則第9號入賬，並初步按公平值計量。於初始確認時對公平值作出的調整被視為來自承租人的額外租賃付款。

**分租**

當本集團為中間出租人時，其就原租約及分租入賬為兩份獨立合約。分租乃參考原租約的使用權資產分類為融資或經營租賃，而非參考相關資產。

*租賃修訂*

由修訂生效日期起，本集團將經營租賃修訂列作為新租賃入賬，當中將與原有租賃相關的任何預付或應計租賃付款，視作新租賃的部分租賃付款。

**借貸成本**

用作收購、建設或生產(即需要一段長時間方可達致其擬定用途或銷售的資產)直接相關的借貸成本計入該等資產的成本內，直至該等資產基本上達致其擬定用途或銷售為止。

所有其他借貸成本於產生期間於損益內確認。

#### Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchanges prevailing at the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing on the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences on monetary items, are recognised in profit or loss in the period in which they arise.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. RMB) using exchange rates prevailing at the end of each reporting period. Income and expenses items are translated at the average exchange rates for the year, unless exchange rates fluctuate significantly during the year, in which case, the exchange rate prevailing at the dates of the transaction are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of exchange fluctuation reserve.

#### Retirement benefit costs

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance for all of its employees in Hong Kong. Contributions are made based on a percentage of the employees' basic salaries and are recognised as an expense as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

#### 外幣

於編製個別集團實體的財務報表時，以該實體功能貨幣以外貨幣(外幣)結算的交易按交易當日的適用匯率確認。於呈報期末，以外幣計值的貨幣項目會按該日的匯率重新換算。按公平值以外幣列賬的非貨幣項目乃按公平值釐定當日的適用匯率重新換算。按外幣歷史成本計量的非貨幣項目毋須重新換算。

貨幣項目的匯兌差額於產生期間於損益內確認。

就呈列綜合財務報表而言，本集團海外業務的資產及負債乃採用於各呈報期末的適用匯率換算為本集團的呈列貨幣(即人民幣)，除非年內匯率出現大幅波動，在該情況下，則須按於該等日期之現行匯率換算。收入及開支項目則按年內平均匯率換算。所產生的匯兌差額(如有)於其他全面收入內確認並於權益中的匯兌波動儲備項下累計。

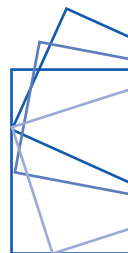
#### 退休福利成本

本集團根據強制性公積金計劃條例，為其香港所有僱員設有定額供款強制性公積金退休福利計劃(「強積金計劃」)。供款乃根據僱員底薪的一定百分比作出，並根據強積金計劃規則於供款到期應付時確認為開支。強積金計劃資產與本集團資產分開，乃透過獨立管理基金持有。本集團的僱主供款於向強積金計劃作出供款時全數歸屬僱員所有。

#### Retirement benefit costs (continued)

The employees of the Group's subsidiary which operates in PRC are required to participate in central pension scheme operated by the local municipal government. The subsidiary is required to contribute a certain percentage of its payroll costs to the central pension scheme. The contributions are charged to the profit or loss as they become payable in accordance with the rules of the central pension scheme.

The Group contributes on a monthly basis to defined contribution housing, medical and other benefit plans organised by the PRC government. The PRC government undertakes to assume the benefit obligations of all existing and retired employees under these plans. Contributions to these plans by the Group are expensed as incurred. The Group has no further obligations for benefits for their qualified employees under these plans.

#### Government grants

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received.

Government grants that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable.

#### Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax. The tax currently payable is based on taxable profit for the year. Taxable profit differs from "loss before tax" as reported in the consolidated statement of profit or loss and other comprehensive income because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

#### 退休福利成本(續)

本集團於中國經營的附屬公司的僱員需要參與由地區市政府運作的中央退休金計劃。附屬公司須就中央退休金計劃於薪酬成本中作若干百分比的供款。根據中央退休金計劃的規則，供款因已成為應付款項而計入損益。

本集團每月向中國政府設立的定額供款住房、醫療及其他福利計劃供款。中國政府保證承擔該等計劃保障的所有現職及退休僱員的福利義務。本集團對該等計劃的供款於產生時列支。本集團就該等計劃對其合資格僱員並無其他福利方面的義務。

#### 政府補貼

政府補貼僅於有合理保證本集團符合該補貼的附帶條件而可收取該補貼時，方予確認。

作為已產生開支或虧損的應收補償或就給予本集團即時財務資助而未來無相關成本的政府補貼，於成為應收款項的期間於損益內確認。

#### 稅項

所得稅開支指即期應付稅項及遞延稅項的總和。即期應付稅項乃根據年內的應課稅溢利計算。應課稅溢利與綜合損益及其他全面收益表中所呈報的「除稅前虧損」不同，乃由於應課稅溢利不包括在其他年度應課稅收入或可扣稅開支項目，亦不包括毋須課稅及不可扣稅項目。本集團的即期稅項負債乃按呈報期末已頒佈或實際已頒佈的稅率計算。

#### Taxation (continued)

Current and deferred tax are recognised in profit or loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary difference to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments and interests are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rate (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

即期及遞延稅項於損益確認，惟當其與在其他全面收益中確認或直接於權益中確認的項目相關，則即期及遞延稅項亦分別於其他全面收益或直接於權益中確認。

遞延稅項乃根據綜合財務報表內資產及負債賬面值與計算應課稅溢利所採用相應稅基的暫時差額確認。遞延稅項負債一般會就所有應課稅暫時差額確認。遞延稅項資產只限於在有應課稅溢利可供對銷的所有可扣稅暫時差額時方會確認。倘暫時差額產生自於既不影響應課稅溢利亦不影響會計溢利的交易中初始確認(於業務合併中除外)資產及負債，則相關遞延稅項資產及負債不予確認。

遞延稅項負債乃就投資於附屬公司所產生的應課稅暫時差額予以確認，除非本集團可控制暫時差額的撥回，且此暫時差額在可見將來可能不會撥回。與該等投資及權益相關之可扣減暫時差異所產生之遞延稅項資產，僅於可能有足夠應課稅溢利可用作抵銷暫時差異之利益，並預期於可見將來撥回的情況下方會予以確認。

遞延稅項資產的賬面值於各報告期間末檢討，並於不再很可能有足夠應課稅溢利以允許收回全部或部分資產時作調減。

遞延稅項資產及負債根據於呈報期末已頒佈或實際已頒佈的稅率(及稅法)，並按於清還負債及變現資產期間預期應用的稅率計量。

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purposes of measuring deferred tax for investment properties that are measured using the fair value model, the carrying amounts of such properties are presumed to be recovered entirely through sale, unless the presumption is rebutted. The presumption is rebutted when the investment property is depreciable and is held within a business model whose objective is to consume substantially all of the economic benefits embodied in the investment property over time, rather than through sale.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied to the same taxable entity by the same taxation authority.

#### Leasehold land and building

When a lease includes both land and building elements, the Group assesses the classification of each element as a finance or an operating lease separately based on the assessment as to whether substantially all the risks and rewards incidental to ownership of each element have been transferred to the Group, unless it is clear that both elements are operating leases in which case the entire lease is classified as an operating lease.

Specifically, the minimum lease payments (including any lump-sum upfront payments) are allocated between the land and the building elements in proportion to the relative fair values of the leasehold interests in the land element and building element of the lease at the inception of the lease. To the extent the allocation of the lease payments can be made reliably, interest in leasehold land that is accounted for as an operating lease is presented as "right-of-use assets" in the consolidated statement of financial position and is amortised over the lease term on a straight-line basis.

遞延稅項負債及資產的計量，反映本集團在呈報期末預期收回或清償其資產及負債賬面值的方式所導致的稅務後果。

為計量利用公平值模型計量的投資物業的遞延稅項，該等物業的賬面值乃假定透過出售全部收回，除非該假定遭駁回則作別論。當投資物業可予折舊，並於本集團以隨時間點(而非透過出售)消耗該投資物業所含絕大部分經濟利益為目標的商業模型持有時，假定即被駁回。

當有合法執行權利許可將即期稅項資產與即期稅項負債抵銷，並涉及同一稅務機構對同一應課稅實體徵收之所得稅時，則遞延稅項資產及負債可予互相抵銷。

#### 租賃土地及樓宇

倘租賃包括土地及樓宇成分，本集團根據各成分擁有權所附帶的絕大部分風險及回報是否已轉移至本集團的評估，決定將成分分類為融資或經營租賃，除非明確兩類租賃均為經營租賃，於該情況下，整份租賃會分類為經營租賃。

具體來說，最低租賃付款(包括任何一次性預付款)於租賃開始時按租賃的土地成分及樓宇成分之租賃權益的相對公平值比例在土地與樓宇成分之間進行分配。倘租賃付款能夠可靠分配，以經營租賃入賬的租賃土地權益於綜合財務狀況表中呈列為「使用權資產」，並於租賃年期按直線法攤銷。

#### Property, plant and equipment

Property, plant and equipment including buildings are tangible assets held for use in the production or supply of goods or for administrative purposes other than properties under construction in progress as described below are stated in the consolidated statement of financial position at cost, less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

Depreciation is recognised so as to write off the cost of assets less their residual values over their estimated useful lives, using the straight-line method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

Properties in the course of construction for production, supply or administrative purposes are carried at cost, less any recognised impairment loss. Costs include professional fees and, for qualifying assets, borrowing costs capitalised in accordance with the Group's accounting policy. Such properties are classified to the appropriate categories of property, plant and equipment when completed and ready for intended use. Depreciation of these assets, as the same basis as other property assets, commences when the assets are ready for their intended use.

Properties in the course of construction for properties held to earn rental and/or for capital appreciation are carried at cost, less any recognised impairment loss. Costs include any costs directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management and, for qualifying assets, borrowing costs capitalised in accordance with the Group's accounting policy. Construction for that purpose are recognised in property, plant and equipment and transferred to investment properties upon the completion of construction.

#### 物業、廠房及設備

物業、廠房及設備(包括持作生產或供應貨品或作行政用途的樓宇,惟下文所述在建物業除外)乃有形資產,於綜合財務狀況表中按成本減其後累計折舊及累計減值虧損(如有)列賬。

折舊乃於估計可使用年期使用直線法撇銷資產成本減其剩餘價值而確認。估計可使用年期、剩餘價值及折舊方法於各呈報期末檢討,而任何估計變動的影響會按前瞻基準入賬。

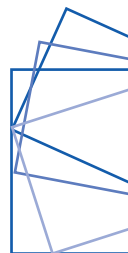
作生產或供應貨品或行政用途的在建物業按成本減任何已確認減值虧損列賬。成本包括專業費及就合資格資產而言,根據本集團會計政策資本化的借貸成本。該等物業落成及可作擬定用途時,將分類至適當類別的物業、廠房及設備。該等資產的折舊按與其他物業資產採用相同的基準進行,在資產可作擬定用途時開始折舊。

持作賺取租金及/或資本增值之在建物業按成本減去任何已確認的減值虧損列賬。成本包括直接歸因於將資產移至使其能夠以管理層預期的方式運作所必需的地點和條件的任何成本,以及對於符合條件的資產而言,根據本集團會計政策,借貸成本資本化。作此目的之工程於物業、廠房及設備中確認並於完工後轉至投資物業。

#### Property, plant and equipment (continued)

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

#### Investment properties

Investment properties are properties held to earn rentals and/or for capital appreciation. Investment properties include land held for undetermined future use, which is regarded as held for capital appreciation purpose.

Investment properties also include leasehold land which are being recognised as right-of-use assets upon application of IFRS 16.

Investment properties are initially measured at cost, including any directly attributable expenditure. Subsequent to initial recognition, investment properties are measured at fair value, adjusted to exclude any prepaid or accrued operating lease income.

Gains or losses arising from changes in the fair value of investment properties are included in profit or loss for the period in which they arise.

An investment property is derecognised upon disposal or when the investment property is permanently withdrawn from use and no future economic benefits are expected from its disposal. A leased property which is recognised as a right-of-use asset is derecognised if the Group as intermediate lessor classifies the sublease as a finance lease. Any gain or loss arising on derecognition of the property (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in profit or loss in the period in which the property is derecognised.

#### 物業、廠房及設備(續)

物業、廠房及設備項目乃於出售時或當預期持續使用該資產將不會產生未來經濟利益時終止確認。於終止確認該資產時產生之任何收益或虧損(以出售所得款項淨額與該項目之賬面值間之差額計算)乃計入年度之損益內。

#### 投資物業

投資物業指為賺取租金及/或資本升值而持有之物業。投資物業包括持有但尚未確定未來用途之土地(其視為持作資本升值)。

投資物業亦包括應用國際財務報告準則第16號後確認為使用權資產之租賃土地。

投資物業初步按成本(包括任何直接應佔開支)計量。於初始確認後,投資物業按公平值計量,並就剔除任何預付或應計經營租賃收入作出調整。

投資物業之公平值變動所產生之盈虧於產生期間計入損益。

投資物業於出售或永久停止使用且預計不會從出售該物業獲得未來經濟利益時取消確認。倘本集團作為中間出租人將分租分類為金融租賃,則確認為使用權資產之出租物業將取消確認。取消確認物業所產生之任何收益或虧損(按該資產之出售所得款項淨額與賬面值之差額計算)會在物業取消確認之期間計入損益。

#### Non-current assets held for sale

Non-current assets are classified as held for sale when their carrying amounts are to be recovered principally through sale transactions and sales are considered highly probable. It is stated at the lower of carrying amount and fair value less costs to sell.

#### Research and development costs

Expenditure on research activities is recognised as an expense in the period in which it is incurred.

Expenditure incurred on projects to develop new products is capitalised and deferred only when the Group can demonstrate the technical feasibility of completing the intangible asset so that it will be available for use or sale, its intention to complete and its ability to use or sell the asset, how the asset will generate future economic benefits, the availability of resources to complete the project and the ability to measure reliably the expenditure during the development. Product development expenditure which does not meet these criteria is expensed when incurred.

Deferred development costs and patents are stated at cost less any impairment losses and are amortised on a systematic basis with reference to projected sales volume, upon future sales volume of related products.

#### Intangible assets acquired separately

Intangible assets with finite useful lives that are acquired separately are carried at costs less accumulated amortisation and any accumulated impairment losses. Amortisation for intangible assets with finite useful lives is recognised on a straight-line basis over their estimated useful lives. The estimated useful life and amortisation method are reviewed at the end of each reporting period, with the effect of any changes in estimate being accounted for on a prospective basis.

An intangible asset is derecognised upon disposal, or when no future economic benefits are expected from its use or disposal. Gains or losses arising from derecognition of an intangible asset are measured at the difference between the net disposal proceeds and the carrying amount of the asset and are recognised in profit or loss in the period when the asset is derecognised.

#### 持有待售非流動資產

當非流動資產之賬面值乃主要透過出售交易收回，且有關出售被視為極可能發生，則分類為持有待售，並按賬面值與公平值減出售成本之較低者列賬。

#### 研發成本

研發活動的支出於其產生的期間確認為開支。

遞延開發成本及專利按成本扣除任何減值虧損後列賬，並根據有關產品的預計未來銷售數量參考預測銷量以系統基準攤銷。

#### 單獨收購的無形資產

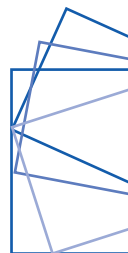
單獨收購可使用年期有限的無形資產按成本減累計攤銷及任何累計減值虧損列賬。可使用年期有限的無形資產於估計可使用年期以直線法攤銷。估計可使用年期及攤銷方法於各呈報期末檢討，而任何估計變動的影響會按前瞻基準入賬。

無形資產乃於出售時或當預期使用或出售該資產將不會產生未來經濟利益時終止確認。於終止確認無形資產時產生的收益或虧損乃按出售所得款項淨額與資產賬面值之間的差額計量，並於該資產終止確認期間在損益內確認。

#### Impairment losses on non-financial assets

At the end of the reporting period, the Group reviews the carrying amounts of its tangible assets including property, plant and equipment, right-of-use assets and intangible assets with finite useful life to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss, if any.

The recoverable amount of property, plant and equipment, right-of-use assets and intangible assets with finite useful life are estimated individually. When it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs.

In addition, the Group assesses whether there is indication that corporate assets may be impaired. If such indication exists, corporate assets are also allocated to individual cash-generating units, when a reasonable and consistent basis of allocation can be identified, or otherwise they are allocated to the smallest group of cash-generating units for which a reasonable and consistent allocation basis can be identified.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or a cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or the cash-generating unit) is reduced to its recoverable amount. An impairment loss is recognised immediately in profit or loss. In allocating the impairment loss, the impairment loss is allocated first to reduce the carrying amount of any goodwill (if applicable) and then to the other assets on a pro-rata basis based on the carrying amount of each asset in the unit or the group of cash-generating units. The carrying amount of an asset is not reduced below the highest of its fair value less costs of disposal (if measurable), its value in use (if determinable) and zero. The amount of the impairment loss that would otherwise have been allocated to the asset is allocated pro-rata to the other assets of the unit or the group of cash-generating units. An impairment loss is recognised immediately in profit or loss.

#### Inventories

Raw materials, work in progress and finished goods are stated at the lower of cost and net realisable value. Cost comprises direct materials, direct labour and an appropriate proportion of variable and fixed overheads expenditure, the latter being allocated on the basis of normal operating capacity. Costs are assigned to individual items of inventory on the basis of weighted average costs. Costs of purchased inventory are determined after deducting rebates and discounts. Net realisable value is the estimated selling price in the ordinary course of business less estimated costs of completion and the estimated costs necessary to make the sale.

#### Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks or other financial institutions and short-term highly liquid investments that are readily convertible to known amount of cash, are subject to an insignificant risk of damages in value, and having been within three months of maturing of acquisition.

#### Financial instruments

Financial assets and financial liabilities are recognised when a group entity becomes a party to the contractual provisions of the instrument. All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the market place.

Financial assets and financial liabilities are initially measured at fair value except for trade receivables arising from contracts with customers which are initially measured in accordance with IFRS 15. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets or financial liabilities at fair value through profit or loss (“FVTPL”)) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at FVTPL are recognised immediately in profit or loss.

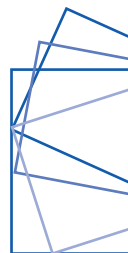

- (i) Amortised cost and interest income  
Interest income is recognised using the effective interest method for financial assets measured subsequently at amortised cost. Interest income is calculated by applying the effective interest rate to the gross carrying amount of a financial asset, except for financial assets that have subsequently become credit-impaired (see below). For financial assets that have subsequently become credit-impaired, interest income is recognised by applying the effective interest rate to the amortised cost of the financial asset from the next reporting period. If the credit risk on the credit-impaired financial instrument improves so that the financial asset is no longer credit-impaired, interest income is recognised by applying the effective interest rate to the gross carrying amount of the financial asset from the beginning of the reporting period following the determination that the asset is no longer credit impaired.
- (ii) Financial assets at FVTPL  
Financial assets that do not meet the criteria for being measured at amortised cost are measured at FVTPL.

Financial assets at FVTPL are measured at fair value at the end of each reporting period, with any fair value gains or losses recognised in profit or loss. The Group performs impairment assessment under expected credit losses ("ECL") on financial assets (including trade and bills receivables, financial assets included in prepayments, deposits and other receivables, pledged deposits and bank balances and cash) which are subject to impairment under IFRS 9. The amount of ECL is updated at each reporting date to reflect changes in credit risk since initial recognition.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of the relevant instrument. In contrast, 12-month ECL ("12m ECL") represents the portion of lifetime ECL that is expected to result from default events that are possible within 12 months after the reporting date. Assessment are done based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current conditions at the reporting date as well as the forecast of future conditions.

The Group always recognises lifetime ECL for all trade receivables which are assessed individually with a provision matrix with appropriate groupings.

For all other instruments, the Group measures the loss allowance equal to 12m ECL, unless when there has been a significant increase in credit risk since initial recognition, the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increases in the likelihood or risk of a default occurring since initial recognition.

- (i) Significant increase in credit risk  
In assessing whether the credit risk has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

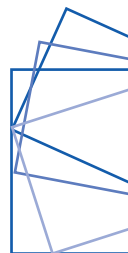

In particular, the following information is taken into account when assessing whether credit risk has increased significantly:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;

- existing or forecast adverse changes in business, financial or economic conditions that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations;

(i) Significant increase in credit risk (continued)

Despite the foregoing, the Group assumes that the credit risk on a debt instrument has not increased significantly since initial recognition if the debt instrument is determined to have low credit risk at the reporting date. A debt instrument is determined to have low credit risk if i) it has a low risk of default, ii) the borrower has a strong capacity to meet its contractual cash flow obligations in the near term and iii) adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow obligations. The Group considers a debt instrument to have low credit risk when it has an internal or external credit rating of 'investment grade' as per globally understood definitions.

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

(ii) Definition of default

For internal credit risk management, the Group considers an event of default occurs when information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group).

Irrespective of the above, the Group considers that default has occurred when a financial asset is more than 365 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

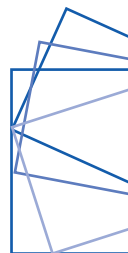

- (iii) Credit-impaired financial assets  
A financial asset is credit-impaired when one or more events of default that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:
- a) significant financial difficulty of the issuer or the borrower;
  - b) a breach of contract, such as a default or past due event;
  - c) the lender(s) of the borrower, for economic or contractual reasons relating to the borrower's financial difficulty, having granted to the borrower a concession(s) that the lender(s) would not otherwise consider;
  - d) it is becoming probable that the borrower will enter bankruptcy or other financial reorganisation; or
  - e) the disappearance of an active market for that financial asset because of financial difficulties.
- (iv) Write-off policy  
The Group writes off a financial asset when there is information indicating that the counterparty is in severe financial difficulty and there is no realistic prospect of recovery, for example, when the counterparty has been placed under liquidation or has entered into bankruptcy proceedings, or in the case of trade receivables, when the amounts are over two years past due, whichever occurs sooner. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. A write-off constitutes a derecognition event. Any subsequent recoveries are recognised in profit or loss.

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward-looking information. Estimation of ECL reflects an unbiased and probability-weighted amount that is determined with the respective risks of default occurring as the weights. The Group uses a practical expedient in estimating ECL on trade receivables using a provision matrix taking into consideration historical credit loss experience, adjusted for forward looking information that is available without undue cost or effort.

Generally, the ECL is the difference between all contractual cash flows that are due to the Group in accordance with the contract and the cash flows that the Group expects to receive, discounted at the effective interest rate determined at initial recognition.

Where ECL is measured on a collective basis or cater for cases where evidence at the individual instrument level may not yet be available, the financial instruments are grouped on the aging basis:

- Nature of financial instruments;
- Past-due status; and
- Nature, size and industry of debtor.

The grouping is regularly reviewed by management to ensure the constituents of each group continue to share similar credit risk characteristics.

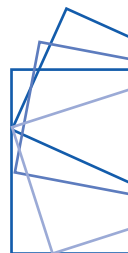

The Group recognises an impairment gain or loss in profit or loss for all financial instruments by adjusting their carrying amount, with the exception of trade receivables, where the corresponding adjustment is recognised through a loss allowance account.

*Derecognition of financial assets*

A financial asset is derecognised only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity. Debt and equity instruments issued by a group entity are classified as either financial liabilities or as equity in accordance with the substance of the contractual arrangements and the definitions of a financial liability and an equity instrument.

#### *Equity instruments*

An equity instrument is any contract that evidences a residual interest in the assets of an entity after deducting all of its liabilities. Equity instruments issued by the Group are recognised at the proceeds received, net of direct issue costs.

**Provisions and contingent liabilities**

When a provision is measured using the cash flows estimated to settle the present obligation, its carrying amount is the present value of those cash flows (where the effect of the time value of money is material).

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

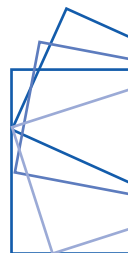

##### Share options granted to employees

Equity-settled share-based payments to employees and others providing similar services are measured at the fair value of the equity instruments at the grant date.

The fair value of the equity-settled share-based payments determined at the grant date without taking into consideration all non-market vesting conditions is expensed on a straight-line basis over the vesting period, based on the Group's estimate of equity instruments that will eventually vest, with a corresponding increase in share options reserve.

The impact of the revision of the original estimates, if any, is recognised in profit or loss such that the cumulative expense reflects the revised estimate, with a corresponding adjustment to share options reserve. For share options that vest immediately at the date of grant, the fair value of the share options granted is expensed immediately to profit or loss.

When share options are exercised, the amount previously recognised in share options reserve will be transferred to share premium. 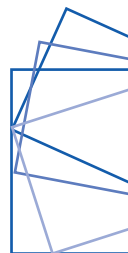

In the application of the Group's accounting policies, which are described in note 3, the directors of the Company are required to make judgements, estimates and assumptions about the amounts of assets, liabilities, that are not readily apparent for other sources. The estimates and underlying assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an on-going basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

##### Critical judgements in applying accounting policies

The following are the critical judgements, apart from those involving estimations (see below), that the directors of the Company have made in the process of applying the Group's accounting policies and that have the most significant effect on the amounts recognised and disclosures made in the consolidated financial statements.

##### Classification between investment properties and owner-occupied properties

The Group determines whether a property qualifies as an investment property, and has developed criteria in making that judgement. Investment property is a property held to earn rentals or for capital appreciation or both. Therefore, the Group considers whether a property generates cash flows largely independently of the other assets held by the Group. Some properties comprise a portion that is held to earn rentals or for capital appreciation and another portion that is held for use in the supply of goods or services or for administrative purposes. If these portions could be sold separately (or leased out separately under a finance lease), the Group accounts for the portions separately. If the portions could not be sold separately, the property is an investment property only if an insignificant portion is held for use in the supply of goods or services or for administrative purposes. Judgement is made on an individual property basis to determine whether ancillary services are so significant that a property does not qualify as an investment property.

Certain properties of the Group comprise a portion that is held to earn rentals and another portion that is held for use in the supply of goods and for administrative purposes. As the portion that is held to earn rentals is small and could not be sold separately and the portion that is held for use in supply of goods and for administrative purposes is significant, the properties are not classified as investment properties.

##### Withholding taxes arising from the distributions of dividends

The Group's determination as to whether to accrue for withholding taxes from the distribution of dividends from a subsidiary in the PRC according to the relevant tax jurisdiction is subject to judgement on the timing of the payment of the dividend, where the Group considered that if it is probable that the profits of the subsidiary in the PRC will not be distributed in the foreseeable future, then no withholding taxes should be provided.

##### 投資物業及自用物業的分類

本集團會釐定一項物業是否屬於投資物業，並已制定決定分類的條件。投資物業為持作賺取租金或資本增值或以上兩用途的物業。因此，本集團會衡量物業所產生現金流量是否獨立於本集團持有的其他資產。若干物業包括持作賺取租金或資本增值以及用作提供貨品及服務或行政用途的另一部分。倘該等物業部分能獨立出售或根據融資租賃獨立出租，則本集團會將各個相關部分分別入賬。倘該等部分不能獨立出售而持作提供貨品及服務或行政用途的部分並不重大，則該等物業方視為投資物業。本集團會獨立衡量個別物業，以釐定一項物業的配套服務是否重要致使其不合資格分類作投資物業。

本集團若干物業包括持作賺取租金以及持作提供貨品及行政用途的部分。由於持作賺取租金的物業部分不重大，且不能單獨出售，而持作提供貨品及行政用途的物業部分較重大，因此該等物業並非歸類為投資物業。

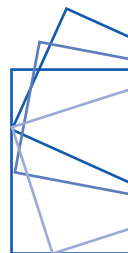

#### Key sources of estimation uncertainty

The following are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of resulting in a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

#### Useful lives and impairment of property, plant and equipment and right-of-use assets

The Group determines the estimated useful lives and related depreciation charges for its property, plant and equipment. This estimate is based on the historical experience of the actual useful lives of property, plant and equipment of similar nature and functions. Management will revise the depreciation charge where useful lives are different to the ones previously estimated, it will write-off or write-down technically obsolete or non-strategic assets that have been abandoned or sold.

The Group assesses whether there are any indicators of impairment for property, plant and equipment at the end of each reporting period. Property, plant and equipment are tested for impairment when there are indicators that the carrying amounts may not be recoverable. An impairment exists when the carrying value of an asset or a cash-generating unit exceeds its recoverable amount, which is the higher of its fair value less costs of disposal and its value in use. The calculation of the fair value less costs of disposal is based on available data from binding sales transactions in an arm's length transaction of similar assets or observable market prices less incremental costs for disposing of the asset. When value in use calculations are undertaken, management must estimate the expected future cash flows from the asset or cash-generating unit and choose a suitable discount rate in order to calculate the present value of those cash flows.

#### 物業、廠房及設備以及使用權資產的可使用年期及減值

本集團釐定物業、廠房及設備的估計可使用年期及相關折舊開支。該等估計乃基於性質及功能相若的物業、廠房及設備過往的實際可使用年期記錄而作出。管理層會修訂可使用年期與之前估計相異的項目的折舊開支，並撤銷或撤減技術已過時或非策略性質的已棄用或已出售資產。

本集團於各呈報期末評估物業、廠房及設備有否出現任何減值跡象。物業、廠房及設備於有跡象顯示可能無法收回賬面值時測試減值。倘資產或現金產生單位之賬面值高於其可收回金額(即公平值減銷售成本與使用價值兩者之較高者)，即表示出現減值。公平值減銷售成本乃以可取得之類似資產公平交易中具約束力之銷售交易數據，或可觀察市場價格減出售資產所帶來之成本計算。計算使用價值時，管理層必須估算資產或現金產生單位之估計未來現金流量，並選用適當之貼現率，以計算該等現金流量之現值。

#### Useful lives and impairment of property, plant and equipment and right-of-use assets (continued)

As at 31 December 2020, the carrying amount of property, plant and equipment and right-of-use assets was approximately RMB28,125,000 (2019: RMB49,291,000) and RMB4,533,000 (2019: RMB27,351,000) respectively. The directors of the Company consider that no impairment loss is required in respect of property, plant and equipment and right-of-use assets during the years ended 31 December 2020 and 2019.

#### Impairment of intangible assets

Intangible asset are stated at costs less accumulated depreciation and impairment, if any. In determining whether an asset is impaired, the Group has to exercise judgment and make estimation, particularly in assessing: (1) whether an event has occurred or any indicators that may affect the asset value; (2) whether the carrying value of an asset can be supported by the recoverable amount, in the case of value in use, the net present value of future cash flows which are estimated based upon the continued use of the asset; and (3) the appropriate key assumptions to be applied in estimating the recoverable amounts including cash flow projections and an appropriate discount rate. When it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit to which the assets belongs. Changing the assumptions and estimates, including the discount rates or the growth rate in the cash flow projections, could materially affect the net present value used in the impairment test.

As at 31 December 2020, the net carrying amounts of the Group's intangible asset was approximately RMB154,000 (2019: RMB77,255,000). Impairment loss on intangible assets for approximately RMB64,842,000 (2019: RMB234,295,000) was recognised in profit or loss.

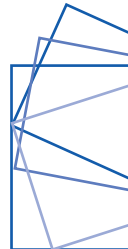

##### Allowance for inventories

Inventories are stated at the lower of cost and net realisable value. Net realisable value of inventories is the estimated selling price in the ordinary course of business less estimated selling expenses. These estimates are based on the current market conditions and the historical experience of selling merchandise of a similar nature. It could change significantly as a result of changes in customer taste or competitor actions. The Group reassesses these estimates at the end of the reporting period. As at 31 December 2020, the carrying amount of inventories was approximately RMB39,127,000 (2019: RMB29,367,000), net of allowance for write-down inventories of approximately RMB3,631,000 (2019: RMB4,527,000).

##### Provision of ECL for trade receivables

The Group uses provision matrix to calculate ECL for the trade receivables. The provision rates are based on past due analysis as groupings of various debtors on this basis which demonstrate similar loss patterns with shared credit risk characteristic. The provision matrix is based on the Group's historical default rates taking into consideration forward-looking information that is reasonable and supportable available without undue costs or effort. At every reporting date, the historical observed default rates are reassessed and changes in the forward-looking information are considered. In addition, trade receivables with significant balances and credit impaired are assessed for ECL individually.

The provision of ECL is sensitive to changes in estimates. As at 31 December 2020, the carrying amount of trade receivables is approximately RMB44,454,000, net of allowance for credit losses of approximately RMB1,179,000 (2019: RMB44,784,000, net of allowance for credit losses of RMB7,986,000).

##### Valuation of investment properties

Investment properties are carried in the consolidated statement of financial position at 31 December 2020 at their fair value of approximately RMB60,029,000 (2019: Nil). The fair value was based on a valuation on these properties conducted by independent firms of professional valuers using property valuation techniques which involve certain assumptions of market conditions. Favourable or unfavourable changes to these assumptions would result in changes in the fair value of the Group's investment properties and corresponding adjustments to the amount of gain or loss reported in the consolidated statement of profit or loss and other comprehensive income.

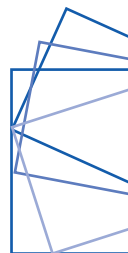

The segment profit or loss represents the profit earned by or loss from each segment without allocation of interest income, other unallocated net income and gains, amortisation of intangible assets, impairment loss on intangible assets and assets held for sale, fair value change on investment properties, fair value change on provision for contingent consideration at FVTPL, finance costs as well as corporate and other unallocated expenses.

Segment assets exclude property, plant and equipment, investment properties, certain right-of-use assets, intangible assets, raw materials, work in progress, prepayments, deposits and other receivables, pledged deposits and cash and bank balances as these assets are managed on a group basis.

Segment liabilities exclude trade and bills payables, certain other payables and accruals, short term borrowings, certain lease liabilities, income tax payable and deferred tax liability as these liabilities are managed on a group basis.

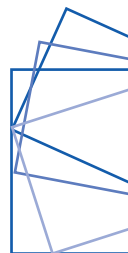
Pursuant to the income tax law of the PRC, a 10% withholding tax is levied on dividends declared to foreign investors from the foreign investment enterprises established in the PRC. The requirement is effective from 1 January 2008 and applies to earnings after 31 December 2007. A lower withholding tax rate may be applied if there is a tax treaty between the PRC and the jurisdiction of the foreign investors. For the Group, the applicable rate for the withholding tax is 5% (2019: 5%). In estimating the withholding taxes on dividends expected to be distributed by those subsidiaries established in the PRC in respect of earnings generated from 1 January 2008, the directors of the Company have made assessment based on the factors which included dividend policy and the level of capital and working capital required for the Group's operations in the foreseeable future. No deferred tax liability has been provided for retained profit as the Group is able to control the timing of the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future.

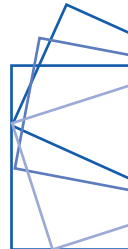

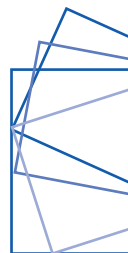

- (a) It represented technological know-how in respect of the application of graphene and includes one patent in the US (“US Patent”), four invention patent applications, three utility model patent applications and two utility model patents in the PRC (collectively as “PRC Patents”), relating to the manufacturing of Graphene-based EVA Foam Material, Sterilizing Chips and graphene-based pressure-sensitive sensors and the exclusive formula (collectively “Technology Know-how”), which was acquired from Bluestone Technologies (Cayman) Limited (“Bluestone”), an independent third party, in 2015.

The completion date of the transaction (“Completion Date”) was 16 December 2015. The cost of the Technology Know-how was determined by the directors of the Company and represented the sum of the cash consideration, the fair value of the convertible notes and provision for contingent consideration at the acquisition date (note 28), and the capitalised transaction costs arising directly from the acquisition of the Technology Know-how. The Group’s first graphene application products mass production line was completed and commenced trial production in late May 2016, and mass production has already been commenced in July 2016.

The Technology Know-how has definite useful lives and is amortised over 10 years using the straight-line method.

- (b) In July 2016, the Group acquired the design of Online-to-Offline (“O2O”) distribution vending system at the consideration of RMB60,000,000 from two independent third parties. The directors of the Company consider that the O2O distribution vending system would provide customers with an interactive and unique shopping experience, enhance the distribution channel of the products made by the Group and establish the core technical competitiveness of the Group.

The O2O distribution vending system has definite useful lives and is amortised over 9 years using the straight-line method.

The directors of the Company conducted an impairment assessment on the O2O distribution vending system with reference to a valuation of the O2O distribution vending system conducted by an independent professional valuer, Ascent Partners Valuation Service Limited ("Ascent Partners"), using relief from royalty method and considered that provision for impairment to the carrying amount of the O2O distribution vending system of approximately RMB13,474,000 (2019: RMB25,835,000) should be made as at 31 December 2020.

The relief from royalty method measures value by estimating budgeted sales associated with the intangible asset (i.e. O2O distribution vending system) over its useful life and then applying an appropriate royalty rate to the revenue estimate. It measures the costs that are avoided (the royalty payments that are not made) due to the firm's ownership of the intangible asset. The royalty rate of approximately 10.00% (2019: 10.00%) was used and the present value of the estimated royalty payments is calculated using discount rate of approximately 20.93% (2019: 20.90%). Assumption of budgeted sales was based on estimated daily average sales of slippers from O2O distribution vending system and expected growth rate of product mix.

(c) The directors of the Company consider that O2O distribution vending system is a contributory asset necessary to support the earnings associated with the Technology Know-how (collectively "CGU"), being the smallest identifiable group of assets that generates earnings that are largely independent of the earnings from other assets.

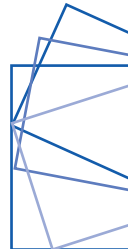

The directors of the Company conducted an impairment assessment on the Technology Know-how with reference to a valuation of the Technology Know-how conducted by Ascent Partners, using multi-period excess earnings method and considered that provision for impairment to the carrying amount of the Technology Know-how of approximately RMB51,368,000 (2019: RMB187,727,000) should be made as at 31 December 2020. The multi-period excess earnings method is based on a discount rate of approximately 22.93% (2019: 22.90%) and financial forecasts approved by the directors of the Company. Assumption of budgeted sales was based on estimated daily average sales of slippers from O2O distribution vending system and expected growth rate of product mix. Other key assumptions for the multi-period excess earnings method relate to the estimation of earnings which include estimated gross profit margin, operating expenses and working capital requirements, such estimation is based on the expected and forecasted performance generated from the past performance of the CGU and management's expectations for the market development.

(d) In July 2016, the Group engaged several independent third parties in the research and development of manufacturing and application technology of graphene material on Sterilizing Chips, energy storage materials for batteries and pressure sensitive lighting devices for shoes ("Other Deferred Development Costs"). The directors of the Company seeks the opportunities in applying the graphene material in products other than shoes and plan to launch in future.

The Sterilizing Chips has definite useful lives and is amortised over 5 years using the straight-line method.

The directors of the Company conducted an impairment assessment on the Sterilizing Chips and considered that the future economic benefits attributable to the Sterilizing Chips is premature and provision for impairment of approximately RMB20,733,000 was made as at 31 December 2019.

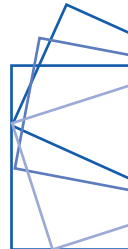

Bank deposits amounting to approximately RMB3,780,000 (2019: RMB3,855,000) have been pledged to secure bills payables of RMB12,600,000 (2019: RMB12,850,000) (note 24).

At 31 December 2020, the amount denominated in RMB included in cash and bank balances and pledged bank deposits amounted to approximately RMB3,971,000 (2019: cash and bank balances amounted to RMB5,869,000). The RMB is not freely convertible into other currencies, however, under the PRC Foreign Exchange Control Regulations and Administration of Settlement, Sale and Payment of Foreign Exchange Regulations, the Group is permitted to exchange RMB for other currencies through banks authorised to conduct foreign exchange business.

Cash at banks earns interest at floating rates based on daily bank deposit rates. Pledged deposits earned interest at fixed rate ranging from 1.55% to 1.75% (2019: 1.55%) per annum. On 10 October 2017, the Group entered into a sales and purchase agreement with an independent third party (the "Buyer") at a consideration of RMB26,000,000 to dispose of certain property, plant and equipment with land use right located in PRC. In accordance with IFRS 5, the disposal assets were reclassified as assets held for sale in 2017. During the year ended 31 December 2018, the transfer of legal title of the disposal asset was in progress and non-refundable deposit amounting to RMB16,500,000 had been received. On 16 September 2019, the Group entered into a supplementary agreement to the sales and purchase agreement with the Buyer and agreed to reduce the consideration by RMB3,000,000 due to the quality issue. In 2019, the transaction had been completed as the land use right had been transferred to the Buyer. The remaining balance was received in 2020.

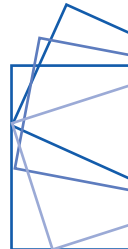

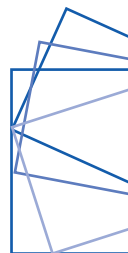

“Second Instalment Conditions” refer to (a) the registration of the transfer of the PRC Patents and the US Patent having been completed in the State Intellectual Property Office of the PRC and the United States Patent and Trademark Office respectively, such that the Company having become the applicant of the PRC Patents (or if the PRC Patents are granted, the Company having become the PRC Patents owner) under the record of the State Intellectual Property Office of the PRC, and the Company having become the US Patent owner under the record of the United States Patent and Trademark Office; and (b) the training provided by Bluestone to the technicians of the Group and its contracted parties having been completed, such that the Group and its contracted parties having been able to produce graphene-based EVA foam material and graphene deodorizing and sterilizing chips based on the Technology Know-how independently, and the graphene-based EVA foam material and graphene deodorizing and sterilizing chips produced having been certified by an independent technical organisation at provincial level or above to meet the inspection standard as stipulated under the Acquisition Agreement.

As at 31 December 2020, the Company had 313,600,000 (2019: 241,180,000) share options outstanding under the Share Option Scheme, which represented approximately 21.09% (2019: 16.22%) of the Shares in issue as at that date. The exercise in full of the outstanding share options would, under the present capital structure of the Company, result in the issue of 313,600,000 (2019: 241,180,000) additional Shares and additional share capital and share premium of approximately HK\$24,312,000 (equivalent to RMB20,462,000) (2019: HK\$18,783,000 and equivalent to RMB16,825,000) and approximately HK\$161,441,000 (equivalent to RMB135,875,000) (2019: HK\$137,170,000 equivalent to RMB122,874,000), before issue expenses.

### 32. RESERVES

#### (i) Contributed surplus

On 17 January 2011, CITIC Capital, the Company and its shareholders had entered into certain conditional release and discharge agreements, pursuant to which, the new exchangeable note would be duly released and discharged, which had taken place on the Listing Date, 28 January 2011, and prior to the commencement of the trading of the Shares on the Stock Exchange. Accordingly, the liability component of the new exchangeable note of RMB57,768,000 on the Listing Date was extinguished and transferred to the contributed surplus in shareholders' equity upon the full conversion of the new exchangeable note.

Pursuant to the stock borrowing agreement entered into between Best Mark and the Subscriber on 21 June 2012, Best Mark lent 32,000,000 Shares to the Subscriber. Upon initial recognition, the value of such contribution amounting to approximately RMB12,183,000 from the substantial shareholder was accounted for as a deemed contribution in the shareholder's equity. The carrying amount of such contribution from the substantial shareholder is not remeasured in subsequent years.

On 10 September 2012, Best Mark and the Subscriber entered into a letter agreement (the "Call and Put Option Confirmation") pursuant to which the Subscriber had granted to Best Mark the right to purchase 32,000,000 of the Shares at a strike price of HK\$1.01 and Best Mark has granted the Subscriber the right to require Best Mark to purchase 32,000,000 of the Shares at the same strike price.

On 17 December 2014, the Company was informed by Best Mark that 32,000,000 Shares had been transferred by the Subscriber to Best Mark and the transaction set out in the Call and Put Option Confirmation was terminated.

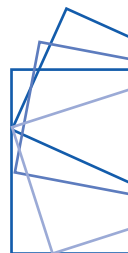

In accordance with the relevant regulations applicable in the PRC, the Group's subsidiary established in the PRC is required to transfer a certain percentage of its statutory annual profits after tax (after offsetting any prior period's losses), if any, to the statutory surplus fund until the balance of the fund reaches 50% of its registered capital. Subject to certain restrictions as set out in the relevant PRC regulations, the statutory surplus fund may be used to offset against accumulated losses of the PRC subsidiary. The amount of the transfer is subject to the approval of the board of directors of the PRC subsidiary.

#### (iii) Exchange fluctuation reserve

The exchange fluctuation reserve comprises all foreign exchange differences arising from the translation of the financial statements of operations outside the PRC which are dealt with in accordance with the accounting policy set out in note 3 to the consolidated financial statements.

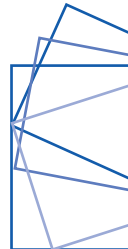

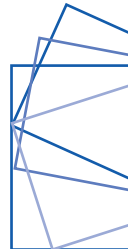

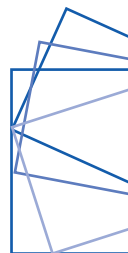

#### Credit risk and impairment assessment

As at 31 December 2020, the Group's maximum exposure to credit risk which will cause a financial loss to the Group due to failure to discharge an obligation by the counterparties arises from the carrying amount of the respective recognised financial assets as stated in the consolidated statement of financial position.

In order to minimise the credit risk, the management of the Group has delegated a team responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In addition, the Group performs impairment assessment under ECL model upon application of IFRS 9 on trade receivables which are assessed individually with a provision matrix with appropriate groupings. In this regard, the directors of the Company consider that the Group's credit risk is significantly reduced.

For financial assets included in prepayments, deposits and other receivables, the Group makes individual assessment based on industrial factors, historical observed default rates and adjusts for forward-looking information that is available without undue cost or effort. No impairment was recognised by the Group on financial assets included in prepayments, deposits and other receivables during the current year.

The Group's credit risk on bank balances and cash is low and there is no significant concentration of credit risk because all bank deposits are deposited in or contracted with several state-owned banks with good reputation and with high credit ratings assigned by international credit-rating agencies. No recognition of ECL on bank balances, restricted bank balances and cash is considered necessary.

The Group's concentration of credit risk by geographical locations is mainly in the US (2019: US), which accounted for 99% (2019: 91%) of the total trade receivables as at 31 December 2020.

The Group has concentration of credit risk as 89% (2019: 48%) and 99% (2019: 97%) of the total trade receivables was due from the Group's largest customer and the five largest customers respectively.

為將信貸風險降至最低，本集團管理層已委派專責小組負責釐定信貸限額、批准信貸，以及應用其他監管程序以確保會就收回逾期債項採取跟進行動。此外，本集團於應用國際財務報告準則第9號後按預期信貸虧損模式就應收貿易賬款採用撥備矩陣與適當的分組進行單獨的減值評估。就此而言，本公司董事認為，本集團的信貸風險已大幅降低。

就包含在預付款項、按金及其他應收款項的金融資產而言，本集團根據行業因素、過往可觀察違約率單獨作出評估，並就毋須付出不必要成本或努力即可獲得之前瞻性資料進行調整。本集團於本年度概無就包含在預付款項、按金及其他應收款項的金融資產確認減值。

本集團銀行結餘及現金之信貸風險為低，且概無重大信貸集中風險，原因為所有銀行存款均存置於多間信譽良好且獲國際信貸評級機構給予高信貸評級之國有銀行。毋須就銀行結餘、受限制銀行結餘及現金確認預期信貸減值。

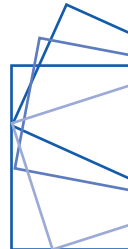

#### Credit risk and impairment assessment (continued)

The Group writes off a trade receivable when there is information indicating that the debtor is in severe financial difficulty and there is no realistic prospect of recovery, e.g. when the debtor has been placed under liquidation or has entered into bankruptcy proceedings, or when the trade receivables are over one year past due, whichever occurs earlier.

#### Interest rate risk

The Group's exposure to the risk of changes in market interest rates relates primarily to the Group's short term borrowings with floating interest rates.

The Group regularly reviews and monitors the floating interest rate borrowings in order to manage its interest rate risks. The short term borrowings, cash and short term deposits are stated at amortised cost and not revalued on a periodic basis. Floating rate interest income and expenses are credited/charged to the statement of profit or loss as earned/incurred.

The following table demonstrates the sensitivity to a reasonably possible change in interest rates, with all other variables held constant, of the Group's net loss before tax (through the impact on floating rate borrowings).

#### Liquidity risk

In the management of the liquidity risk, the Group monitors and maintains a level of cash and cash equivalents deemed adequate by the management to finance the Group's operations and mitigate the effects of fluctuations in cash flows. The management monitors the utilisation of bank borrowings and ensures compliance with loan covenants.

The Group relies on bank borrowings, internal resources and external facilities provided by an independent third party as significant sources of liquidity. As at 31 December 2020, the Group has fully utilised the short-term bank loan facilities (2019: fully utilised short-term bank loan facilities).

The following table details the Group's remaining contractual maturity for its non-derivative financial liabilities. The table has been drawn up based on the undiscounted cash flows of financial liabilities based on the earliest date on which the Group can be required to pay. 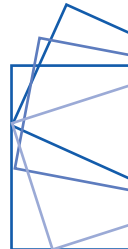

#### Commodity price risk

The major raw materials used in the production of the Group's products include rubber and plastics. The Group is exposed to fluctuations in the prices of these raw materials which are influenced by global as well as regional supply and demand conditions. Fluctuations in the prices of raw materials could adversely affect the Group's financial performance. The Group historically has not entered into any commodity derivative instruments to hedge the potential commodity price changes.

### 41 CONTINGENT LIABILITIES

During the year of 2020, a supplier had filed lawsuit against the overdue payment of Quanzhou Baofeng Shoes Co., Ltd. ("Quanzhou Baofeng"), an indirect wholly-owned subsidiary of the Company, with total amount of approximately RMB0.5 million (the "Amount in Question") and the first trial held that Quanzhou Baofeng shall repay the Amount in Question plus interest.

Based on the best estimation of the management of the Company, Quanzhou Baofeng has valid ground in opposing the Amount in Question in the judgement of the above said case. As the lawsuit is in the process of appeal, the corresponding legal fee and interest are uncertain. Accordingly, no provision has been made in the consolidated financial statement.

Except as described above, there was no material contingent liabilities as at 31 December 2020 and 2019.

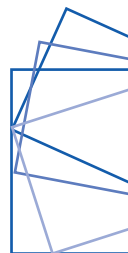

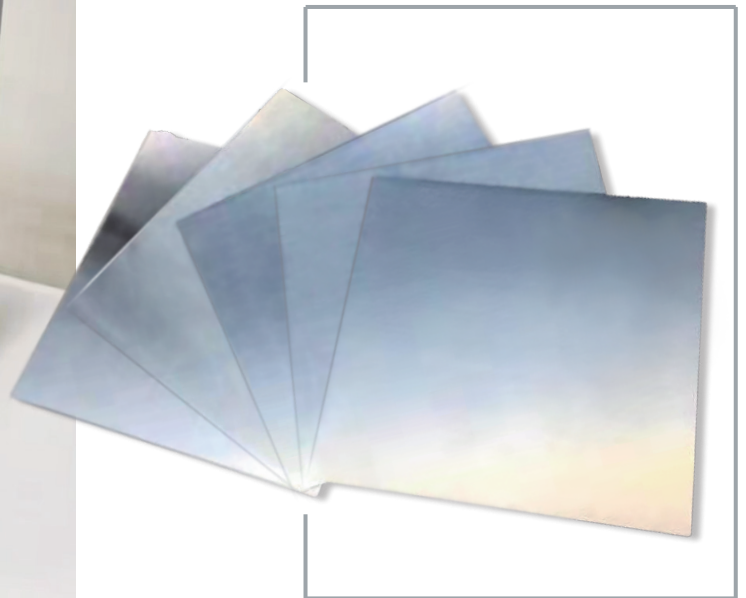
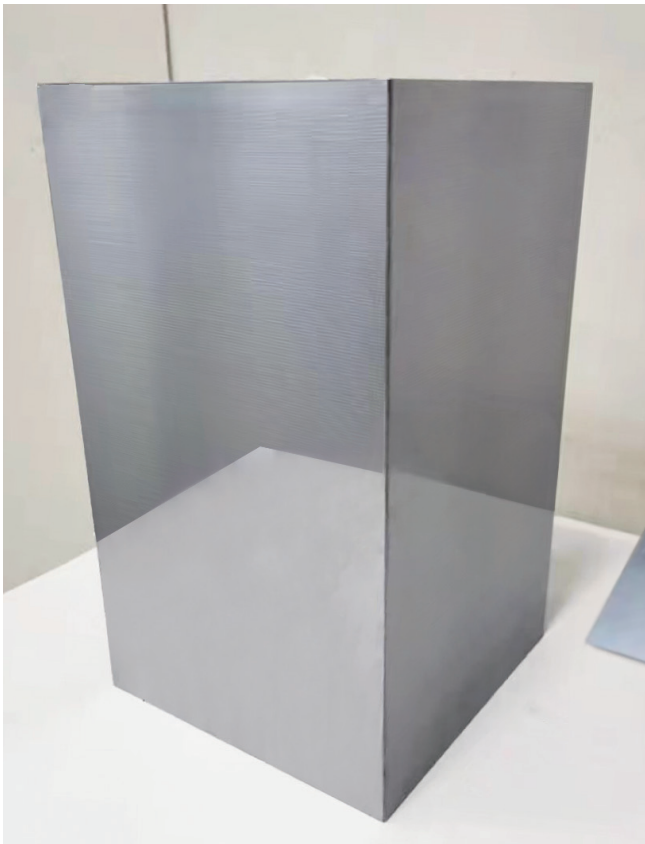
