主席報告

Chairman's Statement

集團業績

本人欣然提呈集團截至二零二一年三月三十一日止年度的全年業績。本財政年度是充滿挑戰的一年,因為COVID-19疫情大流行(「疫情大流行」)不僅對大中華地區而且對所有國際市場都產生了負面影響,導致全球經濟和貿易活動中斷。儘管逆風,集團的虧損收窄。我們已盡力控制開支以盡量減少損失。最近幾個月,我們見證了香港和中國市場的改善。

化挑戰為機遇

中國內地國內生產總值及社會消費品零售總額於本財政年度下半年恢復正增長,至今仍保持增長勢頭。鑑於中國人可支配收入的不斷增加和健康意識的不斷提高,加上中國政府最新的「十四五」規劃中倡導促進體育與健康,我們看好運動服裝市場行業的前景,這比其他服裝行業更具彈性。

由於受到疫情大流行的影響,在本財政年度, 我們的收入下跌19.9%。通過分析我們行業在 利潤率方面使用的關鍵指標,整體毛利率增 加及庫存周轉天數減少。疫情大流行讓電商 變得更加重要,形成了新的消費趨勢。因此, 我們將繼續努力投資於在線平台和社交媒體。

集團在全球擁有美國品牌「Ashworth」和法國品牌「Guy Laroche」。這兩個商標都得到了全世界的認可。此外,YGM自二零一一年起成為瑞典時尚品牌「J.Lindeberg」的香港獨家經銷商。

Ashworth

「Ashworth」是標誌性的高爾夫服裝品牌。當前的趨勢是更前衛的生活方式和更多技術服裝,「Ashworth」可以從中受益。規劃將更加註重中國市場的拓展。在美國和歐洲,由於疫情大流行和旅行限制,擴張計劃被推遲。

Guy Laroche

由於去年疫情大流行對歐洲造成了沉重打擊, 我們大幅減少了開支,並允許我們的被許可 人做出一些讓步。因此,記錄了少量虧損。

J.Lindeberg

港澳市場受疫情大流行影響,全年重點控制 成本、減少庫存天數及提高銷售效率。門店 數量減少,但門店整合反映了市場趨勢,整 個部門將更加健康。

印刷業務

儘管在疫情大流行期間面臨業務活動減少, 但香港安全印刷仍然有利可圖。

Group Results

I am pleased to present the Group's final results for the year ended 31 March 2021. The financial year was a challenging year as the COVID-19 Pandemic (the "Pandemic") negatively impacted not only in the Greater China region but across all international markets, causing disruption to the economic and trade activities across the globe. Despite the headwinds, the Group's losses had narrowed. We had tried our best to contain expenses to minimise our losses. In the recent months, we had witnessed improvements in the Hong Kong and China markets.

Turn Challenges into Opportunities

The GDP of Mainland China and the total retail sales of consumer goods resumed positive growth in the second half of the financial year and the momentum is still continuing to date. Given the continual increase in disposable income and the rising health awareness of the Chinese people, coupled with the Chinese government's advocacy to promote sports and health in their latest 14th Five-Year Plan, we are optimistic about the prospects of the sportswear market industry, which has been more resilient than the rest of the apparel industry.

Due to the impact of the Pandemic, during the financial year our revenues dropped by 19.9%. Upon analysis of key metrics used in our industry on the margin side, the overall gross profit margin increased and inventory turnover days decreased. The Pandemic has made e-commerce more important and formed a new consumption trend. Thus, we will continue to strive to invest in online platforms and social media.

The Group owns globally Ashworth, an American label, and Guy Laroche, a French label. Both labels have worldwide recognition. In addition, YGM is the sole and exclusive Hong Kong distributor for J.Lindeberg, a Swedish fashion brand, since 2011.

Ashworth

Ashworth is an iconic golf wear label. The current trend is more forwards active lifestyle with more technical garment, from which Ashworth can benefit. Planning will be more emphasized on China market expansion. In the USA and Europe, expansion plan was postponed because of the Pandemic and the limitation on travels.

Guy Laroche

As the Pandemic hit Europe hard last year, we reduced expenses drastically and allowed some concessions for our licensees. Consequently, a small loss is recorded.

J.Lindeberg

Hong Kong and Macau markets have been impacted by the Pandemic and the focus throughout the year was on controlling costs, reducing inventory days and improving sales efficiency. The number of outlets reduced but stores consolidation reflects the market trend and it will be healthier for the division overall.

Printing

Hong Kong security printing remains profitable although facing reduced business activities during the Pandemic.

Chairman's Statement

物業

本集團在倫敦擁有一處商業物業,由於倫敦市中心大部分地區處於封鎖狀態,疫情大流行的影響導致高層辦公室空置及零售層面餐廳業務的租金減少。我們預計情況會在截至二零二二年三月三十一日止的年度有所改善,因為我們的餐廳租戶已續約,並且租金收入增加。香港工業處所貢獻穩定收入。

年結後,一間由本集團擁有80%權益的附屬公司以現金代價52,000,000港元出售位於香港九龍油塘的工業物業。

前景

隨著中國內地的持續改善,我們計劃在「Ashworth」加快擴張。在本財政年度,我們與美國的「Ashworth」簽訂了新的許可協議,並希望在海外逐步發展業務。集團的重點將放在中國,並在未來三個財政年度為「Ashworth」制定重大擴張計劃。我們預計商業活動的恢復經濟出現積極增長,進而有利於消費領域。香港市場近期有所改善。進一步擴張將取決於租賃談判,公司對此持保守態度。

Property

The Group owns a commercial property in London which suffered vacancy in the upper floor office and the reduced rent from restaurant business on the retail levels due to the impact of the Pandemic as majority of Central London is under lockdown. We anticipate the situation to improve in the year ending 31 March 2022 as our restaurant tenant has renewed their lease with increase in rental income. Hong Kong industrial premises had contributed steady income.

After the year end, an 80% owned subsidiary of the Group had disposed of an industrial premise at Yau Tong, Kowloon, Hong Kong for a cash consideration of HK\$52,000,000.

Outlook

With continued improvement in Mainland China, we are planning faster expansion in Ashworth. During the financial year, we have entered into a new license agreement of Ashworth in the USA and looked to grow the business gradually overseas. The Group's focus will be on China with significant expansion plans for Ashworth in the coming three financial years. We anticipate that resumption of business activities and gradual recovery of consumer sentiment will lead to positive economic growth in Mainland China which will in turn be beneficial to the consumer sector. Hong Kong market shows some improvements. Further expansion will depend on lease negotiation and the company is conservative in such.

On behalf of the Board of Directors, I would like to express my sincere gratitude to all shareholders for their continued support and to express our gratitude to all employees who have contributed to our growth during this difficult period.

集團經營業績

由於本集團所有業務分部於回顧年度內均受到COVID-19疫情大流行(「疫情大流行」)的影響,本集團年內收益下跌19.9%至216,181,000港元(二零二零年:269,818,000港元)。由於管理層致力控制成本及存貨,整體毛利率上升至63.0%(二零二零年:51.6%),總營運開支減少41.6%至169,600,000港元(二零二零年:290,599,000港元)。本年度經營虧損減少至6,960,000港元(二零二零年:154,540,000港元),經已計入與疫情大流行有關的政府補助收入合共15,033,000港元(二零二零年:無)及索賠撥備9,570,000港元(二零二零年:無)。

Results of the Group's Operations

The Group's revenue for the year dropped by 19.9% to HK\$216,181,000 (2020: HK\$269,818,000) since all business segments of the Group was affected by the COVID-19 pandemic (the "Pandemic") during the year under review. With the effort of the management spent on cost and inventory control, overall gross profit margin increased to 63.0% (2020: 51.6%) and total operating expenses reduced by 41.6% to HK\$169,600,000 (2020: HK\$290,599,000). Loss from operations for the year decreased to HK\$6,960,000 (2020: HK\$154,540,000) after having accounted for government grant income related to the Pandemic totaling HK\$15,033,000 (2020: HK\$Nil) and a provision for claims of HK\$9,570,000 (2020: HK\$Nil).

Management Discussion and Analysis

年內,本公司權益股東應佔虧損為11,740,000 港元(二零二零年:87,125,000港元),包括投資物業的估值淨收益3,178,000港元(二零二零年:虧損35,242,000港元)及註銷遞延稅項資產4,287,000港元(二零二零年:20,811,000港元)。去年錄得回撥潛在中國關稅及彌償保證負債撥備126,495,000港元。

截至二零二一年三月三十一日止年度,本集團的淨營運現金流入為28,461,000港元(二零二零年:淨營運現金流出14,896,000港元)。於二零二一年三月三十一日,存貨為35,443,000港元,較去年底減少24,355,000港元。

於二零二一年三月三十一日,本集團扣除銀行透支後的現金及銀行結存為133,559,000港元(二零二零年:146,011,000港元),較去年底減少12,452,000港元。於二零二一年三月三十一日,本集團持有作買賣用途之證券公允價值為16,475,000港元(二零二零年:18,408,000港元)。

年內,本集團用於添置及更換其他物業、廠房及設備扣除使用權資產的支出約1,089,000港元,而去年則為41,128,000港元。

本集團財務狀況

本集團通過內部產生的現金流量和其往來銀 行給予的銀行融資為其業務提供資金。本集 團在管理財務需求方面會繼續保持審慎的態度。

截至二零二一年三月三十一日,本集團的淨資產為558,928,000港元(二零二零年:557,834,000港元)。本集團於年末之資本負債比率為0.153(二零二零年三月三十一日:0.210),乃按總借貸8,864,000港元及租賃負債73,756,000港元(二零二零年三月三十一日:總借貸7,485,000港元及租賃負債105,991,000港元)及股東權益538,886,000港元(二零二零年三月三十一日:538,095,000港元)計算。本集團之借貸主要按浮動息率計算。

業務回顧

成衣總銷售額為160,402,000港元(二零二零年:201,550,000港元),年內錄得溢利。截至二零二一年三月底,本集團於經營市場擁有由81個銷售點組成的分銷網絡,當中有38個銷售點在香港,5個銷售點在澳門,31個銷售點在中國內地及7個銷售點在台灣,比較二零二零年三月底淨減少5個銷售點。本集團將繼續審慎地擴張分店網絡。

本集團擁有「Guy Laroche」及「Ashworth」之全球知識產權。本年度來自外界客戶之特許商標收益總額為17,820,000港元(二零二零年: 26,042,000港元),分部年內錄得溢利。

Loss attributable to the equity shareholders of the Company for the year was HK\$11,740,000 (2020: HK\$87,125,000) included net valuation gains on investment properties of HK\$3,178,000 (2020: loss of HK\$35,242,000) and write-off of deferred tax assets of HK\$4,287,000 (2020: HK\$20,811,000). A reversal of provision for potential PRC customs duties and indemnity liabilities of HK\$126,495,000 was recorded in last year.

For the year ended 31 March 2021, the Group generated net cash inflow of HK\$28,461,000 (2020: net cash outflow of HK\$14,896,000) from operations. Inventories as at 31 March 2021 was HK\$35,443,000, a decrease of HK\$24,355,000 from the previous year end.

As at 31 March 2021, the Group had cash and bank deposits net of bank overdrafts of HK\$133,559,000 (2020: HK\$146,011,000), representing a decrease of HK\$12,452,000. At 31 March 2021, the Group had trading securities with fair value of HK\$16,475,000 (2020: HK\$18,408,000).

During the year, the Group spent approximately HK\$1,089,000 in additions and replacement of other property, plant and equipment excluding right-of-use assets, compared to HK\$41,128,000 for the previous year.

Group's Financial Position

The Group financed its operations by internally generated cashflows and banking facilities provided by its bankers. The Group continues to maintain a prudent approach in managing its financial requirements.

The Group's net assets as at 31 March 2021 were HK\$558,928,000 (2020: HK\$557,834,000). The Group's gearing ratio at the end of the year was 0.153 (31 March 2020: 0.210) which was calculated based on total borrowings of HK\$8,864,000 and leases liabilities of HK\$73,756,000 (31 March 2020: total borrowings of HK\$7,485,000 and leases liabilities of HK\$105,991,000) and shareholders' equity of HK\$538,886,000 (31 March 2020: HK\$538,095,000). The Group's borrowings are mainly on a floating rate basis.

Operations Review

Total segment sales of garment was HK\$160,402,000 (2020: HK\$201,550,000) and recorded a profit for the year. As at the end of March 2021, the Group has a distribution network of 81 points of sales ("POSs") in the Group's operating market comprising 38 POSs in Hong Kong, 5 POSs in Macau, 31 POSs in Mainland China and 7 POSs in Taiwan. A net decrease of 5 POSs in total POSs from the end of March 2020. The Group will remain prudent with regard to store network expansion.

The Group owns the global intellectual property rights of Guy Laroche and Ashworth. Total income of licensing of trademarks from external customers was HK\$17,820,000 (2020: HK\$26,042,000) and this segment recorded a profit for the year.

Management Discussion and Analysis

於二零二一年三月三十一日,本集團分別於香港及倫敦持有若干物業持作收租,總公允價值為265,024,000港元(二零二零年:243,112,000港元),以及一座位於香港持作自用的工業大廈,賬面淨值為6,688,000港元(二零二零年:7,214,000港元)。目前,該工業大廈全部由安全印刷分部使用。

儘管安全印刷分部的銷售較上年錄得下跌, 分部溢利超越上年。

展望

儘管本集團成衣銷售主要業務市場有改善跡象,但門店網絡的進一步擴張將取決於租賃合約談判,本集團對此持保守態度。管理層預期業務活動的恢復及消費意欲的逐步復甦將帶動中國內地的經濟正增長,進而有利於消費行業。因此,未來幾年,集團將專注於中國內地市場,並為集團的核心品牌「Ashworth」制定重大擴張計劃。

法律及法規

有關工作場所質素、產品安全和環保表現的 法律及法規可能對本集團的主要業務產生重 大影響。

工作場所質素

本集團認為持續業務成功有賴於本集團僱員 全力貢獻和支持。本集團致力在不同範疇為 所有僱員推廣平等機會,當中包括招聘、薪 酬及福利、培訓、晉升機會、調職和解僱。本 集團乃根據所有僱員的能力、表現和貢獻來 進行評估,而不論其國籍、種族、宗教信仰、 性別、年齡或家庭狀況。

本集團遵守勞工或其他相關法例,並沒發現 任何重大地不遵守或違反有關工作場所質素 之法例。

產品安全

本集團致力維持高度環保標準,以滿足根據 適用法律或條例在製造及處置材料過程中的 規定。 As at 31 March 2021, the Group holds certain properties held for rental in Hong Kong and London respectively with total fair value of HK\$265,024,000 (2020: HK\$243,112,000) and an industrial building held for own use in Hong Kong with a net book value of HK\$6,688,000 (2020: HK\$7,214,000). Currently, the said industrial building is wholly occupied by security printing section.

Despite security printing section recorded a decrease in sales from the previous year, its segment profit surpassed that of the previous year.

Outlook

Despite the Group's principal business market of sales of garments shows sign of improvement, further expansion in store network will depend on lease negotiation and the Group is conservative in such. The management anticipates that resumption of business activities and gradual recovery of consumer sentiment will lead to positive economic growth in Mainland China, and in turn will be beneficial to the consumer sector. Thus, the Group will focus on Mainland China market with significant expansion plans for Ashworth, the Group's core brand, in coming years.

Law and Regulations

Law and regulations in relation to workplace quality, product safety and environmental performance may have a material effect on the Group's principal activities.

Workplace Quality

The Group believes that continued business success relies on the full contribution and support of our employees. We are dedicated to promoting equal opportunities for all of our employees in different areas, including recruitment, compensation and benefits, training, staff promotion, transfer, and dismissal. All employees are assessed based on their ability, performance and contribution, irrespective of their nationality, race, religion, gender, age or family status.

The Group is committed to the health, safety and welfare of our employees. We pledge full compliance in all occupational health and safety legislations and we have implemented an effective and safe working environment for our employees.

We complied with labour or other relevant legislations. We did not identify any material non-compliance or breach of legislation related to workplace quality.

Product Safety

The Group places the highest importance on the welfare of its customers globally, as well as on its broader societal and environmental impact. The quality and safety of our products is a vital part of this.

All products are safe and fully adhere to international environmental and safety standards. We did not identify any material non-compliance or breach of legislation related to product safety.

Environmental Performance

The Group is committed to protecting and sustaining the environment through reduced consumption of electrical power.

We are committed to upholding high environmental standards to fulfill relevant requirements under applicable laws or ordinances during the manufacturing and material disposal processes.

二零二零年的COVID-19爆發顛覆了世界各地的經濟。對病毒的擔憂和旅行限制繼續限制了包括香港在內的亞太地區依賴旅遊業的經濟體的經濟活動。儘管區域增長在二零二一年初有所反彈,但各國的復蘇速度有所不同。事實上,只有中國內地的產量超過了疫情大流行前的水平。

本集團的主要業務活動為品牌服裝及配飾的 零售及批發,涉及面向消費者的活動。儘管 二零二一年第一季度零售額同比增長,但仍 遠低於疫情大流行前的水平,因為在全球尤 其是中國內地的旅行限制下,入境旅遊仍處 於凍結狀態。中美關係、地緣政治緊張等其 他風險因素也值得關注。

貨幣市場

本集團的貨幣風險主要是來自香港以外的投資。 本集團的業績以港元入賬,但其香港以外的 附屬公司以其他貨幣收取收益及承擔費用。 此等附屬公司換算業績的過程中或在撥回盈利、 股權投資和貸款時,如果出現任何貨幣匯率 變動,均可能影響本集團的業績。

地方、國家和國際法規的影響

Social Performance

The Group has long been committed to being a responsible corporate citizen and actively supports various charitable organisations and groups. We encourage staff to join our "YGM Volunteer Team" and participated in various charitable activities to help people in need, demonstrating its corporate social responsibility and promoting the caring culture in the society.

Principal Risks and Uncertainties

Risks and uncertainties can affect the Group's businesses, financial conditions, operational results or growth prospects leading to a divergence from expected or historical results. Key risk factors and uncertainties affecting the Group are outlined below. In dealing with these risk factors and uncertainties, the Group remains in touch with our stakeholders with the aim of understanding and addressing their concerns.

These factors are not exhaustive or comprehensive, and there may be other risks in addition to those shown below which are not known to the Group or which may not be material now but could become material in the future.

Global Economy and Macro-economic Conditions

The COVID-19 outbreak in 2020 has upended economies around the world. Concerns about the virus and travel restrictions continue to limit economic activity in tourism-dependent economies of the Asia-Pacific region including Hong Kong. Although regional growth has bounced back in early 2021, the speed of recovery has differed among countries. In fact, only Mainland China has seen its output surpass pre-pandemic levels.

The principal business activities of the Group are retailing and wholesaling of branded garments and accessories, involving consumer-oriented activities. Even though retail sales volume increased in the first quarter of 2021 on a year-on-year basis, it was still far below the pre-pandemic level as inbound tourism remained frozen amid travel restrictions worldwide, especially of Mainland China. Other risk factors such as China-US relations and geopolitical tensions also warrant attention.

Currency Markets

The Group's currency exposure mainly arises from its investments outside Hong Kong. The results of the Group are recorded in Hong Kong dollars, however its subsidiaries outside Hong Kong receive revenue and incur expenses in other currencies. Any currency fluctuations that occur during the progress of translation of the results of these subsidiaries or during the repatriation of earnings, equity investments and loans may have an impact on the Group's results.

Impact of Local, National and International Regulations

Local business risks specific to individual countries and cities where the Group operates could have a material impact on its financing conditions, operating results and growth prospects.

Management Discussion and Analysis

New policies or measures by governments, whether fiscal, tax or regulatory, may pose a risk to the returns delivered by the Group's business and may delay or prevent the commercial operational of an individual business, with a resulting loss in revenue and profit.

The Group has taken a proactive approach to monitoring changes in government policies and legislation. Adequate risk mitigation measures are in place and are constantly reviewed for enhancement.

Employment and Remuneration Policies

As at 31 March 2021, the Group had approximately 400 employees (31 March 2020: 440 employees). The Group offers competitive remuneration packages including medical subsidies and retirement scheme contributions to its employees in compensation for their contribution. In addition, discretionary bonuses may also be granted to the eligible employees based on the Group's and individuals' performances.

Relationship with Suppliers

Fair and Open Competition

The Group promotes fair and open competition that aims to develop long-term relationships with suppliers based on mutual trust.

The Group believes in the economic system of the free market, in which price is determined by supply and demand. The Group also seeks to provide customers with the highest quality products at fair prices which allow the Group a reasonable profit in relation to the value provided.

Important Event After the End of The Reporting Period

Except for the completion of the disposal of an investment property in Hong Kong to an independent third party at a cash consideration of HK\$52,000,000 on 23 June 2021, there is no important event affecting the Group which has occurred since the end of the reporting period.

董事會

於二零二一年三月三十一日,董事會包括六名執行董事及三名獨立非執行董事。獨立非執行董事的數目根據上市規則第3.10A條須至少為董事會成員的三分之一。獨立非執行董事帶來多方面的專業知識、技能和經驗,為本集團提供有效指引,並為本集團面對的所有重大決策帶來局外的觀點。

董事會、審核委員會、薪酬委員會、提名委員 會及風險管理委員會曾於回顧年度分別舉行 了四次、三次、一次、一次及一次會議。 The board of directors (the "Board") of the Company is dedicated to uphold a high corporate governance standard. The Board firmly believes that the principles of transparency, accountability and independence are essential for protecting the interests of the Company and maximising shareholder value.

The Company has complied with the code provisions in the Corporate Governance Code (the "Code") set out in Appendix 14 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Stock Exchange") (the "Listing Rules") throughout the financial year ended 31 March 2021, except for the deviation from code provision A.4.1 of the Code, pursuant to which the non-executive directors of the Company should be appointed for a specific term, subject to re-election. The non-executive directors of Company are not appointed for a specific term but are subject to retirement by rotation and re-election requirements at the annual general meeting of the Company in accordance with Articles 96 and 105 of the Company's articles of association.

Board of Directors

The Board is committed to act in good faith in the best interests of the Company and its shareholders. The Board sets overall objectives and strategic directions of the Company and its subsidiaries (collectively "the Group"), monitors and evaluates its operating and financial performance. It also decides on matters relating to annual and interim results, audited financial statements, notifiable transactions, appointment and re-appointment of directors, major acquisitions and disposals, material contracts, risk management, major financings and borrowings, accounting and dividends policies. The Board delegates day-to-day operations of the Company to the management of the Group and also instructs the management to implement the Board's decisions and resolutions. In addition, the Board has also delegated various responsibilities to the Audit Committee, the Remuneration Committee, the Nomination Committee and the Risk Management Committee.

As at 31 March 2021, The Board comprises six executive directors and three independent non-executive directors. The number of independent non-executive directors represents at least one-third of the Board in accordance with Rule 3.10A of the Listing Rules. The independent non-executive directors bring a diverse range of expertise, skills and experience to provide effective guidance and an outside perspective to all major decisions of the Group.

Details of backgrounds and qualifications of the directors as well as relationships between them are set out in the section of "Directors and Management".

The Board, Audit Committee, Remuneration Committee, Nomination Committee and Risk Management Committee had held 4, 3, 1, 1 and 1 meetings respectively in the year under review.

Corporate Governance Policy and Duties

The Board is committed to ensure that at good corporate governance framework and practices are established within the Group. The Board is responsible for performing the duties on corporate governance functions as required under code provision D.3.1 of the Code which are set out below:

- developing and reviewing the Company's policies and practices on corporate governance and making recommendations to the board;
- reviewing and monitoring the training and continuous professional development of directors and senior management;
- reviewing and monitoring the Company's policies and practices on compliance with legal and regulatory requirements;
- (4) developing, reviewing and monitoring the code of conduct and compliance manual (if any) applicable to employees and directors; and
- (5) reviewing the Company's compliance with the Code and disclosure in the Corporate Governance Report.

Chairman and Chief Executive Officer

The Chairman of the Board is Mr. Chan Wing Sun, Samuel and the Chief Executive Officer of the Company is Mr. Fu Sing Yam, William. The roles of the Chairman of the Board and the Chief Executive Officer of the Company are separated, with a clear division of responsibilities. The Chairman of the Board is responsible for formulating corporate strategies and overall business development planning. The Chief Executive Officer's duty is to oversee the execution of daily business activities. The division of responsibilities at the Board level is to ensure a balance of power and authority.

Directors' Training

According to code provision A.6.5 of the Code, all directors should participate in continuous professional development to develop and refresh their knowledge and skills to ensure that their contribution to the Board remains informed and relevant. The Company should be responsible for arranging and funding suitable training, placing an appropriate emphasis on the roles, functions and duties of the directors. The Company provides tailored induction programme to new director upon his appointment to equip him with the appropriate understanding of the business and operations of the Group and to ensure that he is fully aware of his responsibilities and obligations under the relevant law and the Listing Rules.

During the year, the Company organized one in-house seminar to update the Directors on the new amendments to the corporate governance code and relevant Listing Rules. The Company circulates materials relating to the legislative and regulatory environment to the directors on a regular basis for their information. The Company also encourages directors to attend relevant seminars, conferences or forums to develop and refresh their knowledge and skill. During the year, all directors participated in continuous professional development in compliance with code provision A.6.5 of the Code.

審核委員會主要負責監管本公司財務報表的完整性,透過檢討內部和外聘核數師進行的工作審閱本公司內部監控制度及其執行情况、評估財務資料及有關披露、審閱關連交易及考慮本公司於會計及財務匯報職能方面的資源、員工資歷及經驗是否足夠,以及員工所接受的培訓課程及有關預算是否充足。

於本年度內,董事會並無與審核委員會意見 不合,亦無拒絕接納審核委員會提交之任何 建議。

Directors' Insurance

During the year, the Company has arranged for the renewal of an insurance policy on directors' and officers' liability to ensure our directors and senior management are protected from any liability arising from the performance of their duties.

Board Committees

The Board has established the Audit Committee, the Remuneration Committee, the Nomination Committee and the Risk Management Committee, each with mandate to oversee particular aspects of the affairs of the Company. Each of these four Board committees is set up with written terms of reference. The Board committees are provided with sufficient resources to discharge their duties and are able to seek independent professional advice in appropriate circumstance at the expenses of the Company.

Audit Committee

The Company has established an Audit Committee with written terms of reference. As at 31 March 2021, the Audit Committee comprises three independent non-executive directors, namely Mr. Choi Ting Ki, Mr. So Stephen Hon Cheung and Mr. Li Guangming. It is chaired by Mr. So Stephen Hon Cheung. The members' attendance to the Audit Committee meeting is listed out on page 11.

The Audit Committee is mainly responsible for monitoring the integrity of the Company's financial statements, reviewing the Company's internal control system and its execution through the review of the work undertaken by the internal and external auditors, evaluating financial information and related disclosure, reviewing connected transactions and considering the adequacy of resources, qualifications and experience of staff of the Company's accounting and financial reporting function, and their training programmes and budget.

During the year ended 31 March 2021, the Audit Committee has, inter alia, reviewed and discussed with management and the external auditor the interim and annual results with a view to ensuring that the Group's financial statements were prepared in accordance with accounting principles generally accepted in Hong Kong. The Audit Committee has met with external auditor twice a year, in the absence of management, to discuss any issues arising from the audit and any other matters the auditor may wish to raise. The Audit Committee has also reviewed the independence and quality of work of KPMG and has recommended to the Board to re-appoint KPMG as auditor for the year ending 31 March 2022.

During the year, the Board has not taken any view that is different from that of the Audit Committee nor rejected any recommendation presented by the Audit Committee.

The Risk Management Committee is responsible for coordinating risk management activities, and to report at least annually to the Board. However, the Group's risk management and internal control systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and only provide reasonable and not absolute assurance against material misstatement or loss.

Our approach to manage risks involves identification and assessment of principal risks from the external and internal environments at different organisation levels. The assessment considers the changes in nature and extent of significant risks and the Group's ability to respond to changes in its business and the external environment. Action plans have been developed and risk ownership has been assigned for each key principal risk. The risk owners coordinate the mitigation measures to ensure proper implementation of these action plans. The process is closely monitored by the Risk Management Committee.

Taken into consideration the principal risks and mitigation actions, the Board believes that the Company has the ability to respond to any such changes in our business and the external environment, and considers that the Group's risk management and internal control system was effective and adequate.

Regarding the disclosure of inside information, the Board had implemented procedures and internal controls for handling and dissemination of inside information so that potential inside information can be promptly identified and escalated up for deciding whether an announcement should be made in order to ensure compliance with the continuous obligations under the Listing Rules and the statutory obligation to disclose information under the Securities and Futures Ordinance ("SFO").

Internal Audit Function

During the year under review, the Board has engaged an external consultant to perform internal audit services. The external consultant has assisted the Group to perform a review of the effectiveness of internal controls system for certain selected processes. 意見

本核數師(以下簡稱「我們」)已審計列載於第 39頁至第111頁的YGM貿易有限公司(「貴公司」) 及其附屬公司(統稱「貴集團」)的綜合財務報表, 此財務報表包括於二零二一年三月三十一日 的綜合財務狀況表與截至該日止年度的綜合 損益表、綜合損益及其他全面收益表、綜合 權益變動表和綜合現金流量表,以及綜合財 務報表附註,包括主要會計政策概要。

我們認為,該等綜合財務報表已根據香港會計師公會頒布的《香港財務報告準則》真實而中肯地反映了 貴集團於二零二一年三月三十一日的綜合財務狀況及截至該日止年度的綜合財務表現及綜合現金流量,並已遵照香港《公司條例》妥為擬備。

意見的基礎

Independent auditor's report to the members of YGM Trading Limited

(Incorporated in Hong Kong with limited liability)

Opinion

We have audited the consolidated financial statements of YGM Trading Limited ("the Company") and its subsidiaries ("the Group") set out on pages 39 to 111, which comprise the consolidated statement of financial position as at 31 March 2021, the consolidated statement of profit or loss, the consolidated statement of profit or loss and other comprehensive income, the consolidated statement of changes in equity and the consolidated cash flow statement for the year then ended and notes to the consolidated financial statements, including a summary of significant accounting policies.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 March 2021 and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and have been properly prepared in compliance with the Hong Kong Companies Ordinance.

Basis for opinion

We conducted our audit in accordance with Hong Kong Standards on Auditing ("HKSAs") issued by the HKICPA. Our responsibilities under those standards are further described in the *Auditor's responsibilities for the audit of the consolidated financial statements* section of our report. We are independent of the Group in accordance with the HKICPA's *Code of Ethics for Professional Accountants* ("the Code") and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Key audit matters

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

Impairment of property, plant and equipment and right-of-use assets of retail stores

Refer to note 11 to the consolidated financial statements and accounting policies in note 1(j)(ii).

The Key Audit Matter

Local economic conditions affect customer numbers and spending power such that the revenue generated from each retail store fluctuates during the lease term. During the year ended 31 March 2021, certain of the Group's retail stores were underperforming which indicated the carrying amounts of the property, plant and equipment and right-of-use assets of these retail stores may not be recoverable and required assessment of impairment.

The recoverable amounts of cash generating units ("CGUs"), to which property, plant and equipment and right-of-use assets of these retail stores were allocated, were determined by management on a store-by-store basis based on the higher of fair values less costs of disposal or value-in-use calculations of these retail stores. In determining value-in-use, discounted cash flow forecasts are prepared by the management.

How the matter was addressed in our audit

Our audit procedures to assess the impairment of property, plant and equipment and right-of-use assets of retail stores included the following:

- comparing the actual results of the CGUs for the current year with the future revenue, future profit margin and forecasts adopted by management in the discounted cash flow forecasts for the prior year to assess the effectiveness of management's forecasting process, making enquiries of management as to the reasons for any significant variations identified and considering if there was any indication of management bias;
- assessing and challenging the Group's impairment assessment model. This included challenging management's identification of impairment indicators and CGUs;

由於當地經濟狀況會影響客戶數量和消費能力,故各零售商店的銷售趨勢可能會於有關零售商店的租賃期內有所變動。截至二零二一年三月三十一日止年度,貴集團旗下部分零售商店的表現不佳,顯示有關商店的物業、廠房及設備及使用權資產的賬面值未必可以收回,故須作出減值評估。

與物業、廠房及設備有關的現金產生單位及零售商店分配的使用權資產的可收回金額乃由管理層依據個別零售商店公允值減出售成本與計算使用價值兩者之較高者釐定。於計算使用價值時,管理層編製折現現金流量的預測。

我們的審計如何處理該事項

我們就評估零售商店的物業、廠房及設備及使用權資 產的減值的審計程序包括以下程序:

- 將本年度現金產生單位的實際業績對比管理層在 往年度就折現現金流量預測所採納的未來收益、 未來毛利率及預測數據,以評估管理層預測過程 的有效性,並就發現之任何重大差異向管理層提 問及評估管理層是否存在偏見跡象;

Impairment of property, plant and equipment and right-of-use assets of retail stores

The Key Audit Matter

We identified the impairment of property, plant and equipment and right-of-use assets of retail stores to be a key audit matter because future cash flows and profits of the retail stores are inherently uncertain and the significant judgements and estimates used in the impairment assessments.

How the matter was addressed in our audit

- evaluating the key assumptions used in the discounted cash flow forecasts prepared by management by comparing significant inputs such as future revenue and future profit margin of the respective retail stores with the historical performance of respective retail stores and other available third-party information;
- evaluating the discount rates used in the discounted cash flow forecasts by benchmarking against other comparable companies in the market;
- performing sensitivity analysis of the future revenue and discount rates adopted in the discounted cash flow forecasts prepared by management and assessing the impact of changes in the key assumptions to the conclusion reached in the impairment assessment; and
- considering the reasonableness of the Group's disclosures in the consolidated financial statements in respect of impairment testing of property, plant and equipment and right-of-use assets of retail stores, with reference to the requirements of the prevailing accounting standards.

- 通過比較市場上其他可比較公司,評估折現現金 流量預測中使用的折現率;

Impairment of intangible assets with indefinite useful lives

Refer to note 12 to the consolidated financial statements and accounting policies in note 1(j)(ii).

The Key Audit Matter

As at 31 March 2021, the Group's intangible assets with indefinite useful lives amount to HK\$133,442,000, which represent trademarks acquired by the Group in prior years.

The recoverable amounts of the CGUs to which trademarks were allocated, which are the higher of the fair value less costs of disposal and their value-in-use, are estimated annually whether or not there is any indication of impairment.

In order to determine the recoverable amounts, management prepared discounted cash flow forecasts and engaged an external valuer to assess the valuations of the trademarks. The discounted cashflow forecasts used to assess the risk of impairment is based on a number of key assumptions, including estimations of future revenue, terminal growth rates and the discount rates applied.

We identified the impairment of intangible assets to be a key audit matter because the preparation of discounted cash flow forecasts involves significant management judgement, which could be subjective.

How the matter was addressed in our audit

Our audit procedures to assess whether impairment of intangible assets with indefinite useful lives included the following:

- assessing and challenging the Group's impairment assessment model, including management's identification of the CGUs;
- comparing the actual results of the CGUs for the current year with the forecasts adopted by management in the discounted cash flow forecasts for the prior year to assess the effectiveness of management's forecasting process, making enquiries of management as to the reasons for any significant variations identified and considering if there was any indication of management bias;
- obtaining and inspecting the valuation reports prepared by the external valuer engaged by the Group and assessing the independence, qualifications, expertise and objectivity of the independent external valuer;

Net realisable value of inventories

Refer to note 15 to the consolidated financial statements and the accounting policies in note 1(k).

The Key Audit Matter

As at 31 March 2021, the inventories of the Group amounted to HK\$35,443,000. Inventories are carried at the lower of cost and net realisable value ("NRV") in the consolidated financial statements of the Group.

Sales of inventories in the fashion industry can be volatile due to changing fashion trends, consumer demand and economic conditions.

The changing tastes and patterns of consumption of customers require the Group to periodically review its inventory portfolio and dispose of off-season inventories at a markdown from the original price to maintain the strength of the brands and make room for new season inventories in its retail stores. Accordingly, the selling prices of some items of inventories may fall below their purchase costs.

The Executive Director and senior members of the sales team review the full inventory list regularly to identify inventories which may need to be discounted in order to increase their chances of being sold. Key data used in this review process includes sales volume history and ageing patterns of inventories.

How the matter was addressed in our audit

Our audit procedures to assess the valuation of inventories included the following:

- assessing whether the inventory provision at the reporting date was consistent with the Group's inventory provisioning policy by recalculating the inventory provision based on the percentages of inventory costs and other parameters in the Group's inventory provision policy;
- assessing, on a sample basis, whether items in the inventory ageing report were classified within the appropriate ageing bracket;
- assessing the Group's inventory provisioning policy by comparing management's forecasts of the amounts of inventories which will be unsold at the end of the reporting period with historical sales data for the current and prior years;

於二零二一年三月三十一日,貴集團的存貨為 35,443,000港元。存貨於 貴集團的綜合財務報表以成 本及可變現淨值兩者中之較低數額入賬。

消費者的需求會因應當時的流行趨勢,消費者需求和 零售狀況有所變化,令時裝業的存貨銷售受到波動。

為了維持品牌的實力和騰出零售店的空間供新一季的存貨之用, 貴集團一般會以低於原價出售或處置換季的存貨。因此,某些存貨項目的售價可能會低於其本身的採購成本。

執行董事及銷售團隊的高級人員定期審閱完整之存貨 清單,以確定可能需提供折扣之存貨,以增加其銷售 之機會。審閱過程中使用之關鍵資料包括各地區之銷 售量歷史數據及存貨之貨齡模式。

我們的審計如何處理該事項

我們就評估存貨估值的審計程序包括以下程序:

The Key Audit Matter

We identified the NRV of inventories as a key audit matter because significant judgements and assumptions are involved by management in estimating the amounts of inventories which will be unsold at the end of each season and the markdowns necessary to sell such off-season inventories on a discounted basis through outlets and other channels in the following years.

How the matter was addressed in our audit

- comparing the carrying amount of the inventories at the reporting date to their NRV by reviewing the sales of inventories subsequent to the reporting date;
- comparing inventory balances by season against respective balances in prior years and the movement by season against historical movements to identify inventories which are relatively slow moving; and
- enquiring of the Executive Director and senior members of the sales team about any expected changes in plans for markdowns or disposals of off-season inventories and comparing their representations with actual sales transactions subsequent to the reporting date.

(a) 遵例聲明

(b) 財務報表之編製基準

截至二零二一年三月三十一日止年 度之綜合財務報表涵蓋本公司及其 附屬公司(統稱「本集團」)。

除下文所載之資產按公允價值列賬外, 本財務報表是以歷史成本作為編製 所用之計量基準:

1 Significant accounting policies

(a) Statement of compliance

These financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("HKFRSs"), which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations issued by the Hong Kong Institute of Certified Public Accountant ("HKICPA"), accounting principles generally accepted in Hong Kong and the requirements of the Hong Kong Companies Ordinance. These financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules"). Significant accounting policies adopted by the Group are disclosed below.

The HKICPA has issued certain amendments to HKFRSs that are first effective or available for early adoption for the current accounting period of the Group. Note 1(c) provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current accounting period reflected in these financial statements.

(b) Basis of preparation of the financial statements

The consolidated financial statements for the year ended 31 March 2021 comprise the Company and its subsidiaries (together referred to as the "Group").

The measurement basis used in the preparation of the financial statements is the historical cost basis except that the following assets are stated at their fair value as explained in the accounting policies set out below:

- investment properties, including interests in leasehold land and buildings held as investment properties where the Group is the registered owner of the property interest (see note 1(f));
 and
- trading securities (see note 1(e)).

The preparation of financial statements in conformity with HKFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

本集團已於本財政年度提早採納二零二一年修訂。已收到的租金優惠已作為負可變租賃付款入賬,並於觸發這些付款的事件或條件發生期間計入損益(參閱附註第11項(c)),此舉對二零二零年四月一日權益期初餘額無影響。

(d) 附屬公司及非控股權益

附屬公司為本集團所控制之實體。 當本集團可通過參與實體之業務從 而承擔或享有變動之回報及有能力 運用其控制權以影響回報金額,則 本集團控制該實體。當評定本集團 是否有該等權利時,僅考慮(本集團 和其他方所持有的)實質權利。

(b) Basis of preparation of the financial statements (continued)

Judgements made by management in the application of HKFRSs that have significant effect on the financial statements and major sources of estimation uncertainty are discussed in note 2.

(c) Changes in accounting policies

The Group has applied the following amendment to HKFRSs issued by the HKICPA to these financial statements for the current and prior accounting periods:

Amendment to HKFRS 16, Covid-19-Related Rent Concessions beyond 30 June 2021 (2021 amendment)

The Group previously applied the practical expedient in HKFRS 16 such that as lessee it was not required to assess whether certain rent concessions occurring as a direct consequence of the COVID-19 pandemic are lease modifications, if the eligibility conditions are met (see note 1(i)). One of these conditions requires the reduction in lease payments affects only payments originally due on or before a specified time limit. The 2021 amendment extends this time limit from 30 June 2021 to 30 June 2022.

The Group has early adopted the 2021 amendment in this financial year. Rent concessions received have been accounted for as negative variable lease payments recognised in profit or loss in the period in which the event or condition that triggers those payments occurred (see note 11(c)). There is no impact on the opening balance of equity at 1 April 2020.

(d) Subsidiaries and non-controlling interests

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power, only substantive rights (held by the Group and other parties) are considered.

Investments in subsidiaries are consolidated into the consolidated financial statements from the date that control commences until the date that control ceases. Intra-group balances, transactions and cash flows and any unrealised profits arising from intra-group transactions are eliminated in full in preparing the consolidated financial statements. Unrealised losses resulting from intra-group transactions are eliminated in the same way as unrealised gains but only to the extent that there is no evidence of impairment.

Non-controlling interests represent the equity in subsidiary not attributable directly or indirectly to the Company, and in respect of which the Group has not agreed any additional terms with the holders of those interests which would result in the Group as a whole having a contractual obligation in respect of those interests that meets the definition of a financial liability. For each business combination, the Group can elect to measure any non-controlling interests either at fair value or at the non-controlling interests' proportionate share of the subsidiary's net identifiable assets.

Non-controlling interests are presented in the consolidated statement of financial position within equity, separately from equity attributable to the equity shareholders of the Company. Non-controlling interests in the results of the Group are presented on the face of the consolidated statement of profit or loss and the consolidated statement of profit or loss and other comprehensive income as an allocation of the total profit or loss and total comprehensive income for the year between non-controlling interests and the equity shareholders of the Company. Loans from holders of non-controlling interests and other contractual obligations towards these holders are presented as financial liabilities in the consolidated statement of financial position in accordance with notes 1(n) or (o) depending on the nature of the liability.

Changes in the Group's interests in a subsidiary that do not result in a loss of control are accounted for as equity transactions, whereby adjustments are made to the amounts of controlling and non-controlling interests within consolidated equity to reflect the change in relative interests, but no adjustments are made to goodwill and no gain or loss is recognised.

When the Group loses control of a subsidiary, it is accounted for as a disposal of the entire interest in that subsidiary, with a resulting gain or loss being recognised in profit or loss. Any interest retained in that former subsidiary at the date when control is lost is recognised at fair value and this amount is regarded as the fair value on initial recognition of a financial asset (see note 1(e)) or, when appropriate, the cost on initial recognition of an investment in an associate.

In the Company's statement of financial position, investment in subsidiaries are stated at cost less impairment losses (see note 1(j)(ii)).

(e) Other investments

The Group's policies for investments, other than investments in subsidiaries, are set out below.

Investments are recognised/derecognised on the date the Group commits to purchase/sell the investments. The investments are initially stated at fair value plus directly attributable transaction costs, except for those investments measured at fair value through profit or loss ("FVPL") for which transaction costs are recognised directly in profit or loss. For an explanation of how the Group determines fair value of financial instruments, see note 25(f)(i). These investments are subsequently accounted for as follows, depending on their classification:

Investments other than equity investments

Non-equity investments held by the Group are classified into one of the following measurement categories:

- amortised cost, if the investment is held for the collection of contractual cash flows which represent solely payments of principal and interest. Interest income from the investment is calculated using the effective interest method (see note 1(t)(v)).
- Fair value through other comprehensive income ("FVOCI") (recycling), if the contractual cash flows of the investment comprise solely payments of principal and interest and the investment is held within a business model whose objective is achieved by both the collection of contractual cash flows and sale. Changes in fair value are recognised in other comprehensive income, except for the recognition in profit or loss of expected credit losses, interest income (calculated using the effective interest method) and foreign exchange gains and losses. When the investment is derecognised, the amount accumulated in other comprehensive income is recycled from equity to profit or loss.
- FVPL if the investment does not meet the criteria for being measured at amortised cost or FVOCI (recycling). Changes in the fair value of the investment (including interest) are recognised in profit or loss.

(f) Investment properties

Investment properties are land and/or buildings which are owned or held under a leasehold interest (see note 1(i)) to earn rental income and/or for capital appreciation. These include land held for a currently undetermined future use and property that is being constructed or developed for future use as investment property.

Investment properties are stated at fair value, unless they are still in the course of construction or development at the end of the reporting period and their fair value cannot be reliably measured at that time. Any gain or loss arising from a change in fair value or from the retirement or disposal of an investment property is recognised in profit or loss. Rental income from investment properties is accounted for as described in note 1(t)(iii).

The following items of property held for own use, plant and equipment are stated at cost less accumulated depreciation and impairment losses (see note 1(j)(ii)):

- right-of-use assets arising from leases over freehold or leasehold properties where the Group is not the registered owner of the property interest (see note 1(i)); and

If a property becomes an investment property because its use has changed, any difference between the carrying amount and the fair value of that item at the date of transfer is recognised in other comprehensive income and accumulated in revaluation reserve. On the subsequent sale or retirement of the asset, the relevant revaluation reserve will be transferred directly to retained profits.

Depreciation is calculated to write off the cost of items of property, plant and equipment, less their estimated residual value, if any, using the straight-line method over their estimated useful lives as follows:

- Leasehold land is depreciated over the unexpired term of the lease.
- The Group's interests in buildings situated on leasehold land are depreciated over the shorter of the unexpired term of the lease and their estimated useful lives, being no more than 50 years after the date of completion.
- Plant and machinery

Leasehold improvements, motor vehicles, furniture and equipment

2 to 10 years

Where parts of an item of property, plant and equipment have different useful lives, the cost of the item is allocated on a reasonable basis between the parts and each part is depreciated separately. Both the useful life of an asset and its residual value, if any, are reviewed annually.

Gains or losses arising from the retirement or disposal of an item of property, plant and equipment are determined as the difference between the net disposal proceeds and the carrying amount of the item and are recognised in profit or loss on the date of retirement or disposal. Any related revaluation surplus is transferred from the revaluation reserve to retained profits and is not reclassified to profit or loss.

Trademark acquired and lease premium paid by the Group with an indefinite estimated useful life are stated at cost less impairment losses (see note 1(j)(ii)). Expenditure on internally generated brands is recognised as an expense in the period in which it is incurred.

Intangible assets are not amortised while their useful lives are assessed to be indefinite. Any conclusion that the useful life of an intangible asset is indefinite is reviewed annually to determine whether events and circumstances continue to support the indefinite useful life assessment for that asset. If they do not, the change in the useful life assessment from indefinite to finite is accounted for prospectively from the date of change and in accordance with the policy for amortisation of intangible assets with finite lives.

(i) Leased assets

At inception of a contract, the Group assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

(i) As a lessee

At the lease commencement date, the Group recognises a right-of-use asset and a lease liability, except for short-term leases that have a lease term of 12 months or less and leases of low-value assets. When the Group enters into a lease in respect of a low-value asset, the Group decides whether to capitalise the lease on a lease-by-lease basis. The lease payments associated with those leases which are not capitalised are recognised as an expense on a systematic basis over the lease term.

Where the lease is capitalised, the lease liability is initially recognised at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. After initial recognition, the lease liability is measured at amortised cost and interest expense is calculated using the effective interest method. Variable lease payments that do not depend on an index or rate are not included in the measurement of the lease liability and hence are charged to profit or loss in the accounting period in which they are incurred.

The lease liability is also remeasured when there is a change in the scope of a lease or the consideration for a lease that is not originally provided for in the lease contract ("lease modification") that is not accounted for as a separate lease. In this case the lease liability is remeasured based on the revised lease payments and lease term using a revised discount rate at the effective date of the modification. The only exceptions are any rent concessions which arose as a direct consequence of the COVID-19 pandemic and which satisfied the conditions set out in paragraph 46B of HKFRS 16 Leases. In such cases, the Group took advantage of the practical expedient set out in paragraph 46A of HKFRS 16 and recognised the change in consideration as if it were not a lease modification.

In the consolidated statement of financial position, the current portion of long-term lease liabilities is determined as the present value of contractual payments that are due to be settled within twelve months after the reporting period.

When a contract contains lease and non-lease components, the Group allocates the consideration in the contract to each component on a relative stand-alone selling price basis. The rental income from operating leases is recognised in accordance with note 1(t)(iii).

When the Group is an intermediate lessor, the sub-leases are classified as a finance lease or as an operating lease with reference to the right-of-use asset arising from the head lease. If the head lease is a short-term lease to which the Group applies the exemption described in note 1(i)(i), then the Group classifies the sub-lease as an operating lease.

The maximum period considered when estimating ECLs is the maximum contractual period over which the Group is exposed to credit risk.

In measuring ECLs, the Group takes into account reasonable and supportable information that is available without undue cost or effort. This includes information about past events, current conditions and forecasts of future economic conditions.

ECLs are measured on either of the following bases:

- 12-month ECLs: these are losses that are expected to result from possible default events within the 12 months after the reporting date; and

For all other financial instruments, the Group recognises a loss allowance equal to 12-month ECLs unless there has been a significant increase in credit risk of the financial instrument since initial recognition, in which case the loss allowance is measured at an amount equal to lifetime ECLs.

Significant increases in credit risk

In assessing whether the credit risk of a financial instrument has increased significantly since initial recognition, the Group compares the risk of default occurring on the financial instrument assessed at the reporting date with that assessed at the date of initial recognition. In making this reassessment, the Group considers that a default event occurs when (i) the borrower is unlikely to pay its credit obligations to the Group in full, without recourse by the Group to actions such as realising security (if any is held); or (ii) the financial asset is 90 days past due. The Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly since initial recognition:

- failure to make payments of principal or interest on their contractually due date;
- an actual or expected significant deterioration in a financial instrument's external or internal credit rating (if available);
- an actual or expected significant deterioration in the operating results of the debtor; and
- existing or forecast changes in the technological, market, economic or legal environment that have a significant adverse effect on the debtor's ability to meet its obligation to the Group.

Depending on the nature of the financial instruments, the assessment of a significant increase in credit risk is performed on either an individual basis or a collective basis. When the assessment is performed on a collective basis, the financial instruments are grouped based on shared credit risk characteristics, such as past due status and credit risk ratings.

ECLs are remeasured at each reporting date to reflect changes in the financial instrument's credit risk since initial recognition. Any change in the ECL amount is recognised as an impairment gain or loss in profit or loss. The Group recognises an impairment gain or loss for all financial instruments with a corresponding adjustment to their carrying amount through a loss allowance account.

Basis of calculation of interest income

Interest income recognised in accordance with note 1(t)(v) is calculated based on the gross carrying amount of the financial asset unless the financial asset is credit-impaired, in which case interest income is calculated based on the amortised cost (i.e. the gross carrying amount less loss allowance) of the financial asset.

At each reporting date, the Group assesses whether a financial asset is credit-impaired. A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of the financial asset have occurred.

Evidence that a financial asset is credit-impaired includes the following observable events:

- significant financial difficulties of the debtor;
- a breach of contract, such as a default or delinquency in interest or principal payments;
- it becoming probable that the borrower will enter into bankruptcy or other financial reorganisation;
- significant changes in the technological, market, economic or legal environment that have an adverse effect on the debtor; or

Write-off policy

The gross carrying amount of a financial asset or lease receivable is written off (either partially or in full) to the extent that there is no realistic prospect of recovery. This is generally the case when the Group determines that the debtor does not have assets or sources of income that could generate sufficient cash flows to repay the amounts subject to the write-off.

Subsequent recoveries of an asset that was previously written off are recognised as a reversal of impairment in profit or loss in the period in which the recovery occurs.

The recoverable amount of an asset is the greater of its fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. Where an asset does not generate cash inflows largely independent of those from other assets, the recoverable amount is determined for the smallest group of assets that generates cash inflows independently (i.e. a cash-generating unit).

- Recognition of impairment losses

An impairment loss is recognised in profit or loss if the carrying amount of an asset, or the cash-generating unit to which it belongs, exceeds its recoverable amount. (k) 存貨

於日常業務過程中持之為銷售、或 在生產過程中銷售、或以材料或供 應品形式在生產過程中所消耗的所 持有資產,是為存貨。

存貨以成本及可變現淨值兩者中之 較低數額入賬。

成本以先進先出法計算,其中包括 所有採購成本、加工成本及將存貨 運至目前地點和變成現狀之其他成本。

可變現淨值是以日常業務過程中之 估計售價減去完成生產及銷售所需 之估計成本後所得之數額。

所有出售存貨之賬面值在相關收入 確認之期間內確認為支出。

任何存貨撇減至可變現淨值之數額 及存貨之所有虧損,均在出現撇減 或虧損之期間內確認為支出。存貨 之任何撇減轉回之數額,均在出現 轉回之期間內確認為已列作支出之 存貨數額減少。

An impairment loss is reversed if there has been a favourable change in the estimates used to determine the recoverable amount.

A reversal of an impairment loss is limited to the asset's carrying amount that would have been determined had no impairment loss been recognised in prior years. Reversals of impairment losses are credited to profit or loss in the year in which the reversals are recognised.

(iii) Interim financial reporting and impairment

Under the Listing Rules, the Group is required to prepare an interim financial report in compliance with HKAS 34, *Interim financial reporting*, in respect of the first six months of the financial year. At the end of the interim period, the Group applies the same impairment testing, recognition, and reversal criteria as it would at the end of the financial year (see note 1(j)).

(k) Inventories

Inventories are assets which are held for sale in the ordinary course of business, in the process of production for such sale or in the form of materials or supplies to be consumed in the production process.

Inventories are carried at the lower of cost and net realisable value.

Cost is calculated using the first-in, first-out formula and comprises all costs of purchase, costs of conversion and other costs incurred in bringing the inventories to their present location and condition.

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

When inventories are sold, the carrying amount of those inventories is recognised as an expense in the period in which the related revenue is recognised.

The amount of any write-down of inventories to net realisable value and all losses of inventories are recognised as an expense in the period the write-down or loss occurs. The amount of any reversal of any write-down of inventories is recognised as a reduction in the amount of inventories recognised as an expense in the period in which the reversal occurs.

(l) Contract liabilities

A contract liability is recognised when the customer pays non-refundable consideration before the Group recognises the related revenue (see note 1(t)). A contract liability would also be recognised if the Group has an unconditional right to receive non-refundable consideration before the Group recognises the related revenue. In such cases, a corresponding receivable would also be recognised (see note 1(m)).

(m) Trade and other receivables

A receivable is recognised when the Group has an unconditional right to receive consideration. A right to receive consideration is unconditional if only the passage of time is required before payment of that consideration is due. If revenue has been recognised before the Group has an unconditional right to receive consideration, the amount is presented as a contract asset.

Receivables are stated at amortised cost using the effective interest method less allowance for credit losses (see note1(j)(i)).

(n) Interest-bearing borrowings

Interest-bearing borrowings are measured initially at fair value less transaction costs. Subsequent to initial recognition, interest-bearing borrowings are stated at amortised cost using the effective interest method. Interest expense is recognised in accordance with the Group's accounting policy for borrowing costs (see note 1(v)).

(o) Trade and other payables

Trade and other payables are initially recognised at fair value and are subsequently stated at amortised cost unless the effect of discounting would be immaterial, in which case they are stated at cost.

(p) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Bank overdrafts that are repayable on demand and form an integral part of the Group's cash management are also included as a component of cash and cash equivalents for the purpose of the consolidated cash flow statement. Cash and cash equivalents are assessed for ECL in accordance with the policy set out in note 1(j)(i).

Salaries, annual bonuses, paid annual leave, contributions to defined contribution retirement plans and the cost of non-monetary benefits are accrued in the year in which the associated services are rendered by employees. Where payment or settlement is deferred and the effect would be material, these amounts are stated at their present values.

(ii) Termination benefits

Termination benefits are recognised at the earlier of when the Group can no longer withdraw the offer of those benefits and when it recognises restructuring costs involving the payment of termination benefits.

(r) Income tax

Income tax for the year comprises current tax and movements in deferred tax assets and liabilities. Current tax and movements in deferred tax assets and liabilities are recognised in profit or loss except to the extent that they relate to items recognised in other comprehensive income or directly in equity, in which case the relevant amounts of tax are recognised in other comprehensive income or directly in equity, respectively.

Current tax is the expected tax payable on the taxable income for the year, using tax rates enacted or substantively enacted at the end of the reporting period, and any adjustment to tax payable in respect of previous years.

Deferred tax assets and liabilities arise from deductible and taxable temporary differences respectively, being the differences between the carrying amounts of assets and liabilities for financial reporting purposes and their tax bases. Deferred tax assets also arise from unused tax losses.

Future taxable profits that may support the recognition of deferred tax assets arising from deductible temporary differences include those that will arise from the reversal of existing taxable temporary differences, provided those differences relate to the same taxation authority and the same taxable entity, and are expected to reverse either in the same period as the expected reversal of the deductible temporary difference or in periods into which a tax loss arising from the deferred tax asset can be carried forward. The same criteria are adopted when determining whether existing taxable temporary differences support the recognition of deferred tax assets arising from unused tax losses and credits, that is, those differences are taken into account if they relate to the same taxation authority and the same taxable entity, and are expected to reverse in a period, or periods, in which the tax loss or credit can be utilised.

The limited exception to recognition of deferred tax assets and liabilities are those temporary differences relating to investments in subsidiaries to the extent that, in the case of taxable differences, the Group controls the timing of the reversal and it is probable that the differences will not reverse in the foreseeable future, or in the case of deductible differences, unless it is probable that they will reverse in the future.

Where investment properties are carried at their fair value in accordance with the accounting policy set out in note 1(f), the amount of deferred tax recognised is measured using the tax rates that would apply on sale of those assets at their carrying value at the reporting date unless the property is depreciable and is held within a business model whose objective is to consume substantially all of the economic benefits embodied in the property over time, rather than through sale. In all other cases, the amount of deferred tax recognised is measured based on the expected manner of realisation or settlement of the carrying amount of the assets and liabilities, using tax rates enacted or substantively enacted at the end of the reporting period. Deferred tax assets and liabilities are not discounted.

The carrying amount of a deferred tax asset is reviewed at the end of each reporting period and is reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow the related tax benefit to be utilised. Any such reduction is reversed to the extent that it becomes probable that sufficient taxable profits will be available.

Additional income taxes that arise from the distribution of dividends are recognised when the liability to pay the related dividends is recognised.

Provisions are recognised when the Group has a legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

(t) Revenue and other income

Income is classified by the Group as revenue when it arises from the sale of goods, the provision of printing and related services, the licensing or the use by others of the Group's assets under leases in the ordinary course of the Group's business.

Revenue is recognised when control over a product or service is transferred to the customer, or the lessee has the right to use the asset, at the amount of promised consideration to which the Group is expected to be entitled, excluding those amounts collected on behalf of third parties. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts.

Further details of the Group's revenue and other income recognition policies are as follows:

(i) Sale of goods

Revenue arising from the sale of garments and printing products is recognised when goods are delivered to the customers' premises or picked up by customers for domestic sales and when goods are shipped on board for export sales which is taken to be the point in time when the customer takes possession and accepted the goods.

(ii) Royalty income

Royalty income is recognised on an accrual basis in accordance with the substance of the relevant agreements.

(iii) Rental income from operating leases

Rental income receivable under operating leases is recognised in profit or loss in equal instalments over the periods covered by the lease term, except where an alternative basis is more representative of the pattern of benefits to be derived from the use of the leased asset. Lease incentives granted are recognised in profit or loss as an integral part of the aggregate net lease payments receivable. Variable lease payments that do not depend on an index or a rate are recognised as income in the accounting period in which they are earned.

(iv) Dividends

- Dividend income from unlisted investments is recognised when the shareholder's right to receive payment is established.
- Dividend income from listed investments is recognised when the share price of the investment goes exdividend.

(v) Interest income

Interest income is recognised as it accrues using the effective interest method using the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the gross carrying amount of the financial asset.

(vi) Government grants

Government grants are recognised in the consolidated statement of financial position initially when there is reasonable assurance that they will be received and that the Group will comply with the conditions attaching to them. Grants that compensate the Group for expenses incurred are recognised as income in profit or loss on a systematic basis in the same periods in which the expenses are incurred. Grants that compensate the Group for the cost of an asset are deducted from the carrying amount of the asset and consequently are effectively recognised in profit or loss over the useful life of the asset by way of reduced depreciation expense.

(u) Translation of foreign currencies

Items included in the financial statements of each of the Group's subsidiaries are measured using the currency of the primary economic environment in which the entity operates ("the functional currency"). The consolidated financial statements are presented in Hong Kong dollars, which is the Company's functional and presentation currency.

Foreign currency transactions during the year are translated at the foreign exchange rates ruling at the transaction dates. Monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at the end of the reporting period. Exchange gains and losses are recognised in profit or loss.

Non-monetary assets and liabilities that are measured in terms of historical cost in a foreign currency are translated using the foreign exchange rates ruling at the transaction dates. The transaction date is the date on which the Group initially recognises such non-monetary assets or liabilities. Non-monetary assets and liabilities denominated in foreign currencies that are stated at fair value are translated using the foreign exchange rates ruling at the dates the fair value was measured.

The results of foreign operations are translated into Hong Kong dollars at the exchange rates approximating the foreign exchange rates ruling at the dates of the transactions. Statement of financial position items are translated into Hong Kong dollars at the closing foreign exchange rates ruling at the end of the reporting period. The resulting exchange differences are recognised in other comprehensive income and accumulated separately in equity in the exchange reserve.

On disposal of a foreign operation, the cumulative amount of the exchange differences relating to that foreign operation is reclassified from equity to profit or loss when the profit or loss on disposal is recognised.

(v) Borrowing costs

Borrowing costs that are directly attributable to the acquisition, construction or production of an asset which necessarily takes a substantial period of time to get ready for its intended use or sale are capitalised as part of the cost of that asset. Other borrowing costs are expensed in the period in which they are incurred.

The capitalisation of borrowing costs as part of the cost of a qualifying asset commences when expenditure for the asset is being incurred, borrowing costs are being incurred and activities that are necessary to prepare the asset for its intended use or sale are in progress. Capitalisation of borrowing costs is suspended or ceases when substantially all the activities necessary to prepare the qualifying asset for its intended use or sale are interrupted or complete.

(w) Related parties

- A person, or a close member of that person's family, is related to the Group if that person:
 - (i) has control or joint control over the Group;
 - (ii) has significant influence over the Group; or

(b) Write-down of inventories

The Group performs regular reviews of the carrying amounts of inventories with reference to aged inventories analyses, projections of expected future saleability of goods and management experience and judgement. Based on this review, a write down of inventories will be made when the estimated net realisable value decline below their carrying amounts of inventories. Due to changes in customers' preferences and actual saleability of goods may be different from estimation, profit or loss in future accounting periods could be affected by differences in this estimation.

(c) Impairment of trade debtors

The Group uses a provision matrix to calculate ECLs for trade debtors. The provision rates are based on days past due for groupings of various debtors that have similar loss patterns. The provision matrix is based on management's estimate of the lifetime expected credit losses to be incurred, which is estimated by taking into account the credit loss experience, ageing of overdue trade debtors, customers' repayment history and customers' financial position and an assessment of both the current and forecast general economic conditions, all of which involve a significant degree of management judgment.

Segment assets include all tangible, intangible assets and current assets with the exception of deferred tax assets, trading securities, current tax recoverable, cash and cash equivalents and other corporate assets. Segment liabilities include trade and other payables and contract liabilities, lease liabilities and bank overdrafts with the exception of current tax payable, deferred tax liabilities and other corporate liabilities.

Revenue and expenses are allocated to the reportable segments with reference to sales generated by those segments and the expenses incurred by those segments or which otherwise arise from the depreciation of assets attributable to those segments.

The measure used for reporting segment profit or loss is "adjusted EBITDA", i.e. "adjusted earnings before interest, taxes, depreciation and impairment loss on non-current assets", where "interest" includes investment income. To arrive at adjusted EBITDA, the Group's earnings/losses are further adjusted for items not specifically attributed to individual segments, such as other head office or corporate administration costs.

In addition to receiving segment information concerning adjusted EBITDA, management is provided with segment information concerning revenue (including inter-segment sales), interest income and expenses from cash balances and borrowings managed directly by the segments, depreciation and impairment losses and additions to non-current segment assets used by the segments in their operations. Inter-segments sales are priced with reference to prices charged to external parties for similar orders.

(f) Capital management

The Group's primary objectives when managing capital are to safeguard the Group's ability to continue as a going concern, so that it can continue to provide returns for shareholders and benefits for other stakeholders, by pricing products and services commensurately with the level of risk and by securing access to finance at a reasonable cost.

The Group actively and regularly reviews and manages its capital structure to maintain a balance between a higher shareholder returns that might be possible with higher levels of borrowings and the advantages and security afforded by a sound capital position, and makes adjustments to the capital structure in light of changes in economic conditions.

Consistent with industry practice, the Group monitors its capital structure on the basis of an adjusted net debt-to-capital ratio. For this purpose, the Group defines net debt as total debt (which includes interest-bearing loans and borrowings, trade and other payables and contract liabilities and lease liabilities) plus unaccrued proposed dividends, less cash and cash equivalents. Adjusted capital comprises all components of equity less unaccrued proposed dividends.

Exposure to credit, liquidity, interest rate and currency risks arises in the normal course of the Group's business. The Group is also exposed to trading securities price risk arising from the trading securities held by the Group.

The Group's exposure to these risks and the financial risk management policies and practices used by the Group to manage these risks are described below.

(a) Credit risk

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in a financial loss to the Group.

The Group's credit risk is primarily attributable to trade and other receivables, non-current rental deposits and trading securities. The Group's exposure to credit risk arising from cash and cash equivalents is limited because the counterparties are banks with sound credit rating, for which the Group considers to have low credit risk.

Management has a credit policy in place and the exposures to these credit risks are monitored on an ongoing basis. The maximum exposure to credit risk is represented by the carrying amount of each financial asset in the consolidated statement of financial position.

Non-current rental deposits primarily comprise of amounts receivable from the landlords of retail outlets and shopping malls with no recent history of material defaults. The Group's exposure to credit risk is influenced mainly by the individual characteristic of each landlord of retail outlets and shopping malls. The Group has worked with a large number of landlords of retail outlets and shopping malls and there is no significant concentration of credit risk.

In respect of trade and other receivables, individual credit evaluations are performed on all customers requiring credit over a certain amount. These evaluations focus on the customer's past history of making payments when due and current ability to pay, and take into account information specific to the customer as well as pertaining to the economic environment in which the customer operates. Trade debtors are due within 90 days from the date of billing. Normally, the Group does not obtain collateral from customers.

The Group's exposure to credit risk is influenced mainly by the individual characteristics of each customer rather than the industry or country in which the customer operates and therefore significant concentrations of credit risk only arise if the Group has significant exposure to individual customer. At 31 March 2021 and 2020, no individual debtor with outstanding balance exceeded 10% of the Group's trade debtors.

The Group's policy is to regularly monitor its liquidity requirements and its compliance with lending covenants (if any), to ensure that it maintains sufficient reserves of cash and adequate committed lines of funding from major financial institutions to meet its liquidity requirements in the short and longer term.

The Group is exposed to currency risk primarily through sales and purchases which give rise to receivables, payables and cash balances that are denominated in a foreign currency, i.e. a currency other than the functional currency of the operations to which the transactions relate. The currencies giving rise to this risk are primarily United States dollars ("USD"), Pound Sterling ("GBP"), Euros, Renminbi Yuan and Japanese Yen.

As the Hong Kong dollars ("HKD") is pegged to the USD, management does not expect any significant movements in the USD/HKD exchange rate and considers the exposure to foreign currency risk in relation to the USD to be low. However, management acknowledges that it is exposed to fluctuations in the exchange rate for other currencies and the Group ensures that the net exposure is kept to an acceptable level by buying or selling foreign currencies at spot rates where necessary to address short-term imbalances.

All the Group's borrowings are denominated in the functional currency of the entity taking out the loan or, in the case of the Group's entities whose functional currency is HKD, in either HKD or USD. Given this, management does not expect that there will be any significant currency risk associated with the Group's borrowings.
