#### **BUSINESS REVIEW**

The COVID-19 pandemic was a disaster for the retail trade, especially for watches retail business. The implementation of travel restrictions and other quarantine measures by various countries has caused a sharp decline in inbound visitors and brought the inbound tourism to a standstill, which have dealt a heavy blow to the retail trade. Meanwhile, the Hong Kong government introduced gathering restrictions and social distancing measures to a varying extent in order to contain the spread of the pandemic, which further weakened consumer sentiment. Fortunately, the Hong Kong community has been working together to keep the pandemic under control. With the COVID-19 vaccination programme launched, we hope that the worst time of the pandemic has already passed. Given the unprecedented challenges the Group encountered, the financial performance of watches retail business was inevitably affected.

As for the trading business, the major products sold by the Group include urea, compound fertiliser, coal, crude glycerine and glucose and the application of urea can be broadly divided into agricultural, industrial and vehicle uses. In the first half of the financial year, affected by many factors such as the COVID-19 pandemic and the continued China-US trade friction, the prices of fertilisers showed a downward trend, which led to fluctuation in fertiliser industry. However, the situation changed in the second half of the financial year. Under the influence of rising prices of raw materials and expanding market demand, the fertiliser industry revived with the support of continuous increase in prices. More importantly, since the Group actively expanded its operation into new markets, the Group's trading business as a whole still maintained a momentum of growth during the Year.

Facing with such a difficult business environment, the Group has implemented a series of cost-saving measures, including employees' no pay leave arrangements, a salary reduction scheme for management, a job cut and the minimization of operating costs. Besides, the Group applied for the Retail Sector Subsidy Scheme and the Employment Support Scheme under the Anti-epidemic Fund of Hong Kong to alleviate the financial pressure. To tackle the challenges brought by pandemic, the Group strived to build a lean and efficient operating cost structure by closing under-performed shops and streamlining its administrative structure. Therefore, as at 30 April 2021, the total number of retail shops operated by the Group reduced to 10 (2020: 11). At the same time, the Group has proactively negotiated with landlords for rental reduction in an effort to relieve the rental pressure. The Group also focused on clearing slow-moving inventories through sales promotion activities to accelerate stock clearance. As a result of the foregoing, the Group's net loss for the Year decreased by approximately HK\$58.2 million to approximately HK\$0.8 million, as compared to a net loss of approximately HK\$59.0 million for the Year 2020.

## 業務回顧

COVID-19疫情對零售業(尤其是腕錶零售業務)來說是一場災難。各國實施出行限制及其 他檢疫措施使入境旅客鋭減,入境旅遊陷入 停滯,重挫零售業。同時,香港政府為遏制 疫情蔓延,推行不同程度的限聚令及社交距 離措施,進一步削弱消費者情緒。幸運的是 香港社會一直同心協力,使疫情受控。隨著 COVID-19疫苗接種計劃開展,我們希望疫情 最壞的時間已經過去。由於本集團遭遇到前 所未有的挑戰,腕錶零售業務的財務表現無 可避免地受到影響。

貿易業務方面,本集團銷售的主要產品包括 尿素、複合肥、煤炭、粗甘油及葡萄糖,尿素 用途大致可分為農業、工業及車用用途。於財 政年度上半年,受COVID-19疫情及中美貿易 衝突持續等諸多因素影響,肥料價格呈下行 趨勢,導致肥料行業出現波動。然而,有關 調於財政年度下半年有所改變。在原材料行 化上漲及市場需求擴大的影響下,肥料行業 在價格持續上漲的支持下復甦。更重要的是, 由於本集團積極將業務營運擴展至新市場, 故本集團的整體貿易業務於本年度仍保持增 長勢頭。

面對如此艱難的經營環境,本集團已實行一 系列節約成本措施,包括僱員無薪假安排、管 理層減薪計劃、削減職位及將經營成本降至 最低。此外,本集團申請香港[防疫抗疫基金] 下的「零售業資助計劃」及「保就業計劃」,以緩 解財務壓力。為應對疫情帶來的種種挑戰,本 集團通過關閉表現未如理想的店鋪及精簡行 政架構,致力建立精簡高效的經營成本結構。 因此,於二零二一年四月三十日,本集團運 營之零售商舖總數降至10間(二零二零年:11 間)。同時,本集團已積極與業主進行減免租 金的磋商,以減輕租金的壓力。本集團亦透過 促銷活動,致力於清理滯銷存貨,以加快清理 庫存。由於上文所述,本集團於本年度的虧損 淨額減少約58.2百萬港元至約0.8百萬港元, 而二零二零年度則錄得虧損淨額約59.0百萬 港元。

## **FINANCIAL RESULTS**

For the Year, our Group recorded a turnover of approximately HK\$83.4 million, representing a decrease of approximately HK\$10.8 million from approximately HK\$94.2 million as compared to previous financial year.

The loss attributable to owners of the Company decreased by approximately HK\$58.2 million or 98.6% from approximately HK\$59.0 million for the Year 2020 to approximately HK\$0.8 million for the Year.

### **DIVIDEND PAYMENT**

The Board does not recommend the payment of any dividend for the Year.

## **PROSPECTS**

Affected by the COVID-19 pandemic, expanding market demand and rising prices of raw materials, the prices of fertilisers still remain high in the short term. However, under the background of the Chinese government efforts to stabilize supply and prices, it is expected that there is little room for the further increase in prices. Looking ahead, as China further tightens environmental protection policies, fertiliser industry integration and reshuffle will be accelerated. Some small-scale and heavy-polluting production enterprises will be phased out of the market, and the overcapacity situation will be further alleviated, which will provide support to the fertiliser industry. Facing with the pandemic and the complicated economic environment, the Group will strive to maintain stringent product quality and continuously improve our services to meet the customers' needs so as to further expand our customer base and enhance customers' loyalty. Moreover, the Group will further expand its operations into huge market, strengthening marketing efforts to diversify its customer base.

## 財務業績

## 前景

受COVID-19疫情、市場需求擴大、原材料價格 上漲等因素影響,短期內肥料價格仍處於高 位。然而,在中國政府努力穩定供應及價格的 背景下,預計價格進一步上漲的空間不大。展 望未來,隨著中國進一步收緊環保政策,肥料 行業將加速整合及洗牌。部分規模較小且污 染重的生產企業將被市場淘汰,產能過, 局面將進一步緩解,為肥料行業提供支撐。面 對疫情及複雜多變的經濟環境,本集團將到 力保持嚴格的產品質量及不斷改進服務,力 求滿足客戶需求,以進一步擴大客戶基礎及 提高客戶忠誠度。另外,本集團亦會將其業務 營運進一步拓展至廣大市場,加強營銷力度, 藉此多元化發展客戶基礎。

As regards the watches retail business, as inbound tourism will take time to recover amid travel restrictions worldwide, the business environment of the retail trade will continue to be very difficult. To stimulate local consumer sentiment and support Hong Kong economy, the Hong Kong government will launch the consumption voucher scheme soon. We hope that this scheme will boost the battered retail trade and thus create favourable conditions for the revival of retail trade. Given the current extremely difficult business environment, the Group will continue to carry out stringent measures to control operating costs and take inventory and cost control measures as the top priority to preserve the Group's working capital. We have reviewed our retail network and shall determinedly close more underperforming shops upon expiry of rental agreements. Through these initiatives, we hope that the Group will overcome difficulties and maintain its strategic operations.

Despite the challenging business environment, all of our management and staff will continue uniting and working together to get through this difficult time. As the pace of Hong Kong's economic recovery depends on when travel restrictions can be relaxed, it is important for the community to actively get vaccinated in order to keep the pandemic under control. We believe that the pandemic will eventually pass, and social and economic activities can get back to normal.

On behalf of the Board, I would like to take this opportunity to express my sincere gratitude to the Board members, management and employees for their hard work and dedication that enable the Group to face the challenges and uncertainties in the current unfavorable environment. ## MANAGEMENT DISCUSSION AND ANALYSIS 管理層討論及分析

## FINANCIAL REVIEW

#### Revenue

The Group's revenue for the Year was approximately HK\$83.4 million, representing a decrease of approximately HK\$10.8 million or 11.5% from approximately HK\$94.2 million for the Year 2020. Revenue derived from trading business increased by approximately HK\$2.6 million or 10.9% from approximately HK\$23.8 million for the Year 2020 to approximately HK\$26.4 million for the Year. Revenue derived from watches business decreased by approximately HK\$13.4 million or 19.0% from approximately HK\$70.4 million for the Year 2020 to approximately HK\$70.4 million for the Year 2020 to approximately HK\$57.0 million for the Year. The decrease in revenue derived from watches business was mainly due to a sharp decline in inbound visitors as a result of the pandemic. In addition, the local consumption sentiment was weakened by the gathering restrictions, social distancing measures and the rising unemployment rate.

#### Cost of sales

Our cost of sales primarily consists of cost of inventories sold and provision for slow-moving inventories. Our cost of sales decreased by approximately HK\$10.5 million or 21.1% from approximately HK\$49.8 million for the Year 2020 to approximately HK\$39.3 million for the Year. The decrease was mainly due to the decline in sales of watches and in line with the decrease in revenue of the watches business.

#### Gross profit and gross profit margin

The overall gross profit decreased by approximately HK\$0.3 million or 0.7% from approximately HK\$44.4 million for the Year 2020 to approximately HK\$44.1 million for the Year. Our gross profit of the watches business decreased by approximately HK\$2.9 million or 14.1% from approximately HK\$20.6 million for the Year 2020 to approximately HK\$17.7 million for the Year. Our gross profit margin of the watches business increased from approximately 29.3% for the Year 2020 to approximately 31.1% for the Year. The increase was mainly attributable to a decrease in provision for slow-moving inventories during the Year.

本集團的收益由二零二零年度的約94.2百萬 港元降低約10.8百萬港元或11.5%至本年度的 約83.4百萬港元。貿易業務的所得收益由二零 二零年度的約23.8百萬港元增加約2.6百萬港 元或10.9%至本年度的約26.4百萬港元。腕錶 業務的所得收益由二零二零年度的約70.4百 萬港元下降約13.4百萬港元或19.0%至本年度 的約57.0百萬港元。腕錶業務的所得收益減 少乃主要由於疫情導致入境遊客人數急劇下 降。另外,受限聚令及社交距離措施以及失業 率上升等影響,本地的消費者情緒轉弱。

#### 銷售成本

我們的銷售成本主要包括已售存貨成本及滯 銷存貨撥備。我們的銷售成本由二零二零年 度的約49.8百萬港元減少約10.5百萬港元或 21.1%至本年度的約39.3百萬港元。該減少乃 主要由於腕錶銷售額減少,與腕錶業務收益 減少一致。

#### 毛利及毛利率

總體毛利由二零二零年度的約44.4百萬港元 減少約0.3百萬港元或0.7%至本年度的約44.1 百萬港元。我們腕錶業務的毛利由二零二零 年度的約20.6百萬港元減少約2.9百萬港元或 14.1%至本年度的約17.7百萬港元。我們腕錶 業務的毛利率由二零二零年度的約29.3%增至 本年度的約31.1%。該增加乃主要由於本年度 滯銷存貨撥備減少。



#### Selling and distribution costs

Our selling and distribution costs decreased by approximately HK\$47.9 million or 64.1% from approximately HK\$74.7 million for the Year 2020 to approximately HK\$26.8 million for the Year. The decrease was primarily attributable to the decreases of lease expenses of retail outlets (including rental expenses and depreciation of right-of-use assets), sales staff's salaries and allowances, depreciation of property, plant and equipment, advertising and promotions and impairment loss on right-of-use assets. This decrease was partially offset by the increases in freight.

#### Administrative expenses

Our administrative expenses decreased by approximately HK\$7.5 million or 27.5% from approximately HK\$27.3 million for the Year 2020 to approximately HK\$19.8 million for the Year. The decrease was primarily attributable to the decreases in administrative staff's salaries and allowances, depreciation of right-of-use assets and depreciation of property, plant and equipment, which was partially offset by the increase in impairment loss on right-of-use assets.

#### **Finance costs**

Our finance costs decreased by approximately HK\$1.1 million from approximately HK\$2.3 million for the Year 2020 to approximately HK\$1.2 million for the Year. The decrease was primarily attributable to the decrease in related finance costs on lease liabilities. This decrease was partially offset by the increase in bank loan interest as a result of the increase in the level of borrowings.

## Profit/(loss) before tax and loss attributable to owners of the Company

As a result of the foregoing, the Group recorded a profit before tax of approximately HK\$2.3 million for the Year (2020: loss before tax of approximately HK\$56.2 million). The change was mainly due to (i) subsidies of approximately HK\$2.6 million from Hong Kong Government under Retail Sector Subsidy Scheme and the Employment Support Scheme; (ii) a substantial decrease in depreciation of right-of-use assets and impairment loss on right-of-use assets of a total of approximately HK\$40.0 million as a significant portion of right-of-use assets had been impaired in the previous year; (iii) a decrease in depreciation of property, plant and equipment of approximately 4.6 million; and (iv) the stringent cost control measures.

#### 銷售及分銷成本

我們的銷售及分銷成本由二零二零年度的約 74.7百萬港元減少約47.9百萬港元或64.1%至 本年度的約26.8百萬港元。該減少乃主要由於 零售店舖的租賃開支(包括租金開支及使用權 資產折舊)、銷售員工的工資及津貼、物業、 廠房及設備的折舊、廣告及推廣以及使用權 資產的減值虧損減少所致。該減少部分由運 費增加所抵銷。

#### 行政開支

我們的行政開支由二零二零年度的約27.3百 萬港元減少約7.5百萬港元或27.5%至本年度 的約19.8百萬港元。有關減少主要歸因於行政 人員的薪金及津貼、使用權資產的折舊以及 物業、廠房及設備的折舊減少所致,其部分由 使用權資產的減值虧損增加所抵銷。

#### 融資成本

我們的融資成本由二零二零年度的約2.3百萬 港元減少約1.1百萬港元至本年度的約1.2百萬 港元。該減少乃主要由於租賃負債相關的融 資成本減少。受借款水平增加影響,銀行貸款 利息增加部分抵銷了該項減少。

#### 除税前溢利/(虧損)及本公司擁 有人應佔虧損

由於上述原因,本集團於本年度錄得除税前 溢利約2.3百萬港元(二零二零年:除税前虧損 約56.2百萬港元)。有關變動乃主要歸因於(i) 來自香港政府的零售業資助計劃及保就業計 劃的補貼約2.6百萬港元:(ii)因過往年度絕大 部分的使用權資產已經減值,使用權資產的 折舊及使用權資產減值虧損大幅減少合共約 40.0百萬港元:(iii)物業、廠房及設備折舊減少 約4.6百萬港元;以及(iv)嚴格的成本控制措施。



The loss attributable to owners of the Company decreased by approximately HK\$58.2 million or 98.6% from approximately HK\$59.0 million for the Year 2020 to approximately HK\$0.8 million for the Year.

An analysis of the Group's performance for the Year by operating segment is set out in Note 6 to the Financial Statements.

## **FINANCIAL POSITION**

The Group's primary source of funds were cash inflows from operating activities, bank borrowings and loans from the ultimate holding company.

As at 30 April 2021, the Group's total cash and cash equivalents were approximately HK\$13.4 million (as at 30 April 2020: approximately HK\$22.2 million), most of which were denominated in HK\$ and Renminbi. The current ratio (calculated by dividing current assets by current liabilities) of the Group maintained at approximately 1.0 time as at 30 April 2021 and 30 April 2020. The gearing ratio (calculated by dividing net debt by total equity) was 83.1% as at 30 April 2021 (as at 30 April 2020: 19.4%). Net debt was calculated as bank loans and amount due to ultimate holding company less cash and cash equivalents.

As at the date of the Annual Report, there was no outstanding share option granted under the Share Option Scheme.

The Group had total bank borrowings of approximately HK\$10.2 million as at 30 April 2021 (As at 30 April 2020: approximately HK\$8.3 million).

The carrying amounts of the Group's bank borrowings were denominated in HK\$ and secured and approximated to their fair values.

## **BOARD OF DIRECTORS**

#### **Responsibilities**

The Board is primarily responsible for overseeing and supervising the management of the business affairs and the overall performance of the Group. The Board sets the Group's values and standards and ensures that the requisite financial and human resources support is in place for the Group to achieve its objectives. The functions performed by the Board include but are not limited to formulating the Group's business plans and strategies, deciding all significant financial (including major capital expenditure) and operational issues, developing, monitoring and reviewing the Group's corporate governance practices and all other functions reserved to the Board under the Articles of Association. The Board has established Board committees and has delegated to these Board committees various responsibilities as set out in their respective terms of reference. The responsibilities of these Board committees include monitoring the Group's operational and financial performance, and ensuring that appropriate internal control and risk management are in place. The Board may from time to time delegate certain functions to management of the Group if and when considered appropriate. The management is mainly responsible for the execution of the business plans, strategies and policies adopted by the Board and assigned to it from time to time.

The Directors have full access to information of the Group and the management has an obligation to supply the Directors with adequate information in a timely manner to enable the Directors to perform their responsibilities. The Directors are entitled to seek independent professional advice in appropriate circumstances at the Company's expense.

#### Composition

The Company is committed to holding and implementing the view that the Board should include a balanced composition of Executive Directors and Independent Non-executive Directors so that there is a strong independent element on the Board, which can effectively exercise independent judgment.

## 董事會

## 責任

董事會主要負責監管及監督本集團之業務事 宜管理及整體表現。董事會設定本集團之價 值及標準, 並確保具備必需之財務及人力資 源,使本集團得以實現其目標。董事會履行之 職能包括但不限於制訂本集團業務計劃及策 略、決定所有重大財務(包括主要資本支出)及 營運事項、發展、監察及審查本集團之企業管 治常規及所有其他根據組織章程細則須經由 董事會負責之職能。董事會轄下已設立董事 委員會,並向該等董事委員會轉授其各自職 權範圍載列之各項責任。該等董事委員會之 責任包括監察本集團營運及財務業績,並確 保具備恰當內部監控及風險管理。董事會可 於其認為適當之時不時授予本集團管理層若 干職能。管理層主要負責執行董事會所採用 及其不時獲指派之業務計劃、策略及政策。

董事可充分取閲本集團之資料,且管理層有 義務向董事及時提供充足資料,以便董事履 行其責任。董事有權於適當情況下徵詢獨立 專業意見,費用由本公司支付。

#### 組成

本公司認同,董事會應由執行董事及獨立非 執行董事之均衡組合組成並一直予以實行, 使董事會具備高度獨立性,能有效作出獨立 判斷。

Mr. Meng Guangyin is the brother-in-law of Mr. Liu Guoqing. Save as disclosed, there was no financial, business, family or other material relationship among the Directors.

The INEDs have brought in a wide range of business and financial expertise, experience and independent judgement to the Board. Throughout the Year, the Company had three INEDs, which was in compliance with the requirement of the Listing Rules that the number of INEDs must represent at least one-third of the Board members, and that at least one of the INEDs has appropriate professional qualifications or accounting or related financial management expertise.

The Company has received a confirmation of independence in writing from each of the INEDs pursuant to Rule 3.13 of the Listing Rules. Based on such confirmation and not aware of the occurrence of any event that would impair the independence of the INEDs, the Company considers that all the INEDs are independent and have met the independence guidelines as set out in Rule 3.13 of the Listing Rules.

Code provision of A.2.7 of the CG code provides that the Chairman should at least annually hold meetings with the INEDs without the presence of other directors. During the Year, no meeting was held between Mr. Meng, the Chairman, and the INEDs without the presence of other directors due to business engagements. Since the INEDs have communicated and discussed with the Chairman directly from time to time to share their view on the Company's affairs, therefore, the Company considered that there were sufficient channels and communication for discussion of the Company's affairs between the Chairman and INEDs.

Proper insurance coverage in respect of legal actions against the Directors' liability has been arranged by the Company.

# DIRECTORS' INDUCTION AND CONTINUING PROFESSIONAL DEVELOPMENT

The Company provides each of the newly appointed Directors with a formal, comprehensive and tailored induction on the first occasion of his appointment to ensure that he has a proper understanding of the Company's operations and business and is fully aware of the Director's responsibilities under statute and common law, the Listing Rules, legal and other regulatory requirements and the Company's business and governance policies.

本公司就針對董事責任之法律訴訟已安排適 當保險保障。

Pursuant to code provision A.6.5 of the CG Code, all Directors should participate in continuous professional development to develop and refresh their knowledge and skills. This is to ensure that their contribution to the Board remains informed and relevant. The Company will from time to time fund and arrange suitable training to all Directors to develop and refresh their knowledge and skills in relation to their duties and responsibilities, such that their contribution to the Board remains informed and relevant. All Directors are also encouraged to attend relevant training courses at the Company's expense and they have been requested to provide the Company with their training records. Code provision of A.1.1 of the CG Code provides the Board should meet regularly and board meetings should be held at least four times a year at approximately quarterly intervals. Notice of at least 14 days will be given to the Directors in advance. For all other Board meetings, notice will be given in a reasonable time in advance. The Directors are allowed to include any matter in the agenda that is required for discussion and resolution at the meeting. To enable the Directors to be properly briefed on issues arising at each of the Board meetings and to make informed decisions, an agenda and the accompanying Board papers will be sent to all Directors at least three days before the intended date of the Board meeting, or such other period as agreed. The Company Secretary is responsible for keeping all Board meetings' minutes. Draft and final versions of the minutes will be circulated to the Directors for comments and record respectively within a reasonable time after each meeting and the final version is open for the Directors' inspection.

ATTENDANCE RECORDS

During the Year, two regular full Board meetings have been held and the Board has made resolutions by circulation of written resolutions for all the Directors' execution from time to time. In view of the simplicity of the Group's businesses, regular Board meetings have not been held about quarterly during the Year. The Group's audited consolidated annual results for the Year 2020 and unaudited consolidated interim results for the six months ended 31 October 2020 together with all corporate transactions made during the Year have been reviewed and discussed amongst the Directors at the full Board meetings held in the Year. Together with the circulation of written materials to keep the Board informed throughout the Year, sufficient measures had been

## **BOARD DIVERSITY POLICY**

The Company has a Board diversity policy ("**Board Diversity Policy**") which recognises and embraces the benefits of a diversity of Board members. It endeavours to ensure that the Board has a balance of skills, experience and diversity of perspectives appropriate to the requirements of the Company's business. All Board nominations, appointments and re-appointments will continue to be made on a merit basis with due regard for the benefits of diversity of the Board members and the nomination policy of the Company. Selection of candidates will be based on a range of diversity perspectives, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills and knowledge.

## 董事會多元化政策

本公司擁有董事會多元化政策(「董事會多元 化政策」)且明白並深信董事會成員多元化之 利益,並致力確保董事會具備適用於本公司 業務所需之技巧、經驗及思維多元化之均衡。 董事會所有提名、委任及續聘將繼續以因才 委任為基準,充分兼顧董事會成員多元化之 利益及本公司提名政策,並將根據一系列多 元化思維(包括但不限於性別、年齡、文化及 教育背景、種族、專業經驗、技能及知識)挑 選候選人。



Code provision of A.2.1 of the CG Code provides that the roles of the chairman and chief executive officer should be separated and should not be performed by the same individual. During the Year and up to the date of the Annual Report, Mr. Meng Guangyin acts as the Chairman and the CEO. In the view of fact that Mr. Meng Guangyin has been operating and managing the Company since 7 September 2017, the Board is of the opinion that it is appropriate and in the best interests of the Group to have Mr. Meng Guangyin taking up both roles for effective management and business development. Therefore, the Board considers that the deviation from code provision A.2.1 of the CG Code is appropriate in such circumstances. Nevertheless, the Company will look for suitable candidates and will make necessary arrangement pursuant to the requirement under A.2.1 of CG Code as and when necessary.

#### **BOARD COMMITTEES**

The Board has established certain Board committees, including the Audit Committee, the Remuneration Committee and the Nomination Committee, to oversee particular aspects of the Company's affairs. All Board committees are provided with sufficient resources to discharge their duties and upon reasonable request, members of the Board committees are able to seek independent professional advice in appropriate circumstances at the Company's expenses.

#### Audit Committee

The Audit Committee was established on 21 April 2015 with written terms of reference in compliance with Rule 3.22 of the Listing Rules and code provision C3 of the CG Code. The written terms of reference of the Audit Committee were revised on 1 January 2019 to conform with the requirements under the CG Code and the Listing Rules. Such written terms of reference are published on the respective websites of the Stock Exchange and the Company. It comprises all the three INEDs, namely Mr. Lee Chun Keung, Mr. Wang Luping and Mr. Tian Zhiyuan who is the chairman of the Audit Committee.

## 主席與主要行政人員

## 董事委員會

董事會已設立若干董事委員會,包括審核委 員會、薪酬委員會及提名委員會,以專門監控 本公司不同方面之指定事項。所有董事委員 會均獲充分資源以履行其職責,且於合理要 求時,董事委員會成員均可在適當情況下尋 求獨立專業意見,費用由本公司承擔。

## 審核委員會

審核委員會於二零一五年四月二十一日設 立,具備符合上市規則第3.22條及企業管治守 則之守則條文第C3條之書面職權範圍。審核 委員會之書面職權範圍於二零一九年一月一 日修訂以符合企業管治守則及上市規則之規 定。該書面職權範圍已分別刊載於聯交所及 本公司之網站。成員包括全部三名獨立非執 行董事,即李鎮強先生、王魯平先生及田志遠 先生,田志遠先生為審核委員會主席。



The principal roles and functions of the Audit Committee include but are not limited to:

- making recommendations to the Board on the appointment, reappointment and removal of the external auditors, and approving their remuneration and terms of engagement, and handling any questions regarding their resignation or dismissal;
- reviewing and monitoring the external auditors' independence and objectivity and the effectiveness of the audit process in accordance with applicable standards and discussing with the external auditors the nature and scope of the audit and reporting obligations before the audit commences;
- developing and implementing a policy on engaging external auditors to supply non-audit services and reporting to the Board, identifying and making recommendations on any matters where an action or improvement is needed;
- monitoring the integrity of the Company's financial statements and annual report and financial statements and half-year report, and reviewing significant financial reporting judgments contained in them;
- oversighting the Company's financial reporting system, and risk management and internal control systems;
- discussing the risk management and internal control systems with the management to ensure that the management has performed its duty to have such effective systems;
- considering major investigation findings of internal control matters as delegated by the Board or on its own initiative and management's response to these findings;
- where an internal audit function exists, ensuring co-ordination between the internal and external auditors, ensuring that the internal audit function is adequately resourced and has appropriate standing within the Company, and reviewing and monitoring its effectiveness;

During the Year, two Audit Committee meetings were held and the Audit Committee, amongst other matters, considered and approved (i) the draft unaudited consolidated financial statements of the Group for the six months ended 31 October 2020 for presentation to the Board for its consideration and approval and (ii) audit-related matters.

The attendance of each INED at the Audit Committee meetings during the Year is as follows:

The audited Financial Statements have been reviewed by the Audit Committee at its meeting held on 30 July 2021. The Audit Committee is of the opinion that such consolidated financial statements comply with applicable accounting standards and the Listing Rules and that adequate disclosures have been made. The chairman and the members of the Audit Committee attended such meeting.

#### **Remuneration Committee**

The Remuneration Committee was established on 21 April 2015 with written terms of reference in compliance with the CG Code. The written terms of reference of the Remuneration Committee are published on the respective websites of the Stock Exchange and the Company. The Remuneration Committee comprises two INEDs, namely Mr. Tian Zhiyuan, Mr. Wang Luping and an Executive Director, Mr. Meng Guangyin. Mr. Tian Zhiyuan is the chairman of the Remuneration Committee.

The principal roles and functions of the Remuneration Committee include but are not limited to:

- making recommendations to the Board on the Company's policy and structure for the remuneration of all Directors and senior management and on the establishment of a formal and transparent procedure for developing the remuneration policy;
- reviewing and approving the management's performance-based remuneration by reference to the Board's corporate goals and objectives;
- either: (i) determining, with delegated responsibility, the remuneration packages of individual Executive Directors and senior management; or (ii) making recommendations to the Board on the remuneration packages of individual Executive Directors and senior management. This should include benefits in kind, pension rights and compensation payments, including any compensation payable for loss or termination of their office or appointment;
- making recommendations to the Board on the remuneration of the INEDs;
- considering the salaries paid by comparable companies, time commitment, responsibilities and employment conditions elsewhere in the Group;

  - Diversity in the aspects of, amongst others, gender, age, cultural and educational background, professional experience, skills, knowledge and length of service;
  - (b) Commitment for responsibilities of the Board in respect of available time and relevant interest (details of the Board Diversity Policy set out above);
  - Qualifications, both academic and professional, including accomplishment and experience in the relevant industries in which the business(es) of the Company and its subsidiaries is/are involved;
  - (d) Independence (for INEDs);
  - (e) Reputation for integrity;
  - (f) Potential contributions that the individual can bring to the Board; and
  - (g) Plan(s) in place for the orderly succession of the Board.

- vii The Nomination Committee will thereafter make the recommendation to the Board in relation to the proposed appointment, and where a non-executive Director is considered, the Remuneration Committee will make the recommendation to the Board on the policy and structure for the remuneration;
- viii The Board may arrange for the selected candidate to be interviewed by the members of the Board, who are not members of the Nomination Committee and the Board will thereafter deliberate and decide the appointment as the case may be; and
- ix All appointment of Directors will be confirmed by the filing of the consent to act as Director of the relevant Director (or any other similar filings requiring the relevant Director to acknowledge or accept the appointment as Director, as the case may be) to be filed with the relevant regulatory authorities, if required.

- developing, reviewing and monitoring the code of conduct and compliance manual (if any) applicable to employees and the directors of the Group; and
- reviewing the Company's compliance with the CG Code and disclosure in this report.

# APPOINTMENT AND RE-ELECTION OF DIRECTORS

Each of the Executive Directors has entered into a service agreement with the Company for a term of one year and each of the INEDs has signed a letter of appointment with the Company for a term of one year. The extension of the terms or the renewal of any such service agreements or letters of appointment, where necessary, will be in compliance with the Listing Rules and any other applicable laws, rules and regulations.

Any Director appointed by the Board to fill a casual vacancy shall hold office until the first general meeting of Shareholders after his appointment and shall be subject to re-election at such meeting and any Director appointed by the Board as an addition to the existing Board shall hold office only until the next following AGM and shall then be eligible for re-election.

All the Directors, including INEDs, are subject to retirement by rotation and will be eligible for re-election in accordance with the Articles of Association. At each AGM, one-third of the Directors for the time being (or, if their number is not a multiple of three, the number nearest to but not less than one-third) shall retire from office by rotation provided that every Director shall be subject to retirement at the AGM at least once every three years. A retiring Director shall be eligible for re-election and shall continue to act as a Director throughout the meeting at which he retires. The Directors to retire by rotation shall include (so far as necessary to ascertain the number of Directors to retire by rotation) any Director who wishes to retire and does not offer himself for re-election. Any further Directors so to retire shall be those who have been the longest in office since their last re-election or appointment and so that as between the persons who became or were last re-elected Directors on the same day, those to retire shall (unless they otherwise agree among themselves) be determined by lot.

Particulars of the Directors' remuneration and the five highest paid employees of the Group for the Year are set out in Notes 12 and 13 to the consolidated financial statements, respectively.

#### **CHANGE IN INDEPENDENT AUDITOR**

Baker Tilly Hong Kong Limited ("**Baker Tilly**") resigned as the Independent Auditor on 18 April 2018. On 3 July 2018, the Board appointed Deloitte Touche Tohmatsu, Certified Public Accountants, Hong Kong ("**Deloitte**") to fill the casual vacancy as the Independent Auditor until the conclusion of the 2018 AGM.

Deloitte resigned as the Independent Auditor on 14 December 2018. On 19 December 2018, the Board appointed Fan, Chan to fill the casual vacancy as the Independent Auditor until the conclusion of the 2019 AGM. Fan, Chan was re-appointed by the Shareholders at the 2019 and 2020 AGM as the Independent Auditor to hold office until the conclusion of the 2021 AGM.

#### **DIRECTORS' RESPONSIBILITY IN RESPECT OF THE FINANCIAL STATEMENTS**

The Directors acknowledge their responsibility for the preparation of the Financial Statements.

The Directors were aware that the Group incurred a net loss of HK\$769,000 for the Year and as of that date, had accumulated losses of HK\$126,043,000. These conditions indicate the existence of a material uncertainty which may cast significant doubt about the Group's ability to continue as a going concern.

# RISK MANAGEMENT AND INTERNAL CONTROLS

The Audit Committee reviews the adequacy of the Group's internal financial controls, operational and compliance controls, and risk management policies and systems established by the management of the Company (collectively "**internal controls**").

The risk management and internal control systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

For the Year, the Board has conducted a review and assessment of the effectiveness of the Company's risk management and internal control systems, including financial, operational and compliance controls and risk management. Such review has been made by discussion with the Audit Committee, management and the Independent Auditors from time to time, but at least once a year. The Board will put in place to address the identified area that will be enhanced. The Board considers that the existing risk management and internal control systems are adequate and effective.

The Company also has an internal audit function to carry out the analysis and independent appraisal of the adequacy and effectiveness of the systems, and has procedures in place to keep information confidential and manage actual or potential conflicts of interest. Stringent internal structures have been designed to prevent the misuse of inside information and avoid conflicts of interest.

The Audit Committee has received the summarized information on the risk management and internal controls conducted by the internal audit team. The work carried in relation to the identified areas are summarized as follows:

- the results of selective testing of internal control procedures, assets, and financial records of the Company;
- (ii) a general evaluation of risk management and internal control systems installed by the Company; and
- (iii) an outline of major control issues, if any, noticed during the Year.

The Audit Committee has reviewed the reports and discussed with the management.

The Board is responsible for the overall internal control framework and is fully aware of the need to put in place a system of internal controls within the Group to safeguard the interests of the Shareholders and the Group's assets, and to review and monitor the effectiveness of the internal control and risk management systems on a regular basis to ensure that the systems in place are adequate.

#### **DISCLOSURE OF INSIDE INFORMATION**

The Group acknowledges its responsibilities under the SFO and the Listing Rules and the overriding principle that inside information should be announced promptly. The procedures and internal controls for the handling and dissemination of inside information are as follows:

- the Group conducts its affairs with close regard to the disclosure requirement under the Listing Rules as well as the "Guidelines on Disclosure of Inside Information" published by the Securities and Futures Commission of Hong Kong in June 2012;
- the Group has implemented and disclosed its policy on fair disclosure by pursuing broad, non-exclusive distribution of information to the public through channels such as financial reporting, public announcements and the Company's website;
- the Group has strictly prohibited unauthorised use of confidential or inside information; and
- the Group has established and implemented procedures for responding to external enquiries about the Group's affairs, so that only the Executive Directors, the Company Secretary and the financial controller of the Company are authorised to communicate with parties outside the Group.

Sir Kwok Siu Man KR ("**Sir Seaman Kwok**") was nominated by Boardroom Corporate Services (HK) Limited to be the Company Secretary on 28 September 2017 and resigned as the Company Secretary on 27 January 2021. The primary person at the Company with whom Sir Seaman Kwok contacted in respect of the company secretarial matters was Ms. Mancy Wai, the financial manager of the Company.

Sir Seaman Kwok delivered and attended over 15 hours' relevant continuous professional development training during the Year pursuant to rule 3.29 of the Listing Rules.

Upon the resignation of Sir Seaman Kwok as the Company Secretary on 27 January 2021, Ms. Cho Wing Han was nominated by Tricor Services Limited to be the Company Secretary with effect from 20 May 2021.

The members of the Board, Board committees and the Independent Auditor are present to answer Shareholders' questions at the AGMs. The Company will provide Shareholders with relevant information on the resolution(s) proposed at a general meeting in a timely manner in accordance with the Listing Rules. The information provided shall be reasonably necessary to enable the Shareholders to make an informed decision on the proposed resolution(s). As a channel to promote effective communication, the Group maintains a website where the Company's announcements, financial information and other information are posted. Shareholders and investors may write directly to the Company at its principal place of business in Hong Kong with any inquiries.

Pursuant to code provision E.1.2 of the CG Code, the Company will invite/ has invited representatives of the Independent Auditor to attend the 2021 AGM and the chairman of each of the Audit Committee, the Remuneration Committee and the Nomination Committee to attend the forthcoming 2021 AGM to answer Shareholders' questions regarding the conduct of the audit, the preparation and content of the independent auditor's report, the accounting policies and auditors' independence.

Mr. Meng Guangyin, the Chairman, did not attend the Company's 2020 AGM due to other essential business engagements. In order to ensure an effective communication with the Shareholders, the Directors attending the 2020 AGM elected Mr. Liu Jiaqiang, an Executive Director, to chair the meeting on behalf of the Chairman. The respective chairmen and/or members of the Audit Committee, the Remuneration Committee and the Nomination Committee and a representative of the Independent Auditor were present at the 2020 AGM to answer relevant questions from the Shareholders. To mitigate the above, future AGMs will be scheduled earlier to avoid the timetable clashes.

#### PROCEDURES FOR PUTTING FORWARD PROPOSALS AT SHAREHOLDERS' MEETINGS

There is no provision allowing Shareholders to make proposals or move resolutions at the AGMs under the Articles of Association or the laws of the Cayman Islands. However, Shareholders who wish to make proposals or move a resolution may, however, convene an EGM in accordance with the "Procedures for Shareholders to Convene an EGM" set out below.

# PROCEDURES FOR SHAREHOLDERS TO CONVENE AN EGM

Written requisition of any one or more members holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Board or the Company Secretary, to require an EGM to be called by the Board for the transaction of any business specified in such requisition; and such meeting shall be held within two (2) months after the deposit of such requisition. If within twenty-one (21) days of such deposit the Board fails to proceed to convene such meeting, the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company. 主席孟廣銀先生由於其他重要公務未能出席 本公司的二零二零年股東週年大會。為確保與 股東的有效溝通,經出席二零二零年股東週年 大會的董事推舉,執行董事劉加強先生代表主 席主持該會議。各審核委員會、薪酬委員會及 提名委員會主席及/或成員及一名獨立核數師 之代表均有出席二零二零年股東週年大會以 回答股東的相關提問。為緩解上述情況,未來 股東週年大會將提前安排,以避免時間衝突。

- (ii) the Group's actual and future operations and liquidity position;
- (iii) the Group's expected working capital requirements, capital expenditure requirements and future expansion plans;
- (iv) the retained earnings and distributable reserves of the Company and each of the members of the Group; and
- (v) the general economic conditions and other internal or external factors that may have an impact on the business or financial performance and position of the Group.

The payment of dividend by the Company is also subject to any restrictions under the Law of the Cayman Islands, the Articles of Association and any other applicable laws and regulations. The Board will continually review the Dividend Policy from time to time and reserve the right at its sole and absolute discretion to update, amend, and/or modify the Dividend Policy at any time as it deems fit and necessary. The principal activity of the Company is investment holding. Its subsidiaries are principally engaged in (i) the retail and wholesale of watches in Hong Kong, and (ii) the acting as a sales and trading agent of fertilisers raw materials and related fertiliser products.

Pursuant to article 83(3) of the Articles of Association, any Director appointed by the Board to fill a casual vacancy shall hold office until the first general meeting of Shareholders after his appointment and shall be subject to reelection at such meeting and any Director appointed by the Board as an addition to the existing Board shall hold office only until the next following AGM and shall then be eligible for re-election.

Pursuant to article 84(1) of the Articles of Association, one-third of the Directors will retire by rotation at each AGM. In addition, code provision A.4.2 of the CG Code stipulates that each Director shall retire from office by rotation at least once every three years.

Pursuant to article 84(2) of the Articles of Association, the Directors to retire by rotation shall include (so far as necessary to ascertain the number of Directors to retire by rotation) any Director who wishes to retire and not to offer himself for re-election. Any further Directors so to retire shall be those of the other Directors subject to retirement by rotation who have been the longest in office since their last re-election or appointment and so that as between persons who became or were last re-elected or appointed Directors on the same day, those to retire shall (unless they otherwise agree among themselves) be determined by lot. Any Director appointed by the Board pursuant to article 83(3) shall not be taken into account in determining which particular Director or the number of Directors who are to retire by the rotation. Accordingly, Mr. Lee Chun Keung and Mr. Wang Luping will retire from office as Directors by rotation and are eligible to offer themselves for re-election at the 2021 AGM.

The Company has received from each of the INEDs an annual written confirmation of his independence pursuant to Rule 3.13 of the Listing Rules and is not aware of any event undermining their independence. As such, the Company notes that all the INEDs are independent.

All the INEDs were appointed for a specific term of one year, but subject to the relevant provisions of the Articles of Association or any other applicable laws whereby the Directors shall vacate or retire from their office.



Mr. Tian Zhiyuan has renewed a letter of appointment with the Company for a term of one year commencing on 20 September 2020. Mr. Lee Chun Keung and Mr. Wang Luping have renewed letters of appointment with the Company for a term of one year commencing on 14 and 27 December 2020 respectively. The appointment letters of Mr. Tian Zhiyuan and Mr. Lee Chun Keung may be terminated by not less than one month's notice in writing served by either party on the other. The appointment of Mr. Wang Luping can be terminated during the term of appointment by either party with compensation to be made to the other party for the amount of average monthly director's fee multiplied by the number of months of the remaining term of appointment.

Other than Mr. Wang Luping, no Director proposed for re-election at the forthcoming 2021 AGM has an unexpired service contract with the Company which is not determinable by the Company within one year without payment of compensation, other than statutory compensation.

The transaction values for the purchases amounted to approximately HK\$147.0 million. As the Group is considered to be acting as agent in respect of these purchase and sale transactions, the Group recognised commission income of HK\$7,044,000 for acting as agent in these transactions.

Shandong Runyin is ultimately controlled by Mr. Meng, the Chairman and an Executive Director and the ultimate controlling shareholder of the Company. Therefore, Shandong Runyin is an associate of Mr. Meng and thus a connected person of the Company.

The annual cap of the transaction value under the purchase agreement shall not exceed HK\$215 million, HK\$248 million and HK\$285 million for each of the three years ending 30 April 2020, 2021 and 2022, respectively.

#### Purchases of fertilisers from Shandong Nongyuan Nongzi Company Limited\* 山東農源農資有限公司 ("Shandong Nongyuan")

On 23 September 2019, the Company and Shandong Nongyuan entered into a purchase agreement to purchase fertilisers from Shandong Nongyuan and its subsidiaries. During the Year, the Group had purchased fertilisers from Shandong Nongyuan for sale to independent customers. The transaction values of the purchases amounted to approximately HK\$251.6 million. As the Group is considered to be acting as agent in respect of these purchase and sale transactions, the Group recognised commission income of HK\$12,871,000 for acting as agent in these transactions.

As Shandong Nongyuan is a company owned as to 51% by Mr. Meng Xiao who is a cousin of Mr. Meng, Shandong Nongyuan is, therefore, deemed to be a connected person of the Company.

The annual cap of the transaction value under the purchase agreement shall not exceed HK\$365 million, HK\$419 million and HK\$482 million for each of the three years ending 30 April 2020, 2021 and 2022, respectively.

# Resale of crude glycerine to Shandong Fufu New Material Technology Company Limited\* 山東福富新材料 科技有限公司 ("Shandong Fufu")

On 23 September 2019, the Company and Ruixing entered into a supply agreement to sell crude glycerine to the Ruixing Group. During the Year, the Group had purchased crude glycerine from independent suppliers for resale to Shandong Fufu, a subsidiary of Ruixing. The transaction value for the sales amounted to approximately HK\$9.9 million. As the Group is considered to be acting as agent in respect of these purchase and sale transactions, the Group recognised commission income of HK\$1,535,000 for acting as agent in these transactions.

Shandong Fufu is ultimately controlled by Mr. Meng and is, therefore, an associate of Mr. Meng and a connected person of the Company.

The annual cap of the transaction value under the supply agreement shall not exceed HK\$9 million, HK\$10 million and HK\$11 million for each of the three years ending 30 April 2020, 2021 and 2022, respectively.

#### 1. Purpose and Participants

The primary purpose of the Scheme is providing eligible participants with an opportunity to have a personal stake in the Company and to motivate, attract and retain the eligible participants (the "**Participants**") whose contributions are important to the long-term growth and profitability of the Group. Participants of the Scheme include any employees, Executive Directors, non-executive Directors (including INEDs), advisors, consultants of the Company or any of its subsidiaries.

#### 2. Maximum number of Shares available for issue

The maximum number of Shares which may be issued under the Scheme and any other schemes of the Company (excluding options lapsed pursuant to the Scheme and any other schemes of the Company) must not exceed 80,000,000, representing 10% of the issued Shares of the Company as at the Adoption Date and the date of the Annual Report.

#### 3. Acceptance of offer

Offer of a share option shall be deemed to have been accepted by the grantee when the duplicate of the relevant offer letter comprising acceptance of the option duly signed by the grantee together with a remittance in favour of our Company of HK\$1.00 by way of consideration for the grant thereof, is received by the Company within 28 days from the date of the offer.

#### 4. Subscription price

The subscription price for the Shares under the Scheme shall be a price determined by the Board at its sole discretion and notified to the Participant and shall be no less than the highest of (i) the closing price of the Shares as stated in the Stock Exchange's daily quotations sheet on the date on which a Share Option is granted, and (ii) the average of the closing prices of the Shares as stated in the Stock Exchange's daily quotation sheets for the 5 business days immediately preceding the date on which a Share Option is granted; and (iii) the nominal value of a Share.

- (ii) Notwithstanding (i) above, any further grant of share options to a Participant in excess of the 1% limit or the limit mentioned in paragraph (iii) below (as the case may be) shall be subject to approval by our Shareholders in general meeting with such Participant and his or her close associates (or his associates if the participant is a connected person) abstaining from voting. The number and the terms of the share options to be granted to such Participant shall be fixed before the Shareholders' approval and the date of the Board meeting for proposing such further grant should be taken as the date for grant for the purpose of calculating the subscription price.
- (iii) A substantial Shareholder or an INED, or any of their respective associates can be granted options comprising the underlying Shares (a) in aggregate not over 0.1% of the issued Shares or (b) having an aggregate value, based on the closing price of the Shares at the date of the grant, not in excess of HK\$5 million.

#### 6. Exercise of share options

A share option may be exercised in accordance with the terms of the Scheme and such other terms and conditions upon which a share option was granted, at any time during the option period after the share option has been granted by the Board but in any event, not longer than 10 years from the date of grant. A share option shall lapse automatically and not be exercisable (to the extent not already exercised) on the expiry of the option period.

#### 7. Duration of the Scheme

The Scheme will remain valid and effective for a period of 10 years commencing on the Adoption Date, after which period no further share options will be granted but the provisions of the Scheme shall in all other respects remain in full force and effect and share options which are granted during the life of the Scheme may continue to be exercisable in accordance with their terms of issue.

On 4 January 2018, the Company offered to grant to certain Participants options, which were subject to, among others, a refreshment of the scheme mandate limit for the Scheme (the "**Refreshment**"). The resolution concerning the Refreshment was duly passed by the Shareholders at an EGM held on 25 January 2018.

As the offers of the grant of the share options had not been accepted by the selected Participants in accordance with the terms and conditions of the Scheme, no share options were granted and outstanding as at 30 April 2021.

No share options were exercised or cancelled or lapsed during the Year.

#### **EQUITY-LINKED AGREEMENTS**

The Company has not entered into other equity-linked agreements that (i) would or might result in the Company issuing Shares or (ii) would require the Company to enter into any agreements that would or might result in the Company issuing Shares during the Year and up to the date of the Annual Report.

#### **RELIEF OF TAXATION**

The Company is not aware of any relief from taxation available to the Shareholders by reason of their holding of the Shares of the Company.

# MATERIAL EVENT AFTER THE REPORTING PERIOD

The Group did not have any material subsequent event after the reporting period and up to the date of the Annual Report.

We are independent of the Group in accordance with the HKICPA's Code of Ethics for Professional Accountants (the "Code"), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

# MATERIAL UNCERTAINTY RELATED TO THE GOING CONCERN

We draw attention to note 33b to the consolidated financial statements which states that the Group incurred a net loss of HK\$769,000 for the year ended 30 April 2021 and as of that date, had accumulated losses of HK\$126,043,000. These conditions indicate the existence of a material uncertainty which may cast significant doubt about the Group's ability to continue as a going concern. Our opinion is not modified in respect of this matter.

During the year, retail and wholesale of watches in Hong Kong remained one of the main businesses of the Group and was subject to changing consumer demands and market conditions. Such judgement is mainly focused on estimating future store performance of the retail outlets.

Note 1:

The balance of capital reserve comprises the following:

On 23 June 2011, Mr. Lam Man Wah ("Mr. Lam"), one of the previous controlling shareholders of the Company, acquired the non-controlling interests of a subsidiary of the Company from an independent third party. The difference between the fair value of the equity interests acquired and the consideration paid amounting to HK\$1,610,000 was credited to the capital reserve.

On 31 October 2014, Mr. Lam agreed to waive part of its lending to the Group. The waived amount of HK\$14,282,000 was recognised as deemed capital consideration and credited to the capital reserve.

On 9 April 2015, the Company allotted and issued 5,833 and 94,166 of its shares to Ms. Ma Lili and Tic Tac Investment Holdings Limited, a company owned by the previous controlling shareholders, respectively, to acquire their respective shareholding interests in the subsidiaries of the Company.

As a result, a balance of HK\$3,902,000 was credited to the capital reserve representing the difference between the carrying value of the non-controlling interest of Jenus Top International Limited acquired over the nominal value of the share capital of the Company issued in exchange thereof. The combined share capital of the other subsidiaries of the Company of HK\$4,300,000 was reclassified to capital reserve upon the completion of the Group reorganisation.

#### Note 2:

As stipulated by the relevant regulations in the People's Republic of China (the "PRC"), the Company's subsidiaries established and operating in the PRC are required to appropriate 10% of their profit after tax as determined in accordance with the PRC accounting rules and regulations, to the statutory reserve until the reserve balance reaches 50% of the registered capital. The transfer to this reserve must be made before distribution of a dividend to equity owners. The statutory reserve can be used to make good previous years' losses, if any, and may be converted into paid-up capital by issuing additional capital to the owners in proportion to the owners' existing equity holdings, provided that the balance after such conversion is not less than 25% of the registered capital.

按中華人民共和國(「中國」)的相關法規規定,本公 司於中國成立及運營的附屬公司須將其根據中國 會計法例及法規釐定的除税後溢利中撥出10%以 列入法定儲備,直至該儲備結餘達至其註冊資本之 50%。撥款予該儲備金須於向權益擁有人分派股息 前進行。法定儲備金可用於填補過往年度虧損(如 有),並可通過按所有人現有股權比例向所有人發行 額外資本轉換為實收資本,惟該轉換後的結餘不低 於註冊資本的25%。

#### 1. GENERAL INFORMATION

Prosper One International Holdings Company Limited (the "**Company**") is a public limited company incorporated in the Cayman Islands and its issued shares are listed on The Stock Exchange of Hong Kong Limited. The address of its registered office is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman KY1-1111, Cayman Islands.

In the opinion of the directors of the Company, the immediate and ultimate holding company of the Company is Prosper One Enterprises Limited and its ultimate controlling party is Mr. Meng Guangyin, who is also the chairman of the Board of Directors and the chief executive officer of the Company.

The Company acts as an investment holding company and the principal activities of its subsidiaries (together with the Company, the "**Group**") are the retail and wholesale of watches in Hong Kong, and acting as agent (for financial reporting purposes) in the sales and trading of fertilisers raw materials, fertilisers and other related products. The address of the principal place of business of the Company is Level 43, AIA Tower, 183 Electric Road, North Point, Hong Kong effective on 8 May 2020.

The consolidated financial statements are presented in Hong Kong dollars, which is also the functional currency of the Company.

Such practical expedient applies only to rent concessions occurring as a direct consequence of the COVID-19 pandemic and only if all of the following conditions are met:

- The change in lease payments results in revised consideration for the lease that is substantially the same as, or less than the consideration for the lease immediately preceding the change;
- Any reduction in lease payments affects only payments originally due on or before 30 June 2021; and
- There is no substantive change to other terms and conditions of the lease.

The Group has early adopted the amendment on 1 May 2019 and elected not to apply lease modification accounting for all rent concessions granted by the lessors, which occurred as a direct consequence of the COVID-19 pandemic during the years ended 30 April 2021 and 30 April 2020. The rent concessions amounted to HK\$2,571,000 (2020: HK\$2,422,000) have been credited to "Other gains and losses" in the consolidated statement of profit or loss and other comprehensive income for the year ended 30 April 2021.

Thus they continue to adopt the going concern basis of accounting in preparing the consolidated financial statements.

The consolidated financial statements have been prepared on the historical cost basis except for certain financial instruments that are measured at fair values as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 "Share-based Payment", leasing transactions that are within the scope of HKFRS 16 "Leases", and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 "Inventories" or value in use in HKAS 36 "Impairment of Assets".

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

#### **Basis of consolidation**

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Where necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

#### **Revenue recognition**

#### Revenue from contracts with customers

Under HKFRS 15, revenue is recognised when the Group satisfies a performance obligation by transferring control over a product or service to the customer at the amount of promised consideration to which the Group is expected to be entitled under that performance obligation, excluding those amounts collected on behalf of third parties.

Revenue is recognised either at a point in time or over time. HKFRS 15 identifies the following three situations in which control of the promised good or service is regarded as being transferred over time:

- When the customer simultaneously receives and consumes the benefits provided by the Group's performance, as the Group performs;
- When the Group's performance creates or enhances an asset that the customer controls as the asset is created or enhanced; or
- (iii) When the Group's performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

When another party is involved in providing goods or services to a customer, the Group determines whether the nature of its promise is a performance obligation to provide the specified goods or services itself (i.e. the Group is a principal) or to arrange for those goods or services to be provided by the other party (i.e. the Group is an agent).

The Group is a principal if it controls the specified good or service before that good or service is transferred to a customer.

The Group is an agent if its performance obligation is to arrange for the provision of the specified good or service by another party. In this case, the Group does not control the specified good or service provided by another party before that good or service is transferred to the customer. When the Group acts as an agent, it recognises revenue in the amount of any fee or commission to which it expects to be entitled in exchange for arranging for the specified goods or services to be provided by the other party.

- (a) Sale of merchandise Revenue from the sale of merchandise is recognised at a point in time when control of the products is transferred to the customer, generally on delivery of the products.
- (b) Trading of fertilisers raw materials, fertilisers and other related products (the "fertilisers and other products")

The Group determines that the nature of its promise is to arrange for the fertilisers and other products to be provided by the suppliers to the customers and hence, for financial reporting purposes under HKFRS 15, the Group is an agent not a principal. Commission income is recognised at a point in time when the services are rendered.

- (c) Service income on repairing watches The Group provides repair services on watches to customers, which is a single performance obligation. The service income is recognised at a point in time when the service is completed.
- (d) Interest income

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

#### (e) Promotion income

Promotion income is recognised when the Group's right to receive the income has been established.

Investments in subsidiaries are included in the Company's statement of financial position at cost less accumulated impairment losses, if any.

#### Government grants

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received.

Government grants related to income that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable. Such grants are presented under "Other gains and losses".

#### Lease

#### Definition of a lease

A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

For contracts entered into or modified on or after the date of initial application, the Group assesses whether a contract is or contains a lease based on the definition under HKFRS 16 at inception or modification date, as appropriate. Such contract will not be reassessed unless the terms and conditions of the contract are subsequently changed.

#### Short-term leases

The Group applies the short-term lease recognition exemption to leases of various offices, warehouses, equipment and vehicles that have a lease term of 12 months or less from the commencement date and do not contain a purchase option. Lease payments on short-term leases are recognised as expense on a straight-line basis or another systematic basis over the lease term.

#### **Right-of-use assets**

The cost of right-of-use asset includes:

- the amount of the initial measurement of the lease liability;
- any lease payments made at or before the commencement date, less any lease incentives received;
- any initial direct costs incurred by the Group; and

Right-of-use assets are depreciated on a straight-line basis over the shorter of its estimated useful life and the lease term.

#### Refundable rental deposits

Refundable rental deposits paid are accounted for under HKFRS 9 "Financial Instruments" and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments and included in the cost of right-of-use assets.

#### Lease liabilities

At the commencement date of a lease, the Group recognises and measures the lease liability at the present value of lease payments that are unpaid at that date. In calculating the present value of lease payments, the Group uses the incremental borrowing rate at the lease commencement date.

The lease payments include fixed payments less any lease incentives receivable;

After the commencement date, lease liabilities are adjusted by interest accretion and lease payments.

#### **Foreign currencies**

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's operations are translated into the presentation currency of the Group (i.e. Hong Kong dollars) using exchange rates prevailing at the end of each reporting period. Income and expenses items are translated at the average exchange rates for the period. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of translation reserve.

On the disposal of a foreign operation (that is, a disposal of the Group's entire interest in a foreign operation, or a disposal involving loss of control over a subsidiary that includes a foreign operation, or a partial disposal of an interest in a joint arrangement or an associate that includes a foreign operation of which the retained interest becomes a financial asset), all of the exchange differences accumulated in equity in respect of that operation attributable to the owners of the Company are reclassified to profit or loss.

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets until such time as the assets are substantially ready for their intended use or sale.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

## Retirement benefit costs and termination benefits

Payments to the Mandatory Provident Fund Scheme for staff in Hong Kong and state-managed retirement benefit schemes for staff in the PRC are recognised as an expense when employees have rendered service entitling them to the contributions.

#### Short-term employee benefits

Short-term employee benefits are recognised at the undiscounted amount of the benefits expected to be paid as and when employees rendered the services. All short-term employee benefits are recognised as an expense unless another HKFRS requires or permits the inclusion of the benefit in the cost of an asset.

A liability is recognised for benefits accruing to employees (such as wages and salaries, annual leave and sick leave) after deducting any amount already paid.

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from "profit/(loss) before tax" as reported in the consolidated statement of profit or loss and other comprehensive income because of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax base used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are recognised for all deductible temporary difference to the extent that it is probable that taxable profits will be available against which deductible temporary differences are seen be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable differences arising on investments in subsidiaries except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments and interests are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of the reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rate (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For leasing transactions in which the tax deductions are attributable to the lease liabilities, the Group applies HKAS 12 Income Taxes requirements to the leasing transaction as a whole. Temporary differences relating to right-of-use assets and lease liabilities are assessed on a net basis. Excess of depreciation on right-of-use assets over the lease payments for the principal portion of lease liabilities resulting in net deductible temporary differences.

Current and deferred tax are recognised in profit or loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively.

Property, plant and equipment including buildings held for use in the supply of goods or services, or for administrative purposes, are stated in the consolidated statement of financial position at cost less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

Depreciation is recognised so as to write off the cost of assets less their residual values over their estimated useful lives, using the straightline method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on disposal or retirement of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

#### Intangible asset

Club membership with indefinite life is carried at cost less any subsequent accumulated impairment losses.

#### Inventories

Inventories are stated at the lower of cost and net realisable value. Cost of inventories are determined on the weighted average method. Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale.

#### **Provisions**

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, and it is probable that the Group will be required to settle that obligation and a reliable estimate can be made of the amount of the obligation.

The amount recognised as provision is the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation. When a provision is measured using the cash flows estimated to settle the present obligation, its carrying amount is the present value of those cash flows (where the effect of the time value of money is material).

Present obligations arising under onerous contracts are recognised and measured as provisions. An onerous contract is considered to exist where the Group has a contract under which the unavoidable costs of meeting the obligations under the contract exceed the economic benefits expected to be received from the contract.

## Impairment on tangible, intangible assets and right-of-use assets

At the end of the reporting period, the Group reviews the carrying amounts of its tangible assets and right-of-use assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the relevant asset is estimated in order to determine the extent of the impairment loss (if any). Intangible assets with indefinite useful lives are tested for impairment at least annually, and whenever there is an indication that they may be impaired.

The recoverable amount of tangible, intangible assets and right-of-use assets are estimated individually, when it is not possible to estimate the recoverable amount of an asset individually, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs. When a reasonable and consistent basis of allocation can be identified, corporate assets are also allocated to individual cashgenerating units, or otherwise they are allocated to the smallest group of cash-generating units for which a reasonable and consistent allocation basis can be identified.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset (or a cash-generating unit) for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or a cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or a cash-generating unit) is reduced to its recoverable amount. In allocating the impairment loss, the impairment loss is allocated first to reduce the carrying amount of any goodwill (if applicable) and then to the other assets on a pro-rata basis based on the carrying amount of each asset in the unit. The carrying amount of an asset is not reduced below the highest of its fair value less costs of disposal (if measurable), its value in use (if determinable) and zero. The amount of the impairment loss that would otherwise have been allocated to the asset is allocated pro rata to the other assets of the unit. An impairment loss is recognised immediately in profit or loss.

A reversal of an impairment loss is recognised immediately in profit or loss.

#### **Financial instruments**

Financial assets and financial liabilities are recognised when a group entity becomes a party to the contractual provisions of the instrument. All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the market place.

Financial assets and financial liabilities are initially measured at fair value except for trade receivables arising from contracts with customers which are initially measured in accordance with HKFRS 15. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets or financial liabilities at fair value through profit or loss ("**FVPL**")) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at FVPL are recognised immediately in profit or loss.

#### Investments and other financial assets

#### Initial recognition and measurement

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost, fair value through other comprehensive income ("**FVOCI**"), and FVPL.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value, plus in the case of a financial asset not at FVPL, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a Significant financing component, the Group initially measures a financial asset at its fair value, plus in the case of a financial asset not at FVPL, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under HKFRS 15 in accordance with the policies set out for "Revenue recognition".

In order for a financial asset to be classified and measured at amortised cost or FVOCI, it needs to give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding.

For debt investments at FVOCI, interest income, foreign exchange revaluation and impairment losses or reversals are recognised in the consolidated statement of profit or loss and computed in the same manner as for financial assets measured at amortised cost. The remaining fair value changes are recognised in other comprehensive income. Upon derecognition, the cumulative fair value change recognised in other comprehensive income is recycled to the consolidated statement of profit or loss.

#### Financial assets at FVPL

Financial assets at FVPL include financial assets held for trading, financial assets designated upon initial recognition at FVPL, or financial assets mandatorily required to be measured at fair value. Financial assets are classified as held for trading if they are acquired for the purpose of selling or repurchasing in the near term. Derivatives, including separated embedded derivatives, are also classified as held for trading unless they are designated as effective hedging instruments. Financial assets with cash flows that are not solely payments of principal and interest are classified and measured at FVPL, irrespective of the business model. Notwithstanding the criteria for debt instruments to be classified at amortised cost or at FVOCI, as described above, debt instruments may be designated at FVPL on initial recognition if doing so eliminates, or significantly reduces, an accounting mismatch.

Financial assets at FVPL are carried in the consolidated statement of financial position at fair value with net changes in fair value recognised in the consolidated statement of profit or loss.

This category includes equity investments which the Group had not irrevocably elected to classify at FVOCI. Dividends on equity investments classified as financial assets at FVPL are also recognised as other income in the consolidated statement of profit or loss when the right of payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably.

#### Impairment of financial assets

The Group recognises an allowance for the "expected credit loss" ("ECL") for all debt instruments not held at FVPL. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

#### General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12-months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

A financial asset is credit-impaired when one or more events of default that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- (a) significant financial difficulty of the issuer or the borrower;
- (b) a breach of contract, such as a default or past due event;
- (c) the lender(s) of the borrower, for economic or contractual reasons relating to the borrower's financial difficulty, having granted to the borrower a concession(s) that the lender(s) would not otherwise consider;
- (d) it is becoming probable that the borrower will enter bankruptcy or other financial reorganisation; or

Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. A write-off constitutes a derecognition event. Any subsequent recoveries are recognised in profit or loss.

Debt investments at FVOCI and financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade receivables which apply the simplified approach as detailed below.

For trade receivables that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

#### Financial liabilities and equity instruments

Debt and equity instruments issued by a group entity are classified as either financial liabilities or as equity in accordance with the substance of the contractual arrangements and the definitions of a financial liability and an equity instrument.

#### **Equity instruments**

An equity instrument is any contract that evidences a residual interest in the assets of the group after deducting all of its liabilities. Equity instruments issued by the Group are recognised at the proceeds received, net of direct issue costs.

#### **Financial liabilities**

All financial liabilities are subsequently measured at amortised cost using the effective interest method or at FVPL.

#### Financial liabilities at amortised cost

Financial liabilities (including trade and other payables, bank loans and amount due to ultimate holding company) are subsequently measured at amortised cost, using the effective interest method.

#### Derecognition

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity. # Principal versus agent considerations for trading of fertilisers and other products

Determining whether the Group is acting as a principal or as an agent, for financial reporting purposes, in the sales of goods requires exercise of judgement and consideration of all relevant facts and circumstances. In the evaluation of whether the Group is acting as a principal or an agent, the Group noted that it does not obtain control of the fertilisers and other products from the suppliers before passing on to customers. The Group also considers, individually and in combination, whether the Group is primarily responsible for fulfilling the promise to provide the fertilisers and other products, is subject to inventory risk and has discretion in establishing prices for the goods. Significant judgement is required when making these considerations. Having considered the relevant facts and circumstances, management considers that the Group does not obtain control in respect of the trading activities involving the fertilisers and other products. Accordingly, the Group considers that for financial reporting purposes, it is acting as an agent for sale and trading of fertilisers and other products and the corresponding revenue is presented on a net basis.

The Group will increase the depreciation charge where useful lives are less than previously estimated lives, or will write off or write down technically obsolete or non-strategic assets that have been abandoned or sold. The Group tests annually whether its property, plant and equipment and right-of-use assets have suffered any impairment in accordance with the Group's accounting policies. The assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount of the assets exceeds its recoverable amount. The recoverable amount of an asset or a cash-generating unit is determined based on value in use calculations which require the use of assumptions and estimates.

#### Sales of merchandise

The performance obligation is recognised at a point in time when control of the products is transferred to the customer, being at the point the customer purchases the goods at the store or on delivery of the merchandise for wholesale segment. Payment of the transaction price is due immediately and within 90 days at the point the customer purchases the products under the retail and wholesale segments, respectively.

#### Service income

The Group provides services on repairing watches to customers. The performance obligation is satisfied at a point in time when the service is completed and advance payments are normally required before rendering the services. The Group's enforceable right to the payment is subject to the completion of the whole services. The services are for periods less than one year.

#### **Commission income**

The performance obligation is completed at a point in time when the services on arranging trading of fertiliser and other related products are completed. Payment is generally in advance from the customers before the agency services are provided.

As at the end of the reporting periods, the Group did not have significant amount of unrecognised revenue related to performance obligations which were unsatisfied.

As at the end of the reporting period, the directors of the Company have (a)conducted impairment assessment on recoverable amounts of the Group's leasehold improvements and right-of-use assets which are used in the Group's retail business of watches, in view of the continuous unfavorable operating results from that business. The Group's retail business has been adversely impacted by the outbreak of COVID-19 pandemic since January 2020. The management estimated the recoverable amount of each of the retail outlets, each representing an individual cash-generating unit, to which the assets belonged. The recoverable amounts of the cash-generating units have been determined based on value in use calculations. The discount rate in measuring the amount of value in use was 12% (2020:12%).

Based on the results of the impairment assessments, the management estimated that most of the retail outlets would not generate positive net cash inflows in the future and hence the recoverable amounts of the relevant leasehold improvements and right-of-use assets belonging to these retail outlets were insignificant. Accordingly, impairment losses of HK\$nil (2020: HK\$463,000) and HK\$1,355,000 (2020: 18,383,000) have been recognised on property, plant and equipment and right-of-use assets respectively for the year ended 30 April 2021 and included in "selling and distribution costs".

#### Defined contribution plans

The Group operates a Mandatory Provident Fund Scheme for all qualifying employees in Hong Kong. The assets of the scheme are held separately from those of the Group, in funds under the control of trustees. The Group contributes 5% of relevant payroll costs or up to a maximum of HK\$1,500 per month to the Scheme, which contribution is matched by employees.

The qualifying employees in the PRC of the Group are members of a state-managed retirement benefit scheme operated by the PRC government. The Group is required to contribute a specified percentage of payroll costs to the retirement benefit scheme to fund the benefits. The only obligation of the Group with respect to the retirement benefit scheme is to make the specified contributions.

Pursuant to the board resolution passed on 4 January 2018, the Board resolved to grant 80,000,000 share options (the "Share Option Plan") in total to employees and business associates of the Company (the "Grantees"), subject to acceptance of the Grantees, to subscribe for a total of 80,000,000 ordinary shares of HK\$0.01 each in the capital of the Company. The Share Option Plan was approved by the Shareholders by way of poll at the Extraordinary General Meeting held on 25 January 2018.

The share options granted under the Share Option Plan were not accepted by the Grantees. As a result, no share options were recognised as granted and outstanding as at 30 April 2021 and 2020.

The capital structure of the Group consists of debt, which includes the bank loans disclosed in note 26, amount due to ultimate holding company and lease liabilities, net of cash and cash equivalents and equity attributable to owners of the Company, comprising issued share capital and reserves.

The directors of the Company reviews the capital structure from time to time. As a part of this review, the directors of the Company consider the cost of capital and the risks associated with the share capital and bank loans. #### Sensitivity analysis

The sensitivity analysis below details the Group's sensitivity to a 5% (2020: 5%) increase in the functional currency of the relevant group entities, Renminbi, relative to respective foreign currency, USD. The sensitivity analysis includes only foreign currency denominated monetary items and adjusts their translation at the end of the reporting period for a 5% (2020: 5%) change in the foreign currency rates. #### Interest rate risk

The Group is exposed to cash flow interest rate risk in relation to variable-rate bank balances, and bank loans. It is the Group's policy to keep a portion of its financial assets and financial liabilities at floating rate of interests so as to minimise the fair value interest rate risk. The Group's cash flow interest rate risk is mainly concentrated on the fluctuation of interest rates on bank balances and HIBOR arising from the Group's Hong Kong dollar denominated borrowings.

The sensitivity analysis below has been determined based on the exposure to interest rates for the Group's variable-rate bank balances and bank loans. The analysis is prepared assuming the variable-rate bank balance and bank loans outstanding at the end of the reporting period were outstanding for the whole year. A 50-basis point on bank loans (2020: 50-basis point) and 10-basis point on bank balances (2020: 10-basis point) increase or decrease in the interest rates is the sensitivity rate used when reporting interest risk internally to key management personal and represent the management's assessment of the reasonably possible change in interest rates.

If the interest rate on bank balances had been 10 basis point (2020: 10 basis point) higher/lower and all other variables were held constant, the Group's post tax loss for the year would have decreased/increased by approximately HK\$11,000 (2020: HK\$17,000).

As at 30 April 2021, if the interest rate on bank loans had been 50 basis point higher/lower and all other variables were held constant, the Group's post tax loss for the year would have increased/decreased by approximately HK\$43,000 (2020: HK\$35,000).

#### Credit risk and impairment assessment

The carrying amounts of the respective recognised financial assets as stated in the consolidated statement of financial position best represent the Group's maximum exposure to credit risk which will cause a financial loss to the Group due to failure to discharge an obligation by the counterparties.

In order to minimise the credit risk, the Group has delegated a team responsible for the determination of credit limits and credit approvals.

The directors of the Company have given careful consideration to the future liquidity and performance of the Group and its available sources of financing in assessing whether the Group has sufficient financial resources to continue as a going concern. In the opinion of the directors, the Group will be able to continue to operate as a going concern in the foreseeable future, after taking into consideration the following factors:

- As at 30 April 2021, the Group had total banking facilities of approximately HK\$13,326,000 (2020: HK\$15,688,000), which has not been drawn down as bank borrowings.
- The ultimate holding company has confirmed that it will provide financial support to the Group to finance its operations for at least twelve months from the end of the reporting period and not to recall the loan provided to the Group until the Group has the ability to repay.
