

EQUITY ATTRIBUTABLE TO EQUITY SHAREHOLDERS OF THE COMPANY HK\$'000





Chairman's Statement 主席報告

Dear Shareholders,

Year 2021 has been a most extraordinary year for the Chinese economy. During the year, the COVID-19 pandemic continued to plague the world. 

OPERATING RESULTS

In 2021, the epic changing international scene was evolving at an increasing pace, while the once-in-a-century pandemic continued to ravage. Thanks to the substantial progress in vaccination across various countries, coupled with stimulus measures which had a boosting effect on retail spending and investment, the world economy negotiated a trend-bucking recovery amidst complicated international situations. As the first major economy to emerge from the shadow of the epidemic with the most comprehensive recovery in industrial chain, China provided a strong driving force for global economic recovery with its rapid economic pick-up and became a new engine heralding world economic growth, particularly through active promotion of the low-carbon green economic development model.

Reviewing 2021, the Chinese government unprecedentedly included Dual Carbon in its overall planning for the construction of ecological civilisation and developed a new "low-carbon green industry" in terms of policy, market and technology with consistently enriched substance. In connection with policy, the building of "1+N" policy regime was accelerated and the timetable and roadmap for Dual Carbon targets were planned. In connection with the market, a system of carbon trading rules was developed and improved and the China Carbon Emission Trade Exchange and its first contract fulfillment cycle was officially commenced. In connection with the technology, the "Action Plan for Technology-supported Carbon Peak and Carbon Neutrality" was drafted in a bid to create breakthrough with a special focus on critical low-carbon green technologies. The combined effect of these factors has rendered the low-carbon green industry a new blue ocean market. With its double attributes of pollution alleviation and carbon reduction in close tandem with the national Dual Carbon development strategy, the environment business continues to embrace favorable opportunities for development.

經營業績

二零二一年,百年變局加速演進,世紀疫情持續延宕。得益於各國在疫苗接種方面取得重要進展,有力的刺激措施對消費和投資起了提振作用,世界經濟在錯綜複雜的國際形勢中逆勢復甦。作為最早走出疫情陰霾,產業鏈恢復最完善的主要經濟體,中國經濟快速回暖為世界經濟復甦注入強大動能,尤其是積極倡導的綠色低碳經濟發展模式,成為引領世界經濟增長的新引擎。

As a provider of specialised environmental protection services in China, the Group laid out plans for a new phase of qualitative development and achieved steady development in various business segments in 2021, persisting in prudent progress with a special focus on management enhancement and emphasis on innovation- and reform-driven measures in ongoing firm adherence to the corporate mission of being "Devoted to Ecology and Environment for a Beautiful China" and the corporate vision of endeavouring to "Create Better Investment Value and Undertake More Social Responsibility".

作為一家中國專業環保服務提供商,二零二一年,本集團繼續秉承「情繫生態環境,築夢美麗中國」的企業願景,踐行「創造更好投資價值,承擔更多社會責任」的企業追求,堅持穩中求進, 聚焦管理提升,突出創改驅動,為新一輪高質量發展謀篇佈局,實現各項業務穩健發展。

The Group is principally engaged in the businesses of integrated biomass utilisation, hazardous and solid waste treatment, environmental remediation, solar energy and wind power. As of 31 December 2021, the Group had 136 environmental protection projects with a total investment of approximately RMB32.669 billion and had undertaken 42 environmental remediation projects, with a total contract amount of approximately RMB1.165 billion.

本集團主營業務包括生物質綜合利用、危廢及固廢處置、環境修復、光伏發電及風電等。截至二零二一年十二月三十一日,本集團已落實環保項目136個,總投資額達約人民幣326.69億元,累計承接環境修復項目42個,涉及總合同金額約人民幣11.65億元。

In terms of market development, the Group was engaged in full-gear efforts towards business transformation. The integrated biomass utilisation business has been transforming towards a value-added business model, while continuous progress was made in the heat supply market. The hazardous and solid waste treatment business was steadily transforming to the role of an industrial environmental protection service provider alongside the end-of-life tyre disposal project obtaining further success. In our first move to deploy in the solar energy market since our spinoff listing, we expanded our distributed rooftop solar energy business by advancing projects on a county-wide basis, while making our business debut in the Hong Kong market. Moreover, the Group engaged in in-depth research of market opportunities in the strategic context of Dual Carbon in an active bid to explore new commercial models and growth niches.

市場拓展方面,本集團全力推動轉型發展。生物質綜合利用業務向高附加值方向轉型,供熱市場開發工作持續推進;危廢及固廢處置業務穩步向工業環保服務商轉型,廢舊輪胎處置項目再下一城;並自分拆上市以來首次佈局光伏市場,拓展分佈式屋頂光伏整縣推進項目,業務版圖首次延伸至香港地區。此外,本集團深入研究雙碳戰略背景下的市場機遇,積極探索新的商業模式,謀求打造新的增長極。

During the year under review, the Group secured 17 new projects and entered into 2 supplementary agreements for biomass heat supply, involving an additional total investment of approximately RMB1.2 billion and environmental remediation projects with a contract amount of approximately RMB150 million. Such new projects included 3 integrated biomass utilisation projects, 1 hazardous and solid waste treatment project, 13 solar energy projects and 6 environmental remediation projects. In terms of project scale, our capacity for power generation was increased by 39.07 MW, daily household waste processing capacity was increased by 1,300 tonnes, while our designed capacity for steam supply and hazardous and solid waste treatment were increased by approximately 600,000 tonnes and 100,000 tonnes per annum, respectively.

In terms of project construction, the Group continued to ensure steady progress in the construction work of its projects in adherence to the 7 principles of "productivity, efficiency, quality, cost-effectiveness, legitimacy, safety and integrity", deliberating and exploring new construction plans to accommodate new project types. During the year under review, 17 new projects started implementation while 28 projects had completed construction and commenced operation. As at 31 December 2021, the Group had 23 projects under construction or implementation, including 10 hazardous and solid waste treatment projects and 13 environmental remediation projects. With a strong emphasis on construction safety, construction quality and work scheduling for projects under construction, the Group has enhanced safety management at project sites through ongoing optimisation of its construction management system and framework.

工程建設方面,本集團貫徹工程建設「多快好省法安廉」七字訣,針對新的項目類型鑽研和探索新的施工方案,穩步推進旗下項目工程建設。於回顧年度內,新執行或開工項目17個,完工及投運項目28個。於二零二一年十二月三十一日,本集團在建或執行中的項目共23個,包括10個危廢及固廢處置項目及13個環境修復項目。本集團高度重視在建項目施工安全、建造品質和建設進度,通過不斷優化工程管理制度架構,提高施工現場管理水平。

In terms of technology research and development, the Group emphasises technological innovation as the driving force for the Company's development, as all technological research underway are in tandem with the requirements of the Company's business transformation. During the year under review, the Group's research effort focused on carbon neutrality, solar energy storage and charging integration, recycled use of bulk industrial solid waste, remediation of old landfill sites, end-of-life tyre recycling and incineration of hazardous waste with high sulphuric and halogenic contents, which provided support for the technical feasibility of its new business categories. During the year under review, the project for the "Development and Application of Safe, Clean and Efficient Incineration Technology for General Combustible Industrial Solid Waste", an international cooperation project in technology innovation of the Group under the National Key Research and Development Programme, commenced successfully with preliminary completion of interim tasks. As of 31 December 2021, the Group held 205 authorised patents, including 25 invention patents, 175 utility model patents, and 5 software copyrights.

In terms of operational management, the Group is committed to enhancing its operational safety level by improving the quality and efficiency of its project operations through delicacy management. During the year under review, the Group rolled out trial operations of autonomous fuel intake and storage projects for 5 integrated biomass utilisation projects and explored means to curb fuel prices and improve fuel quality, providing assurance for the new model of fuel supply. To enhance operating efficiency, the Group rolled out benchmarking management on all fronts during the year under review to procure the application of uniform, standardised, timely and accurate key benchmarks for the production management system, whereby benchmarking and ranking among commenced projects were conducted regularly such that backward projects would benchmark themselves against advanced counterparts to make up for the gap so as to improve their economic efficiency for a more solid foundation for delicacy management. During the year under review, the Group continued to deepen the implementation of its environmental, safety, health and social responsibility ("ESHS") management system by drafting safety management standards for high-risk operations to supplement the regime of safety management systems. In-depth effort was made to the commencement of investigation and treatment of hazards to reduce the risk of accidents. Information on pollutant discharge by project companies was monitored on a real-time basis to facilitate environmental management in a more regulated manner and assist in the Company's effective management of ESG risks.

Management Discussion and Analysis 管理層討論及分析

In terms of risk management, the Group has applied risk assessment in the full process of market development, project construction and project operation, and has consistently enhanced the effectiveness of its risk assessment and its risk management standard. During the year under review, the Group formulated "Greentech Risk Appetite 2021" and conducted comprehensive risk inspection of its project companies. Risk statistics and audit on various aspects such as contract management and performance, financial management, production safety and emission compliance, among others, were conducted and a "Risk and Internal Control Management Report" was drawn up to furnish recommendations in operations and compliance to the project companies. During the year under review, the Group achieved notable results in risk management by drawing on the prospective and precautionary natures of risk management.

In 2021, the Group's operating activities were considerably affected by the pandemic. As a result of delays in the export trade for plate materials owing to the pandemic, the supply of processing residues such as bark and scrap among raw materials required in the integrated biomass utilisation business decreased and fuel prices were on the rise. Affected by the suspension or reduced production of upstream waste-generating enterprises, the volume and unit price for processing of the hazardous and solid waste treatment business registered declines. To address these impacts, the Group conducted trial operation of a voluntary biomass fuel collection and storage system to develop a model of fuel acquisition directly connected to the source of fuel supply, in order to safeguard fuel supply and lower fuel prices. The hazardous and solid waste treatment business maintained its customer resources through regional modulation centres on the back of the "major customer" regime, while enhancing information and resource sharing among marketing staff of various projects to increase market shares.

風險管理方面,本集團將風險評估應用於市場拓展、工程建設和項目運營全流程,並不斷增強風險評估效果,提高風險管理水平。於回顧年度內,本集團編製《綠色環保2021年度風險偏好》,對旗下項目公司進行了全面性風險檢查,並開展了風險點統計工作,圍繞合同管理與履行、財務管理、安全生產、達標排放等多個方面進行審計,並已記錄在《風險及內控管理報告》,以此向各項目公司提出運作及經營合規方面的建議。於回顧年度內,本集團切實發揮風險管理的前瞻性和預警作用,風險管控效果顯著。

二零二一年,疫情對本集團經營活動帶來一定程度的影響。由於疫情使板材出口貿易受阻,生物質綜合利用業務所需的原料中樹皮、邊角料等加工剩餘物減少,燃料價格上漲。危廢及固廢處置業務受到上游產廢企業停工或減產影響,處理單價有所下滑。針對這些影響,本集團試點生物質燃料自主收儲體系,建立直接與燃料供應源頭聯繫的燃料收購模式,保障燃料供應,降低燃料價格。危廢及固廢處置業務依託「大客戶」體系,通過區域調度中心維護客戶資源,加強項目間市場拓展人員的資訊互通、資源分享,提升市場佔有率。

In 2021, the Group continued to enhance the development of its ESG competence and fulfill its social responsibility as an established environmental business and contribute its strengths to China's green and sustainable development, winning critical acclaim from the community. During the year under review, the Group received the "EcoChallenger" certificate and the "3 Years + EcoPioneer" logo in the "BOCHK Corporate Environmental Leadership Awards 2020" jointly organised by the Federation of Hong Kong Industries and Bank of China (Hong Kong) Limited, was awarded the "Special Mention for ESG in the Non-Hang Seng Index (Small Market Capitalization) Category" in the "Best Corporate Governance and ESG Awards 2021" presented by the HKICPA, received the "Best Case Study Award of Corporate Governance of China Enterprise 2021" in the "Gold ESG Awards 2021" by Cailianpress, and the "Most Investment Value Award in the Greater Bay Area" in "The Greater Bay Area Navigation Award" by Hong Kong Ta Kung Wen Wei Media Group.

As a member of the Standing Executive Committee of the Biomass Energy Branch of China Association for the Promotion of Industrial Development ("BEIPA"), the Group worked in tandem with BEIPA in the development of "Group Standards under the Voluntary Greenhouse Gas Emission Reduction Audit Guide for Biomass Energy and Power Generation Projects" during the year under review to support the national initiatives of Dual Carbon. To ensure healthy and sustainable development of the industry, we have formulated the "Propositions Relating to Regulations for Automatic Monitoring Data Marking of Pollutant Discharge Entities in Thermal Power, Cement and Paper Industries (Trial)" for timely submission to competent industry authorities. With a strong emphasis on close liaison with industry associations and competent industry authorities, the Group is committed to driving qualitative development of the industry as a whole through industry associations.

二零二一年,本集團繼續加強環境、社會和管治能力建設,立足環保事業,承擔社會責任,為中國的綠色可持續發展事業貢獻自己的力量,受到社會的廣泛讚譽。於回顧年度內,本集團榮獲主業總會與中國銀行(香港)有限公司聯合主辦的「中銀香港企業環保領先大獎2020」的「環保養秀企業」證書及「3年+環保先驅」標誌;獲得香港會計師公會頒發的「2021最佳企業管治及ESG大獎」的「ESG報告評判嘉許一非恆生指數成份股(小市值)組別」;榮獲財聯社舉辨的「2021年度中國企業ESG『金E獎』評選」中「2021中國企業最佳公司治理案例獎」的殊榮;及香港大公文匯傳媒集團主辦的「領航『9+2』第二屆粵港澳大灣區最具投資價值獎」的殊榮。

作為中國產業發展促進會生物質能產業分會(「生物質能產業促進會」)的常務理事單位,於回顧年度內,本集團配合生物質能產業促進會,開發《生物質能發電項目溫室氣體自願減排核算指南團體標準》,為國家雙碳提供助力;為保證行業健康可持續發展,編製了《關於對《火電、水泥和造紙行業排污單位自動監測數據標記規則(試行)》的相關建議》,並適時呈遞行業主管部門。本集團重視與行業協會及行業主管部門的聯繫,致力於通過行業協會推動行業整體向更高質量發展。

The Group firmly believes that commitment to public accountability and acceptance of public scrutiny are requisite conditions for driving the sustainable development of an ecological and environmental enterprise. During the year under review, the Group continued to fulfill the responsibility of opening its environmental facilities to the public with more intensive actions and facilitated disclosure of environmental information with a high level of transparency, as flue emission and sewage discharge data of all projects in operation, among others, were synchronised with and instantly uploaded to government regulatory platforms, while environmental impact assessment reports and environmental surveillance data of projects were also disclosed to the public via various media for governmental and public supervision. Our environmental facilities were open to the public on a normalised basis. As of 31 December 2021, a total of 44 projects were officially opened to the public and 248 offline open-to-the-public activities was held, receiving a total of 4,500 visitors, while 1 online open-house activity was also hosted, attracting more than 9,785 views.

The Group continued to enhance project management at the preparatory stage and drive steady progress of project construction. In connection with operation services, our focused effort in quality and efficiency enhancement with ongoing optimisation of our production technology indicators to accommodate the new market environment has driven continuous growth in revenue from operation services. During the year under review, the Group's revenue amounted to approximately HK\$8,446,999,000, which represented a 14% decrease compared to HK\$9,835,376,000 for 2020. EBITDA decreased by 7% to approximately HK\$2,837,942,000 compared to HK\$3,064,595,000 for 2020. Profit attributable to equity shareholders of the Company for the year was approximately HK\$1,110,385,000, decreasing by 26% compared to HK\$1,502,532,000 for 2020. Basic earnings per share for 2021 was HK53.74 cents, HK18.98 cents less compared to HK72.72 cents for 2020. The Group was backed by ready access to various financing options and ample cash flow with sound financial indicators. As at the end of the year, cash and bank balances amounted to approximately HK\$2,644,110,000 and total bank loan facilities amounted to HK\$24,334,199,000, including unutilised bank loan facilities of HK\$7,907,465,000. The aggregate amount of available cash and unutilised bank loan facilities was approximately HK\$10,551,575,000.

The decrease in revenue and profit attributable to equity holders reflected primarily the Group's proactive adjustment of its development strategy to accommodate changes in national policies and market developments, which resulted in the decline in revenue and profit from construction services. Profit contributions from operations were also affected by rising prices for biological raw materials and the decline in unit prices for hazardous and solid waste treatment. Meanwhile, the volumes of on-grid electricity through integrated biomass utilisation, household waste processed, steam supply and hazardous and solid waste treatment continued to rise in line with the growth in projects under operation, driving the increase in revenue from operation services by 25% from HK\$5,098,641,000 for 2020 to HK\$6,350,948,000 for the year.

In January 2021, the Company received the notice of registration acceptance issued by the National Association of Financial Market Institutional Investors in respect of the Company's application for the proposed issuance of ABN with the maximum registered principal amount of RMB2 billion in the national inter-bank bond market in the People's Republic of China (the "PRC"). The registered principal amount shall be valid for 2 years from the date of the notice of registration acceptance, being 27 January 2021. The targeted subscribers for the ABN shall be institutional investors in the national inter-bank bond market in the PRC. The ABN shall be traded in the national inter-bank bond market.

於二零二一年一月,本公司收到由中國銀行間市場交易商協會就本公司申請於中華人民共和國(「中國」)全國銀行間債券市場建議發行註冊本金金額上限為人民幣20億元資產支持票據而發出的接受註冊通知書,而此註冊本金金額將於接受註冊通知書日期(即二零二一年一月二十七日)起有效,為期兩年。資產支持票據發行對象為全國銀行間債券市場內的機構投資者。有關資產支持票據將於全國銀行間債券市場流通。

In April 2021, the Company completed the issuance of the first ABN with the receivables in connection with State Subsidies as underlying assets (the "ABN Series I 2021"). The ABN Series I 2021 has an issue size of RMB589 million and a term of 3 years, subject to revolving purchase arrangements, with the first 2 years being the revolving purchase period. The issue size of the preferred ABN is RMB569 million, accounting for 96.6% of the total issue size and carrying a coupon rate of 4.05%. The issue size of the subordinated ABN is RMB20 million. Proceeds from the issuance of ABN Series I 2021 will be applied as replenishment of general working capital or for the repayment of borrowings to financial institutions. As at 31 December 2021, the unissued registered capital of the Company's remaining ABN with State Subsidies receivables as underlying assets amounted to RMB1,411 million.

In July 2021, the Company completed the issuance of second tranche of medium-term notes, namely the 2021 Green Medium-term Note (Series 1) (Bond Connect/Carbon-neutral Bond/Rural Vitalisation) (the "2021 Green Medium-term Notes (Series 1)") for an amount of RMB1 billion with a maturity period of 3+2 years at a coupon rate of 3.5% per annum for the first 3 years. The Company shall be entitled to adjust the coupon rate of the 2021 Green Medium-term Notes (Series 1) on the third anniversary of the issuance date. The adjusted coupon rate shall remain unchanged for the last 2 years. The proceeds from issuance of the 2021 Green Medium-term Notes (Series 1) will be used for the repayment of project loan of relevant agricultural and forestry integrated biomass utilisation projects. As at 31 December 2021, the Company's outstanding medium-term notes had an unissued registered principal amount of RMB1.5 billion.

In October 2021, the Company further disposed receivables amounting to RMB193 million in connection with the State Subsidies as underlying assets under the ABN Series I 2021. The further disposal can help replenish the working capital of the Group within a reasonable time, and enable the Group to optimize its financing structure and manage its overall financing cost within a reasonable range.

BUSINESS REVIEW AND PROSPECT

Business Review

During the year under review, revenue generated from integrated biomass utilisation, hazardous and solid waste treatment, environmental remediation and solar energy and wind power segments amounted to approximately HK\$8,446,999,000 in aggregate, comprising approximately HK\$1,736,617,000 from construction services, representing a 61% decrease compared to HK\$4,462,629,000 for 2020, and approximately HK\$6,350,948,000 from operation services, representing a 25% increase compared to HK5,098,641,000 for 2020. Analysed by nature of revenue, construction services, operation services and finance income accounted for 21%, 75% and 4%, respectively, of the total revenue.

業務回顧

於回顧年度內,生物質綜合利用、危廢及固廢處置、環境修復和光伏發電及風電分部的收益合計達約港幣8,446,999,000元,其中建造服務收益約港幣1,736,617,000元,較二零二零年之港幣4,462,629,000元減少61%,至於運營服務收益約為港幣6,350,948,000元,較二零二零年之港幣5,098,641,000元增加25%。按收益性質分析,建造服務、運營服務及財務收入分別佔總收益21%、75%及4%。

The Group remains committed to enhancing value for the shareholders of the Company (the "Shareholders"). To reward the Shareholders for their support while taking into account the Group's long-term sustainable development, the Board has recommended a final dividend of HK4.0 cents per share for the year ended 31 December 2021 (2020: HK7.0 cents per share) to the Shareholders.

Integrated biomass utilisation

The Group mainly utilises biomass raw materials to generate both electricity and heat. Biomass raw materials are categorised into yellow culms and grey culms. Yellow culms consist of agricultural residues, such as wheat straw, rice straw, corn straw, rice husks, peanut husks, etc.; while grey culms consist of forestry residues such as branches, barks and other manufacturing wood wastes, etc. In addition, the Group has developed a unique business model of urban-rural integration combining the construction of integrated biomass utilisation projects and waste-to-energy projects for integrated treatment of agricultural and forestry residues and rural household wastes in a pioneering attempt at treatment of the ecological environment in county areas. The unique advantage of the Group's urban-rural integration model means that it could significantly lower the operating costs of the project and enhance our competitiveness in the industry.

The comprehensive biomass raw material supply regime has safeguarded sufficient fuel supply for and stable operation of the integrated biomass utilisation projects, while the Group has also curbed fuel cost by acquiring biomass raw materials in nearby regions through regional coordination initiatives.

生物質綜合利用

本集團主要利用生物質原材料發電及供熱。生物質原材料分為黃稈和灰稈,黃稈主要為農業廢棄物,如麥稈、稻稈、玉米稈、稻殼、花生殼栗之。 灰稈主要為林業廢棄物,如樹枝、樹皮及其他的 產木材廢料等。除此之外,本集團開發出獨特則 城鄉一體化業務模式,將生物質綜合利用項目則 垃圾焚燒發電項目融為一體建設,統籌處理農林 廢棄物及農村生活垃圾,開創了縣域生態環境 理的先河。本集團的城鄉一體化模式獨具優勢,可以顯著降低項目的運營成本,提升行業競爭力。

完善的生物質原材料供應體系保障了生物質綜合 利用項目燃料的充分供應及穩定運營。本集團通 過區域統籌鄰近生物質原材料收購,控制燃料成 本。 As of 31 December 2021, the Group had a total of 53 integrated biomass utilisation projects, located variously in 10 provinces in China, including mainly Anhui Province, Jiangsu Province, Shandong Province, Hubei Province and Henan Province, etc. Such projects commanded a total investment of approximately RMB16.746 billion and provided an aggregate power generation designed capacity of 1,059 MW, an aggregate annual biomass processing designed capacity of 8,089,800 tonnes, and a daily aggregate household waste processing designed capacity of approximately 11,210 tonnes.

截至二零二一年十二月三十一日,本集團共擁有53個生物質綜合利用項目,分佈在中國境內10個省份,主要位於安徽省、江蘇省、山東省、湖北省及河南省等地。該等項目涉及總投資額約人民幣167.46億元,總設計發電裝機容量達1,059兆瓦,生物質總設計處理能力達每年約8,089,800噸,生活垃圾總設計處理能力達每日約11,210噸。

During the year under review, the Group operated and completed 50 integrated biomass utilisation projects, generating approximately 6,027,143 MWh of on-grid electricity which represented an increase of 12% over 2020; the Group's volume of steam supplied was approximately 2,154,671 tonnes, representing an increase of 60% over 2020; and the Group processed approximately 7,964,335 tonnes of biomass raw materials and approximately 2,918,918 tonnes of household waste, representing increases of 19% and 28% over 2020 respectively. As of 31 December 2021, the Group had 3 integrated biomass utilisation projects under preparation, with an aggregate power generation designed capacity of 32 MW and an aggregate daily household waste processing designed capacity of approximately 1,300 tonnes.

於回顧年度內,本集團運營及完工的生物質綜合利用項目共50個,提供上網電量約6,027,143兆瓦時,較二零二零年增加12%;提供蒸汽供應量約2,154,671噸,較二零二零年增加60%;及處理生物質原材料約7,964,335噸及生活垃圾約2,918,918噸,分別較二零二零年增加19%及28%。截至二零二一年十二月三十一日,本集團籌建生物質綜合利用項目共3個,總設計發電裝機容量32兆瓦,總設計生活垃圾處理能力約每日1,300噸。

During the year under review, the Group's integrated biomass utilisation projects contributed EBITDA of approximately HK\$2,060,530,000, a decrease of 19% compared to 2020. The integrated biomass utilisation projects contributed net profit of approximately HK\$1,059,693,000, decrease of 28% compared to 2020. The decrease in profit was mainly attributable to the decrease in the number of projects under construction resulting in the corresponding decrease in revenue generated from construction services, as well as the increase in operating costs driven by rising biomass raw materials prices during the year under review.

Hazardous and solid waste treatment

The Group is principally engaged in the safe treatment and integrated utilisation of wastes including general industrial solid wastes, hazardous wastes and infectious animal carcasses. Currently, the Group conducts the disposal by way of incineration, landfill, physicochemical treatment and integrated utilisation.

The Group is a leading industry player in the hazardous waste treatment business, with capabilities for safely disposing of 44 out of 46 categories of hazardous wastes listed in the National Catalog of Hazardous Wastes. During the year under review, we continued to explore the potential of the general industrial solid waste electricity and heat cogeneration business. The Group is well-positioned to fully meet various requirements of customers on the back of its solid technical strengths and ability to provide one-stop services.

As of 31 December 2021, the Group had a total of 61 hazardous and solid waste treatment projects, located variously in 10 provinces and autonomous region in China, including mainly Jiangsu Province, Shandong Province, Anhui Province, Hubei Province, Zhejiang Province, etc. Such projects commanded a total investment of approximately RMB14.472 billion and an aggregate annual processing designed capacity of approximately 2,941,900 tonnes.

危廢及固廢處置

本集團主要從事一般工業固廢、危險廢物、病死 動物等的安全處置和綜合利用,目前採用的處置 方式包括焚燒、填埋、物化處理及綜合利用等。

本集團的危廢處置業務在行業中位於前列位置,可安全處置《國家危險廢物名錄》所列46類危廢中的44類,並於回顧年度內繼續挖掘一般工業固廢熱電聯供業務發展潛力。雄厚的技術實力、一站式的服務能力令本集團可全面滿足各類客戶需求。

截至二零二一年十二月三十一日,本集團共擁有 61個危廢及固廢處置項目,分佈在中國境內10個 省份及自治區,主要位於江蘇省、山東省、安徽 省、湖北省、浙江省等地。該些項目涉及總投資 額約人民幣144.72億元,總設計處理能力達每年 約294.19萬噸。

During the year under review, the Group operated and completed 36 hazardous and solid waste treatment projects. For detoxification treatment, approximately 245,676 tonnes of hazardous and solid waste were treated in total, a 51% increase compared to 2020. For integrated resource utilisation, 23,003 tonnes of hazardous and solid waste were treated, increasing by 51% compared to 2020, and approximately 9,490 tonnes of recycled products were sold, a 65% increase compared to 2020. There were 10 hazardous and solid waste treatment projects under construction with an aggregate annual hazardous waste processing designed capacity of 972,500 tonnes.

During the year under review, the Group's hazardous and solid waste treatment projects contributed EBITDA of approximately HK\$686,664,000, increase of 64% compared to 2020. Hazardous and solid waste treatment projects contributed net profit of approximately HK\$364,210,000, increasing by 79% over 2020. The increase in profit was mainly attributable to the increase in the number of projects under construction qualified for contributions to revenue generated from construction services during the year under review.

Environmental remediation

The Group's environmental remediation business covers mainly the restoration of industrial contaminated sites, restoration of contaminated farmland, ecological restoration for mines and landfills, treatment of industrial gas emission, integrated treatment of oil sludge, treatment of river and lake sediments and industrial sludge, construction and operation of wetland parks, environmental stewardship services and anti-seepage at landfill sites.

In connection with qualifications, as of 31 December 2021, the Group held the following accreditations: First-grade Professional Contracting Qualification for Environmental Protection Projects, Second-Grade General Contractor for Municipal Public Works, Third-Grade General Contractor for Construction Works. Environmental Engineering EPO License (Class B) (for pollution remediation and prevention of water pollution), Environmental Pollution Control License (Class A) (remediation of contaminated sites) in Jiangsu Province, Environmental Pollution Control License (Class B) (contaminated water body remediation) in Jiangsu Province, General Contractor for Environmental Pollution Control License (First Class) (remediation of contaminated sites) in Jiangsu Province and General Contractor for Environmental Pollution Control License (Second Class) (contaminated water body remediation) in Jiangsu Province. It had also obtained an "AAA" corporate credit rating given by a credit rating agency, as well as ISO9001, OHSAS18001 and ISO14001 management system accreditations. In addition, the Group holds the China National Accreditation Services for Conformity Assessment (CNAS) qualification accreditation certificate which qualifies it to issue test data and results to third parties as valid proof for certification purposes.

環境修復

本集團的環境修復業務主要涵蓋工業污染場地修復、污染農田修復、礦山及填埋場生態修復、工業廢氣治理、油泥綜合治理、河湖底泥及工業污泥治理、濕地公園建設和運營、環保管家服務及填埋場防滲工程等。

資質方面,截至二零二一年十二月三十一日,本集團已具備環保工程專業承包一級、市政公用工程總承包二級、建築工程施工總承包三級、環境工程設計專項乙級(污染修復工程和水污染防治工程專業)、江蘇省環境污染治理能力評價甲級(污染場地修復)、江蘇省環境污染治理北升評價工級(污染水體修復)、江蘇省環境污染治理工程總承包能力評價二級(污染水體修復)等資質,獲批信用評級機構企業資信等級AAA證書並通過ISO9001、OHSAS18001及ISO14001管理體系認證。本集團亦持有中國合格評定國家認可委員會(CNAS)資質認定證書,可對外出具具有證明效力的檢驗檢測資料和結果。

As of 31 December 2021, the Group had 13 environmental remediation projects under implementation, which were located variously in Jiangsu Province, Anhui Province and Tianjin, with a total contract amount of approximately RMB603 million. There were also 3 projects in the preparatory stage, with a total contract amount of approximately RMB122 million.

During the year under review, the Group's environmental remediation projects contributed EBITDA of approximately HK\$42,182,000, an 8% increase compared to 2020. Environmental remediation projects contributed net profit of approximately HK\$15,831,000, which was broadly unchanged compared to 2020.

As of 31 December 2021, the Group has 16 solar energy projects completed and in operation and 2 wind power projects in operation located in Jiangsu Province, Anhui Province, Shanxi Province, Hong Kong and Germany, respectively, involving a total investment of approximately RMB1.418 billion and providing an aggregate power generation designed capacity of 127.66 MW. The Group is responsible for building, managing and operating these projects and selling electricity generated to local power grid companies.

During the year under review, the Group's solar energy and wind power projects sold approximately 282,976 MWh of electricity, representing a 10% increase compared to 2020. The projects contributed EBITDA of approximately HK\$189,181,000, representing a 4% increase compared to 2020. Solar energy and wind power projects contributed net profit of approximately HK\$73,110,000, which was largely flat compared to 2020.

With a consistent commitment to the dual emphasis on social as well economic benefits, the Group has made vigorous effort in driving energy conservation and discharge reduction. During the year under review, the Group generated approximately 6,310,119 MWh of green electricity, which was sufficient for the annual electricity consumption of 5,258,432 households, reducing standard coal consumption by 2,524,048 tonnes and carbon dioxide (CO₂) emissions by 5,247,423 tonnes, while saving 820,315,462 trees. The Group also treated 725,662.3 m³ of leachate in its waste-to-energy power plants and hazardous waste landfills and removed 31,154 tonnes of chemical oxygen demand.

Business Prospects

Since the conclusion of the 18th National Congress of the Communist Party of China, China has devoted effort as never seen before to the development of an ecological civilisation, culminating in the full accomplishment of the periodic goals and missions for the critical battle against pollution. In the next stage, ecological protection initiatives will focus on the underlying issues and trend-oriented issues of environmental pollution and conduct in-depth environmental treatment in key regions and key industries. Meanwhile, the Chinese economy has transitioned from rapid growth to the new stage of qualitative growth. To drive the transformation and upgrade of industry mix, Dual Carbon will inevitably lead to extensive and profound economic revolution as it ushers in a new low-carbon green era. With the ongoing progress of the "14th Five-Year Plan" period, the development of China's ecological civilisation has entered into a critical stage underpinned by a strategic direction focused on carbon reduction to enhance synergy between waste reduction and lower carbon emission and facilitate a change from quantitative to qualitative improvement for the ecological environment.

業務展望

As a strategic plan for the next 40 years, the primary task of Dual Carbon, in terms of timetable and roadmap, is to drive adjustments to the energy mix and solve the problem of resources and environmental constraints. On that basis, the relevant competent authorities have proposed issue-specific policy measures. Regarding energy, the "Pilot Scheme for Promoting Rooftop Distributed Solar Energy" and "Guide Opinion for Energy Storage Construction" promulgated by the National Energy Administration to procure further reduction of fossil energy consumption and increase in the proportion of clean energy will contribute to the blooming development of the new energy sector. In connection with resources, the "Guide Opinion on the Integrated Utilisation of Bulk Solid Waste", published by the National Development and Reform Commission with the aim of enhancing efficiency of the utilisation of bulk solid waste resources, calls for utilisation of high value added coal gangue, fly ash and industrial tailings. In connection with the environment sector, the second round of trial operations under the ecologyoriented development model ("EOD Model") launched by the Ministry of Ecology and Environment as part of its effort to explore means of integrating ecological treatment projects with resources and industrial development projects has presented new opportunities in the environmental remediation sector. Given its close accord with the positioning of the Group's energy, resources and environmental businesses, the Dual Carbon strategy will definitely have a positive and profound impact on the Company's transformation and development.

雙碳作為未來四十年的戰略規劃,從其時間表和 路線圖上來看,首要工作是推動能源結構調整, 破解資源與環境約束問題,相關行業主管部門也 已據此提出了一些針對性政策措施。能源方面, 為進一步減少化石能源消耗,提高清潔能源佔 比,國家能源局推出了《屋頂分佈式光伏開發推 進試點方案》和《儲能建設指導意見》,新能源行 業方興未艾;資源方面,為推進大宗固廢資源利 用效率,國家發展改革委員會印發《大宗固體廢 棄物綜合利用指導意見》,煤矸石、粉煤灰、工業 尾礦的高附加值利用被提上日程;環境方面,為 探索將生態環境治理項目與資源、產業開發項目 一體化實施方式,生態環境部啟動第二批生態環 境導向的開發模式(「EOD模式」)試點,環境修復 領域迎來新的機遇。雙碳戰略與本集團能源、資 源、環境的業務定位高度統一,勢必對本公司轉 型發展產生積極而深遠的影響。

While trading at the China Carbon Emission Trade Exchange officially commenced in 2021, it has remained rather monotonous in terms of participating principals, sectors and the purpose of trading, and the varieties of products traded and model of trading have vet to be enriched and improved. In 2022, the China Carbon Emission Trade Exchange will undergo its second carbon trading contract performance cycle and will commence the registration of China Certified Emission Reduction projects and issuance of emission reduction quota. The critical task for the development of the China Carbon Emission Trade Exchange in the next stage would be looking for ways to expand its industry coverage, gradually enrich the varieties, mode and principal of trading and boost active market trading on the back of sound operation of the carbon market for the power generation market. As an environmental enterprise principally engaged in integrated biomass utilisation, wind power and solar energy, the Group's projects hand out enormous potential in the development of carbon emission assets. As such, the Company will enhance management of its carbon assets and closely monitor the development of the national carbon market.

In 2022, schemes and initiatives under the "14th Five-Year Plan" will be intensively implemented, and the nation's environmental protection industry will welcome an important period of opportunities for robust development under the profound impact of the development strategy underpinned by the development of the ecological civilisation and Dual Carbon. With the gradual improvement in quality standard of the industry and the industrial policies becoming more mature, market competition is set to escalate. Amidst challenges as well as opportunities, the Group continued to persist in development in "three dimensions": extending the length of the industry chain, penetrating the depth for more market shares and broadening the scope of our business. By aiming at "delivering value" and starting with "reforms and improvements" alongside in-depth research on measures and methods, the Group will drive quality and efficiency improvement in the existing business while exploring new business directions to seize new market opportunities.

The Group will continue to persist in the business philosophy of "reinforcing principal business" and "driving transformation" in a further effort to reinforce the foundation of its principal businesses and optimise its operational and management regime, while guiding the Company's transformation with technology innovation. To solidify its foundation for development, the integrated biomass utilisation business will vigorously drive the coordinated development of the heat supply, kitchen waste and sludge businesses, while promoting the experience of the fuel collection and storage system to enhance the operational quality and efficiency of projects. The hazardous and solid waste treatment business will enhance its regional market coordination mechanism to develop customer resources and procure further cost reduction, so as to enhance its market competitiveness. The environmental remediation business will improve its environmental remediation work management regime by optimising its environmental treatment model to continuously enhance its credibility and strength.

To accelerate the pace of business transformation and upgrade, the Group will conduct policy, market and technology research with a specific focus on frontier developments of the industry and identify higher quality markets, more advanced technologies and projects with higher value, in order to reserve driving power for the Company's latest strategic transformation. Seizing market development opportunities presented by the Dual Carbon goal, the Group will vigorously advance the integrated energy service business through the coordination of solar energy, wind power, energy storage and the biomass projects in operation with a special emphasis on the market for county-wide solar energy projects, in a bid to forge a provider of one-stop services in "Carbon Neutrality". In the meantime, in tandem with a business positioning underpinned by the integration of four areas: environment, resources, energy and climate, we will also monitor segments such as waste-free city development, resources recycling and energy utilisation tiers, while actively expanding our landfill remediation EPC business and strengthening the development of businesses relating to contaminated sites, landfill remediation and leachate treatment to usher in a new cycle of value growth.

Moving forward, with the solid back-up of China Everbright Group and strong support of CEEGL, the Company's controlling shareholder, and on the back of its extensive experience in the development and operation of diversified project portfolios and strong ability in market development, the Group will work in close tandem with national policies and market trends with a firm strategic focus, as it continues to uphold the corporate vision of endeavouring to "Create Better Investment Value and Undertake More Social Responsibility" and strive incessantly to become a leader in China's environmental business sector.

FINANCIAL REVIEW

Financial position

As at 31 December 2021, the Group's total assets amounted to approximately HK\$40,539,581,000 (31 December 2020: HK\$35,264,668,000) with net assets amounting to approximately HK\$14,145,367,000 (31 December 2020: HK\$12,866,841,000). Net asset value per share attributable to equity shareholders of the Company was HK\$6.66 per share, an increase of 10% as compared to HK\$6.06 per share as at the end of 2020. As at 31 December 2021, the gearing ratio (total liabilities over total assets) of the Group was 65.11%, an increase of 1.60 percentage points as compared to that of 63.51% as at the end of 2020. The current ratio of the Group was 137.50%, a decrease of 18.70 percentage points as compared to that of 156.20% as at the end of 2020.

Financial resources

The Group adopts a prudent approach on cash and financial management to ensure proper risk control and lower the costs of funds. It finances its operations primarily with internally generated cash flow, proceeds from the issuance of medium-term notes and ABN and bank loans. As at 31 December 2021, the Group had cash and bank balances of approximately HK\$2,644,110,000, a decrease of HK\$82,943,000 as compared to HK\$2,727,053,000 at the end of 2020. Most of the Group's cash and bank balances were denominated in Hong Kong dollars and Renminbi.

財務回顧

財務資源

本集團對現金及財務管理採取審慎的原則,妥善管理風險及降低資金成本。運營資金主要來自內部現金流、發行中期票據及資產支持票據所得資金及銀行提供之貸款。於二零二一年十二月三十一日,本集團持有現金及銀行結餘約港幣2,644,110,000元,較二零二零年年底之港幣2,727,053,000元減少約港幣82,943,000元。本集團大部分現金及銀行結餘均為港幣及人民幣。



Indebtedness

The Group endeavours to develop a diverse range of financing options and increasing banking facilities to reserve funds for the development of its environmental protection business. As at 31 December 2021, the Group had outstanding borrowings of approximately HK\$20,551,096,000, an increase of approximately HK\$3,617,723,000 as compared to HK\$16,933,373,000 as at the end of 2020. The borrowings included secured interest-bearing borrowings of approximately HK\$9,720,331,000 (31 December 2020: HK\$8,566,054,000) and unsecured interest-bearing borrowings of approximately HK\$10,830,765,000 (31 December 2020: HK\$8,367,319,000). The borrowings of the Group were denominated in Renminbi and Hong Kong dollars, representing 76% and 24% of the total respectively. The majority of the Group's borrowings were subject to floating rates. As at 31 December 2021, the Group had banking facilities of approximately HK\$24,334,199,000 (31 December 2020: HK\$22,038,898,000), of which approximately HK\$7,907,465,000 (31 December 2020: HK\$7,591,705,000) was unutilised. The tenor of banking facilities ranged from 1 year to 18 years.

Foreign exchange risks

The Company's financial statements are denominated in Hong Kong dollars, which is also the functional currency of the Company. The Group's investments made outside Hong Kong (including Mainland China) may incur foreign exchange risks. The Group's operations have been predominantly based in Mainland China, which makes up over 95% of its total investments and revenue. The majority of the Group's assets, borrowings and major transactions are denominated in Renminbi, forming basically a natural hedging effect. The Group closely manages its foreign exchange risk through the optimal allocation of borrowings in different currencies, moderate control of borrowings in non-base currencies, and adoption of appropriate financial instruments.

外匯風險

本公司之列賬及功能貨幣均為港幣。本集團投資於香港以外地區(包括中國內地)存在外匯風險。一直以來,中國為本集團之主要業務所在地,佔總投資及收益超過95%以上。本集團大部分資產、貸款及主要交易以人民幣為單位,基本形成一種自然的對沖。本集團通過合理匹配各種貨幣貸款,適量控制非本位幣貸款,及採用合適的金融工具以密切管理外匯風險。

Pledge of assets

Certain banking facilities of the Group were secured by certain revenue rights, contract assets and receivables in connection with the Group's service concession arrangements, bank deposits, mortgages on property, plant and equipment and right-of-use assets of the Group. As at 31 December 2021, the aggregate net book value of assets pledged amounted to approximately HK\$21,584,176,000 (31 December 2020: HK\$19,019,934,000).

Commitments

As at 31 December 2021, the Group had purchase commitments of approximately HK\$620,324,000 (31 December 2020: HK\$1,104,064,000) under the construction contracts and capital commitments relating to capital injection in an associate and a joint venture of approximately HK\$36,535,000 (31 December 2020: HK\$35,405,000) and NiI (31 December 2020: HK\$3,575,000) respectively.

Contingent liabilities

As at 31 December 2021, the Group did not have any contingent liabilities (31 December 2020: Nil).

Tax relief and exemption

The Company is not aware of any tax relief and exemption available to the Shareholders by reason of their holding of the Company's shares.

Service concession arrangements

The Group entered into Build-Operate-Transfer ("BOT") and Build-Operate-Own ("BOO") arrangements in respect of its projects.

The Group concluded that all the BOT arrangements and certain BOO arrangements are service concession arrangements under Hong Kong (International Financial Reporting Interpretations Committee) ("HK(IFRIC)") Interpretation 12, because the local government controls and regulates the services that the Group must provide with the infrastructure at a pre-determined service charge. In respect of BOT arrangements, upon expiry of concession right agreement, the infrastructure has to be transferred to the local government at nil consideration. Infrastructure for BOO arrangements is used in the service concession arrangements for its entire or substantial useful life.

As of 31 December 2021, the Group had a total of 104 projects had completed construction or commenced operation and 10 projects under construction, in which 51 integrated biomass utilisation projects and 15 hazardous and solid waste treatment projects are accounted for as service concession arrangements. Most of the integrated biomass utilisation projects and some of the hazardous and solid waste treatment projects are accounted for as service concession arrangements. The construction contracts for the biomass portion of our integrated biomass and waste-to-energy projects and some of our hazardous and solid waste treatment projects are recorded under "intangible assets", while the construction contracts for the waste-to-energy portion of our integrated biomass and waste-to-energy projects and some of our hazardous and solid waste treatment projects are recorded under "service concession assets".

INTERNAL MANAGEMENT

Strengthening corporate management is the cornerstone that ensures efficient, healthy and sustainable development of an enterprise. The Group has always upheld a "People-oriented, Pragmatic, Creative and Systematic" management philosophy, as it continues to develop and improve its management system and mechanism with a special emphasis on fostering a corporate management culture that encourages participation by all employees, so as to enhance management awareness and effectively raise its management standards.

During the year under review, against the backdrop of the persistent spreading of the COVID-19 pandemic and austere conditions in the industry, the Group further enhanced its internal management and sought to enhance efficiency through management efforts as it improved the "weekly meeting" mechanism to strengthen the interaction between the headquarters and the project companies, to follow up and jointly solve issues in project operation in a timely manner with stronger execution and operational competence. Focused on future development, we advanced corporate transformation and upgrade with more robust strategic guidance and a technology-driven approach emphasising reform and innovation.

The Group is committed to the introduction of industry-leading technologies to empower the investment, construction and operation sectors, in an ongoing effort to enhance the enterprise's ability to produce benefit and efficiency. Informatisation in operation management is vigorously promoted, extending the boundaries of management and enhancing the standardisation, sophistication and systematisation of operational management with the aid of information technology. Comprehensive cost management on projects has been implemented with the enhancement of cost management awareness and the establishment of a long-term system. Meticulous effort was devoted to the building of the biomass fuel intake and transit regime and the power consumption management regime of project plants, while the "cost reduction and efficiency enhancement" initiative was vigorously promoted. Exchange with industry peers was broadened while deepening internal benchmarking and appraisal management. Inspirations were drawn from role-model vanguard projects to drive synchronous development of all projects in a balanced manner.

Management Discussion and Analysis 管理層討論及分析

Improvements have been made to the risk management regime, to strengthen know-how training and practical drills in relation to the ESHS management system and risk management system. A comprehensive risk inspection with collective involvement across different departments has been organised to procure closed-loop rectification of problems identified. To complement efforts of the Internal audit department, "Risk management-oriented auditing" has been incorporated into our audit process, whereby reviews on the operating conditions and viability of our risk management system from an audit point of view has been conducted to ensure effective implementation and stringent execution of all management systems.

The Group has always been highly concerned with legal compliance of project construction and has rigorously implemented requirements for work progress to ensure that the commencement and construction of all projects are compliant with relevant laws and regulations. In consistent adherence to the operating principle of "Distinction, Perfection and Near-zero Discharge and Excellence", the Company has enhanced management over projects in operation in terms of production safety and emission compliance. Competitions in terms of four indicators, namely, "Expenditure Reduction, Efficiency Enhancement, Energy Saving and Cost Control", have been organised across the board subject to assurance against significant safety or environmental incidents. Moreover, a "Five Minors Innovative Award" has been introduced to encourage staff creativity and facilitate the Company's high-quality development through innovation.

In the meantime, members of the Management Committee deliberated on corporate transformation and development strategies and important tasks of the enterprise in a collective effort to drive the stable development of the Group.

於回顧年度內,本公司每月均召開管理委員會會議,審議項目投資、籌建、在建及運營的情況, 發揮投資項目風險評審委員會和工程技術委員會 的作用,以嚴格的標準審議項目投資和建造方 案;同時,管理委員會成員集思廣益,群策群力 積極研究企業轉型發展戰略,商討企業重要工 作,推動集團穩健發展。

HUMAN RESOURCES

With a special emphasis on human resource management, the Group makes reasonable plans to structure its human resource requirements according to the Company's business development trends to provide an ongoing drive force for its rapid development. During the year under review, the Group continued to actively promote and attract talents through internal training, open recruitment and on-campus recruitment, among others. We seek to improve staff quality through different approaches, such as collective external training, internal associations, technical exchange sessions and personal learning programmes. The Group has also provided different types of trainings designed to explore the potentials of employees, with a view to achieving co-development with employees and sharing with them the rewards of its business achievements.

To enhance technical exchanges and capitalise on its technical resources, the Group made active efforts to build an internal team of lecturers during the year under review and ensured continuous improvements in their teaching standards through selection examination, training and education, so that they could pass on their expertise to upgrade the skills of other employees. In addition to induction training for new employees to facilitate swift integration, special centralised training sessions for general managers, chief commanders and back-up officers were also organised, contributing to significant enhancement in management efficiency and organisational effectiveness. To further enhance its talent pool, in addition to on-campus recruitment of fresh graduates, competitive appointment and selection of talents were promoted to seek internal potentials, with a view to fostering a fair, equitable and open environment for employee selection and appointment underpinned by a stronger competitive sense and positive competition. Meanwhile, the selection and training of back-up personnel has been enhanced, such that staff with the right caliber and ambition can undertake more appropriate positions to play to their strengths and enhance efficiency.

人力資源

本集團一直特別重視人力資源管理工作,根據公司業務發展趨勢合理規劃人力資源需求結構,為本公司的高速發展提供持續動力。於回顧年度內,不斷通過自主培養、社會招聘、校園招聘等方式積極提拔及引進人才,採用集中外訓、內部組織、技術交流、個人學習等方式不斷提升員工質素。本集團亦提供不同類型的培訓以不斷挖掘員工的潛力,著眼於員工與公司共同成長、共享成果。

To establish a scientific and standardised human resources management system, develop an effective and execution-friendly mechanism conducive to the selection, training, appointment and retainment of high-calibre talents and build a first-rate team of talents, the Group announced during the year a series of administrative measures, including "Administrative Measures for Staff Recruitment and Appointment", "Administrative Measures for Staff Induction, Probation and Formal Employment", "Regulations for the Selection and Appointment of Officers", "Everbright Greentech Management Administrative Regulations for Remuneration and Benefits", "Everbright Greentech Administrative Measures for Staff Resignation" and "Everbright Greentech Administrative Regulations for Officers' Resignation and Turnover of Duties".

為了建立科學規範的人力資源管理制度,形成有效管用、簡便易行、有利於優秀人才的選、育、用、留機制,打造一流人才隊伍,本集團於年內發佈了一系列管理辦法,包括《員工招聘與錄用管理辦法》、《員工入職、試用、轉正管理辦法》、《幹部選拔任用規定》、《光大綠色環保薪酬福利管理制度》、《綠色環保員工離職管理辦法》、《綠色環保幹部離任交接管理規定》等相關制度。

The Group is committed to foster a workplace characterised by diversity, inclusivity and mutual respect at work for all employees and believes that it should be safeguarded by a relevant mechanism, under which everyone is entitled to equal opportunities for job positions under the system. The Company also believes that the availability of diverse talents is closely associated with corporate development. Hence it is vigorously procuring talents from diverse backgrounds and strives to foster a harmonious, inclusive and diverse workplace for staff of different genders from different ethnic, cultural or professional backgrounds.

本集團致力為全體員工建立一個多元共融以及在工作間互相尊重的工作環境,並提倡以機制提供保障,在制度及工作崗位前人人享有平等機會。本公司亦相信人才多樣性與企業發展關係密不可分,致力延攬多元人才,並努力為不同性別、來自不同種族、文化或專業背景的員工打造和諧共融的多元工作環境。

As at 31 December 2021, the Group had over 3,800 employees in total in Hong Kong and Mainland China. Total staff cost for 2021 was HK\$774,257,000 (2020: HK\$638,850,000). Employees are remunerated according to their qualifications, experiences, job nature and performance, with reference to market conditions. Apart from the discretionary performance bonus, the Group also provides staff with other benefits such as medical insurance and mandatory provident fund.

PRINCIPAL RISKS AND UNCERTAINTIES

During the year under review, the Group placed a stronger emphasis on the effectiveness of risk control on the back of an improved internal control and risk management system. Feasible and effective risk mitigation measures were implemented by improving the internal environment, enhancing dissemination of information and conducting specific inspections, among others, to address material risks of the Group which had been identified and evaluated. Key risks associated with the development of the Group's environmental business included policy changes, trade receivables, environmental compliance and safety management. investment and business development, construction work budget and cost management, as well as recruitment and staff allocation. In addition to the above-mentioned material risks, the Group has also implemented effective preventive measures against the ongoing COVID-19 pandemic and continued to monitor global climate change. In particular, contingency plans and reasonable response measures have been put in place to address risks which might result from extreme weather.

The risk of policy changes refers to the risk of failure to respond to changes in national policies and business models in a timely and effective manner resulting in an adverse impact on the business of the Group, which will affect its compliance, operation and finance. For example, this risk might result in higher operating costs, greater pressure on emission or failure to obtain new energy subsidies in a timely manner, thereby increasing the pressure on operations. The Group has been closely monitoring adjustments to national environmental policies and has been actively involved in advancing national strategies and macro-policies in tandem with the requirements of national development strategies and environmental policies and prudent investment principles, making adjustments to its development approach in response to changes in environmental policies. In the meantime, we have furnished advice and suggestions to relevant policy-making authorities through industry associations and expert teams, in a bid to ensure that the actual conditions and needs of the industry would be taken into consideration by the nation in its policy formulation. The Group has conducted in-depth and detailed analysis on national industrial development strategies and made pre-emptive moves in project deployment to explore new business frontiers in response to national macro-control measures and specific policies on the environmental industry. We intend to seize development opportunities by employing innovative business models, in order to accomplish the stated objective of sustainable development.

主要風險及不確定性

政策變動風險指未能及時有效應對國家政策調整 及商業模式變化而對本集團業務帶來負面影響的 風險,對合規、運營、財務方面存在影響,如可 能導致運營成本上升、排放壓力增加或未能及時 取得新能源補貼,加大運營壓力。本集團一直密 切關注國家對環保政策的調整,堅持順應國家發 展戰略及環保政策要求、穩妥審慎的投資原則, 積極參與國家戰略及宏觀政策的推進,順應環保 政策的變化而調整本集團發展路線。本集團通過 行業協會、專家團隊等向相關政策制定部門諫言 獻策,力求國家在制定政策時會考慮到行業的真 實情況及需求。本集團細緻深入分析國家產業發 展戰略,針對國家對於環保行業的宏觀調控及具 體政策,提早進行項目佈局,拓展新型業務領 域。創新商業模式,抓住發展機遇,實現可持續 發展的預定目標。

The risk of trade receivables refers to the risk of incurring bad debt losses that would affect the Company's profit and solvency owing to the failure to collect trade receivables in a timely manner. With a strong emphasis on trade receivable management, the Group has announced and implemented pertinent rules and regulations to conduct regular analyses on the overall profile of trade receivables, on the basis of which specific call targets and plans have been formulated to ensure reasonable trade receivable turnover periods and the effective implementation of a mechanism for collection. Appraisals of trade receivable collection have also been conducted to effectively implement the clear-up of trade receivables. Regular analysis reports on trade receivable collection, including reports on ageing management and analysis management, have been prepared. Cross-checking with clients has been conducted on a quarterly basis to facilitate examination of trade receivables. Regarding commercial customers, continuous improvements to customer credit check have been made and a management model comprising screening prior to granting credit, supervision of the granting process, and designated tracking after granting is being formed. Flexibility in credit policies and call strategies are afforded in relation to different customers and instant adjustments have been made to reduce the probability of bad debts.

The risk associated with environmental compliance and safety management can be distinguished into the risk associated with environmental compliance and the risk associated with safety management. The risk associated with environmental compliance refers to the risk of exceeding environmental emission limits, safety incidents and adverse external conditions resulting in an adverse impact on project construction and operation. Excessive emission or illicit operations may in the worst case result in administrative penalties, affect tax rebates and oblige the Company to shut down or suspend operations, thereby compromising its reputation. The risk of safety management refers to the risk of safety liability incidents occurring as a result of deficiencies in the safety management regime, imperfections in the safety management system and ineffective implementation of safety management measures, thereby affecting the reputation, compliance and finance of the Company. The Group has persisted in work design optimisation, stringent quality control over project construction and efficiency upgrade for equipment in a bid to enhance project management standards. We have also exercised stringent control over emission indicators to ensure the compliance with emission standards. The Group has consistently procured the project companies to commence requisite technological upgrades. We have developed a centralised environmental information platform and appointed qualified third-party inspection bodies to conduct environmental monitoring according to plans. We have continued to disclose the environmental emission data of its waste-to-energy projects in a proactive move to subject itself to the supervision of the general public. The Group has upheld the principle of "safety comes first in development" and continued to improve, as well as resolutely and consistently implement, its safety management regime, and to fulfill its responsibility in safety management. The Group has conducted itself in strict accordance with the ESHS management regime with consistent implementation of the "Standard Operating Procedure" ("SOP") and formulation of contingency plans for accidents. Safety inspections within the system have been conducted monthly and quarterly to identify and eliminate safety hazards and avoid safety liability incidents. The Group has also conducted numerous sessions of safety training for the learning of safety management knowledge and enhancement of safety risk awareness, with a view to curbing any potential risks at source and improving its safety management standards. Property and liability insurances have been purchased based on the specific conditions of individual projects to transfer the risks as necessary.

環境合規與安全管理風險可分為環境合規風險與 安全管理風險。環境合規風險指環保排放超標、 安全事故、不良外部環境等對項目的建設及運營 帶來負面影響的風險。超標排放或違規操作的最 嚴重影響可能會受到行政處罰,影響退稅或被迫 關停,影響本公司聲譽。安全管理風險指安全管 理體系不健全、安全管理制度不完善、安全管理 措施不到位等原因導致的發生安全責任事故的風 險,為本公司帶來聲譽、合規及財務影響。本集 團一貫堅持優化工程設計、嚴控項目建設品質、 提升設備效能,提高項目管理水準,嚴格控制排 放指標,保證達標排放。本集團不斷推動各項目 公司開展必要的技改工作,並構建統一的環境資 訊平台,委託具有資質的第三方檢測單位按計劃 開展環境監測工作。繼續堅持垃圾發電項目的環 保排放資料公開,主動接受社會及公眾的監督。 本集團始終堅持「生命至上、安全發展的原則」, 持續完善並堅決貫徹執行安全管理體系,落實安 全管理責任。本集團堅持ESHS管理體系,貫徹執 行「標準作業程式」(SOP)、制定了事故應急預案 並每個月、每季度均在系統內進行安全檢查,查 找並消除安全隱患,避免安全責任事故的發生。 本集團亦多次開展安全培訓工作,學習安全管理 知識、提高安全風險意識、防微杜漸,提升安全 管理水準。針對各項目的特殊情況,購買財產及 責任保險,進行必要的風險轉移。

The risk associated with investment and business development refers to the risk of intense competition in the industry affecting the Group's business expansion capacity and the investment return of its projects, resulting in an impact on the Company's business development and financial conditions. The principal operations of the Group, comprising integrated biomass utilisation, hazardous waste treatment, solar energy and wind power, are all subject to intense market competition. The Group has refrained from unwarranted expansion, investment with insignificant profit return and low price competition. We have optimised our project evaluation system and procedure with the establishment of the investment project risk examination committee, which conducts examination on investment project risks to enhance the quality of investment project evaluation and strengthen risk management prior to investment in projects. The Group places strong emphasis on building partnerships and engaging in friendly information sharing with leading fellow enterprises in the industry to closely monitor movements and trends in the industry. Market information is generated on a regular basis to facilitate comprehensive monitoring and analysis of competitors, market status, market investment information, national policies and regulations, status of industry development, frontier developments in technology and organisational management, among others. Internal information packs such as the regular monthly report on market development information and the annual industry analysis report and national market investment guide are prepared. Relevant competition strategies are formulated on a regular basis according to market trends. Regular meetings are held for project companies to facilitate information-sharing and put together different ideas. Reference materials in the forms of minutes, documents and special-topic publications are provided to relevant departments for studying and to the management as reference for decision-making.

投資與業務開發風險指在業內對手的激烈競爭 下,影響本集團的業務拓展能力及項目投資回報 的風險,對本公司業務發展及財務帶來影響。本 集團主營業務包括生物質綜合利用、危廢處置、 光伏發電及風電等均處於較為激烈的市場競爭狀 態。本集團不作盲目擴張、不作無效益投資、不 作低價競爭;優化項目評審制度與流程,設置投 資項目風險審核委員會進行投資項目風險審核, 提升投資項目評審品質,加強投資項目事前風險 管控。本集團重視加強與行業內優秀企業建立合 作夥伴關係並開展友好交流,即時掌握行業動態 及發展趨勢。定期蒐集市場訊息,對競爭對手、 市場現狀、市場投資情況、國家政策制度、行業 發展現狀、技術前沿、組織管理等方面進行全面 把控分析。每月定期完成市場拓展資訊報告表; 每年完成行業分析報告、全國市場投資指引等內 部資料。定時根據市場趨勢,制定相應的競爭策 略。定期組織各項目公司進行交流分享和思路整 合,並以紀要、檔案、專題刊等形式,供相關部 門學習及為管理層決策提供參考。

The risk associated with construction work budget and cost management refers to the risk of incurring investment overruns as a result of inadequate assessment of essential factors such as technical requirements, design scheme, work schedule requirements, project work quality and fundamental conditions for construction, or inaccurate calculation of work volume, during the stage of construction work budget, thereby affecting the Company's financial conditions. The Group has been engaged in ongoing efforts to enhance standardisation of work sites by consistently substantiating its suppliers' list to enable selection of high-calibre partners, while exercising reasonable control over budgets and cost estimation. During the year, the Group enhanced the feasibility studies in depth and quality to bring them closer to the design tasks and increase the accuracy of budget estimates. The furnishing of information between the equipment manufacturers and the design institutes was expedited, while the order for information supply among various equipment was internally clarified to facilitate the streamlining and implementation of the accountability system for incorporation in the appraisal. Thorough understanding of investments made in similar projects was sought in our due diligence process at the preliminary stage; thorough consideration was given to the feasibility and economics of the technical processes at the stage of feasibility study; and construction work was carried out in strict accordance with the design scheme at the construction stage. Equipment tenders commenced only after the completion of preliminary procedures. Work progress requirements were strictly specified with specific penalty terms in the tenders for civil engineering and installation contractors. Control measures and assessments were implemented at each milestone during the course of construction. Optimised designs were sought to maximise reduction in construction work cost. The suppliers' list was expanded and communication with suppliers (construction work contractors in particular) was enhanced to lower project cost.

工程預算與造價管理風險指在工程預算階段,未 能對技術要求、設計方案、工期要求、工程品 質、建設基礎條件等要素進行充分評估,或者對 工程量計算不準確,造成投資失控的情況,對本 公司財務帶來影響。本集團不斷提升工程現場的 標準化水準,不斷充實供應商庫,選擇優秀合作 夥伴,合理控制預算與工程造價。本集團在本年 度提高可行性研究報告深度及品質,使其與設計 工作緊密結合,提升預算的準確性。加快各設備 廠家和設計院之間的相互提資速度,內部理清各 設備間的提資順序,開展責任制梳理和落實工 作,納入考核。在項目前期,充分瞭解同類型項 目的投資情況;在可研階段,充分考慮到工藝的 可行及經濟性;在建設階段,嚴格按照設計方案 進行建設,落實完前期手續後,再進行設備招標 工作;在土建及安裝單位招標過程中,嚴格明確 進度要求,並提出針對性的罰則;在施工過程中 落實每個進度節點的管控,做好每個節點考核。 通過優化設計,儘量降低工程造價;拓展供應商 範圍,加強與供應商(特別是施工單位)的溝通, 降低工程造價。

The risk associated with recruitment and staff allocation refers to the insufficiency of existing staff backup capacity or establishment for important functions and positions, or inability to recruit sufficient management and technical personnel (especially the recruitment of technology team leaders) and experienced staff affecting the fulfilment of the Company's strategic and operating goals, thereby affecting the Company's development, finance and operation. The Group has sought to enhance its efficiency in recruitment and expand its recruitment channels through a variety of means, such as formulating plans to recruit talents from relevant specialised tertiary colleges and exploring the establishment of a long-term staff recruitment mechanism. We have also commenced the assessment of specialised job skills to procure better match between job requirements with staff competence. The Group is committed to improving its overall human resources management standard with greater efforts to maintain and manage staff relations to enhance staff unity and solidarity. Active efforts are being made to investigate the reasons for staff resignation and improve relevant management processes, with a view to making anticipatory preparations that would alleviate the adverse impact of staff turnover on the Company's production and operation. More duty-specific training sessions have been provided to enhance staff performance at job positions.

Risks associated with the COVID-19 pandemic. The COVID-19 pandemic has resulted in significant fluctuations in the prices of raw materials and eco-friendly consumables, thereby affecting the stability of the operation of project companies. Undersupply of raw materials will prevent the projects from reaching their design capacities, thereby resulting in an adverse impact on the Company's operations. Leveraging its strength in scale, the Group has continued to drive technological innovation and encourage staff inspiration, while promoting the experience of advanced projects to enhance production and operational management. Biomass fuel has been put to reasonable use and resources within the system have also been allocated in a reasonable manner. In connection with solid waste raw materials, more types of materials have been processed in greater volumes. Eco-friendly consumables have been put to reasonable use to enhance efficiency. Ongoing effort has also been made by the Group to broaden suppliers' channels, such that reasonable volumes could be maintained to ensure the sufficiency of raw materials. As the pandemic has basically come under effective control in China now, the Group's project companies have started to engage in normalised anti-epidemic measures. Staff health conditions are being closely monitored and the health impact of the pandemic is effectively countered through body temperature monitoring, health code inspection, distribution and use of anti-epidemic supplies and vaccination, thereby safeguarding the normal operation of the Company's production and business.

*新冠病毒疫情風險。*新冠病毒疫情對於原材料價 格、環保耗材價格都造成較大波動,從而對各項 目公司穩定運營造成影響。原材料供應不足將會 導致各項目無法達到設計產能要求,對本公司經 營造成不利影響。本集團發揮規模優勢,持續推 動技術創新,激發員工活力,總結推廣先進項目 經驗,加強生產運營管理。對於生物質燃料採取 合理使用,合理調配本系統內資源;對於固廢原 料,拓展處理品種,增加處理數量;對於環保耗 材,合理使用,提高使用效率。本集團亦不斷拓 寬供應商供貨管道,維持合理數量,確保原材料 充足。目前國內疫情已經基本得到有效控制,本 集團內各項目公司均進入抗疫常態化階段,時刻 關注員工健康狀況,通過監測體溫、健康碼檢 查、發放並使用防疫物品、注射疫苗等方式,有 效抵禦了疫情對員工健康的影響,從而保障了本 公司生產經營的正常進行。

Global climate change has left a material impact on the environment for human survival and, as an enterprise dedicated to environmental improvement, the Group has been monitoring such issue on an ongoing basis. During the year, effective preventive measures were adopted against risks for the Company's project construction and operation that might result from natural calamities, such as flood, hailstorm, persistently high or persistently low temperature, torrential rain, gale and thunderstorm, arising from extreme weather conditions. Measures to address extreme weather have been taken into consideration at the outset of project design, in order to strengthen the projects' ability to withstand disasters. During project operation, plans are drawn up to implement safety measures during extreme weather, while drills are being organised to enhance our ability to deal with such conditions. For projects susceptible to the impact of extreme weather, such as solar energy projects and wind power projects, relevant insurance have been taken out specifically, in addition to due preparations in the stages of project design, construction and operation, to avoid significant loss. Meanwhile, the Group has actively participated in and supported government authorities in the organisation of environmental projects conducive to the attainment of Dual Carbon, especially projects on safe disposal of waste, clean renewable energy and environmental remediation projects relating to soil, the atmosphere and water bodies, in a persistent effort to contribute to the improvement of the environment.

ENVIRONMENTAL AND SOCIAL MANAGEMENT

The Group has continued to make improvements to its ESHS management system, driving ongoing upgrades in the external as well as internal management of environment, safety, occupational health and social responsibility and improving systematic, regulated, standardised and delicacy management throughout the Group to maximise control over relevant risks and eliminate management deficiencies.

全球氣候變化對人類生存環境造成了重大影響, 本集團作為致力於環境改善的企業,對此持續保 持關注。本年度,針對極端天氣現象所引起的自 然災害,如洪水、冰雹、持續高溫、持續低溫、 暴雨、大風及雷電等,對本公司項目建設及運營 可能產生的風險進行有效防範。從項目設計開始 就考慮到極端天氣發生時的應對,提高項目對災 害的抵禦能力。項目運營期間,針對極端天氣編 製安全措施預案並組織演習,提高應對能力。對 於易受極端天氣影響的項目,如光伏發電項目及 風力發電項目,除在項目設計、建設及運營各階 段進行準備外,還有針對性投保相應保險,避免 出現重大損失。同時,本集團亦推動積極參與及 配合相關政府部門進行有助於實現雙碳的環保項 目,特別是對各類廢棄物進行安全處置、清潔可 再生能源,對土壤、大氣及水體進行環境修復相 關領域項目,力求不斷改善環境。

環境和社會管理

本集團不斷改進ESHS管理體系,推動環境、安全、職業健康和社會責任等內外部管理的不斷提升,優化本集團的系統化、規範化、標準化和精細化管理,最大限度管控相關風險,消除管理缺陷。


In 2021, the Group focused on enhancing management over operators of relevant parties and high-risk operations and exercised effective control over operational risks with the drafting of 9 standard regulatory procedures for high-risk operations and the launching of 17 joint inspections on specific areas. Regarding environmental management, the environmental management system was updated for better applicability with enhanced process supervision and pre-emptive warning to ensure compliant emission. In connection with epidemic prevention, the Group vigorously fulfilled its social responsibilities on top of persistent implementation of normalised epidemic control measures and was commended and honoured by the government for sending selected volunteers to assist the local governments of epidemic-affected areas to handle infected medical waste.

二零二一年度,本集團重點加強對相關方作業人員和高風險作業的管控,起草高風險作業管控標準程序9項,開展聯合專項檢查17次,有效地對作業風險進行管控;環境管理方面,對環境管理制度進行了適用性更新,強化過程監管和事面預警,確保達標排放;疫情防控方面,本集團在堅持落實常態化疫情防控措施的同時,積極承擔社會責任,選拔志願者赴疫區協助地方政府處理涉疫醫療廢棄物,獲得政府嘉許和榮譽。

The performance of the operations and environmental services of the Group's projects are gauged in strict adherence to relevant standards and requirements of their respective environmental impact assessment reports, taking into account the expectations of the neighboring communities. Major laws, regulations and standards applicable to the Group's projects include the "Environmental Protection Law of the People's Republic of China", the "Production Safety Law of the People's Republic of China", the "Labor Law of the People's Republic of China", the Standard for Pollution Control on the Municipal Solid Waste Incineration (GB18485-2014), Directive 2010/75/EU and its relevant Annexes/ Amendments, the Emission Standard of Air Pollutants for Thermal Power Plants (GB13223-2011), the Standard for Pollution Control on the Hazardous Waste Landfill (GB18598-2019) and the Standard for Pollution Control on Hazardous Waste Incineration (GB18484-2020), among others. No breach of the said laws and regulations and environmental standards resulting in significant loss for and impact to the Group was recorded in 2021.

Sustainability Governance Structure 可持續發展管治架構



We are committed to incorporating the philosophy of economic, environmental and social sustainability into our business and management practices, with specific responsible units named for the three dimensions of supervision, decision-making and execution. During the year under review, the Company added the new requirements for expertise and experience in responsibilities relating to risk management and sustainability in its "Nomination Policy" to support the Company's strategy and goals. Under the leadership of the Board, the Sustainability Committee and sustainability working groups enable the senior management to work with the subsidiaries and functional departments in a concerted manner with joint responsibility to drive the Group's sustainability efforts. The Sustainability Committee and sustainability working groups hold regular meetings and report to the Board. Furthermore, our enterprise risk management process provides comprehensive coverage of various risks, taking into account the effective preventive measures that were adopted against risks for the Company's project construction and operation that might result from climate change. Assisted by the Audit and Risk Management Committee and the Sustainability Committee, the Board has reviewed our risks and performance in sustainability to ensure that the Group has established and maintained an appropriate and effective risk management and internal control system. The annual risk management review indicates that our existing control measures are generally effective despite the macro-economic conditions and the higher risk levels of individual risk factors owing to the COVID-19 pandemic.

Climate change



Emissions reduction targets have been set for each country under the "Paris Agreement", aiming to control global warming during the century within 2 degrees Celsius since the level of the Industrial Revolution. In response to the challenge of climate change, the Chinese government and Hong Kong SAR Government have announced the longterm goal of achieving carbon neutrality in 2060 and 2050, respectively. However, climate change has already created numerous problems, such as rising sea levels, frequent extreme weather and torrential rain that causes mudflows, posing real threats to corporations operating in different regions, such as damage to equipment, staff casualties and loss of data, among others.

• The Group actively reduced greenhouse gas ("GHG") emissions and worked to lower emissions in accordance with international carbon reduction targets. Moreover, professionals were invited to conduct research on how to improve quality and enhance efficiency at various projects, with the aim of reducing energy consumption and thereby lowering GHG emissions. In Henan Province, for example, the Xiayi Integrated Project, Zhecheng Integrated Project and Sheqi Integrated Project carried out conversions to attain ultra-low emissions during the year, which were expected to reduce the emission of nitrogen oxides and sulphur dioxide by approximately 320 tonnes annually.

- The Group conducted in-depth research on market opportunities under the strategic backdrop of Dual Carbon and actively explored new business models, in a bid to foster new growth poles. During the year under review, we completed the "Greentech Carbon Neutrality Research Report" and the preliminary research for developing carbon reduction assets to prepare the Company for the development of carbon reduction assets.
- The Group appreciates that it is imperative to take the climate change issue into consideration when formulating its policies and long-term plans. We will conduct a comprehensive analysis to further assess the impact of climate change on our business, so as to improve long-term as well as short-term response measures, such as contingency plans for extreme weather and expanding sources for the supply of raw materials, among others.

《巴黎協定》設定各國的減排目標,致力在本世紀內把全球氣溫自工業革命以來的增幅控制在攝氏兩度以內。為回應氣候變化的挑戰,中國政府和香港特區政府更先後宣佈了在二零六零年及二零五零年達致碳中和的遠大目標。然而,氣候變化已引起許多問題,如海平面上升、極端天氣頻繁以及大雨引發泥石流等,對企業於不同地區的營運構成實體威脅,如設備損壞、員工傷亡和數據丢失等。

- 本集團積極減少溫室氣體排放,並致力 按照國際減碳目標降低排放量。此外, 我們邀請專業人士對多個項目進行提質 增效調研,旨在減少消耗能源,以減少 相關的溫室氣體排放。以河南省為例, 夏邑一體化、柘城一體化、社旗一體化 項目於年內進行了超低排放改造,預計 每年共可減氮氧化物和二氧化硫約 320噸。
- 本集團深入研究雙碳戰略背景下的市場機遇,積極探索新的商業模式,謀求打造新的增長極。我們於回顧年度內完成《綠色環保碳中和調研報告》以及碳減排資產開發前期調研,為本公司碳減排資產開發做好準備。

The circular economy stresses efficiency for the use of resources. An increasing number of corporations are exploring the feasibility of incorporating such concept in their business models, such as increased recycling and extension of useful life of products. The Chinese government has amended the "Circular Economy Promotion Law of the People's Republic of China" with the aim of enhancing efficiency in the use of resources and achieving sustainable development. The implementation of stringent national and regional policies will accelerate the general transformation of the society to circular economy. As a result, environmental enterprises will embrace massive opportunities for development.

Performance and progress during the year 年度表現和進程

- The Group was driving transformation in full force. The integrated biomass utilisation business was steering transition towards high value-added operations, as we continued to advance in our development in the heat supply market; the hazardous and solid waste treatment business was steadily transforming into an industrial environmental service provider, underpinned by the successful launch of the end-of-life tyre recycling business; we entered the solar market for the first time since our spinoff listing as our business presence was extended to Hong Kong. With a strong emphasis on creating driving force through technological innovation, the Group is commencing technological research to ensure our technologies meet the needs of our business transformation.
- To implement the national and provincial principle of giving priority to water conservation, local regions were actively driving water conservation initiatives in cities to increase the efficiency of water consumption; following joint examination by multiple parties, Everbright Biomass Energy (Weihai) Limited, Everbright Biomass Energy (Chuzhou) Company Limited*, Everbright Biomass Energy (Lingbi) Limited and Everbright Environmental Energy (Lingbi) Limited* were granted the status of provincial water conservation enterprise for the year 2021. The Group will continue to solidify its achievements in water conservation to bring into full play its role as an exemplary in water conservation and consistently improve its standard in water conservation management.

Hence, we are subject to the issue of cyber security and data protection on a massive scale.

Staff privy to confidential information are required to receive prejob confidentiality training. During the year under review, the "staff cyber information security awareness training and cyber security management training for information management officers" was arranged to enhance staff awareness for cyber information security and competence in preventing and handling cyber security incidents.
- To enhance management of inside information disclosure, the Group amended its "Policy and Procedures on Disclosure of Inside Information" during the year, providing detailed guidelines to all employees to ensure strict compliance with pertinent laws and regulations. Furthermore, we published the notice of "Code of Corporate Conduct (Trial)" during the year to specify the code of conduct for all employees, including compliance with national and corporate regulations on confidentiality.

According to the "China Renewable Energy Development Report 2019" published by China Renewable Energy Engineering Institute, China currently ranks first in the world in terms of installed capacity for wind power and is expected to sustain rapid growth in the future, thereby offering opportunities for development to environmental companies engaged in renewable energy. Conversely, the rapid development of renewable energy will oblige environmental companies to upgrade their technologies and management competence in this sector.

Performance and progress during the year 年度表現和進程

- During the year under review, the Group's research effort focused on carbon neutrality, solar energy storage and charging integration, recycled of bulk industrial solid waste, remediation of old landfill sites, end-of-life tyre recycling and incineration of hazardous waste with high sulphuric and halogenic contents, which provided support for the technical feasibility of its new business categories. The project for the "Development and Application of Safe, Clean and Efficient Incineration Technology for General Combustible Industrial Solid Waste", an international cooperation project in technology innovation of the Group under the National Kev Research and Development Programme, commenced successfully with preliminary completion of interim tasks, and provided nationwide technical support for 3 hazardous waste incineration projects, including Lianyungang Phase III, Haimen and Wenling.
- The Group developed the group standards of the audit guide for voluntary GHG emission reduction by biomass power generation projects in collaboration with BEIPA and formulated the "Propositions Relating to Regulations for Automatic Monitoring Data Marking of Pollutant Discharge Entities in Thermal Power, Cement and Paper Industries (Trial)" to drive qualitative development of the industry as a whole.

• The Group has formulated the "ESG Policy" which specifically requires due diligence on the supply chain to ensure there are no practices of child labour or forced labour in any form, serious health and safety risks and environmental risks, among others.

• The "Measures for Suppliers' Management" provides for the management of suppliers by tiers, stipulating the management duties of each tier such as the development, inspection and subsequent dynamic assessment of suppliers, among others. Suppliers in violation of rules will forthwith be included in the list of disqualified suppliers and be subject to restrictions in participating tenders.

- In future, we will procure efficient application of the issue proceeds to grasp opportunities in the green business. We will continue to fully utilise various financing instruments in the bond market and facilitate the issuance of the remaining credit limit as and when appropriate to provide long-term financial coverage for the Company's sustainable development.

COMPLIANCE WITH THE CORPORATE GOVERNANCE CODE

The Group believes that maintaining sound and high standards of corporate governance is not only a key element in safeguarding the interest of the Shareholders but also creating long term value for all relevant stakeholders by enhancing the corporate value, accountability and transparency of the Group.

The Group has constantly reinforced its internal control, risk prevention and management, corporate governance through a set of rules and regulations. The Group strives to inculcate the corporate governance, risk management and sustainable development concept into the Company's operation and business for cultivating the strong backup to the breakthrough development of the Company's business.

The Corporate Governance Code (the "CG Code") set out in Appendix 14 to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Stock Exchange") ("Listing Rules") has been adopted by the Board as the guidelines of corporate governance practices of the Company. During the year of 2021, the Company has fully complied with the code provisions set out in the CG Code.

1. RESPONSIBILITIES

The Board is responsible for formulating business policies and strategies, directing and supervising management of the Group, adopting and monitoring internal business and management control, approving and monitoring annual budgets and business plans, reviewing operational and financial performance, reviewing and monitoring the Company's systems of corporate governance, ESG, internal control, and risk management. It oversees the task of making decisions in the best interest of the Company and maximizing the financial performance of the Company. The Board has delegated the daily operations and the execution of Board policies and strategies by formulating and implementing of annual work plans and medium-term development plans for the Group to the management committee of the Company ("Management Committee"). The Company formalized the functions reserved to the Board and those delegated to Management Committee.

Management Committee holds meeting every month for discussing and reviewing the investment proposals, key personnel matters and appraisals, project schedules, budget executions, etc.

The Board has established 3 Board committees, namely Audit and Risk Management Committee, Remuneration Committee and Nomination Committee, to oversee the particular aspect of the Company's affairs. The Board committees are provided with sufficient resources to discharge their duties.

The Board acknowledges that it should take leadership for and accountability in promoting a top-down culture to ensure ESG considerations are part of the business decision-making process. Our comprehensive sustainability governance structure ensures the smooth implementation of sustainable development. A general description of the structure is set out in the section headed "Summary of the Sustainability Report" on pages 56 to 57 of this annual report. Details of the same will be stated in the 2021 sustainability report of the Company.

The Company has subscribed appropriate and sufficient insurance coverage on Directors' liabilities in respect of legal actions taken against the Directors arising out of corporate activities. The Directors may seek independent professional advice at the Company's expenses in carrying out their duties and responsibilities.

All Directors have full and timely access to all relevant information in relation to the Group's businesses and affairs as well as unrestricted access to the advice and services of the Company Secretary, who is responsible for providing Directors with board papers and related materials. The Company provides monthly updates to the Board members on the Company's performance and position to enable them to make a balanced and understandable assessments on the Company's performance, position, and prospect.

Board Evaluation

The Board recognizes that a formal, objective, and open assessment on a continuous basis can enhance the effectiveness of governance structure of the Company. Through the annual board evaluation exercise, each Director can share his/her opinions and concerns to the Company, which enhances Directors' accountability. The evaluation also enhances the continuing improvement and development of the Board and the Board committees by reflecting on their respective performance during the year, in turns improving board effectiveness and maximising its strengths. The Company Secretary acts as a bridge between the Board and the management of the Company, delivers the Board's opinions and concerns to the management, which in turn can take appropriate actions and report to the Board.

During the year under review, the Company conducted a board evaluation in the form of a questionnaire with a peer comparison, which took into account 5 key board performance and corporate governance areas, including Board structure, performance of the Board and Board committees, independent views, communication with stakeholders and professional development, allowing each Board member to rate relevant items in different areas. The Company Secretary conducted statistics on the evaluation results which concluded that the self-evaluation of the Board was at a mid-to-high satisfying level, and had reported the evaluation results to the Nomination Committee and the Board.

2. LEADERSHIP AND INDEPENDENCE

Mr. WANG Tianyi is the Chairman of the Board and Mr. QIAN Xiaodong is the Chief Executive Officer of the Company. The division of responsibilities between the Chairman of the Board and the Chief Executive Officer are clearly divided to ensure a balance of power and authority and to reinforce their independence and accountability.

Mr. WANG Tianyi, being the Chairman, is responsible for providing leadership to the Board and ensuring that the Board functions effectively; that Directors receive in a timely manner adequate information which is complete and reliable and that all Directors are properly briefed on issues arising at Board meetings. The Chairman also encourages Directors to participate actively in and to make a full contribution to the Board so that the Board acts in the best interest of the Company.

Mr. QIAN Xiaodong, being the Chief Executive Officer, is responsible for the daily operations of the Company, execution of business policies, strategies, objectives and plans as formulated and adopted by the Board and leading the management of the Company.

In compliance with rule 3.10 of the Listing Rules, the Company has appointed 3 Independent Non-executive Directors, one of whom has appropriate professional qualifications in accounting and financial management. The Company has received from each of the Independent Non-executive Directors an annual confirmation of his independence and considers them to be independent in accordance with the guidelines for assessing independence set out in rule 3.13 of the Listing Rules. The Nomination Committee has reviewed and concluded that there is no business or other relationships with the Group or management that are likely to affect, or could affect their independence.

Directors have disclosed to the Company the number and nature of office held in Hong Kong and overseas listed companies and organizations, and their other significant commitments. Biographical details of the Directors are set out on pages 109 to 114 of this annual report.

The Nomination Committee has reviewed the "Nomination Policy" and the structure, size, composition (including skills, knowledge and experience) and performance of the Board and the qualification and experience of each of the Director according to the "Board Diversity Policy" and the "Nomination Policy". It has also reviewed the appointment letters of 2 Non-executive Directors and 3 Independent Non-executive Directors, considered the independence of each of the Independent Non-executive Director and assessed the qualification and experience of the Directors to be retired and entitled to be re-elected at the AGM. The aforesaid reviews were recommended to the Board.

The ultimate decision will be based on merit and contribution that the selected candidate(s) will bring to the Board.

In consideration with the strategies and objectives of the Company, the Nomination Committee takes a prime role on board recruitment, including the appointment, re-appointment or/and redesignation of the director(s), to ensure the Board possesses a balance of skills, experience and diversity of perspectives appropriate to the requirement of the business of the Company. When considering a candidate nominated for directorship or a director's proposed re-appointment, the Nomination Committee will make reference to certain selection criteria, such as potential time commitment for the Board/committees responsibilities, reputation for integrity, accomplishment and experience in environmental industry, independence of the candidate and governmental or geopolitical expertise. Nomination committee will review annually the structure, size and diversity of the Board, external agencies for collecting impartial opinion in the nomination procedure may be engaged if necessary. The Board, having the ultimate responsibility for selection and appointment of Director(s), will contemplate the recommendations from the Nomination Committee when considering candidate(s) to be appointed or re-appointed as Director(s).

She also acts as the secretary to the 3 Board committees and Sustainability Committee. She prepares and keeps detailed minutes of each Board meeting, Board committee meeting and Sustainability Committee meeting. Within a reasonable time after each meeting, the draft minutes are circulated to all Directors or committee members for comments and the final and approved version of minutes are sent to all Directors or committee members for their records. Board committees, including the Audit and Risk Management Committee, Nomination Committee and Remuneration Committee, all follow the applicable principles, practices and procedures used in Board meetings. The Company Secretary is also responsible for organizing Board trainings for all Directors and circulating to all directors materials relating to the Directors' jobs and duties for their review.

Ms. CHOW Wing Man possesses professional qualification and extensive experience in discharging her duties as the Company Secretary of the Company and she is an employee of the Company and directly reports to the Chief Executive Officer.

4. CORPORATE CULTURE

The Board emphasizes in creating long-term sustainable growth for Shareholders and delivering long-term value to all stakeholders. Communication is critical to good governance. The valuable recommendations contributed by each committee are highly valued by the Board and the Board takes proactive actions to put the recommendations in place. Facing the major international trends of climate change and circular economy, Everbright Greentech, as an environmental enterprise, endeavors to implement the development of ESG, it also strives to seize the business opportunities derived from them. The Board often discuss and give supportive suggestions on these international trends in the meetings. Staff is the valuable asset of the Company. Specific sessions were conducted for collecting opinions from the staff of project companies and headquarters. The topics of those sessions relate to technical management, construction work management, talent grooming, remuneration and incentive, team integration, etc. Senior management would listen to their views and suggestions to reconsider or adjust its operational and management thinking to formulate management regimes and systems which are compatible with its corporate development.

Other than providing the ESG related trainings to the Board and senior management as stated in the section of "Attendance of Meetings and Trainings of Directors of the Company in 2021" subsequent below, the Company appreciates staffs' personal development are closely associated with the Company's development. To strive for better performance, in 2021, sustainability working group members strengthen their work capacity by gaining the qualifications relating to the Company's ESG performance and reporting, such as Certified Environmental, Social and Governance Analyst (CESGA®) awarded by The European Federation of Financial Analysts Societies (EFFAS), Chartered Governance Professional awarded by The Hong Kong Chartered Governance Institute (formerly known as The Hong Kong Institute of Chartered Secretaries, "HKCGI") and GRI Certification Training Program. The sustainability working group members also actively joined the ESG related forums and seminars arranged by HKEx and professional bodies.

The Company adopted and implemented a series of policies and procedures to ensure the good corporate governance is maintained, including but not limited to "Risk Management Policy", "Policy and Procedures on Disclosure of Inside Information", "Whistleblowing Policy" and "Shareholders Communication Policy". Those policies and procedures are reviewed and monitored periodically.

Board Meetings

During the year of 2021, the Board held 5 meetings. In addition to Board meetings, the Chairman held 1 meeting with Independent Non-executive Directors annually without the presence of Executive Directors and Non-executive Directors. Should a Director have a potential conflict of interest in a matter being considered in the Board meeting, he/she will be abstained from voting. Independent Non-executive Directors with no conflict of interest will be present at meetings dealing with such conflict of interest issues.

When approving a connected transaction, apart from the fairness of the agreement terms, the Independent Non-executive Directors also consider the commercial rationale and the benefits brought by the proposed transaction to the business of the Group.

During the meetings, Independent Non-executive Directors, based on their respective expertise and experience as well as the perspectives of minority Shareholders, actively brought out valuable opinions and queries in order to allow the Board to have comprehensive analysis and decisions on each issue. According to the Board evaluation result in 2021, it was recognized that the Directors had been able to seek external independent professional advice in appropriate circumstances to assist them in the performance of their duties as reasonably required, had made significant contribution to the Board by actively participating in the Board and committees meetings and had provided independent, constructive and well-founded opinions.

According to the Board evaluation result in 2020, the Company Secretary arranged two Board trainings with the title of "Forward looking challenges: setting ESG goals and themes (前瞻性挑戰:設定ESG 目標和方向)" organized by external sustainability consultant and "Exploring ESG of the Board and climate governance (探討董事會ESG和氣候治 理)" organized by The Hong Kong Institute of Directors. Other than the above, the Directors participated in the seminars relating to anti-corruption and/or the seminars in ESG Academy. They have read regulatory/legal updates and other materials pertinent to directors' duties and responsibilities. To meet the expectations and practical needs of the Directors, the Company Secretary has obtained the views of the Directors through a questionnaire and has consolidated their views, which will be progressively advanced as appropriate.

Taking an Active Interest in the Company's Affair

Other than attending regular meetings, the Directors take an active interest in the Company's affairs and obtain a general understanding of its business. Since the outbreak of the pandemic, traffic has been blocked, therefore the Executive Directors visited the project companies when the pandemic was under control, or monitored project operation and employee health and safety through electronic communications from time to time.

Mr. CHOW Siu Lui, the Independent Non-Executive Director, is also one of the persons in charge of whistleblowing case handling, and had joined the online open-to-the-public activity held by Fengyang Integrated Biomass and Waste-to-Energy project on 3 November 2021. To enhance online interaction, the live cast Q&A session was brought. Questions raised by Mr. CHOW relating to the emergency response and preparedness training were answered by staff of the Fengyang Project.

To complement with the development of the laws and regulations and investors' expectations, the Company established a sustainability governance structure. Sustainability Committee, setting up with terms of reference, comprises the Chief Executive Officer as the chairman and 3 Independent Non-executive Directors as the members of the committee. The committee members can directly learn about the latest development of the Company's operations and talent development in the meeting. From the perspective of sustainable development, the Independent Non-executive Directors, leveraging their knowledge and experience, could provide the management of the Company more pertinent and directional opinions, assisting the Company to control risks and capture opportunities. During 2021, Sustainability Committee has reviewed the 2020 sustainability report, discussed the new updates on ESG disclosure requirements, discussed the plan of targets setting on waste emission, exhaust emission, energy use, water resource use and carbon reduction, and reviewed "Waste Management Policy", "Energy Management Policy" and "Water Resource Management Policy".

According to the assessment of the Nomination Committee, our Directors are able to devote sufficient time and effort to perform their duties, despite some of them are holding multiple directorship positions or important tasks in universities.

Compliance with Model Code

The Company has adopted the Model Code for Securities Transactions by Directors of the Listed Issuers (the "Model Code") as set out in Appendix 10 to the Listing Rules as its code of conduct regarding directors' securities transactions. Specific enquiries have been made with all Directors regarding any noncompliance with the Model Code and all Directors confirmed that they have complied with the provisions of the Model Code for the year ended 31 December 2021.

Policy and Procedures on Disclosure of Inside Information

The Board has formally adopted the "Policy and Procedures on Disclosure of Inside Information" which contains the guidelines to the Directors and the Relevant Employees to ensure that the inside information of the Company is to be disseminated to the public in an equal and timely manner in accordance with the applicable laws and regulations. The monitoring system is established to set up formal escalation path of material information in relation to the business, finance and operations of the Group and such information is escalated to headquarters in a timely manner. Chief Executive Officer, in the assistance of the finance department and company secretarial department, determines whether such information constitutes inside information within the meaning of Part XIVA of the Securities and Futures Ordinance, Chapter 571 of the laws of Hong Kong ("SFO") and whether disclosure requirements are needed to be fulfilled. External advisers may be engaged if needed throughout the process.

During 2021, to enhance the awareness of the specified procedures of handling inside information and the importance of compliance with the regulations of insider dealing, the inside information policy and monitoring system were updated. Such policy, together with the enforcement actions taken by the Securities and Futures Commission relating to insider dealing, were circulated to the Relevant Employees from time to time.

In order to maintain business integrity and promote a healthy working culture, a fair and effective "Whistleblowing Policy", complementing with a confidential handling mechanism, is adopted. The scope and purpose of "Whistleblowing Policy" is stated in the Company's website at https://www.ebgreentech.com/en/about/ewp.php.

As stated in the "Whistleblowing Policy", the Company prohibits the disclosure of identity of the whistleblower without consent, unless otherwise specified by law. A well-defined whistleblowing and reporting mechanism can increase the trustfulness of the whistleblower and the whistleblower protection is being enhanced through effective awareness-rising, communication, and training. The whistleblowing reporting channel can be accessed on the Company's website, staff handbook, intranet and annual report. An induction briefing to new joiners be conducted for providing clear explanation on their right and obligations when disclosing wrongdoing.

All whistleblowing cases and the investigation results will be discussed in the Audit and Risk Management Committee meetings and report the same to the Board on semi-annual basis. During 2021, there were 5 cases reported through the whistleblowing channels. No cases were refused to be reported and all cases were reviewed by the external auditor of the Company. After the investigation, these cases were not involved misconduct, fraudulent activities, or malpractices in any matter related to the Group. These cases had exposed the internal management and miscommunication issues, the necessary measures and actions were immediately undertaken by the management.

明確的舉報及報告機制可提高舉報人的信任度,並通過有效的意識提升、溝通及培訓提高舉報人的保護水平。舉報渠道可於本公司網站、員工手冊、企業內聯網及年報上獲取。本公司向新入職者進行簡介,於披露不當行為時,對彼等的權利及義務提供清晰的解釋。

Anti-bribery and Corruption Policy

Our "Staff Handbook" and "Code of Corporate Conduct (Trial)" provide that all employees are strictly prohibited to accept or offer bribes from anyone in the conduct of company affairs, should stay vigilant against corruption and report any cases in accordance with the "Whistleblowing Policy" in a timely manner if they become aware of or reasonably suspect that individuals or enterprises engaged in business transactions with the Group which might involved in corruption. Moreover, staff should surrender gifts or souvenirs provided by individuals or enterprises engaged in business transactions with the Group, and should refuse any unreasonable hospitality to avoid compromising their business judgement.

During the year, the Executive Directors and the employees had attended a seminar with the theme of integrity management organized by the Independent Commission Against Corruption. The Chairman of the Board, the Executive Directors and senior management had also attended another integrity education seminar hosted by CEEGL.

5. AUDIT AND RISK OVERSIGHT

Audit and Risk Management Committee and Accountability

The Audit and Risk Management Committee, currently comprises all 3 Independent Non-executive Directors, namely Mr. CHOW Siu Lui (chairman), Mr. Philip TSAO and Prof. YAN Houmin. Details of the committee's membership and members' attendance records during 2021 are set out on page 87 of this report.

5. 審核及風險監督

The Audit and Risk Management Committee is primarily responsible for, including but not limited to, providing an independent review of the effectiveness of the financial reporting process, risk management and internal control systems of the Group, overseeing the audit process, reviewing the completeness, accuracy, clarity and fairness of the Company's financial statements, considering the scope, approach and nature of both internal and external audits, reviewing and monitoring connected transactions and performing other duties and responsibilities as may be assigned by the Board from time to time, etc. The terms of reference of the Audit and Risk Management Committee are published on the websites of both the Company and HKEx.

The Audit and Risk Management Committee held 3 meetings in 2021 and all minutes were kept by the Company Secretary. The Audit and Risk Management Committee has reviewed with the management and the external auditor of the Company, including but not limited to, the accounting principles and practices adopted by the Group, significant audit matters such as significant accounting estimates and judgmental areas and external auditor's audit plan; and has reviewed and discussed the Group's financial reporting matters, including review of the audited financial results for the year ended 31 December 2020 and the unaudited interim financial results for the six months ended 30 June 2021. The Audit and Risk Management Committee also approved the remuneration and the terms of employment of the external auditors, and recommended the respective re-election to the Board. In order to ensure the effectiveness of the risk management and internal control functions of the Company, the committee reviewed, discussed and monitored the works of risk management and internal audit in 2021 and their plans for 2022. Further, it has reviewed the compliance of continuing connected transactions; the adequacy of resources, staff qualifications and experience, training programmes and budget of the Company's accounting and financial reporting function; and the investigation results of the whistleblowing cases reported through the whistleblowing channels. The Audit and Risk Management Committee reported that there was no material uncertainty that cast doubt on the Company's going concern ability. The aforesaid reviews were recommended to the Board.

Dividend Policy

Adhered to the principle of sharing the fruit of our success with our Shareholders, the Board has adopted "Dividend Policy". Subject to certain factors, including but not limited to, general business conditions and strategies of the Company and the Company's financial results and capital requirements, the dividend payout ratio is approximately 20%.

Risk Management and Internal Control

The Group always places emphasis on risk management and internal control. The main features of the risk management system of the Group are summarised as follows:

I. Risk Management Objective, Mission and Risk Preferences

The risk management objective of the Group is to ensure the realisation of the Company's strategic and operational goals through carrying out risk management works in terms of participating in the development and diversification of the Company's strategic goals and ensuring the achievement of financial and non-financial operational goals.

The mission of risk management of the Group is to ensure "Overall Compliance, Minimise Weaknesses, Manage Uncertainties and Optimise Performance-based Management".

The risk management is guided by the medium-to-long term strategic goals of the Group. We formulate our own risk appetites reasonably by focusing on 6 dimensions including "Investment, Finance, Engineering Construction, Operation, Reputation and Human Resources" through stable market expansion and prudent operation management. Moreover, we set up our quantitative early warning values and limit values in line with our financial and non-financial indicators and constantly optimise the effectiveness of internal control to enhance our risk resistance and management control capabilities.

風險管理及內部監控

本集團一貫重視風險管理與內部監控,下 文概述本集團風險管理系統的主要特徵:

一、 風險管理目標、使命及風險偏好

本集團以保障本公司戰略和經營目標 的實現作為風險管理目標,從參與本 公司戰略目標的發展與多元化、保障 財務類經營目標與非財務類經營目標 實現等方面開展風險管理工作。

本集團以確保「全面合規、弱勢最小 化、不確定性管理、績效最優化管 理」作為風險管理的使命。

風險管理以本集團中長期戰略目標為 導向,通過穩妥的市場拓展和審慎的 運營管理,圍繞「投資、財務、工程 建設、運營、聲譽及人才」6個維度合 理制定自身風險偏好。此外,通過財 務類指標與非財務類指標量化設置預 警值與限額值,不斷優化內部監控的 有效性,提升風險抵禦與管控能力。

II. Risk Management Structure

The risk management structure of the Group is based on the following "Three Lines of Defense" model:

Board

The Board shall be responsible for the evaluation and determination of the nature and level of risk it is willing to undertake in order to achieve the strategic targets of the Group. It shall also ensure the establishment and maintenance of proper and effective risk management and internal control systems by the Group.

Audit and Risk Management Committee

The Audit and Risk Management Committee shall assume the role of supervising the overall risk management structure of the Group and provide advice to the Board on any risk-related matter of the Group.

First Line of Defense

In respect of the first line of defense, each of the business centre, the project companies, command authority and project departments of the Group, being the officers for risk management, shall ensure effective implementation of risk control measures based on the risk management system and requirements of the Company, supervise any risk which involve in every business operations and collect details of, and report any risk-related incident in a timely manner.

董事會

Second Line of Defense

The risk management department, being the second line of defense, shall, based on the Board's appetite, identify and assess relevant risks and conduct necessary monitoring in this regard, execute appropriate supervision to ensure effective and efficient control of all activities of all departments internally or between different departments, as well as evaluate and provide regular report to the Audit and Risk Management Committee. Each functional department at headquarters jointly deals with the risk-related incidents reported from the first line of defense and the comments from the Audit and Risk Management Committee with the risk management department.

Third Line of Defense

For the third line of defense, the department of internal audit shall carry out internal audit on a yearly basis and ensure the effectiveness of the first and the second lines of defense. The department of internal audit shall provide to the Audit and Risk Management Committee and the Board an independent assurance as to the sufficiency and effectiveness of the internal control of the Group.

III. Risk management process

The Board has formulated with due care a "Risk Management Policy" and risk tolerance levels through the Audit and Risk Management Committee, while the management identifies and ranks major risks according to sources of risks, scope of influence, incidents and their potential impact. Risks identified have been categorised into policy changes, trade receivables, environmental compliance and safety management, investment and business development, construction work budget and cost management, recruitment and staff allocation. Discussion in relation to the description of principal risks exposed to the Group, the material impact that may have occurred or may occur in future, and the corresponding mitigation measures is set out in the section headed "PRINCIPAL RISKS AND UNCERTAINTIES" in the "Management Discussion and Analysis" on pages 45 to 52 of this annual report. The Group's risks are classified according to their

IV. Risk Control and Report

A report, which contains the implementation of risk control measures and the results of risk management, as well as details of the risk-related incidents, shall be submitted to the risk management department by each risk bearing unit on a quarterly basis. Based on the contents reported by various project companies and functional departments, the risk management department will prepare "Risk and Internal Control Report" and submit the same to the management of the Company. The management of the Company will understand the status of risk management and optimise the relevant measures. The Audit and Risk Management Committee provides assistance to the Board for maintaining and monitoring the effectiveness of the risk management and internal control systems of Everbright Greentech. The risk management department and internal audit department will semiannually provide conclusive report to the Audit and Risk Management Committee in respect of the risk management and internal control aspects of the Company, and adopt the risk management and internal control plan for the next year. In addition, the Board reviews principal risks taken by Everbright Greentech annually. The risk management department submits the "Risk and Internal Control Report" to the Audit and Risk Management Committee on a quarterly basis.

The Board and the Audit and Risk Management Committee have conducted reviews on the adequacy of resources, staff qualifications and experience, training programmes and budget of the accounting, internal audit and financial reporting functions, and they considered all of the above were adequate.

V. Internal Audit

Everbright Greentech has established the internal audit department which shall directly report to the Audit and Risk Management Committee. Undertaking a key role to provide assurance to the Board of proper maintenance and operation of the internal control system by the management, the internal audit department prepares internal audit report to the Audit and Risk Management Committee and the Board for the review of the sufficiency and effectiveness of the internal audit functionalities. Any matter proposed in the internal audit report shall be dealt with by the management in a timely manner. The Audit and Risk Management Committee and the Board are satisfied with the sufficiency of the risk management and internal control systems of the Group.

VI. Risks Management Culture

Sound communication and ongoing education are among some of the effective means adopted by the Group to cope with existing material risk and internal control issues. Members of the Audit and Risk Management Committee actively furnish specific opinions to the management in relation to the development, operations and culture building of the Company's risk management system, while the management carried out the tasks of implementing the operation of the risk management system and promoting the risk management culture with pragmatic efforts to strengthen the risk management awareness of frontline staff.

A safe working environment is particularly important in the environmental industry. During the year, the Group carried out safety management works in an orderly manner in accordance with its internal safety management system. It conducted comprehensive safety risk inspections on a quarterly basis, with irregular inspections on the implementation of various safety management systems of project companies to identify issues and make rectifications in a timely manner, so as to eliminate potential safety hazards. The Company has set up an ESHS management system to exercise systematic control over risks relating to its operations. For details, please refer to the section headed "ENVIRONMENTAL AND SOCIAL MANAGEMENT" in the "Management Discussion and Analysis" on pages 52 to 53 of this annual report.

The environmental industry itself is already an industry with many SOP. When experienced employees face difficulties and risks in their daily works, they do not want to be restricted by more policies and codes, but a set of feasible and effective work methods.

VII. External Audit

External auditor carries out an assessment of the financial reporting, relevant risk management procedures and the control of the Company, and reports the issues of risks and control identified in the process of the audit to the Audit and Risk Management Committee.

VIII. Annual Confirmation

The risk management and internal control systems of the Group are designed to provide reasonable but not absolute assurance against material misstatement or loss, as well as to manage rather than eliminate the risk of failure to achieve business objectives. The systems take up an important role in risk management, which is critical to achieving business objectives. Through the Audit and Risk Management Committee, the Board has reviewed the risk management and internal control systems of the Group for the year ended 31 December 2021, and considered that the systems were effective and sufficient during the year. The management has provided confirmation as to the effectiveness of the systems for the year ended 31 December 2021 to the Audit and Risk Management Committee and the Board.

7. SHAREHOLDERS RIGHTS AND AGM

Shareholder Relations

The Company understands the importance of maintaining effective mutual communication with its Shareholders and values every opportunity to communicate with them. The Company has adopted a policy of disclosing clear and relevant information to Shareholders through various channels in a timely manner. Annual and interim reports are printed and sent to all Shareholders. The Company has also complied with the Listing Rules by posting announcements, notices, annual reports, interim reports, sustainability reports and shareholders' circulars on the websites of both the Company and HKEx for the designated period. Apart from these documents, press releases are posted on the Company's website to enhance its transparency. Being constantly updated in a timely manner, the website also contains a wide range of additional information on the Company's business activities. The corporate communications can be accessed by clicking "Investor Relations" section on the home page of the Company's website.

In addition to publication of information, the AGM provides a forum for communication between investors, Shareholders and Directors. The AGM and site visit proceedings have been well prepared to ensure that the Company will follow corporate governance practices and Shareholders' rights are preserved.

The AGM was held on 17 May 2021, the Chairman of the Board chaired the AGM and the chairman (or their delegates) of each Board committee attended the meeting to ensure Shareholders' views are communicated to the Board. Auditor of the Company was available to answer any queries that Shareholders may raise.

Procedures for Shareholders to Convene an Extraordinary General Meeting ("EGM")

Pursuant to Article 64 of the Articles of Association, any one or more members holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company ("EGM Requisitionists") shall at all times have the right, by written requisition sent to the Board or the Secretary of the Company, to require an EGM to be called by the Board for the transaction of any business specified in such requisition; and such meeting shall be held within 2 months after the deposit of such requisition.

The EGM Requisitionists can deposit the written request at the Company's principal place of business in Hong Kong, which is currently located at Room 3602, 36/F., Far East Finance Centre, 16 Harcourt Road, Hong Kong. The EGM Requisitionists must state in their request(s) the objects of the EGM, and such request must be signed by all the EGM Requisitionists, any may consist of several documents in like form, each signed by one or more of the EGM Requisitionists.

The share registrar will verify the EGM Requisitionists' particulars in the EGM Requisitionists' request. Promptly after confirmation from the share registrar that the EGM Requisitionists' request is in order, the Company Secretary will arrange the Board to convene an EGM by serving sufficient notice to all the registered Shareholders in accordance with all the relevant statutory and regulatory requirements. On the contrary, if the EGM Requisitionists' request is verified not in order, the EGM Requisitionists will be advised of this outcome and accordingly, an EGM will not be convened as requested.

If within 21 days of such deposit the Board fails to proceed to convene such meeting the EGM Requisitionists' himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the EGM Requisitionists by reason of the Board's failure to duly convene an EGM shall be reimbursed to the EGM Requisitionists by the Company.

However, Shareholders are requested to follow Article 64 of the Articles of Association for including a resolution at an EGM. The requirements and procedures are set out above. Pursuant to Article 113 of the Articles of Association, no person other than a Director retiring at a meeting, shall, unless recommended by the Directors for election, be eligible for election as a director at any general meeting unless a notice signed by a member (other than the person to be proposed) duly qualified to attend and vote at the meeting for which such notice is given of his intention to propose such person for election and also a notice signed by the person to be proposed of his willingness to be elected shall have been lodged at the head office or at the registration office provided that the minimum length of the period, during which such notices(s) are given, shall be at least 7 days and that (if the notices are submitted after the dispatch of the notice of the general meeting appointed for such election) the period for lodgment of such notice(s) shall commence on the day after the dispatch of the notice of the general meeting appointed for such election and end no later than 7 days prior to the date of such general meeting. The written notice must state that person's biographical details as required by rule 13.51(2) of the Listing Rules. The procedures for Shareholders to propose a person for election as Director is posted on the Company's website.



The Group has been maintaining harmonious relationships with local communities with sincerity and openness. Residents of the community are invited to take part in project investigation and hearing sessions prior to project construction so that we could sufficiently solicit their opinions on project construction. Moreover, the Group has continued to enhance the fulfilment of its responsibility to open its environmental facilities to the public by exploring online open-house activities conducted mainly by way of Internet livecast, in order to broaden the scope of the opening of environmental facilities to the public and enhance its influence. As at the end of 2021, 44 projects had been opened to the public and 248 offline public open day activities with a total of 4,500 participants, as well as 1 online open day activity attracting more than 9,785 views, had been organised.

Led by Mr. WANG Qingqiang, deputy general manager of the Fengyang Project, the officers in-charge of various departments explained the processes for handling household waste and the operating model, processing techniques and environmental emissions of biomass projects, and answered questions raised out by the audience.

Environmental policy and performance

As a professional environmental protection service provider in China, the Group is committed to delivering greater investment value to various stakeholders and undertaking greater social responsibility in fulfilment of its corporate mission of being "Devoted to Ecology and Environment for a Beautiful China". Against this backdrop, the Group is profoundly aware of the importance of low-carbon green development, and has established an Environmental Management Department for the supervision of relevant matters to ensure that the entire life cycle of operation has been taken into full consideration in our internal policies and relevant management plans. At present, management systems such as the "Compilation of Environmental Management Systems", "Waste Management Policy", "Water Resource Management Policy", "Energy Management Policy" and "ESG Policy" have been formulated by the Group to lay down detailed management rules for different environmental aspects, such as discharge and emission, energy consumption and climate change. Meanwhile, the Group has developed a number of environmental standards, including the "Environmental Protection and Social Responsibility Management Standards", "Environmental Monitoring and Testing Management Standards", "Atmospheric Pollutant Emission Management Standards", "Water Pollutant Emission Management Standards" and "Solid Waste Management Standards" to provide standardised criteria for environmental management. To ensure effective implementation of our policies, environmental task force groups headed by general managers have been established at all project companies to oversee environmental management. Dedicated personnel have been instituted to conduct regular tests on the environmental indicators of exhaust gas, wastewater, solid waste and noise. The brief discussion on the Group's environmental performance are set out on pages 52 to 67 of this annual report and the details of our environmental performance will be presented in the annual sustainability report to be published later this year. During the year under review, the Group consistently applied standardised operational models, formulated contingency plans and conducted inspection over actual implementation in persistent adherence to its ESHS management regime, making effective rectifications in respect of issues identified.

環境政策及表現

作為中國專業環保服務提供者,本集團以「情繫 生態環境,築夢美麗中國」為企業使命,願為不 同持份者創造更好的投資價值,承擔更多的社會 責任。在此背景下,本集團深諳綠色低碳發展之 重要性,並設有環境管理部門負責監督相關事 宜,確保內部政策及相關的管理方案均充分考慮 運營的整個生命週期。目前,本集團已制定《環 境管理制度匯編》、《廢棄物管理政策》、《水資源 管理政策》、《能源管理政策》及《環境、社會及管 治政策》等管理制度,明確有關排放物、能源使 用以及氣候變化等不同環境範疇的管理細則。同 時,本集團已建立《環境保護和社會責任管理標 準》、《環境監測管理標準》、《大氣污染物排放管 理標準》、《水污染物排放管理標準》及《固體廢棄 物管理標準》等多項環境標準,以規範環境管理 準則。為確保政策有效實行,各項目公司已成立 以總經理為首的環境工作小組,全面負責環境管 理工作,並設專責人員定期測量廢氣、廢水、固 廢以及噪聲等環境指標。有關本集團環境表現的 簡要討論列載於本年報第52頁至67頁及有關的環 境表現詳情將會在本年度稍後時間發表的年度可 持續發展報告中彙報。於回顧年度內,本集團繼 續深化ESHS管理體系,貫徹執行標準作業模式、 制定事故應急預案並對具體執行情況進行檢查, 針對發現的問題實現了有效的整改。

Compliance with laws and regulations having a material impact on the Group

The Group acts in strict accordance with laws and regulations of the operating locations which may have a material impact on its operations, conducts its business with integrity and subject itself to the supervision of government, social groups and the public. To this end, the Group has formulated the "Regulations for the Administration of Legal Affairs" and developed a regime for the administration of legal affairs which is centrally administered by the Risk Management Department and consistently implemented by the subsidiaries.

With reference to laws and regulations relating to the environment and operations, the "Environmental Protection Law of the People's Republic of China" might have a material impact on the Group's business. Such law is aimed at protecting and improving the environmental, preventing pollution and other public hazards, safeguarding public health, advancing the building of ecological civilisation, and facilitating sustainable economic and social development. Competent environmental authorities could order enterprises which have committed violations of environmental regulations, such as exceeding benchmarks and total volumes for emission, to curb production, suspend production for rectification or close down the operation. The Group has instituted a number of internal policies and procedures and ensures prudent management through regular reviews, training and examination. In 2021, there were no cases of violation of such law.

On the corporate level, the Group complies with the requirements under the companies ordinances in the Cayman Islands, Hong Kong and the PRC, the Listing Rules and the SFO for, among other things, the disclosure of information and corporate governance, and the Group has adopted the Model Code as set out in Appendix 10 to the Listing Rules.

RETIREMENT SCHEME

The Company operates a Mandatory Provident Fund Scheme (the "MPF Scheme") under the Hong Kong Mandatory Provident Fund Schemes Ordinance for employees employed under the jurisdiction of the Hong Kong Employment Ordinance and not previously covered by the ORSO Scheme. The MPF Scheme is a defined contribution retirement scheme administered by independent trustees. Under the Group's MPF Scheme, the employer and its employees are each required to make contributions to the scheme at 10% and 5% of the employees' relevant income, respectively.

The employees of the subsidiaries in the PRC are members of the retirement schemes operated by the local authorities. The subsidiaries are required to contribute a certain percentage of their payroll to these schemes to fund the benefits. The only obligation of the Group with respect to these schemes is the required contributions under the schemes. The Group's total contributions to these schemes charged to the consolidated statement of profit or loss during the year ended 31 December 2021 amounted to HK\$66,514,000.

1. CORPORATE AND GROUP INFORMATION

China Everbright Greentech Limited (the "Company") is a limited liability company incorporated in the Cayman Islands. The registered office address of the Company is Cricket Square, Hutchins Drive, PO Box 2681, Grand Cayman, KY1-1111, Cayman Islands.

During the year, the principal activities of the Company and its subsidiaries (collectively referred to as the "Group") are construction, integrated biomass utilisation project operation (biomass direct combustion power generation projects, biomass heat supply project, biomass electricity and heat cogeneration projects, waste-to-energy projects and integrated biomass and waste-to-energy projects), hazardous and solid waste treatment project operation (hazardous waste landfill projects, hazardous waste incineration projects, general industrial solid waste electricity and heat cogeneration projects and physicochemical and resources recycling projects), environmental remediation project operation and solar energy and wind power project operation (solar energy projects and wind power projects).

The immediate holding company of the Company is China Everbright Green Holdings Limited, a limited liability company incorporated in the British Virgin Islands. In the opinion of the directors, the ultimate holding entity of the Company is China Investment Corporation, an entity established in the PRC.

2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") (which include all HKFRSs, Hong Kong Accounting Standards ("HKASs") and Interpretations) issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA"), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention, except for certain debtors which have been measured at fair value. These financial statements are presented in Hong Kong dollars and all values are rounded to the nearest thousand except when otherwise indicated.

1. 公司及集團資料

年內,本公司及其附屬公司(統稱「本集團」)之主要業務為建造、生物質綜合利用項目運營(生物質直燃發電項目、生物質供熱項目、生物質效量等。 也以及生物質及垃圾發電一體化項目)、危廢及固廢處置項目運營(危廢填埋項目、危廢焚燒項目、一般工業固廢熱電聯供項目和物化及資源化利用項目)、環境修復項目運營及光伏發電及風電項目運營(光伏發電項目及風電項目)。

本公司之直接控股公司為中國光大綠色控股有限公司,其為於英屬維爾京群島註冊成立之有限責任公司。董事認為,本公司之最終控股實體為中國投資有限責任公司,其為於中國成立之實體。

2.1 編製基準

此等財務報表乃按照香港會計師公會(「香港會計師公會」)頒佈之香港財務報告準則(「香港財務報告準則」)(包括所有香港財務報告準則、香港會計準則(「香港會計準則」)及詮釋)、香港公認會計原則及香港公司條例的披露規定而編製。此等財務報表已根據歷史成本慣例編製,除若干已按公允值計量的應收賬款外。此等財務報表乃以港幣呈列,除另有指明外,所有數值均調整至最接近的千位數。

Basis of consolidation

The consolidated financial statements include the financial statements of the Group for the year ended 31 December 2021. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets (including goodwill) and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interest and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained and (iii) any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

Investments in associates and joint ventures

An associate is an entity in which the Group has a long term interest of generally not less than 20% of the equity voting rights and over which it is in a position to exercise significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee, but is not control or joint control over those policies.

A joint venture is a type of joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint venture. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control.

Investments in associates and joint ventures (Continued)

The Group's investments in associates and joint ventures are stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting, less any impairment losses.

The Group's share of the post-acquisition results and other comprehensive income of associates and joint ventures is included in the consolidated statement of profit or loss and the consolidated statement of comprehensive income, respectively. In addition, when there has been a change recognised directly in the equity of the associate or joint venture, the Group recognises its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealised gains and losses resulting from transactions between the Group and its associates or joint ventures are eliminated to the extent of the Group's investments in the associates or joint ventures, except where unrealised losses provide evidence of an impairment of the assets transferred. Goodwill arising from the acquisition of associates or joint ventures is included as part of the Group's investments in associates or joint ventures.

If an investment in an associate becomes an investment in a joint venture or vice versa, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method. In all other cases, upon loss of significant influence over the associate or joint control over the joint venture, the Group measures and recognises any retained investment at its fair value. Any difference between the carrying amount of the associate or joint venture upon loss of significant influence or joint control and the fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

Business combinations and goodwill

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree that are present ownership interests and entitle their holders to a proportionate share of net assets in the event of liquidation at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

The Group determines that it has acquired a business when the acquired set of activities and assets includes an input and a substantive process that together significantly contribute to the ability to create outputs.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in profit or loss as a gain on bargain purchase.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31 December. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

Impairment is determined by assessing the recoverable amount of the cash-generating unit (group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cash-generating unit (group of cash-generating units) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation disposed of and the portion of the cash-generating unit retained.

Fair value measurement

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

- Level 2 based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly
- Level 3 based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

For assets and liabilities that are recognised in the financial statements on a recurring basis, the Group determines whether transfers have occurred between levels in the hierarchy by reassessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, contract assets, deferred tax assets and financial assets), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs. In testing a cash-generating unit for impairment, a portion of the carrying amount of a corporate asset (e.g., a headquarters building) is allocated to an individual cash-generating unit if it can be allocated on a reasonable and consistent basis or, otherwise, to the smallest group of cash-generating units.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to the statement of profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to the statement of profit or loss in the period in which it arises.

Property, plant and equipment and depreciation

Property, plant and equipment, other than construction in progress, are stated at cost less accumulated depreciation and any impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to the statement of profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Depreciation is calculated to write off the cost of items of property, plant and equipment, less their estimated residual value, if any, using the straight-line method over their estimated useful lives as follows:

- Buildings situated on leasehold land are depreciated over the shorter of the unexpired term of lease and their estimated useful lives, from 20 to 50 years after the date of completion.

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property, plant and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in the statement of profit or loss in the year the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

Construction in progress is stated at cost less any impairment losses, and is not depreciated. Cost comprises the direct costs of construction and capitalised borrowing costs on related borrowed funds during the period of construction. Construction in progress is reclassified to the appropriate category of property, plant and equipment when completed and ready for use.

Intangible assets (other than goodwill)

Intangible assets acquired separately are measured on initial recognition at cost. The cost of intangible assets acquired in a business combination is the fair value at the date of acquisition. The useful lives of intangible assets are assessed to be either finite or indefinite. Intangible assets with finite lives are subsequently amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at least at each financial year end.

At inception or on reassessment of a contract that contains a lease component and non-lease component(s), the Group adopts the practical expedient not to separate non-lease component(s) and to account for the lease component and the associated non-lease component(s) (e.g., property management services for leases of properties) as a single lease component.

(a) Right-of-use assets

Right-of-use assets are recognised at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Where applicable, the cost of a right-of-use asset also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease terms and the estimated useful lives of the assets as follows:

Leasehold land 10 to 50 years Buildings 20 to 30 years

If ownership of the leased asset transfers to the Group by the end of the lease term or the cost reflects the exercise of a purchase option, depreciation is calculated using the estimated useful life of the asset.

(b) Lease liabilities

Lease liabilities are recognised at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate the lease. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset.

It also applies the recognition exemption for leases of low-value assets to leases of office equipment and laptop computers that are considered to be of low value.

Lease payments on short-term leases and leases of low-value assets are recognised as an expense on a straight-line basis over the lease term.

Investments and other financial assets

Initial recognition and measurement

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost and fair value through other comprehensive income.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of debtors that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Debtors that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under HKFRS 15 in accordance with the policies set out for "Revenue recognition" below.

In order for a financial asset to be classified and measured at amortised cost or fair value through other comprehensive income, it needs to give rise to cash flows that are solely payments of principal and interest ("SPPI") on the principal amount outstanding. Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

The Group's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortised cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows, while financial assets classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace.

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in the statement of profit or loss when the asset is derecognised, modified or impaired.

Financial assets at fair value through other comprehensive income (debt instruments)

For debt investments at fair value through other comprehensive income, interest income, foreign exchange revaluation and impairment losses or reversals are recognised in the statement of profit or loss and computed in the same manner as for financial assets measured at amortised cost. The remaining fair value changes are recognised in other comprehensive income. Upon derecognition, the cumulative fair value change recognised in other comprehensive income is recycled to the statement of profit or loss.

Derecognition of financial assets

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e., removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

Impairment of financial assets

The Group recognises an allowance for expected credit losses ("ECLs") for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

In certain cases, the Group may consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

The Group considers a financial asset in default when contractual payments are 90 days past due from the end of the credit term. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Contract assets that contain a significant financing component and financial assets other than debtors are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for contract assets that do not contain a significant financing component and debtors which apply the simplified approach as detailed below.

- Stage 1 - Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs
- Financial instruments for which credit risk has Stage 2 increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime **ECLs**
- Stage 3 - Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime ECLs

Simplified approach

For debtors and contract assets that do not contain a significant financing component when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings, payables, or as derivatives designated as hedging instruments in an effective hedge, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

The Group's financial liabilities include creditors, other payables and accrued expenses, lease liabilities, amounts due to fellow subsidiaries and a non-controlling interest, and interest-bearing bank and other borrowings.

Subsequent measurement

The subsequent measurement of financial liabilities depends on their classification as follows:

Financial liabilities at amortised cost (loans and borrowings)

After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in the statement of profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in the statement of profit or loss.

Derecognition of financial liabilities

A financial liability is derecognised when the obligation under the liability is discharged or cancelled or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in the statement of profit or loss.

Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

Inventories

Inventories, mainly comprise biomass fuel, spare parts and consumables used in the repairs and maintenance and are stated at cost less provision for obsolete. Cost is determined on the weighted average basis. When inventories are consumed, the carrying amount of these inventories is recognised as an expense in the statement of profit or loss.

Cash and cash equivalents

Cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

現金及現金等價物

Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in the statement of profit or loss.

Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax assets and deferred tax liabilities are offset if and only if the Group has a legally enforceable right to set off current tax assets and current tax liabilities and the deferred tax assets and deferred tax liabilities relate to income taxes levied by the same taxation authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

Government grants

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, for which it is intended to compensate, are expensed.

Where the grant relates to an asset, the fair value is credited to deferred income account and is released to the statement of profit or loss over the expected useful life of the relevant asset by equal annual instalments or deducted from the carrying amount of the asset and released to the statement of profit or loss by way of a reduced depreciation charge.

Revenue recognition

Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group with a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15.

The Group satisfied a performance obligation and recognises revenue over time, if one of the following criteria is met:

- the customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs.
- the Group's performance creates or enhances an asset that the customer controls as the asset is created or enhanced.
- the Group's performance does not create an asset with an alternate use to the Group and the Group has an enforceable right to payment for performance completed to date.

If none of the above conditions are met, the Group recognises revenue at the point in time when the performance obligation is satisfied.

If control of the asset transfers over time, revenue is recognised over the period of the contract by reference to the progress towards complete satisfaction of that performance obligation. Otherwise, revenue is recognised at the point in time when the customer obtains control of the asset.

The progress towards complete satisfaction of the performance obligation is measured based on the Group's efforts or inputs to the satisfaction of the performance obligation, by reference to the surveyors' assessment of work performed and the costs incurred up to the end of the reporting period as a percentage of total estimated costs for each contract.

Revenue from contracts with customers (Continued)

When the Group provides more than one service in a service concession arrangement, the transaction price will be allocated to each performance obligation by reference to their relative stand-alone selling prices. If the stand-alone selling prices are not directly observable, they are estimated based on expected cost plus a margin or adjusted market assessment approach, depending on the availability of observable information.

In determining the transaction price, the Group adjusts the promised amount of consideration for the effect of a financing component if it is significant.

(a) Construction service revenue

The Group's performance in respect of construction services creates or enhances an asset or work in progress that the customer controls as the asset is created or enhanced, thus the Group satisfies a performance obligation and recognises revenue over time, by reference to completion of the specific transaction assessed on the basis of the surveyors' assessment of work performed and the costs incurred up to the end of the reporting period as a percentage of total estimated costs for each contract.

Revenue from construction services under a service concession agreement is estimated on a cost-plus basis with reference to a prevailing market rate of gross margin at the date of the agreement applicable to similar construction services rendered.

(b) Operation revenue

The Group recognised revenue from integrated biomass utilisation project operation services, hazardous and solid waste treatment operation services, environmental remediation project operation services and solar energy and wind power project operation services when the related services are rendered.

Revenue from other sources and other income

Finance and interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset

Contract assets

A contract asset is the right to consideration in exchange for goods or services transferred to the customer. If the Group performs by transferring goods or services to a customer before the customer pays consideration or before payment is due, a contract asset is recognised for the earned consideration that is conditional. Contract assets are subject to impairment assessment, details of which are included in the accounting policies for "impairment of financial assets".

Contract liabilities

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

Employee benefits

Retirement schemes

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance for all of its employees. Contributions are made based on a percentage of the employees' basic salaries and are charged to the statement of profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme, except for the Group's employer voluntary contributions, which are refunded to the Group when the employee leaves employment prior to the contributions vesting fully, in accordance with the rules of the MPF Scheme.

The employees of the Group's subsidiaries which operate in Mainland China are required to participate in a central pension scheme operated by the local municipal government. These subsidiaries are required to contribute a certain percentage of their payroll costs to the central pension scheme. The contributions are charged to the statement of profit or loss as they become payable in accordance with the rules of the central pension scheme.

Termination benefits

Termination benefits are recognised at the earlier of when the Group can no longer withdraw the offer of those benefits and when the Group recognises restructuring costs involving the payment of termination benefits.

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs capitalised. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

Dividends

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting. Proposed final dividends are disclosed in the notes to the financial statements.

Interim dividends are simultaneously proposed and declared, because the Company's memorandum and articles of association grant the directors the authority to declare interim dividends. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared.

Foreign currencies

These financial statements are presented in Hong Kong dollars, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss.

Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss with the exception of monetary items that are designated as part of the hedge of the Group's net investment of a foreign operation. These are recognised in other comprehensive income until the net investment is disposed of, at which time the cumulative amount is reclassified to the statement of profit or loss. Tax charges and credits attributable to exchange differences on those monetary items are also recorded in other comprehensive income.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

The functional currencies of certain overseas subsidiaries, joint ventures and associates are currencies other than the Hong Kong dollar. As at the end of the reporting period, the assets and liabilities of these entities are translated into Hong Kong dollars at the exchange rates prevailing at the end of the reporting period and their statements of profit or loss are translated into Hong Kong dollars at the exchange rates that approximate to those prevailing at the dates of the transactions.

The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve. On disposal of a foreign operation, the component of other comprehensive income relating to that particular foreign operation is recognised in the statement of profit or loss.

Any goodwill arising on the acquisition of a foreign operation and any fair value adjustments to the carrying amounts of assets and liabilities arising on acquisition are treated as assets and liabilities of the foreign operation and translated at the closing rate.

For the purpose of the consolidated statement of cash flows, the cash flows of overseas subsidiaries are translated into Hong Kong dollars at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of overseas subsidiaries which arise throughout the year are translated into Hong Kong dollars at the weighted average exchange rates for the year.

若干海外附屬公司、合營企業及聯營公司 之功能貨幣為港幣以外之貨幣。於報告期 末,該等實體之資產及負債按報告期末之 適用匯率換算為港幣,而其損益表則按相 若於交易日的該等現行匯率換算為港幣。

就此產生之匯兑差額於其他全面收入確認, 並於匯兑波動儲備累計。在出售海外業務 時,與該特定海外業務有關之其他全面收 入部分於損益表確認。

因收購海外業務而產生之任何商譽及收購 所得資產與負債之賬面值之公允值調整會 被當作海外業務的資產及負債處理,並根 據期末匯率換算。

就綜合現金流量表而言,海外附屬公司之 現金流量按現金流量日期適用之匯率換算 為港幣。海外附屬公司於整個年度內不斷 出現之現金流量按年內加權平均匯率換算 為港幣。

3. SIGNIFICANT ACCOUNTING JUDGEMENTS AND ESTIMATES

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

Judgements

In the process of applying the Group's accounting policies, management has made the following judgements, apart from those involving estimations, which have the most significant effect on the amounts recognised in the financial statements:

Service concession arrangements

The Group entered into BOT and BOO arrangements in respect of its projects.

The Group concluded that all the BOT arrangements and certain BOO arrangements are service concession arrangements under HK(IFRIC) Interpretation 12, because the local government controls and regulates the services that the Group must provide with the infrastructure at a pre-determined service charge. In respect of BOT arrangements, upon expiry of concession right agreements, the infrastructure has to be transferred to the local government at nil consideration. Infrastructure for BOO arrangements is used in the service concession arrangements for its entire or substantial useful life.

Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

判斷

管理層在應用本集團會計政策時,除了作 出涉及估計之判斷外,亦曾作出下列對財 務報表已確認金額構成最重大影響之判斷:

服務特許經營權安排

本集團就其項目訂立BOT及BOO安排。

本集團確定所有BOT安排及若干BOO安排均屬《香港(國際財務報告詮釋委員會)詮釋》第12號項下之服務特許經營權安排,因為當地政府控制並監管本集團利用基礎設施按預定服務費所須提供之服務。就BOT安排而言,在特許經營權協議到期後,有關基礎設施須無償轉歸當地政府所有。就BOO安排而言,有關服務特許經營權安排所涉及之基礎設施於其整個或大致可使用年期使用。

估計之不確定性

下文闡述有關未來之主要假設,以及於報告期末導致估計出現不確定性之其他主要緣由,其具有可能導致須對下一個財政年度之資產及負債賬面值作出重大調整之重大風險。

Estimation uncertainty (Continued)

Construction contracts

As explained in the accounting policies set out in note 2.4 to the financial statements for "Revenue recognition" and "Contract assets", revenue and profit recognition on an incomplete project is dependent on estimating the final outcome of the construction contract, as well as the work done to date. Based on the Group's recent experience and the nature of the construction activity undertaken by the Group, the Group makes estimates of the point at which it considers the work is sufficiently advanced such that the costs to complete and revenue can be reliably estimated. As a result, until this point is reached, the "Service concession assets" as disclosed in note 21 will not include profit which the Group may eventually realise from the work done to date. In addition, actual outcomes in terms of revenue or costs may be higher or lower than estimated at the end of the reporting period, which would affect the revenue and profit recognised in future years as an adjustment to the amounts recorded to date.

Construction revenue arising from construction services is recognised based on the estimation of the fair value of construction services and the proportion of construction work completed to date for each project. The fair value of construction services is determined on a cost plus mark up basis with reference to a prevailing market rate of gross margin applicable to similar construction services rendered.

Provision for ECLs for debtors and contract assets

The Group uses a provision matrix to calculate ECLs for debtors and contract assets. The provision matrix is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical settlement pattern, ageing profiles, credit loss experience, published credit ratings with forward-looking information. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

建造合約

建造服務產生之建造收入乃根據建造服務 之公允值及各項目迄今完成之建造工程比 例估計確認。建造服務之公允值根據成本 加成基準,參考適用所提供類似建造服務 的現行市場毛利率釐定。

應收賬款及合約資產的預期信貸虧損撥備

本集團使用撥備矩陣計算應收賬款及合約 資產的預期信貸虧損。撥備矩陣最初基於 本集團的歷史觀察違約率。本集團將通過 調整矩陣以調整歷史結算模式、賬齡概況、 信貸損失經驗、已發佈信貸評級與前瞻性 資料。於各報告日,歷史觀察到的違約率都 會被更新,並分析未來其可能發生的變化。

Provision for ECLs for debtors and contract assets (Continued)

The assessment of the correlation among historical observed default rates, forecast economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forecast economic conditions. The Group's historical credit loss experience, published credit ratings and forecast of economic conditions may also not be representative of a customer's actual default in the future.

The carrying amounts of debtors and contract assets at 31 December 2021 were HK\$5,524,382,000 (2020: HK\$2,290,652,000) and HK\$9,510,877,000 (2020: HK\$10,255,776,000), respectively. The information about the ECLs on the Group's debtors and contract assets is disclosed in notes 21, 22 and 38 to the financial statements.

Impairment losses of goodwill

As explained in the accounting policy set out in note 2.4 to the financial statements for "Business combinations and goodwill", goodwill is allocated to a cash-generating unit or to a group of cash-generating units that are expected to benefit from the synergies of the combination for the purpose of impairment assessment, which requires significant judgement. The Group determined that the group of cash-generating units to which goodwill was allocated reflected the lowest level at which goodwill was monitored for internal reporting and was not larger than an operating segment in accordance with HKAS 36 *Impairment of Assets*.

應收賬款及合約資產的預期信貸虧損撥備(續)

對歷史觀察到的違約率、預測經濟狀況及 預期信貸虧損之間的相關性的評估乃重大 估計。預期信貸虧損風險的金額對環境變 化及預測的經濟狀況較敏感。本集團的歷 史信貸損失經驗、已發佈信貸評級及對經 濟狀況的預測也可能無法代表未來客戶的 實際違約。

應收賬款及合約資產於二零二一年十二月 三十一日的賬面值分別為港幣 5,524,382,000元(二零二零年:港幣 2,290,652,000元)及港幣9,510,877,000元 (二零二零年:港幣10,255,776,000元)。有 關本集團應收賬款及合約資產的預期信貸 虧損資料披露於財務報表附註21、22及38。

商譽之耗損虧損

誠如財務報表附註2.4下有關「業務合併及商譽」之會計政策所闡釋,商譽會被分配至預期可受惠於合併協同效益之一個現金產生單位或一個現金產生單位組別,以便進行耗損評估,而此需要作出重大判斷。根據香港會計準則第36號「資產耗損」,本集團確定獲分配商譽之現金產生單位組別為本集團就內部申報目的而監察商譽之最低層次,且監察層面不會大於一個經營分部。

Impairment losses of goodwill (Continued)

The Group determines whether goodwill is impaired at least on an annual basis. This involves an estimation of the value in use of the cash-generating units to which the goodwill is allocated. Estimating the value in use requires the Group to make an estimate of the expected future cash flows from the cash-generating units and also to choose a suitable discount rate in order to calculate the present value of those cash flows. The carrying amount of goodwill at 31 December 2021 was HK\$162,638,000 (2020: HK\$157,609,000). Further details are given in note 16 to the financial statements.

Impairment of non-financial assets (other than goodwill)

The Group assesses whether there are any indicators of impairment for all non-financial assets (including the right-of-use assets) at the end of each reporting period. Indefinite life intangible assets and intangible assets have not yet available for use are tested for impairment annually and at other times when such an indicator exists. Other non-financial assets are tested for impairment whenever events or changes in circumstances indicate that their recorded carrying amounts may not be recoverable. Determining whether such assets are impaired requires an estimation of the recoverable amount of each CGU to which the assets have been allocated, which is the higher of its fair value less costs of disposal and its value in use.

The calculations of the fair value less costs of disposal or value in use involves significant estimations about future business performance with key assumptions including forecasted revenue growth rate and discount rates used. The Group uses all readily available information in determining an amount that is a reasonable approximation of the recoverable amount, including estimates based on reasonable and supportable assumptions and projections of revenue growth rates, operating costs and discount rates. Further details are set out in note 17 to the financial statements.

商譽之耗損虧損(續)

本集團最少每年一次釐定商譽有否出現耗損,而此涉及估計獲分配商譽之現金產生單位之使用價值。在估計使用價值時,本集團須估計來自現金產生單位之預期未來現金流量,並須選擇合適的貼現率,以便計算有關現金流量之現值。於二零二一年十二月三十一日,商譽之賬面值為港幣162,638,000元(二零二零年:港幣157,609,000元)。進一步詳情載於財務報表附註16。

非金融資產耗損(除商譽外)

公允值減出售成本或使用價值的計算乃涉及有關未來業務表現,包括所用預測收益增長率及貼現率等主要假設在內的重大估計。本集團以所有現有資料釐定可收回金額之合理概約金額,包括根據收益增長率、營運成本及貼現率金額之合理及支持性假設及預測作出的估計。進一步詳情載於財務報表附註17。

Income taxes

Determining income tax provisions involves judgement on the future tax treatment of certain transactions. The Group carefully evaluates the tax implications of transactions and tax provisions are set up accordingly. The tax treatment of such transactions is reconsidered periodically to take into account all changes in tax laws, regulations, relevant interpretation and practices, and other related policies. Deferred tax assets are recognised for temporary deductible differences. As those deferred tax assets can only be recognised to the extent that it is probable that future taxable profits will be available against which the unused tax credits can be utilised, management's judgement is required to assess the probability of future taxable profits. Management reassesses these estimates at the end of each reporting period. Additional deferred tax assets are recognised if it becomes probable that future taxable profits will allow the deferred tax assets to be recovered. The carrying value of deferred tax assets at 31 December 2021 was HK\$82,450,000 (2020: HK\$64,467,000). Further details are included in note 27 to the financial statements.

4. OPERATING SEGMENT INFORMATION

The Group manages its business by segments, which are organised by business lines. In a manner consistent with the way in which information is reported internally to the Group's most senior executive management for the purposes of resource allocation and performance assessment, the Group has presented the following four reportable segments.

(i) Integrated biomass utilisation project construction and operation: this segment engages in the construction and operation of biomass direct combustion power generation projects, biomass heat supply project, biomass electricity and heat cogeneration projects, waste-to-energy projects and integrated biomass and waste-to-energy projects to generate revenue from construction services, revenue from operation services as well as finance income.

所得税

釐定所得税撥備涉及對若干交易之日後税 項處理方法作出判斷。本集團會審慎評估 交易之相關稅務規定,從而計提稅項撥備。 本集團會定期重新考慮有關交易之稅項處 理方法,並會將稅務法律、規例、相關詮釋 及慣例,以及其他相關政策之所有變動列 為考慮因素。遞延税項資產乃就暫時可扣 減差額予以確認。由於可予確認之遞延税 項資產僅限於將來很可能取得應課稅盈利 而令未使用税項抵免得以運用之部分,故 管理層須作出判斷,以評估產生未來應課 税盈利之可能性。管理層會於各報告期末 重新評估上述估計,而倘未來應課税盈利 將有可能讓遞延税項資產得以收回,則會 確認額外的遞延税項資產。於二零二一年 十二月三十一日遞延税項資產的賬面值為 港幣82,450,000元(二零二零年:港幣 64,467,000元)。更多詳情載於財務報表附 **註27。**

本集團按分部(按業務範圍劃分)管理業務。按照內部就資源分配及表現評估向本集團最高管理層呈報資料之一貫方式,本集團呈報了下列四個須予報告之分部。

(i) 生物質綜合利用項目建造及運營:該 分部從事建造及運營生物質直燃發電 項目、生物質供熱項目、生物質熱電 聯供項目、垃圾發電項目及生物質及 垃圾發電一體化項目,以產生建造服 務收益、運營服務收益及財務收入。

- (ii) Hazardous and solid waste treatment project construction and operation: this segment engages in the construction and operation of hazardous waste landfill projects, hazardous waste incineration projects, general industrial solid waste electricity and heat cogeneration projects and physicochemical and resources recycling projects to generate revenue from construction services, revenue from operation services as well as finance income.
- (iii) Environmental remediation project operation: this segment engages in the operation of environmental remediation projects covering restoration of industrial contaminated sites, contaminated farmland, mines and landfills, treatment of industrial gas emission, integrated treatment of oil sludge, treatment of river/ lake sediments and industrial sludge, construction and operation of wetland parks, environmental stewardship services and anti-seepage at landfill sites to generate revenue from operation services.
- (iv) Solar energy and wind power project operation: this segment engages in the operation of solar energy projects and wind power projects to generate revenue from operation services.

For the purposes of assessing segment performance and allocating resources between segments, the Group's most senior executive management monitors the results, assets and liabilities attributable to each reportable segment on the following bases:

Segment assets include all tangible assets, intangible assets, goodwill, interests in associates and joint ventures, deferred tax assets and current assets with the exception of intercompany receivables and other corporate assets which are managed on a group basis. Segment liabilities include tax payables, deferred tax liabilities, creditors, other payables and accrued expenses attributable to the activities of the individual segments and interest-bearing bank and other borrowings managed directly by the segments, with the exception of intercompany payables and other corporate liabilities which are managed on a group basis.

就分部表現評估及分部間之資源分配而言, 本集團之最高級管理層按下列基準監察各個須予報告分部應佔之業績、資產及負債:

分部資產包括所有按組別基準管理的有形 資產、無形資產、商譽、聯營公司及合營企 業權益、遞延税項資產及流動資產,惟不包 括公司間應收款項及其他企業資產。分部 負債包括各個個別分部之業務應佔之應付 税項、遞延税項負債、應付賬款、其他應付 款項及應計費用及由各個分部直接管理之 計息銀行及其他借貸,惟不包括按組別基 準管理的公司間應付款項及其他企業負債。

Revenue and expenses are allocated to the reportable segments with reference to revenue generated by those segments and the expenses incurred by those segments or which otherwise arise from the depreciation or amortisation of assets attributable to those segments.

The measure used for reporting segment profit is "adjusted earnings before interest, taxes, depreciation and amortisation" ("adjusted EBITDA"). To arrive at adjusted EBITDA, the Group's earnings are further excluded for items not specifically attributed to individual segments, such as directors' and auditor's remuneration and other head office or corporate administration costs.

In addition to segment information concerning adjusted EBITDA, management is provided with segment information concerning revenue, interest expense from borrowings managed directly by the segments, depreciation and amortisation and additions to non-current segment assets used by the segments in their operations.

A market-derived discount rate is applied to the projected cash flows in order to establish the present value of the cash flows.

Key assumptions used in FVLCD calculations of the relevant CGUs include revenue annual growth rate, operating costs and discount rates. Revenue is projected with a constant unit price and processing volume at growth rates of 5% to 8% (2020: 5% to 8%) per annum (till reaching optimal production capacity) over the projection periods. Operating expenses are expected to increase at the long term inflation rate. The pretax discount rates applied to the cash flow projections range from 13.3% to 17.9% (2020: 13.5% to 17.5%). Assumptions used are made with reference to historical data of existing projects, observable market data of comparable companies and industry reports, management's expectation for the market development and their business plans. The discount rates used are the pre-tax rates that reflect the current market assessments of the time value of money and the specific risks relating to the relevant CGUs.

During the year ended 31 December 2021, the Group entered into agreements with certain financial institutions whereby the Group sells certain trade receivable of renewable energy tariff subsidies to a trust company, which in turn issues asset-backed notes in the National Association of Financial Market Institutional Investors. The asset-backed notes are backed by the receivables of renewable energy tariff subsidy.

During the year ended 31 December 2021, the Group transferred an aggregate carrying amount of HK\$938,449,800 (equivalent to RMB782,041,500) of trade receivables of renewable energy tariff subsidies to the trust company and received proceeds of HK\$843,719,800, net of the arrangement fee of HK\$94,730,000. In the opinion of the directors, the Group has transferred substantially all the risks and rewards relating to the transferred receivables, and the Group's exposure to the variability in the amounts of the transferred assets was not significant after the transaction. Accordingly, the full carrying amount of the transferred receivables has been derecognised. The Group has provided liquidity support to the asset-backed notes. The maximum exposure to loss from the Group's continuing involvement in the derecognised receivables is equal to their carrying amounts. In the opinion of the directors, the Group's continuing involvement in the derecognised receivables is not significant.

During the year ended 31 December 2021, the Group has not recognised any gain or loss on the transfer of the derecognised receivables.

The Group's principal financial instruments comprise interest-bearing borrowings, cash and short-term deposits. The main purpose of these financial instruments is to finance the Group's operations. The Group has various other financial assets and liabilities such as debtors, other receivables, deposits, and creditors, other payables and accrued expenses, which arise directly from its operations.

The main risks arising from the Group's financial instruments are interest rate risk, foreign currency risk, credit risk and liquidity risk. The board of directors reviews and agrees policies for managing each of these risks and they are summarised below.

Interest rate risk

The Group's interest rate risk arises primarily from the Group's cash and cash equivalents, deposits with banks, bank and other borrowings and medium-term notes. Borrowings issued at variable rates and at fixed rates expose the Group to cash flow interest rate risk and fair value interest rate risk respectively. The Group does not use financial derivatives to hedge against the interest rate risk. The Group's interest rate profile as monitored by management is set out in (i) below.

At 31 December 2021, it is estimated that a general increase/decrease of one percent in interest rates, with all other variables held constant, would decrease/increase the Group's profit before taxation by approximately HK\$156,164,000 (2020 HK\$132,986,000).

Exposure to foreign currency risk

The Group is exposed to foreign currency risk primarily from bank loans, cash and cash equivalents, receivables and payables that are denominated in a foreign currency, i.e., a currency other than the functional currency of the operations to which they relate. The currencies giving rise to this risk are primarily Hong Kong dollars, Renminbi, United States dollars and Euros. The Group ensures that the net exposure is kept to an acceptable level, by buying or selling foreign currencies at spot rates where necessary to address short-term imbalances.

The following table details the Group's exposure at the end of the reporting period to foreign currency risk arising from recognised assets or liabilities denominated in a currency other than the functional currency of the entity to which they relate. For presentation purposes, the amounts of the exposure are shown in Hong Kong dollars, translated using the spot rate at the reporting date. Credit risk

The Group assesses the credit quality of the customers and other counterparties, taking into account their background, financial position, past experience and other factors. The Group has a credit policy in place and the exposures to credit risks are monitored on an ongoing basis. Debtors are usually due immediately within 90 days from the date of billing.

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in a financial loss to the Group. The Group's credit risk is primarily attributable to cash and cash equivalents, debtors, other receivables and contract assets.

Since the Group trades only with recognised and creditworthy third parties, there is no requirement for collateral. Concentrations of credit risk are managed by counterparty and by geographical region. At 31 December 2021, "Debtors, other receivables, deposits and prepayments" and "Contract assets" of the Group amounted to HK\$16,603,083,000 (2020: HK\$14,074,120,000), of which HK\$3,348,437,000 (2020: HK\$2,974,904,000) was due from the largest customer and HK\$5,689,040,000 (2020: HK\$3,983,158,000) was due from the five largest customers in aggregate of the Group, respectively. The maximum exposure to credit risk is represented by the carrying amount of each financial asset and contract asset in the consolidated statement of financial position.

Liquidity risk

Individual operating entities within the Group are responsible for their own cash management, including the short-term investment of cash surpluses and the raising of loans to cover expected cash demands. The Group's policy is to regularly monitor its liquidity requirements and its compliance with lending covenants to ensure that it maintains sufficient reserves of cash and adequate committed lines of funding from major financial institutions to meet its liquidity requirements in the short and longer term.

Capital management

The Group's primary objectives for managing capital are to maintain a strong credit rating and healthy capital ratios in order to support its business and maximise shareholders' value. The Group manages its capital structure and makes adjustments to it in light of changes in economic conditions. The Group reviews the capital structure on a regular basis and considers the cost of capital and the associated risks. Based on recommendations of the board of directors, the Group will balance its overall capital structure through adjusting the amount of dividends paid to shareholders, new share issues or new debt financing.

The Group monitors capital with reference to its debt position. The Group's strategy was to maintain the equity and debt in a balanced position and ensure there was adequate working capital to service its debt obligation. The Group's gearing ratio, being the Group's total liabilities over its total assets, as at 31 December 2021 was 65.1% (2020: 63.5%).
