

Lee's Pharmaceutical Holdings Limited (the "Company", together with its subsidiaries, the "Group", Hong Kong stock code: 950) is a research-driven and market-oriented biopharmaceutical company with more than 25 years of operation in the pharmaceutical industry in the People's Republic of China (the "PRC" or "China").

李氏大藥廠控股有限公司(「本公司」,連同其附屬公司統稱「本集團」,香港股份代號:950)是一間結合研究主導及市場導向的生物醫藥公司,已於中華人民共和國(「中國」)醫藥行業進行逾二十五年的經營活動。

The Group is fully integrated with solid infrastructures in drug development, clinical development, regulatory, manufacturing, sales and marketing based in Mainland China with global perspectives. The Group has established extensive partnerships with over 20 international companies and currently markets over 25 proprietary, generic and licensed-in pharmaceutical products in Mainland China, Hong Kong, Macau and Taiwan.

本集團放眼國際並與在中國內地建立的藥品發展、臨床發展、規管、製造、銷售及市場推廣的穩固基礎建設緊密結合。本集團已與逾二十家國際公司建立廣泛合作關係,且目前於中國內地、香港、澳門及台灣推廣超過二十五種專利、仿製及引進醫藥產品。

The Group focuses on several key disease areas such as cardiovascular, woman health, paediatrics, rare diseases, oncology, dermatology and obstetrics. It has more than 40 products under different development stages stemming from both internal research and development as well as from the licensing of development, commercialisation, and manufacturing rights from various United States, European and Japanese companies.

本集團致力於心血管、女性健康、兒科、罕見病、腫瘤 科、皮膚科及產科等多個重要疾病領域,處於不同開發 階段的產品有超過四十種,來自內部研究及開發以及自 美國、歐洲及日本公司引進的開發、商品化及生產權。

The Group carries out its sales and distribution activities in Hong Kong, Macau, Taiwan and Mainland China through Hong Kong and Taiwan offices and branch offices in Guangzhou, Shanghai and Beijing with direct and channel sales network covering most of the provinces and cities in Mainland China, marketing both domestic self-developed and generic products and overseas licensed-in products. Zhaoke Pharmaceutical (Hefei) Co. Limited, a subsidiary of the Group, is currently operating the manufacturing plant of the Group located in Hefei, Anhui Province of the PRC, comprising four GMP-compliant workshops for the production of topical gel, lyophilised powder for injection, small volume parenteral solutions and eye gel. Zhaoke Pharmaceutical (Guangzhou) Limited, a subsidiary of the Group, is currently operating the new manufacturing site in Nansha District, Guangzhou of the PRC which include a complete range of solid dosage production lines for the development and manufacturing of tablets and capsules.

本集團於香港、澳門、台灣及中國內地透過香港及台灣辦事處以及廣州市、上海市及北京市分公司,覆蓋中國內地大部分省市的直銷及管道銷售網絡進行銷售及分銷活動,推廣國內自行研發和仿製的產品及海外引進的產品。本集團附屬公司兆科藥業(合肥)有限公司現時營運本集團位於中國安徽省合肥市的生產廠房,該廠房設有四間符合GMP的工場,負責生產凝膠劑、注射用凍乾粉針劑、小容量注射劑及眼凝膠。本集團附屬公司兆科藥業(廣州)有限公司現正在中國廣州市南沙區營運新藥廠(包括開發及生產藥片及膠囊的全套固體製劑生產線)。

The mission of the Group is to become a successful biopharmaceutical group in Asia providing innovative products to fight diseases and improve health and quality of life.




REVENUE (HK\$'000)

收益(千港元)




EQUITY ATTRIBUTABLE TO THE OWNERS OF THE COMPANY (HK\$'000)

本公司擁有人應佔權益(千港元)




PROFIT ATTRIBUTABLE TO THE OWNERS OF THE COMPANY (HK\$'000)

Chairman's Statement

主席報告

Dear shareholders,

On behalf of Lee's Pharmaceutical Holdings Limited (the "Company" or "Lee's Pharm", together with its subsidiaries, the "Group") and its board ("Board") of directors ("Directors"), I am pleased to present the annual report of the Company for the year ended 31 December 2021 (the "Reporting Year").

The Group's profit attributable to the Company's shareholders for the year ended 31 December 2021 amounted to HK\$1,987,176,000, compared to HK\$129,316,000 for the last year. Basic earnings per share were HK337.58 cents, compared to HK21.99 cents for the last year. The Board recommended the payment of a final dividend of HK3.1 cents per share for the Reporting Year. Together with the interim dividend of HK3.0 cents per share, the dividend for the full year will be HK6.1 cents per share, compared to HK5.8 cents for the last year. Subject to the approval by the Company's shareholders at the forthcoming annual general meeting, the final dividend will be paid on 15 June 2022.

We have experienced ups and downs during the Reporting Year, from the prolonged impact from the COVID-19 pandemic, the regulatory changes and tougher business environment, and the deteriorated capital market sentiment. At Lee's Pharm, we continue to work together as one team to sail through the storm.

Despite these challenges, we successfully spun off and completed a separate listing of Zhaoke Ophthalmology Limited ("**ZKO**") on the Main Board of The Stock Exchange of Hong Kong Limited (the "**Stock Exchange**") in April 2021 and approximately HK\$1.9 billion was raised in the initial public offering. This was an important step for ZKO to further its business development in the fast-growing ophthalmic drug market in the mainland China by its own resources. Following the ZKO spun off, we can stay focused to develop the businesses in other major therapeutic areas. A one-time gain of approximately HK\$2.3 billion attributable to the derecognition of investment in ZKO as an associate of the Company immediately after the separate listing was recognised during the Reporting Year.

The Volume-Based Procurement ("VBP") program has continued to rollout across the country and cover more products which brought down prices to public hospitals with volume commitments. During the Reporting Year, we acted decisively to optimise our research and development ("R&D") portfolio which enable us to limit our losses on unfavorable projects and to enhance our resources allocation on our priortised projects.

各位尊敬的股東:

本人謹代表李氏大藥廠控股有限公司(「本公司」或「李氏 大藥廠」,連同其附屬公司,「本集團」)及其董事(「董 事」)會(「董事會」),欣然呈列本公司截至二零二一年 十二月三十一日止年度(「報告年度」)的年度報告。

截至二零二一年十二月三十一日止年度,本集團的本公司股東應佔溢利為1,987,176,000港元,而去年為129,316,000港元。每股基本盈利為337.58港仙,而去年為21.99港仙。董事會建議派發報告年度末期股息每股3.1港仙。連同中期股息每股3.0港仙,全年股息為每股6.1港仙,去年則為5.8港仙。待本公司股東在即將舉行的股東週年大會上批准後,末期股息將於二零二二年六月十五日派付。

報告年度內,COVID-19大流行影響不褪,監管方面出現轉變,營商環境更見艱難,資本市場氣氛惡化,我們經歷各種高低起伏。李氏大藥廠團隊一如既往,齊心協力共渡難關。

儘管面對重重挑戰,我們於二零二一年四月成功分拆兆科眼科有限公司(「**兆科眼科**」),並完成其於香港聯合交易所有限公司(「**聯交所**」)主板獨立上市,從首次公開發售中集資約19億港元。此舉對兆科眼科而言極其重要,兆科眼科可因而以自身資源在中國大陸眼科藥物市場快速增長中發展業務。分拆兆科眼科後,我們可集中發展其他主要治療領域的業務。緊隨獨立上市後終止將本公司於兆科眼科的投資確認為聯營公司,因而於報告年度確認一次性收益約23億港元。

藥品集中帶量採購(「藥品集採」)計劃繼續在全國推行, 且擴大藥品覆蓋,藉帶量採購降低公立醫院的採購價。 於報告年度,我們果斷優化研究及開發(「研發」)組合, 讓我們得以限制受不利影響項目的損失,同時增加投放 資源於優先項目。

On the other hand, we have made good progress on our R&D activities and some of our drug development efforts have started to pay off. The Abbreviated New Drug Application ("ANDA") and Import Drug License ("IDL") approvals of Fondaparinux Sodium Injection, Sodium Phenylbutyrate Granules, Lidocaine Hydrochloride Powder Intradermal Injection System, Nitric Oxide Gas for Inhalation and High Concentration Treprostinil Injection, a total of 5 products, were obtained from National Medical Products Administration ("NMPA") during the Reporting Year and up to date, and the IDL approvals of Riluzole Oral Suspension and Procarbazine Hydrochloride Capsule are expected to be obtained soon. Together with Mizoribine Tablets which is in itself a marketable product licensed-in during the Reporting Year, we have moved one big stride forward towards a much broader product range with a wider array of specialty pharmaceutical products.

另一方面,我們的研發活動進度良好,部分藥物開發工作已開始收成。於報告年度內及截至目前為止,磺達肝癸鈉注射液、苯丁酸鈉顆粒、鹽酸利多卡因粉末皮內注射給藥系統、一氧化氮吸入性氣體及高濃度曲前列尼爾注射液合共5項產品已取得國家藥品監督管理局(「國家藥監局」)發出簡化新藥上市申請(「簡化新藥申請」)及進口藥品註冊證批准,而利魯唑口服混懸劑及鹽酸丙卡巴肼膠囊則預期將於短期內取得進口藥品註冊證批准。連同於報告年度內已可上市的引進產品咪唑立賓片劑,我們在擴大產品範圍及增加特種藥品選擇方面向前邁進一大步。

管理層討論及分析

BUSTNESS REVIEW

Revenue and Profit

During the year ended 31 December 2021 (the "Reporting Year"), the Group recorded revenue of HK\$1,266,157,000 (2020: HK\$1,216,716,000), representing a year-on-year increase of 4.1%. Sales of licensed-in products was HK\$749,135,000 (2020: HK\$677,951,000) and accounted for 59.2% (2020: 55.7%) of the Group's revenue while sales of proprietary and generic products was HK\$517,022,000 (2020: HK\$538,765,000) and contributed 40.8% (2020: 44.3%) of the Group's revenue.

For the sales of licensed-in products, Carnitene® recorded a decent growth of 15.0% as the demand for chronic disease medications remains intact; Ferplex® achieved a robust growth of 29.1% through brand transformation and expansion into the OTC category; other products such as Gaslon N® and Sancuso® also made contribution to the revenue growth during the Reporting Year; and Bredinin™, newly launched in third-quarter 2021, also contributed approximately 2.8% to the revenue. As a result, despite the revenue loss from the termination of distribution right of Zanidip® in China, sales of licensed-in products still managed to achieve a growth of 10.5% as compared to last year.

The Group's first generic product, Treprostinil Injection, registered a remarkable growth of 87.3% as compared to last year. Another two generic products, namely Fondaparinux Sodium Injection and Sodium Phenylbutyrate Granule, have started making contribution to the revenue during the Reporting Year. For the sales of proprietary products, Yallaferon® achieved a robust growth of 51.2% through brand transformation and expansion into the OTC category; and Slounase® recorded a mild growth of 5.5%. However, these sales growth can only helped partially offset the revenue loss of Livaracine® due to the market disruption caused by the hospital relisting process as Nadroparin Calcium for Injection. Sales of proprietary and generic products in total dropped 4.0% as compared to last year.

The Group achieved a gross profit of HK\$806,284,000 (2020: HK\$781,066,000), an increase of 3.2% compared to last year. Gross profit margin was 63.7% in 2021, slightly decreased by 0.5 percentage point from 64.2% in 2020 which was mainly due to higher proportion of revenue generated from the sales of licensed-in products.

The Group's research and development ("R&D") expenses during the Reporting Year represented new drugs development in major therapeutic areas such as cardiovascular, woman health, paediatrics, rare diseases, dermatology and obstetrics, as well as in the area of oncology under a separate R&D arm within the Group.

業務回顧

收益及溢利

於截至二零二一年十二月三十一日止年度(「報告年度」)內,本集團錄得收益1,266,157,000港元(二零二零年:1,216,716,000港元),按年增長4.1%。引進產品的銷售額為749,135,000港元(二零二零年:677,951,000港元),佔本集團收益的59.2%(二零二零年:55.7%),而專利及仿製產品的銷售額則為517,022,000港元(二零二零年:538,765,000港元),佔本集團收益的40.8%(二零二零年:44.3%)。

引進產品的銷售額方面,由於長期病患藥物需求不受影響,故《可益能》®錄得不錯的增長,為15.0%;《菲普利》®通過品牌轉型、進軍非處方藥物領域,取得強勁增長,為29.1%;《蓋世龍》®及《善可舒》®等其他產品亦於報告年度帶來收益增長貢獻;而於二零二一年第三季度新推出的《布累迪寧》"亦貢獻約2.8%的收益。因此,儘管《再寧平》®中國特許授權終止而喪失收益,惟引進產品的銷售額仍較去年增長10.5%。

作為本集團首隻仿製產品,曲前列尼爾注射液較去年顯著增長87.3%。另外兩隻仿製產品磺達肝癸鈉注射液及苯丁酸鈉顆粒亦於報告年度內開始帶來收益貢獻。至於來自專利產品的銷售額,《尤靖安》®通過品牌轉型、進軍非處方藥物領域,取得強勁增長,為51.2%;而《速樂涓》®則穩步增長5.5%。然而,此等銷售額增幅只能部分抵銷因《立邁青》®作為那屈肝素鈣注射液重新安排在醫院上市,令市場受干擾而喪失的收益。專利產品及仿製產品總銷售額較去年減少4.0%。

本集團錄得毛利806,284,000港元(二零二零年:781,066,000港元),較去年增長3.2%。二零二一年的毛利率為63.7%,較二零二零年的64.2%輕微下跌0.5個百分點,主要是由於銷售引進產品的收益佔比上升所致。

於報告年度內,本集團的研究及開發(「研發」)費用來自心血管、女性健康、兒科、罕見病、皮膚科及產科等各種主要治療領域的新藥開發,以及獨立的腫瘤科研發分支。

管理層討論及分析

The Chinese government continued to implement a series of major reforms to its drug pricing regulatory mechanisms. In particular, the Volume-Based Procurement ("VBP") program has continued to rollout across the country and cover more products which brought down prices to public hospitals with volume commitments. It is inevitable that such regulatory change of this scale and scope creates uncertainty to the Group's R&D portfolio. After a review of the R&D portfolio, the Group decided to postpone 14 drug development programs and a one-time loss of approximately HK\$190.7 million attributable to the full impairment made in respect of the licensing fee and development cost previously capitalised therefor was recognised. In addition, a one-time loss of approximately HK\$40.2 million attributable to the full impairment for the licensing fee and development cost previously capitalised for a launched oral antihypertensive product, namely Rasilez®, was recognised due to the concern about its future market and revenue potential in view of the lowered prices of competing antihypertensive products after the completion of the fifth round of VBP program.

中國政府繼續對藥品價格監管機制進行多項重大改革,尤其是藥品集中帶量採購(「藥品集採」)計劃繼續在全國推行,且擴大藥品覆蓋,藉帶量採購降低公立醫院的採購價。如此大規模與範圍的監管轉變無可避免地為本集團的研發組合帶來不明朗因素。於檢討研發組合後,本集團決定押後14項藥物開發項目,並因此就已資本化的專利費及開發成本全數減值確認一次性虧損約190,700,000港元。此外,在第五批藥品集採計劃完成後,已推出的口服抗高血壓藥《鋭思力》®在其他抗高血壓競爭產品價格下滑的情況下,未來市場及收益潛力存疑,故本集團亦就其已資本化的專利費及開發成本全數減值確認一次性虧損約40,200,000港元。

Saved for the above, the Group continued to invest its R&D efforts in new drugs development and HK\$463,147,000 was spent in R&D activities during 2021 (2020: HK\$389,399,000), represented 36.6% (2020: 32.0%) to the corresponding yearly revenue. Among which HK\$243,835,000 (2020: HK\$203,294,000) has been recognised as expenses and HK\$219,312,000 (2020: HK\$186,105,000) has been capitalised as intangible assets. In additions, HK\$100,717,000 (2020: HK\$111,139,000) license fees for licensed-in products has been recognised as intangible assets during 2021.

除上文所述者外,本集團於二零二一年繼續投資於開發新藥的研發活動,研發活動開支為463,147,000港元(二零二零年:389,399,000港元),佔相應年度收益的36.6%(二零二零年:32.0%),當中243,835,000港元(二零二零年:203,294,000港元)已確認為費用,而219,312,000港元(二零二零年:186,105,000港元)已資本化作為無形資產。此外,於二零二一年,100,717,000港元(二零二零年:111,139,000港元)的引進產品專利費亦已確認為無形資產。

The Group implemented various measures to strengthen the existing and exploring new distribution channels and preparing for the rollout of new and upcoming products, and adequate resources have been deployed thereto during the Reporting Year. Overall, the selling expenses to revenue ratio was 28.9% in 2021, increased by 5.9 percentage points as compared to 23.0% same period last year. As an example of such efforts, the Group has achieved a speedy take-over of the Bredinin™ sales since July 2021 and realised the revenue of approximately HK\$36.1 million in 2021.

於報告年度內,本集團亦已施行多項措施強化現有分銷管道,同時探索新分銷管道,以及為新產品及即將面世的產品上市作準備,且已投放足夠資源。整體而言,與去年同期的23.0%比較,二零二一年銷售費用對收益的比率上升5.9個百分點至28.9%。有關努力的例子包括本集團自二零二一年七月起迅速接手《布累迪寧》"的銷售工作,更於二零二一年實現收益約36,100,000港元。

During the Reporting Year, the Group recorded a net provision for expected credit losses on financial assets of HK\$90,284,000 (2020: HK\$1,180,000) which was mainly attributable to the full provision for impairment on the advances of HK\$90,838,000 (2020: Nil) made to Powder Pharmaceuticals Incorporated ("PPI"), an associated company of the Group. The financial assistance provided were used to support PPI's business operation which included the production, development and promotion of a powder intra-dermal injection system and the development of a continuous glucose monitoring system. In view of the recent sharp downturn in biotech capital market which leads to a less certain path to new funding on developing stage projects, the Group decided not to extend the advances thereto upon the expiry. Meanwhile, the Group will continue to monitor the progress of PPI product developments and to seek a settlement on the amount which had fallen due but remained unpaid.

於報告年度內,本集團錄得財務資產預期信貸虧損撥備淨額90,284,000港元(二零二零年:1,180,000港元),主要是由於就向本集團聯營公司普樂藥業有限公司(「普樂藥業」)墊付的款項90,838,000港元(二零二零年:無)作出全數減值撥備所致。所提供的財務支援乃用於支持普樂藥業的業務營運,包括生產、開發及推廣粉狀皮下注射系統,以及開發持續葡萄糖檢測系統。鑒於生物科技資本市場近期急挫,導致開發階段項目新資金來源較為不明朗,本集團決定於期滿後不再為墊款延期。與此同時,本集團將繼續監察普樂藥業的產品開發進度,尋求收回已到期但仍未支付之款項。

管理層討論及分析

Together with a one-time gain of approximately HK\$2.3 billion attributable to the derecognition of investment in Zhaoke Ophthalmology Limited ("**ZKO**", stock code: 6622.HK) as an associate of the Company immediately after the separate listing of ZKO on 29 April 2021, net profit attributable the owners of the Company in 2021 was HK\$1,987,176,000, increased by approximately 14.4 times as compared to last year.

Manufacturing Facilities and Production Capability

During the Reporting Year, the Group achieved good progress in production capacity expansions and manufacturing facility upgrades of Yallaferon® and Livaracine® as well as the technology transfer of certain new products in the form of oral lyophilised powder and liposome in Hefei site. In Nansha site, the GMP production lines of Tecarfarin tablet and Nokxaban tablet have been completed and the making of clinical samples have been done. The equipment installation and commission for the manufacturing of inhaled pharmaceutical aerosols has been completed and the making of clinical samples has also been done. The equipment installation and commission for the productions of oral cytotoxic drugs and continuous glucose monitor were completed, and both facilities are ready for making clinical samples and/or registration batch.

Drug Development

To date, the Group has over 40 projects in its pipeline from early- to late-stage development. The applications made in the prior year for Import Drug License ("IDL"), such as Natulan®, and Teglutik®, and for Abbreviated New Drug Application ("ANDA"), namely Azilsartan, and Apremilast tablet (阿普米司特片), are under review by the Centre for Drug Evaluation (the "CDE"). The New Drug Application ("NDA") for Adasuve® made in the prior year has been officially accepted by the China's National Medical Products Administration ("NMPA").

During the Reporting Year and up to date, measurable progress has been made in various clinical programs.

Major Therapeutic Areas

The Group is currently developing several assets in major therapeutic areas, such as cardiovascular, woman health, paediatrics, rare diseases, dermatology and obstetrics, which includes late-stage programs such as (1) Cetraxal® Plus for acute otitis externa (AOE) and acute otitis media with tympanostomy tubes (AOMT); and (2) Intrarosa® in the treatment of vulvovaginal atrophy (VVA), both of which are already in Phase III clinical trial stage. On the other hand, the ANDA of High Concentration Treprostinil Injection (20ml:50mg) has been accepted for review by NMPA in February 2021 and subsequently approved on 9 March 2022.

加上緊隨兆科眼科有限公司(「**兆科眼科**」,股份代號: 6622.HK)於二零二一年四月二十九日分拆上市後,終止將本公司於兆科眼科的投資確認為聯營公司時的一次性收益約2,300,000,000港元,二零二一年的本公司擁有人應佔統利為1,987,176,000港元,較去年增加約14.4倍。

生產設施及生產能力

於報告年度內,本集團合肥基地的《尤靖安》®及《立邁青》®產能提升及生產設施升級以及若干口服凍乾粉及脂質體新產品的技術轉移進度良好。南沙基地生產特卡法林藥片及諾克沙班藥片已完成GMP生產線建設並已生產臨床試驗用藥。生產氣溶膠吸入劑的設施亦已完成安裝及調試,並已生產臨床試驗用藥,而生產口服細胞毒性藥物及進行連續血糖監測的設備則已完成安裝及調試,兩者均已準備好生產臨床試驗用藥及/或註冊批次。

藥物開發

截至目前為止,本集團管道中有超過40個分別處於早期至後期開發階段的項目。於上一年度,本集團的進口藥品註冊證申請(即Natulan®及Teglutik®)及簡化新藥上市申請(「簡化新藥申請」)(即阿齊沙坦及阿普米司特片)正由藥品審評中心(「藥審中心」)評審。上一年度的Adasuve®新藥上市申請(「新藥申請」)已獲中國國家藥品監督管理局(「國家藥監局」)正式受理。

於報告年度內及截至目前為止,多項臨床計劃取得實質 淮展。

主要治療領域

本集團現正開發主要治療領域的各種資產,包括心血管、女性健康、兒科、罕見病、皮膚科及產科,包括處於後期開發階段的計劃,例如(1) Cetraxal® Plus,治療急性外耳道炎及伴有鼓膜置管的急性中耳炎;及(2) Intrarosa®用於治療外陰陰道萎縮(VVA),兩項均處於第III期臨床試驗階段。另一方面,高濃度曲前列尼爾注射液(20毫升:50毫克)的簡化新藥申請已於二零二一年二月獲國家藥監局受理,其後已於二零二二年三月九日獲批。

管理層討論及分析

Oncology Pipeline

China Oncology Focus Limited ("COF"), a 65% owned subsidiary of the Group, is a clinical development stage company and the Group's R&D arm focused on oncology with emphasis in immuno-oncology. To date, COF has built a pipeline of 10 oncology assets, including 6 innovative and 4 generics, through internal development and in-licensing, and is currently developing several assets, including (1) Socazolimab (an anti-PD-L1 antibody) in recurrent or metastatic cervical cancer in new drug application stage in China; (2) Socazolimab in osteosarcoma in Phase III clinical trial; (3) Socazolimab combined with chemotherapy in small cell lung cancer in Phase III clinical trial; (4) Zotiraciclib, an oral multi-kinase inhibitor in Phase I clinical trial for glioblastoma; (5) Gimatecan, a topoisomerase I inhibitor in Phase II clinical trial for ovarian cancer and in Phase Ib/II clinical trial for small cell lung cancer and a Phase I clinical trial for pancreatic cancer in China; and (6) Socazolimab combined with Pexavec (oncolytic virus) which is in Phase Ib clinical trial for melanoma.

During the Reporting Year and up to date, the Group obtained 5 ANDA and IDL approvals from NMPA.

Fondaparinux Sodium Injection

On 2 February 2021, Fondaparinux Sodium Injection (0.5 ml: 2.5 mg), a drug indicated to prevent deep vein thrombosis (DVT; a blood clot, usually in the leg), which can lead to pulmonary embolism (PE; a blood clot in the lung), in people who are having hip surgery, hip or knee replacement, or abdominal surgery, obtained approval for manufacturing and marketing from the NMPA. Fondaparinux sodium is a synthetic and specific inhibitor of coagulation activated factor X (factor Xa) with high bioavailability, fast acting and longer half-life. It has no effect on factor IIa, and has low bleeding adverse event. It inhibits only free factor Xa but not factor Xa bound to the prothrombinase. Use of fondaparinux does not require monitoring of PT (prothrombin time) and aPTT (activated partial thromboplastin time). The short chain length of fondaparinux sodium results in devoid of immunogenicity. It does not interact with platelet and does not induce thrombocytopenia. It has no hepatotoxicity and has less allergic reactions.

腫瘤管道

本集團擁有65%權益的附屬公司中國腫瘤醫療有限公司(「COF」)為本集團在腫瘤科方面的研發分支,並為臨床開發階段公司,專研免疫腫瘤療法領域。截至目前為止,COF已通過內部研發及從外引進的方式建立涵蓋10項腫瘤資產的管道,包括6項創新及4項仿製藥,現正開發多項資產,包括(1) Socazolimab(抗PD-L1抗體),於中國處於復發性或轉移性宮頸癌新藥申請階段:(2) Socazolimab骨肉瘤第III期臨床試驗:(3) Socazolimab結合化療的小細胞肺癌第III期臨床試驗:(4) Zotiraciclib,一種口服多激酶抑制劑,現正進行膠質母細胞瘤第I期臨床試驗:(5) Gimatecan,一種拓撲異構酶I抑制劑,現正於中國進行卵巢癌第II期臨床試驗、小細胞肺癌第Ib/II期臨床試驗及胰臟癌第I期臨床試驗:及(6) Socazolimab結合Pexa-vec(一種溶瘤病毒),現正進行黑色素瘤第Ib期臨床試驗。

於報告年度內及截至目前為止,本集團已取得國家藥監局發出5項簡化新藥申請及進口藥品計冊證批准。

磺達肝癸鈉注射液

於二零二一年二月二日,磺達肝癸鈉注射液(0.5毫升:2.5毫克)已獲國家藥監局的生產及上市批文。該藥物適用於預防正進行髖關節手術、髖關節或膝關節置換或下腹手術的人士出現可導致肺栓塞(PE:肺部血凝塊)的深靜脈血栓(DVT:一般見於腿部的血凝塊)。磺達肝癸鈉乃人工合成的活化凝血X因子(Xa因子)選擇性抑制劑,具有生物利用度高、起效快、半衰期長等優點。磺達肝癸鈉對IIa因子無作用,出血的不良反應少,僅抑制游離的Xa因子而不抑制與凝血酶原酶結合的Xa因子,不需監測PT(凝血酶原時間)及aPTT(活化部分凝血酶時間)。磺達肝癸鈉分子鏈短,不能誘導抗體反應,與血小板並無相互作用,不會引起血小板減少症,且對肝臟無毒害作用,過敏反應發生少。

管理層討論及分析

Sodium Phenylbutyrate Granules

On 13 May 2021, the Drug Registration Certificate for Sodium Phenylbutyrate Granules (specification: 150g/bottle, containing 0.94g Sodium Phenylbutyrate for every 1g) developed and manufactured by Zhaoke Pharmaceutical (Guangzhou) Company Limited ("Zhaoke Guangzhou"), a wholly-owned subsidiary of the Company, has been obtained from the NMPA. Sodium Phenylbutyrate is used as an adjuvant treatment for long-term treatment on urea cycle disorders patients resulting from carbamoyl phosphate synthetase deficiency, ornithine transcarbamylase deficiency or argininosuccinate synthetase deficiency. It is applicable to new-born babies (born less than 28 days) with profound biotinidase deficiency and to patients with a history of late onset hyperammonemia brain dysfunction (partial biotinidase deficiency, born for more than one month). The Sodium Phenylbutyrate Granules developed and manufactured by Zhaoke Guangzhou is the first generic version in China. As there is no original Sodium Phenylbutyrate available for sale in China, the Group's Sodium Phenylbutyrate Granules would address the unmet medical needs in China

Zingo®

On 1 March 2022, the Drug Registration Certificate for Zingo® (Lidocaine Hydrochloride Powder Intradermal Injection System) has been obtained from the NMPA. Zingo® is an amide local anesthetic indicated for use on intact skin to provide local analgesia prior to venipuncture or peripheral intravenous cannulation in children 3–18 years of age and to provide topical local analgesia prior to venipuncture in adults. The rapid onset of analgesia in 1–3 minutes provides care givers and patients the opportunity for a pain-free and needle-free access procedure.

INOmax®

On 8 March 2022, the Drug Registration Certificate for INOmax® (nitric oxide gas for inhalation) has been obtained from the NMPA. INOmax® is a therapy for the treatment of hypoxic respiratory failure ("HRF") associated with pulmonary hypertension ("PPHN") in term and near-term infants greater than 34 weeks gestational age. PPHN is a serious condition in which blood vessels in the lungs constrict, making it difficult to oxygenate blood, often resulting in HRF. INOmax® is a vasodilator which selectively relaxes pulmonary blood vessels and, in conjunction with ventilatory support and other appropriate agents, improves oxygenation in this fragile newborn population.

苯丁酸鈉顆粒

於二零二一年五月十三日,由本公司全資附屬公司兆科藥業(廣州)有限公司(「**兆科廣州**」)開發並生產的苯丁酸鈉顆粒(規格:150克/瓶,每1克含苯丁酸鈉0.94克)取得國家藥監局的藥品註冊證書。苯丁酸鈉作為輔助治療藥物,用於氨基甲醯磷酸合成酶缺乏症、鳥氨酸氨甲醯基轉移酶缺乏症或精氨基琥珀酸合成酶缺乏症引起的尿素循環異常患者的長期治療,適用於新生兒期(出生28天內)出現完全酶缺乏症的患者,亦適用於有高血氨性腦病病史的遲發型(部分酶缺乏症,發生於出生一個月後)患者。兆科廣州開發並生產的苯丁酸鈉顆粒為國內首仿藥物。目前中國沒有原研苯丁酸鈉顆粒為國內首方藥物。目前中國沒有原研苯丁酸鈉銷售,本集團的苯丁酸鈉顆粒正好填補國內醫療需求的空白。

Zingo®

於二零二二年三月一日,Zingo®(鹽酸利多卡因粉末皮內注射給藥系統)取得國家藥監局的藥品註冊許可證。 Zingo®為用於皮膚表層的醯胺局部麻醉劑,提供注射後1-3分鐘即見效的局部鎮痛;用於3至18歲小孩靜脈穿刺或靜脈插管前局部鎮痛,以及成人靜脈穿刺前局部鎮痛,為護理人員及患者提供無針、無痛的注射系統。

INOmax®

於二零二二年三月八日,INOmax®(一氧化氮吸入性氣體)取得國家藥監局的藥品註冊許可證。INOmax®是一種用於治療患有低氧性呼吸衰竭(「HRF」)並伴隨肺動脈高壓(「PPHN」)的足月兒及34週以上的早產兒的療法。PPHN是一種肺血管收縮導致血液難以供氧的嚴重疾病,經常導致HRF。INOmax®是一種血管擴張劑,其可選擇性地讓肺血管放鬆,並通過配合換氣裝置及其他適當藥物,改善脆弱新生兒群體的氧合。

管理層討論及分析

High Concentration Treprostinil Injection

On 9 March 2022, the Drug Registration Certificate for High Concentration Treprostinil Injection (specification: 20ml:50mg) developed and manufactured by Zhaoke Pharmaceutical (Hefei) Company Limited, a wholly-owned subsidiary of the Company, has been obtained from the NMPA.

Business Partnership

The in-licensing approach is the Group's preferred mode of business development strategy. Nevertheless, the Group has remained selective in entering new in-licensing deals. Only 1 licensing deal has been entered into during the Reporting Year. On 15 June 2021, the Group successfully entered into a license agreement with Asahi Kasei Pharma Corporation, a Japan-based company, pursuant to which the Group was awarded the exclusive license to commercialise Bredinin™ (generic name: mizoribine) for the indication of suppression of rejection reaction in renal transplantation in Mainland China. Bredinin™ was first launch in China in 1999 and has already established a decent market presence within the patient population. In addition, supplemental new drug application (sNDA) for the additional indications such as lupus nephritis (LN) and nephrotic syndrome (NS) were submitted to NMPA in June 2020.

Corporate Development

On 29 April 2021, the Group's investment in ZKO has been successfully listed on the Main Board of The Stock Exchange of Hong Kong Limited ("HKEx") at HK\$16.80 per ZKO share and raised approximately HK\$1,932.3 million. Upon the listing of ZKO, ZKO ceased to be an associate of the Company since the Group will not exercise significant influence over the operations thereof and is accounted for as financial assets at fair value through other comprehensive income for financial reporting purposes. The Group has recorded a one-time gain of approximately HK\$2.3 billion in the Company's consolidated statement of profit or loss on this derecognition of investment in ZKO as an associate of the Company in the second quarter of 2021.

高濃度曲前列尼爾注射液

於二零二二年三月九日,本公司的全資附屬公司兆科藥業(合肥)有限公司開發及製造的高濃度曲前列尼爾注射液(規格:20毫升:50毫克)已取得國家藥監局的藥品註冊許可證。

業務夥伴

特許經營策略為本集團業務發展策略的首選模式。然而,本集團在訂立新的特許經營交易時,仍然堅持精挑細選。本集團於報告年度內僅訂立一項特許經營交易。於二零二一年六月十五日,本集團成功與日本公司旭化成製藥株式会社訂立授權協議。據此,本集團獲得《布累迪寧》™(通用名稱:咪唑立賓)商業化的獨家授權,在中國大陸用於抑制腎臟移植的排斥反應。《布累迪寧》™於一九九九年首次在中國面市,已在患者群體中建立良好的市場地位。此外,狼瘡性腎炎(LN)及腎病綜合症(NS)追加適應症的補充新藥申請已於二零二零年六月提交國家藥監局。

企業發展

於二零二一年四月二十九日,本集團於兆科眼科的投資成功於香港聯合交易所有限公司(「**聯交所**」)主板上市,發售價為每股兆科眼科股份16.80港元,集資額約為1,932,300,000港元。於兆科眼科上市後,由於本集團不能再對兆科眼科的運作行使重大影響力,故兆科眼科不再為本公司的聯營公司,就財務報告而言入賬列作按公平值透過其他全面收益列賬的財務資產。於二零二一年第二季終止將本公司於兆科眼科的投資確認為聯營公司時,本集團於本公司的綜合損益表內錄得一次性收益約2,300,000,000,000港元。

FINANCIAL REVIEW

Revenue and Net Profit Attributable to the Owners of the Company

The Group's revenue increased on a year-on-year basis by HK\$49,441,000 or 4.1%, from HK\$1,216,716,000 in 2020 to HK\$1,266,157,000 in 2021. During the Reporting Year, the sales of proprietary and generic products decreased 4.0% and the sales of licensed-in products increased by 10.5%.

財務回顧

本集團收益按年增加49,441,000港元或4.1%,由二零二零年1,216,716,000港元增至二零二一年1,266,157,000港元。於報告年度內,專利及仿製產品的銷售減少4.0%,引進產品的銷售則增加10.5%。

Net profit attributable to the owners of the Company increased by 1,436.7% from HK\$129,316,000 in 2020 to HK\$1,987,176,000 in 2021.

本公司擁有人應佔純利增加1,436.7%,由二零二零年 129,316,000港元增至二零二一年1,987,176,000港 元。

Gross Profit Margin

Gross profit margin for the Reporting Year was 63.7%, slightly decreased by 0.5 percentage point as compared with year 2020 which was mainly due to higher proportion of revenue generated from licensed-in products.

Other Income

Other income for the Reporting Year was HK\$102,323,000, a decrease of 32.1% as compared to corresponding period of last year. Other income included development grants from local government, rental and utilities income, and research and development service income. Other income in the year 2020 included certain one-off items such as compensation income for the early termination of the license and supply agreement of Zanidip®, and government grant in respect of COVID-19-related subsidies.

Other Gains and Losses, Net

Other gains and losses recorded a net gain of HK\$2,067,799,000 for the Reporting Year which was mainly attributable to the HK\$2.3 billion gain on deemed disposal of interest in associate ZKO, and impairment loss recognised in respect of intangible assets of HK\$230,509,000.

Selling and Distribution Expenses

Selling and distribution expenses for the Reporting Year recorded an increase of 30.9% as compared to the corresponding period of last year to HK\$366,439,000, representing 28.9% of the Group's revenue, increased by 5.9 percentage points as compared with 23.0% that of in the prior year. The Group continued to deploy adequate resources to strengthen the existing and exploring new distribution channels, and on the preparation for the roll-out of new products.

毛利率

報告年度的毛利率為63.7%,與二零二零年度相比微跌 0.5個百分點,主要由於引進產品產生的收益比例上升 所致。

其他收入

報告年度的其他收入為102,323,000港元,較去年同期減少32.1%。其他收入包括地方政府授予之開發補助、租金及公共服務收入以及研究及開發服務收入。二零二零年度的其他收入包括若干一次性項目,例如提早終止《再寧平》®特許及供應協議的補償收入以及涉及COVID-19相關補貼的政府補助。

其他收益及虧損淨額

報告年度的其他收益及虧損錄得2,067,799,000港元淨收益,主要源於視為出售聯營公司兆科眼科權益的收益23億港元,以及就無形資產確認的減值虧損230,509,000港元。

銷售及分銷費用

報告年度的銷售及分銷費用較去年同期增加30.9%至366,439,000港元,佔本集團收益28.9%,較去年的23.0%上升5.9個百分點。本集團繼續調撥充足資源強化現有分銷渠道,同時探索新分銷渠道,以及為新產品上市作準備。

Administrative Expenses

Administrative expenses for the Reporting Year increased by 25.0% or HK\$59,544,000, from HK\$237,721,000 in year 2020 to HK\$297,265,000 in 2021, and accounted for 23.5% of the Group's revenue for the Reporting Year, increased by 4.0 percentage points from 19.5% in 2020.

Research and Development Expenses

Research and development expenses for the Reporting Year increased by HK\$40,541,000 as compared with the corresponding year to HK\$243,835,000, and accounted for 19.3% of the Group's revenue, increased by 2.6 percentage points as compared with 16.7% that of in the prior year. Together with the capitalised research and development costs of HK\$219,312,000 (2020: HK\$186,105,000), the amount spent in research and development activities during the Reporting Year was HK\$463,147,000, increased by HK\$73,748,000 or 18.9% as compared with the corresponding year.

Taxation

Income tax expense for the Reporting Year decreased by HK\$46,021,000 as compared with the corresponding period of prior year to HK\$9,482,000. The Group's effective tax rate was approximately 0.5% during the Reporting Year, decreased by 40.9 percentage points as compared with 41.4% for the prior year. More one-off items not subject to tax lower the effective tax rate in current year.

Investments Held

As at 31 December 2021, the Group's investment portfolio amounted to approximately HK\$1,043,464,000 (31 December 2020: HK\$421,690,000) as recorded in the consolidated statement of financial position under various categories including:

- interests in associates which are accounted for by using equity method;
- financial assets at fair value through profit or loss ("FVTPL"); and
- financial assets at fair value through other comprehensive income ("FVTOCI").

Changes in respective items in the consolidated statement of financial position have been disclosed in the notes to the consolidated financial statements in this annual report.

行政費用

税項

Note 1: Zhaoke Ophthalmology Limited ("ZKO") is an ophthalmic pharmaceutical company listed on the Main Board of The Stock Exchange of Hong Kong Limited (stock code: 6622) and is principally engaged in the research, development and commercialisation of therapies that address significant unmet medical needs in eye diseases market. The Group directly held 138,192,000 shares of ZKO, representing 25.5% of the total issued shares of ZKO as at 31 December 2021. During the Reporting Year, the Group did not receive any dividend income from ZKO. The Group takes a longer-term view on this investment as ZKO is still a pre-revenue biotech company. The Group will closely monitor the progress of the clinical development programs of ZKO.

Note 2: None of the carrying amount of each of the financial assets therein constitutes 5% or more of the Group's total assets as at 31 December

The Group will closely monitor the performance of its investment portfolio and will continue to invest strategically, and will explore opportunities in monetising some of the existing investments if appropriate opportunities in the market arise.

The Group strives to reduce exposure to credit risk by performing ongoing credit evaluations of the financial conditions of its customers. To manage liquidity risk, the management of the Group closely monitors the Group's liquidity position to ensure that the liquidity structure of the Group's assets, liabilities and commitments can meet its funding requirements.

The Directors believe that the Group does not have foreign exchange problems in meeting its foreign exchange requirements. The Group will continue to monitor closely its foreign currency exposure and to consider hedging significant foreign currency exposure when necessary.

Employee Information

As at 31 December 2021, the Group had 1,319 (31 December 2020: 1,302) employees working in Hong Kong, Mainland China and Taiwan.

The Group's emolument policies are formulated on the performance of individual employees and based on the trends of salaries in various regions, which will be reviewed regularly every year. Apart from mandatory provident fund scheme, retirement benefit scheme and medical insurance, employees share options may also award to employees according to the assessment of individual performance.

PROSPECT

The Group remains of the view that the long-term prospect for the China pharmaceutical market is promising in terms of the growth of total health spending in the region, but the tough business environment due to regulatory changes will be persisted in 2022.

It is expected that the Chinese government will continue to promote medical pricing reform to increase the coverage of the National Reimbursement Drug List (NRDL) and VBP program to eventually achieve "the domestics to replace the imports" goal, to control price rises in drugs and medical consumables, and to increase the efficiency of medical insurance fund usage in 2022, which has been particularly evident by the annual meetings of the National People's Congress (NPC) and the Chinese People's Political Consultative Conference (CPPCC) commenced in March 2022. As stated in the Government Work Report, it is expected that the VBP program will continue and may cover over 300 drugs by the end of 2022. And in fact, the National Centralised Procurement Office has already issued a Notice to Report Information of the seventh round of VBP in February 2022 for another 58 drugs.

While it is believed that the Group will be eventually benefited from these new laws and regulations in the long run, nevertheless, the Group will implement a series of measures to adapt to the "new normal" and to emphasis efficiency at every step of the value chain, particularly in key areas such as sales and R&D, after taking the present conditions into consideration.

資產抵押

僱員資料

於二零二一年十二月三十一日,本集團於香港、中國內地及台灣工作的僱員人數為1,319人(二零二零年十二月三十一日:1,302人)。

本集團的酬金政策乃按個別僱員的表現及基於不同地區的薪金趨勢而定,並會每年定期檢討。除強制性公積金計劃、退休福利計劃及醫療保險外,本集團亦會按照個別表現評估向僱員授出僱員購股權。

展望

本集團堅信,在區內醫療開支總額增長下,中國醫藥市場長遠前景仍然亮麗,惟二零二二年的經營環境仍會因監管環境轉變而荊棘滿途。

預計中國政府將於二零二二年繼續推動醫療定價機制改革,擴大國家醫保藥品目錄及藥品集採計劃的覆蓋範圍,最終達成以國產藥取代進口藥、控制藥品及醫療耗材價格漲幅以及提高醫保資金使用效率的目標。於二國人民政治協商會議(「政協」)年度會議更進一步確定有關方向。政府工作報告表示,於二零二二年底,藥品集採計劃預計將繼續推行且可能拓展至超過300項藥物。實際上,國家組織藥品聯合採購辦公室已於二零二二年二月發表關於開展第七批國家組織藥品集中採購相關藥品信息填報工作的通知,涉及58個品種的藥品。

儘管本集團深信,此等新法律及法規長遠將有利於本集團,惟考慮到當前環境,本集團仍將實施一連串措施適應[新常態],價值鏈中的每一個環節(尤其是銷售及研發等關鍵流程)均會強調效率。

管理層討論及分析

Currently, the Group have six business units: (1) CardioRenal; (2) Gynecology, Paediatric and Dermatology; (3) Rare Disease; (4) Oncology; (5) Retail Sales; and (6) General Products, and are managed by the Group Commercial Operations Centre, and the Group will continue to enhance the existing sales business unit responsibility scheme in order to reflect contemporary needs and to achieve highly effective sales force.

本集團目前設有六個由集團營銷中心管理的業務單元, 分別為(1)心腎:(2)婦科、兒科及皮膚科:(3)罕見病: (4)腫瘤科:(5)零售:及(6)一般產品。本集團將繼續 改善現行銷售業務單元責任制度,以滿足當前需要並建 立高效的銷售團隊。

In view of the trend of the ongoing VBP program in China, it is expected that sales of standard drugs will remain the Group's bread and butter. and the sales of specialty drugs which focus on specific unmet medical needs and with better bargaining power over its pricing could become the Group's new growth drivers. From the launch of Treprostinil Injection for pulmonary arterial hypertension in March 2020, Sodium Phenylbutyrate Granules for urea cycle disorders in May 2021, and Bredinin™ for immunosuppression in renal transplantation in June 2021, and the recent approval of High Concentration Treprostinil Injection in March 2022, the Group has gradually expanded its product portfolio from the standard drugs towards specialty drugs. In addition, the NDA approvals of Teglutik® (Riluzole Oral Suspension) for the treatment of Amyotrophic Lateral Sclerosis (ALS) and Natulan® (Procabazine Hydrochloride Capsule) for the treatment of cancer are expected to be obtained soon. With more new products coming in 2022 and beyond, the Group aims at advancing its product portfolio to create growth opportunities.

隨着中國藥品集採計劃持續推進,預期標準藥銷售仍將為本集團的主要收益來源,惟針對個別醫療需求缺口且議價能力較高的特種藥銷售勢將成為本集團新的增長動力。自二零二零年三月推出針對肺動脈高壓的曲前列尼爾注射液、二零二一年五月推出用於抑制腎臟移植的排斥反應的《布累迪寧》™及近期於二零二二年三月高濃度曲前列尼爾注射液獲批以來,本集團的產品組合漸次由標準藥品擴大至特種藥。此外,Teglutik®(利魯唑口服混懸劑,治療肌萎縮側索硬化症)及Natulan®(鹽酸丙卡巴肼膠囊,治療癌症)的新藥申請預料快將獲批。隨着更多新產品將於二零二二年及往後面市,本集團計劃優化產品組合,造就發展機遇。

To maximise the value of our existing products will be another way to create growth opportunities. Selected products such as Ferplex® and Yallaferon® have been undergoing brand transformation and expanding into the OTC category and have already yielded some impressive initial results in 2021. The Group will continue to carry out these processes and look forward to the further success in 2022.

During the year, the monthly salaries and allowance for Ms. Lee and Ms. Leelalertsuphakun have been revised to HK\$408,253 and HK\$441,502 respectively.

Dr. Li Xiaoyi ("Dr. Li") has a service contract with the Company since 1 September 2003 and after that the contract has been renewed. Both the Company and Dr. Li shall be entitled to terminate the contract by giving three months' prior written notice. If both of the substantial shareholders, namely Ms. Lee and Ms. Leelalertsuphakun, and Dr. Li together, holding less than 30% of the issued share capital of the Company, Dr. Li shall in his absolute discretion terminate the contract and shall be entitled to the payment equivalent to the aggregate of his monthly salary for the remaining term as compensation or damages for or in respect of such termination. With effect from 29 April 2021, Dr. Li has been re-designated from an executive Director to a non-executive Director and serves as a senior adviser to the Company. Dr. Li has a three-year service contract with the Company from 29 April 2021. Director's fee is HK\$300,000 per annum and bonus will not be paid for service as a non-executive director and senior adviser to the Company. Director's fee is determined by the Board with reference to the market rate. The term of Dr. Li's appointment is subject to retirement and re-election at the annual general meetings of the Company in accordance with the Articles of Association. Dr. Li has a three-year consulting contract with the Company from 1 December 2021 for service as a senior adviser to the Company and is entitled to a service fee of HK\$100,000 per month.

In accordance with supplementary agreement dated 16 April 2017 signed between the Company and each of Ms. Lee, Ms. Leelalertsuphakun and Dr. Li (prior to his re-designation as a non-executive Director), employment terms of executive Directors have been revised as follows:

At the annual general meeting of the Company held on 10 May 2012, a new share option scheme of the Company (the "New Share Option Scheme") was adopted upon expiry of the 2002 Share Option Scheme.

The total number of Shares which may be issued upon exercise of all options to be granted under the New Share Option Scheme shall be subject to a maximum limit of 10% of the Shares in issue on 10 May 2012, the date on which the New Share Option Scheme is conditionally adopted and approved by the shareholders at the annual general meeting, which is 47,023,543 Shares. Under the New Share Option Scheme, upon acceptance of the option, the grantee of an option must pay HK\$1 to the Company by way of consideration for the grant thereof.

The total number of Shares available for issue under the New Share Option Scheme as at 31 December 2021 was 12,277,543, representing approximately 2.1% of the Company's total number of issued shares as at the date of this annual report.

As at 31 December 2021, the number of Shares in respect of which options had been granted and remained outstanding under the 2002 Share Option Scheme and New Share Option Scheme was 28,751,000 (31 December 2020: 27,697,000), representing 4.9% (31 December 2020: 4.7%) of the Shares in issue at that date.

Ms. Leelalertsuphakun Wanee, Ms. Lee Siu Fong and Dr. Li Xiaoyi are the directors and substantial shareholders of the Company who are connected persons of the Company under the Listing Rules. They altogether held a total of approximately 62.85% of the issued ordinary and preferred shares in Perfect Concept Holdings Limited ("PCH") as at the dates of the transaction and therefore, PCH is the associate of Ms. Leelalertsuphakun Wanee, Ms. Lee Siu Fong and Dr. Li Xiaoyi, and is then a connected person of the Company under the Listing Rules. Lee's Pharmaceutical International Limited ("LPI") is a shareholder of COF and at the same time, PCH, is also a shareholder of COF. PCH, being a connected person of the Company, is holding 35% of the issued share capital of COF, and therefore, the shareholder loans made by LPI to COF under the shareholder loan agreements constitutes a connected transaction pursuant to Rule 14A.27 of the Listing Rules.

On 11 February 2020 (as supplemented), the Company as guarantor provided a corporate guarantee in favour of a bank as a security for the provision of a revolving loan facility of up to HK\$13,000,000, a demand loan facility of up to HK\$40,000,000 and an overdraft facility of up to HK\$6,000,000, provided that the total outstanding balance of the overdraft facility and revolving loan facility shall not at any time exceed HK\$13,000,000, to PPI for the purpose of funding its normal commercial operation.

The above continuing connected transactions have been reviewed by the independent non-executive Directors and they have confirmed that the transactions:

- have been entered into in the usual and ordinary course of businesses of the Company and its subsidiaries.
- b. are conducted on normal commercial terms.

KEY RISKS AND UNCERTAINTIES

The Board acknowledges its responsibility for the effectiveness of the internal control and risk management systems of the Group, which are designed to manage the risk of failure to achieve business objectives and provide reasonable assurance against material misstatement or loss.

Business Risk

The Group's business risks include rapid change in the general market conditions, downturn pressure on the overall economy of China and price competition from other market players. The Board is responsible for the overall management of the business and review of material business decisions involving material risks exposures from time to time.

Financial Risk

The Group adopts financial risk management policies to manage its currency risk, interest rate risk, credit risk, and liquidity risk. The Board also reviews monthly management accounts, capital structure and key operating data of the Group.

Compliance Risk

The Board adopts procedures to ensure the Group is in compliance with the applicable laws, rules and regulations. The Group engages professional advisers and consultants to keep the Group abreast of the latest developments in the regulatory environment, including legal, financial, environmental and operational developments. The Group also adopts a strict policy in prohibiting any unauthorised use or dissemination of confidential or inside information.

Operational Risk

The Group adopts procedures to manage its operational risk such as inadequate management efficiency, inefficient raw material procurement and production facilities utilisation. The Board has reviewed the effectiveness of the Group's internal control and risk management systems covering business, financial, compliance and operational risks of the Group and is satisfied that such systems are effective and adequate.

RELATIONSHIPS WITH EMPLOYEES, CUSTOMERS AND SUPPLIERS

The sustainability of the Group's business relies on the growth of the Group's employees. Remuneration packages of the employees are generally structured with reference to prevailing market terms and individual qualifications. Salaries and wages are normally reviewed on an annual basis based on performance appraisals and other relevant factors.

Apart from salary payments, there are other staff benefits including mandatory provident fund, medical insurance and performance related bonus. Share options may also be granted to eligible employees of the Group.

Relationship is the fundamentals of business. The Group fully understands this principal and thus maintain good relationship with the customers to fulfil their immediate and long-term need.

The Group strives to maintain fair and co-operating relationship with the suppliers.

SOCIAL RESPONSIBILITIES AND SERVICES AND ENVIRONMENTAL POLICY

The Group is committed to the long-term sustainability of its businesses and the communities with which it engages. The Group pursues this business approach by managing its business prudently and executing management decisions with due care and attention. Over the years, the Group has been fully committed to environmental protection. Periodic internal control meetings are held to review environmental issues in the production plants to update environmental laws and regulations and to make valuable suggestions and recommendations for improvement.

The Group is not aware of any instances of material breach of or non-compliance with the applicable laws and regulations such as the Hong Kong Companies Ordinance (Cap. 622), Listing Rules, and other applicable local laws and regulations in various jurisdictions during the year ended 31 December 2021 and up to the date of this annual report.

ENVIRONMENTAL, SOCIAL AND GOVERNANCE REPORT

The Environmental, Social and Governance Report prepared in accordance with Appendix 27 of the Listing Rules will be published on the websites of the Company and the Stock Exchange within five months after the Reporting Year.

STAFF RETIREMENT SCHEMES

The group companies operated in Hong Kong are required to participate in a defined contribution retirement scheme set up in accordance with the Mandatory Provident Fund Schemes Ordinance (Cap. 485). Under the scheme, the employees are required to contribute 5% of their monthly salaries up to a maximum of HK\$1,500 and they can choose to make additional contributions. The employer's monthly contributions are calculated at 5% of the employee's monthly salaries up to a maximum of HK\$1,500 (the "Mandatory Contributions"), and are charged to the profit or loss as they become payable in accordance with the rules of the scheme. The assets of the scheme are held separately from those of the Group in an independently administered fund. The employees are entitled to 100% of the employer's Mandatory Contributions upon their retirement at the age of 65 years old, death or total incapacity.

In addition, pursuant to the government regulations in the PRC and Taiwan, the employees of the group companies operated in the PRC and Taiwan are members of a state-managed retirement benefit plan operated by the government of the PRC and Taiwan. Those group companies are required to contribute a specified percentage of payroll costs to the retirement benefit scheme to fund the benefits. The only obligation of the Group with respect to the retirement is to make the specified contributions.

Certain Directors will be entitled to lump sum payment upon retirement and monthly pension payment after retirement if they have engaged in continuous service with the Company for certain years.

Particulars of the scheme of the Group are set out in note 38 to the consolidated financial statements.

The Board believes that corporate governance is essential to the success of the Company and has adopted various measures to uphold good corporate governance to safeguard the interests of our shareholders, investors, customers and staff.

CORPORATE GOVERNANCE PRACTICES

The Company is committed to maintain a high standard of corporate governance to protect the interest of the shareholders of the Company. The Company has complied with all the then-applicable code provisions of the Corporate Governance Code (the "CG Code") as set out in Appendix 14 of the Listing Rules throughout the year ended 31 December 2021, with deviations from provision A.5 of the CG Code.

Under provision A.5 of the CG Code, a nomination committee should be established to make recommendations to the Board on the appointment and reappointment of Directors. The Board as a whole is responsible for the appointment of its own members. The Board did not establish a nomination committee in view of the small size of the Board. The Chairman of the Board was responsible for identifying appropriate candidate and proposing qualified candidate to the Board for consideration. The Board would review profiles of the candidates recommended by the Chairman and make recommendation the appointment, re-election and retirement of the Directors. Candidates were appointed to the Board on the basis of their skill, competence, experience and diversity of perspectives that they can contribute to the Company.

A new CG Code came into effect on 1 January 2022. A nomination committee of the Company comprising Ms. Lee Siu Fong as the chairman, Dr. Chan Yau Ching, Bob and Dr. Tsim Wah Keung, Karl as the members has been established by the Board with written terms of reference with effect from 2 January 2022, in which majority of the committee members are independent non-executive Directors. Since then, the Company has complied with code provision A.5 of the CG Code (which has been renumbered as code provision B.3 with effect from 1 January 2022).

COMPLIANCE WITH THE MODEL CODE FOR DIRECTORS' SECURITIES TRANSACTIONS

During the year ended 31 December 2021, the Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") as set out in Appendix 10 of the Listing Rules. The Company has made specific enquiries of all the Directors and the Company was not aware of any non-compliance with such Model Code and required standard of dealing throughout the year ended 31 December 2021.

The Company has a Board diversity policy whereby it recognises and embraces the benefits of a diversity of Board members. It endeavors to ensure that the Board has a balance of skills, experience and diversity of perspectives appropriate to the requirements of the Company's business. All Board appointments will continue to be made on a merit basis with due regard for the benefits of diversity of the Board members. Selection of candidates will be based on a range of diversity perspectives, including but not limited to gender, age, cultural and educational background, professional experience, skills and knowledge.

The list of Directors and their roles and functions is posted on the websites of the Company and the Stock Exchange.

The roles of the Chairman and Chief Executive Officer are segregated and are not exercised by the same individual. The Chairman of the Company is Ms. Lee Siu Fong and the management committee is responsible for the effective and timely management of the daily activities and business dealings of the Group, as well as implementation of all policies and decision approved by the Board and to assist the Board in implementing the Group's strategic plans.

The Board formulates overall strategic plans and key policies of the Group, monitors its financial performance, maintains effective oversight over the management, risks assessment, controls over business operations and ensures good corporate governance and compliance with legal and regulatory requirements. Responsibility in relation to daily operations and execution of the strategic business plans are delegated to each of the executive Directors and senior management.

AUDIT COMMITTEE AND ACCOUNTABILITY

The Board is responsible for presenting a balanced, clear and comprehensible assessment of the Group's performance and prospects. The Board is also responsible for preparing the accounts of the Group, which give a true and fair view of the financial position of the Group on a going concern basis.

The Company set up an audit committee with written terms of reference in compliance with Rules 3.21 and the CG Code as set out in Appendix 14 of the Listing Rules. The primary duties of the audit committee are to review and supervise the financial reporting process, internal control and risks management system of the Group.

The audit committee is to serve as a focal point for communication between other Directors, the external auditors, the internal auditors (where an internal audit function exists) of the Company, and the management as regards their duties relating to financial and other reporting, risk management, internal controls, external and internal audits and such other financial and accounting matters as the Board determines from time to time. The audit committee is to assist the Board in providing an independent review of the effectiveness of the financial reporting process, internal control and risk management system of the Group, overseeing the audit process and performing other duties and responsibilities as may be assigned by the Board from time to time.

The audit committee comprises three members, Dr. Chan Yau Ching, Bob (chairman of the audit committee), Mr. Lam Yat Cheong and Dr. Tsim Wah Keung, Karl, who are the independent non-executive Directors of the Company. In the financial year ended 31 December 2021, four audit committee meetings were held to review and comment on the Group's draft annual, interim and quarterly financial reports, met with external auditor and provided advices and recommendations to the Board. REMUNERATION COMMITTEE

A remuneration committee has been established in February 2012 in accordance with the requirement of Appendix 14 of the Listing Rules. The remuneration committee of the Company comprises two independent non-executive Directors and one executive Director.

Dr. Tsim Wah Keung, Karl is the chairman of the remuneration committee and Ms. Leelalertsuphakun Wanee and Dr. Chan Yau Ching, Bob are members of the remuneration committee. The Company has adopted the model to make recommendations to the Board to determine the remuneration packages of individual executive Director and senior management. The major roles and functions of the Company's remuneration committee are as follows:

- Establish and apply a formal and transparent procedure for setting policy on remuneration for executive Directors and senior management, and for fixing the remuneration packages for all Directors and senior management; and
- b. Ensure that procedures and principles for fixing packages of all Directors and senior management are proper so that the levels of remuneration of Directors commensurate with their qualifications and competencies, and that such remuneration is sufficient to attract and retain the Directors and senior management but not excessive.

Shareholders shall have the right to request the Board to convene an extraordinary general meeting ("**EGM**") of the Company. Two or more shareholders holding in aggregate of not less than one-tenth (10%) of the paid up capital of the Company which carries the right of voting at the general meeting of the Company may send a written request to the Board of the Company to request for an EGM. The written requisition, duly signed by the shareholders concerned, must state the purposes of the meeting and must be deposited at the registered office of the Company.

Shareholders who wish to move a resolution at general meetings may follow the procedures set out in the preceding paragraph.

OPINION

We have audited the consolidated financial statements of Lee's Pharmaceutical Holdings Limited (the "Company") and its subsidiaries (collectively referred to as "the Group") set out on pages 75 to 224, which comprise the consolidated statement of financial position as at 31 December 2021, and consolidated statement of profit or loss, consolidated statement of profit or loss and other comprehensive income, consolidated statement of changes in equity and consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including a summary of significant accounting policies.

KEY AUDIT MATTERS

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

Revenue recognition (refer to note 7 and 8 to the consolidated financial statements)

The Group's revenue amounted to HK\$1,266 million for the year ended 31 December 2021. Sales of goods are recognised as revenue when goods are delivered and titles have been passed.

We identified the recognition of revenue as a key audit matter because revenue is one of the key performance indicators of the Group and therefore there is an inherent risk of manipulation of the timing of recognition of revenue.

Our response

Our main procedures in relation to revenue recognition included:

- Obtaining evidence regarding the transfer of control of ownership.
- Testing the key internal controls over revenue recognition, and assessing whether the accounting policy related to revenue recognition was applied appropriately and consistently throughout the year.
- On a sample basis, making selections from sales records and delivery records, and tracing to their contracts, delivery orders and customer's acknowledgement of receipts, and paying special attention to samples before and after the end of the reporting period to assess whether the relevant revenue was recognised in the correct period.

Based on our procedures described, we found that the amount and timing of the revenue recorded were supported by available evidence.

關鍵審計事項

關鍵審計事項是根據我們的專業判斷,認為對本期財務 報表的審計最為重要的事項。這些事項是在我們審計整 體綜合財務報表及出具意見時進行處理的。我們不會對 這些事項提供單獨的意見。

收益確認 (參閱綜合財務報表附註7及8)

貴集團於截至二零二一年十二月三十一日止年度的收益 為1,266百萬港元。銷售貨品於交付貨品及所有權已易 手時予以確認。

我們將收益確認識別為關鍵審計事項,乃由於收益 為 貴集團關鍵業績指標之一,因此存在操縱收益確認 時點的內在風險。

我們的回應

我們有關收益確認的主要程序包括:

- 取得有關擁有權的控制權轉移的憑證。
- 測試與收益確認相關的關鍵內部控制,並評估收益確認的相關會計政策在本年度是否適當且一貫地運用。
- 以抽查為基礎,從銷售記錄及交付記錄中作出甄選,追查與該筆銷售相關的合同、交付單及客戶確認收據,特別關注報告期完結前後的樣本,以評估相關收益是否在正確的期間確認。

根據上述程序,我們發現所記錄收益的金額及時間可以 現有憑證佐證。

Valuation of retirement benefits on defined benefit plan (refer to note 38 to the consolidated financial (參閱綜合財務報表附註38) statements)

The Group entered into service contracts with the executive directors to provide certain retirement benefits. There is judgement in determining valuation of the retirement benefits as recorded at the end of the reporting period. The valuation is based on a number of assumptions including discount rate, growth rate of salary and life expectancy.

Our response

Our main procedures in relation to the valuation of the retirement benefits on defined benefit plan included:

- Assessing the independence and competence of the independent external valuer appointed by the Group to calculate the fair value of the retirement benefits.
- Assessing the accuracy and relevance of the input data provided by management to the independent external valuer by challenging and corroborating the market data and information from similar transactions from independent sources.
- Evaluating appropriateness of the methodology and assumptions used by the independent external valuer.
- Testing mathematical accuracy of the underlying valuation.

We found the methodology and key assumptions to be reasonable.

Intangible assets recognition and impairment assessment (refer to note 20 to the consolidated financial (參閱綜合財務報表附註20) statements)

As at 31 December 2021, the Group reported intangible assets of HK\$923 million, of which HK\$621 million were capitalised development expenditure and HK\$302 million were license fee.

Development expenditure mainly comprised of development of pharmaceutical products. The Group capitalised eligible product development costs upon meeting the criteria as described in Hong Kong Accounting Standard 38 "Intangible Assets" ("HKAS 38"). Capitalisation criteria assessment requires significant management judgement and there is measurement uncertainty at inception and throughout the lives of the individual projects.

對定額福利計劃之退休福利進行估值

貴集團與執行董事訂有服務合約以提供若干退休福利。 在釐定退休福利於報告期完結時之估值時須作出判斷。 有關估值乃以多項假設為基礎,包括貼現率、薪金增長 率及預期壽命。

我們的回應

我們有關定額福利計劃之退休福利估值的主要程序包括:

- 評估 貴集團為計算退休福利公平值委聘的獨立 外部估值師的獨立性及能力。
- 通過質疑及核實源自獨立來源之類似交易的市場 數據及資料,評估管理層向獨立外部估值師提供 的輸入數據是否準確及相關。
- 評估獨立外部估值師所採用方法與假設是否合適。
- 測試相關估值計算之算術準確性。

我們發現該等方法及主要假設屬合理。

無形資產確認及減值評估

於二零二一年十二月三十一日, 貴集團錄得無形資產 923百萬港元,當中621百萬港元為已撥充資本之開發 支出及302百萬港元為專利費。

開發支出主要包括開發醫藥產品。 貴集團在合資格產 品開發成本符合《香港會計準則》第38號「無形資產」(「香 港會計準則第38號|)所述條件時將之撥充資本。評定資 本化條件須作出重大管理判斷,且個別項目開始及整個 年期均涉及計量上的不明朗性。

獨立核數師報告

Management is required to assess at the end of each reporting period whether any indication of impairment exists, which requires significant management judgement and assumptions with reference to the ability to use or sell the products, its future market or economic development.

管理層須在每個報告期完結時評估是否有任何減值跡象 存在,而有關評估是需要按使用或銷售產品能力、未來 市場或經濟發展作出重要管理判斷及假設。

Our response

Our main procedures in relation to the recognition of intangible assets included:

- Gaining an understanding of the business process undertaken by management to assess the appropriate accounting treatment for each project.
- Assessing the reasonableness of recognition and eligibility criteria for intangible assets by challenging the key assumptions used or estimates made in capitalising the cost.
- Testing on a sample basis the expenditure capitalised against source documents and signed contracts.
- Assessing the ownership of license fee.

Our main procedures in relation to the impairment assessment of intangible assets included:

- Assessing management's determination of the impairment based on our understanding of the nature of the Group's business.
- Assessing whether there are any indications of impairment by understanding the business, rationale for the products under development.
- Discussing with and interviewing the responsible staff and managers on the progress and future prospects of respective development projects.
- Selecting products with significant development cost and request for independent valuation to be done for impairment assessment.

Based on our procedures described, we found the recognition and impairment assessment on intangible assets to be reasonable.

我們的回應

我們有關確認無形資產的主要程序包括:

- 了解管理層所從事的業務程序,以評估各項目的 合適會計處理方法。
- 通過質疑將成本撥充資本時所使用的主要假設或 估計,評定無形資產確認的合理性及合格性準則。
- 山抽查為基礎,為撥充資本的開支追查文件及所 簽署合約。
- 評定專利費的擁有權。

我們有關無形資產減值評估的主要程序包括:

- 根據我們對 貴集團業務性質的認識,評定管理 層所釐定的減值。
- 通過了解業務及發展中產品的基礎理論,評定是 否出現任何減值跡象。
- 就相關發展項目的進展及未來前景與負責員工及 經理進行討論及面談。
- 一 甄選開發成本重大的產品以及為減值評估而要求 進行獨立估值。

根據上述程序,我們發現無形資產的確認與減值評估屬 合理。

Impairment assessment of goodwill (refer to note 21 to the consolidated financial statements)

Management is required to assess at the end of each reporting period whether there is any indication that goodwill may be impaired. If any such indication exists, the management shall estimate the recoverable amount of the asset.

Our response

Our main procedures in relation to the impairment assessment of goodwill included:

- Assessing management's determination of the Group's cashgenerating units based on our understanding of the nature of the business and the economic environment in which the cashgenerating units operate.
- Based on our knowledge of the business and industry, challenging the reasonableness of the underlying key assumptions and data used in the cash flow forecasts (including revenue growth rate, operating profit, and discount rate used).

Based on our procedures described, we found the estimations of management in relation to goodwill are supported by plausible evidence.

Fair value measurement of unlisted investments held as financial assets at fair value through other comprehensive income and through profit or loss (refer to note 23 and 24 to the consolidated financial statements)

The Group held several unlisted investments on a combination of market observable inputs, unobservable inputs and valuation techniques. The Group's fair value measurement of the financial assets arising from the unobservable inputs used in determining the fair value of the unlisted investments was grouped under level 3 of fair value hierarchy.

As at 31 December 2021, the Group held several unlisted investments which were measured at fair value amounted to HK\$161 million, which had significant unobservable inputs in the valuation, and hence were categorised within Level 3 of fair value hierarchy, representing 4.43% of the Group's total assets as at 31 December 2021.

商譽之減值評估 (參閱綜合財務報表附註**21**)

管理層須在每個報告期完結時評估商譽是否有任何減值 跡象存在。倘若有任何跡象存在,管理層須估計有關資 產的可收回金額。

我們的回應

我們有關評估商譽減值的主要程序包括:

- 根據我們對 貴集團現金產生單位經營所在業務 性質與經濟環境的認識,評定管理層對現金產生 單位的釐定。
- 根據我們對業務及行業的認識,質疑現金流量預 測所用的相關主要假設及數據(包括所用之收益增 長率、經營溢利及貼現率)之合理性。

根據上述程序,我們發現管理層對有關商譽的估計可以合理憑證佐證。

持作按公平值透過其他全面收益及透 過損益列賬之財務資產之非上市投資 之公平值計量

(參閱綜合財務報表附註23及24)

貴集團持有若干非上市投資,混用多種市場可觀測輸入 數據、不可觀測輸入數據及估值技術。 貴集團在釐定 非上市投資公平值時使用不可觀測數據所產生財務資產 公平值計量乃歸屬於第三級公平值等級的組別內。

於二零二一年十二月三十一日, 貴集團持有若干以公平 值計量之非上市投資161百萬港元,該等非上市投資的 估值採用了重大不可觀測數據,故分類於第三級公平值 等級的組別內,佔 貴集團於二零二一年十二月三十一日資產總值之4.43%。

獨立核數師報告

The valuations of these unlisted investments are conducted by independent qualified valuers. The appropriateness of the valuation is dependent on determination of different valuation techniques and certain key assumptions. With different valuation techniques and assumptions applied, the valuation result can vary significantly.

該等非上市投資的估值由獨立合資格估值師進行。估值 的合適性取決於不同估值技術的釐定與若干關鍵假設。 視乎不同估值技術與所應用的假設, 估值結果可能有很 大的差異。

As the unlisted investments are considered significant due to the size of the balance and the inherent judgement involved in determining the fair value measurement, it is considered as a key audit matter.

由於計量非上市投資公平值所涉及的結餘規模與固有判 斷被視為屬重大,故被視為關鍵審計事項。

The fair value was determined using market approach, income approach and reference to the prices of underlying investment portfolio quoted by administrator. The determination of fair value measurement requires the management to exercise their judgement to ensure the appropriateness of the estimates and assumptions.

公平值的計量採用市場法、收入法及參考基金管理人所 報的相關投資組合價格。釐定所計量公平值須管理層在 確保估計及假設的合適性上作出判斷。

Our response

Our procedures in relation to management's fair value measurement of unlisted investments included:

- Evaluating the independent professional valuers' competence, capabilities and objectivity.
- Focusing on the valuation methodologies and assumptions of unlisted investments that were classified as level 3 in the fair value hierarchy and involving valuation specialists in evaluating and assessing:
 - the valuation techniques through comparison with the valuation techniques that are commonly used in the market;
 - the validation of observable inputs using external market data; and
 - the reasonableness of management's assumptions.
- Checking the accuracy and reasonableness of the input data provided by management to the independent professional valuer.
- Review sensitivity analysis in consideration of the potential impact of reasonably possible upside or downside changes in these key assumptions.

Based on our procedures described, we found the impairment assessment on unlisted investments adopted by management to be reasonable.

我們有關管理層對非上市投資的公平值計量的程序包括:

- 評估獨立專業估值師的技能、能力及客觀性。
- 關注在公平值等級中被歸類為第三級的非上市投 資的估值方法及假設,並於估值專家估值及評估 以下各項:
 - 通過與市場上常用的估值技術比較估值技
 - 使用外部市場數據驗證可觀察輸入數據;
 - 管理層假設的合理性。
- 檢查管理層向獨立專業估值師提供的輸入數據的 準確性和合理性。
- 考慮到該等關鍵假設中合理可能的上行或下行變 化的潛在影響,檢討敏感度分析。

根據上述程序,我們發現管理層就非上市投資所採納的 減值評估屬合理。



1. GENERAL INFORMATION

Lee's Pharmaceutical Holdings Limited (the "Company") is a limited company incorporated in the Cayman Islands and its shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). In additions, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited ("Listing Rules") and by the Hong Kong Companies Ordinance ("CO").

Basis of preparation

The consolidated financial statements have been prepared on the historical cost basis except for certain financial instruments that are measured at fair values at the end of each reporting period, as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 "Share-based Payment" ("HKFRS 2"), leasing transactions that are accounted for in accordance with HKFRS 16 "Leases" ("HKFRS 16"), and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 "Inventories" or value in use in HKAS 36 "Impairment of Assets" ("HKAS 36").

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirely, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

The principal accounting policies are set out below.

Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies in line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

Non-controlling interests in subsidiaries are presented separately from the Group's equity therein, which represent the interests entitling their holders to a proportionate share of net assets of the relevant subsidiaries upon liquidation.

Changes in the Group's interests in existing subsidiaries

Changes in the Group's interests in existing subsidiaries that do not result in the Group losing control over the subsidiaries are accounted for as equity transactions. The carrying amounts of the Group's relevant components of equity and the non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiaries, including re-attribution of relevant reserves between the Group and the non-controlling interests according to the Group's and the non-controlling interests' proportionate interests.

Any difference between the amount by which the non-controlling interests are adjusted, and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

When the Group loses control of a subsidiary, the assets and liabilities of that subsidiary and non-controlling interests (if any) are derecognised. A gain or loss is recognised in profit or loss and is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest and (ii) the carrying amount of the assets (including goodwill), and liabilities of the subsidiary attributable to the owners of the Company. All amounts previously recognised in other comprehensive income in relation to that subsidiary are accounted for as if the Group had directly disposed of the related assets or liabilities of the subsidiary (i.e. reclassified to profit or loss or transferred to another category of equity as specified/permitted by applicable HKFRSs). The fair value of any investment retained in the former subsidiary at the date when control is lost is regarded as the fair value on initial recognition for subsequent accounting under HKFRS 9 "Financial Instruments" ("HKFRS 9") or, when applicable, the cost on initial recognition of an investment in an associate.

Business combinations

Acquisitions of businesses are accounted for using the acquisition method. The consideration transferred in a business combination is measured at fair value, which is calculated as the sum of the acquisition-date fair values of the assets transferred by the Group, liabilities incurred by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. Acquisition-related costs are generally recognised in profit or loss as incurred.

Except for certain recognition exemptions, the identifiable assets acquired and liabilities assumed must meet the definitions of an asset and a liability in the International Accounting Standards Committee's Framework for the Preparation and Presentation of Financial Statements (replaced by the Conceptual Framework for Financial Reporting issued in September 2010).

At the acquisition date, the identifiable assets acquired and the liabilities assumed are recognised at their fair value, except that:

- deferred tax assets or liabilities, and assets or liabilities related to employee benefit arrangements are recognised and measured in accordance with HKAS 12 "Income Taxes" and HKAS 19 "Employee Benefits" respectively;
- liabilities or equity instruments related to share-based payment arrangements of the acquiree or share-based payment arrangements of the Group entered into to replace share-based payment arrangements of the acquiree are measured in accordance with HKFRS 2 at the acquisition date;

Goodwill is measured as the excess of the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree, and the fair value of the acquirer's previously held equity interest in the acquiree (if any) over the net amount of the identifiable assets acquired and the liabilities assumed as at acquisition date. If, after reassessment, the net amount of the identifiable assets acquired and liabilities assumed exceeds the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value of the acquirer's previously held interest in the acquiree (if any), the excess is recognised immediately in profit or loss as a bargain purchase gain.

Non-controlling interests that are present ownership interests and entitle their holders to a proportionate share of the relevant subsidiary's net assets in the event of liquidation are initially measured at the non-controlling interests' proportionate share of the recognised amounts of the acquiree's identifiable net assets or at fair value. The choice of measurement basis is made on a transaction-by-transaction basis.

When the consideration transferred by the Group in a business combination includes a contingent consideration arrangement, the contingent consideration is measured at its acquisition-date fair value and included as part of the consideration transferred in a business combination. Changes in the fair value of the contingent consideration that qualify as measurement period adjustments are adjusted retrospectively. Measurement period adjustments are adjustments that arise from additional information obtained during the "measurement period" (which cannot exceed one year from the acquisition date) about facts and circumstances that existed at the acquisition date.

The subsequent accounting for the contingent consideration that does not qualify as measurement period adjustments depends on how the contingent consideration is classified. Contingent consideration that is classified as equity is not remeasured at subsequent reporting dates and its subsequent settlement is accounted for within equity. Contingent consideration that is classified as an asset or a liability is remeasured to fair value at subsequent reporting dates, with the corresponding gain or loss being recognised in profit or loss.

When a business combination is achieved in stages, the Group's previously held equity interest in the acquiree is remeasured to fair value at the acquisition date (i.e. the date when the Group obtains control), and the resulting gain or loss, if any, is recognised in profit or loss or other comprehensive income, as appropriate. Amounts arising from interests in the acquiree prior to the acquisition date that have previously been recognised in other comprehensive income and measured under HKFRS 9 would be accounted for on the same basis as would be required if the Group had disposed directly of the previously held equity interest.

If the initial accounting for a business combination is incomplete by the end of the reporting period in which the combination occurs, the Group reports provisional amounts for the items for which the accounting is incomplete. Those provisional amounts are adjusted retrospectively during the measurement period (see above), and additional assets or liabilities are recognised, to reflect new information obtained about facts and circumstances that existed at the acquisition date that, if known, would have affected the amounts recognised at that date.

Investments in subsidiaries

Investments in subsidiaries are included in the Company's statement of financial position at cost less any identified impairment losses. The results of subsidiaries are accounted for by the Company on the basis of dividends received and receivable.

Goodwill

Goodwill arising on an acquisition of a business is carried at cost as established at the date of acquisition of the business (see the accounting policy above) less accumulated impairment losses, if any.

For the purposes of impairment testing, goodwill is allocated to each of the Group's cash-generating units ("CGUs") (or group of CGUs) that is expected to benefit from the synergies of the combination, which represent the lowest level at which the goodwill is monitored for internal management purposes and not larger than an operating segment.

A CGU (or group of CGUs) to which goodwill has been allocated is tested for impairment annually or more frequently when there is indication that the unit may be impaired. For goodwill arising on an acquisition in a reporting period, the CGU (or group of CGUs) to which goodwill has been allocated is tested for impairment before the end of that reporting period. If the recoverable amount of the CGU (or group of CGUs) is less than its carrying amount, the impairment loss is allocated first to reduce the carrying amount of any goodwill and then to the other assets on a pro-rata basis based on the carrying amount of each asset in the unit (or group of CGUs). Any impairment loss for goodwill is recognised directly in profit or loss. An impairment loss recognised for goodwill is not reversed in subsequent periods.

On disposal of the relevant CGU or any of the CGU within the group of CGUs, the attributable amount of goodwill is included in the determination of the amount of profit or loss on disposal. When the Group disposes of an operation within the CGU (or a CGU within a group of CGUs), the amount of goodwill disposed of is measured on the basis of the relative values of the operation (or the CGU) disposed of and the portion of the CGU (or the group of CGUs) retained.

The Group's policy for goodwill arising on the acquisition of an associate is described below.

Investments in associates

An associate is an entity over which the Group has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee but is not control or joint control over those policies.

The results and assets and liabilities of associates are incorporated in these consolidated financial statements using the equity method of accounting. The financial statements of associates used for equity accounting purposes are prepared using uniform accounting policies as those of the Group for like transactions and events in similar circumstances. Under the equity method, an investment in an associate is initially recognised in the consolidated statement of financial position at cost and adjusted thereafter to recognise the Group's share of the profit or loss and other comprehensive income of the associate. Changes in net assets of the associate other than profit or loss and other comprehensive income are not accounted for unless such changes resulted in changes in ownership interest held by the Group. When the Group's share of losses of an associate exceeds the Group's interest in that associate (which includes any long-term interests that, in substance, form part of the Group's net investment in the associate), the Group discontinues recognising its share of further losses. Additional losses are recognised only to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the associate.

An investment in an associate is accounted for using the equity method from the date on which the investee becomes an associate. On acquisition of the investment in an associate, any excess of the cost of the investment over the Group's share of the net fair value of the identifiable assets and liabilities of the investee is recognised as goodwill, which is included within the carrying amount of the investment. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of the investment, after reassessment, is recognised immediately in profit or loss in the period in which the investment is acquired.

The Group assesses whether there is an objective evidence that the interest in an associate may be impaired. When any objective evidence exists, the entire carrying amount of the investment (including goodwill) is tested for impairment in accordance with HKAS 36 as a single asset by comparing its recoverable amount (higher of value in use and fair value less costs of disposal) with its carrying amount. Any impairment loss recognised is not allocated to any asset, including goodwill, that forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with HKAS 36 to the extent that the recoverable amount of the investment subsequently increases.

When the Group ceases to have significant influence over an associate, it is accounted for as a disposal of the entire interest in the investee with a resulting gain or loss being recognised in profit or loss. When the Group retains an interest in the former associate and the retained interest is a financial asset within the scope of HKFRS 9, the Group measures the retained interest at fair value at that date and the fair value is regarded as its fair value on initial recognition. The difference between the carrying amount of the associate at the date the equity method was discontinued, and the fair value of any retained interest and any proceeds from disposing the relevant interest in the associate is included in the determination of the gain or loss on disposal of the associate. In addition, the Group accounts for all amounts previously recognised in other comprehensive income in relation to that associate on the same basis as would be required if that associate had directly disposed of the related assets or liabilities. Therefore, if a gain or loss previously recognised in other comprehensive income by that associate would be reclassified to profit or loss on the disposal of the related assets or liabilities, the Group reclassifies the gain or loss from equity to profit or loss (as a reclassification adjustment) upon disposal/partial disposal of the relevant associate.

When the Group reduces its ownership interest in an associate but the Group continues to use the equity method, the Group reclassifies to profit or loss the proportion of the gain or loss that had previously been recognised in other comprehensive income relating to that reduction in ownership interest if that gain or loss would be reclassified to profit or loss on the disposal of the related assets or liabilities.

When a group entity transacts with an associate of the Group, profits and losses resulting from the transactions with the associate are recognised in the Group's consolidated financial statements only to the extent of interests in the associate that are not related to the Group.

Revenue from contracts with customers

The Group recognises revenue when (or as) a performance obligation is satisfied, i.e. when "control" of the goods or services underlying the particular performance obligation is transferred to the customer.

A performance obligation represents a good or service (or a bundle of goods or services) that is distinct or a series of distinct goods or services that are substantially the same.

Control is transferred over time and revenue is recognised over time by reference to the progress towards complete satisfaction of the relevant performance obligation if one of the following criteria is met:

- the customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs;
- the Group's performance creates or enhances an asset that the customer controls as the Group performs; or
- the Group's performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

Otherwise, revenue is recognised at a point in time when the customer obtains control of the distinct good or service.

Further details of the Group's revenue and other income recognition policies are as follows:

Manufacturing of proprietary and generic products and trading of licensed-in products

Revenue from manufacturing of proprietary and generic products and trading of licensed-in products are recognised at a point in time when control of the asset is transferred to the customer, generally on delivery of the product and accepted by the customers. No right of return by customers is allowed based on contractual terms. Revenue is thus recognised when the products are delivered to the customers and the customers accepted the products. There is generally only one performance obligation and the consideration include no variable amount.

Other income

Licensing income is recognised over time on a time proportion basis throughout the license period as providing the licensees the right to use the Group's intellectual property.

Research and development service income is recognised when the Group renders the services and all the benefits are received and consumed simultaneously by customer throughout the contract period. Thus, the Group satisfies a performance obligation and recognises as over time.

Rental and utilities income is recognised on a time proportion basis over the lease terms.

Interest income is accrued on a time basis on the principal outstanding at the applicable interest rate, which is the rate that exactly discounts the estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition.

Contract balances

A contract asset represents the Group's right to consideration in exchange for goods or services that the Group has transferred to a customer that is not yet unconditional. It is assessed for impairment in accordance with HKFRS 9. In contrast, a receivable represents the Group's unconditional right to consideration, i.e. only the passage of time is required before payment of that consideration is due.

A contract liability represents the Group's obligation to transfer goods or services to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer. If a customer pays consideration before the Group transfers goods or services to the customer, a contract liability is recognised when the payment is made or the payment is due (whichever is earlier). Contract liabilities are recognised as revenue when the Group performs under the contract.

A contract asset and a contract liability relating to the same contract are accounted for and presented on a net basis.

Leasing

Definition of a lease

A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

For contracts entered into or modified or arising from business combinations on or after the date of initial application, the Group assesses whether a contract is or contains a lease based on the definition under HKFRS 16 at inception, modification date or acquisition date, as appropriate. Such contract will not be reassessed unless the terms and conditions of the contract are subsequently changed.

(a) Allocation of consideration to components of a contract

For a contract that contains a lease component and one or more additional lease or non-lease components, the Group allocates the consideration in the contract to each lease component on the basis of the relative stand-alone price of the lease component and the aggregate stand-alone price of the non-lease components.

(b) Short-term leases and leases of low-value assets

The Group applies the short-term lease recognition exemption to leases of machinery and equipment and premises that have a lease term of 12 months or less from the commencement date and do not contain a purchase option. It also applies the recognition exemption for lease of low-value assets. Lease payments on short-term leases and leases of low-value assets are recognised as expense on a straight-line basis or another systematic basis over the lease term.

(c) Right-of-use assets

The cost of right-of-use asset includes:

- the amount of the initial measurement of the lease liability;

- any initial direct costs incurred by the Group; and

Right-of-use assets are measured at cost, less any accumulated depreciation and impairment losses, and adjusted for any remeasurement of lease liabilities.

Right-of-use assets in which the Group is reasonably certain to obtain ownership of the underlying leased assets at the end of the lease term are depreciated from commencement date to the end of the useful life. Otherwise, right-of-use assets are depreciated on a straight-line basis over the shorter of its estimated useful life and the lease term.

When the Group obtains ownership of the underlying leased assets at the end of the lease term, upon exercising purchase options, the cost of the relevant right-of-use assets and the related accumulated depreciation and impairment loss are transferred to property, plant and equipment.

The Group presents right-of-use assets in "property, plant and equipment", the same line item within which the corresponding underlying assets would be presented if they were owned.

(d) Refundable rental deposits

Refundable rental deposits paid are accounted under HKFRS 9 and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments and included in the cost of right-of-use assets.

(e) Lease liabilities

At the commencement date of a lease, the Group recognises and measures the lease liability at the present value of lease payments that are unpaid at that date. In calculating the present value of lease payments, the Group uses the incremental borrowing rate at the lease commencement date if the interest rate implicit in the lease is not readily determinable.

(a) Classification and measurement of leases

Leases for which the Group is a lessor are classified as finance or operating leases. Whenever the terms of the lease transfer substantially all the risks and rewards incidental to ownership of an underlying asset to the lessee, the contract is classified as a finance lease. All other leases are classified as operating leases.

Rental income from operating leases is recognised in profit or loss on a straight line basis over the term of the relevant lease. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset, and such costs are recognised as an expense on a straight-line basis over the lease term. Rental income is included in "other income" in profit or loss.

(b) Allocation of consideration to components of a contract

When a contract includes both leases and non-lease components, the Group applies HKFRS 15 "Revenue from Contracts with Customers" ("HKFRS 15") to allocate consideration in a contract to lease and non-lease components. Non-lease components are separated from lease component on the basis of their relative stand-alone selling prices.

(c) Refundable rental deposits

Refundable rental deposits received are accounted for under HKFRS 9 and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments from lessees.

(d) Lease modification

Changes in considerations of lease contracts that were not part of the original terms and conditions are accounted for as lease modifications, including lease incentives provided through forgiveness or reduction of rentals.

The Group accounts for a modification to an operating lease as a new lease from the effective date of the modification, considering any prepaid or accrued lease payments relating to the original lease as part of the lease payments for the new lease.

Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing at the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise, except for exchange differences on monetary items receivable from or payable to a foreign operation for which settlement is neither planned nor likely to occur (therefore forming part of the net investment in the foreign operation), which are recognised initially in other comprehensive income and reclassified from equity to profit or loss on disposal or partial disposal of the Group's interests in associates.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. Hong Kong Dollars) using exchange rates prevailing at the end of each reporting period. Income and expenses items are translated at the average exchange rates for the period, unless exchange rates fluctuate significantly during that period, in which case the exchange rates at the dates of the transactions are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of exchange reserve (attributed to non-controlling interests as appropriate).

On the disposal of a foreign operation (that is, a disposal of the Group's entire interest in a foreign operation, or a disposal involving loss of control over a subsidiary that includes a foreign operation, or a partial disposal of an interest in an associate that includes a foreign operation of which the retained interest becomes a financial asset), all of the exchange differences accumulated in equity in respect of that operation attributable to the owners of the Company are reclassified to profit or loss.

Goodwill and fair value adjustments on identifiable assets acquired on an acquisition of a foreign operation are treated as assets and liabilities of the foreign operation and translated at the rate of exchange prevailing at the end of each reporting period. Exchange differences arising are recognised in other comprehensive income.

Borrowing costs

Borrowings costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost to those assets, until such time as the assets are substantially ready for their intended use or sale.

Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

Government grants

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grant will be received.

Government grants are recognised in profit or loss on a systematic basis over the periods in which the Group recognises as expenses the related costs for which the grants are intended to compensate. Specifically, government grants whose primary condition is that the Group should purchase, construct or otherwise acquire non-current assets are recognised as a deduction from the carrying amount of the relevant asset in the consolidated statement of financial position and transferred to profit or loss on a systematic and rational basis over the useful lives of the related assets.

Government grants related to income that are receivable as compensation for expenses or losses already incurred or for the purposes of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable. Such grants are presented under "other income" in profit or loss.

Retirement benefits

Defined contribution plan

Retirement benefits are provided to eligible staff of the Group. Hong Kong employees enjoy retirement benefits under the Mandatory Provident Fund Scheme. The employer's monthly contribution is 5% of each employee's monthly salary with maximum amount of HK\$1,500 per month for each employee.

The pension schemes covering all the Group's employees in the People's Republic of China (the "PRC") and Taiwan are defined contribution schemes at various funding rates, and are in accordance with the local practices and regulations.

Payments to defined contribution retirement benefit plans (including state-managed retirement benefit schemes and the Mandatory Provident Fund Scheme) are recognised as an expense when employees have rendered service entitling them to the contributions.

本集團為其合資格之員工提供退休金福利。香港僱員可獲得強制性公積金計劃之退休福利。僱主之每月供款是每位僱員月薪之5%,每位僱員每月最多獲供1,500港元。

本集團為所有中華人民共和國(「中國」)及台灣僱員而設之退休金計劃是按多個供款率定額供款之計劃,供款率按當地慣例及規定而制定。

用以支付界定之供款退休福利計劃(包括國家管理 退休福利計劃及強制性公積金計劃)之款項於僱員 已提供使彼等有權享受供款之服務時確認為開支。

Defined benefit plan

For defined retirement benefits plan, the cost of providing benefits is determined by the valuation conducted by independent valuer at the end of the reporting period, amortised over the expected average remaining working lives of the participating directors.

The retirement benefits recognised in the consolidated statement of financial position represents the cost of providing benefits, based on the valuation.

Short-term employee benefits

Short-term employee benefits are recognised at the undiscounted amount of the benefits expected to be paid as and when employees rendered the service. All short-term employee benefits are recognised as an expense unless another HKFRS requires or permits the inclusion of the benefit in the cost of an asset.

A liability is recognised for benefits accruing to employees (such as wages and salaries, annual leave and sick leave) after deducting any amount already paid.

Share-based payment arrangements

Equity-settled share-based payment transactions

Equity-settled share-based payments to employees and others providing similar services are measured at the fair value of the equity instruments at the grant date. Details regarding the determination of the fair value of equity-settled share-based transactions are set out in note 37 to the consolidated financial statements.

The fair value of the equity-settled share-based payments determined at the grant date without taking into consideration all non-market vesting conditions is expensed on a straight-line basis over the vesting period, based on the Group's estimate of equity instruments that will eventually vest, with a corresponding increase in equity (share-based compensation reserve). At the end of each reporting period, the Group revises its estimate of the number of equity instruments expected to vest based on assessment of all relevant non-market vesting conditions. The impact of the revision of the original estimates, if any, is recognised in profit or loss such that the cumulative expense reflects the revised estimate, with a corresponding adjustment to share-based compensation reserve.

Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax.

Current tax

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit/loss before taxation because of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit. In addition, deferred tax liabilities are not recognised if the temporary difference arises from the initial recognition of goodwill.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries and associates, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reserve in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purposes of measuring deferred tax for leasing transactions in which the Group recognises the right-of-use assets and the related lease liabilities, the Group first determines whether the tax deductions are attributable to the right-of-use assets or the lease liabilities.

For leasing transactions in which the tax deductions are attributable to the lease liabilities, the Group applies HKAS 12 "Income Taxes" requirements to the leasing transaction as a whole. Temporary differences relating to right-of-use assets and lease liabilities are assessed on a net basis. Excess of depreciation on right-of-use assets over the lease payments for the principal portion of lease liabilities resulting in net deductible temporary differences.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied to the same taxable entity by the same taxation authority.

Current and deferred tax for the year

Current and deferred tax are recognised in profit or loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively. Where current tax or deferred tax arises from the initial accounting for a business combination, the tax effect is included in the accounting for the business combination.

In assessing any uncertainty over income tax treatments, the Group considers whether it is probable that the relevant tax authority will accept the uncertain tax treatment used, or proposed to be use by individual group entities in their income tax filings. If it is probable, the current and deferred taxes are determined consistently with the tax treatment in the income tax filings. If it is not probable that the relevant taxation authority will accept an uncertain tax treatment, the effect of each uncertainty is reflected by using either the most likely amount or the expected value.

Property, plant and equipment

Property, plant and equipment are tangible assets that are held for use in the production or supply of goods or services, or for administrative purposes (other than construction in progress as described below), are stated in the consolidated statement of financial position at cost, less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

Properties in the course of construction for production, supply or administrative purposes are carried at cost, less any recognised impairment loss. Costs include any costs directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management and, for qualifying assets, borrowing costs capitalised in accordance with the Group's accounting policy. Depreciation of these assets, on the same basis as other property assets, commences when the assets are ready for their intended use.

Some properties comprise a portion that is held to earn rentals and another portion is held for use in the supply of goods or services or for administrative purpose. If these portions could be sold separately (or leased out separately under a finance lease), these portions shall be accounted for separately, if the portions could not be sold separately, the property is classified as property, plant and equipment.

Depreciation is recognised so as to write off the cost of assets (other than construction in progress) less their residual values over their useful lives, using the straight-line method, at the following rates per annum:

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

Intangible assets

License fee (intangible assets acquired separately)

License fees are consideration paid for the license contracts and are carried at cost less accumulated amortisation and accumulated impairment losses. License fees with finite useful lives are amortised from the date they are ready for intended use over the remaining license period. The license period ranges from 3 to 10 years, with certain licenses contain renewal clause.

Both the period and method of amortisation are reviewed annually, with the effect of any changes in estimate being accounted for on a prospective basis.

License fees with indefinite useful lives are carried at cost less accumulated impairment losses, if any.

Development cost (internally-generated intangible assets – research and development expenditure)

Expenditure on research activities is recognised as an expense in the period in which it is incurred.

An internally-generated intangible asset arising from development of licensed-in products or from the development phase of internal projects is recognised if, and only if, all of the following have been demonstrated:

- the technical feasibility of completing the intangible asset so that it will be available for use or sale;
- the intention to complete the intangible asset and use or sell it:
- the ability to use or sell the intangible asset;
- how the intangible asset will generate probable future economic benefits;
- the availability of adequate technical, financial and other resources to complete the development and to use or sell the intangible asset; and
- the ability to measure reliably the expenditure attributable to the intangible asset during its development.

Development cost (internally-generated intangible assets - research and development expenditure) (Continued)

The amount initially recognised for internally-generated intangible assets is the sum of the expenditure incurred from the date when the intangible asset first meets the recognition criteria listed above. Where no internally-generated intangible asset can be recognised, development expenditure is recognised in profit or loss in the period in which it is incurred.

Subsequent to initial recognition, internally-generated intangible assets are reported at cost less accumulated amortisation and accumulated impairment losses. Amortisation commences when the development of products completes. Amortisation of development cost of internal projects is over the estimated useful life of 5 years, while amortisation of development cost of licensed-in products is on the same basis as license fees.

The estimated useful life and amortisation method are reviewed at the end of each reporting period, with the effect of any changes in estimate being accounted for on a prospective basis.

Intangible assets acquired in a business combination

Intangible assets acquired in a business combination and recognised separately from goodwill are initially recognised at their fair value at the acquisition date (which is regarded as their cost).

Subsequent to initial recognition, intangible assets acquired in a business combination are reported at cost less accumulated amortisation and accumulated impairment losses, on the same basis as intangible assets that are acquired separately.

Derecognition of intangible assets

An intangible asset is derecognised on disposal, or when no future economic benefits are expected from use or disposal. Gains and losses arising from derecognition of an intangible asset, measured as the difference between the net disposal proceeds and the carrying amount of the asset, are recognised in profit or loss when the asset is derecognised.

At the end of each reporting period, the Group reviews the carrying amounts of its property, plant and equipment, right-of-use assets, and intangible assets with finite useful lives to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss (if any).

The recoverable amount of property, plant and equipment, right-ofuse assets, and intangible assets are estimated individually. When it is not possible to estimate the recoverable amount individually, the Group estimates the recoverable amount of the CGU to which the asset belongs.

In addition, the Group assesses whether there is indication that corporate assets may be impaired. If such indication exists, corporate assets are also allocated to individual CGUs, when a reasonable and consistent basis of allocation can be identified, or otherwise they are allocated to the smallest group of CGUs for which a reasonable and consistent allocation basis can be identified.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset (or a CGU) for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or a CGU) is estimated to be less than its carrying amount, the carrying amount of the asset (or a CGU) is reduced to its recoverable amount. For corporate assets or portion of corporate assets which cannot be allocated on a reasonable and consistent basis to a CGU, the Group compares the carrying amount of a group of CGUs, including the carrying amounts of the corporate assets or portion of corporate assets allocated to that group of CGUs, with the recoverable amount of the group of CGUs. In allocating the impairment loss, the impairment loss is allocated first to reduce the carrying amount of any goodwill (if applicable) and then to the other assets on a pro-rata basis based on the carrying amount of each asset in the unit or the group of CGU. The carrying amount of an asset is not reduced below the highest of its fair value less costs of disposal (if measurable), its value in use (if determinable) and zero. The amount of the impairment loss that would otherwise have been allocated to the asset is allocated pro rata to the other assets of the unit or the group of CGUs. An impairment loss is recognised immediately in profit or loss.

Where an impairment loss subsequently reverses, the carrying amount of the asset (or CGU or a group of CGUs) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or a CGU or a group of CGUs) in prior years. A reversal of an impairment loss is recognised immediately in profit or loss.

Inventories

Inventories are stated at the lower of cost and net realisable value. Costs of inventories are determined on weighted average method. Cost of finished goods and work in progress comprises raw materials, direct labour, other direct cost and related production overheads (based on normal operating capacity). Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale.

Provisions

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, it is probable that the Group will be required to settle that obligation, and a reliable estimate can be made of the amount of the obligation.

The amount recognised as a provision is the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation. When a provision is measured using the cash flows estimated to settle the present obligation, its carrying amount is the present value of those cash flows (where the effect of the time value of money is material).

When some or all of the economic benefits required to settle a provision are expected to be recovered from a third party, a receivable is recognised as an asset if it is virtually certain that reimbursement will be received and the amount of the receivable can be measured reliably.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the market place.

Financial assets and financial liabilities are initially measured at fair value except for trade receivables arising from contracts with customers which are initially measured in accordance with HKFRS 15. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets or financial liabilities at fair value through profit or loss ("FVTPL")) added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at FVTPL are recognised immediately in profit or loss.

The effective interest method is a method of calculating the amortised cost of a financial asset or financial liability and of allocating interest income and interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts and payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial asset or financial liability, or, where appropriate, a shorter period, to the net carrying amount on initial recognition.

The cumulative gain or loss will not be reclassified to profit or loss on disposal of the equity investments/partnership interests, and will be transferred to retained profits.

The Group performs impairment assessment under expected credit loss ("ECL") model on financial assets (including trade and other receivables (excluding prepayments and other items which were not financial instruments), deposits, loan receivables, advance to associates, pledged bank deposits, time deposits and cash and bank balances) which are subject to impairment under HKFRS 9. The amount of ECL is updated at each reporting date to reflect changes in credit risk since initial recognition.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of the relevant instrument. In contrast, 12-month ECL ("12m ECL") represents the portion of lifetime ECL that is expected to result from default events that are possible within 12 months after the reporting date. Assessment are done based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current conditions at the reporting date as well as the forecast of future conditions.

The Group always recognises lifetime ECL for trade receivables without significant financing component. The ECL on these assets are assessed collectively using a provision matrix with appropriate groupings.

For all other instruments, the Group measures the loss allowance equal to 12m ECL, unless when there has been a significant increase in credit risk since initial recognition, the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increases in the likelihood or risk of a default occurring since initial recognition.

(i) Significant increase in credit risk

In assessing whether the credit risk has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk, e.g. a significant increase in the credit spread, the credit default swap prices for the debtor;

(ii) Definition of default

For internal credit risk management, the Group considers an event of default occurs when information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full.

Irrespective of the above, the Group considers default has occurred when a financial asset is more than 365 days pass due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward-looking information. Estimation of ECL reflects an unbiased and probabilityweighted amount that is determined with the respective risks of default occurring as the weights.

Generally, the ECL is the difference between all contractual cash flows that are due to the Group in accordance with the contract and the cash flows that the Group expects to receive, discounted at the effective interest rate determined at initial recognition.

Where ECL is measured on a collective basis or cater for cases where evidence at the individual instrument level may not yet be available, the financial instruments are grouped on the basis:

Derivative financial instruments

Derivatives are initially recognised at fair value at the date when derivative contracts are entered into and are subsequently remeasured to their fair value at the end of the reporting period. The resulting gain or loss is recognised in profit or loss.

A financial asset and a financial liability are offset and the net amount presented in the statement of financial position when, and only when, the Group currently has a legally enforceable right to set off the recognised amounts; and intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously.

Cash and cash equivalents

In the application of the Group's accounting policies, which are described in note 3 to the consolidated financial statements, the directors of the Company are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on the historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Key sources of estimation uncertainty

The following are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period that may have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

Estimated impairment of goodwill

The Group determines whether goodwill is impaired at least on an annual basis. This requires an estimation of the value in use of the CGUs to which the goodwill is allocated. Estimating the value in use requires the Group to make an estimate of the expected future cash flows from the CGUs and also to choose a suitable discount rate in order to calculate the present value of those cash flows. As at 31 December 2021, the carrying amount of goodwill is HK\$3,900,000 (net of impairment loss provision HK\$2,342,000) (31 December 2020: HK\$3,900,000, net of HK\$2,342,000 impairment loss provision). Details of the recoverable amount calculation are disclosed in note 21 to the consolidated financial statements.

Determination of impairment loss event and estimated impairment of trade and other receivables

The Group uses provision matrix to calculate ECL for the trade and other receivables. The provision rates are based on past-due status of debtors as groupings of various debtors on this basis demonstrate similar loss patterns with shared credit risk characteristics. The provision matrix is based on the Group's historical default rates taking into consideration forward-looking information that is reasonable and supportable available without undue costs or effort. At every reporting date, the historical observed default rates are reassessed and changes in the forward-looking information are considered. In addition, trade and other receivables with significant balances and credit impaired are assessed for ECL individually.

The provision of ECL is sensitive to changes in estimates. Where the actual future cash flows are less than expected, a material impairment loss may arise. As at 31 December 2021, the carrying amount of trade receivables is HK\$168,323,000, net of allowance for ECL of HK\$1,046,000 (31 December 2020: HK\$159,574,000, net of allowance for ECL of HK\$1,708,000).

Fair value measurements of financial instruments

As at 31 December 2021, certain of the Group's financial assets (including financial assets at FVTPL and financial assets at FVTOCI) are measured at fair value with fair value being determined based on significant unobservable inputs using valuation techniques. Judgement and estimation are required in establishing the relevant valuation techniques and the relevant inputs thereof. Changes in assumptions relating to these factors could result in material adjustments to the fair value of these instruments. Estimated impairment of intangible assets, property, plant and equipment and right of use assets

Being part of the principal activities, the Group acquired certain license fees and capitalised development cost relating to the development of pharmaceutical products, since these costs meet the recognition criteria of HKAS 38. The Group reviews the carrying amount of all intangible assets held at the end of the reporting period and HK\$230,509,000 (2020: HK\$3,840,000) impairment was considered necessary for these assets.

As at 31 December 2021, in view of impairment indicators, the Group performed impairment assessment on property, plant and equipment approximately (excluding right-of-use assets) HK\$532,289,000 (31 December 2020: HK\$573,359,000) and right-of-use assets approximately HK\$155,976,000 (31 December 2020: HK\$151,193,000) respectively. No impairment losses in respect of property, plant and equipment and right-of-use assets have been recognised for both years ended 31 December 2021 and 2020.

Depreciation

The Group's net carrying amount of property, plant and equipment (excluding right-of-use assets) as at 31 December 2021 was approximately HK\$532,289,000 (31 December 2020: approximately HK\$573,359,000). The Group depreciates the property, plant and equipment, using the straight-line method, at the rate 5% to 33% per annum, commencing from the date the assets is placed into productive use. The estimated useful lives and dates that the Group places the assets into productive use reflect the directors' estimate of the periods that the Group intends to derive future economic benefits from the use of the assets.

Share-based payments

The Group recognises share-based payments expense on options granted. Share-based payments expense is based on the estimated fair value of each option at its grant date, the estimation of which requires the directors to make assumptions about future volatility of the Group's stock price, future interest rates and the timing with respect to exercise of the options. The effects of a change in one or more of these variables could result in a materially different fair value. The fair value of the share options granted during the year was estimated at HK\$4,605,000 (2020: HK\$9,225,000) and the amount associated with share-based payments for the year ended 31 December 2021 is HK\$16,888,000 (2020: HK\$17,442,000).

Income taxes

The Group is subject to income taxes in a number of jurisdictions. Significant judgement is required in determining the provision for income taxes in various jurisdictions. There are many transactions and calculations for which the ultimate tax determination is uncertain. The Group recognises liabilities for anticipated tax audit issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the current and deferred income tax assets and liabilities in the period in which such determination is made.

Financial risk management objectives

The Group's corporate treasury function provides services to the business units, co-ordinates access to domestic and international financial markets, monitors and manages the financial risks relating to the operations of the Group through internal risk reports which analyse exposures by degree and magnitude of risks. These risks include market risk (including foreign currency risk, interest rate risk, and other price risk), credit risk and liquidity risk.

The Group seeks to minimise the effects of these risks and may use derivative financial instruments to hedge risk exposures. The use of financial derivatives is governed by the Group's policies approved by the board of directors, which provide written principles on foreign exchange risk, interest rate risk, credit risk, the use of financial derivatives and non-derivative financial instruments, and the investment of excess liquidity. The Group does not enter into or trade derivative financial instruments for speculative purposes.

There has been no change to the types of the Group's exposure in respect of financial instruments or the manner in which it manages and measures the risks.

Interest rate sensitivity analysis

The sensitivity analysis below has been determined based on the exposure to interest rates for both derivative and non-derivative instruments at the end of the reporting period. For floating rate liabilities, the analysis is prepared assuming the amount of the liability outstanding at the end of the reporting period was outstanding for the whole year. A 50 basis points (2020: 50 basis points) increase or decrease in variable-rate borrowings is used when reporting interest rate risk internally to key management personnel and represents management's assessment of the reasonably possible change in interest rates. Bank balances are excluded from sensitivity analysis as the directors of the Company consider that the exposure of cash flow rate risk from variable-rate bank balances is insignificant.

If interest rates had been 50 basis points (2020: 50 basis points) higher/lower and all other variables were held constant, the Group's pre-tax profit for the year ended 31 December 2021 would decrease/increase by HK\$1,233,000 (2020: decrease/increase by HK\$707,000). This is mainly attributable to the Group's exposure to interest rates on its variable-rate borrowings.

Other price risk

The Group is exposed to equity price risk mainly through its investment in financial assets measured at FVTPL and FVTOCI with the underlying assets are equity securities. The Group's equity price risk is mainly concentrated on entities operating in biopharmaceutical industry which are either listed in Nasdaq Capital Market® or Hong Kong or unlisted.

Other price risk sensitivity analysis

The sensitivity analysis below has been determined based on the exposure to equity price risk at the end of the reporting period.

For the year ended 31 December 2021, if the price of the equity instruments had been 5% (2020: 5%) higher/lower, the Group's pre-tax profit would increase by HK\$268,000 (2020: HK\$1,593,000) or decrease by HK\$262,000 (2020: HK\$1,589,000) as a result of the changes in fair value of financial assets at FVTPL, while the other comprehensive income would increase/decrease by HK\$47,012,000 (2020: increase/decrease by HK\$14,774,000) as a result of the changes in fair value of financial assets at FVTOCI.

Credit risk management

As at 31 December 2021, the Group's maximum exposure to credit risk which will cause a financial loss to the Group due to failure to discharge an obligation by counterparties is the carrying amount of each financial asset as stated in the consolidated statement of financial position.

In order to minimise the credit risk, the management of the Group has delegated a team responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In addition, the Group reviews the recoverable amount of each individual trade debt at the end of the reporting period to ensure that adequate ECL provision are made for irrecoverable amounts. In this regard, the directors of the Company consider that the Group's credit risk is significantly reduced.

The Group's credit risk exposure is spread over a number of counterparties and customers. Hence, it has no significant concentration of credit risk by single counterparty. Ongoing credit evaluation is performed on the financial condition of receivables.

The credit risk on liquid funds is limited because the counterparties are banks with high credit ratings.

The Group does not hold any collateral or other credit enhancements to cover its credit risks associated with its financial assets.

Liquidity risk management

Ultimate responsibility for liquidity risk management rests with the board of directors, which has built an appropriate liquidity risk management framework to meet the Group's short, medium and long-term funding and liquidity management requirements. The Group manages liquidity risk by maintaining adequate reserves, banking facilities and reserve borrowing facilities, by continuously monitoring forecast and actual cash flows and matching the maturity profiles of financial assets and liabilities.

Liquidity tables

The following tables detail the Group's remaining contractual maturity for its non-derivative financial liabilities. The tables have been drawn up based on the undiscounted cash flows of financial liabilities based on the earliest date on which the Group can be required to pay. Specifically, bank borrowings with a Repayment on Demand Clause are included in the earliest time band regardless of the probability of the banks choosing to exercise their rights. Impairment of intangible assets

During the year ended 31 December 2021, the management of the Company has conducted a review of its intangible assets portfolio. After considering the continuous reforms of drug pricing mechanisms by the Chinese authority and the tight competition for drugs which are covered by the Volume-Based Procurement, the Group has made a full impairment of HK\$40,195,000 (comprising of license fee HK\$35,816,000 and development cost HK\$4,379,000) on Rasilez®, a launched oral antihypertensive licensed-in product of the Group.

In additions, the management of the Company has implemented tight measure on resource allocation for its existing research and development portfolio with more focus will be given to prioritised projects, and decided to postpone a total of 14 development programmes. A total of HK\$190,314,000 impairment provision (comprising of license fee HK\$43,072,000 and development costs HK\$147,242,000) was made.

Development programme

The Group has over 40 early- to late-stage development in various therapeutics areas. Key development programme is set out below:

1. Anfibatide

Anfibatide is a new molecular entity discovered and developed by the Group. It is a first-in-class platelet GPIb α receptor antagonist that has fast onset, potent, and reversible antithrombotic effect among healthy subjects without impairing coagulation or prolonging bleeding time. As at 31 December 2021 and 2020, Anfibatide was not ready for sales and the Group continues the underlying research and development activities. As such, it is subject to annual impairment test based on its recoverable amount. Management determined the recoverable amount of this asset using the value in use calculations. These calculations use cash flow projections based on management's expectations of timing of commercialisation, royalty rate and success rate of commercialisation over useful life of Anfibatide. The valuation is considered to be level 3 in the fair value measurement hierarchy due to unobservable inputs used in the valuation.

The Company's share option scheme (the "2002 Share Option Scheme") and new share option scheme (the "New Share Option Scheme", together with the 2002 Share Option Scheme referred to as "Share Option Schemes") were adopted on 26 June 2002 and 10 May 2012 respectively for the primary purpose of providing incentives to directors, eligible employees, advisers and consultants.

For the 2002 Share Option Scheme, the total number of shares in respect of which options may be granted under the scheme is not permitted to exceed 10% of the shares of the Company ("Shares") in issue at the time of listing, without prior approval from the Company's shareholders. The number of Shares issued and to be issued in respect of which options granted and may be granted to any individual in any one year is not permitted to exceed 1% of the Shares in issue, without prior approval from the Company's shareholders.

For the New Share Option Scheme, the total number of shares which may be issued upon exercise of all options to be granted under the New Share Option Scheme shall be subject to a maximum limit of 10% of the Shares in issue on the date on which the New Share Option Scheme is conditionally adopted and approved by the shareholders at the AGM, unless the Company obtains an approval from the shareholders in general meeting to refresh such 10% in accordance with the Listing Rules. Options lapsed in accordance with the terms of the New Share Option Scheme will not be counted for the purpose of calculating such 10%. The overall limit on the number of Shares which may be issued upon exercise of all outstanding options granted and yet to be exercised under the New Share Option Scheme and any other share option schemes must not exceed 30% of the Shares in issue from time to time.

The exercise price is determined by the directors, and will not be less than the highest of (i) the closing price of the Shares on the date of grant; (ii) the average closing price of the Shares for five business days immediately preceding the date of grant; and (iii) the nominal value of the Shares.

The assets of the MPF Scheme are held separately from those of the Group, in funds under the control of independent trustees. Under the MPF Scheme, the employer and its employees are each required to make contributions to the plan at 5% of the employees' relevant income, subject to a cap of monthly relevant income of HK\$30,000. Contributions to the plan vest immediately, there is no forfeited contributions that may be used by the Group to reduce the existing level of contribution.

The total expenses recognised in profit or loss of HK\$770,000 (2020: HK\$772,000) represents contributions payable to the MPF Scheme by the Group at rates specified in the rules of the plans.

The employees of the Group's subsidiaries in the PRC and Taiwan are members of a state-managed retirement benefit plan operated by the government of the PRC and Taiwan. The subsidiaries are required to contribute a specified percentage of payroll costs to the retirement benefit scheme to fund the benefits. The only obligation of the Group with respect to the retirement benefits is to make the specified contributions.

Defined benefit plan

Retirement benefits scheme represents the retirement benefits provided to certain directors of the Company in accordance with their service contract (as supplemented).

Each of the eligible directors will be entitled to lump sum payment upon retirement and monthly pension payment after retirement if he/she has engaged in continuous service with the Group for certain years.

The carrying amount of the retirement benefits represents the cost of providing benefits determined by valuation conducted by independent valuer at the end of the reporting period, amortised over the expected average remaining working lives of the eligible employees. The fair value of the retirement benefits at 31 December 2021 was valued by Peak Vision Appraisal Limited, an independent professional valuer not connected to the Group.

The fair value is measured by using discount cash flows method to capture the present value of the expected future economic benefits that will flow out of the Group arising from the retirement benefits. The valuation is considered to be level 3 in the fair value measurement hierarchy due to unobservable inputs used in the valuation. Details of key unobservable inputs are as follows:
