# 截動顧客三十載 傳承唐宮人情味





On behalf of the Board, I would like to present the annual report of the Group for the year ended 31 December 2021.

2021 marks the 29th anniversary of the establishment of Tang Palace.

As the Group moves towards its 30th anniversary, we are caught in the era of normalized pandemic. In the midst of variable and unstable subjective elements, we adhered to the operating philosophy of "Operating altruistically, Devoting relentless efforts, and Conveying happiness". We continued to promote impressive services, upgraded the membership system comprehensively, provided diverse dining experience by innovating brands, as well as accelerated improving takeaway services, enhanced online sales promotion, explored more possibilities of new retail, and continued to refine the operation system and employee training, devoting to seize the opportunity of the recovery of dining market in the first place under the circumstances of rapidly changing consuming habits.

I'm honored to report now that under the joint efforts of all the personnel of the Group, a total revenue of RMB1,361.3 million was recorded as for the year ended 31 December 2021 (the "Year"), representing a year-on-year increase of 23.2%.

## PRECISE PROMOTION AS THE MOMENTUM OF MARKET GROWTH

Looking back at 2021, through precise positioning of the market, the group enhanced brand effect and market shares percentage through public realm platform (third party takeaway platforms), while proactively developing private realm platform, enabling takeaway business to increase continuously. Meanwhile, the electronic membership system was comprehensively upgraded in September 2021, allowing members to place orders directly to nearby branches for our delicate and delicious dishes without leaving their homes. Private realm platforms have strong autonomy, so that we can position dining situations of middleclass families more accurately, build relationships and enhance membership activities through various promotion and live stream activities. 在集團邁向三十年之際,適逢疫情常態化時 代,面對多變且不穩定的客觀因素,我們秉 承「利他經營、用心做事、傳遞幸福」的經營 理念,持續推動感動服務,全面升級會員系 統,以創新品牌提供多元化餐飲體驗,並且 加速提升外賣業務,推動線上銷售推廣,開 發更多新零售的可能性,持續完善營運系統 及員工培訓,致力在市場消費習慣迅速改變 的大環境下,捕捉餐飲市場復甦先機。

在此欣然報告,在集團上下共同努力下,集 團於截至二零二一年十二月三十一日止(「本 年度」)的整體收益錄得人民幣1,361.3百萬 元,按年上升23.2%。

#### 精準營銷 成市場增長動力

回顧二零二一年,集團通過精準市場定位, 一方面透過公域平台(第三方外賣平台)增加 品牌效應及市場佔有率,同時積極發展私域 平台,外賣業務得以持續增長。同時,電子 會員系統已於二零二一年九月全面更新,會 員可直接向鄰近的唐宮分店下達訂單,足不 出戶即可品嚐精緻可口的菜餚。私域平台具 很強的自主性,我們能夠更精準定位中產階 級家庭用餐場景,通過豐富的營銷、直播等 活動與顧客建立關係,提升會員活躍度,目 前電子會員數目已超過70萬人,市場前景樂 觀。



## IMPRESSIVE SERVICES PASSING ON THE HUMANISTIC TOUCH OF THE BRAND

The Group's corporate culture which accumulated for years is one of the keys for us to proactively face all kinds of challenges. For years, Tang Palace has promoted impressive services, regarding "bring happiness to customers" as our mission. We provided unique and caring services through various value-added services, allowing customers to have different dining experiences and fulfilling their dining demands which are becoming more and more diversified.

As a corporate with humanistic touch, we wish happiness for both our customers and employees. Moving towards the 30th anniversary of the establishment of the brand, Tang Palace will launch a series of events for celebration and gratitude. We also plan to film the brand's story in the form of a documentary, inviting 30 people who have been associated with Tang Palace for years, including employees, customers, suppliers, etc., to document happy stories and touching moments shared with Tang Palace by several generations of people in their different life stages, so as to pass on the humanistic touch of the brand.

## SYSTEM UPGRADE AND DEPLOYMENT OF NEW MARKET IN SECOND-TIER CITIES

As there still are some uncertainties of the global economy under the pandemic, we should be cautious in investment and expansion. Meanwhile, we should also take the opportunity in enhancing our internal competitiveness, namely improving team building and system upgrade for the benefit of development in the next 10 years. As the business in major cities began to reach market saturation, the Group plans to explore markets in secondtier cities, deploying new market targets in Chongqing, Nanjing, Wuhan, etc. While exploring, the Group will cooperate with other excellent brands with a strategy of brand symbiosis, creating a synergy effect on research and development costs, resources promotion, etc.

疫情下環球經濟仍存不確定性,投資及拓展 都應較審慎,同時亦是練好內功的良機,即 提升團隊建設、系統升級更有利於未來十年 發展。隨著主要城市開始飽和,集團計劃開 拓二線城市,佈局重慶、南京、武漢等新市 場目標。在拓展過程會以品牌共生策略,跟 其他優秀品牌合作,在研發成本、推廣資源 等方面產生協同效應。



#### EMPOWERING EMPLOYEES TO CULTIVATE HIGH-PERFORMING COMPREHENSIVE TALENTS

Tang Palace attaches importance to nourishing talents and cultivating partners with both morality and talent. We understand deeply that focusing on people's heart is the key to corporate development. Therefore, we created a working environment of filial piety and benevolent, gratitude and modesty, and honesty and altruism through passing on the essence of traditional Chinese culture and holding various cultural events, cultivating cultural literacy of our partners, allowing them to enhance character growth, stimulate potentials and achieve self-accomplishment.

We provide diverse talent development channels, continue to improve team building, and stimulate inner motivations of employees in a more systematic and autonomous manner, to cultivate versatile talents and new management personnel, providing employment and development platform for those aspired in catering business, as well as supporting the development of the Group with a competitive personnel storage.

#### GREEN DINING WITH A NEW TREND OF CARBON REDUCTION AND HEALTH CARE

The Group enhanced in "environment, society and governance" continuously, believing that we can only achieve the vision of "happiness in dining, centennial brand" through maintaining a harmonious and balanced relationship with nature. #### **INDUSTRY REVIEW**

In 2021, the novel coronavirus disease (the "Pandemic") continued to ravage the world. However, the global economy began its recovery in an orderly manner due to the boost of vaccination rate by different countries. According to the "Global Economic Outlook" published by the World Bank in 2022, the global economic growth rate increased from negative in 2020 to 5.5% in 2021, which demonstrated the positive effects on the economy brought by the availability of vaccines and limited easing of social distancing measures in various countries. In particular, China was the only major economy that recorded positive economic growth in 2021, leading the economic growth rate among the world's major economies. According to the National Bureau of Statistics, China's GDP in 2021 increased by 8.1% when compared with that of 2020, and the national per capita disposal income had an actual increase of 8.1% compared with last year, representing an average growth rate of 5.1% over both years, which was basically in line with economic growth and met the requirement of steady growth in residents' income. The increase was mainly due to the economic benefits brought by continuously supporting internal circulation and expanding domestic demand in Mainland China, with domestic demand contributing 79% to economic growth in 2021. Although there is a clear upward trend in consumption, the Pandemic has also catalyzed the increase in online retailing, thus driving sales and leading to the gradual recovery of the food and beverage market, which indicated a significant improvement in the resilience of Chinese food and beverage enterprises. However, catering counts as contact and scenario consumption, displaying a most direct and clear impact from continuous and volatile pandemic situations. In 2021, the national revenue for food and beverage increased by 18.6% when compared with 2020. Still, it decreased by 1.1% when compared with 2019, representing an average decrease of 0.5% over both years, which showed that the scale of food and beverage consumption has not yet recovered to the pre-pandemic level.

#### 行業概覽

二零二一年新型冠狀病毒肺炎(「疫情」)持續 肆虐全球,然而在各國努力推高疫苗接種率 之下,全球經濟得以逐步有序恢復。據世界 銀行於二零二二年發布的《全球經濟展望》中 表示,全球經濟成長率由二零二零年的負增 長至二零二一年的5.5%,可見經濟隨著疫苗 的普及和各國有限度放寬社交距離措施帶來 正面影響。當中,中國更成為二零二一年唯 一經濟錄得正增長的主要經濟體,經濟增速 在全球主要經濟體中名列前茅。根據國家統 計局,二零二一年國內生產總值對比二零二 零年增長8.1%,全國居民人均可支配收入比 上年實際增長8.1%,兩年平均增長5.1%, 與經濟增長基本同步,達到居民收入穩步增 長的要求。此乃主要由於中國內地持續支持 內循環、擴大內需所帶來的經濟效益,二零 二一年內需對經濟增長的貢獻率達79%。雖 然消費有明顯向好趨勢,疫情亦催化了網上 零售的增長從而帶動銷售,餐飲市場亦得以 漸漸活躍起來,顯示中國餐飲企業的抗風險 能力明顯提升。然而餐飲屬接觸式、場景式 消費,受持續反覆的疫情衝擊最為直接明 顯。二零二一年全國餐飲收入對比二零二零 年增長達18.6%,但若對比二零一九年則下 降1.1%,兩年平均下降0.5%,可見餐飲消 費規模仍未恢復至疫情前水準。

#### **BUSINESS REVIEW**

According to the analysis in relation to the food and beverage market in 2021 published by the China Cuisine Association, the food and beverage market of various provinces has turned from negative growth in 2020 to positive growth in 2021. Some provinces have even recovered to the level before the Pandemic, especially in some regions such as Sichuan province and Beijing, where a more pronounced recovery was witnessed, with growth rates of over 30%. The branches of the Group are mainly located in five major areas, namely Northern China, Eastern China, Guangdong, Chengdu and Hong Kong. Benefiting from the vast control of the Pandemic in Mainland China, the operation has basically returned to normal. As a result, the Group's business in various districts in China in 2021 recorded a double-digit growth when compared with 2020, especially in Northern China, where revenue significantly increased by more than 30%. The revenue of Eastern China and Guangdong also increased by approximately 20% when compared with 2020. Chengdu, a new region tapped into by the Group in recent years, which has seen the most obvious recovery in business in 2020, whose revenue growth for the year maintained at double-digit figures. Hong Kong was impacted dramatically by the Pandemic in the first half of 2021, but in the second half of the year, as the consumption voucher scheme launched by the Hong Kong government boosted consumer sentiment, and the Pandemic has eased, revenue also increased significantly when compared with that of 2020. Overall, for the year ended 31 December 2021 (the "Year"), the Group recorded total revenue of RMB1,361.3 million (2020: RMB1,105.1 million), representing an increase of 23.2% on a year-to-year basis.

#### 業務回顧

根據中國烹飪協會發布有關二零二一年餐飲 市場的分析,各省區的餐飲市場已從二零二 零年的負增長轉為二零二一年的正增長,部 分省更已恢復至疫情之前水準,當中尤以四 川省、北京市等部分區域復甦更為明顯,增 速達30%以上。集團分店主要分布在五大區 域,分別是華北、華東、廣東、成都及香 港,受惠於中國內地疫情的廣泛受控,業務 得以大致回復正常運作,因此集團於二零 二一年在中國內地各區的業務對比二零二零 年均錄得雙位數的增長,尤以華北地區的增 長最為明顯,獲得超過30%的收益增幅。而 華東區及廣東區的收益對比二零二零年亦有 約20%的增幅。成都區屬於集團近年拓展的 新區,其業務於二零二零年恢復最為明顯, 於本年度的收益增長仍維持於雙位數。香港 區於二零二一年上半年受疫情的影響較大, 下半年隨著政府推出的消費券津貼帶動消費 氣氛,以及疫情相對緩和的情況下收益對比 二零二零年也有顯著的上升。整體而言,集 團截至二零二一年十二月三十一日止年度 (「本年度」)的整體收益錄得人民幣1,361.3百 萬元(二零二零年:人民幣1,105.1百萬元), 按年上升23.2%。

## Management Discussion and Analysis

管理層討論及分析

## Online-to-Offline Measures and Quality Reform for Service Improvement

Apart from the consumer sentiment boosted by the slight easing of the Pandemic, the business growth of the Group for the Year was mainly due to the strategic repositioning, which enabled each region to grasp the target through re-calculating and focusing on the continuation and deepening of the theme strategy of "creating customer consumption needs". Due to the volatility of the Pandemic, the dine-in business has been impacted to a certain extent, thus making online promotion as one of the main channels, maintaining online exposure, promoting online marketing and maintaining customer interaction as being the Group's strategic focus. In this regard, the Group has launched our own mini-program live streaming during the year, allowing seasonal products, meal packages and promotions offered in each region according to local characteristics to be directly advertised and displayed online, which in turn could lead to end sales, including online sales and offline in-store dining. On the other hand, the Group believes continuous quality improvement is the key competitive strength. Apart from effectively improving service quality by analyzing online reviews and mystery shoppers, it can also be used to keep abreast of customers' needs. Meanwhile, given that the banquet consumption has reduced significantly in recent years due to the Pandemic, the Group turned to enhance the marketing strategy of private rooms as well as optimize management of customer relations, while adding personalized service for family festival celebrations and small banquets.

#### 線上引流線下質量改革提升服務

除了因疫情稍緩而帶動消費氣氛,集團於本 年度的業務增長主要由於策略的調整,透過 重新盤點及聚焦於延續並且深入強化「創造 顧客消費需求」的主題策略讓各區掌握目 標。由於疫情的反覆,堂食受到一定程度的 影響,故此線上推廣成為主要渠道之一,保 持線上曝光、推動線上營銷,以及維持顧客 互動仍然是集團的焦點策略。就此,集團於 年內推出了自家小程序直播,讓各區可按地 區特性而推出的季節性產品或套餐、優惠推 廣等可於線上直接解説、展示,並引導至最 終的銷售,包括線上銷售及線下的店內用 餐。另一方面,集團認為持續提高質量是關 鍵性的競爭優勢,除了透過網絡評價及神秘 顧客分析從而有效提升服務質素,亦可藉此 緊貼顧客需要;同時,近年因疫情而大大減 少宴會消費,集團轉而提升廳房的銷售策 略,並且優化顧客關係管理;又針對家庭式 節日慶祝或小型宴會而加入個性化訂製服 務。



#### **Continuous Growth in Takeaway Business**

As takeaway has become a regular consumption, the Group thrived for the best to continuously improve its takeaway business. During the Year, the Group reconstructed the takeaway business model in Mainland China from the previous takeaway system that depended mainly on third-party public platforms to "public platform + self-operated takeaway mini-program" and achieved interoperability with the membership system, allowing us to enhance customers' loyalty and increase their consumption desire, in hopes of increasing average consumption of an takeaway order and reducing platform commission costs. In addition, the Group launched holiday featured special products and innovated food from time to time, added environmental protection elements on the package, enhanced the convenience and practicality from customer perspective, and introduced value-added services, etc. As of 31 December 2021, the total revenue of takeaway business reached RMB171 million, making the average annual growth rate of over 30% in both 2020 and 2021.

#### **Development Potential in New Retail**

Retail was not a key business of traditional food and beverage business in the past. The Group considers the business to be of development potential and thus it has been actively managing and expanding it in recent years, continuously seeking breakthroughs and making numerous attempts during the Year. In relation to seasonal products, large-scale themed conferences, tasting sessions and other activities involving interacting with customers were held regularly in all regions, such as hand-made rice dumplings for parents and children, etc. On the other hand, we added high-quality food, seasonal fruits and vegetables, tea leaves gift box sourced from various origins, as well as self-made packaged foods and dishes for family banquets on the Tang Palace Weimob. In relation to the promotion channels, more platforms were opened, such as Ole Boutique Supermarket, Taobao Tmall Store, Jingdong Self-operated Store, Douyin Store, WeChat social group platforms, etc., while enhancing the professionalism of warehousing and logistics to support online sales more smoothly and effectively.

#### 外賣續增長

外賣已成常態化消費,故此集團精益求精持 續提升外賣業務,於本年度集團將中國內地 的外賣模式從原來主要靠第三方公域平台的 外賣系統,調整為「公域平台+自營外賣小 程序」,並實現與會員系統的互通,藉此增 加與顧客黏性,提高會員消費意慾,有望提 升外賣單均消費及減少平台佣金成本。另 外,亦不時推出節日主題特色產品及創新食 品,並且在包裝上加入環保元素,從客人角 度提高便利性、實用性,以及添加增值服務 等。外賣整體收益於二零二一年十二月 三十一日止達到人民幣171百萬元,二零二 零年及二零二一年兩年間平均每年增幅超過 30%。

#### 新零售具發展空間

以往零售並非傳統餐飲的重點業務,集團認 為此業務具有發展潛力,故於近年積極管理 及拓展,於本年度持續尋求突破並作出多方 嘗試。於季節性產品方面,各地區均定期舉 辦大型的主題發布會、品鑑會等與顧客互動 的活動,如親子手工粽製作等。另一方面, 在唐宮微商城加入從各地搜羅的優質食品、 時令蔬果、茶葉禮盒及自家研發的包裝自 品、家宴菜式等。在推廣渠道上也開通更多 平台如Ole精品超商、淘寶天貓店、京東自營 店、抖音小店、微信社群平台等,同時加強 倉存物流專業化,更流暢及有效配合線上銷 售。

#### **Upgrading Membership System**

With intelligent digitalization being a major business trend, the Group has further fully upgraded the digital membership system to a nationwide system available to all stores this year, while being connected to self-operated takeaway mini-program and E-shop after upgrading the membership system to digital membership in the early years. This new feature system was launched in the second half of the year, enabling members to accumulate points, dine in, takeaway order and online purchase anytime at any store across the country. It has significantly enhanced the convenience and sense of experience, at the same time increased repeated purchases. It is believed to make considerable contributions for the Group on expanding business and increasing revenue in the long term. As of 31 December 2021, the number of members was over 700,000, representing an increase of over two times compared with the same period in 2020, with the percentage of membership consumption in each region rising gradually. Digital membership has also been introduced in Hong Kong since the second half of 2020. As of 31 December 2021, the number of members has reached nearly 70,000, with the percentage of consumption reaching over 50%, which is expected to bring more opportunities for business development in the future.

#### 會員系統升級

智慧型數碼化是商業大趨勢,集團於早年將 會員系統升級成電子會員後,今年更進一步 將電子會員系統,實現所有門店升級至全國 通用,並且同時接駁自營外賣小程序及電子 商城。此全新功能系統已於下半年推出,會 員可以在全國各地分店隨時進行會員儲值、 堂食消費、外賣,以及在網上商城購買產 品,使用的便利性和體驗感都得到極大的提 升,同時增加顧客複購率。相信長遠可為集 團擴展業務、增加收益帶來不少貢獻。截至 二零二一年十二月三十一日止,會員人數已 超過70萬,對比二零二零年同期有超過2倍 的增長,各區的會員消費佔比亦逐步提升。 香港區亦於二零二零年下半年開始推行電子 會員,截至二零二一年十二月三十一日止, 會員人數已接近7萬,消費佔比已達一半以 上,期望將來可為業務發展帶來更多機遇。





#### **Cuisine Diversification under Innovative Brands**

The Group has always been devoted to providing diversified cuisine experiences for customers, thus launching new brands from time to time to cater to different markets. During the Year, the Group opened "Soup Delice" themed on Guangdong health stew serving quick and easy meals in Shanghai Honggiao Airport, and opened upgraded "Tang's Cuisine" with a high-end business position in a renowned business district in Shenzhen. An additional "Tang Palace", a Cantonese-Style cuisine restaurant was opened in Chengdu during the Year. In terms of joint ventures, two new brands were introduced to Hong Kong during the Year, including an innovative Japanese-style barbecue restaurant that combines the traditional kaiseki cuisine with modern barbecue culture, as well as an innovative multi-cuisine restaurant, first of its kind, set in the theme of French-style café by the street that blends the ancient with the modern and the Asian with the European. In addition, the Group also opened one "PappaRich", a restaurant serving Malaysian cuisine in Taiwan.

#### **Cost Challenges**

Staff costs remained one of the biggest challenges of the food and beverage industry. As business gradually normalized and customer flow slowly resumed, staff costs have increased in response to business needs. In addition, stable and high-quality catering staff is crucial to the Group; thus, the Group has invested considerable resources in remuneration, benefits and training during the Year. Besides, the recurring impact of the Pandemic on customer flow volume has caused a certain extent of pressure on the control of staff costs. However, the Group believes that the continued implementation of policies such as enhancing human resources effectiveness and training versatile talents can stabilize staff costs. The percentage of staff costs accounted for 32.9% of total revenue for the Year, which was comparable to that of the corresponding period last year. During 2020, the gross profit margin dropped due to the impact of the Pandemic. However, under the efforts of the Group, the earlier launched and ongoing refinement of controllable cost analysis has enabled the strategy of meticulous management of gross profit to gradually take effect in each region and even in each branch, resulting in a slight increase in the gross profit margin for the Year compared with 2020.

#### 創新品牌多元化飲食

集團一直致力為客人提供多元化餐飲體驗, 故此不時推出新品牌迎合不同市場。本年度 集團分別在上海虹橋機場開設了以廣東養生 燉湯為主題的快捷簡餐「唐宮湯品」,在深圳 知名商圈開設高端商務費定位的「唐宮壹號」 升級版,成都作為集團的業務發展新區,也 於本年度增設了一家粵菜餐廳「唐宮」。合營 方面,本年度在香港新增兩個全新品牌,除 了有結合傳統懷石料理和現代燒肉文化的創 新日式烤肉店以外,亦首次開設休閒法式路 邊咖啡廳主題的跨國創意料理餐廳,融合古 今、亞歐合璧。另外台灣亦新增設一家馬來 西亞料理「金爸爸」。

#### 成本挑戰

人員成本依舊是餐飲業的最大挑戰之一,隨 著業務逐漸正常化,客流量逐漸恢復,人員 成本亦因應業務需要而上升,加上穩定性的 高質餐飲從業員對集團來說十分關鍵,因此 本年度在薪酬、培訓等亦投入不少資 源。另外,疫情反覆影響客流量,對於人員 成本方面的掌控構成一定的壓力。然而,集 個相信透過持續提高人效及培養各型人才 等政策可穩定人員成本。本年度人員成本佔 總收益32.9%,對比去年同期之佔比相若。 二零二零年因疫情影響令毛利率有所下降, 然而在集團努力下,早前推行並持續進行的 細化可控成本份漸見成果,本年度的毛利率 對比二零二零年有輕微提升。

#### **Corporate Social Responsibilities**

The Group has been following the spirit of altruism for many years, put a great deal of effort in environmental protection and integrating the brand image of "Quality Products, Safety Assurance, Health Cultivation and Environmental Protection" into the operations of the Group, including reform of basic facilities in branches, cool kitchen scheme and others that promoted energy saving and emission reduction and gained significant green achievements in regard of the energy utilization. As the customers value health and environmental protection more after the Pandemic, the Group introduced a "green menu" made from plant-based meat and other vegetarian ingredients and held tasting sessions for vegetarian food, to encourage healthy, wellness-focused and low-carbon diet habits. In addition, the Group cooperated with various charity groups, supported society members in need through different charity activities and charitable donations, promoting the flow of love and contributing to achieve "happiness of employee and society". For detailed disclosure on the Group's corporate social responsibilities in 2021, please refer to the 2021 Environmental, Social and Governance report to be published in May 2022.

#### 社會企業責任

集團多年奉行利他精神,在環保公益上不遺 餘力,將「優品、安心、養生、環保」的品牌 形象貫穿在集團運營中,包括以門店基礎設 置改革、清凉廚房計劃等促進節能減排,在 能源利用效率方面獲得頗為顯著的綠色成 果團推出以植物肉及其他素食材料製作的 「綠色菜餐單」,舉辦素食品鑑會,鼓勵健康、養生、低碳的飲食習慣。此外,集團與 不同慈善團體合作,通過不同公益活動及慈 費指款,幫忙社會上有需要的人士,促進愛 的流動,為成就「幸福員工、幸福社會」作貢 面的詳細披露,可參閱將於二零二二年五月 刊出的二零二一環境、社會及管治報告。





#### Outlook

With the intermittent surge of the Pandemic in early 2022 and the probable effect of international economic situation and geopolitics, the Group predicts that 2022 will be a more challenging year. If the Pandemic becomes worse again in 2022, any implementation of more stringent measures to curb the Pandemic such as restricting social gathering, limiting restaurant business hours and banning dine-in business may cause serious impact to the catering industry. As a catering company that closely related to people's livelihood, the Group will continue to adhere to a high standard of Pandemic protection and control to provide safety assured dining environment and cuisine for the customers. Meanwhile, the Group also attaches great importance to expanding business in different areas and exploring diverse growth potential, which will require more efforts to cultivate comprehensive catering personnel to meet the development needs. 2022 marks the 30th anniversary of the establishment of the Group, the Group regards "Making Employees Happy" as its mission, expanding humanistic care and improving employee satisfactory through four major systems of "Caring, Connecting, Encouraging, Growing", improving customers satisfaction and achieving society well-being through practicing the value of reassurance, kindness, considerateness and selflessness. "Passing on the humanistic touch of Tang Palace as a fresh start of 30th anniversary" is the theme of the Group for 2022, for which the Group has prepared a series of anniversary appreciation activities. Setting out again on the solid foundation of 30 years, the Group looks forward to embark on a brand new journey and create another glorified 30 years.

#### 展望

As at 31 December 2021, the Group was operating 49 restaurants and 13 other restaurants under joint ventures. The table below illustrates the number of restaurants by major brands, together with the average spending per customer and percentage of revenue to the Group:

As mentioned above, the Group's overall revenue for the Year increased by 23.2% to RMB1,361.3 million, while the overall gross profit margin increased to 62.2% (2020: 61.8%).

誠如上文所述,本集團於本年度之整體收益 增加23.2%至人民幣1,361.3百萬元,整體毛 利率上升至62.2%(二零二零年:61.8%)。





During the Year, the Group had no share award plan expense (2020: RMB4.5 million). By excluding this expense item, the Group's percentage of revenue on staff costs was 32.9% (2020: 32.6%). In addition, percentage of revenue on depreciation of items of property, plant and equipment was 3.3% (2020: 4.4%) and utility and consumables expenses was 5.6% (2020: 6.0%). Rental and related expenses were categorized as depreciation of right-of-use assets and finance costs according to HKFRS 16. During the Year, percentage of revenue on depreciation of right-of-use assets was 6.1% (2020: 8.4%), percentage of revenue on finance costs was 1.4% (2020: 2.2%) and percentage of revenue on rental and related expenses was 1.9% (2020: 1.2%). Due to the increase in revenue as a result of the gradual improvement of the Pandemic since the second half of 2020, the percentage of revenue on expenses resumed normal compared to prior year.

During the Year, income tax expense was RMB27.6 million (2020: RMB15.4 million), which included withholding tax on dividend income of RMB2.9 million (2020: RMB3.5 million) and deferred tax expense of RMB2.3 million (2020: deferred tax credit of RMB5.7 million). The profit attributable to owners of the Company for the year amounted to approximately RMB40.6 million (2020: profit attributable to owners of the Company amounted to approximately RMB40.6 million (2020: profit approximately RMB4.4 million).

#### **Cash flow**

Cash and cash equivalents increased by RMB1.0 million from RMB402.0 million as at 31 December 2020 to RMB403.0 million as at 31 December 2021.

Net cash of RMB177.3 million was generated from operating activities during the Year. Net cash used in investing activities amounted to RMB17.4 million during the Year, of which RMB40.9 million was related to the purchase of property, plant and equipment, offset by RMB12.0 million decrease in time deposits. Net cash used in financing activities amounted to RMB158.0 million for the Year.

於本年度,本集團並無股份獎勵計劃開支 (二零二零年:人民幣4.5百萬元)。倘不包括 該開支項目,本集團的員工成本的收入百分 比為32.9%(二零二零年:32.6%)。此外, 物業、廠房及設備項目折舊的收入百分比為 3.3%(二零二零年:4.4%),公共設施及消 耗品開支為5.6%(二零二零年:6.0%)。根 據香港財務報告準則第16號,租金及相關費 用被歸類為使用權資產的折舊及財務成本。 於本年度,使用權資產折舊的收入百分比為 6.1%(二零二零年:8.4%),融資成本的收 入百分比為1.4%(二零二零年:2.2%),租 金及相關費用的收入百分比為1.9%(二零二 零年:1.2%)。由於自二零二零年下半年以 來疫情的逐步緩和導致收入增加,開支的收 入百分比較上年相比恢復正常。

於本年度,所得税開支為人民幣27.6百萬元 (二零二零年:人民幣15.4百萬元),其中包 括股息收入的預扣税款人民幣2.9百萬元(二 零二零年:人民幣3.5百萬元)及遞延税項開 支人民幣2.3百萬元(二零二零年:遞延税項 收入人民幣5.7百萬元)。本年度本公司擁有 人應佔溢利約為人民幣40.6百萬元(二零二 零年:本公司擁有人應佔溢利約人民幣4.4 百萬元)。

#### 現金流

現金及現金等值增加人民幣1.0百萬元,由二 零二零年十二月三十一日的人民幣402.0百 萬元增加至二零二一年十二月三十一日的人 民幣403.0百萬元。

於本年度,經營活動產生人民幣177.3百萬元 現金淨額。於本年度,投資活動所用現金淨 額為人民幣17.4百萬元,當中包括購置物 業、廠房及設備共人民幣40.9百萬元,抵銷 定期存款人民幣12.0百萬元的減少。本年度 融資活動所用現金淨額為人民幣158.0百萬 元。

#### **Liquidity and Financial Resources**

The Group's funding and treasury activities are managed and controlled by the senior management. The Group maintained cash and cash equivalents and time deposits, in aggregate, of RMB503.7 million as at 31 December 2021 (31 December 2020: RMB519.5 million). As at 31 December 2021, the Group's total assets, net current assets and net assets were RMB1,034.0 million (31 December 2020: RMB1,064.5 million), RMB150.1 million (31 December 2020: RMB144.9 million) and RMB416.9 million (31 December 2020: RMB418.9 million), respectively.

As at 31 December 2021, the Group had bank borrowings of RMB52.2 million (31 December 2020: RMB74.8 million). The gearing ratio (calculated as bank borrowings divided by total equity) was 12.5% as at 31 December 2021 (31 December 2020: 17.8%).

As at 31 December 2021, the current ratio (calculated as current assets divided by current liabilities) was 1.3 (31 December 2020: 1.3).

The directors are of the opinion that the Group has sufficient working capital for the Group's operations and expansion in the near future.

#### **Foreign Currency Exposure**

The business operations of the Group's subsidiaries were conducted mainly in the Mainland China with revenues and expenses of the Group's subsidiaries denominated mainly in RMB. The Group's cash and bank deposits were denominated mainly in RMB, with some denominated in Hong Kong dollars. Any significant exchange rate fluctuations of Hong Kong dollars against RMB as the functional currency may have a financial impact to the Group.

#### 流動資金及財務資源

本集團的資金及庫務活動由高級管理層管理 及控制。本集團於二零二一年十二月三十一 日有現金及現金等值及定期存款合共人民幣 503.7百萬元(二零二零年十二月三十一日: 人民幣519.5百萬元)。於二零二一年十二月 三十一日,本集團的資產總值、流動資產淨 值及資產淨值分別為人民幣1,034.0百萬元 (二零二零年十二月三十一日:人民幣 1,064.5百萬元)、人民幣150.1百萬元(二零 二零年十二月三十一日:人民幣144.9百萬 元)及人民幣416.9百萬元(二零二零年十二 月三十一日:人民幣418.9百萬元)。

於二零二一年十二月三十一日,本集團有銀 行借貸人民幣52.2百萬元(二零二零年十二 月三十一日:人民幣74.8百萬元)。於二零 二一年十二月三十一日的資本負債比率(以 銀行借貸除以權益總額計算)為12.5%(二零 二零年十二月三十一日:17.8%)。

於二零二一年十二月三十一日,流動比率 (以流動資產除以流動負債計算)為1.3(二零 二零年十二月三十一日:1.3)。

董事認為,本集團有足夠營運資金供本集團 於可見將來之營運及擴展所需。

#### 外匯風險

本集團附屬公司主要於中國內地經營業務, 其收入及開支主要以人民幣列值。本集團之 現金及銀行結餘大部分以人民幣列值,部分 則以港元列值。由於人民幣為本集團之功能 貨幣,港元兑人民幣的匯率若出現大幅波 動,可能會對本集團構成財務影響。





As at 31 December 2021, the directors considered the Group's foreign exchange risk to be insignificant. During the Year, the Group did not use any financial instruments for hedging purposes.

#### OTHER INFORMATION

#### Number and Remuneration of Employees

As at 31 December 2021, the Group had around 3,800 employees in Hong Kong and the PRC (31 December 2020: 3,800). The Group recognises the importance of human resources to its success, therefore qualified and experienced personnel are recruited for expansion of new restaurants. Remuneration is maintained at competitive levels with discretionary bonuses payable on a merit basis, which is in line with industry practice. Other staff benefits provided by the Group include mandatory provident fund, insurance schemes, share options, share awards and performance related bonus.

#### **Capital Commitment**

The Group's capital commitment was approximately RMB7.5 million and RMB7.5 million as at 31 December 2021 and 31 December 2020, respectively.

#### **Charges on Group Assets**

As at 31 December 2021, the Group had pledged deposits of RMB80.7 million (31 December 2020: RMB85.4 million) for banking facilities amounting to RMB72.7 million (31 December 2020: RMB74.8 million).

## COMPLIANCE WITH CORPORATE GOVERNANCE CODE

The Board is committed to maintaining a high standard of corporate governance practices to safeguard the interests of the Company and its shareholders and to enhance corporate value and accountability. These can be achieved by an effective and diversified Board, segregation of duties with clear responsibility, sound internal control, appropriate risk assessment procedures and transparency to all the shareholders.

The Company has complied with all the code provisions as set out in Appendix 14 (Corporate Governance Code and Corporate Governance Report) (version up to 31 December 2021) to the Listing Rules throughout the year.

#### **BOARD OF DIRECTORS**

The Board is in charge of the task of maximizing the financial performance of the Group and making decisions in the best interest of the Company. The Board is responsible for formulating business policies and strategies, monitoring the performance of the senior management of the Company, adopting and monitoring internal business and management control, approving and monitoring annual budgets and business plans, reviewing operational and financial performance, considering dividend policy, reviewing and monitoring the Company's systems of financial control and risk management. The Board has delegated the day-to-day management, administration and operation of the Group and implementation and execution of Board policies and strategies to the executive directors and management of the Company.

## 企業管治守則之遵守

董事會致力維持高水平的企業管治常規,以 保障本公司及股東利益,提升企業價值及問 責性。此目標可透過有效及多元的董事會、 分明的職責分工、穩定的內部監控、恰當的 風險評估程序及對全體股東的透明度來實 現。

本公司於本年度內已遵守上市規則附錄14企 業管治守則及企業管治報告(版本截至二零 二一年十二月三十一日)所載的所有守則 條文。

#### 董事會

董事會肩負持續優化本集團的財務表現及以 本公司的最佳利益進行決策的責任。董事會 亦負責制訂業務政策及策略、監督本公司高 級管理人員的表現、採納及監察內部業務及 管理監控、批准及監察年度預算及業務計 劃、審閱經營及財務表現、考慮股息政策、 檢討及監察本公司的財務監控及風險管理系 統。董事會將本集團日常管理、行政、運作 及董事會政策及策略的實施及推行委託予本 公司的執行董事及管理人員負責。

As at 31 December 2021, the Board consisted of nine members, including six executive directors, Ms. WENG Peihe (Chairman), Mr. YIP Shu Ming, Mr. CHAN Man Wai, Mr. KU Hok Chiu, Mr. CHEN Zhi Xiong (Chief Executive Officer), Mr. WONG Chung Yeung (Chief Financial Officer and Company Secretary) and three independent non-executive directors, Mr. KWONG Chi Keung, Mr. KWONG Ping Man and Mr. CHEUNG Kin Ting Alfred. The Board's composition was established with diversification as a major objective and consists of one female member, one aged between 40 and 49, three aged between 50 and 59 and five aged 60 or above. All members are Chinese and except for Mr. CHEN Zhi Xiong and Mr. WONG Chung Yeung who were appointed on 1 July 2020, all members have more than ten years of service as directors. Biographical details of each of the directors are set out on pages 27 to 34 of this annual report. Save as disclosed in this annual report, there is no financial, business, family or other material/relevant relationship among members of the Board.

All executive directors entered into service contracts with the Company for a specific term commencing from 1 July 2020 and expiring on 30 June 2023, which could be terminated by either party by giving not less than three months' written notice.

In compliance with Rule 3.10 of the Listing Rules, the Company has appointed three independent non-executive directors (representing one-third of the Board), one of whom has appropriate professional qualifications in accounting and financial management. All the independent non-executive directors have confirmed in writing to the Company that they have met all the guidelines for assessing their independence as set out in rule 3.13 of the Listing Rules. All independent non-executive directors renewed their respective letter of appointment for a specific term commencing from 1 July 2020 and expiring on 30 June 2023, which could be terminated by either party by giving not less than one month's written notice.

Not less than one-third of the Board are subject to retirement from office by rotation at the annual general meeting provided that every director shall be subject to retirement by rotation at least once every three years in accordance with the Articles of Association. Besides, a new director appointed by the Board to fill a casual vacancy or as an additional director shall hold office only until the next following general meeting and shall then be eligible for re-election.

All directors, including independent non-executive directors, have given sufficient time and effort to the affairs of the Group. Independent non-executive directors have provided the Board with their diversified expertise, experience and professional advice. The Board believes that the ratio between executive directors and independent non-executive directors is reasonable and adequate to provide sufficient checks and balances in order to safeguard the interests of shareholders of the Company and of the Group. The Board also believes that the views and participation of the independent non-executive directors in the Board and committee meetings provide independent judgment on the issues relating to strategy, performance, conflict of interest and management process to ensure that the interests of all shareholders of the Company are considered and safeguarded.

All directors have full and timely access to all relevant information in relation to the Group's businesses and affairs as well as unrestricted access to the advice and services of the company secretary, who is responsible for providing directors with board papers and related materials. The directors may seek independent professional advice at the Company's expenses in carrying out their duties and responsibilities.

The Company has maintained appropriate and sufficient insurance coverage on directors' liabilities in respect of legal actions taken against directors arising out of corporate activities.

本公司已對董事在履行公司事務期間產生對 董事所提出法律訴訟的責任購買合適及充足 的保險。

During the year ended 31 December 2021, the Board held four regular board meetings. At these regular board meetings, directors discussed and exchanged their views on significant issues and general operations of the Group, formulated business policies and strategies, reviewed the financial performance, budget plan and approved the annual results for the year ended 31 December 2020 and the interim results of the Company for the six months ended 30 June 2021.

The Board is responsible for performing the corporate governance duties set out in paragraph D.3.1 of the Corporate Governance Code, and in this regard the duties of the Board shall include:

- (a) to develop and review the Company's policies and practices on corporate governance;
- (b) to review and monitor the training and continuous professional development of directors and the senior management;
- (c) to review and monitor the Company's policies and practices on compliance with legal and regulatory requirements;
- (d) to develop, review and monitor the code of conduct and compliance manual (if any) applicable to employees and directors of the Company; and
- (e) to review the Company's compliance with the code and disclosure in the Corporate Governance Report.

# Corporate Governance Report 企業管治報告

## **RISK MANAGEMENT AND INTERNAL CONTROL**

The Board is responsible for ensuring that sound and effective risk management and internal control systems are maintained within the Group. It is achieved by ongoing reviews through 2 committees, namely Audit Committee and risk management and internal control committee (the "Risk and Control Committee"). Risk and Control Committee comprises the chairman of the Board, the chief executive officer and chief financial officer of the Company, an external PRC legal advisor engaged by the Company, and Mr. KWONG Ping Man (the independent non-executive director, who possesses relevant experience to review and assess the effectiveness and adequacy of the Company's internal control measures). Such reviews cover all material controls, including financial, operational and compliance controls.

The Company has also established an internal audit department in which the internal audit manager is professionally qualified with relevant experience to monitor and oversee daily operation of internal control matters. The Risk and Control Committee is responsible for i) the implementation of the remedial plans recommended by the internal audit department and ii) ensuring the compliance with the Listing Rules and applicable laws, rules and regulations in various business locations. The internal audit department and Risk and Control Committee facilitate the annual review of the risk management and internal control systems and directly report to the Audit Committee. Any deficiencies and risks identified during the review process will be evaluated and addressed in the Audit Committee and be reported to the Board if the impact is considered as significant.

Pursuant to the code provision C.2.4 of the Corporate Governance Code, the process described above and the main feature of the Group's risk management and internal control systems is through effective communications with various business units and functional departments so as to identify, evaluate and manage significant risks. Such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable but not absolute assurance against material misstatement or loss.

#### 風險管理及內部監控

董事會負責於本集團維持完善及有效之風險 管理及內部監控系統。此乃透過兩個委員會 之持續檢討實現,即審核委員會及風險管理 及內部監控委員會(「風險及監控委員會」)。 風險及監控委員會之成員包括董事會主席、 本公司行政總裁及首席財務官、本公司外聘 之中國法律顧問及鄺炳文先生(獨立非執行 董事,擁有相關經驗以檢討及評估本公司內 部監控措施是否有效及充分)。有關檢討涵 蓋全部重大監控,包括財務、運作及合規監 控。

本公司亦已成立內審部門,當中內審經理為 具備相關經驗的專業人士以監管及監察內部 監控事宜之日常運作。風險及監控委員會負 責i)執行內審部門建議的改善計劃及ii)確保遵 守上市規則及不同業務地點之適用法例、規 則及規例。內審部門及風險及監控委員會協 調風險管理及內部監控系統之年度檢討工作 並直接向審核委員會報告。檢討過程中辨認 之任何不足及風險將由審核委員會評估及處 理,倘事件影響重大,則向董事會報告。

根據企業管治守則守則條文第C.2.4條,上述 提及之本集團風險管理與內部監控系統程序 及其主要特點為透過與不同業務單位及職能 部門的有效溝通,以辨認、評估及管理重大 風險。有關系統乃旨在管理而非消除未能達 成業務目標的風險,而且只能就不會有重大 的失實陳述或損失作出合理而非絕對的保 證。



Besides, the Company has according to the requirement under part XIVA of the Securities and Futures Ordinance, established written procedures for the handling and dissemination of inside information and circulated to all staff and management who may due to their roles and duties, be in possession of these potential price sensitive information.

The Board, through the Audit Committee and Risk and Control Committee, reviewed the effectiveness of the Group's risk management and internal control systems for the year ended 31 December 2021 in accordance with the requirement set out in code provision C.2.1 of the Corporate Governance Code, and discussed with the management of the Company and its external and internal auditors. It is considered that i) no material change in the nature and extent of significant risks was noted since the last annual review, ii) no significant control failure or weakness that may have a material impact on the Company's financial performance has been identified during the year, and iii) the systems covered all material controls: including financial, operational and compliance controls and risk management functions, and are effective and adequate to safeguard the Group's assets and shareholders' interest.

At least 14 days' notice prior to the date of a regular board meeting is given to all directors and an agenda together with board papers are sent to all directors no less than three days before the date of a regular board meeting (or other agreed period). #### CHAIRMAN AND CHIEF EXECUTIVE OFFICER

Mr. CHEN Zhi Xiong, being the chief executive officer of the Company, is responsible for the daily operations of the Company, execution of business policies, strategies, objectives and plans as formulated and adopted by the Board and leading the management of the Company.

The Nomination Committee comprises three members who are all independent non-executive directors, namely Mr. CHEUNG Kin Ting Alfred (the Chairman), Mr. KWONG Chi Keung and Mr. KWONG Ping Man.

The Company recognises the importance of the Board's diversity in achieving a sustainable and balanced development. The Company has adopted a board diversity policy. Pursuant to the Nomination Policy, the Nomination Committee has been delegated to identify individuals suitably qualified to become Board members and select or make recommendations to the Board on the selection of individuals nominated for directorships. The Board is ultimately responsible for selection and appointment of new Directors.

The Nomination Committee should utilize various methods for identifying candidates for directorship, including recommendations from Board members, management, and professional search firms. In addition, the Nomination Committee will consider candidates for directorship properly submitted by the shareholders of the Company.

The Nomination Committee should consider the following qualifications as a minimum criteria to be required for a candidate in recommending to the Board to be a potential new Director, or the continued service of existing Director:

- the highest personal and professional ethics and integrity;
- proven achievement and competence in the nominee's field and the ability to exercise sound business judgment;
- skills that are complementary to those of the existing Board;
- the ability to assist and support management and make significant contributions to the Company's success;
- an understanding of the fiduciary responsibilities that is required for a member of the Board and the commitment of time and energy necessary to diligently carry out those responsibilities;
- independence: the candidates for independent non-executive directorship should meet the "independence" criteria as required under the Listing Rules and the composition of the Board is in conformity with the provisions of the Listing Rules.

- One or more shareholders ("Requisitionist(s)") holding, at the date of deposit of the requisition, not less than one tenth of the paid up capital of the Company having the right of voting at general meetings, shall have the right, by written notice, to require an EGM to be called by the directors for the transaction of any business specified in such requisition.
- (2) Such requisition shall be made in writing to the directors or the company secretary of the Company and lodged with (i) the head office and (ii) the registered office of the Company in the Cayman Islands at Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman KY1-1111, Cayman Islands.
- (3) The EGM shall be held within two months after the deposit of such requisition.
- (4) If the directors fail to proceed to convene the EGM within twenty-one (21) days of such deposit, the Requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the Requisitionist(s) as a result of the failure of the directors shall be reimbursed to the Requisitionist(s) by the Company.

# Procedures for putting forward proposals at general meetings by shareholders

There are no provisions under the Articles of Association or the Companies Act, Cap 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands regarding procedures for shareholders to put forward proposals at general meetings other than a proposal of a person for election as director. Shareholders may follow the procedures set out above to convene an extraordinary general meeting for any business specified in such written requisition.

# Procedures for Shareholders to Propose a Person for Election as a Director

The following procedures for a shareholder of the Company to propose a person for election as a director of the Company are prepared in accordance with Article 110 of the Articles of Association:

A shareholder may propose a person ("Candidate") for election as a director at a general meeting by lodging the following documents within the period mentioned below at the head office and principal place of business of the Company in Hong Kong at Unit 3 on 10th Floor, Greenfield Tower, Concordia Plaza, No. 1 Science Museum Road, Kowloon, Hong Kong or the branch share registrar and transfer office ("Hong Kong Share Registrar") of the Company in Hong Kong, Tricor Investor Services Limited at Level 54, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong:

- (a) a written notice ("Proposal Notice") of the intention to propose the Candidate for election as a Director, which must (i) state the information of the Candidate as required by Rule 13.51(2) of the Listing Rules, which is available on the Stock Exchange's website (www.hkex.com.hk); and (ii) must be signed by the nominating shareholder; and
- (b) a written notice ("Consent Notice") by the Candidate, which must (i) indicate his/her willingness to be elected as a Director and consent to the publication of his/her personal information as required by Rule 13.51(2) of the Listing Rules; and (ii) must be signed by the Candidate.

The Company shall assess whether or not it is necessary to adjourn the general meeting of the election to give shareholders at least ten (10) business days to consider the relevant information disclosed in the announcement or supplemental circular.

Green initiatives and measures have been adopted in the Group's managed restaurants. Such initiatives include recycling of recyclable waste, various energy saving measures, water saving practices and promoting the awareness of customers and employees. The Group will disclose further details in its Environmental, Social and Governance report which will be published subsequent to this annual report in accordance with the requirement of Rule 13.91 and the reporting framework of Appendix 27 of the Listing Rules.

#### COMPLIANCE WITH LAWS AND REGULATIONS

The Group's operations are mainly carried out by the Company's subsidiaries established in the Mainland China while the Company itself is incorporated in the Cayman Islands with its shares listed on the Stock Exchange. Our establishment and operations accordingly shall comply with relevant laws and regulations in the Cayman Islands, Mainland China and Hong Kong. During the year ended 31 December 2021 and up to the date of this report, as far as the Board and management are aware, the Group has complied with the relevant laws and regulations in the Mainland China, Hong Kong and the Cayman Islands that have a significant impact on the Group.

## **RESULTS AND DIVIDENDS**

The results of the Group for the year ended 31 December 2021 are set out in the consolidated statement of profit or loss on page 101 of this annual report.

An interim special dividend of HK2.50 cents per ordinary share amounting to approximately RMB22,328,000 in total was paid to the shareholders of the Company during the year.

The directors recommended the payment of a final dividend of HK2.5 cents per ordinary share in respect of the year ended 31 December 2021 to the Shareholders whose names appear on the register of members of the Company on 17 June 2022, total amounting to approximately RMB22,059,000. Subject to the approval of the Shareholders at the forthcoming AGM, the final dividend is expected to be paid on 29 July 2022.

There is no arrangement that a shareholder has waived or agreed to waive any dividend.

## **DIVIDEND POLICY**

According to the dividend policy approved and adopted by the Board of the Company with effect from 1 January 2019, the Company considers stable and sustainable returns to shareholders of the Company to be its goal and endeavours to maintain a dividend policy to achieve such goal. In deciding whether to propose a dividend and in determining the dividend amount, the Board would take into account the Group's results of operations, earnings performance, cashflows, financial condition, future prospects and other factors that the Board may consider relevant. Whilst the Board will review from time to time for determination on proposed dividend with the above factors taken into account, there can be no assurance that dividends will be declared or paid in any particular amount for any given period.

## CLOSURE OF REGISTER OF MEMBERS

For the purpose of determining the entitlement of the Shareholders to attend and vote at the AGM, the register of members of the Company will be closed from 6 June 2022 to 10 June 2022 (both days inclusive), during which period no transfer of share(s) will be effected. In order to be eligible to attend and vote at the AGM, all transfers documents, accompanied by the relevant share certificates, must be lodged with Tricor Investor Services Limited, the branch share registrar and transfer office of the Company in Hong Kong, at Level 54, Hopewell Centre, 183 Queen's Road East, Hong Kong for registration not later than 4:30 p.m. on 2 June 2022.

The proposed final dividend is subject to the passing of an ordinary resolution by the Shareholders at the AGM. For the purpose of determining the entitlement of the Shareholders to the final dividend for the year ended 31 December 2021 (if approved), the register of members of the Company will be closed on 17 June 2022, during which no transfer of share(s) will be effected. To be entitled to the final dividend for the year ended 31 December 2021 (if approved), all transfers documents, accompanied by the relevant share certificates, must be lodged with Tricor Investor Services Limited, the branch share registrar and transfer office of the Company in Hong Kong, at Level 54, Hopewell Centre, 183 Queen's Road East, Hong Kong for registration not later than 4:30 p.m. on 16 June 2022.



- (hh) any other group or classes of participants who have contributed or may contribute by way of joint venture, business alliance or other business arrangement to the development and growth of the Company;

#### (v) Time of acceptance and exercise of options

An option may be accepted by a participant within 21 days from the date of the offer of grant of the option.

An option may be exercised in accordance with the terms of the Share Option Scheme at any time during a period to be determined and notified by the directors to each grantee, which period may commence from the date of the offer for the grant of options is made, but shall end in any event not later than 10 years from the date of grant of the option subject to the provisions for early termination thereof. Unless otherwise determined by the directors and stated in the offer for the grant of options to a grantee, there is no minimum period required under the Share Option Scheme for the holding of an option before it can be exercised.

#### (iv) 每名參與者可獲購股權的上限

# *(vi)* Subscription price for the shares and consideration for the option

The subscription price for the shares under the Share Option Scheme shall be a price determined by the directors, but shall not be less than the highest of (i) the closing price of the shares as stated in the Stock Exchange's daily quotations sheet for trade in one or more board lots of the shares on the date of the offer for the grant, which must be a business day; (ii) the average closing price of shares as stated in the Stock Exchange's daily quotations for the five business days immediately preceding the date of the offer for the grant; and (iii) the nominal value of a Share.

A nominal consideration of HK\$1 is payable on acceptance of the grant of an option within such time as maybe specified in the offer for the grant, which shall not be later than 21 days from the date of the offer for the grant.

#### (vii) Period of the Share Option Scheme

The Share Option Scheme remained in force for a period of 10 years commencing on 25 March 2011 and expired on 24 March 2021.

#### (viii) Shares available for issue under the Share Option Scheme

As at 24 March 2021 (being the date of expiry of the Share Option Scheme), the total number of shares which may be issued pursuant to the exercise of options which may be granted under the Share Option Scheme was 80,000,000 shares (after pro-rata adjustments upon the Share Subdivision which became effective on 5 June 2018), representing about 7.43% of the issued share capital of the Company as at 24 March 2021. As at the date of this report, there are no outstanding share options and thus no further shares available for issue under the expired Share Option Scheme.

#### (b) 2011 Share Award Plan

The Board may, subject to and in accordance with the rules of the Share Award Plan adopted on 25 March 2011 (the "2011 Share Award Plan"), make an award of shares to certain classes of eligible participants as specified in the Share Award Plan, as determined by the Board from time to time on the basis of the Board's opinion as to the proposed awardee's contribution and/or future contribution to the development and growth of the Group. The shares and other trust fund for the implementation of the Share Award Plan are administered by a trustee or trustees (the "Share Award Plan Trustee") to be appointed by the Company.

Under the 2011 Share Award Plan, the Board shall determine the eligibility of the eligible participants and the number of shares to be awarded (the "Awarded Shares") and notify the 2011 Share Award Plan Trustee of the making of awards. The 2011 Share Award Plan Trustee shall then set aside the appropriate number of Awarded Shares pending the transfer and vesting to the relevant participants out of a pool of shares which shall comprise of, among others, shares either (1) transferred to it from any person (other than the Group) by way of gift; (2) purchased by the 2011 Share Award Plan Trustee out of the funds received by it by way of gift or for nominal consideration; and (3) subscribed for or purchased by the 2011 Share Award Plan Trustee out of the funds allocated by the Board out of the Group's resources, subject to the terms and conditions of the rules of the 2011 Share Award Plan. The 2011 Share Award Plan Trustee may purchase shares on the Stock Exchange at the prevailing market price or off market. In respect of off-market transactions, purchases shall not be made with any connected person, nor shall the purchase price be higher than the lower of (1) the closing market price on the date of such purchase, and (2) the average closing market price for the five preceding trading days on which shares of the Company were traded on the Stock Exchange. In any given financial year of the Company, the maximum numbers of shares to be purchased by the 2011 Share Award Plan Trustee shall not exceed 10% of the total number of shares in issue of the Company at the beginning of such financial year. The 2011 Share Award Plan Trustee may also subscribe for new shares at par or at such other subscription price as instructed by the Board out of the Group's contribution if the Board considers it appropriate to do so. The Company shall comply with the relevant Listing Rules when granting the Awarded Shares.

The legal and beneficial ownership of the relevant Awarded Shares shall vest in the relevant selected participant within 10 business days after the latest of (1) the date specified on the notice of the award given by the Board to the 2011 Share Award Plan Trustee; and (2) where applicable, the date on which the condition(s) or performance target(s) (if any) to be attained by such selected participant as specified in the related notice of award have been attained and notified to the 2011 Share Award Plan Trustee by the Board in writing.

The 2011 Share Award Plan was valid and effective for a term of 10 years commencing from 25 March 2011 and has expired on 24 March 2021. Taking into account the effect of retrospective adjustment made to the number of shares as a result of Share Subdivision, up to and as at 24 March 2021, 37,249,000 shares had been regarded as awarded and vested to selected grantees under the 2011 Share Award Plan. There was no movement of the Awarded Shares during the year. No further grant of awarded shares shall be made under the 2011 Share Award Plan after its expiry.

#### (c) Share Award Scheme

In view of the expiry of the Share Option Scheme and the 2011 Share Award Plan on 24 March 2021, the Company adopted a new share award scheme (the "Share Award Scheme") on 1 April 2021. The purpose of the Share Award Scheme is to recognize the contributions by certain eligible persons and to provide them with incentives in order to retain them for the continual operation and development of the Group and to attract suitable personnel for the growth and further development of the Group. Subject to any early termination, the Share Award Scheme shall be valid and effective for a term of 10 years commencing on the adoption date.

#### (c) 股份獎勵計劃

鑑於購股權計劃及2011股份獎勵計劃 已於二零二一年三月二十四日屆滿, 本公司於二零二一年四月一日採納新 股份獎勵計劃(「股份獎勵計劃」)。股 份獎勵計劃旨在表彰若干合資格人士 的貢獻,並給予彼等獎勵,以挽留彼等 為本集團的持續營運及發展效力,並 吸引合適人才加入以進一步推動本集 團的發展。除提前終止外,股份獎勵計 劃自採納日期起計10年內有效及生效。





Eligible persons include any of the (i) senior management of any member of the Group; and (ii) employees of the Group other than excluded persons. The selection of the eligible persons and number of awarded shares to be granted must be recommended by the Remuneration Committee and approved by the Board to become effective.

Pursuant to the Share Award Scheme, any awarded shares shall be either (i) existing shares purchased by the trustee of the Share Award Scheme from the open market (either onmarket or off-market); or (ii) new shares to be allotted and issued to the trustee (which will hold the same on behalf of the selected participant(s)) by the Company pursuant to the general mandate granted by the shareholders at the annual general meeting of the Company from time to time. Subject to the rules of the Share Award Scheme, in the event that any awarded shares are to be allotted and issued as new shares under the general mandate, the Company shall comply with the relevant Listing Rules when allotting and issuing any new shares under general mandate and application shall be made to the Stock Exchange for the granting of the listing of, and permission to deal in the new shares to be issued at the time of offering the shares. The Company shall comply with all requirements of the Listing Rules when making any grant of awarded shares under the Share Award Scheme.

Pursuant to the Share Award Scheme, the Board shall not make any further award which will result in the aggregated number of awarded shares granted pursuant to the Share Award Scheme (excluding awarded shares that have been forfeited in accordance with the Share Award Scheme) exceeding 10% of the total number of issued shares from time to time. The maximum number of shares which may be awarded to a selected participant under the Share Award Scheme in any 12-month period shall not exceed 1% of the number of issued shares from time to time. 合資格人士包括(i)本集團旗下任何高級管理人員;及(ii)本集團僱員(被排除人士除外)。合資格人士之選擇及獎勵股份授出的數目,必須由薪酬委員會建議並獲董事會批准,方可生效。

In relation to a selected participant, subject to the fulfilment of all vesting conditions (if any) to the vesting of the awarded shares on such selected participant, the awarded shares held by the trustee on behalf of the selected participant shall be vested and transferred to such selected participant pursuant to the rules of the Share Award Scheme. The Board shall have absolute discretion to waive the fulfilment of any vesting condition.

The trustee shall not exert any power in respect of the voting rights (if any) attached to the shares held under the trust.

No awarded shares were granted under the Share Award Scheme since its adoption. For further details of the Share Award Scheme, please refer to the announcement of the Company dated 1 April 2021.

During the year, the Group had conducted the following nonexempt continuing connected transactions which are required to be disclosed pursuant to Rule 14A.71 of the Listing Rules. Save as disclosed below, the related party transactions disclosed in note 30 to the financial statements are either fully exempt or do not constitute connected transactions or continuing connected transactions under Chapter 14A of the Listing Rules. The Company has complied with the disclosure requirements in accordance with Chapter 14A of the Listing Rules. The Directors were not aware of any transactions requiring disclosure as connected transactions in accordance with the Listing Rules except for those disclosed in this report.

#### (1) Continuing Connected Transactions – CCT Tenancy Agreements

Meco Group, a company incorporated in Hong Kong with limited liability, is principally engaged in property investment. It is owned as to 50% by Mr. CHAN Man Wai, 35% by Mr. YIP Shu Ming and 15% by Mr. KU Hok Chiu. Dongguan Well Excellent, a company established in the PRC with limited liability, is principally engaged in property leasing. It is wholly owned by HK Well Excellent, an investment holding company incorporated in Hong Kong with limited liability and owned as to 50% by Mr. CHAN Man Wai, 35% by Mr. YIP Shu Ming and 15% by Mr. KU Hok Chiu. As Mr. CHAN Man Wai, Mr. YIP Shu Ming and Mr. KU Hok Chiu are the controlling shareholders of the Company and executive directors, each of Meco Group and Dongguan Well Excellent is a connected person of the Company under the Listing Rules.

Pursuant to the CCT Tenancy Agreements entered into between the Group as lessee and Meco Group or (as the case may be) Dongguan Well Excellent as landlord, the Group agreed to lease the premises set out below for a specific term which expired on 31 December 2021. The leased premises are used for operation of restaurant or ancillary office by the respective Group member.

The PRC subsidiaries are required to contribute a certain percentage of their payroll to the retirement benefit schemes to fund the benefits. The only obligation of the Group with respect to the retirement benefit schemes is to make the required contributions under the schemes.

The Group also operates a Mandatory Provident Fund Scheme ("MPF Scheme") for all its qualifying employees in Hong Kong. The assets of the MPF Scheme are held separately from those of the Group in funds under the control of trustees. Under the rule of the MPF Scheme, the employer and its employees are each required to make contributions to the scheme at rate specified in the rules.

The Group contributed RMB44.4 million to the above mentioned schemes for the year ended 31 December 2021.

#### Impairment assessment on property, plant and equipment and right-of-use assets

As at 31 December 2021, the Group had property, plant and equipment of RMB120,510,000 and right-of-use assets of RMB186,197,000. The Group's management performed impairment assessment of property, plant and equipment and right-of-use assets for identified restaurants with impairment indicators by estimating the recoverable amount of their property, plant and equipment and right-ofuse assets based on value-inuse calculation. Impairment losses of approximately RMB2,019,000 and RMB4,288,000 have been recorded to write down the carrying amount of certain property, plant and equipment and right-of-use assets, respectively, to their estimated recoverable amounts. Significant judgement was involved in the assessment of the recoverable amounts of the property, plant and equipment and right-of-use assets of those restaurants, including assumptions on the budgeted gross margin of respective restaurants and discount rates.

Relevant disclosures are included in notes 3.2, 13 and 14 to the financial statements.

Our audit procedures included evaluating the Group's policies and procedures in identifying impairment indicators and assessing management's significant assumptions adopted in the cash flow forecasts by reviewing the Group's business plan and evaluating the growth rate by comparing to market data. In addition, we involved our internal valuation specialists to assist us with our assessment of the methodology and the discount rates used to determine the recoverable amounts of the property, plant and equipment and right-ofuse assets of those restaurants. We also assessed certain inputs of the cash flow forecasts by comparing to underlying records of the Group.

# 2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") (which include all Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations) issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention, except for certain financial instruments which have been measured at fair value. These financial statements are presented in Renminbi ("RMB") and all values are rounded to the nearest thousand except when otherwise indicated.

#### **Basis of consolidation**

The consolidated financial statements include the financial statements of the Company and its subsidiaries (collectively referred to as the "Group") for the year ended 31 December 2021. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e. existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

(a) the contractual arrangement with the other vote holders of the investee;

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

The nature and impact of the revised HKFRSs are described below:

Amendments to HKFRS 9, HKAS 39, HKFRS 7, (a) HKFRS 4 and HKFRS 16 address issues not dealt with in the previous amendments which affect financial reporting when an existing interest rate benchmark is replaced with an alternative risk-free rate ("RFR"). The amendments provide a practical expedient to allow the effective interest rate to be updated without adjusting the carrying amount of financial assets and liabilities when accounting for changes in the basis for determining the contractual cash flows of financial assets and liabilities, if the change is a direct consequence of the interest rate benchmark reform and the new basis for determining the contractual cash flows is economically equivalent to the previous basis immediately preceding the change. In addition, the amendments permit changes required by the interest rate benchmark reform to be made to hedge designations and hedge documentation without the hedging relationship being discontinued. Any gains or losses that could arise on transition are dealt with through the normal requirements of HKFRS 9 to measure and recognise hedge ineffectiveness. The amendments also provide a temporary relief to entities from having to meet the separately identifiable requirement when an RFR is designated as a risk component. The relief allows an entity, upon designation of the hedge, to assume that the separately identifiable requirement is met, provided the entity reasonably expects the RFR risk component to become separately identifiable within the next 24 months. Furthermore, the amendments require an entity to disclose additional information to enable users of financial statements to understand the effect of interest rate benchmark reform on an entity's financial instruments and risk management strategy.

These amendments did not have any significant impact on the Group's financial statements.

The amendment is effective retrospectively for annual periods beginning on or after 1 April 2021 with any cumulative effect of initially applying the amendment recognised as an adjustment to the opening balance of retained profits at the beginning of the current accounting period. Earlier application is permitted.

The Group has early adopted the amendment on 1 January 2021 and applied the practical expedient during the year ended 31 December 2021 to all rent concessions granted by the lessors that affected only payments originally due on or before 30 June 2022 as a direct consequence of the COVID-19 pandemic. A reduction in the lease payments arising from the rent concessions of RMB4,153,000 has been accounted for as a variable lease payment by derecognising part of the lease liabilities and crediting to profit or loss for the year ended 31 December 2021. There was no impact on the opening balance of equity as at 1 January 2021.

Furthermore, the amendments clarify that contingent assets do not qualify for recognition at the acquisition date. The Group expects to adopt the amendments prospectively from 1 January 2022. Since the amendments apply prospectively to business combinations for which the acquisition date is on or after the date of first application, the Group will not be affected by these amendments on the date of transition.

Amendments to HKFRS 10 and HKAS 28 (2011) address an inconsistency between the requirements in HKFRS 10 and in HKAS 28 (2011) in dealing with the sale or contribution of assets between an investor and its associate or joint venture. The amendments require a full recognition of a gain or loss resulting from a downstream transaction when the sale or contribution of assets between an investor and its associate or joint venture constitutes a business. For a transaction involving assets that do not constitute a business, a gain or loss resulting from the transaction is recognised in the investor's profit or loss only to the extent of the unrelated investor's interest in that associate or joint venture. The amendments are to be applied prospectively. The previous mandatory effective date of amendments to HKFRS 10 and HKAS 28 (2011) was removed by the HKICPA in January 2016 and a new mandatory effective date will be determined after the completion of a broader review of accounting for associates and joint ventures. However, the amendments are available for adoption now.

Amendments to HKAS 1 Classification of Liabilities as Current or Non-current clarify the requirements for classifying liabilities as current or non-current. The amendments specify that if an entity's right to defer settlement of a liability is subject to the entity complying with specified conditions, the entity has a right to defer settlement of the liability at the end of the reporting period if it complies with those conditions at that date. Classification of a liability is unaffected by the likelihood that the entity will exercise its right to defer settlement of the liability. The amendments also clarify the situations that are considered a settlement of a liability. The amendments are effective for annual periods beginning on or after 1 January 2023 and shall be applied retrospectively. Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

Amendments to HKAS 1 Disclosure of Accounting Policies require entities to disclose their material accounting policy information rather than their significant accounting policies. Accounting policy information is material if, when considered together with other information included in an entity's financial statements, it can reasonably be expected to influence decisions that the primary users of general purpose financial statements make on the basis of those financial statements. Amendments to HKFRS Practice Statement 2 provide non-mandatory guidance on how to apply the concept of materiality to accounting policy disclosures. Amendments to HKAS 1 are effective for annual periods beginning on or after 1 January 2023 and earlier application is permitted. Since the guidance provided in the amendments to HKFRS Practice Statement 2 is non-mandatory, an effective date for these amendments is not necessary. The Group is currently assessing the impact of the amendments on the Group's accounting policy disclosures.

Amendments to HKAS 8 clarify the distinction between changes in accounting estimates and changes in accounting policies. Accounting estimates are defined as monetary amounts in financial statements that are subject to measurement uncertainty. The amendments also clarify how entities use measurement techniques and inputs to develop accounting estimates. The amendments are effective for annual reporting periods beginning on or after 1 January 2023 and apply to changes in accounting policies and changes in accounting estimates that occur on or after the start of that period. Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

The amendments are effective for annual reporting periods beginning on or after 1 January 2023 and shall be applied to transactions related to leases and decommissioning obligations at the beginning of the earliest comparative period presented, with any cumulative effect recognised as an adjustment to the opening balance of retained profits or other component of equity as appropriate at that date. In addition, the amendments shall be applied prospectively to transactions other than leases and decommissioning obligations. Earlier application is permitted.

Upon initial application of these amendments, the Group will recognise a deferred tax asset and a deferred tax liability for deductible and taxable temporary differences associated with right-of-use assets and lease liabilities, and recognise the cumulative effect of initially applying the amendments as an adjustment to the opening balance of retained profits at the beginning of the earliest comparative period presented.

The amendments are effective for annual periods beginning on or after 1 January 2022 and shall be applied retrospectively only to items of property, plant and equipment made available for use on or after the beginning of the earliest period presented in the financial statements in which the entity first applies the amendments. Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

Amendments to HKAS 37 clarify that for the purpose of assessing whether a contract is onerous under HKAS 37, the cost of fulfilling the contract comprises the costs that relate directly to the contract. Costs that relate directly to a contract include both the incremental costs of fulfilling that contract (e.g., direct labour and materials) and an allocation of other costs that relate directly to fulfilling that contract (e.g., an allocation of the depreciation charge for an item of property, plant and equipment used in fulfilling the contract as well as contract management and supervision costs). General and administrative costs do not relate directly to a contract and are excluded unless they are explicitly chargeable to the counterparty under the contract. The amendments are effective for annual periods beginning on or after 1 January 2022 and shall be applied to contracts for which an entity has not yet fulfilled all its obligations at the beginning of the annual reporting period in which it first applies the amendments. Earlier application is permitted. Any cumulative effect of initially applying the amendments shall be recognised as an adjustment to the opening equity at the date of initial application without restating the comparative information. The amendments are not expected to have any significant impact on the Group's financial statements.

An entity applies the amendment to financial liabilities that are modified or exchanged on or after the beginning of the annual reporting period in which the entity first applies the amendment. #### Investments in joint ventures

A joint venture is a type of joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint venture. Joint control is the contractually agreed sharing of control of an arrangement, where exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control.

The Group's investments in joint ventures are stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting less any impairment losses.

Adjustments are made to bring into line any dissimilar accounting policies that may exist.

The Group's share of the post-acquisition results and other comprehensive income of joint ventures is included in the consolidated statement of profit or loss and consolidated other comprehensive income, respectively. In addition, when there has been a change recognised directly in the equity of the joint venture, the Group recognises its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealised gains and losses resulting from transactions between the Group and its joint ventures are eliminated to the extent of the Group's investments in the joint ventures, except where unrealised losses provide evidence of an impairment of the asset transferred. Goodwill arising from the acquisition of joint ventures is included as part of the Group's investments in joint ventures.

If an investment in an associate becomes an investment in a joint venture or vice versa, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method. In all other cases, upon loss of joint control over the joint venture, the Group measures and recognises any retained investment at its fair value. Any difference between the carrying amount of the joint venture upon loss of joint control and the fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

#### Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, deferred tax assets and financial assets), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cashgenerating unit's value-in-use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs. In testing a cash-generating unit for impairment, a portion of the carrying amount of a corporate asset (e.g., a headquarters building) is allocated to an individual cash-generating unit if it can be allocated on a reasonable and consistent basis or, otherwise, to the smallest group of cash-generating units.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value-in-use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to the statement of profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired assets.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to the statement of profit or loss in the period in which it arises.

#### Fair value measurement

The Group measures its equity and debt investments at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

#### Fair value measurement (Continued)

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

- Level 1 based on quoted prices (unadjusted) in active markets for identical assets or liabilities
- Level 2 based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly
- Level 3 based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

For assets and liabilities that are recognised in the financial statements on a recurring basis, the Group determines whether transfers have occurred between levels in the hierarchy by reassessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

The Group recognises an allowance for expected credit losses ("ECLs") for all debt instruments not held at fair value through profit or loss. #### General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the reporting instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

The Group considers a financial asset in default when contractual payments are 90 days past due. #### Simplified approach

For trade receivables that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

#### **Financial liabilities**

#### Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings, payables or as derivatives designated as hedging instruments in an effective hedge, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

Gains and losses are recognised in the statement of profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in the statement of profit or loss.

#### **Derecognition of financial liabilities**

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in the statement of profit or loss.

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

#### Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the first-in, first-out basis. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to completion and disposal.

#### Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the consolidated statement of financial position, cash and cash equivalents comprise cash on hand and at banks, including term deposits, and assets similar in nature to cash, which are not restricted as to use.

## **Provisions**

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in profit or loss.

#### **Income tax**

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the jurisdictions in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

#### **Revenue recognition**

#### Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

## Sale of goods

Revenue from the sale of goods is recognised at the point in time when control of the asset is transferred to the customer, generally on delivery of the goods.

Commission income is recognised when the services have been rendered.

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

#### **Contract liabilities**

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

#### **Share-based payments**

The Company operates a share award plan for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group's operations. Employees (including directors) of the Group receive remuneration in the form of share-based payments, whereby employees render services as consideration for equity instruments ("equity-settled transactions").

The cost of equity-settled transactions with employees for grants after 7 November 2002 is measured by reference to the fair value at the date at which they are granted. Further details of which are given in note 27 to the financial statements.

The charge or credit to the statement of profit or loss for a period represents the movement in the cumulative expense recognised as at the beginning and end of that period.

Service and non-market performance conditions are not taken into account when determining the grant date fair value of awards, but the likelihood of the conditions being met is assessed as part of the Group's best estimate of the number of equity instruments that will ultimately vest. Market performance conditions are reflected within the grant date fair value. Any other conditions attached to an award, but without an associated service requirement, are considered to be non-vesting conditions. Non-vesting conditions are reflected in the fair value of an award and lead to an immediate expensing of an award unless there are also service and/or performance conditions.

For awards that do not ultimately vest because non-market performance and/or service conditions have not been met, no expense is recognised. Where awards include a market or non-vesting condition, the transactions are treated as vesting irrespective of whether the market or non-vesting condition is satisfied, provided that all other performance and/or service conditions are satisfied.

#### **Employee benefits**

#### Pension schemes

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance for all of its employees. Contributions are made based on a percentage of the employees' basic salaries and are charged to the statement of profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

The employees of the Group's subsidiaries which operate in Mainland China are required to participate in a central pension scheme operated by the local municipal government. These subsidiaries are required to contribute a certain percentage of their payroll costs to the central pension scheme. The contributions are charged to the statement of profit or loss as they become payable in accordance with the rules of the central pension scheme.

#### **Borrowing costs**

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs capitalised. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

#### **Dividends**

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting. Proposed final dividends are disclosed in the notes to the financial statements.

Interim dividends are simultaneously proposed and declared, because the Company's memorandum and articles of association grant the directors the authority to declare interim dividends. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared.

#### **Foreign currencies**

The Company's functional currency is the Hong Kong dollar, while these financial statements are presented in RMB, which is the Company's presentation currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

#### Foreign currencies (Continued)

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

The functional currencies of certain subsidiaries are currencies other than the RMB. As at the end of the reporting period, the assets and liabilities of these entities are translated into the presentation currency of the Company at the exchange rates prevailing at the end of the reporting period and their statements of profit or loss are translated into RMB at the exchange rates that approximate to those prevailing at the dates of the transactions.

For the purpose of the consolidated statement of cash flows, the cash flows of the subsidiaries operate outside Mainland China are translated into RMB at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of the subsidiaries operate outside Mainland China which arise throughout the year are translated into RMB at the weighted average exchange rates for the year.

The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve. On disposal of a foreign operation, the component of other comprehensive income relating to that particular foreign operation is recognised in the statement of profit or loss.

# 3.2 SIGNIFICANT ACCOUNTING JUDGEMENTS AND ESTIMATES

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

#### **Judgements**

In the process of applying the Group's accounting policies, management has made the following judgements, apart from those involving estimations, which have the most significant effect on the amounts recognised in the financial statements:

#### Impairment of assets

In determining whether an asset is impaired or the event previously causing the impairment no longer exists, the Group has to exercise judgement in the area of asset impairment, particularly in assessing: (1) whether an event has occurred that may affect the asset value or such event affecting the asset value has not been in existence; (2) whether the carrying value of an asset can be supported by the net present value of future cash flows which are estimated based upon the continued use of the asset or derecognition; and (3) the appropriate key assumptions to be applied in preparing cash flow projections including whether these cash flow projections are discounted using an appropriate rate. Changing the assumptions selected by management to determine the level of impairment, including the discount rates or the growth rate assumptions in the cash flow projections, could materially affect the net present value used in the impairment test.

#### **Estimation uncertainty**

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

#### Depreciation of property, plant and equipment

The Group depreciates the different classes of property, plant and equipment on a straight-line basis at applicable depreciation rates over the estimated useful life. The useful life is estimated with reference to the wear and tear history of property, plant and equipment. The estimated useful life reflects the directors' estimate of the periods that the Group intends to derive future economic benefits from the use of the Group's property, plant and equipment.

## Impairment of property, plant and equipment and rightof-use assets

The Group determines whether property, plant and equipment and right-of-use assets are impaired when there are indicators that the carrying amounts may not be recoverable. An impairment exists when the carrying value of the property, plant and equipment and right-of-use assets exceeds its recoverable amount, which is the higher of its fair value less costs of disposal and its value-in-use. The calculation of the fair values less costs of disposal is based on available data from binding sales transactions in an arm's length transaction of similar assets or observable market price less incremental costs for disposing of the asset. When value-in-use calculations are undertaken, management must estimate the expected future cash flows from the asset or cash-generating unit using key assumptions such as growth rate and budgeted gross margin and choose a suitable discount rate in order to calculate the present value of those cash flows. Further details are given in notes 13 and 14 to the financial statements.

#### Fair value of unlisted equity and debt investments

The Group determines the fair values of unlisted equity and debt investments based on quoted market prices whenever possible. If such quoted market prices are not available or an active market does not exist, the Group determines the fair values based on internally developed models which make use of market parameters, such as net assets of the underlying investments. Any changes in these parameters can affect the estimates of the fair values of these investments. The Group classifies the fair values of the unlisted equity and debt investments as Level 3. The fair values of the unlisted equity and debt investments at 31 December 2021 were RMB23,301,000 (2020: RMB13,620,000) and RMB28,521,000 (2020: RMB26,208,000), respectively. Further details are included in notes 17 and 32 to the financial statements.

#### Leases - Estimating the incremental borrowing rate

The Group cannot readily determine the interest rate implicit in a lease, and therefore, it uses an incremental borrowing rate ("IBR") to measure lease liabilities. The IBR is the rate of interest that the Group would have to pay to borrow over a similar term, and with a similar security, the funds necessary to obtain an asset of a similar value to the right-of-use asset in a similar economic environment. The IBR therefore reflects what the Group "would have to pay", which requires estimation when no observable rates are available (such as for subsidiaries that do not enter into financing transactions) or when it needs to be adjusted to reflect the terms and conditions of the lease (for example, when leases are not in the subsidiary's functional currency). The Group estimates the IBR using observable inputs (such as market interest rates) when available and is required to make certain entityspecific estimates (such as the subsidiary's stand-alone credit rating).

For management purposes, the Group is organised into business units based on geographical areas and has four reportable operating segments as follows:

Segment performance is evaluated based on reportable segment profit/loss, which is a measure of adjusted profit/loss before tax. The adjusted profit/loss before tax is measured consistently with the Group's profit before tax except that certain interest income, share of losses of joint ventures, change in fair value of a financial asset at fair value through profit or loss, unallocated expenses and finance costs (other than interest on lease liabilities) are excluded from such measurement.

Inter-segment sales and transfers are transacted with reference to the selling prices used for sales made to third parties at the then prevailing market prices.

#### Information about major customers

There was no revenue from customers individually contributing over 10% to the total revenue of the Group.

At 31 December 2021, the Group's management identified certain restaurants which were loss-making and performed impairment assessment of property, plant and equipment for identified restaurants with impairment indicators and estimated corresponding recoverable amounts of the property, plant and equipment based on value-in-use calculation. Based on these estimates, an impairment loss of RMB2,019,000 (2020: RMB2,503,000) was recognised to write down the carrying amounts of certain property, plant and equipment to their estimated recoverable amounts as at 31 December 2021. The recoverable amount of the items of property, plant and equipment is determined based on a value-in-use calculation using cash flow projections based on financial budgets covering the remaining useful lives of the respective property, plant and equipment. The pre-tax discount rates applied for the cash flow projections ranged from 11.5% to 14.5% (2020: 11.5% to 14.5%).

At 31 December 2021, the Group's management identified certain restaurants which were loss-making and performed impairment assessment of right-of-use assets for the identified restaurants with impairment indicators and estimated the corresponding recoverable amounts of the right-of-use assets based on value-in-use calculation. Based on these estimates, an impairment loss of RMB4,288,000 (2020: RMB5,802,000) was recognised to write down the carrying amounts of certain right-of-use assets to their estimated recoverable amounts as at 31 December 2021. Certain of the Group's cash at banks earns interest at floating rates based on daily bank deposit rates. The Group has tax losses arising in Hong Kong of RMB25,948,000 (2020: RMB20,019,000) that are available indefinitely for offsetting against the future taxable profits of the company in which the losses arose. As at 31 December 2021, no deferred tax asset was recognised in respect of the tax losses in Hong Kong of RMB5,858,000 (2020: RMB6,287,000) due to the unpredictability of future profit streams.

The Group has tax losses arising in Mainland China of RMB34,036,000 (2020: RMB31,802,000) that will expire in one to five years for offsetting against future taxable profits of the companies in which the losses arose. Pursuant to the PRC Corporate Income Tax Law, a 10% withholding tax is levied on dividends declared to foreign investors from the foreign investment enterprises established in Mainland China. The requirement is effective from 1 January 2008 and applies to earnings after 31 December 2007. A lower withholding tax rate may be applied if there is a tax treaty between Mainland China and the jurisdiction of the foreign investors. For the Group, the applicable rate is 5% or 10%. The Group is therefore liable for withholding taxes when dividends distributed by those subsidiaries established in Mainland China in respect of earnings generated from 1 January 2008.

At the end of the reporting period, the aggregate amount of temporary difference associated with undistributed earnings of subsidiaries was approximately RMB285,010,000 (2020: RMB298,692,000). A deferred tax liability has been recognised in respect of approximately RMB124,106,000 (2020: RMB104,645,000) of such undistributed earnings. No deferred tax liability has been recognised in respect of the undistributed earnings of certain subsidiaries of RMB160,904,000 (2020: RMB194,047,000) because the Group is in a position to control the timing of the reversal of the temporary differences and it is probable that such differences will not be reversed in the foreseeable future.

There are no income tax consequences attaching to the payment of dividends by the Company to its shareholders.

## 26. RESERVES

#### Statutory general reserve

The statutory general reserve represents the appropriation of 10% of profit after taxation determined based on the relevant accounting rules and regulations of the PRC as required by the Articles of Association of the Company's PRC subsidiaries. The appropriation may cease to apply if the balance of the statutory general reserve has reached 50% of the PRC subsidiaries' registered capital.

#### **Other reserve**

The other reserve includes: (a) the difference between the nominal value of the share capital issued by Tang Palace F&B Enterprise Limited ("Tang Palace BVI") and the nominal value of share capital of the subsidiaries acquired by Tang Palace BVI, (b) the deemed contribution from a controlling shareholder of RMB1,866,000 arising on the acquisition of the remaining 10% equity interest in Meco Petrochemical Limited from Mr. Hui Yui Chuen ("Mr. Hui"), a noncontrolling shareholder, by Mr. Chan, a founder shareholder of the Company, on 23 December 2009 and representing the unaudited combined net asset value of Meco Petrochemical Limited attributable to Mr. Hui as at 30 November 2009 reclassified from non-controlling interests as deemed contribution by Mr. Chan, (c) the difference between the subscription price and the nominal value of the shares allotted and issued by Tang Palace BVI of RMB35,014,000 and the deemed contribution from controlling shareholders of RMB107,215,000 and (d) the difference between the then nominal value of 1,999,999 shares of HK\$0.1 each in the Company's issued share capital and the entire issued share capital of Tang Palace BVI of US\$50,000 eliminated as a result of the Group Reorganisation.

### 27. SHARE-BASED PAYMENT TRANSACTIONS

#### Share Award Plan

The Company adopted a share award plan on 25 March 2011 which was revised on 22 March 2013 (the "Share Award Plan") pursuant to which the board of directors may, subject to and in accordance with the rules of the Share Award Plan, make an award of shares to certain classes of eligible participants as specified in the Share Award Plan, as determined by the board of directors from time to time on the basis of the opinion of the board of directors as to the proposed awardee's contribution and/or future contribution to the development and growth of the Group. The shares and other trust fund for the implementation of the Share Award Plan are administered by a trustee or trustees (the "Share Award Plan Trustee") to be appointed by the Company.

Under the Share Award Plan, the board of directors shall determine the eligibility of the eligible participants and the number of shares to be awarded (the "Awarded Shares") and notify the Share Award Plan Trustee of the making of awards. The Awarded Shares are either (1) transferred from any person (other than the Group) by way of gift; (2) purchased by the Share Award Plan Trustee out of the funds received by way of gift or for nominal consideration; or (3) subscribed for or purchased by the Share Award Plan Trustee out of the funds allocated by the board of directors out of the Group's resources, subject to the terms and conditions of the rules of the Share Award Plan. The Share Award Plan Trustee may purchase shares on the Stock Exchange at the prevailing market price or off market, or subscribe for new shares at par or at such other subscription price as instructed by the board of directors out of the Group's contribution if the board of directors considers it appropriate to do so.

The Share Award Plan has expired on 24 March 2021 and no further grant of awarded shares shall be made under it after its expiry.

The fair value of the financial asset at fair value through profit or loss is estimated by an independent valuer by discounting the expected future cash flows using rates currently available for instruments with similar terms, credit risk and remaining maturities. The significant unobservable input is the discount rate. The increase/decrease in this significant unobservable input would decrease/increase in fair value of the financial asset at fair value through profit or loss.

The main risks arising from the Group's financial instruments are foreign currency risk, credit risk and liquidity risk. The directors meet periodically to analyse and formulate measures to manage each of these risks and they are summarised below.

#### Foreign currency risk

The Group has transactional currency exposures. Such exposures arise from sales or purchases by operating units in currencies other than the units' functional currencies. It is the Group's policy not to enter into forward contracts until a firm commitment is in place.

The Group manages its capital structure and makes adjustments to it in light of changes in economic conditions and the risk characteristics of the underlying assets. To maintain or adjust the capital structure, the Group may adjust the dividend payment to shareholders, return capital to shareholders or issue new shares. No changes were made in the objectives, policies or processes for managing capital during the years ended 31 December 2021 and 31 December 2020.

The capital structure of the Group consists of cash and cash equivalents and equity attributable to owners of the Company, comprising issued capital and reserves as disclosed in the consolidated statement of financial position.

The directors of the Company review the capital structure periodically. As part of this review, the directors consider the cost of capital and risk associated with each class of capital. Based on recommendations of the directors, the Group will balance the overall capital structure of the Group through the payment of dividends, new share issues as well as the raising of new bank loans.

The Group monitors capital using a gearing ratio, which is calculated as bank borrowings divided by total equity. The gearing ratio as at the end of the reporting period was 12.5% (2020: 17.8%).
