Chairman's Statement 主席報告

Dear Shareholders,

On behalf of the board (the "Board") of directors (the "Directors") of Yan Tat Group Holdings Limited (the "Company"), I am pleased to present the audited consolidated results of the Company and its subsidiaries (collectively referred to as the "Group") for the year ended 31 December 2021.

Our Group's turnover increased from approximately HK\$587.1 million in 2020 to approximately HK\$763.8 million in 2021, representing an increase of approximately 30.1%. Gross profit was approximately HK\$143.0 million in 2021, representing an increase of approximately 4.7% from that of 2020. Profit attributable to ordinary equity holders of the Company was approximately HK\$46.2 million in 2021, representing an increase of approximately 19.4% from that of 2020. The increase in net profit was primarily due to the corresponding increase of orders from customers as a result of the recovery of global economy from the coronavirus disease 2019 (the "COVID-19").

Printed circuit board (the "PCB") is the bridge that carries electronic components and connects to the circuit. Therefore, many people describe PCB as the "the mother of electronic products". It is widely used in the fields of communication electronics, consumer electronics, computers, automotive electronics, industrial controller, medical devices, national defense and aerospace, etc. It is everywhere around modern electronic world. Due to the wide market of downstream consumers of PCB products, this industry is less affected as compared to other industries with a single downstream industry, and the total output value of the global PCB industry is mainly closely related to the macroeconomic conditions.

The PCBs enjoy extensive applications, which cover 3C products, Internet-of-Things, self-driving vehicles, big data, automotive electronization and electrification, and more. The development of every application will drive the demand for PCBs. In particular, the application of 5G technology and the development of electrical vehicles will require a massive supply of PCBs, ushering in a wonderful business opportunity. 各位股東:

本人謹代表恩達集團控股有限公司(「本公司」)之董事 (「董事」)會(「董事會」),欣然呈報本公司及其附屬公 司(統稱為「本集團」)截至二零二一年十二月三十一日 止年度之經審核綜合業績。

本集團之營業額由二零二零年的約587.1百萬港元上 升至二零二一年約763.8百萬港元,增幅約為30.1%。 於二零二一年,毛利約為143.0百萬港元,較二零二零 年上升約4.7%。於二零二一年,本公司普通權益持有 人應佔溢利約46.2百萬港元,較二零二零年上升約 19.4%。純利上升主於全球的經濟從2019冠狀病毒病 (「COVID-19」)疫情中復甦,導致客戶的銷售訂單相應 增加所致。

印刷電路板(PCB)是承載電子元器件並連接電路的橋 樑,所以不少人描述PCB為「電子產品之母」,它廣泛 應用於通訊電子、消費電子、計算機、汽車電子、工 業控制、醫療器械、國防及航空航天等領域,在現代 電子世界無處不在,由於PCB產品下游受眾市場較廣, 產業受單一下游行業的影響相對其他產業較小,全球 PCB行業總產值主要與宏觀經濟狀況緊密聯繫。

PCB應用層面廣,涉及3C產品、物聯網、自動駕駛汽 車、大數據、汽車電子化電氣化等等,每項應用的發 展,都會牽領PCB需求,特別是5G技術的應用和電動 汽車的發展,將需要大量PCB供應,這是一個極大的 商機。

Chairman's Statement 主席報告

Looking back at 2021, COVID-19 was still affecting across the globe, but the indication of recovery appeared after the successive usage of various types of vaccines and various countries relaxed restrictions at the beginning of last year. However, variant viruses emerged, especially Delta and Omicron. and spread rapidly, causing the restrictions in various countries to be tightened again. This struck again the economic downturn and significantly affected the supply chains in different industries due to the slow flow of people and logistics across the globe and the instability and uncertainties significantly increased. The appropriate pandemic control by the PRC government helped the production activities recover. On the contrary, the production activities in other regions were disrupted and unstable and many merchants have shifted their orders to the PRC and therefore there was an encouraging increase in the sales volume of domestic manufacturers in 2021. This trend will extend to 2022 and the production base of the Company set in the Mainland China will follow this opportunity and take a share of the spoils.

Last but not least, I would like to take this opportunity to extend my sincere gratitude to all fellow Directors, management and our staff for their unwavering dedication and contribution to our Group's development. I would also like to thank all of our shareholders, for their trust and continuous support over a challenging but rewarding 2021. 回顧二零二一年,全球仍然受到COVID-19影響,在多 款疫苗相繼使用下,復甦的跡象萌現,年初各國有放 鬆管制的行動,可是新變種病毒的出現,特別是德爾 塔及奧密克戎的迅速擴散,令各國再次收緊管制,這 對低迷經濟再作打擊,全球物流人流緩慢,大大影響 各行各業的供應鏈,不穩定性不確定性明顯增加。由 於中國政府對疫情控制得宜,生產活動回復正常,反 觀其他地區,生產活動停擺不定,不少商家把訂單轉 到中國來,所以國內廠商的銷售量在二零二一年有不 錯的增長,這個勢頭亦會延續至二零二二年,本公司 的生產基地設置在中國內地,將能緊隨這個機會分一 杯羹。

最後,本人謹藉此機會衷心感謝全體董事、管理層及 旗下職工的竭誠投入以及對本集團發展的貢獻。本人 亦謹此感謝全體股東於充滿挑戰又具意義的二零二一 年裡一直給予信任及一如既往的支持。

INDUSTRY OVERVIEW

The printed circuit board, also known as "PCB", is mainly comprised of insulation base materials and conductors. PCBs, which support and connect electronic devices as they provide connection between electric components, are components required to combine a majority of electronic devices with electronics, machinery, and chemical materials. They are also given the name of "the mother of electronic products".

In 2021, under the backdrop of the coronavirus disease 2019 ("COVID-19") pandemic and complicated international relations, the global economy recorded moderate growth as compared to 2020. According to the International Monetary Fund ("IMF"), the economy is estimated to have increased by about 5.9% in 2021. Although a number of COVID-19 vaccines were approved for use in early 2021, the outbreak of another wave of the COVID-19 pandemic, together with rapid spread of Delta and Omicron variants, brought adverse effects to the economic development. Under uncertain circumstances, IMF predicts that the global economy grows by about 4.4% in 2022.

In 2019, under the effect of trade friction, decline in terminal demand and exchange rate depreciation, the output value of PCBs in the global market amounted to US\$61.3 billion. Although the COVID-19 pandemic in 2020 has an impact on the industry, the rapid development of 5G technology has given the PCB industry more room for growth. The research report states that the output value of PCBs in the global market amounted to approximately US\$65.2 billion in 2020 and it is predicted that it will reach approximately US\$78.0 billion by 2026.

The PCB industry has been long established, with its early presence mainly distributed in Europe, North America, and Japan. Due to global migration of the electronics sector, Asia takes the lead in the PCB industry development on the globe. According to the information available, the output value of PCBs in the PRC was approximately US\$35.05 billion in 2020, accounting for approximately 53.8% of the global market share.

A PCB is a necessary component of electronic products. With continuous technological advancements, the demand for PCBs is steady and is expected to grow continuously. The range of application of PCBs is extensive, including communication electronics, consumer electronics, computers, automotive electronics, industrial controller, medical devices, national defense and aerospace and other fields. In recent years, driven by the demands of emerging sectors such as 5G technology, new energy vehicles, Internet-of-Things, big data, cloud computing, energy conservation and environmental protection, and information security, good business opportunities will be maintained in the PCB market.

行業概覽

印刷電路板,又稱「PCB」,主要由絕緣基材與導體兩 類材料組成。PCB是電子元器件連接的提供者,在電 子設備中起支撐、互連的作用,是結合電子、機械、 化工材料等絕大多數電子設備產品必需的元件,又被 稱為「電子產品之母」。

二零二一年在2019冠狀病毒病(「COVID-19」)疫情及 複雜的國際關係的環境下,全球經濟雖然較二零二零 年好,但只有溫和的增長,據國際貨幣基金組織 (「IMF」)估計二零二一年的經濟增長約5.9%。雖然在 二零二一年初多款COVID-19疫苗相繼獲准使用,但新 一波疫情來襲,加上變種病毒德爾塔及奥密克戎迅速 傳播,均對經濟發展造成不利影響,在這不確定性的 情況下,IMF預計二零二二年全球經濟增長約4.4%。

二零一九年受貿易磨擦、終端需求下降和匯率貶值等 影響,全球市場的PCB產值為613億美元。二零二零 年COVID-19疫情對行業雖有所影響,但5G科技的快 速發展讓PCB行業的成長空間不斷加大。有研究報告 二零二零年全球市場的PCB產值為約652億美元,更 預計二零二六年達到約780億美元。

PCB行業發展悠久,早年主要分佈在歐洲、北美、日本等,隨著全球電子產業轉移,亞洲主導全球PCB產業發展。根據可得資料顯示,二零二零年中國PCB產值約為350.5億美元,全球市場佔比約53.8%。

PCB作為電子產品中不可或缺的元件,隨著科技水平 的不斷提升,其需求穩定且將持續增長,其應用領域 之廣,包含了通訊電子、消費電子、計算機、汽車電 子、工業控制、醫療器械、國防及航空航天等領域。 近年來,隨著5G科技、新能源汽車、物聯網、大數 據、雲計算、節能環保、信息安全等新興領域需求的 帶動,PCB市場將保持不錯的商機。

Automobile electronics has become a global trend, which promotes the rapid growth of automobile PCBs. PCBs are widely used in engine, control, safety, information and in-vehicle systems. Compared with conventional vehicles, the requirement of electronics for new energy vehicle is higher and the PCB value of new energy vehicles is approximately 4 times than that of conventional vehicles. In view of the immense effort in promoting the development of new energy vehicle by countries around the world, it shall create tremendous business opportunities to the PCB market in the future.

The new applications of PCBs will further drive the development of the PCB industry. The 5G technology deployment will significantly advance the progress of the PCB industry. In 2020, 5G technology-related PCB orders focused on base station construction. It is estimated that there are approximately 0.6 million newly-built 5G base stations in the PRC for 2021 and will reach its maximum in 2022 at approximately 1.1 million. After that , the number will be gradually reduced to approximately 0.44 million in 2026. With the establishment of a complete 5G network, it also accelerates the formation of the consumer 5G electronics industry chain. It is expected that prospect will emerge in the PCB market.

Although the PCB market has an encouraging prospect, it also faces numerous difficulties. As the PRC government has strengthened its efforts on environmental protection, manufacturing enterprises that fail to meet the requirements will be subject to rectification, or even replacement or suspension. As a result, compliant PCB manufacturers are required to increase investments in environmental engineering and wastewater treatment capacities, which undoubtedly adds weight on their operating costs.

The COVID-19 outbreak in early 2020, which has spread across China with worldwide infection, has caused material impact on a wide range of economic activities. The operation of PCB manufacturers is inevitably affected. Although a number of COVID-19 vaccines have been approved for use worldwide in 2021, their effectiveness fell short of expectations. The emerging of new variants Delta and Omicron, which have higher transmission, has brought more uncertainties to the duration of the pandemic, and even slowed down the development of global economy.

Against the capacity expansion launched by many PCB manufacturers amid a growing number of new PCB manufacturers in recent years, as well as the failure of production and technology capacities to meet market demands, the market has eventually become aggressive, with the possibility of triggering a fierce pricing competition. With the unit price being adjusted downwards, the slim profit margin will further shrink.

汽車電子化是大勢所趨,推動汽車PCB高速增長,無 論是發動機系統、操縱系統、安全系統、信息系統及 車內環境系統等等,都不難找到PCB的蹤影,相比傳 統型汽車,新能源汽車對電子程度的要求更高,新能 源汽車的PCB價值量是傳統型汽車的約4倍,隨著各 國正大力推動新能源汽車的發展,可為未來PCB市場 帶來無限商機。

PCB新應用更能帶動PCB行業發展,5G科技建置將大 大推動PCB產業前進,二零二零年,5G科技相關的 PCB訂單以基站建設為主,二零二一年中國估計新建 約60萬座5G基站,二零二二年將達至峰值,新建約 110萬座,之後開始逐步回落,二零二六年將新建約 44萬座,隨著完善的5G網絡成立,消費類的5G電子 產業鏈亦會加速形成,預期PCB市場將有另一番景象。

儘管PCB市場確有不錯的前景,但是也面對不少的困難。隨著中國政府對環保力度加強,未能達標的生產 企業會面對被整改,更甚至被取替或停產,因此合規 的PCB制造商,在環保工程及廢水處理投放力度亦有 所提升,無疑加重PCB製造商的運營成本。

二零二零年初在全國爆發COVID-19,更蔓延世界各地,該情況嚴重影響各式各樣的經濟活動,PCB製造商的營運亦無一倖免。雖然多款COVID-19疫苗在二零二一年相繼在世界各地批准使用,但是成效未達預期,新變種病毒相繼出現,德爾塔及奧密克戎的傳播力更強,這給疫情的持續時間帶來了更多不確定性,這更會拖慢全球的經濟發展。

隨著近年不少PCB製造商擴產,新進PCB製造商不斷 增加,而生產技術能力未達目前市場需求能力,結果 令市場變得激進,有機會引發激烈的價格競爭,當單 位價格下調,微薄利潤會再度收窄。

The labor costs in China have been on the rise over the past decade, as corporate expenditure rises due to full implementation of policies on social security and public housing fund. A phenomenon of "recruitment difficulty, labor shortage" often appears in the developed coastal areas, in which case, recruitment of frontline employees, particularly seasoned technicians, becomes increasingly difficult. As a result, many domestic PCB enterprises gradually relocate their production bases to inland provinces and cities, or undergo comprehensive reform to accelerate the process of production automation and intellectualization to reduce the dependence on manpower and ensure the stability of quality.

The price increase of raw materials is a problem that PCB manufacturers have generally faced since the second half of 2020. The reason behind is the continuous impact of the COVID-19 pandemic on production capacity and freight. The contradiction between the supply and demand of upstream raw materials such as copper foil, resin and aluminum sheet was prominent. Their price began to rise sharply in mid 2020, which forced PCB material manufacturers to decide to adjust product prices due to cost pressure, which would then be passed down to PCB manufacturers. There would even be tight supply of raw materials, and the situation of shortages and price increase in raw materials continued in 2021. After rounds of price increase, it stabilized from its peak at the end of 2021, and at the same time, PCB enterprises also transferred part of its costs to the downstream, resulting in gradual stabilization of profitability.

BUSINESS REVIEW AND DEVELOPMENT

The Group is an original equipment manufacturer ("OEM") provider of PCBs and focused on the production of quality PCBs, which meet industrial standards such as IPC Standards, as well as the customers' requirement.

We focused on the conventional PCBs with a well-developed capacity to produce multi-layered and special material PCBs with primary applications in cars, communication equipment, medical devices, industrial automation equipment and consumer electronics.

Our continuous diversification of product mix and market coverage allow the Group to swiftly cater for the changes in demand from certain sectors and adjust our production output accordingly, resulting in reduced reliance on a single product and market. Benefited from the enormous business opportunities generated from automobile electronics in recent years, the proportion of our revenue generated from this section is correspondingly higher. 中國國內勞動成本在過去十年不斷上升,全面實施社 會保障和住房公積金政策增加企業的成本,在沿海發 達地區經常出現「招工難,用工荒」的現象,招聘一線 員工(特別是有經驗的技術員)更見困難,因此國內不 少PCB企業將生產基地逐漸遷往內地省市或進行全面 改革,加快加大力度進行生產自動化、智能化,減少 人力的依賴,又可保證品質的穩定性。

原材料漲價,是PCB生產商在二零二零年下半年起普 遍面對的問題,背後的其中原因是COVID-19疫情對產 能及貨運持續衝擊,包括銅箔、樹脂、鋁板等上游原 材料供需矛盾突出,其價格在二零二零年年中開始大 幅上漲,這迫使PCB材料廠制造商出於成本壓力決定 調整產品價格,從而向下傳至PCB製造商,更甚的, 會出現原材料供應緊張,這原材料缺貨漲價的現象在 二零二一年持續,經過多輪漲價,在二零二一年末才 從頂峰回穩,同時PCB企業亦逐漸將部份成本向下遊 轉嫁,盈利能力亦逐步回穩。

業務回顧及發展

本集團為PCB原設備製造(「OEM」)供應商,專注於從 事製造高質量PCB,產品皆符合行業標準(例如IPC標 準),以及我們客戶的規定。

我們的目標鎖定在傳統PCB,並具備製造多層及特殊物料PCB的完備能力,主要應用於汽車、通訊設備、 醫療設備、工業自動化設備以及電子消費品。

我們持續多元化的產品組合及市場覆蓋讓本集團能夠 快速迎合部分行業的需求變化,據此調節我們的產出, 從而減少對單一產品及市場的依賴,受惠於近年汽車 電子化的龐大商機,該部分產生的收益比重相應較大。

Over the past 32 years of our operation, the Group has established a solid foundation and close relationship with our customers. The Group provided direct and indirect services to OEM customers across Asia, Europe, Africa, North America, South America and Oceania, who are engaged in various industries with many of them running in a multinational model. Certain of our major OEM customers are leading players in their markets. The Group supplied PCB products directly to a number of leading electronic manufacturing service providers, in order to assemble finished goods of OEM for the Group's indirect OEM customers. To date, the Group has built up long-term relationship with major customers, and some of them have been working with us for over a decade. The Company believed that these customers also considered the Group as their important partner for their supply chain. Therefore, our profound and longterm relationship with customers will enable the Group to know the trend of customers' demand more quickly.

The Group is of the view that product and process quality are integral to its business. The Group complies with various international quality standards and systems, including ISO9001, ISO14001 and IATF16949 certifications. The Group has put in place a number of quality measures and simplification plan to promote a culture of quality product. Quality is of paramount importance to the business of the Group and is regularly reviewed and improved by dedicated personnel to enhance customer satisfaction. In addition, the Group obtained AS9100 certification in 2009 to qualify for the provision of advanced and reliable PCBs for the aerospace industry. This is a testament to our product quality.

The high production cost continues to affect the PCB industry in the current year. Followed by the sweep of emission limits and environmental protection measures across China, PCB manufacturers are facing steep challenges. As a PCB manufacturer, the Group needs to formulate appropriate responses and increase the capital input in respect of environmental protection resulting in the set-off of part of the profits of the Group. However, viewing from another perspective, manufacturers failing to meet the required standards would be eliminated or would have to enhance their operation cost in order to comply with the required standards, whereas the Group has realized the need for environmental protection and has made relevant investment many years ago. Therefore, compared with those failing to meet the standards, the Group is under less pressure in such new setting in the PCB market and better positioned to seize opportunities.

Although China remains to be the "World Factory", labor costs are no longer as low as a decade before and have gradually increased. In addition, the labor supply is insufficient in the coastal areas. The Group enhanced its production automation, promoted the use and flow of production information, optimized and improved costs and quality which could eventually lead the Group to develop towards intelligent production in the future. 在過去超過三十二年的經營,本集團已建立穩固的根 基及深厚的客戶關係,本集團向遍佈在亞洲、歐洲、 非洲、北美洲、南美洲及大洋洲的原設備製造商客戶 提供直接及間接的服務,該等客戶在林林總總的行業 經營,許多更以跨國模式運作。若干主要原設備製造 商客戶為其所屬市場中的表表者。本集團亦向多家領 先電子製造服務提供者,直接供應PCB產品,藉以為 本集團的間接原設備造商客戶組裝原設備製造商製成 品。迄今,本集團與主要客戶建立長遠關係,當中部 分已合作逾十載,而本公司相信彼等亦視本集團為其 供應鏈上的重要夥伴。因此,與客戶所建立的深厚長 久關係,可使本集團更快掌握客戶需求的動向。

本集團認為,產品及工序的質素對其業務有關鍵作用。 本集團符合多項國際品質標準及系統,包括ISO9001、 ISO14001及IATF16949認證。本集團亦已實施多項品 質方案及簡化計劃,以促進優質產品文化。品質乃本 集團業務的關鍵所在,並由專人定期作出檢討及改善, 藉以提升客戶滿意度,此外,本集團於二零零九年獲 得AS9100認證,籍以能夠為航天工業供應高科技及可 靠性高的PCB,此舉乃對我們的產品質量的一種肯定。

高生產成本持續於本年度影響PCB行業,緊隨著限排 環保措施的旋風席捲全中國,各PCB製造商正面臨對 此嚴竣的挑戰,作為PCB製造商的本集團,更需要考 慮適當的應對方法,加大對環保的資金投入,因而抵 銷了本集團一部分利潤;但在另一角度看,未能達標 的生產企業,有可能被淘汰,或大大增加成本來符合 標準,而本集團早在多年前已注意到環保需要,作出 相應投入。因此,在PCB市場新的環境下,本集團較 其他未達標的企業,壓力較少,而此消彼長,可能有 更好的機遇。

雖然中國仍是「世界工廠」,惟十多年前較低的勞工成 本已日漸上升,沿海地區的勞工供應,亦有不足的情 況,本集團加強生產自動化,促進生產信息的運用流 轉,優化改善成本與質量,日後更令本集團最終朝著 智能化生產方向邁進。

In 2021, COVID-19 is still bringing serious negative consequences to people's living and the global economy. Despite successive use of vaccines over the world, low vaccination rates are recorded in many regions. A worse case happened when variant strains of virus emerged threatening the pace of global recovery. As the production base of the Company is located in Mainland China, where effective control over the COVID-19 pandemic is easily observed, its production environment is better than other regions. However, the Company shall pay attention to changes in situation for the pandemic and shall adjust its production strategy accordingly.

For the circuit board industry, raw materials account for a large proportion of costs. Since mid-2020, the prices of a variety of major raw materials such as copper clad laminates, prepregs and copper foils have been soaring incessantly. They stabilized from its peak at the end of 2021. Amid this difficult environment, customers are eagerly required to share the effects of rising costs, while the profit margin of the Company is inevitably reduced.

In 2021, serious challenges exposed the Group to a lot of risks and uncertainties. The Group has been concentrating on its PCB business for over 30 years, in which the accumulated experience and networks allow the Group to make further development in the PCB market. With the rapid progress of the urbanization in Shenzhen, the Shenzhen Pingshan District Government has also made strategic planning for promoting its local development. Given the increased labor costs in Shenzhen and the need to maintain competitiveness and respond to the future change in the planned use of the current production area of Yan Tat Printed Circuits (Shenzhen) Co., Ltd., after consultation with the Board and the professional advisers, the Group plans to establish another production base in the Greater Bay Area to support the long-term development of the Group. Apart from the headquarters in China and the research and development department which will remain located in Pingshan District, Shenzhen, the bulk production capacity of the Group will be relocated gradually to the new production base. The Group entered into a cooperation agreement with independent third parties in relation to the urban renewal project located at the current production area in Pingshan District. At the same time, the Group will also consider opportunities to maximize shareholders' benefits from time to time.

二零二一年,COVID-19仍然在民生與全球經濟帶來嚴 重的負面影響,雖然多款疫苗在世界各地相繼使用, 但很多地區的接種率偏低,更甚的是出現變種病毒株, 這正威脅全球的復甦步伐。由於本公司的生產基地位 處中國內地,中國對COVID-19疫情控制非常之有效, 所在在生產環境上較其他生產地區好,但本公司亦留 意疫情變化,而調整相應的生產策略。

電路板行業,原材料佔成本的比重很大,自二零二零 年中期,多種主要原材,如銅箔基板、半固化黏合材 料、銅箔等價格相繼持續大幅上漲。直至二零二一年 末才從高峰回穩,在這艱難的環境下,本公司積極地 要求客戶分攤成本上升帶來的影響,與此同時,公司 利潤率也難免下調。

二零二一年,嚴峻的挑戰令本集團面對不少風險及不 明朗因素。本集團專注PCB業務超過三十年,所累積 經驗及網絡有利本集團在PCB市場進一步發展,隨深 圳城市化的忽速發展,深圳市坪山區政府亦制定策略 規劃以支持當地發展。鑒於深圳勞動成本增加,為保 規劃用途改變,經董事會及專業顧問共同研究後決定, 為配合長遠發展,本集團計劃在大灣區發展另一個生 產基地,除保留本集團中國總部及研發部門在深圳坪 山區外,將其大批量生產逐步遷往新基地,本集團與 獨立第三方就坪山現廠區之城市更新項目的發展簽訂 合作協議,與此同時,本集團亦會不時考慮為股東爭 取最大利益的機會發展。

FINANCIAL REVIEW

The Group's turnover for the year of 2021 was approximately HK\$763.8 million, representing an increase of approximately 30.1% compared to that of the previous year, which was primarily attributable to the increase in sales orders from customers due to the global economic recovery from COVID-19 pandemic in 2021.

The Group's gross profit for the year of 2021 was approximately HK\$143.0 million, representing an increase of approximately 4.7% compared to that of the previous year, primarily due to the increase in sales and production in volume. Gross profit margin decreased by approximately 4.6% to 18.7% from 23.3%, which was primarily attributable to the increase in the price of major raw materials.

The Group's total operating expenses for the year of 2021 were approximately HK\$95.7 million, representing an increase of approximately 0.6% compared to approximately HK\$95.1 million for the previous year, primarily due to the increase in selling and distribution expenses.

The Group's EBITDA amounted to approximately HK\$92.7 million for the year of 2021 as compared to approximately HK\$82.6 million for the previous year.

The Group recorded a profit attributable to ordinary equity holders of the Company of approximately HK\$46.2 million for the year of 2021 as compared to approximately HK\$38.7 million for the previous year.

Other income and gain

Other income and gain increased by approximately HK\$0.9 million, or 4.9%, to approximately HK\$19.1 million for the year ended 31 December 2021 from approximately HK\$18.2 million for the year ended 31 December 2020, primarily due to the net effect of the decrease in government grants of approximately HK\$6.4 million, and the increase in income linked to recycling of approximately HK\$7.1 million.

本集團於二零二一年之營業額約763.8百萬港元,較 去年增加約30.1%,主要由於二零二一年,全球的經 濟從COVID-19疫情中復甦,導致客戶的銷售訂單相應 增加。

本集團於二零二一年之毛利約143.0百萬港元,較去 年增加約4.7%,主要由於銷量及產量增加。毛利率由 23.3%減少約4.6%至18.7%,主要由於主要原材料價 格上升所致。

本集團於二零二一年的經營開支總額約為95.7百萬港 元,較去年約95.1百萬港元增加約0.6%,主要由於銷 售及分銷開支增加所致。

本集團於二零二一年的EBITDA約為92.7百萬港元,而 去年則約為82.6百萬港元。

本集團於二零二一年錄得本公司普通權益持有人應佔 溢利約46.2百萬港元,而去年則約為38.7百萬港元。

其他收入及收益

其他收入及收益由截至二零二零年十二月三十一日止 年度約18.2百萬港元增加約0.9百萬港元或4.9%,至 截至二零二一年十二月三十一日止年度約19.1百萬港 元,主要由於政府補貼減少約6.4百萬港元,及回收相 關的收入增加約7.1百萬港元的淨影響。

Selling and distribution expenses

Selling and distribution expenses increased by approximately HK\$3.5 million, or 23.6%, to approximately HK\$18.3 million for the year ended 31 December 2021 from approximately HK\$14.8 million for the year ended 31 December 2020. The increase was primarily due to increase in commission and transportation cost resulting from the increase in sales orders.

General and administrative expenses

General and administrative expenses decreased by approximately HK\$3.0 million, or 3.7%, to approximately HK\$77.3 million for the year ended 31 December 2021 from approximately HK\$80.3 million for the year ended 31 December 2020. The decrease was primarily due to the decrease in legal and professional fees of approximately HK\$3.8 million.

Other expenses

Loss on disposal of old machinery amounted to approximately HK\$3.1 million and write-off of old machinery amounted to approximately HK\$4.0 million were incurred during the year ended 31 December 2020. As only write-off of old machinery amounted to approximately HK\$0.3 million and other miscellaneous expenses were incurred for the year ended 31 December 2021, other expenses decreased significantly.

Finance costs

Finance costs decreased by approximately HK\$1.4 million, or 77.8%, to approximately HK\$0.4 million for the year ended 31 December 2021 from approximately HK\$1.8 million for the year ended 31 December 2020. The decrease was primarily due to the decrease in the amount of bank loans interest resulting from the decrease in average bank borrowings during the year ended 31 December 2021.

Profit attributable to ordinary equity holders of the Company

The Group recorded profit attributable to ordinary equity holders of the Company of approximately HK\$46.2 million for the year ended 31 December 2021 compared to approximately HK\$38.7 million for the year ended 31 December 2020, representing an increase of approximately 19.4%. The increase of profit attributable to ordinary equity holders of the Company was mainly due to the net effect of the increase in gross profit of approximately HK\$6.5 million, the increase in other income and gain of approximately HK\$0.9 million, the increase in selling and distribution expenses of approximately HK\$3.5 million, the decrease in general and administrative expenses of approximately HK\$6.4 million, the decrease in other expenses of approximately HK\$1.4 million and the increase in income tax expense of approximately HK\$7.1 million.

銷售及分銷開支

銷售及分銷開支由截至二零二零年十二月三十一日止 年度約14.8百萬港元增加約3.5百萬港元或23.6%, 至截至二零二一年十二月三十一日止年度約18.3百萬 港元。有關增幅主要由於銷售訂單增加以致佣金及運 輸成本增加。

一般及行政開支

一般及行政開支由截至二零二零年十二月三十一日止 年度約80.3百萬港元減少約3.0百萬港元或3.7%,至 截至二零二一年十二月三十一日止年度約77.3百萬港 元。此減幅主要由於法律及專業費用減少約3.8百萬港 元所致。

其他開支

於二零二零年十二月三十一日止年內產生出售舊機器 的虧損約3.1百萬港元及舊機器撇銷約4.0百萬港元。 於截至二零二一年十二月三十一日止年度只有舊機器 撇銷約0.3百萬港元及其他雜項支出,使其他開支大幅 減少。

融資成本

融資成本由截至二零二零年十二月三十一日止年度約 1.8百萬港元減少約1.4百萬港元或77.8%,至截至二 零二一年十二月三十一日止年度約0.4百萬港元。有關 減幅主要由於截至二零二一年十二月三十一日止年內 平均銀行借款減少以致銀行貸款利息下跌所致。

本公司普通權益持有人應佔溢利

截至二零二一年十二月三十一日止年度,本集團錄得 本公司普通權益持有人應佔溢利約46.2百萬港元,較 截至二零二零年十二月三十一日止年度約38.7百萬港 元增加約19.4%。本公司普通權益持有人應佔溢利增 加主要由於毛利增加約6.5百萬港元;其他收入及收益 增加約0.9百萬港元;銷售及分銷開支增加約3.5百萬 港元;一般及行政開支減少約3.0百萬港元;其他開支 減少約6.4百萬港元;融資成本減少約1.4百萬港元; 及所得税開支增加約7.1百萬港元的淨影響。

Property, plant and equipment

The net carrying amount as at 31 December 2021 was approximately HK\$347.1 million, representing a decrease of approximately HK\$12.6 million from that of 31 December 2020. This was mainly due to the net effect of (i) depreciation of approximately HK\$27.4 million with respect to the Group's property, plant and equipment in the current year, (ii) increase in exchange realignment of approximately HK\$10.6 million, (iii) total additions during the year of approximately HK\$8.1 million, and (iv) reclassification to assets classified as held for sale of approximately HK\$3.6 million.

Trade and bills receivables

There was an increase in trade and bills receivables of approximately HK\$22.5 million as at 31 December 2021 as compared to that as at 31 December 2020, which was mainly due to the rise in sales in the fourth quarter of 2021 as compared to the fourth quarter of 2020.

Trade payables

There was an increase in trade payables as at 31 December 2021 of approximately HK\$15.2 million as compared to that as at 31 December 2020, which was mainly due to the increase of trade payables caused by the rise in sales in the fourth quarter of 2021 as well as purchases.

Bank and other borrowings

The Group had bank borrowings as at 31 December 2021 in the sum of approximately HK\$32.0 million, representing an increase of approximately HK\$26.5 million from the sum of approximately HK\$5.5 million as at 31 December 2020. The increase in borrowings was mainly due to the increased use of trade finance in the fourth quarter of 2021 as compared to the fourth quarter of 2020. No financial instruments were used for hedging purposes, nor were there any foreign currency net investments hedged by current borrowings and/or other hedging instruments.

Liquidity and financial resources

As at 31 December 2021, the Group had current assets of approximately HK\$679.9 million (2020: HK\$563.1 million) including cash and cash equivalents and pledged deposits totalling approximately HK\$304.4 million (2020: HK\$276.5 million). As at 31 December 2021, the Group had non-current liabilities of approximately HK\$159.2 million (2020: HK\$155.8 million), and its current liabilities amounted to approximately HK\$265.3 million (2020: HK\$210.5 million), consisting mainly of payables arising in the normal course of operations and bank borrowings for financing of production facilities. Accordingly, the Group's current ratio, being the ratio of current assets to current liabilities, was around 2.6 as at 31 December 2021 (2020: 2.7).

物業、廠房及設備

於二零二一年十二月三十一日,賬面淨值約為347.1 百萬港元,較二零二零年十二月三十一日減少約12.6 百萬港元,主要由於(i)本集團物業、廠房及設備的本 年度折舊約27.4百萬港元,(ii)匯兑調整增加約10.6百 萬港元,(iii)年內添置總計約8.1百萬港元,及(iv)重新 分類至分類為持作出售之資產約3.6百萬港元的淨影響。

貿易應收款項及應收票據

於二零二一年十二月三十一日之貿易應收款項及應收 票據較二零二零年十二月三十一日增加約22.5百萬港 元,主要由於二零二一年第四季度相較二零二零年第 四季度銷售額有所上升。

貿易應付款項

於二零二一年十二月三十一日之貿易應付款項較二零 二零年十二月三十一日增加約15.2百萬港元,主要由 於二零二一年第四季度的銷售上升的同時,採購上升, 從而導致貿易應付款項增加。

銀行及其他借款

於二零二一年十二月三十一日,本集團的銀行借款合計約為32.0百萬港元,較二零二零年十二月三十一日 合共約5.5百萬港元增加約26.5百萬港元。借款增加 主要由於二零二一年第四季度使用貿易融資相較二零 二零年第四季度有所上升所致。並未動用財務工具作 對沖用途,亦無通過現有借款及/或其他對沖工具對 沖任何外幣淨投資。

流動資金及財務資源

於二零二一年十二月三十一日,本集團流動資產約為 679.9百萬港元(二零二零年:563.1百萬港元),包括 現金及現金等價物及已抵押存款總計約304.4百萬港 元(二零二零年:276.5百萬港元)。於二零二一年十二 月三十一日,本集團非流動負債約為159.2百萬港元(二 零二零年:155.8百萬港元),而其流動負債約為265.3 百萬港元(二零二零年:210.5百萬港元),主要包括一 般業務過程中產生的應付款項及就生產設施融資之銀 行借款。因此,於二零二一年十二月三十一日,本集 團的流動比率(流動資產除以流動負債)約為2.6(二零 二零年:2.7)。

Gearing ratio

The gearing ratio of the Group, calculated as total borrowings over total equity, was approximately 0.05 as at 31 December 2021 (2020: approximately 0.01).

Treasury policies

The Group has adopted a prudent financial management approach towards its treasury policies and thus maintained a healthy liquidity position throughout the year of 2021. The Group strives to reduce exposure to credit risk by performing ongoing credit assessments and evaluations of the financial status of its customers. To manage liquidity risk, the Board closely monitors the Group's liquidity position to ensure that the liquidity structure of the Group's assets, liabilities and other commitments can meet its funding requirements from time to time.

Foreign exchange exposure

As at 31 December 2021, we had cash and cash equivalents, pledged deposits, trade and bills receivables, trade payables, other payables and interest-bearing bank borrowings which are denominated in currencies other than Hong Kong dollar, and consequently we have foreign exchange exposure from translation of amounts denominated in foreign currencies as at the reporting date. During the year ended 31 December 2021, the Group did not engage in any derivatives activities and did not commit to any financial instruments to hedge its foreign currency exposure.

Capital structure

There has been no change in the capital structure of the Company during the current and previous years. The capital of the Company is comprised of ordinary shares and capital reserves.

Capital commitments

As at 31 December 2021, capital commitments of the Group amounted to approximately HK1.6 million (2020: HK1.5 million).

Dividend

The Board recommended the payment of a final dividend of HK6.0 cents per share for the year ended 31 December 2021 (2020: HK6.0 cents per share).

The proposed dividend is subject to approval by the shareholders of the Company at the annual general meeting to be held on Thursday, 2 June 2022 and, if approved, is expected to be paid on or about Wednesday, 6 July 2022 to shareholders whose names appear on the register of members of the Company on Wednesday, 15 June 2022. The dividend is declared and will be paid in HKD.

資產負債比率

於二零二一年十二月三十一日,本集團之資產負債比 率(按總借款除以總權益計算)約為0.05(二零二零年: 約0.01)。

庫務政策

本集團已就庫務政策採取審慎的財務管理方針,因此 於二零二一年內維持穩健流動資金狀況。本集團透過 持續進行信貸評估及評估其客戶財務狀況,致力減低 信貸風險。為管理流動資金風險,董事會密切監察本 集團流動資金狀況,確保本集團資產、負債及其他承 擔之流動資金結構能應付不時之資金需要。

外匯風險

於二零二一年十二月三十一日,我們有並非以港元計 值的現金及現金等價物、已抵押存款、貿易應收款項 及應收票據、貿易應付款項、其他應付款項及計息銀 行借款,因此我們於報告日期面對換算外幣計值金額 之外匯風險。於截至二零二一年十二月三十一日止年 度,本集團並無從事任何衍生工具活動,亦無作出任 何財務工具承擔,以對沖所面對之外匯風險。

資本架構

於本年度及去年,本公司資本架構概無變動。本公司 資本包括普通股及資本儲備。

資本承擔

於二零二一年十二月三十一日,本集團的資本承擔約 為1.6百萬港元(二零二零年:1.5百萬港元)。

股息

董事會建議就截至二零二一年十二月三十一日止年度 派付末期股息每股6.0港仙(二零二零年:每股6.0港 仙)。

建議股息須經本公司股東於二零二二年六月二日(星期 四)舉行的股東週年大會上批准後方可作實,倘批准, 預期將於二零二二年七月六日(星期三)或前後向於二 零二二年六月十五日(星期三)名列本公司股東名冊的 股東派付股息。股息以港元宣派並將以港元派付。

Dividend Policy

The Board regularly reviews and manages its capital structure to ensure an optimal capital structure and shareholders' return when its dividend policy considers:

- the Group's actual and expected financial performance;
- retained profits and distributable reserves of the Group;
- return on equity and other corresponding restrictions of the Group;
- the Group's capital requirement and surplus;
- the Group's liquidity position;
- general economic conditions, business cycle of the Group's business and internal or external factors that may have an impact on the business, financial results and position of the Company; and
- other factors that the Board deems relevant.

The Board will continue to review the Group's dividend policy from time to time and there can be no assurance that dividends will be paid in any particular amount for any given period.

The payment of dividend is also subject to any restrictions under the applicable laws and the Company's Articles of Association.

Closure of the Register of Members

To determine the eligibility of the shareholders of the Company to attend the annual general meeting of the Company ("AGM") to be held on Thursday, 2 June 2022, the register of members will be closed from Monday, 30 May 2022 to Thursday, 2 June 2022, both days inclusive, during which period no transfer of shares will be effected. In order to be entitled to attend and vote at the AGM, all transfer forms accompanied by the relevant share certificates must be lodged with the Company's Hong Kong branch share registrar, Tricor Investor Services Limited, Level 54, Hopewell Centre, 183 Queen's Road East, Hong Kong, for registration not later than 4:30 p.m. on Friday, 27 May 2022.

In addition, to determine shareholders' entitlement to the dividend, the register of members will be closed from Monday, 13 June 2022 to Wednesday, 15 June 2022, both days inclusive, during which period no transfer of shares will be effected. Information on employees

As at 31 December 2021, the Group had 766 employees (2020: 739 employees), including the executive Directors, amongst others, 482 males and 284 females. Total employee benefit expense (including Directors' remuneration) was approximately HK\$88.0 million, as compared to approximately HK\$80.0 million for the year ended 31 December 2020. Remuneration is determined with reference to market norms and individual employee's performance, gualification and experience.

On top of basic salaries, bonuses may be paid by reference to the Group's performance as well as the individual's performance. Other staff benefits include contributions to Mandatory Provident Fund scheme in Hong Kong, and various welfare plans including the provision of pension funds, medical insurance and other relevant insurance for employees of our Group.

The salaries and benefits of the Group's employees are kept at a competitive level and employees are rewarded on a performance-related basis within the general framework of the Group's salary and bonus system, which is reviewed annually. The Group also operates a share option scheme adopted by the Company on 18 November 2014 ("Share Option Scheme") where options to subscribe for shares may be granted to the Directors and employees of the Group.

Details of the Share Option Scheme are disclosed in the section headed "Share Option Scheme" on pages 47 to 49 of this annual report.

The Company did not grant any share option under the Share Option Scheme during the current and prior years. Details of remuneration of Directors and chief executive and the five highest paid individuals of the Group for the year ended 31 December 2021 are set out in note 8 and note 9 to the consolidated financial statements.

Significant investments held

As at 31 December 2021, the Group did not hold any significant investment.

Future plans for material investments and capital assets

Other than those disclosed in this annual report, on 8 May 2020, the Group has entered into, amongst others, a cooperation agreement for the urban renewal project located at our production base in Pingshan District, Shenzhen, the PRC. The entering into of the cooperation agreement and the transactions thereunder have been approved by the shareholders of the Company at the extraordinary general meeting on 14 July 2020. For details, please refer to the Company's announcements dated 15 May 2020 and 14 July 2020, and the circular dated 24 June 2020. Also, the Group is currently exploring the opportunity and proactively discussing with independent third parties in relation to the investment of the establishment of a Greater Bay Area production base for the production of PCBs. The Company will make further disclosure as and when appropriate pursuant to the relevant requirements of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited ("Listing Rules").

Material acquisitions and disposals of subsidiaries, associates and joint ventures

On 8 May 2020, the Group has entered into a cooperation agreement with independent third parties on a disposal of certain parcels of land located in Pingshan New District, Shenzhen, with certain parcels of the land being used by the Group for the production of PCB, through disposal of subsidiaries of the Group and/or disposal of the relevant land and properties in relation to an urban renewal project. As at the date of this annual report, as Urban Renewal Approval (${\rm int}$, has not yet been obtained, the disposals have not been materialised. For further details, please refer to Company's announcements dated 15 May 2020 and 14 July 2020, and the circular dated 24 June 2020.

Save as disclosed above and those disclosed in this annual report, the Group did not have any material acquisitions and disposals of subsidiaries, associates and joint ventures during the year ended 31 December 2021.

Charges on assets

As at 31 December 2021, certain assets of the Group as set out below were charged to secure banking facilities granted to the Group:

- (i) the Group's investment property amounting to approximately HK\$6.9 million (2020: HK\$6.7 million).

Prospects

COVID-19 continues to affect the global economy and people's livelihoods, with new variant viruses becoming more infectious. The effectiveness of the "coexistence with virus" and "zero-COVID" approaches will have to be seen in time. It is certain that the economic development in 2022 will be affected by the ups and downs of the pandemic. The United States' unfriendly policies towards China (i.e. high tariffs, suppression of Chinese enterprises and restrictions on technology transfer) will have adverse effects on Chinese enterprises. The outbreak of war between Russia and Ukraine will have far-reaching impact on the world, depending on the development of the war. This, coupled with geopolitical issues around the world, has added to the political and economic uncertainties. In 2021, major raw materials such as copper clad laminates, the prices of prepregs and copper foils, which have gone up several times, are now at high level, which will continue to eat into the profits of circuit boards manufacturers in the coming year. In short, the future challenges will be more severe. Although we have a diversified market and industry sector, a broad high-guality customer base, and strong defensiveness, the general unfavorable environment has a negative impact on the Company. The Company is closely monitoring external developments and its own internal customer orders to make appropriate adjustments accordingly.

Events after reporting period

There were no other significant events from the end of the reporting period up to the date of this annual report.

Mr. Chan has more than 31 years of experience in the PCB production and sales.

CORPORATE GOVERNANCE PRACTICES

Adapting and adhering to recognised standards of corporate governance principles and practices has always been one of the top priorities of the Company. The Board believes that good corporate governance is one of the areas that leads to the success of the Company and in balancing the interests of shareholders, customers and employees, and the Board is devoted to ongoing enhancements of the efficiency and effectiveness of such principles and practices.

From 1 January 2021 up to the date of this annual report, the Company had complied with the code provisions ("Code Provisions") set out in the Corporate Governance Code previously contained in Appendix 14 to the Listing Rules, except code provision A.2.1 as more particularly described below.

Pursuant to code provision A.2.1 of the Corporate Governance Code set out in Appendix 14 of the Listing Rules, the responsibilities between the chairman and the chief executive officer should be segregated and should not be performed by the same individual. However, we do not have a separate chairman and chief executive officer and Mr. Chan Wing Yin currently performs these two roles. The Board believes that vesting the roles of both chairman and chief executive officer in the same person has the benefit of ensuring consistent leadership within the Group and enables more effective and efficient overall strategic planning for the Group. The Board considers that the balance of power and authority for the present arrangement will not be impaired and this structure will enable the Company to make and implement decisions promptly and effectively. The Board will continue to review and consider splitting the roles of chairman of the Board and chief executive officer of the Company at a time when it is appropriate and suitable by taking into account the circumstances of the Group as a whole.

On 1 January 2022, the amendments to the Corporate Governance Code (the "New CG Code") came into effect and the requirements under the New CG code will apply to corporate governance reports for financial year commencing on or after 1 January 2022. The Company will continue to review its corporate governance practices in order to enhance its corporate governance standard, to comply with the increasingly tightened regulatory requirements and to meet the rising expectations of the shareholders and investors.

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

Pursuant to code provision A.2.1 of the Corporate Governance Code previously set out in Appendix 14 of the Listing Rules, the responsibilities between the chairman and the chief executive officer should be segregated and should not be performed by the same individual. However, we do not have a separate chairman and chief executive officer and Mr. Chan Wing Yin currently performs these two roles. The Board believes that vesting the roles of both chairman and chief executive officer in the same person has the benefit of ensuring consistent leadership within our Group and enables more effective and efficient overall strategic planning for our Group. The Board considers this structure will enable our Company to make and implement decisions promptly and effectively. The Board believes that the balance of power and authority is adequately ensured by the operation of the Board, which comprises experienced and high calibre individuals with a sufficient number thereof being independent non-executive Directors.

APPOINTMENT, RE-ELECTION AND REMOVAL

Each of the executive Directors has entered into a service contract with the Company, non-executive Director and each of the independent non-executive Directors has signed a letter of appointment with the Company. Such term is for an initial term of three years commencing from the Listing Date (except for Mr. Lau Shun Chuen and Mr. Chan Yan Kwong, whose term is for three years commencing from his date of appointment) and shall continue subject to termination by either party in accordance with the terms thereof and the retirement and re-election provisions in accordance with the articles of association of the Company.

In accordance with the articles of association of the Company, at each annual general meeting ("AGM") one third of the Directors for the time being shall retire from office by rotation. However, if the number of Directors is not a multiple of three, then the number nearest to but not less than one third shall be the number of retiring Directors. The Directors who shall retire in each year will be those who have been longest in the office since their last re-election or appointment but as between persons who become or were last re-elected Directors on the same day those to retire will (unless they otherwise agree among themselves) be determined by the Company. Such retiring Directors may, being eligible, offer themselves for re-election at the AGM. All Directors appointed by the Board to fill a casual vacancy shall hold office until the first general meeting of shareholders after their appointment and be subject to reelection at such meeting and all Directors appointed by the Board as an addition to the existing Board shall hold office only until the next following AGM and shall then be eligible for reelection.

The primary duties of the nomination committee are to review the structure, size and composition of the Board on regular basis; identify individuals suitably qualified to become Board members; assess the independence of independent nonexecutive Directors; and make recommendations to the Board on relevant matters relating to the appointment or re-appointment of Directors. The nomination committee comprises three independent non-executive Directors, namely Mr. Lau Shun Chuen (Chairman), Mr. Chung Yuk Ming and Mr. Yau Wing Yiu, one executive Director, namely Mr. Chan Yan Wing, and one non-executive Director, namely Mr. Chan Yan Kwong.

For the year under review, the Nomination Committee held one meeting, in which it reviewed the structure of the Board and recommended to the Board for reappointment of all directors at the forthcoming annual general meeting. The Nomination Committee also determined the criteria of the board diversity policy (the "Board Diversity Policy").

When identifying suitable candidates for directorship, the nomination committee will carry out the selection process by making reference to the skills, experience, education background, professional knowledge, personal integrity and time commitments of the proposed candidates, and also the Company's needs and other relevant statutory requirements and regulations required for the positions. All candidates must be able to meet the standards as set forth in Rules 3.08 and 3.09 of the Listing Rules. A candidate who is to be appointed as an independent non-executive Director should also meet the independence criteria set out in Rule 3.13 of the Listing Rules. Qualified candidates will then be recommended to the Board for approval.

To enhance the quality of the performance of the Board and to achieve diversity on the Board, the Board adopted on 18 November 2014 the Board Diversity Policy, pursuant to which (i) differences in the skills, regional and industry experience, background, race, gender and other qualities of Directors will be taken into account in determining the optimum composition of the Board; and (ii) all Board appointments will be based on merit while taking into account diversity (including gender diversity). For the purpose of implementation of the Board Diversity Policy, the following measurable objectives were adopted:

- (A) at least one-third of the members of the Board shall be independent non-executive directors;
- (B) at least one of the members of the Board shall have obtained accounting or other professional qualifications;
- (C) at least 70% of the members of the Board shall have more than seven years of experience in the industry he/she is specialised in; and
- (D) at least two of the members of the Board shall have China-related work experience.

For the year ended 31 December 2021, the Board has fulfilled the measurable objectives of the Board Diversity Policy.

REMUNERATION COMMITTEE

The Company established a remuneration committee pursuant to a resolution of the Directors passed on 18 November 2014 with written terms of reference in compliance with Rule 3.25 and Rule 3.26 of the Listing Rules. The written terms of reference of the remuneration committee was adopted in compliance with the Code Provisions. Its terms of reference are available on the websites of the Company and the Stock Exchange.

The primary duties of the remuneration committee are to make recommendations to the Board on the overall remuneration policy and structure relating to all Directors and senior management of the Group and ensure none of the Directors determine their own remuneration. The emoluments of executive Directors are determined based on the skills, knowledge, individual performance as well as contributions, the scope of responsibility and accountability of such Directors, taking into consideration of the Company's performance and prevailing market conditions. The remuneration policy of independent nonexecutive Directors is to ensure that the independent nonexecutive Directors are adequately compensated for their efforts and time dedicated to the Company's affairs including their participation in respective Board committees. The emoluments of independent non-executive Directors are determined with reference to their skills, experience, knowledge, duties and market trends. As at the date of this annual report, the remuneration committee consists of three independent nonexecutive Directors, namely Mr. Chung Yuk Ming (Chairman), Mr. Lau Shun Chuen and Mr. Yau Wing Yiu, one executive Director, namely Mr. Chan Yan Wing and one non-executive Director, namely Mr. Chan Yan Kwong.

The Company established an audit committee pursuant to a resolution of the Director passed on 18 November 2014 with written terms of reference in compliance with Rule 3.21 and Rule 3.22 of the Listing Rules. The written terms of reference of the audit committee was adopted in compliance with the Code Provisions. Its terms of reference are available on the websites of the Company and the Stock Exchange.

The primary duties of the audit committee, among other things, are to make recommendations to the Board on the appointment, re-appointment and removal of external auditor, review the financial statements and material advice in respect of financial reporting and oversees risk management and internal control procedures of the Company. As at the date of this annual report, the audit committee consists of three independent non-executive Directors, namely Mr. Yau Wing Yiu (Chairman), Mr. Lau Shun Chuen and Mr. Chung Yuk Ming.

During the year and up to the date of this annual report, the Audit Committee members met twice with the external auditors and the Group's senior management to discuss and review, among other things, the following matters:

(a) the annual results for the year ended 31 December 2021 and the interim results for the six months ended 30 June 2021 to ensure the full, complete and accurate disclosure in the aforesaid financial statements pursuant to the accounting standards and other legal requirements for presenting the same to the Board for approval;

- (g) the adequacy of resources, qualifications and experience of staff and the accounting and financial reporting matters and their training programmes and budget.

The Audit Committee is satisfied with, inter alia, the audit fees, effectiveness of the audit process, independence and objectivity of the external auditors and has recommended to the Board the re-appointment of Ernst & Young as the Company's external auditors for the ensuing year at the forthcoming annual general meeting of the Company.

During the period from the Listing Date to the date of this annual report, the Board has not taken a different view from the audit committee on the selection, appointment, resignation or dismissal of external auditors.

AUDITOR'S REMUNERATION

During the year, the Company engaged Ernst & Young as the external auditors. Apart from providing audit services, Ernst & Young also provided non-audit services including: i) taxation services; ii) review of interim financial information; iii) certain procedures on the annual result announcement; and iv) certain procedures on very substantial transactions. The fees in respect of audit and non-audit services provided by Ernst & Young for the year ended 31 December 2021 approximately amounted to HK\$1,540,000 and HK\$1,537,500, respectively.

The reporting responsibilities of Ernst & Young are set out in the Independent Auditor's Report on pages 57 to 62.

Mr. Lai Hau Yin being our company secretary is primarily responsible for the company secretarial work of our Group. Mr. Lai is also our Company's chief financial officer. The Company confirms that Mr. Lai has for the year 2021 attended no less than 15 hours of relevant professional training.

RISK MANAGEMENT AND INTERNAL CONTROL

During the year, the Group has complied with Principle C.2 of the Corporate Governance Code by establishing appropriate and effective risk management and internal control systems. Management is responsible for the design, implementation and monitoring of such systems, while the Board oversees management in performing its duties on an ongoing basis. Main features of the risk management and internal control systems are described in the sections below:

Risk Management System

The Group adopts a risk management system which manages the risk associated with its business and operations. The system comprises the following phases:

- Identification: Identify ownership of risks, business objectives and risks that could affect the achievement of objectives.
- Evaluation: Analyze the likelihood and impact of risks and evaluate the risk portfolio accordingly.
- Management: Consider the risk responses, ensure effective communication to the Board and on-going monitor the residual risks.

The management assesses the potential risks faced by the Group from time to time, which is also evaluated annually by a professional institute engaged by the Group. This year's evaluation covered the period from 1 January 2021 to 31 December 2021.

Based on the risk assessments conducted in 2021, no significant risk was identified.

Internal Control System

The Company has in place an internal control system which is compatible with the Committee of Sponsoring Organizations of the Treadway Commission ("COSO") 2013 framework. The framework enables the Group to achieve objectives regarding effectiveness and efficiency of operations, reliability of financial reporting and compliance with applicable laws and regulations. The components of the framework are shown as follows:

- Control Environment: A set of standards, processes and structures that provide the basis for carrying out internal control across the Group.
- Risk Assessment: A dynamic and iterative process for identifying and analyzing risks to achieve the Group's objectives, forming a basis for determining how risks should be managed.
- Control Activities: Action established by policies and procedures to help ensure that management directives to mitigate risks to the achievement of objectives are carried out.

風險管理及內部監控

年內,本集團已遵守企業管治守則原則C.2,設立適當 及有效的風險管理及內部監控制度。管理層負責該等 制度的設計、實施及監察,而董事會則監督管理層持 續履行其職責。風險管理及內部監控制度的主要特點 於下文各節闡述:

風險管理制度

本集團採納風險管理制度以管理與其業務及營運有關 的風險。該制度包括以下階段:

- 識別:識別擁有權風險、業務目標及可影響能否 達成目標的風險。
- 評估:分析風險的可能性及影響及據此評估風險 組合。
- 管理層:考慮風險回應、確保與董事會有效溝通
 及持續監察殘留風險。

管理層不時評估本集團面臨的潛在風險,本集團聘任 的專業機構亦會每年就有關風險進行評估。本年度的 評估涵蓋二零二一年一月一日至二零二一年十二月 三十一日期間。

根據二零二一年進行的風險評估,概無識別到重大風險。

內部監控制度

本公司已設置內部監控制度,其切合全美反虛假財務 報告委員會下屬的發起人委員會(Committee of Sponsoring Organizations of the Treadway Commission) (「COSO」)二零一三年框架。此框架令本集團達成關於 經營效率與效能、財務匯報的可靠性及遵從適用的法 律及法規等方面的目標。以下列舉框架的內容:

- 監控環境:整套的標準、過程及架構,為本集團 內實行內部監控提供基礎。
- 風險評估:識別及分析風險以達成本集團目標, 並為如何管理風險提供基礎的靈活縝密程序。
- 監控活動:以政策及程序設立的行動,協助確保 減少風險以達成目標的管理指令獲得執行。

- Information and Communication: Internal and external communication to provide the Group with the information needed to carry out day-to-day controls.
- Monitoring: Ongoing and separate evaluations to ascertain whether each components of internal control is present and functioning.

In order to enhance the Group's system of handling inside information, and to ensure the truthfulness, accuracy, completeness and timeliness of its public disclosures, the Group also adopts and implements an inside information policy and procedures. Certain reasonable measures have been taken from time to time to ensure that proper safeguards exist to prevent a breach of a disclosure requirement in relation to the Group, which include:

- The access of information is restricted to a limited number of employees on a need-to-know basis. Employees who are in possession of inside information are fully conversant with their obligations to preserve confidentiality.
- Confidentiality agreements are in place when the Group enters into significant negotiations.
- The Executive Directors are designated persons who speak on behalf of the Company when communicating with external parties such as the media, analysts or investors.

The management assess the internal control system of the Group from time to time, which is also evaluated annually by a professional institution engaged by the Group. The professional institution has completed the evaluation for the period from 1 January 2021 to 31 December 2021. Based on the internal control reviews conducted in 2021, no significant control deficiency was identified.

Internal Auditors

The Group has an Internal Audit ("IA") function, which is consisted of professional staff with relevant expertise. The IA function is independent of the Group's daily operation and carries out appraisal of the risk management and internal control systems by conducting interviews, walkthroughs and tests of operating effectiveness.

An IA plan has been approved by the Board. According to the established plan, review of the risk management and internal control systems is conducted annually and the results are reported to the Board via Audit Committee afterwards.

- 與傳媒、分析員或投資者外界溝通時,執行董事 為指定代表本公司發言之人士。

管理層不時評估本集團的內部監控制度,同時本集團 亦聘請專業機構每年評估本集團內部監控情況。該專 業機構已完成自二零二一年一月一日至二零二一年 十二月三十一日止期間的評估。根據二零二一年進行 的內部監控檢討,並無識別到重大監控缺陷。

內部核數師

本集團設有內部審計(「內部審計」)部門,由具備有關 專長的專業員工組合。內部審計部門獨立於本集團的 日常營運,藉進行訪問、巡查及檢測營運效能對風險 管理及內部監控制度進行評估。

內部審計計劃已獲董事會批准。根據已制定的計劃, 每年將檢視風險管理及內部監控制度,隨後經審計委 員會向董事會報告結果。

Effectiveness of the Risk Management and Internal Control Systems

The Board is responsible for the risk management and internal control systems of the Group and ensuring review of the effectiveness of these systems has been conducted annually. Several areas have been considered during the Board's review, which include but not limited to (i) the changes in the nature and extent of significant risks since the last annual review, and the Group's ability to respond to changes in its business and the external environment; (ii) the scope and quality of management's ongoing monitoring of risks and of the internal control systems.

The Board, through its review and the review made by IA function and Audit Committee, concluded that the risk management and internal control systems were effective and adequate. Such systems, however, are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss. It is also considered that the resources, staff qualifications and experience of relevant staff were adequate and the training programs and budget provided were sufficient.

SHAREHOLDERS' RIGHTS

The following procedures for shareholders of the Company to convene an extraordinary general meeting ("EGM") of the Company are prepared in accordance with the articles of association as follows:

- (1) One or more shareholders holding, at the date of deposit of the requisition, not less than one tenth of the paid up capital of the Company having the right to vote at general meetings, shall have the right, by written notice, to require an EGM to be called by the Directors of the Company for the transaction of any business specified in such requisition.
- (2) Such requisition shall be made in writing to the Board or the company secretary of the Company at the following:

The total number of shares which may be issued upon exercise of all options to be granted under the Share Option Scheme and any other share option schemes of the Company must not exceed 10% of the total number of shares in issue on 8 December 2014 unless the Company seeks the approval of the shareholders in general meeting for refreshing the 10% limit under the Share Option Scheme provided that options lapsed in accordance with the terms of the Share Option Scheme or any other share option schemes of the Company will not be counted for the purpose of calculating 10% limit.

Details of the principal terms of the Share Option Scheme are set out in paragraph headed "Share Option Scheme" in the section headed "Statutory and General Information" in Appendix V to the Prospectus. The principal terms of the Share Option Scheme are summarised as follows:

The Share Option Scheme was adopted for a period of 10 years commencing from 18 November 2014 and remains in force until 17 November 2024. The Company may, by resolution in general meeting or, such date as the Board determined, terminate the Share Option Scheme at any time without prejudice to the exercise of options granted prior to such termination.

The exercise price per share of the Company for each option granted shall be determined by the Board in its absolute discretion but in any event shall be at least the higher of:

- the closing price of the shares as stated in the daily quotations sheets issued by the Stock Exchange on the date of offer for the grant of option ("Date of Grant") which must be a trading day;
- (2) the average closing price of the shares as stated in the daily quotations sheets issued by the Stock Exchange for the five business days immediately preceding the Date of Grant; and
- (3) the nominal value of the shares on the Date of Grant.

Upon acceptance of the options, the grantee shall pay HK\$1.00 to the Company as consideration for the grant. The acceptance of an offer of the grant of the option must be made within the date as specified in the offer letter issued by the Company. The exercise period of any option granted under the Share Option Scheme shall not be longer than 10 years commencing on the date of grant and expiring on the last day of such 10-year period subject to the provisions for early termination as contained in the Share Option Scheme.

Any further grant of options in excess of this 1% limit shall be subject to issuance of a circular by the Company and approved by its shareholders in accordance with the Listing Rules.

Any grant of share options to a director, chief executive or substantial shareholder of the Company, or to any of their associates, is required to be approved by the independent nonexecutive directors. In addition, any grant of share options to a substantial shareholder or an independent non-executive director of the Company, or any of their respective associates, in excess of 0.1% of the shares of the Company in issue at any time or with an aggregate value (based on the closing price of the Company's shares at the date of grant) in excess of HK\$5 million, within any 12-month period, are subject to shareholders' approval in advance in a general meeting.

Share options do not confer rights on the holders to dividends or to vote at shareholders' meetings.

From the date of adoption of the Share Option Scheme to 31 December 2021, no options were granted under the Share Option Scheme.

Additional particulars of the Company's Share Option Scheme are set out in note 27 to the Consolidated Financial Statements.

PRINCIPAL RISKS AND UNCERTAINTIES

The Group produces PCB in China and sells them around the world, and is faced with certain different types of risks and uncertainties. The principal items are listed as below.

- i. The COVID-19 outbreak, which has spread across China and various regions in the world, has brought material impact on people's livelihood. Although vaccines have begun to be used, their effectiveness has been lower than expected. Coupled with the emergence and rapid spread of variant viruses, the economy along with the operation and production of enterprises are being exposed to adverse conditions.
- ii. The Group derives a significant portion of its revenue from major customers, particularly automobile customers. The decrease in demand from major customers may materially and adversely affect the business.
- iii. Fluctuation in exchange rates may adversely affect the business.
- iv. The Group may be subject to any labour shortages, increased labour cost or other factors affecting labour force, or full implementation of social security and public housing policies, which may materially affect the Group's business operation and financial condition.
- v. The PRC government has tightened its environmental regulation. Although the Group's current operation falls in line with the requirement, it may be affected and incur additional expenses when the relevant regulatory threshold is further raised in the future.
- vi. U.S.' China Policy continues to imposes higher tariffs on imported Chinese goods, and restricts Huawei from participating in 5G projects, which may slow down economic growth across the globe, and in return decelerate the development of the PCB market.
- vii. For the circuit boards industry, raw materials account for a large proportion of costs. Since mid 2020, the prices of a variety of major raw materials, such as copper clad laminates, prepregs, copper foils have continuously risen sharply. After several price increases in 2021, the prices stabilized at the end of the year. This caused a great impact on PCB operations. Failure to make appropriate adjustments has reduced the profit of the Company.
- viii. Currently, various PCB manufacturers are vigorously expanding their production capacity. When the market fails to meet the development expectation, the excessive production capacity will result in irrational competition among industrial peers, pushing down the unit price and diminishing the company's profitability.

主要風險及不明朗因素

- 新型冠狀病毒肺炎爆發,疫情蔓延全國及世界各地,嚴重影響民生與經濟,雖然多款疫苗開始陸續使用,但效用未如預期,加上變種病毒的出現及迅速擴散,這對經濟以及企業經營及生產造成不利的環境。
- ii. 本集團大部分收益乃來自主要客戶,特別是汽車
 客戶。來自主要客戶的需求減少或會對業務造成
 重大不利影響。
- iii. 匯率波動或會對業務造成不利影響。
- iv. 本集團或受制於任何勞工短缺、勞工成本上 漲或其他影響勞動力的因素,加上全面實施 社會保障和公積金政策,這可能對本集團的 業務營運及財務狀況造成重大影響。
- v. 中國政府收緊了對環保方面的監管。雖然本 集團目前的營運狀況符合要求,但倘若政府 日後進一步提高相關監管門檻,本集團的營 運或會受到影響並產生額外費用。
- vi. 美國的對華政策,對從中國進口的貨物仍然 徵收較高關税,同時亦限制華為參與5G項 目,這有可能拖慢全球經濟發展,繼而減慢 PCB市場發展步伐。
- vii. 電路板行業,原材料佔成本的比重很大,自 二零二零中期,多種主要原材料,如銅箔基 板、半固化黏合材料、銅箔等價格相繼持續 大幅上漲,二零二一年經過多次的漲價,在 年末有所回穩。這對PCB營運造成很大衝擊, 若本公司未能作出適當的調整,本公司的利 潤因而下降。
- viii. 目前,眾多PCB製造商正在大幅擴充產能, 當市場未符合預期發展,而出現產能過剩, 引致同行不理性競爭,推低單位價格,公司 的利潤因而減少。

- ix. The Group's sole production facility is based in Shenzhen. If this facility experiences any issue that results in a lower production output, and no third-party assistance is identified, our sales will decline.
- x. The Group's major production operation activities take place in Mainland China. Any change to the policies in Mainland China (including taxation, foreign exchange control, and imports and exports) is likely to affect the Group's overall performance.
- xi. China's "zero tolerance" COVID anti-epidemic policy has brought inconvenience to economic activities, and real estate developers continue to face financial pressure, which affects China's economic development and may slow down the pace of global recovery.
- xii. During the pandemic, the global supply chain has been severely hit, with logistics time and costs increasing, flights reducing, shipping taking a long time to unload cargo, and land transportation is facing the problem of driver shortage. If these problems cannot be improved, economic development will continue to be affected.
- xiii. In 2021, there were power supply problems in various parts of China, and then the government relaxed the price restrictions on electricity tariffs, which may increase the future electricity cost of domestic manufacturers.
- xiv. The outbreak of war between Russia and Ukraine results in frequent geopolitical conflicts and oppositions between countries and thus has impacted normal transactions and increased development risks of each industry.

ENVIRONMENTAL PROTECTION

Environmental protection is a collective responsibility not to be ignored. The Group's production factories in Shenzhen, China possesses state-of-the-art PCB technologies and attaches a great importance to environmental protection. The Group recognises that the production process of PCBs would generate more emissions than some other industries. In regard of this, we strive to enhance the efficiency of environmental protection. The Group sets up different management requirements for environmental protection every year, aiming at reducing negative impact on the environment from our operation. We have obtained certification of IATF16949:2016 (quality assurance), ISO14001 (environment management system), ISO9001 (quality management system) and AS9100D (quality management system) as well as UL-796 (safety and management) for PCB quality standard and environment management system.

- xiv. 俄烏戰事爆發,各處地緣衝突頻生,國與國 的對抗行為,影響正常交易,增加各個行業 發展風險。

環境保護

保護環境是不容忽視的共同責任,本集團於中國深圳 的生產廠房擁有最先進的PCB技術,且對環保高度重 視。本集團明白PCB的生產過程會較其他工業產生 更多排放物,有鑑於此,我們致力提高環保效能。本 集團在環境保護方面每年制定不同的管理規範,旨在 減少本集團業務對環境帶來的負面影響。我們的PCB 品質標準及環境管理系統已獲頒IATF16949:2016品質 保證認證、ISO14001環境管理系統認證、ISO9001品 質管理系統及AS9100D品質管理系統以及UL-796安全 管理認證等。

The Group strictly observed the laws and regulations governing air pollution, noise pollution, hazardous chemicals, sewage and waste discharge and other environmental matters issued by PRC national, provincial and municipal governments and authorities. Meanwhile, as a responsible corporation, we produce all of our products in compliance with the requirement of Cleaner Production Standard: Printed Circuit Board Manufacturing (清潔 生產標準:印刷電路板製造業) issued by the Ministry of Environmental Protection of China.

With resources in the Earth becoming increasingly scarce, corporations should have long-term vision instead of focusing on existing interests. The Group sees that there are economic benefits to be capitalized in environmental protection and our effort focuses chiefly in the following aspects, among others: actively pushing forward the initiative of energy conservation and consumption reduction by saving energy, water, material and reducing resource consumption during the course of our production, with a view to maximizing the cost effectiveness with minimal resources; and full implementation of clean production to achieve waste reduction at source. At the same time, under the guidance of a paperless office, the Group introduced the Enterprise Resources Planning System ("ERP" System), through which it implemented electronic management on the its production, sales, supply chain, and human resources with a view to saving paper.

The environmental, social and governance report in Compliance with Appendix 27 of the Listing Rules will be issued in due course.

COMPLIANCE WITH LAWS AND REGULATIONS

The Board paid attention to the Group's policies and practices on compliance with legal and regulatory requirements. External compliance and legal advisers are engaged to ensure transactions and business performed by the Group are within the applicable legal framework. 1. CORPORATE AND GROUP INFORMATION

The Company was incorporated in the Cayman Islands on 8 July 2014 as an exempted company with limited liability. 2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") (which include all Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations) issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance.

They have been prepared under the historical cost convention, except for a financial asset at fair value through other comprehensive income and investment properties which have been measured at fair value. These financial statements are presented in Hong Kong dollars ("HK\$") and all values are rounded to the nearest thousand except when otherwise indicated.

Basis of consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries (collectively referred to as the "Group") for the year ended 31 December 2021. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

2.1 編製基準

綜合財務報表包括本公司及其附屬公司(統稱「本 集團」)截至二零二一年十二月三十一日止年度 之財務報表。附屬公司為本公司直接或間接控制 的實體(包括結構性實體)。當本集團對參與投 資對象業務的浮動回報承擔風險或享有權利以 及能透過對投資對象行使的權力(即本集團獲賦 予現有能力以主導投資對象相關活動的既存權 利)影響該等回報時,即取得控制權。

倘本公司直接或間接擁有少於投資對象大多數 投票的權利或類似權利,則本集團於評估其是否 擁有對投資對象的權力時會考慮一切相關事實 及情況,包括:

- (b) 其他合約安排產生的權利;及
- (c) 本集團的投票權及潛在投票權。

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

All intra-group assets and liabilities, equity, income. expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets (including goodwill) and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interest and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained and (iii) any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

The nature and the impact of the revised HKFRSs are described below:

(a) Amendments to HKFRS 9, HKAS 39, HKFRS 7, HKFRS 4 and HKFRS 16 address issues not dealt with in the previous amendments which affect financial reporting when an existing interest rate benchmark is replaced with an alternative risk-free rate ("RFR"). The amendments provide a practical expedient to allow the effective interest rate to be updated without adjusting the carrying amount of financial assets and liabilities when accounting for changes in the basis for determining the contractual cash flows of financial assets and liabilities, if the change is a direct consequence of the interest rate benchmark reform and the new basis for determining the contractual cash flows is economically equivalent to the previous basis immediately preceding the change. In addition, the amendments permit changes required by the interest rate benchmark reform to be made to hedge designations and hedge documentation without the hedging relationship being discontinued. Any gains or losses that could arise on transition are dealt with through the normal requirements of HKFRS 9 to measure and recognise hedge ineffectiveness. The amendments also provide a temporary relief to entities from having to meet the separately identifiable requirement when an RFR is designated as a risk component. The relief allows an entity, upon designation of the hedge, to assume that the separately identifiable requirement is met, provided the entity reasonably expects the RFR risk component to become separately identifiable within the next 24 months. Furthermore, the amendments require an entity to disclose additional information to enable users of financial statements to understand the effect of interest rate benchmark reform on an entity's financial instruments and risk management strategy.

The Group had certain interest-bearing bank borrowings denominated in United States dollars based on the London Interbank Offered Rate ("LIBOR") as at 31 December 2021. For the LIBORbased borrowings, since the interest rates of these instruments were not replaced by RFRs during the year, the amendments did not have any impact on the financial position and performance of the Group. If the interest rates of these borrowings are replaced by RFRs in a future period, the Group will apply the above-mentioned practical expedient upon the modification of these instruments provided that the "economically equivalent" criterion is met.

Further information about those HKFRSs that are expected to be applicable to the Group is described below.

Amendments to HKFRS 3 are intended to replace a reference to the previous Framework for the Preparation and Presentation of Financial Statements with a reference to the Conceptual Framework for Financial Reporting issued in June 2018 without significantly changing its requirements. The amendments also add to HKFRS 3 an exception to its recognition principle for an entity to refer to the Conceptual Framework to determine what constitutes an asset or a liability. The exception specifies that, for liabilities and contingent liabilities that would be within the scope of HKAS 37 or HK(IFRIC)-Int 21 if they were incurred separately rather than assumed in a business combination, an entity applying HKFRS 3 should refer to HKAS 37 or HK(IFRIC)-Int 21 respectively instead of the Conceptual Framework. Furthermore, the amendments clarify that contingent assets do not gualify for recognition at the acquisition date. The Group expects to adopt the amendments prospectively from 1 January 2022. Since the amendments apply prospectively to business combinations for which the acquisition date is on or after the date of first application, the Group will not be affected by these amendments on the date of transition.

Amendments to HKFRS 10 and HKAS 28 (2011) address an inconsistency between the requirements in HKFRS 10 and in HKAS 28 (2011) in dealing with the sale or contribution of assets between an investor and its associate or joint venture. The amendments require a full recognition of a gain or loss resulting from a downstream transaction when the sale or contribution of assets between an investor and its associate or joint venture constitutes a business. For a transaction involving assets that do not constitute a business, a gain or loss resulting from the transaction is recognised in the investor's profit or loss only to the extent of the unrelated investor's interest in that associate or joint venture. The amendments are to be applied prospectively. The previous mandatory effective date of amendments to HKFRS 10 and HKAS 28 (2011) was removed by the HKICPA in January 2016 and a new mandatory effective date will be determined after the completion of a broader review of accounting for associates and joint ventures. However, the amendments are available for adoption now.

Classification of a liability is unaffected by the likelihood that the entity will exercise its right to defer settlement of the liability. The amendments also clarify the situations that are considered a settlement of a liability. The amendments are effective for annual periods beginning on or after 1 January 2023 and shall be applied retrospectively. Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

Amendments to HKAS 1 Disclosure of Accounting Policies require entities to disclose their material accounting policy information rather than their significant accounting policies. Accounting policy information is material if, when considered together with other information included in an entity's financial statements, it can reasonably be expected to influence decisions that the primary users of general purpose financial statements make on the basis of those financial statements. Amendments to HKFRS Practice Statement 2 provide non-mandatory guidance on how to apply the concept of materiality to accounting policy disclosures. Amendments to HKAS 1 are effective for annual periods beginning on or after 1 January 2023 and earlier application is permitted. Since the guidance provided in the amendments to HKFRS Practice Statement 2 is non-mandatory, an effective date for these amendments is not necessary. The Group is currently assessing the impact of the amendments on the Group's accounting policy disclosures.

Amendments to HKAS 8 clarify the distinction between changes in accounting estimates and changes in accounting policies. Accounting estimates are defined as monetary amounts in financial statements that are subject to measurement uncertainty. Costs that relate directly to a contract include both the incremental costs of fulfilling that contract (e.g., direct labour and materials) and an allocation of other costs that relate directly to fulfilling that contract (e.g., an allocation of the depreciation charge for an item of property, plant and equipment used in fulfilling the contract as well as contract management and supervision costs). General and administrative costs do not relate directly to a contract and are excluded unless they are explicitly chargeable to the counterparty under the contract. The amendments are effective for annual periods beginning on or after 1 January 2022 and shall be applied to contracts for which an entity has not yet fulfilled all its obligations at the beginning of the annual reporting period in which it first applies the amendments. Earlier application is permitted. Any cumulative effect of initially applying the amendments shall be recognised as an adjustment to the opening equity at the date of initial application without restating the comparative information. The amendments are not expected to have any significant impact on the Group's financial statements.

Annual Improvements to HKFRSs 2018–2020 sets out amendments to HKFRS 1, HKFRS 9, Illustrative Examples accompanying HKFRS 16, and HKAS 41. Details of the amendments that are expected to be applicable to the Group are as follows:

- HKFRS 9 Financial Instruments: clarifies the fees that an entity includes when assessing whether the terms of a new or modified financial liability are substantially different from the terms of the original financial liability. These fees include only those paid or received between the borrower and the lender, including fees paid or received by either the borrower or lender on the other's behalf. An entity applies the amendment to financial liabilities that are modified or exchanged on or after the beginning of the annual reporting period in which the entity first applies the amendment. The amendment is effective for annual periods beginning on or after 1 January 2022. Earlier application is permitted. The amendment is not expected to have a significant impact on the Group's financial statements.
- HKFRS 16 *Leases*: removes the illustration of payments from the lessor relating to leasehold improvements in Illustrative Example 13 accompanying HKFRS 16. This removes potential confusion regarding the treatment of lease incentives when applying HKFRS 16.

Fair value measurement

The Group measures its investment properties and an equity investment at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

- Level 1 based on quoted prices (unadjusted) in active markets for identical assets or liabilities
- Level 2 based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly
- Level 3 based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

For assets and liabilities that are recognised in the financial statements on a recurring basis, the Group determines whether transfers have occurred between levels in the hierarchy by reassessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

Where an indication of impairment exists, or when annual

impairment testing for an asset is required (other than inventories, investment properties, deferred tax assets, financial assets and non-current assets classified as held for sale), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to the statement of profit or loss in the period in which it arises.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to the statement of profit or loss in the period in which it arises.

Property, plant and equipment and depreciation Property, plant and equipment, other than construction in progress, are stated at cost less accumulated depreciation and any impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to the statement of profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Depreciation is calculated on the straight-line basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. The principal annual rates used for this purpose are as follows:

Leasehold land and buildings	2.2% to 4%
Leasehold improvements	33 ¹ / ₃ %
Plant and machinery	9% to 18%
Furniture, fixtures and equipment	9% to 331/₃%
Motor vehicles	30% to 33 ¹ / ₃ %

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property, plant and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in the statement of profit or loss in the year the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

Construction in progress mainly represents buildings and leasehold improvements under construction, which are stated at cost less any impairment losses, and are not depreciated. Cost comprises the direct costs of construction and capitalised borrowing costs on related borrowed funds during the period of construction. Construction in progress is reclassified to the appropriate category of property, plant and equipment when completed and ready for use.

物業、廠房及設備(在建工程除外)乃按成本減 累計折舊及任何減值虧損後列賬。物業、廠房及 設備項目成本包括其購入價及任何令該項資產 達致運作狀態及將其運往擬定用途地點之直接 應計成本。

物業、廠房及設備項目投入運作後產生之開支, 例如維修及保養費用,一般於該等開支產生之期 間於損益表內扣除。在符合確認條件的情況下, 大型檢驗的開支於資產的賬面值資本化為重置 資產。倘物業、廠房及設備的主要部份須分段重 置,則本集團將該等部份確認為獨立資產,並設 有特定的可使用年期及作出相應折舊。

一項物業、廠房及設備(包括任何初步已確認之 重大部分)於出售或預計日後其使用或出售不再 產生經濟利益時,將終止確認。於資產終止確認 年度因其出售或報廢並在損益表確認之任何收 益或虧損,乃有關資產之出售所得款項淨額與賬 面值之差額。

在建工程主要指在建樓宇及租賃物業裝修,其按 成本扣除任何減值虧損列賬,且不計算折舊。成 本包括直接建築成本及建築期內產生之相關借 貸之資本化借貸成本。在建工程於落成及可供使 用時重新分類至物業、廠房及設備之適當類別。

Investment properties

Investment properties are interests in land and buildings (including the leasehold property held as a right-of-use asset which would otherwise meet the definition of an investment property) held to earn rental income and/or for capital appreciation, rather than for use in the production or supply of goods or services or for administrative purposes; or for sale in the ordinary course of business. Such properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are stated at fair value, which reflects market conditions at the end of the reporting period.

Gains or losses arising from changes in the fair values of investment properties are included in the statement of profit or loss in the year which they arise.

Any gains or losses on the retirement or disposal of an investment property are recognised in the statement of profit or loss in the year of the retirement or disposal.

Non-current assets and disposal groups held for sale

Non-current assets and disposal groups are classified as held for sale if their carrying amounts will be recovered principally through a sales transaction rather than through continuing use. For this to be the case, the asset or disposal group must be available for immediate sale in its present condition subject only to terms that are usual and customary for the sale of such assets or disposal groups and its sale must be highly probable. All assets and liabilities of a subsidiary classified as a disposal group are reclassified as held for sale regardless of whether the Group retains a non-controlling interest in its former subsidiary after the sale.

Non-current assets and disposal groups (other than investment properties and financial assets) classified as held for sale are measured at the lower of their carrying amounts and fair values less costs to sell. Property, plant and equipment classified as held for sale are not depreciated.

投資物業公平值變動所帶來的盈虧於產生的年 度計入損益表。

報廢或出售投資物業的任何盈虧於報廢或出售 之年度在損益表確認。

持作出售非流動資產及出售組別

倘非流動資產及出售組別的賬面值將主要通過 銷售交易而非持續使用收回,則其將分類為持作 出售。要達至此情況,該資產或出售組別須可於 現況下即時出售而僅受出售有關資產或出售組 別的常規性及習慣性條款制約,且其很可能售 出。分類為出售組別的附屬公司所有資產及負債 均獲重新分類為持作出售(不論本集團是否於銷 售後保留其前附屬公司的非控股權益)。

Leases

The Group assesses at contract inception whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

Group as a lessee

The Group applies a single recognition and measurement approach for all leases. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

(a) Right-of-use assets

Right-of-use assets are recognised at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Right-of-use assets are depreciated on a straight-line basis over the lease terms.

If ownership of the leased asset transfers to the Group by the end of the lease term or the cost reflects the exercise of a purchase option, depreciation is calculated using the estimated useful life of the asset.

(b) Lease liabilities

Lease liabilities are recognised at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including insubstance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate the lease. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset.

Group as a lessor

When the Group acts as a lessor, it classifies at lease inception (or when there is a lease modification) each of its leases as either an operating lease or a finance lease.

Leases in which the Group does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. When a contract contains lease and non-lease components, the Group allocates the consideration in the contract to each component on a relative stand-alone selling price basis. Rental income is accounted for on a straight-line basis over the lease terms and is included in revenue in the statement of profit or loss due to its operating nature. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income. Contingent rents are recognised as revenue in the period in which they are earned.

Leases that transfer substantially all the risks and rewards incidental to ownership of an underlying asset to the lessee are accounted for as finance leases.

租賃負債 租賃負債於租賃開始日期按租期內將予支 付租賃付款的現值確認。租賃付款包括固 定付款(包括實質固定付款)減任何租賃獎 勵應收款項、取決於指數或利率之可變租 賃款項以及預期根據剩餘價值擔保支付之 金額。租賃付款亦包括本集團合理確定行 使之購買選擇權之行使價及在租賃期反映 本集團行使終止租賃選擇權時,有關終止 租賃之罰款。並非取決於指數或利率之可 變租賃付款在出現觸發付款之事件或條件 之期間內確認為開支。

於計算租賃付款之現值時,由於租賃隱含 利率不易釐定,本集團使用租賃開始日期 之增量借款利率計算。於開始日期後,租 賃負債金額之增加反映利息之增長,並會 因支付租賃付款而減少。此外,倘出現修 訂、租賃期有所變更、租賃付款出現變動 (如因指數或利率變動而變更為未來租賃 付款),或購買有關資產之評估出現變動, 租賃負債之賬面值將會重新計量。

倘本集團為出租人,則其在租賃開始時(或發生 租賃變更時)將其各項租賃分類為經營租賃或融 資租賃。

Financial assets of the Group are classified, at initial recognition, as subsequently measured at amortised cost and fair value through other comprehensive income.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value, plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under HKFRS 15 in accordance with the policies set out for "Revenue recognition" below.

In order for a financial asset to be classified and measured at amortised cost or fair value through other comprehensive income, it needs to give rise to cash flows that are solely payments of principal and interest ("SPPI") on the principal amount outstanding. Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

The Group's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortised cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows, while financial assets classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace.

於初步確認時,財務資產分類取決於財務資產的 合約現金流量特點及本集團管理該等財務資產 的業務模式。除並無重大融資成分或本集團已應 用不調整主要融資組成部分影響的可行權宜方 法的貿易應收款項外,本集團初步按公平值加上 (倘財務資產並非按公平值計入損益)交易成本 計量財務資產。並無重大融資成分或本集團已根 據下文「收益確認」所載政策應用可行權宜方法 的貿易應收款項按香港財務報告準則第15號釐 定的交易價格計量。

為使財務資產按攤銷成本或按公平值計入其他 全面收益進行分類及計量,需產生就未償還本金 的純粹本息付款(「SPPI」)的現金流量。具有並非 SPPI之現金流量之財務資產分類為按公平值計入 損益計量,而不論業務模式。

本集團管理財務資產的業務模式指其如何管理 其財務資產以產生現金流量。業務模式確定現金 流量是否來自收集合約現金流量、出售財務資 產,或兩者兼有。按攤銷成本分類及計量的財務 資產乃在為持有財務資產以收取合約現金流量 的業務模式中持有,而按公平值計入其他全面收 益分類及計量的財務資產在為持有財務資產以 收取及出售合約現金流量的業務模式中持有。未 於上述業務模式中持有的財務資產按公平值計 入損益分類及計量。

所有正常途徑的財務資產買賣乃於交易日期確 認,交易日期即本集團承諾收購或出售資產的日 子。正常途徑買賣指需要於一般由法規或市場慣 例確定的期間內交付資產的財務資產買賣。

Investments and other financial assets (continued) Subsequent measurement

The subsequent measurement of financial assets depends on their classification as follows:

Financial assets at amortised cost (debt instruments) Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in the statement of profit or loss when the asset is derecognised, modified or impaired.

Financial assets designated at fair value through other comprehensive income (equity investments)

Upon initial recognition, the Group can elect to classify irrevocably its equity investments as equity investments designated at fair value through other comprehensive income when they meet the definition of equity under HKAS 32 *Financial Instruments: Presentation* and are not held for trading. The classification is determined on an instrument-by-instrument basis.

Gains and losses on these financial assets are never recycled to the statement of profit or loss. Dividends are recognised as other income in the statement of profit or loss when the right of payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably, except when the Group benefits from such proceeds as a recovery of part of the cost of the financial asset, in which case, such gains are recorded in other comprehensive income. Equity investments designated at fair value through other comprehensive income are not subject to impairment assessment.

Derecognition of financial assets

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e., removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

指定按公平值計入其他全面收益的財務資產(股 權投資)

於初步確認時,本集團可選擇於股權投資符合香 港會計準則第32號*財務工具*:呈報項下的股本 定義且並非持作買賣時,不可撤回地將其股權投 資分類為指定按公平值計入其他全面收益的股 權投資。分類乃按個別工具基準釐定。

該等財務資產的收益及虧損概不會被重新計入 損益表。當確立支付權且與股息有關的經濟利益 將可能流入本集團及股息金額能可靠計量時,股 息於損益表中確認為其他收入,惟當本集團於作 為收回財務資產一部分成本的所得款項中獲益 時則除外,於此情況下,該等收益於其他全面收 益記錄。指定按公平值計入其他全面收益的股權 投資不受減值評估影響。

終止確認財務資產

一項財務資產(或(如適用)一項財務資產的部分 或一組同類財務資產的部分)主要在以下情況被 終止確認(即自本集團的綜合財務狀況表中剔 除):

- 從資產取得現金流量的權利已過期;或
- 本集團已轉移其從資產取得現金流量的權 利或已於一個「轉付」安排下承擔將取得 的現金流量全部向第三方支付的義務,且 不得有重大延誤;及(a)本集團已轉移該資 產的絕大部分風險及回報,或(b)本集團既 無轉移亦無保留該資產的絕大部分風險及 回報,但已轉移該資產的控制權。

Derecognition of financial assets (continued)

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risk and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

Impairment of financial assets

The Group recognises an allowance for expected credit losses ("ECLs") for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

以對已轉讓資產作出擔保之形式進行之持續參 與,按以下兩者中較低者計量:該資產之原賬面 值及本集團須償還之最高代價。

財務資產減值

本集團確認對並非按公平值計入損益的所有債 務工具預期信貸虧損(「預期信貸虧損」)的撥備。 預期信貸虧損乃基於根據合約到期的合約現金 流量與本集團預期收取的所有現金流量之間的 差額而釐定,並以原實際利率的近似值貼現。預 期現金流量將包括出售所持抵押的現金流量或 組成合約條款的其他信貸提升措施。

一般法

預期信貸虧損分兩個階段進行確認。就自初始確 認起未有顯著增加的信貸風險而言,預期信貸虧 損提供予由未來12個月內可能發生違約事件而 導致的信貸虧損(12個月預期信貸虧損)。就自 初始確認起經已顯著增加的信貸風險而言,不論 何時發生違約,於餘下風險年期內的預期信貸虧 損均須計提虧損撥備(全期預期信貸虧損)。

於各報告日期,本集團評估財務工具的信貸風險 是否自初次確認後大幅提高。於作出該評估時, 本集團比較報告日期財務工具產生的違約風險 及於初步確認時財務工具產生的違約風險,並考 慮在毋須付出不必要成本或努力而可獲得合理 及支持資料,包括過往及前瞻性資料。

Impairment of financial assets (continued) General approach (continued)

The Group considers a financial asset in default when contractual payments are certain days past due, rebuttable when certain information becomes available that demonstrates that another default definition is more appropriate. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade and bills receivables which apply the simplified approach as detailed below.

Stage 1	_	Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs
Stage 2		Financial instruments for which credit risk has increased significantly since initial recognition but that are not credit- impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECLs
Stage 3	_	Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime ECLs

Simplified approach

For trade and bills receivables that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

-般法(續)

本集團認為,倘合約付款逾期若干日,則財務資 產視作違約(當若干資料成為可得資料,顯示另 一項違約定義更為合適時可推翻)。然而,於若 干情況下,在並無計及本集團持有的任何增信安 排前,本集團亦可於內部或外部資料顯示本集團 不大可能悉數收取尚未償還合約金額時將財務 資產視作違約。倘無法合理預期收回合約現金流 量,則撇銷財務資產。

按攤銷成本計量的財務資產根據一般方法減值 及於下列計量預期信貸虧損的各階段分類,惟貿 易應收款項及應收票據使用下文詳述的簡化法 除外。

- 第一階段 信貸風險自初次確認後並無 大幅增加的財務工具,其虧 損撥備按等於12個月預期信 貸虧損的金額計量
- 第二階段 信貸風險自初次確認後大幅 增加但並無出現信貸減值的 財務工具,其虧損撥備按等 於全期預期信貸虧損的金額 計量
- 第三階段 於報告日期已出現信貸減值 的財務資產(但在購買或產 生之時並無信貸減值),其 虧損撥備按等於全期預期信 貸虧損的金額計量

簡化法

就不包含重大融資組成部分的貿易應收款項及 應收票據或當本集團使用不調整重大融資組成 部分影響的可行權宜方法時,本集團計算預期信 貸虧損時應用簡化法。根據簡化法,本集團並無 追蹤信貸風險的變化,但於各報告日期根據全期 預期信貸虧損確認虧損撥備。本集團已根據過往 信貸虧損經驗,建立撥備矩陣,並就債務人及經 濟環境的特定前瞻性因素作出調整。

Initial recognition and measurement

Financial liabilities of the Group are classified, at initial recognition, as loans and borrowings, or payables, as appropriate.

All financial liabilities are recognised initially at fair value and net of directly attributable transaction costs.

Subsequent measurement of financial liabilities at amortised cost (loans and borrowings)

After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in the statement of profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in the statement of profit or loss.

Derecognition of financial liabilities

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in the statement of profit or loss.

Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the weighted average basis and, in the case of work in progress and finished goods, comprises direct materials, direct labour and an appropriate proportion of overheads. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to completion and disposal.

初步確認及計量

本集團的財務負債在初步確認時分類為貸款及 借款或應付款項(如適用)。

所有財務負債初步均按公平值確認並扣除直接 應佔交易成本。

按攤銷成本計量之財務負債(貸款及借款)其 後計量

於初步確認後,計息貸款及借款其後按攤銷成本 使用實際利率法計量,除非貼現的影響並不重 大,在該情況下則按成本列賬。當終止確認負債 及透過實際利率攤銷程序時,則於損益表確認收 益及虧損。

攤銷成本的計算已計及任何收購折讓或溢價以 及為實際利率整體一部分的費用或成本。實際利 率攤銷計入損益表。

終止確認財務負債

當負債的責任被解除或取消或屆滿,財務負債將 終止確認。

倘現有財務負債由同一放債人以條款極為不同 的負債所取代,或現有負債的條款經大幅修訂, 該等交換或修訂視作終止確認原有負債及確認 新負債處理,有關賬面值的差額於損益表確認。

抵銷金融工具

倘有現行可予執行之法律權利以抵銷確認金額 及有意按淨額基準償付,或變現資產與償還負債 同時進行,則抵銷財務資產及財務負債,並於財 務狀況表內呈報淨額。

存貨

存貨按成本及可變現淨值之較低者列賬。成本按 加權平均基準釐定,對在製品及成品而言,包括 直接物料、勞工成本及適當比例的經常性開支。 可變現淨值乃基於估計售價減任何因完成交易 及出售而產生的估計成本計算。

Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the consolidated statement of financial position, cash and cash equivalents comprise cash on hand and at banks, including term deposits, and assets similar in nature to cash, which are not restricted as to use.

Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in the statement of profit or loss.

Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries/ jurisdictions in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

現金及現金等價物

就綜合現金流量表而言,現金及現金等價物包括 手頭現金、活期存款及可隨時轉換為已知數額現 金並於短期內(一般在購入後三個月內)到期, 且並無重大價值變動風險的短期高流通量投資, 再扣除須按要求償還及構成本集團現金管理一 個必要部分的銀行透支。

就綜合財務狀況表而言,現金及現金等價物包括 手頭及銀行現金(包括定期存款及與現金性質類 似的資產),而其用途不受限制。

撥備

倘因過往事件導致現時承擔責任(法定或推定責任),且日後可能須流失資源以履行責任,並能 可靠估計有關責任之數額,則確認撥備。

倘若貼現影響重大,則所確認之撥備數額為預計 履行責任所需之未來開支於報告期末之現值。隨 時間流逝使貼現現值增加之款項計入損益表。

所得税

所得税包括即期及遞延税項。與於損益以外確認 項目相關之所得税於損益以外之其他全面收益 或直接於權益內確認。

即期税項資產及負債乃按預期可收回的數額或 支付予税務機關的數額計算,其根據於報告期末 已頒佈或實質上已頒佈的税率(及税務法例)計 算,並考慮到本集團經營所在國家/司法權區的 現行詮釋及慣例。

遞延税項就於報告期末資產及負債的税項基準 及其於財務報告中的賬面值的所有暫時性差額 以負債法撥備。

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- when the deferred tax liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of taxable temporary differences associated with investments in subsidiaries, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax assets are recognised for all deductible temporary differences, and the carryforward of unused tax credits and any unused tax losses. Deferred tax assets are recognised to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carryforward of unused tax credits and unused tax losses can be utilised, except:

- when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of deductible temporary differences associated with investments in subsidiaries, deferred tax assets are only recognised to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

所有應課税暫時性差額均被確認為遞延税項負 債,惟:

- 倘若遞延税項負債來自在一宗屬非業務合併的交易中初步確認商譽或資產或負債, 而且在交易時對會計溢利或應課税溢利或 虧損均無影響,則屬例外;及
- 就於附屬公司的投資的相關應課税暫時性
 差額而言,倘若撥回暫時性差額的時間可以控制,以及暫時性差額不太可能在可見將來撥回,則屬例外。

就所有可扣減暫時性差額、結轉的未動用税項抵 免及任何未動用税項虧損而言,遞延税項資產一 律確認入賬。若日後有可能應課税溢利,可用以 抵銷該等可扣減暫時性差額、結轉的未動用税項 抵免及未動用税項虧損產生,則遞延税項資產確 認入賬,惟:

- 倘若有關可扣減暫時性差額的遞延税項資 產來自在一宗屬非業務合併的交易中初步 確認資產或負債,而且在交易時對會計溢 利或應課税溢利或虧損均無影響,則屬例 外;及
- 就於附屬公司的投資的相關可扣減暫時性 差額而言,僅在暫時性差額有可能在可見 將來撥回,而且日後有可能出現應課税溢 利,可用以抵銷該等暫時性差額時,方會 確認遞延税項資產。

遞延税項資產的賬面值在每個報告期末予以審 閱。若不再可能有足夠應課税溢利用以抵扣全部 或部分遞延税項資產,則扣減遞延税項資產賬面 值。未確認的遞延税項資產於每個報告期末重新 評估,並於可能有足夠應課税溢利用以收回全部 或部分遞延税項資產時確認。

Deferred tax assets and deferred tax liabilities are offset if and only if the Group has a legally enforceable right to set off current tax assets and current tax liabilities and the deferred tax assets and deferred tax liabilities relate to income taxes levied by the same taxation authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

Government grants

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, for which it is intended to compensate, are expensed.

Where the grant relates to an asset, the fair value is credited to a deferred income account and is released to the statement of profit or loss over the expected useful life of the relevant asset by equal annual instalments.

Employee benefits

Pension scheme

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Hong Kong Mandatory Provident Fund Schemes Ordinance for those employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries and are charged to the statement of profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

The employees of the Group's subsidiaries which operate in Mainland China are required to participate in a central pension scheme operated by the local municipal government. These subsidiaries are required to contribute a certain percentage of their payroll costs to the central pension scheme. The contributions are charged to the statement of profit or loss as they become payable in accordance with the rules of the central pension scheme.

所得税(續)

僅於本集團具有可依法強制執行的權利,可以即 期税項資產抵銷即期税項負債,及僅於遞延税項 資產與遞延税項負債是關於同一税務機關就同 一應課税實體所徵收的所得税或就計劃於各段 未來期間(而預期在有關期間內將結清或收回大 額的遞延税項負債或資產)以淨額基準結算即期 税項負債與資產或同時變現資產及結清負債之 不同應課稅實體所徵收的所得税時,則遞延所得 税資產及遞延所得税負債可相互抵銷。

政府補貼

僱員福利 退休金計劃

Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

Revenue from the sale of printed circuit boards is recognised at the point in time when control of the asset is transferred to the customer, generally on delivery of the printed circuit boards.

Revenue from other sources

Rental income is recognised on a time proportion basis over the lease terms. Variable lease payments that do not depend on an index or a rate are recognised as income in the accounting period in which they are incurred.

Other income

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

Dividends

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting. Proposed final dividends are disclosed in the notes to the consolidated financial statements.

Interim dividends are simultaneously proposed and declared, because the Company's memorandum and articles of association grant the directors the authority to declare interim dividends. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared.

These financial statements are presented in Hong Kong dollars, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Nonmonetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss, respectively).

The functional currencies of certain overseas subsidiaries are currencies other than the Hong Kong dollar. As at the end of the reporting period, the assets and liabilities of these entities are translated into Hong Kong dollars at the exchange rates prevailing at the end of the reporting period and their statements of profit or loss are translated into Hong Kong dollars at the exchange rates that approximate to those prevailing at the dates of transactions. The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve. On disposal of a foreign operation, the component of other comprehensive income relating to that particular foreign operation is recognised in the statement of profit or loss.

For the purpose of the consolidated statement of cash flows, the cash flows of overseas subsidiaries are translated into Hong Kong dollars at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of overseas subsidiaries which arise throughout the year are translated into Hong Kong dollars at the exchange rates that approximate to those prevailing at the dates of the transactions.

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

Judgements

In the process of applying the Group's accounting policies, management has made the following judgements, apart from those involving estimations, which have the most significant effect on the amounts recognised in the financial statements:

Determination of functional currency

In determining the functional currency of each entity of the Group, judgement is required to determine and consider the currency that mainly influences sales prices of goods; the currency that mainly influences costs of providing goods; the currency in which funds from financing activities are generated; and the currency in which receipts from operating activities are usually retained, etc. The functional currency of each entity is determined based on management's assessment of the primary economic environment in which the entities operate. When the indicators are mixed and the functional currency is not obvious, management uses its judgement to determine the functional currency that most faithfully represents the economic effects of the underlying transactions, events and conditions.

Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

估計不明朗因素

涉及將來及報告期末的其他主要估計不確定性 來源並很有可能引致資產及負債賬面值於下一 財政年度內大幅調整的主要假設在下文闡述。

Estimation uncertainty (continued)

Measurement of an unlisted equity investment at fair value

The fair value of an unlisted equity investment that is not traded in an active market is estimated by management with reference to valuation performed by an independent professionally qualified valuer by using valuation technique that requires various sources of information and assumptions. The carrying amount of the Group's unlisted equity investment at 31 December 2021 was HK\$4,440,000 (2020: HK\$4,311,000).

Estimation of fair value of investment properties

In the absence of current prices in an active market for similar properties, the Group considers information from a variety of sources, including:

- (a) current prices in an active market for properties of a different nature, condition or location, adjusted to reflect those differences; and
- (b) recent prices of similar properties on less active markets, with adjustments to reflect any changes in economic conditions since the date of the transactions that occurred at those prices.

The carrying amount of investment properties at 31 December 2021 was HK\$29,293,000 (2020: HK\$28,933,000). Further details, including the key assumptions used for fair value measurement are given in note 14 to the financial statements.

Write-down of inventories to net realisable value

The Group performs regular review of the carrying amount of inventories to determine whether any write-down of inventories to net realisable value is required after considering, inter alia, the ageing analysis of the Group's inventories, current market conditions and the expected future sales of goods and usage of materials. Write-down of inventories will be made when the estimated net realisable values of inventories decline below their carrying amounts. Net realisable values of inventories are based on estimated selling prices less any estimated costs to be incurred to completion and disposal. These estimates are made with reference to the current market conditions and the historical experience of manufacturing and selling products of a similar nature. Actual selling prices and saleability/usage of goods/materials might be different from estimations and profit or loss could be affected by differences in the estimations

本集團定期審閱其存貨賬面值,當中經考慮(其 中包括)本集團的存貨的賬齡分析、當前市況及 產品預期未來銷售及材料用途,以釐定是否撇減 存貨至可變現淨值。倘存貨可變現價值淨估值下 降到其賬面值以下,則會撇減存貨。存貨的可變 現淨值乃根據估計售價減任何估計完成及出售 將會產生的成本計算。該等估計乃參照當前市況 以及製造及銷售相似性質產品的歷史經驗作出。 貨品/物料實際售價及銷售能力/使用可能異於 估計,而損益可能受估計差異影響。

Leases — Estimating the incremental borrowing rate The Group cannot readily determine the interest rate implicit in a lease, and therefore, it uses an incremental borrowing rate ("IBR") to measure lease liabilities. The IBR is the rate of interest that the Group would have to pay to borrow over a similar term, and with a similar security, the funds necessary to obtain an asset of a similar value to the right-of-use asset in a similar economic environment. The IBR therefore reflects what the Group "would have to pay", which requires estimation when no observable rates are available (such as for subsidiaries that do not enter into financing transactions) or when it needs to be adjusted to reflect the terms and conditions of the lease (for example, when leases are not in the subsidiary's functional currency). The Group estimates the IBR using observable inputs (such as market interest rates) when available.

Provision for expected credit losses on trade and bills receivables

The Group uses a provision matrix to calculate ECLs for trade and bills receivables. The provision rates are based on days past due for groupings of various customer segments that have similar loss patterns.

The provision matrix is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

The assessment of the correlation among historical observed default rates, forecast economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forecast economic conditions. The Group's historical credit loss experience and forecast of economic conditions may also not be representative of a customer's actual default in the future. The information about the ECLs on the Group's trade and bills receivables is disclosed in note 18 to the financial statements.

本集團使用撥備矩陣以計算貿易應收款項及應 收票據的預期信貸虧損。撥備率乃基於不同客戶 分部組別的欠款逾期日數而定,該等客戶分部的 虧損模式相似。

撥備矩陣乃初始基於本集團的過往可觀察違約 比率。本集團將按經前瞻性資料調整的過往信貸 虧損經驗調節該矩陣。於各報告日期,本集團更 新過往可觀察違約比率及分析前瞻性估計的變 動。

過往可觀察違約比率、預測經濟狀況及預期信貸 虧損之間關係的評估乃重大的估計。預期信貸虧 損金額對情況的變動及預測經濟狀況相當敏感。 本集團的過往信貸虧損經驗及預測經濟狀況就 客戶未來實際違約而言亦未必有代表性。有關本 集團貿易應收款項及應收票據的預期信貸虧損 資料於財務報表附註18披露。

Deferred tax liabilities are recognised for withholding tax in respect of certain unremitted earnings of certain subsidiaries of the Group established in Mainland China to the extent that the directors are of the opinion that it would be probable for distribution in the foreseeable future. Significant management judgement is required to determine the amount of deferred tax liabilities that should be recognised. Further details are contained in note 25 to the consolidated financial statements.

Deferred tax assets

Deferred tax assets are recognised for unused tax losses to the extent that it is probable that taxable profits will be available against which the tax losses can be utilised. Recognition of deferred tax assets primarily involves management judgement and estimations regarding the taxable profits of the entities in which the losses arose. Significant management judgement is required to determine the amount of deferred tax assets that can be recognised, based upon the likely timing and level of future taxable profits together with future tax planning strategies.

4. OPERATING SEGMENT INFORMATION

The Group focused primarily on the manufacture and sale of printed circuit boards during the year. Information reported to the Group's chief operating decision maker, for the purpose of resource allocation and performance assessment, focuses on the operating results of the Group as a whole as the Group's resources are integrated and no discrete operating segment financial information is available. Accordingly, no operating segment information is presented.

Hong Kong profits tax has been provided at the rate of 16.5% (2020: 16.5%) on the estimated assessable profits arising in Hong Kong during the year, except for one subsidiary of the Group which is a qualifying entity under the two-tiered profits tax rates regime. The first HK\$2,000,000 (2020: HK\$2,000,000) of assessable profits of this subsidiary are taxed at 8.25% (2020: 8.25%) and the remaining assessable profits are taxed at 16.5% (2020: 16.5%). Taxes on profits assessable elsewhere have been calculated at the rates of tax prevailing in the jurisdictions in which the Group operates.

The provision for land appreciation tax has been estimated according to the requirements set forth in the relevant PRC laws and regulations. Land appreciation tax has been provided at ranges of progressive rates of the appreciation value, with certain allowable deductions.

All subsidiaries of the Group established in the PRC are subject to PRC corporate income tax at a standard rate of 25% (2020: 25%) during the year, except for a subsidiary of the Group which qualified as a High and New Technology Enterprise in Mainland China and a lower PRC corporate income tax rate of 15% (2020: 15%) has been applied for the year.

Each year, the Group's chief financial officer decides, after approval from the directors, to appoint which external valuer to be responsible for the external valuations of the Group's investment properties. Selection criteria include market knowledge, reputation, independence and whether professional standards are maintained. The Group's chief financial officer has discussions with the valuer on the valuation assumptions and valuation results twice a year when the valuations are performed for interim and annual financial reporting.

The investment properties consisting of a commercial property and residential properties are leased to third parties under operating leases, further summary details of which are included in note 15 to the financial statements.

At 31 December 2021, an investment property of the Group with a carrying amount of HK\$6,862,000 (2020: HK\$6,678,000) was pledged to secure general banking facilities granted to the Group (note 24).

Yan Tat (HK) Industrial Limited ("YT Industrial") is an indirect wholly-owned subsidiary of the Company. During the year ended 31 December 2020, a framework agreement (the "Framework Agreement") in relation to possible disposal of YT Industrial for an urban renewal project located at the Group's factory in Pingshan District, Shenzhen, the PRC was expired. Accordingly, the relevant assets and liabilities of YT Industrial, which were previously classified as held for sale as at 31 December 2019, were ceased to be classified as held for sale during the year ended 31 December 2020.

On 8 May 2020, the Group entered into, amongst others, a cooperation agreement (the "Cooperation Agreement") with certain independent third parties, pursuant to which the relevant parties have conditionally agreed to cooperate in connection with an urban renewal project, which comprises of certain arrangements involving certain target land parcels and related premises currently owned by the Group. The Cooperation Agreement and the transactions contemplated thereunder (the "Transactions") were approved by the shareholders of the Company at an extraordinary general meeting held on 14 July 2020. Further details of the Cooperation Agreement and the Transactions are also set out in the Company's announcements dated 15 May 2020 and 14 July 2020 and the Company's circular dated 24 June 2020.

Pursuant to the Cooperation Agreement, in respect of one of the target land parcels and the buildings erected thereon (the "Target Land and Buildings") currently owned by a subsidiary of YT Industrial, the Group shall sell the entire equity interest in YT Industrial (the "Disposal of YT Industrial"). In the opinion of the directors, the Disposal of YT Industrial, including the relevant underlying assets in accordance with terms of the Cooperation Agreement (the "Relevant Assets"), is expected to be completed within one year from 31 December 2021. Accordingly, the Relevant Assets (including the Target Land and Buildings) were classified as held for sale as at 31 December 2021.

35. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The Group's principal financial instruments arise directly from its operations.

The main risks arising from the Group's financial instruments are interest rate risk, foreign currency risk, credit risk and liquidity risk. The board of directors reviews and agrees policies for managing each of these risks and they are summarised below.

Interest rate risk

Interest rate risk is the risk that the future cash flows of a financial instrument will fluctuate because of changes in market interest rates. The Group's exposure to the risk of changes in market interest rates relates primarily to the Group's cash at banks, time deposits and borrowings with floating interest rates.

The following table demonstrates the sensitivity to a reasonably possible change in interest rates, with all other variables held constant, of the Group's profit before tax (through the impact on deposits with banks and floating rate borrowings). There is no impact on the Group's equity except on the retained profits.

Foreign currency risk

The Group has transactional currency exposures. Those exposures arise from sales or purchases by operating units in currencies other than the units' functional currencies. The Group's main operating subsidiaries are located in Hong Kong and Mainland China and the Group's sales and purchases were mainly conducted in HK\$, RMB and US\$.

The RMB is not a freely convertible currency. Future exchange rates of the RMB could vary significantly from the current or historical exchange rates as a result of the changes in the PRC foreign currency policy. The exchange rates may also be affected by economic developments and political changes domestically and internationally, and the demand and supply of the RMB. The appreciation or devaluation of RMB against HK\$ and US\$ may have an impact on the operating results of the Group.

The following table demonstrates the sensitivity at the end of the reporting period to a reasonably possible change in the RMB exchange rates, with all other variables held constant, of the Group's profit before tax (due to changes in the fair values of monetary assets and liabilities). There is no impact on the Group's equity except on the retained profits.

Credit risk (continued)

The credit risk of the Group's financial assets, which comprise trade and bills receivables, pledged deposits, cash and cash equivalents, and financial assets included in prepayments, deposits and other receivables, arises from default of the counterparty, with a maximum exposure equal to the carrying amounts of these instruments.

Concentrations of credit risk are managed by customer/ counterparty. At the end of the reporting period, the Group had certain concentrations of credit risk as 37.3% (2020: 52.9%) and 63.7% (2020: 73.0%) of the Group's trade and bills receivables were due from the Group's largest customer and five largest customers, respectively.

Liquidity risk

The Group's objective is to maintain a balance between continuity of funding and flexibility through the use of bank borrowings. The Group's policies are to regularly monitor the current and expected liquidity requirements, and to ensure that it maintains sufficient reserves of cash and available banking facilities to meet its liquidity requirements in the short and longer term.

The primary objectives of the Group's capital management are to safeguard the Group's ability to continue as a going concern and to maintain healthy capital ratios in order to support its business and maximise shareholders' value.

The Group manages its capital structure and makes adjustments to it in light of changes in economic conditions. To maintain or adjust the capital structure, the Group may adjust the dividend payment to shareholders or raise new capital from its investors. The Group is required to comply with certain externally imposed capital requirements set out in certain of its bank loan agreements/bank facility letters. No changes were made in the objectives, policies or processes for managing capital during the years ended 31 December 2021 and 31 December 2020.

The Group monitors capital using a gearing ratio, which is total debt divided by total equity. Total debt includes interest-bearing bank borrowings.
