Lifestyle China Group Limited ("Lifestyle China" or together with its subsidiaries, the "Group") is an established retail venue operator based in the PRC. The Group has been operating two "lifestyle" department stores under the Jiuguang brand in Shanghai and Suzhou respectively. The latest addition to its portfolio is the Shanghai Jiuguang Center, comprising a seven-storey shopping mall and two office towers, situated also in the Jing'an District, Shanghai. Opened in November 2021, the shopping mall houses the Group's second Jiuguang department store in Shanghai and other complementary facilities including restaurants, beauty salons and fitness centers. The office towers will be leased out for generating rental income to the Group.

Targeting the mid-range to upper-end consumer market in China, the Group's Shanghai Jiuguang Center and Jiuguang department stores have differentiated themselves with their appealing product and brand portfolios and top-notch one-stop shopping experiences. The Group is committed to optimizing its product mix and enhancing its customer services with a view to satisfy the diverse needs of local consumers in terms of shopping, leisure and lifestyle.

In addition to operating its own retailing venues, the Group has been maintaining a strategic equity interest in the Beiren Group, a leading retailing group based in Shijiazhuang, Hebei Province, PRC. Business of the Beiren Group includes operating department stores, supermarkets, electrical appliances, gold and jewelry and outlet mall. The business performance of the Beiren Group is important to the Group and the share of results by the Group in the Beiren Group represents a significant portion of the results of the Group. 利福中國集團有限公司(「利福中國」或連同其附 屬公司,「本集團」)為中國廣為人知的零售場所 營運商。本集團以久光品牌分別於上海及蘇州經 營兩間「生活時尚」百貨店。其物業組合之最新增 加的物業為上海久光中心,包括一座七層高的購 物中心及兩座辦公樓,其亦位於上海靜安區。該 購物中心於二零二一年十一月開業,以打造本集 團在上海第二個久光百貨店及其他配套設施,包 括餐廳、美容院及健身中心。辦公樓將會出租, 為本集團帶來租金收入。

以中國中高端消費者市場為目標,本集團的上海 久光中心及久光品牌旗下的百貨店憑藉具吸引力 的產品及品牌組合,以及頂尖一站式的購物體驗 而脱穎而出。本集團致力優化其產品組合並提升 其顧客服務,以滿足本地消費者在購物、休閒及 生活時尚方面的多樣化需求。

除了經營其零售場所,本集團一直持有素根於中 國河北省石家莊的零售龍頭集團北人集團之策略 性股權。北人集團的業務包括經營百貨店、超 市、電器、金器及珠寶及特賣場。北人集團的經 營業績對本集團乃屬重要,而本集團應佔北人集 團之業績為本集團業績的一個重大部分。

Dear Shareholders,

The year 2021 saw recovery in most economies across the globe from the COVID-19 pandemic low and China, the world's second largest economy, is of no exception and continued to record strong growth in its economy especially during the first half of the year, before the growth momentum somewhat slowed in the second half of the year. Nevertheless, the retailing environment in China during the year was still fraught with operational challenges and market instability that the Group forged ahead with the implementation of a series of multifaceted strategies that were focused on the continuous optimization of store operations in a bid to further bolster the Group's competitiveness.

With the Group's strategic efforts and in spite of the difficult operating environment, the Group's revenue for the year ended 31 December 2021 grew 15.6% year-on-year to RMB1,299.7 million and also surpassed the pre-pandemic level of RMB1,204.1 million in 2019.,Profit attributable to owners of the Company for the year amounted to RMB143.4 million, a drop of 32.6% when compared with RMB212.7 million recorded in 2020. The board of directors has resolved not to declare any dividend for the year.

While the Group's two well-established department stores, Shanghai Jiuguang and Suzhou Jiuguang, outperformed the general retailing market and recorded sales growth of approximately 15.0% and 17.9% respectively for the year, the launch of the retail mall of the Group's Shanghai Jiuguang Center, a commercial complex comprising the retail mall and two office blocks, is another cause for optimism. Opened in Shanghai in late November, the retail mall not only provides a wide range of retailers and merchandises to meeting the diverse needs of local consumers as a shopping venue, the complex also acts as a lifestyle and community hub where visitors can meet and unwind. With two impressive Shanghai-based shopping complexes under its belt, it is expected that the Group's market presence in the city will further increase.

致各位股東:

於二零二一年,全球大多數經濟體從COVID-19 疫情的低谷中復甦,世界第二大經濟體中國亦不 例外,尤其是本年度上半年,其經濟持續錄得強 勁增長,而增長勢頭於下半年有所放緩。儘管如 此,年內中國零售環境仍面臨營運挑戰及市場不 穩定性,本集團積極實施一系列多方位策略,著 力持續優化店舖營運,進一步加強本集團的競 爭力。

在本集團的策略努力下,儘管經營環境艱難,本 集團截至二零二一年十二月三十一日止年度的收 入按年增長15.6%至人民幣1,299.7百萬元,亦超 過二零一九年的疫情前人民幣1,204.1百萬元的水 平。本公司擁有人應佔年內溢利為人民幣143.4百 萬元,較二零二零年錄得的人民幣212.7百萬元下 跌32.6%。董事會已決議年內不宣派任何股息。

本集團旗下兩家知名百貨店— 上海久光及蘇州 久光年內表現優於一般零售市場,分別錄得約 15.0%及17.9%的銷售增長,而本集團旗下的上海 久光中心(一個由零售商場及兩座辦公樓組成的 商業綜合體)的零售商場開業是情況樂觀的另一 個要素。該零售商場於十一月下旬在上海開業, 不僅作為購物場所提供各式各樣的零售商及商 品,以滿足當地消費者的多樣化需求,該綜合體 亦作為生活時尚及社區樞紐,讓遊客可會面及放 鬆身心。憑藉該區域的兩個以上海為基地的矚目 購物綜合體,預期本集團於該市的市場佔有率將 進一步提升。 To enrich the lifestyle experiences for customers visiting its stores, the Group added during the year unconventional retailers and service providers such as gyms and medical aesthetics centers to its existing department stores and this move has resulted in a higher number of repeated visits as well as increased spending in other surrounding shops. To increase and deepen customer engagement, the Group continued to embrace digitalization of its retail management system and that different social media platforms including live streaming are being utilized to drive foot traffic to its department stores. While the constant evolution and diversification of consumption patterns and consumer behavior remains a challenge to retailers, we believe there are enormous opportunities arising from the deeper integration of online and offline sales platforms.

In order to remain competitive and promote sustainable growth amid the challenging external environment, the Group will continue to implement prudent strategies by expanding its product portfolio and improve its customer services in an effort to uphold its reputation and cater to its customers' expectations. The Group will continue to leverage Jiuguang's strong brand recognition and to position as a department store chain that serves the sophisticated needs of China's middle class.

Separately, the Group has started the leasing process to recruit tenants for the two office blocks of the Shanghai Jiuguang Center, which will bring to the Group stable rental income stream in the future. With the location advantage, the two office blocks are set to become one of Shanghai's most desirable business locations and will further enhance the image of the Group's Shanghai Jiuguang Centre and its overall presence in the city.

Looking ahead, China's economy will continue to face challenges resulted from the ongoing geopolitical and trade tensions and the continued sporadic outbreaks of COVID-19. As such, the government is likely to deploy various fiscal and monetary policies to boosting the country's economic development with an aim to achieving the 5.5% GDP growth target for 2022, the Group remains cautiously optimistic about the health of China's retail sector going forward. We are committed to strengthening our position as a leading lifestyle retailer serving the sophisticated needs of China's middle-class and are confident that, given our enhanced business strategies and extensive industry experience, we can achieve a stable performance despite the difficult operating environment.

On behalf of the board of directors, I would like to express my gratitude to our management team and staff for their considerable efforts and continued contributions to the Group's development. The dedication they have shown, despite facing additional pressure as a result of the epidemic, has been a pillar of strength for the Group over the past year. Finally, on behalf of the Group, I would also like to thank our customers, business partners and shareholders for their unswerving support.

展望未來,中國經濟將繼續面臨持續的地緣政治 及貿易緊張局勢以及 COVID-19持續零星爆發所 帶來的挑戰。因此,政府可能會部署各種財政及 貨幣政策以促進國家經濟發展,以達致二零二二 年國內生產總值增長5.5%的目標,本集團對未來 中國零售業的發展保持謹慎樂觀。我們致力鞏固 我們作為領先生活時尚零售商的地位,滿足中國 中產階層的更高需求,並深信憑藉我們經強化的 業務策略及豐富的行業經驗,我們能夠在艱難的 經營環境中取得穩定的業績。

Market Overview

The global economy in 2021 generally saw a rebound from the bottom that was caused by the COVID-19 pandemic. However, economic situation remained complex and marred by uncertainty with the emergence of new COVID-19 variants and ongoing political tensions between the US and China that has set the stage for a challenging global economic environment. In China, notwithstanding the resurgence of COVID-19 infections in certain parts of the country in the second half of the year that cooled the economy with the gross domestic product ("GDP") grew only 4.9% and 4.0% in the third and fourth quarters respectively, the strong rebound in economic growth in the first half of the year brought about by resumption of normal economic activities has resulted a 8.1% growth in the country's GDP to approximately RMB114.37 trillion for the year 2021.

China's GDP growth also led to a 12.5% growth in the country's total retail sales of consumer goods although the growth momentum started to slow from August onwards with the year-on-year growth rate dropped to a low of 1.7% in December. In the same month, the overall consumer price index ("CPI") edged down by 0.3% from November, bringing down the inflation rate for the whole year to a moderate increase of 0.9% from the preceding year.

Financial Review

Faced with a challenging market environment, the Group responded by adopting a series of multifaceted strategies which included optimizing its product mix, continuing to leverage its well-established brand equity and promoting the new retail business to give full play to the complementary advantages of online and offline retailing. Most noteworthy is the opening of the Group's Shanghai Jiuguang Center in Daning in late November which will not only provide additional revenue to the Group but also bring synergies to the Group's retail business with its already well-established Shanghai Jiuguang and Suzhou Jiuguang department stores.


市場概覽

全球經濟於二零二一年普遍從新型冠狀病毒 (「COVID-19」)疫情導致的谷底反彈。然而,受到 新COVID-19變種病毒的出現以及中美之間持續 的政治緊張局勢所帶來之不明朗因素困擾,經濟 情況依然複雜並奠定了充滿挑戰的全球經濟環 境。儘管COVID-19疫情在下半年於國內部分地 區再次出現,使經濟降溫,中國國內生產總值 (「國內生產總值」)於第三及第四季度僅分別錄得 4.9%及4.0%之增長。而上半年經濟活動恢復正 常,卻為經濟增長帶來強勁反彈,帶動中國的國 內生產總值於二零二一年增長8.1%至約人民幣 114.37萬億元。

儘管增長勢頭自八月起放緩至十二月低見1.7%之 按年增長,但中國的國內生產總值的增長仍帶動 國家消費品的零售銷售總額增加12.5%。同月, 整體消費者物價指數(「消費者物價指數」)較十一 月稍回落0.3%,導致全年通脹水平只較上年溫和 增長0.9%。

財務回顧

為應對挑戰重重的市場環境,本集團採取一系列 多方面的策略,其中包括優化產品組合,繼續發 揮良好的品牌認受性,推廣新零售業務,以充分 發揮線上及線下零售的互補優勢。最尤其關注的 本集團位於大寧的上海久光中心已於十一月底開 業,其不僅可為本集團帶來額外的收入,亦可為 本集團的零售業務,包括其建立已久的上海久光 及蘇州久光百貨店,帶來協同效應。



For the year ended 31 December 2021, the Group's revenue increased 15.6% to reach RMB1,299.7 million, compared with the RMB1,124.0 million recorded in 2020 and surpassed the pre-pandemic level of RMB1,204.1 million recorded in 2019. The increase was primarily a result of the Group's effective marketing strategies which successfully drove sales at the two Jiuguang stores, particularly in the first half of 2021, as well as the contribution from the newly-opened Shanghai Jiuguang Center since late November. Sales performance at the two stores continued to see improvement following the addition of more mid-range and high-end products from internationally renowned brands during the year. The total sales proceeds of the Group grew by 17.3% year-on-year to RMB3,482.9 million in 2021, up from RMB2,968.2 million in 2020. If excluding the contribution of approximately RMB53.5 million from the newly-opened Shanghai Jiuguang Center, aggregate sales proceeds from the existing stores increased 15.5% to RMB3,429.4 million.

Gross Profit and Concessionaire Rate

The Group's gross profit amounted to RMB790.4 million for the year, an increase of 16.0% from RMB681.4 million in the previous year. The gross profit margin as a percentage of total sales proceeds was approximately 22.7%, compared with 23.0% in 2020. Meanwhile, the Group's gross profit margin as a percentage of revenue remained stable at 60.8% as compared to 60.6% last year. The average concessionaire rate dropped slightly to approximately 20.6% from last year's 21.0%.

Net Profit Attributable to Shareholders

Net profit attributable to shareholders of the Company for the year ended 31 December 2021 amounted to RMB143.4 million, as compared to RMB212.7 million in 2020. The decrease in profit was mainly due to increase in selling and distribution costs and administrative expenses, which was a result of the inclusion of the normal operating and preopening fitting and decoration expenses, as well as an one-off opening expenses of RMB34.8 million of the Shanghai Jiuguang Center.

Selling and Distribution Costs

The Group's aggregate selling and distribution costs grew 28.1% to RMB523.7 million in 2021 from RMB408.8 million in 2020. The increase was mainly attributable to (i) increase in operating expenses of RMB33.2 million amid sales growth; (ii) increase in depreciation and amortization charges of RMB21.1 million, mainly from the Shanghai Jiuguang Center; and (iii) an approximately RMB36.6 million of counter fitting and decoration costs for the brand partners as incentives for them to operate in the Group's Shanghai Jiuguang Center. The Group's aggregate selling and distribution expenses as a percentage of total sales proceeds increased to approximately 15.0% for the year, compared with 13.8% in 2020 as initial sales from the newly-opened Shanghai Jiuguang Center was not in proportion to its operating expenses.

收入及銷售所得款

截至二零二一年十二月三十一日止年度,本集團 收入由二零二零年錄得的人民幣1,124.0百萬元增 加15.6%至人民幣1,299.7百萬元,並超逾二零 一九年疫情前人民幣1,204.1百萬元的水平。該增 幅乃主要由於本集團在兩間久光店舖有效的營銷 策略成功帶動銷售,尤其是在二零二一年上半 年,加上新開業的上海久光中心自十一月底起的 貢獻所致。隨著引入更多國際知名品牌的中高檔 產品,年內兩間店舖的銷售表現持續改善。本集 團的銷售所得款總額按年增長17.3%,由二零二 零年的人民幣2,968.2百萬元增加至二零二一年的 人民幣3,482.9百萬元。如扣除來自新開業的上海 久光中心人民幣53.5百萬元的貢獻,來自現有店 舖的銷售所得款總額則增加15.5%至人民幣 3,429.4百萬元。

毛利及特許專櫃扣率

本集團年內的毛利為人民幣790.4百萬元,較去年 人民幣681.4百萬元上升16.0%。毛利率按銷售所 得款總額計算之百分比約為22.7%,而二零二零 年則為23.0%。同時,本集團毛利率按收入計算 之百分比維持穩定於60.8%,而去年則為60.6%。 平均特許專櫃扣率則由去年的21.0%稍降至約 20.6%。

股東應佔溢利淨額

截至二零二一年十二月三十一日止年度,本公司 股東應佔淨溢利為人民幣143.4百萬元,在二零二 零年則為人民幣212.7百萬元。該溢利減少乃主要 由於銷售及分銷成本以及行政開支增加,主要因 計入來自上海久光中心的經營開支以及開業前的 裝潢及裝修費用,而當中包括一次性開業成本人 民幣34.8百萬元。

銷售及分銷成本

本集團的總銷售及分銷成本由二零二零年的人民 幣408.8百萬元增加28.1%至二零二一年的人民幣 523.7百萬元。此增加主要是由於(i)銷售增長令經 營開支增加人民幣33.2百萬元:(ii)主要來自上海 久光中心的折舊及攤銷費用增加人民幣21.1百萬 元:及(iii)以鼓勵品牌夥伴於本集團上海久光中心 營運需負擔專櫃的裝潢及裝修成本為人民幣36.6 百萬元。因來自新開業的上海久光中心的初始銷 售與營運開支不成正比,本集團年內的總銷售及 分銷開支按銷售所得款總額之百分比由二零二零 年的13.8%增加至約15.0%。

Administrative Expenses

The Group's general administrative expenses surged 52.7% to approximately RMB238.3 million from RMB156.1 million recorded in 2020. The increase was mainly attributable to (i) additional depreciation charge of approximately RMB11.8 million and a one-off store grand-opening expense of RMB34.8 million with respect to the Shanghai Jiuguang Center; and (ii) increase in staff costs of approximately RMB32.0 million.

Staff Costs

Staff costs (excluding directors' emoluments) increased by 22.9% to approximately RMB191.3 million from RMB155.6 million in 2020. The increase was mainly attributable to (i) additional staff costs incurred for the operation of the Shanghai Jiuguang Center; (ii) increase in social security contributions in the absence of relief measures implemented by the government last year; and (iii) payment of a one-off compensation of RMB6.2 million for the dismissed staff after outsourcing the Freshmart supermarket operation at Suzhou store and optimizing checkout process for the concessionaire counters. Notwithstanding additional headcount was required for the operation of the Shanghai Jiuguang Center, the total number of full-time staff employed by the Group as at 31 December 2021 was 1,167, only a small increase from 1,159 as at 31 December 2020 as the additional headcount was off-set by the number of staff being made redundant.

Other Income, Gains and Losses

Other income, gains and losses, which mainly comprises management fees, third-party payment platform charges and other miscellaneous income received from the counters/tenants, other sundry income and exchange gains/losses, recorded an increase of 26.3% to RMB130.5 million for the year ended 31 December 2021. The increase was primarily attributable to (i) rise in management fee income and third-party payment platform charges from counters amid sales growth; and (ii) a gain on lease modification of RMB17.0 million (2020 : RMB15.3 million) resulting from a change in the lease term in respect of the tenancy for the Freshmart supermarket in Changning, Shanghai.

Interest and Investment Income

The Group's income from interest and investments decreased by 6.4% to RMB51.3 million in 2021 from RMB54.8 million in 2020. The drop was mainly due to a decrease in investment income from the Group's structured deposits.

行政開支

本集團的一般行政開支由二零二零年錄得的人民幣156.1百萬元飆升52.7%至約人民幣238.3百萬元。該增加主要是來自(i)額外的折舊費用約人民幣11.8百萬元及有關上海久光中心的一次性開業成本人民幣34.8百萬元;及(ii)員工成本增加約人民幣32.0百萬元所致。

員工成本

員工成本(不包括董事酬金)由二零二零年的人民 幣155.6百萬元增加22.9%至約人民幣191.3百萬 元。該增加主要來自(i)上海久光中心營運而產生 的額外員工成本:(ii)在政府沒有如去年採取救濟 措施的情況下而增加的社會保障繳款:及(iii)因外 判蘇州店「鮮品館」超市營運及特許專櫃收銀方式 優化而為辭退的員工支付人民幣6.2百萬元的補 償金。儘管在上海久光中心營運中增加了員工數 目,該增加的員工人數被解僱的員工人數抵銷, 於二零二一年十二月三十一日,本集團全職員工 總數由二零二零年十二月三十一日的1,159名只 微升至1,167名。

其他收入、收益及虧損

其他收入、收益及虧損主要包括從專櫃/租戶收 取的管理費收入、第三方支付平台費用及其他各 項收入,以及其他雜項收入及匯兑收益/虧損, 截至二零二一年十二月三十一日止年度,錄得 26.3%增幅至約人民幣130.5百萬元。該增加主要 來自(i)銷售增長令從專櫃收取的管理費及第三方 支付平台費用增加,及(ii)來自位於上海長寧的 「鮮品館」超市租賃協議的租賃條款變更產生的人 民幣17.0百萬元(二零二零年:人民幣15.3百萬 元)收益。

利息及投資收入

本集團的利息及投資收入由二零二零年的人民幣 54.8百萬元減少6.4%至二零二一年的人民幣51.3 百萬元。下跌主要是由於來自本集團結構性存款 的投資收入減少。

Finance Costs

The Group's finance costs mainly consisted of interest incurred on bank borrowings. Total finance costs and interest incurred for the year before capitalization, was approximately RMB124.9 million (2020 : RMB133.8 million) and the slight decrease was mainly due to a drop in the finance charge from lease liabilities following the lease modification relating to the lease for the Freshmart in Changning, Shanghai. Finance costs charged to the profit and loss account amounted to RMB27.9 million (2020 : RMB25.4 million) comprised mainly an approximately RMB19.0 million (2020 : RMB25.4 million) of finance charge in respect of lease liabilities and an approximately RMB8.9 million of bank loan interest expenses which could no longer be capitalized following opening of the Shanghai Jiuguang Center.

Liquidity and Financial Resources

The Group's adjusted EBITDA for the year increased to RMB326.4 million from RMB313.8 million recorded last year, mainly attributable to the sales growth. As at 31 December 2021, the Group's net debt (defined as cash and cash equivalents and amount due from associates less total bank borrowings, amount due to a non-controlling shareholder of subsidiaries and amount due to a joint venture) improved slightly to approximately RMB444.8 million from RMB457.8 million as at 31 December 2020.

As at 31 December 2021, the Group's cash and cash equivalents amounted to approximately RMB1,858.2 million (2020 : RMB1,906.9 million), of which RMB9.3 million was denominated in Hong Kong dollars and kept in Hong Kong. The remaining cash balance was kept in mainland China, of which approximately 4.2% was denominated in United States dollars and the remaining 95.8% in Renminbi. The decrease in cash at banks, as compared with that at 31 December 2020, was mainly a result of the RMB60 million repayment of bank loan during the year.

As at 31 December 2021, the Group's outstanding secured bank loans amounted to RMB2,340 million (2020 : RMB2,400 million) and this bank loan facility bears interest calculated with reference to benchmark lending rates of the People's Bank of China. The Group's debt to equity ratio (defined as bank borrowings divided by equity attributable to owners of the Company) improved to 25.1% as at the end of the year from 26.1% a year earlier. As at 31 December 2021, the Group had no unutilized banking facility available (2020 : same).

融資成本

本集團的融資成本主要包括銀行借貸產生的利息。在資本化前,年內產生的融資成本及利息總額約為人民幣124.9百萬元(二零二零年:人民幣 133.8百萬元),而輕微跌幅乃主要由於位於上海 長寧的「鮮品館」超市租賃變更導致租賃負債的財 務費用下降所致。計入損益表中的融資成本為人 民幣27.9百萬元(二零二零年:人民幣25.4百萬 元),當中包括租賃負債的財務費用人民幣19.0 百萬元(二零二零年:人民幣25.4百萬元),以及 有關上海久光中心開業後不再被資本化的銀行借 貸的利息開支約人民幣8.9百萬元。

流動資金及財務資源

本年度本集團經調整的未計利息、税項、折舊及 攤銷前的盈利(EBITDA)由去年錄得的人民幣313.8 百萬元增加至人民幣326.4百萬元,主要由於銷售 增長。於二零二一年十二月三十一日,本集團的 淨負債(定義為現金及現金等價物及應收聯營公 司款項減總銀行借貸、應付一名附屬公司非控股 股東款項及應付一間合資企業款項)由二零二零 年十二月三十一日的人民幣457.8百萬元輕微改 善至約人民幣444.8百萬元。

於二零二一年十二月三十一日,本集團的現金及 現金等價物約為人民幣1,858.2百萬元(二零二零 年:人民幣1,906.9百萬元),當中人民幣9.3百萬 元以港元計值並存放於香港。其餘現金餘額則存 放於中國內地,其中約4.2%以美元計值,其餘 95.8%以人民幣計值。與二零二零年十二月 三十一日的銀行結存比較,銀行結存有所減少, 主要是由於在年內償還人民幣60百萬元的銀行貸 款所致。

於二零二一年十二月三十一日,本集團按參考中 國人民銀行基準利率計算利息之未償還抵押銀行 貸款約為人民幣2,340百萬元(二零二零年:人民 幣2,400百萬元)。本集團的負債與權益比率(定義 為銀行借款除本公司擁有人應佔權益)由去年的 26.1%改善至年底的25.1%。於二零二一年十二月 三十一日,本集團沒有可用而未使用銀行信貸額 度(二零二零年:相同)。

Foreign Exchange Management

The functional currency of the Company and its subsidiaries operating in the PRC is Renminbi, in which majority of the Group's transactions are denominated. As described in the "Liquidity and Financial Resources" section above, a small portion of the Group's monetary assets are denominated in foreign currencies, namely Hong Kong dollars and United States dollars. Given the fact that the majority of the Group's revenue and expenses, as well as its borrowings and capital expenditures, are denominated in Renminbi, and the Hong Kong dollar cash balance kept in Hong Kong is for settling operating expenses outside of mainland China, the Group currently does not need a comprehensive foreign currency hedging policy. Management will, however, monitor the Group's foreign currency exposure and will consider taking appropriate measures to mitigate any significant potential foreign currency risk should the need arise.

Pledge of Assets

As at 31 December 2021, certain of the Group's (i) property, plant and equipment in the PRC with a book value of approximately RMB3,936 million (2020 : RMB3,382 million); (ii) right-of-use assets in the PRC with a book value of approximately RMB1,671 million (2020 : RMB1,721 million); and (iii) investment property in the PRC with a book value of approximately RMB1,292 million (2020 : property under development of RMB1,346 million) were pledged to secure bank loan facilities of approximately RMB2,340 million (2020 : RMB2,400 million) for development of the Shanghai Jiuguang Center, which comprises both property, plant and equipment and investment property.

Contingent Liabilities

The Group did not have any material contingent liabilities as at 31 December 2021.

Significant Investments, Material Acquisitions and Disposals

There were no significant investments, material acquisitions or disposals during the year.

Review of Operations

Faced with a competitive retailing market and operation challenges, including related travel restrictions resulting from the ongoing pandemic, the Group prioritized the expansion of its retail portfolio and strengthening of its brand equity with an aim to leverage its competitiveness and strengthen customer loyalty. The Group's brand equity was further enhanced by the launch of the Group's Shanghai Jiuguang Center in late November, putting the Group in a better position to capture market opportunities and provide best in class customer experience in Shanghai. The Group also continued to take advantage of the huge demand from local middle and upper-class customers in Shanghai and Suzhou by introducing a number of new mid-range and high-end products of internationally renowned brands into the Group's department stores, further enhancing its brand image and product mix and ultimately driving sales growth.

外匯監管

本公司及其位於中國的附屬公司的功能貨幣為人 民幣,本集團的大部分交易亦以人民幣計值。如 上文「流動資金及財務資源」一節所述,本集團一 小部分貨幣資產以外幣(港元及美元)計值。鑒於 本集團大部分收益及開支以及其借貸及資本開支 均以人民幣計值,而存放於香港之港元現金結餘 是用作支付中國內地以外地方產生的營運開支, 本集團目前並不需要一套全面外幣對沖政策。然 而,管理層將監察本集團的外幣風險,並將於有 需要時考慮採取適當措施減低任何潛在重大外幣 風險。

資產抵押

於二零二一年十二月三十一日,本集團已抵押其 若干(i)位於中國之物業、廠房及設備,賬面價值 約為人民幣3,936百萬元(二零二零年:人民幣 3,382百萬元):(ii)位於中國之使用權資產,賬面 價值約為人民幣1,671百萬元(二零二零年:人民 幣1,721百萬元):及(iii)位於中國之投資物業,賬 面價值約為人民幣1,292百萬元(二零二零年:發 展中物業為人民幣1,346百萬元)作為獲授銀行貸 款額度約人民幣2,340百萬元(二零二零年:人民 幣2,400百萬元),以用作發展包括物業、廠房及 設備以及投資物業之上海久光中心。

或然負債

於二零二一年十二月三十一日,本集團並無任何 重大或然負債。

重大投資、收購及出售

年內並無重大投資、重大收購或出售事項。

業務回顧

面對競爭激烈的零售市場及營運挑戰,包括疫情 持續帶來的相關旅遊限制,本集團優先擴展其零 售組合及加強其品牌認受性,以發揮其競爭優勢 及加強顧客忠誠度。本集團的品牌認受性因本集 團於十一月底開業的上海久光中心而進一步提 升,使本集團更有能力把握市場機遇及為上海的 顧客提供最佳的顧客體驗。本集團亦透過引入國 際知名品牌的多款新中高檔產品到本集團的百貨 店,繼續把握上海及蘇州中高檔客戶的龐大本地 消費需求,進一步提升其品牌形象及產品組合, 最終帶動銷售增長。 The Group also made available from time to time non-traditional retail names to enrich its product offerings in a bid to further deepening customer engagement and driving foot traffic with increased sales ticket size. These retailers proved to be successful in lifting the sales of other shops within our stores as a result of improved foot traffic. Meanwhile, to better serve young and affluent middle-class customers in the increasingly popular e-commerce market, the Group made effective use of mobile internet technology in its marketing and promotion activities, including live streaming as well as utilizing popular social media platforms.

Shanghai Jiuguang Center

Situated in a prime location close to the Shanghai Circus World Station alongside the Shanghai Metro Line 1, the Group's Shanghai Jiuguang Center provides a gross floor area of approximately 347,000 square meters, comprising two office towers and a seven-storey retail complex. The retail complex was grand-opened on 27 November 2021 and greeted nearly 220,000 visitors in its first day of operation. The retail complex is home to a portfolio of approximately 400 retailers covering the diverse needs of local consumers. In addition to offering a variety of familiar global brands and numerous domestic favorites, the retail complex also houses restaurants, supermarkets, beauty salons and fitness centers, enabling it not only serve as a shopping venue but also a leisure and lifestyle hub. The initial response from the customers has been encouraging and during the thirty-plus business days to the end of the year following its opening in late November, the Shanghai Jiuguang Center recorded daily average footfall of approximately 112,000 visitors.

Shanghai Jiuguang

Despite sporadic outbreaks of COVID-19 noted in the city during the year, Shanghai Jiuguang continued to see an improvement in its business, thanks to the increased application of online marketing as well as the various on-site facilities introduced with an aim to enhancing customers shopping experiences. In addition to the introduction of a fitness center to meet the demand of health-conscious consumers, the Group also organized various classes for customers including make-up class, dance and floral arranging class etc. These activities not only proved to be an effective way of driving footfall into the store, but also increased opportunities for participants to visit the shops nearby. Registration for these classes is done online through mobile internet-enabled applications, and was therefore used also as part of the Group's omni-channel marketing strategy, encouraging online customers to spend at the Group's physical store.

The store's total sale proceeds for the year amounted to RMB2,292.7 million, an increase of 15.0% over that in 2020. Sales performance of cosmetic products and accessories was particularly outstanding, with a growth of more than 20.0% when compared with the previous year. Average daily footfall and stay-and-buy ratio increased 10.1% to approximately 41,000 visitors and 4.6 percentage points to 47.1% respectively. However, average ticket size saw a 2.9% year-on-year decrease to RMB432. The average concessionaire rate collected by the store remained stable at around 23.4%.

本集團亦不時提供非傳統零售品牌,以豐富其產 品供應,從而進一步加深顧客參與度,帶動人流 及增加銷售交易額。該等零售商因改善客流量, 而成功提升於本店內共鄰近商店消費。同時,為 了在日益流行的電子商貿市場給年輕及富裕的中 產消費者提供更好服務,本集團在營銷及推廣活 動中有效利用移動互聯網技術,包括直播以及利 用受歡迎的社交媒體平台。

上海久光中心

上海久光中心位處鄰近上海地鐵1號線中上海馬戲 城站的優越地點,總樓面面積約為347,000平方 米,由兩座辦公大樓及一座樓高七層的零售綜合 體組成。該零售綜合體於二零二一年十一月二十七 日隆重開業,於首個營業日接待近220,000名訪 客。約400個零售商進駐該零售綜合體,滿足當地 消費者的各種需求。除提供各式各樣全球知名品 牌及多個國內至愛品牌外,零售綜合體亦擁有餐 廳、超級市場、美容院及健身中心,讓其不僅是 購物場所,更成為一個休閒與生活時尚中心。於 十一底月開業至年底之三十多天的營業日期間, 上海久光中心錄得日均客流量約112,000人次,顧 客的起初反應令人鼓舞。

上海久光

年內,儘管COVID-19於市內出現零聲爆發,上海 久光業務繼續有所改善,此乃得益於增加應用線 上營銷及引入各種場內設施以提升顧客的購物體 驗所致。除開設健身中心以迎合注重健康的顧客 需求外,本集團亦為顧客安排各種課程,包括化 妝、舞蹈及插花班等。該等活動不但是吸引店舖 人流的有效途徑,亦增加參與者到訪周邊店鋪的 機會。該等課程註冊通過移動互聯網應用程式於 線上完成,因此亦被用作本集團全渠道營銷策略 的一部分,並助長線上顧客於本集團的實體店舖 消費。

店舖的年內銷售所得款總額達人民幣2,292.7百萬 元,較二零二零年上升15.0%。化妝品及配飾銷 售表現尤其突出,較去年增長逾20.0%。日均客 流量及逗留購買比率分別上升10.1%至約41,000 人次及上升4.6個百分點至47.1%。然而,平均每 宗交易額按年下跌2.9%至人民幣432元。百貨店 平均特許專櫃扣率則保持穩定於23.4%。

Suzhou Jiuguang

Suzhou Jiuguang continued to see strong recovery in its business, predominantly due to its customer base being largely local citizens and it is therefore less dependent on cross-city visitors and travellers. On the contrary, affluent locals who were unable to travel due to continued travel restrictions ended up spending on luxury items such as jewellery and watches locally. In a bid to enhance its retail portfolio to drive footfall, tenant-mix refinements were carried out during the year which included the introduction of a medical aesthetics center and a sporting goods brand.

Total sale proceeds for the year in Suzhou store amounted to RMB1,092.9 million, an increase of 17.9% from 2020. Similar to the Shanghai Jiuguang store, sales of cosmetics products and accessories recorded a remarkable growth of 36.5%. Average daily traffic footfall and average ticket size rose 9.6% to around 14,000 visitors and 15.7% to RMB551 respectively. Nonetheless, stay-and-buy ratio was slightly down by 2.5 percentage points to 53.1%, with the average concessionaire rate collected by the store edged lower to 16.0% from 16.8% in the preceding year as low commission rate product categories such as jewellery and watches outperformed during the year.

Dalian and Shenyang Property

The Group's commercial properties in Dalian and Shenyang remained vacant during the year and continued to suffer cash outflows of approximately RMB17.9 million for the general upkeep and maintenance costs of these properties.

Standalone Freshmart Operation

Freshmart sells high-quality food and confectionery products and is a standalone operation of the Group at a rented premise in Changning, Shanghai. To improve sales efficiency, the Group continued to try enhancing concessionaire arrangements and reducing the portion of direct sales. However, due to keen competition, the store recorded a slight decrease of 3.3% in sales proceeds in 2021. During the year, the Group continued to negotiate with the landlord for a modification of the lease term and realized a gain on such modification amounted to RMB17 million (2020 : RMB15.3 million).

Investments in Associates

Beiren Group, a well-established Shijiazhuang-based retail group in which the Group holds a strategic equity interest, continued to deliver stable business performance during the year. Notwithstanding the continual outbreaks of COVID-19 in the city during the year, Beiren Group managed to achieve sales levels similar to the previous year. Net profit (after share of non-controlling interests) attributable to the Group increased 6.1% to RMB141.5 million in 2021, compared with RMB133.3 million recorded in 2020. The share of profit from this investment remained significant and accounted for more than 90% of the profit attributable to owners of the Company for the year.

蘇州久光

蘇州久光的業務持續展現強勁復甦,主要是由於 其顧客群大部分為當地市民,因而對跨市旅客及 遊客的依賴大大降低。與此相反,由於持續的旅 遊限制,無法到海外旅遊的當地富裕階層最終在 當地消費於奢侈品,如珠寶及鐘錶。為了增強零 售組合以推動人流,已於年內進行租戶組合優 化,包括引入醫學美容中心及體育用品品牌。

蘇州店舖年內的銷售所得款總額為人民幣1,092.9 百萬元,較二零二零年增加17.9%。與上海久光 店舖的情況相約,化妝品及配飾的銷售錄得可觀 增長36.5%。日均客流量及平均每宗銷售額分別 增加9.6%至約14,000名人次及增加15.7%至人民 幣551元。然而,逗留購買比率稍降2.5個百分點 至53.1%,百貨店平均特許專櫃扣率自去年的 16.8%減少至16.0%,此乃由於低扣率產品,如珠 寶及鐘錶,表現較優勝。

大連及瀋陽物業

本集團於大連及瀋陽的商用物業於年內依然空置,並繼續因該等物業的維修保養成本錄得負現 金流約為人民幣17.9百萬元。

獨立「鮮品館」之經營

本集團在上海長寧租賃物業獨立經營的「鮮品館」 出售優質食品及糕餅產品。為提高銷售效率,本 集團繼續提升特許專櫃銷售的比例,並降低自營 銷售比例。然而,由於競爭激烈,該店舖二零 二一年的銷售所得款錄得3.3%的輕微跌幅。年 內,本集團繼續與業主協商變更租賃條款,並因 該變更而實現人民幣17百萬元的收益(二零二零 年:人民幣15.3百萬元)。

於聯營公司的投資

紮根石家莊的北人集團乃本集團持有策略性股本 權益的知名零售集團,其於年內業務表現繼續維 持穩定。年內,COVID-19於其市內持續爆發的情 況下,北人集團錄得與去年相近的銷售額。本集 團於二零二一年的應佔溢利淨額(扣除應佔非控 股權益)由二零二零年所錄得的人民幣133.3百萬 元增長6.1%至人民幣141.5百萬元。應佔該投資 溢利仍然重大並佔年內本公司擁有人應佔溢利超 過90%。 As further disclosed on pages 128 to 130 under section "Beiren Group" in note 17 of Notes to the Consolidated Financial Statements, the Group made Full Impairment against the full amount of Trade Receivable balances due by the Debtors during the year ended 31 December 2019.

The Group understood from the management of the Beiren Group that there has not been any progress made in terms of recovering the outstanding Trade Receivables nor obtaining further financial information related to the Debtors and the Guarantor. As at 31 December 2021 and based on information then available, the Group considered the Full Impairment against the outstanding Trade Receivables of the Debtors made in the year 2019 remained the best estimate.

The Group followed up during the year the Company's plan to address the Qualified Opinion as set out in details in the supplemental announcement dated 5 May 2020 whereby quarterly contacts were made by our Chief Financial Officer ("CFO") with management of the Beiren Group to obtain updates on the progress regarding the legal actions against the Debtors and the criminal case against the Guarantor. Due to travel restriction induced by the COVID-19 pandemic throughout the year, contacts with management of the Beiren Group made during the year could only be conducted through telephone and no physical meetings were managed to be arranged and held.

As the Group only holds a non-controlling interest in the Beiren Group and therefore could only rely on management of the Beiren Group to (i) take appropriate and necessary actions to recover the trade receivables from the Debtors and/or the Guarantor; and (ii) obtain up-to-date and relevant information, including but not limited to financial information and financial conditions of the Debtors and the Guarantor, that could be pursued to settle the outstanding trade receivables, as well as the progress, if any, of the legal proceedings taken against the Debtors and/or the Guarantor. The contacts made by the Group's CFO with management of the Beiren Group during the year however failed to obtain any updated information about the legal actions against the Debtors and/or Guarantor as all the assets, records and information of the Debtors and/or Guarantor are still under the custody of the local authority in the PRC and management of the Beiren Group did not receive any concrete reply from the authority regarding progress of the legal cases. As such, no relevant information of the Debtors and/or Guarantor as required by the auditors could be obtained for the purpose of resolving the Qualified Opinion.

The Board understands that the Group, with only a non-controlling interest in the Beiren Group, could only rely on management of the Beiren Group to take the necessary legal actions and to monitor the progress through regular contact with the relevant authorities. The Board also understands the difficulties faced by management of the Beiren Group in obtaining updated information without the cooperation of the relevant authorities in the PRC. In light of the above and although there has not been any progress made in obtaining the latest information of the Debtors and/or Guarantor as requested by the auditor, the Board is of the view that the actions adopted by the Group and management of the Beiren Group represent the most appropriate actions under the circumstances. 如於綜合財務報表附註中附註17的第128至130頁 「北人集團」一節進一步所披露,截至二零一九年 十二月三十一日止年度,本集團就債務人的應收 賬項結餘全額計提之全額減值。

本集團自北人集團管理層得知,就收回未償還應 收賬項或取得與債務人及擔保人有關的任何進一 步財務資料上並無任何進展。於二零二一年十二 月三十一日,並根據現有資料,本集團認為於就 債務人的逾期應收賬項在二零一九年作出全額減 值仍為最佳估算。

本集團已於年內跟進本公司就解除保留意見之計 劃,其詳情載於日期為二零二零年五月五日之補 充公告,據此,本集團財務總監(「財務總監」)與 北人集團管理層進行季度聯繫,以獲得有關對債 務人進行之法律行動及對擔保人的刑事起訴之最 新進展。由於全年因COVID-19疫情導致的旅遊 限制,年內與北人集團管理層的聯繫僅可透過電 話進行,無法安排及舉行實體會面。

由於本集團僅持有北人集團非控股權益,因此僅 可依賴北人集團管理層(i)採取適當及必要行動, 以向債務人及/或擔保人收回應收賬項;及(ii)獲 得最新相關資訊,包括但不限於債務人及擔保人 的財務資料及財務狀況,從而可追索清償逾期應 收賬項,以及取得對債務人及/或擔保人進行的 法律行動的進展(如有)。然而,本集團財務總監 與北人集團管理層於年內的聯繫未能獲得任何有 關對債務人及/或擔保人進行的法律行動的更新 資料,原因是債務人及/或擔保人的所有資產, 記錄及資料仍由中國地方當局保管,北人集團管 理層並無收到當局任何有關法律案件進展的實質 回覆。因此,無法獲得核數師要求的債務人及/ 或擔保人的相關資料以解決保留意見。

董事會了解,本集團僅持有北人集團非控股權 益,僅可依賴北人集團管理層採取必要的法律行 動,並透過與相關機構定期聯繫監察事態進展。 董事會亦了解,北人集團管理層在未獲中國有關 當局合作的情況下獲取最新資料時所面臨的困 難。鑒於上述事項及儘管在取得核數師要求的有 關債務人及/或擔保人的最新資訊未有任何進 展,董事會認為,本集團及北人集團管理層所採 取的行動在此情況下是最為適當的行動。 As almost all the key employees of the Debtors or companies owned by the Guarantor as well as the Guarantor are understood to be, as of the date of this submission, still being detained by the local authority, no progress could be made in terms of obtaining further information of the Debtors and/or the Guarantor. Until the time management of the Beiren Group has access to the Guarantor and/or any of his key staff and the criminal case against the Guarantor has any meaningful progress or conclusion by the local authority, the Company does not expect there would be any progress regarding the legal actions taken by the Beiren Group against the Debtors nor any of the trade receivables could be recovered from the Debtors. In view of the above, the Company is not in a position to come up with any other realistic and practicable actions or a concrete timetable for addressing or removing the Qualified Opinion for the time being.

The Board and the audit committee fully understand that the Group, being a non-controlling shareholder of the Beiren Group could only rely on management of the Beiren Group to obtain the necessary relevant information and updates as required by the auditor and hence do share the view that the actions taken so far by the Group and management of the Beiren Group are the most appropriate and practicable in the circumstances. The Board and the audit committee also concur that given the circumstances there is currently no other realistic and practicable actions or any concrete timetable available for addressing or removing the audit modification.

The auditor noted the actions taken and the difficulties faced by the Company and management of the Beiren Group over the past years in obtaining the information of the Debtors/Guarantor while the Guarantor and most of his key staff are being detained and all assets owned by the Guarantor have been seized by the local authority. The auditor also understands the Company's plan to continue relying on management of the Beiren Group in obtaining the relevant information of the Debtor/ Guarantor. However, until the Company is able to provide the auditor with adequate evidence with respect to the financial conditions of the Debtors/ Guarantor and details of other assets of the Guarantor, the auditor will not be able to assess whether sufficient appropriate audit evidence they consider necessary has been obtained. Accordingly, the auditor is not in a position, based on their understanding of the Company's planned actions to be taken, to form a view as to whether the Company will be able to provide such relevant information to enable them to assess and consider removing the Qualified Opinion in the next financial year.

The Group will make continuous efforts to further explore with management of the Beiren Group options in obtaining relevant information of the Debtors, including but not limited to financial information and financial conditions of the Debtors and the Guarantor that could be pursued to settle the outstanding Trade Receivables. Furthermore, the Group will continue to make regular contact with management of the Beiren Group to monitor the development of the situation and to assess the possibility of recovering the outstanding Trade Receivables from the Debtors and will discuss the same with the auditor to address the issue in due course. 截至本提交日期,由於幾乎所有債務人或擔保人 擁有的公司的核心僱員以及擔保人據理解都仍被 地方當局拘留,因此在取得債務人及/或擔保人 的進一步資料上未有進展。在北人集團管理層能 夠接觸擔保人及/或其任何核心員工並且對擔保 人的刑事起訴取得任何有意義的進展或地方當局 作出結論前,本公司預期北人集團對債務人採取 之法律行動及從債務人收回任何應收賬項方面均 不會有任何進展。鑒於上述事項,本公司暫時未 就解決或移除保留意見有任何其他實際可行的行 動或具體時間表。

董事會及審核委員會充分理解,本集團作為北人 集團的非控股股東,僅可依賴北人集團管理層按 照核數師要求取得必要的相關資料及更新資料, 因此同意其認為本集團及北人集團管理層迄今所 採取的行動在當時情況下屬最適當及切實可行的 觀點。董事會及審核委員會亦同意,鑒於此等情 況,目前就解決或移除審計修改並無其他實際可 行的行動或任何具體時間表。

核數師知悉到本公司及北人集團管理層於過往年 度中在取得債務人/擔保人資料方面所採取的行 動和面臨的困難,而擔保人及其大部分核心員工 被拘留,及擔保人擁有的所有資產已被地方當局 查封。核數師亦了解本公司計劃繼續依賴北人集 團管理層取得債務人/擔保人的相關資料。然 而,在本公司能夠就債務人/擔保人的相關資料。然 而,在本公司能夠就債務人/擔保人的財務狀況 及擔保人的其他資產詳情向核數師提供充分憑證 前,核數師將無法評估是否已取得彼等認為必要 的充足適當審核憑證。因此,根據核數師對本公 司將採取的計劃行動的瞭解,核數師無法就本公 司能否提供有關資料以讓彼等評估及考慮於下一 個財政年度移除保留意見達成意見。

本集團將繼續努力與北人集團管理層進一步探索 可獲取債務人相關資訊(包括但不限於債務人及 擔保人之財務資料及財務狀況)的方案,從而追 索清償逾期應收賬項。此外,本集團將繼續與北 人集團管理層定期聯繫,以監察進展情況及評估 收回債務人逾期應收賬項的可能性,並將適時與 核數師討論相關解決事宜。

Outlook and Plan

Looking ahead, with the COVID-19 pandemic showing no signs of abating and the escalating geopolitical tensions, the external environment is set to remain complex and uncertain. While China's economy will continue to face potential hardships due to ongoing trade tensions and continued sporadic outbreaks of COVID-19, the government is likely to deploy various fiscal and monetary policies to boosting the country's economic development with an aim to achieving the 5.5% GDP growth target for 2022. In view of this, the Group remains cautiously optimistic that China's economy will remain relatively strong, keeping consumer confidence at a relatively stable level.

In order to capture business opportunities arising from the rapidly changing consumption patterns, the Group will continue to position itself as a department store chain serving the sophisticated needs of China's middle class and high-spending younger generation. We will remain committed to optimizing product mix and enhancing customer services so as to further strengthen the brand equity of the Jiuguang brand and continue to provide best in class shopping experiences that meet the customers' expectations.

The Group is also set to strengthen the integration of its online and offline retail experience through leveraging on social media platforms and mobile internet technology. We will continue to making use of our retail management system to understand consumer behavior and make timely adjustments to our product assortment in order to better serve our customers. The Group also plans to actively explore new marketing initiatives and utilize engaging marketing campaigns which feature livestreaming, short video clips and other emerging media with an aim to broaden its customer base and increase customer loyalty.

Separately, the leasing work to recruit tenants for the two office blocks of the Shanghai Jiuguang Center have been commenced. Benefitting from being next to the metro station and with its proximity to the retail complex, the office blocks are set to becoming the Group's new source of income growth.

With the expected government supportive policies in the near term, China's retail sector and the business operations of the Group are expected to remain healthy. Leveraging the strong brand equity of the Jiuguang brand and dedicated management team, the Group is poised to explore potential investment opportunities with the overall aim of achieving long-term growth and providing returns to its shareholders.

為把握消費模式快速轉變所帶來的業務機遇,本 集團將繼續定位為迎合中國中產及高消費年輕世 代複雜需求的百貨連鎖店。本集團將繼續致力優 化其產品組合及提升顧客服務,以進一步加強其 久光品牌的品牌認受性,並繼續提供滿足顧客期 望之一流購物體驗。

本集團亦將透過社交媒體平台及移動互聯網技術 加強其線上及線下零售體驗的整合。我們將繼續 利用其零售管理系統了解消費者行為,並適時調 整其產品組合,從而為顧客提供更好的服務。本 集團亦計劃積極探索新的營銷舉措,利用串流直 播、視頻短片及其他新興媒體進行具吸引力的營 銷活動,以擴大顧客基礎及提高顧客忠誠度。

另一方面,本集團位於上海久光中心兩座辦公樓 招攬租戶的招租工作已開展。受惠於位置毗鄰地 鐵站及鄰近零售綜合體,辦公樓將成為本集團新 的收入增長來源。

隨著政府於近期推出的扶持政策,預期中國零售 業及本集團的業務營運將維持穩健。憑藉久光品 牌的強大品牌認受性及專注的管理團隊,本集團 已準備就緒發掘潛在投資機會,整體目標是實現 長期增長及為其股東帶來回報。

Governance Structure

The Board is the highest governing body of the Group. It is responsible for formulating the management objectives, strategies, priorities and goals of the Group in relation to Environment, Social and Governance ("ESG") aspects and is also in charge of supervising their implementation.

The ESG Committee comprises the Chief Executive Officer of the Group and senior members from various operating aspects, and is responsible for the formulation, implementation and daily governance of the overall ESG strategies of the Group.

According to the overall ESG strategies of the Group, members of the ESG Committee are responsible for the specific formulation and implementation of the relevant ESG objectives in relation to various operating aspects as well as the collecting and reporting of the relevant information. It is also the responsibility of the members to submit the relevant performance and annual reports in relation to the ESG issues to the Board on a regular basis. They also endeavour to constantly improve the reporting mechanism in relation to the ESG issues, which will allow the Board to be fully aware of the initiatives in relation to the ESG issues of various operating aspects of the Group and their subsequent implementation and follow-up progress, as well as the relevant governance system and measures in relation to the potential risks of the ESG issues of the Group.

To implement strategies in relation to the ESG issues more effectively and monitor the relevant possible ESG-related risks, the ESG Committee will hold meetings on a regular or irregular basis depending on the situation to investigate, formulate and adjust the relevant strategies. Regular meeting will be held with sub-units under the ESG Committee to follow-up on the implementation of ESG targets on the relevant policies and standards in relation to various operating aspects of the Group. Meanwhile, the ESG Committee will also collaborate with the relevant departments such as the legal and audit departments timely to assess the risks, to which the Group may be exposed and formulate corresponding responsive and control measures.

Being the final stage on implementing strategies in relation to ESG issues, the ESG Committee will continuously acquaint themselves with the trends and changes of development in relation to the ESG issues, striving to promote an effective incorporation of the strategies in relation to the ESG issues of the Group into the corporate's daily decision making and business operation. It is the belief of the Group that under the fully collaboration of various operating departments, the efforts made by the Group will strenuously ensure the Group having a high level of corporate responsibility standard in relation to the ESG issues.

管治架構

Environment

Emissions


While creating social and economic value with an aim to minimising the impact of our business on the environment, the Group dedicates our efforts to establishing sustainable development and acting as a responsible corporation in discharging our social responsibilities. To achieve these objectives, we strive to take appropriate measures to ensure that correct decisions and executions are made at all levels of our operations.

The primary sources of greenhouse gas emissions of the Group include electricity, water and natural gas consumption. Hazardous and non-hazardous wastes mainly come from sewage, kitchen waste, construction and household wastes. The Group focuses on measuring and reporting carbon reduction results and promoting waste reduction at source. In this connection, the Group strictly complies with relevant legislative requirements on sewage and waste disposal, and appoint government approved professional firms to carry out recycling treatment, so as to implement effective environmental management system standards. Regular inspections on the Group's operations are conducted by relevant government environmental protection authorities. Annual government inspection on all relevant sewage and waste disposal for the financial year 2021 was passed, which complied with government standards.

本集團致力採取相應措施在運營的各個層面做出 正確的抉擇及採取正確的行動,著眼將業務對環 境構成的影響減至最低,在創造社會及經濟價值 的同時,亦為建立可持續發展做出持久的努力及 貢獻,履行良好企業公民的社會責任。

本集團的溫室氣體排放源主要包括耗用電、水、 天然氣等。有害廢棄物和無害廢棄物排放主要集 中於污水、餐廚垃圾、建築及生活垃圾等。本集 團的重點是測量及彙報減碳成績,推動源頭減 廢。為此,本集團嚴格遵守政府污水及廢棄物排 放等相關規定,聘請政府認可的專業管理公司進 行回收處理,以配合環境管理體系標準的有效實 施。本集團定期接受政府環保機構的檢測。於 2021財政年度,各相關污水、廢棄物等污染排放 監測結果均通過政府年度檢測,符合政府標準。




KPI A1.1: There are 7 types of emissions including air pollutant, kitchen waste, slop oil, household waste, domestic wastewater, construction waste, sewage well and grease trap wastes. The total emission and corresponding intensity in the financial year 2021 were 312,972.4 tons and 1.03 ton/sq.m. respectively.

KPI A1.2: The total greenhouse gas emission of carbon dioxide and corresponding intensity for the financial year 2021 were 48,622.47 tons and 0.16 ton/sq.m. respectively. The greenhouse gas emission of carbon dioxide from direct energy and corresponding intensity were 125.24 tons and 0.0004 ton/sq.m. respectively. The greenhouse gas emission of carbon dioxide from indirect energy and corresponding intensity were 48,497.23 tons and 0.16 ton/sq.m. respectively.

KPI A1.5: The Group's targets and measures to mitigate emissions for the financial year 2021 are set out below.

- We strived to constantly improve energy use efficiency and minimise carbon emission to the surrounding area during the construction processes of environmentally friendly projects.
- We endeavoured to use environmentally friendly products and services for our decoration and renovation projects in order to minimise the creation of hazardous substance. For instance, we would request our contractors to use environmentally friendly and energy saving products which are approved by relevant government authorities, especially materials such as adhesives, paints, coatings, etc., which must be low VOC (Volatile Organic Compounds) compliant.

- We set up a sewage treatment system for handling sewage in compliance with the government's "Pollutant discharge standard for urban sewage treatment plant".
- Waste prevention and management play an indispensable role in the Group's overall environmental policy. Accordingly, the Group has set up an effective waste management approach to ensure that collection and treatment of waste were carried out in compliance with relevant government regulations and would cause the least impact on the surrounding environment. The Group will strictly follow the relevant government requirements and enter into disposal agreements with government approved professional firms with relevant expertise to carry out separation, recycling and removal of waste.
- Kitchen waste mainly come from catering tenants. The Group provides guidance to the catering tenants and employees to promote reducing unnecessary food waste on production and consumption. At the same time, the Group has procedures in place on collection and treatment of kitchen waste which are strictly in accordance with the principles and requirements as set by the government. As opposed to dumpling, land filling or selling kitchen waste in an illegal manner, we will enter into disposal agreements with the municipal city government departments or designated professional firms with relevant expertise to carry out collection and disposal of kitchen waste.
- To improve the efficiency of the piping and drainage systems, the Group carried out transformation and optimisation works on the sewage pump system of the water collection wells.

In 2021, thorough dredging and cleaning were conducted for all sewage pipes and sewage treatment equipment at our Shanghai store to improve the efficiency of the drainage system. Meanwhile, in 2021, our Suzhou store has strengthened the daily inspection on sewage pipes in order to eliminate the relevant safety hazard and maintain the normal operation of on-site facilities and equipment, and to ensure smooth drainage of water sources.

- 餐廚垃圾主要來自於餐飲租戶。本集團對 僱員及有關租戶提供指引,宣導將不必要 的浪費控制在生產及消費環節。同時,本 集團嚴格按照政府處理餐廚垃圾的原則及 規例制定及執行有關收集、清運餐廚垃圾 的相關管理規定,通過與地區環衛管理部 門或指定具有相關收集、清運餐廚垃圾的 專業資質承包公司簽訂清運回收協定,而 不是自行隨意傾倒,填埋或販賣給非法商 人。
- 為提升管道和排水系統效率,本集團對集 水井水泵排污系統進行改造、優化。

於2021年,上海店針對商場全部排污管道 及污水處理設備進行了徹底的疏通清洗, 藉以提升排水系統之效率。同時,蘇州店 亦於2021年加大了對排污管道日常巡檢, 排除了相關安全隱患,保障現場設施設備 正常運行,藉以保障水源排水通暢。

Use of Resources

The Group is committed to minimising the overall energy consumption in our daily operations. Through scientific management and implementing appropriate controls in every part of our operations, we strive to maximise the energy efficiency and minimise the wastage of electricity, gas fuel and water resources.

KPI A2.1: The Group's direct and/or indirect energy consumptions by type for the financial year 2021 were 57,516,705 kWh of electricity; 57,924 cubic meters of natural gas consumption, and 5,279 tons of steam energy consumption. Accordingly, their energy consumption intensities were 188.45 kWh/sq.m., 0.19 cubic metre/sq.m. and 0.02 ton/sq.m. respectively.

KPI A2.2: The total water consumption and corresponding intensity for the financial year 2021 were 376,308 tons and 1.23 tons/sq.m. respectively.

KPI A2.3: Electricity is mainly consumed by air conditioning systems, vertical transportation systems, general lighting, refrigeration systems, plumbing and drainage systems, ELV system and I.T facilities within the Group's department stores/buildings. The Group's targets and measures in respect of the efficiency of energy use for the financial year 2021 are set out below:

equipment is an important evaluation criterion in outsourcing and procuring new equipment for the Group. Priority has been given to those energy saving and environmentally friendly products in our general procurement of lighting and power equipment. Meanwhile, energy saving and environmentally friendly related requirements are also applied to the entire tendering process.

In 2021, the power equipment of our Shanghai store and Suzhou store were set to operate based on actual needs in order to better reduce energy consumption.

 To substantially reduce power energy consumption, the Group is gradually adopting long-life and lower power consumption LED lightings in shops and office area to reduce power consumption. 的一個重要評價標準,本集團在日常採購 光源,動力設備上首先選用的為節能環保 型產品,並將節能環保相關要求貫穿於整 個招標過程之中。

於2021年,上海店及蘇州店根據實際需求,合理開啟/關閉動力設備,藉以更好降低能耗。

為大幅降低電力能源消耗,本集團陸續在 商鋪及辦公域採用使用壽命長,耗電量較 低的LED燈源節約用電。 In 2021, our Shanghai store continued to promote and further renovate lighting systems for its tenants with LED lighting, and completed the renovation of LED lighting in the public area including the supermarket food street and the dining area on the 8th floor. In 2021, our Suzhou store also completed the renovation of the public LED lighting in the underground parking lot. These two stores have adopted measures such as reasonable control of lighting in public areas and general examination on tenants' electricity consumption according to the regulations on energy conservation management, in order to monitor the electricity current control, electricity level pre-warning and reduction of electricity dissipation in real time in the public areas of the shopping mall and tenants.

- As the Group strives to implement low carbon and environmentally friendly practices, excellent performance has been achieved in energy saving and emission reduction. In 2021, our Shanghai store completed the carbon emission task assigned by the Shanghai Municipal Government and was accredited as the "2021 Excellent Unit for Energy-saving Assessment in Key Energy Consumption Units of Jing'an District in Shanghai". Meanwhile, our Suzhou store also successfully passed the government's carbon emission verification of building in 2021.
- To improve the efficiency in use of natural gas, our Shanghai store completed the maintenance on heating boilers before their operations for winter season of 2021. Daily inspections and temperature monitoring were also enhanced to control the starting time for the boilers and their number, so as to eradicate the waste of natural gas.

KPI A2.4: Water consumption mainly comes from sanitary facilities for our customers and staff as well as the water-cooled air conditioning systems. The Group's targets and measures in respect of enhancement of water efficiency for the financial year 2021 are set out below:

- The Group's targets on improving water use efficiency are based on the relevant information for the financial year 2019 and it strives to reduce the intensity of the total water consumption of the Group by 5% to 1.61 ton/sq.m. for the financial year 2030.
- In 2021, in order to improve water consumption efficiency and avoid wastage of water resources, our Shanghai store carried out inspection and maintenance on the underground part of the main water supply pipes in the pedestrian streets around the shopping mall and a professional company was engaged to conduct a water balance test on the water supply system of the shopping mall. In order to prevent water wastage and enhance the water consumption efficiency. In 2021, our Suzhou store continued to strengthen the inspection and maintenance on the water valves, water saving devices, faucets and sewer pipes in the toilets of the building to reduce or control water leaking.

KPI A2.5: Packaging materials used for finished products for our business operation are not material.

於2021年,上海店繼續推進新進及二次裝 修租戶的照明光源均採用LED環保光源, 並完成了包括超市美食街及8樓餐飲區公共 區域區域LED照明的改造工作。蘇州店亦 於2021年完成了地庫停車場公共照明LED 照明的改造工作,且兩店已按照節能管理 規定,通過合理控制公共區域照明、對租 戶用電情況進行大檢查等措施,藉以對於 商場公共部分及租戶之電流控制、電量預 警及降低電力損耗進行即時監測。

- 由於本集團致力於低碳環保,節能減排卓 有成效,上海店於2021年已完成上海市下 發的碳排放任務,並被政府管理部門評為 「上海市靜安區2021年重點用能單位節能考 核優秀單位」。同時,蘇州店亦已在2021年 順利完成政府該年度大廈碳排放核查。
- 為提升天然氣能源使用效益,上海店於 2021年在冬季開爐前完成供暖鍋爐器等的 大保養,並加大日常巡檢及測溫,合理控 制鍋爐開啟時間及台數,以杜絕天然氣的 浪費。

關鍵績效指標 A2.4:本集團用水主要集中在為顧客及僱員提供服務的洗手間設施及空調冷卻塔迴圈水系統。於2021財政年度,本集團在提升用水效益方面的的目標及步驟載列如下:

- 本集團在提升用水效益方面的目標以2019 財政年度相關資料為基準,力爭至2030財 政年度將本集團總耗水量相應密度降低5% 至每平方米1.61噸。
- 為了提升用水效益及避免水資源的無益浪費,於2021年度,上海店,對商場外圍步行街處生活用水總供水管地下部分進行了檢查和維修,且於聘請專業公司對商場供水系統進行了一次水平衡測試,藉以避免有關水資源之浪費,提升用水效益。於2021年,度蘇州店繼續加強對大廈衛生間的水閥、節水器、龍頭與下水彎管的巡檢及維修工作,減少或控制了滴跑漏現象。

關鍵績效指標A2.5: 於我們的運營中製成品所用 包裝材料視為不重大。



Environment and Natural Resources

The Group supports environmental protection and carries on the greening of our operating environment. The Group also constantly assesses its measures taken to minimise the impact of our business operation on the surrounding environment so that appropriate improvement actions could be taken promptly. These measures include the use of energy-efficient lightings and environmentally friendly paper, paper usage reduction, turning off idle lightings, computers and electrical appliances and other facilities and equipment to save energy. The Group is also committed to promoting the use of recycled paper and shopping bags made by recycled paper in our stores, where feasible.

KPI A3.1: Appropriate actions are taken to manage the impacts of the Group's operations on the environment and natural resources. We actively promote environmental protection, formulate a number of policies and measures to optimise the operation and office environment, strengthen energy conservation and emission reduction management and emphasise green operation and green office. Relevant polices and measures taken for the financial year 2021 are as follows:

 Implementing the Office Automation Application System. In 2021, the Group further upgraded electronic office automation systems to optimise office procedures and streamline processes to reduce the use of office paper and facilitate the Group's paperless office operation.

環境及天然資源

本集團一貫支持環保並持續執行綠化營運環境的 活動,更不時評估業務營運過程中有關對於周遭 環境保護的措施,從而即時作出改善,有關措施 包括使用節能照明及環保紙張,減少用紙,關閉 閒置照明、電腦及電器等設施設備以節省能耗。 本集團亦在可行情況下致力於推動環保紙張的使 用,並在各百貨門店使用以環保紙張製造的購 物袋。

關鍵績效指標 A3.1:本集團已採取行動管理業務 活動對環境及天然資源的重大影響,配合積極宣 傳環保理念,制定多項優化經營及辦公環境的政 策及措施,加強節能減排管理,強調綠色運營、 綠色辦公。於2021財政年度,相關政策及措施載 列如下:

實施OA辦公自動化應用系統。於2021年, 本集團進一步提升OA電子辦公系統,以優 化辦公程式,簡化流程,以減少辦公用紙 使用,推進本集團無紙化辦公模式。



- Implementing double-sided printing and reusing and recycling toner cartridges, paper, envelope and paper files. In 2021, the Group continued to facilitate the reduction of paper consumption at our stores based on it actual needs. At the same time, printing facilities are reasonably adjusted to reduce the consumption of consumables. Centralised collection and disposal of used consumables were adopted to minimise environmental pollution resulting from improper waste disposal.
- Purchasing and using recycled paper bags instead of traditional packaging bags. To advocate environmentally responsible shopping, the Group provides customers with paper bags produced with recycled paper and printed with the environmentally friendly recycling label, reminding the customers that paper bags can be recycled. We take appropriate measures to strictly comply with "General Technical Requirements of the Environmental Protection, Safety and Labelling for Plastic Shopping Bags" and "Notice on Restrictions of Manufacturing and the Sale of Plastic Bags" issued by the country. Reduction on plastic bag consumption was achieved by charging customers for non-woven bags, and providing plastic bags only when necessary;
- Encouraging the use of environmentally friendly materials and energy efficient equipment in our construction projects. In respect of the renovation and design of our office and stores, the Group actively adds in environmental-friendly philosophy to adopt open atrium design to maximise the use of natural light and share lightings in common areas, and retain or refinish the existing furniture where possible during renovations to reasonably make use of the existing resources.

The Group aims to achieve a compatible development of people, buildings and the natural environment. While utilising natural resources and handmade means to create a good and healthy living and entertaining environment, we aim at controlling and minimising the use and destruction of the natural environment.

- 一 實施辦公用紙雙面列印及碳粉盒、廢紙、 舊信封、公文袋等回收再利用:於2021年 本集團對於有關表單依據實際需求,繼續 推動本集團店鋪減少用紙。同時,合理調 整列印設施,以減少耗材損耗,並採用廢 舊耗材集中回收處理方式,減少隨處丟棄 廢物所造成環境污染。
- 採購及使用再生紙加工的環保袋以取代傳
 統包裝袋。本集團提倡環保購物,為顧客
 提供由可回收環保紙製作的紙制購物袋,
 並印製可回收環保標誌,提示顧客紙張可
 廢物回收;嚴格執行國家發佈的《塑膠購物
 袋的環保、安全和標識通用技術要求》及
 《關於限制生產銷售使用塑膠購物袋的通
 知》:通過實行無紡布購物袋有償使用制
 度,推進節能減排;同時嚴格審核使用要
 求,合理發放使用數量;
- 在項目施工過程中,鼓勵使用環保材料和 高效能源裝置。在辦公室及商鋪裝修設計 方面,本集團也積極注入環保理念,採用 開放式的環保設計,最大限度利用室外自 然光源及共用同區燈光照明,裝修時也盡 可能保留原有的傢俱或對其進行改裝翻 新,合理利用現有資源。

本集團以人、建築和自然環境的協調發展為目標,在利用天然條件和人工手段創造良好、健康的居住、娛樂環境的同時,盡可能地控制和減少對自然環境的使用和破壞。

Climate Change

KPI A4.1: Climate change has become a global focus and a major issue. Extreme weather events caused by climate change are also becoming more and more serious, bringing significant risks and impacts to the global economy. The Group has always been committed to managing climate change and has taken various measures to assess and reduce risks. The Group has identified different physical risks that may pose a threat to its operations and its financial performance, including various extreme weather conditions and disasters (including droughts, floods, severe typhoons, unusually persistent heat waves, epidemics, etc.) caused by climate change. In addition, the Group also recognised the corresponding transition risks caused by climate change, including the increase in attention to climate-related issues, changes in consumer preferences and changes in investors' expectations and views to the Group, which may result in the potential increase in operation, compliance and other costs.

Therefore, the Group will review the latest policies and regulations related to climate change in the regions where it operates in a timely manner, and identify potential climate-related risks that affect its operation activities and long-term sustainable development. At the same time, the Group also communicates with stakeholders to understand their climate-related expectations and concerns.

In order to deal with climate-related risks, ensure the safety of employees and on-site personnel, and reduce the adverse effects of various extreme weather conditions and disasters on operations and long-term sustainable development, the Group has formulated relevant counter-measures and plans as internal guidelines for its work procedures, so as to issue safety warnings and make special work arrangements when such situations occur. At the same time, the Group also pays close attention to and understands the relevant requirements and regulations on addressing climate change where it operates, continuously reviews and improves relevant work arrangements and guidelines, and conducts relevant special drills on a regular basis every year, in order to enhance employees' awareness of protection and response, ensure the safety of employees and on-site personnel, and reduce property losses.

Moreover, in view of the current global outbreak of the novel coronavirus ("COVID-19"), the Group has also proactively taken measures to prevent and control the pandemic affected by extreme weather conditions in the regions where it operates. The Group has also established emission reduction targets and corresponding measures that help reducing greenhouse gas emissions, so as to contribute to the sustainability of the global ecosystem.

氣候變化

關鍵績效指標A4.1:氣候變化已經成為全球關注 焦點及重大議題。因氣候變化導致的極端天氣事 件亦日趨嚴重,對全球經濟構成重大風險和影 響。本集團始終致力於管理氣候變化,並已採取 不同措施評估及減低風險。本集團已識別可能對 運營及其財務表現構成威脅的不同實體風險,包 括由氣候變化引發的各種極端天氣狀況及災害 (包括旱災、水災、強颱風、異常持續的酷熱、疫 情等)。此外,本集團亦認識到因氣候變化引發 的相應過渡風險,包括由於氣候相關議題關注度 的增加,消費者偏好的轉變及因投資者對本集團 的期望及觀點的改變等,可能產生運營、合規及 其他成本的增加。

因此,本集團會適時審閱經營所在地區與氣候變 化相關的政策及規例更新,識別對企業的實際運 營活動及長期可持續發展產生影響的潛在氣候相 關風險。同時,亦與持份者溝通,以瞭解其與氣 候相關的期望及關注。

為應對氣候相關風險,保障僱員及現場人員的安 全,減少各類極端天氣狀況及災害對企業運營活 動及長期可持續發展產生的不利影響,本集團制 定相關應對措施及方案作為工作安排的內部指 引,以在此類情況發生時發出安全警告及作出特 別工作安排。同時,本集團亦隨時關注及瞭解經 營所在地有關應對氣候變化的相關要求及規例, 持續檢討及改善相關工作安排及指引,並每年定 期進行相關專項演練,以增強員工的防護及應對 意識,確保僱員及現場人員的安全,降低財產損 失。

此外,鑒於當前全球新型冠狀病毒(「COVID-19」) 疫情肆虐,本集團亦積極配合經營所在地區做好 在特殊氣候影響下有關疫情防控之應對措施。本 集團亦已制定減排目標及相應措施,該等措施有 助減少溫室氣體排放,以對全球生態系統的可持 續性作出一份貢獻。



Social

Employment and Labour Practices Employment

As of 31 December 2021, we had 1,167 employees, with 1,162 stationed in the PRC and 5 in Hong Kong.

As an employer embracing equal opportunities, the Group's employment policy aims to provide a working environment where is no discrimination on the basis of race, gender, religion, age, etc., and establish a sound and quality work environment to attract talents. All applicants enjoy equal opportunities and fairness.

In order to attract and retain outstanding talents, the Group has a comprehensive performance appraisal management system and regularly communicates with employees to ensure its system's transparency and fairness. Through the assessment of employees' job performance, we employ and promote employees who are with common values and professional ethics, and praise those who are self-motivated, responsible and honest in order to ensure the continued improvement of the Group's business.

Employees' remuneration package is reviewed regularly by the Group. The evaluation makes reference to the labour market and the level of salaries and benefits in the same industry and takes into account of employees' performance and working experience to ensure that competitive remuneration packages are being offered so as to motivate their continuous improvement and contribution to the Group. In terms of employee dismissal policy, the Group follows the local regulations as stipulated by the government.

The policy on working hours, rest days, other benefits and welfare of the Group is in line with the requirements of the local government and industry practices. In addition to paid annual leave, we also offer employees other types of leaves, including sick leave, marriage leave, maternity leave and care leave.

Furthermore, the Group takes steps and initiatives to maintain a harmonious labour relationship. We work with labour unions to organise a wide range of leisure and cultural activities to express our care to our employees and promote healthy lifestyle and strengthen their sense of belonging and togetherness to the Group.

In the financial year 2021, there were no serious breaches of applicable legislations and/or regulations.

社會 僱傭及勞工常規 *僱傭*



本集團實施之工作時數、假期及其他待遇及福利 與政府及當地行業慣例一致。除有薪年假外,本 集團亦為員工提供不同種類的假期,包括病假、 婚假、產假及護理假等。

此外,本集團也積極開展和落實各項有利於構建 企業和諧勞動關係,亦與各級工會協力經常組織 多元化的文體活動,共同關愛及提升僱員之身心 健康,增強僱員的歸屬感和團隊凝聚力。

於2021財政年度,並無嚴重違反適用法例及/或 規例。





Health and Safety

The Group always strives to provide and maintain a safe and healthy environment in its property portfolio for all the customers, employees, and business partners. Therefore, the Group provides comprehensive insurance coverage including work injury and employer liability, as well as annual health check to its employees. We conduct regular inspection of premises, provide training and education to our employees on disaster prevention, fire drills, occupational safety, as well as first aid training to enhance employees' knowledge and skills to prevent accidents.

KPI B2.1: There was no work-related fatality incidents reported in the past three years, including the financial year 2021.

KPI B2.2: In the financial year 2021, the number of loss of working days due to work injuries was 49 days, accounting for 0.02% of normal working days.

KPI B2.3: Occupational health and safety measures implemented are as follows:

- Maintaining proper lightings and ventilation systems and a tidy environment in office and department store areas, and providing sufficient working space in the offices.
- Smoking is prohibited in office and department store areas.
- Following government guidelines relating to severe weather warnings such as typhoons and rainstorms.

健康與安全

本集團一貫致力於在物業組合內為所有顧客、僱員及合作夥伴提供及維持安全及健康的環境。為此,本集團為僱員提供包括工傷保險、僱主責任險在內的全面的僱員保險保障計劃及年度的健康檢查,推動店內巡檢、防災意識及教育、消防演習、職業安全教育、急救安全等訓練課程的開展,以加強僱員在安全領域的知識及技能,防範僱員發生工傷意外。

關鍵績效指標B2.1:包括2021財政年度在內的過去三年內,無任何因工作相關而死亡的事故。

關鍵績效指標B2.2:於2021財政年度,因工傷意 外損失的日數為49天,佔正常工作天數的0.02%。

關鍵績效指標B2.3:有關所執行的職業健康與安 全措施如下:

- 辦公室與店鋪具備妥善照明及通風系統, 環境保持整潔。辦公室設有充裕空間。
- 辦公室與店鋪均禁煙。
 - 遵照政府有關颱風及暴雨等惡劣自然情況 預警及警告的工作指引。

At the same time, the Group requires its employees to share the responsibility in the setting, execution and monitoring of policies in respect of safety and health. Their responsibilities include:

- Identifying, reporting and avoiding hazards at workplace in relation to health and safety and having the responsibility to report such hazards immediately to superiors or the security department.
- Investigating any accidents or hazards to prevent them from happening or re-occurrence.
- Working together with the company in adopting work safety methods and procedures.

同時,本集團也要求僱員肩負有制定、執行及監 督有關健康與安全政策之職責,這些職責包括:

- 識別、報告及避免在工作場所與健康及安 全有關的隱患,一旦有發現有存在的隱 患,有責任即時通知上司或安保部門。
- 參與有關事故或隱患的調查以避免事故的 發生或重現。
- 與公司共同致力於確保工作環境安全的方 法及流程的實施。



In 2021, against the backdrop of the ongoing outbreak of COVID-19, the Group has been committed to providing and maintaining a safe and healthy shopping and working environment for all customers, employees and partners in the property portfolio during the epidemic prevention and control period in accordance with the relevant government requirements on epidemic prevention and control and based on the actual operation situation of the operating sites. The relevant policies and measures are set out below:

- Through the establishment of an effective epidemic prevention and control system and in accordance with the information and requirements on epidemic prevention and control issued by the government, the Group continuously formulated, adjusted and implemented corresponding emergency plans and protective measures for epidemic prevention and control.
- Arranging special personnel to purchase epidemic protective equipment regularly, including masks, hand sanitisers, alcohol, disinfectants, etc., to ensure the supply of materials for epidemic prevention and control.

2021年度,在COVID-19持續肆虐的嚴峻形勢下,本集團依據政府關於疫情防控之相關要求及結合營運場所實際營運情況,在疫情防控期間,致力於在物業組合內為所有顧客、僱員及合作夥伴提供及維持安全及健康的購物及工作環境,相關政策及措施載列如下:

- 透過建立有效的疫情防控體系,依據政府 發佈之疫情防控資訊及要求,不斷制定、 調整及實施疫情防控之相關應急預案及防 護措施。
- 安排專人定期採購疫情防護用品,包括:
 口罩、免洗洗手液、酒精、消毒液等,以
 確保疫情防控之物料供應。

- Arranging special personnel to be responsible for frequent disinfection and division of dining areas of staff canteens, and adopted epidemic prevention and control measures such as different time slots and separated areas for dining to reduce crowds gathering.
- Arranging special personnel to conduct body temperature screening on the personnel entering and leaving the premises and requiring relevant personnel to wear protective masks.
- Arranging professional cleaning staff to disinfect the facilities of the premises (including but not limited to passageway handles, lift cars and buttons, escalators handles, information desks, public garbage bins and shopping carts, etc.) on a daily basis with high frequency. Professional cleaning staff disinfected the washrooms daily with high frequency and thoroughly disinfected the operating premises on a weekly basis as scheduled.
- Disinfection stations were set up at customer information desk and major entrances and exits of the premises in order to provide alcohol disinfection services to customers. At the same time, special garbage bins for disinfection were prepared for disposal of discarded masks for unified collection to avoid further pollution.
- The operation of air-conditioning and fresh air system and ventilation work during the epidemic prevention and control period has complied strictly with the relevant government requirements on epidemic prevention.
- In accordance with the relevant government requirements on pandemic prevention and control, professionals are arranged to clean and disinfect the air-conditioning room and air-conditioning units.

Professional air-conditioning system cleaning companies were engaged to thoroughly clean the air-conditioning systems and pipes in the operating premises, and professional institutions were arranged to assess the cleaning results to ensure that the hygiene of the air-conditioning systems meets the relevant government technical requirements.

- 安排專人負責對員工餐廳之就餐區域進行 高頻次消毒及劃分,採取分時段、分區域 就餐等疫情防控措施,減少人群聚集。
- 安排專人對進出營運場所之人員實施體溫 測試工作,並要求相關人員佩戴防護口罩。
- 安排專業保潔人員每日對營運場所設施(包括但不限於通道門把手,電梯轎廂及按鈕,手扶梯扶手、服務台、公共垃圾桶、購物車等)進行高頻次消毒,由專業保潔人員每日對洗手間進行高頻次消毒處理及每週按照計劃對營運場所進行徹底消毒。
- 於營運場所顧客服務台及主要出入口設置 消毒站,以為顧客提供酒精消毒服務。同時,亦增設消毒專用垃圾桶用以廢棄口罩 之丢棄處理,統一回收,避免再次污染。
- 嚴格按照政府防疫相關要求,在疫情防控 期間空調及新風系統之啟閉及通風工作。
- 依據政府關於疫情防控之相關要求,安排 專業人員於對空調機房及空調機組等進行 清洗及消毒。

聘請專業空調系統清潔公司對營運場所空調系統 及管道進行徹底清洗,並安排專業機構對清潔結 果進行檢測,以確保空調系統衛生符合政府相關 技術要求。



Development and Training

The Group firmly regards employees as valuable assets and their development helps driving the growth of the Group. In pursuing our business objectives and providing protection to the general rights and interests of our employees, the Group aims to put in place a suitable platform that supports the Group and employee development and training through performance evaluation, two-way communications and questionnaires on training needs. The employee development and training policies adopted by the Group include:


- Providing new comers with comprehensive orientation programme to assist new comers familiar with the Group.

KPI B3.1: Percentage of employees trained by gender and employee category are as follow:





Labour Standards

The Group is committed to strictly complying with the relevant local labour and employment laws and regulations, and ensure that the employment contracts with employees are on a legal, fair, equal, voluntary, mutually agreed and good faith basis. The Group adopts employment policy and procedures which prohibit forced labour and child labour. The same requirements also apply to the Group's concessionaires and tenants.

KPI B4.1: We strive to perform continuous review and improvement on the recruitment practices to prevent child labour and forced labour.

The relevant policies adopted by the Group are:

- Strictly prohibiting any departments to request and/or employ any persons who are below 16 years old for any reason. The Human Resources Department is responsible for the review of the age of the applicants during recruitment to ensure that no minors under the age of 16 are employed.
- All employment must be on a voluntary basis and we do not allow forced labour, or using any form of deception to allure employee to join the Group.

KPI B4.2: We are not aware of any child or forced labour incidents in the financial year 2021. The Group believes that it is not exposed to any risk of having child or forced labour in our business operation. We are committed to taking immediate measures to eliminate any non-compliance in respect of child and forced labour.

Operating Practices

Supply Chain Management

In accordance with our operating practices and the composition of different segments along our supply chain management model, our department stores sell direct purchased merchandises and offer branded merchandises and services through concessionaire and leasing arrangements. Through seamless cooperation with suppliers and business partners, and highly efficient information technology networks, the Group is able to work smoothly along the supply chain which optimises the resources allocation to deliver high-quality products and services to our customers. The Group strives to share our commitments and beliefs in environmental and social aspects with our business partners. This also encourages our business partners to pay attention to and control environmental and social risks that may be related to supply chain management and embrace high standards of corporate responsibilities which are similar to those of ours.

The supply chain management policy adopted within the Group set out as below:

- To cooperate in a fair, honest and responsible manner with suppliers who share our business philosophy.
- Suppliers are contractually prohibited to hire child labour.

勞工準則

本集團嚴格遵守僱員所屬地相關勞動及僱傭法 規,與僱員雙方均遵循合法公平、平等自願、協 商一致、誠實信用的原則,訂立勞動合同書。本 集團也透過有關招聘及用工措施以防止童工或強 制勞工,同樣的法規要求亦適用於本集團店鋪銷 售商品的寄售商及租賃品牌的供應商。

關鍵績效指標B4.1:我們致力於不斷檢討及完善招聘慣例以避免出現童工及強制勞工。

本集團已採納以下有關政策:

- 絕對禁止任何部門以任何理由申請及/或 聘用未滿十六周歲的未成年人僱員。人力 資源部負責審核需招聘崗位的年齡範圍, 確保不得聘用未滿十六周歲的未成年人。
- 所有被聘用之僱員必須以自願為原則,絕 不允許任何強迫性行為,不得以欺騙手 段,引誘僱員來工作。

關鍵績效指標B4.2:於2021財政年度,概無任何 有關童工或強制勞工的事件。本集團相信目前的 經營環境並不存在僱用童工及強制勞工的相關風 險;亦承諾一旦發現違規情況將即時採納措施消 除,堅決杜絕童工及強制勞工。

營運慣例 *供應鏈管理*

依照本集團經營慣例及供應鏈管理模式的各個環節的構成,相關店鋪既銷售自營買斷品牌的產品,也提供寄售商及租賃品牌商品及服務。本集團通過與供應商及合作夥伴緊密合作,透過高效的資訊網路以實現供應鏈各個環節的有效連結,優化資源配置,為顧客提供高素質的產品及服務。本集團致力於與業務合作夥伴分享環境及社會方面的承諾和理念,亦鼓勵我們的業務合作夥伴關注及管控供應鏈管理中可能涉及的環境及社會方面的風險,及遵守與我們相若的高水準企業責任標準。

本集團已採納供應鏈管理政策,載列如下:

- 務求與擁有共同營商理念的供應商合作,
 以公平、誠實及盡責之態度經營業務。
- 供應商受合約約束,確保其不可僱用童工。

Suppliers are contractually obliged to ensure that the products they
offer are non-toxic and meet relevant government and industry
requirements and standards.

KPI B5.1: As of 31 December 2021, the Group had 1,619 suppliers in China, including 1,120 suppliers for Shanghai store and 499 suppliers for Suzhou store.

KPI B5.2:

- In engaging suppliers, they are required to meet the Group's product requirements, such as price, quantity and delivery time.
- In engaging suppliers, it is based on a set of standards, including quality control and compliance with relevant standards applicable to China and/or the globe.
- Renewal of supplier contracts is subject to review of their performance based on the practice and their achievements.

KPI B5.3:

— Suppliers are responsible for product management in the sales area, ensuring that the products provided are of good quality, and shall not provide inferior commodities, and all process in their supply chain shall comply with the practices of environmental protection and social risk reduction. The Group has the right to conduct random inspections on the quality of products provided by the suppliers.

KPI B5.4:

— Suppliers are required to abide by the "Store Decoration Design Guidelines", "Interior Decoration Code" and other specifications formulated by the Group. After completing the decoration project, it should be inspected by the relevant departments of the Group's member companies to ensure that the decoration conforms to the practices and requirements of environmental protection and services. In the event of not meeting the requirements, the suppliers are required to rectify immediately. 一 供應商受合約約束,提供產品須不含有毒 物質,符合政府及或行業相關標準。

關鍵績效指標B5.1:於2021年12月31日,本集團 中國地區供應商數目為1,619家,其中上海門店供 應商數目為1,120家,蘇州門店供應商數目為499 家。

關鍵績效指標B5.2:

- 聘用供應商時,依據本集團對其交付產品 能力的要求(如價格、數量及交付時間)。
- 聘用供應商時,依據一套標準條件,如品 質控制,符合中國內地及或國際相關標準 等。

 供應商必須遵守本集團制定的「店鋪裝修設 計指引」、「室內裝修守則」等規範。裝修工 程完成後應經本集團旗下公司相關部門驗 收,以確保裝修符合環保及服務的慣例及 要求。如不符合,將要求供應商即時整改。

Product Responsibility

The Group believes that our corporate sustainability and reputation are built on our high quality products and services. Our operation team is committed to providing safe and high quality products and services to our customers, and addressing customer complaints with utmost attention.

Moreover, the Group believes that product safety is the key to our success. We strictly follow the industry standards and government regulations relevant to our products and services. We provide trainings to employees to enhance their consciousness of product safety in order to prevent any counterfeits and sub-standard merchandises being sold at our stores and to protect the rights and interests of our consumers.

The product safety policies adopted by the Group are as follow:

- For non-food products, the Group enhanced the quality checks on products provided by our suppliers and business partners to ensure that these products meet the relevant safety standards and requirements. Based on the characteristics of product, special attention is placed on the compliance with those regulations and requirements related to baby and children products, toys and customer safety to ensure that our products sold fully comply with the relevant mandatory regulations and requirements of the PRC.
- For food products, the Group assumes the primary responsibility for food safety in accordance with the relevant provisions of the "Food Safety Law of the PRC". We also set and implement policies and procedures such as "Purchase inspection and recording policy", "Food selling procedure management", "Procedures regarding removal of substandard food items from shelves", and "policy and procedures relating to reporting and handling of emergency food safety incident" to ensure all food items provided are safe.

KPI B6.1: During the year, no products were recalled by the Group due to significant safety and health reasons.

KPI B6.2: Our customer services extended to before, during and after the sales. All complaints are handled by professional personnel of the Group's customer service department. Details of the complaints, progress status, handling time and settlement are properly recorded and supervised. There were 454 complaints in respect to products and services received by the Group in financial year 2021, which were consistent with the industry norm. At the same time, during the epidemic prevention and control period, the customer service department also overcame various difficulties to ensure that relevant customers' complaints relating to return and exchange of products and maintenance were properly handled.

KPI B6.3: The Group recognises that brand equity is critical to our success. We actively allocate resources to maintain and protect the intellectual property rights of our brands.

 We value intellectual property rights and determine intellectual property rights as an indispensable element of successful business.

產品責任

本集團堅信,優質的產品和服務是本集團存續及 良好聲譽的重要元素。營運團隊致力於為顧客提 供優質安全的產品及高標準的服務,重視處理所 有顧客投訴。

同時,本集團亦深信產品安全是安身立命的關鍵,恪守與銷售產品和提供服務有關的行業標準 及政府法例規例,並強化對僱員的有關培訓,藉 以提升僱員的產品安全責任意識,杜絕假冒偽劣 產品的流入,以保障消費者的合法權益。

本集團已採納以下有關產品安全的政策:

- 一對於非食品類產品,本集團加強對供應商以及合作夥伴的產品監督以及檢查,確保產品符合安全規範。本集團依據品類特點,著重強化對嬰幼兒產品、玩具以及消費者安全方面的法規制度的遵守以及執行,確保產品銷售運營符合國家強制性標準。
- 對於食品類產品,本集團依照《中華人民共和國食品安全法》等規定,履行食品安全第一責任人義務,透過建立及實施諸如「進貨查驗及記錄制度」、「食品銷售環節管理制度」、「不符合食品安全標準食品下架退市制度」、「突發食品安全事故緊急報告及處理制度」等完備的食品類產品管理制度,確保食品類產品經營安全。

關鍵績效指標B6.1:於年內,本集團並無因產品 出現重大安全與健康理由而需召回產品。

關鍵績效指標B6.2:顧客服務的工作始終貫穿於 售前、售中以及售後的各個環節。本集團所有投 訴由顧客服務部門專業人士處理,期間記錄投訴 詳情、監察投訴處理及進度、處理投訴所需時 間,並記錄解決結果。2021財政年度本集團接獲 454個關於產品及服務的投訴,符合行業常規。 同時,在疫情防控期間,顧客服務部門亦克服種 種困難,以確保顧客退換貨及維修等相關投訴得 到妥善處理。

- We manage and protect our intellectual property rights through registration and maintenance and enforcement measures.
- We respect intellectual property rights of others and do not infringe their intellectual property rights.
- Suppliers who have business dealings with the Group are required to ensure that they will not display, sell, use and store any items that infringe the intellectual property rights of others at designed sales areas or counters, and also undertake not to engage in other related illegal acts at designed sales areas or department store areas.

KPI B6.4: If products are found to be of significant quality problems, the Group will initiate action plan to trace the product batch so as to ensure the improved quality of products and services.

KPI B6.5: In order to protect the relevant information and privacy of consumers, the personal information that consumers fill out in the "Membership Application Form" when applying for a membership card are entered into the membership system of the Group by specialised personnel, and are archived confidentially and centrally managed. Our employees are not allowed to access member information without authorisation.

Anti-corruption

The Group strives to achieve transparency, integrity and accountability in our operations and require our employees to maintain high standard on ethics, personal and professional conducts in order to maintain and promote the Group's reputation. In addition to these codes of conduct for employees, the Group has in place an interest declaration and whistleblowing mechanism, which we share with our Directors, colleagues and business partners to minimise and mitigate any situations that may lead to the occurrence of conflict of interests or corruptions. At the same time, the Group considers integrity as our core value and encourages our employees to report any improper, misconduct or fraudulent conducts. The anti-corruption policy of the Group is set out in the Employees' Handbook and the "Letter of Undertaking by Supplier in respect of Anti-Commercial Bribery".

KPI B7.1: In the financial year 2021, there were no members of the Group or any of their employees during the employment term being prosecuted for corruption.

KPI B7.2: The Group requires employees to confirm and sign the "Declaration and Commitment of Honesty and Integrity" when they are employed, and requires relevant suppliers and outsourcing processors that have business dealings with the Group to confirm and sign the "Anti-Commercial Bribery Commitment" before conducting formal transactions, and comply with the relevant anti-corruption commitments and requirements set out in the employee handbook and commitment letter.

關鍵績效指標B7.1:於2021財政年度,本集團旗 下公司或其僱員(於受僱期間)並無因貪腐而被起 訴。

關鍵績效指標B7.2:本集團要求僱員入職時均須 確認簽署「廉潔奉公聲明與承諾」,及要求與本集 團發生業務往來的相關供應商與外發加工商,正 式交易前均須確認簽署「反商業賄賂承諾書」,並 遵循載於僱員手冊及承諾書中之相關反貪腐承諾 及要求。



Any employee can report to the relevant departments of the Group companies directly or through any managerial staff if corruption is identified or suspected. The whistleblower may also request that his/her identity be kept confidential. We will protect the whistleblower from any form of retaliation to the extent practicable, unless the whistleblower himself/herself has violated the regulations or acts maliciously.

KPI B7.3: The Group's member companies are required to provide Directors and employees with the above anti-corruption training and reiterate the above anti-corruption requirements on a regular or irregular basis as the case may be.

Community

Community Investment

The Group adheres to the concept of "Giving back to society" and proactively participate in community and social services to promote corporate social responsibilities and make contributions to the society. In this regard, we actively invest in the community, especially in those less privileged groups as well as the young generation in respect of education, growth and development. Through engaging and interacting with the community, the Group aims to:

- Support less privileged groups and bring them love and hopes;
- Encourage employees to be compassionate and sympathetic;
- Strengthen our employees' sense of belonging to the society; and
- Provide education to help them achieving better future.

- Supporting and interacting with the community (such as the less privileged groups and people with disabilities); and
- Education

KPI B8.2: The related initiative in each area include:

 For education support, activities organised by the Group in the financial year 2021 were as follows,

In August 2021, our Suzhou store continued to participate in the Charity Education Support Programme of Suzhou Industrial Park Charity Federation, and continued to support students from less privileged families in Suzhou Industrial Park, thus students from less privileged families would acquire knowledge and not give up the opportunities to learn due to the poverty of their families. Suzhou store donated RMB200,000 in this activity.

2021年8月蘇州店繼續參加蘇州工業園區 慈善總會愛心慈善助學活動,繼續資助蘇 州工業園區貧困家庭學生,使之不因家庭 貧困而放棄享有教育學習和吸收知識的機 會。蘇州店在本次活動中捐贈人民幣 200,000元。

KPI B8.1: The Group contributes its time and resources to the community in the following areas:

In July 2021, our Suzhou store participated in the project of love dormitory construction project for schools in poor mountainous areas organised by Ying Chun Hua Love Federation (迎春花愛心聯 合會) of the Suzhou Industrial Park, providing assistance to schools from the less privileged region. We extended our support to Majian Middle School in Xiji County, Ningxia Autonomous Region (寧夏西 吉縣馬建中學) and Gupo School in Gangu County, Gansu Province (甘肅甘谷縣古坡學校) by donating 240 sets of dormitory bedding with a value of approximately RMB24,000.

In August 2021, our Shanghai store joined hands with the Art Rainbow, a charity creative art exhibition for the children of the earth in the future as a charity bazaar. We supported the Shanghai Charity Education and Training Center with actions and financial support by sponsoring children in need for 6 consecutive years (especially the development of disabled youth) and caring for their growth and success, and contributed to the charity with a donation of RMB50,000.

 In terms of social care, activities organised by the Group in the financial year 2021 were as follows,

In January 2021, our Shanghai store continued to participate in the "Love under Blue Sky — Charity Sale by Thousands of Shop" event hosted by the Shanghai Charity Foundation, and donated part of a day's sales revenue in the amount of RMB10,000 to support women living in poverty for gynecological examination and the elderly in difficulties.

In October 2021, our Shanghai store participated in the targeted poverty alleviation donation organised by the Jing'an District Representative Institution of Shanghai Charity Foundation, and donated RMB50,000 to the "Street Lighting Project in Guima Village, Guangnan County, Wenshan Prefecture, Yunnan Province (雲南省文山州廣南縣貴馬村委會路燈亮化工程)" and the "Living Environment Improvement Project in Shiyakou Village, Guangnan County, Wenshan Prefecture, Yunnan Province (雲南省文山州廣南縣 G 丫口村委會人居環境提升工程)" respectively and a total of RMB100,000 was donated to the Jing'an District Representative Institution of Shanghai Charity Foundation.

 In terms of earthquake and disaster relief and social assistance, the Group's support for the flood relief in Henan Province in the financial year 2021 are as follows, 於2021年7月,蘇州店參加蘇州工業園區迎 春花愛心聯合會貧困山區學校愛心宿舍建 立項目,本次贊助的對象為寧夏西吉縣馬 建中學和甘肅甘谷縣古坡學校,捐贈價值 為人民幣24,000元的宿舍床上用品240套。

於2021年8月,上海店牽手藝術彩虹、獻給 未來地球少兒慈善創意藝術作品展暨慈善 義賣活動。以行動及金錢支持上海市慈善 教育培訓中心,連續6年資助有需要幫助的 少年兒童,尤其是對殘障青少年的成長, 關愛他們的成才,為公益慈善事業貢獻一 份力量,捐贈金額為人民幣50,000元。

在關愛社會方面,本集團於2021財政年度 行動如下,

於2021年1月,上海店繼續參加由上海市慈 善基金會主辦的「藍天下的至愛 — 千店慈 善義賣」活動,捐出一天部分營業額為人民 幣10,000元,用於開展幫助貧困婦女的婦 科篩查和關愛困難老人。

於2021年10月,上海店參與上海市慈善基 金會靜安區代表機構精准扶貧捐贈「雲南省 文山州廣南縣貴馬村委會路燈亮化工程」和 「雲南省文山州廣南縣石丫口村委會人居環 境提升工程」,各捐贈人民幣50,000元,共 計向上海市慈善基金會靜安區代表機構捐 贈人民幣100,000元。

在抗震救災、社會援助方面,本集團於 2021財政年度對河南水災援助行動如下, In July 2021, Henan Province was ravaged by extremely heavy rainfall, our Shanghai store actively launched the "Henan Flood Relief" charity donation activity, and donated RMB1,000,000 through the Shanghai Charity Federation to support flood control and disaster relief in Henan Province. Suzhou store also donated RMB1,000,000 through the Suzhou Industrial Park Charity Federation. At the same time, employees of the Shanghai store and Suzhou store donated RMB107,985 and RMB38,112 respectively to contribute to the flood control and rescue and post-disaster reconstruction, working together with the compatriots in Henan Province to fight against the disaster and overcome the difficulties.

The Group continued to work with various charitable organisations to actively interact with local communities in a variety of ways during the year. In the financial year 2021, the charitable organisations we worked with included Shanghai Charity Foundation, Shanghai Jing'an District Civil Affairs Bureau, Shanghai Charitable Education and Training Center, Suzhou Industrial Park Charity Foundation and Ying Chun Hua Love Federation of Suzhou Industrial Park. 2021年7月河南遭受極端強降雨天氣的肆虐,上 海店積極展開「馳援河南水災」愛心捐助活動,上 海店通過上海市慈善總會捐贈人民幣1,000,000元 以支援河南省防汛救災工作。蘇州店亦通過蘇州 工業園區慈善總會捐贈人民幣1,000,000元。與此 同時,上海店及蘇州店所有員工分別捐贈人民幣 107,985元及人民幣38,112元,共同為防汛搶險和 災後重建工作貢獻一份力量,與河南同胞們共同 努力共抗災情,共度難關。

本集團繼續於年內與多個慈善機構合作,致力於 透過不同方式積極與地方社區進行互動。於2021 財政年度,本集團的合作夥伴機構包括上海市慈 善基金會、上海市靜安區民政局、上海市慈善教 育培訓中心、蘇州工業園區慈善基金會、蘇州工 業園區迎春花愛心聯合會等。



Corporate Governance Report 企業管治報告

Corporate Governance Principles

The board of directors ("Board") and management of the Company are committed to maintaining good corporate governance practices appropriate to the businesses of the Group. The Company has adopted the code provisions in the Corporate Governance Code ("CG Code") as set out in Appendix 14 to the Rules Governing the Listing of Securities ("Listing Rules") on The Stock Exchange of Hong Kong Limited ("Stock Exchange") as its guidelines and focus on a quality Board, sound internal controls, and transparency and accountability to all stakeholders.

Corporate Governance Code Compliance

The Company has complied with the code provisions of the CG Code for the year ended 31 December 2021, except the following deviation:

The roles of the Chairman and Chief Executive Officer are not segregated but such arrangement facilitates the development and execution of the Group's business strategies and enhances efficiency and effectiveness of its operations.

The Board

(1) Board Composition

As at the date of this report, the Board consists of a total of five directors, including one executive director, one non-executive director and three independent non-executive directors. More than one-third of the Board is represented by independent nonexecutive directors with one of whom being a certified public accountant. The Board believes that the number of executive and non-executive directors is reasonable and adequate to provide sufficient checks and balances that would safeguard the interests of the shareholders and the Company. The directors possess professional qualification and knowledge and industry experience and expertise, which enable them to make valuable and diversified advice and guidance to the Group's business activities and development.

Details of the composition of the Board are set out in the "Corporate Information" in this annual report. During the year and up to the date of this report, there was no change in the composition of the Board. The directors' biographical details and the relationships among them are set out in the "Profile of Directors" in this annual report.

The independence of the independent non-executive directors is assessed according to the relevant rules and requirements under the Listing Rules. The Company has received written annual confirmation of independence from each of the independent nonexecutive directors and the Company is of the view that all independent non-executive directors meet the independence guidelines as set out in Rule 3.13 of the Listing Rules and are independent.

企業管治原則

董事會 (1) 董事會組成

於本報告日期,董事會由共五位董事組 成,包括一位執行董事、一位非執行董事 及三位獨立非執行董事。超過三分之一董 事會成員由獨立非執行董事出任,其中一 人為執業會計師。董事會相信,執行董事 與非執行董事之數目是合理且足以提供充 份監察及起平衡作用,以保障股東及本公 司之利益。各董事擁有專業資格和知識及 行業經驗和專門知識,可為本集團業務活 動及發展帶來寶貴貢獻及提供不同意見與 指引。

董事會組成詳情列載於本年報「企業資料」 內。於年內及直至本報告日期,董事會之 組成並無變動。各董事之個人履歷詳情及 董事間的關係,列載於本年報「董事簡介」 內。

獨立非執行董事的獨立性乃根據上市規則 相關條例及規定而作出評核。本公司已接 獲各獨立非執行董事書面發出確認其獨立 性之週年確認書,本公司認為所有獨立非 執行董事皆符合上市規則第3.13條之獨立 性指引,並為獨立人士。

(2) Board Diversity Policy

The Company adopted a Board diversity policy in accordance with the requirements set out in the code provisions of the CG Code. The Company recognises the benefits of having a diverse Board, and sees diversity at the Board level is essential in achieving a sustainable and balanced development. In designing the Board's composition, Board diversity has been considered from a number of aspects, including but not limited to gender, age, educational background, ethnicity, professional experience, skills, knowledge, industry experience and expertise. All Board appointments are based on meritocracy and considered against a variety of criteria, having due regard for the benefits of diversity on the Board.

(3) Chairman and Chief Executive Officer

The Chairman of the Board and the Chief Executive Officer, being the same person, is responsible for setting overall strategic plan and development of the Group as well as for implementing the Board's decisions, monitoring and supervising the Group's overall performance, ensuring adequate capital and managerial resources are available to implement the business strategies being adopted from time to time, setting out and monitoring targets, plans and direction for management, reporting to the Board on the Group's performance and proposing business plans and strategies for further evaluation and assessment by the Board.

(4) Responsibilities

The Board is charged with promoting the success of the Company by directing and supervising its affairs in a responsible and effective manner. The Board steers and oversees the management of the Company including, establishing the strategic direction and setting long-term objectives for the Company, monitoring the performance of management, protecting and maximising the interests of the Company and its shareholders, and reviewing, considering and approving and the subsequent reviewing and monitoring of the annual budget against actual performances and results. The Board has delegated management, under the leadership of the Chief Executive Officer, with authorities and responsibilities for the dayto-day operations and administration of the Group.

Each director has a duty to act in good faith in the best interests of the Company. The directors are aware of their collective and individual responsibilities to the Company and the shareholders in respect of the manner in which the affairs of the Company are being controlled and managed.

(2) 董事會成員多元化政策

董事會主席及首席執行官乃同一人,負責 制定本集團整體策略計劃及發展及執行董 事會決策、監察與監督本集團整體表現、 確保具備充裕資金及管理資源以執行不時 所採納之業務策略、為管理層制定及監察 目標、計劃及方向、就本集團表現向董事 會匯報以及提呈業務計劃和策略以讓董事 會作進一步的分析及評估。

(4) 責任

董事會以負責任、重效益的態度領導及監 管本公司,促使其成功。董事會負責領導 及監管本公司管理層,工作包括制訂本公 司之策略方向、訂立本公司長遠目標、監 控管理層表現、保障及盡力提高本公司與 其股東之利益,以及審閱、考慮及批准及 隨後審查及監控年度預算、並對實際表現 及業績作考評。董事會委派由首席執行官 所領導的管理層,授權負責管理本集團日 常業務及行政事宜。

各董事均有責任真誠地以本公司的最佳利 益為前提行事。董事明白,須就本公司的 監控和管理事宜向本公司及股東承擔共同 和個別的責任。 Directors are requested to make declaration of their direct or indirect interests, if any, in any proposals or transactions to be considered by the Board. If a director has a potential conflict of interest in a matter to be considered by the Board which the Board has determined to be material, the matter will be dealt with in accordance with applicable rules and regulations and, if appropriate, an independent board committee will be set up to deal with the matter.

All directors have full access to and are provided with adequate, reliable and timely information about the operations and latest development of the Group to enable them to discharge their responsibilities and make timely decision. Updates have also been provided to all members of the Board on a regular basis to enable them to discharge their duties. Operational and financial information and analysis of the Group can be accessed directly through briefing and reporting by the Chief Executive Officer and management during Board meetings. Through the company secretary, independent professional advice, on the account of the Company, could be sought should such advice be considered necessary by any director for carrying out his/her duties properly.

(5) Appointment and Re-election of Directors

After recommendation from the nomination committee, appointment of new director(s), if any, is vested with the Board. Under the Company's articles of association, the Board may from time to time appoint a director either to fill a casual vacancy or as an addition to the Board. Any such new director shall hold office until the first general meeting of the Company (in the case of filling a casual vacancy) or until the next following annual general meeting of the Company (in the case of an addition to the Board) after his/her appointment and shall then be eligible for re-election at the same general meeting.

All non-executive directors (including independent non-executive directors) are appointed for a specific term of three years and all directors (including non-executive directors) are subject to retirement by rotation at least once every three years and are subject to re-election in accordance with the Company's articles of association.

Risk Management and Internal Controls

The Board has overall responsibility for evaluating and determining the nature and extent of the risks it is willing to take in achieving the Group's strategic objectives, and maintaining sound and effective risk management and internal control systems. As such, the Board not only sets and communicates the Group's strategies and objectives but also oversees the Group's risk management and internal controls systems on an ongoing basis, and to ensure that a review of the effectiveness of the Group's risk management and internal controls systems has been conducted at least annually.

The audit committee plays a vital role in overseeing the risk management and internal controls systems on behalf of the Board. The audit committee reviews, on at least an annual basis, the Group's risk management and internal controls systems to ensure that management has fulfilled its duties in establishing and maintaining an effective risk management and internal controls systems. It also assesses the extent and frequency of the communication of the monitoring results to the Board, as well as considering the results of any investigation into the Group's risk management practices and internal controls and management's responses to the findings of such investigations. 
The Group also regulates the handling and dissemination of inside information and procedures are in place for the handling of confidential commercial information to ensure that inside information remains confidential until the disclosure of such information is approved, and its dissemination effectively made.

The main features of the Group's risk management and internal controls systems are illustrated below:

The Group has established an organisational structure with defined levels of responsibility and reporting procedures. Monthly management accounts are available for review of the senior management and the Board (in a concise format of a Monthly Report) for monitoring the Group's financial and operating results. The management, supported by the operation units and the internal audit team, are responsible for formulating, implementing and monitoring sound risk management and internal control systems, and reporting to the Board and the audit committee on the result of risk assessment, as well as the assessment on the effectiveness of risk management and internal control systems. 本集團已建立責任及申報程序明確的組織架構。 每月管理賬目可供高級管理層及董事會審閱(以 月報報告的簡潔格式),以監察本集團的財務及 營運業績。由營運單位及內部審核團隊支援的管 理層負責制訂、實施及監察穩健的風險管理及內 部監控系統,並向董事會及審核委員會報告風險 評估結果,以及風險管理及內部監控系統有效性 的評估。 The internal audit provides an independent appraisal on the adequacy and effectiveness of the Group's risk management and internal control systems. The yearly internal audit plan is derived based on the assessed risk of the Group's major operations and business and, taking into account also result of internal audit activities conducted in the preceding period, are reported to the audit committee for approval. In addition to its scheduled internal audit works, the internal audit team may be requested to conduct other review or investigative work. The results of internal audit reviews and agreed management action plans in response to recommendations of the internal audit are reported to the executive director and audit committee periodically. The internal audit also follows up with management regarding the implementation of the agreed action plans to ensure that operation procedures and internal controls are continuously enhanced.

In addition to the assessment and review of risk management and internal controls undertaken internally, the half-yearly review and annual audit conducted by our external auditors, aim to provide assurance that the Group's financial statements are prepared in accordance with generally accepted accounting principles, the Group's accounting policies and applicable laws, rules and regulations, will also provide to certain extent independent checks on the Group's internal controls system.

For the year ended 31 December, 2021, management has conducted regular reviews during the year on the effectiveness of the risk management and internal control systems covering all material aspects related to financial, operational and compliance controls, various functions for risk management and security of physical assets and information systems. The audit committee had been reported during the audit committee meetings of key findings identified by internal auditors and external auditors and discussed findings and actions or measures taken in addressing those findings relating to the Group's risk management and internal controls. No material issues on the risk management and internal controls system have been identified during the year ended 31 December 2021 and no significant areas of concern which might require rectification works or affect our stakeholders, including our shareholders. The Board and its audit committee considered the risk management and internal control system to be effective and adequate, including the adequacy of resources, staff qualifications and experience, training and budget of its accounting, internal audit and financial reporting functions.

The Board emphasizes in creating and maintaining a high level of transparency through timely disclosure of relevant information on the Group's business and activities to the shareholders, investors, media and investing public, through regular press releases, analyst's briefings, press conferences, as well as timely updating of the Company's website. Our executive director and management, who look after the business operation, are committed to respond to enquiries from regulators, shareholders and business partners.

Investors' Relations and Communication with Shareholders

The Company regards high quality reporting as an essential element in building successful relationships with its shareholders. The Company always seeks to provide relevant information to existing and potential investors, not only to comply with the different regulatory requirements in force but also to enhance transparency and communications with the shareholders and the investing public. This is part of a continuous communication program that encompasses meetings and relevant announcements to the market in addition to periodic written reports in the form of preliminary results announcement and the publication of interim and annual reports. The annual general meeting of the Company also provides an opportunity for communication between the Board and the shareholders.

In addition, the Company also maintains a corporate website on which comprehensive information about the Group is made available on a timely basis. Regular meetings are also held with institutional investors and research analysts to provide them with timely updates on the Group's latest business developments which are not inside information (as defined under the Listing Rules) in nature. These activities will keep the public informed of the Group's activities and foster effective communications.

The Group also participated in investment conferences and forums during the year in order to enhance the awareness of the investing public of the Group's business operations and development strategies.

The Company is committed to ensuring that it is fully complied with disclosure obligations stipulated in the Listing Rules and other applicable laws and regulations, and that all shareholders and potential investors have an equal opportunity to receive and obtain externally available information released by the Group.

If within twenty-one (21) days of such deposit the Board fails to proceed to convene such meeting the shareholder(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the shareholder(s) as a result of the failure of the Board shall be reimbursed to the shareholder(s) by the Company.

Principal Activities

The Company acts as an investment holding company and the principal activities of its subsidiaries are the operation of department stores and related retailing business as well as property investment in the PRC.

Staff costs (excluding directors' emoluments) amounted to RMB191.3 million (2020: RMB155.6 million) for the year. The Group ensures that the pay levels of its employees are competitive and in line with the market trend and its employees are rewarded on a performance related basis within the general framework of the Group's salary and bonus system.

In November 2019, PricewaterhouseCoopers ("PwC") was appointed as the auditor of the Company to fill the vacancy following the resignation of Deloitte Touche Tohmatsu. Save as disclosed above, there were no changes in auditor of the Company in any of the preceding three years.

The consolidated financial statements for the year have been audited by PwC. A resolution will be submitted to the forthcoming annual general meeting of the Company to reappoint PwC as auditor of the Company.

我們的保留意見

我們認為,除我們報告中保留意見的基礎部份所 述事項的潛在影響外,該等綜合財務報表已根據 香港會計師公會(「香港會計師公會」)頒佈的《香 港財務報告準則》(「香港財務報告準則」)真實而 中肯地反映了 貴集團於二零二一年十二月 三十一日的綜合財務狀況及其截至該日止年度的 綜合財務表現及綜合現金流量,並已遵照香港《公 司條例》的披露要求妥為擬備。

Basis for Qualified Opinion

As further detailed in note 17 to the Group's consolidated financial statements, the Group holds equity interests in certain associated companies herein referred to as "Beiren Group". For the year ended 31 December 2021, the Group recognised a share of profits of associates of RMB237.3 million and carried RMB3,095.1 million investments in associates on the consolidated statement of financial position as at 31 December 2021, of which RMB235.8 million of the share of profits of associates for the year and RMB3,089.9 million of the carrying value of investments in associates as at 31 December 2021 were attributable to the Beiren Group.

In 2019, the Group made a full expected credit loss allowance, net of deferred tax credit ("Full Impairment") against the entire overdue trade receivable balances due from three PRC companies ("Debtors") of the Beiren Group ("Trade Receivables"), for the purpose of recognising the Group's share of results of the Beiren Group. Such Trade Receivables are guaranteed by the ultimate beneficial owner of the Debtors (the "Guarantor"). The impact of the Full Impairment on the Group's share of losses of associates, loss attributable to owners and loss attributable to non-controlling interests for the year ended 31 December 2019 amounted to RMB812.4 million, RMB487.4 million and RMB325.0 million respectively.

We have previously qualified our auditor's report on the Group's consolidated financial statements for the year ended 31 December 2020 due to a limitation of scope as we were unable to obtain sufficient appropriate evidences on whether any adjustments were necessary to the carrying amount of the Trade Receivables of nil balance and the related deferred tax credit in respect of the Full Impairment, which had consequential impact on (i) the Group's share of profits of associates for the year ended 31 December 2020 and the carrying value of its investments in associates as at that date; (ii) the Group's profit attributable to owners and profit attributable to non-controlling interests in the Group's consolidated statement of profit or loss and other comprehensive income for the year ended 31 December 2020; and (iii) the equity attributable to owners of the Company and the non-controlling interests on the Group's consolidated statement of financial position as at 31 December 2020.

During the year ended 31 December 2021 and up to the date of this report, there has been no additional information or development in relation to the recoverability of the Trade Receivables due from the Debtors. Accordingly, the Group's management considered the Full Impairment of the Trade Receivables of the Beiren Group brought forward is still appropriate as at 31 December 2021.

如 貴集團綜合財務資料附註17所述, 貴集團 持有若干聯營公司,以下簡稱為「北人集團」之股 權。截至二零二一年十二月三十一日止年度, 貴 集團確認應佔聯營公司溢利為人民幣237.3百萬 元及於二零二一年十二月三十一日在綜合財務狀 況表對聯營公司的投資賬面價值為人民幣3,095.1 百萬元,而於本年度屬於北人集團之應佔聯營公 司溢利為人民幣235.8百萬元及於二零二一年十二 月三十一日對聯營公司的投資賬面價值為人民幣 3,089.9百萬元。

於二零一九年, 貴集團已就因三家中國公司(「債務人」)欠北人集團的全部逾期應收賬款餘額(扣除遞延税項抵免)(「應收賬項」),計提全額預期 信貸虧損撥備(「全額減值」),以確認 貴集團應 佔北人集團的業績。有關應收賬項由債務人之最 終實質擁有人(「擔保人」)提供擔保。截至二零 一九年十二月三十一日止年度,全額減值對 貴 集團應佔聯營公司虧損、擁有人應佔虧損及非控 股權益應佔虧損的影響分別為人民幣812.4百萬 元、人民幣487.4百萬元及人民幣325.0百萬元。

我們先前於 貴集團截至二零二零年十二月 三十一日止年度的綜合財務報表發表的核數師報 告中作出保留意見,原因為審計範圍受到限制, 我們無法獲得充足及適當的證據,以是否必須對 應收賬項賬面價值為零及有關全額減值的相關遞 延稅項抵免作任何調整,而這將最終影響(i)截至 二零二零年十二月三十一日止年度的 貴集團綜 百價值:(ii)截至二零二零年十二月三十一日止年 度 貴集團綜合損益及其他全面收益表中的擁有 人應佔 貴集團溢利及非控股權益應佔溢利;及 (iii)於二零二零年十二月三十一日,貴集團綜合 財務狀況表中的 貴公司擁有人應佔權益及非控 股權益。

於二零二一年十二月三十一日止年度及直至本報 告日,就應收債務人之應收賬項的可收回性沒有 任何進一步的資料及發展。因此, 貴集團管理 層認為於結轉北人集團應收賬項的全額減值於二 零二一年十二月三十一日仍為合適。 However, the Group's management was not able to provide us with adequate evidence with respect to the financial conditions of the Debtors and the Guarantor up to the date of this report, including the financial information of the Debtors to date, details of other assets (including nature, amounts, and claims or pledges against such assets, if any) of the Guarantor that could be pursued to settle the outstanding Trade Receivables due to the Beiren Group. We were therefore unable to obtain sufficient appropriate audit evidence we considered necessary to assess the recoverable amounts of the Trade Receivables. Given the abovementioned scope limitations, there were no other satisfactory procedures that we could perform to determine whether any adjustments were necessary to the Trade Receivables of nil balance and the related deferred tax credit in respect of the Full Impairment as at 31 December 2021 which consequentially impacted (i) the Group's share of profits of associates for the year ended 31 December 2021 and the carrying value of its investments in associates as at that date; (ii) the Group's profit attributable to owners and profit attributable to non-controlling interests in the Group's consolidated statement of profit or loss and other comprehensive income for the year ended 31 December 2021; and (iii) the Group's equity attributable to owners of the Company and the non-controlling interests on the consolidated statement of financial position as at 31 December 2021.

We conducted our audit in accordance with Hong Kong Standards on Auditing ("HKSAs") issued by the HKICPA. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Consolidated Financial Statements section of our report.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified opinion.

Independence

We are independent of the Group in accordance with the HKICPA's Code of Ethics for Professional Accountants ("the Code"), and we have fulfilled our other ethical responsibilities in accordance with the Code.

Key Audit Matters

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. In addition to the matter described in the Basis for Qualified Opinion section, we have determined the matter described below to be the key audit matter to be communicated in our report.

The Group has equity interests in a group of companies • herein referred to as "Beiren Group") which were accounted for as associates under the equity method. The Beiren Group's principal activities include operation of department stores and supermarkets. The results of the Beiren Group is highly dependent on the revenues derived from its retail operations which typically comprise of high volume of low-value transactions.

Based on the procedures performed, we found that, in the context of our audit of the Group's consolidated financial statements, the Group's share of results of associates and investments in associates in respect of the Beiren Group (except for the share of Full Impairment of certain trade receivables as mentioned under "Basis for Qualified Opinion") were supported by the available evidence.

In connection with our audit of the consolidated financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the consolidated financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated.

If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. As described in the Basis for Qualified Opinion section above, we were unable to obtain sufficient appropriate evidence about (i) the Group's share of profits of associates for the year ended 31 December 2021 and the carrying value of its investments in associates as at that date; (ii) the Group's profit attributable to owners and profit attributable to non-controlling interests in the Group's consolidated statement of profit or loss and other comprehensive income for the year ended 31 December 2021; and (iii) the Group's equity attributable to owners of the Company and the non-controlling interests on the consolidated statement of financial position as at 31 December 2021. Accordingly, we are unable to conclude whether or not the other information is materially misstated with respect to this matter.

Responsibilities of Directors and Those Charged with Governance for the Consolidated Financial Statements

The directors of the Company are responsible for the preparation of the consolidated financial statements that give a true and fair view in accordance with HKFRSs issued by the HKICPA and the disclosure requirements of the Hong Kong Companies Ordinance, and for such internal control as the directors determine is necessary to enable the preparation of consolidated financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the consolidated financial statements, the directors are responsible for assessing the Group's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the directors either intend to liquidate the Group or to cease operations, or have no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Group's financial reporting process.

We report our opinion solely to you, as a body, and for no other purpose. We do not assume responsibility towards or accept liability to any other person for the contents of this report. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with HKSAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these consolidated financial statements.

1 General

Lifestyle China Group Limited (the "Company") was incorporated as an exempted company with limited liability under the Companies Law in the Cayman Islands on 4 January 2016 and its shares are listed on The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). The addresses of the registered office and the principal place of business of the Company are set out in section headed "Corporate Information" to the annual report. The Company acts as an investment holding company and the principal activities of its subsidiaries are the operation of "Jiuguang" department stores and related retailing business as well as property investment in the People's Republic of China (the "PRC").

The Company's ultimate controlling party is Mr. Lau Luen Hung, Thomas ("Mr. Lau"), who is also the Chairman and executive director of the Company.

The consolidated financial statements are presented in Renminbi ("RMB") which is the functional currency of the Company.

2 Summary of significant accounting policies

The principal accounting policies applied in the preparation of those consolidated financial statements are set out below. These policies have been consistently applied to all the years presented unless otherwise stated.

(a) Basis of preparation

The consolidated financial statements of the Group have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and disclosure requirements of the Hong Kong Companies Ordinance ("HKCO") (Cap. 622).

The consolidated financial statements have been prepared on a historical cost basis, except for the financial assets and liabilities at fair value through profit or loss ("FVTPL"), which are measured at fair value. The preparation of consolidated financial statements in conformity with HKFRS requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the Company's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements are disclosed in note 3.

Certain comparative figures have been reclassified to conform to the current year's presentation.

(b) Consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income are attributed to the owners of the Company and to the noncontrolling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the noncontrolling interests having a deficit balance.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies in line with the Group's accounting policies.

Non-controlling interests in subsidiaries are presented separately from the Group's equity therein, which represent present ownership interests entitling their holders to a proportionate share of net assets of the relevant subsidiaries upon liquidation.

Changes in the Group's interests in subsidiaries

Changes in the Group's interests in subsidiaries that do not result in the Group losing control over the subsidiaries are accounted for as equity transactions. The carrying amounts of the Group's relevant components of equity and the noncontrolling interests are adjusted to reflect the changes in their relative interests in the subsidiaries, including reattribution of relevant reserves between the Group and the non-controlling interests' proportionate interests. Any difference between the amount by which the non-controlling interests are adjusted, and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

When the Group loses control of a subsidiary, the assets and liabilities of that subsidiary and non-controlling interests (if any) are derecognised. A gain or loss is recognised in profit or loss and is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest and (ii) the carrying amount of the assets (including goodwill) and liabilities of the subsidiary attributable to the owners of the Company. All amounts previously recognised in other comprehensive income in relation to that subsidiary are accounted for as if the Group had directly disposed of the related assets or liabilities of the subsidiary (i.e. reclassified to profit or loss or transferred to another category of equity as specified/ permitted by applicable HKFRSs). The fair value of any investment retained in the former subsidiary at the date when control is lost is regarded as the fair value on initial recognition for subsequent accounting under HKFRS 9/HKAS 39 or, when applicable, the cost on initial recognition of an investment in an associate or a joint venture.

Investments in associates and a joint venture

An associate is an entity over which the Group has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee but is not control or joint control over those policies.

A joint venture is a joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint arrangement. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require unanimous consent of the parties sharing control.

The results and assets and liabilities of associates and a joint venture are incorporated in these consolidated financial statements using the equity method of accounting. The financial statements of associates and a joint venture used for equity accounting purposes are prepared using uniform accounting policies as those of the Group for like transactions and events in similar circumstances. Under the equity method, an investment in an associate or a joint venture is initially recognised in the consolidated statement of financial position at cost and adjusted thereafter to recognise the Group's share of the profit or loss and other comprehensive income of the associate or joint venture. Changes in net assets of the associate/joint venture other than profit or loss and other comprehensive income are not accounted for unless such changes resulted in changes in ownership interest held by the Group. When the Group's share of losses of an associate or joint venture exceeds the Group's interest in that associate or joint venture (which includes any long-term interests that, in substance, form part of the Group's net investment in the associate or joint venture), the Group discontinues recognising its share of further losses. Additional losses are recognised only to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the associate or joint venture.

An investment in an associate or a joint venture is accounted for using the equity method from the date on which the investee becomes an associate or a joint venture. On acquisition of the investment in an associate or a joint venture, any excess of the cost of the investment over the Group's share of the net fair value of the identifiable assets and liabilities of the investee is recognised as goodwill, which is included within the carrying amount of the investment. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of the investment, after reassessment, is recognised immediately in profit or loss in the period in which the investment is acquired.

The Group assesses whether there is an objective evidence that the interest in an associate or a joint venture may be impaired. When any objective evidence exists, the entire carrying amount of the investment (including goodwill) is tested for impairment in accordance with HKAS 36 as a single asset by comparing its recoverable amount (higher of value in use and fair value less costs of disposal) with its carrying amount. Any impairment loss recognised forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with HKAS 36 to the extent that the recoverable amount of the investment subsequently increases.

When a group entity transacts with an associate or a joint venture of the Group, profits and losses resulting from the transactions with the associate or joint venture are recognised in the Group's consolidated financial statements only to the extent of interests in the associate or joint venture that are not related to the Group.

Investments in subsidiaries are accounted for at cost less impairment. Cost includes direct attributable costs of investment. The results of subsidiaries are accounted for by the company on the basis of dividend received and receivable.

Impairment testing of the investments in subsidiaries is required upon receiving a dividend from these investments if the dividend exceeds the total comprehensive income of the subsidiary in the period the dividend is declared or if the carrying amount of the investment in the separate financial statements exceeds the carrying amount in the consolidated financial statements of the investee's net assets including goodwill.

Offsetting financial instruments

Financial assets and liabilities are offset and the net amount is reported in the statement of financial position where the Group currently has a legally enforceable right to offset the recognised amounts, and there is an intention to settle on a net basis or realise the asset and settle the liability simultaneously. The Group has also entered into arrangements that do not meet the criteria for offsetting but still allow for the related amounts to be set off in certain circumstances, such as bankruptcy or the termination of a contract.

(c) Revenue from contracts with customers

Under HKFRS 15, the Group recognises revenue when (or as) a performance obligation is satisfied, i.e. when "control" of the goods or services underlying the particular performance obligation is transferred to the customer. The revenues are presented as revenue in the consolidated statement of profit or loss and other comprehensive income.

A performance obligation represents a good or service (or a bundle of goods or services) that is distinct or a series of distinct goods or services that are substantially the same.

Control is transferred over time and revenue is recognised over time by reference to the progress towards complete satisfaction of the relevant performance obligation if one of the following criteria is met:

• the customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs;

抵銷金融工具

Otherwise, revenue is recognised at a point in time when the customer obtains control of the distinct good or service.

For direct sales of goods, revenue is recognised when control of the goods has transferred, being at the point the customer purchases the goods at the department stores.

For income from concessionaire sales, the Group recognises commission income over time which it is entitled and is based on certain percentage of sales made by the concessionaires in accordance with the terms of contracts. When they fail to meet the minimum guarantee income in accordance with the terms of certain contracts, the minimum guarantee amount is recognised as income as it is the amount that the Group has the right to receive.

For service income, it represents income from concessionaires for displaying their products and billboards in department stores. The revenue is recognised over time by reference to the progress towards complete satisfaction of the relevant performance obligation when the customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs.

A contract asset represents the Group's right to consideration in exchange for goods or services that the Group has transferred to a customer that is not yet unconditional. It is assessed for impairment in accordance with HKFRS 9. In contrast, a receivable represents the Group's unconditional right to consideration, i.e. only the passage of time is required before payment of that consideration is due.

A contract liability represents the Group's obligation to transfer goods or services to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer.

A contract asset and a contract liability relating to the same contract are accounted for and presented on a net basis.

合約負債指本集團自客戶已收取代 價(或代價金額已到期)後,本集團 轉讓貨品或服務予客戶的責任。

與同一份合約有關的合約資產及合約負債按淨值基準入賬及呈列。

(c) Revenue from contracts with customers (continued) Contracts with multiple performance obligations (including allocation of transaction price)

For contracts that contain more than one performance obligations including obligation to provide goods or services to customers on complementary basis and customer's options to acquire additional goods or services for free or at a discount in future granted under loyalty reward program, the Group allocates the transaction price to each performance obligation on a relative standalone selling price basis.

The stand-alone selling price of the distinct good or service underlying each performance obligation is determined at contract inception. It represents the price at which the Group would sell a promised good or service separately to a customer.

Accounting for unredeemed gift certificates and reward points under customer loyalty program

The unredeemed gift certificates and reward points under customer loyalty program is recorded as contract liabilities, and reflect the value that is expected to be redeemed, i.e. anticipated breakage.

Breakage will need to be estimated considering the guidance on constraining estimates of variable consideration as well as the Group's historical experience with gift certificates and loyalty points under loyalty reward program. Revenue is recognised in regard to breakage in the proportion of gift certificates and loyalty points redeemed in that period and likely to result in the acceleration of revenue when the possibility of redemption becomes remote.

就包含多於一項履約責任(包括以補 充形式向客戶提供貨品或服務)的合 約,而客戶選擇免費或根據忠誠獎 勵計劃所授出的日後折扣獲取額外 貨品或服務,本集團以相關獨立售 價基準,將交易價格分配至各項履 約責任。

根據各項履約責任,特定貨品或服務的獨立銷售價格於合約開始時釐 定。其代表本集團向客戶獨立出售 所承諾貨品或服務的價格。

未兑換禮券及忠誠獎勵計劃下的獎 勵積分之會計處理

尚未兑換之禮券及忠誠獎勵計劃下 之獎勵積分記錄為合約負債,並反 映預期兑換的價值,即預計撇賬。

考慮到限制可變代價估計的指引, 以及本集團於禮券及忠誠獎勵計劃 下之積分的過往經驗,因此將需要 就撇賬作出估計。有關撇賬應將該 期間兑換的禮券及積分按比例確認 為收入,當兑換的可能性變低時,可 能導致收入增加。

For contracts that contain variable consideration, the Group recognises the amount of consideration to which it is entitled using the most likely amount, which better predicts the amount of consideration to which the Group is entitled.

The amount of variable consideration is included in the transaction price only to the extent that it is highly probable that such an inclusion will not result in a significant revenue reversal in the future when the uncertainty associated with the variable consideration is subsequently resolved.

The Group updates the estimated transaction price based on issued statements to consignors and concessionaires (including assessment of whether the variable consideration is constrained) to represent fairly the circumstances present at the end of the reporting period.

Principal versus agent

When another party is involved in providing goods or services to a customer, the Group determines whether the nature of its promise is a performance obligation to provide the specified goods or services itself (i.e. the Group is a principal) or to arrange for those goods or services to be provided by the other party (i.e. the Group is an agent).

The Group is a principal if it controls the specified goods or services before these good or service is transferred to a customer.

The Group is an agent if its performance obligation is to arrange for the provision of the specified goods or services by another party. In this case, the Group does not control the specified good or service provided by another party before that goods or services is transferred to the customers. When the Group acts as an agent, it recognises revenue in the amount of any fee or commission to which it expects to be entitled in exchange for arranging for the specified goods or services to be provided by the other party.

The Group acts as an agent for concessionaire sales as the Group does not control the specific goods provided by the consignors and concessionaires before goods are transferred to a customers.

倘於此等貨品或服務轉讓予客戶前, 本集團對有關貨品或服務擁有控制 權,本集團即為委託人。

倘履約責任為安排另一方提供特定 貨品或服務,本集團即為代理人。在 此情況下,於該貨品或服務轉讓予 客戶前,本集團並無對由另一方提 供的特定貨品或服務擁有控制權。 當本集團為代理人時,本集團因為 另一方提供的特定貨品或服務作出 安排,而預期有權收取的任何費用 或佣金金額確認收入。

由於本集團於貨品轉讓予客戶前, 對寄售商及特許專櫃提供的特定貨 品並無控制權,因此本集團就特許 專櫃銷售充當代理人。

(d) Property, plant and equipment

Property, plant and equipment including buildings held for use in the production or supply of goods or services, or for administrative purposes (other than construction in progress) are stated in the consolidated statement of financial position at cost less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

Properties in the course of construction for production, supply or administrative purposes are carried at cost, less any recognised impairment loss. Costs include professional fees and, for qualifying assets, borrowing costs capitalised in accordance with the Group's accounting policy.

Such properties are classified to the appropriate categories of property, plant and equipment when completed and ready for intended use.

Depreciation is recognised so as to write off the cost of assets (other than construction in progress) less their residual values over their estimated useful lives, using the straight-line method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

Items of property, plant and equipment, other than construction in progress, are depreciated after taking into account their estimated residual value, using straight-line method over the following useful lives:

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

When buildings are in the course of development for production or for administrative purposes, the amortisation of right-of-use assets provided during the construction period is included as part of costs of buildings under construction. Buildings under construction are carried at cost, less any identified impairment losses. Depreciation of buildings commences when they are available for use (i.e. when they are in the location and condition necessary for them to be capable of operating in the manner intended by management).

Properties under development

Properties under development are stated at the lower of cost and net realisable value. The cost comprises right-of-use assets, development and construction expenditure, borrowing costs capitalised and other direct costs attributable to the development. Net realisable value is the estimated selling price at which the property can be realised less related expenses.

(e) Investment property

Investment property, principally comprising leasehold land and buildings, is held for long-term rental yields or for capital appreciation or both, and is not occupied by the Group.

Investment property is measured at cost, including related transaction costs, less accumulated depreciation and accumulated impairment losses, if any.

Depreciation is provided using the straight-line method to write off the cost of the investment properties over their estimated useful lives. Items of investment property are after taking into account their estimated residual value, using straight-line method over the following useful lives:

Subsequent expenditure is charged to the asset's carrying amount only when it is probably that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other repair and maintenance costs are expensed in the consolidated income statement during the financial period in which they are incurred.

If an investment property becomes owner-occupied, it is reclassified as property, plant and equipment. At the date of reclassification, its cost and accumulated depreciation are transferred to property, plant and equipment and become its cost and accumulated depreciation for accounting purposes. If an owner- occupied property becomes an investment property because its use has changed, it is reclassified as investment property.

(f) Leases

An arrangement, comprising a transaction or a series of transactions, is or contains a lease if the Group determines that the arrangement conveys a right to control the use of an identified asset for a period of time in exchange for consideration. Such determination is made on an evaluation of the substance of the arrangement, regardless of whether the arrangements take the legal form of a lease.

Assets and liabilities arising from a lease are initially measured on a present value basis.

(i) Lease liabilities

Lease liabilities include the net present value of the following lease payments:

- fixed payments (including in-substance fixed payments), less any lease incentives receivable; and
- payments of penalties for terminating the lease, if the lease term reflects the Group, as a lessee, exercising an option to terminate the lease.

- where possible, uses recent third-party financing received by the Group as a starting point, adjusted to reflect changes in financing conditions since third party financing was received;
- uses a build-up approach that starts with a riskfree interest rate adjusted for credit risk for leases held by the Group, which does not have recent third party financing; and
- makes adjustments specific to the lease.

The Group is exposed to potential future increases in variable lease payments based on an index or rate, which are not included in the lease liability until effective. When adjustments to lease payments based on an index or rate take effect, the lease liability is reassessed and adjusted against the right-of-use asset.

Lease payments are allocated between the principal and finance cost. The finance cost is charged to the consolidated income statement over the lease period so as to produce a constant periodic rate of interest on the remaining balance of the liability for each period.

Right-of-use assets linked to owner occupied buildings are measured applying the cost model relevant to that specific class of property, plant and equipment.

Payments associated with all leases of low-value assets are recognised on a straight-line basis as an expense in profit or loss.

(iv) The Group as lessor

Rental income which are derived from the Group's ordinary course of business are presented as revenue in the consolidated statement of profit or loss and other comprehensive income.

In the event that lease incentives are received to enter into operating leases, such incentives are recognised as a liability. The aggregate benefit of incentives is recognised as a reduction of rental expense on a straight-line basis.

Leasehold land and buildings

When the Group makes payment for a property interest which includes both leasehold land and building elements, the Group assesses the classification of each element separately based on the assessment as to whether substantially all the risks and rewards incidental to ownership of each element have been transferred to the Group, unless it is clear that both elements are operating leases in which case the entire property is accounted as an operating lease. Specifically, the entire consideration (including any lump-sum upfront payments) are allocated between the leasehold and the building elements in proportion to the relative fair values of the leasehold interests in the land element and building element at initial recognition.

To the extent the allocation of the relevant payments can be made reliably, interest in leasehold land that is accounted for as an operating lease is presented as "prepaid lease payments" in the consolidated statement of financial position and is amortised over the lease term on a straight-line basis except for those that are classified and accounted for as investment properties under the fair value model. When the payments cannot be allocated reliably between the leasehold land and building elements, the entire property is generally classified as if the leasehold land is under finance lease.

Provisions are recognised when the Company has a present legal or constructive obligation as a result of past events, it is probable that an outflow of resources will be required to settle the obligation; and the amount has been reliably estimated.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Provisions are measured at the present value of the expenditures expected to be required to settle the obligation using a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the obligation. The increase in the provision due to passage of time is recognised as interest expense.

(h) Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise, except for exchange differences arising on a monetary item that forms part of the Company's net investment in a foreign operation, in which case, such exchange differences are recognised in other comprehensive income and accumulated in equity and will be reclassified from equity to profit or loss on disposal of the foreign operation.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. RMB) using exchange rates prevailing at the end of each reporting period. Income and expenses items are translated at the average exchange rates for the period, unless exchange rates fluctuate significantly during the period, in which case, the exchange rates prevailing at the dates of transactions are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of translation reserve.

On the disposal of a foreign operation (that is a disposal of the Group's entire interest in a foreign operation, or a disposal involving loss of control over a subsidiary that includes a foreign operation), all of the exchange differences accumulated in equity in respect of that operation attributable to the owners of the Company are reclassified to profit or loss.

(i) Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax. The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit before taxation because of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries and interests in associates and a joint venture, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied by the same taxation authority and the Group intends to settle its current tax assets and liabilities on a net basis. Current and deferred tax are recognised in profit or loss.

Current and deferred tax are recognised in profit or loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively.

The Group considers the lease as a single transaction in which the asset and liability are integrally linked, so there is no net temporary difference at inception. Subsequently, as differences arise on settlement of the liability and the amortisation of the leased asset, there will be a net temporary difference on which deferred tax is recognised.

At the end of each reporting period, the Group reviews the carrying amounts of its non-financial assets with finite useful lives to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the relevant asset is estimated in order to determine the extent of the impairment loss (if any).

The recoverable amount of non-financial assets are estimated individually, or when it is not possible to estimate the recoverable amount of an asset individually, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs. When a reasonable and consistent basis of allocation can be identified, corporate assets are also allocated to individual cash generating units, or otherwise they are allocated to the smallest group of cashgenerating units for which a reasonable and consistent allocation basis can be identified.

The recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pretax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset (or a cash generating unit) for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or a cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or a cash-generating unit) is reduced to its recoverable amount. In allocating the impairment loss, the impairment loss is allocated to reduce the carrying amount of the assets on a pro-rata basis based on the carrying amount of each asset in the unit. The carrying amount of an asset is not reduced below the highest of its fair value less costs of disposal (if measurable), its value in use (if determinable) and zero. The amount of the impairment loss that would otherwise have been allocated to the asset is allocated pro rata to the other assets of the unit. An impairment loss is recognised immediately in profit or loss.

Where an impairment loss subsequently reverses, the carrying amount of the asset (or cash-generating unit) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or a cash-generating unit) in prior years. A reversal of an impairment loss is recognised immediately in profit or loss.

Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the market place.

Financial assets and financial liabilities are initially measured at fair value except for trade receivables arising from contracts with customers which are initially measured in accordance with HKFRS 15. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets or financial liabilities at fair value through profit or loss ("FVTPL")) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition.

Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit or loss are recognised immediately in profit or loss.

Effective interest method

The effective interest method is a method of calculating the amortised cost of a financial asset or financial liability and of allocating interest income and interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts and payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial asset or financial liability, or, where appropriate, a shorter period, to the net carrying amount on initial recognition.

Financial assets

Classification and subsequent measurement of financial assets Financial assets that meet the following conditions are subsequently measured at amortised cost:

- the financial asset is held within a business model whose objective is to collect contractual cash flows; and
- the contractual terms give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

In addition, the Group may irrevocably designate a financial asset that are required to be measured at the amortised cost or fair value through other comprehensive income ("FVOCI") as measured at FVTPL if doing so eliminates or significantly reduces an accounting mismatch.

Amortised cost and interest income

Interest income is recognised using the effective interest method for financial assets measured subsequently at amortised cost. Interest income is calculated by applying the effective interest rate to the gross carrying amount of a financial asset, except for financial assets that have subsequently become credit-impaired. For financial assets that have subsequently become credit-impaired, interest income is recognised by applying the effective interest rate to the amortised cost of the financial asset from the next reporting period. If the credit risk on the credit-impaired financial instrument improves so that the financial asset is no longer credit-impaired, interest income is recognised by applying the effective interest rate to the gross carrying amount of the financial asset from the beginning of the reporting period following the determination that the asset is no longer credit impaired.

Financial assets at FVTPL

Financial assets that do not meet the criteria for being measured at amortised cost or FVOCI or designated as FVOCI are measured at FVTPL.

Financial assets at FVTPL are measured at fair value at the end of each reporting period, with any fair value gains or losses recognised in profit or loss. The net gain or loss recognised in profit or loss excludes any dividend or interest earned on the financial asset which is included in the "interest and investment income" line item.

Impairment of financial assets

The Group recognises a loss allowance for expected credit loss ("ECL") on financial assets which are subject to impairment requirements under HKFRS 9 (including trade and other receivables and bank balances). The amount of ECL is updated at each reporting date to reflect changes in credit risk since initial recognition.

The Group assesses on a forward-looking basis the ECL associated with its debt instruments carried at amortised cost and FVOCI. The impairment methodology applied depends on whether there has been a significant increase in credit risk.

For trade receivables, the Group applies the simplified approach permitted by HKFRS 9, which requires expected lifetime losses to be recognised from initial recognition of the receivables, see note 37 for further details.

Significant increase in credit risk

In assessing whether the credit risk has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forwardlooking information that is available without undue cost or effort.

於評估信貸風險是否自初始確認以 來已大幅增加時,本集團將於報告 日金融工具發生違約的風險,以及 於初始確認日期金融工具發生違約 的風險進行比較。於進行此評估時, 本集團考慮合理而具理據的定量及 定質資料,包括過往經驗及可在毋 須付出不必要成本或資源即可取得 的前瞻性資料。

 - an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
 - significant deterioration in external market indicators of credit risk, e.g. a significant increase in the credit spread, the credit default swap prices for the debtor;
 - existing or forecast adverse changes in business, financial or economic conditions that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations;
 - an actual or expected significant deterioration in the operating results of the debtor; and
 - an actual or expected significant adverse change in the regulatory, economic, or technological environment of the debtor that results in a significant decrease in the debtor's ability to meet its debt obligations.

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

Despite the aforegoing, the Group assumes that the credit risk on a debt instrument has not increased significantly since initial recognition if the debt instrument is determined to have low credit risk at the reporting date. A debt instrument is determined to have low credit risk if i) it has a low risk of default, ii) the borrower has a strong capacity to meet its contractual cash flow obligations in the near term and iii) adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow obligations. The Group considers a debt instrument to have low credit risk when it has an internal or external credit rating of 'investment grade' as per globally understood definitions.

Significant increase in credit risk (continued)

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

Definition of default

For internal credit risk management, the Group considers an event of default occurs when information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group).

Irrespective of the above, the Group considers that default has occurred when the instrument is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

Credit-impaired financial assets

A financial asset is credit-impaired when one or more events of default that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- (a) significant financial difficulty of the issuer or the borrower;
- (b) a breach of contract, such as a default or past due event;
- (c) the lender(s) of the borrower, for economic or contractual reasons relating to the borrower's financial difficulty, having granted to the borrower a concession(s) that the lender(s) would not otherwise consider;
- (d) it is becoming probable that the borrower will enter bankruptcy or other financial reorganisation; or
- (e) the disappearance of an active market for that financial asset because of financial difficulties.

The Group writes off a financial asset when there is information indicating that the counterparty is in severe financial difficulty and there is no realistic prospect of recovery, for example, when the counterparty has been placed under liquidation or has entered into bankruptcy proceedings, or in the case of trade receivables, when the amounts are over one year past due, whichever occurs sooner. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. A write-off constitutes a derecognition event. Any subsequent recoveries are recognised in profit or loss.

Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward-looking information. Estimation of ECL reflects an unbiased and probability-weighted amount that is determined with the respective risks of default occurring as the weights.

Generally, ECL is the difference between all contractual cash flows that are due to the Group in accordance with the contract and the cash flows that the Group expects to receive, discounted at the effective interest rate determined at initial recognition.

Interest income is calculated based on the gross carrying amount of the financial asset unless the financial asset is credit impaired, in which case interest income is calculated based on amortised cost of the financial asset.

Derecognition of financial assets

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expires, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity.

On derecognition of a financial asset in its entirety, the difference between the asset's carrying amount and the sum of the consideration received and receivable is recognised in profit or loss.

Classification as debt or equity

Debt and equity instruments issued by a Group entity are classified as either financial liabilities or as equity in accordance with the substance of the contractual arrangements and the definition of a financial liability and an equity instrument.

Equity instruments

An equity instrument is any contract that evidences a residual interest in the assets of an entity after deducting all of its liabilities. Equity instruments issued by the Company are recognised at the proceeds received, net of direct issue costs.

Repurchase of the Company's own equity instruments is recognised and deducted directly in equity. No gain or loss is recognised in profit or loss on the purchase, sale, issue or cancellation of the Company's own equity instruments.

Financial liabilities

All financial liabilities are subsequently measured at amortised cost using the effective interest method or at FVTPL.

Financial liabilities at amortised cost

Financial liabilities including bank borrowings, trade and other payables, amount due to a joint venture and amount due to a non-controlling shareholder of subsidiaries are subsequently measured at amortised cost, using the effective interest method.

Derecognition of financial liabilities

The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable is recognised in profit or loss.

(I) Trade and other payables

Trade and other payables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method. Trade and other payables are classified as current liabilities unless payment is not due within 12 months after the reporting period.

(m) Inventories

Inventories are stated at the lower of cost and net realisable value. Costs of inventories are calculated using the weighted average method. Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale.

(n) Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets until such time as the assets are substantially ready for their intended use or sale.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

(o) Government grants

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received.

Government grants are recognised in profit or loss on a systematic basis over the periods in which the Group recognises as expenses the related costs for which the grants are intended to compensate. Specifically, government grants whose primary condition is that the Group should purchase, construct or otherwise acquire non-current assets are recognised as deferred income in the consolidated statement of financial position and transferred to profit or loss on a systematic and rational basis over the useful lives of the related assets.

Government grants that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable.

(o) 政府補助

政府補助金不予確認,直至有合理 保證本集團將遵守其所附條件並將 收到補助金。

政府補助於本集團確認該等補助擬 補償之有關成本為開支之期間內按 有系統基準於損益確認。具體而言, 主要條件要求本集團應購買、興建 或以其他方式收購非流動資產的政 府補助,於綜合財務狀況表中確認 為遞延收入,並有系統及合乎情理 地,於相關資產使用年期內轉撥至 損益。

作為補償已產生有關開支或虧損, 或作為向本集團提供即時財務援助 (並無日後相關成本)之政府補助 金,乃於其成為可收取之期間於損 益確認。

(p) Short-term employee benefits

Short-term employee benefits are recognised at the undiscounted amount of the benefits expected to be paid as and when employees render the services. All short-term employee benefits are recognised as an expense unless another HKFRS requires or permits the inclusion of the benefit in the cost of an asset. A liability is recognised for benefits accruing to employees (such as wages and salaries and annual leave) after deducting any amount already paid.

(q) Retirement benefit costs

Payments to defined contribution retirement benefit plans are recognised as an expense when employees have rendered service entitling them to the contributions.

(r) Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker ("CODM"). The CODM, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the chief executive of the Company that makes strategic decisions.

(s) Trade and other receivables

Trade and other receivables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less provision for impairment. Trade and other receivables are generally due for settlement within 30 days and therefore are all classified as current.

(t) Cash and cash equivalents

For the purpose of presentation in the consolidated statement of cash flows, cash and cash equivalents include cash on hand and deposits held at call with financial instruments and short-term bank deposits with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

(s) 應收賬款及其他應收款項 應收賬款及其他應收款項初步按公 平價值確認,其後採用實際利率法 按攤銷成本,並扣除減值撥備計算。 應收賬款及其他應收款項一般於三十 日內到期結算,並因而全部分類為 流動。

(u) Share capital

Ordinary shares are classified as equity. Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

(v) Borrowings

Borrowings are initially recognised at fair value, net of transaction costs incurred. Borrowings are subsequently measured at amortised cost. Any difference between the proceeds (net of transaction costs) and the redemption amount is recognised in profit or loss over the period of the borrowings using the effective interest method. Fees paid on the establishment of loan facilities are recognised as transaction costs of the loan to the extent that it is probable that some or all of the facility will be drawn down. In this case, the fee is deferred until the draw-down occurs.

To the extent there is no evidence that it is probable that some or all of the facility will be drawn down, the fee is capitalised as a prepayment for liquidity services and amortised over the period of the facility to which it relates.

Borrowings are removed from the statement of financial position when the obligation specified in the contract is discharged, cancelled or expired. The difference between the carrying amount of a financial liability that has been extinguished or transferred to another party and the consideration paid, including any non-cash assets transferred or liabilities assumed, is recognised in profit or loss as finance costs.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the reporting period.

(w) Interest income

Interest income is recognised on a time-proportion basis using the effective interest method.

(x) Dividend distribution

Provision is made for the amount of any dividend declared, being appropriately authorised and no longer at the discretion of the entity, on or before the end of the reporting period but not distributed at the end of the reporting period.

3. Critical accounting estimates and judgements

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

Significant estimates and assumptions concerning the future may be required in selecting and applying accounting methods and policies in these financial statements. The Group bases its estimates and assumptions on historical experience and various other assumptions that it believes are reasonable under the circumstances. Actual results may differ from these estimates or assumptions.

The following is a review of the more significant estimates and assumptions used in the preparation of these financial statements.

(a) Recognition of deferred tax assets for carried forward tax losses

At 31 December 2021, the Group had unused tax losses of approximately RMB651,728,000 (2020: RMB589,649,000) available for offset against future profits. For the year ended 31 December 2020, no deferred tax asset has been recognised in respect of tax losses due to unpredictability of future profit streams of relevant entities. For the year ended 31 December 2021, the group reviewed previously unrecognised tax losses and determined that it was now probable that taxable profits will be available against which the tax losses can be utilised. As a consequence, a deferred tax asset of RMB4,000,000 was recognised for these losses.

The realisation of the deferred tax asset mainly depends on whether sufficient future assessable profits or taxable temporary differences will be available in the future. In cases where the estimated future assessable profits or taxable temporary difference are more than previously estimated, a material recognition of deferred tax assets may arise, which would be recognised in profit or loss for the period in which the revised estimate takes place. 3. 關鍵會計估計及判斷 根據過往經驗及其他因素,包括在有關情 況下相信為合理之對未來事件之預測,估 計和判斷會被持續評估。

The Group uses provision matrix to calculate ECL for trade receivables. The provision rates are based on internal credit ratings/past due status as groupings of various debtors that have similar loss patterns. The provision matrix is based on the Group's historical default rates taking into consideration forward-looking information that is reasonable supportable and available without undue costs or effort. At every reporting date, the historical observed default rates are reassessed and changes in the forward-looking information are considered. In addition, trade receivables with significant balances and credit impaired are assessed for ECL individually.

The provision for ECL is sensitive to changes in estimates. The information about ECL and the Group's trade receivables are disclosed in note 21 and 37 respectively.

Revenue represents the amounts received and receivable for goods sold by the Group to customers, net of discounts and sales related taxes, income from concessionaire sales, service income and rental income during the year, and is analysed as follows:

The Group recognises revenue from the following major sources which arise from contracts with customers:

- For sales of goods, revenue is recognised when control of the goods has been transferred to customers, being at the point the customer purchases goods at department stores. Payment of transaction price is due immediately at the point the customer purchases the goods.
- Income from concessionaire sales is generated from sales of goods by the relevant concessionaires based on certain percentage of sales in accordance with the terms of contracts. When the concessionaires fail to meet the minimum guarantee income in accordance with the terms of contracts, the minimum guarantee amount is recognised as income. The Group recognised revenue in the net amount of consideration to which the Group will be entitled in exchange for the service, which is the commission it is entitled upon the sale of goods by the concessionaire. The concessionaire simultaneously receives and consumes the benefits of the Group's performance in processing each sales transaction as and when each transaction is processed.
- Service income is generated from the Group's promotion, product display and billboards services at its department stores. Such services are recognised as a performance obligation satisfied over time.
- Rental income is recognised on a time proportion basis over the lease terms.

5 **Segment information**

The Group's operating activities are attributable to a single operating segment under HKFRS 8 "Operating Segments" focusing on operation of department stores, retailing and related business as well as property investment in the PRC. This operating segment has been identified on the basis of internal management reports prepared in accordance with accounting policies conform to HKFRSs as disclosed in note 2, that are regularly reviewed by the chief operating decision maker ("CODM") (i.e. the chief executive of the Company). The CODM regularly reviews revenue analysis and the profit for the year of the Group as a whole to make decisions about resource allocation. Accordingly, no separate segment information other than entity-wide information is presented.

The Group's non-current assets are all based in the PRC. The Group has no customers that contributed over 10% of the total revenue of

the Group for both years.

Beiren Group

The principal activities of the Beiren Group are the operation of department stores and supermarkets in the PRC. It was also engaged in auto trading business and sales were made to three PRC companies ("the Debtors") in prior years. The ultimate beneficial owner of the Debtors has provided personal guarantees over the Debtors' outstanding amounts owing to the Beiren Group (the "Guarantor"). During the year ended 31 December 2019, the Debtors defaulted on settlement of trade balances due to the Beiren Group ("Trade Receivables") and the Beiren Group has ceased trading with the Debtors and the entire auto trading business since July 2019. Legal actions have been taken by the Beiren Group to recover the outstanding Trade Receivables.

Meanwhile, the Group became aware from public sources that the Guarantor has been detained by the relevant local authority in Hebei province in relation to alleged illegal activities in one of his businesses. Based on public notices issued by the local authority in Hebei, the Group noted that all companies (including the Debtors) and assets which are located in Hebei Province that are directly or indirectly owned by the Guarantor have been seized by the local authority pending further investigations.

For the year ended 31 December 2019, after obtaining an understanding from management of the Beiren Group in respect of the actions taken to recover the Trade Receivables from the Debtors and taking into consideration advices from the Group's external legal advisers, the Group had concluded the likelihood of recovering any amount from the Debtors or the Guarantor as remote and made a loss allowance of expected credit loss, net of deferred tax credit, against the full amount of overdue Trade Receivables due from the Debtors ("Full Impairment") for the purpose of recognising the share of results of the Beiren Group as at 31 December 2019.

The impact of this Full Impairment on the Group's share of losses of associates, loss attributable to owners and loss attributable to noncontrolling interests for the year ended 31 December 2019 amounted to RMB812.4 million, RMB487.4 million and RMB325.0 million respectively, while its impact on the Group's carrying value of the investments in associates, equity attributable to owners of the Company and the non- controlling interests as at that date amounted to RMB812.4 million, RMB487.4 million and RMB325.0 million respectively.

To date, the Group understood from management of the Beiren Group that there has not been any progress made regarding their legal actions taken against the Debtors as the criminal case against the Guarantor taken by the relevant authority is still pending. Management of the Beiren Group has been maintaining regular contact with the relevant local authority regularly to follow up the development of the case against the Debtors, however, there has not been any concrete reply from the authority. The Guarantor was still being detained by the relevant local authority and there has been no additional information or development in relation to the recoverability of the Trade Receivables due from the Debtors. As such, there has not been any progress made in terms of recovering the outstanding trade receivables nor able to obtain any further financial information of the Debtors and the Guarantor. As at 31 December 2021, the Group considered that the Full Impairment remained the best estimate based on the information currently available.

The Group manages its capital to ensure that entities in the Group will be able to continue as a going concern while maximising the return to stakeholders through the optimisation of the debt and equity balance. The Group's overall strategy remains unchanged from prior year.

The capital structure of the Group consists of bank borrowings, net of cash and cash equivalents and equity attributable to owners of the Company, comprising issued share capital, reserves and retained profits.

The directors of the Company review the capital structure on a regular basis. As part of this review, the directors of the Company consider the cost of capital and the risks associated with each class of capital. Based on recommendations of the directors of the Company, the Group will balance its overall capital structure through the payment of dividends, new share issues and share buybacks as well as the issue of new debt or the redemption of existing debt.

As part of the Group's credit risk management, the Group performs impairment assessment under ECL model upon application of HKFRS 9. The Group assessed the 12-month ECL for other receivables individually as at 31 December 2021 and 2020 and considered that impairment allowance on other receivables (not credit impaired) to be insignificant and thus negligible to be provided by the Group based on the low probability of default on those counterparties based on historical credit loss experience. The Group has no significant concentration of credit risk in relation to trade and other receivables, with exposure spread over a number of counterparties and customers.

The Group has concentration of credit risk in respect of the amounts due from associates. The Group monitors the credibility of associates continuously. After taking into account of their financial position, past experience and other factors, the Group considers the risks associated with amounts due from associates are minimal.

Liquidity risk

In management of the liquidity risk, the Group monitors and maintains a level of cash and cash equivalents deemed adequate by the management to finance the Group's operations and mitigate the effects of fluctuations in cash flows. The management monitors the utilisation of bank borrowings and ensures compliance with loan covenants.

The Group relies on bank borrowings as a significant source of liquidity. As at 31 December 2021 and 2020, the Group had no unutilised borrowing facilities. Details of bank borrowings are set out in note 28.

Based on the above, the management of the Company considers the Group does not have any significant liquidity risk and it will be able to meet its financial obligations as they fall due in the foreseeable future.

44 Subsequent events

Following the resurgence of COVID-19 infections in certain parts of China in the second half of the year, a series of precautionary and control measures have been and continued to be implemented across the country, including certain level of restrictions and controls over the travelling of people and traffic arrangements, quarantine of certain residents, heightening of hygiene and epidemic prevention requirements in factories and offices and encouraged social distancing. It remains uncertain when the COVID-19 pandemic will be completely brought under control in both China and the rest of the world. At this point in time, the Group is not yet able to quantify the possible financial impact of the COVID-19 pandemic. The management of the Group will pay close attention to the development of the COVID-19 pandemic and perform further assessment of its financial impact.

The COVID-19 pandemic is a non-adjusting event after the financial year end and does not result in any adjustments to the consolidated financial statements for the year ended 31 December 2021.
