## 公司簡介 COMPANY PROFILE

農夫山泉股份有限公司成立於1996年，為中國包裝飲用水及飲料的龍頭企業。我們的產品主要覆蓋包裝飲用水、茶飲料、功能飲料及果汁飲料等類別。本公司於2001年6月從有限責任公司整體變更為股份有限公司，並於2020年9月在香港聯交所主板上市（股份代號：9633.HK）。

我們秉持「天然、健康」的產品理念，堅持使用優質原料。我們的包裝飲用水全部源自優質天然水源，含天然的礦物元素。我們擁有領先的裝備水平、製造能力、強大的供應鏈管理能力和嚴格的質量保障體系。

我們建立了包裝飲用水和飲料的雙引擎發展格局，擁有覆蓋各省市及縣級行政區域的全國性銷售網絡。我們實行多品牌戰略，具有長遠的品牌規劃和強大的品牌傳播能力，鑄就了中國軟飲料的超級品牌。

Established in 1996, Nongfu Springs Co., Ltd. is a leader in the packaged drinking water and beverage industry in the PRC. Our major products include packaged drinking water, tea beverage, functional beverage and juice beverage. The Company was transformed from a limited liability company into a joint stock company with limited liabilities in June 2001 and listed on the Main Board of the Hong Kong Stock Exchange in September 2020 (stock code: 9633. HK).

We believe in offering natural and healthy products and insist on using high quality raw materials. All of our packaged drinking water products are sourced from quality natural water sources containing natural mineral elements. We possess industry-leading equipment, manufacturing capabilities, strong supply chain management capabilities and rigorous quality assurance systems.

We have established dual growth engines, packaged drinking water and beverage and set up a nationwide sales network covering all provinces, municipalities and prefecture-level administrative divisions across China. We implement a multi-brand strategy, have long-term visions for our brands and strong brand communication capabilities, and have built a super brand in the PRC soft beverage market.

## 董事長致辭 CHAIRMAN'S STATEMENT

尊敬的各位股東：

2021年，中國疫情防控統籌和經濟發展戰略持續促進消費秩序穩定和發展，本集團經營情況亦得到改善，農夫山泉在廣大員工、經銷商、合作夥伴的精誠團結和努力下迎來新的增長。

2021年本集團錄得總收益人民幣29,696百萬元，比2020年增長29.8%。且本集團盈利能力繼續提升，2021年本集團母公司擁有人應佔利潤由2020年的人民幣5,277百萬元進一步增加至人民幣7,162百萬元(扣除一次性與經營無關的損益後為人民幣7,269百萬元)。同時，本集團營運資金狀況持續穩健，2021年的經營活動現金流同比2020年增加35.2%至人民幣11,400百萬元。

基於本集團2021年的經營情況，考慮本集團的盈餘、整體財務狀況、以及資本支出等，董事會將於本公司即將舉行的年度股東大會中建議派發截至2021年12月31日止年度末期現金股息每股人民幣0.45元(共計股息人民幣約5,061百萬元)。

2021年，農夫山泉成立滿25週年。從僅千島湖一個水源地發展到全國十一大水源地，從單一飲用水產品發展為多品類、多品牌的飲料企業，筭路藍縷、風雨兼程，我們對天然和健康的堅守從未改變。未來，我們將繼續貫徹包裝飲用水和飲料雙引擎發展的戰略，突破創新，推出更多優質產品，以滿足消費者的期待。

Dear shareholders,

In 2021, the epidemic prevention and control strategy and economic development strategy in the PRC continued to promote the stability and development of the consumption order. The operation of the Group has also improved, and Nongfu Spring has witnessed new growth with the sincere unity and efforts of our employees, distributors and partners.

The Group recorded a total revenue of RMB29,696 million in 2021, representing an increase of 29.8% as compared to 2020. The profitability of the Group also kept improving. Profit attributable to the owners of the parent in 2021 recorded further increase from RMB5,277 million in 2020 to RMB7,162 million (RMB7,269 million after excluding one-time non-operating gains and losses). Meanwhile, the working capital level of the Group remained stable, and cash flow from operating activities in 2021 increased by 35.2% as compared to 2020, to RMB11,400 million.

In light of the Group's operations in 2021 and taking into account earnings, overall financial condition and capital expenditures of the Group, the Board will recommend the distribution of a cash dividend of RMB0.45 per share for the year ended December 31, 2021 at the forthcoming annual general meeting of the Company (amounting to a total dividend of approximately RMB5,061 million).

In 2021, Nongfu Spring celebrated its 25th anniversary. From a sole water source of Thousand-Island Lake to eleven major water sources all over the country, from a sole drinking water product to a multi-category and multi-brand beverage enterprise, through years of enduring great hardships in pioneer work, after weathering rain and shine, we have never changed our commitment to natural and healthy products. In the future, we will continue to implement the strategy of dual growth engines with packaged drinking water and beverages, achieve breakthroughs in innovation, and launch more high-quality products to meet the expectations of consumers.

# MANAGEMENT DISCUSSION AND ANALYSIS

### 宏觀及行業環境

全球新冠疫情仍在持續，在中國穩中有進的疫情防控和經濟發展戰略下，2021年中國企業生產經營和人民生活秩序總體穩定，此外，政府也推行了一系列擴大和支持消費的政策和措施，中國消費進一步增長並呈現出較強韌性和潛力。

2021年中國國內生產總值(GDP)超114萬億元，同比增長8.1%；社會消費品零售總額超44萬億元，同比增長12.5%。2021年中國飲料行業也恢復了增長，全國飲料產量超183百萬噸，同比增長12%。2021年中國飲料製造業營業收入同比增長13.5%，其中，瓶(罐)裝飲用水製造業同比增長12%，茶飲料及其他軟飲料製造業同比增長12%，果菜汁及果菜汁飲料製造業同比增長近14%，碳酸飲料製造業同比增長19%，含乳飲料和植物蛋白飲料製造業同比增長近11%，固體飲料製造業同比增長近15%。

消費者對飲品的選擇和口感期望越發多元化，對產品成分的健康性、品牌價值觀的共鳴度等要求都在提高，各品牌在日益激烈的市場環境下競相推出新產品，行業競爭更加激烈，這既推進了產品的優化與革新，也促進了飲料市場持續擴容，機遇與挑戰並存。

### MACRO AND INDUSTRY ENVIRONMENT

The global COVID-19 pandemic is still ongoing. Under the steady progress in epidemic prevention and control and economic development strategies in China, the production and operation of Chinese enterprises and the order of people's lives were stable as a whole in 2021. In addition, the government has also implemented a series of policies and measures to expand and support consumption, and the consumption in China has grown further and showed strong potential and resilience.

The gross domestic product (GDP) of China for 2021 exceeded RMB114 trillion, representing a year-on-year increase of 8.1%; the total retail sales of consumer goods exceeded RMB44 trillion, representing a year-on-year increase of 12.5%. The beverage industry in China has also resumed growth in 2021, with national beverage production exceeding 183 million tonnes, representing a year-on-year increase of 12%. In 2021, the operating revenue of the beverage manufacturing industry in China showed a year-on-year increase of 13.5%, of which, bottled (canned) drinking water manufacturing showed a year-on-year increase of 12%, tea beverages and other soft drinks manufacturing showed a year-on-year increase of 12%, fruit and vegetable juice and fruit and vegetable juice beverage manufacturing showed a year-on-year increase of nearly 14%, carbonated beverage manufacturing showed a year-on-year increase of 19%, dairy beverage and plant protein beverage manufacturing showed a year-on-year increase of nearly 11%, and solid beverage manufacturing showed a year-on-year increase of nearly 15%.

The consumer's expectations for beverage choices and taste have become increasingly diversified, and their requirements for the healthiness of product ingredients and the resonance of brand values are increasing as well. Various brands are competing to launch new products in an increasingly fierce market environment, bringing forth more intense industry competition. In addition to the promotion of optimization and innovation of products, it also facilitates the continuous expansion of the beverage market, with both opportunities and challenges.

## 業務回顧

隨疫情防控常態化，我們的廣大員工和經銷商、合作夥伴更加精誠團結、密切配合。2021年，本集團錄得全年收益人民幣29,696百萬元，較2020年增長29.8%，其中，包裝飲用水產品的收益佔總收益的比例為57.4%，飲料產品的收益佔總收益的比例為40.4%。下表載列本集團於所示期間各產品類別的收益和佔總收益比例明細：

## BUSINESS REVIEW

Under the normalization of epidemic prevention and control, our employees, distributors and partners have become sincerer, united and working more closely. In 2021, the Group recorded annual revenue of RMB29,696 million, representing an increase of 29.8% as compared to 2020. Among which, the proportion of revenue from packaged drinking water products to total revenue was 57.4% and the proportion of revenue from beverage product to total revenue was 40.4%. The following table sets out the breakdown of the Group's revenue and the percentage of total revenue for each product category during the period indicated:

**包裝飲用水產品**

包裝飲用水產品的全年收益為人民幣17,058百萬元，較2020年增長22.1%，佔2021年總收益的57.4%。

2021年農曆新年，我們繼續推出了「牛」年生肖紀念典藏版玻璃瓶裝礦泉水，並以寓意「戰勝疫情、重回美好」的賀歲廣告《耕雲》同消費者一起歡度新春。報告期內我們相繼推出了源自新水源地福建武夷山的「農夫山泉飲用天然山泉水(泡茶用)」(「泡茶水」)和源自吉林長白山原始森林自湧泉群的「農夫山泉長白雪天然雪山礦泉水」(「長白雪」)新品，進一步豐富了飲用水產品線。長白雪的產品標籤設計將長白山的動物以鏤空形式呈現於瓶身，輔以水源生態，使消費者直觀感受到水源與生態的縮影。我們還相應推出了《長白山的第一場雪》和《長白山的秋沙鴨》兩支優美精良的廣告宣傳片，將「長白雪」具有長白山鬆軟雪花味道的產品特質和「什麼樣的水源孕育什麼樣的生命」的品牌價值觀進一步傳達給消費者。

**Packaged drinking water products**

The revenue of packaged drinking water products in 2021 was RMB17,058 million, representing an increase of 22.1% as compared to 2020 and accounting for 57.4% of our total revenue for the year.

During the Chinese New Year of 2021, we continued our tradition of launching an anniversary edition of zodiac version of natural mineral water (glass bottled) in Chinese year of “Ox”, and presented the Chinese New Year short advertisement film titled “Golden Cows Plow Cloud (《耕雲》)” with the moral of “conquering the pandemic, restoring the prosperity” to celebrate the Chinese New Year together with consumers. During the Reporting Period, we launched new products like “Nongfu Spring drinking natural spring water (for tea brewing) (農夫山泉飲用天然山泉水(泡茶用))”(“Tea brewing water”) Wuyi Mountain, a new water source in Fujian and “Nongfu Spring Changbai Snow natural Jokul mineral water (農夫山泉長白雪天然雪山礦泉水)” (“Changbai Snow”) originated from the artesian springs in the primeval forest of Changbai Mountain in Jilin, further enriching the drinking water product line. The label design of Changbai Snow displays the image of animals in Changbai Mountain in hollow form on the bottle, supplemented by the water source ecology, so that consumers can intuitively feel the epitome of water source and ecology. We also correspondingly launched two sophisticated advertising films, “The First Snowflake in Changbai Mountain (《長白山的第一場雪》)” and “Chinese Merganser in Changbai Mountain (《長白山的秋沙鴨》)”, further conveying the product characteristics of “Changbai Snow” with the soft snowflake flavor in Changbai Mountain and the brand value of “what kind of water source gives birth to what kind of life” to the consumers.





### 茶飲料產品

茶飲料產品的全年收益為人民幣4,579百萬元，較2020年增長48.3%，佔2021年總收益的15.4%。2021年年中，「茶π」杯茶入駐部分便利店，實現線上線下同步銷售。面對Z世代觸媒習慣的變化和自信多元的審美，「茶π」找到「無限可能，自成一派」的精神新內核。2021年上半年，「茶π」同中國知名音樂流媒體平台「QQ音樂」合作發起「我們的畢業歌」原創歌曲徵集大賽，並通過參與全國各地高校音樂節，與更多年輕消費者互動。2021年8月，「茶π」聯合主流時尚雜誌打造「茶π新世代」主題活動，引發「茶π」與Z時代的情感共鳴。

2021年是「東方樹葉」茶飲料上市十週年。沿襲2011年「東方樹葉」上市時的東方美學廣告，「東方樹葉」上市十週年宣傳片用場景再現的方式，還原千百年來人們捕捉留住茶香的重要時刻。2021年上半年，我們推出「青柑普洱」和「玄米茶」兩款新口味，十年如一日地堅持用科技還原自然本味。中秋節期間，我們進一步推出首款季節限定產品「桂花烏龍」，聯結中國人獨有的東方情感，結合秋冬季消費者飲用暖茶的需求和場景，通過對茶文化和茶產品的探索、研究和創新，讓更多人愛上「東方樹葉」。

### Tea beverage products

The revenue from our tea beverage products in 2021 was RMB4,579 million, representing an increase of 48.3% as compared to 2020, accounting for 15.4% of the total revenue for the year. In mid-2021, “Tea π” in cups became available in some convenience stores for simultaneous online and offline sales. Facing the changes in the catalyst habits and the confident and diverse aesthetics of Generation Z, “Tea π” has found a new spiritual core of “infinite possibilities, self-contained faction”. During the first half of 2021, the “Tea π” brand launched the “Our Graduation Songs” original song solicitation contest in cooperation with China’s well-known music streaming platform “QQ Music” and involved in music festivals on camp of colleges across the country, so as to interact with more young consumers. In August 2021, “Tea π” cooperated with mainstream fashion magazines to create the theme event of “Tea π New Generation”, which created the emotional resonance between “Tea π” and the Generation Z.

2021 was the 10th anniversary of the launch of “Oriental Leaf (東方樹葉)”, one of our tea beverage products. As done with Oriental Aesthetics Advertising when “Oriental Leaf (東方樹葉)” was first launched in 2011, the promotional video for the 10th anniversary of the launch of “Oriental Leaf (東方樹葉)” used scene reappearance method to reproduce the happenings at important moments that people have captured the fragrance of tea during thousands of years. During the first half of 2021, we launched two new flavors of products, named “Ganpu Tea (青柑普洱)” and “Brown Rice Tea (玄米茶)”. Persevering for ten years as if it were one day, we use technology to restore the natural original taste. During the Mid-Autumn Festival, we further launched the first seasonal limited product “Osmanthus Oolong (桂花烏龍)”, which connects the unique Chinese oriental sentiments and combines the needs and scenarios of consumers to drink warm tea in autumn and winter. Through exploration, research and innovation of tea culture and tea products, we are striving to make more people to love “Oriental Leaf (東方樹葉)”.





2021年9月，公司推出煥新「打」奶茶產品。該產品承襲了「好味道的奶茶打出來」這一經典產品理念，匹配以全新口味和包裝，含紅茶奶茶、烏龍奶茶和茉莉綠茶三種口味。12月進一步推出冬季限定新口味可可奶茶。「打」奶茶產品由優質茶葉原葉萃取，不添加乳粉、茶粉、香精，憑藉其高質量的原料、先進的工藝和低糖配方，為消費者帶來了全新的高品質奶茶新體驗，一經上市即受到眾多消費者的稱讚和歡迎。

In September 2021, the Company launched the rejuvenated “Mix Milk Tea (打奶茶)” product. This product inherits the classic product concept of “mixing good-tasting milk tea (好味道的奶茶打出來)”, matching with new flavors and packaging, including three flavors of black tea milk tea, oolong milk tea and jasmine green tea. In December, a new flavor of cocoa milk tea limited to winter was launched. The “Mix Milk Tea (打奶茶)” product is extracted from high-quality tea leaves, without adding milk powder, tea powder, or flavor, bringing brand new experience in tasting high-quality milk tea for consumers with its high-quality raw materials, advanced technology and low-sugar formula. The product received praise and welcome from numerous consumers once launched in the market.



**功能飲料產品**

功能飲料產品的全年收益為人民幣3,695百萬元，較2020年增長32.3%，佔2021年總收益的12.4%。

2021年，「尖叫」飲料推出中國首款主打等滲概念的「等滲」系列新品，該產品專為運動科學補水而設計，其滲透壓範圍在250-340mOsmol/L，與人體體液滲透壓相近，能快速補充人體運動後流失的水分、電解質和能量。此次推出的兩款新品分別為海鹽柚子味(含糖)和海鹽青橘味(無糖)，分別適合中高強度運動人群和輕運動、有氧運動人群。「尖叫」亦同步啟用了「尖叫就贏，贏就尖叫」的廣告語，通過推出「足球戰舞」廣告宣傳片和與中國游泳協會各奪冠熱門運動員合作的「運動員流汗篇」宣傳視頻，並與國內第一運動社交平台「KEEP」合作定制「等滲尖叫暴汗課程」，在運動人群市場中獲得了關注和認可。

同時，「維他命水」攜手「草莓音樂節」、「草莓MDSK音樂節」，為音樂愛好者們帶來維生素和能量，進一步提升了品牌在年輕消費者中的知名度。

**Functional beverage products**

The revenue from our functional beverage products in 2021 was RMB3,695 million, representing an increase of 32.3% as compared to 2020, accounting for 12.4% of the total revenue for the year.

In 2021, "Scream (尖叫)" beverage launched new "isotonic 等滲" series, the first kind of sports drink featuring the concept of isotonic in China. This series is specially designed for scientific replenishing water after sports. Its osmotic pressure is in the range of 250-340 mOsmol/L, which is similar to the osmotic pressure of human body fluids. It can quickly replenish the water, electrolytes and energy lost after sports of human body. The new products launched this time included two flavors, sea salt grapefruit flavor (sugar-containing) and sea salt green orange flavor (sugar-free), which are suitable for people after high-intensity exercise and people after light exercise and aerobic sports respectively. By simultaneously promoting the slogan "Scream for win, win to scream (尖叫就贏·贏就尖叫)", through the launch of "Football Dance (足球戰舞)" advertising video and the "Athlete's Sweat (運動員流汗篇)" promotional video in cooperation with hot championship-winning athletes of the Chinese Swimming Association, and the launch of "Isotonic screaming and sweating course (等滲尖叫暴汗課程)" in cooperation with "KEEP", the top one sports social platform in China, "Scream (尖叫)" received attention and recognition among the cohort who love sports.

At the same time, "Vitamin Water" joined hands with the "Strawberry Music Festival" and "Strawberry MDSK Music Festival" to bring vitamins and energy to music lovers, further raising the popularity of the brand among young consumers



### 果汁飲料產品

果汁飲料產品的全年收益為人民幣2,614百萬元，較2020年增長32.2%，佔2021年總收益的8.8%。

我們繼續堅持「好果汁是種出來的」的源頭戰略。2021年，「農夫山泉NFC果汁」與「農夫山泉17.5°鮮果」全年進行聯合推廣、產地溯源，強化農夫山泉果汁的原產地優勢。已擁有18年歷史的「農夫果園」果汁品牌，則通過大包裝「雙聯喜宴裝」，結合節慶場景進行主題推廣，助力旺季銷售，繼續實現品牌提升和增長。「水溶C100」飲料則在2021年推出了西柚汁口味時尚口袋裝，滿足年輕消費者的個性化和便攜化需求，拓寬消費場景。

### 其他產品

其他產品主要包括蘇打水飲料、含氣風味飲料、咖啡飲料、植物酸奶產品等其他飲料產品，及鮮果等農產品。2021年其他產品的全年收益為人民幣1,750百萬元，較2020年增長66.0%，佔2021年總收益的6.0%。

2021年，本集團推出蘇打氣泡水全新系列飲品。產品以無菌生產工藝生產，取水自農夫山泉優質水源地，0糖0卡0脂0山梨酸鉀。農夫山泉蘇打氣泡水以「給夏天打打『汽』」的宣傳廣告語，強調品牌帶給消費者快樂、積極向上的精神價值。

此外，蘇打水產品延續「好水好SODA」的品牌主張，繼續深化品牌天然好水源的概念。農夫山泉鮮果「17.5°」系列鮮果、「炭灸」咖啡、「東北香米」大米等其他產品，在2021年度也各有發展。

### Juice beverage products

The revenue from our juice beverage products in 2021 was RMB2,614 million, representing an increase of 32.2% as compared to 2020, accounting for 8.8% of the total revenue for the year.

We adhere to the source-focused strategy that “Good Juice is Grown” (“好果汁是種出來的”). In 2021, “Nongfu Spring (農夫山泉) NFC juice” and “Nongfu Spring (農夫山泉) 17.5° Fresh Fruit” carried out full-year joint promotion and origin tracing to strengthen the origin advantage of Nongfu Spring Juice. The “Farmer’s Orchard (農夫果園)” juice brand, which has a history of 18 years, has carried out themed promotion in combination with the festival scene through the large-package “Double Wedding Banquet (雙聯喜宴裝)” to help sales in peak seasons and continue to achieve brand promotion and growth. The “Water-soluble C100 (水溶C100)” beverage has launched in a fashionable grapefruit juice-flavored pocket size in 2021 to meet the personalized and portable needs of young consumers and broaden consumption scenarios.

### Other products

Other products primarily include other beverage products such as soda water beverage, sparkling flavored beverage, coffee beverage plant-based yogurts and others, as well as agricultural products such as fresh fruits etc. In 2021, revenue from other products increased by 66.0% to RMB1,750 million as compared to 2020, accounted for 6.0% of our total revenue in 2021.

In 2021, the Group launched brand new sparkling soda water beverages. The product is produced in an aseptic production process, with water drawn from high-quality natural sources and 0 sugar, 0 calories, 0 fat, and 0 potassium sorbate. Using the advertising slogan of “Adding Soda for Summer (給夏天打打『汽』)”, Nongfu Spring sparkling soda water beverages emphasizes the brand’s spiritual value of bringing happiness and positivity to consumers.

In addition, the soda water products continue the brand proposition of “nice water, nice SODA (好水好SODA)”, and continue to deepen the concept of the brand’s natural good water source. Nongfu Spring fresh fruit “17.5°” series, “Tan Bing (炭灸)” coffee, “Northeast fragrant rice (東北香米)” rice and other products have also developed well in 2021.

### 研發與創新

本集團始終力主創新，尋求突破，我們的研發團隊聚焦天然產物及其加工工藝、食品安全與質量，持續研發更貼近消費者需求的產品。

2021年，我們推出了多款創新產品，「農夫山泉泡茶武夷山泉水」、「長白雪」、「東方樹葉」三款新口味（「青柑普洱」、「玄米茶」、「桂花烏龍」）、「打」奶茶、「尖叫」等滲系列新品以及蘇打氣泡水全新系列飲品。其中我們在國內首創「等滲」專業運動飲料新品類，通過科學配方與工藝，建立產品行業標準，樹立運動補水新標杆。等滲飲料是指液體滲透壓與血漿滲透壓類似的飲料，有著水分、電解質、營養素的科學配比，滲透壓在250-340mOsmol/L，此範圍與人體的體液滲透壓相近，更有利於人體快速吸收和補充水分。而我們的蘇打氣泡水系列飲品也通過技術創新，在不添加防腐劑的情況下達到9個月保質期。

### 信息系統建設

匹配本集團業務戰略發展和佈局，我們2021年持續升級行銷數字化系統，並上線了生產排程系統和倉庫管理系統，同時優化應用架構、技術架構、數據架構，實現信息系統功能可複用性和高拓展性。

本集團繼續私域流量的建設，鎖定更長期的消費和客流。我們升級新零售運營平台，進一步優化平台，重塑消費者的消費體驗，整合平台數據，通過數據統計、分析、標籤化管理賦能業務，發掘新零售業務潛力。

### Research & Development and Innovation

The Group always strives for innovation and seeks breakthroughs. Our R&D team focuses on natural products and their processing technology, food safety and quality, and continues to develop products that are suitable for consumers' needs.

In 2021, we launched various brand new innovative product series, including “Nongfu Spring drinking natural spring water (for tea brewing) (農夫山泉泡茶武夷山泉水)”, “Changbai Snow (長白雪)”, three new flavors of “Oriental Leaf (東方樹葉)” (Ganpu Tea (青柑普洱)”, “Brown Rice Tea (玄米茶)”, “Osmanthus Oolong (桂花烏龍)”, “Mix Milk Tea” (打奶茶), “Scream (尖叫)” of the new isotonic (等滲) series and sparkling soda water beverages. Among which, we pioneered a new category of “isotonic” (等滲) professional sports drinks in China. Scientific formulas and crafts enable us to establish product industry standards and set a new benchmark for sports hydration. Isotonic beverage refers to beverages with osmotic pressure similar to the osmotic pressure of plasma, scientific ratio of water, electrolytes and nutrients. Its osmotic pressure is in the range of 250-340mOsmol/L, which is approximate to the osmotic pressure of human body fluids, allowing the human body to replenish water in a more efficient manner. Our sparkling soda water beverages series has also realized technology innovation, achieving a 9-month shelf life without adding preservatives.

### Information system buildup

In 2021, to support the strategic development and goals of the Group, we continued to upgrade our digitized marketing system, and launched the production scheduling system and warehouse management system online. Meanwhile, by optimizing the frameworks for application, technology and data, we have achieved high reusability and scalability in terms of information system functions.

The Group continued the construction of private domain traffic and aimed at longer-term consumption and customer flow. We have upgraded the new retail operation platform, further optimized the platform, reshaped the consumer experience, integrated platform data, empowered business through data statistics, analysis, and label management, and explored the potential of new retail business.



## 財務回顧

如下財務業績摘錄於本集團於報告期間按照國際財務報告準則編製之財務報告：

### 收益及毛利

隨疫情防控常態化，通過廣大員工和經銷商、合作夥伴的精誠團結和努力，2021年本集團錄得收益人民幣29,696百萬元，較2020年的人民幣22,877百萬元增加29.8%。2021年本集團毛利為人民幣17,656百萬元，較2020年的人民幣13,508百萬元增加30.7%。2021年本集團毛利率為59.5%，與2020年的59.0%基本持平。

### 銷售及分銷開支

2021年本集團的銷售及分銷開支為人民幣7,233百萬元，較2020年的人民幣5,511百萬元增加31.2%。2021年本集團的銷售及分銷開支佔總收益的24.4%，與2020年的24.1%基本持平。

### 行政開支

2021年本集團的行政開支為人民幣1,751百萬元，較2020年的人民幣1,324百萬元增加32.3%。2021年本集團的行政開支佔我們總收益的5.9%，較2020年的5.8%基本持平。

### 其他開支

2021年本集團其他開支為人民幣139百萬元，佔我們總收益的0.5%，主要為募集資金獲得的外幣帶來的匯兌損失。2021年度匯兌損失約人民幣117百萬元。截至2021年12月31日，本集團持有港幣1,485百萬、美元491百萬以及少量其他外幣，比2020年12月31日持有港幣1,537百萬、美元563百萬及少量其他外幣，略有減少。

### 財務費用

2021年本集團借貸利率小幅下降，財務費用由2020年的人民幣79百萬元下降至2021年的人民幣53百萬元。

## FINANCIAL REVIEW

The following financial results are extracted from the financial report of the Group prepared in accordance with the IFRS during the Reporting Period:

### Revenue and Gross Profit

With the normalization of epidemic prevention and control, through the sincere unity and efforts of the employees, distributors and partners, the Group recorded a revenue of RMB29,696 million in 2021, representing an increase of 29.8% as compared with RMB22,877 million in 2020. In 2021, gross profit of the Group was RMB17,656 million, representing an increase of 30.7% as compared with RMB13,508 million in 2020. In 2021, gross profit margin of the Group was 59.5%, essentially maintaining at the level of 59.0% in 2020.

### Selling and Distribution Expenses

In 2021, sales and distribution expenses of the Group were RMB7,233 million, representing an increase of 31.2% as compared with RMB5,511 million in 2020. In 2021, sales and distribution expenses of the Group accounted for 24.4% of the total revenue, essentially maintaining at the level of 24.1% in 2020.

### Administrative Expenses

In 2021, administrative expenses of the Group were RMB1,751 million, representing an increase of 32.3% as compared with RMB1,324 million in 2020. In 2021, administrative expenses of the Group accounted for 5.9% of our total revenue, essentially maintaining at the level of 5.8% in 2020.

### Other Expenses

Other expenses of the Group in 2021 were RMB139 million, accounting for 0.5% of the total revenue, mainly representing the exchange losses caused by the foreign currencies obtained from funds raising. In 2021, the exchange losses of the Group were RMB117 million. As of December 31, 2021, the Group held HK\$1,485 million, US\$491 million and a small amount of other foreign currencies, representing a slight decrease as compared with the HK\$1,537 million, US\$563 million and a small amount of other foreign currencies held in December 31, 2020.

### Finance Costs

In 2021, the borrowing rate of the Group decreased slightly. The finance costs decreased from RMB79 million in 2020 to RMB53 million in 2021.

### 年內利潤

基於以上變動，本集團的年內利潤由2020年的人民幣5,277百萬元增加35.7%至2021年的人民幣7,162百萬元。

### 股息

基於本集團2021年整體績效表現，考慮集團盈餘、整體財務狀況、以及資本支出等，董事會將於本公司即將舉行之年度股東大會中建議派發截至2021年12月31日止年度末期現金股息每股人民幣0.45元(含稅，共計股息人民幣約5,061百萬元)。

### 長期銀行定期存款、質押存款、現金及銀行結餘及借款

於2021年12月31日，本集團的長期銀行定期存款、質押存款及現金及銀行結餘總額為人民幣15,909百萬元，較2020年12月31日的人民幣9,119百萬元提升74.5%。本集團於2021年12月31日的授信總額度為人民幣11,545百萬元，計息借貸為人民幣2,500百萬元，較2020年12月31日的人民幣2,414百萬元提升3.6%，到期償還總金額人民幣2,914百萬元。所有借款均以人民幣計值。截至2021年12月31日的借款總額中，按固定利率收取的借款金額為人民幣200百萬(不含銀行承兌匯票貼現)。本集團並無實施任何利率對沖政策。

### 存貨

本集團的存貨由2020年12月31日的人民幣1,805百萬元增加0.2%至2021年12月31日的人民幣1,809百萬元。由於銷售的增長帶動存貨的周轉，存貨周轉天數由2020年的69.5天減少至2021年的54.8天。

### 貿易應收款項及應收票據

本集團的貿易應收款項及應收票據由2020年12月31日的人民幣358百萬元增加至2021年12月31日的人民幣476百萬元。貿易應收款項及應收票據周轉天數從2020年的5.3天減少至2021年的5.1天。

### Profit for the Year

As a result of the aforementioned changes, profit of the Group for the year increased by 35.7% from RMB5,277 million in 2020 to RMB7,162 million in 2021.

### Dividends

Having accounted for, including but not limited to, the Group's overall performance, surplus, overall financial condition, capital expenditures in 2021, the Board proposed to declare a final cash dividend of RMB0.45 per share (inclusive of tax, amounting to a total dividend of approximately RMB5,061 million) for the year ended December 31, 2021 at the forthcoming annual general meeting of the Company.

### Balances of Long-term Bank Deposits, Pledged Deposits and Cash and Bank Balances and Borrowings

As of December 31, 2021, the sum of long-term bank deposits, pledged deposits and cash and bank balances of the Group amounted to RMB15,909 million, representing an increase of 74.5% as compared with RMB9,119 million as of December 31, 2020. The total credit facility of the Group was RMB11,545 million and interest-bearing borrowings amounted to RMB2,500 million as of December 31, 2021, representing an increase of 3.6% as compared with RMB2,414 million as of December 31, 2020, with due repayment of a total amount of RMB2,914 million. All of the borrowings are denominated in RMB. Among the total borrowings as of December 31, 2021, the borrowings of RMB200 million were charged at a fixed interest rate (not including discounted bank acceptances). The Group does not have any interest rate hedging policy.

### Inventories

Inventories of the Group increased by 0.2% from RMB1,805 million as at December 31, 2020 to RMB1,809 million as at December 31, 2021. Due to inventory turnover driven by growth in sales, inventory turnover days decreased from 69.5 days in 2020 to 54.8 days in 2021.

### Trade and Bills Receivables

Trade and bills receivables of the Group increased from RMB358 million as of December 31, 2020 to RMB476 million as of December 31, 2021. The turnover days of trade receivables and bills receivable decreased from 5.3 days in 2020 to 5.1 days in 2021.



#### 貿易應付款項及應付票據

本集團的貿易應付款項及應付票據由2020年12月31日的人民幣882百萬元增加至2021年12月31日的人民幣1,153百萬元。貿易應付款項與應付票據周轉天數從2020年的32.6天減少至2021年的30.8天。

#### Trade and Bills Payables

Trade and bills payables of the Group increased from RMB882 million as of December 31, 2020 to RMB1,153 million as of December 31, 2021. The turnover days of trade payables and bills payable decreased from 32.6 days in 2020 to 30.8 days in 2021.

#### 資本負債比率

於2021年12月31日，本集團資本負債比率（等於（計息借貸+租賃負債）／權益）為12.5%（報告期內本集團無少數股東權益），比2020年12月31日本集團的資本負債比率15.9%有所下降，這主要由於2021年本集團計息借貸增長低於同期權益的增長速度。

#### Gearing Ratio

As at December 31, 2021, the gearing ratio of the Group (equaling (interest-bearing borrowings + lease liabilities)/equity) was 12.5% (during the Reporting Period, the Group has no minority equity), representing a decrease as compared with the gearing ratio of the Group as at December 31, 2020 being 15.9%, mainly due to the growth in interest-bearing borrowings of the Group in 2021 lower than that of the equity in the same period.

#### 庫務政策

本集團針對其庫務政策採取審慎的財務管理方法，確保本集團的資產、負債及其他承擔的流動資金構架始終能夠滿足其資金需求。

#### Treasury Policy

The Group adopts a prudent financial management approach for its treasury policy to ensure that the Group's liquidity structure comprising assets, liabilities and other commitments is able to always meet its capital requirements.

#### 報告期後重大事項

經2022年1月14日召開的臨時股東大會審議通過，本公司已採納員工股權激勵計劃（「員工股權激勵計劃」），員工股權激勵計劃詳情請見本年報「管理層討論及分析－人力資源與酬金政策」部分。

#### MATERIAL EVENTS AFTER THE REPORTING PERIOD

As approved in the extraordinary general meeting held in January 14, 2022, the Company has adopted an employee share incentive scheme (the "Employee Share Incentive Scheme"). For details of the Employee Share Incentive Scheme, please refer to "Management Discussion and Analysis – Human Resources and Remuneration Policy" in this announcement.

於2022年3月28日，根據員工股權激勵計劃，本公司向107名本集團合資格僱員及1名養生堂人士分別授出對應本集團6,596,800股及39,600股H股的激勵份額，彼等對本集團之業務表現作出重大貢獻，並在本集團未來發展上擔當重要角色。

On 28 March 2022, pursuant to the Employee Share Incentive Scheme, the Company granted awards that representing 6,596,800 and 39,600 underlying H Shares of the Company, respectively, to 107 eligible employees of the Group and one individual of Yangshengtang who have made significant contributions to the Group's business performance, and play an important role in the Group's future development.

### 外匯風險

截至2021年12月31日，本集團持有港幣1,485百萬、美元491百萬以及少量其他外幣。截至本報告日期，美元和港幣匯率均有所下降，需關注外匯市場進一步動向。本集團會密切監察我們的外匯風險，並會在有需要時通過適當金融工具做對沖用途，以助降低外匯風險。

### 或有負債

截至2021年12月31日，本集團無任何重大或有負債。

### 資本承諾

於2021年12月31日，本集團的資本承諾約為人民幣2,146百萬元，主要用於建設生產廠房、購置生產設備。

### 資產抵押

於2021年12月31日，本集團已抵押銀行存款人民幣3.6百萬元(2020年12月31日：零)。

### 重大投資、重大收購及出售事項

於報告期內本集團並無持有任何重大投資，亦無任何有關附屬公司、聯營公司及合營企業的重大收購或出售事項。

### 未來重大投資或資本資產計劃

於最後可行日期，除招股書披露的「未來計劃及所得款項用途」外，本集團現時沒有計劃取得其他重大投資或資本資產。

### 持續經營

根據現行財務預測和可動用的融資，本集團在可見未來有足夠財務資源繼續經營。因此在編製財務報告時已採用持續經營基準編製。

### FOREIGN EXCHANGE RISK

As of December 31, 2021, the Group held HK\$1,485 million, US\$491 million and a small amount of other foreign currencies. As of the date of this report, the exchange rates of the U.S. dollar and the Hong Kong dollar have both dropped, and we need to monitor the further trends in the foreign exchange market. The Group will closely monitor our foreign exchange risks and will utilize appropriate financial tools for hedging purposes when necessary to help reduce foreign exchange risks.

### CONTINGENT LIABILITIES

As of December 31, 2021, the Group did not have any significant contingent liabilities.

### CAPITAL COMMITMENTS

Capital commitments of the Group amounted to approximately RMB2,146 million as of December 31, 2021, mainly used for construction of production plants and purchase of production equipment.

### PLEDGE OF ASSETS

As at December 31, 2021, bank deposits of RMB3.6 million (December 31, 2020: nil) were pledged by the Group.

### SIGNIFICANT INVESTMENT, MATERIAL ACQUISITION AND DISPOSAL

The Group did not have any significant investments held, or any material acquisition or disposal of any relevant subsidiaries, associates and joint ventures during the Reporting Period.

### FUTURE PLAN FOR MATERIAL INVESTMENTS OR CAPITAL ASSETS

As of the Latest Practicable Date, save for the “Future Plans and Use of Proceeds” disclosed in the Prospectus, the Group did not have any existing plan for acquiring other material investments or capital assets.

### GOING CONCERN

On the basis of current financial projections and facilities available, the Group has adequate financial resources to continue its operation in the foreseeable future. Accordingly, the financial statements are prepared on a going concern basis.

## 人力資源與酬金政策

於2021年12月31日，本集團員工總人數超過2萬名，2021年度員工福利開支總額（包括董事酬金）為人民幣2,882百萬元。我們始終堅信本集團的長期增長取決於員工的專業知識、能力及發展，我們積極完善人才選拔培養機制，提高員工的整體競爭力和對本集團的歸屬感。本集團的員工薪金及福利水平參考市場以及個人資歷及能力而定，並設立績效獎金等激勵機制。績效獎金會根據本集團達成的收益、利潤等目標以及員工所在組織的績效、員工個人的績效評核發放，並嘉許及鼓勵為本集團業務作出杰出貢獻的組織、員工，整體薪資政策具有競爭力。

為完善公司激勵機制，留住關鍵員工，牽引公司業務的可持續發展等，經2022年1月14日召開的臨時股東大會審議通過，本公司已採納員工股權激勵計劃，以激勵對本集團經營業績和未來發展發揮重要作用的管理人員和核心技術專家，包括(i)本集團的董事、監事和員工；以及(ii)在雙方的項目和合作中對本集團做出重大貢獻的養生堂集團一定數量的員工。董事相信，將上述參與者納入計劃將有助於激發他們的創新和激情，激勵他們更努力地為本集團提供服務，這符合本公司及股東的整體利益。該員工股權激勵計劃將自採納日期起十(10)年期間有效。根據該員工股權激勵計劃，董事會將委託合資格信託管理人作為員工股權激勵計劃的受託人，由其根據董事會的指令通過港股通購買公司H股作為激勵股份來源。受託人在員工股權激勵計劃存續期間根據員工股權激勵計劃可不時獲得和持有的H股最高數量不得超過員工股權激勵計劃採納日本公司已發行股本總額的5%。由於該員工股權激勵計劃不涉及發行新股或授予本公司任何新證券的期權，其並不構成上市規則第十七章所界定及規管的購股權計劃。員工股權激勵計劃詳情請見本公司2021年12月13日刊載於香港聯交所網站(www.hkexnews.hk)和本公司網站(www.nongfuspring.com)的公告。

## HUMAN RESOURCES AND REMUNERATION POLICY

As at December 31, 2021, the total number of employees of the Group exceeded 20,000. In 2021, the total employee benefit expenses (including directors' remuneration) amounted to RMB2,882 million. The Group always believes that our long-term growth depends on the expertise, experience and development of our employees. We proactively optimize the talent selection and cultivation system in order to improve the general competitiveness of our employees and their sense of belongings to the Group. The remuneration and benefits for employees of the Group are determined with reference to the market standards as well as individual qualification and experience, performance bonus and other incentive systems are established. Performance bonuses are paid based on the Group's revenue and profit targets, as well as the performance of the organisation in which the employee works and the performance of the individual employee, and to recognise and encourage outstanding contributions to the Group's business. Our overall remuneration policy is competitive.

In order to improve the Company's incentive mechanism, retain key employees and promote sustainable growth of the Company's performance, as approved in the extraordinary general meeting held in January 14, 2022, the Company has adopted the Employee Share Incentive Scheme to incentivize management personnel and core technical experts, including (i) the Directors, Supervisors and employees of the Group; and (ii) certain number of employees of Yangshengtang Group who make significant contributions to the Group in the projects and cooperations between the Group and Yangshengtang Group, who play an important role in the Group's business performance and future development. The Directors believe that including the participants as mentioned above in the Scheme will help stimulate their innovation and passion, and encourage them to devote more efforts in providing services to the Group, which is in the interests of the Company and Shareholders as a whole. The Employee Share Incentive Scheme will be effective for ten (10) years starting from the adoption date. According to the Employee Share Incentive Scheme, the Board shall entrust a qualified agent to act as the trustee under the Employee Share Incentive Scheme, with the H Shares of the Company it acquired through Hong Kong Stock Connect instructed by the Board as the source of awards. The maximum number of H Shares that the Trustee can acquire and hold from time to time under the Employee Share Incentive Scheme throughout the duration of the Employee Share Incentive Scheme shall not exceed 5% of the total issued share capital of the Company as at the Adoption Date of the Employee Share Incentive Scheme. Since the Employee Share Incentive Scheme involves no issuance of new shares or granting of option for any new securities of the Company, it does not constitute a share option scheme as defined and regulated under Chapter 17 of the Listing Rules. For details of the Employee Share Incentive Scheme, please refer to the announcement of the Company dated December 13, 2021 published on the website of the Stock Exchange (www.hkexnews.hk) and the website of the Company (www.nongfuspring.com).

根據員工股權激勵計劃的規則，本公司董事會於2022年3月28日審議批准了《農夫山泉股份有限公司第一期員工股權激勵計劃管理辦法》和《農夫山泉股份有限公司第一期員工股權激勵計劃授予方案》(以下稱「授予方案」)，並於2022年3月29日(「授予日」)按授予方案對合計108名激勵對象實施了授予(以下稱「本次授予」)。本次授予的授予價格根據員工股權激勵計劃的規定，為授予日前一百二十個香港交易日本公司H股收盤價均值的百分之三十，即每激勵份額13.22港元。本次授予授出的激勵份額對應本公司H股數量為6,636,400股，佔本公司已發行股份總數的0.059%及佔本公司已發行H股的0.1318%。本次授予的108名激勵對象包括本公司監事劉熹悅先生和饒明紅先生，二人各自獲授予的激勵份額對應本公司H股數量為99,000股；1名養生堂集團員工，獲授予激勵份額對應本公司H股數量為39,600股，該名員工在參與養生堂集團向本集團提供IT服務的關連交易項目時，為本集團信息系統建設做出了重大貢獻(有關養生堂集團向本集團提供IT服務的關連交易詳情，請參閱本年報「董事會報告－關連交易」部分)；其餘105名激勵對象全部為本集團員工，且不含本公司的董事、監事、其他關連人士及本公司H股上市前一日(即2020年9月7日)登記於本公司股東名冊的股東。董事會已制訂適當的公司業績考核標準和員工績效考核標準等作為歸屬條件，在滿足歸屬條件的情況下，本次授予的激勵份額將按以下時間表歸屬：

Pursuant to the rules of the Employee Share Incentive Scheme, on March 28, 2022, the Board of the Company considered and approved the “Administrative Measures for the First Tranche of the Employee Share Incentive Scheme of Nongfu Spring Co., Ltd.” (《農夫山泉股份有限公司第一期員工股權激勵計劃管理辦法》) and the “Grant Proposal for the First Tranche of the Employee Share Incentive Scheme of Nongfu Spring Co., Ltd.” (《農夫山泉股份有限公司第一期員工股權激勵計劃授予方案》) (hereinafter referred to as the “Grant Proposal”), grants were made to a total of 108 Scheme Participants according to the Grant Proposal (hereinafter referred to as the “Grant”) on March 29, 2022 (the “Grant Date”). According to the provisions of the Employee Share Incentive Scheme, the grant price for the Grant is 30% of the average closing price of the Company’s H Shares in the 120 Hong Kong trading days immediately prior to the Grant Date, being HK\$13.22 per Awards. The Awards granted in the Grant correspond to 6,636,400 H Shares of the Company, accounting for 0.059% of the total issued shares of the Company and 0.1318% of the issued H Shares of the Company. The 108 Scheme Participants in the Grant include Mr. Liu Xiyue and Mr. Rao Minghong, the Supervisors of the Company. The number of H Shares of the Company underlying the Awards granted to each of them is 99,000. The number of H Shares of the Company underlying the Awards granted to 1 employee of Yangshengtang Group is 39,600. Such employee made significant contributions to the construction of the information system of the Group during the participation in the connected transaction project where Yangshengtang Group provided IT services to the Group (for details of the connected transaction in relation to the provision of IT services by Yangshengtang Group to the Group, please refer to the section headed “Report of The Directors – Connected Transactions” in this annual report). The remaining 105 Scheme Participants are all employees of the Group, excluding the Directors, Supervisors, other connected persons of the Company and shareholders registered in the register of members of the Company on the day before the listing of the Company’s H Shares (being September 7, 2020). The Board has formulated appropriate performance appraisal standards and employee performance appraisal standards of the Company as vesting conditions. Subject to the vesting conditions, the Awards in the Grant will be vested according to the following schedule:

## 環境、社會與管治

環境、社會與管治(下稱「ESG」)是本集團企業管治框架的重要構成部分。本集團在上市之初已建立職責清晰的可持續發展三級管治架構，由董事會全面負責可持續發展相關事宜，並設立公共政策與可持續發展辦公室，以協助董事會識別並監控公司的ESG風險、制定可持續發展戰略、跟踪ESG表現並披露可持續發展相關資訊。各職能部門和附屬公司作為執行層，負責參與和落實業務運營中環境、社會和管治各層面的工作計劃。同時，本集團建立了完善的ESG管理體系，從政策和制度層面為引導和推動公司的可持續發展提供了保障。

2021年，本集團持續管控可持續發展風險，通過與內外部利益相關方溝通，更新了對公司重要的關鍵ESG議題排序，並針對重大性議題提出了相應的目標和願景。我們發布了以《可持續發展政策》為總領的一系列ESG公共政策，全面而完善的政策體系為引導和推動公司的可持續發展提供保障。報告期內，我們根據氣候變化相關財務信息披露工作組(TCFD)指南，對農夫山泉氣候變化風險進行了識別與排序，並將對我們業務運營可能帶來較為顯著影響的氣候變化風險納入風險管理體系之中，採取了一系列減緩和應對措施。

本集團在戰略制定及日常運營管理中貫徹可持續發展理念。我們規範自身行為，以穩健的治理作為企業發展的基石；我們不斷創新，堅守品質，通過優質的產品將天然健康的理念傳遞給每一位消費者；我們充分意識到企業的發展依賴良好的生態環境，致力於將整個價值鏈對環境的影響降到最低；我們深知員工是企業最寶貴的財富，以人為本，努力給員工提供更好的平台；我們積極投身慈善公益事業，回饋社會，給有需要的人帶來溫暖。

## ENVIRONMENT, SOCIAL AND GOVERNANCE

Environment, Social and Governance (ESG) is an important area of our corporate governance framework. The Group has established a three-level governance structure for sustainable development with defined duties since its listing. The Board is fully responsible for sustainability-related matters, and an Office of Public Policy & Sustainable Development has been established to assist the Board in identifying and monitoring the ESG risks of the Company, developing sustainability strategies, tracking the ESG performance and disclosing sustainability-related information. As the execution level, each functional department and subsidiary is responsible for engaging in and implementing the work plans in all aspects of environmental, social and governance in business operations. At the same time, the Group has established a sound ESG management system, which provides a guarantee for guiding and promoting the sustainable development of the Company in terms of the policy and system.

In 2021, the Group continued to manage and control risks related to sustainable development, updated the ranking of key ESG topics of importance to the Company through communication with internal and external stakeholders, and put forward corresponding goals and visions for material topics. We have released a series of public ESG policies with the "Sustainable Development Policy" as the guiding principle, and a comprehensive policy system is in place to provide guarantees to guide and promote the sustainable development of the Company. During the Reporting Period, we identified and ranked the climate change risks of Nongfu Spring according to the guidelines of the Task Force on Climate-related Financial Disclosures (TCFD), and included the climate change risks that may have a significant impact on our business operations into risk management system. A series of mitigation and response measures have been adopted.

The Group practices the concept of sustainable development during strategies formulation and daily operation management. We standardize our own behaviors and take sound governance as the cornerstone of corporate development. We keep making innovations, adhering to quality and convey the concept of natural health to every consumer through high-quality products. We are fully aware that the development of an enterprise depends on a favourable ecosystem environment, and therefore are committed to minimizing the impact of the entire value chain on the environment. We deeply know that employees are the most valuable asset of an enterprise, and we remain people-oriented and strive to provide a better platform for employees. We take active part in charity and public welfare undertakings, and make contributions to the society, with an aim to bring warmth to those in need.

- 在企業管治方面，農夫山泉制定了《農夫山泉員工商業行為準則》、《反貪污政策》、《舉報政策》等政策制度文件，要求我們的全體員工及供應商規範自身行為，共創清正廉潔的企業文化。我們通過主動審計和鼓勵舉報兩種方式確保政策的有效落實，並通過多維度的合規培訓持續提升員工合規意識，為企業的穩健發展打下良好基礎。報告期內，我們商業行為準則簽署和商業行為準則培訓覆蓋的員工佔比均為100%。
- Regarding corporate governance, Nongfu Spring has formulated the policies and system documents such as the “Code of Business Conduct for Employees of Nongfu Spring (《農夫山泉員工商業行為準則》)”, “Anti-Corruption Policy” (《反貪污政策》), and “Whistleblowing Policy” (《舉報政策》), requiring all employees and suppliers to regulate their own behaviors, so as to create a clean and honest corporate culture. We ensure the effective implementation of policies by actively auditing and encouraging whistleblowing, and continue to enhance employees’ compliance awareness through multi-dimensional compliance trainings, laying a solid foundation for the steady development of the Company. During the Reporting Period, percentage of employees covered by our signed Code of Business Conduct and training on the Code of Business Conduct was 100%.
- 在環境保護方面，農夫山泉建立了健全的環境管理體系，農夫山泉及其下屬所有水和飲料生產性工廠已全部獲得ISO 14001認證。在制定了完善的政策和管理制度的基礎上，本集團基於對業務發展情況的分析，分別針對用水強度、綜合能耗強度、碳排放強度和包材可持續制定了可持續發展戰略目標。
- Regarding environmental protection, Nongfu Spring has established a sound environmental management system, and Nongfu Spring and all of its subsidiary water and beverage production factories have obtained ISO 14001 certification. On the basis of formulating sound policies and management systems, the Group has developed strategic sustainability goals for water consumption intensity, comprehensive energy consumption intensity, carbon emission intensity and sustainable packaging materials based on the analysis of business development.
- 對於能源使用及碳排放管理，我們密切關注國家對氣候變化的相關政策及行動計劃，積極探索節能低碳發展新模式，為應對氣候變化貢獻力量。我們訂立了到2030年，綜合能耗強度和碳排放強度較2019年下降20%的目標。基於完備的制度和管理体系，我們從低碳生產、低碳物流、清潔能源使用和綠色辦公四個方面開展工作，降低運營過程中的能源消耗和溫室氣體排放。
- In terms of energy use and carbon emission management, we pay close attention to the relevant national policies and action plans on climate change, and actively explore new development models of energy-saving and low-carbon, so as to make contributions to coping with climate change. We have set a target of reducing comprehensive energy consumption intensity and carbon emission intensity by 20% as compared with 2019 by 2030. Based on a complete system and management system, we conduct works from four aspects: low-carbon production, low-carbon logistics, clean energy use and green office to reduce energy consumption and greenhouse gas emissions during the operations.

- 對於水資源管理，我們以水源地保護和節約水資源為兩大支點，將水資源可持續的理念貫穿整個生產價值鏈中。我們的目標是對比2020年，2030年用水強度下降20%。為此，我們強化節水管理、研發節水技術、改造節水設備，逐年降低用水強度。同時，我們重視水源地周圍的生物多樣性和水源地環境保護，盡可能降低運營活動帶給水源地的影響。
- 對於排放物管理，我們持續投入研發更加高效的廢氣、廢水處理技術，提高排放物管理水平。我們定期對廢氣、廢水等污染物排放濃度檢測，以確保達標排放。我們還積極與多方合作，就減少食物浪費與損失的方法進行研究，積極尋找生產過程中產生的橙渣、茶渣、米渣的再利用方式。
- 對於包裝材料管理，我們持續尋找減少包裝材料使用量及包裝材料循環使用的機會，開展了一系列包材減量化研究。我們加快環保包材替代的腳步，期望於2025年，實現水和飲料塑料包裝100%可回收，同時消除有問題或難以回收的包裝材料。我們積極探索終端包材回收機制，攜手價值鏈推動塑料循環利用，助力循環經濟的發展。
- In terms of water resources management, we practice the concept of sustainable water resources throughout the entire production value chain by means of water source protection and water conservation. Our goal is to reduce water intensity by 20% in 2030 as compared to 2020. To this end, we strengthen water-saving management, develop water-saving technologies, transform water-saving equipment and reduce water use intensity year by year. At the same time, we attach great importance to protecting the biodiversity around the water source and environment of the water source, so as to minimize the impact of the operation activities on the water source.
- In terms of emissions management, we continue to invest in research and development of more efficient waste gas and wastewater treatment technologies to improve emissions management. We conduct regular test on the emission concentration of pollutants such as exhaust gas and waste water to ensure that the discharge meets the standard. We also actively cooperate with various parties to conduct research on ways to reduce food waste and loss, and seek ways to reuse the orange residue, tea residue and rice residue generated in the production process.
- In terms of packaging material management, we continue to seek for opportunities to reduce the amount of packaging materials used and the recycling of packaging materials, and have carried out a series of research on packaging material reduction. We have speeded up the replacement of environmentally friendly packaging materials, with an expectation to achieve 100% recyclable plastic packaging for water and beverages by 2025, while eliminating packaging materials that are unable or difficult to recycle. We actively explored the recycling mechanism of terminal packaging materials, and worked with the value chain to promote the recycling of plastics, so as to contribute to the development of circular economy.



- 在員工方面，農夫山泉秉持「利他、創新、團隊合作、誠信、敬業、激情」的公司價值觀，打造了平等多元、公正包容的企業氛圍。我們重視員工的發展，建立了公平公正的職業發展、內部晉升途徑和資源豐富的能力提升平台。此外，我們加大了職業健康安全的投入，進行安全改革，將每一位員工的安全和健康放在我們的第一位。
- 在產品方面，農夫山泉積極響應國家「三減三健」膳食行動，將消費者的健康作為我們的追求目標，不斷推陳出新，通過天然健康的產品助力健康中國建設。我們建立了全方位、全流程的產品質量保障體系，通過提高檢驗標準，加強質量監察、構建質量文化等方式持續提高質量管理能力。報告期內，農夫山泉及其下屬所有工廠均獲得ISO 9001、ISO 22000（或HACCP）體系認證。
- 在社會方面，農夫山泉堅持傳遞自身價值，帶動供應鏈、行業和社會共同進步。我們通過發布《供應商健康度管理辦法》，提高對供應商社會環境方面的要求，推動行業健康發展；我們通過救助災區、減緩貧困、改善教育、支持公共體育，持續回饋社會，踐行企業社會責任，實現「兼濟天下」的目標。
- Regarding staff employment, Nongfu Spring adheres to the company values of “altruism, innovation, teamwork, integrity, dedication and passion”, to create a corporate atmosphere of equality, diversity, fairness and inclusiveness. We attach great importance to the development of employees, and have established a capacity improvement platform equipped with fair and just career development, internal promotion channels and rich resources. In addition, we have increased investment in occupational health and safety, and carried out safety reforms, by putting the safety and health of every employee as our first priority.
- Regarding products, Nongfu Spring actively responds to the national “Three Reductions & Three Kinds of Health (三減三健)” campaigns, and strives for the health of consumers. We keep putting forth new ideas to contribute to the construction of a healthy China through natural and healthy products. We have established a product quality assurance system that features all-dimensional and covers the whole process. We have enhanced our quality management capability by improving inspection standards, strengthening quality supervision, and building a quality culture. During the Reporting Period, Nongfu Spring and all of its subsidiary factories have obtained ISO 9001, ISO 22000 (or HACCP) system certification.
- Regarding social welfare, Nongfu Spring insists on delivering its own value and drives the common progress of the supply chain, industry and society. We have raised the requirements for social and environment efforts of suppliers by issuing the “Supplier Health Management Measures (《供應商健康度管理辦法》)”, so as to promote the healthy development of the industry. We made continuous efforts in people’s livelihood, poverty alleviation, education and public sports to give back to the society and practice corporate social responsibilities, with an aim to achieve the goal of “contributing to the world”.

二十五年的深度耕耘，成就了農夫山泉如今的企業高度。未來，農夫山泉將持續優化可持續發展治理，積極承擔企業責任，以更寬闊的視野、更長遠的目光持續踐行可持續發展。

## 展望

新冠疫情進入第三年，德爾塔 (Delta)、奧密克戎 (Omicron) 等病毒在全球範圍繼續傳播，新變種病毒也可能出現，這給疫情的持續時間帶來了更多不確定性。自2022年以來，中國部分城市亦面臨新發疫情的考驗，在國家常態化疫情防控總方針之下，局部地區也在適時動態調整防疫措施和力度。此外，俄烏戰爭爆發，國際政治經濟形勢更加複雜。同國際油價具有關聯性的PET等原材料的採購價格顯著上升，包裝物、能源價格也呈現上漲趨勢，給包裝飲用水和飲料生產企業帶來成本上升壓力。我們將繼續以審慎態度，密切關注各方面的影響和變化，動態調整公司運營，積極應對。

## OUTLOOK

The third year of since the outbreak of the COVID-19 pandemic sees the ongoing spread of Delta and Omicron viruses across the world, and possible emergence of new variants, which have brought more uncertainties to the duration of the pandemic. Since 2022, some cities in the PRC have also faced the test of new outbreaks. Under the general national policy of normalised pandemic prevention and control, some areas are also dynamically adjusting pandemic prevention measures and efforts in a timely manner. In addition, the outbreak of the Russian-Ukrainian war has made the international political and economic situation more complicated, reflected by the significant increase in the purchase price of raw materials such as PET, which is linked to the international oil price, and the rising prices of packaging materials and energy. All the above has exerted pressure of increasing costs on the manufacturer of packaged drinking water and beverages. We will continue to adopt a prudent approach, pay close attention to the impact of and changes in all aspects, dynamically adjust the Company's operations and take proactive responses.

# 企業管治報告

## CORPORATE GOVERNANCE REPORT

本公司致力樹立高標準之企業管治，並相信此舉對公司發展及保障本公司股東利益十分重要。本公司已經採納良好的管治與披露常規，並將不斷改良，建立具高度操守的企業文化。

### 遵守《企業管治守則》

本公司致力踐行企業管治最佳實踐，截至2021年12月31日止年度，一直遵守《企業管治守則》所載的所有守則條文，惟下文所披露《企業管治守則》第二部分第C.2.1條的偏離者除外。

《企業管治守則》第二部分C.2.1條訂明，董事會主席與行政總裁的角色應有區分，並不應由同一人兼任。主席及行政總裁的職責劃分應清晰界定並以書面列示。鍾睽先生為本公司董事長兼總經理。鍾睽先生為本集團的創始人，擁有豐富的飲用水及軟飲料行業經驗，負責本公司業務策略及營運的整體管理，自本公司於1996年成立以來對本集團的增長及業務擴展起著關鍵作用。董事會認為，由鍾睽先生一人兼任董事長與總經理對本公司管理有利。

此外，由經驗豐富及才能出眾的人士組成的高級管理層與董事會可確保權力與權限之間有所制衡。董事會現時由五名執行董事（包括鍾睽先生）、一名非執行董事及三名獨立非執行董事組成，因此，我們認為其組成具有較高的獨立性。

The Company is committed to upholding high standards of corporate governance which, it believes, is crucial to the development of the Company and safeguarding the interests of the shareholders of the Company. The Company has adopted sound governance and disclosure practices, and will continuously improve these practices and establish a highly ethical corporate culture.

### COMPLIANCE WITH THE CORPORATE GOVERNANCE CODE

The Company is committed to the best practices on corporate governance, and had complied with all the code provisions as set out in the Corporate Governance Code of the Company during the year ended December 31, 2021, save for the deviations from the code provision C.2.1 under Section II of the Corporate Governance Code disclosed below.

Pursuant to code provision C.2.1 under Section II of the Corporate Governance Code, the roles of chairman of the board and chief executive officer should be separated and should not be performed by the same individual. The division of responsibilities between the chairman and chief executive officer should be clearly established and set out in writing. Mr. Zhong Shanshan is the Chairman of the Board and General Manager of the Company. As the founder of the Group, Mr. Zhong Shanshan has extensive experience in the drinking water and soft beverage industry and is responsible for the overall management of the Company's business strategies and operations. He has been mainstay to the growth and business expansion of the Group since the Company's establishment in 1996. The Board is of the view that vesting both roles of Chairman and General Manager in Mr. Zhong Shanshan is beneficial to the management of the Company.

In addition, the balance of power and authority is ensured by the operation of the senior management and the Board, which comprises experienced and high-caliber individuals. The Board currently consists of five executive Directors (including Mr. Zhong Shanshan), one non-executive Director and three independent non-executive Directors. Therefore, we consider that the Board has a fairly strong independence element in its composition.

董事會將不時檢討架構，以確保架構有助於執行本集團的業務策略及盡量提高其運營效率。

### 董事及監事進行之證券交易

本公司採納《標準守則》，制定了本公司的《董事、監事及有關僱員證券交易守則》。本公司已向各董事及監事作出特定查詢，彼等確認於報告期間，彼等皆已遵守《標準守則》規定的有關董事及監事證券交易的要求。

### 董事會的組成

截至2021年12月31日及最後可行日期，董事會由九位董事組成，包括五位執行董事鍾睽先生(董事長)、郭振先生、周力先生、周震華女士、廖原先生及一位非執行董事Zhong Shu Zi先生，以及三位獨立非執行董事Stanley Yi Chang先生、楊磊先生、呂源先生。就本公司所知，除了非執行董事Zhong Shu Zi先生是董事長及總經理鍾睽先生的兒子，其他董事會成員與總經理之間概無任何財務、業務及親屬關係或重大／相關的關係，董事、監事和高級管理人員之間不存在重大須披露的關係。

董事履歷詳情載於本年報「董事、監事及高級管理人員履歷」一節。

The Board shall review the structure from time to time to ensure that the structure facilitates the execution of the business strategies of the Group and maximizes effectiveness of its operation.

### SECURITIES TRANSACTIONS BY DIRECTORS AND SUPERVISORS

The Company works out the Regulations on Securities Transactions by Directors, Supervisors and Related Employees by applying the Model Code. The Company has made specific enquires with the directors and supervisors and all of them confirmed that they had been in compliance with the requirements for securities transactions of directors and supervisors set out in the Model Code during the Reporting Period.

### COMPOSITION OF THE BOARD

As of December 31, 2021 and up to the Latest Practicable Date, the Board currently consists of nine Directors, including five executive Directors (namely, Mr. Zhong Shanshan (Chairman), Mr. Guo Zhen, Mr. Zhou Li, Ms. Zhou Zhenhua and Mr. Liao Yuan), one non-executive Director (namely, Mr. Zhong Shu Zi) and three independent non-executive Directors (namely, Mr. Stanley Yi Chang, Mr. Yang, Lei Bob and Mr. Lu Yuan). As far as the Company is aware, except for the non-executive Director Mr. Zhong Shu Zi, who is the son of Mr. Zhong Shanshan, the Chairman and General Manager, there is neither financial, business, family or material/related relationship between other members of the Board and the General Manager, nor significant relationships between Directors, Supervisors and senior management that need to be disclosed.

The biographical details of the Directors are set out in the section headed "Biographies of Directors, Supervisors and Senior Management" in this annual report.

## 董事會的主要職責

董事會負責且擁有我們業務管理及運營的一般權力，包括釐定我們的業務策略及投資計劃、實施於股東大會通過的決議案，以及行使公司章程授予的其他權力、職能及職責。董事會亦負責制定及審視本公司在企業治理、風險管理及內部控制以及法律及法規合規方面的政策及實踐。

董事會在發揮科學戰略決策功能時能代表公司長遠利益和股東及相關者的利益，在控制企業資源、參加經營管理時能受到有效的監督和評價，在對高級管理層適度授權時能有效激勵和約束高級管理層人員。董事會作為本公司企業管治架構的核心，與高級管理層之間有明確的分工。本公司明確劃分股東大會、董事會、監事會及高級管理層的職責。股東大會是本公司的最高權力機構，董事會對股東大會負責，董事會已成立三個專門委員會，專門委員會在董事會領導之下運作，並就董事會的決策提供意見。監事會監督董事會及高級管理層履行職責以及本公司的財務活動、風險管理及內部控制。在董事會領導下，高級管理層負責執行董事會的決議並負責本公司的日常業務與管理，並向董事會及監事會報告。

## MAJOR RESPONSIBILITIES OF THE BOARD

The Board is responsible for and has the general power over the management and operation of our business, including determining our business strategies and investment plans, implementing resolutions passed at our Shareholders' general meetings, and exercising other powers, functions and duties as conferred by the Articles of Association. The Board also assumes the responsibilities for developing and reviewing the policies and practices of the Company on corporate governance, risk management and internal control and compliance with legal and regulatory requirements.

The Board shall represent the long-term interest of the Company and the interest of shareholders and related parties when making scientific and strategic decisions, be effectively supervised and evaluated when controlling corporate resources and conducting operation management and maintain effective stimulation and supervision over the senior management when duly delegating its power to the senior management. The Board is the core of the Company's corporate governance framework and its role is clearly separated from that of senior management. The Company clearly defines the responsibilities of the general meeting, the Board, the Supervisor Committee, and senior management. The general meeting is the highest authority of the Company, and the Board is responsible to the general meeting. The Board has established three specialized committees that operate under the leadership of the Board and offer advices on the Board's decision-making. The Supervisor Committee supervises the performance of duties by the Board and senior management as well as the financial activities, risk management, and internal control of the Company. Under the leadership of the Board, senior management is responsible for implementing the resolutions of the Board and for daily business and management of the Company, and reports to the Board and the Supervisor Committee.

本公司設總經理(「總經理」)一職。本公司董事長及總經理的職位均由鍾睽先生擔任，董事長負責確保各董事妥善履行責任，並確保及時就重大事項進行討論。經營日常業務及執行董事會所設定策略及方針的權力及授權乃授予本公司的管理團隊(「管理層」)。管理層對本集團的營運向董事會承擔責任。

董事會成立了審計委員會、薪酬委員會及提名委員會。各委員會的組成及職責請見下文。各委員會根據各自的職責向董事會報告其建議，除了各委員會職責明確訂明外，其建議最終由董事會決定。

報告期間，董事會亦在督促完善本公司企業管治制度，提高企業管治水平方面做了大量工作，包括根據有關法律、法規和監管規則(經不時修訂)的要求以及本公司的實際情況持續完善本公司的內部管理制度，建立健全本公司內部制度和流程以落實和保障《企業管治守則》的有效執行，為董事、監事及公司高管安排持續專業培訓，定期檢討公司遵守境內外監管規定及執行公司內部各項企業管治制度及政策的情況，檢討公司遵守《企業管治守則》的情況及在《企業管治報告》內的披露。

The Company has a general manager (the “General Manager”). The roles of the Chairman of the Board and General Manager of the Company are performed by Mr. Zhong Shanshan. The Chairman of the Board is responsible for ensuring that the Directors perform their duties properly and ensuring discussions on material matters take place on a timely basis. The power and authority to carry out daily operations and implementation of the strategies and directions set by the Board are delegated to the management team of the Company (the “Management”). The Management assumes accountability to the Board for the operation of the Group.

The Board has established an audit committee, a remuneration committee and a nomination committee. Please see below for the composition and responsibilities of each committee. Each committee shall provide its recommendations to the Board based on its respective terms of reference. The decisions of the Board on such recommendations shall be final, unless otherwise clearly stated in the terms of reference of these committees.

During the Reporting Period, the Board made a lot of efforts in improving the corporate governance system of the Company and enhancing the corporate governance standards, including developing and amending relevant internal management rules in accordance with the requirements of relevant laws, regulations and regulatory rules as amended from time to time, as well as the practice of the Company; establishing and improving the internal systems and processes of the Company to implement and ensure the effective implementation of the Corporate Governance Code; arranging continuous professional trainings for the Directors, Supervisors and the senior management of the Company; regularly reviewing the Company’s compliance with the domestic and overseas regulatory requirements and its implementation of various internal corporate governance rules and policies, and reviewing the Company’s compliance with the Corporate Governance Code and the disclosures in the Corporate Governance Report.



## 董事、監事及高級管理人員變動

2021年4月16日，監事裘紅鸞女士因到法定退休年齡，向監事會提交辭呈，請求辭去公司監事及監事會主席的職務。裘紅鸞女士的辭任自下任監事填補因其辭任產生的空缺後生效，在其辭任尚未生效期間，裘紅鸞女士仍按照有關法律、行政法規和公司章程的規定繼續履行職責。2021年4月16日，本公司監事會決議建議委任鍾紀鋼先生為本公司股東代表監事。2021年6月25日，經本公司2020年度股東大會批准，鍾紀鋼先生獲委任為本公司股東代表監事，裘紅鸞女士不再擔任本公司監事及監事會主席。緊接於2020年度股東大會後舉行的本公司第七屆監事會第五次會議，監事會同意選舉鍾紀鋼先生為本公司第七屆監事會主席，其任期自2021年6月25日起至第七屆監事會任期屆滿時止。詳情請參閱本公司於2021年4月16日及2021年6月25日刊發的公告。

除此外，在報告期內，本公司董事、監事及高級管理人員無其他變動。

## CHANGES OF DIRECTORS, SUPERVISORS AND SENIOR MANAGEMENT

On April 16, 2021, Ms. Qiu Hongying tendered her resignation to the Supervisory Committee and will resign as the shareholder representative Supervisor of the Company and the chairman of the Supervisory Committee as she has attained the age of retirement. Ms. Qiu Hongying's resignation will take effect after the next Supervisor fills in the vacancy arising from her resignation. During the period before her resignation takes effect, Ms. Qiu Hongying continues to perform her duties in accordance with relevant laws, administrative regulations and the Articles of Association. The Supervisory Committee resolved on April 16, 2021 to propose the appointment of Mr. Zhong Jigang as the shareholder representative Supervisor of the Company. On June 25, 2021, subject to the approval on the 2020 Annual General Meeting of the Company, Mr. Zhong Jigang was appointed as the shareholder representative Supervisor of the Company, and Ms. Qiu Hongying ceased to be the Supervisor and the Chairman of the Supervisory Committee of the Company. At the fifth meeting of the seventh session of the Supervisory Committee of the Company held immediately after the 2020 Annual General Meeting, the Supervisory Committee agreed to elect Mr. Zhong Jigang as the Chairman of the seventh session of the Supervisory Committee of the Company, with a term from June 25, 2021 to the expiry of the term of office of the seventh session of the Supervisory Committee. For details, please refer to the announcements of the Company dated April 16, 2021 and June 25, 2021.

- assessing the independence of independent non-executive directors;

## SHAREHOLDERS' RIGHTS

The Company shall convene an extraordinary general meeting at the request of shareholders who individually or collectively hold more than 10% of the Company's shares. However, prior to the announcement of the resolutions approved at the general meeting, the number of the Company's shares individually or jointly held by the above shareholders shall not be lower than 10% of the total number of the Company's shares with voting rights; should the shareholding is less than 10%, resolutions passed at the extraordinary general meeting would become invalid.

When the Company convenes a shareholders' general meeting, the shareholders who individually or jointly, hold more than 3% of the total number of voting shares of the Company, have the right to put forward a new proposal in written form to the Company and submit it to the convener not less than 10 days before the shareholders' general meeting is held. The convener of the shareholders' general meeting shall, within 2 days after receiving the proposal, issue a supplementary notice of the shareholders' general meeting to inform other shareholders and include the matters which are within the scope of responsibilities of the shareholders' general meeting in the agenda of the meeting and submitted to the shareholders' general meeting for deliberation.

## AMENDMENTS TO THE ARTICLES OF ASSOCIATION

In accordance with the Company Law and the regulatory requirements of The Hong Kong Securities Clearing Company, the Board resolved on March 25, 2021 to propose amendments to the existing Articles of Association of the Company in terms of Shareholders' capital contribution information upon the Company's establishment, Shareholder proxies and procedures of general meetings (if applicable). On June 25, 2021, the Company's 2020 Shareholders' General Meetings considered and approved such amendment to the Articles of Association.

On July 5, 2021, the Company completed the registration and filing procedures for the amendments to the Company's Articles of Association with the Administration for Industry and Commerce of Zhejiang Province.

## EFFECTIVE COMMUNICATIONS WITH INVESTORS

The Group had made effective improvements in investor relations in 2021 under the leadership and support of the Board and management. The Group has participated in a number of investor/analyst communication meetings, investment forums and investor events, etc., to promote the Company’s communications with shareholders and investors. In the future, the Company will maintain on-going and effective communications with shareholders of the Company and investors through road shows after the issuance of interim results, annual results as well as through general meetings.

### 不競爭承諾履行情況

獨立非執行董事已審閱鍾睽睽先生及養生堂對不競爭承諾的遵守情況，並確認鍾睽睽先生及養生堂於截至2021年12月31日止年度一直遵守該等承諾條款。鍾睽睽先生及養生堂亦向本公司確認其一直遵守不競爭承諾的條款。

就獨立非執行董事所知，鍾睽睽先生及養生堂並無違反不競爭承諾的條款，因此，截至2021年12月31日止年度，本公司並無採取任何補救行動。

根據本公司與鍾睽睽先生及養生堂訂立的不競爭承諾，鍾睽睽先生及養生堂及其附屬公司(不包括上市附屬公司及本集團)於不競爭承諾期限內獲推薦或獲提供與受限制業務直接或間接於中國構成競爭的業務機會，該新業務機會應推薦或介紹給本集團。詳情可參閱招股章程「與控股股東的關係」一節所提及「不競爭承諾」及「新業務機會」內文。

於報告期間，本公司董事(包括獨立非執行董事)概無做出行使或終止選擇權或優先購買權，及接受或放棄任何商業機會的決定。

### PERFORMANCE OF NON-COMPETITION UNDERTAKING

The independent non-executive Directors have reviewed the compliance by Mr. Zhong Shanshan and Yangshengtang of the Non-competition Undertaking and confirmed that Mr. Zhong Shanshan and Yangshengtang have complied with the terms of such undertaking during the year ended December 31, 2021. Mr. Zhong Shanshan and Yangshengtang also confirmed to the Company that they have complied with the terms of the Non-Competition Undertaking.

The independent non-executive Directors were not aware of any breach of the terms of the Non-Competition Undertaking by Mr. Zhong Shanshan and Yangshengtang and therefore, no remedy action was taken by the Company during the year ended December 31, 2021.

In accordance with the Non-Competition Undertaking entered into between the Company and Mr. Zhong Shanshan and Yangshengtang, if any of Mr. Zhong Shanshan and Yangshengtang or their subsidiaries (excluding their listed subsidiaries and the Group) are recommended or provided with business opportunities which directly or indirectly compete with the Restricted Business in the PRC during the term of the Non-competition Undertaking, the New Business Opportunities should be recommended or introduced to the Group. For details, please refer to the “Non-Competition Undertaking” and “New Business Opportunities” mentioned in the section headed “Relationship with the Controlling Shareholders” in the Prospectus.

During the Reporting Period, the Directors of the Company (including the independent non-executive Directors) did not make any decisions in relation to the exercise or termination of the option or the right of first refusal or take up or waive any Business Opportunities.



## 風險管理及內部監控

董事會已按照《企業管治守則》第二部分第D.2段的要求建立了風險管理及內部監控系統，負責對本公司的風險管理及內部監控系統的充分性和有效性進行獨立審核，持續監督並每年至少檢討一次其運行的有效性。該系統旨在管理而非消除未能達成業務目標的風險，促進有效及高效運營，合理保證財務報告可靠性及遵守適用法律及法規以及保障本集團資產。董事會只能就不會有重大的失實陳述或損失作出合理而非絕對的保證。

### 風險管理和內部監控組織體系特點

根據《企業管治守則》第二部分第D.2.2條的要求，為確保本集團在風險管理和內部審核方面具備足夠的資源、員工資歷及經驗、足夠的培訓課程和有關預算，本集團建立了完善的風險管理和內部監控組織體系，包括董事會、審計委員會、監事會、本集團管理層、董事會辦公室、審計稽查中心、法務部以及其他各部門。本集團各部門為風險管理和內部監控第一道防綫；本集團董事會辦公室和管理層為第二道防綫；審計稽查中心、法務部、審計委員會及監事會為第三道防綫。董事會對本集團風險管理及內部監控體系的建立健全和風險管理工作的有效實施承擔最終責任，並作為本集團風險管理和內部監控的最高決策機構。

## RISK MANAGEMENT AND INTERNAL CONTROL

The Board has established a risk management and internal control system in accordance with the requirements of paragraph D.2 under Section II of the Corporate Governance Code, which is responsible for independently reviewing the adequacy and effectiveness of the risk management and internal control system of the Company, and continuously monitoring and reviewing the effectiveness of its operation once a year. The system aims to manage rather than eliminate the risk of failure to achieve business objectives, promote effective and efficient operations, reasonably ensure the reliability of financial reports and comply with applicable laws and regulations and protect the assets of the Group. The Board can only give reasonable but not absolute assurance that there will be no material misrepresentation or loss.

### Characteristics of the Risk Management and Internal Control Organization System

In accordance with the requirements of code provision D.2.2 under Section II of the Corporate Governance Code, the Group has established a sound risk management and internal control organization system which includes the Board, the Audit Committee, the Supervisory Committee, the management of the Group, the office of the Board, the audit and inspection center, the legal department and other departments to ensure that the Group has sufficient resources, qualified and experienced staffs, training courses and related budget for risk management and internal audit. The various departments of the Group are the first line of defense for risk management and internal control; the office of the Board and the management of the Group are the second line of defense; while the audit and inspection center, the legal department, the Audit Committee and the Supervisory Committee are the third line of defense. The Board bears the ultimate responsibility for the establishment and improvement of the Group's risk management and internal control system as well as the effective implementation of the risk management work, and serves as the highest decision maker for the Group's risk management and internal control.

**風險管理和內部監控工作開展**

本集團每年對風險管理及內部監控系統的有效性進行檢討，根據內部環境、風險評估、控制活動、信息與溝通及內部監督等內部監控元素，對所有重要的監控方面，包括財務監控、運作監控及合規監控等進行評估。

經過風險評估，公司2021年度重大風險主要涉及業務風險、財務風險、合規風險、內幕消息及內部監控風險，我們根據企業實際情況制定了切實可行的應對方案對風險進行有效管理：

**業務風險：**本集團在中國經營業務，面臨的業務風險包括疫情等宏觀環境風險、競爭風險、供應鏈風險、投資及併購風險及可持續發展風險。董事會定期檢討本集團的發展策略、業務計劃、財務業績及主要的表現指標，識別出潛在風險，及時調整策略和政策來應對，確保業務風險已受控制及管理。

**財務風險：**本集團已採納財務風險管理政策，以控制本集團的財務風險，例如稅務風險、貨幣風險及財務報告風險。而且，董事會在本集團內財務部門協助下，定期監督財務業績及主要營運數據。

**Implementation of Risk Management and Internal Control**

The Group reviews the effectiveness of the risk management and internal control systems every year and assesses all important monitoring aspects including supervision on financial, operation and compliance affairs, etc. based on the elements of internal control such as the internal environment, risk assessment, control activities, information and communication as well as internal supervision.

After risk assessment, the Company's major risks in 2021 mainly involve business risks, financial risks, compliance risks, inside information and internal control risks. According to our actual situation, we have formulated practical and feasible response plans to effectively manage risks:

**Business risks:** The business risks the Group mainly faces in respect of its operations in the PRC include macro-environmental risks such as the epidemic, competition risks, supply chain risks, investment in merger and acquisition risks and sustainability risks. The Board regularly reviews the development strategies, business plans, financial results, and key performance indicators of the Group, identifies potential risks and adjusts strategies and policies in a timely manner, to ensure that the business risks are controlled and managed.

**Financial risks:** The Group has adopted financial risk management policies to control the Group's financial risk exposure, such as taxation risks, currency risks and financial reporting risks. Also, the Board monitors the financial results and key operating statistics with the assistance of the Group's internal finance department on a regular basis.

合規風險：本集團已採納內部程序，監管本集團的合規風險，以確保本集團已遵守本集團業務經營所在地區的法律及法規。此外，本集團不時委聘專業顧問以保持本集團知悉規管環境的最新發展，並通過對員工開展責任營銷、反貪腐、知識產權等合規培訓，對經銷商進行《反商業賄賂與欺詐互相監督守則》宣導，進一步規範風險管理行為。

內幕消息及內部監控風險：本集團極為重視適當處理及傳送內幕消息。本集團設有內部政策，確保能適當控制內幕消息。本集團已實施信息管理系統控制，防止敏感數據外泄。

#### 風險管理和內部監控長效機制形成

我們制訂了風險管理政策及程序，明確風險管理的架構及職責權限，建立風險管控三道防綫，識別阻礙目標實現的重大風險，並將其控制在可接受水平內，保障經營目標的達成、運作效率的提升，確保財務報告可靠性及國家法規等合規要求的遵循。

我們通過管理層、風險管理體系中各業務單元、集團審計稽查團隊、外聘核數師及外聘合規顧問、法務顧問等渠道來評估與檢核我們風險管理及內部控制系統的有效性，完善風險應對措施。同時為保障風險管理體系的運作行之有效，我們成立了審計委員會進行審核、監督。

Compliance risks: The Group has adopted internal procedures to monitor the Group's compliance risks to ensure that the Group has complied with the laws and regulations of the regions where the Group conducts business. In addition, the Group engages professional advisers from time to time to keep the Group updated with the latest development in the regulatory environments. It also arranges compliance trainings on responsible marketing, anti-corruption and intellectual property for employees, and promotes the "Code for Mutual Supervision of Anti-Commercial Bribery and Fraud" among distributors, to further standardize risk management efforts.

Inside information and internal control risks: The Group attaches utmost importance to the proper handling and dissemination of inside information. Internal policies are put in place to ensure that inside information is properly controlled. The Group has implemented information management system control to prevent the leakage of sensitive information.

#### Formation of a Long-term Mechanism for Risk Management and Internal Control

We have formulated risk management policies and procedures, specified the risk management structure and responsibilities, established three lines of defense for risk management and control. We identify major risks that hinder the achievement of objectives and control them within acceptable levels to ensure the achievement of business objectives, the improvement of operational efficiency, the reliability of financial reports and compliance with national regulations and other compliance requirements.

We evaluate and check the effectiveness of our risk management and internal control systems through channels such as the management, business units in the risk management system, audit and inspection teams of the Group, external auditors, external compliance consultant and legal advisor to improve risk response measures. Meanwhile, in order to ensure the effective operation of the risk management system, we have established the Audit Committee to conduct review and supervision.

本集團審計稽查團隊根據董事會的授權，聚焦於業務風險、財務風險和合規風險，通過敏捷審計，實現更全面、精準的風險監控，更快地發現風險隱患，督促管理、制度流程改善，以支持公司中長期的願景及戰略目標的實現。

本集團財務報告、信息披露等管理流程嚴格遵守《上市規則》的規定，董事會辦公室制定《信息披露管理制度》，並按規定建立信息申報、審定、披露的控制程序，該制度由董事會審批通過。本集團在向公眾披露有關消息前，會確保該消息適當保密，並按規定進行內幕信息知情人的義務告知和監督。

董事會已對報告期內風險管理和內部監控工作進行了檢討，集團截至最後可行日期的風險管理和內部監控工作開展的結果表明，本集團不存在重大風險監控失誤的情形，也未發現重大風險監控弱項。董事會認為本集團的風險管理和內部監控系統是有效及足夠的。

According to the authorization of the Board, the audit and inspection team of the Group focuses on business risks, financial risks and compliance risks. Through agile audits, it achieves more comprehensive and accurate risk control, identifies potential risks more quickly, and promotes the improvement in management and system processes to support the achievement of the mid – to long-term vision and strategic goals of the Company.

The Group's management procedures for financial reporting and information disclosure, etc. are in strict compliance with the requirements of the Listing Rules. Office of the Board formulated the Rules on the Information Disclosure Management, which was approved by the Board, and has set up controlling procedures for information reporting, reviewing and disclosure. Prior to disclosing relevant information to the public, the Group will ensure that such information is kept confidential properly and will perform the obligation to inform and supervise the insiders of inside information as required.

The Board reviewed the risk management and internal control during the Reporting Period and concluded that there had been no deficiency in material risk control nor any weakness in material risk control based on the outcome of the risk management and internal control work implemented by the Group as of the Latest Practicable Date. The Board was of the view that the risk management and internal control system of the Group is effective and sufficient.

# 董事會報告

## REPORT OF THE DIRECTORS

董事會欣然提呈其報告連同本集團截至2021年12月31日止年度之經審核綜合財務報表。

### 主要業務

本集團是中國包裝飲用水及飲料的龍頭企業，致力於向消費者提供高質量的產品。本集團的主要產品覆蓋包裝飲用水、茶飲料、功能飲料及果汁飲料等類別。

自1996年成立以來，本集團即確保「每一滴農夫山泉都有它的源頭」。本集團的包裝飲用水產品全部源自天然水源。我們已在中國各不同區域佈局了十一大優質水源地，全面覆蓋了全國市場供應。該十一大水源所在地生態環境卓越，水質優異。本集團對優質天然原水做包括過濾及殺菌在內的必要處理。我們的包裝飲用水產品含有鉀、鈉、鈣、鎂、偏矽酸等對人體有益的礦物元素。

The Board is pleased to present its report together with the audited consolidated financial statements of the Group for the year ended December 31, 2021.

### PRINCIPAL BUSINESS

The Group is a leader in the packaged drinking water and beverage business in the PRC with devotion to providing consumers with high-quality products. The Group's major products include packaged drinking water, tea beverage, functional beverage and juice beverage.

Since its establishment in 1996, the Group has adhered to the principle that “every drop of Nongfu Spring has its source” (「每一滴農夫山泉都有它的源頭」). The Group sources all of packaged drinking water products from natural water sources. We have obtained access to ten quality natural water sources in different regions of China which cover the entire national market supply. The ten water sources are all located in excellent ecological environments and have outstanding water quality. The Group treats the quality natural water with the necessary process, including filtration and sterilization. Our packaged drinking water products contain the natural minerals that are beneficial to human body, such as potassium, sodium, calcium, magnesium and metasilicate.

本集團建立了包裝飲用水和飲料的雙引擎發展格局，既有利於增強我們的市場競爭能力又能有效降低業績波動風險。本集團實行多品牌戰略，具有長遠的品牌規劃和強大的品牌傳播能力，鑄就了中國軟飲料的超級品牌。

對本集團業務的中肯審視及運用財務關鍵表現指標進行的分析、本集團面臨的主要風險和不確定性，及本集團業務未來發展的討論請見本年報「董事長致辭」、「管理層討論與分析」及「企業管治報告」章節。

The Group has established dual growth engines, packaged drinking water and beverage, which enhance our competitive advantage and reduce the risks of fluctuating operating results. The Group implements a multi-brand strategy, has long-term visions for our brands and strong brand communication capabilities, and has built a super brand in the PRC soft beverage market.

董事會並不知悉任何股東已放棄或同意放棄任何股息。

## 股息政策

我們目前並無任何預先釐定的派息率。董事會及本公司將在考慮我們的經營業績、財務狀況、現金流量、營運及資本開支需求、未來業務發展戰略及預測以及可能認為相關的其他因素後宣派及派付股息。我們的過往股息宣派未必反映我們的日後股息宣派。

根據中國會計規則及法規，劃撥至法定公積金的金額現時定為有關財政年度公司權益持有人應佔稅後利潤的10%。當法定公積金累計撥款達本公司註冊資本50%時，本公司毋須再撥款至法定公積金。

## DIVIDENDS

The Board recommended the distribution of a final dividend (the “Final Dividend”) of RMB0.45 (tax inclusive) per share for the year ended December 31, 2021, with a total amount of RMB5,061 million. If such profit distribution plan is approved by shareholders at the annual general meeting to be held on Tuesday, June 14, 2022, the Final Dividend will be paid no later than August 31, 2022 to the shareholders whose names are listed on the register of shareholders of the Company on Thursday, June 23, 2022.

The Company will not be liable for any claim or dispute over the withholding mechanism arising from any delay in, or inaccurate determination of the status of the shareholders.

The Board is not aware of any shareholders who have waived or agreed to waive any dividend.

## DIVIDEND POLICY

The Company currently do not have a pre-determined dividend payout ratio. The Board may declare and pay, dividends after taking into account results of operations, financial condition, cash flow, operating and capital expenditure requirements, future business development strategies and estimates of the Group and other factors as it may deem relevant. Our historical declarations of dividends may not reflect our future declarations of dividends.

The allocations to the statutory common reserve are currently determined to be 10% of the Company’s after-tax profit attributable to equity holders of the Company for the fiscal year determined in accordance with PRC accounting rules and regulations. When the accumulated allocations to the statutory common reserve reach 50% of the registered capital of the Company, it will no longer be required to make allowances for allocation to the statutory common reserve.

### 對法律法規的合規和法律訴訟

本集團的業務營運主要在中國進行，而本公司的股份則在香港聯交所上市。我們所營運的業務主要受中國、香港等相關區域的法律監管。截至2021年12月31日止年度以及最後可行日期止，我們已遵守所適用區域對本集團有重大影響的相關法例及規例。具體而言，作為包裝水與飲料生產商，本集團在中國的運營受適用中國食品安全及環境保護法律法規的監管。於報告期間內，本集團未有任何重大違反該等法律法規的行為。

為了建立我們的海外運營能力，我們於2016年11月簽訂兩項協議及於2017年10月簽訂兩項補充協議（「收購協議」），向Otakiri Springs Limited（一家在新西蘭註冊成立的公司，主要從事新西蘭市場的瓶裝水生產及銷售）及其所在土地當時的擁有人（全部為獨立第三方）收購其業務、土地及相關資產（「新西蘭項目」）。有關該項目的詳情和過往年度的訴訟情況請參閱招股章程「歷史—本公司的成立與發展—3. 建立海外運營能力」及「業務—合規及法律訴訟」以及本公司2020年年報「企業管治報告—對法律法規的合規和法律訴訟」章節。繼2021年2月，異議群體向上訴法院（Court of Appeal）提交了繼續訴訟的申請後，於最後可行日期，上訴法院尚未就本案件做出判決或裁定。

由於新冠疫情及異議群體對當地政府批准我們擴大現有取水及灌裝運營發起多輪訴訟等原因，新西蘭項目的投產時間較原計劃設定的2019年已經出現大幅度推遲，且仍存在不確定性。公司正在重新評估該項目的可行性。

### COMPLIANCE WITH LAWS AND REGULATIONS AND LEGAL PROCEEDINGS

The Group's operations are carried out primarily in the PRC, while the Shares of the Company are listed on the Hong Kong Stock Exchange. The businesses operated by the Group are subject to the laws of relevant jurisdiction in the PRC and Hong Kong. During the year ended December 31, 2021 and as of the Latest Practicable Date, the Group has complied with relevant laws and regulations that have a significant impact on the Group in the applicable jurisdictions. Specifically, as a manufacturer of packaged water and beverages, the Group's operations in China are subject to the applicable food safety and environmental protection laws and regulations in the PRC. During the Reporting Period, the Group did not have any material non-compliance with such laws and regulations.

To build up our overseas operation capability, we entered into two agreements in November 2016 and two supplemental agreements in October 2017 (the "Acquisition Agreements") to acquire the business, the farmland and associated assets of Otakiri Springs Limited from Otakiri Springs Limited (a company incorporated in New Zealand and mainly engaged in production and sales of bottled water in New Zealand) and its then owners (all being independent third parties) (the "New Zealand Project"). For details of the project and the litigation in past years, please refer to the sections headed "History – Establishment and Development of the Company – 3. Building up Overseas Operation Capability" and "Business – Compliance and Legal Proceedings" in the prospectus and the section headed "Corporate Governance Report – Compliance with Laws and Regulations and Legal Proceedings" in the 2020 Annual Report. Following the application filed by the opposition group to the Court of Appeal demanding that the proceedings be continued in February 2021, as of the Latest Practicable Date, the Court of Appeal has not made any judgment or decision on this case.

Due to the COVID-19 pandemic and multiple rounds of lawsuits initiated by the opposition groups against the local government's grant of various consents to enable the expansion of an existing water extraction and bottling operation, the launch of the New Zealand Project has been significantly delayed compared with year 2019 set in the original plan, and still remains uncertain. The Company is reassessing the feasibility of the project.

As of December 31, 2021, the Group has utilised approximately HK\$4,394 million of the proceeds for the intended purposes set out in the Prospectus, accounting for 46.85% of all raised funds, and the remaining unutilised proceeds is approximately HK\$4,983 million. The balance of the proceeds from the Listing will continue to be unutilised according to the purposes and proportions disclosed in the Prospectus. See the table below for details:

According to the Articles of Association, for the purpose of determining distributable profit, the distributable profit of the Company shall be the lower of its profit after tax determined in accordance with: (i) the PRC accounting standards and regulations; and (ii) the international standards or the accounting standards of the place(s) outside the PRC where the shares of the Company are listed.

As at December 31, 2021, the distributable reserves of the Company, calculated based on the above principles, amounted to approximately RMB9,378 million.

本集團於2021年度進行了不獲全面豁免持續關連交易，下文所載交易乃於一般及日常業務過程中按正常商業條款訂立，如董事所預期，就《上市規則》第十四A章而言，其最高適用百分比率為每年超過0.1%但低於5%。因此，該等交易須遵守《上市規則》第十四A章有關公告、申報及年度審閱的規定，但獲豁免遵守《上市規則》第十四A章有關通函（包括獨立財務顧問意見）及獨立股東批准的規定。

To the best of the directors' knowledge, none of the Directors or their associates or any Shareholders who is expected to have 5% or more of the issued share capital of the Company has any interest in the top five suppliers and top five customers of the Group.

### PERMITTED INDEMNITY PROVISIONS

The Company has maintained directors' liability insurance to protect the Directors of the Company against any potential losses arising from his/her actual or alleged misconduct. During the Year and up to the Latest Practicable Date, permitted indemnity provision (as defined in section 9 of the Companies (Directors' Report) Regulation (Chapter 622D of the Laws of Hong Kong)) was and is being in force for the benefit of the Directors of the Company.

### CONNECTED TRANSACTIONS

Pursuant to the requirements of the Listing Rules, the transactions between the Company and its connected persons (as defined under the Listing Rules) constitute connected transactions of the Company. The Company regulates and manages such transactions in compliance with the Listing Rules. The followings are the non-fully exempt continuing connected transactions conducted by the Group during the Reporting Period.

#### Non-fully Exempt Continuing Connected Transactions

As of December 31, 2021, Mr. Zhong Shanshan held approximately 83.9757% interest in our total share capital, including approximately 17.1543% direct interest and approximately 66.8215% indirect interest through Yangshengtang (Mr. Zhong Shanshan holds 100% of the total registered capital of Yangshengtang, including 98.38% direct equity and 1.62% indirect equity held by Hangzhou Youfu, which is wholly-owned by Mr. Zhong Shanshan). Mr. Zhong Shanshan and Yangshengtang and their respective associates are our connected persons.

The Group conducted non-fully exempt continuing connected transactions in 2021. The transactions set out below are made in the ordinary and usual course of business and on normal commercial terms where, as our Directors expected, the highest applicable percentage ratios for the purpose of Chapter 14A of the Listing Rules would be more than 0.1% but less than 5% on an annual basis. #### Purchasing Framework Agreement

On August 12, 2020, the Company entered into the purchasing framework agreement with Yangshengtang, pursuant to which, Yangshengtang and its associates have agreed to sell and the Group has agreed to purchase bottle caps for the production of “Scream (尖叫)” and other products of Yangshengtang Group (including snack food and cosmetics products) which are sold through the Group’s new retail channels represented by vending machines, with a term commencing from the Listing Date to December 31, 2022. The Purchasing Framework Agreement will be renewable subject to the negotiation between the parties to the agreement and compliance with the requirements of the Listing Rules. For details of this agreement and the transaction, please refer to the “Connected Transactions” section of the Prospectus.

根據《上市規則》，鍾先生及養生堂為本公司的主要股東，屬本公司的關連人士。因此，本公司與養生堂訂立於採購框架協議下進行的交易構成本公司的持續關連交易。

根據採購框架協議的條款，本集團與養生堂及其聯繫人訂立具體協議或向其下達採購訂單，以就貨物的供應訂明具體條款及條件。本集團根據採購框架協議就採購貨物應付的代價根據於具體協議或採購訂單中協議的時間及方法支付。

Mr. Zhong and Yangshengtang are substantial Shareholders of the Company and the connected persons of the Company under the Listing Rules. Therefore, the transactions under the Purchasing Framework Agreement entered into by the Company and Yangshengtang constitute the continuing connected transactions of the Company.

Subject to terms of the Purchasing Framework Agreement, the Group entered into specific agreements or place purchase orders with Yangshengtang and its associates to set out specific terms and conditions in respect of the supply of goods. The consideration payable by the Group under the Purchasing Framework Agreement for purchasing goods is paid at the time and according to the method to be agreed in specific agreements or purchase orders.

The prices of transactions contemplated under the Purchasing Framework Agreement is determined on an arm's length basis. The price for purchasing bottle caps of "Scream (尖叫)" from Yangshengtang and/or its associates by the Group is determined with reference to the fee quote of bottle caps of "Scream (尖叫)" that the Group could obtain from the independent third party, but in any event is not higher than the fee quote provided by the independent third party; and the price for purchasing other products of Yangshengtang and its associates, such as snack food and cosmetics products, is determined with reference to prices of such products provided to other independent third parties by Yangshengtang and its associates, but in any event does not exceed the prices provided to independent third parties by Yangshengtang and its associates.

The proposed annual cap and the actual amount of the transactions contemplated under the Purchasing Framework Agreement and for the year ending December 31, 2021 are RMB235.0 million and RMB205.3 million, respectively.

於2020年8月12日，本公司與養生堂及其全資附屬公司養生堂天然藥物研究所訂立基礎研發及檢測服務框架協議。據此，自上市日期起至2022年12月31日為止，養生堂及／或養生堂天然藥物研究所同意向本公司提供與飲料相關的基礎研發及原材料與產品測試服務。基礎研發及檢測服務框架協議將可予重續，惟須經協議訂約方磋商及須遵守《上市規則》的規定。有關本協議及交易的詳情，請參閱招股章程「關連交易」部分。

**IT Product and Service Framework Agreement**

On August 12, 2020, the Company entered into the IT product and service framework agreement with Yangshengtang and its wholly-owned subsidiary, Rainbow Fish Technology, pursuant to which, Yangshengtang and Rainbow Fish Technology have agreed to provide several types of IT products and services to the Company with a term commencing from the Listing Date to December 31, 2022. The IT Product and Service Framework Agreement will be renewable subject to the negotiation between the parties to the agreement and compliance with the requirements of the Listing Rules. For details of this agreement and the transaction (including the types of services, the main terms of the agreement, the basis for pricing and other main contents), please refer to the “Connected Transactions” section of the Prospectus.

Mr. Zhong and Yangshengtang are substantial Shareholders of the Company and the connected persons of the Company under the Listing Rules. Therefore, the transactions under the IT Product and Service Framework Agreement entered into by the Company and Yangshengtang and its wholly-owned subsidiary, Rainbow Fish Technology constitute the continuing connected transactions of the Company.

The proposed annual cap and the actual amount of the transactions contemplated under the IT Product and Service Framework Agreement and for the year ending December 31, 2021 are RMB150.0 million and RMB111.8 million, respectively.

**Basic R&D and Test Service Framework Agreement**

On August 12, 2020, the Company entered into the basic R&D and test framework agreement with Yangshengtang and its wholly-owned subsidiary, YST Natural Medicine Research, pursuant to which, Yangshengtang and/or YST Natural Medicine Research have/has agreed to provide basic beverage R&D services and test services of raw material and product to the Company, with a term commencing from the Listing Date to December 31, 2022. The Basic R&D and Test Framework Agreement shall be renewable subject to the negotiation between the parties to the agreement and compliance with the requirements of the Listing Rules. For details of this agreement and the transaction, please refer to the “Connected Transactions” section of the Prospectus.

根據《上市規則》，鍾先生及養生堂為本公司的主要股東，屬本公司的關連人士。因此，本公司與養生堂及其全資附屬公司養生堂天然藥物研究所訂立於基礎研發及檢測服務框架協議下進行的交易構成本公司的持續關連交易。

根據基礎研發及檢測服務框架協議的條款，本集團與養生堂及／或其聯繫人訂立具體協議或下達訂單，以就基礎研發及檢測服務訂明具體條款及條件。本集團根據基礎研發及檢測服務框架協議就接納該等服務而應付的代價根據於具體協議或訂單中協議的時間及方法支付。根據基礎研發及檢測服務框架協議取得的工作成果及相關知識產權及其他權利由本集團與養生堂及／或養生堂天然藥物研究所共同所有。本集團對於該等知識產權具有排他性使用權，而養生堂及／或養生堂天然藥物研究所僅在獲得本集團同意時方可使用。養生堂及／或養生堂天然藥物研究所使用該等共同所有的知識產權無需支付任何費用。

養生堂及／或養生堂天然藥物研究所根據基礎研發及檢測服務框架協議提供基礎研發服務的費用經參考養生堂及／或養生堂天然藥物研究所產生的實際成本後釐定，成本加成為實際成本的25%，且不得高於本集團可向獨立第三方服務供應商採購類似服務的價格。養生堂及／或養生堂天然藥物研究所根據基礎研發及檢測服務框架協議提供檢測服務的費用將參考現行市價決定，且不得高於本集團可向獨立第三方服務供應商採購類似服務的價格。

截至2021年12月31日止年度，基礎研發及檢測服務框架協議項下擬進行交易的建議年度上限為人民幣100.0百萬元，而實際發生的金額為人民幣77.2百萬元。

Mr. Zhong and Yangshengtang are substantial Shareholders of the Company and the connected persons of the Company under the Listing Rules. Therefore, the transactions under the Basic R&D and Test Framework Agreement entered into by the Company and Yangshengtang and its wholly-owned subsidiary, YST Natural Medicine Research constitute the continuing connected transactions of the Company.

Subject to terms of the Basic R&D and Test Framework Agreement, the Group enters into specific agreements or place orders with Yangshengtang and/or its associates to set out specific terms and conditions in respect of the basic R&D and test services. The consideration payable by the Group under the Basic R&D and Test Framework Agreement for accepting such services is paid at the time and according to the method agreed in specific agreements or orders. The proprietary rights of all work products and intellectual property rights and other rights obtained pursuant to the Basic R&D and Test Framework Agreement are jointly owned by the Group and Yangshengtang and/or YST Natural Medicine Research. The Group has the exclusive right of use on such intellectual properties, while Yangshengtang and/or YST Natural Medicine Research are/is only able to use them with the consent of the Group. Use of such jointly-owned intellectual properties by Yangshengtang and/or YST Natural Medicine Research is free of charge.

Fees of basic R&D services provided by Yangshengtang and/or YST Natural Medicine Research under the Basic R&D and Test Framework Agreement are determined with reference to the actual cost incurred by Yangshengtang and/or YST Natural Medicine Research with a cost markup of 25% of the actual costs, and in any event are not higher than the prices of similar services that can be procured from independent third-party suppliers by the Group. Fees of test services provided by Yangshengtang and/or YST Natural Medicine Research under the Basic R&D and Test Framework Agreement are determined with reference to the prevailing market prices, and in any event are not higher than the prices of similar services that can be procured from independent third-party suppliers by the Group.

The proposed annual cap and the actual amount of the transactions contemplated under the Basic R&D and Test Service Framework Agreement and for the year ending December 31, 2021 are RMB100.0 million and RMB77.2 million, respectively.

**不獲全面豁免持續關連交易的豁免申請**

本公司確認上述截至2021年12月31日止年度的持續關連交易項下具體協議的簽訂及執行均已遵循該等持續關連交易的定價原則。

根據《上市規則》第14A.55條，獨立非執行董事已審閱以上不獲全面豁免的持續關連交易，並確認該等交易：

- i. 於本公司日常業務中訂立；
- ii. 按照一般商務條款或更佳條款進行；及
- iii. 根據有關的協議條款進行，而交易條款公平合理，並且符合本公司股東的整體利益。

**Waiver Application for Non-fully Exempt Continuing Connected Transactions**

Mr. Zhong and Yangshengtang are substantial Shareholders of the Company and the connected persons of the Company under the Listing Rules. Therefore, the transactions abovementioned constitute the continuing connected transactions of the Company.

As the above non-fully exempt continuing connected transactions are expected to continue a recurring and continuing basis, our Directors consider that compliance with the above announcement requirements will be impractical, will incur unnecessary administrative costs for us, and will be unduly burdensome to us.

Accordingly, we have applied to the Hong Kong Stock Exchange for, and the Hong Kong Stock Exchange has granted, a waiver to us under Rule 14A.105 of the Listing Rules from compliance with the announcement requirements in respect of the above non-fully exempt continuing connected transactions.

The Company has confirmed that the execution and enforcement of the implementation agreements under the continuing connected transactions set above for the year ended December 31, 2021 has followed the pricing principles of such continuing connected transactions.

Pursuant to Rule 14A.55 of the Listing Rules, the independent non-executive Directors had reviewed the above non-fully exempt continuing connected transactions and confirmed that these transactions had been entered into:

- i. in the ordinary and usual course of business of the Company;
- ii. either on normal commercial terms or on better terms; and
- iii. in accordance with relevant agreements governing them on terms that are fair and reasonable and in the interests of the shareholders of the Company as a whole.

The auditors of the Company had informed the Board and confirmed that the abovementioned continuing connected transactions:

- i. were approved by the Board;
- ii. were conducted in accordance with the pricing policy of the Company;
- iii. were entered into pursuant to the terms of relevant transaction agreements; and
- iv. did not exceed the annual cap disclosed by the Company in the Prospectus.

Save as disclosed above, for the year ended December 31, 2021, there is no other related party transaction or continuing related party transaction set out in note 37 to the financial statements which constitutes disclosable connected transaction or disclosable continuing connected transaction under the Listing Rules. In respect of the connected transactions and the continuing connected transactions, the Company has complied with the disclosure requirements of the Listing Rules (as amended from time to time).

## 意見

本核數師(以下簡稱「我們」)已審計第104至206頁所載農夫山泉股份有限公司(「貴公司」)及其附屬公司(「貴集團」)的綜合財務報表，該等綜合財務報表包括於2021年12月31日的綜合財務狀況表與截至該日止年度的綜合損益表、綜合全面收益表、綜合權益變動表和綜合現金流量表，以及綜合財務報表附註，包括主要會計政策概要。

The directors of the Company are responsible for the preparation of the consolidated financial statements that give a true and fair view in accordance with IFRSs issued by the IASB and the disclosure requirements of the Hong Kong Companies Ordinance, and for such internal control as the directors determine is necessary to enable the preparation of consolidated financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the consolidated financial statements, the directors of the Company are responsible for assessing the Group's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the directors of the Company either intend to liquidate the Group or to cease operations or have no realistic alternative but to do so.

Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these consolidated financial statements.

As part of an audit in accordance with HKSA's, we exercise professional judgement and maintain professional scepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the consolidated financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. ## 2.1 編製基準

該等綜合財務報表乃根據國際財務報告準則(「國際財務報告準則」)編製，當中包括國際會計準則理事會(「國際會計準則理事會」)批准的所有準則及詮釋，及國際會計準則理事會批准的國際會計準則及常務詮釋委員會詮釋以及香港公司條例之披露規定。

除衍生金融工具及理財產品按公平值計量外，綜合財務報表乃按照歷史成本原則編製。除另有註明者外，該等財務報表以人民幣(「人民幣」)呈列，且所有數值均調整至最近的千元單位。

### 綜合基準

綜合財務報表包括本公司及其附屬公司(統稱「本集團」)於截至2021年12月31日止年度的財務報表。附屬公司為本公司直接或間接控制的實體(包括結構性實體)。當本集團對參與被投資方業務的可變回報承擔風險或享有權利以及能透過其權力影響被投資方的回報時(即賦予本集團現有能力主導被投資方相關活動的既存權利)，即取得控制權。

倘本公司直接或間接擁有少於被投資方過半數投票或類似權利，則本集團於評估其是否對被投資方擁有權力時會考慮一切相關事實及情況，包括：

- (a) 與被投資方其他投票權持有人的合約安排；
- (b) 其他合約安排產生的權利；及
- (c) 本集團的投票權及潛在投票權。

## 2.1 BASIS OF PREPARATION

These consolidated financial statements have been prepared in accordance with International Financial Reporting Standards (“IFRSs”), which comprise standards and interpretations approved by the International Accounting Standards Board (the “IASB”), and International Accounting Standards and Standing Interpretations Committee interpretations approved by the International Accounting Standards Committee and the disclosure requirements of the Hong Kong Companies Ordinance.

The consolidated financial statements have been prepared under the historical cost convention, except for derivative financial instruments and wealth management products which have been measured at fair value. These financial statements are presented in Renminbi (“RMB”) and all values are rounded to the nearest thousand except when otherwise indicated.

### Basis of consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries (collectively referred to as the “Group”) for the year ended 31 December 2021. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group’s voting rights and potential voting rights.

## 2.1 編製基準(續)

### 綜合基準(續)

附屬公司的財務報表乃就與本公司相同的報告期間採用一致的會計政策編製。附屬公司的業績自本集團取得控制權當日起綜合入賬，並繼續綜合入賬直至有關控制權終止當日為止。

倘本集團失去對一間附屬公司的控制權，則其終止確認(i)該附屬公司的資產(包括商譽)及負債、(ii)任何非控股權益的賬面值及(iii)於權益內記錄的累計匯兌差額；及確認(i)已收代價的公平值、(ii)任何保留投資的公平值及(iii)損益中任何因此產生的盈餘或虧絀。先前於其他全面收益內確認的本集團應佔部分按倘若本集團直接出售相關資產或負債而規定使用的相同基準重新分類至損益或保留溢利(如適用)。

### Basis of consolidation (continued)

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets (including goodwill) and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interest and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained and (iii) any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

## 2.4 重大會計政策概要

### 公平值計量

本集團計量各報告期末的衍生金融工具及股本投資。公平值為市場參與者於計量日期在有序交易中出售資產所收取或轉讓負債所支付的價格。公平值計量乃基於假設出售資產或轉讓負債的交易於資產或負債的主要市場或(在無主要市場的情況下)資產或負債的最有利市場進行。主要或最有利市場必須為本集團可進入的市場。資產或負債的公平值乃採用市場參與者為資產或負債定價時所用的假設計量，並假設市場參與者依照彼等的最佳經濟利益行事。

非金融資產的公平值計量經計及市場參與者能否以最高及最佳用途使用有關資產或能否將有關資產出售予會以最高及最佳用途使用有關資產的另一名市場參與者以產生經濟利益。

本集團採取適用於不同情況且具備充分數據以供計量公平值的估值技巧，以盡量使用相關可觀察輸入數據及盡量減少使用不可觀察輸入數據。

於財務報表內計量或披露公平值的所有資產及負債基於對公平值計量整體屬重要的最低輸入數據水平，按如下所述在公平值層級中分類：

- 第一級 — 基於相同資產或負債於活躍市場的報價(未經調整)
- 第二級 — 基於可直接或間接觀察對公平值計量而言屬重大的最低層輸入數據的估值技巧

## 2.4 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Fair value measurement

The Group measures its derivative financial instruments and equity investments at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

- Level 1 — based on quoted prices (unadjusted) in active markets for identical assets or liabilities
- Level 2 — based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly
- Level 3 — based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

## 2.4 重大會計政策概要(續)

### 公平值計量(續)

就按經常性基準於財務報表確認的資產及負債而言，本集團透過於各報告期間末重新評估分類(基於對公平值計量整體而言屬重大的最低層輸入數據)確定是否發生不同等級轉移。

### 非金融資產減值

倘有跡象顯示出現減值，或須就資產進行年度減值測試(存貨、遞延稅項資產、金融資產及非流動資產除外)，則會估計資產的可收回金額。資產的可收回金額按資產或現金產生單位的使用價值及其公平值減出售成本兩者中的較高者計算，並就個別資產而釐定，除非相關資產並無產生在頗大程度上獨立於其他資產或資產組別的現金流入，在此情況下，可收回金額就資產所屬的現金產生單位而釐定。於測試現金產生單位的減值狀況時，倘可在合理及一致的基礎上進行分配，則公司資產(例如總部大樓)的一部分賬面值會分配予個別現金產生單位，否則分配予最小的現金產生單位組別。

減值虧損僅於資產賬面值超逾其可收回金額時確認。評估使用價值時，估計未來現金流量按可反映現時市場對貨幣期間價值及資產特定風險的評估的稅前貼現率貼現至其現值。減值虧損乃於其在與該已減值資產的功能一致的該等開支類別中產生期間自損益中扣除。

於各報告期間末，將評估是否有跡象顯示先前確認的減值虧損可能不再存在或可能已減少。倘出現有關跡象，則會估計可收回金額。資產(商譽除外)過往確認的減值虧損僅在用以釐定該項資產可收回金額的估計改變時撥回，但撥回後的金額不得高於過往年度該項資產並無確認減值虧損的情況下而釐定的賬面值(扣除任何折舊後)。撥回的減值虧損於其產生期間計入損益。

### Fair value measurement (continued)

For assets and liabilities that are recognised in the financial statements on a recurring basis, the Group determines whether transfers have occurred between levels in the hierarchy by re-assessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

### Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, deferred tax assets, financial assets and non-current assets), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs. In testing a cash-generating unit for impairment, a portion of the carrying amount of a corporate asset (e.g., a headquarters building) is allocated to an individual cash-generating unit if it can be allocated on a reasonable and consistent basis or, otherwise, to the smallest group of cash-generating units.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to profit or loss in the period in which it arises.

倘任何一方符合以下條件，則被視為與本集團有關聯：

- (a) 倘該方屬以下一方或以下一方的家庭近親成員，且該方：
- (i) 控制或共同控制本集團；

  - (iii) 為本集團或本集團母公司的主要管理層成員；

或

- (b) 倘該方為符合下列任何條件的實體：
- (i) 該實體與本集團屬同一集團的成員公司；
  - (ii) 一間實體為另一實體(或另一實體的母公司、附屬公司或同系附屬公司)的聯營公司或合營企業；

- (b) the party is an entity where any of the following conditions applies:
- (i) the entity and the Group are members of the same group;
  - (ii) one entity is an associate or joint venture of the other entity (or of a parent, subsidiary or fellow subsidiary of the other entity);
  - (iii) the entity and the Group are joint ventures of the same third party;
  - (iv) one entity is a joint venture of a third entity and the other entity is an associate of the third entity;
  - (v) the entity is a post-employment benefit plan for the benefit of employees of either the Group or an entity related to the Group;
  - (vi) the entity is controlled or jointly controlled by a person identified in (a);
  - (vii) a person identified in (a)(i) has significant influence over the entity or is a member of the key management personnel of the entity (or of a parent of the entity); and
  - (viii) the entity, or any member of a group of which it is a part, provides key management personnel services to the Group or to the parent of the Group.

物業、廠房及設備(在建工程除外)按成本減累計折舊及任何減值虧損列賬。物業、廠房及設備項目的成本包括其購買價及任何使資產達致其運作狀況及地點作擬定用途的直接應佔成本。

物業、廠房及設備項目投入營運後產生的開支(如維修及保養)一般於產生期間自損益表扣除。在符合確認條件的情況下,重大檢查支出會於資產的賬面值中撥充資本作為重置成本。倘物業、廠房及設備的主要部分須定期替換,本集團會確認該等部分為有特定可使用年期的個別資產,並對其作出相應折舊。

折舊乃按各項物業、廠房及設備的估計可使用年期以直線法撇銷其成本至其剩餘價值計算。就此採用的主要年率如下:

倘物業、廠房及設備項目各部分的可使用年期不同,則該項目的成本按合理基準分配至各部分,而各部分將分開折舊。剩餘價值、可使用年期及折舊方法至少於各財政年度末檢討及調整(如適用)。

Property, plant and equipment, other than construction in progress, are stated at cost less accumulated depreciation and any impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to the statement of profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Depreciation is calculated on the straight-line basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. The principal annual rates used for this purpose are as follows:

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

### 物業、廠房及設備及折舊(續)

物業、廠房及設備項目(包括初步確認的任何重大部分)於出售或預期使用或出售不會產生未來經濟利益時終止確認。於資產終止確認年度在損益表確認的任何出售或報廢收益或虧損，為相關資產的出售所得款項淨額與賬面值的差額。

在建工程指樓宇及機器，按成本減任何減值虧損列賬，且不予折舊。成本包括直接建築成本。在建工程於完成及可供使用時重新分類至物業、廠房及設備的適當類別。

### 無形資產(商譽除外)

獨立收購的無形資產於初步確認時按成本計量。於業務合併中收購的無形資產的成本為於收購當日的公平值。無形資產的可使用年期評估為有限。年期有限的無形資產其後於可使用經濟年期內攤銷，並於有跡象顯示無形資產可能出現減值時評估減值。另一項可使用年期有限的無形資產的攤銷期及攤銷方法至少於各財政年度末檢討一次。

An item of property, plant and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in the statement of profit or loss in the year the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

Construction in progress represents buildings and machinery, which are stated at cost less any impairment losses, and are not depreciated. Cost comprises the direct costs of construction. Construction in progress is reclassified to the appropriate category of property, plant and equipment when completed and ready for use.

### Intangible assets (other than goodwill)

Intangible assets acquired separately are measured on initial recognition at cost. The cost of intangible assets acquired in a business combination is the fair value at the date of the acquisition. The useful lives of intangible assets are assessed to be finite. Intangible assets with finite lives are subsequently amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortisation period and the amortisation method for another intangible asset with a finite useful life are reviewed at least at each financial year end.

The principal estimated useful lives of intangible assets are as follows:

#### 軟件

軟件按成本減任何減值虧損列賬，並按其估計可使用年期2至10年以直線法攤銷。

#### 礦泉水採礦許可證

礦泉水採礦許可證按成本列賬，並以直線法按許可證期限攤銷。

#### 其他

其他(包括專利及排放權)按成本列賬，並以直線法按其估計可使用年期5至10年攤銷。

#### 研發成本

所有研究成本於產生時自損益表扣除。

開發新產品項目所產生的開支僅會在本集團可證實其完成該無形資產使之可供使用或出售的技術可行性、其有意完成及其有能力使用或出售該資產、該資產將產生未來經濟利益的方式、具有可用資源完成項目以及於開發階段的開支能夠可靠地計量時，方會予以資本化及遞延。未符合上述準則的產品開發開支於產生時支銷。

### Intangible assets (other than goodwill) (continued)

#### Software

Software is stated at cost less any impairment losses and is amortised on the straight-line basis over its estimated useful lives of 2 to 10 years.

#### Mineral water mining licence

Mineral water mining licence is stated at cost and is amortised on the straight-line basis over the licence term.

#### Others

Others include patents and emission right, which are stated at cost and amortised on the straight-line basis over their estimated useful lives of 5 to 10 years.

#### Research and development costs

All research costs are charged to the statement of profit or loss as incurred.

Expenditure incurred on projects to develop new products is capitalised and deferred only when the Group can demonstrate the technical feasibility of completing the intangible asset so that it will be available for use or sale, its intention to complete and its ability to use or sell the asset, how the asset will generate future economic benefits, the availability of resources to complete the project and the ability to measure reliably the expenditure during the development. Product development expenditure which does not meet these criteria is expensed when incurred.

### 租賃

本集團於合約開始時評估合約是否為租賃或包含租賃。如果合同表達在一段時期內控制已識別資產使用以換取代價的權利，則該合約為租賃或包含租賃。

#### 本集團作為承租人

本集團就所有租賃(不包括短期租賃及低價值租賃)應用單一確認及計量法。本集團確認租賃負債以進行租賃付款及確認使用權資產(相當於使用相關資產的權利)。

#### (a) 使用權資產

使用權資產在租賃開始日期(即相關資產可供使用之日)確認。使用權資產按成本減任何累計折舊以及任何減值虧損進行計量，並就租賃負債的任何重新計量進行調整。使用權資產的成本包括已確認的租賃負債款項，已產生的初始直接成本以及在開始日期或之前支付的租賃付款額減已收到的任何租賃激勵。使用權資產按租賃期和資產的估計使用期限中的較短者按直線法計提折舊如下：

倘若租賃資產的所有權在租賃期結束時轉移至本集團或成本反映購買期權的行使，則使用資產的估計使用期限計算折舊。

### Leases

The Group assesses at contract inception whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

#### Group as a lessee

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

#### (a) Right-of-use assets

Right-of-use assets are recognised at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease terms and the estimated useful lives of the assets as follows:

If ownership of the leased asset transfers to the Group by the end of the lease term or the cost reflects the exercise of a purchase option, depreciation is calculated using the estimated useful life of the asset.

**(b) 租賃負債**

租賃負債於租賃開始日期按租賃期內作出的租賃付款之現值確認。租賃付款包括固定付款(包括實質固定付款)減去任何應收租賃優惠、取決於某一指數或比率的可變租賃付款、以及預期根據剩餘價值擔保支付的金額。租賃付款亦包括本集團合理確定將行使的購買選擇權之行使價，以及在租賃條款反映了本集團行使選擇權終止租賃之情況下因終止租賃而支付的罰款。不取決於某一指數或比率的可變租賃付款於觸發付款的事件或條件發生的期間確認為開支。

於計算租賃付款之現值時，由於租賃中隱含的利率不易確定，則本集團採用其於租賃開始日期的遞增借貸利率。於開始日期後，租賃負債金額會增加以反映利息的增長，並就所作出的租賃付款作出扣減。此外，倘租賃期限存在修改、變動、租賃付款變動(例如因某一指數或比率變動而出現未來租賃付款的變動)或購買相關資產的評估變更，則重新計量租賃負債的賬面值。

**(c) 短期租賃及租賃低價值資產**

本集團對其機器及設備的短期租賃(即自開始之日起租賃期為12個月或更短的租賃且不包含購買期權)應用短期租賃確認豁免。低價值資產租賃的確認豁免亦應用於被認為低價值的辦公設備的租賃。

短期租賃的租賃租金及低價值資產租賃在租期內按直線法確認為支出。

Group as a lessee (continued)

**(b) Lease liabilities**

Lease liabilities are recognised at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate the lease. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset.

**(c) Short-term leases and leases of low-value assets**

The Group applies the short-term lease recognition exemption to its short-term leases of machinery and equipment (that is those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option). It also applies the recognition exemption for leases of low-value assets to leases of office equipment that are considered to be of low value.

Lease payments on short-term leases and leases of low-value assets are recognised as an expense on a straight-line basis over the lease term.

### 租賃(續)

#### 本集團作為出租人

當本集團作為出租人時，其於租賃開始時(或出現租賃變動時)將其各項租賃分類為經營租賃或融資租賃。

所有本集團並未轉讓資產所有權所附帶的絕大部分風險及回報的租賃歸類為經營租賃。當合約包含租賃及非租賃部分時，本集團將合約中的代價按相對獨立售價基準分配至各部分。租賃收益於租期內按直線法入賬並因其經營性質於損益表計入收益。於磋商及安排經營租賃時產生的初始直接成本乃計入租賃資產的賬面值，並於租期內按相同方法確認為租金收益。或然租金乃於所賺取的期間內確認為收益。

將與相關資產所有權有關的絕大部分風險和報酬轉移給承租人的租賃，均作為融資租賃入賬。

### 投資及其他金融資產

#### 初步確認及計量

金融資產於初步確認時分類為其後按攤銷成本、按公平值計入其他全面收益(「其他全面收益」)及按公平值計入損益計量。

金融資產於初步確認時的分類取決於金融資產的合約現金流量特徵，以及本集團管理金融資產的業務模式。除並無重大融資成分或本集團已應用不調整重大融資部分之影響的可行權宜方法的貿易應收款項外，本集團初步按公平值加上(倘金融資產並非按公平值計入損益)交易成本計量金融資產。並無重大融資成分或本集團已應用可行權宜方法的貿易應收款項按根據下文「收益確認」所載政策按國際財務報告準則第15號釐定的交易價格計量。

### Leases (continued)

#### Group as a lessor

When the Group acts as a lessor, it classifies at lease inception (or when there is a lease modification) each of its leases as either an operating lease or a finance lease.

Leases in which the Group does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. When a contract contains lease and non-lease components, the Group allocates the consideration in the contract to each component on a relative stand-alone selling price basis. Rental income is accounted for on a straight-line basis over the lease terms and is included in revenue in the statement of profit or loss due to its operating nature. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income. Contingent rents are recognised as revenue in the period in which they are earned.

Leases that transfer substantially all the risks and rewards incidental to ownership to an underlying asset to the lessee are accounted for as finance leases.

### Investments and other financial assets

#### Initial recognition and measurement

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost, fair value through other comprehensive income ("OCI"), and fair value through profit or loss.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value plus, in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under IFRS 15 in accordance with the policies set out for "Revenue recognition" below.

為使金融資產按攤銷成本或按公平價值計入其他全面收益進行分類及計量，需就「純粹為支付本金及未償還本金的利息(「SPPI」)」的現金流量。具有現金流且並非SPPI的金融資產按公平價值計入損益分類及計量，與業務模式無關。

本集團管理金融資產的業務模式指其如何管理其金融資產以產生現金流量。業務模式確定現金流量是否來自收集合約現金流量、出售金融資產，或兩者兼有。按攤銷成本分類及計量的金融資產按其目的為持有金融資產以收回合約現金流的業務模式持有，而按公平價值計入其他全面收益分類及計量的金融資產則按其目的為持有以收回合約現金流及出售的業務模式持有。不按上述業務模式持有的金融資產，按公平價值計入損益分類及計量。

購買或出售須於市場規定或慣例設定的時間框架內交付資產的金融資產(常規交易)按交易日期(即本集團承諾購買或出售該資產的日期)予以確認。

*後續計量*

金融資產的後續計量取決於其如下分類：

*按攤銷成本計量的金融資產(債務工具)*

按攤銷成本計量的金融資產其後使用實際利率法計量及須進行減值。當資產終止確認、修改或減值時，則損益於損益表中確認。

In order for a financial asset to be classified and measured at amortised cost or fair value through OCI, it needs to give rise to cash flows that are solely payments of principal and interest ("SPPI") on the principal amount outstanding. Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

The Group's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortised cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows, while financial assets classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

Purchases or sales of financial assets that require delivery of assets within a time frame established by regulation or convention in the market place (regular way trades) are recognised on the trade date, i.e., the date that the Group commits to purchase or sell the asset.

*Subsequent measurement*

The subsequent measurement of financial assets depends on their classification as follows:

*Financial assets at amortised cost (debt instruments)*

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in the statement of profit or loss when the asset is derecognised, modified or impaired.

按公平值計入損益的金融資產

按公平值計入損益的金融資產按公平值於財務狀況表列賬，而公平值變動淨額則於損益表確認。

該類別包括本集團並無不可撤回地選擇按公平值計入其他全面收益分類的衍生工具及股本投資。當支付權已確立，與股息相關的經濟利益很可能流入本集團，且股息金額能可靠地計量時，分類為按公平值計入損益的金融資產的股本投資的股息亦於損益表中確認為其他收益。

當嵌入混合合約(包含金融負債及非金融主體)的衍生工具具備與主體不緊密相關的經濟特徵及風險；與嵌入式衍生工具條款相同的單獨工具符合衍生工具的定義；而混合合約並非按公平值計入損益計量，則該衍生工具與主體分開並作為獨立衍生工具列賬。嵌入式衍生工具按公平值計量，而公平值變動於損益表確認。倘合約條款有所變動而須就現金流量作出重大修改，或自按公平值計入損益表類別將金融資產重新分類，方會進行重新評估。

包含金融資產主體的混合合約中嵌入的衍生工具不單獨入賬。金融資產主體連同嵌入式衍生工具須整體分類為按公平值計入損益的金融資產。

Financial assets at fair value through profit or loss

Financial assets at fair value through profit or loss are carried in the statement of financial position at fair value with net changes in fair value recognised in the statement of profit or loss.

This category includes derivative instruments and equity investments which the Group had not irrevocably elected to classify at fair value through OCI. Dividends on equity investments classified as financial assets at fair value profit or loss are also recognised as other income in the statement of profit or loss when the right of payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably.

A derivative embedded in a hybrid contract, with a financial liability or non-financial host, is separated from the host and accounted for as a separate derivative if the economic characteristics and risks are not closely related to the host; a separate instrument with the same terms as the embedded derivative would meet the definition of a derivative; and the hybrid contract is not measured at fair value through profit or loss. Embedded derivatives are measured at fair value with changes in fair value recognised in the statement of profit or loss. Reassessment only occurs if there is either a change in the terms of the contract that significantly modifies the cash flows that would otherwise be required or a reclassification of a financial asset out of the fair value through profit or loss category.

A derivative embedded within a hybrid contract containing a financial asset host is not accounted for separately. The financial asset host together with the embedded derivative is required to be classified in its entirety as a financial asset at fair value through profit or loss.

### 終止確認金融資產

金融資產(或(如適用)一項金融資產或一組同類金融資產的部分)主要於下列情況下終止確認(即從本集團的綜合財務狀況表內剔除):

- 自資產收取現金流量的權利已屆滿;或
- 本集團已轉讓其自資產收取現金流量的權利,或已根據一項「轉付安排」承擔責任,在無重大延誤的情況下將所得現金流量全數付予第三方;及(a)本集團已轉讓資產的絕大部分風險及回報,或(b)本集團並無轉讓或保留資產的絕大部分風險及回報,惟已轉讓資產的控制權。

倘本集團已轉讓其收取該項資產所得現金流量的權利或已訂立轉付安排,會評估其有否保留該項資產擁有權的風險及回報,以及其程度。倘本集團並無轉讓或保留資產的絕大部分風險及回報,亦無轉讓資產的控制權,則本集團繼續按本集團持續參與的程度確認已轉讓資產。在該情況下,本集團亦確認相關負債。已轉讓資產及相關負債按反映本集團所保留權利及責任的基準計量。

以擔保形式對已轉讓資產的持續參與按資產原賬面值與本集團可能須償還的最高代價金額之間的較低者計量。

### Derecognition of financial assets

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e., removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risk and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

### 金融資產減值

本集團就並非按公平值計入損益持有的所有債務工具確認預期信貸虧損(「預期信貸虧損」)撥備。預期信貸虧損乃基於根據合約到期的合約現金流量與本集團預期收取的所有現金流量之間的差額而釐定，並以原實際利率的近似值貼現。預期現金流量將包括來自出售所持抵押品或組成合約條款的其他信貸提升措施的現金流量。

#### 一般方法

預期信貸虧損於兩個階段確認。就自初步確認以來信貸風險並無大幅增加的信貨風險而言，本集團會為未來12個月可能發生的違約事件所產生的信貨虧損(12個月預期信貨虧損)計提預期信貨虧損撥備。對於自初步確認後有顯著增加的信貨風險，須在信貨虧損風險預期的剩餘年期計提虧損撥備，不論違約事件於何時發生(全期預期信貨虧損)。

於各報告日期，本集團評估金融工具的信貨風險自初步確認以來有否大幅增加。於作出評估時，本集團比較金融工具於報告日期發生違約的風險與金融工具於初步確認日期發生違約的風險，並考慮毋須付出不必要成本或努力即可獲得的合理及可靠資料，包括歷史及前瞻性資料。

倘合約付款逾期90日，則本集團認為金融資產違約。然而，在若干情況下，倘內部或外部資料反映，在考慮本集團持有的任何信貸提升措施前，本集團不大可能悉數收到未償還合約款項，則本集團亦可認為金融資產違約。倘無法合理預期收回合約現金流量，則撇銷金融資產。

## 2.4 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

### Impairment of financial assets

The Group recognises an allowance for expected credit losses ("ECLs") for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

#### General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

按攤銷成本計量的金融資產須根據一般方法進行減值，並就計量預期信貸虧損分類為以下階段，惟應用下文詳述的簡化方法的貿易應收款項及合約資產除外。

第一階段 — 信貸風險自初步確認以來並無顯著增加的金融工具，其虧損撥備按相等於12個月預期信貸虧損的金額計量

第二階段 — 自初步確認以來信貸風險顯著增加但並非屬信貸減值金融資產的金融工具，其虧損撥備按相等於全期預期信貸虧損的金額計量

第三階段 — 於報告日期信貸減值的金融資產(但並非購買或原始信貸減值)，其虧損撥備按相等於全期預期信貸虧損的金額計量

*簡化方法*

就並無重大融資成分或本集團應用可行權宜方法不調整重大融資成分影響的貿易應收款項而言，本集團應用簡化方法計算預期信貸虧損。根據簡化方法，本集團不會追蹤信貸風險的變化，而是於各報告日期根據全期預期信貸虧損確認虧損撥備。本集團已設立根據其過往信貸虧損經驗計算的撥備矩陣，並按債務人特定的前瞻性因素及經濟環境作出調整。

Financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade receivables and contract assets which apply the simplified approach as detailed below.

Stage 1 — Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs

Stage 2 — Financial instruments for which credit risk has increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECLs

Stage 3 — Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime ECLs

*Simplified approach*

For trade receivables that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

**2.4 重大會計政策概要(續)****金融負債***初步確認及計量*

金融負債於初步確認時分類為按公平值計入損益的金融負債、貸款及借款、或應付款項(如適用)。

所有金融負債於初步確認時以公平值計量，如屬貸款及借款以及應付款項，則再減去直接應佔交易成本。

本集團的金融負債包括貿易應付款項及應付票據、其他應付款項及應計費用、計息借貸、租賃負債及衍生金融工具。

*後續計量*

金融負債的後續計量取決於其如下分類：

*按公平值計入損益的金融負債*

倘購買該金融負債的目的為於近期購回，則該金融負債應分類為持作交易用途。此分類亦包括本集團根據國際財務報告準則第9號所界定之對沖關係不被指定為對沖工具之衍生金融工具。獨立嵌入式衍生工具亦分類為持作交易用途，除非其被指定為有效的對沖工具則另作別論，持作交易用途的負債損益於損益表內確認。於損益表確認的公平值收益或虧損淨額並不包括任何向該等金融負債所扣除的任何利息。

**2.4 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)****Financial liabilities***Initial recognition and measurement*

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings, or payables, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

The Group's financial liabilities include trade and bills payables, other payables and accruals, interest-bearing borrowings, lease liabilities and derivative financial instruments.

*Subsequent measurement*

The subsequent measurement of financial liabilities depends on their classification as follows:

*Financial liabilities at fair value through profit or loss*

Financial liabilities are classified as held for trading if they are incurred for the purpose of repurchasing in the near term. This category also includes derivative financial instruments entered into by the Group that are not designated as hedging instruments in hedge relationships as defined by IFRS 9. Separated embedded derivatives are also classified as held for trading unless they are designated as effective hedging instruments. Gains or losses on liabilities held for trading are recognised in the statement of profit or loss. The net fair value gain or loss recognised in the statement of profit or loss does not include any interest charged on these financial liabilities.

按攤銷成本計量的金融負債(貸款及借貸)

於初步確認後，計息貸款及借款其後以實際利率法按攤銷成本計量，除非貼現影響並不重大，在此情況下則按成本列賬。當負債終止確認以及按實際利率法進行攤銷程序時，其收益及虧損於損益表內確認。

計算攤銷成本時，應考慮收購產生的任何折讓或溢價，且作為實際利率不可或缺部分的費用或成本。實際利率攤銷計入損益表財務費用項下。

**終止確認金融負債**

當負債項下的責任獲解除或註銷或屆滿時，金融負債將終止確認。

倘一項現有金融負債被來自同一貸款方且大部分條款均有差別的另一項金融負債所取代，或現有負債的條款被大幅修改，此種置換或修改被視作終止確認原有負債並確認新負債處理，而兩者的賬面值差額於損益表確認。

**抵銷金融工具**

倘目前具有合法可執行權利以抵銷確認金額及有意按淨額基準償付，或變現資產與清償負債同時進行，則金融資產及金融負債予以抵銷及淨額於財務狀況表內呈報。

*Financial liabilities at amortised cost (loans and borrowings)*

After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in the statement of profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in the statement of profit or loss.

**Derecognition of financial liabilities**

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in the statement of profit or loss.

**Offsetting of financial instruments**

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

### 存貨

存貨按成本與可變現淨值兩者中的較低者列賬。成本按加權平均成本基準釐定，而就在產品及製成品而言，成本包括直接材料、直接勞工及適當比例的間接成本。可變現淨值按估計售價減完成及出售將產生的任何估計成本計算。

### 現金及現金等價物

就綜合現金流量表而言，現金及現金等價物包括手頭現金及活期存款，以及可隨時轉換為已知數額現金、價值變動風險極微及一般自購入後三個月內到期的短期高流動性投資，減須按要求償還及構成本集團現金管理不可分割部分的銀行透支。

就綜合財務狀況表而言，現金及銀行結餘包括不限用途的手頭現金及銀行現金(包括定期存款及性質與現金相近無受限的資產)。

### 撥備

倘因過往事件而產生現時責任(法定或推定)，且日後可能須流出資源以履行有關責任，則確認撥備，惟責任金額須能可靠估計。

當貼現影響重大時，就撥備而確認的金額為預期結清責任所需未來開支於報告期末的現值。因期間流逝而產生的貼現現值增加計入為損益表的財務費用。

## 2.4 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

### Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined on a weighted average cost basis and, in the case of work in progress and finished goods, comprises direct materials, direct labour and an appropriate proportion of overheads. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to completion and disposal.

### Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the consolidated statement of financial position, cash and bank balances comprise cash on hand and at banks, including term deposits, and assets similar in nature to cash, which are not restricted as to use.

### Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in the statement of profit or loss.

**2.4 重大會計政策概要(續)****所得稅**

所得稅包括即期及遞延稅項。與在損益外確認的項目有關的所得稅，在損益外的其他全面收益或直接在權益中確認。

即期稅項資產及負債，乃根據於各報告期末已頒佈或實質上已頒佈的稅率（及稅法），並考慮本集團經營所在國家的現行詮釋及慣例，按預期自稅務機關退回或付予稅務機關的金額計量。

遞延稅項採用負債法就於各報告期末資產及負債的稅基與其作財務報告用途的賬面值之間的所有暫時差額計提撥備。

所有應課稅暫時差額均確認為遞延稅項負債，惟以下情況除外：

- 倘遞延稅項負債乃因在一項並非業務合併的交易中初步確認商譽或資產或負債而產生，且於交易時並不影響會計溢利或應課稅溢利或虧損；及
- 就與於附屬公司的投資有關的應課稅暫時差額而言，暫時差額的撥回期間為可控制，而該等暫時差額於可見將來可能不會撥回。

**2.4 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)****Income tax**

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted at the end of each reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of each reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- when the deferred tax liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of taxable temporary differences associated with investments in subsidiaries, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future.

### 所得稅(續)

遞延稅項資產乃就所有可扣稅暫時差額、未動用稅項抵免及任何未動用稅項虧損的結轉予以確認。只限於有應課稅溢利可供對銷可扣稅暫時差額，以及可動用結轉的未動用稅項抵免與及未動用稅務虧損的情況下，方會確認遞延稅項資產，惟下列情況除外：

- 與可扣減暫時差額有關的遞延稅項資產乃因在一項並非業務合併的交易中初步確認資產或負債而產生，且於交易時並不影響會計溢利或應課稅溢利或虧損；及
- 就與於附屬公司的投資有關的可扣稅暫時差額而言，遞延稅項資產僅於暫時差額於可見將來有可能撥回以及將有應課稅溢利以動用暫時差額以作對銷的情況下，方予確認。

遞延稅項資產的賬面值於各報告期末進行審閱，並於不再可能有足夠應課稅溢利以動用全部或部分遞延稅項資產時作出調減。未確認的遞延稅項資產於各報告期末重新評估，並在可能有足夠應課稅溢利以收回全部或部分遞延稅項資產時予以確認。

遞延稅項資產及負債乃根據於截至各報告期末已頒佈或實質上已頒佈的稅率(及稅法)，按預期適用於變現資產或清償負債期間的稅率計量。

### Income tax (continued)

Deferred tax assets are recognised for all deductible temporary differences, and the carryforward of unused tax credits and any unused tax losses. Deferred tax assets are recognised to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carryforward of unused tax credits and unused tax losses can be utilised, except:

- when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of deductible temporary differences associated with investments in subsidiaries, deferred tax assets are only recognised to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of each reporting period.

**2.4 重大會計政策概要(續)****政府補助**

政府補助於可合理確定將會收取補助及將符合所有附帶條件時按公平值確認。倘補貼與開支項目有關，則會有系統地在擬補貼成本支銷的相應期間確認補貼為收益。

倘補助與資產有關，則其公平值會計入遞延收益賬項，並按相關資產的預計可使用年期以每年等額分期款項撥回損益表或自該項資產的賬面值中扣除並以降低折舊開支方式撥回損益表。

**收益確認***客戶合約收益*

客戶合約收益於貨品或服務的控制權轉移至客戶時確認，而該金額反映本集團預期就提供該等貨品或服務有權獲得的代價。

當合約中的代價包括可變金額時，估計代價金額為本集團向客戶轉讓貨品或服務而有權換取的金額。可變代價於合約開始時估計並受到約束，直至與可變代價相關的不確定因素其後得到解決時，已確認累計收益金額極有可能不會發生重大收益撥回。

*銷售貨品*

銷售貨品的收益於資產控制權轉移至客戶的時間點(一般為交付貨品時)確認。

若干銷售貨品合約為客戶提供退貨權利及銷售獎勵折扣。退還權及銷售獎勵折扣生可變對價。

**2.4 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)****Government grants**

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, for which it is intended to compensate, are expensed.

Where the grant relates to an asset, the fair value is credited to a deferred income account and is released to the statement of profit or loss over the expected useful life of the relevant asset by equal annual instalments or deducted from the carrying amount of the asset and released to the statement of profit or loss by way of a reduced depreciation charge.

**Revenue recognition***Revenue from contracts with customers*

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

*Sale of goods*

Revenue from the sale of goods is recognised at the point in time when control of the asset is transferred to the customer, generally on delivery of the goods.

Some contracts for the sale of goods provide customers with rights of return and volume rebates. The rights of return and volume rebates give rise to variable consideration.

### 收益確認(續)

#### 退貨權

就向客戶提供於指定期限內享有退回貨物權利的合約而言，採用預期估值法估計將不予以退回的貨物，原因為該方法在預測本集團將有權享有的可變對價金額方面屬最佳。採用國際財務報告準則第15號有關限制估計可變對價的規定，以釐定可計入交易價內的可變對價金額。就預期將予退回的貨物而言，退款負債而非收益得以確認。退貨權資產(及相應調整銷售成本)亦就自客戶收回產品的權利確認。

#### 可變代價：基於數量的銷售獎勵折扣

當期內採購的產品數量超出合約訂明的限度，可向若干客戶提供追溯性銷售獎勵折扣。折扣抵銷客戶應付的金額。為估計預期未來銷售獎勵折扣的可變對價，就單一數量限額的合約採用最可能的金額方法。最佳預測可變對價金額的所選方法主要由合約中包含的多個銷量限額驅動。就此應用有關約束可變動對價之估計的規定，並就預期未來銷售獎勵折扣確認負債。

#### 利息收入

利息收入按應計基準以實際利率法，採用將金融工具在預期可使用年期或較短期間(如適用)的估計未來現金收入準確貼現至金融資產賬面值淨值的利率確認。

#### 合約負債

倘客戶在本集團向客戶轉移貨品或服務前支付代價，則會在作出付款或付款到期時(以較早者為準)確認合約負債。合約負債於本集團根據合約履約時確認為收益(即，將相關商品或服務的控制權轉讓給客戶)。

### Revenue recognition (continued)

#### Rights of return

For contracts which provide a customer with a right of return the goods within a specified period, the expected value method is used to estimate the goods that will not be returned because this method best predicts the amount of variable consideration to which the Group will be entitled. The requirements in IFRS 15 on constraining estimates of variable consideration are applied in order to determine the amount of variable consideration that can be included in the transaction price. For goods that are expected to be returned, instead of revenue, a refund liability is recognised. A right-of-return asset (and the corresponding adjustment to cost of sales) is also recognised for the right to recover products from a customer.

#### Variable consideration: volume-based rebates

Retrospective volume rebates may be provided to certain customers once the quantity of products purchased during the period exceeds a threshold specified in the contract. Rebates are offset against amounts payable by the customer. To estimate the variable consideration for the expected future rebates, the most likely amount method is used for contracts with a single-volume threshold. The selected method that best predicts the amount of variable consideration is primarily driven by the number of volume thresholds contained in the contract. The requirements on constraining estimates of variable consideration are applied and a liability for the expected future rebates is recognised.

#### Interest income

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

#### Contract liabilities

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

### 股份支付

本集團僱員(包括董事)以股份支付方式收取酬金，而僱員則提供服務作為換取股本工具的代價(「股本結算交易」)。

與僱員進行股本結算交易的成本乃參考授出日期的公平值計量。公平值乃根據其最近期的投資後估值計算。

股本結算交易的成本連同股本的相應增加於達成表現及服務條件的期間內於僱員福利開支確認。於各報告期末至歸屬日期就股本結算交易確認的累計開支，反映本集團對歸屬日期屆滿時最終歸屬的股本工具數目的最佳估計。某一期間在損益表中扣除或計入之款項反映該期間開始及結束時確認的累計支出變動。

釐定獎勵之授出日公平值並不考慮服務及非市場表現條件，惟能達成條件之可能性則被評定為將最終歸屬為本集團權益工具數目之最佳估計之一部分。市場表現條件將反映在授出日之公平值。附帶於獎勵中但並無相關聯服務要求之其他任何條件皆視為非歸屬條件。非歸屬條件反映於獎勵之公平值，除非同時具服務及／或績效條件，否則獎勵即時支銷。

### Share-based payments

Employees (including directors) of the Group receive remuneration in the form of share-based payments, whereby employees render services as consideration for equity instruments ("equity-settled transactions").

The cost of equity-settled transactions with employees is measured by reference to the fair value at the date on which they are granted. The fair value is computed based on their most recent post-money valuations.

The cost of equity-settled transactions is recognised in employee benefit expense, together with a corresponding increase in equity, over the period in which the performance and service conditions are fulfilled. The cumulative expense recognised for equity-settled transactions at the end of each reporting period until the vesting date reflects the extent to which the vesting period has expired and the Group's best estimate of the number of equity instruments that will ultimately vest. The charge or credit to the statement of profit or loss for a period represents the movement in the cumulative expense recognised as at the beginning and end of that period.

Service and non-market performance conditions are not taken into account when determining the grant date fair value of awards, but the likelihood of the conditions being met is assessed as part of the Group's best estimate of the number of equity instruments that will ultimately vest. Market performance conditions are reflected within the grant date fair value. Any other conditions attached to an award, but without an associated service requirement, are considered to be non-vesting conditions. Non-vesting conditions are reflected in the fair value of an award and lead to an immediate expensing of an award unless there are also service and/or performance conditions.

### 股份支付(續)

因未能達至非市場表現及／或服務條件，而導致最終並無歸屬之報酬並不會確認支銷，惟包括一項市場或非歸屬條件之報酬，無論市場或非歸屬條件是否達成，其均會被視為已歸屬，前提是所有其他表現及／或服務條件須已達成。

當股本結算獎勵之條款修改時，倘符合有關報酬之原有條款，最低開支按條款並無修改來確認。此外，就增加基於股份之付款之公平值總值或對僱員有利之修改而言，按修改日期之計算確認開支。

當股本結算獎勵註銷時，會視作已於註銷當日處理，而該獎勵尚未確認之任何開支會即時確認。此包括任何未能符合本集團或僱員控制以內非歸屬條件之報酬。然而，倘有一項新報酬替代註銷之報酬，並指定為授出當日之替代報酬，則該項註銷及新報酬會如上段所述被視為原有報酬之修改般處理。

### Share-based payments (continued)

For awards that do not ultimately vest because non-market performance and/or service conditions have not been met, no expense is recognised. Where awards include a market or non-vesting condition, the transactions are treated as vesting irrespective of whether the market or non-vesting condition is satisfied, provided that all other performance and/or service conditions are satisfied.

Where the terms of an equity-settled award are modified, as a minimum an expense is recognised as if the terms had not been modified, if the original terms of the award are met. In addition, an expense is recognised for any modification that increases the total fair value of the share-based payments, or is otherwise beneficial to the employee as measured at the date of modification.

Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately. This includes any award where non-vesting conditions within the control of either the Group or the employee are not met. However, if a new award is substituted for the cancelled award, and is designated as a replacement award on the date that it is granted, the cancelled and new awards are treated as if they were a modification of the original award, as described in the previous paragraph.

本集團於中國大陸經營的附屬公司之僱員須參與由當地市政府運作的中央退休金計劃。本集團須按彼等工資成本的若干百分比向中央退休金計劃作出供款。供款於根據中央退休金計劃規則應付時自損益表扣除。就僱員支付的供款不可用作降低本集團的未來義務，即使有關僱員離職。

海外附屬公司所有合資格僱員的僱員福利乃根據集體勞工協議所載規則作出，並於應付期間入賬列作開支，自損益表扣除。

**借款成本**

收購、建造或生產合資格資產(即需要一段頗長期間方可投入作擬定用途或出售的資產)直接應佔的借款成本均撥充資本，作為該等資產的部分成本。當資產大致可作擬定用途或出售時，該等借款成本不再撥充資本。在特定借款撥作合資格資產的支出前暫時用作投資所賺取的投資收益，須自資本化的借款成本中扣除。所有其他借款成本於產生期間支銷。借款成本包括實體就借入資金而產生的利息及其他成本。

**股息**

末期股息於股東大會上獲股東批准時確認為負債。擬派末期股息於財務報表附註披露。

The employees of the Group's subsidiaries which operate in Mainland China are required to participate in a central pension scheme operated by the local municipal government. The Group is required to contribute a certain percentage of their payroll costs to the central pension scheme. The contributions are charged to the statement of profit or loss as they become payable in accordance with the rules of the central pension scheme. Contributions paid for an employee are not available to reduce the Group's future obligations even if the employee leaves.

Employee benefits to all eligible employees of the overseas subsidiaries are made in accordance with the rules set forth in the collective labour agreement, and recorded as an expense in the period they are due as a charge to the statement of profit or loss.

**Borrowing costs**

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs capitalised. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

**Dividends**

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting. Proposed final dividends are disclosed in the notes to the financial statements.

### 外幣

該等財務報表以本公司的功能貨幣人民幣呈列。本集團旗下各實體自行決定其功能貨幣，而各實體財務報表內的項目均以該功能貨幣計量。本集團實體錄得的外幣交易初步按交易當日各自現行的功能貨幣匯率入賬。以外幣計值的貨幣資產及負債按各報告期末的功能貨幣匯率換算。結算或換算貨幣項目產生的差額於損益表確認。

以外幣按歷史成本法計量的非貨幣項目按首次交易日期的匯率換算。以外幣按公平值計量的非貨幣項目按計量公平值當日的匯率換算。換算按公平值計量的非貨幣項目產生的收益或虧損按與確認該項目公平值變動的收益或虧損一致的方式處理(即公平值收益或虧損於其他全面收益或損益中確認之項目的匯兌差額亦分別於其他全面收益或損益中確認)。

於釐定有關初步確認相關資產的匯率及有關終止確認有關預付代價的非貨幣資產或非貨幣負債的開支或收益時，首次交易日期為本集團初步確認預付代價所產生的非貨幣資產或非貨幣負債當日。倘有多項預先支付或收取的代價，本集團則會就各項預先支付或收取的代價釐定交易日期。

### Foreign currencies

These financial statements are presented in RMB, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of each reporting period. Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation differences on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss are also recognised in other comprehensive income or profit or loss, respectively).

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

### 外幣(續)

若干海外附屬公司的功能貨幣為人民幣以外的貨幣。於各報告期末，該等實體的資產及負債按各報告期末的現行匯率換算為本公司的呈列貨幣，其損益表則按與交易日期現行匯率相約的匯率換算為人民幣。

所產生的匯兌差額於其他全面收益確認，並於匯兌波動儲備累計。出售海外業務時，與該特定海外業務有關的其他全面收益部分於損益表確認。

收購海外業務產生的任何商譽及收購產生的資產及負債賬面值之任何公平值調整，均視作海外業務的資產及負債處理，並按收市匯率換算。

就綜合現金流量表而言，海外附屬公司的現金流量按現金流量產生日期的通行匯率換算為人民幣。海外附屬公司於整個年度內經常產生的現金流量乃按年內的加權平均匯率換算為人民幣。

### Foreign currencies (continued)

The functional currencies of certain overseas subsidiaries are currencies other than RMB. As at the end of each reporting period, the assets and liabilities of these entities are translated into the presentation currency of the Company at the exchange rates prevailing at the end of each reporting period and their statements of profit or loss are translated into RMB at the exchange rates that approximate to those prevailing at the dates of the transactions.

The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve. On disposal of a foreign operation, the component of other comprehensive income relating to that particular foreign operation is recognised in the statement of profit or loss.

Any goodwill arising on the acquisition of a foreign operation and any fair value adjustments to the carrying amounts of assets and liabilities arising on acquisition are treated as assets and liabilities of the foreign operation and translated at the closing rate.

For the purpose of the consolidated statement of cash flows, the cash flows of overseas subsidiaries are translated into RMB at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of overseas subsidiaries which arise throughout the year are translated into RMB at the weighted average exchange rates for the year.

### 3. 主要會計判斷及估計

編製本集團的財務報表需要管理層作出判斷、估計及假設，而該等判斷、估計及假設會影響收益、開支、資產及負債的呈報金額及其隨附披露以及或然負債的披露。該等假設及估計的不確定性可導致需要對未來受影響的資產或負債的賬面值作重大調整的後果。

#### 判斷

於應用本集團會計政策的過程中，除涉及估計的判斷外，管理層已作出以下對財務報表內確認的金額有最重大影響力的判斷：

#### 遞延稅項資產

未動用的稅項虧損及可扣減暫時差額應確認為遞延稅項資產，惟限於有可能動用該虧損及可扣減暫時差額以供抵銷將會錄得的應課稅溢利。確認遞延稅項資產金額須要管理層按可能發生之時間及未來應課稅溢利之數量連同未來課稅規劃策略作出重大判斷。進一步詳情載列於財務報表附註17。

#### 估計不確定性

於各報告期末，有關未來的主要假設及估計不確定因素的其他主要來源(具有導致下個財政年度的資產及負債賬面值出現大幅調整的重大風險)載述如下。

#### 銷售獎勵折扣的可變代價

本集團估計將計入附有銷售獎勵折扣的產品銷售交易價格的可變代價。

本集團就設有單一數量限額的合約按每名客戶作基準分析銷售獎勵折扣。釐定客戶是否可能有權獲得折扣取決於客戶過往享有的折扣及迄今的累計採購量。

### 3. SIGNIFICANT ACCOUNTING JUDGEMENT AND ESTIMATES

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

#### Judgement

In the process of applying the Group's accounting policies, management has made the following judgement, apart from those involving estimations, which has the most significant effect on the amounts recognised in the financial statements:

#### Deferred tax assets

Deferred tax assets are recognised for unused tax losses and deductible temporary differences to the extent that it is probable that taxable profit will be available against which the losses and deductible temporary differences can be utilised. Significant management judgement is required to determine the amount of deferred tax assets that can be recognised, based upon the likely timing and level of future taxable profits together with future tax planning strategies. Further details are contained in note 17 to the financial statements.

#### Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of each reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

#### Variable consideration for volume rebates

The Group estimates variable consideration to be included in the transaction price for the sales of products with volume rebates.

The Group's volume rebates are analysed on a per customer basis for contracts that are subject to a single volume threshold. Determining whether a customer will likely be entitled to a rebate depends on the customer's historical rebate entitlement and accumulated purchases to date.



**3. 主要會計判斷及估計(續)****估計不確定性(續)***銷售獎勵折扣的可變代價(續)*

本集團每年更新其對預期銷售獎勵折扣的評估，並相應調整應付銷售折扣及獎勵折扣。預期獎勵折扣的估計對情況變動敏感，而本集團有關獎勵折扣配額的過往經驗未必能代表客戶日後的實際獎勵折扣配額。

*貿易應收款項預期信貸虧損撥備*

本集團使用撥備矩陣計算貿易應收款項的預期信貸虧損。撥備率乃基於具有類似虧損模式的多個客戶分部組別(即按產品類型、客戶類型及評級以及其他形式的信貸保險劃分)的逾期天數計算。

撥備矩陣初步基於本集團的歷史觀察違約率。本集團將校準矩陣，以前瞻性資料調整歷史信貸虧損經驗。例如，倘預測經濟狀況(即國內生產總值、消費物價指數、存款準備金率、通脹率及失業率)預期將於未來一年惡化，並可導致製造業違約數目增加，歷史違約率將予以調整。在各報告日期，歷史觀察違約率會作更新，並分析前瞻性估計的變化。

對歷史觀察違約率之間關連性的評估、預測經濟狀況及預期信貸虧損屬於重大的估計。預期信貸虧損的金額對環境及預測經濟狀況的變動敏感。本集團的歷史信貸虧損經驗及對經濟狀況的預測亦可能無法代表客戶未來的實際違約情況。有關本集團貿易應收款項預期信貸虧損的資料於附註20披露。

The Group updates its assessment of expected volume rebates yearly and the sales discount and rebate payables are adjusted accordingly. Estimates of expected volume rebates are sensitive to changes in circumstances and the Group's past experience regarding rebate entitlements may not be representative of a customer's actual rebate entitlements in the future.

*Provision for expected credit losses on trade receivables*

The Group uses a provision matrix to calculate ECLs for trade receivables. The provision rates are based on days past due for groupings of various customer segments that have similar loss patterns (i.e., by product type, customer type and rating and other forms of credit insurance).

The provision matrix is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. For instance, if forecast economic conditions (i.e., gross domestic products, consumer price index, deposit reserve ratio, inflation rate and rate of unemployment) are expected to deteriorate over the next year which can lead to an increased number of defaults in the manufacturing sector, the historical default rates are adjusted. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

The assessment of the correlation among historical observed default rates, forecast economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forecast economic conditions. The Group's historical credit loss experience and forecast of economic conditions may also not be representative of a customer's actual default in the future. The information about the ECLs on the Group's trade receivables is disclosed in note 20.

### 3. 主要會計判斷及估計(續)

#### 估計不確定性(續)

##### 租賃－估算增量借款利率

本集團無法輕易釐定租賃內所隱含的利率，因此，使用增量借款利率(「增量借款利率」)計量租賃負債。增量借款利率為本集團於類似經濟環境中為取得與使用權資產價值相近之資產，而以類似抵押品與類似期間借入所需資金應支付之利率。因此，增量借款利率反映了本集團「應支付」的利率，當無可觀察的利率時(如就並無訂立融資交易之附屬公司而言)或當須對利率進行調整以反映租賃之條款及條件時(如當租賃並非以附屬公司之功能貨幣訂立時)，則須作出利率估計。當可觀察輸入數據可用時，本集團使用可觀察輸入數據(如市場利率)估算增量借款利率並須作出若干實體特定的估計(例如附屬公司的獨立信貸利率)。

##### 金融工具的公平值

倘某項金融工具的市場並不活躍，本集團會採用估值技巧估計公平值。估值技巧包括採用最近知情自願交易方進行公平市場交易的價格(如有)、參考另一大致相同工具的現行公平值或折現現金流量分析及期權定價模型。如實際可行，估值技巧會最大限度地使用市場輸入值。

##### 非金融資產減值(商譽除外)

本集團於各報告期末評估所有非金融資產(包括使用權資產)是否有任何減值跡象。其他非金融資產於有跡象顯示賬面值可能無法收回時進行減值測試。倘資產或現金產生單位的賬面值超過其可收回金額(即其公平值減出售成本與其使用價值兩者中的較高者)，則存在減值。公平值減出售成本乃按同類資產公平交易中具約束力的銷售交易所得數據或可觀察市價減出售資產的增量成本計算。計算使用價值時，管理層必須估計資產或現金產生單位的預期未來現金流量，並選擇合適的貼現率計算該等現金流量的現值。

### 3. SIGNIFICANT ACCOUNTING JUDGEMENT AND ESTIMATES (continued)

#### Estimation uncertainty (continued)

##### Leases – Estimating the incremental borrowing rate

The Group cannot readily determine the interest rate implicit in a lease, and therefore, it uses an incremental borrowing rate (“IBR”) to measure lease liabilities. The IBR is the rate of interest that the Group would have to pay to borrow over a similar term, and with a similar security, the funds necessary to obtain an asset of a similar value to the right-of-use asset in a similar economic environment. The IBR therefore reflects what the Group “would have to pay”, which requires estimation when no observable rates are available (such as for subsidiaries that do not enter into financing transactions) or when it needs to be adjusted to reflect the terms and conditions of the lease (for example, when leases are not in the subsidiary’s functional currency). The Group estimates the IBR using observable inputs (such as market interest rates) when available and is required to make certain entity-specific estimates (such as the subsidiary’s stand-alone credit rating).

##### Fair value of financial instruments

If the market for a financial instrument is not active, the Group estimates fair value by using a valuation technique. Valuation techniques include using recent prices in arm’s length market transactions between knowledgeable and willing parties, if available, reference to the current fair value of another instrument that is substantially the same, or discounted cash flow analyses and option pricing models. To the extent practicable, the valuation technique makes the maximum use of market inputs.

##### Impairment of non-financial assets (other than goodwill)

The Group assesses whether there are any indicators of impairment for all non-financial assets (including the right-of-use assets) at the end of each reporting period. Other non-financial assets are tested for impairment when there are indicators that the carrying amounts may not be recoverable. An impairment exists when the carrying value of an asset or a cash-generating unit exceeds its recoverable amount, which is the higher of its fair value less costs of disposal and its value in use. The calculation of the fair value less costs of disposal is based on available data from binding sales transactions in an arm’s length transaction of similar assets or observable market prices less incremental costs for disposing of the asset. When value in use calculations are undertaken, management must estimate the expected future cash flows from the asset or cash-generating unit and choose a suitable discount rate to calculate the present value of those cash flows.

#### 4. 經營分部資料

就管理而言，本集團按其服務劃分業務單位，設有以下五個可呈報經營分部：

- 製造及銷售天然包裝飲用水的水類產品分部；
- 製造及銷售即飲茶的即飲茶類產品分部；
- 製造及銷售功能飲料的功能飲料產品分部；
- 製造及銷售果汁飲料產品的果汁飲料產品分部；及
- 製造及銷售農產品及其他飲料產品的其他產品分部。

管理層個別監察本集團經營分部業績，以便作出資源分配決策及評估表現。分部表現評估乃基於可報告分部溢利，為經調整除稅前溢利之計量。除利息收入、財務費用、其他收入及收益以及總部和企業開支於計量中剔除外，該經調整除稅前溢利計量與本集團除稅前溢利一致。由於管理層不會為資源分配及表現評估而定期審閱該等資料，因此未呈列對分部資產及負債的分析。故此僅呈列分部收益及分部業績。

#### 4. OPERATING SEGMENT INFORMATION

For management purposes, the Group is organised into business units based on their services and has five reportable operating segments as follows:

- the water products segment engages in the manufacture and sale of natural packaged drinking water;
- the ready-to-drink tea products segment engages in the manufacture and sale of ready-to-drink tea beverages;
- the functional drinks products segment engages in the manufacture and sale of functional beverages;
- the juice beverage products segment engages in the manufacture and sale of juice beverage products; and
- the other products segment engages in the manufacture and sale of agricultural products and other beverages.

Management monitors the results of the Group's operating segments separately for the purpose of making decisions about resource allocation and performance assessment. Segment performance is evaluated based on reportable segment profit, which is a measure of adjusted profit before tax. The adjusted profit before tax is measured consistently with the Group's profit before tax except that interest income, finance costs, other income and gains, as well as head office and corporate expenses are excluded from such measurement. No analysis of segment assets and liabilities is presented as management does not regularly review such information for the purposes of resource allocation and performance assessment. Therefore, only segment revenue and segment results are presented.

## 11. 所得稅(續)

### 中國企業所得稅

根據《中華人民共和國企業所得稅法》(「企業所得稅法」)及企業所得稅法實施條例，本集團中國附屬公司的企業所得稅稅率為25%，除非符合以下免稅規定。

於本年度，中國附屬公司的法定中國企業所得稅稅率為25%。根據財政部、國家稅務總局與海關總署聯合發佈的《關於深入實施西部大開發戰略有關稅收政策問題的通知》(財稅[2011]58號)，位於中國西部地區的鼓勵類產業企業，其鼓勵類產業主營業務收益佔企業收益總額70%以上的，於2011年1月1日至2020年12月31日10年期間，有權享有15%的優惠所得稅稅率。根據於2020年4月發佈的《關於延續西部大開發企業所得稅政策的公告》(財稅[2020]23號)，相關附屬公司的鼓勵類產業主營業務收益於財政年度內佔企業收益總額60%以上的，於2021年1月1日至2030年12月31日10年期間，有權享有15%的優惠所得稅稅率。

截至2020年及2021年12月31日止年度，本集團若干中國附屬公司獲認可為「高新技術企業」，及因此有權享有15%的優惠所得稅稅率。有關資格每三年由中國相關稅務機關審閱。

本集團若干中國附屬公司從事農牧業，並有權享有農產品免稅。

### 香港利得稅

截至2020年及2021年12月31日止年度，於香港產生的估計應課稅溢利須按16.5%的法定稅率繳納香港利得稅。由於本集團於2020年並無於香港產生任何應課稅溢利，故並無就香港利得稅計提撥備。

### PRC corporate income tax

Under the Law of the PRC on Enterprise Income Tax (the "EIT Law") and Implementation Regulation of the EIT Law, the EIT rate of the Group's PRC subsidiaries is 25% unless subject to tax exemption set out below.

The statutory PRC enterprise income tax for the PRC subsidiaries is 25% for the year. According to the Tax Relief Notice (Cai Shui [2011] no.58) on the Grand Development of Western Region jointly issued by the Ministry of Finance, the State Administration of Taxation and China Customs, enterprises located in the western region of the PRC with over 70% of the principal revenue generated from the encouraged business activities were entitled to a preferential income tax rate of 15% for 10 years from 1 January 2011 to 31 December 2020. Pursuant to Tax Relief Notice (Cai Shui [2020] no.23) issued in April 2020, each of the relevant subsidiaries is subject to a preferential tax rate of 15% from 1 January 2021 to 31 December 2030, when the principal revenue from the encouraged business exceeds 60% of its total revenue in a fiscal year.

Certain of the Group's PRC subsidiaries are accredited as "High and New Technology Enterprise" and were therefore entitled to a preferential income tax rate of 15% for the years end 31 December 2020 and 2021. Such qualifications are subject to review by the relevant tax authority in the PRC for every three years.

Certain of the Group's PRC subsidiaries are engaged in agriculture and entitled to the tax exemption on agricultural products.

### Hong Kong profits tax

The statutory rate of Hong Kong profits tax was 16.5% for the years ended 31 December 2020 and 2021 on the estimated assessable profits arising in Hong Kong. No provision for Hong Kong profits tax was made as the Group had no assessable profits arising in Hong Kong in 2020.

On 14 August 2020, cash dividends of RMB7,799,760,000 were declared out of historical retained profits of the Company as of 31 December 2019, which were paid in August 2020 to shareholders of the Company.

On 25 June 2021, the Company's shareholders approved the 2020 profit distribution plan at an annual general meeting, pursuant to which cash dividends of RMB0.17 for every share of the Company's 11,246,466,400 shares, in an aggregate amount of RMB1,911,899,000, which were paid in July and August 2021 to shareholders of the Company.

The proposed 2021 final dividend for the year of RMB0.45 per ordinary share, equivalent to an aggregate of approximately RMB5,060,910,000, is subject to the approval of the Company's shareholders at the forthcoming annual general meeting.

The calculation of the basic earnings per share amounts is based on the profit for the year attributable to ordinary equity holders of the parent, and the weighted average number of ordinary shares of 11,246,466,400 (2020: 10,936,782,718) in issue during the year, as adjusted retrospectively to reflect the approval of the issue of stock dividend on the basis of 20 shares for every 10 shares in March 2020 and the subdivision of shares on a one-for-ten basis in August 2020.

The calculation reflects the probability-weighted outcome, the time value of money and reasonable and supportable information that is available at year end about past events, current conditions and forecasts of future economic conditions.

The Group writes off trade receivables when there is information indicating that the counterparty is in severe financial difficulties and there is no realistic prospect of recovery. The Group also takes into account legal advice where appropriate, e.g. when the counterparty has been placed under liquidation or has entered into bankruptcy proceedings, whichever occurs sooner.
