主席報告 CHAIRMAN'S STATEMENT

奧密克戎變異株於二零二一年末及二零二二年初引 發另一輪全球封城,但是發達國家積極推出疫苗接種 計劃,顯著降低了接種疫苗國家於二零二一年數次病 毒變異株爆發而導致的死亡人數。商業社會及普羅大 眾在很大程度上已經習慣漫長疫情時代下的新常態。

業務回顧

於二零二一年,我們同時面臨機遇及挑戰。我們受益於中華人民共和國(「**中國**」)強勁的業務復甦以及 Personify軟件應用的日益普及。然而,我們的新零售 業務因台灣疫情而受到影響,而我們的品牌授權及供 應鏈管理(「**BLSC**」)業務則因全球電子元件供應短缺 及全球運輸供應鏈瓶頸而受到影響。儘管存在該等不 利因素,我們的二零二一年整體收入及淨利潤仍然成 功取得增長。

於報告年度,向海外客戶交付數個大型解決方案,顯 著提升工業解決方案業務的業績。於智慧辦公業務方 面,我們於二零二一年三月二十二日完成從鴻海精密 工業股份有限公司(「鴻海」)及其子公司(統稱「鴻海集 團」)收購一攬子Personify相關知識產權。此外,於報 告年度我們的BLSC業務逐漸從北美擴展至亞洲及歐 洲市場。因此,我們現時擁有來自世界各主要地區更 為平衡的收入組合。

業務展望

我們對海外客戶的工業解決方案訂單感到樂觀,它 們預計將為我們二零二二年的業績作出貢獻。由於 對成本及地緣政治風險的擔憂,大型製造商正將產 能從中國分散至海外市場,有鑒於此,我們將繼續物 色在中國及海外市場的機遇。於智慧辦公業務方面, Personify及BLSC業務正處於擴張狀態,並計劃於二 零二二年推出新產品。

本人謹此感謝所有持份者的持續支持,並感謝董事、 管理層及所有員工為本集團持續成功作出的寶貴貢 獻。 Omicron variant induced another round of global lockdown in late 2021 and early 2022. However, the aggressive roll-out of the vaccination programs in developed countries notably reduced the fatality numbers in vaccinated countries from the outbreak of numerous virus variants in 2021. Business communities and general public are largely used to the new normal under the prolonged pandemic era.

BUSINESS REVIEW

We faced both opportunities and challenges in 2021. We benefited from the resilient business recovery in the People's Republic of China (the "**PRC**") and the increasing adoption of Personify's software applications. However, our new retail business was distorted due to the outbreaks in Taiwan and our brand licensing and supply chain management ("**BLSC**") business has suffered because of the global supply shortages of electronic components and worldwide transportation supply chain bottlenecks. Despite those headwinds, we managed to increase our overall revenue and net profit in 2021.

The delivery of a number of sizable solutions to overseas clients boosted the performance of the industrial solution business remarkably during the reporting year. For smart office business, we completed the acquisition of a basket of Personify related intellectual properties from Hon Hai Precision Industry Company Limited ("Hon Hai") and its subsidiaries (collectively, the "Hon Hai Group") on 22 March 2021. In addition, our BLSC business gradually expanded to Asian and European markets from North America during the reporting year. As a results, we now have a more balanced revenue mix from major regions of the world.

BUSINESS OUTLOOK

The backlog orders from oversea clients for our industrial solutions are promising and they are expected to contribute to our performance in 2022. Given sizable manufacturers are diversifying their production capacities from the PRC to overseas markets due to cost and geopolitical risk concerns, we shall continue to explore opportunities in both the PRC and oversea markets. For smart office business, both Personify and BLSC businesses are in an expansion mood and scheduled to launch new products in 2022.

I would like to express our gratitude to all our stakeholders for their continuous supports, and to our directors, management and all our employees for their dedications and invaluable contributions to our sustainable success.

管理層討論及分析 MANAGEMENT DISCUSSION AND ANALYSIS

財務回顧

本集團主要從事工業解決方案、智慧辦公及新零售業務。與二零二零年相比,報告年度的收入及淨利潤分別增長14%及134%至人民幣596.3百萬元(二零二零年:人民幣523.4百萬元)及人民幣34.3百萬元(二零二零年:人民幣14.6百萬元)。倘撇除按公平值計入損益 之金融資產之公平值變動及股份支付開支,核心淨利 潤增加34%至人民幣26.3百萬元。

存貨及營業應收賬項

於二零二一年十二月三十一日,存貨約為人民幣 110.1百萬元(二零二零年:人民幣23.2百萬元),存貨 主要為待交付予客戶的項目相關硬件及軟件產品,以 及BLSC業務的製成品。相較二零二零年全年,報告年 度的存貨週轉由23天升至50天,主要由於關鍵電子元 件全球供應短缺,令BLSC業務需要囤積存貨所致。

於二零二一年十二月三十一日,營業及租賃應收賬項 約為人民幣195.1百萬元(二零二零年:人民幣202.0 百萬元),包括流動及非流動部分分別為人民幣182.4 百萬元(二零二零年:人民幣181.4百萬元)及人民幣 12.7百萬元(二零二零年:人民幣20.6百萬元)。我們 將若干項目包裝為融資租賃的模式,客戶可於特定年 份內分期付款。本報告年度的營業及租賃應收賬項週 轉由二零二零年的149天降至122天,僅由於在疫情期 間,我們加大了追收賬款及監控逾期賬款的力度。

流動資金及財務資源

我們於二零二一年十二月三十一日處於現金淨值狀 態,現金及現金等價物為人民幣189.1百萬元(二零二 零年:人民幣212.4百萬元)。我們的資產總值為人民 幣641.9百萬元(二零二零年:人民幣536.4百萬元), 資金來自總負債人民幣229.4百萬元(二零二零年:人 民幣181.6百萬元)及股東權益人民幣412.5百萬元(二 零二零年:人民幣354.8百萬元)。儘管本集團於年 內可用之銀行預批信貸額度總額為人民幣30.6百萬元 (二零二零年:無),但均未被動用,且我們並無銀行 借款(二零二零年:無)。我們的流動比率為2.4(二零 二零年:2.7)。應付營業賬項須於一年內償還。

庫務政策

我們的營運經費一般以內部資源撥付。我們採用審慎 的庫務管理方法,因此於整個報告年度維持穩健的流 動資金狀況。我們對外部客戶進行定期信貸評估來盡 力降低信貸風險。

FINANCIAL REVIEW

The group principally engages in industrial solution, smart office and new retail businesses. Our revenue and net profit increased by 14% and 134% to RMB596.3 million (2020: RMB523.4 million) and RMB34.3 million (2020: RMB14.6 million) respectively for the reporting year when compared with those of 2020. If the fair value change on financial assets at fair value through profit or loss and the share-based payment were stripped, core net profit increased by 34% to RMB26.3 million.

Inventory and Trade Receivable

As at 31 December 2021, there were approximately RMB110.1 million in inventory (2020: RMB23.2 million) and they are primarily project-related hardware and software products pending to be delivered to our customers, and finished goods for BLSC business. Inventory turnover for the reporting year increased to 50 days from 23 days as compared to the year of 2020 mainly because of the stack-up of inventory for BLSC business in light of global supply shortage of key electronic components.

As at 31 December 2021, there were approximately RMB195.1 million in trade and lease receivables (2020: RMB202.0 million) which consisted of current and non-current portion of RMB182.4 million (2020: RMB181.4 million) and RMB12.7 million (2020: RMB20.6 million) respectively. Some of our projects have been structured as finance lease in which customers are eligible to pay in periodic instalments over a specific number of years. Trade and lease receivable turnover for the reporting year declined to 122 days from 149 days as compared to the year of 2020 solely due to our increasing efforts on debt collection and ageing debt monitoring under the pandemic period.

Liquidity and Financial Resources

As at 31 December 2021, we had a net cash position while our cash and cash equivalents were RMB189.1 million (2020: RMB212.4 million). Our total assets of RMB641.9 million (2020: RMB536.4 million) were financed by total liabilities of RMB229.4 million (2020: RMB181.6 million) and shareholders' equity of RMB412.5 million (2020: RMB354.8 million). Although there were a total amount of RMB30.6 million banking facilities available to the group (2020: Nil), none of them were utilised during the year and we had no bank borrowing (2020: Nil). We had a current ratio of 2.4 (2020: 2.7). Trade payables were repayable within one year.

Treasury Policy

We generally financed our operations with internally generated resources. We have adopted a prudent management approach for our treasury policies and therefore maintained a healthy liquidity position throughout the reporting year. We strive to reduce credit risk exposure by performing periodic credit evaluations of our external customers.

財務回顧 (續)

外匯風險

我們的業務主要位於中國、台灣、香港、美利堅合眾 國(「美國」)、歐洲及東南亞,其中大部份交易以人民 幣、美元、新台幣、港元、歐元、英鎊及越南盾結算。 我們面對各類貨幣的外匯風險,但主要為美元的外匯 風險。我們已訂立政策,要求我們的集團公司管理與 其功能貨幣有關的外匯風險,包括有關集團公司因以 非自身功能貨幣銷售及購貨而引起之風險。我們亦透 過定期檢討本集團的淨外匯風險以管理外匯風險及 考慮使用外匯合約以管理外匯風險(倘適用)。我們並 無使用衍生金融工具作投機用途。

業務回顧

工業解決方案業務

我們為客戶提供全方位的智能製造解決方案及服務, 包括i)將軟件系統(即企業資源規劃、製造執行系統、 倉庫管理系統等)及自動化設備安裝至生產線上,通 過智能化流程以降低成本及提高運營效率及效益;ii) 安裝監控生產廠房水、電及天然氣使用效益之設施監 控系統;及iii)安裝用於整個工業園區工人及保安管理 之人臉識別系統。我們亦就以上智能製造解決方案提 供日常的資訊科技營運服務及安裝後維護工作。由於 中國市場業務強勁復甦及向海外客戶交付數個大型 項目,報告年度分部收入及利潤較二零二零年分別增 加33%及40%至人民幣333.3百萬元及人民幣44.4百 萬元。

智慧辦公業務

智慧辦公業務包括Personify及BLSC業務。與二零二 零年相比,本報告年度的分部收入上升1%至人民幣 236.0百萬元,但分部利潤則減少63%至人民幣3.2百 萬元。

FINANCIAL REVIEW (continued)

Foreign Exchange Exposure

We mainly operate in the PRC, Taiwan, Hong Kong, the United States of America (the "**US**"), Europe and Southeast Asia with most of the transactions settled in Chinese yuan, US dollars, New Taiwanese dollars, Hong Kong dollars, Euro, British pound and Vietnamese dong. We are exposed to foreign exchange risk from various currencies, primarily with respect to US dollars. We have a policy to require our group companies to manage their foreign exchange risk against their functional currencies which includes managing the exposures arising from sales and purchases made by the relevant group companies in currencies other than their own functional currencies. We also manage our foreign exchange risk by performing regular reviews of the group's net foreign exposures and would consider the use of foreign exchange contracts to manage foreign exchange risks, where appropriate. We did not use derivative financial instruments for speculative purposes.

BUSINESS REVIEW

Industrial Solution Business

We provide full range of smart manufacturing solutions and services to our customers, including i) the implementation of a combination of software system (i.e. enterprise resources planning, manufacturing execution system, warehouse management system etc.) and automation equipment into the production lines to enable smart processes that lower costs and increase operational effectiveness and efficiency; ii) the implementation of facility monitor and control system for monitoring the efficiency of the usage of water, power and gas to production plants; and iii) the implementation of facial recognition system for labour and security management of the entire industrial parks. We also provide daily I.T. operating services and after-installation maintenance work in relation to those smart manufacturing solutions. Due to the resilient business recovery in the PRC market and the delivery of a number of sizable projects to overseas clients, segment revenue and profit increased by 33% and 40% to RMB333.3 million and RMB44.4 million respectively during the reporting year when compared with the year of 2020.

Smart Office Business

Smart office business consists of Personify plus BLSC business. Segment revenue soared 1% to RMB236.0 million but segment profit fell 63% to RMB3.2 million during the reporting year when compared with the year of 2020.

智慧辦公業務 (續)

Personifv業務向兩組客戶提供服務,即B2C客戶及 B2B客戶。B2C客戶通過定期或一次性方式訂購軟件 應用,而B2B客戶可以協商價格訂購軟件應用或將相 關技術嵌入其自己的現有軟件或網絡產品中。自疫情 爆發起對該等應用產品的需求急劇增加,因為疫情導 致封城,視訊會議成為新常態的一部分,而且人們大 多被要求在家工作。於二零二一年三月完成向鴻海 集團收購目標資產後,我們加快了對該業務的營銷 及研究工作。由於發達國家積極展開疫苗接種計劃 及從疫情中逐漸恢復過來,一如預期B2C業務的收入 較二零二零年按比例減半,但降幅被B2B業務收入翻 倍所抵銷有餘,而此乃得益於報告年度新簽訂的企業 合約以及現有企業客戶的高續約率。除歐美企業客戶 外,我們亦成功增加亞洲客戶。與二零二零年相比, Personify業務的總收入按比例增長20%以上。於報告 年度,我們於新產品開發及現有產品改進方面投入大 量資源,導致研發費用大幅增加,並對該分部的利潤 構成壓力,但被視為為了公司的未來利益所作投入, 通過使用所收購的電腦視覺技術擴展Personify業務的 產品系列。

於BLSC業務方面,報告年度我們已從美國市場擴展 至歐洲、東南亞及中國市場。於二零二一年上半年, 此業務受全球關鍵電子元器件供應短缺及運輸供應 鏈瓶頸的嚴重影響。然而,此業務於下半年迎頭趕 上,全年取得令人滿意的業績。

新零售業務

我們正在探索台灣零售業數字標牌解決方案的新機 遇。於二零二零年我們為一家台灣著名超市營運商的 600家門店完成安裝專有數字標牌解決方案。憑藉對 該解決方案的積極反饋,我們獲得同一客戶的二期項 目訂單,為其台灣的餘下400多家門店進行解決方案 安裝。然而,二期項目進度由於二零二一年年中台灣 爆發的疫情而嚴重受阻。因此,報告年度分部收入及 利潤較二零二零年均減少32%至人民幣27.1百萬元及 人民幣3.7百萬元。

BUSINESS REVIEW (continued)

Smart Office Business (continued)

Personify business serves two group of customers, namely B2C and B2B customers. B2C customers subscribe the software applications through periodic or one-off subscriptions while B2B customers subscribe the applications or embed the technology in their own existing software or webbased products on negotiated fees. Demand for the applications increased dramatically since the outbreak of the pandemic because video conferencing becomes a part of the new normal following the pandemic induced lockdown and people are largely required to work from home. After the completion of the acquisition of the Target Assets from Hon Hai Group in March 2021, we have accelerated our marketing and research efforts in this business. Due to the aggressive roll-out of the vaccination programs and the gradual recovery from pandemic in the developed countries, revenue from B2C business, as expected, was halved on a pro-rata basis when compared with the year of 2020 but the fall was more than offset by the doubling of the revenue from B2B business. Thanks to the new corporate contracts entered plus a high renewal rate of the existing corporate clients during the reporting year. On top of the corporate clients from US and Europe, we have successfully added clients from Asia. Aggregate revenue for Personify business increased by over 20% on a pro-rata basis when compared with the year of 2020. We have invested heavily in developing new products as well as enhancing our existing products and resulted in drastic increase in research and development expenses which hammered the profit of this segment during the reporting year. However, it is considered as the investment for the future benefits of the company by expanding the product family of Personify business using the acquired computer vision technology.

For BLSC business, we have expanded into Europe, Southeast Asia and China markets from the US market during the reporting year. The business was severely distorted by the worldwide supply shortage of key electronic components and transportation supply chain bottlenecks in the first half of 2021. However, it managed to catch up in the second half and achieved satisfactory results for the whole year.

New Retail Business

We are delving into new opportunities for our digital signage solutions in the retail sector of Taiwan. We completed installing our proprietary digital signage solutions into 600 supermarket stores operated by a preeminent player in Taiwan in 2020. With positive feedback for the solutions, we have been granted the second phase project from the same customer, installing the solutions into the rest of its stores in Taiwan, amounting to over 400 stores. However, the progress of the second phase project was severely disrupted by the outbreak of the pandemic in Taiwan in mid-2021. As a result, both segment revenue and profit dropped by 32% to RMB27.1 million and RMB3.7 million respectively during the reporting year when compared with the year of 2020.

業務前景

工業解決方案業務

在最新的中美地緣政治環境及疫情引發封城之後,製 造業的具規模參與者正採取多元化策略。彼等將繼續 維持於中國的業務,但與此同時,彼等會將相當一部 分產能分散至海外市場以降低風險。未來我們將繼續 努力同時發展在中國及海外市場的業務。此外,我們 注意到部分客戶迅速擁抱新興技術,並開展或計劃開 展電動汽車及/或元宇宙相關產品的生產,這可能為 我們日後的業務带來新的機遇。

智慧辦公業務

我們將繼續在Personify業務上投入研發、銷售及營銷 資源。新產品的Beta測試已經於二零二一年末開始, 而我們正密切注視市場反饋。在正式推出新產品後, 我們將加大對該業務的銷售及營銷力度。自二零二一 年以來,我們將部分研發工作外包予烏克蘭資訊科技 的承包商,以加快產品開發,並以具有競爭力的成本 使用此東歐國家的資訊科技人才資源。最近的俄烏戰 爭可能會對我們部分新產品的推出造成影響。我們將 密切監察事件的發展並採取適當措施,以減少對我們 業務的潛在不利影響。就BLSC業務而言,我們正與供 應商緊密合作,推出新產品型號,以滿足客戶的需求 並提高我們的整體競爭力。

新零售業務

我們將於二零二二年上半年完成於台灣的第二階段 數字零售標牌項目,並正在積極物色大中華區內的機 會以發展我們的業務。

主要風險及不明朗因素

本公司的業務風險主要為以下各項:

- (i) 全球及中國之宏觀經濟狀況,而此將影響對資 訊科技相關的解決方案、服務及產品的總體需 求;
- (ii) 市場對我們的工業、智慧辦公及新零售解決方 案的接受程度;
- (iii) 瞬息萬變的技術變革可能會不可預測地打亂 我們現有的解決方案及產品在市場的地位及 對我們該等解決方案及產品的需求;及
- (iv) 由於海外業務擴張及近年來主要功能貨幣匯 率的較大波動,導致匯兌風險增加。

BUSINESS PROSPECT

Industrial Solution Business

In wake of the latest Sino-US geopolitical environment and pandemic induced lockdowns, sizable players in manufacturing sector are adopting diversification strategies. They will continue to maintain their operations in China but, at the same time, they will diversify a meaningful share of their production capacity to overseas markets in order to mitigate risks. We shall continue our business development efforts in both the PRC and overseas markets going forward. Furthermore, we witnessed some of our customers have rapidly embraced new emerging technologies and commenced or planned to commence their productions in electric vehicles and/or metaverse related products which may provide new business opportunities to our business in the future.

Smart Office Business

We shall continue to devote our research and development and sales and marketing efforts on Personify business. Beta testing on the new products has commenced since late 2021 and we are closely monitoring the market feedback. Once the new products are officially launched, we shall dedicate more sales and marketing efforts on this business. Since 2021, we have outsourced part of the research and development work to I.T. contractors based in Ukraine in order to speed up our product development as well as tap into the IT talent pools of this Eastern European country at competitive cost. The recent Russia-Ukraine war may create complications for the launch of some of our new products. We shall closely monitor the development of the incident and adopt appropriate measures with an aim of reducing the potential adverse impacts to our business. For BLSC business, we are working closely with our suppliers in launching new product models to cater for the needs of our customers as well as enhancing our overall competitiveness.

New Retail Business

We shall complete our second phase digital retail signage project in Taiwan in the first half of 2022 and we are actively exploring opportunities in Greater China region in a bid to develop our business.

PRINCIPAL RISKS AND UNCERTAINTIES

The company's business risks are mainly the following:

- macroeconomic conditions of the globe and the PRC which in turn will affect the general demand of I.T. solutions, services and products;
- (ii) market acceptance of our industrial, smart office and new retail solutions;
- (iii) rapid technological changes that may disrupt the market positions and demand of our existing solutions and products unpredictably; and
- greater foreign exchange risk exposure due to the expansion of our overseas businesses and higher volatility in major functional currencies in recent years.

(「買方」)與鴻海全資子公司 Foxconn (Far East) Limited (「賣方」) 宣佈, 三方於二 零二零年十二月二十四日就買方向賣方收購一籃子 知識產權(「目標資產」)訂立收購協議(「收購協議」), 目標資產包括(i)13項專利;(ii) Personify商標;(iii) 26 個軟件組件(包括「Presenter」及「ChromaCam」);及 (iv) 11個域名,代價為23.34百萬港元。於該交易完成 後,該代價將以按每股股份0.5港元向賣方發行46.68 百萬股新股份(相當於本公司經擴大股權之6.65%)的 方式支付。其乃須予披露交易及關連交易,且須向香 港證券及期貨事務監察委員會「證監會」)申請清洗豁 免。詳情載於本公司日期為二零二零年十二月二十七 日的公告及本公司日期為二零二一年二月二十二日 的通函。目標資產之收購獲本公司獨立股東(「獨立 股東」)(於二零二一年三月十五日舉行之股東特別大 會(「**股東特別大會**」)上批准,並於二零二一年三月 二十二日完成。

憑藉目標資產的所有權,(a)我們可通過探索各種可行 業務選擇,制定更全面之業務發展及營銷策略,包括 但不限於通過轉授專利及/或提供源代碼或相關軟 件開發套件使用權,授權他人使用其技術,從而產生 額外許可費;(b)我們有更大的動力投入資源開發新的 及現有應用及產品;(c)從長遠來看此將節省成本,因 為我們於收購目標資產後將不再需支付目標資產之 許可費;及(d)此將消除買方與其許可方之間現有許可 安排連續性方面的不確定性。我們認為,該收購事項 符合本公司及股東的整體利益。

鑒於交易完成日期的當天收市股價遠高於每股0.5港 元,從會計角度而言,以基於完成日期的收市股價計 算的總代價與目標資產的相關價值存在顯著差異。因 此,在報告年度產生以股份支付的開支為人民幣10.5 百萬元。

除上文所披露者外,我們於本報告年度並無子公司之 重大收購及出售。

MATERIAL ACQUISITION AND DISPOSAL OF SUBSIDIARIES

Acquisition of Intellectual Properties

On 27 December 2020, the company, Personify Inc. (the "Buyer"), our wholly owned subsidiary, and Foxconn (Far East) Limited (the "Seller"), a wholly owned subsidiary of Hon Hai, announced that all the three parties entered into an acquisition agreement ("Acquisition Agreement") on 24 December 2020 for the Buyer to acquire a basket of intellectual properties ("Target Assets"), which included (i) 13 patents; (ii) trademark of Personify; (iii) 26 software components including "Presenter" and "ChromaCam"; and (iv) 11 domain names, from the Seller at a consideration of HK\$23.34 million. The consideration would be settled by the issuance of 46.68 million new shares, representing 6.65% enlarged shareholding of the company, to the Seller at HK\$0.5 per share upon completion of the transaction. It is a disclosable and connected transaction and requires the application for a whitewash waiver from the Securities and Future Commission of Hong Kong (the "SFC"). Details are set out in the announcement of the company dated 27 December 2020 and the circular of the company dated 22 February 2021. The acquisition of the Target Assets was approved by the independent shareholders (the "Independent Shareholders") of the company in the special general meeting (the "SGM") held on 15 March 2021 and was completed on 22 March 2021.

With the ownership of the Target Assets, (a) we are able to formulate a more comprehensive business development and marketing strategy by exploring every available business options including, but not limited to, generating additional licensing fee for granting others to use its technology by sublicensing the patents and/or providing access to the source code or related software development kit; (b) we are more motivated to devote resources to develop new and existing applications and products; (c) it will be cost-saving in the long run as we shall no longer have to pay the licence fees for the Target Assets after the acquisition of the Target Assets; and (d) it will eliminate the uncertainties of the continuity of the existing licensing arrangement between the Buyer and its licensor. We believe such acquisition is in the interests of the company and our shareholders as a whole.

Given the day-end closing share price on the completion date of the transaction was far above HK\$0.5 per share, the total consideration, based on the closing share prices on the completion date, is significantly deviated from the underlying value of the Target Assets from accounting perspective. As a result, a share-based payment of RMB10.5 million was accounted for in the reporting year.

Saved as disclosed above, we had no material acquisition and disposal of subsidiaries during the reporting year.

重大投資

深圳富華私募股權天使投資合夥企業(「富華基金」)

於二零二一年六月九日,本公司宣佈,我們的全資子 公司雲智匯(深圳)高新科技服務有限公司於二零二一 年六月八日作為有限合夥人與深圳富華股權投資基 金管理有限公司就投資於富華基金訂立有限合夥協 議。根據有限合夥協議,我們承諾出資人民幣30百萬 元,其規模預期約佔富華基金合夥人承諾出資之6%。 富華基金於二零二一年六月十八日成立,擬投資於戰 略性新興行業、未來行業及其他行業,包括但不限於 半導體、生物醫藥、新能源、新材料、高端智能製造等 高新技術產業。訂立有限合夥協議為一項須予披露交 易,詳情分別載於本公司日期為二零二一年六月九日 及二零二一年七月十三日之公告及補充公告。在富華 基金的承諾出資總額人民幣30百萬元中,我們於二零 二一年投入了人民幣9百萬元。截至二零二一年十二 月三十一日,我們於富華基金中的權益價值發生並不 重大的變動。該投資預計將長期產生資本增值,並可 能為本集團帶來其他業務機會。

SIGNIFICANT INVESTMENTS

GRC SinoGreen Fund V, L.P. ("GRC Fund")

On 9 June 2021, the company announced that Maxnerva (Shenzhen) Technology Services Limited, our wholly owned subsidiary, entered into the limited partnership agreement as a limited partner with GRC SinoGreen Capital Co., Ltd. on 8 June 2021, in relation to the investment in the GRC Fund. Pursuant to the limited partnership agreement, we have committed to contribute RMB30 million which size is expected to account for approximately 6% of the capital contribution committed by the partners of the GRC Fund. The GRC Fund was established on 18 June 2021 and intends to invest in strategic emerging industries, future industries and other industries including but not limited to semiconductor, biomedicine, new energy, new materials, high-end intelligent manufacturing and other high-tech industries. Entering into the limited partnership agreement is a disclosable transaction and details are set out in the announcement and supplementary announcement of the company dated 9 June 2021 and 13 July 2021 respectively. We invested RMB9 million out of the total committed capital of RMB30 million in GRC Fund in 2021. As at 31 December 2021, there were immaterial changes in the value of our interest in GRC Fund. The investment is expected to generate capital appreciations in the long term and may bring other business opportunities to the group.

SigmaSense, LLC (「SigmaSense」)

我們於二零一九年及二零二零年分別投資了2百萬 美元及0.5百萬美元於SigmaSense的優先股,於二零 二一年十二月三十一日,我們的投資佔SigmaSense總 股權約1.99%。SigmaSense於二零一五年成立,專注 於從筆記本電腦、平板電腦及智能手機到大尺寸交互 式顯示器、遊戲及汽車等一系列產品所用的顯示屏相 關觸控感應技術。隨著SigmaSense於二零二一年底成 功募得新一輪資金,我們於SigmaSense的投資估值增 至約5.6百萬美元,約佔本集團於二零二一年十二月 三十一日總資產價值的5.5%。於本報告年度,該投資 的未變現收益約為人民幣19.8百萬元。該投資預計將 於中長期內為本集團帶來資本增值。

除上文所披露者外,我們於本報告年度概無重大投 資。

SigmaSense, LLC ("SigmaSense")

We invested US\$2 million and US\$0.5 million in the preferred shares of SigmaSense in 2019 and 2020 respectively and our investment accounted for approximately 1.99% of the total shareholding of SigmaSense as at 31 December 2021. SigmaSense founded in 2015 focusing on display related touch sensing technology for a wide range of products, from laptops, tablets and smartphones to large format interactive displays, gaming and automotive etc. With the success of raising new round of funding by Sigmasense in late 2021, the valuation of our investment in SigmaSense increased to approximately US\$5.6 million, about 5.5% of the total asset value of our group as at 31 December 2021. The unrealized gain of the investment was approximately RMB19.8 million during the reporting year. The investment is expected to generate capital appreciations to the group in the medium to long term.

Saved as disclosed above, we had no significant investment during the reporting year.

As at 31 December 2021, there were no charges on the group's assets and contingent liabilities (2020: Nil).

Saved as disclosed above, neither the company nor its subsidiaries had sold and redeemed any of the company's listed securities during the reporting year of 2020 and 2021.

The board does not recommend any payment of a final dividend in respect of the reporting year (31 December 2020: Nil).








Below are the graphical presentation of the diversity of the board as at 31 December 2020 and 2021:

BOARD MEETINGS

The executive directors meet on a regular basis to discuss the ordinary business of the company. Board meetings are held to discuss the overall development, operation, financial performance, interim results, annual results and other business of the company that requires approval from the board. Reasonable notice has been given to board members to give them an opportunity to attend. All board members are provided with relevant documentation covering the subject matter of the board meetings. Board members are also provided with sufficient information in a timely manner to review and consider matters to be discussed at board meetings. The company utilises telephone conferencing for directors who are not able to attend in person.

During the reporting year, all directors discharged their duties in a dedicated, diligent and proactive manner with reasonable prudence. They have executed their duties in accordance with statutory requirements, the company's bye-laws (the "**Bye-laws**") and the Listing Rules. All directors have exercised due care in monitoring corporate matters of the company and provided sufficient time and attention to all significant issues of the group.

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

The duties of the Chairman are as follows:

- provides leadership and governance of the board so as to create the conditions for overall board's and individual director's effectiveness, and ensures that all key and appropriate issues are discussed by the board in a timely manner;
- promotes effective relationships and open communication, and creates an environment that allows constructive debates and challenges, both inside and outside the boardroom, between non-executive directors and the management;
- ensures that the board as a whole plays a full and constructive part in the development and determination of the group's strategies and policies, and that board decisions taken are in the group's best interests and fairly reflect board's consensus;
- ensures that the strategies and policies agreed by the board are effectively implemented by the Chief Executive Officer and the management;
- sets the board meeting schedule and agenda to take full account of the important issues facing the group and the concerns of all directors, and ensures that adequate time is available for thorough discussion of critical and strategic issues;

INDEPENDENT NON-EXECUTIVE DIRECTORS

The independent non-executive directors bring independent judgment to the board. Each independent non-executive director sent a written confirmation of their independence pursuant to Rule 3.13 of the Listing Rules to the company. Based on these confirmations, the board considers that all independent nonexecutive directors have met the qualifications of Rule 3.13 of the Listing Rules for the reporting year.

APPOINTMENT AND RE-ELECTION OF DIRECTORS

Directors are appointed in accordance with their gualifications and experience to ensure they are capable to perform their duties and protect the interests of the stakeholders. Every newly appointed director receives a comprehensive and formal introduction to ensure that he/she has an understanding of the group's business and operation, his/her responsibilities and obligations under the Listing Rules and relevant regulatory requirements, and the Model Code.

Under code provision C.3.3 issuers should have formal letters of appointment for directors setting out the key terms and conditions for their appointment. The independent non-executive directors are appointed for a specific term of office of one year while all non-executive directors and all executive directors have not entered into any service agreements or letters of appointment (as the case may be) with the company and have no fixed term of service. However, they are subject to retirement by rotation at the annual general meeting of the company (the "AGM") in accordance with the Bye-laws. As such, the board considers that sufficient measures have been taken to ensure that the company's corporate governance practices are no less exacting than set out in the CG Code.

董事會委員會

According to the provisions of the Bye-laws and the Listing Rules, any director appointed by the board to fill a casual vacancy shall hold office until the next following general meeting of the company, and in the case of an addition to the existing board, until the next following AGM. Furthermore, each director, including those appointed for a specific term or holding office as Chairman and/ or chief executive officer, are subject to retirement by rotation at least once every three years.

CONTINUING PROFESSIONAL DEVELOPMENT

The directors are encouraged to participate in continuous professional development to develop and refresh their knowledge and skills. The company would provide a comprehensive induction package covering the summary of the responsibilities and legal obligations of a director of a Hong Kong listed company, the company's Memorandum of Association and Bye-laws (the **"Constitutional Documents**") and the Guides on Directors' Duties issued by the Companies Registry to each newly appointed director to ensure that he/she is sufficiently aware of his/her responsibilities and obligations under the Listing Rules and other regulatory requirements.

Directors are continually updated on developments in the statutory and regulatory regime and the business environment to facilitate the discharge of their responsibilities. Continuing briefings and professional development to directors would be arranged whenever necessary.

During the reporting year, all directors and company secretary of the company confirmed that they have complied with the CG Code.

BOARD COMMITTEES

The Board has set up three board committees, namely the audit committee (the "Audit Committee"), the remuneration committee (the "Remuneration Committee") and the nomination committee (the "Nomination Committee") to oversee particular aspects of the group's affairs. The committees are provided with sufficient resources to discharge their duties and, upon reasonable requests, are able to seek independent professional advice in appropriate circumstances at the company's expenses.

(a) Remuneration Committee

The Remuneration Committee comprises three independent nonexecutive directors and one executive director. The current members are Mr. KAN Ji Ran, Laurie, Mr. TANG Tin Lok, Stephen, Prof. ZHANG Xiaoquan and Mr. CAI Liting. Mr. Kan is currently the chairperson of the Remuneration Committee.

The remuneration packages for directors and senior management are determined by reference to the skill, experience, performance, contribution to the company and the prevailing market condition.

(b) Nomination Committee

The Nomination Committee comprises three independent non-executive directors and one executive director. The current members are Mr. CHIEN Yi-Pin, Mr. KAN Ji Ran, Laurie, Mr. TANG Tin Lok. Stephen and Prof. ZHANG Xiaoquan. Mr. Chien is currently the chairperson of the Nomination Committee.

The principal duties of the Nomination Committee are to:

- 1. review the structure, size and composition of the board (including the skills, knowledge and experience) at least once every year and make recommendations to the board regarding any proposed changes;
- identify individuals suitably qualified to become board members and select or make recommendations to the board on the selection of, individuals nominated for directorships;

The diversity policy is achieved by consideration of various aspects, including but not limited gender, age, cultural and educational backgrounds, professional knowledge and experience with the business of the company. The ultimate decision on selection of candidates will be made upon the merits and contribution that the selected candidate will bring to the board.

(c) Audit Committee

The Audit Committee was established and is governed by its written terms of reference in accordance with code provision D.3.3 of the CG Code. It currently comprises three independent non-executive directors, namely, Mr. TANG Tin Lok, Stephen, Mr. KAN Ji Ran, Laurie and Prof. ZHANG Xianquan. Mr. TANG is currently the chairperson of the Audit Committee.

The Audit Committee is responsible for reviewing and supervising the financial reporting process and internal control system of the group and providing advice and recommendations to the board.

The Audit Committee is also authorised to obtain outside legal or other independent professional advice and to secure the attendance of outsiders with relevant experience and expertise if it considers this necessary.

During the reporting year, the Audit Committee has performed the following duties:

- 1. reviewed the annual financial statements with the auditor and reviewed the unaudited interim financial statements, with recommendations to the board for approval;
- reviewed the changes in accounting standards and policies as well as assessment of potential impacts on the group's financial statements;
- reviewed the group's internal control and risk management systems, the effectiveness of the group's internal audit function and discussed the relevant issues including financial, operational and compliance controls, and risk management functions;
- 4. reviewed the compliance issues with the regulatory and statutory requirements;
- considered and recommended the appointment, re-appointment and approved the remuneration and terms of engagement of external auditor;
- 6. discussed with external auditor the nature and scope of the audit and reporting obligations; and
- 7. reviewed and monitored external auditor's independence and objectivity and the effectiveness of the audit process in accordance with applicable standards.

風險管治及管理

ACCOUNTABILITY AND AUDIT

The directors acknowledge their responsibility for the preparation of the financial statements of the group for the relevant accounting periods in accordance with statutory and regulatory requirements. In preparing the financial statements for the reporting year, the directors have adopted appropriate accounting policies and applied them consistently. The financial statements for the reporting year have been prepared on a going concern basis.

A statement by the auditor about their reporting responsibilities is set out on pages 88 to 89 in this annual report.

RISK MANAGEMENT AND INTERNAL CONTROL

During the reporting year, the group has complied with principle D.2 of the CG Code by establishing appropriate and effective risk management and internal control systems. Management is responsible for the design, implementation and monitoring of such systems, while the board oversees management in performing its duties on an ongoing basis and an internal audit on the internal control and risk management systems performed on an annual basis. Main features of the risk governance and management systems are described as follows:

Risk Governance and Management

The management of the group proactively manages the risks by establishing an Enterprise Risk Management ("**ERM**") framework to assist the Audit Committee and the board in discharging its risk management responsibilities and individual business units in managing their key risks. With reference to the "Internal Control – Integrated Framework" Issued by the Committee of Sponsoring Organizations of the Treadway Commission ("**COSO**"), the main features of the ERM system are illustrated below:

- Control Environment: a set of standards, processes and structures that provide the basis for carrying out internal control across the group.
- Risk Assessment: a dynamic and iterative process for identifying and analysing risks to achieve the group's objectives, forming a basis for determining how risks should be managed.
- Control Activities: action established by policies and procedures to help ensure that management directives to mitigate risks to the achievement of objectives are carried out.
- Information and Communication: internal and external communication to provide the group with the information needed to carry out day-to-day controls.
- Monitoring: ongoing and separate evaluations to ascertain whether each components of internal control is present and functioning.



作為第一道防線,本集團所有部門及業務單位的風險 責任人識別及評估可能對達成其業務目標有潛在影 響的風險,並於日常營運中設計和執行監控程序以緩 解並監察風險(包括但不限於業務及營運風險)。他們 定期進行風險評估,以評估其用於緩減已識別風險的 現行監控措施是否足夠有效。

作為第二道防線,本集團建立了特定職能,以確保第 一道防線已妥為制訂並按預期運作。這些特定職能包 括但不限於財務監控、風險管理和內部監控、合規、 資料保護及信息安全等等。

作為第三道防線,現有內部審核(「內部審核」)職能的 角色為獨立評核者(由具備如執業會計師等相關專長 的專業人員組成),負責i)持續審閱本集團主要營運、 財務、合規及風險管理控制及ii)建議對風險管理及內 部控制系統實施加強措施以供審核委員會及/或相 關個別部門審議。內部審核部門在年度審核計劃內規 劃其工作,該計劃每年由審核委員會審閱。審核計劃 以風險評估為基礎,旨在於合理期間內涵蓋本集團涉 及日常管理的各重要部門及業務單位。

審核委員會協助董事會監督集團的風險管理及內部 監控系統,包括:

- 與內部審核職能最少每年檢討一次集團的風險 管理及內部監控系統,以確定管理層是否已履 行其建立及維持有效系統的責任;
- 檢討風險評估結果,包括自上次檢討後重大風 險的性質及嚴重程度的轉變以及集團應付其業 務轉變及外圍環境轉變的能力;及
- 與管理層討論集團在會計、內部審核及財務匯 報職能方面的資源、員工資歷及經驗,以及員工 所接受的培訓課程及有關預算,從而確定是足 夠的。

As the first line of defense, risk owners of all corporate departments and business units of the group identify and evaluate the risks which may potentially impact the achievement of their business objectives, mitigate and monitor the risks (including but not limited to business, operation risks) by designing and executing control procedures in their day-to-day operations. They conduct risk assessment on a regular basis to evaluate the adequacy and effectiveness of controls that are in place to mitigate the identified risks.

As the second line of defense, the group establishes specific functions to ensure the first line of defense is properly in place and operating as intended. The responsibilities of these functions include but not limited to financial control, risk management and internal control, compliance, data protection and information security and so forth.

As the third line of defense, the existing Internal Audit ("IA") function acts as an independent assessor which is composed of professionals with relevant expertise (such as certified public accountant). It is responsible for i) reviewing the major operational, financial, compliance and risk management controls of the group on a continuous basis and ii) proposing any enhancement to the risk management and internal control systems for consideration by the Audit Committee and/or the individual department concerned. It schedules its work in an annual audit plan which is reviewed by the Audit Committee every year. The audit plan is derived from risk assessment basis and is aimed at covering each significant corporate department and business unit in which the group involves in day-to-day management within a reasonable period.

The Audit Committee assists the board in overseeing the risk management and internal control systems of the group, including:

- reviewing, at least annually, the risk management and internal control systems of the group with the IA function to ascertain whether management has fulfilled its responsibilities in establishing and maintaining effective systems;
- reviewing the risk assessment results, including changes in the nature and extent of significant risks since the last review and the group's ability to respond to changes in its business and the external environment; and
- discussing with management on the resources, staff qualifications and experience, training programmes and budget of the group's accounting, internal audit and financial reporting functions to ensure that these are adequate.

The board has the overall responsibility for establishing and maintaining sound and effective risk management and internal control systems, including:

- 1. setting the group's strategies and corporate goals;
- 2. evaluating and determining the nature and extent of the risks it is willing to take in achieving its strategic and business objectives;
- overseeing management in the design, implementation and monitoring of the risk management and internal control systems;
- overseeing the risk management and internal control systems on an ongoing basis, and ensuring that a review of the systems is conducted at least annually to ensure their effectiveness;
- reviewing the changes in the nature and extent of significant risks since the last review and the group's ability to respond to changes in its business and the external environment;
- 6. considering any significant control failings or weaknesses that have been identified during the period.

Based on the internal control reviews conducted for the reporting year, no significant control deficiency was identified.

The board, through its reviews and the reviews made by IA function and Audit Committee, concluded that the risk management and internal control systems were effective and adequate. Such systems, however, are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss. It is also considered that the resources, staff qualifications and experience of relevant staff were adequate and the training programs and budget provided were sufficient.

Shareholders' Meetings

Shareholders are encouraged to participate in general meetings or to appoint proxies to attend and vote at meetings if they are unable to attend the meetings. The process of the company's general meeting will be monitored and reviewed on a regular basis, and if necessary, changes will be made to ensure that shareholders' needs are best served.

Board members, in particular, either the chairman of board committees or their delegates, appropriate management executives and external auditors will attend AGMs to answer shareholders' questions.

Procedures for members to convene a special general meeting

Shareholders holding at the date of deposit of the requisition not less than one-tenth of the paid-up capital of the company carrying the right of voting at general meetings of the company shall at all times have the right, by written requisition sent to the company's registered office in Bermuda and its principal place of business in Hong Kong, for the attention of the company secretary, to require a SGM to be called by the board for the transaction of any business specified in such requisition; and such meeting shall be held within two months after the deposit of such requisition. If the directors do not within 21 days from the date of the deposit of such requisition proceed duly to convene a SGM, the requisitionists themselves or any of them representing more than one half of the total voting rights of all of them may convene the SGM in the same manner, as nearly as possible, as that in which meetings may be convened by the directors, and all reasonable expenses incurred by the requisitionists as a result of the failure of the directors to convene such a meeting shall be reimbursed to them by the company.

The written requisition must state the purposes of the general meeting, signed by the shareholders concerned and may consist of several documents in like form, each signed by one or more of those shareholders.

If the requisition is in order, the company secretary will ask the board to convene a SGM by serving sufficient notice in accordance with the statutory requirements to all the registered members. On the contrary, if the requisition is invalid, the shareholders will be advised of this outcome and accordingly, a SGM will not be convened as requested.

The notice period to be given to all the registered members for consideration of the proposal raised by the shareholders concerned at SGM varies according to the nature of the proposal is as follows:

- at least twenty-one clear days' and not less than ten clear business days' notice in writing if the proposal constitutes a special resolution of the company, which cannot be amended other than a mere clerical amendment to correct a patent error; and
- at least fourteen clear days' and not less than ten clear business days' notice in writing if the proposal constitutes an ordinary resolution of the company.

Procedures for putting forward proposals at a general meeting

Pursuant to Sections 79 and 80 of the Bermuda Companies Act 1981 (as amended), (i) shareholders holding not less than one-twentieth of the total voting rights; or (ii) not less than 100 shareholders, are entitled to request the company to give shareholders notice of a resolution which is intended to be approved at the next annual general meeting or special general meeting. If any shareholders wish to propose a resolution to be put forward at a general meeting of the company, a written notice to that effect signed by the requisitionists with contact information must be deposited at the company's Hong Kong principal place of business, Room 1001, 10/F, Houston Centre, 63 Mody Road, Tsim Sha Tsui East, Kowloon (addressed to the company secretary). The notice shall contain, inter alia, a description of the proposed resolution desired to be put forward at the meeting, the reasons for such a proposal and any material interest of the proposing shareholder in such a proposal. The request will be verified with the company's share registrar in Bermuda or the Hong Kong branch share registrar and upon their confirmation that the request is proper and in order, the company secretary will ask the board to include the resolution in the agenda for the general meeting.

The notice period to be given to all the shareholders for consideration of the proposal raised by the shareholders concerned at the AGM or the SGM varies according to the nature of the proposal, the details of which are as follows:

- At least 14 days' notice (the notice period must include 10 business days) in writing if the proposal constitutes an ordinary resolution of the company in SGM.
- At least 21 days' notice (the notice period must include 20 business days) in writing if the proposal constitutes an ordinary resolution of the company in AGM or a special resolution of the company in AGM or SGM.

In the event of failure in serving the notice to the company by the requisitionist within reasonable time, the company reserves the right to claim from the requisitionist any expenses incurred by the company in serving the notice of the resolution and circulating the statement given by that requisitionist to all shareholders in accordance with the requirements under the Listing Rules (unless the company otherwise resolves).

The rights and procedures for proposing resolution to be put forward by shareholders at a general meeting is posted on the company's website www.maxnerva.com.

All shareholders are also encouraged to attend general meetings of the company to discuss matters relating to the group. At general meetings of the company, the directors will answer questions from the shareholders.

Investor relations has always formed an important part of the company's corporate governance. It provides two-way communication between management and the investment community and continually updates investors on the company's latest business developments in a timely manner. The designated team also regularly provides management with market feedback and opinions from the investment community to improve the governance and operations of the company.

CONSTITUTIONAL DOCUMENTS

There was no significant change to the Constitutional Documents during the reporting year. The latest version of the Constitutional Documents can be downloaded from the websites of the company or the Stock Exchange.

On 28 March 2022, the company announced proposing to amend the Bye-laws ("**Proposed Amendments**") and to adopt a amended and restated bye-laws of the company ("**New Bye-laws**") in order to update and bring the Bye-laws in line with the latest legal and regulatory requirements, including the amendments made to Appendix 3 (the "**Core Shareholder Protection Standards**") to the Listing Rules.

In November 2021, the Stock Exchange introduced a new listing regime for overseas issuers which, covers, among others things, that all issuers are required to comply with the Core Shareholder Protection Standards. The amended Listing Rules are effective as from 1 January 2022. The Proposed Amendments also include other updates incorporating legal and regulatory changes in both Hong Kong and Bermuda. Details are set out in the announcement of the company dated 28 March 2022.

The Proposed Amendments and the adoption of New Bye-laws are subject to the approval of the shareholders by way of a special resolution at the forthcoming AGM, and will become effective upon the approval by the shareholders at the AGM.

Anti-discrimination is highly valued during the employment process, we select the right candidates only based on their qualifications, experience and ability without taking into consideration of their gender, race, age, nationality, marital status, pregnancy, disability and religion etc. We strictly prohibit the use of child labour and forced labour in accordance with the Provisions on the Prohibition of Using Child Labour (禁止使用童工規定). As a means to avoid employing child labour, all newly employed staff is required to provide identification documents for age verification purpose. Once such practice is discovered, the group would investigate the case thoroughly and dismiss relevant employees immediately. An employment contract which clearly defines the job title and duties of the respective employee are required to be signed to prevent the employee from performing work out of their prescribed responsibilities. For employees who wish to resign, we follow relevant procedures to conduct exit interviews in an effort to collect opinions from them for any possible improvement of our policies and operations.









The emergency procedures such as fire or explosion emergency plan have been well established, and we regularly arrange rescue, fire and evacuation drills in order to prevent casualties in case of accidents. Employee Welfare

In order to stimulate the working initiative of the employees, we provide a wide range of welfare including those required by laws and offered by the group. To assure our employees of sufficient rest time, we follow relevant regulations to define working duration for employees and we allow employees to have flexible working hours. Our employees are also entitled to a number of leaves such as public holidays, annual leave, maternity leave, marriage leave and funeral leave. We also contribute to all applicable statutory insurance and mandatory funds for employees in different locations. Besides, we offer allowances to employees at different positions, for instance, salespersons who frequently communicate with clients are granted communication allowances. Every year, each employee is also provided with a free body checkup.

In addition, we place emphasis on the work-life balance of our employees by hosting various team-building activities, festival parties and birthday parties which allow our employees to relax and interact. We also prepare lucky draws and gifts during birthday parties and special festivals as a reward for our employees. Furthermore, we regularly organized outdoor team building activities to help employees construct bond between each other.

Supply Chain Management

To thoroughly fulfill the environmental and social responsibility, management of our business operation including the supply chain cannot be neglected. As a way to ensure that qualified products and services are provided, we target and cooperate with suppliers with high credibility such as long-established suppliers and those from eminent enterprises. We have set up comprehensive procurement policies and systems which act as a guide to opt for and manage our suppliers. During the selection process, suppliers are evaluated mainly based on their product quality, delivery, production capacity, compliance and past performance from environmental, health and safety aspects. Suppliers who fail to meet the requirements will ultimately be disqualified.

Environmental and social risks along the supply chain are always considered by the group. We give priority to suppliers that comply with national, regional and industrial environmental standards, follow internationally recognized standards and own certifications concerning energy management systems, environmental management systems and social risk management. We also value the employment and incorruptibility of suppliers. Therefore, we ensure that suppliers are committed to uphold the human rights of employees by implementing internal regulations in accordance with internationally accepted norms. Whether they have adopted sufficient occupational health and safety policies and obtained relevant certifications is also an important consideration. The cooperation with suppliers who are found to be incompliant with relevant laws and regulations regarding anti-bribery, anti-corruption and any other unethical business practices will be terminated at once.



For example, we prefer eco-friendly products which are energy-efficient or made of recyclable materials such as refillable pens and recycled paper. We also encourage the staff to pay attention to the expiry date of products and use products purchased earlier to avoid unnecessary wastage. Besides, we tend to select local suppliers or suppliers geographically closer to the company to reduce carbon footprint.

Product and Service Quality

We provide industrial, smart office and new retail solutions, in which our employees are involved in the sales and installation of the hardware and software. The group has established a quality management system, which has obtained ISO 9001:2015 certification, to ensure that we can attain a high level of product and service quality.

When selecting and purchasing products, the group strictly follows the Product Quality Law of the People's Republic of China (中華人民共和國產品質量法). We always set up contract terms regarding product quality with suppliers to ensure that the corresponding products have passed necessary testing and attained certain industrial standards. The products we provide are guaranteed to have met all applicable health and safety requirements under China Compulsory Certification (中國強制性產品認證), as stipulated according to the Provision on the Administration of Compulsory Product (強制性產品認證管理規 定).

As a professional service provider, we never spare ourselves in the pursuit of excellence in service quality and the complete provision of services in accordance with customers' needs and expectations. After-sales services such as maintenance, training on product application and product return are always provided, adding to the major I.T. services we provide. We constantly keep track of the experience and opinions of our customers by implementing a thorough feedback-tracking system. In case of complaints on goods and service quality, staff from different teams who have their own designated roles and responsibilities will work together in carrying out prompt follow-up actions so that impacts or inconvenience can be minimised.

During the reporting year, the group did not received any major complaints about its products and services and did not record any products sold or shipped that were subject to recalls for safety and health reasons.

Privacy Protection

We play a pivotal role in privacy protection by handling information and data of customers and employees with the highest degree of carefulness. We strictly complied with relevant personal privacy regulations adopted in places of business such as the Personal Data (Privacy) Ordinance (個人資料 (私隱) 條例) of Hong Kong during the reporting year.

We provide our privacy policy along with our services to let customers understand how we collect, utilise, save and share their information, as well as how the information is controlled, updated and protected. Specifically, we have established a comprehensive database encryption system with regular checking, both manually and automatically, to protect customer data. To access customers' personal data, employees are required to get approval from several parties including the legal department and their department heads. Our employees are also liable to not divulging confidential information of the group to any third parties.

Furthermore, we show exceptional care to our employees' personal information, so we spare no effort on the prevention of data leakage. Information of all employees, including the resigned ones and the candidates, is used for recruitment purpose only and is absolutely confidential. Such data will not be kept for a period longer than that required by relevant regulations.

於本報告年度,為防止本集團、客戶、供應商及任何 其他業務夥伴之知識產權受到侵犯,我們嚴格遵守 《中華人民共和國專利法》及《中華人民共和國商標 法》等相關法律及法規。

我們的專業人才精通研究與發明,特別是在軟件開發 方面。於本報告年度,本集團已成功獲得45項自主開 發系統的專利,例如遠程控制應用程序和全面質量管 理系統。為有效申請及保護發明專利及軟件版權,我 們已制定並實施知識產權保護政策。此外,與客戶、 供應商及僱員簽訂之合約已加入經本集團之專業律 師團隊審閱及批准之保護條文,以讓本集團的知識產 權得到合法保護。

Intellectual Property Rights

To prevent infringement of intellectual property rights of the group, our customers, suppliers and any other business partners, we strictly conformed to the relevant laws and regulations such as the Patent law of the People's Republic of China (中華人民共和國專利法) and the Trademark Law of the People's Republic of China (中華人民共和國商標法) during the reporting year.

Our specialised talents are proficient in research and invention, particularly in the aspect of software development. During the reporting year, the group has successfully obtained patents for 45 self-developed systems, such as remote control app and total quality management system. To effectively apply for and protect the invention patent and software copyright, we have established and implemented a policy on intellectual property right protection. Besides, protective clauses which have been reviewed and approved by our professional lawyers are included in the contracts signed with customers, suppliers and employees in order to give legitimacy to our intellectual property right protection.

In case of advertisement, we are also devoted to preventing the infringement of intellectual property rights, either by others or by the group, through the conformity with relevant laws such as the Advertising Law of the People's Republic of China (中華人民共和國廣告法) during the reporting year.

Anti-corruption

Corruptive behavior may be a source of risk that weakens a business's stability and hampers its development. We on no account allow any actions and behavior to blemish the image of the group. Thus, we are committed to ensuring that every department meets its legal obligations, at the same time joins hands to prevent, detect and eliminate corrupt practices, hence reducing the number of bribery and corruption incidents.

We do not tolerate any attempt to commit corrupt practices by employees, contractors, agents and business partners and take any such attempts seriously. We communicate internal rules, laws and regulations to employees through meetings and other usual communication channels in an effort to emphasise the importance of integrity, honesty and fairness and to prevent potential bribery, extortion, fraud as well as money laundering. All management and staff are highly encouraged to report cases of suspected corruption, either to their supervisors or other managers. Suspected corruption cases will be properly investigated and associated actions, such as disciplinary action, reporting to relevant authorities and prosecution, will be taken. Any breach of the anti-corruption policy is deemed to have committed a major misconduct and is meted out to a disciplinary action.

We believe that it is essential to regularly provide training to the employees on topics regarding corruptive behavior so as to maintain employees' awareness towards corruptive behavior. The group has provided its Board of Directors and its employees with reading material regarding the prevention and avoidance of corruptive behavior as training. The group will continue to look for different opportunities to further strengthen employees' resilience against corruptive behavior.

During the reporting year, we are not aware of any breach of laws and regulations in relation to bribery, extortion, fraud and money laundering, such as the Regulations of the People's Republic of China for Suppression of Corruption (中華人民共和國懲治貪污條例) and the Prevention of Bribery Ordinance (防止賄賂條例) of Hong Kong, that had a significant impact on the group.

Pollution Management

As environmental issues are drawing increasing attention among the business community, we are dedicated to mitigating negative environmental impacts, such as climate change, by controlling and minimising our emission. We bear the environmentally friendly concept in mind in our daily operation and business development.

Owing to the service-based business, we generate no water pollutants commonly discharged from manufacturing processes. Likewise, we do not emit air pollutants except for the private car used for maintaining our daily operation. As a way to reduce emission, we require all the users of the vehicle to switch off the idling engine to avoid unnecessary emission.

Another principal source of emissions is the waste generated from daily business operations in our office. During the reporting year, we were in compliance with relevant laws and regulations that have a significant impact on the group such as the Law of the People's Republic of China on Prevention and Control of Environmental Pollution by Solid Waste (中華人民共和國固體廢物 污染環境防治法). Both hazardous and non-hazardous wastes were generated during the reporting year, of which the former included waste batteries and the latter consisted of mainly daily office garbage produced by employees. The group deems that waste disposal is not of significance or risk to the group's business, and that the amount of hazardous and non-hazardous waste is insignificant due to its business nature, the group has not set targets for waste disposal. Nonetheless, we still strive to avoid detrimental impacts on the environment, non-hazardous wastes generated by the office were collected by the cleaning company employed by the commercial building where the office is located at, while the hazardous wastes were collected separately at specific points in the building before collecting by the designated party.

我們遵循「4R」原則採取多項措施,以盡量降低我們 產生的廢物量。例如,我們通過雙面打印減少紙張的 使用,並不遺餘力重複使用辦公用品,例如文具、紙 張、信封及文件卡。就回收而言,我們設置分類箱, 以便員工可以在使用後分類回收塑料及紙張,且舊電 腦將由電子公司回收。我們亦採購可回收及可填充產 品,例如可填充筆及充電電池,以替換辦公室中的一 次性產品。於本報告年度,深圳辦事處並沒有產生任 何包裝材料。 Emissions data relating to non-hazardous waste is based on the daily estimated volume of office garbage and the volume to weight conversion factors provided by Shenzhen Urban Management and Comprehensive Law Enforcement Bureau.

We have carried out a number of measures by following the principle of "4R" to minimise the amount of waste we generated. For example, we reduced the use of paper by implementing double-side printing, and we spared no effort to reuse office supplies such as stationary, papers, envelopes and files. For recycling, we have set up sorting bins so that staff can sort and recycle plastics and paper after using, and old computers would be recycled by electronics companies. We also purchased recyclable and refillable products such as refillable pens and rechargeable batteries to replace those disposable ones in our office. During the reporting year, our Shenzhen office did not produce any packaging materials.

Greenhouse Gas Emission

Despite the fact that we are not involved in energy-intensive businesses, normal office operation which is indispensable to maintain our remarkable and professional services is still a source of greenhouse gas ("**GHG**") emission. Hence, we exert ourselves to abide by the relevant laws and make our daily operation more environmentally-friendly. During the reporting year, we were in compliance with relevant laws and regulations that have a significant impact on the group, such as the Environment Protection Law of the People's Republic of China (中華人民共和國環境保護法).

In addition to the use of vehicles, which is a type of direct emission of GHG, indirect emission from processes such as electricity consumption, water and sewage treatment, disposal of paper to landfills and business trips of employees are the main sources of greenhouse gas emission from our operation.

During the reporting year, the group has not set any goals regarding greenhouse gas emissions, since we believe that GHG emissions do not pose a risk to the group's business operations and performance, and that the emissions amount is viewed to be insignificant. However, we are aware of the importance to effectively manage our emissions, therefore, we have adopted a number of measures from paper recycling to energy conservation in an attempt to reduce our GHG emissions. For example, we pragmatically cut down on the use of paper by using office automation system to replace paper-based administration system and using recycled paper and double-sided printing. Reminders are posted at printing corners to remind employees to reuse and maximise the use of papers whenever possible. Employees who are engaged actively in overseas meetings are encouraged to substitute phone or video conferences for business trips, although business travels have become less frequent in the reporting year due to COVID-19. Generally, we endeavor to build a green and healthy environment together with all our employees, thus we encourage the use of public transport instead of private cars in their commute to work. For details of energy conservation, please refer to "Energy and Water Conservation".

Energy and Water Conservation

To make contributions to environmental protection, the group endeavors to conserve energy and water usage so as to reduce emission. We are always aware of the possible impacts resulted from the overuse of energy and water, thus we strictly manage energy and water consumption in our operation, particularly in the office. We have set targets regarding energy and water conservation, aiming to reduce energy and water consumption on a per employee basis.

在日常運營中,我們始終牢記避免能源浪費,以實現 我們的目標。我們將非使用中的所有電腦設置為休眠 模式,並要求我們的員工在不使用時以及每天離開 辦公室之前,完全關閉電燈、電腦及打印機等電器。 我們亦清潔所有燈具及空調,以確保最高效率運行, 避免浪費能源。此外,通過辦公室設計,我們嘗試最 大程度地利用自然光,將辦公室劃分為單獨的照明區 域,以便更靈活地利用光。我們亦允許非前線員工穿 著輕便服裝,以節省空調能源。

就節水而言,我們亦付出很多努力,並已採取大量節 水措施,包括在洗手間張貼節水標示以提高員工的 節水意識,並及時安排維修及保養滴水的水龍頭等。 此外,我們盡可能地重複利用灰水進行清潔及灌溉。 於本報告年度,我們於求取適用水源方面並無遇到問 題。

應對氣候變化

氣候變化目前是最緊迫的全球問題之一,促使不同行 業的企業相應作出應對。我們也不例外,高度警惕氣 候變化對本集團業務營運帶來的潛在風險及影響。例 如,本集團明白,越來越頻繁及嚴重的極端天氣事件 或會令本集團面臨多種負面影響的風險,特別是由於 設施及設備可能損壞並需要修復,可能導致營運成本 不斷增加。

In daily operation, we always bear in mind the avoidance of energy waste in order to achieve our targets. We set all computers to sleeping mode when idling and require our staff to switch off appliances such as lights, computers and printers completely when not in use and before leaving the office every day. We also clean all light fixtures and air-conditioners in order to ensure that they are running at the highest efficiency to avoid wasting energy. Besides, through office design, we try to maximise the use of natural light and divide the office in separate lighting zones so as to allow a more flexible use of light. Non-frontline employees are also allowed to wear light so that energy for air conditioning can be saved.

In terms of water saving, we have also put in lots of efforts and have implemented plenty of water-saving measures including putting up water-saving reminder labels in toilets to raise our employees' awareness of water-saving and arranging for repair and maintenance for dripping faucets immediately. In addition, grey water is reused for cleaning and irrigation wherever possible. During the reporting year, we had no issue in sourcing water that is fit for purpose.

Response to Climate Change

Climate change is currently one of the most urgent global issues, prompting corporates from different sectors to respond accordingly. We are no exception, being highly aware of the potential risks and impacts brought to the group's business operations by climate change. For instance, the group is aware that increasingly frequent and severe extreme weather events may put the group at risk of numerous negative impacts, especially potentially increasing operational costs since facilities and equipment may be damaged and require repair.

面對該等氣候相關風險,我們定期進行氣候相關風險 評估,以確定、監測及管理潛在的氣候相關風險,從 而分析氣候變化的不同方面對我們業務營運造成的 風險。此外,我們已制定各種措施,以防止及減輕可 能出現的潛在影響。特別是,為減輕越來越極端及頻 繁的天氣事件的影響,我們已實施緊急管理計劃,當 中詳細說明針對極端天氣狀況的具體措施,例如雷暴 情況下的特殊工作安排。

In face of such climate-related risk, we regularly conduct climate-related risk assessments to identify, monitor and manage potential climate-related risks, so as to analyze the vulnerability of our business operations against different aspects of climate change. Furthermore, we have put in place various measures to prevent and mitigate the potential impacts that may arise. Particularly, in order to mitigate the impacts from increasingly extreme and frequent weather events, we have implemented an emergency management plan, which details the specific measures against extreme weather conditions, such as special work arrangements under thunderstorms.

Looking forward, we shall continue to monitor and assess the ever-changing risks that climate change may bring to the group and shall swiftly take preventive and mitigative steps once climate-related risks of any form arise.

CONTRIBUTING TO COMMUNITY

We encourage employees to care for and spend time on the local communities through participating in all kinds of social activities such as attending local community activities and charitable donations. Employees are also encouraged to participate in environmental protection activities and promote environmental awareness within the group. We have identified via our ESG materiality assessment that community contribution is an immaterial issue to the group and its business, therefore we have not contributed any resources to the community during the reporting year. However, we will continue to look for other opportunities to devote back to the community in the future.

RESULTS AND APPROPRIATIONS

Our results for the reporting year are set out in the consolidated income statement on page 90.

The directors do not recommend any payments of final dividend.

BUSINESS REVIEW AND PERFORMANCE, FUTURE PROSPECTS AND DEVELOPMENT

A fair review of our businesses comprising analysis of the group's performance during the reporting year under review using financial key performance indicators, future prospects and business development of the group, description of the principal risks and uncertainties facing by the group, are set out in the section of "Management Discussion and Analysis" in this annual report. There had been no material events after 31 December 2021 till the issuance of this annual report.

We have long considered environmental protection and energy conservation as one of our key priorities in order to enhance the sustainable development and undertake relative social responsibility. 僱員

本公司嚴格遵守與僱傭有關的所有適用規則及法規, 例如《僱傭條例》、《強制性公積金計劃條例》及《個人 資料(私隱)條例》等。本集團已為其員工購買所有必 要之保險,並每月作出退休金供款,亦已制定措施保 障全體員工的個人資料。員工有渠道表達彼等對於工 作的意見。此外,本集團亦致力提供安全、健康及和 諧的工作環境,為兩性及不同種族員工提供公平及平 等的機會。

客戶

本集團向客戶提供直接服務及貨品,並作出調查與彼 等進行互動,以洞悉市場情况及取得反饋意見。於本 報告年度,本集團向五大客戶作出之銷售共佔本集團 總收入約44%,而最大客戶約佔16%。本集團授予客 戶的信貸期介於30至90天不等。管理層根據過往付 款記錄、逾期時間、營業及其他債務人的財務實力以 及與相關債務人有否任何糾紛,定期對營業應收賬項 的可收回性進行總體評估以及單獨評估。本集團過往 收回應收營業賬項及其他應收款項並無超出有關記 錄撥備,董事認為已就不可收回的應收款項於該等財 務報表中作出充分撥備。逾期結餘由高級管理人員定 期檢討。本報告年度後並無發現任何重大可收回性問 題。

COMPLIANCE WITH RELEVANT LAWS AND REGULATIONS

The board was not aware of any non-compliance with the relevant laws and regulations that had a significant impact on the company during the reporting year.

RELATIONSHIPS WITH EMPLOYEES, CUSTOMERS AND SUPPLIERS

The company highly values the relationships with employees, customers and suppliers as they are the foundation of the group's success.

Employees

The company strictly complies with all the applicable rules and regulations in relation to employment, to name a few, the Employment Ordinance, the Mandatory Provident Fund Ordinance and the Personal Data (Privacy) Ordinance, etc. The group has purchased all necessary insurance and made monthly pension contributions for its staff and has measures in place endeavoured to protect all staff's personal information. There are channels for staff to express their opinions with regard to their work. Moreover, the group also strives to provide a safe, healthy and harmonious workplace with fair and equal opportunities for staff of both gender and different races.

Customers

The group provides direct services and goods to customers and conduct surveys to interact with them to gain market insights and feedback. For the reporting year, sales to the five largest customers of the group in total accounted for approximately 44% of the group's total revenue, with the largest customer accounting for approximately 16%. Credit terms offered to customers ranged from 30 to 90 days. Management makes periodic collective assessment as well as individual assessment on the recoverability of trade receivables based on historical payment records, the length of the overdue period, the financial strength of the trade and other debtors and whether there are any disputes with the relevant debtors. The group's historical experience in collection of trade and other receivables falls within the recorded allowances and the directors are of the opinion that adequate provision for uncollectible receivables has been made in these financial statements. Overdue balances are reviewed regularly by senior management. No significant recoverability problem is identified subsequent to the reporting year.

The suppliers of the group are either well established companies or from wellknown enterprises to ensure that they are able to deliver goods and services as requested. The five largest suppliers of the group in aggregate accounted for approximately 50% by value of the group's total purchases during the reporting year, with the largest supplier accounting for approximately 23%. Furthermore, anti-bribery policies are in place for all staff to comply.

The company has adopted a share option scheme (the "Share Option Scheme") approved by a resolution passed by the shareholders of the company on 30 August 2013, under which it may grant options to eligible participants (as defined in the share option scheme rules) to subscribe for shares in the company. Eligible participants refer to any full time or part time employees of the group or any entity in which the group holds an equity interest ("Invested Entity") (including any directors, whether executive or nonexecutive and whether independent or not, of the company or any subsidiary or any Invested Entity); any holder of any securities issued by the group; and any business or joint venture partners, contractors, agents or representatives, consultants, advisers, suppliers, producers or licensors, customers, licensees (including any sub-licensee) or distributors, landlords or tenants (including any sub-tenants) of the group or any Invested Entity or any person who, in the sole discretion of the board, has contributed or may contribute to the group or any Invested Entity.

During the year ended 31 December 2021, no share options were granted or lapsed but a total of 350,000 share options were cancelled.

Subsequently on 8 April 2022, the company granted a total of 7,610,000 share options under the Share Option Scheme to certain eligible participants. The exercise price is HK\$0.31 each and the vesting period is 2 years from the date of grant with 10 years of validity. Among the grantees, Mr. CAI Liting and Mr. CHENG Yee Pun are directors of the company, who were granted with 800,000 and 500,000 share options respectively.

Save as disclosed, no share options were granted, lapsed and cancelled during the year ended 31 December 2021.

A summary of the principal terms of the Share Option Scheme is set out as below:

1. **Purpose of the Share Option Scheme**

The purpose of the Share Option Scheme is to enable the company to grant options to selected eligible participants as incentives or rewards for their contribution or potential contribution to the group or any Invested Entity. The company considers that the Invested Entity, an entity in which the group holds an equity interest, may contribute to the group's profits. The company also considers that the granting of the options to the employee, director, officer or consultant of the Invested Entity would provide an incentive for their contribution to the Invested Entity which indirectly benefits the group.

2. Administration of the Share Option Scheme

The Share Option Scheme shall be subject to the administration of the board whose decision on all matters arising in relation to the Share Option Scheme or its interpretation or effect shall (save as otherwise provided herein and in the absence of manifest error) be final and binding on all persons who may be affected thereby.

There is no specific minimum period under the Share Option Scheme for which an option must be held or the performance target which must be achieved before an option can be exercised under the terms of the Share Option Scheme.

Notwithstanding that Hon Hai was not a connected person of the company under the Listing Rules at that time, the company voluntarily complied with the reporting, announcement and Independent Shareholders' approval requirements for the transactions contemplated under the 2015 Framework Agreements as if Hon Hai is a connected person of the company under Chapter 14A of the Listing Rules. The 2015 Framework Agreements consist of (1) the I.T. System Operation and Maintenance Framework Agreement, (2) the Build-Own-Operate and I.T. Project Framework Agreement, (3) the Procurement Framework Agreement and (4) the Sales Framework Agreement. As disclosed in the circular issued by the company on 29 December 2020, the transactions as contemplated under the 2020 Framework Agreements are also subject to the condition that the revenue attributable to Hon Hai Group will be less than 60% of the group's annual total revenue (the **"Condition**"). For the year ended 31 December 2021, the actual revenue attributable from Hon Hai Group represented 47% of the total revenue. Thus we comply with the Condition for the reporting year of 2021.

The independent non-executive directors have reviewed and confirmed that all the continuing connected transactions taken place during the reporting year were (i) in the ordinary and usual course of business of the group; (ii) on normal commercial terms or better; and (iii) in accordance with the relevant agreements governing the same on terms that are fair and reasonable and in the interests of the company's shareholders as a whole. Moreover, the company's auditor has provided an unqualified letter to the board containing their findings and conclusions in respect of the continuing connected transactions taken place during the reporting year in accordance with Rule 14A.56 of the Listing Rules. A copy of the auditor's letter has been provided by the company to the Stock Exchange.

On 24 December 2020, the company, Personify Inc. as the Buyer and Foxconn (Far East) Limited as the Seller entered into an Acquisition Agreement, pursuant to which the Buyer has conditionally agreed to acquire and the Seller has conditionally agreed to sell all of the Seller's right, title, benefit and interest in the Target Assets owned by the Seller and licensed to the Buyer. The company has conditionally agreed to allot and issue 46,680,000 shares of the company at HK\$0.50 each (the "Consideration Shares") at a total consideration of HK\$23.34 million (equivalent to approximately RMB19.84 million) to the Seller for transferring the Target Assets to the Buyer. The consideration was arrived at after arm's length negotiations between the parties to the Acquisition Agreement on normal commercial terms with reference to (i) the future development and application prospects of the Target Assets and the synergies expected to be created by applying the Target Assets in further developing new applications and products and new sub-licensing business model; (ii) operating and financial performances of Personify business in the first ten months period ended 30 November 2020 as a result of the execution of the licensing arrangement between the Buyer and the Seller and its associates; (iii) the preliminary valuation of the Target Assets conducted by an independent valuer; and (iv) the original arm's length acquisition cost to the Seller and its associates.

The Consideration Shares represent (i) 7.13% of the existing issued share capital of the company as at the date of signing the Acquisition Agreement; and (ii) 6.65% of the issued share capital of the company as enlarged by the allotment and issue of the Consideration Shares at the completion date. The Consideration Shares are to be issued by the company under the specific mandate to be granted by the Independent Shareholders to the directors at the SGM.

Reasons for the Acquisition

Ever since the outbreak of the pandemic, substantial changes have been made to people's lifestyle as well as workstyle and demand for the video conferencing related applications have increased dramatically since video conferencing becomes a part of the new normal following the pandemic induced lockdown and people are largely required to work from home, and the group also foresees that in the long run, people and businesses will be more get used to and adapting to the use of video conferencing and online smart office services even after the pandemic. In view of the above, the company intends to allocate more internal resources to the smart office business segment to grasp the possible business opportunities that arise from the fundamental change to the society caused by the pandemic. Given the above, the company intends to continue developing Personify business. However, since the Target Assets are only being licensed to Personify Inc. by the Seller and its associates, the directors are concerned that the growth of Personify business might be hindered in the long run without the ownership of Personify's patents and source code etc. The directors consider the acquisition to be crucial to the group for its development in the smart office business segment as (i) it may enable the group to formulate a more comprehensive business development and marketing strategy by exploring every available business options including, but not limited to, generate additional licensing fee for granting others to use its technology by sub-licensing the patents and/or providing access to the source code or related software development kit that Personify Inc. cannot do so now under the current licensing agreement with the Seller and its associates; (ii) it is expected to provide the group with more incentive to deploy resources to develop new and existing applications and products for Personify business; (iii) it will be cost-saving in the long run as the group will no longer have to pay the licence fee for the Target Assets after the acquisition; and (iv) it will eliminate the uncertainties of the continuity of the current licensing arrangement between Personify Inc. and the Seller and its associates as there is no guarantee that the Seller and its associate will renew the existing licensing agreement upon its expiry of the one year term. Furthermore, the acquisition will be settled by issuance of the Consideration Shares to the Seller and the directors consider this to be beneficial to the group as it enables the group to retain more cash to endure the worsening economic environment due to the pandemic. Overall, the directors are of the view that the terms of the Acquisition Agreement and the transactions contemplated thereunder and the whitewash waiver are on normal commercial terms, fair and reasonable and in the interests of the company and its shareholders as a whole.

As one or more of the relevant percentage ratios applicable to the acquisition exceeds 5% but all of them are less than 25%, the acquisition constitutes a discloseable and connected transaction under Chapter 14 of the Listing Rules. As at the date of the Acquisition Agreement, Hon Hai holds 100.00% equity interest in the Seller and Hon Hai indirectly holds approximately 42.33% attributable equity interest in FSK Holdings Limited, which is a substantial shareholder of the company and has interests in 167,236,560 shares directly and 72,267,562 shares indirectly through FDG Fund, L.P. (formerly known as "Asia-IO Acquisition Fund, L.P."), representing approximately 25.53% and 11.04% of the issued share capital of the company respectively. FSK Holdings Limited is a limited partner of FDG Fund, L.P. contributing to about 75% of its total commitment. Despite Hon Hai does not fall within the ambit of an associate of FSK Holdings Limited under the Listing Rules, the company voluntarily complies with the reporting, announcement, circular and Independent Shareholders' approval requirements for the transactions contemplated under the Acquisition Agreement as if Hon Hai is a connected person of the company under Chapter 14A of the Listing Rules.

Takeovers Code Implications

The issue of the Consideration Shares to the Seller will result in the increase in shareholding of the Seller and its concert parties in the company from approximately 39.38% to approximately 43.42% immediately after the completion of the transaction. Accordingly, such an increase will give rise to an obligation under Rule 26 of the Hong Kong Code on Takeovers and Mergers (the "Takeovers Code") for the Seller to make a mandatory general offer under Rule 26 of the Takeovers Code for all the shares and other securities issued by the company not already held or agreed to be acquired by the Seller and its concert parties unless the whitewash waiver is obtained. An application will be made by the Seller to the SFC for the whitewash waiver pursuant to Note 1 on dispensations from Rule 26 of the Takeovers Code. The whitewash waiver will be subject to, among other things, the approval of the Independent Shareholders at the SGM. The Seller and parties acting in concert with it and the shareholders who are involved in or interested in the acquisition and/or the whitewash waiver, including but not limited to FSK Holdings Limited, FDG Fund, L.P. and Ms. Kan, Sachiko, will abstain from voting on the resolutions to approve the acquisition and the whitewash waiver at the SGM. It is one of the conditions of the Acquisition Agreement that the whitewash waiver be granted by SFC and be approved by the Independent Shareholders at the SGM. If the whitewash waiver is not granted by the SFC or not approved by the Independent Shareholders, the acquisition will not proceed.

1 GENERAL INFORMATION

Maxnerva Technology Services Limited (the "**Company**", together with its subsidiaries, the "**Group**"), is a limited liability company incorporated in Bermuda on 3 February 1994 as an exempted company under Companies Act 1981 of Bermuda. The address of its registered office is Canon's Court, 22 Victoria Street, Hamilton HM 12, Bermuda. The shares of the Company have been listed on the Main Board of The Stock Exchange of Hong Kong Limited since 14 April 1994.

As at 31 December 2021, the Group is principally engaged in the sales of I.T. products and software applications, and the provision of system and network integration, information technology solutions development and implementation, and related maintenance services to industrial, office and retail customers.

These financial statements are presented in Renminbi ("**RMB**"), unless otherwise stated.

2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies adopted in the preparation of these consolidated financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated. The consolidated financial statements are for the Group consisting of Maxnerva Technology Services Limited and its subsidiaries.

2.1 Basis of preparation

(a) Compliance with HKFRS and HKCO

The consolidated financial statements of the Group have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("**HKFRS**") and requirements of the Hong Kong Companies Ordinance Cap. 622.

Subsidiaries are fully consolidated from the date on which control is transferred to the Group. They are de-consolidated from the date that control ceases.

Intercompany transactions, balances and unrealised gains on transactions between group companies are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the transferred asset. Accounting policies of subsidiaries have been changed when necessary to ensure consistency with policies adopted by the Group.

(b) Associates

An associate is an entity over which the Group has significant influence but not control or joint control. This is generally the case where the Group holds between 20% and 50% of the voting rights. Investments in associates are accounted for using the equity method of accounting.

Under the equity method of accounting, the investments are initially recognised at cost and adjusted thereafter to recognise the Group's share of the post-acquisition profits or losses of the investee in profit or loss, and the Group's share of movements in other comprehensive income of the investee in other comprehensive income.

Where the Group's share of losses in an equity-accounted investment equals or exceeds its interest in the entity, including any other unsecured long-term receivables, the Group does not recognise further losses, unless it has incurred obligations or made payments on behalf of the other entity.

(c) Joint arrangement

The Group has applied HKFRS 11 Joint Arrangements Investments in joint arrangements are classified as joint venture. The classification depends on the contractual rights and obligations of each investor, rather than the legal structure of the joint arrangement. Investments in joint ventures are accounted for using the equity method of accounting.

Under the equity method of accounting, the investments are initially recognised at cost and adjusted thereafter to recognise the Group's share of the post-acquisition profits or losses of the investee in profit or loss, and the Group's share of movements in other comprehensive income of the investee in other comprehensive income. Dividends received or receivable from joint venture is recognised as a reduction in the carrying amount of the investment.

Where the Group's share of losses in an equity-accounted investment equals or exceeds its interest in the entity, including any other unsecured long-term receivables, the Group does not recognise further losses, unless it has incurred obligations or made payments on behalf of the other entity.

Impairment testing of the investments in subsidiaries is required upon receiving dividends from these investments if the dividend exceeds the total comprehensive income of the subsidiary in the period the dividend is declared or if the carrying amount of the investment in the separate financial statements exceeds the carrying amount in the consolidated financial statements of the investee's net assets including goodwill.

2.4 Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision maker.

The chief operating decision-maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the executive directors that make strategic decisions.

2.5 外幣換算

(a) 功能和呈報貨幣

本集團旗下各實體之財務報表所載 項目均採用有關實體營運所在之主 要經濟環境通用之貨幣(「**功能貨** 幣」)計量。本公司之功能貨幣為港 元,而合併財務報表以本公司及本 集團之呈報貨幣人民幣呈報。

2.5 Foreign currency translation

(a) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The Company's functional currency is Hong Kong dollars while the consolidated financial statements are presented in RMB, which is the Company's and the Group's presentation currency.

(b) Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions or valuation where items are remeasured. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in the income statement.

Foreign exchange gains and losses are presented in the income statement within "Other gains, net".

Non-monetary items that are measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was determined. Translation differences on assets and liabilities carried at fair value are reported as part of the fair value gain or loss. For example, translation differences on non-monetary assets and liabilities such as equities held at fair value through profit or loss are recognised in profit or loss as part of the fair value gain or loss. Mon-monetary assets such as equities classified as fair value through other comprehensive income are recognised in other comprehensive income.

The results and financial position of all the group entities (none of which has the currency of a hyperinflationary economy) that have a functional currency different from the presentation currency are translated into the presentation currency as follows:

- assets and liabilities for each balance sheet presented are translated at the closing rate at the date of that balance sheet;
- income and expenses for each income statement are translated at average exchange rates (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the rate on the dates of the transactions); and
- (iii) all resulting exchange differences are recognised in other comprehensive income.

On consolidation, exchange differences arising from the translation of any net investment in foreign entities, are recognised in other comprehensive income. When a foreign operation is sold, the associated exchange differences are reclassified to profit or loss, as part of the gain or loss on sale.

2.6 Property, plant and equipment

All property, plant and equipment are stated at historical cost less depreciation. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other repairs and maintenance are charged to the income statement during the financial period in which they are incurred.

Depreciation is calculated using the straight-line method to allocate their cost amounts, net of their residual values if any, over their estimated useful lives or, in the case of leasehold improvements, the lease term as follows:

Computer equipment	3 to 5 years
Leasehold improvements	Shorter of lease term or 5 years
Furniture, fixtures and equipment	3 to 5 years

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount (Note 2.8).

Gain or loss on disposals are determined by comparing the proceeds with the carrying amount and are recognised within "Other gains, net" in the income statement.

Acquired computer software is capitalised on the basis of the costs incurred to acquire and bring to use the specific software. These costs are incurred to acquire and bring to use the specific software, and are amortised using the straight-line method over their estimated useful life of 3 to 5 years.

Acquired software components, patents, domain names and trademark are capitalised on the basis of the costs acquired. They are carried at cost less accumulated amortisation. They are amortised using the straight-line method over their estimated useful lives of 8 years.

2.8 Impairment of non-financial assets

Non-financial assets that are not subject to depreciation or amortisation are tested annually for impairment, or more frequently if events or changes in circumstances indicate that they might be impaired. Other non-financial assets are tested for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs of disposal and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash inflows which are largely independent of the cash inflows from other assets or groups of assets (cash-generating units). Nonfinancial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at the end of each reporting period.

(a) Classification

The Group classifies its financial assets as following measurement categories: (i) those measured subsequently at fair value through profit or loss; and (ii) those to be measured at amortised cost. The classification depends on the entity's business model for managing the financial assets and the contractual terms of the cash flows. Management determines the classification of its financial assets at initial recognition.

For assets measured at fair value through profit or loss, gains and losses will be recorded in profit or loss. For investments in equity instruments that are not held for trading, this will depend on whether the Group has made an irrevocable election at the time of initial recognition to account for the equity investment at fair value through other comprehensive income ("**FVOCI**").

The Group reclassifies debt investments when and only when its business model for managing those assets changes.

(b) Recognition and derecognition

Regular way purchases and sales of financial assets are recognised on the trade-date, the date on which the Group commits to purchase or sell the asset. Financial assets are derecognised when the rights to receive cash flows from the financial assets have expired or have been transferred and the Group has transferred substantially all risks and rewards of ownership.

(c) Measurement

At initial recognition, the Group measures a financial asset at its fair value plus, in the case of a financial asset not at fair value through profit or loss ("**FVPL**"), transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at FVPL are expensed in profit or loss.

Debt instruments

Subsequent measurement of debt instruments depends on the Group's business model for managing the asset and the cash flow characteristics of the asset. There are two measurement categories into which the Group classifies its debt instruments:

- Amortised cost: Assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are measured at amortised cost. A gain or loss on a debt investment that is subsequently measured at amortised cost and is not part of a hedging relationship is recognised in the consolidated income statements when the asset is derecognised or impaired. Interest income from these financial assets is included in finance income using the effective interest rate method.
- Fair value through profit or loss: Assets that do not meet the criteria for amortised cost or FVOCI are measured at FVPL. A gain or loss on a debt investment that is subsequently measured at FVPL and is not part of a hedging relationship is recognised in profit or loss and presented net in 'Other gains, net' in the period in which it arises.
- Financial assets with embedded derivatives, for example, a convertible bond, are considered in their entirety when determining whether their cash flows are solely payment of principal and interest.

Equity instruments

The Group subsequently measures all equity investments at fair value. Changes in the fair value of financial assets at FVPL are recognised in the consolidated income statement as applicable.

The Group assesses on a forward looking basis the expected credit losses associated with all instruments subjected to the expected credit loss assessment. The impairment methodology applied to debt instruments other than financial assets through profit or loss depends on whether there has been a significant increase in credit risk. Note 3.1(b) details how the Group determines whether there has been a significant increase in credit risk.

For trade and other receivables (excluding other tax receivables), contract assets and finance leases receivables, the Group applies the simplified approach permitted by HKFRS 9, which requires expected lifetime losses to be recognised from initial recognition of the receivables, see Note 3.1(b) for further details.

2.10 Offsetting financial instruments

Financial assets and liabilities are offset and the net amount is reported in the balance sheet when there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis or realise the asset and settle the liability simultaneously. The legally enforceable right must not be contingent on future events and must be enforceable in the normal course of business and in the event of default, insolvency or bankruptcy of the Group or the counterparty.

2.11 Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined by using the weighted average method. Net realisable value is the estimated selling price in the ordinary course of business, less applicable variable selling expenses.

2.12 Trade receivables

Trade receivables are amounts due from customers for products sold or services performed in the ordinary course of business. If collection of trade receivables is expected in one year or less (or in the normal operating cycle of the business if longer), they are classified as current assets. If not, they are presented as noncurrent assets.

Trade receivables are recognised initially at the amount of consideration that is unconditional unless they contain significant financing components, when they are recognised at fair value. The Group holds the trade receivables with the objective to collect the contractual cash flows and therefore measures them subsequently at amortised cost using the effective interest method. See note 20 for further information about the Group's accounting for trade receivables and note 3.1(b) for a description of the Group's impairment policies.

Trade receivables are presented on the consolidated balance sheet within trade and lease receivables.

2.13 Contracts assets and contract liabilities

A contract asset represents the Group's right to consideration in exchange for goods or services that the Group has transferred to a customer. A contract asset becomes a receivable when the Group's right to consideration is unconditional, which is the case when only the passage of time is required before payment of the consideration is due. The impairment of contract assets is measured, presented and disclosed on the same basis set out in Note 2.9(d).

A contract liability represents the Group's obligation to transfer goods or services to a customer for which the Group has received consideration.

2.14 Cash and cash equivalents

For the purpose of presentation in the statement of cash flows, cash and cash equivalents include cash in hand and deposits held at call with banks.

Ordinary shares are classified as equity. Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

2.16 Trade payables

Trade payables are obligations to pay for goods or services that have been acquired in the ordinary course of business from suppliers. Trade payables, other payables and accruals are classified as current liabilities if payment is due within one year or less (or in the normal operating cycle of the business if longer). If not, they are presented as non-current liabilities.

Trade payables, other payables and accruals are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method.

2.17 Current and deferred income tax

The income tax expense or credit for the period is the tax payable on the current period's taxable income based on the applicable income tax rate for each jurisdiction adjusted by changes in deferred tax assets and liabilities attributable to temporary differences and to unused tax losses.

(a) Current income tax

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the end of the reporting period in the countries where the Company and its subsidiaries operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation. It establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

Deferred income tax is provided in full, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial statements. However, deferred tax liabilities are not recognised if they arise from the initial recognition of goodwill. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantially enacted by the end of the reporting period and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

Deferred tax assets are recognised only if it is probable that future taxable amounts will be available to utilise those temporary differences and losses.

Deferred tax liabilities and assets are not recognised for temporary differences between the carrying amount and tax bases of investments in foreign operations where the Group is able to control the timing of the reversal of the temporary differences and it is probable that the differences will not reverse in the foreseeable future.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets and liabilities and when the deferred tax balances relate to the same taxation authority. Current tax assets and tax liabilities are offset where the entity has a legally enforceable right to offset and intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously.

Current and deferred tax is recognised in profit or loss, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, respectively.

(a) 退休金責任

本集團參與若干可供所有相關僱員 享用的設定提存供款退休福利計 劃。該等計劃一般以向政府成立的 計劃或信託管理基金支付款項之方 式運作。設定提存計劃指本集團以 強制、合約或自願基準向獨立實體 作出供款之退休金計劃。倘基金並 無足夠資產就當期及過往期間之僱 員服務向所有僱員支付福利,本集 團並無法定或推定責任作出進一步 供款。

香港

本集團於香港之僱員須參與強制性 公積金計劃(「**強積金計劃**」)界定之 定額供款計劃。強積金計劃之資產 由獨立管理之基金持有,獨立於本 集團之資產。

在強積金計劃下,本集團及各僱員 分別按僱員有關入息(按照強制性 公積金計劃條例之定義)百分之五 供款。本集團及僱員雙方之供款均 為每月最高1,500港元,隨後為自願 性供款。有關供款即時悉數歸屬僱 員。

中國

按照中國法規規定,本集團為中國 有關僱員向國家資助退休計劃供 款。本集團及其相關僱員按有關入 息(包括薪金、津貼及花紅)按各自 法定比例供款。除以上供款外,本 集團沒有額外支付實際退休後福利 之承擔。此國家資助退休計劃負責 對退休僱員提供全部退休後收益。

2.18 Employee benefits

(a) Pension obligations

The Group participates in various defined contribution retirement benefit plans which are available to all relevant employees. These plans are generally funded through payments to schemes established by government or trustee-administered funds. A defined contribution plan is a pension plan under which the Group pays contributions on a mandatory, contractual or voluntary basis into a separate entity. The Group has no legal or constructive obligations to pay further contributions if the fund does not hold sufficient assets to pay all employees the benefit relating to employee service in the current and prior periods.

Hong Kong

Employees of the Group in Hong Kong are required to participate in a defined contribution scheme as defined in Mandatory Provident Fund Scheme ("**MPF Scheme**"). The assets of the MPF Scheme are held separately from those of the Group under independently administered funds.

Under the MPF Scheme, each of the Group and its employees makes monthly contributions to the scheme at 5% of the employee's relevant income, as defined in the Mandatory Provident Fund Scheme Ordinance. Both the Group's and the employee's contributions are subjected to a cap of HK\$1,500 per month, with contributions beyond these amounts being voluntary. The contributions are fully and immediately vested to the employees.

The PRC

As stipulated by rules and regulations in The PRC, the Group contributes to state-sponsored retirement plans for its relevant employees in The PRC. The Group and its relevant employees make monthly contributions to the plans at the respective statutory rates on the relevant income (comprising salaries, allowances and bonus). The Group has no further obligations for the actual payment of post-retirement benefits beyond its contributions. The state-sponsored retirement plans are responsible for the entire post-retirement benefits payable to retired employees.

本公司根據勞工退休金條例(「條 例」),參與界定供款退休金計劃 (「新計劃」),適用於所有台灣普 通員工。根據新計劃,本公司每月 按員工月薪及工資之6%提繳至勞 保局員工個人退休金賬戶。產生之 福利於僱傭終止時每月或一次性支 付。除供款外,本集團對實際支付 退休後福利並無其他責任。

退休計劃之所有供款均全部及即時 歸屬,本集團並無未歸屬之福利以 減少將來供款。

(b) 花紅計劃

當本集團因僱員已提供之服務而產 生現有法定或推定責任,而該責任 金額能夠可靠估算時,派付花紅之 預期成本將確認為負債。花紅計劃 之負債預期在十二個月內結付,並 以結付時預計需付之金額計量。

(c) 僱員應享假期

僱員的年假權利於僱員應享時確 認。本集團就僱員截至報告期末已 提供的服務而享有的年假的估計負 債作出撥備。

僱員應享的病假及產假於休假前不 予確認。

(a) Pension obligations (continued)

Taiwan

The Company participates in a defined contribution pension plan (the "**New Plan**") under the Labor Pension Act (the "**Act**"), covering all regular employees in Taiwan. Under the New Plan, the Company contribute monthly an amount based on 6% of the employees' monthly salaries and wages to the employees' individual pension accounts at the Bureau of Labor Insurance. The benefits accrued are paid monthly or in lump sum upon termination of employment. The Group has no further obligations for the actual payment of postretirement benefits beyond its contributions.

All contributions to pension plans are fully and immediately vested and the Group had no unvested benefits available to reduce its future contributions.

(b) Bonus plan

The expected cost of bonus payments is recognised as a liability when the Group has a present legal or constructive obligation as a result of services rendered by employees and a reliable estimate of the obligation can be made. Liabilities of bonus plan are expected to be settled within twelve months and are measured at the amounts expected to be paid when they are settled.

(c) Employee leave entitlements

Employee entitlements to annual leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave as a result of services rendered by employees up to the end of reporting period.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

2.19 Share-based compensation

The Group operates a share-based compensation plan for the purpose of providing incentives and rewards to eligible participates who contribute to the success of the Group's operations. The fair value of the employee services received in exchange for the grant of the options is recognised as an expense. The total amount to be expensed is determined by reference to the fair value of the options granted:

- including any market performance conditions (for example, an entity's share price);
- excluding the impact of any service and non-market performance vesting conditions (for example, profitability, sales growth targets and remaining an employee of the entity over a specified time period); and
- including the impact of any non-vesting conditions (for example, the requirement for employees to save).

Non-market vesting conditions are included in assumptions about the number of options that are expected to vest. The total expense is recognised over the vesting period, which is the period over which all of the specified vesting conditions are to be satisfied.

At the end of each reporting period, the Group revises its estimates of the number of options that are expected to vest based on the non-market performance and service conditions. It recognises the impact of the revision to original estimates, if any, in the income statement, with a corresponding adjustment to equity. When the options are exercised, the Company issues new shares. The proceeds received net of any directly attributable transaction costs are credited to share capital (nominal value) and share premium.

The Group issued shares for the acquisition of intangible assets. The difference between the fair value of shares issued and the fair value of the intangible assets is recognised as an expense in the consolidated income statement.

Provisions are recognised when: the Group has a present legal or constructive obligation as a result of past events; it is probable that an outflow of resources will be required to settle the obligation; and the amount has been reliably estimated. Provisions are not recognised for future operating losses.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Provisions are measured at the present value of the expenditures expected to be required to settle the obligation using a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the obligation. The increase in the provision due to passage of time is recognised as interest expense within "finance cost" in the income statement.

2.21 Government grants

Grants from the government are recognised at their fair value where there is a reasonable assurance that the grant will be received and the Group will comply with all attached conditions. Government grants relating to costs are deferred and recognised in the profit or loss over the period necessary to match them with the costs that they are intended to compensate. Government grants are presented in "other income" in the consolidated income statement.

2.22 Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable, and represents amounts receivable for goods supplied, stated net of discounts, returns and value added taxes. The Group recognises revenue when the amount of revenue can be reliably measured; when it is probable that future economic benefits will flow to the entity; and when specific criteria have been met for each of the Group's activities, as described below.

(a) Sales of goods

The Group engages in sales of I.T products including but not limited to servers, projectors, monitors, Mondopads, computer hardwares and softwares, and other IoT products. Sales of goods are recognised when the control of the products has transferred, being when the products are delivered to the customer, the customer has full discretion over the channel and price to sell the products, and there is no unfulfilled obligation that could affect the customer's acceptance of the products. Delivery occurs when the products have been shipped to the specified location, the risks of obsolescence and loss have been transferred to the customer, and either the customer has accepted the products in accordance with the sales contract, the acceptance provisions have lapsed, or the Group has objective evidence that all criteria for acceptance have been satisfied.

Accounts receivable is recognised when the goods are delivered, this is the point in time that the consideration is unconditional because only the passage of time is required before the payment is due.

(b) Interest income

Interest income is recognised using the effective interest method.

Interest income is presented as finance income where it is earned from financial assets that are held for cash management purposes. Any other interest income is included in other income.

(c) Finance and operating lease income

The revenue recognition for the lease income under finance and operating leases are stated in Note 2.23.

(d) 資訊科技項目

如屬固定價格合約,客戶按付款期 支付固定金額。倘本集團提供之服 務超逾付款,則確認合約資產。倘 付款超逾所提供服務,則確認合約 負債。

倘合約包括時薪,收入確認為本集 團有權出具發票的金額。客戶按月 或根據協定付款條款出具發票,代 價於出具發票時支付。

(d) I.T. Project

Revenues from I.T. Project are generated from providing services for development of tailor-made software, platform and related hardware in smart manufacturing and other IoT applications. The revenue is recognised based on the actual service provided to the end of the reporting period as a proportion of the total services to be provided because the customer receives and uses the benefits simultaneously. This is determined based on the actual labour hours spent relative to the total expected labour hours.

The revenue of rendering of services comprises the agreed contract amount. Some contracts include multiple performance obligations, such as the sale of hardware, consultation services and related installation services. Where the contracts include multiple performance obligations, the transaction price will be allocated to each performance obligation based on the stand-alone selling prices. Where these are not directly observable, they are estimated based on expected cost plus margin. If contracts include the installation of hardware, revenue for the hardware is recognised at a point in time when the hardware is delivered, the legal title has passed and the customer has accepted the hardware.

Estimates of revenues, costs or extent of progress toward completion are revised if circumstances change. Any resulting increases or decreases in estimated revenues or costs are reflected in profit or loss in the period in which the circumstances that give rise to the revision become known by management.

In case of fixed-price contracts, the customer pays the fixed amount based on a payment schedule. If the services rendered by the Group exceed the payment, a contract asset is recognised. If the payments exceed the services rendered, a contract liability is recognised.

If the contract includes an hourly fee, revenue is recognised in the amount to which the Group has a right to invoice. Customers are invoiced on a monthly basis or according to agreed payment terms and consideration is payable when invoiced.

(e) Maintenance and consulting services

Revenues from maintenance and consulting services are recognised on a time proportion basis over the period of the contract or when the relevant services have been rendered, as appropriate.

(f) Financing components

For contracts where the period between the transfer of the promised goods or services to customers and payment by the customers exceeds one year, the transaction prices were adjusted for the time value of money. For the sales with credit terms ranging from 30 to 90 days, no element of financing is deemed present, which is consistent with market practice.

2.23 Leases

Leases are recognised as a right-of-use asset and a corresponding liability at the date at which the leased asset is available for use by the Group, except for all short-term leases and leases of low-value assets.

Contracts may contain both lease and non-lease components. The Group allocates the consideration in the contract to the lease and non-lease components based on their relative stand-alone prices.

Assets and liabilities arising from a lease are initially measured on a present value basis. Lease liabilities include the net present value of the fixed lease payments.

Lease payments to be made under reasonably certain extension options are also included in the measurement of the liability.

The lease payments are discounted using the interest rate implicit in the lease. If that rate cannot be readily determined, which is generally the case for leases in the Group, the lessee's incremental borrowing rate is used, being the rate that the individual lessee would have to pay to borrow the funds necessary to obtain an asset of similar value to the right-of-use asset in a similar economic environment with similar terms, security and conditions.

Lease payments are allocated between principal and finance cost. The finance cost is charged to profit or loss over the lease period so as to produce a constant periodic rate of interest on the remaining balance of the liability for each period.

Right-of-use assets are measured at cost comprising the following:

- the amount of the initial measurement of lease liability; and
- any lease payments made at or before the commencement date less any lease incentives received.

Right-of-use assets are generally depreciated over the shorter of the asset's useful life and the lease term on a straight-line basis. If the Group is reasonably certain to exercise a purchase option, the right-of-use asset is depreciated over the underlying asset's useful life.

Payments associated with short-term leases of equipment and vehicles and all leases of low-value assets are recognised on a straight-line basis as an expense in profit or loss. Short-term leases are leases with a lease term of 12 months or less. Low-value assets comprise IT equipment and small items of office equipment.

Lease income from operating leases where the Group is a lessor is recognised in income on a straight-line basis over the lease term. Initial direct costs incurred in obtaining an operating lease are added to the carrying amount of the underlying asset and recognised as expense over the lease term on the same basis as lease income. The respective leased assets are included in the balance sheet based on their nature.

Lease income from finance lease recognised as finance income based on a pattern reflecting a constant periodic rate of return on the lessor's net investment outstanding in respect of the finance lease. At commencement of the lease term, the lessor should record a finance lease in the balance sheet as a receivable, at an amount equal to the net investment in the lease. The derecognition and impairment requirements of HKFRS 9 apply to a lessor's net investment in a lease.

2.24 Dividend distribution

Provision is made for the amount of any dividend declared, being appropriately authorised and no longer at the discretion of the entity, on or before the end of the reporting period but not distributed at the end of the reporting period.

3 財務風險管理

3.1 財務風險因素

本集團經營活動面對多項財務風險:市場 風險(包括外匯風險及現金流量及公平值 利率風險)、信貸風險及流動資金風險。 本集團整體風險管理計劃針對難以預測 的金融市場,以將對本集團財務表現的潛 在不利影響降至最低。

管理層定期監察本集團之財務風險。使用 衍生金融工具對沖若干風險受本公司董 事會批准的本集團政策規管。本集團會按 情況考慮訂立若干外匯遠期期權以管理 其外匯風險。本集團並無使用衍生金融工 具作投機活動。

(a) 市場風險

(i) 外匯風險

本集團業務主要位於香港、 台灣、中國及美國,其大部 份交易以港元、人民幣、美 元(「美元」)、新台幣(「新台 幣」)及歐元(「歐元」)結算。倘 日後商業交易或已確認資產 及負債以非公司功能貨幣計 值,則將會產生外匯 的外匯風險,主要為有關美 元、新台幣及歐元的外匯風 險。

管理層已訂立政策,要求集 團公司管理與其功能貨幣有 關的外匯風險。管理主要包 括有關集團公司因銷售及購 貨以非公司功能貨幣計值而 引起之風險。本集團亦透過 定期檢討本集團外匯淨額風 險管理其外匯風險及考慮使 用外匯合約管理外匯風險(如 適合)。

3 FINANCIAL RISK MANAGEMENT

3.1 Financial risk factors

The Group's activities expose it to a variety of financial risks: market risk (including foreign exchange risk and cash flow and fair value interest-rate risks), credit risk and liquidity risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

Management regularly monitors the financial risks of the Group. The use of derivative financial instruments to hedge certain risk exposures is governed by the Group's policies approved by the Board of Directors of the Company. The Group would occasionally enter into certain foreign currency forwards options to manage its exchange risks. The Group does not use derivative financial instruments for speculative purposes.

(a) Market risk

(i) Foreign exchange risk

The Group mainly operates in Hong Kong, Taiwan, the PRC and the United States with most of the transactions settled in HK\$, RMB, United States dollars ("**USD**"), New Taiwanese dollars ("**NTD**") and Euro ("**EUR**"). Foreign exchange risk arises when future commercial transactions or recognised assets or liabilities are denominated in a currency that is not the entity's functional currency. The Group is exposed to foreign exchange risk from various currencies, primarily with respect to USD, NTD and EUR.

Management has a policy to require group companies to manage their foreign exchange risk against their functional currencies. It mainly includes managing the exposures arising from sales and purchases made by the relevant group companies in currencies other than their own functional currencies. The Group also manages its foreign exchange risk by performing regular reviews of the Group's net foreign exchange exposures and would consider the use of foreign exchange contracts to manage its foreign exchange risks, where appropriate.

As at 31 December 2021, for companies with RMB as their functional currency, if USD had weakened/ strengthened by 5% against the RMB, with all other variables held constant, post-tax profit for the year would have been approximately RMB189,000 (2020: RMB48,000) lower/higher, mainly as a result of foreign exchange losses/gains on translation of bank balances denominated in USD.

For a company with NTD as its functional currency, if USD and RMB had weakened/strengthened by 5% against the NTD, with all other variables held constant, post-tax profit for the year would have been approximately RMB281,000 higher/lower and RMB409,000 lower/higher (2020: RMB151,000 higher/ lower and RMB22,000 lower/higher), respectively, mainly as a result of foreign exchange gains/losses on translation of lease liabilities denominated in USD and losses/gains on translation of bank balances denominated in RMB.

For the group companies with HKD and NTD as their functional currencies, if EUR had weakened/ strengthened by 5% against HKD and NTD respectively, with all other variables held constant, post-tax profit for the year would have been approximately RMB324,000 (2020: Nil) lower/higher, mainly as a result of foreign exchange losses/gains on translation of bank balances, trade receivables, prepayment and accruals denominated in EUR.

(ii) Cash flow and fair value interest-rate risk

The Group's income and operating cash flows are substantially independent of changes in market interest rates. The Group has no significant interest-bearing assets except for the cash at banks, details of which are disclosed in Note 22. The Group's exposure to changes in interest rates is mainly attributable to its lease liabilities, details of which are disclosed in Note 15. Lease liabilities carried at fixed rates expose the Group to fair value interest rate risk but management considers that the fair value interest rate risk is immaterial. The Group has not used any interest rate swaps to hedge its exposure to interest rate risk.

No sensitivity analysis is presented as the Group did not have material interest bearing liabilities as at 31 December 2021.

Credit risk arises from cash at banks, trade and lease receivables and contract assets, deposits and other receivables carried at amortised cost.

(i) Risk management

Credit risk is managed on a group basis.

The majority of the Group's cash at banks are deposited in major financial institutions located in Hong Kong, The PRC and Taiwan, which are in good reputation and high credit quality. Management does not expect any losses arising from non-performance by these counterparties.

Credit risk includes risks resulting from risks of concentration and counterparty default. As at 31 December 2021, the Group has concentration of credit risk as its top 5 trade debtors represent 40% (2020: 48%) of the total trade and lease receivables and contract assets. The Group also has policies in place to ensure that sale of products are made to customers with an appropriate credit history and the Group performs periodic credit evaluations of its customers. Normally the Group does not require collaterals from trade debtors.

Measurement of expected credit loss on collective basis

The Group categories its trade receivables and contract assets, except those individually assessed, based on the risk characteristics.

The expected loss rates are based on the payment profiles of sales over a period of 12 months before 31 December 2021 and the corresponding historical credit losses experienced within this period. The historical loss rates are adjusted to reflect current and forward-looking information on macroeconomic factors affecting the ability of the customers to settle the receivables, including but not limited to the impact of the COVID-19 pandemic on the global economic growth.

The Group has identified the Gross Domestic Products ("**GDP**") and unemployment rate of the countries in which it sells its goods and services to be the most relevant factor, and accordingly adjusts the historical loss rates based on expected changes in these factors.

The Group divided trade receivables and contract assets into 2 categories by the geographic location of its customers and credit risk characteristic, as follow:

- Category 1 is for customers conducting business in Asia region
- Category 2 is for customers conducting business in non-Asian region

With different types of customers, the Group calculated the expected loss rate respectively.

On that basis, the loss allowance as at 31 December 2021 was determined as follows for both trade receivables and contract assets.

Given the track record of regular cash flow received by the Group, the directors are of the opinion that the risk of default and expected loss rates by these counterparties is low and does not expect any losses from non-performance by the counterparties. The Group uses judgement in making these assumptions and selecting the inputs to the impairment calculation, based on the Group's past history, existing market conditions as well as forwardlooking estimates at the end of each reporting period. The expected credit loss rate of the finance leases receivable is minimal and no loss allowance was made as at 31 December 2021 (2020: Nil).

Other financial assets at amortised costs

Other financial assets at amortised cost include deposits and other receivables (excluding tax recoverable).

The credit quality of other financial assets at amortised cost has been assessed with reference to historical information about the counterparties default rates and financial position of the counterparties. Management considers that its credit risk has not increased significantly since initial recognition and the impairment provision is determined based on the 12-month expected credit loss. The loss allowance for other financial assets at amortised cost as at 31 December 2021 is RMB98,000 (2020: RMB98,000).

The Group's primary cash requirements have been for additions of property, plant and equipment, purchase of inventories, settlement of lease liabilities, payment for trade and other payables and payment for operating expenses. The Group mainly finances its working capital requirements through a combination of internal resources and bank borrowings, as necessary.

3.3 資本風險管理

(b) Fair value of financial assets and liabilities measured at amortised costs

The carrying amounts of the Group's current financial assets, including cash and cash equivalents, trade and lease receivables and contract assets, deposits and other receivables, and the Group's current financial liabilities including trade payables, accruals and other payables and lease liabilities, approximate their fair values due to their short maturities. The carrying amounts of non-current trade and lease receivables, rental deposits and lease liabilities approximate their fair values which are estimated based on the discounted cash flows.

(c) Offsetting financial assets and financial liabilities

The Group has no financial assets and financial liabilities, which is subject to offsetting, enforceable master netting arrangements and similar agreements.

3.3 Capital risk management

The Group's objectives when managing capital are to safeguard the Group's ability to continue as a going concern in order to provide returns for shareholders and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital.

The Group actively and regularly reviews and manages its capital structure to ensure optimal capital structure and shareholder returns, taking into consideration the future capital requirements of the Group and capital efficiency, prevailing and projected profitability, projected operating cash flows, projected capital expenditures and projected strategic investment opportunities.

The Group also monitors capital on the basis of the gearing ratio. This ratio is calculated as net debt divided by total capital. Net debt is calculated as total borrowings (including current and noncurrent borrowings as shown in the consolidated balance sheet) less cash and cash equivalents. Total capital is calculated as "equity", as shown in the consolidated balance sheet, plus net debt.

As at 31 December 2021 and 2020, the Group was at net cash position.

根據有關違約風險及預期信貸虧損率之 假設,本集團就營業及租賃應收賬項計提 虧損撥備。根據本集團過往歷史、現有市 況及各報告期末之前瞻性估計(包括空前 新型冠狀病毒疫情對本集團業務營運及 其營運所在國家的經濟影響),本集團於 作出該等假設及選擇減值計算之輸入數 據時使用判斷。所用之關鍵假設及輸入數 據詳情披露於附註3.1(b)(ii)表格。

(b) 就資訊科技項目提供服務的收入確認

當合約結果能可靠估計時,本集團按報告 期末合約活動之完成百分比確認所提供 服務之若干收入。完成百分比按截至該日 實際進行工作所產生合約成本佔交易項 下將產生之估計合約總成本的比例,或按 截至該日所提供服務價值佔交易項下將 提供服務價值總值百分比計量。估計合約 成本總值及/或完成百分比時須依據員 工成本預算總額等重大假設。有關估計乃 根據管理層過往經驗及知識作出。

CRITICAL ACCOUNTING ESTIMATES AND ASSUMPTIONS

Estimates are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are addressed below.

(a) Expected credit loss of trade and lease receivables

The Group makes loss allowance for trade and lease receivables based on assumptions about risk of default and expected credit loss rates. The Group uses judgement in making these assumptions and selecting the inputs to the impairment calculation, based on the Group's past history, existing market conditions as well as forward looking estimates, including the economic impact of the unprecedented COVID-19 pandemic on the operations of the Group and the countries in which it operates at the end of each reporting period. Details of the key assumptions and inputs used are disclosed in the tables in Note 3.1(b)(ii).

(b) Revenue recognition of rendering of services for I.T. Projects

The Group recognises certain revenue on the rendering of services by reference to the percentage of completion of the contract activity at the end of the reporting period, when the outcome of a contract can be estimated reliably. The percentage of completion is measured by reference to the proportion that contract costs incurred for work performed to date compared to the estimated total contract costs to be incurred under the transaction, or the value of services performed to date as a percentage of the value of total services to be performed under the transaction. Significant assumptions such as the total budgeted staff costs, are required to estimate the total contract costs and/or the percentage of completion. The estimates are made based on past experience and knowledge of management.

(c) 所得稅及遞延稅項

(e) 存貨之可變現淨值

存貨之可變現淨值乃於日常業務過程中 的估計售價,減去估計銷售開支。該等估 計乃基於現時市況以及銷售類似性質產 品的過往經驗。其可能因客戶喜好轉變及 競爭對手因應嚴峻行業週期而採取的行 動而出現重大變動。管理層於各報告日期 重新評估該等估計。

(c) Income tax and deferred tax

The Group is subject to income taxes in the jurisdictions where its subsidiaries operate. Significant judgement is required in determining provisions for income taxes. There are certain transactions and calculations for which the ultimate tax determination is uncertain. The Group recognises liabilities for anticipated tax audit issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the current and deferred income tax assets and liabilities in the period in which such determination is made.

The Group is also exposed to other taxes and duties. Significant judgement is required in determining these provisions. Where the final outcomes of these matters differ from the actual results, such difference will impact the provisions made and the earnings stated in the income statement.

(d) Estimation of the fair value of financial assets at fair value through profit or loss

The fair value of financial assets at fair value through profit or loss that are not traded in an active market is determined using valuation techniques. The Group uses its judgement to select a variety of methods and make assumptions that are mainly based on market conditions existing at the end of each reporting period. For details of the key assumptions used and the impact of changes to these assumptions (Note 3.2(a)).

(e) Net realisable value of inventories

Net realisable value of inventories is the estimated selling price in the ordinary course of business, less estimated selling expenses. These estimates are based on the current market condition and the historical experience of selling products of similar nature. It could change significantly as a result of changes in customer taste and competitor actions in response to severe industry cycle. Management reassesses these estimates at each reporting date.

本集團各營運分部均為策略性業務單位,由相 關業務單位的領導人管理。主要營運決策人根 據除所得稅前溢利之計量指標評估經營分部的 表現。提供予主要營運決策人的其他資料乃以 與合併財務報表一致的方式計量。

呈報分部的資產不包括統一管理的公司資產 (主要包括公司的現金及現金等價物、物業、 機器及設備、使用權資產、預付款項及其他應 收款項、按公平值計入損益之金融資產以及遞 延所得稅資產)。呈報分部的負債不包括公司負 債(主要包括租賃負債、應計費用、其他應付款 項、應付稅項以及遞延所得稅負債)。該等資產 及負債為資產負債表合計的對賬部分。

REVENUE AND SEGMENT INFORMATION

The chief operating decision maker has been identified as the executive directors (collectively referred to as the "**Chief Operation Decision Maker**" or "**CODM**") that make strategic decisions. The CODM reviews the internal reporting of the Company and its subsidiaries in order to assess performance and allocate resources. Management has determined the operating segment based on the Group's development plan and the internal reporting provided to the CODM. The management determined to divide its operation into three segments as follows:

1. Industrial Solution Business

 The provision of smart manufacturing solutions and services to improve the effectiveness and efficiency of production lines, plant facilities and the management of industrial parks.

2. Smart Office Business

 The provision of video conference related solutions plus brand licensing and supply chain management of smart office equipment.

3. New Retail Business

- The provision of digital retail signage solutions.

Each of the Group's operating segments represents a strategic business unit that is managed by the respective business unit leaders. CODM assesses the performance of the operating segments based on a measure of profit before income tax. Other information provided to the CODM is measured in a manner consistent with that in the consolidated financial statements.

Assets of reportable segments exclude corporate assets (mainly including corporate cash and cash equivalents, property, plant and equipment, right-of-use assets, prepayments and other receivables, financial assets at fair value through profit or loss and deferred income tax assets), all of which are managed on a central basis. Liabilities of reportable segments exclude corporate liabilities (mainly including lease liabilities, accruals, other payables, tax payables and deferred income tax liabilities). These are part of the reconciliation to total balance sheet assets and liabilities.

On 26 March 2019, the Group entered into an investment agreement to acquire 15% shareholding of 威屏 at consideration of RMB353,000, which was settled by injection of intangible assets of the Group at equivalent value to 威屏, the fair value of which was determined by an independent qualified valuer in the PRC. The injected intangible assets are softwares and trademark internally generated by the Group. As a result, a gain on investment in an associate was recognised as other gains during the year ended 31 December 2019.

(ii) On 11 July 2019, Maxnerva Technology Services US LLC, a wholly owned subsidiary of the Company, entered into a shareholder agreement with Soda Labs Inc. ("Soda Labs"), an independent third party, to establish a joint venture, Retail Hardware, which is a limited liability company incorporated in the United States. The Group contributed USD501 (equivalent to RMB4,000) and hold 50.1% of equity shares of Retail Hardware. The Group classified its investment in Retail Hardware as a joint venture. It engaged in provision of temperature screening access control solution in the US.

On 14 May 2021, Maxnerva Technology Services US LLC entered into an assets purchase agreement with Soda Labs to purchase certain intellectual properties and 49.9% of equity shares of Retail Hardware from Soda Labs by forfeiting any and all obligations, payments, right and privileges with respective to outstanding convertible bond held by the Group in Soda Labs in the amount of USD885,100. Since then, Retail Hardware became a wholly owned subsidiary of the Company. Retail Hardware has minimal operation since its incorporation. Considering the minimal business activities of Soda Labs, directors consider that the intellectual properties acquired were of nominal value. Also, the convertible bond in Soda Labs had been fully written down last year.
