主席報告 Chairman's Statement

致各位股東：

我們謹代表董事會（「董事會」）向各位股東提呈中國星集團有限公司（「本公司」）及其附屬公司（以下統稱「本集團」）截至二零二一年十二月三十一日止年度的年度業績及年報。

過去一年，2019冠狀病毒病疫情反覆且病毒變種（如Delta和Omicron等）層出，繼續禍延全球，導致世界各國政府須繼續採取或鼓勵採取社交隔離措施以管控疫情，從而影響全球供應鏈暢通以至經濟復甦。我國方面，抗疫情況依然嚴峻，二零二二年初便先有香港後有上海疫情大規模爆發，衝擊民生經濟甚巨，內地及大灣區內各地乃至港澳之間亦未能恢復通關。因此，實體商業和旅遊活動難言恢復，相關收入亦低谷徘徊，百業不振。國際方面，中美關係未因美國政黨交替，白宮易主而有明顯改善，相反更見不斷出台打壓中國企業之舉。另外，二零二二年二月底爆發的俄烏戰事至今陷入膠著，局勢發展更可能動搖全球地緣政治格局，影響深遠且令人擔憂。

To the shareholders,

On behalf of the board of directors (the "Board"), we are pleased to present the annual results and the annual report for the year ended 31st December 2021 of China Star Entertainment Limited (the "Company") and its subsidiaries (collectively as the "Group") to the shareholders.

In the last year, COVID-19 continued to wreaked havoc across the globe along with its several variances such as Delta and Omicron, such that governments in the world had to keep adopting or encourage their people to adopt social distancing measures so as to contain and control the pandemic, which consequently resulted in impeded supply chains as well as recovery of economy globally. In respect of Mainland China, the anti-epidemic situation remained rigorous as there came recently massive outbreaks of COVID-19 in Hong Kong and Shanghai successively in earlier 2022, dealing a tremendous blow to the people's livelihood and the economy, not to mention the re-opening of borders in between many places in the Mainland, in the Greater Bay Area, and that between Hong Kong and Macau. As a result, real economic activities and tourism became basically impossible to resume with respective revenues at their troughs as industries suffered from depression. On the international front, the Sino-US relations saw no marked improvement in spite of the alternation of power in the White House, and there were suppressive actions imposed against Chinese enterprises instead from time to time. On the other hand, the Russian-Ukrainian War broke out at the end of February 2022 has stalemated so far, but the development of the war may probably shatter the global geopolitical situation with far-reaching and worrying impacts.

此大環境下，澳門多項經濟指標仍乏善足陳，僅因低基數效應而有起色，例如二零二一年全年本地生產總值(GDP)為2,417.55億澳門幣，按年回升18%，博彩毛收入為868億澳門幣，按年反彈43.7%或264.2億澳門幣(但仍較疫情前的二零一九年水平下降70.3%)，全年入境旅客共770.6萬人次，按年增加30.7%(但與二零一九年比較減少逾八成)。其中，內地旅客佔逾九成，約有704.5萬人次，同比增加48.2%，其中國際旅客近乎絕跡亦可理解。

物業市道方面，據中原地產的數據，澳門住宅及工商舖(包括寫字樓和工廈)持續低迷，而橫琴樓市雖先高後低，惟隨著橫琴粵澳深度合作區發展推進，預料今年將有不少優惠措施陸續出台實施，加上有國家大力支持以及國內媒體宣傳，相信有助提升橫琴以至澳門整體區域經濟，後市發展值得看好。

本集團兩大持續經營業務方面，電影相關業務經營業務除來自片庫發行之影片收益外並無發行任何新電影，亦無開拍電視連續劇；物業開發及投資經營業務中的狄梵尼 • 豪舍已準備好隨時可以出售，在澳門及香港的銷售中心也已裝修完成，本該在二零二二年三月推售，惟由於Omicron疫情現延至二零二二年年中適時推售。

Under the above macro environment, various economic indicators of Macau posted downturn figures, though improved owing only to the low-base effect. For instance, the local gross domestic product (GDP) for the year amounted to MOP241.755 billion, a rebound of 18% year-on-year; the gaming gross revenue recorded MOP86.8 billion, a rebound of 43.7% year-on-year or MOP26.42 billion (but a drop of 70.3% as compared to that of 2019 before the pandemic); and the number of tourists visiting Macau for the year was 7.706 million visits, a rise of 30.7% year-on-year (but a drop of more than 80% as compared to that of 2019). Among them, tourists from the Mainland accounted for more than 90% at approximately 7.045 million tourists, an increase of 48.2% year-on-year, with nearly vanished tracks of international tourists understandably.

In respect of the property market, according to figures published by Centaline Property, the residential and the commercial (including offices and industrial buildings) markets remained sluggish while the market in Hengqin fluctuated from high to low over the year. However, it is believed that the economy of Hengqin and Macau as a whole will be boosted along with the deepening development of the Guangdong-Macao In-Depth Cooperation Zone in Hengqin, the launch of series of preferable measures and the support with great exertion by the State with vigorous media promotions, and that the market outlook for Henqin is promising as well.

With regard to our two major continuing operations, other than the revenue arose from the distribution of films in the film library, no new film distributed nor production of television drama series started for the film related business operations; as to the property development and investment operations, Tiffany House is ready for sale with the sale offices in Macau and Hong Kong furnished. The launch for sale would have been commenced in March 2022, but postponed to mid-year owing to the outbreak of Omicron.

縱然如此，我們從澳門特首新發表的題為「凝心聚力、共創新局」的《2022年財政年度施政報告》中看到亮麗願景，其施政總方針為：防疫情、穩復甦、保民生、促多元、強合作、謀發展，主要任務包括落實《澳門特別行政區經濟和社會發展第二個五年規劃（2021-2025年）》和《橫琴粵澳深度合作區建設總體方案》。特首表示，政府將從以下九個方面展開施政工作，分別為，一、築牢疫情防控體系，推動經濟穩定復甦；二、大力培育發展產業，加快經濟適度多元；三、共商共建共管共享，務實推進橫琴建設；四、優化社會民生工作，提升民生服務水平；五、切實維護國家安全，鞏固城市安全防線；六、深化公共行政改革，強化重點領域立法；七、加強教青文體工作，完善人才引進制度；八、有序完善城市規劃，建設智慧宜居城市；及九、積極推進區域合作，更好融入國家發展。作為扎根澳門的企業，我們充滿期待，願積極配合並樂見其成。

Nevertheless, we see a brilliant vision from the Policy Address for the Fiscal Year 2022 titled "Making Concerted Efforts to Open up New Horizons" announced by the Chief Executive of Macau, which highlights the general principles of "pandemic prevention; the stabilization of economic recovery; protection of livelihoods; promotion of economic diversification; the strengthening of cooperation; and the exploration of development opportunities", and the major tasks including the implementation of the Second Five-Year Plan for Economic and Social Development of the Macau Special Administrative Region (MSAR), spanning 2021 to 2025, and of the Master Plan of the Development of the Guangdong-Macao In-Depth Cooperation Zone in Hengqin. The Chief Executive stated that, the Government will devote utmost effort to the following nine major strands of public policy, which are to: 1. Establish and secure anti-pandemic mechanism and promote stable economic recovery; 2. Foster and develop various industries to expedite adequate economic diversification; 3. Mutual discussion, joint construction, joint administration, and shared benefits for the pragmatic development of Hengqin; 4. Optimize social and livelihood-related work, to enhance quality of social services; 5. Safeguard and sustain national security, and the safety of Macau; 6. Deepen public administration reform and strengthen legislation in major areas; 7. Enhance education, youth development, cultural and sport affairs, and perfect the system for importing talented people; 8. Perfect urban planning, to build a smart and livable city; and 9. Actively promote regional cooperation to integrate Macau into the overall national development plan. As an enterprise deeply rooted in Macau, we look favorably on the success of all the above policies with earnest expectation and active cooperation as needed.

踏入新一年雖然仍有上述的一線城市疫情爆發，但無阻所謂後疫情時期的到來，即隨著全民疫苗接種趨向實現，人們對疫情常態化生活日漸適應，而澳門在疫情防控方面的成績亦增強我們的信心。因此本集團願意相信最困難時刻已經過去，更深信在澳門政府務實有為施政以及中央支持下，本土民生與經濟可逐步復甦及改善，而粵港澳大灣區計劃的深度發展亦可望帶動樓市轉旺，為狄梵尼•豪舍推售創造利好條件。

展望未來，本集團將透過不斷提高盈利能力，並審時度勢而實現其投資最大回報及業務穩健增長。

最後，本人謹代表董事會對各位股東的不斷支持致以萬二分的謝意，並感謝各位員工努力不懈的精神，以及合作夥伴的配合與支援。

管理層論述及分析 Management Discussion and Analysis

財務回顧

截至二零二一年十二月三十一日止年度，本集團錄得來自持續經營業務之收益3,717,000港元，較截至二零二零年十二月三十一日止年度之3,647,000港元減少2%。

本年度虧損為156,515,000港元，較截至二零二零年十二月三十一日止年度之110,443,000港元增加42%。本年度虧損主要包括確認透過損益以公平價值列賬之金融資產之公平價值變動所產生之虧損152,413,000港元（二零二零年：97,204,000港元）、其他經營開支24,977,000港元（二零二零年：40,167,000港元）及行政開支75,063,000港元（二零二零年：67,118,000港元），而部分由其他收益及其他收入102,903,000港元（二零二零年：97,153,000港元）所抵銷。虧損增加主要歸因於確認透過損益以公平價值列賬之金融資產之公平價值變動所產生之虧損大幅增加所致，分別來自香港上市股本證券62,671,000港元（二零二零年：72,321,000港元）、認購期權（定義見下文）57,526,000港元（二零二零年：24,883,000港元）及電影投資32,216,000港元（二零二零年：無），其為本集團所持有按公平價值列賬之金融資產。

截至二零二一年十二月三十一日止年度，本公司擁有人應佔來自持續經營業務之虧損為148,630,000港元，較上年之107,314,000港元增加39%。

該等業績反映本集團扣除已終止經營業務之餐廳經營業務之持續經營業務。

截至二零二一年十二月三十一日止年度，本公司擁有人應佔來自已終止經營業務之虧損為7,866,000港元，較上年之3,116,000港元增加152%。

股息

董事不建議派發截至二零二一年十二月三十一日止年度之末期股息（二零二零年：無）。

FINANCIAL REVIEW

For the year ended 31st December 2021, the Group recorded revenue from continuing operations of HK\$3,717,000, representing a decrease of 2% from HK\$3,647,000 for the year ended 31st December 2020.

Loss for the year amounted to HK\$156,515,000, representing an increase of 42% from HK\$110,443,000 for the year ended 31st December 2020. Loss for the year mainly included recognition of loss arising on change in fair value of financial assets at fair value through profit or loss of HK\$152,413,000 (2020: HK\$97,204,000), other operating expenses of HK\$24,977,000 (2020: HK\$40,167,000) and administrative expenses of HK\$75,063,000 (2020: HK\$67,118,000) and partially offset by other revenue and other income of HK\$102,903,000 (2020: HK\$97,153,000). The increase in loss is mainly attributable to the substantial increase in recognition of loss arising on change in fair value of financial assets at fair value through profit or loss from equity securities listed in Hong Kong of HK\$62,671,000 (2020: HK\$72,321,000), Call Option (defined below) of HK\$57,526,000 (2020: HK\$24,883,000) and investment in films of HK\$32,216,000 (2020: nil) respectively which were financial assets stated at fair values held by the Group.

Loss attributable to owners of the Company from continuing operations for the year ended 31st December 2021 amounted to HK\$148,630,000, representing an increase of 39% from HK\$107,314,000 in the previous year.

These results reflect the continuing operations of the Group excluded the discontinued operation of the restaurant operations.

Loss attributable to owners of the Company from discontinued operation for the year ended 31st December 2021 amounted to HK\$7,866,000, representing an increase of 152% from HK\$3,116,000 in the previous year.

DIVIDEND

The directors do not recommend the payment of a final dividend for the year ended 31st December 2021 (2020: nil).

管理層論述及分析 Management Discussion and Analysis

業務回顧

持續經營業務

本集團有兩個持續經營須予報告分類—(1)電影相關業務經營業務；及(2)物業開發及投資經營業務。

在本年度總收益中，3,717,000港元或100%來自電影相關業務經營業務，惟並無收益來自物業開發及投資經營業務。

電影相關業務經營業務

電影相關業務經營業務包括投資、製作、發行及授權電影及電視連續劇以及提供其他電影相關服務，包括藝人管理服務。

本集團從事電影業務至今已逾廿載。電影製作一般涉及三個階段：前期製作、製作或拍攝，以及後期製作。華語片在香港由前期製作階段至在戲院上映，一般需時超過一年，亦有歷時數載方告完成。電影的大部份收益將於電影上映後兩年內入賬。因此，電影製作及發行的特點為收益並非按所涉時間平均入賬。本集團亦有投資於與其他製作公司合資製作電影，並將根據相關協議之投資百分比分享所投資電影的收益。本集團於此類聯合製作安排中屬被動角色，但投入人力資源較少。

BUSINESS REVIEW

Continuing Operations

The Group has two continuing reportable segments - (1) film related business operations; and (2) property development and investment operations.

Of the total revenue for the year, HK\$3,717,000 or 100% was generated from film related business operations and no revenue was generated from property development and investment operations.

Film Related Business Operations

Film related business operations included investment, production, distribution and licensing of films and television drama series and provision of other film related services including artist management services.

The Group has been engaging in the film business for more than 20 years. Film production normally involves three stages including pre-production, production or shooting and post-production. From the pre-production stage to theatrical release of Chinese film in Hong Kong, it normally takes more than one year and sometimes several years to complete. The majority of revenue in film will record within the following two years after the film is released. As such, it is the characteristic of film production and distribution that revenue is not recognised evenly with time. The Group also has investment in production of film which is co-financing with other production companies and will shared revenue from the invested film according to the investment percentage in the relevant agreement. The Group takes a passive role in this kind of co-production arrangement but needs to contribute less human resource.

於二零二一年，電影相關業務經營業務之收益為3,717,000港元（二零二零年：3,647,000港元）而其分類虧損為43,526,000港元（二零二零年：28,900,000港元）。年內本集團並無自行開拍及發行任何新電影。二零二零年初爆發2019冠狀病毒病（「COVID-19疫情」）後，所有電影製作已暫時擱置或放緩進行。於二零二一年中，隨著疫情防控措施得當及疫苗接種率上升，香港的COVID-19疫情看似受控，本集團已逐步重新開始審視本身製作。然而，通漲壓力明顯，COVID-19變種病例數字飆升，電影市道再度放緩，令人擔憂的經濟跡象近年底再次浮現。本集團一直有定期審視其製作中電影並考慮應否繼續或暫停有關項目。分類虧損主要包括有關製作中電影及電影版權之已確認減值虧損分別1,313,000港元（二零二零年：26,384,000港元）及2,862,000港元（二零二零年：無）以及電影投資之公平價值變動所產生之虧損32,216,000港元（二零二零年：無）。公平價值變動所產生之虧損主要來自一齣分類為電影投資之新片於二零二一年上映惟票房不盡人意。於二零二一年十二月三十一日，本集團概無電影或電視連續劇在攝製階段，而於報告日期有一齣分類為電影投資之電影正在中國攝製階段。本集團將密切注視COVID-19疫情的發展，並評估其對電影經營業務的影響及於必要時採取適當行動。

In year 2021, revenue from film related business operations amounted to HK\$3,717,000 (2020: HK\$3,647,000) and its segment loss amounted to HK\$43,526,000 (2020: HK\$28,900,000). The Group did not start own production shooting and distribute any new film during the year. After the outbreak of Coronavirus Disease 2019 (“COVID-19 pandemic”) in early 2020, all film productions have temporary suspended or slowed down. In the mid-2021, the Group has gradually restarted reviewing our productions when COVID-19 pandemic in Hong Kong seems under control with proper prevention and control measures and increasing vaccination rates. However, worrying economic signs resurfaced near end of the year amidst pronounced inflationary pressures, surging cases of COVID-19 variants, film market slowed down again. The Group has regularly reviewed its film in progress and considered whether these titles should proceed or suspended further productions. The segment loss mainly included impairment loss recognised in respect of films in progress and film rights of HK\$1,313,000 (2020: HK\$26,384,000) and HK\$2,862,000 (2020: nil) respectively and loss arising on change in fair value of investment in films of HK\$32,216,000 (2020: nil). Loss arising on change in fair value mainly came from unsatisfactory result of a new film that classified as investment in films released in year 2021. As at 31st December 2021, no film or television drama series of the Group are in shooting stage and one film classified as investment in films is in shooting stage in China as at the reporting date. The Group will pay close attention to the development of the COVID-19 pandemic and evaluate its impact on our film operations and take appropriate action when necessary.

管理層論述及分析 Management Discussion and Analysis

物業開發及投資經營業務

物業開發及投資經營業務包括投資及開發物業。目前，本集團有兩個位於澳門之發展中項目，即(i)位於何鴻燊博士大馬路南灣湖畔地區，名為「南灣湖計劃C區7地段」之土地，其於澳門物業登記局之登記編號為第23070號（「C7物業」）；及(ii)位於澳門外港填海區第6C地段、第6D地段及第6E地段之合併地盤（名為「狄梵尼•豪舍」）（「狄梵尼•豪舍」）。

根據城市規劃圖，C7物業（一幅地盤面積為4,669平方米的地皮）將發展作住宅及停車場用途，其樓宇最大許可高度為海拔34.5米及最大許可地積比率為5.58倍（不包括停車場）。初步發展藍圖為興建一幢屬分層所有權的建築物，其建築樓面面積（按平方米計）為：住宅26,047及停車場5,200。本集團已按照參數編製C7物業的經修訂發展藍圖，以供澳門土地工務運輸局（「土地工務局」）審批，惟尚未獲土地工務局任何回覆。C7物業的發展工作計劃於狄梵尼•豪舍項目開發後開始。本集團目前間接擁有C7物業的50%權益。陳明英女士（「陳女士」）已向本公司之全資附屬公司Best Combo Limited（「Best Combo」）授出一項認購期權（「認購期權」），允許Best Combo由二零一七年四月六日起計60個月屆滿之行使期（「行使期」）內要求陳女士以代價500,000,000港元（可予調整）出售其間接持有C7物業25%權益之Reform Base Holdings Limited全部已發行股本，而Best Combo則授出一筆本金額為500,000,000港元（可予調整）之定期貸款，其按5厘計息，須於由二零一七年四月六日起計60個月屆滿之日（「最後還款日」）償還。本集團擬延後最後還款日及延長認購期權之行使期，詳情於「報告期後事項」一節進一步披露。

Property Development and Investment Operations

Property development and investment operations included investing and development of properties. Currently, the Group has two projects under development in Macau, namely (i) Lot C7 do Plano de Urbanizacao da Baia de Praia Grande, located in the Nam Van Lakes Zone, at Avenida Doutor Stanley Ho, registered with the Macau Land and Real Estate Registry under no. 23070 (the "Property C7"); and (ii) the combined site at Lot 6C, Lot 6D and Lot 6E at Zona de Aterros do Porto Exterior, Macau which is named as "Tiffany House" (the "Tiffany House").

Under the Urbanistic Conditions Plan, the Property C7 which is a lot of land with the site area of 4,669 square meters, will be developed for residential and parking purpose, with the maximum allowed height of the building of 34.5 meters above sea level and maximum utilization rate of 5.58 (parking not included). The very preliminary development plan is to develop a building under strata title with gross floor areas (in square meters) for residential of 26,047 and parking of 5,200. The Group has compiled a revised development plan of the Property C7 in accordance with the parameters for submission to the Land, Public Works and Transport Bureau of Macau ("DSSOPT") for approval and has not yet received any reply from DSSOPT. The development of the Property C7 is planned to start after the development of Tiffany House. The Group is currently indirectly interested in 50% of the Property C7. Ms. Chen Ming Yin Tiffany ("Ms. Chen") had granted a call option (the "Call Option") to Best Combo Limited, a wholly owned subsidiary of the Company ("Best Combo") which allowed Best Combo to require Ms. Chen to sell the entire issued share capital of Reform Base Holdings Limited that indirectly held 25% of the Property C7 at consideration of HK\$500,000,000 (subject to adjustment) during the exercise period falling on the expiry of 60 months from 6th April 2017 (the "Exercisable Period") and Best Combo had granted a fixed term loan at principal amount of HK\$500,000,000 (subject to adjustment), interest bearing at 5% and repayable on the date falling 60 months from 6th April 2017 ("Final Repayment Date"). The Group intends to extend the Final Repayment Date and the Exercisable Period of the Call Option, details are further disclosed in section "Event after the Reporting Period".

狄梵尼•豪舍鄰近澳門理工學院，毗鄰金蓮花廣場，澳門漁人碼頭及金沙娛樂場亦近在咫尺。狄梵尼•豪舍的建築樓面面積為：(a)住宅—31,192平方米，包括約1,900平方米作會所；(b)商業—3,716平方米；及(c)停車場—11,250平方米，兩幢大樓提供230個單位，由開放式單位到四房公寓以及特式單位，以及272個車位及75個摩托車車位。其著名會所提供多種設施，而位於平台的商場將成為鄰近地區的主要購物商場。建築工程已於二零一七年六月動工，並於二零一九年十二月取得其佔用許可證。狄梵尼•豪舍已準備好發售。自澳門與中國重新通關，訪澳旅客持續回升，並於二零二一年首季城市之經濟呈復甦跡象，惟物業市道仍然呆滯且無大起色，而澳門政府統計數據亦顯示澳門勞工市場有外勞持續流出。為提升狄梵尼•豪舍的銷路，本集團決定在香港設立售樓處以吸納澳門以外的潛在買家。港澳兩地的售樓處均可隨時開張。由於中國內地、香港及澳門之間仍有嚴格跨境管制措施，導致港珠澳大灣區內人員往來大為減少。隨著二零二一年年中香港本地防疫措施逐步撤銷及接近年底開始就香港健康碼進行登記，本集團預期中國內地、香港及澳門之間的嚴格跨境管制措施可望於二零二二年首季解除。因此，狄梵尼•豪舍預定於二零二二年三月推售。

於報告日期，鑒於Omicron病毒在香港嚴重爆發，本集團認為目前不宜推售狄梵尼•豪舍。本集團將密切注視Omicron病毒的發展及於最適當時候推售，並認為推售將於二零二二年成事。

Tiffany House is located adjacent to Macao Polytechnic Institute and next to Golden Lotus Square, and is a couple of blocks away from Macau Fisherman's Wharf and Sands Casino. Tiffany House has a gross floor area of (a) residential – 31,192 square meters, including approximately 1,900 square meters for clubhouse, (b) commercial – 3,716 square meters and (c) parking – 11,250 square meters and provides 230 units in two towers, with units ranging from studio flats to four-bedroom apartments as well as special units and 272 carparks and 75 motorcycle parks. A prestigious clubhouse provides a wide range of facilities and retail space at the podium will become a major shopping arcade in the nearby area. Construction works started in June 2017 and has obtained its occupational permit in December 2019. Tiffany House is ready for sale. Macau's visitor arrivals have been picking up since the reopening of the border with China and the city's economy showed signs of recovery in first quarter of year 2021, however, its property market remained stagnant with no significant improvement and statistics by Macau government shows ongoing outflow of expatriate employees from Macau's labour market. In order to increase the marketability of Tiffany House, the Group decided to set up a sales office in Hong Kong so as to absorb potential buyers outside Macau. Both Hong Kong and Macau sale offices are ready to open anytime. As there are still stringent inbound control measures in Mainland China, Hong Kong and Macau, thereby severely reducing the travel between the Guangdong-Hong Kong-Macau Greater Bay Area. With the gradual lifting of Hong Kong's local anti-epidemic measures in the mid-year 2021 and registration for Hong Kong Health Code starts near year end, the Group expected release of inbound control measures in Mainland China, Hong Kong and Macau can effect in the first quarter of year 2022. Therefore, Tiffany House is scheduled to launch sales in March 2022.

Following the severe outbreak of Omicron in Hong Kong at date of reporting, the Group considers that it is not appropriate time for launching sales of Tiffany House. The Group will closely monitor the development of Omicron and launch sales in the most appropriate time and considers that sales can be launch in year 2022.

本集團一直在物色合適投資機遇，以增強其現有之物業開發及投資業務分類。於二零二零年十二月二十四日，本公司一間全資附屬公司訂立買賣協議以購入一項位於台灣台北市尊尚豪宅地段，包括一個豪宅公寓及兩個車位之物業（「台灣物業」），代價約為160,365,000港元。於二零二一年一月二十七日，本集團完成收購台灣物業。於二零二一年十二月三十一日，台灣物業已交吉並持作投資物業（賬面值162,176,000港元）以達致長遠資本增值目的。台灣物業將作出租用途並預期可為本集團產生穩定租金收入。

截至二零二一年十二月三十一日及二零二零年十二月三十一日止年度，概無錄得來自物業開發及投資經營業務之收益，而其分類虧損為38,441,000港元（二零二零年：24,153,000港元）。分類虧損主要包括出售一項物業之虧損16,550,000港元、投資物業之公平價值變動所產生之虧損694,000港元及行政開支。

已終止經營業務

餐廳經營業務

本集團在香港上環之自置物業開設餐廳「哥哥的家」，提供各式高端國際美食。

於二零二一年，來自餐廳經營業務之收益為1,595,000港元（二零二零年：1,379,000港元）而其分類虧損為7,866,000港元（二零二零年：3,116,000港元）。本集團曾盡力改善「哥哥的家」的營運表現而其收益亦有些微好轉。然而，本集團經審慎考慮後認為，餐廳位置乃其表現不濟之致命因素。因此，「哥哥的家」於二零二一年九月底停止營運，而位於香港上環之自置物業已由本集團出售。分類虧損增加主要由於就停業而出售及撇銷傢俬、裝置及設備之虧損分別5,435,000港元及156,000港元所致。

The Group always looks for suitable investment opportunities to strengthen its existing segment in property development and investment. On 24th December 2020, a wholly owned subsidiary of the Company entered into a sale and purchase agreement to purchase a property which comprises a luxury residential apartment with two car parking spaces, situated in a prime luxury residential location in Taipei, Taiwan (the "Taiwan Property") for consideration of approximately HK\$160,365,000. On 27th January 2021, the Group completed the acquisition of the Taiwan Property. As at 31st December 2021, the Taiwan Property was vacant and held as an investment property in carrying amount of HK\$162,176,000 for long term capital growth purposes. The Taiwan Property is going for rental purpose and is expected to generate stable rental income to the Group.

No revenue was recorded from property development and investment operations for the years ended 31st December 2021 and 31st December 2020 and its segment loss amounted to HK\$38,441,000 (2020: HK\$24,153,000). The segment loss mainly included loss on disposal of a property of HK\$16,550,000, loss arising on change in fair value of investment property of HK\$694,000 and administrative expenses.

Discontinued Operation

Restaurant Operations

The Group's restaurant "Obba Bar" served various high-ended international cuisine and was located in the Group's property in Sheung Wan, Hong Kong.

In year 2021, revenue from restaurant operations amounted to HK\$1,595,000 (2020: HK\$1,379,000) and its segment loss amounted to HK\$7,866,000 (2020: HK\$3,116,000). The Group had worked on every effort to improve the performance of the operation of Obba Bar and its revenue showed slight improvement. However, after careful consideration, the Group considered that the location of the restaurant was a fatal factor for its unsatisfactory performance. Therefore, Obba Bar ceased its operation at end of September 2021 and the owned property in Sheung Wan, Hong Kong was disposed by the Group. The increase in segment loss was mainly due to loss on disposal and written off of furniture, fixtures and equipment of HK\$5,435,000 and HK\$156,000 respectively for cessation of business.

地區分類

就地區分類方面，收益15,000港元或0%（二零二零年：71,000港元或2%）源自香港，3,437,000港元或93%（二零二零年：3,537,000港元或97%）源自中國，及265,000港元或7%（二零二零年：39,000港元或1%）源自其他地區。

行政開支

截至二零二一年十二月三十一日止年度，來自持續經營業務之行政開支為75,063,000港元（二零二零年：67,118,000港元），即增加12%。該增加主要為僱員福利開支上升6%至43,984,000港元（二零二零年：41,370,000港元）及狄荻尼•豪舍所招致維修及營運開支普遍上漲。此外，本集團與其他九間主要電影公司共同製作電影《總是有愛在隔離》，以資助電影業面對困境之公司及於疫情期間沒有收入的電影工作者。本集團為此錄得開支約3,000,000港元，而該影片由香港演藝人協會及香港電影工作者總會於二零二一年四月二十二日發行。

融資成本

截至二零二一年十二月三十一日止年度，融資成本1,833,000港元（二零二零年：250,000港元）已於綜合收入表扣除，而狄荻尼•豪舍建築成本之融資利息54,576,000港元（二零二零年：63,896,000港元）已撥充物業存貨資本。

Geographical Segments

For the geographical segments, revenue of HK\$15,000 or 0% (2020: HK\$71,000 or 2%) was sourced from Hong Kong, HK\$3,437,000 or 93% (2020: HK\$3,537,000 or 97%) was sourced from China and HK\$265,000 or 7% (2020: HK\$39,000 or 1%) was sourced from other territories.

Administrative Expenses

For the year ended 31st December 2021, administrative expenses from continuing operations amounted to HK\$75,063,000 (2020: HK\$67,118,000), representing an increase of 12%. The increase mainly represented 6% increase in employee benefit expenses which amounted to HK\$43,984,000 (2020: HK\$41,370,000) and generally increase in maintenance and operation expenses incurred in Tiffany House. Besides, the Group joined 9 other major film companies to produce the film "All U Need is Love" as a benefit effort to finance struggling companies in the film industry and those film workers without income during the pandemic. The Group recorded expenses of approximately HK\$3,000,000 for this purpose and the film was released by the Hong Kong Performing Artistes Guild and the Federation of Hong Kong Filmmakers on 22nd April 2021.

Finance Costs

For the year ended 31st December 2021, finance costs amounted to HK\$1,833,000 (2020: HK\$250,000) were charged to the consolidated income statement and interests financing construction costs of Tiffany House amounted to HK\$54,576,000 (2020: HK\$63,896,000) were capitalised to stock of properties.

流動資金及財務資源及資本架構

於二零二一年十二月三十一日，本集團之總資產為5,285,909,000港元（二零二零年：5,343,571,000港元），而流動資產淨值則為2,849,594,000港元（二零二零年：4,147,002,000港元），即流動比率為2.3（二零二零年：7.8）。本集團之現金及銀行結餘及定期存款為102,300,000港元（二零二零年：503,726,000港元）。

於二零二一年十二月三十一日，本集團之借貸總額為1,576,191,000港元（二零二零年：1,299,565,000港元），其包括有抵押銀行定期貸款（「定期貸款」）1,478,850,000港元（二零二零年：1,293,880,000港元）、貸款票據（「應付票據」）96,360,000港元（二零二零年：無）及租賃負債981,000港元（二零二零年：5,685,000港元）。定期貸款旨在為狄梵尼•豪舍的建築成本及任何其他項目成本融資。定期貸款可多次提取，並以租賃土地及將於狄梵尼•豪舍的土地上興建的物業（列作物業存貨，賬面值2,159,307,000港元）作抵押，由借款人選擇的三個月或六個月期間於每個利息期按香港銀行同業拆息（「HIBOR」）加3.35厘的息差之年利率計息，並須於(i)定期貸款協議日期起之36個月或(ii)發出狄梵尼•豪舍之佔用許可證日期（即二零二零年九月十三日）後9個月（以較早者為準）償還。於二零二零年，定期貸款之到期日已獲延後至二零二二年九月十五日。應付票據自二零二一年一月二十九日起六個月內按0.25厘固定利率每半年計息一次，並已於二零二一年七月二十八日重續六個月。賬面值為162,176,000港元之投資物業已質押予一間銀行，以就本集團發行用於台灣業務融資之應付票據取得擔保。本集團可每六個月申請重續應付票據，而銀行擔保將於二零二一年一月二十四日到期或提前終止。

LIQUIDITY AND FINANCIAL RESOURCES AND CAPITAL STRUCTURE

As at 31st December 2021, the Group had total assets of HK\$5,285,909,000 (2020: HK\$5,343,571,000) and a net current assets of HK\$2,849,594,000 (2020: HK\$4,147,002,000), representing a current ratio of 2.3 (2020: 7.8). The Group had cash and bank balances and time deposits of HK\$102,300,000 (2020: HK\$503,726,000).

As at 31st December 2021, the Group had total borrowing of HK\$1,576,191,000 (2020: HK\$1,299,565,000) which comprised a secured bank term loan (the "Term Loan") of HK\$1,478,850,000 (2020: HK\$1,293,880,000), a loan note (the "Note Payable") of HK\$96,360,000 (2020: nil) and lease liabilities of HK\$981,000 (2020: HK\$5,685,000). The purpose of the Term Loan is to finance the construction costs and any other soft costs in relation to Tiffany House. The Term Loan is in multiple drawdown and secured by the leasehold land and properties to be erected on the land of Tiffany House with carrying amount as stock of properties of HK\$2,159,307,000, interest bearing at Hong Kong Interbank Offered Rate ("HIBOR") for three or six month period selected by the borrower plus margin of 3.35% per annum for each interest period and repayable by the earlier of (i) 36 months from date of the agreement of the Term Loan or (ii) 9 months after date of issuing of the occupation permit of Tiffany House, i.e. 13th September 2020. In year 2020, the maturity date of the Term Loan is extended to 15th September 2022. The Note Payable is interest bearing at fixed interest rate of 0.25% semi-annually for six months period from 29th January 2021 and has renewed for six months period on 28th July 2021. Investment property in carrying amount of HK\$162,176,000 has been pledged to a bank for obtaining its guarantee for the Note Payable issued by the Group that was used to finance the operation in Taiwan. The Group can apply for renewal of the Note Payable for every six months period and the bank guarantee will expired on 24th January 2051 or upon early termination.

於二零二一年十二月三十一日，本集團之銀行信貸額為1,600,000,000港元，已動用1,478,850,000港元。年內，本集團之資本負債比率在可接受水平，總債務為1,576,191,000港元（二零二零年：1,299,565,000港元），而擁有人之權益為3,064,638,000港元（二零二零年：3,435,914,000港元）。即資本負債比率（以本集團之借貸總額除以擁有人之權益計算）為51%（二零二零年：38%）。

按認購價每股0.25港元於二零一八年八月六日配發及發行1,807,406,986股供股股份之所得款項淨額約為448,850,000港元，其中98,850,000港元已於截至二零一八年十二月三十一日及二零一九年十二月三十一日止年度內按擬定用途用作電影及電視連續劇相關業務營運之資金；另350,000,000港元原擬用於撥付物業開發及投資業務營運融資。於二零二一年一月二十七日，本集團動用所得款項約160,365,000港元以完成購入台灣物業。除此之外，年內已分別動用60,000,000港元及68,580,000港元作狄芬尼·豪舍的市場推廣及狄芬尼·豪舍的建築成本墊付款項。於二零二一年十二月三十一日，尚有所得款項61,055,000港元未動用並將按擬定用途動用。

截至二零二一年十二月三十一日止年度內，本集團已以總代價74,060,000港元出售若干物業並錄得來自持續經營業務之出售溢利13,366,000港元。所出售物業包括我們的「哥哥的家」餐廳所在地點（其被視為不合適業務營運用途並錄得出售虧損16,550,000港元）、我們的片庫（專為儲存35毫米電影菲林而設計已近廿載，惟其功能隨著數碼電影的出現而消失並錄得出售溢利25,021,000港元）以及倉儲用之小型工業單位（本集團認為將其出售可節省人力維持營運並錄得出售溢利4,895,000港元）。

As at 31st December 2021, the Group had banking facilities amounting to HK\$1,600,000,000 which were utilised to the extent of HK\$1,478,850,000. The Group's gearing was acceptable during the year with total debts of HK\$1,576,191,000 (2020: HK\$1,299,565,000) against owners' equity of HK\$3,064,638,000 (2020: HK\$3,435,914,000). This represents a gearing ratio, calculated in the basis of the Group's total borrowings over owners' equity of 51% (2020: 38%).

The net proceeds from the allotment and issue of 1,807,406,986 rights shares at the subscription price of HK\$0.25 per share on 6th August 2018 of approximately HK\$448,850,000, of which HK\$98,850,000 was used to fund the film and television drama series related business operations as intended during the years ended 31st December 2018 and 31st December 2019; and HK\$350,000,000 was originally intended to be applied to finance the business operations of the property development and investment. On 27th January 2021, the Group utilized proceeds of approximately HK\$160,365,000 for completion of the acquisition of the Taiwan Property. Except for this, HK\$60,000,000 and HK\$68,580,000 were utilized for the marketing and promotion of Tiffany House and advance payment of construction costs for Tiffany House respectively during the year. As at 31st December 2021, proceeds of HK\$61,055,000 were unused and will be utilized as intended.

During the year ended 31st December 2021, the Group had disposed certain properties at an aggregate consideration of HK\$74,060,000 and recorded gain on disposal of HK\$13,366,000 from the continuing operations. The disposed properties included the location of our restaurant "Obba Bar" which considered not suitable for our business operation purpose and recorded loss on disposal of HK\$16,550,000, our film library which was tailored to store 35mm motion pictures for nearly 20 years and its function flamed out upon the advent of digital cinematography and recorded gain on disposal of HK\$25,021,000, and small industrial units for storage purpose which considered their disposals can save manpower for maintaining their operation and recorded gain on disposal of HK\$4,895,000.

於批准本全年業績日期及於二零二一年十二月三十一日，本集團於二零二一年十二月三十一日所持有之香港上市股本證券之公平價值分別約為68,130,000港元及87,531,000港元。截至二零二一年十二月三十一日止年度內，本集團購入39,946,000港元之香港上市股本證券及出售所得款項35,294,000港元之香港上市股本證券。透過損益以公平價值列賬之金融資產之公平價值變動所產生之虧損62,671,000港元，此乃由於截至二零二一年十二月三十一日與截至二零二零年十二月三十一日止年度之間香港上市股本證券之公平價值變動所致。於二零二一年十二月三十一日，概無本集團所持單一股本證券之公平價值佔本集團總資產5%或以上。

年內，本公司在聯交所購回共144,760,000股本公司普通股股份，總代價214,150,000港元。91,920,000股普通股股份於二零二一年二月四日註銷，及52,840,000股普通股股份於二零二一年五月三日註銷。於二零二一年十二月三十一日，本公司註銷後的已發行股份總數減少至2,485,851,000股（二零二零年十二月三十一日：2,630,611,000股），而其已發行股本為24,858,000港元（二零二零年十二月三十一日：26,306,000港元）。

截至二零二一年十二月三十一日止年度內，概無本公司購股權獲授出、行使、失效，已屆滿或註銷。

資產抵押

於二零二一年十二月三十一日，物業存貨賬面值2,159,307,000港元及本公司全資附屬公司中國星創新發展有限公司（從事物業開發及投資業務）之定額資本已質押作為本集團獲授予的銀行信貸1,600,000,000港元之抵押品，而定期存款249,000港元因在澳門開發物業存貨需繳納按金而已作為保證金質押予澳門政府；及賬面值162,176,000港元之投資物業已質押予一間銀行，以就本集團所發行之應付票據取得擔保。

As at the date of approving these annual results and as at 31st December 2021, the fair value of the Group's equity securities listed in Hong Kong held at 31st December 2021 was approximately HK\$68,130,000 and HK\$87,531,000 respectively. During the year ended 31st December 2021, the Group acquired HK\$39,946,000 equity securities listed in Hong Kong and disposed proceeds of HK\$35,294,000 equity securities listed in Hong Kong. The loss arising on change in fair value of financial assets at fair value through profit and loss of HK\$62,671,000 was resulted from change in fair values of equity securities listed in Hong Kong between the year ended 31st December 2021 and 31st December 2020. As at 31st December 2021, no single equity security's fair value held by the Group accounted for 5% or more of the total assets of the Group.

During the year, the Company repurchased a total of 144,760,000 ordinary shares of the Company at an aggregate price of HK\$214,150,000 on the Stock Exchange. 91,920,000 ordinary shares were cancelled on 4th February 2021 and 52,840,000 ordinary shares were cancelled on 3rd May 2021. The total number of issued shares of the Company after its cancellation as at 31st December 2021 was reduced to 2,485,851,000 (31st December 2020: 2,630,611,000) and its issued share capital was HK\$24,858,000 (31st December 2020: HK\$26,306,000).

During the year ended 31st December 2021, no share options of the Company were granted, exercised, lapsed, expired or cancelled.

PLEDGE OF ASSETS

As at 31st December 2021, stock of properties in carrying amount of HK\$2,159,307,000 and quota capital of China Star Creative Development Limited, a wholly owned subsidiary of the Company which is engaged in the business of property development and investment had been pledged for banking facilities of HK\$1,600,000,000 granted to the Group, and time deposit in amount of HK\$249,000 had been pledged as guarantee to Macau government for deposits in the development of stock of properties in Macau; and investment property in carrying amount of HK\$162,176,000 has been pledged to a bank for obtaining its guarantee for the Note Payable issued by the Group.

本集團大部份交易、資產及負債以港元、澳門幣、美元、新台幣及人民幣列值。人民幣匯率波動之風險主要來自電影投資、製作及發行所產生收支。本集團會密切監察此波動並於必要時考慮對沖活動。其他貨幣之波動風險甚低，故認為無需任何對沖活動。

於二零二一年十二月三十一日，本集團有未履行承擔194,512,000港元，其中171,981,000港元為澳門物業存貨之開發經費，22,531,000港元為電影版權、製作中電影及電影按金。

於二零二一年十二月三十一日，本集團概無重大或然負債。

僱員及薪酬政策

於二零二一年十二月三十一日，本集團之持續經營業務僱用66名員工（二零二零年：62名員工），僱員福利開支為43,984,000港元（二零二零年：41,370,000港元（經扣除關於香港政府所提供的保就業計劃之2,249,000港元）），增加6%。除政府補助金之影響外，此增加的主要原因乃為負責澳門狄芬尼·豪舍推售準備及管理的員工人數增加。董事相信，其優秀員工乃本集團維持聲譽及改善盈利能力之單一最重要因素。員工之酬金乃根據彼等之工作表現、專業經驗及當時之行業慣例而釐定。除基本薪金、公積金、住房補貼、膳食津貼、醫療計劃及酌情花紅外，若干員工更可按個別表現評估獲授購股權。

EXCHANGE RISK AND HEDGING

The majority of the Group's transactions, assets and liabilities are denominated in Hong Kong Dollar, Macau Pataca, United States Dollar, New Taiwan Dollar and Renminbi. The exposure to fluctuation in exchange rates in Renminbi mainly arises from receipts and expenditure incurred in film investment, production and distribution. The Group has closely monitors its exposure to this fluctuation and consider appropriate hedging activities if necessary. The exposure to fluctuation in other currencies is considered to be minimal and no hedge activity is considered necessary.

COMMITMENTS

As at 31st December 2021, outstanding commitments by the Group amounted to HK\$194,512,000, of which HK\$171,981,000 as development expenditure for stock of properties in Macau and HK\$22,531,000 for film rights, films in progress and film deposits.

CONTINGENT LIABILITIES

As at 31st December 2021, the Group had no material contingent liability.

SIGNIFICANT INVESTMENTS, MATERIAL ACQUISITIONS AND DISPOSALS

There were no significant investments, material acquisitions or disposals during the year.

EMPLOYEES AND REMUNERATION POLICY

As at 31st December 2021, the Group employed 66 staff (2020: 62 staff) with employee benefit expenses of HK\$43,984,000 (2020: HK\$41,370,000, after deducting of HK\$2,249,000 related to Employment Support Scheme provided by the Hong Kong government) from the continuing operations, an increase of 6%. Other than the effect of government grants, the increase mainly included increase in headcount who are responsible for preparation for sales and management of the Tiffany House in Macau. The directors believe that the quality of its employees is the single most important factor in sustaining the Group's reputation and improving its profitability. The staff are remunerated based on their work performance, professional experience and prevailing industry practices. Apart from basic salaries, pension fund, housing allowances, meal allowances, medical schemes and discretionary bonuses, share options are awarded to certain staff according to the assessment of individual performance.

管理層論述及分析 Management Discussion and Analysis

報告期後事項

於二零二二年一月二十八日及二零二二年二月十一日，Best Combo與陳女士分別訂立第二份更改契據及附函，據此，Best Combo(作為貸款人)及陳女士(作為借款人)已同意(i)待本公司獲得獨立股東批准後，延長最後還款日至自提取日期起計69個月屆滿之日，即二零二三年一月五日；及(ii)延長行使期至自提取日期起計69個月屆滿之日(即二零二三年一月五日)前任何時間。由於本公司仍在與土地工務局就C7物業的未來發展進行商討，且至今尚未獲批准，故董事會需要更多時間與土地工務局商討C7物業的未來發展，並認為保留行使認購期權的權利以通過收購認購期權股份而獲得C7物業額外25%權益符合本公司利益，而因此Best Combo與陳女士同意延長行使期並相應地延後最後還款日期。此外，本公司現持有C7物業之50%間接權益，而如本公司可行使認購期權，則本公司將持有C7物業之75%間接權益，並將就其發展擁有控制性權益，此被視為對本公司有利及符合本公司利益。

報告期後並無發生其他重大事項。

前景

二零二二年的營商環境仍將動盪，香港尤甚。二零二二年伊始，Omicron變種病毒爆發導致保持社交距離措施需要重施，嚴重打擊香港的穩定和經濟環境，我們寄望情況可於下半年改善。本集團將暫時放緩其各項經營業務，直至出現清晰及正面的經濟復甦跡象。

EVENTS AFTER THE REPORTING PERIOD

On 28th January 2022 and 11th February 2022, Best Combo and Ms. Chen entered into the Second Deed of Variation and the Side Letter, respectively, pursuant to which Best Combo (as lender) and Ms. Chen (as borrower) have agreed to (i) conditional upon the Company having obtained approval from the independent shareholders of the Company, extend the Final Repayment Date to the date falling on the expiry of 69 months from the drawdown date, i.e., 5th January 2023; and (ii) extend the Exercisable Period to any time within the date falling on the expiry of 69 months from the drawdown date, i.e., 5th January 2023. As the Company is still in discussions with the DSSOPT regarding the future development of the Property C7 and no approval has yet obtained, the Board required more time to discuss the future development of the Property C7 with DSSOPT and considers that it is in the interest of the Company to retain the right to exercise the Call Option to acquire an additional 25% interest in the Property C7 through the acquisition of the Call Option Shares, and as such, Best Combo and Ms. Chen have agreed to extend the Exercisable Period and correspondingly the Final Repayment Date. In addition, the Company is currently holding a 50% indirect interest in the Property C7 and if the Company can exercise the Call Option, the Company will hold 75% indirect interest in the Property C7 and will have controlling interest in the Property C7 over its development which is considered beneficial to and in the interest of the Company.

There is no other significant event took place subsequent to end of the reporting period.

PROSPECT

The business environment in 2022 will remain volatile, especially in Hong Kong. As year 2022 commenced, the Omicron variant outbreak and the re-introduced social distancing measures severely hurt the stability and economic environment of Hong Kong, we hope the situation can improve in the second half of the year. The Group will temporarily slowdown our operations until there are clear and positive signs of economic recovery.

管理層論述及分析 Management Discussion and Analysis

物業開發及投資經營業務方面，本集團已將狄芬尼•豪舍的開售延遲至二零二二年年中。此段時間內，本集團將全力提升其銷售及推廣計劃。本集團對今年餘下時間的市場前景仍感樂觀，因為COVID-19疫情消退後，香港已經歷最困難時刻並將逐步重拾經濟復甦跡象。隨著香港本地抗疫措施逐步撤銷及香港健康碼系統實施，本集團預期中國內地、香港及澳門之間的跨境管制措施可望解除，使澳門物業市場受惠。本集團將把握此機遇推售狄芬尼•豪舍。

電影相關業務經營業務方面，本集團將繼續促進及發展其本身已具規模的電影及電視連續劇製作及發行業務。這兩年內，以票房收益計中國是世界上最大的電影市場。全球電影製作及影院營運備受COVID-19疫情打擊之際，中國仍能保持其票房收益。鑒於生活水平不斷提升及娛樂需求龐大，中國電影觀眾對全球電影業而言將日益重要。憑著我們在電影及電視連續劇製作的經驗及在該行業的發行網絡，本集團對製作電影及電視連續劇的經營業務充滿信心，並希望能在疫後在此快速增長的票房市場中獲得更大份額。

展望未來，本集團將繼續致力於實現健康及穩定增長，提高盈利能力，實現其投資最大回報並尋求適當商機。

For the property development and investment operations, the Group has postponed sale of Tiffany House to around mid-year 2022. During this period, the Group will spend its effort to fluent our sales and marketing plan. The Group is still optimistic towards the market prospect for the rest of this year, as Hong Kong has experiencing the most difficult moment and will gradually gain signs of economic recovery following relieve of the COVID-19 pandemic. With the gradual lifting of Hong Kong's local anti-epidemic measures and implementation for Hong Kong Health Code system, the Group expected release of inbound control measures in Mainland China, Hong Kong and Macau can benefit the property market in Macau. The Group will grasp this opportunity to launch sales of Tiffany House.

For film related business operation, the Group will continue its furtherance and development of production and distribution operations in its own established film and television drama series. During these two years, China is the world's largest film market in terms of box office revenue. While film production and cinema operation around the world have been experiencing massive disruptions due to the COVID-19 pandemic, China can still keep its box office revenue. Giving a rising living standard and a massive demand for entertainment, Chinese moviegoers will become more significant for the global film industry. Given our experience in film and television drama series production and distribution network in the film and television drama series industry, the Group is confident in the production of film and television drama series operations and hopes to gain greater share of this fast growing box office market in the aftermath of the pandemic.

Looking forward, the Group will continue to strive to achieve healthy and stable growth by enhancing profitability, maximize its investment return and position to appropriate business opportunity.

She has over 35 years of experience in the entertainment and multimedia industries and over 10 years of experience in property development. Ms. Chen has produced a number of blockbuster films for Win's and One Hundred Years. In 2003, she was selected as one of 2003 Women in Entertainment – International Power by The Hollywood Reporter. For the years from 2006 to 2010, Ms. Chen was involved in the planning, monitoring and management of the renovation and operation of "Beijing Jianguo Apartment" into serviced apartment by Beijing Shama Real Estate Development Co. 緒言

本公司董事(「董事」)會(「董事會」)及管理層致力設立良好企業管治常規及程序。本公司及其附屬公司(「本集團」)一向維持高水平之商業操守及企業管治常規，此乃本集團目標之一。本公司相信，良好企業管治所提供之架構，對有效管理、業務成功發展及建立良好企業文化屬至關重要，藉此提高股東之價值。

本公司之企業管治原則著重董事會質素、穩健之內部監控，並且對全體股東具透明度及問責性。透過採用嚴密之企業管治常規，本集團相信將可改善問責性及透明度，從而增強股東及大眾之信心。截至二零二一年十二月三十一日止整個財政年度，本公司已應用並遵照香港聯合交易所有限公司(「聯交所」)證券上市規則(「上市規則」)附錄十四所載之《企業管治守則》(「守則」)之所有適用守則條文，惟一項偏離事項除外，有關詳情於本報告相關「偏離守則之事項」一節闡述。董事會自聯交所首次建議就有關企業管治常規修訂上市規則後，一直監察及檢討本集團就企業管治常規之進度以確保符合規定。本公司於年內舉行多次會議，並於適當時向本集團董事及高級管理層發出通函及其他指引說明，以確保彼等知悉有關企業管治常規之事宜。

INTRODUCTION

The board (the “Board”) of directors (“Directors”) of the Company and the management of the Company are committed to establishing good corporate governance practices and procedures. The maintenance of high standard of business ethics and corporate governance practices has always been one of the goals of the Company and its subsidiaries (the “Group”). The Company believes that good corporate governance provides a framework that is essential for effective management, successful business growth and a healthy corporate culture, thereby leading to the enhancement of shareholders’ value.

CORPORATE GOVERNANCE PRACTICES

The corporate governance principles of the Company emphasize a quality Board, sound internal controls, transparency and accountability to all shareholders. By applying rigorous corporate governance practices, the Group believes that its accountability and transparency will be improved thereby instilling confidence to shareholders and the public. Throughout the financial year ended 31st December 2021, the Company has applied the principles and complied with all the applicable code provisions laid down in the Corporate Governance Code (the “Code”) as set out in Appendix 14 to the Rules Governing the Listing of Securities (the “Listing Rules”) on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) save for one deviation, details of which will be explained in the section “Deviation from the Code” in this report. The Board has, since the amendments to the Listing Rules regarding corporate governance practices were first proposed by the Stock Exchange, continued to monitor and review the Group’s progress in respect of corporate governance practices to ensure compliance. Meetings were held throughout the year and where appropriate, circulars and other guidance notes were issued to directors and senior management of the Group to ensure awareness to issues regarding corporate governance practices.

董事會

職責

董事會負責本公司之領導及監控工作，並監管本集團之業務、策略決策及表現，以及藉指引及監督本公司事務共同負責引領本公司邁向成功。實際上，董事會負責就本公司所有主要事項作出決策，包括：審批及監控所有政策事宜、制定目標、年度預算及整體策略、重大交易、委任董事及其他重大財務及經營事項。本公司之日常管理、行政及營運均由高級行政人員執行。有關職責包括實行董事會之決策、根據董事會審批之管理策略及計劃協調及指引本公司日常營運及管理。該等高級行政人員在訂立任何重大交易前須先獲得董事會批准，而董事會亦全力支持彼等執行職務。

組成

於二零二一年十二月三十一日，董事會由六名董事組成，包括三名執行董事，分別為向華強先生（主席）、陳明英女士（副主席，擔任上市規則附錄十四所述行政總裁之角色）及李玉嫦女士，以及三名獨立非執行董事，分別為洪祖星先生、何偉志先生及鄧澤林先生。

其中一名獨立非執行董事具備適當專業資格，或會計或相關財務管理專業知識。獨立非執行董事佔董事會人數超過三分之一。董事之履歷詳情載於第21頁至第24頁之「董事及高級管理人員履歷」一節內。

THE BOARD

Responsibilities

The Board is responsible for the leadership and control of the Company and oversees the Group's business, strategic decisions and performances and is collectively responsible for promoting the success of the Company by directing and supervising its affairs. In practice, the Board takes responsibility for decision making in all major matters of the Company including: the approval and monitoring of all policy matters, the setting of objectives, annual budgets and overall strategies, material transaction, appointment of directors and other significant financial and operational matters. The day-to-day management, administration and operation of the Company are delegated to the senior executives. These responsibilities include the implementation of decisions of the Board, the co-ordination and direction of day-to-day operation and management of the Company in accordance with the management strategies and plans approved by the Board. Approval has to be obtained from the Board prior to any significant transactions entered into by these senior executives and the Board has the full support of them to discharge its responsibilities.

Composition

As at 31st December 2021, the Board comprises six Directors: including three executive Directors, namely, Mr. Heung Wah Keung (Chairman), Ms. Chen Ming Yin, Tiffany (Vice Chairman, performing the role of chief executive as stated in Appendix 14 of the Listing Rules) and Ms. Li Yuk Sheung and three independent non-executive Directors, namely, Mr. Hung Cho Sing, Mr. Ho Wai Chi, Paul and Mr. Tang Chak Lam, Gilbert.

One of the independent non-executive Directors has appropriate professional qualifications, or accounting or related financial management expertise. The number of independent non-executive Directors is more than one-third of the Board. Biographical details of the Directors are set out in the section "Biographical Details of Directors and Senior Management" on pages 21 to 24.

董事會認為，董事會包括三名獨立非執行董事，此可讓執行與非執行董事間取得合理之制衡。董事會認為，此制衡能為保障股東及本集團利益提供充份之核查及平衡。獨立非執行董事向本集團提供廣泛專業知識及經驗，從而可作出獨立判斷及確保已考慮全體股東之利益。彼等亦負責出席董事會會議、處理潛在利益衝突、出任審核委員會、薪酬委員會及提名委員會成員，以及監察本集團之表現及呈報。彼等之積極參與，為董事會及彼等所任職之委員會提供寶貴技能、專業知識及經驗，從而審慎檢討及監控管理程序。

董事在本身之專業範圍均為傑出人士，並展示高水平之個人及專業操守和誠信。全體董事均就本公司事務付出充足時間及心血。董事會相信，執行董事對非執行董事之比率誠屬合理，並足以發揮互相監察及制衡之作用，以保障股東及本公司之整體利益。

董事會全體須負責委任新董事及提名董事於本公司股東週年大會上接受股東重選。根據本公司之公司細則（「公司細則」），董事會可不時委任董事填補臨時空缺或出任董事會新成員。獲委任以填補臨時空缺之任何新董事須任職至其獲委任後之首次股東大會為止，並合資格於下一屆股東週年大會上膺選連任。獲董事會委任以加入現有董事會之任何新董事須任職至本公司下一屆股東週年大會為止，屆時將合資格膺選連任。

根據公司細則第99(A)條，洪祖星先生將於即將舉行之股東週年大會上告退，惟彼合資格並願意膺選連任。

The presence of three independent non-executive Directors is considered by the Board to be a reasonable balance between executive and non-executive Directors. The Board is of the opinion that such balance can provide adequate checks and balances for safeguarding the interests of shareholders and of the Group. The independent non-executive Directors provide to the Group with a wide range of expertise and experience so that independent judgement can effectively be exercised as well as ensuring that the interests of all shareholders are taken into account. They are also responsible for participating in Board meetings, dealing with potential conflicts of interest, serving on audit committee, remuneration committee and nomination committee, scrutinising the Group's performance and reporting. Through their active participation, they provide their valuable skills, expertise and experience to the Board and the committees on which they serve so that the management process can be critically reviewed and controlled.

The Directors have distinguished themselves in their field of expertise, and have exhibited high standards of personal and professional ethics and integrity. All the Directors give sufficient time and attention to the Company's affairs. The Board believes that the ratio of executive to non-executive Directors is reasonable and adequate to provide checks and balances that safeguard the interest of the shareholders and the Company as a whole.

The Board as a whole is responsible for the appointment of new director and nomination for re-election by shareholders at the annual general meeting of the Company. Under the Company's bye-laws (the "Bye-laws"), the Board may from time to time appoint a director either to fill a vacancy or as an addition to the Board. Any new director appointed to fill a casual vacancy shall hold office until the first general meeting after his appointment and shall then be eligible for re-election at the next following annual general meeting. Any new director appointed by the Board as an addition to the existing Board shall hold office until the next following annual general meeting of the Company and shall then be eligible for re-election.

Pursuant to Bye-law 99(A) of the Bye-laws, Mr. Hung Cho Sing will retire at the forthcoming annual general meeting and, being eligible, will offer himself for re-election.

主席及副主席

主席與副主席（擔任上市規則附錄十四所述行政總裁之角色）之職責分離，並不由同一人同時兼任，以確保董事會有明確責任分擔，達致權力及權限的平衡。

主席負責領導董事會，確保董事會有效運作，及確保向公眾傳達董事會的意見。在履行此項職責時，主席的責任包括主持董事會會議；確保董事會會議收到有關本公司事務之準確、完整、及時且清晰的資料；確保執行董事與非執行董事之間保持有建設性的關係；安排就提呈董事會考慮的問題進行討論及作出決定；確保所有董事均適當聽取董事會會議提出的事項之簡報；作為董事會與管理層之間的聯絡人；與副主席及公司秘書或其代表商議，草擬及批准每次董事會會議的議程，在適當情況下考慮其他董事提議納入議程的任何事項；以及至少每年與獨立非執行董事在執行董事不出席的情況下舉行會議。

副主席主要負責建議政策及策略方向供董事會批准；以及實施董事會採納的策略及政策，及執行本公司之日常營運。

CHAIRMAN AND VICE CHAIRMAN

The roles of Chairman and Vice Chairman (performing the role of chief executive as stated in Appendix 14 of the Listing Rules) are separate and not performed by the same individual to ensure that there is a clear division of responsibilities at the board level to entail a balance of power and authority.

The Chairman is responsible for leadership of the Board, for ensuring that the Board functions effectively, and for ensuring communication of the views of the Board to the public. In performing this role, the Chairman's responsibilities include chairing meetings of the Board; ensuring the board meetings receive accurate, complete, timely and clear information concerning affairs of the Company; ensuring constructive relations between executive and non-executive Directors; formulating for discussion and decision, questions which have been moved for the consideration of the Board; ensuring that all Directors are properly briefed on issues arising at board meetings; acting as liaison between the Board and management; in consultation with the Vice Chairman and the company secretary or his/her designated delegates, drawing up and approving the agenda for each board meeting taking into account, where appropriate, any matters proposed by the other Directors for inclusion in the agenda; and at least annually hold meetings with independent non-executive Directors without the presence of the executive Directors.

The Vice Chairman is primarily responsible for recommending policy and strategic directions for Board approval; implementing the strategies and policies adopted by the Board; and conducting the day-to-day operation of the Company.

獨立性

遵照上市規則，本公司有三名獨立非執行董事，其中至少一名獨立非執行董事具備適當財務管理專業知識。本集團已接獲各獨立非執行董事之年度獨立性確認書。根據上市規則第3.13條所載指引，本公司認為該等董事均為獨立人士。

所有載有董事姓名之公司通訊中，均已說明全體獨立非執行董事之身份。此外，除本公司主席向華強先生為副主席陳明英女士之丈夫外，董事會成員之間並無重大關係。

偏離守則之事項

截至二零二一年十二月三十一日止年度內，本公司一直遵守上市規則附錄十四之守則，惟以下偏離事項除外：

根據守則之A.4.1守則條文，非執行董事之委任應有指定任期，並須接受重新選舉。然而，全體獨立非執行董事均並無指定任期，惟須根據公司細則條文於本公司之股東週年大會上輪流退任及接受重新選舉。本公司認為已採取足夠措施，確保本公司之企業管治常規不比守則所訂者寬鬆。

截至二零二一年十二月三十一日止年度內，每名獨立非執行董事之酬金為240,000港元。

INDEPENDENCE

The Company has three independent non-executive Directors, at least one of whom has appropriate financial management expertise, in compliance with the Listing Rules. The Group has received from each independent non-executive Director an annual confirmation of his independence. The Company considers these Directors to be independent under the guidelines set out in Rule 3.13 of the Listing Rules.

All independent non-executive Directors are identified as such in all corporate communications containing the names of the Directors. In addition, there is no material relationship among members of the Board except that Mr. Heung Wah Keung, the Chairman, is the husband of Ms. Chen Ming Yin, Tiffany, the Vice Chairman of the Company.

DEVIATION FROM THE CODE

Throughout the year ended 31st December 2021, the Company complied with the Code in Appendix 14 of the Listing Rules, except for the following deviation:

Under the code provision A.4.1 of the Code, non-executive directors should be appointed for a specific term and subject to re-election. However, all the independent non-executive Directors are not appointed for specific terms but are subject to retirement by rotation and re-election at the annual general meeting of the Company in accordance with the provision of the Bye-laws. The Company considers that sufficient measures have been taken to ensure that the Company's corporate governance practices are no less exacting than those in the Code.

Each of the independent non-executive Directors has remunerated at HK\$240,000 for the year ended 31st December 2021.

董事會會議及股東大會

董事會定期以親身出席或透過其他電子通訊方式舉行會議，有關會議每年至少舉行四次，以釐定整體策略方向及目標及審批中期及年度業績以及其他重大事項。倘召開董事會例會，則會向全體董事發出最少14日之通知，以讓彼等藉此機會出席及提出事項於議程中討論。除例會外，高級管理層亦不時向董事提供有關本集團業務活動及發展之資料。公司秘書協助主席編製會議議程，並確保有關會議之所有適用規則及規例均獲得遵守及遵從。最終落實之議程及隨附之董事會文件其後將在舉行會議前最少三日發送予全體董事。公司秘書亦會就會議作出詳盡會議記錄，並就會上之討論事項及議決決定保留記錄。

於回顧年度內，已舉行八次董事會會議。董事出席股東大會、董事會及其有關委員會之會議之詳情如下：

BOARD MEETINGS AND SHAREHOLDERS' MEETINGS

The Board regularly meets in person or through other electronic means of communication at least four times every year to determine overall strategic direction and objectives and approve interim and annual results, and other significant matters. At least 14 days' notice of regular Board meeting are given to all Directors, who are all given an opportunity to attend and include matters in the agenda for discussion. Apart from regular meetings, senior management from time to time provides Directors with information on activities and development of the businesses of the Group. The company secretary assists the Chairman in preparing the agenda for the meeting and ensures that all applicable rules and regulations in connection with the meetings are observed and complied with. The finalized agenda and accompanying board papers are then sent to all Directors at least three days prior to the meeting. The company secretary also takes detailed minutes of the meetings and keeps records of matters discussed and decision resolved at the meetings.

During the year under review, eight board meetings were held. Details of the attendance of the Directors at the general meetings, meetings of the Board and its respective committees are as follows:

於董事會之定期會議中，董事商討及制定本集團之整體策略、監察財務表現及商討年度及中期業績、制定年度預算方案，以及商討及決定其他重要事宜。日常營運事務已委派本集團管理層執行。

公司秘書就各董事會會議之議事程序作詳細之會議記錄，包括記錄董事會所作出之所有決定，以及所提出之關注事宜或表達之反對意見(如有)。會議記錄之初稿須於會議結束後，於切實可行之情況下盡快發送予全體董事，以供評論及審批。任何董事均可在任何合理時間要求查閱所有會議記錄。

由於主席會確保管理層向董事會及其委員會適時提供所有相關資料，故全體董事均可在所有情況下取得相關最新資料。董事於其認為有需要或適當時均可要求提供進一步資料。

彼等亦可取得公司秘書之意見及享用其服務，包括負責向董事提供董事會文件及相關材料，確保遵循所有正確董事會程序，以及遵守一切適用法律及法規。如董事認為有需要及適當時，彼等可聘用獨立專業顧問提供服務，費用由本集團支付。

倘一名主要股東或董事存有利益衝突，有關事項將於董事會會議上進行討論，而不會以書面決議案方式處理。概無利益衝突之獨立非執行董事將會出席會議以處理該等衝突事宜。

董事委員會(包括審核委員會、薪酬委員會及提名委員會)均就所有委員會會議採納董事會會議沿用之適用常規及程序。

During regular meetings of the Board, the Directors discuss and formulate the overall strategies of the Group, monitor financial performances and discuss the annual and interim results, set annual budgets, as well as discuss and decide on other significant matters. The execution of daily operational matters is delegated to management of the Group.

The company secretary records the proceedings of each board meeting in detail by keeping minutes, including the record of all decisions by the Board together with concerns raised and dissenting views expressed (if any). Drafts of board minutes are circulated to all directors for comment and approval as soon as practicable after the meeting. All minutes are open for inspection at any reasonable time on request by any Director.

All Directors have access to relevant and timely information at all times as the Chairman ensures that the management will supply the Board and its committees with all relevant information in a timely manner. They may make further enquiries if in their opinion it is necessary or appropriate to request for further information.

They also have unrestricted access to the advice and services of the company secretary, who is held responsible for providing Directors with board papers and related materials and ensuring that all proper Board procedures are followed and that all applicable laws and regulations are complied with. If considered necessary and appropriate by the Directors, they may retain the service of independent professional advisers at the Group's expense.

In case where a conflict of interest may arise involving a substantial shareholder or a director, such matter will be discussed in a physical meeting and will not be dealt with by way of written resolutions. Independent non-executive Directors with no conflict of interest will be present at meetings dealing with such conflict issues.

The board committees, including the audit committee, the remuneration committee and the nomination committee, have all adopted the applicable practices and procedures used in board meetings for all committee meetings.

董事之培訓及支援

所有董事（包括獨立非執行董事）必須不時瞭解其作為董事之共同責任，以及本集團之業務。因此，本集團於每名新委任董事獲委任後將向彼等提供全面及正式指導，並向彼等提供及安排簡介會及介紹，以確保彼等熟悉董事會之角色、彼等作為董事之法律及其他責任，以及本集團之業務及管治常規。該等計劃考慮到各個別董事之背景及專業知識而為彼等度身制定。公司秘書將繼續向所有董事提供有關上市規則及其他適用監管規定之最新發展，以確保各董事遵守該等規則及規定。

全體董事亦會參與本集團提供或安排之持續專業發展計劃，例如由合資格專業人士舉辦之外界研討會更新有關法律及規例及上市規則資料，以發展及更新有關彼等對董事會作出貢獻之知識及技能。各董事所接受之培訓記錄由本公司之公司秘書留存及更新。

The annual general meeting and other general meetings of the Company are the primary forum for communication by the Company with the shareholders and for shareholders' participation. All shareholders are encouraged to attend the general meetings or to appoint proxies to attend and vote at meetings on their behalf if they are unable to attend the meetings.

TRAINING AND SUPPORT FOR DIRECTORS

All Directors, including independent non-executive Directors, must keep abreast of their collective responsibilities as directors and of the business of the Group. As such, the Group provides a comprehensive and formal induction to each newly appointed director upon his/her appointment. Briefings and orientations are provided and organised to ensure that the new Directors are familiar with the role of the Board, their legal and other duties as a director as well as the business and governance practices of the Group. Such programmes are tailored to each individual director taking into account their background and expertise. The company secretary will continuously update all Directors on the latest developments regarding the Listing Rules and other applicable regulatory requirements to ensure compliance of the same by all Directors.

All Directors also participate in continuous professional development programmes provided or procured by the Group, such as external seminars organised by qualified professionals update materials regarding laws and regulation and the Listing Rules, to develop and refresh their knowledge and skills in relation to their contribution to the Board. A record of the training received by the respective Directors are kept and updated by the company secretary of the Company.

Mr. Hung Cho Sing is the chairman of the committee.

NOMINATION COMMITTEE

A nomination committee was formed with specific written terms of reference. As at 31st December 2021, the nomination committee consists of two independent non-executive Directors, namely Mr. Tang Chak Lam, Gilbert and Mr. Hung Cho Sing, and an executive Director, namely Mr. Heung Wah Keung. Mr. Tang Chak Lam, Gilbert is the chairman of the nomination committee.

提名委員會之職責包括每年最少檢討董事會架構、人數及成員一次，並就任何建議變更向董事會提出推薦建議以補足本公司之企業策略、物色合適及合資格人士出任董事會成員，並挑選個別人士提名出任董事、評估獨立非執行董事之獨立性及就委任或重新委任董事及董事繼任計劃（尤其是主席及副主席）向董事會提出推薦建議。提名委員會亦獲提供足夠資源以履行其職責。如有需要，提名委員會可尋求獨立專業意見以履行其職責，費用由本集團承擔。

The duties of the nomination committee include reviewing the structure, size and composition of the Board at least annually, making recommendations on any proposed changes to the Board to complement the Company's corporate strategy, identifying individuals suitably qualified to become members of the Board and selecting individuals nominated for directorship, assessing the independence of the independent non-executive Directors and making recommendations to the Board on the appointment or re-appointment of Directors and succession planning for directors, in particular the chairman and the vice chairman. The nomination committee is also provided with sufficient resources to perform its duties. Where necessary, the nomination committee can seek independent professional advice, at the Group's expense, to perform its responsibilities.

During the year under review, the nomination committee held one meeting to review the structure, size and composition of the Board and to review the Board Diversity Policy.

董事會成員多元化

董事會於二零一三年採納了董事會多元化政策（「政策」），並根據董事會於二零一九年三月二十六日通過的決議進行了修訂。其主要條款載列如下。

BOARD DIVERSITY

The Board adopted a Board Diversity Policy (the "Policy") in 2013 and amended pursuant to the resolution of the Board passed on 26th March 2019. The key terms of the Policy are set out as follows.

1. 目的

本政策旨在列載董事會為達致成員多元化而採取的方針。

1. Purpose

This Policy aims to set out the approach to achieve diversity in the Board.

2. 願景

本公司明白並深信董事會成員多元化對提升其表現素質有利。

2. Vision

The Company recognises and embraces the benefits of having a diversified Board to enhance the quality of its performance.

3. 政策聲明

為實現可持續和均衡的發展，本公司認為董事會層面的日益多元化是實現其戰略目標和可持續發展的關鍵因素。在實現董事會的多元化方面，將考慮每位董事候選人的若干方面，包括但不限於性別、年齡、文化和教育背景、種族、專業經驗、技能、知識和服務任期。所有董事會委任均以用人唯才為原則，候選人將根據本政策中規定的客觀標準進行考慮，同時適當考慮董事會多元化的裨益。

3. Policy Statement

With a view to achieving a sustainable and balanced development, the Company sees an increase in diversity at the Board level to be an essential element in the attainment of its strategic objectives and sustainable development. In achieving diversity of the Board, a number of aspects of each director candidate will be considered, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service. All Board appointments will be based on meritocracy, and the candidates will be considered based on the objective criteria set out in this Policy having due regard for the benefits of diversity on the Board.

4. 可衡量的目標

選擇董事會成員候選人將基於一系列不同角度，包括但不限於：性別、年齡、文化和教育背景、種族、專業技能和知識，以及工作經驗。董事會將根據候選人可能帶給董事會的優點和貢獻作出最終決定。

4. Measurable Objectives

Selection of candidates will be based on a range of diversity perspectives, including but not limited to the candidate's gender, age, cultural and educational background, ethnicity, professional skills and knowledge, and working experience. The ultimate decision will be made by the Board based on the merit and contribution which the candidates may be able to bring to the Board.

5. 監察及匯報

6. 檢討本政策

董事會認為董事會目前的結構，規模和組成適合使其能夠對管理實踐執行平衡且獨立的監督職能，以補充公司的企業戰略，及由於董事會由不同背景的董事組成，因此董事會已實現多元化。

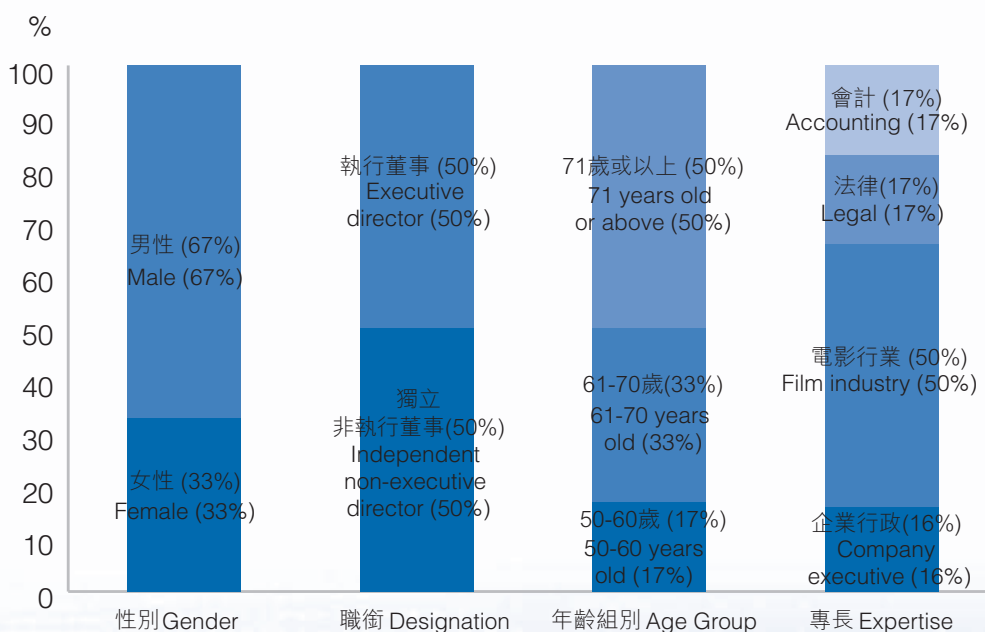
The Nomination Committee will report annually on the Board's composition under the diversified perspectives in the Corporate Governance Report, and monitor the implementation of this Policy.

The Nomination Committee will review this Policy, on an annual basis, to ensure its implementation and effectiveness. The Nomination Committee will discuss any revisions that may be required, and recommend any such revisions to the Board for consideration and approval.

The Board considered that the current structure, size and composition of the Board to be appropriate in enabling it to perform a balanced and independent monitoring function on management practices to complement the Company's corporate strategy and diversity within the Board has been achieved as the Board is composed of director from a diverse range of background.

審核委員會

本公司已遵照上市規則成立審核委員會，並以書面訂明其職權範圍。上市規則第3.21條規定審核委員會必須由至少三名非執行董事組成，而至少一名成員須為獨立非執行董事及必須具備適當專業資格或會計或相關財務管理專業知識。審核委員會之主要職責包括以下各項：

- (a) 於財務報表及報告提交董事會前進行審閱，並考慮外聘核數師提出之任何重大或不尋常項目。
- (b) 根據核數師進行之工作、其費用及聘用條款檢討與外聘核數師之關係，並就委聘、續聘及罷免外聘核數師向董事會提出建議。
- (c) 檢討本公司之財務申報制度、內部監控系統及風險管理系統以及有關程序是否足夠及有效。

審核委員會之其他職責載於本公司網站刊載之具體成文職權範圍內。審核委員會已獲提供充足資源，讓彼等履行其職責。

於二零二一年十二月三十一日，審核委員會有三名成員，分別為何偉志先生（審核委員會主席）、洪祖星先生及鄧澤林先生，均為獨立非執行董事。概無審核委員會成員在其終止成為合夥人或享有核數公司財務利益之日期起計兩年內，為本公司之現有核數公司之前任合夥人。審核委員會已審閱本集團所採納之會計原則及慣例，並與本公司管理團隊討論內部監控及財務申報事宜。年內，審核委員會已舉行二次會議以審閱本集團之年度報告及中期報告。

AUDIT COMMITTEE

The Company established an audit committee with written terms of reference in compliance with the Listing Rules. Rule 3.21 of the Listing Rules requires that the audit committee must comprise a minimum of three non-executive directors, at least one of them should be independent non-executive directors with appropriate professional qualifications or accounting or related financial management expertise. The main duties of the audit committee include the followings:

- (a) To review the financial statements and reports and consider any significant or unusual items raised by the external auditor before submission to the Board.
- (b) To review the relationship with the external auditor by reference to the work performed by the auditor, their fees and terms of engagement, and make recommendation to the Board on the appointment, re-appointment and removal of external auditor.
- (c) To review the adequacy and effectiveness of the Company's financial reporting system, internal control system and risk management system and associated procedures.

Other duties of the audit committee are set out in its specific terms of reference which are posted on the Company's website. The audit committee is provided with sufficient resources enabling it to discharge its duties.

As at 31st December 2021, the audit committee has three members, namely Mr. Ho Wai Chi, Paul (chairman of the audit committee), Mr. Hung Cho Sing and Mr. Tang Chak Lam, Gilbert, all being independent non-executive Directors. No member of the audit committee is a former partner of the existing auditing firm of the Company within two years on the date of his ceasing to be a partner or had any financial interest in the auditing firm. The audit committee has reviewed the accounting principles and practices adopted by the Group and discussed internal controls and financial reporting matters with the management team of the Company. During the year, the audit committee held two meetings to review the Group's annual report and interim report.

審核委員會亦已檢討財務申報及監察程序，以及就本公司之內部監控及風險管理檢討及程序及續聘外聘核數師作出匯報。現時並無任何與可能對本公司能否持續經營產生重大疑問之事件及情況有關之重大不確定因素。董事會及審核委員會就推選、委任、辭任或罷免外聘核數師並無意見分歧。

本集團的外聘核數師為國衛會計師事務所有限公司。國衛會計師事務所有限公司已向審核委員會發出函件，確認該事務所對本公司而言為獨立，並且國衛會計師事務所有限公司與本公司之間不存在任何有可能被合理認為可影響其獨立性的關係。為維持外聘核數師的獨立性，該工作只在不會影響其獨立性並經由審核委員會預先批准的情況下，本公司才會聘用外聘核數師從事非審核工作。年內，外聘核數師向本集團提供了審核和非審核服務。審核服務包括與審核本集團的綜合財務報表有關的審核服務。非審核服務包括刊發特別審核報告或中期審閱或其他監管目的之服務。

本公司截至二零二一年十二月三十一日止年度之年報已由審核委員會審閱。本年度之財務報表已經由國衛會計師事務所有限公司審核，其任期將於即將舉行之股東週年大會上屆滿。審核委員會已向董事會建議，於本公司應屆股東週年大會上提名委任國衛會計師事務所有限公司為本公司之核數師。

截至二零二一年十二月三十一日止年度，核數師國衛會計師事務所有限公司提供之核數服務及非核數服務之已付及應付費用分別為800,000港元及137,000港元。

The audit committee has also reviewed the financial reporting and compliance procedures, report on the company's internal control and risk management review and processes as well as the re-appointment of the external auditor. There is no material uncertainty relating to events and conditions that may cast significant doubt on the Company's ability to continue as a going concern. There is no disagreement between the Board and the audit committee regarding the selection, appointment, resignation or dismissal of external auditor.

The Group's external auditors is HLB Hodgson Impey Cheng Limited. HLB Hodgson Impey Cheng Limited has written to the Audit Committee confirming that they are independent with respect to the Company and that there is no relationship between HLB Hodgson Impey Cheng Limited and the Company which may reasonably be thought to bear on their independence. In order to maintain the external auditors' independence, it would only be employed for non-audit work if the work does not compromise the external auditors' independence and has been pre-approved by the Audit Committee. During the year, the external auditors provided audit services and non-audit services to the Group. Audit services include services provided in connection with the audit of the Group's consolidated financial statements. Non-audit services include services such as issuance of special audit reports or interim review or other regulatory purposes.

The Company's annual report for the year ended 31st December 2021 has been reviewed by the audit committee. The financial statements for the year were audited by HLB Hodgson Impey Cheng Limited whose term of office will expire upon the forthcoming annual general meeting. The audit committee has recommended to the Board that HLB Hodgson Impey Cheng Limited be nominated for appointment as the auditor of the Company at the forthcoming annual general meeting.

For the year ended 31st December 2021, the fees paid and payable in respect of audit services and non-audit services provided by the auditors, HLB Hodgson Impey Cheng Limited, amounted to HK\$800,000 and HK\$137,000 respectively.

The company secretary keeps full minutes of all audit committee meetings. In line with practices consistent with Board meetings and other committee meetings, draft and final versions of audit committee meeting minutes are circulated to all members of the audit committee for comments, approval and record as soon as practicable after each meeting.

本公司已就本公司董事買賣證券，採納載於上市規則附錄十有關上市發行人董事進行證券交易的標準守則（「標準守則」）。標準守則適用於相關僱員（包括因其職務或受僱而可能掌握有關本公司或其證券的內幕消息的任何僱員或附屬公司或控股公司的董事或僱員）進行有關本公司之證券交易。在本公司作出特定查詢後，董事會所有成員已確認彼等於截至二零二一年十二月三十一日止年度內，一直遵守標準守則所載之標準要求及其有關董事進行證券交易的行為守則。標準守則亦適用於本集團其他指定高級管理人員。

CODE OF CONDUCT REGARDING SECURITIES TRANSACTIONS BY DIRECTORS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") as set out in Appendix 10 of the Listing Rules for securities transactions by directors of the Company. The Model Code is extended to relevant employees (including any employee or a director or employee of a subsidiary or holding company who, because of his office or employment, is likely to possess inside information in relation to the Company or its securities) in respect of their dealings in the Company's securities. All the members of the Board have confirmed, following specific enquiry by the Company, that they have complied with the required standard as set out in the Model Code and its code of conduct regarding directors securities transactions throughout the year ended 31st December 2021. The Model Code also applies to other specified senior management of the Group.

RESPECTIVE RESPONSIBILITIES OF DIRECTORS AND AUDITORS

The Directors are responsible for the preparation of the financial statements, which give a true and fair view of the financial position of the Group. The auditors are responsible to form an independent opinion, based on the audit, on the financial statements prepared by the Directors and report the opinion solely to the shareholders of the Company.

The Independent Auditors' Report on pages 59 to 66 set out the reporting responsibilities of the auditors of the Company for the consolidated financial statements.

所有董事均可以取得公司秘書的建議和享用其服務。公司秘書向董事會匯報，並負責確保董事會程序得到遵守、促進董事之間的信息流和相互溝通、以及股東與管理層之溝通。自二零二零一年十二月起，黃淑嫻女士獲委任為本公司之公司秘書。於本年度，黃女士符合上市規則的專業培訓要求。

企業管治職能

由於並無成立企業管治委員會，因此董事會須負責執行企業管治職能，包括制定、檢討及監察本公司之政策、企業管治常規、為董事及高級管理層提供培訓及持續專業發展，確保本公司之政策、常規符合法律及監管規定，以及本公司的行為守則及本公司遵守《企業管治守則》及在企業管治報告中披露等。

截至二零二一年十二月三十一日止財政年度，董事會已檢討本公司有關企業管治之政策及常規。

風險管理及內部監控

董事會確認其有責任確保本集團風險管理及內部監控系統行之有效。

風險管理程序包括風險識別、風險評估、風險管理以及風險控制及審查。

管理層獲委派於其責任及權力範圍內識別、分析、評估、應對、監控及傳達與任何活動、職務或程序有關風險。

本集團至少每年持續進行監督其風險管理及內部監控系統。

COMPANY SECRETARY

All Directors have access to the advice and services of the company secretary. The company secretary reports to the Board, and is responsible for ensuring that Board procedures are followed and for facilitating information flows and communications among Directors as well as with shareholders and the management. Ms. Wong Shuk Han, Dorothy has been appointed as the company secretary of the Company with effect from December 2021 and Ms. Wong has complied with the professional training requirement of the Listing Rules during the year.

CORPORATE GOVERNANCE FUNCTION

No corporate governance committee has been established and the Board will therefore be responsible for performing the corporate governance functions such as developing, reviewing and monitoring the Company's policies, practices on corporate governance, training and continuous professional development of Directors and senior management, the Company's policies, practices on compliance with legal and regulatory requirements, the Company's code of conduct and the Company's compliance with the Corporate Governance Code and disclosure in the Corporate Governance Report, etc.

During the financial year ended 31st December 2021, the Board has reviewed the Company's policies and practices on corporate governance.

RISK MANAGEMENT AND INTERNAL CONTROL

The Board acknowledges its responsibility for the effectiveness of the Group's risk management and internal control systems.

The risk management process includes risk identification, risk evaluation, risk management and risk control and review.

The management is entrusted with duties to identify, analyze, evaluate, respond, monitor and communicate risks associated with any activity, function or process within its scope of responsibility and authority.

The Group has overseen its risk management and internal control system on an ongoing basis and conducted at least annually.

本集團於截至二零二一年十二月三十一日止年度已聘用外聘專業顧問博奕顧問有限公司，進行獨立內部監控審閱，有關審閱於本年報日期已完成。

截至二零二一年十二月三十一日止年度，董事會認為本集團的風險管理及內部監控系統已充分及有效，且本公司已遵守守則內有關內部監控的守則條文。

董事會權力之轉授

董事會負責就本集團業務之整體策略性發展作出決定。所有董事均有正式委任書，訂明有關委任之主要條款及條件。由於本集團業務多元化及繁多，有關策略性業務計劃之日常運作及執行之責任已交予本集團管理層。

所有委員會（即審核委員會、薪酬委員會及提名委員會）均有具體職權範圍，明確界定相關委員會之權力及責任。所有委員會須按其職權範圍之規定就其決定、發現或推薦建議向董事會報告，並於若干特定情況下，在採取任何行動前徵求董事會批准。

The Group has conducted a review of the implemented system and procedures, including areas covering financial, operational, compliance controls and risk management functions during the year under review. The systems are implemented to minimise the risk to which the Group is exposed and is used as a management tool for the day-to-day operation of business. The system can only provide reasonable but not absolute assurance against misstatement or losses.

The Group does not have an internal audit function as the Board has reviewed the effectiveness of the internal control system of the Company and is currently of the view that there is no immediate need to set up an internal audit function within the Group in light of the size, nature and complexity of the Group's business. The situation will be reviewed from time to time.

The Group had engaged Insightnetic Consultancy Limited, external professional consultant, to conduct independent internal control review for the year ended 31st December 2021 and the review is completed as at the date of this annual report.

For the year ended 31st December 2021, the Board considered the Group's risk management and internal control system as adequate and effective and that the Company has complied with the code provisions on internal control of the Code.

DELEGATION BY THE BOARD

The Board is responsible for decisions in relation to the overall strategic development of the Group's business. All Directors have formal letters of appointment setting out key terms and conditions relative to their appointment. Due to the diversity and volume of the Group's business, responsibility in relation to the daily operations and execution of the strategic business plans are delegated to management of the Group.

All committees, namely the audit committee, the remuneration committee and the nomination committee, have specific terms of reference clearly defining the authorities and responsibilities of the respective committees. All committees are required by their terms of reference to report to the Board in relation to their decisions, findings or recommendations, and in certain specific situations, to seek the Board's approval before taking any actions.

DIRECTORS' AND OFFICERS' LIABILITY INSURANCE

Insurance cover has been taken out for Directors' and Officers' Liability to provide adequate cover, as determined by the Board, in respect of the Board members and senior management members of the Company.

與股東之關係及溝通

本公司承諾維持高水平之透明度，並向其股東公開及適時披露有關資料。對公平披露及全面透徹報告本公司活動之承諾可在多方面得到反映。

SHAREHOLDERS RELATIONS AND COMMUNICATION

The Company is committed to maintaining a high level of transparency and employs a policy of open and timely disclosure of relevant information to its shareholders. The commitment to fair disclosure and comprehensive and transparent reporting of the Company's activities can be reflected in many aspects.

董事會致力維持與股東持續溝通，股東週年大會則提供一個實用之討論平台，以供董事會與股東交流意見。

In endeavouring to maintain an on-going dialogue with shareholders, the annual general meeting provides a useful forum for shareholders to exchange views with the Board.

主席亦積極參與籌備及親自舉行二零二一年股東週年大會，確保股東意見可傳達董事會。在股東週年大會上，主席就各項個別事宜提呈獨立決議案。

The Chairman was also actively involved in organizing, and personally held the annual general meeting in 2021 in order to ensure that shareholders' views were communicated to the Board. A separate resolution was proposed by the Chairman in respect of each separate issue at the annual general meeting.

股東週年大會之議事程序將不時檢討，以確保本公司遵從最佳企業管治守則。股東週年大會通函於舉行股東週年大會前不少於二十一日發送予各股東，當中載有所提呈每項決議案之詳情、投票表決之程序（包括要求及進行投票表決之程序）及其他有關資料。於本公司之二零二一年股東週年大會上，所有決議案均以投票方式表決，而本公司之香港股份過戶登記分處香港中央證券登記有限公司，乃受聘擔任監票員以確保票數妥為點算。股東之權利及於股東大會上要求就決議案進行投票表決之程序載於公司細則。

The proceedings of the annual general meeting are reviewed from time to time to ensure the Company conforms to the best practices regarding corporate governance. The annual general meeting circular, which is circulated to all shareholders at least twenty-one days prior to the holding of the annual general meeting, sets out the details in relation to each resolution proposed, voting procedures (including procedures for demanding and conducting a poll) and other relevant information. At the Company's 2021 annual general meeting, all the resolutions were put to the vote by poll and Computershare Hong Kong Investor Services Limited, the Company's Hong Kong Branch Share Registrar, was engaged as scrutineer to ensure the votes were properly counted. The rights of shareholders and the procedures for demanding a poll on resolutions at shareholders' meeting are contained in the Bye-laws.

本公司的股東週年大會及其他股東大會是本公司與股東之間的主要溝通方式。鼓勵股東參加股東大會。董事會成員、適當的管理人員和外聘核數師將出席股東週年大會，以在股東大會上回答股東問題。本公司網站向股東提供企業資料，本公司刊發的中期及年度報告，公佈和通函。它還提供有關本集團企業管治以及董事會和董事委員會的組成和職能的信息。

The Company also communicates to its shareholders through its annual and interim reports. The Directors, company secretary or other appropriate members of senior management also respond promptly to inquiries from shareholders and investors.

The annual general meetings and other general meetings of the Company are the primary communication between the Company and the Shareholders. Shareholders are encouraged to participate in general meetings. Board members, appropriate management executives and external auditors will attend annual general meetings to answer Shareholders' questions at the general meetings. The Company's website provides the Shareholders with corporate information, interim and annual reports, announcements and circulars issued by the Company. It also provides information on corporate governance of the Group and the compositions and functions of the Board and the Board committees.

股東權利

股東召開股東特別大會（「股東特別大會」）之程序

持有不少於本公司十分之一繳足股本且已繳付所有到期催繳股款或其他款項之股東之書面要求時，董事會須立即就此召開股東特別大會。

1. 一般事項

中國星集團有限公司(「本公司」)乃於百慕達註冊成立之受豁免有限公司，其股份在香港聯合交易所有限公司(「聯交所」)上市。本公司之註冊辦事處及主要營業地點之地址分別為Victoria Place, 5th Floor, 31 Victoria Street, Hamilton HM10, Bermuda及香港干諾道中168-200號信德中心西翼34樓09室。

其直接及最終控股公司為Heung Wah Keung Family Endowment Limited，由向華強先生(「向先生」)及向先生之配偶陳明英女士(「陳女士」)等份擁有。

本綜合財務報表以港元(「港元」)列值，其亦為本公司之功能貨幣。除另有說明者外，所有價值均計算至最近之千位數(千港元)。

本集團之主要業務為投資、製作、發行以及授權電影及電視連續劇、提供藝人管理服務、以及物業開發及投資。

本集團亦從事提供餐飲服務，其已於本年度終止經營。

1. GENERAL

China Star Entertainment Limited (the “Company”) is incorporated in Bermuda as an exempted company with limited liability and its shares are listed on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”). The addresses of the registered office and principal place of business of the Company are Victoria Place, 5th Floor, 31 Victoria Street, Hamilton HM10, Bermuda and Unit 3409, Shun Tak Centre, West Tower, 168-200 Connaught Road Central, Hong Kong respectively.

Its immediate and ultimate holding company is Heung Wah Keung Family Endowment Limited which is equally owned by Mr. Heung Wah Keung (“Mr. Heung”) and Ms. Chen Ming Yin, Tiffany (“Ms. Chen”), spouse of Mr. Heung.

The consolidated financial statements are presented in Hong Kong dollar (“HK\$”), which is also the functional currency of the Company and all values are rounded to the nearest thousand (HK\$’000) except otherwise indicated.

The principal activities of the Group are investment, production, distribution and licensing of films and television drama series, provision of artist management services and properties development and investment.

The Group was also engaged in provision of catering services which was discontinued in current year.

The consolidated financial statements have been prepared on the historical cost basis except for investment property and certain financial instruments that are measured at fair values at the end of each reporting period, as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 *Share-based Payment*, leasing transactions that are accounted for in accordance with HKFRS 16 *Leases*, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 *Inventories* or value in use in HKAS 36 *Impairment of Assets*.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;

- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

When the Group has less than a majority of the voting rights of an investee, it has power over the investee when the voting rights are sufficient to give it the practical ability to direct the relevant activities of the investee unilaterally. The Group considers all relevant facts and circumstances in assessing whether or not the Group's voting rights in an investee are sufficient to give it power, including:

- the size of the Group's holding of voting rights relative to the size and dispersion of holdings of the other vote holders;
- potential voting rights held by the Group, other vote holders or other parties;
- rights arising from other contractual arrangements; and

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated income statement from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies in line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

Non-controlling interests in subsidiaries are presented separately from the Group's equity therein, which represent present ownership interests entitling their holders to a proportionate share of net assets of the relevant subsidiaries upon liquidation.

Acquisitions of businesses are accounted for using the acquisition method. The consideration transferred in a business combination is measured at fair value, which is calculated as the sum of the acquisition-date fair values of the assets transferred by the Group, liabilities incurred by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. Acquisition-related costs are generally recognised in profit or loss as incurred.

Except for certain recognition exemptions, the identifiable assets acquired and liabilities assumed must meet the definitions of an asset and a liability in the *Framework for the Preparation and Presentation of Financial Statements* (replaced by the *Conceptual Framework for Financial Reporting* issued on October 2010).

At the acquisition date, the identifiable assets acquired and the liabilities assumed are recognised at their fair value, except that:

- deferred tax assets or liabilities, and assets or liabilities related to employee benefit arrangements are recognised and measured in accordance with HKAS 12 *Income Taxes* and HKAS 19 *Employee Benefits* respectively;
- liabilities or equity instruments related to share-based payment arrangements of the acquiree or share-based payment arrangements of the Group entered into to replace share-based payment arrangements of the acquiree are measured in accordance with HKFRS 2 at the acquisition date (see the accounting policy below);

Right-of-use assets are recognised and measured at the same amount as the relevant lease liabilities, adjusted to reflect favourable or unfavourable terms of the lease when compared with market terms.

Goodwill is measured as the excess of the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree, and the fair value of the acquirer's previously held equity interest in the acquiree (if any) over the net amount of the identifiable assets acquired and the liabilities assumed at acquisition date. If, after re-assessment, the net amount of the identifiable assets acquired and liabilities assumed exceeds the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value of the acquirer's previously held interest in the acquiree (if any), the excess is recognised immediately in profit or loss as a bargain purchase gain.

Non-controlling interests that are present ownership interests and entitle their holders to a proportionate share of the relevant subsidiary's net assets in the event of liquidation are initially measured at the non-controlling interests' proportionate share of the recognised amounts of the acquiree's identifiable net assets or at fair value. The choice of measurement basis is made on a transaction-by-transaction basis.

收購業務而產生之商譽乃按於收購業務當日之成本減累計減值虧損(如有)列賬。

就減值測試而言，收購產生之商譽會分配至預期可自收購之協同效益獲益之本集團各現金產生單位(「現金產生單位」)(或現金產生單位組合)，即為內部管理目的監察商譽之最低水平且不大於經營分類。

獲分配商譽之現金產生單位(或現金產生單位組合)會每年或於有跡象顯示該單位可能出現減值時進行更頻繁的減值測試。就報告期內收購所產生之商譽，獲分配商譽之現金產生單位(或現金產生單位組合)會於報告期末前進行減值測試。倘可收回金額低於其賬面值，則減值虧損會先用作減低任何分配至商譽之賬面值，其後則按該單位(或現金產生單位組合)內各項資產賬面值之比例分配至其他資產。

出售相關現金產生單位(或現金產生單位組合內任何現金產生單位)時，商譽之應佔金額於釐定出售之損益金額時加入計算。本集團出售現金產生單位(或現金產生單位組合內某現金產生單位)內一項經營業務時，所出售商譽金額乃按所出售經營業務(或現金產生單位)之相對價值及所保留現金產生單位(或現金產生單位組合)之份額計量。

(d) Goodwill

Goodwill arising on an acquisition of a business is carried at cost as established at the date of acquisition of the business less accumulated impairment losses, if any.

For the purposes of impairment testing, goodwill is allocated to each of the Group's cash-generating units (the "CGU") (or group of CGUs) that is expected to benefit from the synergies of the combination, which represent the lowest level at which the goodwill is monitored for internal management purposes and not larger than an operating segment.

A CGU (or group of CGUs) to which goodwill has been allocated is tested for impairment annually or more frequently when there is indication that the unit may be impaired. For goodwill arising on an acquisition in a reporting period, the CGU (or group of CGUs) to which goodwill has been allocated is tested for impairment before the end of that reporting period. If the recoverable amount is less than its carrying amount, the impairment loss is allocated first to reduce the carrying amount of any goodwill and then to the other assets on a pro-rata basis based on the carrying amount of each asset in the unit (or group of CGUs).

On disposal of the relevant CGU or any of the CGU within the group of CGUs, the attributable amount of goodwill is included in the determination of the amount of profit or loss on disposal. When the Group disposes of an operation within the CGU (or a CGU within a group of CGUs), the amount of goodwill disposed of is measured on the basis of the relative values of the operation (or the CGU) disposed of and the portion of the CGU (or the group of CGUs) retained.

A joint venture is a joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint arrangement. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require unanimous consent of the parties sharing control.

The results and assets and liabilities of joint venture are incorporated in these financial statements using the equity method of accounting. The financial statements of joint venture used for equity accounting purposes are prepared using uniform accounting policies as those of the Group for like transactions and events in similar circumstances. Under the equity method, an investment in a joint venture is initially recognised in the consolidated statement of financial position at cost and adjusted thereafter to recognise the Group's share of the profit or loss and other comprehensive income of the joint venture. Changes in net assets of the joint venture other than profit or loss and other comprehensive income are not accounted for unless such changes resulted in changes in ownership interest held by the Group. When the Group's share of losses of a joint venture exceeds the Group's interest in that joint venture (which includes any long-term interests that, in substance, form part of the Group's net investment in the joint venture), the Group discontinues recognising its share of further losses. Additional losses are recognised only to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the joint venture.

Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of the investment, after reassessment, is recognised immediately in profit or loss in the period in which the investment is acquired.

The Group assesses whether there is an objective evidence that the interest in a joint venture may be impaired. When any objective evidence exists, the entire carrying amount of the investment (including goodwill) is tested for impairment in accordance with HKAS 36 as a single asset by comparing its recoverable amount (higher of value in use and fair value less costs of disposal) with its carrying amount. Any impairment loss recognised forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with HKAS 36 to the extent that the recoverable amount of the investment subsequently increases.

In addition, the Group accounts for all amounts previously recognised in other comprehensive income in relation to that joint venture on the same basis as would be required if that joint venture had directly disposed of the related assets or liabilities. Therefore, if a gain or loss previously recognised in other comprehensive income by that joint venture would be reclassified to profit or loss on the disposal of the related assets or liabilities, the Group reclassifies the gain or loss from equity to profit or loss (as a reclassification adjustment) upon disposal/partial disposal of the relevant joint venture.

In contrast, a receivable represents the Group's unconditional right to consideration, i.e. only the passage of time is required before payment of that consideration is due.

A contract liability represents the Group's obligation to transfer goods or services to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer.

A contract asset and a contract liability relating to the same contract are accounted for and presented on a net basis.

For contracts that contain more than one performance obligations, the Group allocates the transaction price to each performance obligation on a relative stand-alone selling price basis.

Revenue is recognised when control over a product or service is transferred to the customer, at the amount of promised consideration to which the Group is expected to be entitled, excluding those amounts collected on behalf of third parties. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts.

The Group provides artist management services by arranging for the provision of artist services to counterparty under fixed-price contracts. Artist management service income is recognised in which the services are rendered. Certain contracts include multiple performance obligations and the transaction price of such contract will be allocated to each performance obligation based on the stand-alone selling prices. Artist management service income is recognised at a point in time.

Distribution fee income

The Group licenses the distribution rights of films and television drama series internationally. Distribution fee income is recognised when the Group's entitlement to such payments has been established which, subject to the terms of the relevant agreements, is usually upon the master materials have been delivered or the sharing of the relevant revenue have been reliably ascertained. Distribution fee income is recognised at a point in time.

Income from investment in films

Income from investment in films is recognised when the Group's entitlement to such payment has been established, which is subject to the terms of the relevant agreements.

Lease modifications

Except for Covid-19-related rent concessions in which the Group applied the practical expedient, the Group accounts for a lease modification as a separate lease if:

- the modification increases the scope of the lease by adding the right to use one or more underlying assets; and
- the consideration for the leases increases by an amount commensurate with the stand-alone price for the increase in scope and any appropriate adjustments to that stand-alone price to reflect the circumstances of the particular contract.

For a lease modification that is not accounted for as a separate lease, the Group remeasures the lease liability based on the lease term of the modified lease by discounting the revised lease payments using a revised discount rate at the effective date of the modification.

The Group accounts for the remeasurement of lease liabilities by making corresponding adjustments to the relevant right-of-use asset.

When the modified contract contains a lease component and one or more additional lease or non-lease components, the Group allocates the consideration in the modified contract to each lease component on the basis of the relative stand-alone price of the lease component and the aggregate stand-alone price of the non-lease components.

就關於Covid-19疫情直接所致之租金優惠，若符合以下所有條件，本集團選擇應用可行權宜方法而非評估該等變動是否租賃修訂：

- 租賃付款之變動導致經修訂的租賃代價大致上與變動前的租賃代價相同或更少；
- 任何租賃付款之減少僅影響於二零二一年六月三十日或之前的付款；以及

- the change in lease payments results in revised consideration for the lease that is substantially the same as, or less than, the consideration for the lease immediately preceding the change;
- any reduction in lease payments affects only payments originally due on or before 30 June 2021; and
- there is no substantive change to other terms and conditions of the lease.

A lessee applying the practical expedient accounts for changes in lease payments resulting from rent concessions the same way it would account for the changes applying HKFRS 16 if the changes are not a lease modification. Forgiveness or waiver of lease payments are accounted for as variable lease payments. The related lease liabilities are adjusted to reflect the amounts forgiven or waived with a corresponding adjustment recognised in the profit or loss in the period in which the event occurs.

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets until such time as the assets are substantially ready for their intended use or sale. For properties under development for which revenue is recognised over time, the Group ceases to capitalise borrowing costs as soon as the properties are ready for the Group's intended sale.

Any specific borrowing that remains outstanding after the related asset is ready for its intended use or sale is included in the general borrowing pool for calculation of capitalisation rate on general borrowings. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

All other borrowing costs are recognised in the profit or loss in the period in which they are incurred.

獲發的政府補助金於本集團將擬用於彌補相關成本確認為開支的期間有系統地於損益確認。

與收入有關的應收政府補助金，作為對已產生開支或虧損的彌補，或為旨在給予本集團提供即時財務支援而不涉及未來相關成本，於應收期間於損益確認。該等補助金於「其他收益及其他收入」項下呈列。彌補有關開支的補助金從相關開支中扣除。

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received.

Government grants are recognised in profit or loss on a systematic basis over the periods in which the Group recognises as expenses the related costs for which the grants are intended to compensate.

Government grants related to income that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable. Such grants are presented under "other revenue and other income". Grants relating to compensation of expenses are deducted from the related expenses.

(j) Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing on the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Income and expenses items are translated at the average exchange rates for the period. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of exchange reserve (attributed to non-controlling interests as appropriate).

On the disposal of a foreign operation (that is, a disposal of the Group's entire interest in a foreign operation, or a disposal involving loss of control over a subsidiary that includes a foreign operation), all of the exchange differences accumulated in equity in respect of that operation attributable to the owners of the Company are reclassified to profit or loss.

僱員之年假權益在假期歸於僱員時確認。就員工年內提供服務而產生之年假估計負債已作出撥備。員工之產假及病假權益在休假前不會予以確認。

花紅

當有合約責任且該金額可作可靠估算時，本集團就花紅確認負債。

退休福利責任

向強制性公積金計劃(「強積金計劃」)及退休金計劃供款乃於僱員已提供服務並可享有供款時確認為開支。

本集團根據香港強制性公積金計劃條例為其受香港僱傭條例所管轄之僱員設立強積金計劃。強積金計劃乃一項定額供款計劃，其資產由獨立信託管理基金持有。

根據強積金計劃，僱主及僱員均須按僱員相關收入之5%向計劃作出供款，惟僱主供款以每月有關收入30,000港元為上限。本集團對強積金計劃之供款於產生時支銷。支付供款後本集團即再無其他付款責任。由於向強積金計劃付款時供款全數歸屬僱員，故並無強積金計劃之供款被沒收。

Annual leave

Employee entitlement to annual leave is recognised when it accrues to employees. A provision is made for the estimated liability for annual leave as a result of services rendered by employees during the year. Employee entitlements to maternity leave and sick leave are not recognised until the time of leave.

Bonuses

The Group recognises a liability for bonuses when there is a contractual obligation and the amount can be estimated reliably.

Retirement benefit obligations

Payments to the Mandatory Provident Fund Scheme (the "MPF Scheme") and pension fund schemes are recognised as an expense when employees have rendered service entitling them to the contributions.

The Group operates the MPF Scheme under the Hong Kong Mandatory Provident Fund Schemes Ordinance for those employees employed under the jurisdiction of the Hong Kong Employment Ordinance. The MPF Scheme is a defined contribution scheme, the assets of which are held in separate trustee-administered funds.

Under the MPF Scheme, the employer and its employees are each required to make contributions to the scheme at 5% of the employees' relevant income, with the employers' contributions subject to a cap of monthly relevant income of HK\$30,000. The Group's contributions to the MPF Scheme are expensed as incurred. The Group has no further payment obligations once the contributions have been paid. There are no forfeited contributions for the MPF Scheme as the contributions are fully vested to the employees upon payment to the MPF Scheme.

本集團為其澳門僱員設立定額供款退休計劃，其資產由獨立信託管理基金持有。僱主及僱員均須按僱員基本薪金之5%向計劃作出供款，供款以每月2,000澳門幣為上限。本集團之計劃供款於產生時支銷。支付供款後本集團再無其他付款責任。倘僱員於有權享有僱主供款之前退出計劃，被沒收供款將用作扣減本集團之應付供款。僱員於完成任職三年後合資格可享有僱主之計劃供款之30%。歸屬利益比率按每年10%遞增，而完成任職十年後比率達100%。

Retirement benefit obligations (Continued)

The Group operates defined contribution retirement schemes for its employees in Macau, the assets of which are held in separate trustee-administered funds. The employers and their employees are each required to make contributions to the schemes at 5% of the employees' basic salary subject to a cap of monthly contribution of MOP2,000 each. The Group's contributions to the schemes are expensed as incurred. The Group has no further payment obligations once the contributions have been paid. Where employees leave the schemes prior to the full vesting of the employers' contributions, the amount of forfeited contributions is used to reduce the contributions payable by the Group. Employees are eligible for 30% of the employer's contribution to schemes after completion of three years of service. The rate of vested benefit increases at an annual increment of 10% thereafter reaching 100% after completion of ten years of service.

Equity-settled share-based payments to employees and others providing similar services are measured at the fair value of the equity instruments at the grant date.

The fair value of the equity-settled share-based payments determined at the grant date without taking into consideration all non-market vesting conditions is expensed on a straight-line basis over the vesting period, based on the Group's estimate of equity instruments that will eventually vest, with a corresponding increase in equity under the heading of share-based payment reserve. At the end of each reporting period, the Group revises its estimate of the number of equity instruments expected to vest based on assessment of all relevant non-market vesting conditions. The impact of the revision of the original estimates, if any, is recognised in the profit or loss such that the cumulative expense reflects the revised estimate, with a corresponding adjustment to the share options reserve. For share options that vest immediately at the date of grant, the fair value of the share options granted is expensed immediately to the profit or loss.

When share options are exercised, the amount previously recognised in share-based payment reserve will be transferred to share premium. When the share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in share-based payment reserve will be transferred to retained earnings.

現時應付稅項乃按本年度應課稅溢利計算。應課稅溢利因為其他年度應課稅或應扣除之收入及開支項目及從毋須課稅或不可扣稅之項目，故與綜合收入表所報「除稅前虧損」不同。本集團之即期稅項負債乃按報告期末制定或實質上制定之稅率計算。

遞延稅項

Income tax expense represents the sum of the tax currently payable and deferred tax.

Current tax

The tax currently payable is based on taxable profit for the year. Taxable profit differs from 'loss before tax' as reported in the consolidated income statement because of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit. In addition, deferred tax liabilities are not recognised if the temporary difference arises from the initial recognition of goodwill.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries and interest in a joint venture, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments and interest are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rate (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For leasing transactions in which the tax deductions are attributable to the lease liabilities, the Group applies HKAS 12 requirements to right-of-use assets and lease liabilities separately. Temporary differences relating to right-of-use assets and lease liabilities are not recognised at initial recognition and over the lease terms due to application of the initial recognition exemption. Temporary differences arising from subsequent revision to the carrying amounts of right-of-use assets and lease liabilities, resulting from remeasurement of lease liabilities and lease modifications, that are not subject to initial recognition exemption are recognised on the date of remeasurement or modification.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied to the same taxable entity by the same taxation authority.

物業、機器及設備乃持作生產或供應貨品或服務、或作行政用途之有形資產。物業、機器及設備於綜合財務狀況表按成本減其後累計折舊及其後累計減值虧損(如有)列賬。

一項資產之成本包括其購買價及將資產達至其營運狀況及地點作擬定用途所產生之任何直接應計成本。物業、機器及設備投入運作後所產生之支出，如維修及保養，一般於產生支出期間自損益扣除。倘若可清楚顯示有關支出將令日後使用該物業、機器及設備時帶來經濟利益，支出將撥充資本，作為該項資產之額外成本。

本集團就物業之所有權權益(包括租賃土地及樓宇成分)付款時，全部代價於租賃土地及樓宇成分之間按初始確認時的相關公平價值之比例分配。倘相關付款能可靠地作出分配，租賃土地之權益乃於綜合財務狀況表呈列為物業、機器及設備項下之使用權資產。倘代價無法在相關租賃土地之非租賃樓宇成分及未分割權益間可靠地分配時，則全部物業分類為物業、機器及設備。

(m) Property, plant and equipment

Property, plant and equipment are tangible assets that are held for use in the production or supply of goods or services, or for administrative purposes. Property, plant and equipment are stated in the consolidated statement of financial position at cost less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

The cost of an asset comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use. Expenditure incurred after the property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to the profit or loss in the period in which it is incurred. In situations where it can be clearly demonstrated that the expenditure has resulted in an increase in the future economic benefits expected to be obtained from the use of the property, plant and equipment, the expenditure is capitalised as an additional cost of that asset.

When the Group makes payments for ownership interests of properties which includes both leasehold land and building elements, the entire consideration is allocated between the leasehold land and the building elements in proportion to the relative fair values at initial recognition. To the extent the allocation of the relevant payments can be made reliably, interests in leasehold land is presented as right-of-use assets under line item of property, plant and equipment in the consolidated statement of financial position. When the consideration cannot be allocated reliably between non-lease building element and undivided interest in the underlying leasehold land, the entire properties are classified as property, plant and equipment.

(o) Film rights

Film rights represent films and television drama series produced by the Group or acquired by the Group. Film rights are stated at cost less accumulated amortisation and accumulated impairment losses. The Group begins amortisation of the capitalised costs of film rights when a film is released and it begins to recognise revenue from that film.

The effect from changes in estimates is recognised on a prospective basis.

Amortisation expense is charged to profit or loss based on the proportion of actual income earned during the year to the total estimated income from the sale of film rights. The amortisation of film rights will not exceed twenty years. In the case where there is any impairment in value, the carrying amount is written down to its estimated recoverable amount.

At the end of each reporting period, both internal and external market information are considered to assess whether there is any indication that film rights are impaired. If any such indication exists, the carrying amounts of such assets are assessed and where relevant, an impairment loss is recognised to reduce the asset to its estimated recoverable amount. Such impairment losses are recognised in profit or loss.

(p) Films in progress

Films in progress represents films and televisions drama series under production and is stated at cost at the date incurred, less any identified impairment losses. Cost includes all costs associated with the production of films including remuneration for the film director, casts and production crew, costumes, insurance, makeup and hairdressing as well as rental of camera and lighting equipment. Films in progress is transferred to film rights when the film is released.

The investments are carried at amortised cost if their cash flows represent solely payments of principal and interest. All other investments that are not solely payments of principal and interest are carried at fair value.

(r) Impairment on property, plant and equipment

At the end of the reporting period, the Group reviews the carrying amounts of its property, plant and equipment and intangible assets with finite useful lives to determine whether there is any indication that these assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the relevant asset is estimated in order to determine the extent of the impairment loss (if any).

The recoverable amount is determined for the CGU or group of CGUs to which the corporate asset belongs, and is compared with the carrying amount of the relevant CGU or group of CGUs.

Recoverable amount is the higher of fair value less costs of disposal and value in use. When inventories are sold, the carrying amount of those inventories is recognised as cost of sales in the period in which the related revenue is recognised. The amount of any write-down of inventories to net realisable value and all losses of inventories are recognised as cost of sales or administrative expenses as appropriate in the period the write-down or loss occurs as appropriate. The amount of any reversal of any write-down of inventories is offset against the cost of sales in the period in which the reversal occurs.

(u) Financial instruments

Financial assets and financial liabilities are recognised when a group entity becomes a party to the contractual provisions of the instrument. All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the market place.

Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Critical judgements in applying accounting policies

The followings are the critical judgements, apart from those involving estimations, that the directors of the Company have made in the process of applying the Group's accounting policies and that have the most significant effect on the amounts recognised in the consolidated financial statements.

Classification of Sparkle Star Entertainment Limited ("Sparkle Star") as a joint venture

Sparkle Star is a limited liability company whose legal form confers separation between the parties to the joint arrangements and the company itself. Furthermore, there are no contractual arrangements or any other facts and circumstances that specify that the parties to the joint arrangements have rights to the assets and obligations for the liabilities of the joint arrangements. Accordingly, Sparkle Star is classified as a joint venture of the Group.

The directors assessed whether or not the Group has control over on *Over Profit Group* based on whether the Group has the practical ability to direct the relevant activities of *Over Profit Group* unilaterally. In making the judgement, the directors considered the Group's absolute size of holding in *Over Profit Group* and the relative size of and dispersion of the shareholdings owned by other shareholders. After assessment, the directors concluded that the Group has sufficiently dominant voting interest to direct the relevant activities of *Over Profit Group* and the Group has control over on *Over Profit Group*.

Deferred taxation on investment property

For the purposes of measuring deferred tax arising from investment property that are measured using the fair value model, the directors of the Company have reviewed the Group's investment property portfolios and concluded that the Group's investment property are not held under a business model whose objective is to consume substantially all of the economic benefits embodied in the investment property over time. Therefore, in determining the deferred taxation on investment property, the directors of the Company have determined that the presumption that the carrying amounts of investment property measured using the fair value model are recovered entirely through sale is not rebutted. For investment property located in The Republic of China (“Taiwan”), the Group is subject to capital gain tax upon disposal of the relevant investment property. The Group has not recognised deferred tax asset on change in fair value of investment property due to the unpredictability of future profit streams of the Taiwan subsidiary.

Provision of ECL for financial assets

Financial assets are assessed for ECL individually. The provision rates are based on the Group's historical default rates taking into consideration forward-looking information that is reasonable and supportable available without undue costs or effort. The Group is exposed to equity price risk through its investments in equity securities measured at FVTPL. For equity securities measured at FVTPL quoted in the Stock Exchange, the directors manage this exposure by maintaining a portfolio of investments with different risks. In addition, the Group also invested in equity security listed in the Stock Exchange without quoted market price. The management has monitored the price risk and will consider hedging the risk exposure should the need arise.

The sensitivity analyses have been determined based on the exposure to equity price risk at the end of the reporting period. 於二零二一年及二零二零年十二月三十一日，本集團面臨有關就澳門建築項目融資所取得浮息銀行借貸的現金流量利率風險。本集團之現金流量利率風險主要集中於本集團以港元列值的銀行借貸所產生的香港銀行同業拆息（「HIBOR」）。本集團旨在保持浮息借貸。本集團藉基於利率水平及展望評估任何利率變動所產生潛在影響而管控其利率風險。管理層將檢討浮息借貸比例並確保其在合理範圍內。

主要利率基準之根本性改革正在全球進行，包括以近乎無風險之替代利率取代部分銀行同業拆借利率（「IBORs」）。有關該利率基準改革對本集團風險管理策略所產生的影響及實施替代基準利率進程的詳情載列於本附註「利率基準改革」一節。

敏感度分析

(iii) Interest rate risk

At 31st December 2021 and 2020, the Group is exposed to cash flow interest rate risk in relation to variable-rate bank borrowings obtained for financing construction project in Macau. The Group's cash flow interest rate risk is mainly concentrated on the Hong Kong Interbank Offered Rate ("HIBOR") arising from the Group's HK\$ denominated bank borrowings. The Group aims at keeping borrowings at variable rates. The Group manages its interest rate exposures by assessing the potential impact arising from any interest rate movements based on interest rate level and outlook. The management will review the proportion of borrowings in floating rates and ensure they are within reasonable range.

A fundamental reform of major interest rate benchmarks is being undertaken globally, including the replacement of some Interbank Offered Rates ("IBORs") with alternative nearly risk-free rates. Details of the impacts on the Group's risk management strategy arising from the interest rate benchmark reform and the progress towards implementation of alternative benchmark interest rates are set out under "interest rate benchmark reform" section in this note.

Sensitivity analysis

The sensitivity analysis below has been determined based on the exposure to interest rates for non-derivative instruments at the end of each reporting period. The analysis is prepared assuming the financial instruments outstanding at the end of the reporting period were outstanding for the whole year. A 25 basis points increase or decrease is used when reporting interest rate risk internally to key management personnel and represents management's assessment of the reasonably possible change in interest rates. If interest rates had been 25 basis points higher/lower and all other variables were held constant, the Group's interests capitalised to stock of properties for the year ended 31st December 2021 would increase/decrease by approximately HK\$3,697,000 (2020: HK\$3,235,000).

本集團之信貸風險主要歸因於提供予一名董事之貸款、貿易應收賬款、按金及其他應收款項、應收一間合資企業款項、定期存款及銀行結餘。於二零二一年及二零二零年十二月三十一日，因交易對方未能履行責任而可為本集團帶來財務虧損為本集團最大信貸風險，乃來自綜合財務狀況表所列各項已確認金融資產之賬面值。本集團並無持有任何抵押品或其他信貸增強措施以為其金融資產有關之信貸風險提供保障，惟與提供予一名董事之貸款有關的信貸風險已予減輕，因為該筆提供予一名董事之貸款乃以陳女士全資擁有於英屬處女群島（「英屬處女群島」）註冊成立之公司 Reform Base Holdings Limited（「Reform Base」）全部已發行股本的股份押記作為抵押。

為將信貸風險降至最低，管理層已委派一個團隊負責釐定信貸限額、信貸批准及其他監管程序，以確保採取行動追收逾期貸款。此外，本集團就金融資產個別進行預期信貸虧損模式下的減值評估。就此而言，董事認為本集團之信貸風險已大幅降低。

Credit risk and impairment assessment

The Group's credit risk is primarily attributable to loan to a director, trade receivables, deposits and other receivables, amount due from a joint venture, time deposits and bank balances. At 31st December 2021 and 2020, the Group's maximum exposure to credit risk, which will cause a financial loss to the Group due to failure to discharge an obligation by the counterparties arising from the carrying amounts of the respective recognised financial assets as stated in the consolidated statement of financial position. The Group does not hold any collateral or other credit enhancements to cover its credit risks associated with its financial assets, except that the credit risks associated with loan to a director is mitigated because loan to a director is secured by way of a share charge over the entire issued share capital of Reform Base Holdings Limited ("Reform Base"), a company incorporated in the British Virgin Islands (the "BVI") and wholly owned by Ms. Chen.

In order to minimise the credit risk, the management has delegated a team responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In addition, the Group performs impairment assessment under ECL model on financial assets individually. In this regard, the directors consider that the Group's credit risk is significantly reduced.

The Group applies simplified approach to measure lifetime ECL for trade receivables on an individual basis. The directors assessed customers' ability to settle the receivables based on historical default experience. Trade receivables with gross carrying amount of HK\$2,044,000 (2020: HK\$290,000) are due from customers that have good track record with the Group, the directors conclude that the credit risk attributable to these customers is low and allowance for ECL of HK\$46,000 (2020: Nil) was recognised with expected average loss rate of 2.25% (2020: Nil). The directors considered that trade receivables with gross carrying amount of HK\$640,000 was credit-impaired and allowance for ECL was fully provided as at 31st December 2021 and 2020.

The Group assessed the ECL for deposits and other receivables individually. The expected loss rate was determined by reference to past default experience and have been adjusted to reflect current and forward-looking information on macroeconomic factors that affecting the ability of settlement. The directors concluded that there is no significant increase in credit risk of these amounts since initial recognition and the Group provided impairment based on 12m ECL. The Group had advanced a loan to a director and considered the credit risk is limited since the borrower has an appropriate credit history and good reputation. The directors concluded that there is no significant increase in credit risk of these amounts since initial recognition and the Group provided impairment based on 12m ECL. Credit risk associated with loan to a director is also mitigated by way of a share charge over the entire issued share capital of Reform Base which holds indirect interest in a property located in Macau. Hence, the Group assessed the 12m ECL for loan to a director is insignificant and no allowance for ECL was recognised.

The Group regularly monitors the business performance of the joint venture. The Group's credit risks in these balances are mitigated through the power to participate or jointly control the relevant activities of the entity. The management believes that there is no significant increase in credit risk of these amounts since initial recognition and the Group provided impairment based on 12m ECL. During the year ended 31st December 2021, the Group assessed the ECL for amount due from a joint venture is insignificant and no allowance for ECL was recognised.

Credit risk on time deposits and bank balances is limited because the counterparties are reputable banks with high credit ratings. The Group assessed 12m ECL for time deposits and bank balances to be insignificant and no allowance for ECL was recognised.

Liquidity risk

The Group manages liquidity risk by maintaining adequate cash and cash equivalents, monitoring forecast and actual cash flows and matching the maturity profiles of financial assets and financial liabilities.

The liquidity risk is under continuous monitoring by the management. Reports with maturity dates of bank borrowings and thus the liquidity requirements are provided to management for review periodically. Management will raise or refinance bank borrowings whenever necessary.

At 31st December 2021, the Group has available unutilised banking facilities of HK\$121,150,000 (2020: HK\$306,120,000).

The following table shows details of the Group's remaining contractual maturity for its non-derivative financial liabilities. The tables have been drawn up based on the undiscounted cash flows of financial liabilities based on the earliest date on which the Group can be required to pay. Interest rate benchmark reform

The management reports the findings to the directors at the end of each reporting period to explain the cause of fluctuations in fair value of the asset.

- Level 3 valuations: fair value measured using significant unobservable inputs.

The Bill was signed into law on 28th March 2018 and was gazetted on the following day. Under the two-tiered profits tax rates regime, the first HK\$2 million of profits of the qualifying group entity will be taxed at 8.25%, and profits above HK\$2 million will be taxed at 16.5%. The profits of group entities not qualifying for the two-tiered profits tax rates regime will continue to be taxed at a flat rate of 16.5%.

The directors considered the amount involved upon implementation of the two-tiered profits tax rates regime as insignificant to the consolidated financial statements. Hong Kong Profits Tax is calculated at 16.5% of the estimated assessable profit for both years.

No provision for Hong Kong Profits Tax has been made for the year ended 31st December 2021 and 2020 as the Group has no assessable profits arising in Hong Kong or taxable profits were wholly absorbed by estimated tax losses brought forward.

Contributions to the MPF Scheme vest immediately upon the completion of the services in the relevant service period.

Under other defined contribution retirement schemes, the employers and their employees are required to make contributions to the schemes at 5% of the employees' basic salary subject to a cap of monthly contribution of MOP2,000 each. Where employees leave the schemes prior to the full vesting of the employers' contributions, the amount of forfeited contributions is used to reduce the contributions payable by the Group.

Contributions totaling HK\$40,000 were forfeited and utilised during the year ended 31st December 2021 to reduce contributions paid by the Group and no forfeited contribution was available at 31st December 2021.

At 31st December 2020, there was no forfeited contribution under any defined contribution schemes available which may be used by the Group to reduce the existing level of contributions, nor any contribution under any defined contribution schemes was forfeited by the Group during the year.

由於澳門政府延誤批出位於外港填海區第6B地段（「第6B地段」）之物業的發展所需批文及許可，導致第6B地段不能開始發展而澳門政府更開始收回土地之行政工作。第6B地段為一個發展中項目中的四個地段之一，而第6B地段擬發展為一個休閒區。本集團已於二零一六年十二月三十日向澳門中級法院院長提出上訴。於二零一八年六月十一日，本集團收到澳門政府終審法院日期為二零一八年六月八日的函件，當中終審法院駁回最終上訴的申請。因此，第6B地段將由澳門政府收回。根據本公司取得的法律意見，本集團具法律理據就本集團蒙受的損害尋求賠償。由於第6B地段擬發展為休閒區而澳門政府已批准其他3個地段的發展計劃，本集團認為難以支撐蒙受損害之說。

於二零二一年及二零二零年十二月三十一日，董事參考獨立合資格專業估值師行第一太平戴維斯（澳門）有限公司及捷評資產所進行估值而評估物業存貨之可變現淨值，並論定其可變現淨值高於其賬面值，故認為沒必要就物業存貨之賬面值作出撇減。

In September 2013, the Macau Government promulgated the Macau New Land Law (the “MNLL”) which came into effect in March 2014. The MNLL provides that the Macau Government will have the right to resume the land of any property development that is not completed and/or where the conditions as stated in the land concession for which have not been fulfilled by the stipulated expiry date without any compensation to the property owner.

Owing to the delays caused by the Macau Government in granting the requisite approvals and permits for the development of the property located in Lot 6B at Zona de Aterros do Porto Exterior (ZAPE) (“Lot 6B”), Lot 6B could not commence development and the Macau Government has started the administrative work to reclaim it. Lot 6B is one of the four lots of land in a project held under development and Lot 6B is intended to be developed as recreational area. The Group has filed an appeal to the president of the Macau Second Instance Court on 30th December 2016. On 11th June 2018, the Group received a letter dated 8th June 2018 from the Tribunal de Ultima Instancia of the Macau Government, in which the Tribunal de Ultima Instancia rejected the application of the final appeal. Accordingly, Lot 6B will be reclaimed by the Macau Government. According to the legal opinion obtained by the Company, the Group has legal ground to seek compensation for damages sustained by the Group. As Lot 6B is intended to develop as recreational area and the Macau Government has approved the development plan of the other 3 lots of land, the Group considers that it is difficult to sustain its damages incurred.

At 31st December 2021 and 2020, the directors had assessed the net realisable value of the stock of properties with reference to valuations performed by Savills (Macau) Limited and JP Assets, firms of independent qualified professional valuers, and concluded that no write-down of carrying amounts of the stock of properties are considered necessary as the net realisable value are greater than the carrying amounts.
