




Total revenue from pawn loan business 典當貸款業務之總收益




Profit attributable to equity shareholders 權益股東應佔溢利




Net profit margin 純利率

Operating profit margin 經營溢利率




Return on total assets 資產總額回報




Return on shareholders' equity 股東權益回報




Net interest margin - mortgage loans 淨息差-按揭抵押貸款




Gross mortgage loan receivables 應收按揭抵押貸款總額




Net interest margin - pawn loans 淨息差-典當貸款

Chairman Statement 主席報告

On behalf of the board of directors (the "**Board**") of Oi Wah Pawnshop Credit Holdings Limited (the "**Company**" or "**our Company**"), and its subsidiaries (together with the Company collectively referred to as the "**Group**" or "**our Group**"), I am delighted to present the annual report of the Group for the year ended 28 February 2022 ("**FY2022**").

During the year, the Group recorded revenue and profit attributable to shareholders of the Company of approximately HK\$152.0 million and 71.7 million respectively. In FY2022, while local mortgage loan demand continued to be affected by the prolonged pandemic and cross-border travel restriction, we saw a stable growth in pawn loan business due to the rebounding luxury consumer market. We will continue to deploy this two-pronged business approach to build a solid firewall and protect us from any major downward risks.

Looking ahead, given the macro-economy variables and geopolitical risks, the Group will continue to adopt a prudent strategy when granting loans, in order to maintain a healthy portfolio and strengthen its risk management measures. We will also keep a close eye on the performance of the Group's loan portfolio, especially in respect to the repayment status of existing customers. With COVID-19 eases off, the Group sees opportunities with the impending rebound of economy is well positioned to capture the opportunity to expand its market share when business activities pick up again. Being one of the few listed financial institutions in Hong Kong, we believe Oi Wah is in a strong position to benefit.

On behalf of the Board, I would like to express my heartfelt gratitude to the unremitting efforts of our management team and employees. I also wish to offer sincere thanks to our customers and shareholders for their continuing loyalty and trust. We will continue to explore and seize the new business opportunities to further create value for our shareholders in the long run.

Management Discussion and Analysis

BUSINESS REVIEW

Oi Wah Pawnshop Credit Holdings Limited (the "**Company**" or "**our Company**"), and its subsidiaries (together with the Company collectively referred to as the "**Group**" or "**our Group**") is a financing service provider in Hong Kong operating under the brand name of "Oi Wah", principally engaged in providing secured financing, including mortgage loans and pawn loans.

MORTGAGE LOAN BUSINESS

For the year ended 28 February 2022 ("FY2022"), Hong Kong market continued to be affected by the closure of major border crossings with the on-going COVID-19 pandemic, thus a full recovery of business and investment activities was constrained, and local loan demand remained softened. The interest income of the mortgage loan business of the Group decreased by approximately HK\$35.9 million or 30.3% from approximately HK\$118.6 million for the year ended 28 February 2021 ("FY2021") to approximately HK\$82.7 million in FY2022, which accounted for approximately 54.4% of the Group's total revenue. The gross mortgage loan receivables was approximately HK\$726.3 million as at 28 February 2022 with the total new mortgage loans granted amounted to approximately HK\$428.5 million in FY2022. During the year, net interest margin of the mortgage loan business slightly decreased by approximately 0.1% to approximately 9.9% (FY2021: approximately 10.0%). During the year, there were 100 new cases of mortgage loan transactions, with average loan size of approximately HK\$4.3 million.

業務回顧

靄華押業信貸控股有限公司(「本公司」)及其附屬公 司(連同本公司統稱「本集團」)為以「靏華」品牌名 稱在香港經營之融資服務供應商,主要從事提供有抵 押融資(包括按揭抵押貸款及典當貸款)業務。

按揭抵押貸款業務

截至二零二二年二月二十八日止年度(「**二零二二年** 財政年度」),香港市場繼續受2019冠狀病毒病疫情 持續導致主要邊境口岸關閉影響,故業務及投資活動 全面復甦受到限制,且本地貸款需求仍然疲弱。本集 團按揭抵押貸款業務的利息收入由截至二零二一年 二月二十八日止年度(「**二零二一年財政年度**」)的約 118,600,000港元減少約35,900,000港元或30.3%至 二零二二年財政年度的約82,700,000港元,佔本集 團總收益的約54.4%。於二零二二年二月二十八日, 應收按揭抵押貸款總額約為726,300,000港元,於二 零二二年財政年度新批出的按揭抵押貸款總額約為 428,500,000港元。年內,按揭抵押貸款總額約為 428,500,000港元。年內,按揭抵押貸款業務的淨息差 輕微減少約0.1%至約9.9%(二零二一年財政年度: 約10.0%)。年內,本集團共錄得100宗新造按揭抵押 貸款交易,平均貸款金額約為4,300,000港元。

In FY2022, given the US rate hike and its potential impacts on local property market, the Group continued to adopt a prudent and cautious approach when granting loans, as well as maintaining a higher proportion of first mortgage loans in the Group's portfolio to mitigate risk. The loan-to-value ratio for the first mortgage is approximately 52.4%, while overall loan-tovalue ratio for subordinary mortgage is approximately 58.5%, of which, loan-to-value ratio of subordinary mortgage that the Group participate in is approximately 5.4% in FY2022.

PAWN LOAN BUSINESS

In FY2022, the revenue from the pawn loan business increased from approximately HK\$64.2 million to approximately HK\$69.3 million, representing an increase of approximately 7.9% or HK\$5.1 million, with interest income from pawn loan receivables and gain from disposal of repossessed assets of approximately HK\$60.2 million and HK\$9.1 million respectively, thanks to the growing luxury goods market that led to an increase of pawn loan size. The aggregate pawn loan amount granted increased by approximately 19.7% or HK\$130.2 million from approximately HK\$660.9 million in FY2021 to approximately HK\$791.1 million in FY2022.

During the year, the Group continued to channel resources to advertising and promotion to enhance the Group's brand exposure. Such effort has generated demand for one-to-one pawn loan appointment services for pawn loans exceeding HK\$0.1 million. The number of pawn loan transactions granted of such amount increased from 437 transactions in FY2021 to 497 transactions in FY2022. The average loan amount also increased to approximately HK\$11,700 per transaction (FY2021: HK\$10,200 per transaction).

INDUSTRY OVERVIEW

Solid gold price, coupled with the continued recovery of luxury goods market during the year, has lent a strong support to the Group's pawn loan business.

On the other hand, private home prices in Hong Kong has seen a bounce back and edged close to the historical peak despite the spread of Omicron variant, with prices going up 3.3% in 2021 according to an index published by the Rating and Valuation Department. However, in order to put a damper on inflation, the US Fed's ongoing interest rate increase and its plan of balance sheet reduction to put a damper on inflation have marked the end of the era of low interest rates and cheap money. Although the HKD interbank rates may not necessarily rise with the US dollar interest rates immediately, the Board is of the view that property market which is interest sensitive will remain largely uncertain in the coming year. Therefore, the Group will remain cautious of the valuation of properties when granting loans, in order to mitigate risks. 於二零二二年財政年度,鑑於美國加息及其對本地物 業市場的潛在影響,本集團於發放貸款時繼續採取審 慎嚴謹之策略,並於本集團的組合中維持高比例之第 一按揭抵押貸款以減低風險。第一按揭之貸款對估值 比率約為52.4%,而次級按揭之整體貸款對估值比率 則約為58.5%,其中於二零二二年財政年度本集團經 手之次級按揭之貸款對估值比率約為5.4%。

典當貸款業務

二零二二年財政年度, 典當貸款業務的收益由約 64,200,000港元增加約7.9%或5,100,000港元至約 69,300,000港元, 其中應收典當貸款之利息收入及 出售經收回資產之收益分別約為60,200,000港元及 9,100,000港元, 此乃由於奢侈品市場增長導致典 當貸款規模增加。已批出典當貸款總額由二零二一 年財政年度的約660,900,000港元增加約19.7% 或130,200,000港元至二零二二年財政年度的約 791,100,000港元。

年內,本集團繼續投放資源於廣告及宣傳以提升本集 團之品牌曝光度,成功帶動對100,000港元以上典當 貸款之一對一典當貸款預約服務需求。獲得有關金額 的典當貸款交易數量由二零二一年財政年度的437宗 增加至二零二二年財政年度的497宗。平均貸款金額 亦增加至每宗交易約11,700港元(二零二一年財政年 度:每宗交易10,200港元)。

行業回顧

金價穩定加上年內奢侈品市場持續復甦,成為本集團 典當貸款業務的強大後盾。

另一方面,儘管Omicron變種病毒擴散,香港私人住 宅價格反彈及貼近歷史高位,根據差餉物業估價署發 佈的指數,價格於二零二一年上升3.3%。然而,為 遏制通脹,美國聯儲局持續加息及遏制通脹縮表計劃 為低息環境及低息貸款劃上句號。儘管香港銀行同業 拆息未必即時與美元利率一同上升,惟董事會認為物 業市場對利息敏感,於下一年度將仍相當不穩定。故 此,本集團授出貸款時將繼續審慎考慮物業估值,以 減低風險。

FINANCIAL REVIEW

Revenue

Our Group's revenue reduced from approximately HK\$182.8 million for the FY2021 to approximately HK\$152.0 million for the FY2022, representing a decrease of approximately HK\$30.8 million or 16.8%. The decrease was attributable to the decrease in our interest income from mortgage business by approximately HK\$35.9 million or 30.3% from approximately HK\$118.6 million in FY2021 to approximately HK\$82.7 million in FY2022, netting off the increase in our revenue from pawn loan business by approximately HK\$5.1 million or 7.9% from approximately HK\$64.2 million in FY2021 to approximately HK\$69.3 million in FY2022.

Mortgage loan business

The decrease in our interest income from mortgage business was mainly due to the fact that under the global outbreak of the COVID-19 pandemic, the Group has adopted a cautious approach in granting our mortgage loan during FY2022. Moreover, as most of our customers are SMEs, they preferred to reduce their debt equity ratio in this gloominess situation. As such, the average month end balance for the gross mortgage loans receivables for the year decreased from approximately HK\$992.5 million in FY2021 to approximately HK\$713.1 million in FY2022 with total new mortgage loans granted of approximately HK\$428.5 million during FY2022 (FY2021: approximately HK\$392.1 million).

Pawn loan business

The increase in our pawn loan business was due to the increase in our interest income earned on our pawn loan receivables by approximately HK\$4.0 million or 7.1% from approximately HK\$56.2 million in FY2021 to approximately HK\$60.2 million in FY2021 and the increase in revenue from disposal of repossessed assets by approximately HK\$1.1 million.

The increase in our interest income earned on our pawn loan receivables was mainly attributable to (i) the increase in the price of second-hand brand watches; and (ii) a new customer was found through our network in December 2021 which the Group have provided a revolving loan to this customer amounted to HK\$40.0 million (As at 28 February 2022: HK\$17.1 million was utilised). Therefore, the aggregated amounts of pawn loan granted increased from approximately HK\$660.9 million in FY2021 to approximately HK\$791.1 million in FY2022 and the average month end balance for the gross pawn loans receivables for the year increased from approximately HK\$139.6 million in FY2021 to approximately HK\$153.8 million in FY2022.

財務回顧

收益

本集團收益由二零二一年財政年度約182,800,000 港元減少約30,800,000港元或16.8%至二零二二年 財政年度約152,000,000港元。該減幅乃由於本集團 按揭抵押業務之利息收入由二零二一年財政年度約 118,600,000港元減少約35,900,000港元或30.3% 至二零二二年財政年度約82,700,000港元,並扣除 典當貸款業務所得收益由二零二一年財政年度約 64,200,000港元增加約5,100,000港元或7.9%至二零 二二年財政年度約69,300,000港元。

按揭抵押貸款業務

本集團按揭抵押業務所得利息收入減少主要由於全 球爆發2019冠狀病毒病疫情,本集團於二零二二年 財政年度發放按揭抵押貸款時謹慎行事所致。此外, 我們的大部分客戶為中小企業,彼等傾向於不景氣 的情況下減少其負債權益比。因此,年內之應收按揭 抵押貸款總額平均月終結餘由二零二一年財政年度 約992,500,000港元減少至二零二二年財政年度約 713,100,000港元,二零二二年財政年度已發放新按 揭抵押貸款總額則約為428,500,000港元(二零二一 年財政年度:約392,100,000港元)。

典當貸款業務

本集團典當貸款業務增加乃由於本集團應收典當貸款 所得利息收入由二零二一年財政年度約56,200,000港 元增加約4,000,000港元或7.1%至二零二二年財政年 度約60,200,000港元及出售經收回資產之收益增加約 1,100,000港元。

本集團應收典當貸款所得利息收入增加乃主要歸因於 (i)二手品牌手錶價格上升:及(ii)於二零二一年十二月 透過網絡獲得一名新客戶,本集團向該客戶提供循環 貸款40,000,000港元(於二零二二年二月二十八日: 17,100,000港元已使用)。因此,已發放典當貸總額 由二零二一年財政年度約660,900,000港元增加至二 零二二年財政年度約791,100,000港元,而該年度應 收典當貸款總額的平均月終結餘則由二零二一年財政 年度約139,600,000港元增加至二零二二年財政年度 約153,800,000港元。

Revenue from disposal of repossessed assets represents the gain/ (loss) of the Group as we sold the repossessed assets in the event of default in repayment of our pawn loans. The increase in our gain on disposal of repossessed assets in FY2022 was mainly due to the increase in the price of second-hand brand watches. Since every pawn loan has a loan term of four lunar months, revenue was derived from the appreciation of the price of secondhand brand watches in FY2022 and thus the increase in gain on disposal of repossessed assets in FY2022 was recorded.

Other income, gains or losses

Other income decreased from approximately HK\$7.9 million in FY2021 to approximately HK\$3.0 million in FY2022, representing an decrease of approximately HK\$4.9 million or 62.0%, which was mainly due to (i) the receipt of a one-off subsidy from The Government of the Hong Kong Special Administrative Region under the Anti-Epidemic Fund for relieving financial burdens of the businesses of approximately HK\$2.1 million in FY2021 and no such income in FY2022; (ii) a decrease in our credit related fee income by approximately HK\$0.9 million representing early repayment fees and handling charges from our mortgage loan customers; (iii) a decrease in rental income by approximately HK\$1.3 million; netting off with the increase in rent concession received from landlord due to COVID-19 of approximately HK\$0.3 million.

Operating expenses

Operating expenses decreased by approximately HK\$1.0 million or 1.8% from approximately HK\$55.6 million in FY2021 to approximately HK\$54.6 million in FY2022.

During FY2022, staff costs slightly increased by approximately HK\$0.4 million or 1.4% from approximately HK\$29.1 million in FY2021 to approximately HK\$29.5 million in FY2022. The increase was mainly contributed by the increase in the salaries and other benefits to staff of approximately HK\$0.3 million.

According to HKFRS 16, all operating lease with contract terms more than 1 year should be treated as finance lease. Thus, the contractual liabilities for the rental agreements are discounted and recognised as finance lease assets. Rental expenses and depreciation for right-to-use assets remained stable at approximately HK\$13.2 million in FY2021 and FY2022.

Apart from staff costs, rental expenses and depreciation for right-to-use assets as mention above, other operating expenses decreased by approximately HK\$1.4 million or 10.5% from approximately HK\$13.3 million in FY2021 to approximately HK\$11.9 million in FY2022. This was mainly due to the decrease in advertising expenses and legal and professional fees by approximately HK\$0.4 million and HK\$0.9 million respectively.

出售經收回資產之收益指本集團於典當貸款出現拖欠 還款之情況時出售經收回資產之收益/(虧損)。本 集團於二零二二年財政年度出售經收回資產之收益增 加乃主要由於二手品牌手錶價格上升。由於每項典當 貸款之貸款期限為四個農曆月,而二零二二年財政年 度二手品牌手錶價格升值帶動收益,故本集團於二零 二二年財政年度錄得出售經收回資產收益增加。

其他收入、收益或虧損

其他收入由二零二一年財政年度約7,900,000港元減 少約4,900,000港元或62.0%至二零二二年財政年度 約3,000,000港元,乃主要由於(i)二零二一年財政年度 收到香港特別行政區政府在抗疫基金下為減輕企業財 務負擔而提供的一次性補貼約2,100,000港元,而二 零二二年財政年度並無有關收入;(ii)本集團信貸相關 費用收入減少約900,000港元,為提前支付費用及向 按揭抵押貸款客戶收取的手續費;(iii)租金收入減少約 1,300,000港元,扣除因2019冠狀病毒病而獲得業主 的租金寬減增加約300,000港元。

經營開支

經營開支由二零二一年財政年度約55,600,000港元減 少約1,000,000港元或1.8%至二零二二年財政年度約 54,600,000港元。

於二零二二年財政年度,員工成本由二零二一年財 政年度約29,100,000港元輕微增加約400,000港元 或1.4%至二零二二年財政年度約29,500,000港元。 該增幅乃主要歸因於員工薪金及其他福利增加約 300,000港元。

根據香港財務報告準則第16號,所有合約期超過一年的經營租賃應被視為融資租賃。因此,租賃協議之合約負債獲貼現並確認為融資租賃資產。使用權資產之租金開支及折舊於二零二一年財政年度及二零二二年財政年度穩定維持於約13,200,000港元。

除了上述員工成本、租金開支及使用權資產折舊,其 他經營開支由二零二一年財政年度約13,300,000港元 減少約1,400,000港元或10.5%至二零二二年財政年 度約11,900,000港元。此乃主要由於廣告開支以及法 律及專業費用分別減少約400,000港元及900,000港 元所致。

Finance costs

During the year, the finance costs decreased by approximately HK\$8.5 million or 40.7% from approximately HK\$20.9 million in FY2021 to approximately HK\$12.4 million in FY2022. It was mainly due to the decrease in bank loans and overdrafts, other loans and debt securities issued in FY2022.

Charged for impairment losses on loan receivables *For FY2022*

The charge for impairment losses on loan receivables of approximately HK\$2.3 million in FY2022 was measured based on the requirement under HKFRS 9. The charge for impairment losses represented a further impairment made to a mortgage loan (same mortgage loan impaired in FY2021) which had been overdue for more than 1 year and management considered that the valuation of the collateral of the respective loan cannot fully cover the outstanding amount and the said loan had been written-off during the year.

For FY2021

The charge for impairment losses on loan receivables of approximately HK\$2.0 million in FY2021 was measured based on the requirement under HKFRS 9. The charge for impairment losses represented a further impairment made to a mortgage loan (same mortgage loan impaired in previous years) which had been overdue for more than 1 year and the management considered there is an increasing possibility which the valuation of the collateral of the respective loan cannot fully cover the outstanding amount.

Income tax expenses

Our Group's effective tax rate decreased from approximately 16.9% in FY2021 to approximately 16.3% in FY2022. The decrease was mainly due to additional assessment amounted of approximately HK\$1.0 million charged in FY2021 and no such expenses in FY2022.

Profit and total comprehensive income for the year

Our Group's profit for FY2022 decreased to approximately HK\$71.7 million from approximately HK\$93.1 million in FY2021, representing a decrease of approximately HK\$21.4 million or 23.1%. The decrease was mainly attributable to the decrease in revenue and other revenue by approximately HK\$30.8 million and HK\$4.9 million respectively, netting off with the decrease in finance costs amounted to approximately HK\$8.5 million.

融資成本

於年內,融資成本由二零二一年財政年度約 20,900,000港元減少約8,500,000港元或40.7%至二 零二二年財政年度約12,400,000港元。該減幅乃主要 由於二零二二年財政年度的銀行貸款及透支、其他貸 款及已發行債務證券減少。

扣除應收貸款之減值虧損 *二零二二年財政年度*

二零二二年財政年度扣除應收貸款之減值虧損約 2,300,000港元乃基於香港財務報告準則第9號項下之 規定計量。扣除減值虧損乃指對一筆逾期1年以上之 按揭抵押貸款(於二零二一年財政年度進行減值之相 同按揭抵押貸款)所作之進一步減值。管理層認為各 份貸款抵押品之估值未能悉數抵償未償還金額及上述 貸款於年內撇銷。

二零二一年財政年度

二零二一年財政年度扣除應收貸款之減值虧損約 2,000,000港元乃基於香港財務報告準則第9號項下 之規定計量。扣除減值虧損乃指對一筆逾期1年以上 之按揭抵押貸款(於過往年度進行減值之相同按揭抵 押貸款)所作之進一步減值,乃因管理層認為各份貸 款抵押品之估值未能悉數抵償未償還金額之可能性增 加。

所得税開支

本集團之實際税率由二零二一年財政年度約16.9%減 少至二零二二年財政年度約16.3%。減少的主要原因 是二零二一年財政年度扣除額外評税約1,000,000港 元及二零二二年財政年度概無有關開支。

年內溢利及全面收入總額

本集團於二零二二年財政年度之溢利由二零二一年財政年度約93,100,000港元減少約21,400,000港元或23.1%至約71,700,000港元。該減幅乃主要歸因於經扣除融資成本減少約8,500,000港元後之收益及其他收益分別減少約30,800,000港元及4,900,000港元。

Management Discussion and Analysis

Liquidity and financial resources

The Group adopts a prudent funding and treasury policy and maintained a healthy financial position during FY2022. During FY2022, the Group's operational and capital requirements were financed principally through retained earnings, bank loans and overdrafts, loans from the immediate holding company, other loans and debt securities issued. Throughout FY2022, there was no material or significant impact of COVID-19 on the Group's liquidity and financial resources with reference to the operations and capital commitments.

As at 28 February 2022, all outstanding interest-bearing bank loans and overdrafts were repayable in one year and bore interest at variable rates. The bank loans and overdrafts were secured by (i) a sub-mortgage charge on certain loans receivable of a subsidiary of the Company; and/or (ii) a corporate guarantee executed by the Company. During FY2022, the Group had fulfilled all the financial covenants, if any, under the Group's banking facilities.

As at 28 February 2022, the loans from immediately holding company were repayable in one year and bore interest at 5% per annum. The loans were secured by a corporate guarantee executed by the Company.

As at 28 February 2022, the debt securities issued bore interest at 6% to 7%. Except for amounted to approximately HK\$50.0 million were repayable in one year, the remaining were repayable over one year but less than five years.

Based on the Group's current and anticipated levels of operation, the Group's future operations and capital requirements will be mainly financed through bank loans and overdrafts, loans from the immediate holding company, other loans, retained earnings and share capital. There were no significant commitments for capital expenditure as at 28 February 2022.

流動資金及財務資源

於二零二二年財政年度,本集團採取審慎的資金及財 務政策及維持健康的財務狀況。於二零二二年財政年 度,本集團之營運及資本規定主要透過保留盈利、銀 行貸款及透支、直屬控股公司之貸款、其他貸款及已 發行債務證券撥付資金,其中參考營運及資本承擔。

於二零二二年二月二十八日,所有尚未償還的計息銀 行貸款及透支須於一年內償還並按浮動利率計息。銀 行貸款及透支以下列項目作抵押:(i)本公司一間附屬 公司若干應收貸款的次級按揭押記;及/或(ii)本公司 簽立的公司擔保。於二零二二年財政年度,本集團已 履行本集團銀行信貸下的所有財務契約(如有)。

於二零二二年二月二十八日,直接控股公司貸款須於 一年內償還及按年利率5%計息。有關貸款由本公司 簽訂的公司擔保作抵押。

於二零二二年二月二十八日,所發行的債務證券按 6%至7%的利率計息。除須於一年內償還的約50.0百 萬港元外,餘下須於一年後但五年內償還。

按照本集團目前及預期營運水平,本集團之日後營運 及資本規定將主要透過銀行貸款及透支、直屬控股公 司之貸款、其他貸款、保留盈利及股本撥付資金。於 二零二二年二月二十八日,概無重大資本開支承擔。

As at 28 February 2022, cash and cash equivalents (net of bank overdraft) amounted to approximately HK\$206.6 million, representing a net decrease of approximately HK\$38.7 million as compared to the position as at 28 February 2021. The decrease was attributable to the following items:

Current ratio

Our Group's current ratio increased from approximately 6.5 times as at 28 February 2021 to approximately 8.9 times as at 28 February 2022, which was mainly due to the decrease in other loans, bank loans and overdrafts and current portion of debt securities issued that were amounted to approximately HK\$23.3 million, HK\$2.7 million and HK\$25.0 million respectively.

Gearing ratio

Our Group's gearing ratio decreased from approximately 26.2% as at 28 February 2021 to approximately 15.0% as at 28 February 2022, which was mainly triggered by the decrease in other loans, bank loans and overdrafts and debt securities issued which were amounted to approximately HK\$23.3 million, HK\$2.7 million and HK\$75.0 million respectively as a result of the decrease of our mortgage loan portfolio.

Return on total assets and return on equity

Our return on total assets decrease from approximately 7.6% in FY2021 to 6.2% in FY2022. The decrease was mainly attributable to the decrease in our revenue in mortgage business by approximately HK\$35.9 million in FY2022 as the management adopted a prudent strategy on mortgage business during FY2022.

Our return on equity decreased from approximately 9.8% in FY2021 to approximately 7.3% in FY2022. This was mainly due to the decrease in gearing ratio during FY2022. In view of the current volatile market conditions, the management of the Company decided to adopt a prudent strategy in granting new loans and thus less funding was required during FY2022. This led to a drop in the Group's borrowings and thereby limited the available funds of the Group to lend to our customers. As such, the Group's return on equity decreased in FY2022 notwithstanding the positive net interest margin of the Group.

Net profit margin and net interest margin

There was an increase in our net interest margin from approximately 13.7% in FY2021 to approximately 15.0% in FY2022. The reason for such an increase was mainly due to the decrease in finance cost by approximately HK\$8.5 million during FY2022.

There was a decrease in our net profit margin from approximately 51.0% in FY2021 to approximately 47.2% in FY2022. The reason for the decrease was mainly due to the decrease in our revenue in mortgage business by approximately HK\$35.9 million in FY2022.

流動比率

本集團流動比率由二零二一年二月二十八日約6.5倍 上升至二零二二年二月二十八日約8.9倍,乃主要由 於其他貸款、銀行貸款及透支以及已發行債務證券的 即期部分均有所減少,分別為數約23,300,000港元、 2,700,000港元和25,000,000港元。

借貸比率

本集團借貸比率由二零二一年二月二十八日約26.2% 下降至二零二二年二月二十八日約15.0%,乃主要由 於其他貸款、銀行貸款及透支以及已發行債務證券均 有所減少,分別為數約23,300,000港元、2,700,000港 元和75,000,000港元,主要由於按揭抵押貸款組合減 少。

資產總額回報及權益回報

本集團資產總額回報由二零二一年財政年度約7.6% 減少至二零二二年財政年度之6.2%。減少乃主要 由於按揭業務收益於二零二二年財政年度減少約 35,900,000港元,因為管理層於二零二二年財政年度 對按揭業務採取審慎策略。

本集團權益回報由二零二一年財政年度約9.8%減少 至二零二二年財政年度約7.3%。此乃主要由於二零 二二年財政年度之借貸比率下降所致。鑑於目前市況 動盪,本公司管理層決定於發放新貸款時採取審慎策 略,故二零二二年財政年度所需資金較少。此舉導致 本集團之借貸下跌,限制了本集團可借予客戶之資 金。因此,儘管本集團之淨息差錄得正數,惟本集團 權益回報於二零二二年財政年度減少。

純利率及淨息差

淨息差由二零二一年財政年度的約13.7%上升至二零 二二年財政年度的約15.0%。上升的原因主要為融資 成本於二零二二年財政年度減少約8,500,000港元。

純利率由二零二一年財政年度的約51.0%下跌至二零 二二年財政年度的約47.2%。下跌的原因主要為按揭 業務的收益於二零二二年財政年度減少約35,900,000 港元。

PRINCIPAL RISKS AND UNCERTAINTIES

The Group's operations, financial conditions, profits and growth prospects are affected by a number of risks and uncertainties as outlined below. These factors are not exhaustive and there may be other risks in addition to those shown below which are not known to the Group or which may not be material now but could become material in the future.

Financial risk

Financial risk factors include credit risk, interest rate risk, liquidity risk and fair value risk. As a money lender in Hong Kong providing pawn loan and mortgage loan financings to corporations or private individuals which are secured with collaterals, credit risk is regarded as the prime risk of the Group.

Mortgage business

For mortgage business, the Group generates revenue from interest received from the provision of loans to corporate and private individual customers. The Group's principal loan products for mortgage business are (i) first mortgage loans, which are secured by the first mortgage on the borrowers' real estates; and (ii) subordinated mortgage loans, which are secured by mortgages subordinated to the first mortgages charged on the borrowers' pledged properties. The Group only offers mortgage loan financings which are secured against real estate assets located in Hong Kong which include residential, commercial and industrial real estate assets.

The Group has a credit policy in place and the exposures to credit risk are monitored on an ongoing basis. Approval for loan applications, together with the loan amount and corresponding interest rate, are determined based on a number of factors including, amongst others, the credit history and profile of the applicant, the property type, profile and valuation of the proposed property to be mortgaged and the prevailing market conditions. In the majority of the cases, the Group grants loan with a loan-to-value ratio of no more than 70%. As at 28 February 2022, the overall weighted average loan-to-value ratio of the Group's loan portfolio is managed at around 53%.

The Group also establishes standard procedures and the mortgage department is responsible for on ongoing monitoring of loan recoverability, which includes the repayment status and a quarter review per year on the market value of the underlying collateral, and loan collection.

主要風險及不確定因素

本集團的經營、財務狀況、溢利及增長前景受下文所 列多項風險及不確定因素所影響。該等因素並非詳盡 無遺,除下文所列者外,仍有其他本集團尚未知悉或 目前並不重大但日後可能成為重大的其他風險。

財務風險

財務風險因素包括信貸風險、利率風險、流動資金風 險及公平值風險。作為香港的一家貸款人,我們向企 業及個人提供以抵押物作抵押的典當貸款及按揭貸款 融資,信貸風險被視為本集團的首要風險。

按揭業務

就按揭業務而言,本集團自向公司及個人客戶提供貸 款所得利息產生收入。本集團按揭業務的主要貸款產 品為(i)物業一按貸款,以借款人的一按物業作抵押; 及(ii)物業二按貸款,以借款人已作第一抵押的二按 物業作抵押。本集團僅提供以位於香港的物業資產作 抵押的按揭貸款融資,包括住宅、商用及工業物業資 產。

本集團已制訂信貸政策,並持續監察信貸風險。貸款 申請的審批以及貸款金額及相應利率由我們根據多項 因素決定,包括(其中包括)申請人的信貸記錄及概 況、建議將予抵押物業的物業類型、概況及估值以及 當時市況。在大多數情況下,本集團授予貸款的貸款 對估值比率不超過70%。於二零二二年二月二十八 日,本集團貸款組合的整體加權平均貸款對估值比率 維持於約53%。

本集團亦設立標準程序,而按揭部門負責監察貸款可 收回性,包括每年還款狀況及對相關抵押品的市值進 行季度審閱以及追討欠款。

Pawn loan business

For pawn business, the Group generates revenue from (i) interest received from the provision of loans to corporate and private individual customers, and (ii) if the loan defaulted, the potential gain/loss on the disposal of the respective collaterals from the defaulted loan. The major category of collaterals we received in pawn business are gold and jewelries, diamond, brand watches and consumer electronic products.

The Group establishes internal guidelines for the pawnshop staff for granting each pawn loan. Customer identification, evaluation of ownership of the collaterals and the valuation of the collaterals are the major factors when we grant our pawn loan. The Group usually grants loans with a loan-to-value ratio ranging from 50% – 85%, depending on the type of collateral and the valuation is made at the point of granting the loan. In addition, approval is required to obtain from management if the loan amount is greater than HK\$60,000 for each single transaction.

The Group has a wide and diversify customer base. For mortgage loan business, outstanding loan size of each loan ranges from approximately HK\$120,000 to HK\$60,000,000 as at 28 February 2022. For pawn loan business, each pawn loan size ranges from approximately HK\$80 to HK\$7,470,000 during FY2022. The largest customer of the Group accounted for approximately 4.8% of the Group's revenue for FY2022.

Further information on the internal control and risk management measures in relation to credit risk and other aforesaid financial risk factors of the Group are elaborated in Note 25 "Financial risk management and fair value" to the consolidated financial statements of this annual report

Operational risk

Operational risk is defined as the risk of loss resulting from inadequate or failed internal processes, human and system errors or from external events. Responsibility for managing operational risks basically rests with every function at departmental levels. Key functions in the Group are guided by their standard operating procedures, limits of authority and reporting framework. Management will identify and assess key operational exposures regularly so that appropriate risk response can be taken.

典當貸款業務

就典當業務而言,本集團自(i)向公司及個人客戶提供 貸款所得利息;及(ii)倘貸款違約,則出售有關違約貸 款各自的抵押物的潛在收益/虧損中產生收入。我們 在典當業務中收到的主要抵押物類別為黃金及珠寶、 鑽石、品牌手錶及消費電子產品。

本集團為典當行員工制訂發放每筆典當貸款的內部指 引。在發放典當貸款時,客戶身份的識別、抵押物所 有權的評估及抵押物的估值是我們考慮的主要因素。 本集團發放貸款時,通常會根據抵押物的類型,設定 50%-85%的貸款比例,並在發放貸款時進行估價。此 外,倘每筆交易的貸款金額超過60,000港元,則須獲 得管理層的批准。

本集團擁有廣泛及多元的客戶基礎。就按揭貸款業務 而言,於二零二二年二月二十八日,各項貸款的未償 還貸款數額介乎約120,000港元至60,000,000港元。 就典當貸款業務而言,於二零二二年財政年度,各項 典當貸款金額介乎約80港元至7,470,000港元。於二 零二二年財政年度,本集團的最大客戶佔本集團收入 約4.8%。

有關本集團信貸風險及其他上述財務風險因素的內部 控制及風險管理措施的更多資料,於本年報綜合財務 報表附註25「財務風險管理及公平值」中闡述。

操作風險

操作風險是指由不完善或不起效用的內控程序、人員 及系統失誤或外部事件導致損失的風險。管理操作風 險的責任基本落於各部門級別的職能單位。本集團的 主要職能單位設有標準操作程序、權限及匯報架構作 為指引。管理層會定期識別及評估主要操作風險以便 採取適當的風險應對措施。

Market risk

Performance of the Group's business will be affected by various market factors in Hong Kong, including but not limited to economic conditions, valuation of the luxury goods and the overall property market conditions in Hong Kong. A downturn in (i) the economy, (ii) value of luxury goods, and/or (iii) property market in Hong Kong may result not only in a decline in the number of real estate and luxury goods transactions, which may limit the growth of the Group's pawn and mortgage loan portfolio, but also a decline in the value of the underlying coallaterals in respect of the Group's pawn and mortgage loan portfolio or result in loss on disposal if the pawn loan default.

For mortgage business, the Group has implemented policies to carry out continuous monitoring of the property market and the collateral value of the underlying mortgage loan portfolio so that appropriate risk response can be taken.

For pawn loan business, except from the internal guidelines for granting the loan, monthly review and discussion between management and pawnshop staff are made in order to ensure everyone are keep update on the trend of the luxury goods in order to mitigate the potential risk exposure.

Risk management

The Group has established and maintained sufficient risk management procedures to identify and control various types of risk within the organisation and the external environment with active management participation and effective internal control procedures in the best interest of the Group and its shareholders. Details of its risk management system are elaborated on pages 51 to 54 under section "Corporate Governance Report" of this annual report.

HUMAN RESOURCES

As at 28 February 2022, our Group had a total of 50 staff (28 February 2021: 51). Total staff costs (including Directors' emoluments) were approximately HK\$29.5 million for FY2022 (FY2021: approximately HK\$29.1 million). Remuneration is determined with reference to market conditions and the performance, qualifications and experience of each individual employee. Bonus based on individual performance will be paid to employees as recognition of and reward for their contributions. Other benefits include a share option scheme and contributions to statutory mandatory provident fund scheme to our Group's employees in Hong Kong.

市場風險

本集團業務表現受香港多個市場因素影響,包括但不限於經濟狀況、奢侈品的估值及香港整體樓市狀況。 (i)香港經濟:(ii)奢侈品的價值;及/或(iii)樓市低迷不 僅會導致房地產及奢侈品交易量減少,限制本集團典 當及按揭貸款組合的發展,亦會致使有關本集團典當 及按揭貸款的相關抵押物之價值下降,進而可能加大 本集團按揭貸款組合的減值風險或在典當貸款違約的 情況下引致出售虧損。

就按揭業務而言,本集團已採取政策持續監控樓市和 相關按揭貸款組合的抵押物價值,以應對相應風險。

有關典當貸款業務,除發放貸款的內部指引外,管理 層及典當行員工之間每月都會進行審閱及討論,以確 保每個人均能了解奢侈品的最新趨勢,以減少潛在的 風險。

風險管理

本集團已建立及保持足夠風險管理程序,輔以管理層 之積極參與及有效之內部監控程序,以找出及控制公 司內部及外圍環境現存之多種風險,符合本集團及其 股東之最佳利益。有關風險管理系統的詳情於本年報 第51至54頁的「企業管治報告」一節闡述。

人力資源

於二零二二年二月二十八日,本集團共有50名員 工(二零二一年二月二十八日:51名)。二零二二 年財政年度之員工成本總額(包括董事酬金)約 為29,500,000港元(二零二一年財政年度:約 29,100,000港元)。薪酬乃經參考市場狀況以及各個 別僱員之表現、資格及經驗後釐定。本集團將根據僱 員之個人表現向其發放花紅,作為對彼等所作貢獻之 認可及獎勵。其他福利包括購股權計劃及為本集團之 香港僱員作出法定強制性公積金計劃之供款。

RELATIONSHIP WITH KEY STAKEHOLDERS

The Company understands the importance of maintaining a good relationship with its employees, customers and other stakeholders to meet its immediate and long-term goals. The Company will continue to ensure effective communication and maintain good relationship with each of its key stakeholders.

During FY2022, there was no material and significant dispute between the Company and its employees, customers and/or other stakeholders.

FOREIGN CURRENCY EXPOSURE

The business activities of the Group were denominated in HKD. The Directors did not consider the Group was exposed to any significant foreign exchange risks during FY2022. As the impact from foreign exchange exposure was minimal, the Directors were of the view that no hedging against foreign currency exposure was necessary. In view of the operational needs, the Group will continue to monitor the foreign currency exposure from time to time and take necessary actions to minimise the exchange related risks.

MATERIAL ACQUISITIONS AND DISPOSALS

Our Group did not engage in any material acquisitions or disposals during FY2022.

FUTURE PLANS FOR MATERIAL INVESTMENTS AND CAPITAL ASSETS

Save as disclosed in this annual report, the Group does not have any present plans for material investments and capital assets.

PROSPECTS

With a high vaccination rate and a growing mass immunity from previous infection, it is expected that COVID-19 pandemic will pose less of a threat to Hong Kong. The continuous travel restrictions had undermined the city's competitiveness and business operations were unable to return to normal. We believe that future loan demand in Hong Kong will depend largely on the government's disease prevention measures. Local businesses, especially SMEs will continue to be prudent regarding future expansion until they see a substantial resumption of vital economic activities.

與主要持份者之關係

本公司明白與其僱員、客戶及其他持份者保持良好關 係以達致中長期目標的重要性。本公司將繼續確保與 各主要持份者維持有效溝通和保持良好關係。

於二零二二年財政年度,本公司與其僱員、客戶及/ 或其他持份者之間並無發生重大糾紛。

外匯風險

本集團的業務活動以港元計值。董事認為,於二零 二二年財政年度,本集團並無承受任何重大外匯風 險。由於外匯風險的影響極微,故董事認為毋須為外 匯風險作出對沖。鑑於營運需要,本集團將繼續不時 監察外匯風險,並採取必要行動以降低匯兑相關風 險。

重大收購及出售

於二零二二年財政年度,本集團並無進行任何重大收 購或出售。

重大投資及資本資產之未來計劃

除本年報所披露者外,本集團現時並無任何重大投資 及資本資產之計劃。

前景

隨著疫苗接種率上升及過往感染個案造成群體免疫擴 大,預料2019冠狀病毒病疫情對香港的威脅會減低。 持續出入境限制令香港的競爭力減弱及業務營運無法 恢復正常。我們相信,香港的未來貸款需求將主要取 決於政府的防疫措施。本地企業(特別是中小企)將對 未來擴張繼續採取審慎態度,直至關鍵經濟活動顯著 復甦為止。

The uncertainties of macro-economy and geopolitical risks are also expected to linger, with the USA's tightening policy and the evolving pandemic being pivotal to market sentiments. In planning ahead of the upcoming financial year, the Group anticipates there will be more challenges to overcome.

In response to this, the Group will continue to strengthen its risk management measures, such as increasing the proportion of first mortgage loans, further tightening its loan-to-value ratio, adopting a more cautious approach when granting loans, in order to maintain financial stability of the Group and wait for market recovery.

Meanwhile, the Group will continue to seize opportunities and strive to create the best interests for our shareholders and the Company. The Group is currently developing a mobile APP to provide a quick and easy alternative financing solution to its customers, as well as to capture opportunities of the online pawn loan market. 宏觀經濟不確定因素及地緣政治風險亦預期持續,美 國的緊縮政策及疫情演變將左右市場氣氛。於計劃下 一財政年度時,本集團預料須克服更多挑戰。

就此,本集團將繼續加強其風險管理措施,如提高第 一按揭抵押貸款之比例、進一步收緊其貸款對估值比 率、發放貸款時採取更嚴謹之態度,以維持本集團的 財務穩定,等待市場復甦。

同時,本集團將繼續把握機會,竭力為股東及本公司 創造最佳利益。本集團目前正開發一款流動應用程 式,為客戶提供快捷簡便的替代性融資方案,並抓住 線上典當貸款市場的機遇。

The Board is pleased to submit this report of the Directors together with the audited financial statements of the Group for the year ended 28 February 2022.

PRINCIPAL ACTIVITIES

The Company is an investment holding company. The principal activities of the Group are providing secured financing business in Hong Kong, including pawn loans and mortgage loans.

FINANCIAL RESULTS

The results of the Group for the year ended 28 February 2022 and the state of the Company's and the Group's affairs as at that date are set out in the consolidated financial statements on pages 71 to 160 of this annual report.

CASH FLOW POSITION

The cash flow position of the Group for the year ended 28 February 2022 is set out and analysed in the consolidated statement of cash flows set out on pages 75 to 76 of this annual report.

DIVIDEND

At our Board meeting held on Wednesday, 25 May 2022 (the "**Board Meeting**"), our Directors recommended the payment of a final dividend (the "**Final Dividend**") of HK0.71 cents per ordinary share. In addition, during the Board Meeting, our Directors also recommended the payment of a special dividend (the "**Special Dividend**") of HK0.37 cents per ordinary share to the Shareholders in recognition of their continuous support to the Company.

The Final Dividend and the Special Dividend, together with the interim dividend of HK0.78 cents per share declared and paid during the year ended 28 February 2022, represent 50.1% of the profit attributable to the Shareholders for the year ended 28 February 2022.

The Final Dividend and the Special Dividend are subject to approval by the Shareholders at the AGM and will be paid on Tuesday, 23 August 2022 to the Shareholders whose names appear on the register of members of our Company at the close of business on Monday, 8 August 2022. 董事會欣然提呈本董事會報告連同本集團截至二零 二二年二月二十八日止年度之經審核財務報表。

SHARE OPTION SCHEME

A share option scheme (the "Share Option Scheme") was adopted pursuant to a written resolution of the then sole shareholder on 19 February 2013 (the "Adoption Date").

The purpose of the Share Option Scheme is to attract and retain the best available personnel, to provide additional incentive to them to promote the success of the business of the Group. The Board may, at its discretion, grant options pursuant to the Share Option Scheme to any employee (full-time and part-time), consultant, adviser, Director (including executive, non-executive or independent non-executive Director), Substantial Shareholder (as defined in the Rules Governing the Listing of Securities on the Stock Exchange (the "**Listing Rules**")), distributor, contractor, supplier, agent, customer, business partner or service provider of any member of the Group whom the Board determines have contribution or potential contribution to the development and growth of the Group.

As at 28 February 2022, being the financial year ended 28 February 2022 for the Group:

- a total of 40,000,000 options to subscribe for shares were available for issue under the Share Option Scheme, representing approximately 2.1% of the total issued shares of the Company as at 28 February 2022;
- ii) an option granted under the Share Option Scheme may be exercised in accordance with the terms of the Share Option Scheme at any time during a period as the Board may determine which shall not exceed ten years from the date of grant subject to the provisions of early termination thereof; and
- iii) the Share Option Scheme will remain in force until 18 February 2023.

The aggregate number of shares of the Company which may be issued upon exercise of all outstanding options granted and yet to be exercised under the Share Option Scheme and any other share option schemes of the Company must not exceed 30% of the shares of the Company in issue from time to time. No option may be granted under the Share Option Scheme or any other share option schemes of the Company if this will result in the limit being exceeded.

The limit of 10% may be refreshed at any time by approval of the shareholders of the Company in general meeting provided that the total number of the shares of the Company which may be issued upon exercise of all options to be granted under the Share Option Scheme and any other share option schemes of the Company must not exceed 10% of the shares of the Company in issue as at the date of approval of the refreshed limit.

Unless approved by shareholders of the Company in general meeting, the maximum number of shares underlying the options granted to each eligible participant (including both exercised and outstanding options) in any 12-month period shall not exceed 1.0% of the shares of the Company in issue for the time being.

A consideration of HK\$1.0 is payable on acceptance of the grant of an option.

Pursuant to the Share Option Scheme, the participants may subscribe for the shares of the Company on the exercise of an option at the price determined by the Board provided that it shall be at least the highest of (a) the closing price of the shares of the Company as stated in the Stock Exchange's daily quotations sheet on the date on which an option is offered to a participant, which must be a business date (the "**Offer Date**"); (b) the average of the closing prices of the shares of the Company as stated in the Stock Exchange's daily quotations sheets for the five business days immediately preceding the Offer Date; and (c) the nominal value of a share of the Company on the Offer Date.

Tenancy agreements

- On 25 June 2021, for the purpose of operating one of our (j) pawnshops, Hing Wah Pawnshop Credit Limited ("Hing Wah HK"), an indirectly wholly-owned subsidiary of the Company entered into a tenancy agreement ("Hing Wah Tenancy Agreement") with Kwan Chart (Holding) Company Limited ("Kwan Chart Holding"), which is owned as to 90% and 10% by Mr. Chan Chart Man (an executive Director) and his spouse Ms. Mui Hang Sin (a substantial shareholder of the Company), respectively. Pursuant to the Hing Wah Tenancy Agreement, Kwan Chart Holding shall lease a premises to Hing Wah HK for a term of one year from 8 June 2021 to 7 June 2022 at a monthly rent of HK\$80,000 and pay a monthly management fee of HK\$3,300. During the contract period, the management fee may be increased by a maximum of 30% (up to HK\$4,290) if and only if the respective management fee payable by Kwan Chart Holding increases.
- (ii) On 25 June 2021, for the purpose of operating one of our pawnshops, Wai Wah Pawnshop Credit Limited ("Wai Wah HK"), an indirectly wholly-owned subsidiary of the Company entered into a tenancy agreement ("Wai Wah Tenancy Agreement") with Mr. Chan Chart Man, an executive Director. Pursuant to the Wai Wah Tenancy Agreement, Mr. Chan Chart Man shall lease a premises to Wai Wah HK for a term of one year from 8 June 2021 to 7 June 2022 at a monthly rent of HK\$90,000.

(iii) On 25 June 2021, for the purpose of operating our head office, Oi Wah Pawnshop Credit Limited ("Oi Wah HK") entered into a tenancy agreement ("Oi Wah Tenancy Agreement") with Kwan Chart Estate Company Limited ("Kwan Chart Estate"), which is owned as to 95% and 5% by Mr. Chan Chart Man (an executive Director) and his spouse Ms. Mui Hang Sin (a substantial shareholder of the Company), respectively. Pursuant to the Oi Wah Tenancy Agreement, Kwan Chart Estate shall lease a premises to Oi Wah HK for a term of one years from 31 May 2021 to 30 May 2022 at a monthly rent of HK\$55,000.

Annual review of the Continuing Connected Transactions

Although all the Continuing Connected Transactions are fully exempt from shareholders' approval, annual review and all disclosure requirements under Rule 14A.76 of the Listing Rules, these transactions have been reviewed by the independent nonexecutive Directors who have confirmed that the Continuing Connected Transactions have been entered into (i) in the ordinary and usual course of business of the Group; (ii) either on normal commercial terms or on terms no less favourable to the Group than terms available to (or from) independent third parties; and (iii) in accordance with the relevant agreements governing them on terms that are fair and reasonable and in the interests of the shareholders of the Company as a whole.

Save as disclosed above, the significant related party transactions that did not constitute connected transactions under the Listing Rules made during the year were disclosed in note 27 to the consolidated financial statements.

TAX RELIEF AND EXEMPTION

The Directors are not aware of any tax relief and exemption available to the Shareholders by reason of their holding of the Company's securities.

PERMITTED INDEMNITY PROVISION

Appropriate Directors' liability insurance has been arranged to indemnify the Directors for liabilities arising out of corporate activities. The coverage and the sum insured under the policy are reviewed annually. Further, the Company's Articles of Association provide that Directors are entitled to be indemnified out of the Company's assets against claims from third parties in respect of certain liabilities.

The Company has taken out and maintained appropriate insurance cover in respect of potential legal actions against its Directors and officers. CORPORATE GOVERNANCE PRACTICES

The Company is committed to achieving and maintaining high standards of corporate governance consistent with the needs and requirements of its business and the Shareholders. Our Company has adopted the code provisions set out in the Corporate Governance Code (the "**Code Provisions**") and Corporate Governance Report contained in Appendix 14 to the Listing Rules. The corporate governance principles of the Company emphasise a quality board, sound internal controls, and transparency and accountability to all Shareholders.

Throughout the year ended 28 February 2022, and up to the date of this annual report, our Company applied the principles in the Corporate Governance Code and complied with the Code Provisions, save for the deviation from Code Provision C.2.1 (previous Code Provision A.2.1) and Code Provision C.1.6 (previous Code Provision A.6.7) which is explained below.

Code Provision C.2.1 (previous Code Provision A.2.1) requires that the roles of the chairman and the chief executive to be separate and should not be performed by the same individual. Mr. Chan Kai Ho Edward ("Mr. Chan"), an executive Director, currently holds both positions. Mr. Chan has been the key leadership figure of our Group and has been primarily involved in the formulation of business strategies and determination of the overall direction of our Group. He has also been chiefly responsible for our Group's operations as he directly supervises other executive Directors and senior management of our Group. Taking into account the continuation of the implementation of our Group's business plans, our Directors (including the independent non-executive Directors) consider that Mr. Chan is the best candidate for both positions and the present arrangements are beneficial and in the best interests of our Company and its shareholders (the "Shareholders" or "our Shareholders") as a whole.

Code Provision C.1.6 (previous Code Provision A.6.7) requires independent non-executive Directors and non-executive Directors to attend general meetings to gain and develop a balanced understanding of the views of shareholders. At the annual general meeting held on 29 July 2021, an independent non-executive Director was absent due to his urgent family matter.

The Directors will review our Company's corporate governance policies and compliance with the Code Provisions from time to time.

Appointment, Re-election and Removal of Directors

Each of the executive Directors has entered into a service contract with the Company, and each of the non-executive Directors and independent non-executive Directors has signed a letter of appointment with the Company. Such term is for an initial term of three years commencing from the Listing Date and is subject to the re-appointment of each of the Directors by the Company at an annual general meeting upon retirement.

In addition, every Director should be subject to retirement by rotation at least once every three years. At every annual general meeting, one-third of the Directors for the time being, or if their number is not three or a multiple of three, the number nearest to but not less than one-third, shall retire from office by rotation according to Article 108(a) of the Articles of Association of the Company.

Responsibilities of Directors

All the Directors received an induction on appointment to ensure appropriate understanding of the business and operation of the Group and full awareness of director's responsibilities and obligations under the Listing Rules and relevant regulatory requirements. The Directors will also be updated from time to time on the business development and operation plans of the Company.

In compliance with Code Provision C.1.4 (previous Code Provision A.6.5), the Company will arrange for, and provide funds for, all the Directors to participate in continuous professional development organised in the form of in-house training, seminars or other appropriate courses to keep them refresh of their knowledge, skill and understanding of the Group and its business or to update their skills and knowledge on the latest development or changes in the relevant statutes, the Listing Rules and corporate governance practices. The Company will also update the Directors of any material changes in the Listing Rules and corporate governance practices from time to time.

Non-executive Directors

Pursuant to the previous Code Provision A.4.1, a non-executive director should be appointed for a specific term and subject to reelection. Each of our non-executive Directors has entered into a letter of appointment with the Company for a term of three years and shall continue thereafter unless terminated in accordance with the terms of the letters of appointment.

DIRECTORS' SECURITIES TRANSACTIONS

The Company has adopted the standard set out in Appendix 10 (Model Code for Securities Transactions by Directors of Listed Issuers) (the "**Model Code**") to the Listing Rules, in relation to the dealings in securities of the Company by the Directors.

Having made specific enquiries with all Directors, each Director has confirmed that he/she has complied with the standard set out in the Model Code throughout the year ended 28 February 2022 and up to the date of this annual report. 此外,各董事須至少每三年輪值退任一次。根據本公司組織章程細則第108(a)條,於每屆股東週年大會上,當時董事人數之三分之一(或當人數非三或三之倍數時,則最接近三分之一但不少於三分之一)須輪值退任。

Nomination Committee

The Nomination Committee of the Company was established on 19 February 2013 with effect from the Listing Date with specific written terms of reference in compliance with the Listing Rules. With the adoption of the board diversity policy (the "**Board Diversity Policy**") to comply with the Code Provisions, the terms of reference of the Nomination Committee were revised on 23 May 2014. According to the Board Diversity Policy, the Board should be composed of directors with diversed skills, knowledge, gender, age, cultural and educational background or professional experience. The Board will review such measurable objectives from time to time to ensure their appropriateness and assess the progress made towards achieving those objectives. The Nomination Committee considered the Board composition was in compliance with the Board Diversity Policy.

The primary duties of the Nomination Committee are to make recommendations to the Board regarding candidates to fill vacancies on the Board and senior management. The existing members of the Nomination Committee include Dr. Leung Shiu Ki Albert and Mr. Lam On Tai, both are independent non-executive Directors, and Mr. Chan Kai Ho Edward, an executive Director. Dr. Leung Shiu Ki Albert is the chairman of the Nomination Committee.

The terms of reference of the Nomination Committee are available on the website of the Company and the website of the Stock Exchange.

The Nomination Committee held one meeting during the reporting year. NOMINATION POLICY

The Group has adopted a nomination policy (the "**Nomination Policy**") which specifies the procedures, process and criteria of the nomination of Directors.

Selection criteria for nomination and appointment of Directors

When making any recommendations in relation to the appointment of any proposed candidate to the Board or reappointment of any existing member(s) of the Board, the Nomination Committee shall consider, but without limitation, the following factors when evaluating the suitability of the proposed candidate:

- competence, experience, skills, expertise, education and professional qualifications, background and other personal attributes of the candidate that can best complement and expand the skill set and expertise of the Board as a whole;
- reputation for integrity;
- availability of the candidate, as to whether the candidate can devote sufficient time and effort to properly discharge his duties as a Director; and
- other factors as the Nomination Committee or the Board may deem relevant.

If the candidate is proposed to be appointed as an independent non-executive director, he or she must comply with the independence requirements under the Listing Rules. Such candidate shall be independent in judgment and character, and shall be able to act in the best interests of the Shareholders.

Nomination procedure and process

The Nomination Policy sets out the procedure and process in relation to the nomination of Directors as follows:

- members of the Nomination Committee or the Board shall identify, nominate and invite suitable candidates;
- the Nomination Committee shall determine the suitable candidate for appointment in accordance with the selection criteria set out in the Nomination Policy and the Board Diversity Policy;
- in the context of re-appointment of retiring Directors, the Nomination Committee shall review and evaluate the

ACCOUNTABILITY AND AUDIT

Financial Reporting

Financial results of the Group are announced in a timely manner in accordance with all statutory requirements, particularly the timeframe stipulated in Rules 13.49(1) and (6) of the Listing Rules.

All Directors acknowledge their responsibility for preparing the consolidated financial statements of the Group for the year ended 28 February 2022. Currently, the Company's external auditors are SHINEWING (HK) CPA Limited (the "**Auditors**").

For the year ended 28 February 2022, the fees paid or payable by the Company to the Auditors amounted to approximately HK\$0.83 million, which was all for audit services.

The statement of the Auditors about their reporting responsibilities on the consolidated financial statements of the Group is set out in the Independent Auditor's Report on pages 64 to 70 of this annual report.

Risk Management and Internal Controls

The Board recognizes its responsibility for maintaining an adequate and sound enterprise risk management and internal control system and through the Audit Committee and, if necessary, an external firm of qualified accountants to provide internal control services, conducts reviews on the effectiveness of these systems at least annually, covering material controls, including financial, operational, compliance and strategic risk control functions. The Board understands that such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

During the year under review, the Board, through the Audit Committee, conducted annual review of both design and implementation effectiveness of the risk management and internal control systems of the Group, covering all material controls, including financial, operational and compliance controls, with a view to ensuring that resources, staff qualifications and experience, training programmes and budget of the Group's accounting, internal audit and financial reporting functions are adequate. In this respect, the Audit Committee communicates any material issues identified to the Board.

風險管理及內部監控

董事會知悉其維持合適及穩健的企業風險管理及內 部監控系統的責任並透過審核委員會及(如需要)外 聘合資格會計師事務所提供內部監控服務,最少每年 檢討該等系統是否有效,有關檢討涵蓋重要的監控方 面,包括財務監控、營運監控、合規監控及策略風險 監控職能。董事會明白,該等系統旨在管理而非消除 未能達成業務目標的風險,而且只能就不會有重大的 錯誤陳述或損失作出合理而非絕對的保證。

於回顧年度,董事會透過審核委員會就本集團風險管 理及內部監控系統的設計及實施是否有效進行年度 檢討,有關檢討涵蓋所有重要的監控方面,包括財務 監控、營運監控及合規監控,以確保本集團在會計、 內部審核及財務匯報職能方面的資源、員工資歷及經 驗,以及員工所接受的培訓課程及有關預算是足夠 的。就此而言,審核委員會將任何辨認的重大議題傳 達給董事會。

During the year under review, the Company also appointed an independent professional consultancy firm, BT Corporate Governance Limited ("**BTCGL**") to:

- assist in identifying and assessing the risks of the Group through a series of workshops and interviews; and
- independently perform internal control review and assess effectiveness of the Group's risk management and internal control systems.

The results of the independent review and assessment were reported to the Audit Committee and the Board. Moreover, improvements in internal control and risk management measures as recommended by BTCGL to enhance the risk management and internal control systems of the Group and mitigate risks of the Group were adopted by the Board. Based on the findings and recommendations of BTCGL as well as the comments of the Audit Committee, the Board considered the internal control and risk management systems effective and adequate.

Our Enterprise Risk Management Framework

The Group reviewed its enterprise risk management framework during the year ended 28 February 2022. While the Board has the overall responsibility to ensure that sound and effective internal controls are maintained, management is responsible for designing and implementing an internal control system to manage all kinds of risks faced by the Group.

Through the risk identification and assessment processes, risks are identified, assessed, prioritized and allocated treatments. Our risk management framework follows the COSO Enterprise Risk Management – Integrated Framework, which allows the Board and management to manage the risks of the Group effectively. The Board receives regular reports through the Audit Committee that oversights risk management and internal audit functions. 於回顧年度,本公司亦委任一家獨立專業管理顧問公司哲慧企管專才有限公司(簡稱「**哲慧企管**」),以:

獨立檢討及評估的結果已經向審核委員會及董事會報 告。此外,董事會已採納哲慧企管所推薦的內部監控 及風險管理措施改進,以提升本集團之風險管理及內 部監控系統以及減低本集團風險。根據哲慧企管的調 查結果及建議以及審核委員會的意見,董事會認為內 部監控及風險管理系統有效和足夠。

Our Risk Control Mechanism

The Group adopts a "three-layer" corporate governance structure with operational management and controls performed by operations management, coupled with risk management monitoring carried out by the finance team and independent internal audit outsourced to and conducted by BTCGL. The Group maintains a risk register to keep track of all identified major risks of the Group. The risk register provides the Board, the Audit Committee, and management with a profile of its major risks and records management's action taken to mitigate the relevant risks. Each risk is evaluated at least annually based on its likelihood of occurrence and potential impact upon the Group. The risk register is updated by management as the risk owners with addition of new risks and/or removal of existing risks, if applicable, at least annually, after the annual risk evaluation has been performed. This review process can ensure that the Group proactively manages the risks faced by it in the sense that all risk related parties have access to the risk register and are aware of and alert to those risks in their area of responsibility so that they can take follow-up action in an efficient manner.

本集團的風險監控機制

本集團採用「三層」企業管治架構,營運管理及控制 由營運管理層進行,風險管理監察由財務團隊進行, 而獨立內部審核則外判予哲慧企管及由其進行。本集 團維持風險登記冊,以追蹤本集團所有已辨認的主要 風險。風險登記冊為董事會、審核委員會和管理層提 供其主要風險的資料,並記錄管理層為減低相關風險 而採取的行動。每項風險最少每年根據其發生的可能 性和對本集團的潛在影響進行評估。風險登記冊由管 理層以風險擁有人身份更新,其最少每年在進行年度 風險評估後加入新風險及/或移除現有風險(如適 用)。該檢討過程可確保本集團主動管理其面臨的風 險,所有風險相關人士均可取覽風險登記冊,並知悉 及警覺到其責任範圍內的風險,以便其能夠有效率地 採取跟進行動。

The Group's risk management activities are performed by management on an ongoing process. The effectiveness of the Group's risk management framework will be evaluated at least annually, and periodic management meeting is held to update the progress of risk monitoring efforts. Management is committed to ensure that risk management forms part of the daily business operation processes in order to align risk management with corporate goals in an effective manner.

The Directors have reviewed the need for an internal audit function and are of the view that in light of the size, nature and complexity of the business of the Group, it would be more cost effective to appoint external independent professionals to perform internal audit function for the Group in order to meet its needs.

The Company will continue to engage external independent professionals to review the Group's system of internal controls and risk management annually and further enhance the Group's internal control and risk management systems as appropriate.

The Group has established internal control procedures for the handling and dissemination of inside information in order to comply with Chapter 13 of the Listing Rules as well as Part XIVA of the SFO. The internal control mechanism includes information flow and reporting processes, confidentiality arrangements, disclosure procedures, and staff training arrangements, etc.

DELEGATION BY THE BOARD

In general, the Board oversees the Company's strategic development and determines the objectives, strategies and policies of the Group. The Board also monitors and controls operating and financial performance and sets appropriate policies for risk management in pursuit of the Group's strategic objectives. The Board delegates the implementation of strategies and day-to-day operation of the Group to the management.

COMPANY SECRETARY

Mr. Cheng Yiu Hang, the company secretary appointed by the Board and an employee of the Company, in the opinion of the Board, possesses the necessary qualification and experience, and is capable of performing the functions of the company secretary. The Company will provide fund for Mr. Cheng to take not less than 15 hours of appropriate professional training in each financial year as required under Rule 3.29 of the Listing Rules. During the year ended 28 February 2022, Mr. Cheng had taken not less than 15 hours of relevant professional training.

本集團的風險管理活動由管理層持續進行。本集團最 少每年評估其風險管理框架是否有效,並定期舉行管 理會議,以更新風險監察工作的進展情況。管理層致 力於確保風險管理構成日常業務營運流程的一部分, 以使風險管理有效地配合企業目標。

董事已審視內部審核職能的需要,並且認為,有鑒於 本集團業務的規模、性質及複雜程度,委任外部獨立 專業人士為本集團執行內部審核職能以滿足其需要將 更具成本效益。

本公司將繼續委聘外部獨立專業人士以每年檢討本集 團之內部監控及風險管理系統,以及進一步提升本集 團的內部監控及風險管理系統(如適用)。

本集團已就處理及發佈內幕消息制訂內部監控程序, 以遵守上市規則第13章以及證券及期貨條例第XIVA 部。內部監控機制包括消息流向與申報流程、保密安 排、披露程序及員工培訓安排等。

董事會之授權

一般而言,董事會監督本公司之策略發展及釐定本集 團之目標、策略及政策。董事會亦監察及控制營運及 財務表現,並制訂適當之風險管理政策,以求達致本 集團之策略目標。董事會授予管理層執行本集團策略 及處理日常營運事務之權力。

公司秘書

鄭耀衡先生為獲董事會委任之公司秘書,並為本公司 僱員,董事會認為其具備所需資格及經驗,並有能力 履行公司秘書之職能。本公司將向鄭先生提供資金, 讓其按上市規則第3.29條規定在每個財政年度參加不 少於15個小時之合適專業培訓。於截至二零二二年二 月二十八日止年度,鄭先生已接受不少於15小時的相 關專業培訓。

DIVIDEND POLICY

The Company has adopted a dividend policy (the "**Dividend Policy**"). Under the Dividend Policy, in circumstances that the Group is profitable and without affecting the normal operations and business of the Group, the Company may consider declaring and paying dividends to its shareholders.

When considering whether to declare any dividends and determining the dividend amount, the Board will take into consideration, inter alia, the following factors: (i) the financial position of the Group; (ii) the capital and debt level of the Group; (iii) the general market conditions; (iv) any cash requirements for any future development plans of the Group; (v) any restrictions on dividend payouts imposed by any of the Group's lenders; and (vi) any other relevant factors that the Board may deem appropriate.

The payment of the dividends by the Company will also be subject to any restrictions imposed by the Companies Law of the Cayman Islands as well as the articles of association of the Company.

The Board endeavors to strike a balance between the Shareholders' interests and prudent capital management with a sustainable dividend policy. The Board will from time to time review the dividend policy and may exercise at its absolute and sole discretion to update, amend, and/or modify the Dividend Policy at any time as the Board deems fit and necessary. There is no assurance that dividends will be paid in any particular amount for any specific reporting period.

No arrangement under which a shareholder has waived or agreed to waive any dividends was made by the Company.

股息政策

The Board recognises the importance of maintaining a clear, timely and effective communication with the Shareholders and investors of the Company. The Board also recognises that effective communication with the Company's investors is critical in establishing investor confidence and to attract new investors. Therefore, the Group is committed to maintaining a high degree of transparency to ensure the Shareholders and the investors of the Company will receive accurate, clear, comprehensive and timely information of the Group through the publication of annual reports, interim reports, announcements and circulars. The Company also publishes all corporate communications on the website of the Company.

In respect of each matter to be considered at the annual general meetings and extraordinary general meetings, including the reelection of Directors, a separate resolution will be proposed by the Chairman.

Pursuant to Code Provision F.2.2 (previous Code Provision E.1.2), the Chairman of the Board, the chairman of the Audit Committee, Remuneration Committee and Nomination Committee, or in their absence, another member of the relevant committee or an appointed representative, will attend the forthcoming annual general meeting to answer questions of Shareholders.

Pursuant to Code Provision F.2.2 (previous Code Provision E.1.2), the Company will invite representatives of the Auditors to attend the forthcoming annual general meeting to answer Shareholders' questions about the conduct of the audit, the preparation and content of the auditors' report, the accounting policies and auditor independence.

Such requisition shall be made in writing to the Board or the company secretary of the Company for the purpose of requiring an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition. Such meeting shall be held within two months after the deposit of such requisition. If within 21 days of such deposit, the Board fails to proceed to convene such meeting, the requisitionist(s) himself/herself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

3. Procedures for Putting Forward Proposals at 3. Shareholders' Meetings

(i) Proposal for election of a person other than a Director as a Director:

The identity of the Shareholder and his/her request will be verified with the Company's Hong Kong share registrar and upon confirmation by the share registrar that the request is proper and in order, and is made by a Shareholder, the Board will in its sole discretion decide whether the Proposal may be included in the agenda for the general meeting to be set out in the notice of meeting.

Mr. Chan established the business of our Group in 1975 and has played a significant role in the growth of our business. He has over 45 years of experience in finance and pawn loan business. Mr. Chan is the father of Mr. Chan Kai Ho Edward, Ms. Chan Mei Fong, Ms. Chan Ying Yu and Mr. Chan Kai Kow Macksion, all of whom are our Directors.

Ms. Chan Mei Fong (陳美芳), aged 52, is our executive Director and chief operating officer. Ms Chan is also a director of all the subsidiaries within the Group. Ms. Chan joined our Group in 2007 and is responsible for the overall operations of our Group's business. Ms. Chan obtained a Bachelor of Arts degree in Town and Country Planning from the University of the West of England, Bristol, United Kingdom in September 1996. Ms. Chan also obtained a diploma in Gemmology and Gem Diamond diploma from The Gemmological Association and Gem Testing Laboratory of Great Britain in January 2006 and January 2007, respectively. ### **1 GENERAL INFORMATION**

Oi Wah Pawnshop Credit Holdings Limited (the "**Company**") was incorporated in the Cayman Islands and is listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "**Stock Exchange**").

The Company and its subsidiaries (hereinafter collectively referred to as the "**Group**") are principally engaged in secured financing business in Hong Kong, including pawn loans and mortgage loans. Details of the principal activities of the Company's subsidiaries are set out in note 31.

The directors of the Company (the "**Directors**") consider the immediate parent and ultimate controlling party of the Group to be Kwan Lik Holding Limited, which is incorporated in the British Virgin Islands (the "**BVI**"), and TMF (Cayman) Ltd. as trustee of a reserved power discretionary trust for the benefit of Mr. Chan Chart Man, Mr. Chan Kai Ho Edward, Ms. Chan Ying Yu, Ms. Chan Mei Fong, Ms. Chan Nga Yu, Ms. Mui Hang Sin and Mr. Chan Kai Kow Macksion, which is incorporated in the Cayman Islands, respectively. These entities do not produce financial statements available for public use.

The Company's registered office is located at Windward 3, Regatta Office Park, PO Box 1350, Grand Cayman KY1-1108, Cayman Islands and its head office and principal place of business in Hong Kong is located at Rooms 2302–2303, Kwan Chart Tower, No. 6 Tonnochy Road, Wanchai, Hong Kong.

The consolidated financial statements are presented in Hong Kong dollars ("**HK\$**" or "**\$**"), which is also the functional currency of the Company, and all values are rounded to the nearest thousand (\$'000) except when otherwise indicated.

### 1 一般資料

本公司之註冊辦事處位於Windward 3, Regatta Office Park, P.O. Box 1350, Grand Cayman KY1-1108, Cayman Islands,而其香港總辦事處 及主要營業地點位於香港灣仔杜老誌道6號羣策 大廈2302-2303室。

In addition, the Group has early applied Amendment to HKFRS 16, COVID-19-Related Rent Concessions beyond 30 June 2021.

Except as described below, the application of the amendments to HKFRSs in the current year has had no material effect on the Group's financial performance and positions for the current and prior periods and/or on the disclosures set out in these consolidated financial statements.

### Early application of Amendment to HKFRS 16, COVID-19-Related Rent Concessions beyond 30 June 2021

In prior year, the Group applied the practical expedient in the Amendment to HKFRS 16, COVID-19-Related Rent Concessions which issued in 2020, such that as lessee it was not required to assess whether rent concessions occurring as a direct consequence of the COVID-19 pandemic were lease modifications, if the eligibility conditions are met. One of these conditions requires the reduction in lease payments affect only payments originally due on or before a specified time limit. In 2021, the Amendment to HKFRS 16, COVID-19-Related Rent Concessions beyond 30 June 2021 (the "**2021 Amendment**") has been issued by the HKICPA. The 2021 Amendment extends this time limit from 30 June 2021 to 30 June 2022.

The Group has early adopted the 2021 Amendment in the current year. The amendment did not have significant impact on the financial position and performance of the Group.

### **3 SIGNIFICANT ACCOUNTING POLICIES**

The consolidated financial statements have been prepared in accordance with HKFRSs issued by the HKICPA. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on the Stock Exchange and by the Hong Kong Companies Ordinance.

The consolidated financial statements have been prepared on the historical cost basis except for loan receivables at FVPL that are measured at fair values, at the end of each reporting period.

Historical cost is generally based on the fair value of the consideration given in exchange for goods or services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants in the principal (or most advantageous) market at the measurement date under current market conditions (i.e. an exit price) regardless of whether that price is directly observable or estimated using another valuation technique. Details of fair value measurement are explained in the accounting policies set out below.

#### **Revenue recognition**

Income is classified by the Group as revenue when it arises from the provision of services and disposal of repossessed assets in the ordinary course of the Group's business.

Revenue is recognised to depict the transfer of promised goods or services to customers in an amount that reflects the consideration to which the entity expects to be entitled in exchange for those goods or services. Specifically, the Group uses a 5-step approach to revenue recognition:

- Step 1: Identify the contract(s) with a customer
- Step 2: Identify the performance obligations in the contract
- Step 3: Determine the transaction price
- Step 4: Allocate the transaction price to the performance obligations in the contract
- Step 5: Recognise revenue when (or as) the entity satisfies a performance obligation.

The Group recognised revenue when (or as) a performance obligation is satisfied, i.e. when "control" of the goods or services underlying the particular performance obligation is transferred to customers.

A performance obligation represents a good or service (or a bundle of goods or services) that is distinct or a series of distinct goods or services that are substantially same.

Control is transferred over time and revenue is recognised over time by reference to the progress towards complete satisfaction of the relevant performance obligation if one of the following criteria is met:

- The customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs;
- The Group's performance creates or enhances an asset that the customer controls as the asset is created or enhanced; or
- The Group's performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

Otherwise, revenue is recognised at a point in time when the customer obtains control of the distinct goods or service.

Revenue is measured based on the consideration specified in a contract with a customer, excludes amounts collected on behalf of third parties.

Further details of the Group's revenue and other income recognition policies are as follows:

### (i) Interest income

Interest income for all financial assets are recognised as it accrues using the effective interest method. The effective interest rate is the rate that exactly discounts estimated future cash payments or receipts through the expected life of the financial instrument to the gross carrying amount of the financial asset. For financial assets measured at amortised cost that are not creditimpaired, the effective interest rate is applied to the gross carrying amount of the asset. For credit impaired financial assets, the effective interest rate is applied to the amortised cost (i.e. gross carrying amount net of loss allowance) of the asset.

### (ii) Fee income

Fee income is recognised when the corresponding service is provide, except where the fee is charged to cover the costs of a continuing service to, or risk borne for, the customer, or is interest in nature. In these cases, the fee is recognised as income in the accounting period in which the costs or risk are incurred or is accounted for as interest income.

### (iii) Disposal of repossessed assets

Disposal gain or loss is recognised when the buyer of the repossessed assets takes control of and accepts the goods.

### (iv) Rental income from operating leases

Rental income receivable under operating leases is recognised in profit or loss in equal instalments over the periods covered by the lease term.

#### **Basis of consolidation**

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries.

Control is achieved where the Group has: (i) the power over the investee; (ii) exposure, or rights, to variable returns from its involvement with the investee; and (iii) the ability to use its power over the investee to affect the amount of the Group's returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary.

Income and expenses of subsidiaries acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income of subsidiaries are attributed to shareholders of the Company. Total comprehensive income of subsidiaries is attributed to shareholders of the Company.

All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

#### **Investments in subsidiaries**

Investments in subsidiaries are stated on the statement of financial position of the Company at cost less accumulated impairment loss.

The Group initially recognises financial assets and financial liabilities on the date it becomes a party to the contractual provisions of the instrument.

Financial instruments are measured initially at fair value, which normally will be equal to the transaction price plus, in case of a financial asset or financial liability not held at fair value through profit or loss, transaction costs that are directly attributable to the acquisition of the financial asset or issue of the financial liability. Transaction costs on financial assets and financial liabilities at fair value through profit or loss are expensed immediately.

### Financial assets

Financial assets represent loans receivables which mainly comprise pawn loans and mortgage loans, trade and other receivables and cash and cash equivalents. Pawn loans are loans provided whereby personal property such as gold, jewellery and diamonds, watches and consumer electronic products are used as collateral for the security of the loans. Mortgage loans are loans secured by real estates.

All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the marketplace.

All recognised financial assets are subsequently measured in their entirety at either amortised cost or fair value, depending on the classification of the financial assets. Financial assets are classified, at initial recognition, as subsequently measured at amortised cost, fair value through other comprehensive income ("**FVOCI**") and FVPL.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them.

Financial assets held by the Group are classified into one of the following measurement categories:

- amortised cost, if the loan and receivable is held within a business model whose objective is to hold financial assets in order to collect contractual cash flows which represent solely payments of principal and interest ("SPPI"). Interest income from the loan and receivable is calculated using the effective interest method;
- FVOCI recycling, if the contractual cash flows of the loan and receivable comprise solely payments of principal and interest and the investment is held within a business model whose objective is achieved by both the collection of contractual cash flows and selling the financial assets. Changes in fair value are recognised in other comprehensive income, except for the recognition in profit or loss of expected credit losses or impairment gains or losses, interest income (calculated using the effective interest method) and foreign exchange gains and losses. When the loan and receivable is derecognised, the amount accumulated in other comprehensive income is recycled from equity to profit or loss; or
- FVPL, if the loan and receivable does not meet the criteria for being measured at amortised cost or FVOCI (recycling). Changes in the fair value of the loan and receivable (including interest) are recognised in profit or loss.

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment.

*(i)* Amortised cost and effective interest method

The effective interest method is a method of calculating the amortised cost of a debt instrument and of allocating interest income over the relevant period.

For financial assets, the effective interest rate is the rate that exactly discounts estimated future cash receipts (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) excluding expected credit losses, through the expected life of the debt instrument, or, where appropriate, a shorter period, to the gross carrying amount of the debt instrument on initial recognition. For originated credit-impaired financial assets, a credit-adjusted effective interest rate is calculated by discounting the estimated future cash flows, including expected credit losses, to the amortised cost of the debt instrument on initial recognition.

The amortised cost of a financial asset is the amount at which the financial asset is measured at initial recognition minus the principal repayments, plus the cumulative amortisation using the effective interest method of any difference between that initial amount and the maturity amount, adjusted for any loss allowance. The gross carrying amount of a financial asset is the amortised cost of a financial asset before adjusting for any loss allowance. 重大會計政策(續)

(i) Amortised cost and effective interest method (CONT'D) Interest income is recognised using the effective interest method for debt instruments measured subsequently at amortised cost. For financial assets that have subsequently become credit-impaired, interest income is recognised by applying the effective interest rate to the amortised cost of the financial asset. If, in subsequent reporting periods, the credit risk on the credit-impaired financial instrument improves so that the financial asset is no longer credit-impaired, interest income is recognised by applying the effective interest rate to the gross carrying amount of the financial asset.

Interest income is recognised in profit or loss and is included in the "Revenue" line item (note 5).

#### Financial assets at FVPL

Financial assets at FVPL are measured at fair value at the end of each reporting period, with any fair value gains or losses recognised in profit or loss to the extent they are not part of a designated hedging relationship. The net gain or loss recognised in profit or loss excludes any interest earned on the financial asset and is included in the 'other operating expenses' line item. Fair value is determined in the manner described in note 25(d).

#### Impairment of financial assets

Expected credit loss ("**ECL**") are a probability-weighted estimate of credit losses. Credit losses are measured as the present value of all expected cash shortfalls (i.e. the difference between the cash flows due to the Group in accordance with the contract and the cash flows that the Group expects to receive).

The expected cash shortfalls are discounted using the following discount rates where the effect of discounting is material:

- fixed-rate financial assets, trade and other receivables: effective interest rate determined at initial recognition or an approximation thereof;
- variable-rate financial assets: current effective interest rate;

The maximum period considered when estimating ECLs is the maximum contractual period over which the Group is exposed to credit risk.

In measuring ECLs, the Group takes into account reasonable and supportable information that is available without undue cost or effort. This includes information about past events, current conditions and forecasts of future economic conditions.

ECLs are measured on either of the following bases:

- 12-month ECLs: these are losses that are expected to result from possible default events within the 12 months after the reporting date; and
- lifetime ECLs: these are losses that are expected to result from all possible default events over the expected lives of the items to which the ECL model applies.

The Group recognises a loss allowance for expected credit losses on loan receivables (exclude pawn loans at FVPL) that are measured at amortised cost. The amount of expected credit losses is updated at each reporting date to reflect changes in credit risk since initial recognition of the respective financial instrument.

The Group always recognises lifetime ECL for trade receivables. The expected credit losses on these financial assets are estimated using individual basis based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current as well as the forecast direction of conditions at the reporting date, including time value of money where appropriate.

For all other financial instruments, the Group measures the loss allowance equal to 12-month ECL, unless when there has a significant increase in credit risk since initial recognition, the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increase in the likelihood or risk of a default occurring since initial recognition.

#### Significant increase in credit risk

In assessing whether the credit risk of a financial instrument has increased significantly since initial recognition, the Group compares the risk of default occurring on the financial instrument assessed at the reporting date with that assessed at the date of initial recognition. In respect of the mortgage loans and pawn loan receivables at amortised cost which have been past due for less than 1 month, the amounts mainly represent occasional delay in repayment and are not an indication of significant deterioration of credit guality of the mortgage loans and pawn loan receivables at amortised cost. The Group considers both guantitative and gualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort. Forward-looking information considered includes the future prospects of the debtors' repayment ability as well as consideration of various external sources of actual and forecast economic information that relate to the Group's operations.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly since initial recognition:

- failure to make payments of principal or interest on their contractually due dates;
- an actual or expected significant deterioration in a financial instrument's external or internal credit rating (if available);
- an actual or expected significant deterioration in the operating results of the debtor;
- existing or forecast adverse changes in business, financial or economic conditions that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations;
- an actual or expected significant adverse change in the regulatory, economic, or technological environment of the debtor that results in a significant decrease in the debtor's ability to meet its debt obligations.

### Significant increase in credit risk (CONT'D)

Depending on the nature of the financial instruments, the assessment of a significant increase in credit risk is performed on either an individual basis or a collective basis. When the assessment is performed on a collective basis, the financial instruments are grouped based on shared credit risk characteristics, such as past due status and credit risk ratings.

Despite the foregoing, the Group assumes that the credit risk on a debt instrument has not increased significantly since initial recognition if the debt instrument is determined to have low credit risk at the reporting date. A financial instrument is determined to have low credit risk if i) the financial instrument has a low risk of default, ii) the borrower has a strong capacity to meet its contractual cash flow obligations in the near term, and iii) adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow obligations.

ECLs are remeasured at each reporting date to reflect changes in the financial instrument's credit risk since initial recognition. Any change in the ECL amount is recognised as an impairment gain or loss in profit or loss. The Group recognises an impairment gain or loss for all financial instruments with a corresponding adjustment to their carrying amount through a loss allowance account.

### Definition of default

The Group considers the following as constituting an event of default for internal credit risk management purposes as historical experience indicates that receivables that meet either of the following criteria are generally not recoverable:

- when there is a breach of financial covenants by the debtor; or
- information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group).

#### Definition of default (CONT'D)

In making this reassessment, the Group considers that a default event occurs when (i) the borrower is unlikely to pay its credit obligations to the Group in full, without recourse by the Group to actions such as realising security (if any is held); or (ii) the financial asset is 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

#### Credit-impaired financial assets

A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- significant financial difficulties of the debtor;
- a breach of contract, such as a default or delinquency in interest or principal payments;
- it becoming probable that the borrower will enter into bankruptcy or other financial reorganisation;
- the disappearance of an active market for a security because of financial difficulties of the debtor.

### Write-off policy

The gross carrying amount of a financial asset is written off (either partially or in full) to the extent that there is no realistic prospect of recovery. This is generally the case when the Group determines that the debtor does not have assets or sources of income that could generate sufficient cash flows to repay the amounts subject to the write-off.

Subsequent recoveries of an asset that was previously written off are recognised as a reversal of impairment in profit or loss in the period in which the recovery occurs.

#### Measurement and recognition of expected credit losses

The measurement of expected credit losses is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward-looking information as described above. As for the exposure at default, for financial assets, this is represented by the assets' gross carrying amount at the reporting date.

For financial assets, the expected credit loss is estimated as the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive, discounted at the original effective interest rate.

If the Group has measured the loss allowance for a financial instrument at an amount equal to lifetime ECL in the previous reporting period, but determines at the current reporting date that the conditions for lifetime ECL are no longer met, the Group measures the loss allowance at an amount equal to 12-month ECL at the current reporting date, except for assets for which simplified approach was used.

#### Derecognition of financial assets

A financial asset is derecognised only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity.

On derecognition of a financial asset in its entirety, the difference between the asset's carrying amount and the sum of the consideration received and receivable is recognised in profit or loss.

### Classification as debt or equity

Debt and equity instruments issued by a group entity are classified as either financial liabilities or as equity in accordance with the substance of the contractual arrangements and the definitions of a financial liability and an equity instrument.

#### Equity instruments

An equity instrument is any contract that evidences a residual interest in the assets of an entity after deducting all of its liabilities. Equity instruments issued by a group entity are recognised at the proceeds received, net of direct issue costs.

Repurchase of the Company's own equity instruments is recognised and deducted directly in equity. No gain or loss is recognised in profit or loss on the purchase, sale, issue or cancellation of the Company's own equity instruments.

#### Financial liabilities

All financial liabilities are subsequently measured at amortised cost using the effective interest method.

#### Financial liabilities subsequently measured at amortised cost

Financial liabilities that are not 1) contingent consideration of an acquirer in a business combination, 2) held-for-trading, or 3) designated as at FVPL, are subsequently measured at amortised cost using the effective interest method.

The effective interest method is a method of calculating the amortised cost of a financial liability and of allocating interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial liability, or, where appropriate, a shorter period, to the amortised cost of a financial liability.

Interest expense is recognised on an effective interest basis.

A financial liability is derecognised when, and only when, the Group's obligations are discharged, cancelled or they expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable is recognised in profit or loss.

#### Leasing

#### Definition of a lease

Under HKFRS 16, a contract is, or contains, a lease if the contract conveys a right to control the use of an identified asset for a period of time in exchange for consideration.

#### The Group as leasee

For contracts entered into or after the date of initial application, the Group assesses whether a contract is or contains a lease, at inception of the contract. The Group recognises a right-of-use asset and a corresponding lease liability with respect to all lease arrangements in which it is the lessee, except for short-term leases (defined as leases with a lease term of 12 months or less from the commencement date and do not contain a purchase option). For these leases, the Group recognises the lease payments as an operating expense on a straight-line basis over the term of the lease.

#### Lease liabilities

At the commencement date, the Group measures lease liability at the present value of the lease payments that are not paid at that date. The lease payments are discounted by using the interest rate implicit in the lease. If this rate cannot be readily determined, the Group uses its incremental borrowing rate.

Lease payments included in the measurement of the lease liability comprise fixed lease payments (including in-substance fixed payments), less any lease incentives receivable.

The lease liability is presented as a separate line in the consolidated statement of financial position.

The lease liability is subsequently measured by increasing the carrying amount to reflect interest on the lease liability (using the effective interest method) and by reducing the carrying amount to reflect the lease payments made.

#### Right-of-use assets

The right-of-use assets comprise the initial measurement of the corresponding lease liability, lease payments made at or before the commencement date and any initial direct costs, less lease incentives received.

Whenever the Group incurs an obligation for costs to dismantle and remove a leased asset, restore the site on which it is located or restore the underlying asset to the condition required by the terms and conditions of the lease, a provision is recognised and measured under HKAS 37 "Provision, Contingent Liabilities and Contingent Assets". The costs are included in the related right-of-use asset, unless those costs are incurred to produce inventories.

Rights-of-use assets are subsequently measured at cost less accumulated depreciation and impairment losses other than adjustments to lease liabilities resulting from COVID-19 related rent concessions in which the Group applied the practical expedient. They are depreciated over the shorter period of lease term and useful life of the underlying asset. The depreciation starts at the commencement date of the lease.

The Group presents right-of-use assets as a separate line in the consolidated statement of financial position.

The Group applies HKAS 36 to determine whether a rightof-use asset is impaired and accounts for any identified impairment loss.

### COVID-19-Related Rent Concessions

For rental concessions relating to lease contracts that occurred as a direct consequence of the COVID-19 pandemic, the Group has elected to apply the practical expedient not to assess whether a COVID-19-Related Rent Concession for lease contracts is a lease modification. The practical expedient only applies to rent concessions occurring as a direct consequence of the COVID-19 that meets all of the following conditions:

- the change in lease payments results in revised consideration for the lease that is substantially the same as, or less than, the consideration for the lease immediately preceding the change;
- any reduction in lease payments affects only payments originally due on or before 30 June 2022; and
- there is no substantive change to other terms and conditions of the lease.

A lessee applying the practical expedient accounts for changes in lease payments resulting from rent concessions the same way it would account for the changes applying HKFRS 16 Leases if the changes were not a lease modification. Forgiveness or waiver of lease payments are accounted for as variable lease payments. The related lease liabilities are adjusted to reflect the amounts forgiven or waived with a corresponding adjustment recognised in the profit or loss in the period in which the event occurs.

The Group enters into lease agreements as a lessor. Leases for which the Group is a lessor are classified as finance or operating leases. Whenever the terms of the lease transfer substantially all the risks and rewards of ownership to the lessee, the contract is classified as a finance lease. All other leases are classified as operating leases.

When a contract includes both lease and non-lease components, the Group applies HKFRS 15 to allocate the consideration under the contract to each component.

### Sublease

When the Group is an intermediate lessor, it accounts for the head lease and the sublease as two separate contracts. The sublease is classified as a finance or operating lease by reference to the right-of-use asset arising from the head lease, rather than by reference to the underlying asset. If the head lease is a short-term lease to which the group applies the exemption described above, the sublease shall be classified as an operating lease.

Rental income from operating leases is recognised on a straight-line basis over the term of the relevant lease.

#### **Plant and equipment**

Plant and equipment are stated in the consolidated statement of financial position at cost less subsequent accumulated depreciation and subsequent accumulated impairment loss, if any.

Depreciation is recognised so as to allocate the cost of items of plant and equipment over their estimated useful lives, using the straight-line method. The estimated useful lives and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

An item of plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

### Impairment losses on plant and equipment and rightof-use assets

At the end of the reporting period, the Group reviews the carrying amounts of its plant and equipment and rightof-use assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss, if any. When it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit (the "**CGU**") to which the asset belongs. When a reasonable and consistent basis of allocation can be identified, corporate assets are also allocated to individual CGU, or otherwise they are allocated to the smallest group of CGU for which a reasonable and consistent allocation basis can be identified.

Recoverable amount is the higher of fair value less costs of disposal and value-in-use. In assessing value-in-use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

廠房及設備按成本減其後累計折舊及其後累計 減值虧損(如有)於綜合財務狀況表列賬。

折舊乃按估計可使用年期以直線法分配廠房及 設備項目之成本予以確認。估計可使用年期及折 舊法於各報告期末予以檢討,並按預期基準將任 何估計變動之影響入賬。

廠房及設備項目於出售或預期不會因繼續使用 該資產而產生未來經濟利益時終止確認。因出售 或報廢某項廠房及設備項目而產生的任何收益 或虧損乃按銷售所得款項與資產賬面值之間的 差額釐定,並於損益確認。

### Impairment losses on plant and equipment and rightof-use assets (CONT'D)

If the recoverable amount of an asset (or a CGU) is estimated to be less than its carrying amount, the carrying amount of the asset (or a CGU) is reduced to its recoverable amount. For corporate assets or portion of corporate assets which cannot be allocated on a reasonable and consistent basis to a CGU, the Group compares the carrying amount of a group of CGU, including the carrying amounts of the corporate assets or portion of corporate assets allocated to that group of CGU, with the recoverable amount of the group of CGU. In allocating the impairment loss, the impairment loss is allocated first to reduce the carrying amount of any goodwill (if applicable) and then to the other assets on a pro-rata basis based on the carrying amount of each asset in the unit or the group of CGU. The carrying amount of an asset is not reduced below the highest of its fair value less costs of disposal (if measurable), its value in use (if determinable) and zero. The amount of the impairment loss that would otherwise have been allocated to the asset is allocated pro rata to the other assets of the unit or the group of CGU. An impairment loss is recognised immediately in profit or loss.

Where an impairment loss subsequently reverses, the carrying amount of the asset (or a CGU) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or a CGU) in prior years. A reversal of impairment loss is recognised immediately in profit or loss.

#### **Repossessed assets**

In the recovery of impaired loan receivables granted under the Pawnbrokers Ordinance (Chapter 166 of the laws of Hong Kong), the Group takes possession of the collateral assets from the customers. This possession takes place once a loan becomes overdue, subject to a grace period granted at the discretion of the Group in certain cases.

Repossessed assets are initially recognised at the amortised cost of the related outstanding loans on the date of repossession, which is generally below the net realisable value of the repossessed assets. Upon repossession of the assets, the related loan receivables are derecognised from the consolidated statement of financial position. Repossessed assets are carried at the lower of the amount initially recognised or net realisable value and are therefore written down if and when the net realisable value falls to below the carrying amount of the asset. The excess/shortfall of the net proceeds over the carrying amount of the repossessed assets is recognised as a gain/loss upon the disposal of the assets.

#### Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Bank overdrafts that are repayable on demand and form an integral part of the Group's cash management are also included as a component of cash and cash equivalents for the purpose of the consolidated cash flow statement.

### 經收回資產

在收回根據香港法例第166章當押商條例發放之 已減值應收貸款時,本集團管有客戶提供之抵押 品資產。此項管有行動在貸款逾期時作出,惟本 集團於若干情況下可酌情給予寬限期。

經收回資產初始按相關尚未償還貸款於收回日 之攤銷成本確認,而該價值通常低於經收回資產 之可變現價值淨額。於收回資產後,相關應收貸 款自綜合財務狀況表終止確認。經收回資產按初 始確認款項或可變現價值淨額之較低者入賬,並 因此於倘及當可變現價值淨額低於資產賬面值 時撇銷。出售資產後,所得款項淨額超逾/少於 經收回資產賬面值之部分確認為收益/虧損。

#### 現金及現金等價物

現金及現金等價物包括銀行及手頭現金、於銀行 之活期存款,以及可隨時兑換為已知金額現金且 承受之價值變動風險並不重大之短期、高流動性 投資(在購入後三個月內到期)。按要求償還之 銀行透支構成本集團現金管理不可或缺之一部 分,於編製綜合現金流量表時亦計入現金及現金 等價物部分。

#### **Provisions and contingent liabilities**

Provisions are recognised for liabilities of uncertain timing or amount when the Group has a legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditures expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events, are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

#### **Income tax**

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit before taxation as reported in the consolidated statement of profit or loss and other comprehensive income because it excludes items of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

### 撥備及或然負債

當本集團因過去事件須承擔法定或推定責任, 而履行該責任很可能需要付出經濟利益及能可 靠估計時,則就未確定時間或金額之負債確認撥 備。倘貨幣之時間值重大,則撥備會以履行該等 責任預期支出現值列賬。

倘不大可能需要經濟利益流出,或其數額未能可 靠估計,除非經濟利益流出之可能性極低,否則 須披露該等責任為或然負債。其存在僅能以一 宗或多宗未來事件之發生與否來確定之潛在責 任,除非經濟利益流出之可能性極低,否則亦披 露為或然負債。

#### 所得税

所得税開支乃應付即期税項及遞延税項之總 和。

應付即期税項乃按年度應課税溢利計算。應課税 溢利與綜合損益及其他全面收入表所呈報之除 税前溢利不同,原因是其不包括其他年度之應課 税或可扣減收入或支出項目,亦進一步不包括毋 須課税或不可扣減項目。本集團即期税項負債 乃按各報告期末已頒佈或實質已頒佈之税率計 算。

#### Income tax (CONT'D)

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary difference to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rate (and tax laws) that have been enacted or substantively enacted by the end of the reporting period. When different tax rates apply to different levels of taxable income, deferred tax assets and liabilities are measured using the average tax rates that are expected to apply to the taxable income of the periods in which the temporary differences are expected to reverse.

遞延税項就綜合財務報表內資產及負債賬面值 與計算應課税溢利所採用相應税基間之暫時差 額確認。遞延税項負債通常就所有應課税暫時差 額確認。遞延税項資產通常在很可能將有可動用 可扣減暫時差額抵銷之應課税溢利之情況下就 所有可扣減暫時差額確認。倘該暫時差額乃源自 商譽或初始確認一項交易(業務合併除外)中其 他資產與負債,且並無影響應課税溢利或會計溢 利,則不會確認該等遞延税項資產與負債。

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied by the same taxation authority and the Group intends to settle current tax liabilities and assets on a net basis.

Current and deferred tax are recognised in profit or loss.

#### **Employee benefits**

#### Short-term employee benefits

A liability is recognised for benefits accruing to employees in respect of salaries, annual bonus, paid annual leave and the cost of non-monetary benefits in the period the related service is rendered at the undiscounted amount of the benefits expected to be paid in exchange for that service.

Liabilities recognised in respect of short-term employee benefits are measured at the undiscounted amount of the benefits expected to be paid in exchange for the related service.

#### **Retirement benefits**

Retirement benefits are provided by the Group under the Mandatory Provident Fund Scheme (the "**MPF Scheme**") as defined contribution schemes. The employer's monthly contributions to the scheme are at a maximum of 5% of each employee's monthly salary, subject to a cap of monthly relevant income of \$30,000.

The cost of all these schemes is charged to profit or loss of the Group for the year concerned and the assets of all these schemes are held separately from those of the Group.

所有該等計劃之成本於本集團相關年度之損益 內扣除,而所有該等計劃的資產與本集團的資產 分開持有。

#### Long service payments

Certain of the Group's employees have completed the required number of years of service to the Group in order to be eligible for long service payments under the Hong Kong Employment Ordinance in the event of the termination of their employment. The Group is liable to make such payments in the event that such a termination of employment meets the circumstances specified in the Employment Ordinance.

A provision is recognised in respect of probable future long service payments based on the best estimate of the probable future outflow of resources which have been earned by the employees from their service to the Group at the reporting date.

#### Government grants

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received.

Government grants related to income that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable.

### **Related parties**

- (a) A person, or a close member of that person's family, is related to the Group if that person:
  - (i) has control or joint control over the Group;
  - (ii) has significant influence over the Group;
  - (iii) is a member of the key management personnel of the Group or the Group's parent.

### **Segment reporting**

Operating segments, and the amounts of each segment item reported in the financial statements, are identified from the financial statements provided regularly to the Group's most senior executive management for the purposes of allocating resources to, and assessing the performance of, the Group's various lines of businesses and geographical locations.

Individually material operating segments are not aggregated for financial reporting purposes unless the segments have similar economic characteristics and are similar in respect of the nature of products and services, the nature of production processes, the type of class of customers, the methods used to distribute the products or provide the services, and the nature of the regulatory environment. Operating segments which are not individually material may be aggregated if they share a majority of these criteria.

### **Borrowing costs**

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets until such time as the assets are substantially ready for their intended use or sale.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

### Fair value measurement

When measuring fair value, except for the net realisable value of repossessed assets and leasing transactions, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs. Specifically, the Group categorised the fair value measurements into three levels, based on the characteristics of inputs, as follows:

- Level 1: Quoted (unadjusted) market prices in active markets for identical assets or liabilities.
- Level 2: Valuation techniques for which the lowest level input that is significant to the fair value measurement is directly or indirectly observable.
- Level 3: Valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable.

At the end of the reporting period, the Group determines whether transfer occur between levels of the fair value hierarchy for assets and liabilities which are measured at fair value on recurring basis by reviewing their respective fair value measurement.

## 4 KEY SOURCES OF ESTIMATION 4 UNCERTAINTY

In the application of the Group's accounting policies, which are described in note 3, the Directors are required to make estimates and assumptions about amounts of assets, liabilities, revenue and expenses reported and disclosures made in the consolidated financial statements. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an on-going basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

### Key sources of estimation uncertainty

The following is the key assumption concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that has a significant risk of resulting in a material adjustment to the carrying amounts of assets within the next financial year.

### Impairment of loan receivables

The Group determines the impairment of loan receivables based on assumptions about ECL. Key parameters included the identification of loss stages, estimation of probability of default, loss given default, exposures at default, discount rate, adjustments for forward-looking information and other adjustment factors including value of collaterals. At every reporting date, the default rates are updated. Changes in these assumptions and estimates could materially affect the result of the assessment and it may be necessary to make additional impairment charge to the consolidated statement of profit or loss and other comprehensive income.

As at 28 February 2022, the carrying amount of loan receivables was approximately HK\$789.7 million (2021: HK\$838.6 million) net of nil accumulated impairment (2021: HK\$5.1 million). During the year ended 28 February 2022, an impairment loss of approximately HK\$2.3 million (2021: HK\$2.0 million) have been recognised. The impairment loss of HK\$7.3 million was fully written off during the year (2021: nil).

On 21 March 2018, the Hong Kong Legislative Council passed The Inland Revenue (Amendment) (No. 7) Bill 2017 (the "**Bill**") which introduces the two-tiered profits tax rates regime. The Bill was signed into law on 28 March 2018 and was gazetted on the following day. Under the two-tiered profits tax rates regime, the first HK\$2.0 million of profits of qualifying corporation will be taxed at 8.25%, and profits above HK\$2.0 million will be taxed at 16.5%. For both years, Hong Kong profits tax of the qualified entity of the Group is calculated in accordance with the two-tiered profits tax rates regime. The profits of other Group entities in Hong Kong not qualifying for the two-tiered profits tax rates regime will continue to be taxed at the flat rate of 16.5%.

During the year ended 28 February 2021, an under provision for Hong Kong Profits Tax was mainly arising from part of the advertising expenses in previous years were subsequently disqualified as deductible expense by Hong Kong Inland Revenue Department.

The Group's primary objectives when managing capital are to safeguard the Group's ability to continue as a going concern, so that it can continue to provide returns for its shareholders and benefits for other stakeholders, by pricing products commensurately with the level of risk and by securing access to finance at a reasonable cost. The Group was not subject to external imposed capital requirements, except for the loan covenants attached to the interest-bearing borrowings.

The capital structure of the Group consists of cash and cash equivalents net of bank loans and overdrafts, other loans, loans from the immediate holding company, debt securities issued and equity attributable to shareholders of the Company, comprising paid in capital and reserves.

The Group actively and regularly reviews and manages its capital structure to maintain a balance between the higher shareholder returns that might be possible with higher levels of borrowings and the advantages and security afforded by a sound capital position, and makes adjustments to the capital structure in light of changes in economic conditions.

The Group monitors capital with reference to its debt position. The Group's strategy was to maintain the equity and debt in a balanced position with the debt equity ratio, being the Group's total borrowings over its total equity, no more than 150%, and ensure there was adequate working capital to repay its debt obligations. As at 28 February 2022 the Group and the Company's debt equity ratio were 15.0% (2021: 26.2%) and 27.0% (2021: 44.4%) respectively. No change was made on the Group's overall strategy.

### Financial risk management objectives and policies

The Group's major financial instruments include loan receivables, trade and other receivables, cash and cash equivalents, accruals and other payables, bank loans and overdrafts, other loans, loans from the immediate holding company and debt securities issued. Details of the financial instruments are disclosed in respective notes. The risks associated with these financial instruments include market risk (interest rate risk), credit risk and liquidity risk. The policies on how to mitigate these risks are set out below. The management manages and monitors these exposures to ensure appropriate measures are implemented on a timely and effective manner.

As the core business of the Group is engaged in secured financing business in Hong Kong, including pawn loans and mortgage loans, the main risks associated with its business are credit risk and the need to maintain a fairly liquid position.

### (a) Credit risk management

The Group's maximum exposure to credit risk in the event of the counterparties' failure to perform their obligations in relation to each class of recognised financial assets is the carrying amount of those assets as stated in the consolidated statement of financial position. The Group's credit risk is primarily attributable to its loan receivables. In order to minimise the credit risk, the Group have established policies and systems for the monitoring and control of credit risk.

The Group has developed and adopted a systematic approach in running its business in an efficient way, including the adoption of internal control procedures for risk management purposes.

The Group manages its credit risk on a conservative basis by evaluating its loan portfolio in relation of quantitative risk/return criteria.

In relation to the pawn loan business, the Group has adopted internal control procedures including the identification and evaluation of ownership and obtaining an accurate valuation of personal property. The Group usually grants loans with a loan-to-value ratio ranging from 50% – 85%, depending on the type of collateral and the valuation is made at the point of granting the loan. The maximum exposure of the credit risk arising from pawn loan business at the end of each reporting period is the carrying amount of the pawn loan receivables as stated in the consolidated statement of financial position.

A customer is considered to have defaulted in repayment of the pawn loan if they have not redeemed the collateral or renewed the pawn loan by the end of the term of the pawn loan. At the Group's sole discretion, a grace period of up to six weeks may be provided to customers after the end of the loan period during which the Group may allow the customers to renew the pawn loan and/or redeem the collateral. The Group will take possession of the collateral if the customer has not redeemed the collateral or renewed the pawn loan by the end of the loan period or the grace period provided. Repossessed assets are accounted for in accordance with the accounting policy as set out in note 3 and the carrying amount of repossessed assets as at 28 February 2022 was approximately HK\$7,481,000 (2021: HK\$6,228,000). The Group will proceed to dispose the collateral within a reasonable time after possession.

### (a) Credit risk management (CONT'D)

In relation to the mortgage loan business, the Group has also adopted internal control procedures for the identification and evaluation of the legal ownership and accurate valuation of property. As a matter of risk management, the Group usually grants loans with a loan-to-value ratio of no more than 70% of the value in the valuation report of the property, which is generally lower than bank's loan-to-value ratio for mortgages which can be as high as 70%. In a few cases if the customers request loans with the loanto-value ratio of over 70%, approval from the chief executive officer is required. For the valuation of the property, the Group will make reference to a third party valuer and/or the internet valuation services provided by banks in Hong Kong. The Group holds collateral against loan receivables in the form of mortgages over properties located in Hong Kong. The Group considers that the credit risk arising from the mortgage loan receivables is significantly mitigated by the property held as collateral, with reference to the estimated market value of the property at the grant date. The Group may take possession of assets held as collateral through court proceeding or voluntary delivery of possession by the borrowers. It disposes the property by auction once receiving the possession.

Management has overall responsibility for the Group's credit policies and oversees the credit quality of the Group's loan portfolio. In addition, management reviews the recoverable amount of loan receivables individually at each reporting date to ensure that adequate impairment losses are made for irrecoverable amounts. For trade receivables, the Group has applied the simplified approach in HKFRS 9 to measure the loss allowance at lifetime ECL. The Group determines the ECL by using individual basis, estimated based on historical credit loss experience, as well as the general economic conditions of the industry in which the debtors operate. In this regard, management considers that the Group's credit risk is significantly reduced.

#### (a) Credit risk management (CONT'D)

For other non-traded related receivables, the Group has assessed whether there has been a significant increase in credit risk since initial recognition. If there has been a significant increase in credit risk, the Group will measure the loss allowance based on lifetime rather than 12-month ECL.

The Group's exposure to credit risk is influenced mainly by the individual characteristics of each customer and therefore significant concentrations of credit risk primarily arise when the Group has significant exposure to individual customers. At the end of the reporting period, 7.6% (2021: 6.3%) and 28.5% (2021: 21.6%) of the total loan receivables was due from the Group's largest customer and the five largest customers respectively.

Although most of the customers are from Hong Kong, the concentration of credit risk is limited due to the customer base is large and unrelated.

The credit risk on liquid funds is limited because the counterparties are banks with high credit ratings assigned by international credit-rating agencies.

Further quantitative disclosures in respect of the Group's exposure to credit risk arising from loan receivables are set out in note 15.

The Group has developed its processes for measuring ECL including monitoring of credit risk, incorporation of forward-looking information and the methodology used to measure ECL. The Group has policies and procedures in place to appropriately maintain the models used to assess and measure ECL.

本集團所承受信貸風險主要受到每名客戶 之個別特性所影響,故重大信貸風險集中 主要由於本集團與個別客戶往來時所承受 重大風險所致。於報告期末,應收貸款總 額之7.6%(二零二一年:6.3%)及28.5% (二零二一年:21.6%)分別來自本集團最 大客戶及五大客戶。

儘管大部分客戶來自香港,風險利率之集 中度仍有限,此乃由於客戶基礎龐大且不 相關。

流動資金之信貸風險有限,因為對手方為 獲國際信貸評級機構授予高信貸評級之銀 行。

### (b) Market risk management

The Group's activities expose it primarily to the financial risks of changes in interest rate.

#### Interest rate risk

The Group is exposed to fair value interest rate risk in relation to certain loan receivables, loans from the immediate holding company, debt securities issued and lease liabilities which carried at fixed rates.

The Group is also exposed to cash flow interest rate risk in relation to variable rate mortgage loan receivables, bank loans and overdrafts, other loans and cash at banks.

It is the Group's policy to keep its certain of its mortgage loan receivables, bank loans and overdrafts and other loans at floating rate of interests so as to minimise the fair value interest rate risk. The Group's cash flow interest rate risk is mainly concentrated on the fluctuation of prime rate, HIBOR and HSBC prime rate.

(i) Sensitivity analysis

The sensitivity analysis below has been determined based on the exposure of the Group at the end of the reporting period. The analysis is prepared assuming that the financial instruments outstanding at the end of the reporting period were outstanding for the whole year. A 100 basis points (2021: 100 basis points) increase or decrease is used when reporting interest rate risk internally to key management personnel and represents management's assessment of the reasonably possible change in interest rates.

At 28 February 2022, it is estimated that a general increase/decrease of 100 basis points (2021: 100 basis points) in interest rates, with all other variables held constant, would have decreased/increased the Group's profit after tax by approximately HK\$2,420,000 (2021: HK\$3,247,000).

### (c) Liquidity risk management

The Group's policy is to regularly monitor its liquidity requirements and its compliance with loan/borrowing covenants, to ensure that it maintains sufficient reserves of cash and adequate committed lines of funding from major financial institutions and immediate holding company to meet its liquidity requirements in the short and long-term. The Directors are satisfied that the Group will be able to meet in full its financial obligations as and when fall due in the foreseeable future.

The following table details the remaining contractual maturities at the end of the reporting period of the Group's financial liabilities and lease liabilities, which are based on contractual undiscounted cash flows (including interest payments computed using contractual rates or, if floating, based on rates current at the end of the reporting period) and the earliest date the Group can be required to pay. During the year ended 28 February 2022, the Group entered into new arrangements in respect of leased properties. Right-of-use assets and lease liabilities of approximately HK\$17,648,000 (2021: nil) were recognised at the commencement of the leases.

#### (b) COVID-19-related rent concession

During the year ended 28 February 2022, the Group received approximately HK\$1,007,000 (2021: HK\$694,000) rent concessions in the form of a discount on fixed payments during the period of severe social distancing and travel restriction measures introduced to contain the spread of COVID-19.

### **29 RETIREMENT BENEFITS SCHEME**

The Group operates the MPF Scheme for all qualifying employees in Hong Kong. The assets of the schemes are held separately from those of the Group, in funds under the control of trustees. The Group contributes 5% of relevant payroll costs, capped at HK\$1,500 per month, to the MPF Scheme, in which the contribution is matched by employees. The only obligation of the Group with respect to the MPF Scheme is to make the required contributions under the Scheme. No forfeited contribution is available to reduce the contribution payable in future year.

The total cost charged to consolidated statement of profit or loss and other comprehensive income of approximately HK\$581,000 (2021: HK\$580,000) represents contributions payable to this scheme by the Group in respect of the current accounting period.
