# 主席報告

## Chairman's Statement

本人謹代表董事會（「董事會」）呈報環科國際集團有限公司（「本公司」）及其附屬公司（組成「本集團」）截至2022年3月31日止財政年度之年報。

### 業績

本集團截至2022年3月31日止年度之經審核綜合股東應佔虧損約為14,100,000港元。根據1,946,314,108已發行普通股計算之每股虧損為0.72港仙。

### 股息

董事會已議決不建議派發截至2022年3月31日止年度之任何末期股息（2021年：無）。

### 業務回顧

截至2022年3月31日止年度，本集團錄得綜合收入約114,600,000港元，較去年綜合收入約37,200,000港元增加約77,400,000港元或208.1%。

On behalf of the board of directors (the "Board"), I would like to present the annual report of G-Vision International (Holdings) Limited (the "Company") and its subsidiaries (together the "Group") for the financial year ended 31 March 2022.

### RESULTS

The audited consolidated loss attributable to the shareholders of the Group for the year ended 31 March 2022 was approximately HK\$14.1 million. Loss per share based on 1,946,314,108 ordinary shares in issue amounted to HK\$0.72 cents.

### DIVIDEND

The Board has resolved not to recommend the payment of a final dividend for the year ended 31 March 2022 (2021: Nil).

### REVIEW OF OPERATIONS

For the year ended 31 March 2022, the Group recorded consolidated revenue of approximately HK\$114.6 million, representing an increase of approximately HK\$77.4 million or 208.1% from last year's consolidated revenue of approximately HK\$37.2 million.

### 香港酒樓業務

本集團主要在香港經營以潮州菜為特色的中式酒樓。於回顧期內，酒樓業務收入約為40,600,000港元，較去年同期約37,200,000港元增加約3,400,000港元或9.1%。

隨著社交距離措施的逐步放鬆，酒樓業務在本財政年度上半年有所改善。此外，香港政府（「香港政府」）恢復本地遊及推出港幣360億元消費券計劃，對本集團酒樓的整體表現帶來了正面影響。

本集團於2021年9月30日租約屆滿時終止長沙灣廣場的酒樓業務，但會重新考慮在類似地點開設新餐廳，但須與業主作進一步磋商。

於2021年7月28日，本集團公佈計劃於觀塘裕民坊開設新分店，名稱為「潮觀城酒樓」（「潮觀城」）。根據上市規則，訂立自2021年9月1日起為期五年的固定期限租賃要約被視為本集團收購資產。根據香港財務報告準則第16號，於租賃開始時，本集團根據租賃要約確認的使用權資產約為13,600,000港元。由於潮觀城仍在裝修，本集團於2021年10月及2021年11月期間的收入較低。開業儀式在2021年12月7日隆重舉行。在潮觀城的額外貢獻下，本集團於2021年12月和2022年1月期間的收入得到進一步提升。

### Restaurant Operations in Hong Kong

The Group is mainly engaged in the operation of Chinese restaurants in Hong Kong which specialise in Chiu Chow cuisine. Revenue from the restaurant operations amounted to approximately HK\$40.6 million for the period under review, representing an increase of approximately HK\$3.4 million or 9.1% from the last corresponding period of approximately HK\$37.2 million.

The restaurant business improved in the first half of the financial year in line with the progressive relaxation of the social distancing measures. In addition, the resumption of local tours as well as the launching of the HK\$36 billion Consumption Voucher Scheme by the Hong Kong Government ("HK Govt") had brought a positive impact on the overall performance of our restaurants.

The Group discontinued its restaurant operations at the Cheung Sha Wan Plaza at the expiry of lease on 30 September 2021 but would reconsider to open a new restaurant at similar location subject to further negotiation with the landlord.

On 28 July 2021, the Group announced the plan to open a new branch at Yue Man Square, Kwun Tong under the trade name "Kwun Tong City Chiu Chow Restaurant" ("KTCCC"). The entering into the Offer to Lease for a fixed term of five years from 1 September 2021 would be regarded as an acquisition of asset by the Group under the Listing Rules. Pursuant to HKFRS 16, the right-of-use asset recognised by the Group under the Offer to Lease amounted to approximately HK\$13.6 million as at the commencement of lease. The revenue for the Group in the month of October 2021 and November 2021 were lower as the KTCCC was still under renovation. The grand opening ceremony was held on 7 December 2021. The revenue of the Group further improved with additional contribution from KTCCC in the month of December 2021 and January 2022.

### 香港酒樓業務(續)

然而，自2022年1月7日起，香港政府進一步收緊社交距離措施，並全面禁止下午6時後的堂食服務，以及限制每桌顧客的人數。酒樓允許四人一枱如果員工已接種疫苗及六人一枱如果員工及顧客都已接種疫苗。由於酒樓所有員工已於2022年1月上旬全面接種疫苗，因此本集團的酒樓能夠在最高規定標準下營運。然而，社區對感染COVID-19的擔憂日益增加，阻止了人們外出用膳之意欲。自2022年1月起，本集團酒樓的收入急劇下降。

儘管香港政府為遏制另一場疫情付出了巨大努力，但隨著確診的COVID-19病例在2022年2月和2022年3月達到頂峰，香港無可避免地進入第五波疫情。作為安全措施，集團決定自2022年2月中旬起暫停其酒樓業務近兩個月，導致2022年第一季度的收入約為260萬港元，創記錄新低。

本集團於2022年3月向香港政府申請第五及第六輪防疫抗疫基金的進一步資助，並於2022年3月收到950,000港元。由於本集團亦於2021年8月從第二輪防疫抗疫基金中收到1,100,000港元。截至2022年3月31日止年度，共收到2,050,000港元政府資助。去年同期收到的資助總額約為5,700,000港元。

### Restaurant Operations in Hong Kong (Continued)

However, from 7 January 2022, the HK Govt further tightened social distancing measures and imposed complete ban on dine-in services after 6 p.m. and restrictions on the number of patrons per table. Groups of four were allowed with vaccinated staff members and groups of six were only allowed for restaurants with both vaccinated staff and customers. As all our staff were fully vaccinated in early January 2022, the Group's restaurants were able to operate at the highest standard as permitted. However, the rising fear in the community of contracting COVID-19 deterred people from dining out. There was a drastic drop in revenue for the Group's restaurants from January 2022.

Despite HK Govt's tremendous effort to contain another outbreak, Hong Kong inevitably headed to the fifth wave of epidemic as confirmed COVID-19 cases peaked in the month of February and March 2022. As safety measures, the Group decided to suspend its restaurant operations for almost two months from mid of February 2022 resulting in a record low revenue of approximately HK\$2.6 million in the first quarter of 2022.

The Group applied for further subsidies from the HK Govt under the fifth and sixth round of the Anti-epidemic Fund and received HK\$0.95 million in the month of March 2022. As the Group also received HK\$1.1 million in August 2021 from the second round of the Anti-epidemic Fund, the total amount of government subsidies received for the year ended 31 March 2022 was \$2.05 million. The total amount of subsidies received in the last corresponding period was approximately \$5.7 million.

### 澳洲物業發展

於2019年10月18日，GV Australia Pty Ltd (本公司的全資附屬公司)與關連人士訂立協議，於澳洲新南威爾士州悉尼的卡姆登區之土地上開發及建設一幢低層公寓樓，包括26套公寓及若干公共設施。有關交易已由獨立股東於2019年11月29日舉行的股東特別大會上正式通過。

建築工程於2020年3月份在任命HT Building Pty Ltd為建築商後已展開。Rider Lovett Bucknall RLB Sydney，一間信譽良好之測量師行，為此項目的認證測量師。另外本集團已成立一個於當地的項目團隊，負責監察及監督施工進度。在COVID-19全球大流行和新南威爾士州的各種封鎖措施中，建設仍然能順利進行。於2021年10月發出該公寓樓的入伙證後，本集團收到並確認物業發展收入約12,900,000澳元(折合港幣74,000,000港元)及銷售成本約11,500,000澳元(折合66,300,000港元)為本集團貢獻毛利約1,400,000澳元(折合7,700,000港元)。截至2022年3月31日，已完成25套公寓的交收。

### Property Development in Australia

On 18 October 2019, GV Australia Pty Ltd (a wholly-owned subsidiary of the Company) entered into an agreement with a connected party in relation to the development and construction of a low-rise apartment block on the land comprising 26 apartments and certain communal facilities situated in Camden, Sydney, New South Wales, Australia. The transaction was approved by the shareholders of the Company at the special general meeting held on 29 November 2019.

The construction commenced following the appointment of HT Building Pty Ltd as the main contractor in March 2020. Rider Lovett Bucknall RLB Sydney, a reputable quantity surveyor firm, had been appointed as the certified quantity surveyor for the project. A project control team was set up to oversee and monitor the sales and development progress. The construction progressed well amidst the COVID-19 pandemic and the various lockdown measures in the state of New South Wales. Following the issue of the occupation certificate for the apartment block in October 2021, the Group received and recognised property development income of approximately A\$12.9 million (HK\$ equivalent of HK\$74.0 million) and cost of sales of approximately A\$11.5 million (HK\$ equivalent of HK\$66.3 million) contributing a gross profit of approximately A\$1.4 million (HK\$ equivalent of HK\$7.7 million) to the Group. As at 31 March 2022, settlement was completed for 25 apartments.

## Chairman's Statement

### 展望

由於COVID-19全球大流行和旅遊限制仍然持續，而各種社交距離措施亦仍然生效，香港餐飲行業及本集團酒樓業務的前景將非常黯淡。在充滿挑戰性的營商環境中，本集團對進一步的資本開支會採取更為謹慎的態度，並會實施各種措施來減輕這困難時期的損失，例如增加促銷和折扣以促進堂食和外賣業務，盡力向業主爭取租金減免並且暫停招聘全職和兼職員工。

本集團將繼續不時檢討及修改其業務策略，旨在改善本集團的狀況以應付未來之挑戰並把握任何新出現的投資機會。在澳洲之物業發展業務，已為本集團提供一個能擴大業務範圍和分散風險，並且能提高股東回報之合適機會。本集團將繼續拓展其物業發展業務，並積極物色於澳洲及香港之商機。

### PROSPECTS

With COVID-19 and travel restrictions still ongoing and the strict social-distancing measures still in effect, the outlook is bleak for the food and beverage industry in Hong Kong and the Group's restaurant operations. Amid the severely challenging operating environment, the Group will adopt a more cautious approach in committing further capital expenditure and will implement various measures to mitigate the loss during this difficult time such as increasing promotion and discount to boost dine-in and takeaway businesses, relentlessly negotiating rental concession with the landlords and suspending the hiring of full-time and temporary workers.

The Group will continue to review and revise its business strategies from time to time with an aim to better position itself to meet the challenges ahead and to capture any new investment opportunities as they arise. The property development project is considered as a suitable opportunity for the Group to expand its business activities and diversify risks with an aim to improve the returns for its shareholders. The Group will continue to expand its property development segment and is actively seeking investment opportunities both in Australia and in Hong Kong.

# 管理層討論及分析 Management Discussion and Analysis

## 財務回顧

截至2022年3月31日止年度，本集團錄得之綜合收入約114,600,000港元，較去年收入約37,200,000港元增加208.1%。收入大幅增加主要是由於本集團於澳洲的物業發展業務確認收入約74,000,000港元、香港酒樓業務收入約為40,600,000港元，較去年約37,200,000港元的收入增加9.1%。

本集團於回顧年度內錄得之虧損淨額約14,100,000港元，而去年同期則錄得虧損淨額約8,800,000港元。

毛利增加約10,000,000港元來自物業發展分部約7,700,000港元及酒樓業務分部約2,300,000港元。然而，毛利改善帶來的正面影響被香港政府（「香港政府」）補貼減少約3,700,000港元；外匯變動約4,400,000港元及潮濠城酒樓於10月初關閉後，物業、廠房及設備餘額被註銷約2,000,000港元所抵消。

自2020年4月起，本集團已根據防疫抗疫基金紓困計劃的各個階段從香港政府收到合共約7,250,000港元之補貼。截至2022年3月31日止年度，本集團根據餐飲處所（社交距離）資助計劃為酒樓業務確認補貼金額約2,100,000港元。截至2021年3月31日止年度，本集團根據餐飲業務（社交距離）補貼計劃為其酒樓業務確認約5,200,000港元補貼，另就保就業計劃為其管理公司確認約500,000港元補貼。

## FINANCIAL REVIEW

For the year ended 31 March 2022, the Group recorded consolidated revenue of approximately HK\$114.6 million, representing an increase of 208.1% from the previous year's revenue of approximately HK\$37.2 million. The substantial increase in revenue was primarily attributable to the recognition of approximately HK\$74.0 million of revenue from the Group's property development business in Australia. The revenue from the restaurant operations in Hong Kong was approximately HK\$40.6 million, representing an increase of 9.1% from previous year's revenue of approximately HK\$37.2 million.

The Group recorded a net loss of approximately HK\$14.1 million for the year under review compared to a net loss of approximately HK\$8.8 million for the last corresponding period.

The increase in gross profit of approximately HK\$10.0 million was contributed by the property development segment of approximately HK\$7.7 million and the restaurant operations segment of approximately HK\$2.3 million. The positive impact from the improvement in profit margin, however, was offset by the decrease in subsidies granted by the Hong Kong Government ("HK Govt") of approximately HK\$3.7 million; foreign exchange movement of approximately HK\$4.4 million and also the write-off of the remaining balances of property, plant and equipment for Hover City Chiu Chow Restaurant following its closure in the beginning of October 2021 of approximately HK\$2.0 million.

The Group had received in total approximately HK\$7.25 million subsidies from the HK Govt under various stages of the Anti-epidemic Fund relief schemes since April 2020. For the year ended 31 March 2022, the Group recognised subsidies amounting to approximately HK\$2.1 million under the Catering Business (Social Distancing) Subsidy Scheme for its restaurants. For the year ended 31 March 2021, the Group recognised approximately HK\$5.2 million under the Catering Business (Social Distancing) Subsidy Scheme for its restaurant operations and approximately HK\$0.5 million under the Employment Support Scheme for its management office.

### 財務回顧(續)

於回顧年度確認匯兌虧損約700,000港元，主要由於本集團以澳元計值的銀行結餘匯兌虧損所致。去年同期匯兌收益約3,700,000港元，乃由於以澳元計值的公司間貸款重估所致。截至2022年3月31日止年度，公司間貸款已全數償還。

於回顧年度員工成本總額約為19,200,000港元，較去年同期增加500,000港元。

潮觀城酒樓的新租約因應用香港財務報告準則第16號需增加使用權(「使用權」)資產及確認租賃負債分別約13,600,000港元。於回顧年度，使用權折舊及租賃負債的融資成本分別約為2,400,000港元及400,000港元。

考慮到香港COVID-19疫情的最新發展以及其對本集團未來現金流量的不利影響和不確定性後，管理層已調整了現金流量預測並對業務增長採取了更審慎的考慮，因而於回顧年度為本集團之使用權資產及物業、廠房及設備確認減值虧損分別約3,100,000港元和1,900,000港元。

### FINANCIAL REVIEW (Continued)

The exchange loss of approximately HK\$0.7 million recognised for the year under review was mainly due to the translation loss on the Group's bank balances which were denominated in Australian Dollar. The exchange gain of approximately HK\$3.7 million in the last corresponding period was due to the revaluation of the intercompany loan denominated in Australian dollar. The intercompany loan was fully repaid during the year ended 31 March 2022.

Total staff costs were approximately HK\$19.2 million for the year under review, representing an increase of HK\$0.5 million from the last corresponding period.

The adoption of HKFRS 16 on the new lease for Kwun Tong City Chiu Chow Restaurant resulted in an addition of right-of-use ("ROU") assets and the recognition of lease liability each of approximately HK\$13.6 million. The depreciation charged for the ROU and the finance costs on the lease liability amounted to approximately HK\$2.4 million and HK\$0.4 million respectively for the year under review.

After considering the latest development of the COVID-19 epidemic in Hong Kong and the adverse impact and uncertainties casted on the Group's future cash flows stream, the management had adjusted the cash flow forecast and adopted a more prudent view on the business growth resulted in the recognition of approximately HK\$3.1 million and HK\$1.9 million impairment losses on the Group's ROU assets and the property, plant and equipment respectively for the year ended under review.

### 香港酒樓業務

由2020年1月起，由於COVID-19全球大流行的爆發，以及香港政府實行一系列之社交距離及檢疫措施，香港餐飲業受到重創。截至2021年及2022年3月31日止年度，本集團酒樓之經營及財務業績受到嚴重影響：

#### 2021年4月至6月

隨著2020年11月出現的第四波COVID-19疫情受到控制，香港政府對提供堂食之餐飲處所實行「疫苗氣泡」政策以放寬社交距離措施，並於2021年4月29日起生效。根據「疫苗氣泡」政策，餐飲業務分為4種經營模式，其中的主要細節總結如下：

- A類：堂食服務可於每天早上5時至下午5時59分提供，處所內的顧客數目在任何時間均不得超過該處所通常座位數目的一半，並不得有多於2人同坐一桌。每次宴會的人數上限為20人。
- B類：所有顧客（不包括只購買外賣的人士）在進入處所前必須使用「安心出行」流動應用程式，或登記其姓名、聯絡電話及到訪處所的日期及時間。所有涉及處所運作的員工需每14天進行一次檢測。堂食服務可於每天早上5時至晚上9時59分提供，處所內的顧客數目在任何時間均不得超過該處所通常座位數目的一半，不得多於4人同坐一桌。每次宴會的人數上限為20人。

## BUSINESS REVIEW

### Restaurant Operations in Hong Kong

Since January 2020, the food and beverage industry in Hong Kong has been hit hard by the outbreak of the COVID-19 pandemic and the various social distancing and quarantine measures imposed by the HK Govt. The operations and financial results of the Group's restaurants in the years ended 31 March 2021 and 2022 were severely affected:

#### April to June 2021

As the fourth wave of the COVID-19 outbreak which emerged in November 2020 subsided, the HK Govt relaxed the social distancing measures by implementing the "vaccine bubble" policy to dine-in catering premises with effect from 29 April 2021. Under the "vaccine bubble" policy, catering businesses are classified into 4 types of mode of operation, the key details of which are summarised below:

- Type A: Dine-in services can be provided from 5 a.m. to 5:59 p.m. every day, with the number of customers at the catering premises at any one time not exceeding 50% of the normal seating capacity of the premises and no more than two persons seated together at one table. The maximum number of persons per banquet is capped at 20.
- Type B: All customers (excluding persons who only order takeaways) must use the "LeaveHomeSafe" mobile application or register their names, contact numbers and the dates and times of their visits before they are allowed to enter the premises. All staff members involved in the operation of the premises be tested once every 14 days. Dine-in services can be provided from 5 a.m. to 9:59 p.m. every day, with the number of customers at the catering premises at any one time not exceeding 50% of the normal seating capacity of the premises and no more than four persons seated together at one table. The maximum number of persons per banquet is capped at 20.

#### 香港酒樓業務(續)

##### 2021年4月至6月(續)

- C類：所有員工必須接種至少一劑COVID-19疫苗。整個餐飲處所或處所的部分範圍可劃分為「特定範圍C區」，所有該區域的顧客必須使用「安心出行」流動應用程式。於「特定範圍C區」內，餐飲業務可於每天早上5時至晚上11時59分提供堂食，處所內的顧客數目在任何時間均不得超過該處所通常座位數目的一半，不得有多於6人同坐一桌。每次宴會的人數上限為20人。
- D類：所有員工已完成接種COVID-19疫苗(一般而言即接種兩劑新冠疫苗後加上14天)。餐飲業務負責人可按需要把整個處所或處所的部分範圍劃分為「特定範圍D區」，並須確保「特定範圍D區」內所有顧客已接種第一劑COVID-19疫苗，及必須使用「安心出行」流動應用程式。於「特定範圍D區」內，餐飲業務可於每天早上5時至翌日凌晨1時59分提供堂食，處所內的顧客數目在任何時間均不得超過該處所通常座位數目的75%，不得有多於8人同坐一桌。每次宴會的人數上限為100人。

##### April to June 2021 (Continued)

- Type C: All staff must have received the first dose of COVID-19 vaccine. The whole or part of the catering premises can be designated as "Designated Zone C", and all customers in the zone must use the "LeaveHomeSafe" mobile application. Within the "Designated Zone C", the catering business can provide dine-in services from 5 a.m. to 11:59 p.m. every day, with the number of customers at the catering premises at any one time not exceeding 50% of the normal seating capacity of the premises and no more than six persons seated together at one table. The maximum number of persons per banquet is capped at 20.
- Type D: All staff have completed the full course of COVID-19 vaccination (which generally refers to having received two doses of COVID-19 vaccine plus 14 days). The person responsible for carrying on a catering business can designate the whole or part of the premises as "Designated Zone D", and must ensure that all customers in the zone have received the first COVID-19 vaccine dose and use the "LeaveHomeSafe" mobile application. Within the "Designated Zone D", the catering business can provide dine-in services every day from 5 a.m. to 1:59 a.m. on the subsequent day, with the number of customers at the catering premises at any one time not exceeding 75% of the normal seating capacity of the premises and no more than eight persons seated together at one table. The maximum number of persons per banquet is capped at 100.

#### 2021年4月至6月(續)

為符合上述規定，以及考慮到顧客的需要和員工的疫苗接種情況，本集團酒樓以B/C/D模式或以三種混合模式經營。本集團於此期內之收入約為13,600,000港元，較上季度增加49%及按年增加16%。收入增加是由於去年尖沙咀分行於2020年4月暫停營業，因此基數較低。由於COVID-19情況基本受到控制，本集團的業務於2021年5月及2021年6月有所改善，但仍然30%低於COVID-19前的水平。隨著越來越多的人留在家中或在家工作，遊客業務的缺乏以及企業和本地業務的下降繼續影響集團之酒樓業務。如果相關工作人員已接種第一劑疫苗，則可恢復不超過30人的本地遊。尖沙咀分店於2021年6月起恢復本地遊業務。

#### 2021年7月至9月

在此期間，全球COVID-19疫情依然嚴峻，流行的Delta變異病毒株具有高度傳播性，對本港的抗疫工作構成巨大挑戰。考慮到餐飲業的經營風險，特別是顧客在店內用餐時需要除下口罩，香港政府收緊了對採用B類經營模式的餐飲業員工的檢測要求。要求員工進行更頻繁的檢測，從每14天檢測一次到每7天檢測一次。經營環境於不同經營模式下，依然艱難。

#### April to June 2021 (Continued)

In order to comply with the above requirements and in view of our customers' needs and the vaccination conditions of the staff, the Group's restaurants had to operate under Type B/C/D mode or a combination of the 3 modes. The Group's revenue in this period was approximately HK\$13.6 million, representing a 49% increase from the previous quarter and a year-on-year increase of 16%. The increase in revenue was due to the fact that the revenue for the corresponding period in the previous year was significantly lower as a result of the suspension of operation of the Tsim Sha Tsui's branch in April 2020. Although the Group's business had improved in May and June 2021 as the COVID-19 situation was largely under control, the Group's revenue was still 30% less than that of prior to the outbreak of COVID-19. The absence of tourists' business and the lower corporate and local businesses continued to affect our restaurant operations as more people stayed at or worked from home. As local tours of not more than 30 persons were permitted provided that the relevant staff had received their first dose of COVID-19 vaccine, local tour business at our Tsim Sha Tsui's branch began to resume from June 2021.

#### July to September 2021

The global COVID-19 epidemic situation remained severe during this period, with the prevailing Delta mutant strain being highly transmissible and posed incredible challenges to local anti-epidemic efforts. After considering the operational risk of catering businesses, especially the fact that customers had to take off their masks when consuming food or drinks within the catering premises, the HK Govt tightened the testing requirement for staff of catering businesses which adopted the Type B mode of operation. The staff would be required to undergo more frequent testing, from once every 14 days to once every seven days. The operating environment remained difficult under the different mode of operations.

##### 2021年7月至9月(續)

為促進本地消費，香港政府於2021年7月實施36,000,000,000港元消費券計劃，向每名合資格及有效登記人士分期發放總值5,000港元的電子消費券。該計劃為集團的酒樓業務帶來了正面影響。本集團錄得較強勁的季度表現，收入飆升至約16,300,000港元，較上一季度增長20%，同比增長140%。去年同期，為遏制第三波疫情下COVID-19的蔓延，夜間堂食業務被禁止，導致尖沙咀分店於2020年7月26日至2020年8月19日期間全面暫停營業，長沙灣廣場分店亦於2020年7月29日至2020年8月18日期間暫停營業。

##### 2021年10月至12月

2021年10月至12月，雖然包括最新的Omicron在內的COVID-19變異病毒株在全球迅速蔓延，但香港的疫情較為穩定。從2021年12月9日起，所有客戶或用戶必須使用移動應用程式掃描安心出行場地二維碼才能進入場地。

本季收入約為8,200,000港元，較上季下跌50%，較去年同期下跌17%，是因為長沙灣廣場分店於2021年9月30日租約屆滿後關閉。而去年同期，為應對第四波疫情下更嚴厲的措施，長沙灣廣場分店於2020年12月10日至2021年2月17日期間暫停晚市營業。

##### July to September 2021 (Continued)

In order to boost local consumption, the HK Govt implemented the HK\$36 billion Consumption Voucher Scheme in July 2021, to disburse by instalments electronic consumption vouchers with a total value of \$5,000 to each eligible and validly registered person. The scheme had brought a positive impact to our restaurant operations. The Group recorded a relatively strong quarterly performance with revenue surged to approximately HK\$16.3 million, representing an increase of 20% from the previous quarter and a year-on-year increase of 140%. The significant year-on-year increase in revenue was due to the tightening of social distancing requirements by the HK Govt which prohibited dine-in services at night time during the last corresponding period in order to contain the spread of COVID-19 under the third wave of COVID-19 outbreak, causing the suspension of operation of the Tsim Sha Tsui's branch from 26 July 2020 to 19 August 2020 and the Cheung Sha Wan Plaza's branch from 29 July 2020 to 18 August 2020.

##### October to December 2021

From October to December 2021, although COVID-19 mutant strains including the latest Omicron variant was spreading rapidly around the world, the epidemic situation was relatively stable in Hong Kong. Starting from 9 December 2021, all customers had to use the "LeaveHomeSafe" mobile application before entering the premises.

The revenue for this quarter was approximately HK\$8.2 million, representing a decrease of 50% from the previous quarter and a decrease of 17% compared to the last corresponding period due to the closure of the Cheung Sha Wan Plaza's branch after its lease expired on 30 September 2021. In spite of this, the year-on-year decrease in revenue was relatively less significant since, during the last corresponding period, the Cheung Sha Wan Plaza's branch suspended its dinner operations from 10 December 2020 to 17 February 2021 in response to the more stringent social distancing measures under the fourth wave of COVID-19 outbreak.

此外，觀塘裕民坊新店潮觀城酒樓於2021年10月及2021年11月仍在裝修中，其於2021年12月7日正式開業後才開始為本集團貢獻收益。

#### 第五波COVID-19疫情-2022年1月至3月

1月中旬，香港正面臨Delta和Omicron兩種變異病毒株在社區蔓延的即時威脅。1月下旬，香港政府宣佈各局和部門將實施特別工作安排，包括允許部分員工輪流在家工作。為進一步減少社區的人流和社會接觸，鼓勵公眾在節日期間避免家庭聚會，以控制疫情。政府還呼籲僱主根據其業務需要，允許員工盡可能在家工作。所有酒樓員工都必須在2022年2月24日之前接種至少1劑疫苗，並於8週後至少接種2劑疫苗。自2022年1月7日起，禁止晚市堂食。

於2022年1月27日，香港政府解釋疫苗通行證計劃。自2022年2月24日起，12歲或以上人士進入所有預定場所必須通過使用安心出行移動應用程序並出示其疫苗接種記錄以遵從疫苗通行證之安排。

In addition, Kwun Tong City Chiu Chow Restaurant, the new branch at Yue Man Square, Kwun Tong was still under renovation in October and November 2021. It commenced to contribute revenue to the Group following its official opening on 7 December 2021.

#### Fifth Wave of COVID-19 Outbreak – January to March 2022

In mid-January 2022, Hong Kong was facing the imminent threat of both the Delta and Omicron mutant strains spreading in the community. In late-January 2022, the HK Govt announced that bureaus and departments would implement special work arrangements, including allowing some staff to take turns working from home. To further reduce the flow of people and social contact in the community, the public was encouraged to avoid gatherings among families during the festive season in order to contain the epidemic. The HK Govt also appealed to employers to allow their staff to work from home as far as possible according to their operational needs. All restaurant staff would be required to have received at least the first dose of COVID-19 vaccine by 24 February 2022 and then at least second doses of COVID-19 vaccine after eight weeks' time. From 7 January 2022, dine-in services for catering businesses were prohibited at night time.

On 27 January 2022, the HK Govt outlined its plan to expand the vaccine pass arrangement whereby, starting from 24 February 2022, all persons aged 12 or above entering certain specified premises are required to adhere to the vaccine pass arrangements by using the LeaveHomeSafe mobile app and presenting their vaccination record.

##### 第五波COVID-19疫情-2022年1月至3月(續)

1月至3月季度是傳統餐飲行業的旺季。然而，各項社交距離措施的收緊，加上香港疫情形勢惡化，導致集團的業務大幅下滑。由於農曆新年後確診的COVID-19病例數量激增，為了顧客和員工的安全，尖沙咀分店於2022年2月14日至2022年4月9日期間被迫全面暫停營業，觀塘分店亦於2022年2月8日至2022年4月12日期間暫停營業，本季收入僅2,600,000港元，較上一季大幅下跌68%，較去年同期下跌35%。

為補償和支持受收緊社交距離措施影響的各行各業，香港政府啟動了第五輪和第六輪防疫抗疫基金。在這兩輪基金下，本集團的酒樓有資格就餐飲業務(社交距離)資助計劃獲得合共1,350,000港元。

#### 澳洲物業發展

澳洲物業發展項目於2020年3月動工，並於2021年10月竣工。一個項目控制小組已成立，以監督及監察市場推廣及建設進度。於2021年10月下旬發出公寓樓入伙證後，本集團相應確認物業發展收入約12,900,000澳元(折合74,000,000港元)和銷售成本約11,500,000澳元(折合66,300,000港元)。利潤約為1,400,000澳元(折合7,700,000港元)。於2022年3月31日，26套公寓已全數出售，其中25套已完成交收。

##### Fifth Wave of COVID-19 Outbreak – January to March 2022 (Continued)

The January-March quarter is traditionally the peak season for the food and beverage industry in Hong Kong. However, the tightening of the various social distancing measures coupled with the deteriorating condition of the epidemic situation in Hong Kong resulted in a significant downturn in our business. As a result of the surge in the number of COVID-19 confirmed cases after the Chinese New Year period and for the safety of our patrons and staff, the Tsim Sha Tsui's branch was forced to completely suspend its operations from 14 February to 9 April 2022. The Kwun Tong's branch also suspended its operations from 8 February to 12 April 2022. The Group recorded a revenue of merely HK\$2.6 million in this quarter, representing a significant drop in revenue of 68% from the previous quarter and a drop of 35% from the last corresponding period.

As compensation and support for the different sectors affected by the tightened social distancing measures, the HK Govt launched the fifth and sixth round of the Anti-epidemic Fund. The Group's restaurants were entitled to a total sum of HK\$1.35 million in respect of the Catering Business (Social Distancing) Subsidy Scheme under these two rounds of funding.

#### Property Development in Australia

The property development project in Australia commenced from March 2020 and completed in October 2021. A project control team had been set up to oversee and monitor the marketing and construction progress. Following the issue of the occupation certificate for the apartment block end of October 2021, the Group recognised property development income of approximately A\$12.9 (HK\$74.0 million equivalent) and cost of sales of approximately A\$11.5 (HK\$66.3 million equivalent) accordingly. The profit margin was approximately A\$1.4 million (HK\$7.7 million equivalent). As of 31 March 2022, all 26 apartments were sold, out of which 25 apartments had completed settlement.

### 流動資金及財政資源

本集團於2022年3月31日之銀行及現金結餘約為31,700,000港元。由於本集團並無銀行貸款，本集團於2022年3月31日及2021年3月31日之資本負債比率（定義為總銀行貸款除以總資產值）為零。

本集團已於2021年2月1日從其最終母公司Kong Fai International Limited獲得40,000,000港元的貸款融資額，年利率為5%。於2021年9月1日，貸款額度增加至50,000,000港元。截至2022年3月31日止年度，本集團提取貸款約43,000,000港元（2021年3月31日：20,000,000港元），應計利息約1,000,000港元（2021年3月31日：100,000港元）。該等貸款（包括應計利息在內）約44,100,000港元已於2021年10月悉數償還。

考慮到本集團在其日常業務過程中取得之現金以及現時尚未動用之銀行及其他信貸額，故董事會認為本集團擁有充裕之營運資金以應付其業務所需。

### 外匯匯兌風險

由於本集團從酒樓業務獲得之大部分銷售、採購以及銀行及現金結餘均以港元列值，本集團面對之外匯風險，主要來自澳洲之物業發展業務，因其相關之交易，資產及負債均以澳元列值。管理層會密切監察該等風險，並在有需要時會考慮對沖重大外匯風險。

### LIQUIDITY AND FINANCIAL RESOURCES

The Group's bank and cash balances amounted to approximately HK\$31.7 million as at 31 March 2022. As the Group had no bank borrowings, the Group's gearing ratio was zero (defined as total bank borrowings divided by total assets) as at 31 March 2022 and 31 March 2021.

The Group obtained loan facilities on 1 February 2021 of HK\$40.0 million from its ultimate parent, Kong Fai International Limited, which bear interest at a rate of 5% per annum. On 1 September 2021, the loan facilities were increased to HK\$50.0 million. During the year ended 31 March 2022, the total sum drawn down by the Group was approximately HK\$43.0 million (31 March 2021: HK\$20.0 million), with accrued loan interests of approximately HK\$1.0 million (31 March 2021: HK\$0.1 million). The loans and accrued interest amounted to HK\$44.1 million were fully repaid in October 2021.

With the cash generated from the Group's operations in its ordinary course of business and the existing unutilised banking and credit facilities, the Directors consider that the Group has sufficient working capital for its operations.

### FOREIGN EXCHANGE EXPOSURE

Most of the Group's sales, purchases, bank and cash balances from the restaurant operations are denominated in Hong Kong dollars. The Group is exposed to foreign currency risk primarily through its property development operations in Australia as the relevant transactions, assets, liabilities and bank balances are denominated in Australian dollar. The management would closely monitor such risk and would consider hedging significant foreign currency exposure should the need arise.

### 僱員

於2022年3月31日，本集團擁有僱員約90人。於回顧年度內總員工成本（包括董事酬金）已達至約19,200,000港元（2021年3月31日：18,700,000港元）。

本集團一般會每年及根據情況需要不時檢討僱員之薪酬組合。本集團僱員之薪酬及福利水準具競爭力，並參考個人表現透過本集團之分紅計劃予以獎賞。其他福利包括醫療保險以及為僱員提供強制性公積金計劃。

### 業務模式及策略

本集團致力透過其可持續之業務發展為股東帶來正面回報或保留其價值。對於本集團之傳統業務，本集團會嘗試為客戶提供更創新之產品或服務；實施更嚴格之成本控制及更有效地善用及管理資源以尋求增長及更高之回報。為了進一步提升本集團之價值及為股東們實現更高之回報，本集團之長遠方法是透過業務多元化以擴大收入來源。本集團之目標是透過物色及選擇極具潛質之新業務機會包含至現有之業務範圍並且以最大力度長遠提升整體股東之回報。

### EMPLOYEES

As at 31 March 2022, the Group had approximately 90 staff. Total staff costs including directors' emoluments amounted to approximately HK\$19.2 million (31 March 2021: HK\$18.7 million) for the year under review.

Review of the employees' remuneration packages is normally conducted annually and as required from time to time. The salary and benefit levels of the Group's employees are competitive and individual performance is rewarded through the Group's bonus scheme. Other benefits including medical coverage and mandatory provident fund scheme are also provided to employees.

### BUSINESS MODEL AND STRATEGY

The Group strives to generate positive return to preserve values of shareholders through its sustainable business development. For the Group's traditional business, the Group would try to seek growth and higher returns by offering more innovative products or services to customers, to implement more stringent cost control and to apply and manage resources as effectively as possible. In order to further enhance the value of the Group and to achieve higher returns to the shareholders, the longer term approach is to expand the income source through business diversification. The aim is to maximise the overall returns to shareholders in the long run by identifying and selecting new business opportunities which are of great potential and include them in the Group's existing business portfolio.

### 展望

酒樓業務將仍然為本集團之核心業務。然而，本集團酒樓業務之經營環境仍然極具挑戰性。本集團必須密切注意COVID-19之情況變化，並適應不斷變化的健康、社會、政治和經濟環境。酒樓業務方面，本集團的策略是專注於經營中型食肆，同時實現有效的風險管理。對未來的擴張計劃以及進一步的資本開支，本集團將採取更謹慎的態度。本集團將繼續在香港及澳洲物色物業發展項目的投資機會。多元化發展該分部將為本集團帶來充分機會增加收入來源，並為本集團及其股東帶來正面回報。

### OUTLOOK

The restaurant business will continue to serve as our core operation. However, the operating environment for the Group's restaurant operation remains challenging. The Group has to monitor the dynamic COVID-19 situation closely and adapt to the ever-changing health, social, political and economic climate. For the restaurant business, the Group's strategy is to concentrate on operating medium-sized restaurants while achieving efficient risk management. It will also adopt a more cautious approach in future expansion plan as well as in committing further capital expenditure. The Group will continue to seek investment opportunities in property development projects both in Hong Kong and in Australia. The diversification into this segment will give the Group ample opportunities to acquire additional source of income and a positive return to the Group and its shareholders.

董事會知悉良好企業管治之重要性及好處，並竭力根據香港聯合交易所有限公司（「聯交所」）有關有效企業管治之指引處理其業務，以加強其透明度、公平性、完整性及問責性。

### 企業管治守則

本公司已採納聯交所上市規則（「上市規則」）附錄十四所載之企業管治守則（「企業管治守則」）作為其企業管治守則。於截至2022年3月31日止年度內，本公司已遵守企業管治守則之守則條文，惟守則條文A.2.1條（由2022年1月1日起已被重新編號為C.2.1）（有關主席及行政總裁之角色分開）；守則條文A.4.1條（由2022年1月1日起已由企業管治守則中被刪除）（有關非執行董事（「非執行董事」）之服務期限）及守則條文D.1.4條（由2022年1月1日起已被重新編號為C.3.3）（有關董事們之委任書）除外。

守則條文D.1.4條訂明，上市發行人須為董事們提供正式委任書並列明委任之條款及細則。本公司有若干董事未有正式委任書。但是，本公司所有董事均需要參考由公司註冊處發出之「董事責任指引」及由香港董事學會發出之「董事指南」及「獨立非執行董事指南」以履行其作為公司董事之職責及責任。董事認為，此舉符合守則條文D.1.4條之目標。

The Board acknowledges the importance and benefits of good corporate governance and strives to manage the Company and the business in accordance with the guidelines of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) for effective corporate governance emphasizing transparency, fairness, integrity and accountability.

### CORPORATE GOVERNANCE CODE

The Company has adopted the Corporate Governance Code (the “Code”) contained in Appendix 14 to the Rules Governing the Listing of Securities on the Stock Exchange (the “Listing Rules”) as its own corporate governance code. The Company has complied with the code provisions set out in the Code throughout the year ended 31 March 2022 except for code provision A.2.1 (which has been renumbered as C.2.1 since 1 January 2022) in respect of the role separation of the chairman and the chief executive; code provision A.4.1 (which has been deleted from the Code since 1 January 2022) in respect of the service term of non-executive directors (“NEDs”) and code provision D1.4 (which has been renumbered as C.3.3 since 1 January 2022) in respect of the letters of appointment for directors.

Code provision D.1.4 sets out that issuers should have formal letters of appointment for directors setting out the key terms and conditions of their appointment. The Company did not have formal letters of appointment for certain directors. All of the directors of the Company are, however, required to refer to the guidelines set out in “A Guide on Directors’ Duties” issued by the Companies Registry and “Guidelines for Directors” and “Guide for Independent Non-Executive Directors” published by the Hong Kong Institute of Directors in performing their duties and responsibilities as directors of the Company. In the opinion of the directors, this meets the objective of the code provision D.1.4.

### 董事進行證券交易

本公司已採納上市規則附錄十所載上市發行人之董事進行證券交易之標準守則（「標準守則」），作為其本身規範董事進行證券交易之行為守則。全體董事經本公司作出特定查詢後，確認彼等於截至2022年3月31日止年度內已遵守標準守則所載之規定準則。

The mix of professional skills and experience of the INEDs is an important element in the proper functioning of the Board. Their participation in Board and committee meetings brings independent judgment and helps to ensure that adequate checks and balances are provided and that the interests of all shareholders are taken into account. Directors have full access to appropriate business documents and information about the Group on a timely basis. The Directors can also obtain independent professional advice at the Group's expense if they require it. The Board delegates the day-to-day operation and administration to the management.

The Company has complied with rules 3.10(1) and (2) of the Listing Rules in maintaining at all times sufficient number of INEDs on the Board including an INED with professional accounting and financial qualifications. The Company has complied with rule 3.10A since 1 December 2012 and has INEDs representing at least one-third of the Board. The Company considers all of the INEDs are independent and has received from each INED an annual confirmation of independence pursuant to rule 3.13 of the Listing Rules.

### FINANCIAL REPORTING

The directors acknowledge their responsibility for the preparation of financial statements of the Group that give a true and fair view of the Group's financial position and are in accordance with applicable accounting standards and statutory rules and guidelines. The Board is not aware of any material uncertainties relating to events or conditions that may cast significant doubt upon the Company's ability to continue on a going concern basis. The Company has also received a statement by the auditor of the Company about their reporting responsibilities.

### RISK MANAGEMENT AND INTERNAL CONTROLS

The Board recognizes its overall responsibility for the establishment, maintenance and review of the risk management and internal control systems that provide reasonable assurance on the reliability and integrity of financial and operational information, effective and efficient operations, safeguarding of assets and compliance with laws and regulations. Such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

### RISK MANAGEMENT AND INTERNAL CONTROLS (Continued)

The Group's risk management and internal control systems are based on a set of policies, rules and guidelines as outlined in the Group's internal control manual and governed by the following types of control principles:

- a. Organization – to have clearly defined line of responsibility and delegation
- b. Segregation of duties – to reduce risk of intentional manipulation or error
- c. Physical Control – to restrict unauthorized access to all kinds of assets
- d. Authorization and approval – to have clearly defined limits for authorizations
- e. Arithmetical and accounting – to ensure accuracy of transactional records
- f. Personnel – to have qualified staff to perform day-to-day duties
- g. Supervision – to observe and closely monitor, to identify and report on control weaknesses
- h. Management – to maintain overall controls; to manage and mitigate significant risks and to highlight significant matters to the Board and the audit committee

The Company has adopted the "Guidelines on Disclosure of Inside Information" issued by the Securities and Futures Commission as its own guidelines in handling and dissemination of inside information. Unauthorized use of confidential information is strictly prohibited.

The Board through the executive management team, the internal control team and the audit committee had conducted an annual review on the risk management and internal control systems of the Group and considered that the systems in place are adequate and effective.

### 主席及行政總裁

守則條文A.2.1條(由2022年1月1日起已被重新編號為C.2.1)訂明,主席及行政總裁之角色須分開,不得由同一人擔任。現時,鄭合輝先生擔任本公司之主席及董事總經理(即與行政總裁之角色相同)。董事會認為此安排不會促使權力過份集中,而於現階段,能有效地制定及實施本集團之策略,促使本集團能更有效率地發展其業務。

### 非執行董事

守則條文A.4.1條(由2022年1月1日起已在企業管治守則中被刪除)訂明,非執行董事之委任須有指定任期,並須接受重選。本公司若干獨立非執行董事均無指定任期。此情況構成偏離守則條文A.4.1條。然而,由於本公司之全體獨立非執行董事須於本公司之股東週年大會上至少三年一次根據本公司之公司細則輪值退任,故董事們認為,此舉符合守則A.4.1條之目標。守則條文A.4.1條已於2022年1月1日生效之新企業管治守則中被刪除。

### CHAIRMAN AND CHIEF EXECUTIVE

Code provision A.2.1 (which has been renumbered as C.2.1 since 1 January 2022) sets out that the roles of the chairman and the chief executive should be separate and should not be performed by the same individual. Currently, Mr. Cheng Hop Fai assumes the role of both the chairman and the managing director (equivalent to the role of a chief executive) of the Company. The Board considers that such arrangement will not result in undue concentration of power and is, at this stage, conducive to the efficient formulation and implementation of the Group's strategies thus allowing the Group to develop its business more effectively.

### NON-EXECUTIVE DIRECTORS

Code provision A.4.1 (which has been deleted from the Code since 1 January 2022) stipulates that NEDs should be appointed for a specific term, subject to re-election. Some INEDs are not appointed for a specific term. This constitutes a deviation from code provision A.4.1. However, as all the INEDs are subject to retirement by rotation at the annual general meetings of the Company at least once every three years in accordance with the Company's Bye-laws, in the opinion of the directors, this meets the objective of the code provision A.4.1. The code provision A.4.1 was deleted from the new Corporate Governance Code which became effective from 1 January 2022.

During the year ended 31 March 2022, the nomination committee held one meeting to review the composition and diversity of the Board as well as to assess the independence of the INED who offered himself for re-election at the annual general meeting. Since the Board is composed of members having a mix of core competencies in areas of accounting and finance, business management, industry knowledge and marketing strategies, the nomination committee considered the Board possessed a diversity of perspectives which is up to the standard of the Code and was appropriate to the Group's requirements. If the Board fails to proceed to convene such meeting within twenty-one days after receiving the request, the shareholders themselves may do so in accordance with the provisions of section 74(3) of the Companies Act 1981 of Bermuda.

The results of the Group for the year ended 31 March 2022 are set out in the consolidated statement of profit or loss and other comprehensive income on pages 64 to 65 of this annual report.

The Board has resolved not to recommend the payment of a final dividend for the year ended 31 March 2022 (2021: Nil).

### BUSINESS REVIEW

A fair review of the business of the Group as well as a discussion and analysis of the Group's performance during the year as required by schedule 5 to the Companies Ordinance (Chapter 622 of the laws of Hong Kong) including a discussion of the principal risks and uncertainties facing the Group and a discussion of the Group's likely future development can be found in the Chairman's Statement and the Management Discussion and Analysis of this annual report. The financial risk management objectives and policies of the Group are shown in note 6 to the consolidated financial statements. Those discussions form part of this report of the directors. The environmental, social and governance report of the Company to be published within five months after the end of the financial year shall also form part of the business review.

### COMPLIANCE WITH RELEVANT LAWS AND REGULATIONS

During the year under review, as far as the Board and the management are aware, there was no material breach of or non-compliance with the applicable laws and regulations by the Group that has a significant impact on the business and operations of the Group.

The aggregate revenue attributable to the five largest customers of the Group was less than 30% of the Group's revenue for the year from restaurant operations.

None of the directors, their respective close associates nor any shareholder, (which to the knowledge of the directors owns more than 5% of the Company's share capital), has an interest in any of the five largest suppliers of the Group.

The Company is committed to the sustainable development of the environment and the society. ### 1. 一般資料

環科國際集團有限公司（「本公司」）於百慕達註冊成立為受豁免有限公司。其註冊辦事處地址為Clarendon House, 2 Church Street, Hamilton HM 11, Bermuda。其主要營業地點為香港九龍尖沙咀東部加連威老道98號東海商業中心1樓108室。本公司之股份於香港聯合交易所有限公司（「聯交所」）主板上市。

本公司為一間投資控股公司。其附屬公司之主要業務載於綜合財務報表附註32。

本公司董事認為，於英屬處女群島註冊成立之Kong Fai International Limited為其最終控股公司。鄭合輝先生（「鄭先生」）及其家族成員為本公司之最終控股方。

### 2. 編製基準

該等綜合財務報表乃根據香港會計師公會（「香港會計師公會」）頒佈之所有適用香港財務報告準則（「香港財務報告準則」）編製。香港財務報告準則包括香港財務報告準則（「香港財務報告準則」）、香港會計準則（「香港會計準則」）及詮釋。該等綜合財務報表已符合香港聯合交易所有限公司證券上市規則（「上市規則」）之適用披露條文及香港公司條例（第622章）之披露規定。本集團採納的主要會計政策披露如下。

香港會計師公會已頒佈若干新訂及經修訂之香港財務報告準則，於本集團之當前會計期間首次生效或可供提早採納。附註3提供首次應用該等與本集團有關的新訂及經修訂準則所引致當前及過往會計期間的任何會計政策變動的資料，並已於該等綜合財務報表中反映。

### 1. GENERAL INFORMATION

G-Vision International (Holdings) Limited (the "Company") was incorporated in Bermuda as an exempted company with limited liability. The address of its registered office is Clarendon House, 2 Church Street, Hamilton HM 11, Bermuda. The address of its principal place of business is Unit 108, 1st Floor, East Ocean Centre, 98 Granville Road, Tsimshatsui East, Kowloon, Hong Kong. The Company's shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange").

The Company is an investment holding company. The principal activities of its subsidiaries are set out in note 32 to the consolidated financial statements.

In the opinion of the directors of the Company, Kong Fai International Limited ("Kong Fai"), a company incorporated in the British Virgin Islands (the "BVI"), is the ultimate parent. Mr. Cheng Hop Fai ("Mr. Cheng") and his family members are the ultimate controlling parties of the Company.

### 2. BASIS OF PREPARATION

These consolidated financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA"). HKFRSs comprise Hong Kong Financial Reporting Standards ("HKFRS"); Hong Kong Accounting Standards ("HKAS"); and Interpretations. These consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on the Stock Exchange (the "Listing Rules") and with the disclosure requirements of the Hong Kong Companies Ordinance (Cap. 622). Significant accounting policies adopted by the Group are disclosed below.

The HKICPA has issued certain new and revised HKFRSs that are first effective or available for early adoption for the current accounting period of the Group. Note 3 provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current and prior accounting periods reflected in these consolidated financial statements.

**4. 主要會計準則**

該等綜合財務報表已按歷史成本慣例編製，除下述會計政策另行提及外，例如若干按公平值計量之金融工具。

編製符合香港財務報告準則的財務報表需要採用若干重要會計估計。這亦需要管理層在應用本集團的會計政策過程中行使其判斷。涉及高度判斷或極為複雜的範疇，或對綜合財務報表屬重大假設及估計的範疇，均於附註 5 中披露。

編製該等綜合財務報表所採用之主要會計政策載列如下。

**(a) 綜合賬目**

綜合財務報表包括本公司及其附屬公司截至 3 月 31 日止之財務報表。附屬公司是指本集團對其擁有控制權的實體。當本集團通過參與實體業務而享有或有權享有可變動回報，並透過控制實體的權力而影響該等回報時，即控制該實體。當本集團擁有現行權力以使其有能力操控該實體之相關活動（即對實體回報造成重大影響的活動）時，本集團即對實體擁有權力。

在評估控制權時，本集團會考慮其潛在投票權以及其他各方持有的潛在投票權。僅於持有人能實際行使潛在投票權的情況下，方會考慮其權利。

附屬公司在控制權轉移至本集團之日起綜合入賬，並在控制權終止之日起停止綜合入賬。

**4. SIGNIFICANT ACCOUNTING POLICIES**

These consolidated financial statements have been prepared under the historical cost convention, unless mentioned otherwise in the accounting policies below (e.g. certain financial instruments that are measured at fair value).

The preparation of financial statements in conformity with HKFRSs requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the Group's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements are disclosed in note 5.

The significant accounting policies applied in the preparation of these consolidated financial statements are set out below.

**(a) Consolidation**

The consolidated financial statements include the financial statements of the Company and its subsidiaries made up to 31 March. Subsidiaries are entities over which the Group has control. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The Group has power over an entity when the Group has existing rights that give it the current ability to direct the relevant activities, i.e. activities that significantly affect the entity's returns.

When assessing control, the Group considers its potential voting rights as well as potential voting rights held by other parties. A potential voting right is considered only if the holder has the practical ability to exercise that right.

Subsidiaries are consolidated from the date on which control is transferred to the Group. They are de-consolidated from the date the control ceases.

#### (a) 綜合賬目(續)

集團內之交易、結餘及未變現溢利均會予以對銷。除非交易提供憑證顯示所轉讓資產出現減值，否則未變現虧損亦予以對銷。附屬公司之會計政策會在有需要時更改，以確保與本集團所採納之政策一致。

非控股權益是指不直接或間接歸屬於本公司的附屬公司權益。非控股權益在綜合財務狀況表和綜合權益變動表中之權益項下列示。非控股權益在綜合損益表和綜合損益及其他全面收益表中列示，作為本年度非控股股東與本公司股東之間對年度損益和全面收益總額之分配。

損益及其他全面收益的每個組成部分均歸屬於本公司股東和非控股股東，即使這會導致非控股權益出現赤字餘額。

#### (a) Consolidation (Continued)

The gain or loss on the disposal of a subsidiary that results in a loss of control represents the difference between (i) the fair value of the consideration of the sale plus the fair value of any investment retained in that subsidiary and (ii) the Company's share of the net assets of that subsidiary plus any remaining goodwill and any related accumulated foreign currency translation reserve relating to that subsidiary.

Intragroup transactions, balances and unrealised profits are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

Non-controlling interests represent the equity in subsidiaries not attributable, directly or indirectly, to the Company. Non-controlling interests are presented in the consolidated statement of financial position and consolidated statement of changes in equity within equity. Non-controlling interests are presented in the consolidated statement of profit or loss and consolidated statement of profit or loss and other comprehensive income as an allocation of profit or loss and total comprehensive income for the year between the non-controlling shareholders and owners of the Company.

Profit or loss and each component of other comprehensive income are attributed to the owners of the Company and to the non-controlling shareholders even if this results in the non-controlling interests having a deficit balance.

**(b) 外幣換算****(i) 功能及呈列貨幣**

Changes in the Company's ownership interest in a subsidiary that do not result in a loss of control are accounted for as equity transactions (i.e. transactions with owners in their capacity as owners). The carrying amounts of the controlling and non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiary. Any difference between the amount by which the non-controlling interests are adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to the owners of the Company.

In the Company's statement of financial position, investments in subsidiaries are stated at cost less impairment loss, unless the investment is classified as held for sale (or included in a disposal group that is classified as held for sale).

**(b) Foreign currency translation****(i) Functional and presentation currency**

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in Hong Kong dollars, which is the Company's functional and presentation currency.

When a foreign operation is sold, such exchange differences are reclassified in the consolidated profit or loss as part of the gain or loss on disposal.

Goodwill and fair value adjustments arising on the acquisition of a foreign entity are treated as assets and liabilities of the foreign entity and translated at the closing rate.

Property, plant and equipment held for use in the production or supply of goods or services, or for administrative purposes, are stated in the consolidated statement of financial position at cost, less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other repairs and maintenance are recognised in profit or loss during the period in which they are incurred.

Depreciation of property, plant and equipment is calculated at rates sufficient to write off their cost less their residual values over the estimated useful lives on a straight-line basis. The principal annual rates are as follows:

The residual values, useful lives and depreciation method are reviewed and adjusted, if appropriate, at the end of each reporting period.

The gain or loss on disposal of property, plant and equipment is the difference between the net sales proceeds and the carrying amount of the relevant asset, and is recognised in profit or loss.

#### (d) Leases

At inception of a contract, the Group assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

當合約包含租賃部分及非租賃部分，本集團選擇不區分非租賃部分並將各租賃部分及任何相關非租賃部分入賬列為所有租賃的單一租賃部分。

本集團會於租賃開始日確認使用權資產及租賃負債，惟租期為12個月或以下的短期租賃及低價值資產租賃(主要為本集團的酒樓、辦公室、董事宿舍及儲物室)除外。當本集團就低價值資產訂立租約時，會決定是否按個別租賃基礎將其資本化。該等未資本化租賃，其相關的租賃付款會於租期內按系統基礎被確認為開支。

當租賃被資本化，租賃負債初步按租期內應付租賃付款以租賃中所隱含的利率貼現後之現值被予以確認。倘若該利率不能被輕易釐定，則以相關增量借款利率貼現。於初始確認後，租賃負債按攤銷成本計量，而利息開支則採用實際利率法計量。不依賴指數或利率的可變租賃付款不會被包括在租賃負債的計量中，而是會在其產生的會計期間內於損益中扣除。

Where the contract contains lease component(s) and non-lease component(s), the Group has elected not to separate non-lease components and accounts for each lease component and any associated non-lease components as a single lease component for all leases.

At the lease commencement date, the Group recognizes a right-of-use asset and a lease liability, except for short-term leases that have a lease term of 12 months or less and leases of low-value assets which, for the Group are primarily restaurant, office, director's quarter and storage room. When the Group enters into a lease in respect of a low-value asset, the Group decides whether to capitalise the lease on a lease-by-lease basis. The lease payments associated with those leases which are not capitalised are recognised as an expense on a systematic basis over the lease term.

Where the lease is capitalised, the lease liability is initially recognised at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. After initial recognition, the lease liability is measured at amortised cost and interest expense is calculated using the effective interest method. Variable lease payments that do not depend on an index or rate are not included in the measurement of the lease liability and hence are charged to profit or loss in the accounting period in which they are incurred.

於資本化租賃時確認的使用權資產初步按成本計量，其中包括租賃負債的初始金額，再加上於開始日或之前作出的任何租賃付款以及任何初始產生的直接成本。倘適用，使用權資產的成本亦包括拆卸及移除相關資產或還原相關資產或該資產所在地而產生的估計成本之貼現值並減去任何所收的租賃優惠。使用權資產其後按成本減累計折舊及減值虧損列賬。

The right-of-use asset recognised when a lease is capitalised is initially measured at cost, which comprises the initial amount of the lease liability plus any lease payments made at or before the commencement date, and any initial direct costs incurred. Where applicable, the cost of the right-of-use assets also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, discounted to their present value, less any lease incentives received. The right-of-use asset is subsequently stated at cost less accumulated depreciation and impairment losses.

Right-of-use assets in which the Group is reasonably certain to obtain ownership of the underlying leased assets at the end of the lease term are depreciated from commencement date to the end of the useful life. Otherwise, right-of-use assets are depreciated on a straight-line basis over the shorter of its estimated useful life and the lease term.

Refundable rental deposits paid are accounted under HKFRS 9 and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments and included in the cost of right-of-use assets.

**(e) 存貨**

The lease liability is remeasured when there is a change in future lease payments arising from a change in an index or rate, or there is a change in the Group's estimate of the amount expected to be payable under a residual value guarantee, or there is a change arising from the reassessment of whether the Group will be reasonably certain to exercise a purchase, extension or termination option. When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the right-of-use asset, or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

The lease liability is also remeasured when there is a change in the scope of a lease or the consideration for a lease that is not originally provided for in the lease contract ("lease modification") that is not accounted for as a separate lease. In this case the lease liability is remeasured based on the revised lease payments and lease term using a revised discount rate at the effective date of the modification.

**(e) Inventories**

Inventories are stated at the lower of cost and net realisable value. Cost is determined using the first-in, first-out basis. Net realisable value is the estimated selling price in the ordinary course of business, less the estimated costs of completion and the estimated costs necessary to make the sale.

其他合同成本是與客戶簽訂合同時的增量成本或與客戶履行合同時的成本，這些成本並未資本化為存貨、物業、廠房及設備或無形資產。

取得合同的增量成本是本集團為取得與客戶簽訂合同而產生之費用，即是如未有取得合同，則不會有的費用。取得合同的增量成本如果預期能夠收回，則在產生時予以資本化，除非預期攤銷期為自資產初始確認之日起計為期一年或以內，在這種情況下，成本在產生時可計入費用。取得合同的其他費用在產生時計入費用。

如果成本直接與現有合同或與可明確識別的預期合同相關，則履行合同的成本會被資本化；產生或增強資源用於未來提供之商品或服務；此成本亦有望能被收回。與現有合同或可明確識別的預期合同直接相關的成本可能包括直接人工、直接材料、分攤之成本、明確能向客戶收取的成本以及僅因集團立約而產生的其他成本。在履行合同時未被資本化為存貨、物業、廠房及設備或無形資產的其他成本在產生時計入費用。

#### (f) Other contract costs

Other contract costs are either the incremental costs of obtaining a contract with a customer or the costs to fulfil a contract with a customer which are not capitalised as inventory, property, plant and equipment or intangible assets.

Incremental costs of obtaining a contract are those costs that the Group incurs to obtain a contract with a customer that it would not have incurred if the contract had not been obtained. Incremental costs of obtaining a contract are capitalised when incurred if the costs are expected to be recovered, unless the expected amortisation period is one year or less from the date of initial recognition of the asset, in which case the costs are expensed when incurred. Other costs of obtaining a contract are expensed when incurred.

Costs to fulfil a contract are capitalised if the costs relate directly to an existing contract or to a specifically identifiable anticipated contract; generate or enhance resources that will be used to provide goods or services in the future; and are expected to be recovered. Costs that relate directly to an existing contract or to a specifically identifiable anticipated contract may include direct labour, direct materials, allocations of costs, costs that are explicitly chargeable to the customer and other costs that are incurred only because the group entered into the contract. Other costs of fulfilling a contract, which are not capitalised as inventory, property, plant and equipment or intangible assets, are expensed as incurred.

資本化合同成本按成本減累計攤銷及減值虧損入賬。當合同成本資產賬面值超過 (i) 本集團預期為換取與資產相關的商品或服務而收到的剩餘代價，減去 (ii) 與提供商品或服務直接相關的任何尚未確認費用之淨差額會被確認為減值虧損。

資本化合同成本的攤銷在確認與資產相關的收入時計入損益。

**(g) 確認及終止確認金融工具**

金融資產及金融負債於本集團成為工具合約條文之訂約方時，於綜合財務狀況表內確認。

金融資產及金融負債最初會按公平值計量。於初始確認時，收購或發行金融資產及金融負債（按公平值計入損益的金融資產及金融負債除外）而直接引致的交易成本會按適用情況計入或扣減該等金融資產或金融負債的公平值。收購按公平值計入損益之金融資產或金融負債直接引致的交易成本會即時於損益中確認。

Capitalised contract costs are stated at cost less accumulated amortisation and impairment losses. Impairment losses are recognised to the extent that the carrying amount of the contract cost asset exceeds the net of (i) remaining amount of consideration that the group expects to receive in exchange for the goods or services to which the asset relates, less (ii) any costs that relate directly to providing those goods or services that have not yet been recognised as expenses.

Amortisation of capitalised contract costs is charged to profit or loss when the revenue to which the asset relates is recognised.

**(g) Recognition and derecognition of financial instruments**

Financial assets and financial liabilities are recognised in the consolidated statement of financial position when the Group entity becomes a party to the contractual provisions of the instrument.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss ("FVTPL")) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit or loss are recognised immediately in profit or loss.

本集團僅從資產收取現金流量之合約權利屆滿時，或當其將金融資產及該資產擁有權之絕大部分風險及回報轉讓予另一實體時，方會終止確認金融資產。倘若本集團繼續控制已轉讓資產，既無轉讓亦無保留擁有權之絕大部分風險及回報，則本集團會確認其於資產的保留權益及其於相關負債可能須支付的款項。倘本集團保留已轉讓金融資產擁有權之絕大部分風險及回報，則本集團會繼續確認該金融資產，並同時確認已收所得款項為有抵押借款。

本集團僅於其責任已獲解除、註銷或屆滿時，方會終止確認金融負債。終止確認的金融負債的賬面值與已付及應付代價(包括所轉讓之非現金資產或所承擔之負債)的差額會於損益中確認。

#### (h) 金融資產

所有以常規方式購入或出售的金融資產會於交易當日被確認及被終止確認。以常規方式購入或出售是指需要按照市場規則或慣例所設定之既定時間內，交收購入或出售之金融資產。所有已確認的金融資產，其後視乎金融資產的分類，須全數按攤銷成本或公平值計量。

The Group derecognizes a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity. If the Group neither transfers nor retains substantially all the risks and rewards of ownership and continues to control the transferred asset, the Group recognizes its retained interest in the asset and an associated liability for amounts it may have to pay. If the Group retains substantially all the risks and rewards of ownership of a transferred financial asset, the Group continues to recognize the financial asset and also recognizes a collateralised borrowing for the proceeds received.

The Group derecognizes financial liabilities when, and only when, the Group's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable, including any non-cash assets transferred or liabilities assumed, is recognised in profit or loss.

#### (h) Financial assets

All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the marketplace. All recognised financial assets are measured subsequently in their entirety at either amortised cost or fair value, depending on the classification of the financial assets.

Debt investments held by the Group are classified into one of the following measurement categories:

- FVTOCI – recycling, if the contractual cash flows of the investment comprise solely payments of principal and interest and the investment is held within a business model whose objective is achieved by both the collection of contractual cash flows and sale. Changes in fair value are recognised in other comprehensive income, except for the recognition in profit or loss of expected credit losses, interest income (calculated using the effective interest method) and foreign exchange gains and losses. When the investment is derecognised, the amount accumulated in other comprehensive income is recycled from equity to profit or loss.

#### (i) 貿易及其他應收款項

應收款項待本集團擁有無條件收取代價權利時被予以確認。收取代價之權利只需在該代價到期收取前經過一段時間才被認為是無條件。如收入在本集團擁有無條件權利收取代價前已被確認，則把金額呈列為合約資產。

應收款項以實際利率法按攤銷成本扣除信貸虧損撥備後列賬。

#### (h) Financial assets (Continued)

##### Equity investments

An investment in equity securities is classified as FVTPL unless the equity investment is not held for trading purposes and on initial recognition of the investment the Group makes an election to designate the investment at FVTOCI (non-recycling) such that subsequent changes in fair value are recognised in other comprehensive income. Such elections are made on an instrument-by-instrument basis, but may only be made if the investment meets the definition of equity from the issuer's perspective. Where such an election is made, the amount accumulated in other comprehensive income remains in the fair value reserve (non-recycling) until the investment is disposed of. At the time of disposal, the amount accumulated in the fair value reserve (non-recycling) is transferred to retained earnings. It is not recycled through profit or loss. Dividends from an investment in equity securities, irrespective of whether classified as at FVTPL or FVTOCI, are recognised in profit or loss as other income.

#### (i) Trade and other receivables

A receivable is recognised when the group has an unconditional right to receive consideration. A right to receive consideration is unconditional if only the passage of time is required before payment of that consideration is due. If revenue has been recognised before the group has an unconditional right to receive consideration, the amount is presented as a contract asset.

Receivables are stated at amortised cost using the effective interest method less allowance for credit losses.

**(j) 現金及現金等值項目**

現金及現金等值項目包括銀行及手頭現金、銀行及其他金融機構的活期存款以及購入後於三個月內到期可隨時轉換為可知現金金額的短期高流通性並且價值改變風險不大的投資。就綜合現金流量表而言，按求償還並構成本集團現金管理不可或缺部分之銀行透支，亦被列為現金及現金等值項目一部分。本集團會為現金及現金等值項目評估預期信貸虧損（「預期信貸虧損」）。

**(k) 金融負債及股本工具**

金融負債及股本工具會根據所訂立合約安排之實質以及香港財務報告準則中金融負債及股本工具之定義被予以分類。股本工具為任何合約能證明本集團資產具有剩餘權益（在扣除其所有負債後）。下文載列就特定金融負債及股本工具採納之會計政策。

**(l) 借款**

借款初步按公平值扣除所產生的交易成本後被予以確認，其後採用實際利率法按攤銷成本計量。

借款被分類為流動負債，除非本集團有權無條件將負債的清償推遲至報告期後至少12個月。

(Continued)**(j) Cash and cash equivalents**

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Bank overdrafts that are repayable on demand and form an integral part of the group's cash management are also included as a component of cash and cash equivalents for the purpose of the consolidated statement of cash flows. Cash and cash equivalents are assessed for expected credit losses ("ECL").

**(k) Financial liabilities and equity instruments**

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument under HKFRSs. An equity instrument is any contract that evidences a residual interest in the assets of the Group after deducting all of its liabilities. The accounting policies adopted for specific financial liabilities and equity instruments are set out below.

**(l) Borrowings**

Borrowings are recognised initially at fair value, net of transaction costs incurred, and subsequently measured at amortised cost using the effective interest method.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the reporting period.

#### (m) 貿易及其他應付款項

貿易及其他應付款項初步按公平值確認，其後採用實際利率法按攤銷成本計量，除非貼現影響輕微，於此情況下，則以成本列賬。

#### (n) 股本工具

股本工具為任何合約能證明實體資產具有剩餘權益(經扣除其所有負債後)。本公司發行之股本工具是按照已收所得款項扣除直接發行成本時被予以確認。

#### (o) 收入及其他收入

##### 客戶合同收入

收入即按本集團預期有權獲取的承諾代價金額(不包括第三方收取的金額)，會於產品或服務的控制權轉移至客戶時被予以確認。收入為扣除增值稅、其他銷售稅及任何貿易折扣後的金額。

##### 酒樓營運

履約義務是提供食品和飲料的承諾。經營中式酒樓的收入是於向顧客提供食品及飲料時被確認。應收款項是於向客戶提供服務，即收取代價的權利為無條件(只是時間性)時被確認。交易價格應在向客戶提供服務時立即支付。對於客戶以信用卡結算的款項，結算期一般為交易日起計2日內。由於根據香港財務報告準則第15號的規定，這些服務的供應期限為一年或更少，因此無需披露未履行合同的交易價格分配。

#### (m) Trade and other payables

Trade and other payables are recognised initially at their fair value and subsequently measured at amortised cost using the effective interest method unless the effect of discounting would be immaterial, in which case they are stated at cost.

#### (n) Equity instruments

An equity instrument is any contract that evidence a residual interest in the assets of an entity after deducting all of its liabilities. Equity instruments issued by the Company are recorded at the proceeds received, net of direct issue costs.

#### (o) Revenue and other income

##### Revenue from contracts with customers

Revenue is recognised when control over a product or service is transferred to the customer, at the amount of promised consideration to which the Group is expected to be entitled, excluding those amounts collected on behalf of third parties. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts.

##### Restaurant operations

The performance obligation is the promise to provide food and beverages. Revenue from operation of Chinese restaurants is recognised at a point in time when the food and beverages are served to the customers. A receivable is recognised by the Group when the services are rendered to the customers at which the right to consideration becomes unconditional, as only the passage of time is required before payment is due. Payment of the transaction price is due immediately at the point the services are rendered to the customers. For payments settled by credit cards by customers, the settlement period is normally within 2 days from the trade date. As the provision of these services are at a period of one year or less, as permitted under HKFRS 15, the transaction price allocation to the unsatisfied contracts is not disclosed.

**物業發展**

收入在財產控制權轉移給客戶時確認。

**股息收入**

股息收入可於股東獲得款項的權利確實後確認。

**其他收入**

利息收入是採用實際利率法確認應計利息。對於按攤銷成本或按未計入信貸減值的公平值計入其他全面收益(可回收)計算的金融資產,實際利率可適用於資產的總賬面值。就已計入信貸減值的金融資產而言,實際利率適用於資產的攤銷成本(即總賬面值減去虧損撥備)。

## (p) 僱員福利

**(i) 僱員應享假期**

僱員享有之年假及長期服務金在應計時被予以確認。本集團已為僱員截至報告期末提供服務而產生之年假及長期服務金的估計負債作出撥備。

僱員之病假及產假津貼會在僱員正式休假時才予以確認。

## (o) Revenue and other income (Continued)

**Property development**

Revenue is recognised at the point in time when control over the property has been transferred to the customer.

**Dividend income**

Dividend income is recognised when the shareholders' rights to receive payment are established.

**Other income**

Interest income is recognised as it accrues using the effective interest method. For financial assets measured at amortised cost or FVTOCI (recycling) that are not credit-impaired, the effective interest rate is applied to the gross carrying amount of the asset. For credit impaired financial assets, the effective interest rate is applied to the amortised cost (i.e. gross carrying amount net of loss allowance) of the asset.

## (p) Employee benefits

**(i) Employee leave entitlements**

Employee entitlements to annual leave and long service leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave and long service leave as a result of services rendered by employees up to the end of the reporting period.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

本集團為所有僱員提供定額供款之退休福利計劃。本集團及僱員向計劃作出之供款乃根據僱員基本薪金之百分比計算。於損益內扣除之退休福利計劃費用乃指本集團應付基金之供款。

##### (iii) 離職福利

本集團可確認離職福利當本集團再不能撤銷提供該等福利之日及本集團確認重組成本及支付離職福利之日(以較早者為準)。

#### (q) 以股份支付的款項

本集團向若干董事及僱員發行以權益結算以股份支付的款項。

向董事及僱員作出以權益結算以股份支付之款項按股本工具於授出日期之公平值計量(不計非市場化之歸屬條件的影響)。以權益結算以股份支付之款項於授出當日釐定之公平值，會根據本集團所估計最終歸屬之股份(因應非市場化之歸屬條件的影響進行調整後)，按歸屬期以直線法支銷。

以權益結算以股份支付給顧問的費用，以提供服務的公平值計量；如果未能可靠地計算所提供服務的公平值，則以授予的權益工具的公平值計量。公平值於本集團收到服務當日計量，並確認為費用。

##### (ii) Pension obligations

The Group contributes to defined contribution retirement schemes which are available to all employees. Contributions to the schemes by the Group and employees are calculated as a percentage of employees' basic salaries. The retirement benefit scheme cost charged to the profit or loss represents contributions payable by the Group to the funds.

##### (iii) Termination benefits

Termination benefits are recognised at the earlier of the dates when the Group can no longer withdraw the offer of those benefits, and when the Group recognizes restructuring costs and involves the payment of termination benefits.

#### (q) Share-based payments

The Group issues equity-settled share-based payments to certain directors and employees.

Equity-settled share-based payments to directors and employees are measured at the fair value (excluding the effect of non-market based vesting conditions) of the equity instruments at the date of grant. The fair value determined at the grant date of the equity-settled share-based payments is expensed on a straight-line basis over the vesting period, based on the Group's estimate of shares that will eventually vest and adjusted for the effect of non-market based vesting conditions.

Equity-settled share-based payments to consultants are measured at the fair value of the services rendered or, if the fair value of the services rendered cannot be reliably measured, at the fair value of the equity instruments granted. The fair value is measured at the date the Group receives the services and is recognised as an expense.

所有借貸成本會於產生期間在損益中確認。

**(s) 政府補貼**

政府補貼是當有合理保證本集團能遵守附帶條件並且能收到補貼時才被予以確認。

與收入相關的政府補貼被延遲至當期損益中確認，以配對其打算補償的成本。

為補償已產生的開支或虧損或為向本集團提供即時財務支援而不會產生未來相關成本而應收的政府補貼，會當其成為應收款項期間於損益中確認。

**(t) 稅項**

所得稅開支為現時應付稅項及遞延稅項之總和。

現時應付稅項乃按本年度應課稅溢利計算。應課稅溢利與綜合損益中所報不同，乃由於前者不包括其他年度應課稅收入或可扣稅開支，並且不包括不能計稅或扣稅的項目。本集團的即期稅項負債乃按照報告期結算日已頒佈或實質上已頒佈的稅率計算。

All borrowing costs are recognised in profit or loss in the period in which they are incurred.

**(s) Government grants**

A government grant is recognised when there is reasonable assurance that the Group will comply with the conditions attaching to it and that the grant will be received.

Government grants relating to income are deferred and recognised in profit or loss over the period to match them with the costs they are intended to compensate.

Government grants that become receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable.

**(t) Taxation**

Income tax represents the sum of the current tax and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit recognised in profit or loss because it excludes items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

遞延稅項乃按綜合財務報表資產及負債賬面值與計算應課稅溢利所用相應稅基之間的差額確認。遞延稅項負債通常會就所有應課稅臨時差額被確認，而遞延稅項資產則於可能出現應課稅溢利以抵銷可扣稅的臨時差額、未用稅項虧損或未用稅項減免時才被確認。倘若來自商譽或者來自一項交易中(業務合併除外)初步確認其他資產及負債時產生之臨時差額，對應課稅溢利及會計溢利未造成影響，則該等資產及負債不會被確認。

來自投資附屬公司之應課稅臨時差額可以被確認為遞延稅項負債，除非本集團可控制臨時差額之回撥以及臨時差額未必於可見將來會被撥回。

Deferred tax is recognised on differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences and deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences, unused tax losses or unused tax credits can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax is calculated at the tax rates that are expected to apply in the period when the liability is settled or the asset is realised, based on tax rates that have been enacted or substantively enacted by the end of the reporting period. Deferred tax is recognised in profit or loss, except when it relates to items recognised in other comprehensive income or directly in equity, in which case the deferred tax is also recognised in other comprehensive income or directly in equity.

遞延稅項資產及負債的計算反映本集團期望於報告期結算日預期收回或償還其資產及負債賬面值的稅務後果。

為計算租賃交易下，即本集團確認使用權資產及相關租賃負債時的遞延稅項，本集團得首先界定稅務扣減項目是否屬於使用權資產或租賃負債。

在租賃交易下，對屬於租賃負債之稅務扣減項目，本集團會就使用權資產及租賃負債分開應用香港會計準則第12號的規定。由於應用初始確認豁免，故與使用權資產及租賃負債相關之暫時性差異不會於初始確認時及於租賃期內被確認。

當有合法執行權利容許即期稅項資產與即期稅項負債互相對銷，當與其相關之所得稅是由同一稅務機構所徵收以及當本集團亦準備按淨額基準結算其即期稅項資產及負債之時，則遞延稅項資產及負債也可以被互相對銷。

The measurement of deferred tax assets and liabilities reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purposes of measuring deferred tax for leasing transactions in which the Group recognizes the right-of-use assets and the related lease liabilities, the Group first determines whether the tax deductions are attributable to the right-of-use assets or the lease liabilities.

For leasing transactions in which the tax deductions are attributable to the lease liabilities, the Group applies HKAS 12 requirements to right-of-use assets and lease liabilities separately. Temporary differences relating to right-of-use assets and lease liabilities are not recognised at initial recognition and over the lease terms due to application of the initial recognition exemption.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied by the same taxation authority and the Group intends to settle its current tax assets and liabilities on a net basis.

#### (u) 非金融資產減值

本集團於各報告日就減值跡象審查非金融資產之賬面值，若有資產被減值至其估計可收回金額，此減值會於綜合損益及其他全面收益表內呈列為開支。可收回金額按個別資產而釐定，倘若資產並無產生大部分獨立於其他資產或資產組合之現金流，在此情況下，可收回金額可根據資產所屬現金產生單位（「現金產生單位」）而釐定。可收回金額以個別資產或現金產生單位之使用價值及公平值減去出售成本後，兩者之較高者為準。

使用價值為資產／現金產生單位估計未來現金流量之現值。計算使用價值可應用反映貨幣時間價值及資產／現金產生單位（已計入減值後）的特定風險之稅前貼現率。

現金產生單位之減值虧損首先被分配到該單位之商譽，然後按比例分配到現金產生單位的其他資產。其後估計變動導致的可收回金額增加會被計入損益，直至減值被轉回。

#### (v) 金融資產減值

本集團就應收貿易賬款的預期信貸虧損確認撥備。預期信貸虧損金額在每個報告日進行更新，以反映自初始確認各個金融工具以來信貸風險的變化。

#### (u) Impairment of non-financial assets

The carrying amounts of non-financial assets are reviewed at each reporting date for indications of impairment and where an asset is impaired, it is written down as an expense through the consolidated statement of profit or loss and other comprehensive income to its estimated recoverable amount. The recoverable amount is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets. If this is the case, recoverable amount is determined for the cash-generating unit ("CGU") to which the asset belongs. Recoverable amount is the higher of value in use and the fair value less costs of disposal of the individual asset or the CGU.

Value in use is the present value of the estimated future cash flows of the asset/CGU. Present values are computed using pre-tax discount rates that reflect the time value of money and the risks specific to the asset/CGU whose impairment is being measured.

Impairment losses for CGUs are allocated first against the goodwill of the unit and then pro rata amongst the other assets of the CGU. Subsequent increases in the recoverable amount caused by changes in estimates are credited to profit or loss to the extent that they reverse the impairment.

#### (v) Impairment of financial assets

The Group recognizes a loss allowance for expected credit losses on trade receivables. The amount of expected credit losses is updated at each reporting date to reflect changes in credit risk since initial recognition of the respective financial instrument.

本集團就貿易應收款項確認全期預期信貸虧損。此等金融資產的預期信貸虧損乃根據本集團過往信貸虧損經驗及使用撥備矩陣進行估計，並根據債務人特定因素、一般經濟狀況及對當前及報告日預測方向的條件，包括貨幣的時間價值 (倘適用) 而作出調整。

對於所有其他金融工具，假如信貸風險自初始確認以來顯著增加，本集團會確認全期預期信貸虧損。另一方面，倘金融工具的信貸風險自初始確認後並無顯著增加，則本集團按相等於12個月預期信貸虧損的金額計算該金融工具的虧損撥備。

全期預期信貸虧損指金融工具預期於存續期內所有可能違約的事件而導致之預期信貸虧損。相對而言，12個月之預期信貸虧損指全期預期信貸虧損之一部分，由金融工具預期於報告日後12個月內可能發生之違約事件所導致。

The Group always recognizes lifetime ECL for trade receivables. The expected credit losses on these financial assets are estimated using a provision matrix based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current as well as the forecast direction of conditions at the reporting date, including time value of money where appropriate.

For all other financial instruments, the Group recognizes lifetime ECL when there has been a significant increase in credit risk since initial recognition. However, if the credit risk on the financial instrument has not increased significantly since initial recognition, the Group measures the loss allowance for that financial instrument at an amount equal to 12-month ECL.

Lifetime ECL represents the expected credit losses that will result from all possible default events over the expected life of a financial instrument. In contrast, 12-month ECL represents the portion of lifetime ECL that is expected to result from default events on a financial instrument that are possible within 12 months after the reporting date.

##### 信貸風險顯著增加

在評估自初始確認以來金融工具的信貸風險是否顯著增加時，本集團將金融工具於報告日發生的違約風險與金融工具於初始確認日期發生的違約風險進行比較。進行評估時，本集團會考慮合理且有理據的定量及定性資料，包括過往經驗及無需付出不必要的成本或努力而可獲得的前瞻性資料。所考慮的前瞻性資料包括獲取自經濟專家報告、金融分析師、政府機構、相關智庫及其他類似組織有關本集團債務人經營行業的未來前景，以及來自各種外部來源與本集團核心業務相關的實際及預測經濟資料。

##### Significant increase in credit risk

In assessing whether the credit risk on a financial instrument has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument at the reporting date with the risk of a default occurring on the financial instrument at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort. Forward-looking information considered includes the future prospects of the industries in which the Group's debtors operate, obtained from economic expert reports, financial analysts, governmental bodies, relevant think-tanks and other similar organisations, as well as consideration of various external sources of actual and forecast economic information that relate to the Group's core operations.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly since initial recognition:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk for a particular financial instrument;
- existing or forecast adverse changes in business, financial or economic conditions that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations;

不論上述評估結果如何，本集團均假設合約付款逾期超過30日後金融資產的信貸風險已自初始確認以來顯著上升，除非本集團有合理及可靠資料證明其他情況則當別論。

儘管如此，倘若金融工具於報告日被認為具有低信貸風險，則本集團假設金融工具的信貸風險自初始確認以來並無顯著增加。在以下情況下，金融工具會被認為具有較低信貸風險：

- (i) 金融工具具有低違約風險；
- (ii) 債務人近期有良好承擔合約現金流量責任的能力；及
- (iii) 從長遠看，經濟及營商環境的不利變化可能但不一定會削弱債務人履行合約現金流量責任的能力。

- an actual or expected significant deterioration in the operating results of the debtor;
- significant increases in credit risk on other financial instruments of the same debtor;
- an actual or expected significant adverse change in the regulatory, economic, or technological environment of the debtor that results in a significant decrease in the debtor's ability to meet its debt obligations.

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk on a financial asset has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

Despite the foregoing, the Group assumes that the credit risk on a financial instrument has not increased significantly since initial recognition if the financial instrument is determined to have low credit risk at the reporting date. A financial instrument is determined to have low credit risk if:

- (i) the financial instrument has a low risk of default,
- (ii) the debtor has a strong capacity to meet its contractual cash flow obligations in the near term, and
- (iii) adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow obligations.

##### 信貸風險顯著增加(續)

本集團認為，若資產的外部信貸評級被公認為「投資級別」，或若無外部信貸評級，資產的內部信貸評級為「履約」，則該金融資產具有較低信貸風險。履約指交易對手財務狀況良好並且無逾期款項。

本集團定期監測用於識別信貸風險是否顯著增加之準則與其有效性，並在適當情況下作出修訂，以確保該準則在款項逾期前，能識別出其信貸風險已顯著增加。

##### 違約的定義

本集團認為以下情況就內部信貸風險管理目的而言已構成違約事件，因為憑過往經驗顯示，符合以下任何一項條件的應收款項一般無法收回：

- 交易對手已違反財務契諾；或
- 從內部提交或從外部來源取得的資料顯示，債務人不太可能向債權人(包括本集團)還清欠款(未有考慮本集團持有之任何抵押品)。

無論上述情況如何，一般而言，當金融資產逾期超過90天時，本集團均認為違約已發生，除非本集團有合理且可靠資料證明更長期間的違約標準更為恰當，則作別論。

##### Significant increase in credit risk (Continued)

The Group considers a financial asset to have low credit risk when the asset has external credit rating of “investment grade” in accordance with the globally understood definition or if an external rating is not available, the asset has an internal rating of “performing”. Performing means that the counterparty has a strong financial position and there is no past due amounts.

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

##### Definition of default

The Group considers the following as constituting an event of default for internal credit risk management purposes as historical experience indicates that receivables that meet either of the following criteria are generally not recoverable.

- when there is a breach of financial covenants by the counterparty; or
- information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group).

Irrespective of the above analysis, the Group considers that default has occurred when a financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

倘發生一項或多項事件對金融資產之未來現金流量之估計有不利影響時，則金融資產已發生信貸減值。金融資產信貸出現減值之憑據包括下列事項中之可觀察數據：

- 發行人或交易對手出現重大財務困難；
- 違反合約（如拖欠或逾期事件）；
- 交易對手的貸款人出於與交易對手財務困難相關的經濟或合約原因，而向交易對手授予貸款人原本不會考慮的優惠；
- 交易對手可能破產或進行其他財務重組；或
- 該金融資產的活躍市場因財務困難而消失。

**核銷政策**

本集團會核銷金融資產，當有資料顯示債務人有嚴重財政困難而且無實際期望可收回欠款（包括債務人已進行清算或已進入破產程序）或（倘為貿易應收款項）賬款已逾期超過兩年（以較早發生者為準）。所核銷之金融資產根據本集團收回程序，可能仍受到執法活動之約束，因此需要考慮法律建議（如適用）。任何收回之款項會於損益內確認。

A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- significant financial difficulty of the issuer or the counterparty;
- a breach of contract, such as a default or past due event;
- the lender(s) of the counterparty, for economic or contractual reasons relating to the counterparty's financial difficulty, having granted to the counterparty a concession(s) that the lender(s) would not otherwise consider;
- it is becoming probable that the counterparty will enter bankruptcy or other financial reorganisation; or
- the disappearance of an active market for that financial asset because of financial difficulties.

**Write-off policy**

The Group writes off a financial asset when there is information indicating that the debtor is in severe financial difficulty and there is no realistic prospect of recovery, including when the debtor has been placed under liquidation or has entered into bankruptcy proceedings, or in the case of trade receivables, when the amounts are over two years past due, whichever occurs sooner. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. Any recoveries made are recognised in profit or loss.

##### 計量及確認預期信貸虧損

預期信貸虧損的計量為違約概率、違約損失率(即違約發生時的損失程度)及違約風險的函數。評估違約概率及違約損失率的依據為過往數據，並按上述前瞻性資料調整。至於違約風險敞口，就金融資產而言，代表資產於報告日之總賬面值。

金融資產的預期信貸虧損是根據合約上應付本集團的所有合約現金流量與本集團預計收取的所有現金流量(按原定實際利率貼現)之間的差額估算。對於應收租賃，用於確定預期信貸虧損的現金流量與根據香港財務報告準則第16號用於計量應收租賃的現金流量大致相同。

倘若本集團於上一個報告期間按相等於全期預期信貸虧損的金額計量金融工具的虧損撥備，惟於本報告日認為該全期預期信貸虧損的條件不再符合，則本集團於本報告日可按相等於12個月預期信貸虧損的金額計量虧損撥備，惟使用簡化法的資產除外。

本集團於損益中確認所有金融工具的減值收益或虧損，並透過虧損撥備賬項相應調整其賬面值。

##### Measurement and recognition of ECL

The measurement of expected credit losses is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward-looking information as described above. As for the exposure at default, for financial assets, this is represented by the assets' gross carrying amount at the reporting date.

For financial assets, the expected credit loss is estimated as the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive, discounted at the original effective interest rate. For a lease receivable, the cash flows used for determining the expected credit losses is consistent with the cash flows used in measuring the lease receivable in accordance with HKFRS 16.

If the Group has measured the loss allowance for a financial instrument at an amount equal to lifetime ECL in the previous reporting period, but determines at the current reporting date that the conditions for lifetime ECL are no longer met, the Group measures the loss allowance at an amount equal to 12-month ECL at the current reporting date, except for assets for which simplified approach was used.

The Group recognizes an impairment gain or loss in profit or loss for all financial instruments with a corresponding adjustment to their carrying amount through a loss allowance account.

**(w) 撥備及或然負債**

當本集團為了過往已發生的事件需承擔現有法定或推定責任時，就需要為這些不確定時間或金額之負債確認撥備。履行責任可能導致經濟利益流出，並且需要可靠地估計責任金額。倘貨幣的時間價值重大，撥備金額可按預期用於解除該責任之金額的現值列賬。

倘經濟利益流出的機會不大，或責任之金額無法被可靠估計，則該責任會被披露為或然負債，除非經濟利益流出之可能性極低則另作別論。可能出現之責任，如取決於日後一宗或多宗事項，除非經濟利益流出之可能性極低，否則這些負債亦會被披露為或然負債。

**(x) 報告期後事項**

為本集團於報告期末之狀況提供額外資料之報告期後事項或有資料顯示持續經營之假設不恰當時均屬於調整事項，並於綜合財務報表內反映。並非調整事項之報告期後事項如屬重大，則於綜合財務報表附註中披露。

Provisions are recognised for liabilities of uncertain timing or amount when the Group has a present legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditures expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow is remote.

**(x) Events after the reporting period**

Events after the reporting period that provide additional information about the Group's position at the end of the reporting period or those that indicate the going concern assumption is not appropriate are adjusting events and are reflected in the consolidated financial statements. Events after the reporting period that are not adjusting events are disclosed in the notes to the consolidated financial statements when material.

在應用附註 4 所述的本集團會計政策時，本公司董事須對不容易由其他途徑得悉的資產和負債之賬面值作出判斷、估計和假設。估計和基本假設是根據歷史經驗和其他被認為相關的因素。實際結果可能與這些估計不同。

估計及相關假設將持續被審查。倘若修訂僅影響當前期間，則會計估計修訂會在此期間確認，如修訂影響當前和未來期間，則分別在修訂當前和未來期間確認。

#### 物業、廠房及設備以及使用權資產之減值

物業、廠房及設備以及使用權資產是按成本減累計折舊及減值（如有）列賬。於釐定資產會否減值時，本集團須作出判斷及估計，尤其是評估：(1) 是否有已發生事件或有任何指標能影響資產的價值；(2) 可收回金額是否足夠支持資產賬面值，就使用價值而言，是指根據持續使用資產估計的未來現金流量之淨現值；及(3) 估計可收回金額時所用的適當主要假設，包括現金流量的預測及適當的貼現率。當無法估計個別資產（包括使用權資產）的可收回金額時，本集團會估計該資產所屬的現金產生單位的可收回金額。更改假設及估計，包括貼現率及現金流量的增長率，可重大影響可收回金額。

### 5. KEY SOURCE OF ESTIMATION UNCERTAINTY

In the application of the Group's accounting policies, which are described in note 4, the directors of the Company are required to make judgements, estimates and assumption about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and underlying assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an on-going basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affect both current and future periods.

#### Impairment of property, plant and equipment and right-of-use assets

Property, plant and equipment and right-of-use assets are stated at costs less accumulated depreciation and impairment, if any. In determining whether an asset is impaired, the Group has to exercise judgment and make estimation, particularly in assessing: (1) whether an event has occurred or any indicators that may affect the asset value; (2) whether the carrying value of an asset can be supported by the recoverable amount, in the case of value in use, the net present value of future cash flows which are estimated based upon the continued use of the asset; and (3) the appropriate key assumptions to be applied in estimating the recoverable amounts including cash flows projections and an appropriate discount rate. When it is not possible to estimate the recoverable amount of an individual asset (including right-of-use assets), the Group estimates the recoverable amount of the CGU to which the assets belong. Changing the assumptions and estimates, including the discount rates or the growth rate in the cash flow projections, could materially affect the recoverable amounts.

此外，由於 COVID-19 全球大流行未知如何發展和演變以及金融市場的波動，包括本集團酒樓業務潛在暫停營業之風險，本年度現金流量預測、增長率和貼現率面臨更大的不確定性。

於2022年3月31日，鑑於減值指標，本集團分別對賬面價值6,000,000港元的物業、廠房及設備及9,711,000港元的使用權資產進行減值評估，並分別就物業、廠房及設備及使用權資產確認減值虧損1,890,000港元及3,110,000港元。物業、廠房設備及使用權資產的減值評估詳情披露於附註18及19中。

**遞延稅項**

於2022年3月31日，本集團尚有未動用稅項虧損約241,935,000港元(2021年：239,676,000港元)，可用於抵銷日後溢利。由於對日後溢利未能作出準確預測，故並無就該尚未動用稅項虧損確認遞延稅項資產。若日後應課稅溢利多於預期，遞延稅項資產可能出現重大確認並須於確認期內計入損益表。

Further, the cash flows projections, growth rate and discount rate are subject to greater uncertainties in the current year due to uncertainty on how the COVID-19 pandemic may progress and evolve and volatility in financial markets, including potential disruptions in the Group's restaurant operation.

As at 31 March 2022, in view of impairment indicators, the Group performed impairment assessment on property, plant and equipment with carrying amount of HK\$6,000,000 and right-of-use assets of HK\$9,711,000 respectively. Impairment losses of HK\$1,890,000 and HK\$3,110,000 in respect of property, plant and equipment and right-of-use assets have been recognised respectively. Details of the impairment assessment of property, plant equipment and right-of-use assets are disclosed in notes 18 and 19.

**Deferred taxation**

At 31 March 2022, the Group had unused tax losses of HK\$241,935,000 (2021: HK\$239,676,000) available for offset against future profits. No deferred tax asset has been recognised in respect of such unused tax losses due to the unpredictability of future profit streams. In cases where the actual future profits generated are greater than expected, a material recognition of deferred tax assets may arise, which will be recognised in profit or loss in the period in which such recognition takes place.

本集團之業務承受各種財務風險：外匯風險、價格風險、信貸風險、流動性風險及利率風險。本集團的整體風險管理計劃集中於財務市場的不確定性，並尋求減低其對本集團財務表現的潛在不利影響。

#### (a) 外匯風險

本公司部分附屬公司的外幣銷售或銀行結餘以澳元（「澳元」）計價，令本集團面對外幣風險。本集團約 65% 和 84% 的銷售額和銷售成本分別以澳元計價。此外，本公司與附屬公司之間的集團內部結餘以外幣計價，亦令本集團面對外幣風險。

本集團目前對外幣交易，資產和負債沒有外幣對沖政策。本集團將密切監察其外匯風險，並將於有需要時考慮對沖重大外匯風險。

於 2022 年 3 月 31 日，如果澳元（「澳元」）對港元貶值 5%，而所有其他變量保持不變，則本年度的稅後綜合虧損將增加約 1,319,000 港元（2021 年：3,009,000 港元），主要是由於以澳元計價的銀行和現金餘額之外匯虧損。倘若在其他所有變量保持不變的情況下，澳元兌港元匯率每上漲 5%，則本年度的稅後綜合虧損將降低約 1,319,000 港元（2021 年：3,009,000 港元），主要是由於外匯以澳元計價的銀行和現金餘額的匯兌收益。

### 6. FINANCIAL RISK MANAGEMENT

The Group's activities expose it to a variety of financial risks: foreign currency risk, price risk, credit risk, liquidity risk and interest rate risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

#### (a) Foreign currency risk

Some of the subsidiaries of the Company has foreign currency sales or bank balances in Australian dollar ("AUD") which expose the Group to foreign currency risk. Approximately 65% and 84% of the Group's sales and cost of sales, respectively are denominated in AUD. In addition, the Company has intra-group balances with subsidiaries denominated in foreign currency which also expose the Group to foreign currency risk.

The Group currently does not have a foreign currency hedging policy in respect of foreign currency transactions, assets and liabilities. The Group will monitor its foreign currency exposure closely and will consider hedging significant foreign currency exposure should the need arise.

At 31 March 2022, if AUD had weakened 5 per cent against HK\$ with all other variables held constant, consolidated loss after tax for the year would have been approximately HK\$1,319,000 (2021: HK\$3,009,000) higher, arising mainly as a result of the foreign exchange loss on bank and cash balances denominated in AUD. If the AUD had strengthened 5 per cent against HK\$ with all other variables held constant, consolidated loss after tax for the year would have been approximately HK\$1,319,000 (2021: HK\$3,009,000) lower, arising mainly as a result of the foreign exchange gain on bank and cash balances denominated in AUD.

## (b) 價格風險

本集團主要通過投資股本證券而承受股本價格風險。管理層通過持有不同風險和回報狀況的投資組合來持續管理此風險。本集團的股票價格風險主要集中於在聯交所上市的股票證券。

以下敏感度分析是根據報告期末面對之股票價格風險而釐定。

如果截至2022年3月31日止年度的股票價格上漲/下跌10% (2021年：10%)，其他綜合收益將增加/減少約113,000港元 (2021年：126,000港元)。這主要是由以公平值計入其他全面收益的金融資產的公平值變動所引致。

## (c) 信貸風險

本集團由於交易對手未能履行其責任而面對的最大信貸風險來自於綜合財務狀況表所載各項已確認金融資產的賬面值。

本集團採用預期信貸虧損模式為本集團所有金融資產計算相當於12個月的預期信貸虧損之虧損撥備，倘若自初始確認後信貸風險顯著增加，本集團則確認全期信貸虧損。本集團於初始確認資產時會考慮違約概率以及信用風險是否持續顯著增加。本公司董事認為，自初始確認後，本集團金融資產的信用風險並無顯著增加。

本集團未有提供任何其他擔保可使本集團面對信貸風險。

## (b) Price risk

The Group is exposed to equity price risk mainly through its investment in equity securities. The management manages this exposure by maintaining a portfolio of investments with different risk and return profiles. The Group's equity price risk is mainly concentrated on equity securities quoted on the Stock Exchange.

The sensitivity analysis below has been determined based on the exposure to equity price risk at the end of the reporting period.

If equity prices had been 10% (2021: 10%) higher/lower, other comprehensive income for the year ended 31 March 2022 would increase/decrease by HK\$113,000 (2021: HK\$126,000). This is mainly due to the changes in fair value of financial assets at FVTOCI.

## (c) Credit risk

The Group's maximum exposure to credit risk in the event of the counterparties failure to perform its obligations is arising from the carrying amounts of the respective recognised financial assets as stated in the consolidated statement of financial position.

The Group applies ECL model under which the Group measures the loss allowance equal to 12-month ECL for all the Group's financial assets, unless when there has been a significant increase in credit risk since initial recognition in which circumstance the Group recognizes lifetime ECL. The Group considers the probability of default upon initial recognition of asset and whether there has been a significant increase in credit risk on an ongoing basis. The directors of the Company believe that there are no significant increase in credit risk of the Group's financial asset since initial recognition.

The Group does not provide any other guarantees which would expose the Group to credit risk.

##### 貿易應收款項

各業務單位會根據本集團有關客戶信貸風險的政策、程序及監控來管理客戶之信貸風險。本集團會為所有要求信貸超過一定金額之客戶進行個別信貸評估。該等評估集中於客戶過往之到期還款記錄及當前的還款能力，亦會考慮客戶的獨有資料以及客戶營運所處之經濟狀況。貿易應收款項自賬單日起計30天內到期。結餘已逾期90天以上的債務人須清還所有未償還結餘方可再獲授任何信貸。一般而言，本集團不會要求客戶提供抵押品。

本集團貿易應收款項之虧損撥備是按照相等於全期預期信貸虧損之金額計量，並且使用撥備矩陣計算得出。基於本集團以往的信貸虧損經驗，不同客戶層未有顯示重大不同虧損模式，有關逾期款項的虧損撥備不會在本集團不同客戶之間再作分類。當前應收款項和合同資產的預期損失率估計為0%。截至2022年3月31日和2021年3月31日，有關結餘之虧損撥備並不重大。

##### 其他應收款項／物業租賃按金／已抵押銀行存款／銀行結餘

本集團透過前瞻性信息考慮過對各交易對手違約率的假設，應為其他應收款項及物業租賃按金的預期虧損在 12 個月預期信貸虧損模式下並不重大，因此，並無就此等結餘確認撥備。

#### (c) Credit risk (Continued)

##### Trade receivables

Customer credit risk is managed by each business unit subject to the Group's established policy, procedures and control relating to customer credit risk management. Individual credit evaluations are performed on all customers requiring credit over a certain amount. These evaluations focus on the customer's past history of making payments when due and current ability to pay, and take into account information specific to the customer as well as pertaining to the economic environment in which the customer operates. Trade receivables are due within 30 days from the date of billing. Debtors with balances that are more than 90 days past due are requested to settle all outstanding balances before any further credit is granted. Normally, the Group does not obtain collateral from customers.

The Group measures loss allowances for trade receivables at an amount equal to lifetime ECLs, which is calculated using a provision matrix. As the Group's historical credit loss experience does not indicate significantly different loss patterns for different customer segments, the loss allowance based on past due status is not further distinguished between the Group's different customer bases. The expected loss rate of current trade receivables and contract assets are assessed to be 0%. As at 31 March 2022 and 2021, there is no loss allowance provision for these balances.

##### Other receivables/property rental deposits/pledged bank deposits/bank balances

No allowance has been recognised for other receivables and property rental deposits as the expected loss for these balances is immaterial under 12-month ECL model based on the Group's assumption on the rates of default of respective counterparties taking into account forward-looking information.

As the provision of these services are at a period of one year or less, as permitted under HKFRS 15, the transaction price allocation to the unsatisfied contracts is not disclosed.

**Property development**

The Group develops residential properties in Australia. Revenue is recognised at the point in time when control over the property has been transferred to the customer.

The key assumptions for the discounted cash flow method are those regarding the discount rate, growth rate and budgeted gross margin and revenue during the period. The Group estimates discount rates using pre-tax rates that reflect current market assessments of the time value of money and the risks specific to the CGU. The growth rates are based on long-term average economic growth rate of the geographical area in which the businesses of the CGU operate. Budgeted gross margin and revenue are based on past performance and expectations on market development.

The Group prepares cash flow forecasts derived from the most recent financial budgets approved by the directors over the remaining lease term of the leased properties of restaurant operation with the residual period using the growth rate of 1.6% (2021: 2.15%). This rate does not exceed the average long-term growth rate for the relevant markets.

The rate used to discount the forecast cash flows from the Group's operating restaurant activities are 10.69% (2021: 12.31%).

Accordingly, a total recoverable amount of HK\$15,409,000 was estimated. As the recoverable amount of CGU is lower than the respective carrying amounts of property, plant and equipment and right-of-use assets, impairment losses of approximately HK\$1,890,000 and HK\$3,110,000 were recognised on property, plant and equipment and right-of-use assets in the profit or loss for the year ended 31 March 2022 so arising from the CGU, respectively.

### 31. SHARE OPTION SCHEME

The Company adopted a share option scheme on 10 May 2010 (the "2010 Scheme") which expired on 8 May 2020. By a shareholders' resolution passed at the annual general meeting held on 3 August 2020, the Company adopted a new share option scheme (the "2020 Scheme", and, together with the 2010 Scheme, the "Schemes"). No further share options may be offered under the 2010 Scheme. However, any outstanding share options granted under the 2010 Scheme shall continue to be exercisable subject to the rules of the 2010 Scheme and the provisions of Chapter 17 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Stock Exchange") (the "Listing Rules"). Unless terminated earlier in accordance with the rules of the 2020 Scheme, the 2020 Scheme shall be valid and effective until 3 August 2030.

Pursuant to the 2020 Scheme, an option shall be deemed to have been granted to the grantee and to have taken effect when the duplicate offer document constituting acceptance of the offer for such option duly signed by the grantee, together with a non-refundable remittance in favour of the Company of HK\$1.00 by way of consideration for the grant thereof, is received by the Company within 30 business days after the date of offer.

The exercise price under the Schemes of the option shares shall at least be the highest of (i) the average closing price of the shares of the Company as stated in the Stock Exchange's daily quotations sheets for the five business days immediately preceding the date of offer; (ii) the closing price of the shares of the Company as stated in the Stock Exchange's daily quotations sheet on the date of offer, which shall be a business day; and (iii) the nominal value of the shares of the Company.

Save for this, there is neither any performance targets that need to be achieved by the grantee nor any minimum period for which a share option must be held before a share option can be exercised.

鴻利是Golden Toy Investments Limited（「Golden Toy」）之全資附屬公司，而Golden Toy乃由一項全權信託全資擁有，該項信託之受益人包括鄭合輝先生、鄭白明女士、鄭白敏女士及鄭白麗女士，彼為本公司之執行董事並為Kong Fai，即本集團最終控股公司之實益擁有着。

- (b) 於年內，本集團向豪城實業有限公司（「豪城」）租用一住宅物業。豪城於年內收取之租金為900,000港元（2021年：900,000港元）。於2022年3月31日，租賃按金150,000港元已包括在流動物業租賃按金中（2021年：150,000港元已包括在流動物業租賃按金中）。於2022年及2021年3月31日，並沒有應計租金應付予豪城。

豪城是Golden Toy之全資附屬公司。

## 36. RELATED PARTY TRANSACTIONS

- (a) During the year, the Group leased certain properties for its restaurant operations from Homley Development Limited (“Homley”). Rentals charged by Homley during the year amounted to HK\$2,940,000 (including HK\$660,000 rental concession) (2021: HK\$3,200,000 (including HK\$1,120,000 rental concession)). At 31 March 2022, rental deposit of HK\$1,080,000 was included in current property rental deposits (2021: HK\$1,080,000 included in current property rental deposits). At 31 March 2022, accrued rental payable to Homley was HK\$Nil (2021: HK\$20,000).

Homley is a wholly-owned subsidiary of Golden Toy Investments Limited (“Golden Toy”) whose entire issued share capital is beneficially owned by a discretionary trust the objects of which include Mr. Cheng Hop Fai, Ms. Cheng Pak Ming, Judy, Ms. Cheng Pak Man, Anita and Ms. Cheng Pak Lai, Lily who are also executive directors of the Company and beneficial owners of Kong Fai, the Company’s ultimate holding company.

- (b) During the year, the Group leased an unit of a residential building from Hover City Industrial Limited (“Hover City”). Rental charged by Hover City during the year amounted to HK\$900,000 (2021: HK\$900,000). At 31 March 2022, rental deposit of HK\$150,000 was included in current property rental deposits (2021: HK\$150,000 included in current property rental deposits). At 31 March 2022 and 2021, no accrued rental was payable to Hover City.

Hover City is a wholly-owned subsidiary of Golden Toy.

- (c) During the year, the Group leased an office from Sky Global Investments Limited (“Sky Global”). Rentals charged by Sky Global during the year amounted to HK\$1,200,000 (2021: HK\$1,200,000). At 31 March 2022, rental deposit of HK\$240,854 was included in current property rental deposits (2021: HK\$240,854 was included in current property rental deposits). At 31 March 2022 and 2021, no accrued rental was payable to Sky Global.

Sky Global is a wholly-owned subsidiary of Hover City which in turn is a direct wholly-owned subsidiary of Golden Toy.

- (d) During the year, the Group entered into transactions with Hung Yick Metal Company Limited (“Hung Yick”). Sales to Hung Yick during the year amounted to HK\$438,000 (2021: HK\$476,000). At 31 March 2022 and 2021, there was no receivable from Hung Yick.

Hung Yick is a wholly-owned subsidiary of Hover City which in turn is a direct wholly-owned subsidiary of Golden Toy.

- (e) On 31 October 2019, the Group entered into a loan agreement with Hover City for a loan facility to the extent of HK\$15,000,000 offered to the Group by Hover City. The sum drawn down by the Group would bear interest at 2.5% over the best lending rate quoted by a bank in Hong Kong. On 29 January 2021, the loan agreement was terminated with no outstanding balances.

(f) On 1 February 2021, the Group entered into a loan agreement with Kong Fai for a loan facility to the extent of HK\$40,000,000 offered to the Group by Kong Fai and further extent to HK\$50,000,000 on 1 September 2021. The sum drawn down by the Group will bear interest at 5% per annum. The total sum drawn down by the Group was HK\$43,000,000 (2021: HK\$20,000,000) during the year. The loans and accrued interest amounted to HK\$44,060,000 were fully repaid in October 2021. Interest charged by Kong Fai during the year amounted to HK\$948,000 (2021: HK\$112,000).
