Reference is made to the announcement of CITIC Limited on 30 August 2022, with respect to (a) the payment of interim dividend of HK\$0.20 per share for the year ending 31 December 2022 and (b) the option given to the shareholders to elect to receive all (but not part) of their dividend in Renminbi ("RMB") at the exchange of HK\$1.0/RMB0.873318.

If you wish your election to be applicable for the 2022 Interim Dividend, you must complete this election form and make sure that it is received by the Company's Share Registrar, Tricor Tengis Limited, at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong, not later than 4:30 p.m. on Monday, 17 October 2022 ("Closing Time"). If no election form is received by the Company's Share Registrar by the Closing Time, you will receive your 2022 Interim Dividend in HONG KONG DOLLARS. The Closing Time will be adjusted, as the case may be, in accordance with (a) or (b) below if a Typhoon Warning Signal No. 8 or above is hoisted, a Black Rainstorm Warning is in force in Hong Kong or "extreme conditions" resulting from a typhoon or a rainstorm are announced by the Government of the Hong Kong Special Administrative Region of the People's Republic of China:

(a) at any local time before 12:00 p.m. on Monday, 17 October 2022. In such a case, the Closing Time will be extended to 5:00 p.m. on the same business day; or

(b) at any local time between 12:00 noon and 4:30 p.m. on Monday, 17 October 2022. In such a case, the Closing Time will be extended to 4:30 p.m. on the next business day which does not have any of the above warnings in force at any time between 9:00 a.m. and 4:30 p.m..

倘閣下希望閣下之選擇適用於2022年度中期股息，閣下須填妥本選擇表格及確保於2022年10月17日(星期一)下午4時30分(「最後時限」)或之前送達本公司之股份過戶登記處卓佳證券有限公司(地址為香港夏愷道16號遠東金融中心7樓)。倘選擇表格未能於最後時限或之前送達本公司之股份過戶登記處，則閣下將會以港幣收取2022年度中期股息。倘懸掛八號或以上颱風信號、黑色暴雨警告信號或中華人民共和國香港特別行政區政府宣布有關颱風或暴雨引致的極端情況於以下香港時間發生，則最後時限將根據下述(a)及(b)段作出調整：
