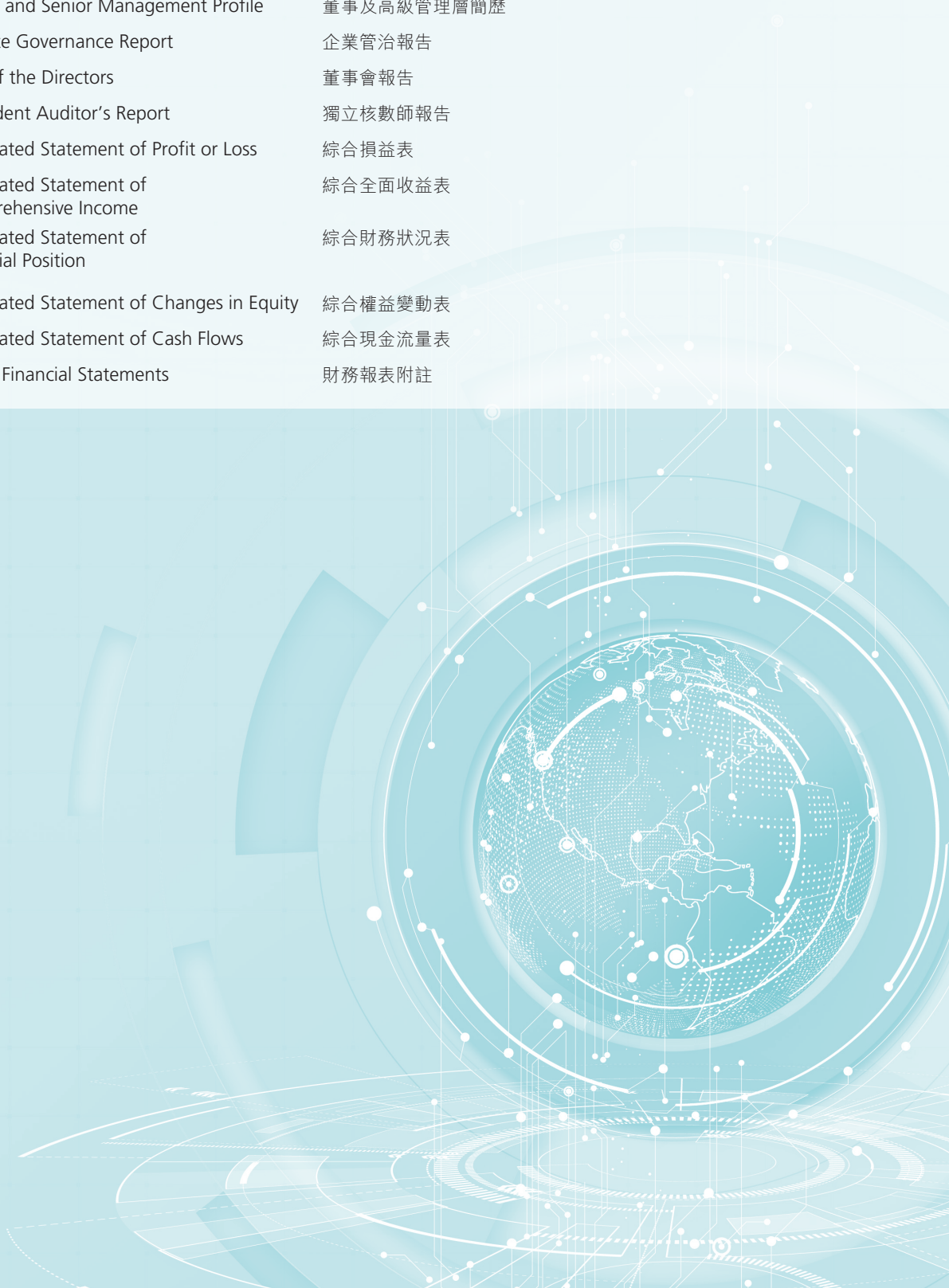

# Chairman's Statement

## 主席報告

Dear Shareholders,

On behalf of the board (the "Board") of directors (the "Directors") of Yan Tat Group Holdings Limited (the "Company"), I am pleased to present the audited consolidated results of the Company and its subsidiaries (collectively referred to as the "Group") for the year ended 31 December 2022.

Our Group's turnover decreased from approximately HK\$763.8 million in 2021 to approximately HK\$743.6 million in 2022, representing a decrease of approximately 2.6%. Gross profit was approximately HK\$180.8 million in 2022, representing an increase of approximately 26.4% from that of 2021. Profit attributable to ordinary equity holders of the Company was approximately HK\$94.3 million in 2022, representing an increase of approximately 104.1% from that of 2021. The increase in net profit was primarily due to the recovery of certain surging material costs from certain clients and the increase in net foreign exchange revenue mainly driven by the appreciation of USD against RMB.

Printed circuit board (the "PCB") is the bridge that carries electronic components and connects to the circuit. Therefore, many people describe PCB as the "the mother of electronic products". It is widely used in the fields of communication electronics, consumer electronics, computers, automotive electronics, industrial controller, medical devices, national defense and aerospace, etc. It is everywhere around modern electronic world. Due to the wide market of downstream consumers of PCB products, this industry is less affected as compared to other industries with a single downstream industry, and the total output value of the global PCB industry is mainly closely related to the macroeconomic conditions.

Year 2022 is complicated. Tension around the global has been intensified by geopolitical issues. The unexpected and recurring pandemic impacts people's livelihood and the economy. Logistics and the people flow are not smooth. Recruitment is difficult, and talent acquisition is even harder. Disruptions to the supply chain and the backlog of land, sea and air transport lead to the increase in production costs of producers.

Nonetheless, the PCB industry is a substantially stable business segment which is only slightly affected by the negative factors of the overall situation. The range of application of PCBs is extensive, including but not limited to 4C products, Internet-of-Things, autonomous cars, big data as well as automobile electronics and electrification. The development of each mode of application will drive the demand for PCBs.

各位股東：

本人謹代表恩達集團控股有限公司(「本公司」)之董事(「董事」)會(「董事會」)，欣然呈報本公司及其附屬公司(統稱為「本集團」)截至二零二二年十二月三十一日止年度之經審核綜合業績。

本集團之營業額由二零二一年的約763.8百萬港元下降至二零二二年約743.6百萬港元，減幅約為2.6%。於二零二二年，毛利約為180.8百萬港元，較二零二一年上升約26.4%。於二零二二年，本公司普通權益持有人應佔溢利約94.3百萬港元，較二零二一年上升約104.1%。純利上升主由於向若干客戶收回部分飆升的材料成本；及外匯收益淨額增加，其主要由美元兌人民幣升值所帶動。

印刷電路板(PCB)是承載電子元器件並連接電路的橋樑，所以不少人描述PCB為「電子產品之母」，它廣泛應用於通訊電子、消費電子、計算機、汽車電子、工業控制、醫療器械、國防及航空航天等領域，在現代電子世界無處不在，由於PCB產品下游受眾市場較廣，產業受單一下游行業的影響相對其他產業較小，全球PCB行業總產值主要與宏觀經濟狀況緊密聯繫。

二零二二年是複雜的一年，地緣政治問題加劇世界各地的緊張氣氛，疫情發展飄忽和持續，影響民生及經濟，物流人流的不順暢，招工難，搵人材更難，供應鏈流轉慢，海陸空運輸都有所積壓，增加生產商的經營成本。

然而，PCB行業正處於非常穩的業務板塊，所受大環境負面因素影響較細，PCB應用層面廣，涉及4C產品、物聯網、自動駕駛汽車、大數據、汽車電子化電氣化等等，每項應用的發展，都會牽領PCB需求。

The amount of corresponding equipment and devices associated with the rapid development of 5G is enormous, thus creating tremendous business opportunities. Automobile electronics and electrification involves utilization of a considerable amount of circuit boards. The utilization of circuit boards in new energy vehicles exceeds that of conventional vehicles by several times. The demand for 4C products remains steady. # Management Discussion and Analysis

## 管理層討論及分析

### INDUSTRY OVERVIEW

The printed circuit board, also known as “PCB”, is mainly comprised of insulation base materials and conductors. PCBs, which support and connect electronic devices as they provide connection between electric components, are components required to combine a majority of electronic devices with electronics, machinery, and chemical materials. They are also given the name of “the mother of electronic products”.

In 2022, global economic activities generally slowed down. Various countries faced cost of living crisis due to high inflation. Financial environment of various regions has been contracting. Russia-Ukraine conflict and the persistence of COVID-19 have posed severe impacts to the economic outlook. International Monetary Fund predicted that the global economy will grow by about 3.4% in 2022. The growth rate, however, is expected to decrease to 2.9% in 2023 and slightly increase in 2024.

Despite the threat of unpredictable factors such as geopolitics, high inflation and high level of inventories, it is estimated that the global PCB industry will still grow slightly in 2022 with global output value of approximately US\$84.6 billion. PCB market of 5G related equipment, servers, new energy vehicles and the supply chain of Apple Inc. recorded better performance. Research institutions predict that global PCB market will grow to approximately US\$101.5 billion in 2026.

The PCB industry has been long established, with its early presence mainly distributed in Europe, North America, and Japan. Due to global migration of the electronics sector, Asia takes the lead in the PCB industry development on the globe. According to the information available, the output value of PCBs in the PRC was approximately US\$44.2 billion in 2021, accounting for approximately 54.6% of the global market share.

PCB is a necessary component of electronic products. With continuous technological advancements, the demand for PCBs is steady and is expected to grow continuously. The range of application of PCBs is extensive, including communication electronics, consumer electronics, computers, automotive electronics, industrial controller, medical devices, national defense and aerospace and other fields. In recent years, driven by the demands of emerging sectors such as 5G technology, new energy vehicles, Internet-of-Things, big data, cloud computing, energy conservation and environmental protection, and information security, good business opportunities will be maintained in the PCB market.

### 行業概覽

印刷電路板，又稱「PCB」，主要由絕緣基材與導體兩類材料組成。PCB是電子元器件連接的提供者，在電子設備中起支撐、互連的作用，是結合電子、機械、化工材料等絕大多數電子設備產品必需的元件，又被稱為「電子產品之母」。

二零二二年全球經濟活動普遍放緩，通脹處於高水平，各國面臨著生活成本危機，多數地區的金融環境不斷收緊，俄烏衝突，新冠疫情持續不退，這些都對經濟前景造成了嚴重影響，國際貨幣基金組織估計二零二二年全球增長率約為3.4%，二零二三年預計將降至2.9%，二零二四年再作稍微回升。

在地緣政治、高通膨、高庫存等不可預測的因素威脅下，二零二二年全球PCB產業估計仍有輕微的增長，全球總產值達約846億美元，5G相關配置、服務器、新能源汽車以及蘋果供應鏈等PCB市場表現較好，更有研究機構預計二零二六年全球PCB市場將增長至約1,015億美元。

PCB行業發展悠久，早年主要分佈在歐洲、北美、日本等，隨著全球電子產業轉移，亞洲主導全球PCB產業發展。根據可得資料顯示，二零二一年中國PCB產值約為442億美元，全球市場佔比約54.6%。

PCB作為電子產品中不可或缺的元件，隨著科技水平的不斷提升，其需求穩定且將持續增長，其應用領域之廣，包含了通訊電子、消費電子、計算機、汽車電子、工業控制、醫療器械、國防及航空航天等領域。近年來，隨著5G科技、新能源汽車、物聯網、大數據、雲計算、節能環保、信息安全等新興領域需求的帶動，PCB市場將保持不錯的商機。



# Management Discussion and Analysis

## 管理層討論及分析

Automobile electronics has become a global trend, which promotes the rapid growth of automobile PCBs. PCBs are widely used in engine, control, safety, information and in-vehicle systems. Compared with conventional vehicles, the requirement of electronics for new energy vehicle is higher and the PCB value of new energy vehicles is approximately 4 times than that of conventional vehicles. In view of the immense effort in promoting the development of new energy vehicle by countries around the world, it shall create tremendous business opportunities to the PCB market in the future.

The new applications of PCBs will further drive the development of the PCB industry. The 5G technology deployment will significantly advance the progress of the PCB industry. There are approximately 0.654 million newly-built 5G base stations in the PRC for 2021. As at September 2022, 5G base stations which have been established and commenced operation amounted to approximately 2.2 million in total. A research institute estimates that the output value of PCBs for communications infrastructure was approximately US\$8 billion in 2021 and will reach US\$9.2 billion in 2026. With the establishment of a complete 5G network, it also accelerates the formation of the consumer 5G electronics industry chain. It is expected that prospect will emerge in the PCB market.

Although the PCB market has an encouraging prospect, it also faces numerous difficulties. As the PRC government has strengthened its efforts on environmental protection, manufacturing enterprises that fail to meet the requirements will be subject to rectification, or even replacement or suspension. As a result, compliant PCB manufacturers are required to increase investments in environmental engineering and wastewater treatment capacities, which undoubtedly adds weight on their operating costs.

The COVID-19 outbreak in early 2020, which has spread across China with worldwide infection, has caused material impact on a wide range of economic activities. The operation of PCB manufacturers is inevitably affected. After a long time of three years, various countries around the globe are moving along the path to normalcy, yet the PRC has progressed rather slowly in this regard. In 2022, the COVID-19 pandemic quickly spread across the PRC, and has been quickly contained. The PRC has accelerated opening up recently, laying a smooth path towards global economic recovery.

Against the large-scale capacity expansion launched by many PCB manufacturers with excess capacity amid a growing number of new PCB manufacturers in recent years, the market has eventually become increasingly competitive, with the possibility of triggering a fierce pricing competition. With the unit price being adjusted downwards, the slim profit margin will further shrink.

汽車電子化是大勢所趨，推動汽車PCB高速增長，無論是發動機系統、操縱系統、安全系統、信息系統及車內環境系統等等，都不難找到PCB的蹤影，相比傳統型汽車，新能源汽車對電子程度的要求更高，新能源汽車的PCB價值量是傳統型汽車的約4倍，隨著各國正大力推動新能源汽車的發展，可為未來PCB市場帶來無限商機。

PCB新應用更能帶動PCB行業發展，5G科技建置將大大推動PCB產業前進，二零二一年，中國內地全年新增5G基站數約65.4萬個，截止到二零二二年九月，累計建成開通5G基站約220萬個，有研究機構估計，應用於通訊基礎設施建設的PCB在二零二一年產值約為80億美元，到二零二六年預計將達到92億美元。隨著完善的5G網絡成立，消費類的5G電子產業鏈亦會加速形成，預期PCB市場將有另一番景象。

儘管PCB市場確有不錯的前景，但是也面對不少的困難。隨著中國政府對環保力度加強，未能達標的生產企業會面對被整改，更甚至被取替或停產，因此合規的PCB製造商，在環保工程及廢水處理投放力度亦有所提升，無疑加重PCB製造商的運營成本。

二零二零年初在全國爆發COVID-19，更蔓延世界各地，該情況嚴重影響各式各樣的經濟活動，PCB製造商的營運亦無一倖免。經過了漫長的三年，世界各地先後走上復常之路，而中國在復常之路起步較慢，二零二二年，COVID-19疫情在中國快速蔓延，及後迅速平復，中國在近期更加快開放步伐，為全球經濟復蘇之路鋪平了不少。

隨著近年不少PCB製造商大規模地擴產，有產能過剩的現象，新進PCB製造商不斷增加，結果令市場變得激進，有機會引發激烈的價格競爭，當單位價格下調，微薄利潤會再度收窄。

# Management Discussion and Analysis

## 管理層討論及分析

The labor costs in China have been on the rise over the past decade, as corporate expenditure rises due to full implementation of policies on social security and public housing fund. A phenomenon of “recruitment difficulty, labor shortage” often appears in the developed coastal areas, in which case, recruitment of frontline employees, particularly seasoned technicians, becomes increasingly difficult. As a result, many domestic PCB enterprises gradually relocate their production bases to inland provinces and cities, or undergo comprehensive reform to accelerate the process of production automation and intellectualization to reduce the dependence on manpower and ensure the stability of quality.

### BUSINESS REVIEW AND DEVELOPMENT

The Group is an original equipment manufacturer (“OEM”) provider of PCBs and focused on the production of quality PCBs, which meet industrial standards such as IPC Standards, as well as the customers’ requirements.

We focused on the conventional PCBs with a well-developed capacity to produce multi-layered and special material PCBs with primary applications in automobiles, communication equipment, medical devices, industrial automation equipment and consumer electronics.

Our continuous diversification of product mix and market coverage allowed the Group to swiftly cater for the changes in demand from certain sectors and adjust our production output accordingly, resulting in reduced reliance on a single product and market. Benefited from the enormous business opportunities generated from automobile electronics in recent years, the proportion of our revenue generated from this section is correspondingly higher.

Over the past 33 years of our operation, the Group has established a solid foundation and close relationship with our customers. The Group provided direct and indirect services to OEM customers across Asia, Europe, Africa, North America, South America and Oceania, who are engaged in various industries with many of them running in a multinational model. Certain of our major OEM customers are leading players in their markets. The Group supplied PCB products directly to a number of leading electronic manufacturing service providers, in order to assemble finished goods of OEM for the Group’s indirect OEM customers. To date, the Group has built up long-term relationship with major customers, and some of them have been working with us for over a decade. The Company believed that these customers also considered the Group as their important partner for their supply chain. Therefore, our profound and long-term relationship with customers will enable the Group to know the trend of customers’ demand more quickly.

中國國內勞動成本在過去十年不斷上升，全面實施社會保障和住房公積金政策增加企業的成本，在沿海發達地區經常出現「招工難，用工荒」的現象，招聘一線員工（特別是有經驗的技術員）更見困難，因此國內不少PCB企業將生產基地逐漸遷往內地省市或進行全面改革，加快加大力度進行生產自動化、智能化，減少人力的依賴，又可保證品質的穩定性。

### 業務回顧及發展

本集團為PCB原設備製造（「OEM」）供應商，專注於從事製造高質量PCB，產品皆符合行業標準（例如IPC標準），以及我們客戶的規定。

我們的目標鎖定在傳統PCB，並具備製造多層及特殊物料PCB的完備能力，主要應用於汽車、通訊設備、醫療設備、工業自動化設備以及電子消費品。

我們持續多元化的產品組合及市場覆蓋讓本集團能夠快速迎合部分行業的需求變化，據此調節我們的產出，從而減少對單一產品及市場的依賴，受惠於近年汽車電子化的龐大商機，該部分產生的收益比重相應較大。

在過去超過三十年的經營，本集團已建立穩固的根基及深厚的客戶關係，本集團向遍佈在亞洲、歐洲、非洲、北美洲、南美洲及大洋洲的原設備製造商客戶提供直接及間接的服務，該等客戶在林林總總的行業經營，許多更以跨國模式運作。若干主要原設備製造商客戶為其所屬市場中的表表者。本集團亦向多家領先電子製造服務提供者，直接供應PCB產品，藉以為本集團的間接原設備製造商客戶組裝原設備製造商製成品。迄今，本集團與主要客戶建立長遠關係，當中部分已合作逾十載，而本公司相信彼等亦視本集團為其供應鏈上的重要夥伴。因此，與客戶所建立的深厚長久關係，可使本集團更快掌握客戶需求的動向。

The Group is of the view that product and process quality are integral to its business. The Group complies with various international quality standards and systems, including ISO9001, ISO14001 and IATF16949 certifications. The Group has put in place a number of quality measures and simplification plan to promote a culture of quality product. Quality is of paramount importance to the business of the Group and is regularly reviewed and improved by dedicated personnel to enhance customer satisfaction. In addition, the Group obtained AS9100 certification in 2009 to qualify for the provision of advanced and reliable PCBs for the aerospace industry. This is a testament to our product quality. During 2022, the Group complies with ISO 13485 certification, proving that the Group's quality management system complies with the production and sales requirement of circuit boards for medical equipment.

The high production cost continues to affect the PCB industry in 2022. Followed by the sweep of emission limits and environmental protection measures across China, PCB manufacturers are facing steep challenges. As a PCB manufacturer, the Group needs to formulate appropriate responses and increase the capital input in respect of environmental protection resulting in the set-off of part of the profits of the Group. However, viewing from another perspective, manufacturers failing to meet the required standards would be eliminated or would have to enhance their operation cost in order to comply with the required standards, whereas the Group has realized the need for environmental protection and has made relevant investment many years ago. Therefore, compared with those failing to meet the standards, the Group is under less pressure in such new setting in the PCB market and better positioned to seize opportunities.

Although China remains to be the "World Factory", labor costs are no longer as low as a decade before and have gradually increased. In addition, the labor supply is insufficient in the coastal areas. The Group enhanced its production automation, promoted the use and flow of production information, optimized and improved costs and quality which could eventually lead the Group to develop towards intelligent production in the future.

本集團認為，產品及工序的質素對其業務有關鍵作用。本集團符合多項國際品質標準及系統，包括ISO9001、ISO14001及IATF16949認證。本集團亦已實施多項品質方案及簡化計劃，以促進優質產品文化。品質乃本集團業務的關鍵所在，並由專人定期作出檢討及改善，藉以提升客戶滿意度，此外，本集團於二零零九年獲得AS9100認證，籍以能夠為航天工業供應高科技及可靠性高的PCB，此舉乃對我們的產品質量的一種肯定。二零二二年，本集團更獲得ISO 13485認證，證明本集團的質量管理體系符合醫療器械用电路板的生產和銷售要求。

高生產成本持續於二零二二年度影響PCB行業，緊隨著限排環保措施的旋風席捲全中國，各PCB製造商正面臨對此嚴峻的挑戰，作為PCB製造商的本集團，更需要考慮適當的應對方法，加大對環保的資金投入，因而抵銷了本集團一部分利潤；但在另一角度看，未能達標的生產企業，有可能被淘汰，或大大增加成本來符合標準，而本集團早在多年前已注意到環保需要，作出相應投入。因此，在PCB市場新的環境下，本集團較其他未達標的企業，壓力較少，而此消彼長，可能有更好的機遇。

雖然中國仍是「世界工廠」，惟十多年前較低的勞工成本已日漸上升，沿海地區的勞工供應，亦有不足的情況，本集團加強生產自動化，促進生產信息的運用流轉，優化改善成本與質量，日後更令本集團最終朝著智能化生產方向邁進。

In 2022, various foreign countries have overcome the COVID-19 crisis. As the overseas market recovers, the demand for downstream PCB products increases. The Group grasps this opportunity and maintains its overseas sales. However, domestic business environment is still under the influence of the pandemic. During the middle of the year, the pandemic spread quickly. Fortunately, its spread has been suppressed shortly and has not caused severe adverse impact to the Group's domestic market. Accordingly, the Group's sales remains steady.

In 2022, enterprises which focus on the overseas market are likely to enjoy foreign exchange gain as the exchange rate of USD against RMB increases from US\$1 to approximately RMB6.35 in the beginning of the year to US\$1 to approximately RMB7.25 in October. As a certain proportion of the Group's sales originates from the overseas market, the Group can obtain a considerable amount of foreign exchange gain.

In 2022, serious challenges exposed the Group to a lot of risks and uncertainties. The Group has been concentrating on its PCB business for over 30 years, in which the accumulated experience and networks allow the Group to make further development in the PCB market. With the rapid progress of the urbanization in Shenzhen, the Shenzhen Pingshan District Government has also made strategic planning for promoting its local development. Given the increased labor costs in Shenzhen and the need to maintain competitiveness and respond to the future change in the planned use of the current production area of Yan Tat Printed Circuits (Shenzhen) Co., Ltd., after consultation with the Board and the professional advisers, the Group plans to establish another production base in the Greater Bay Area to support the long-term development of the Group. Apart from the headquarters in China and the research and development department which will remain located in Pingshan District, Shenzhen, the bulk production capacity of the Group will be relocated gradually to the new production base. The Group entered into a cooperation agreement with independent third parties in relation to the urban renewal project (the "Urban Renewal Project") located at the current production area in Pingshan District, details of which are further particularised in "Financial Review — Future plans for material investments and capital assets" below. At the same time, the Group will also consider opportunities to maximize shareholders' benefits from time to time.

二零二二年，海外各國先後已逐步從COVID-19的陰霾走出，海外市場正復甦當中，對PCB下游產品需求增加，本集團抓緊此機遇，維持集團的海外銷售，然而國內經營環境仍然持續受疫情影響，年中疫情更有迅速蔓延擴散的情況，幸好短時間內得以平復，未有集團國內市場造成很大的負面傷害，此消彼長，集團銷售仍然維持平穩。

二零二二年對注重海外市場的企業，很大機會能獲得匯差的紅利，美元兌人民幣從低位上升，從年初的1美元兌約6.35人民幣，上升至十月份的1美元兌約7.25人民幣，由於本集團的銷售，有一定份額來自國外市場，所以亦能獲得大額的匯差收益。

二零二二年，嚴峻的挑戰令本集團面對不少風險及不明朗因素。本集團專注PCB業務超過三十年，所累積經驗及網絡有利本集團在PCB市場進一步發展，隨深圳城市化的急速發展，深圳市坪山區政府亦制定策略規劃以支持當地發展。鑒於深圳勞動成本增加，為保持競爭力及配合恩達電路(深圳)有限公司現廠址未來規劃用途改變，經董事會及專業顧問共同研究後決定，為配合長遠發展，本集團計劃在大灣區發展另一個生產基地，除保留本集團中國總部及研發部門在深圳坪山區外，將其大批量生產逐步遷往新基地，本集團與獨立第三方就坪山現廠區之城市更新項目(「城市更新項目」)的發展簽訂合作協議，具體詳情載於下文「財務回顧 — 重大投資及資本資產的未來計劃」，與此同時，本集團亦會不時考慮為股東爭取最大利益的機會發展。

The Group's turnover for the year of 2022 was approximately HK\$743.6 million, representing a decrease of approximately 2.6% compared to that of the previous year, which was primarily attributable to the slight decrease in sales orders from customers due to the generally slowed-down global economic activities in 2022.

The Group's gross profit for the year of 2022 was approximately HK\$180.8 million, representing an increase of approximately 26.4% compared to that of the previous year. Gross profit margin increased by approximately 5.6% to 24.3% from 18.7%. The increase of gross profit and gross profit margin were mainly due to reduction in production costs and the recovery of certain surging material costs from certain clients.

The Group's total operating expenses for the year of 2022 were approximately HK\$97.3 million, representing an increase of approximately 1.7% compared to approximately HK\$95.7 million for the previous year, primarily due to the increase in selling and distribution expenses.

The Group's EBITDA amounted to approximately HK\$138.0 million for the year of 2022 as compared to approximately HK\$92.7 million for the previous year.

The Group recorded a profit attributable to ordinary equity holders of the Company of approximately HK\$94.3 million for the year of 2022 as compared to approximately HK\$46.2 million for the previous year.

#### Other income and gains

Other income and gains increased by approximately HK\$9.9 million, or 51.8%, to approximately HK\$29.0 million for the year ended 31 December 2022 from approximately HK\$19.1 million for the year ended 31 December 2021, primarily due to the net effect of the decrease in income linked to recycling of approximately HK\$1.4 million, and net foreign exchange gain of approximately HK\$10.2 million.

本集團於二零二二年之營業額約743.6百萬港元，較去年減少約2.6%，主要由於二零二二年，全球的經濟活動普遍放緩，導致客戶的銷售訂單相應輕微減少。

本集團於二零二二年之毛利約180.8百萬港元，較去年增加約26.4%。毛利率由18.7%增加約5.6%至24.3%。毛利及毛利率上升主要由於生產成本下降及向若干客戶收回部分飆升的材料成本。

本集團於二零二二年的經營開支總額約為97.3百萬港元，較去年約95.7百萬港元增加約1.7%，主要由於銷售及分銷開支增加所致。

本集團於二零二二年的EBITDA約為138.0百萬港元，而去年則約為92.7百萬港元。

本集團於二零二二年錄得本公司普通權益持有人應佔溢利約94.3百萬港元，而去年則約為46.2百萬港元。

#### 其他收入及收益

其他收入及收益由截至二零二一年十二月三十一日止年度約19.1百萬港元增加約9.9百萬港元或51.8%，至截至二零二二年十二月三十一日止年度約29.0百萬港元，主要由於回收相關的收入減少約1.4百萬港元，及匯兌收益淨額約10.2百萬港元的淨影響。

### Selling and distribution expenses

Selling and distribution expenses increased by approximately HK\$1.2 million, or 6.6%, to approximately HK\$19.5 million for the year ended 31 December 2022 from approximately HK\$18.3 million for the year ended 31 December 2021. The increase was primarily due to increase in commission paid to employees resulting from the increase in sales orders from certain customers.

### General and administrative expenses

General and administrative expenses increased by approximately HK\$0.5 million, or 0.6%, to approximately HK\$77.8 million for the year ended 31 December 2022 from approximately HK\$77.3 million for the year ended 31 December 2021. The increase was primarily due to the increase in employee salaries of approximately HK\$0.8 million.

### Other expenses

Other expenses for the year ended 31 December 2022 were approximately HK\$1.1 million, which was slightly higher than the amount of approximately HK\$0.9 million recorded during the previous year.

### Finance costs

Finance costs for the year ended 31 December 2022 were approximately HK\$0.4 million, which was similar to the amount of approximately HK\$0.4 million recorded during the previous year.

### Profit attributable to ordinary equity holders of the Company

The Group recorded profit attributable to ordinary equity holders of the Company of approximately HK\$94.3 million for the year ended 31 December 2022 compared to approximately HK\$46.2 million for the year ended 31 December 2021, representing an increase of approximately 104.1%. The increase of profit attributable to ordinary equity holders of the Company was mainly due to the net effect of the increase in gross profit of approximately HK\$37.8 million, the increase in other income and gains of approximately HK\$9.9 million, the increase in selling and distribution expenses of approximately HK\$1.2 million, the increase in general and administrative expenses of approximately HK\$0.5 million, and the decrease in income tax expense of approximately HK\$2.3 million.

### 銷售及分銷開支

銷售及分銷開支由截至二零二一年十二月三十一日止年度約18.3百萬港元增加約1.2百萬港元或6.6%，至截至二零二二年十二月三十一日止年度約19.5百萬港元。有關增幅主要由於個別客戶的銷售訂單增加以致僱員佣金增加。

### 一般及行政開支

一般及行政開支由截至二零二一年十二月三十一日止年度約77.3百萬港元增加約0.5百萬港元或0.6%，至截至二零二二年十二月三十一日止年度約77.8百萬港元。此增幅主要由於僱員薪金增加約0.8百萬港元所致。

### 其他開支

截至二零二二年十二月三十一日止年度的其他開支約為1.1百萬港元，輕微高於去年約0.9百萬港元。

### 融資成本

截至二零二二年十二月三十一日止年度的融資成本約為0.4百萬港元，與去年約0.4百萬港元相若。

### 本公司普通權益持有人應佔溢利

截至二零二二年十二月三十一日止年度，本集團錄得本公司普通權益持有人應佔溢利約94.3百萬港元，較截至二零二一年十二月三十一日止年度約46.2百萬港元增加約104.1%。本公司普通權益持有人應佔溢利增加主要由於毛利增加約37.8百萬港元；其他收入及收益增加約9.9百萬港元；銷售及分銷開支增加約1.2百萬港元；一般及行政開支增加約0.5百萬港元；及所得稅開支減少約2.3百萬港元的淨影響。

### Property, plant and equipment

The net carrying amount as at 31 December 2022 was approximately HK\$293.3 million, representing a decrease of approximately HK\$53.8 million from that of 31 December 2021. This was mainly due to the net effect of (i) depreciation of approximately HK\$27.7 million with respect to the Group's property, plant and equipment in the current year, (ii) exchange realignment loss of approximately HK\$29.8 million due to the depreciation of RMB against HKD and (iii) total additions during the year of approximately HK\$4.1 million.

### Trade and bills receivables

There was a decrease in trade and bills receivables of approximately HK\$44.0 million as at 31 December 2022 as compared to that as at 31 December 2021, which was mainly due to the decrease in sales in the fourth quarter of 2022 as compared to the fourth quarter of 2021.

### Trade payables

There was a decrease in trade payables as at 31 December 2022 of approximately HK\$34.7 million as compared to that as at 31 December 2021, which was mainly due to the decrease in trade payables caused by the decrease in purchases in the fourth quarter of 2022.

### Bank and other borrowings

The Group had bank borrowings as at 31 December 2022 in the sum of approximately HK\$36.0 million, representing an increase of approximately HK\$4.0 million from the sum of approximately HK\$32.0 million as at 31 December 2021. The increase in borrowings was mainly due to the increased use of trade finance in the fourth quarter of 2022 as compared to the fourth quarter of 2021. No financial instruments were used for hedging purposes, nor were there any foreign currency net investments hedged by current borrowings and/or other hedging instruments.

### Liquidity and financial resources

As at 31 December 2022, the Group had current assets of approximately HK\$717.8 million (2021: HK\$679.9 million) including cash and cash equivalents and pledged deposits totalling approximately HK\$409.1 million (2021: HK\$304.4 million). As at 31 December 2022, the Group had non-current liabilities of approximately HK\$147.0 million (2021: HK\$159.2 million), and its current liabilities amounted to approximately HK\$228.0 million (2021: HK\$265.3 million), consisting mainly of payables arising in the normal course of operations and bank borrowings for financing of production facilities. Accordingly, the Group's current ratio, being the ratio of current assets to current liabilities, was around 3.1 as at 31 December 2022 (2021: 2.6).

### 物業、廠房及設備

於二零二二年十二月三十一日，賬面淨值約為293.3百萬港元，較二零二一年十二月三十一日減少約53.8百萬港元，主要由於(i)本集團物業、廠房及設備的本年度折舊約27.7百萬港元，(ii)由於人民幣兌港元貶值，匯兌調整虧損約29.8百萬港元及(iii)年內添置總計約4.1百萬港元。

### 貿易應收款項及應收票據

於二零二二年十二月三十一日之貿易應收款項及應收票據較二零二一年十二月三十一日減少約44.0百萬港元，主要由於二零二二年第四季度相較二零二一年第四季度銷售額有所減少。

### 貿易應付款項

於二零二二年十二月三十一日之貿易應付款項較二零二一年十二月三十一日減少約34.7百萬港元，主要由於二零二二年第四季度的採購下降，從而導致貿易應付款項減少。

### 銀行及其他借款

於二零二二年十二月三十一日，本集團的銀行借款合計約為36.0百萬港元，較二零二一年十二月三十一日合共約32.0百萬港元增加約4.0百萬港元。借款增加主要由於二零二二年第四季度使用貿易融資相較二零二一年第四季度有所上升所致。並未動用財務工具作對沖用途，亦無通過現有借款及／或其他對沖工具對沖任何外幣淨投資。

### 流動資金及財務資源

於二零二二年十二月三十一日，本集團流動資產約為717.8百萬港元(二零二一年：679.9百萬港元)，包括現金及現金等價物及已抵押存款總計約409.1百萬港元(二零二一年：304.4百萬港元)。於二零二二年十二月三十一日，本集團非流動負債約為147.0百萬港元(二零二一年：159.2百萬港元)，而其流動負債約為228.0百萬港元(二零二一年：265.3百萬港元)，主要包括一般業務過程中產生的應付款項及就生產設施融資之銀行借款。因此，於二零二二年十二月三十一日，本集團的流動比率(流動資產除以流動負債)約為3.1(二零二一年：2.6)。

### Gearing ratio

The gearing ratio of the Group, calculated as total borrowings over total equity, was approximately 0.05 as at 31 December 2022 (2021: approximately 0.05).

### Treasury policies

The Group has adopted a prudent financial management approach towards its treasury policies and thus maintained a healthy liquidity position throughout the year of 2022. The Group strives to reduce exposure to credit risk by performing ongoing credit assessments and evaluations of the financial status of its customers. To manage liquidity risks, the Board closely monitors the Group's liquidity position to ensure that the liquidity structure of the Group's assets, liabilities and other commitments can meet its funding requirements from time to time.

### Foreign exchange exposure

As at 31 December 2022, we had cash and cash equivalents, pledged deposits, trade and bills receivables, trade payables, other payables and interest-bearing bank borrowings which are denominated in currencies other than Hong Kong dollar, and consequently we have foreign exchange exposure from translation of amounts denominated in foreign currencies as at the reporting date. During the year ended 31 December 2022, the Group did not engage in any derivatives activities and did not commit to any financial instruments to hedge its foreign currency exposure.

### Capital structure

There has been no change in the capital structure of the Company during the current and previous years. The capital of the Company is comprised of ordinary shares and capital reserves.

### Capital commitments

As at 31 December 2022, capital commitments of the Group amounted to approximately HK\$0.8 million (2021: HK\$1.6 million).

### Dividend

The Board recommended the payment of a final dividend of HK12.0 cents per share for the year ended 31 December 2022 (2021: HK6.0 cents per share).

The proposed dividend is subject to approval by the shareholders of the Company at the annual general meeting to be held on Friday, 2 June 2023 and, if approved, is expected to be paid on or about Thursday, 6 July 2023 to shareholders whose names appear on the register of members of the Company on Wednesday, 14 June 2023. The dividend is declared and will be paid in HKD.

### 資產負債比率

於二零二二年十二月三十一日，本集團之資產負債比率(按總借款除以總權益計算)約為0.05(二零二一年：約0.05)。

### 庫務政策

本集團已就庫務政策採取審慎的財務管理方針，因此於二零二二年內維持穩健流動資金狀況。本集團透過持續進行信貸評估及評估其客戶財務狀況，致力減低信貸風險。為管理流動資金風險，董事會密切監察本集團流動資金狀況，確保本集團資產、負債及其他承擔之流動資金結構能應付不時之資金需要。

### 外匯風險

於二零二二年十二月三十一日，我們有並非以港元計值的現金及現金等價物、已抵押存款、貿易應收款項及應收票據、貿易應付款項、其他應付款項及計息銀行借款，因此我們於報告日期面對換算外幣計值金額之外匯風險。於截至二零二二年十二月三十一日止年度，本集團並無從事任何衍生工具活動，亦無作出任何財務工具承擔，以對沖所面對之外匯風險。

### 資本架構

於本年度及去年，本公司資本架構概無變動。本公司資本包括普通股及資本儲備。

### 資本承擔

於二零二二年十二月三十一日，本集團的資本承擔約為0.8百萬港元(二零二一年：1.6百萬港元)。

### 股息

董事會建議就截至二零二二年十二月三十一日止年度派付末期股息每股12.0港仙(二零二一年：每股6.0港仙)。

建議股息須經本公司股東於二零二三年六月二日(星期五)舉行的股東週年大會上批准後方可作實，倘批准，預期將於二零二三年七月六日(星期四)或前後向於二零二三年六月十四日(星期三)名列本公司股東名冊的股東派付股息。股息以港元宣派並將以港元派付。

### Dividend Policy

The Board regularly reviews and manages its capital structure to ensure an optimal capital structure and shareholders' return when its dividend policy considers:

- the Group's actual and expected financial performance;
- retained profits and distributable reserves of the Group;
- return on equity and other corresponding restrictions of the Group;
- the Group's capital requirement and surplus;
- the Group's liquidity position;
- general economic conditions, business cycle of the Group's business and internal or external factors that may have an impact on the business, financial results and position of the Company; and
- other factors that the Board deems relevant.

The Board will continue to review the Group's dividend policy from time to time and there can be no assurance that dividends will be paid in any particular amount for any given period.

The payment of dividend is also subject to any restrictions under the applicable laws and the Company's Articles of Association.

### Closure of the Register of Members

To determine the eligibility of the shareholders of the Company to attend the annual general meeting of the Company ("AGM") to be held on Friday, 2 June 2023, the register of members will be closed from Tuesday, 30 May 2023 to Friday, 2 June 2023, both days inclusive, during which period no transfer of shares will be effected. In order to be entitled to attend and vote at the AGM, all transfer forms accompanied by the relevant share certificates must be lodged with the Company's Hong Kong branch share registrar, Tricor Investor Services Limited, 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong for registration not later than 4:30 p.m. on Monday, 29 May 2023.

In addition, to determine shareholders' entitlement to the dividend, the register of members will be closed from Monday, 12 June 2023 to Wednesday, 14 June 2023, both days inclusive, during which period no transfer of shares will be effected. ### Information on employees

As at 31 December 2022, the Group had 696 employees (2021: 766 employees), including the executive Directors. Total employee benefit expense (including Directors' remuneration) was approximately HK\$104.2 million, as compared to approximately HK\$88.0 million for the year ended 31 December 2021. Remuneration is determined with reference to market norms and individual employee's performance, qualification and experience.

On top of basic salaries, bonuses may be paid with reference to the Group's performance as well as the individual's performance. Other staff benefits include contributions to the Mandatory Provident Fund scheme in Hong Kong and various welfare plans including the provision of pension funds, medical insurance and other relevant insurance for employees who are employed by our Group pursuant to the PRC rules and regulations and the existing policy requirements of the local PRC government as well as share options.

The salaries and benefits of the Group's employees are kept at a competitive level and employees are rewarded on a performance-related basis within the general framework of the Group's salary and bonus system, which is reviewed annually. The Group also operates a share option scheme adopted by the Company on 18 November 2014 ("Share Option Scheme") where options to subscribe for shares may be granted to the Directors and employees of the Group.

Details of the Share Option Scheme are disclosed in the section headed "Share Option Scheme" on pages 52 to 54 of this annual report.

The Company did not grant any share option under the Share Option Scheme during the current and prior years. Details of remuneration of Directors and chief executive and the five highest paid individuals of the Group for the year ended 31 December 2022 are set out in note 8 and note 9 to the consolidated financial statements.

### Significant investments held

As at 31 December 2022, the Group did not hold any significant investment.

### Future plans for material investments and capital assets

Other than those disclosed in this annual report, on 8 May 2020, the Group entered into, amongst others, a cooperation agreement for the urban renewal project located at our production base in Pingshan District, Shenzhen, the PRC. The entering into of the cooperation agreement and the transactions thereunder have been approved by the shareholders of the Company at the extraordinary general meeting on 14 July 2020. As disclosed in the Company's announcements dated 24 June 2022, 14 October 2022 and 1 December 2022, as a result of the progress of the Urban Renewal Project being slightly affected by the COVID-19 pandemic, payment schedule of certain payment installments under the Urban Renewal Project has been postponed at the request of the counterparty. However, such payment installments have become due from and payable by the counterparty, and remain outstanding as at the date of this annual report. No further agreement has been made between the parties to further postpone the payment schedule nor the milestones of the Urban Renewal Project as at the date of this annual report. The Company is in the course of further following up with the counterparty on, among other things, the status of the outstanding payment installments. For details, please refer to the Company's announcements dated 15 May 2020, 14 July 2020, 24 June 2022, 14 October 2022 and 1 December 2022, and the circular dated 24 June 2020.

Also, the Group is currently exploring the opportunity and proactively discussing with independent third parties in relation to the investment of the establishment of a Greater Bay Area production base for the production of PCBs. The Company will make further disclosure as and when appropriate pursuant to the relevant requirements of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited ("Listing Rules").

### Material acquisitions and disposals of subsidiaries, associates and joint ventures

On 8 May 2020, the Group entered into a cooperation agreement with independent third parties on a disposal of certain parcels of land located in Pingshan New District, Shenzhen, with certain parcels of the land being used by the Group for the production of PCB, through disposal of subsidiaries of the Group and/or disposal of the relevant land and properties in relation to the Urban Renewal Project. As at the date of this annual report, as Urban Renewal Approval (立項完成) has not yet been obtained, the disposals have not been materialised. For further details, please refer to Company's announcements dated 15 May 2020, 14 July 2020, 24 June 2022, 14 October 2022 and 1 December 2022, and the circular dated 24 June 2020.

Save as disclosed in this annual report, the Group did not have any material acquisitions and disposals of subsidiaries, associates and joint ventures during the year ended 31 December 2022.

### Contingent liabilities

The Group had no material contingent liabilities as at 31 December 2022 (2021: Nil).

### Prospects

Looking forward to 2023, underperforming economy, economic recession, inflation, Ukrainian War and the European energy crisis may continue. Sluggish demand and high inventory will continue to affect the world at least during the first half the year. Optimistically speaking, as the PRC quickly opens up, a considerable amount of inventory has been consumed. Economic and consumption demand may recover in the second half of the year when inflation is slowing down. Economic prospect, whether optimistic or pessimistic, will directly affect the development of the PCB industry.

In the past three years, the pandemic and international political instability led to change in the deployment of global supply chain. Customers demand risk diversification and enhancement in PCB productions in regions other than China, thus hindering the business environment of Chinese production enterprises.

In short, the future challenges will be more severe. Although we have a diversified market and industry sector, a broad high-quality customer base, and strong defensiveness, the general unfavorable environment has a negative impact on the Company. The Company is closely monitoring external developments and its own internal customer orders to make appropriate adjustments accordingly.

### Events after reporting period

There were no other significant events from the end of the reporting period up to the date of this annual report.

展望二零二三年，整體經濟環境不佳，經濟衰退、貨幣通脹、烏克蘭戰爭、歐洲能源危機可能會持續，需求疲弱和高庫存將至少在上半年持續影響全球，從樂觀的情景來看，中國迅速開放，庫存消耗了不少，待通脹趨緩，下半年經濟與消費的需求有望恢復成長，而經濟前景榮衰將直接影響PCB產業的消長。

近三年因疫情衝擊、國際政治動盪引發全球供應鏈佈局的轉移，加上客戶要求分散地緣風險下，提高PCB產業到中國以外地區，這都會損害中國生產企業的營銷環境。

總括而言，未來挑戰，更見嚴峻，雖然我們擁有多元化的市場及行業板塊，寬闊的優質客戶群，防守性較強，但大圍不利的環境下，造成對本公司負面的影響，本公司正密切留意外圍事態發展，及本身內在客戶訂單情況，並相應作出適當的調整。

### Corporate Strategy

To realize the goal of creating long-term value for the Shareholders and other stakeholders, the Group focuses on producing high-quality circuit boards and enhancing the production and management procedures by world-recognized quality and management systems such as ISO 9001, ISO 14001 and IAF, IATF 16949 to ensure each piece of high-quality circuit board produced satisfies the needs of the downstream industry. By stressing on diversity in our market position, we can supply products for various downstream markets and regional segments. With good business acumen, we respond to market changes and strive for various opportunities. In view of the global aging population and the COVID-19 pandemic, the Company has successfully obtained ISO 13485 quality system certification for circuit boards used in medical equipment in 2022, laying the foundation to step into the medical equipment market. The Company establishes solid long-term relationships with suppliers and customers and has cooperated with some of them for over a decade. Under the basis of mutual trust, the flow of supply has been more smooth and stable.

Meanwhile, the Group continues to focus on environment, society and governance and abide by the laws and regulations to contribute to a green, healthy, inclusive and diversified lifestyle of our next generation.

### CORPORATE GOVERNANCE PRACTICES

Adapting and adhering to recognised standards of corporate governance principles and practices has always been one of the top priorities of the Company. The Board believes that good corporate governance is one of the areas that leads to the success of the Company and in balancing the interests of shareholders, customers and employees, and the Board is devoted to ongoing enhancements of the efficiency and effectiveness of such principles and practices.

Pursuant to code provision C.2.1 of the Corporate Governance Code set out in Appendix 14 to the Listing Rules, the responsibilities between the chairman and the chief executive officer should be segregated and should not be performed by the same individual. However, we do not have a separate chairman and chief executive officer and Mr. Chan Wing Yin currently performs these two roles. The Board believes that vesting the roles of both chairman and chief executive officer in the same person has the benefit of ensuring consistent leadership within the Group and enables more effective and efficient overall strategic planning for the Group. The Board considers that the balance of power and authority for the present arrangement will not be impaired and this structure will enable the Company to make and implement decisions promptly and effectively. The Board will continue to review and consider splitting the roles of chairman of the Board and chief executive officer of the Company at a time when it is appropriate and suitable by taking into account the circumstances of the Group as a whole.

The Company will continue to review its corporate governance practices in order to enhance its corporate governance standard, to comply with the increasingly tightened regulatory requirements and to meet the rising expectations of the shareholders and investors.

### CODE OF CONDUCT FOR SECURITIES TRANSACTIONS BY DIRECTORS

The Company has adopted a code of conduct regarding securities transactions by Directors on terms no less exacting than the required standard of dealings of the Model Code for Securities Transaction by Directors of Listed Issuers (the "Model Code") as set out in Appendix 10 of the Listing Rules. Having made specific enquiries to all the Directors, the Company was not aware of any non-compliance with the required standard of dealings set out in the Model Code and its code of conduct regarding securities transactions by Directors during the year ended 31 December 2022.

### BOARD MEETINGS

The Board is scheduled to meet regularly at least four times a year at approximately quarterly intervals, to discuss the overall strategy as well as the operational and financial performance of the Company. Other Board meetings will be held when necessary. Such Board meetings involve the active participation, either in person or through other electronic means of communication, of a majority of Directors. For the year ended 31 December 2022, four Board meetings were held.

Appropriate notices are given to all Directors in advance for attending regular and other Board meetings. Meeting agendas and other relevant information are provided to the Directors in advance of Board meetings. All Directors are consulted to include additional matters in the agenda for Board meetings.

Directors have access to the advice and services of the company secretary with a view to ensuring that Board procedures, and all applicable rules and regulations, are followed.

Both draft and final versions of the minutes are sent to all Directors for their comment and records. Minutes of Board meetings are kept by the company secretary and such minutes are open for inspection at any reasonable time on reasonable prior notice by any Director.

### GENERAL MEETINGS

For the year ended 31 December 2022, one general meeting was held.

### RESPONSIBILITIES OF THE BOARD AND MANAGEMENT

The Board is primarily responsible for overseeing and managing the Company's affairs, including the responsibilities for the adoption of long-term strategies and appointing and supervising senior management to ensure that the operation of the Group is conducted in accordance with the objective of the Group. The Board is also responsible for determining the Company's corporate governance policies which include: (i) to develop and review the Company's policies and practices on corporate governance; (ii) to review and monitor the training and continuous professional development of Directors and senior management; (iii) to review and monitor the Company's policies and practices on compliance with legal and regulatory requirements; (iv) to review and monitor the code of conduct and compliance manual (if any) applicable to employees and Directors; and (v) to review the Company's disclosure in the Corporate Governance Report.

With the new composition of members of the nomination committee, the remuneration committee and the audit committee, the independent non-executive Directors will be able to effectively devote their time to perform the duties required by the respective Board committees.

The Board has also delegated the responsibility of implementing its strategies and the day-to-day operation to the management of the Company under the leadership of the executive Directors. Clear guidance has been made as to the matters that should be reserved to the Board for its decision which include matters on, inter alia, capital, finance and financial reporting, risk management and internal controls, communication with shareholders, Board membership, delegation of authority and corporate governance.

The Board acknowledges its responsibility for the preparation of the financial statements which give a true and fair view of the state of affairs of the Group. The financial statements set out on pages 68 to 156 were prepared on the basis set out in note 2.1 to the consolidated financial statements. Financial results of the Group are announced in a timely manner in accordance with statutory and/or regulatory requirements. The declaration of reporting responsibility issued by the external auditors of the Company on the Company's financial statements is set out in the Independent Auditor's Report on pages 62 to 67.

There is no non-compliance with rules 3.10(1), (2) and 3.10A of the Listing Rules.

### CONFIRMATION OF INDEPENDENCE

Each of the independent non-executive Directors has made an annual confirmation of independence pursuant to Rule 3.13 of the Listing Rules. The Company is of the view that all independent non-executive Directors meet the independence guidelines set out in Rule 3.13 of the Listing Rules and are independent in accordance with the terms of the guidelines.

### 持續專業發展

於截至二零二二年十二月三十一日止年度，全體董事均已獲提供相關指引資料，並參加培訓，內容涵蓋作為董事之職責及責任、適用於董事之相關法例及規例及本集團權益披露責任及業務。新任董事獲委任為董事後，亦會於短期內獲發該等就職資料及簡報。如有需要，本公司將為董事安排持續簡報及專業發展。

全體董事均已提供培訓出席記錄，而本公司將繼續根據守則條文安排及／或資助培訓。

年內，所有董事均追求持續專業發展，相關詳情載列如下：

### CHAIRMAN AND CHIEF EXECUTIVE OFFICER

Pursuant to code provision C.2.1 of the Corporate Governance Code set out in Appendix 14 to the Listing Rules, the responsibilities between the chairman and the chief executive officer should be segregated and should not be performed by the same individual. However, we do not have a separate chairman and chief executive officer and Mr. Chan Wing Yin currently performs these two roles. The Board believes that vesting the roles of both chairman and chief executive officer in the same person has the benefit of ensuring consistent leadership within our Group and enables more effective and efficient overall strategic planning for our Group. The Board considers this structure will enable our Company to make and implement decisions promptly and effectively. The Board believes that the balance of power and authority is adequately ensured by the operation of the Board, which comprises experienced and high calibre individuals with a sufficient number thereof being independent non-executive Directors.

### 主席及行政總裁

根據上市規則附錄十四所載企業管治守則的守則條文第C.2.1條，主席與行政總裁的職責應有區分，並不應由一人兼任。然而，我們並無區分主席與行政總裁，現時由陳榮賢先生兼任該兩個角色。董事會相信，由同一人兼任主席及行政總裁的角色，可確保本集團內部領導貫徹一致，使本集團的整體策略規劃更有效及更具效率。董事會認為，此架構可讓本公司迅速及有效地作出及落實決策。董事會認為，董事會成員經驗豐富、才幹出眾，且足夠成員為獨立非執行董事，其運作可確保權力和授權平衡獲充分保障。

### APPOINTMENT, RE-ELECTION AND REMOVAL

Each of the executive Directors has entered into a service contract with the Company, non-executive Director and each of the independent non-executive Directors has signed a letter of appointment with the Company. Such term is for an initial term of three years commencing from the Listing Date (except for Mr. Lau Shun Chuen and Mr. Chan Yan Kwong, whose term is for three years commencing from his date of appointment) and shall continue subject to termination by either party in accordance with the terms thereof and the retirement and re-election provisions in accordance with the articles of association of the Company.

In accordance with the articles of association of the Company, at each annual general meeting (“AGM”) one third of the Directors for the time being shall retire from office by rotation. However, if the number of Directors is not a multiple of three, then the number nearest to but not less than one third shall be the number of retiring Directors. The Directors who shall retire in each year will be those who have been longest in the office since their last re-election or appointment but as between persons who become or were last re-elected Directors on the same day those to retire will (unless they otherwise agree among themselves) be determined by the Company. Such retiring Directors may, being eligible, offer themselves for re-election at the AGM. All Directors appointed by the Board to fill a casual vacancy shall hold office until the first general meeting of shareholders after their appointment and be subject to re-election at such meeting and all Directors appointed by the Board as an addition to the existing Board shall hold office only until the next following AGM and shall then be eligible for re-election.

### NOMINATION COMMITTEE

The Company established a nomination committee pursuant to a resolution of the Directors on 18 November 2014 with written terms of reference in compliance with the Code Provisions. Its terms of reference are available on the websites of the Company and the Stock Exchange.

The primary duties of the nomination committee are to review the structure, size and composition of the Board on regular basis; identify individuals suitably qualified to become Board members; assess the independence of independent non-executive Directors; and make recommendations to the Board on relevant matters relating to the appointment or re-appointment of Directors. The nomination committee comprises three independent non-executive Directors, namely Mr. Lau Shun Chuen (Chairman), Mr. Chung Yuk Ming and Mr. Yau Wing Yiu, one executive Director, namely Mr. Chan Yan Wing, and one non-executive Director, namely Mr. Chan Yan Kwong.

### 委任、重選及罷免

各執行董事已與本公司訂立服務合約，而非執行董事及各獨立非執行董事已與本公司簽訂委任函。有關任期初步由上市日期起為期三年（劉順銓先生及陳恩光先生除外，其任期由其委任日期起為期三年），並將繼續由任何一方根據委任函之條款予以終止，並須遵守本公司組織章程細則之退任及重選連任條文。

根據本公司之組織章程細則，於每屆股東週年大會（「股東週年大會」），三分之一之時任董事須輪席退任。然而，倘董事人數並非三之倍數，則最接近但不少於三分之一之董事人數將須退任。各年度退任之董事將為自上次重選或獲委任以來在任最久之董事，惟於同一日獲委任或重選為董事之人士而言，將由本公司決定應予告退之人士（除非彼等互相協定）。有關退任董事可能合資格於股東週年大會膺選連任。董事會委任以填補臨時空缺之所有董事將留任至彼等獲委任後首次股東大會，並將於有關大會膺選連任；董事會委任作為現有董事會新增成員之所有董事將僅留任至下屆股東週年大會，並屆時將合資格膺選連任。

### 提名委員會

本公司於二零一四年十一月十八日根據董事決議案成立提名委員會，其書面職權範圍符合守則條文。其職權範圍可於本公司及聯交所網站查閱。

提名委員會的主要職責為定期檢討董事會架構、人數及組成；物色具備合適資格可擔任董事會成員的人士；評核獨立非執行董事的獨立性；及就委任或續任董事的相關事宜向董事會提出建議。提名委員會由三名獨立非執行董事（即劉順銓先生（主席）、鍾玉明先生及邱榮耀先生）、一名執行董事（即陳恩永先生）及一名非執行董事（即陳恩光先生）組成。

For the year under review, the Nomination Committee held one meeting, in which it reviewed the structure of the Board and recommended to the Board for reappointment of all directors at the forthcoming annual general meeting. The Nomination Committee also determined the criteria of the board diversity policy (the "Board Diversity Policy").

When identifying suitable candidates for directorship, the nomination committee will carry out the selection process by making reference to the skills, experience, education background, professional knowledge, personal integrity and time commitments of the proposed candidates, and also the Company's needs and other relevant statutory requirements and regulations required for the positions. All candidates must be able to meet the standards as set forth in Rules 3.08 and 3.09 of the Listing Rules. A candidate who is to be appointed as an independent non-executive Director should also meet the independence criteria set out in Rule 3.13 of the Listing Rules. Qualified candidates will then be recommended to the Board for approval.

To enhance the quality of the performance of the Board and to achieve diversity on the Board, the Board adopted on 18 November 2014 the Board Diversity Policy, pursuant to which (i) differences in the skills, regional and industry experience, background, race, gender and other qualities of Directors will be taken into account in determining the optimum composition of the Board; and (ii) all Board appointments will be based on merit while taking into account diversity (including gender diversity). For the purpose of implementation of the Board Diversity Policy, the following measurable objectives were adopted:

- (A) at least one-third of the members of the Board shall be independent non-executive directors;
- (B) at least one of the members of the Board shall have obtained accounting or other professional qualifications;
- (C) at least 70% of the members of the Board shall have more than seven years of experience in the industry he/she is specialised in; and
- (D) at least two of the members of the Board shall have China-related work experience.

The Board currently has one female Director out of seven Directors, and is committed to improving gender diversity as and when suitable candidates are identified. The Company is of the view that gender diversity in respect of the Board has been achieved. Of the 696 employees (including senior management) of the Group as at 31 December 2022, 278 are female. Accordingly, the Company considers that gender diversity is also achieved in its workforce generally.

For the year ended 31 December 2022, the Board has fulfilled the measurable objectives of the Board Diversity Policy.

於回顧年度，提名委員會曾舉行一次會議，其於會上檢討董事會架構並就於應屆股東週年大會重新委任全體董事向董事會提出建議。提名委員會亦已釐訂其董事會成員多元化政策（「董事會成員多元化政策」）的準則。

於物色合適董事候選人時，提名委員會將參考建議候選人的技能、經驗、教育背景、專業知識、個人誠信及時間投入，以及本公司需求及其他相關法規要求以及有關職位的規定而進行篩選程序。所有候選人須符合上市規則第3.08及3.09條所載標準。將獲委任為獨立非執行董事的候選人亦須符合上市規則第3.13條所載獨立性標準。合資格候選人屆時將獲推薦以供董事會批准。

為提高董事會表現質素及實現董事會成員多元化，董事會於二零一四年十一月十八日採納董事會成員多元化政策，據此，(i)在確定董事會成員的最佳組合時將考慮董事於技能、地區及行業經驗、背景、種族、性別及其他素質等方面之差異；及(ii)所有董事會成員之任命將以用人唯才為原則，並考慮多元化（包括性別多元化）。就實施董事會成員多元化政策而言，乃採納以下可計量目標：

- (A) 至少三分之一董事會成員須為獨立非執行董事；
- (B) 至少一名董事會成員須獲得會計或其他專業資格；
- (C) 至少70%董事會成員須於其專攻行業內擁有七年以上經驗；及
- (D) 至少兩名董事會成員須擁有中國相關工作經驗。

董事會七名董事之中，目前有一名女性董事，而董事會致力於物色到合適人選時加強性別多元化。本公司認為，董事會已達到性別多元化。於本集團截至二零二二年十二月三十一日的696名僱員（包括高級管理層）之中，278人為女性。因此，本公司認為其員工整體而言亦達到性別多元化。

截至二零二二年十二月三十一日止年度，董事會已實現董事會成員多元化政策中的可計量目標。

### REMUNERATION COMMITTEE

The Company established a remuneration committee pursuant to a resolution of the Directors passed on 18 November 2014 with written terms of reference in compliance with Rule 3.25 and Rule 3.26 of the Listing Rules. The written terms of reference of the remuneration committee was adopted in compliance with the Code Provisions. Its terms of reference are available on the websites of the Company and the Stock Exchange.

The primary duties of the remuneration committee are to make recommendations to the Board on the overall remuneration policy and structure relating to all Directors and senior management of the Group and ensure none of the Directors determine their own remuneration. The emoluments of executive Directors are determined based on the skills, knowledge, individual performance as well as contributions, the scope of responsibility and accountability of such Directors, taking into consideration of the Company's performance and prevailing market conditions. The remuneration policy of independent non-executive Directors is to ensure that the independent non-executive Directors are adequately compensated for their efforts and time dedicated to the Company's affairs including their participation in respective Board committees. The emoluments of independent non-executive Directors are determined with reference to their skills, experience, knowledge, duties and market trends. As at the date of this annual report, the remuneration committee consists of three independent non-executive Directors, namely Mr. Chung Yuk Ming (Chairman), Mr. Lau Shun Chuen and Mr. Yau Wing Yiu, one executive Director, namely Mr. Chan Yan Wing and one non-executive Director, namely Mr. Chan Yan Kwong.

Details of remuneration of Directors and chief executive are set out in note 8 to the consolidated financial statements.

The Company established an audit committee pursuant to a resolution of the Director passed on 18 November 2014 with written terms of reference in compliance with Rule 3.21 and Rule 3.22 of the Listing Rules. The written terms of reference of the audit committee was adopted in compliance with the Code Provisions. Its terms of reference are available on the websites of the Company and the Stock Exchange.

The primary duties of the audit committee, among other things, are to make recommendations to the Board on the appointment, re-appointment and removal of external auditor, review the financial statements and material advice in respect of financial reporting and oversees risk management and internal control procedures of the Company. As at the date of this annual report, the audit committee consists of three independent non-executive Directors, namely Mr. Yau Wing Yiu (Chairman), Mr. Lau Shun Chuen and Mr. Chung Yuk Ming.

During the year and up to the date of this annual report, the Audit Committee members met twice with the external auditors and the Group's senior management to discuss and review, among other things, the following matters:

- (a) the annual results for the year ended 31 December 2022 and the interim results for the six months ended 30 June 2022 to ensure the full, complete and accurate disclosure in the aforesaid financial statements pursuant to the accounting standards and other legal requirements for presenting the same to the Board for approval;
- (b) the term and remuneration for the appointment of Ernst & Young as external auditors to perform the audit of final results for the year ended 31 December 2022 and the review on the interim results for the six months ended 30 June 2022;
- (c) the independence of the external auditors especially for those non-audit services;
- (d) the continuing connected transactions of the Group;
- (e) the overall effectiveness of risk management and internal controls;
- (f) the overall effectiveness of its internal audit function; and
- (g) the adequacy of resources, qualifications and experience of staff and the accounting and financial reporting matters and their training programmes and budget.

The Audit Committee is satisfied with, inter alia, the audit fees, effectiveness of the audit process, independence and objectivity of the external auditors and has recommended to the Board the re-appointment of Ernst & Young as the Company's external auditors for the ensuing year at the forthcoming annual general meeting of the Company.

During the period from the Listing Date to the date of this annual report, the Board has not taken a different view from the audit committee on the selection, appointment, resignation or dismissal of external auditors.

### AUDITOR'S REMUNERATION

During the year, the Company engaged Ernst & Young as the external auditors. Apart from providing audit services, Ernst & Young also provided non-audit services including: i) taxation services; ii) review of interim financial information; iii) certain procedures on the annual result announcement; and iv) certain procedures on very substantial transactions. The fees in respect of audit and non-audit services provided by Ernst & Young for the year ended 31 December 2022 approximately amounted to HK\$1,600,000 and HK\$505,500, respectively.

The reporting responsibilities of Ernst & Young are set out in the Independent Auditor's Report on pages 62 to 67.

### COMPANY SECRETARY

Mr. Lai Hau Yin being our company secretary is primarily responsible for the company secretarial work of our Group. Mr. Lai is also our Company's chief financial officer. The Company confirms that Mr. Lai has for the year 2022 attended no less than 15 hours of relevant professional training.

### RISK MANAGEMENT AND INTERNAL CONTROL

During the year, the Group has complied with Principle D.2 of the Corporate Governance Code by establishing appropriate and effective risk management and internal control systems. Management is responsible for the design, implementation and monitoring of such systems, while the Board oversees management in performing its duties on an ongoing basis. Main features of the risk management and internal control systems are described in the sections below:

#### Risk Management System

The Group adopts a risk management system which manages the risk associated with its business and operations. The system comprises the following phases:

- Identification: Identify ownership of risks, business objectives and risks that could affect the achievement of objectives.
- Evaluation: Analyze the likelihood and impact of risks and evaluate the risk portfolio accordingly.

安永會計師事務所之申報責任載於第62至67頁之獨立核數師報告。

### 公司秘書

公司秘書黎孝賢先生主要負責本集團之公司秘書工作。黎先生亦為本公司之首席財務總監。本公司確認黎先生於二零二二年已出席不少於十五小時的相關專業培訓。

### 風險管理及內部監控

年內,本集團已遵守企業管治守則原則D.2,設立適當及有效的風險管理及內部監控制度。管理層負責該等制度的設計、實施及監察,而董事會則監督管理層持續履行其職責。風險管理及內部監控制度的主要特點於下文各節闡述:

#### 風險管理制度

本集團採納風險管理制度以管理與其業務及營運有關的風險。該制度包括以下階段:

- 識別: 識別擁有權風險、業務目標及可影響能否達成目標的風險。
- 評估: 分析風險的可能性及影響及據此評估風險組合。

- Management: Consider the risk responses, ensure effective communication to the Board and on-going monitor the residual risks.

The management assesses the potential risks faced by the Group from time to time, which is also evaluated annually by a professional institute engaged by the Group. This year's evaluation covered the period from 1 January 2022 to 31 December 2022.

Based on the risk assessments conducted in 2022, no significant risk was identified.

### Internal Control System

The Company has in place an internal control system which is compatible with the Committee of Sponsoring Organizations of the Treadway Commission ("COSO") 2013 framework. The framework enables the Group to achieve objectives regarding effectiveness and efficiency of operations, reliability of financial reporting and compliance with applicable laws and regulations. The components of the framework are shown as follows:

- Control Environment: A set of standards, processes and structures that provide the basis for carrying out internal control across the Group.
- Risk Assessment: A dynamic and iterative process for identifying and analyzing risks to achieve the Group's objectives, forming a basis for determining how risks should be managed.
- Control Activities: Action established by policies and procedures to help ensure that management directives to mitigate risks to the achievement of objectives are carried out.
- Information and Communication: Internal and external communication to provide the Group with the information needed to carry out day-to-day controls.
- Monitoring: Ongoing and separate evaluations to ascertain whether each components of internal control is present and functioning.

In order to enhance the Group's system of handling inside information, and to ensure the truthfulness, accuracy, completeness and timeliness of its public disclosures, the Group also adopts and implements an inside information policy and procedures. Certain reasonable measures have been taken from time to time to ensure that proper safeguards exist to prevent a breach of a disclosure requirement in relation to the Group, which include:

- The access of information is restricted to a limited number of employees on a need-to-know basis. Employees who are in possession of inside information are fully conversant with their obligations to preserve confidentiality.

管理層不時評估本集團面臨的潛在風險，本集團聘任的專業機構亦會每年就有關風險進行評估。本年度的評估涵蓋二零二二年一月一日至二零二二年十二月三十一日期間。

根據二零二二年進行的風險評估，概無識別到重大風險。

### 內部監控制度

本公司已設置內部監控制度，其切合全美反虛假財務報告委員會下屬的發起人委員會(Committee of Sponsoring Organizations of the Treadway Commission) (「COSO」)二零一三年框架。此框架令本集團達成關於經營效率與效能、財務匯報的可靠性及遵從適用的法律及法規等方面的目標。以下列舉框架的內容：

- 監控環境：整套的標準、過程及架構，為本集團內實行內部監控提供基礎。
- 風險評估：識別及分析風險以達成本集團目標，並為如何管理風險提供基礎的靈活縝密程序。
- 監控活動：以政策及程序設立的行動，協助確保減少風險以達成目標的管理指令獲得執行。
- 資訊及溝通：內部及外部溝通，為本集團提供執行日常監控所需的資訊。
- 監察：持續及獨立評估，釐定內部監控各個部分是否完備及正常運作。

為改善本集團處理內部資料的制度，以及確保其公開披露資料為真實、準確、完整及適時，本集團亦採納及實施內部資料政策及程序，並已不時採取若干合理措施，確保有妥善保障，防止違反有關本集團的披露規定，包括：

- 僅有限數目的僱員可按需要知道的基準查閱資料。擁有內幕資料的僱員完全明白本身須保密的責任。

- Confidentiality agreements are in place when the Group enters into significant negotiations.
- The Executive Directors are designated persons who speak on behalf of the Company when communicating with external parties such as the media, analysts or investors.
- 本集團進行重大磋商時，會訂立保密協議。
- 與傳媒、分析員或投資者外界溝通時，執行董事為指定代表本公司發言之人士。

The management assess the internal control system of the Group from time to time, which is also evaluated annually by a professional institution engaged by the Group. The professional institution has completed the evaluation for the period from 1 January 2022 to 31 December 2022. Based on the internal control reviews conducted in 2022, no significant control deficiency was identified.

### Internal Auditors

The Group has an Internal Audit (“IA”) function, which is consisted of professional staff with relevant expertise. The IA function is independent of the Group’s daily operation and carries out appraisal of the risk management and internal control systems by conducting interviews, walkthroughs and tests of operating effectiveness.

An IA plan has been approved by the Board. According to the established plan, review of the risk management and internal control systems is conducted annually and the results are reported to the Board via Audit Committee afterwards.

### Effectiveness of the Risk Management and Internal Control Systems

The Board is responsible for the risk management and internal control systems of the Group and ensuring review of the effectiveness of these systems has been conducted annually. Several areas have been considered during the Board’s review, which include but not limited to (i) the changes in the nature and extent of significant risks since the last annual review, and the Group’s ability to respond to changes in its business and the external environment; (ii) the scope and quality of management’s ongoing monitoring of risks and of the internal control systems.

The Board, through its review and the review made by IA function and Audit Committee, concluded that the risk management and internal control systems were effective and adequate. Such systems, however, are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss. It is also considered that the resources, staff qualifications and experience of relevant staff were adequate and the training programs and budget provided were sufficient.

董事會根據其檢視及內部審計部門及審計委員會之檢視達成結論，即風險管理及內部監控制度屬有效及充份。然而，該等制度之設計旨在管理而非消除失效風險以達成業務目標，故僅可對重大錯誤陳述或虧損提供合理而非絕對保證。董事會亦認為有關僱員之資源、員工資歷及經驗屬充足及所提供之培訓計劃及預算屬充分。

The Company has entered into the following continuing connected transactions (as defined under the Listing Rules) for the year ended 31 December 2022:

- (1) On 4 October 2021, Yan Tat Technology Limited ("YT Technology"), an indirect wholly-owned subsidiary of the Company entered into a lease agreement ("Yantek Lease") with Yantek Electronics Company Limited ("Yantek") a connected person of the Company within the meanings of the Listing Rules. Pursuant to the Yantek Lease, YT Technology shall lease from Yantek the premises situated at Flat E on 15th Floor and Flat Roof immediately above of Tower 5 and Car Parking Space No. 11 on Car Park B1, One Beacon Hill, No. 1 Beacon Hill Road, Kowloon, Hong Kong with a gross total floor area of approximately 1,473 square feet at a monthly rental of HK\$58,000 for a term of 2 years commencing from 1 November 2021 (total consideration: HK\$1,392,000). The lease term is from 1 November 2021 to 31 October 2023 as staff quarter for Mr. Chan Wing Yin and Mrs. Chan Yung.

(2) On 13 October 2020, YT Technology renewed a tenancy agreement (“Headquarters Lease”) with Yantek, a connected person of the Company within the meanings of the Listing Rules. Pursuant to the Headquarters Lease, YT Technology shall lease from Yantek the office premises and warehouse located at Room 09, 10 and 14 on 8th Floor, Kwong Sang Hong Centre, Nos. 151–153 Hoi Bun Road, Kwun Tong Kowloon, Hong Kong at a monthly rental of HK\$90,000 for a term of 2 years commencing on 25 November 2020 and ending on 24 November 2022 for the Group’s use (total consideration: HK\$2,160,000).

On 2 November 2022, the agreement has been renewed for two years at the same monthly rent. The lease period is starting from 25 November 2022 to 24 November 2024. Total consideration is HK\$2,160,000.

Yantek is beneficially owned as to 34% by Mr. Chan Yan Wing, 33% by Mr. Chan Yan Kwong and 33% by Ms. Chan Yan Sam. Mr. Chan Yan Wing and Mr. Chan Yan Kwong are the Directors of the Company. Ms. Chan Yan Sam is the sister of Mr. Chan Yan Kwong and Mr. Chan Yan Wing and the daughter of Mr. Chan Wing Yin and Mrs. Chan Yung.

The continuing connected transactions mentioned above are fully exempt from the reporting, annual review, announcement requirements and the independent shareholders’ approval requirements as set out in Chapter 14A of the Listing Rules. Pursuant to Rule 14A.55 of the Listing Rules, the independent non-executive Directors have reviewed the above continuing connected transactions and in their opinion, the transactions are: (1) in the ordinary and usual course of business of the Group; (2) on normal commercial terms or better; and (3) in accordance with the agreement governing them on terms that are fair and reasonable and in the interests of the shareholders of the Company as a whole.

Save as disclosed above, a summary of significant related party transactions, which do not constitute connected transactions, made during the year is disclosed in note 32 to the Consolidated Financial Statements. The Company confirmed that it has complied with the disclosure requirements in Chapter 14A of the Listing Rules.

### SHARE OPTION SCHEME

The Company's existing Share Option Scheme was approved for adoption pursuant to a written resolution of all of our Shareholders passed on 18 November 2014 for the purpose to provide our Company with a flexible means of giving incentive to, rewarding, remunerating, compensating and/or providing benefits to eligible participants and for such other purposes as the Board approve from time to time.

Subject to the terms of the Share Option Scheme, the Board may, at their absolute discretion, grant or invite any person belonging to any of the following classes to take up options to subscribe for shares: (a) any employee, supplier, service provider, customer, partner or joint-venture partner of the Group (including any director, whether executive and whether independent or not, of the Group) who is in full-time or part-time employment with the Company or any subsidiaries; (b) any person who have contributed or may contribute to the Group.

The maximum number of shares which may be issued upon exercise of all outstanding options granted under the Share Option Scheme and any other share option schemes of the Company must not exceed 30% of the total number of shares in issue from time to time.

The total number of shares which may be issued upon exercise of all options to be granted under the Share Option Scheme and any other share option schemes of the Company must not exceed 10% of the total number of shares in issue on 8 December 2014 unless the Company seeks the approval of the shareholders in general meeting for refreshing the 10% limit under the Share Option Scheme provided that options lapsed in accordance with the terms of the Share Option Scheme or any other share option schemes of the Company will not be counted for the purpose of calculating 10% limit.

Details of the principal terms of the Share Option Scheme are set out in paragraph headed "Share Option Scheme" in the section headed "Statutory and General Information" in Appendix V to the Prospectus. The principal terms of the Share Option Scheme are summarised as follows:

The Share Option Scheme was adopted for a period of 10 years commencing from 18 November 2014 and remains in force until 17 November 2024. The Company may, by resolution in general meeting or, such date as the Board determined, terminate the Share Option Scheme at any time without prejudice to the exercise of options granted prior to such termination.

### PRINCIPAL RISKS AND UNCERTAINTIES

The Group produces PCB in China and sells them around the world, and is faced with certain different types of risks and uncertainties. The principal items are listed as below.

- i. It has been more than three years since the COVID-19 outbreak. Various countries are moving along the path to normalcy, and the PRC has also reopened. However, it is uncertain whether there will be future pandemics which will hinder the recovery progress. The economy along with the operation and production of enterprises are being exposed to adverse conditions.
- ii. The Group derives a significant portion of its revenue from major customers, particularly automobile customers. The decrease in demand from major customers may materially and adversely affect the business.
- iii. Fluctuation in exchange rates may adversely affect the business.
- iv. The Group may be subject to any labour shortages, increased labour cost or other factors affecting labour force, or full implementation of social security and public housing policies, which may materially affect the Group's business operation and financial condition.
- v. The PRC government has tightened its environmental regulation. Although the Group's current operation falls in line with the requirement, it may be affected and incur additional expenses when the relevant regulatory threshold is raised further in the future.
- vi. U.S.' China Policy continues to impose higher tariffs on imported Chinese goods, and restricts Huawei from participating in 5G projects, which may slow down economic growth across the globe, and in return decelerate the development of the PCB market.

### 主要風險及不明朗因素

本集團於中國製造PCB，並銷售予全世界，其面臨若干不同類別的風險及不明朗因素。主要項目載列如下。

- i. 新型冠狀病毒肺炎爆發已三年多，各國開始步向復常的道路，中國亦重新開放，但不能明確疫情不會重來，衝擊復甦步伐，這對經濟以及企業經營及生產造成不利的環境。
- ii. 本集團大部分收益乃來自主要客戶，特別是汽車客戶。來自主要客戶的需求減少或會對業務造成重大不利影響。
- iii. 匯率波動或會對業務造成不利影響。
- iv. 本集團或受制於任何勞工短缺、勞工成本上漲或其他影響勞動力的因素，加上全面實施社會保障和公積金政策，這可能對本集團的業務營運及財務狀況造成重大影響。
- v. 中國政府收緊了對環保方面的監管。雖然本集團目前的營運狀況符合要求，但倘若政府日後進一步提高相關監管門檻，本集團的營運或會受到影響並產生額外費用。
- vi. 美國的對華政策，對從中國進口的貨物仍然徵收較高關稅，同時亦限制華為參與5G項目，這有可能拖慢全球經濟發展，繼而減慢PCB市場發展步伐。

- vii. Currently, various PCB manufacturers are vigorously expanding their production capacity. When the market fails to meet the development expectation, the excessive production capacity will result in irrational competition among industrial peers, pushing down the unit price and diminishing the company's profitability.
- viii. The Group's sole production facility is based in Shenzhen. If this facility experiences any issue that results in a lower production output, and no third-party assistance is identified, our sales will decline.
- ix. The Group entered into a cooperation agreement with an independent third party in relation to the urban renewal project located at the current production area in Pingshan District. Failure for the counterparty to make payment instalments in time in accordance with the terms of the cooperation agreement may result in the cooperation being terminated. For further details, please refer to "Management Discussion and Analysis — Financial Review — Future plans for material investments and capital assets" above.
- x. The Group's major production operation activities take place in Mainland China. Any change to the policies in Mainland China (including taxation, foreign exchange control, and imports and exports) is likely to affect the Group's overall performance.
- xi. In 2021, there were power supply problems in various parts of China, and then the government relaxed the price restrictions on electricity tariffs, which may increase the future electricity cost of domestic manufacturers.
- xii. The persistence of war between Russia and Ukraine results in frequent geopolitical conflicts and oppositions between countries and thus has an impact on normal transactions and increased development risks of each industry.
- xiii. Overseas customers would like to realize the "China Plus One" concept in their supply chain to reduce their reliance in Chinese suppliers. They would like to look for alternative suppliers outside China, thus reducing procurements of Chinese factories in the future.
- vii. 目前，眾多PCB製造商正在大幅擴充產能，當市場未符合預期發展，而出現產能過剩，引致同行不理性競爭，推低單位價格，公司的利潤因而減少。
- viii. 本集團的生產基地位於深圳，亦是唯一的生產設施。若該設施有任何問題導致產量減少且未能及時找到第三方協助，或會引致銷售下降。
- ix. 本集團與獨立第三方就坪山現廠區之城市更新項目的發展簽訂合作協議。若對方未能按合作協議條文按時分批付款，有可能導致合作取消。有關進一步詳情，請參閱上文「管理層討論及分析 — 財務回顧 — 重大投資及資本資產的未來計劃」。
- x. 本集團主要生產營運地方在中國內地，中國內地政策的變動(包括稅務、外匯管制、進出口等等)可能會影響到本集團的整體表現。
- xi. 二零二一年中國多個地方出現供電問題，繼而政府放寬電費價格限制，這可能提高國內生產企業未來的用電成本。
- xii. 俄烏戰事持續，各處地緣衝突頻生，國與國的對抗行為，影響正常交易，增加各個行業發展風險。
- xiii. 海外客戶希望在他們的供應鏈中，推行「中國加一」概念，減少對中國供應商的依賴，在中國以外地區，再找另外的供應商，這樣可能在日後減少中國廠家的採購。

### ENVIRONMENTAL PROTECTION

Environmental protection is a collective responsibility not to be ignored. The Group's production factories in Shenzhen, China possesses state-of-the-art PCB technologies and attaches a great importance to environmental protection. The Group recognises that the production process of PCBs would generate more emissions than some other industries. In regard of this, we strive to enhance the efficiency of environmental protection. The Group sets up different management requirements for environmental protection every year, aiming at reducing negative impact on the environment from our operation. We have obtained certification of IATF16949:2016 (quality assurance), ISO14001 (environment management system), ISO9001 (quality management system), ISO13485:2016 (quality assurance for medical devices) and AS9100D (quality management system) as well as UL-796 (safety and management) for PCB quality standard and environment management system.

The Group strictly observed the laws and regulations governing air pollution, noise pollution, hazardous chemicals, sewage and waste discharge and other environmental matters issued by PRC national, provincial and municipal governments and authorities. Meanwhile, as a responsible corporation, we produce all of our products in compliance with the requirement of Cleaner Production Standard: Printed Circuit Board Manufacturing (清潔生產標準：印刷電路板製造業) issued by the Ministry of Environmental Protection of China.

With resources in the Earth becoming increasingly scarce, corporations should have long-term vision instead of focusing on existing interests. The Group sees that there are economic benefits to be capitalized in environmental protection and our effort focuses chiefly in the following aspects, among others: actively pushing forward the initiative of energy conservation and consumption reduction by saving energy, water, material and reducing resource consumption during the course of our production, with a view to maximizing the cost effectiveness with minimal resources; and full implementation of clean production to achieve waste reduction at source. At the same time, under the guidance of a paperless office, the Group introduced the Enterprise Resources Planning System ("ERP" System), through which it implemented electronic management on the its production, sales, supply chain, and human resources with a view to saving paper.

The environmental, social and governance report in Compliance with Appendix 27 of the Listing Rules will be issued in due course.

### 環境保護

保護環境是不容忽視的共同責任，本集團於中國深圳的生產廠房擁有最先進的PCB技術，且對環保高度重視。本集團明白PCB的生產過程會較其他工業產生更多排放物，有鑑於此，我們致力提高環保效能。本集團在環境保護方面每年制定不同的管理規範，旨在減少本集團業務對環境帶來的負面影響。我們的PCB品質標準及環境管理系統已獲頒IATF16949:2016品質保證認證、ISO14001環境管理系統認證、ISO9001品質管理系統、ISO13485：2016醫療器械質量保證及AS9100D品質管理系統以及UL-796安全管理認證等。

本集團嚴格遵守由中國國家、各級省市政府及機關頒布規管空氣污染、噪音污染、危險化學品、污水及廢物排放及其他環境事宜的法律和法規。與此同時，作為負責任的企業，我們按照中國環境保護部頒布的清潔生產標準：印刷電路板製造業的要求生產本公司所有產品。

地球資源不斷減少，企業應立足長遠不要只顧眼前利益。本集團主要從以下幾方面出發，以環保體現經濟利潤，包括：積極推進節能降耗，在生產過程中節能、節水、節材，減少資源消耗，從而以最少的資源達致最大的經濟效益；全面推行清潔生產，從源頭減廢。同時，本集團推行辦公無紙化的理念，透過引入企業資源計劃系統（「ERP」系統），利用其對本集團的生產、銷售、供應鏈、人力資源等進行電子化管理，以節省紙張的使用。

Accordingly, our audit included the performance of procedures designed to respond to our assessment of the risks of material misstatement of the consolidated financial statements. The Group performs regular review of the carrying amounts of inventories to determine whether any write-down of inventories to net realisable value is required after considering, inter alia, the ageing analysis of inventories, current market conditions and the expected future sales of goods and usage of materials.

### 2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards (“HKFRSs”) (which include all Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards (“HKASs”) and Interpretations) issued by the Hong Kong Institute of Certified Public Accountants (“HKICPA”), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance.

They have been prepared under the historical cost convention, except for a financial asset at fair value through other comprehensive income and investment properties which have been measured at fair value. These financial statements are presented in Hong Kong dollars (“HK\$”) and all values are rounded to the nearest thousand except when otherwise indicated.

#### Basis of consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries (collectively referred to as the “Group”) for the year ended 31 December 2022. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

Generally, there is a presumption that a majority of voting right results in control. When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group’s voting rights and potential voting rights.

### 2.1 編製基準

該等財務報表乃根據香港會計師公會(「香港會計師公會」)頒佈的香港財務報告準則(「香港財務報告準則」)(包括所有香港財務報告準則、香港會計準則(「香港會計準則」)及詮釋)、香港公認會計原則以及香港公司條例的披露規定而編製。

除一項按公平值計入其他全面收益的財務資產及投資物業以公平值計量外，財務報表乃根據歷史成本法編製。除另有指明外，該等財務報表以港元(「港元」)呈列，而所有數值均約整至最接近的千位。

#### 綜合基準

綜合財務報表包括本公司及其附屬公司(統稱「本集團」)截至二零二二年十二月三十一日止年度之財務報表。附屬公司為本公司直接或間接控制的實體(包括結構性實體)。當本集團對參與投資對象業務的浮動回報承擔風險或享有權利以及能透過對投資對象行使的權力(即本集團獲賦予現有能力以主導投資對象相關活動的既存權利)影響該等回報時，即取得控制權。

一般假設大部分投票權產生控制權。倘本公司直接或間接擁有少於投資對象大多數投票的權利或類似權利，則本集團於評估其是否擁有對投資對象的權力時會考慮一切相關事實及情況，包括：

- (a) 與投資對象其他投票持有人的合約安排；
- (b) 其他合約安排產生的權利；及
- (c) 本集團的投票權及潛在投票權。

#### Basis of consolidation (continued)

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets (including goodwill) and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interest and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained and (iii) any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

The nature and impact of the revised HKFRSs that are applicable to the Group are described below:

- (a) Amendments to HKFRS 3 replace a reference to the previous *Framework for the Preparation and Presentation of Financial Statements* with a reference to the *Conceptual Framework for Financial Reporting* (the "Conceptual Framework") issued in June 2018 without significantly changing its requirements. The amendments also add to HKFRS 3 an exception to its recognition principle for an entity to refer to the Conceptual Framework to determine what constitutes an asset or a liability. The exception specifies that, for liabilities and contingent liabilities that would be within the scope of HKAS 37 or HK(IFRIC)-Int 21 if they were incurred separately rather than assumed in a business combination, an entity applying HKFRS 3 should refer to HKAS 37 or HK(IFRIC)-Int 21 respectively instead of the Conceptual Framework. Furthermore, the amendments clarify that contingent assets do not qualify for recognition at the acquisition date. The Group has applied the amendments prospectively to business combinations that occurred on or after 1 January 2022. As there were no business combinations during the year, the amendments did not have any impact on the financial position and performance of the Group.
- (b) Amendments to HKAS 16 prohibit an entity from deducting from the cost of an item of property, plant and equipment any proceeds from selling items produced while bringing that asset to the location and condition necessary for it to be capable of operating in the manner intended by management. Instead, an entity recognises the proceeds from selling any such items, and the cost of those items as determined by HKAS 2 Inventories, in profit or loss. The Group has applied the amendments retrospectively to items of property, plant and equipment made available for use on or after 1 January 2021. Since there was no sale of items produced prior to the property, plant and equipment being available for use, the amendments did not have any impact on the financial position or performance of the Group.

(c) Amendments to HKAS 37 clarify that for the purpose of assessing whether a contract is onerous under HKAS 37, the cost of fulfilling the contract comprises the costs that relate directly to the contract. Costs that relate directly to a contract include both the incremental costs of fulfilling that contract (e.g., direct labour and materials) and an allocation of other costs that relate directly to fulfilling that contract (e.g., an allocation of the depreciation charge for an item of property, plant and equipment used in fulfilling the contract as well as contract management and supervision costs). General and administrative costs do not relate directly to a contract and are excluded unless they are explicitly chargeable to the counterparty under the contract. The Group has applied the amendments prospectively to contracts for which it has not yet fulfilled all its obligations at 1 January 2022 and no onerous contracts were identified. Therefore, the amendments did not have any impact on the financial position or performance of the Group.

(d) *Annual Improvements to HKFRSs 2018–2020* sets out amendments to HKFRS 1, HKFRS 9, Illustrative Examples accompanying HKFRS 16, and HKAS 41. Details of the amendments that are applicable to the Group are as follows:

- HKFRS 9 *Financial Instruments*: clarifies the fees that an entity includes when assessing whether the terms of a new or modified financial liability are substantially different from the terms of the original financial liability. These fees include only those paid or received between the borrower and the lender, including fees paid or received by either the borrower or lender on the other's behalf. The Group has applied the amendment prospectively from 1 January 2022. As there was no modification or exchange of the Group's financial liabilities during the year, the amendment did not have any impact on the financial position or performance of the Group.

Further information about those HKFRSs that are expected to be applicable to the Group is described below.

Amendments to HKFRS 10 and HKAS 28 (2011) address an inconsistency between the requirements in HKFRS 10 and in HKAS 28 (2011) in dealing with the sale or contribution of assets between an investor and its associate or joint venture. The amendments require a full recognition of a gain or loss resulting from a downstream transaction when the sale or contribution of assets between an investor and its associate or joint venture constitutes a business. For a transaction involving assets that do not constitute a business, a gain or loss resulting from the transaction is recognised in the investor's profit or loss only to the extent of the unrelated investor's interest in that associate or joint venture. The amendments are to be applied prospectively. The previous mandatory effective date of amendments to HKFRS 10 and HKAS 28 (2011) was removed by the HKICPA in January 2016 and a new mandatory effective date will be determined after the completion of a broader review of accounting for associates and joint ventures. However, the amendments are available for adoption now.

Amendments to HKFRS 16 specify the requirements that a seller-lessee uses in measuring the lease liability arising in a sale and leaseback transaction to ensure the seller-lessee does not recognise any amount of the gain or loss that relates to the right of use it retains. The amendments are effective for annual periods beginning on or after 1 January 2024 and shall be applied retrospectively to sale and leaseback transactions entered into after the date of initial application of HKFRS 16 (i.e., 1 January 2019). Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements. In respect of sale and leaseback transactions with variable lease payments that do not depend on an index or a rate, the Group will develop an accounting policy for such transactions.

香港財務報告準則第16號(修訂本)訂明賣方一承租人於計量售後租回交易中產生的租賃負債時所採用的規定，以確保賣方一承租人不確認與其保留的使用權有關的任何損益。該等修訂本自二零二四年一月一日或其後開始的年度期間生效，並將追溯應用於香港財務報告準則第16號首次應用日期(即二零一九年一月一日)之後簽訂的售後租回交易。允許提早應用。該等修訂本預期不會對本集團的財務報表產生任何重大影響。對於並非視乎指數或比率而定的可變租賃付款的售後租回交易，本集團將就此類交易制定會計政策。

Amendments to HKAS 1 *Classification of Liabilities as Current or Non-current* clarify the requirements for classifying liabilities as current or non-current, in particular the determination over whether an entity has a right to defer settlement of the liabilities for at least 12 months after the reporting period. Classification of a liability is unaffected by the likelihood that the entity will exercise its right to defer settlement of the liability. The amendments also clarify the situations that are considered a settlement of a liability. In 2022, the HKICPA issued the 2022 Amendments to further clarify that, among covenants of a liability arising from a loan arrangement, only those with which an entity must comply on or before the reporting date affect the classification of that liability as current or non-current. In addition, the 2022 Amendments require additional disclosures by an entity that classifies liabilities arising from loan arrangements as non-current when it has a right to defer settlement of those liabilities that are subject to the entity complying with future covenants within 12 months after the reporting period. The amendments are effective for annual periods beginning on or after 1 January 2024 and shall be applied retrospectively. Earlier application is permitted. An entity that applies the 2020 Amendments early is required to apply simultaneously the 2022 Amendments, and vice versa. The Group is currently assessing the impact of the amendments and whether existing loan agreements may require revision. Based on a preliminary assessment, the amendments are not expected to have any significant impact on the Group's financial statements.

Amendments to HKAS 1 Disclosure of Accounting Policies require entities to disclose their material accounting policy information rather than their significant accounting policies. Accounting policy information is material if, when considered together with other information included in an entity's financial statements, it can reasonably be expected to influence decisions that the primary users of general purpose financial statements make on the basis of those financial statements. Amendments to HKFRS Practice Statement 2 provide non-mandatory guidance on how to apply the concept of materiality to accounting policy disclosures. Amendments to HKAS 1 are effective for annual periods beginning on or after 1 January 2023 and earlier application is permitted. Since the guidance provided in the amendments to HKFRS Practice Statement 2 is non-mandatory, an effective date for these amendments is not necessary. The Group is currently revisiting the accounting policy disclosures to ensure consistency with the amendments.

香港會計準則第1號(修訂本)負債分類為即期或非即期澄清將負債分類為流動或非流動的規定，尤其是釐定實體是否有權於報告期後至少12個月延遲清償債務。負債的分類並不受實體將行使其權利延遲清償負債的可能性的影響。該等修訂同時對被視為清償負債的情況進行澄清。於二零二二年，香港會計師公會頒佈2022年修訂本以進一步澄清，在貸款安排產生的負債的契約中，只有實體於報告日期或之前須遵守的契約會影響該負債分類為即期或非即期。此外，2022年修訂本要求將貸款安排產生的負債分類為非流動負債的實體進行額外披露，前題為該實體有權推遲清算於報告期後12個月內實體遵守未來契約的負債。該等修訂於二零二四年一月一日或其後開始的年度期間生效，且將追溯應用。允許提早應用。提早應用2020年修訂本的實體必須同時應用2022年修訂本，反之亦然。本集團目前正在評估修訂的影響以及現有貸款協議是否需要進行修訂。根據初步評估，該等修訂預期不會對本集團的財務報表產生任何重大影響。

香港會計準則第1號(修訂本)會計政策披露要求企業披露其重大會計政策資料，而非其重大會計政策。倘將會計政策資料與實體財務報表中所載的其他資料一併考慮，而可合理預期會影響一般財務報表主要使用者根據該等財務報表作出的決定，則該會計政策資料屬重大。香港財務報告準則實務公告第2號(修訂本)就如何將重大性概念應用於會計政策披露提供非強制性指引。香港會計準則第1號(修訂本)於二零二三年一月一日或其後開始的年度期間生效，並允許提前應用。由於香港財務報告準則實務公告第2號(修訂本)所提供的指引為非強制性，因此該等修訂毋須有生效日期。本集團目前正在重新審視會計政策披露以確保與修訂本一致。

Amendments to HKAS 8 clarify the distinction between changes in accounting estimates and changes in accounting policies. Accounting estimates are defined as monetary amounts in financial statements that are subject to measurement uncertainty. The amendments also clarify how entities use measurement techniques and inputs to develop accounting estimates. The amendments are effective for annual reporting periods beginning on or after 1 January 2023 and apply to changes in accounting policies and changes in accounting estimates that occur on or after the start of that period. Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

Amendments to HKAS 12 narrow the scope of the initial recognition exception in HKAS 12 so that it no longer applies to transactions that give rise to equal taxable and deductible temporary differences, such as leases and decommissioning obligations. Therefore, entities are required to recognise a deferred tax asset (provided that sufficient taxable profit is available) and a deferred tax liability for temporary differences arising from these transactions. The amendments are effective for annual reporting periods beginning on or after 1 January 2023 and shall be applied to transactions related to leases and decommissioning obligations at the beginning of the earliest comparative period presented, with any cumulative effect recognised as an adjustment to the opening balance of retained profits or other component of equity as appropriate at that date. In addition, the amendments shall be applied prospectively to transactions other than leases and decommissioning obligations. Earlier application is permitted. The Group is in the process of performing a detailed assessment of the impact of these amendments upon initial application. Subject to further assessment, the amendments currently are not expected to have a significant impact on the Group's financial statements in the period of initial application.

香港會計準則第8號(修訂本)闡明會計估計變動與會計政策變動的區別。會計估計的定義為存在計量不確定性的財務報表內的貨幣金額。該等修訂亦闡明實體如何使用計量技術及輸入數據編製會計估計。該等修訂於二零二三年一月一日或其後開始的年度報告期間生效，並適用於該期間開始時或之後發生的會計政策變動及會計估計變動。該等修訂允許提前應用。該等修訂預期不會對本集團的財務報表造成任何重大影響。

香港會計準則第12號(修訂本)縮小了於香港會計準則第12號初步確認例外的範圍，使其不再適用於產生相等的應課稅和可扣減暫時差額的交易，例如租賃及停用責任。因此，實體須就該等交易產生的暫時差額確認遞延稅項資產(前題為有足夠的應課稅溢利)和遞延稅項負債。該等修訂於二零二三年一月一日或其後開始的年度報告期間生效並應用於與所呈列最早比較期間開始時的租賃及停用責任有關的交易，其中任何累計影響確認為對該日期保留盈利或其他權益組成部分(倘適用)年初結餘的調整。此外，該等修訂應前瞻性地應用於租賃及停用責任以外的交易。允許提早應用。本集團正在對該等修訂本初步應用後的影響做詳細評估。該等修訂本目前在初步應用期間預期不會對本集團的財務報表造成任何重大影響(視乎進一步評估而定)。

#### Fair value measurement

The Group measures its investment properties and an equity investment at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

#### 公平值計量

本集團於各報告期末按公平值計量其投資物業及一項股權投資。公平值為於計量日期市場參與者之間進行的有序交易中出售資產所收取或轉移負債所支付的價格。公平值計量乃基於出售資產或轉移負債的交易於資產或負債的主要市場進行，或在未有主要市場的情況下，則於資產或負債的最有利市場進行的假設。主要或最有利市場必須為本集團可進入的市場。資產或負債的公平值乃基於市場參與者為資產或負債定價時所用的假設計量（假設市場參與者以符合彼等最佳經濟利益的方式行事）。

非財務資產的公平值計量計及一名市場參與者透過以最大限度及最佳用途使用該資產，或透過將資產出售予將以最大限度及最佳用途使用該資產的另一名市場參與者而產生經濟利益的能力。

#### Fair value measurement (continued)

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

Level 1	—	based on quoted prices (unadjusted) in active markets for identical assets or liabilities
Level 2	—	based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly
Level 3	—	based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

For assets and liabilities that are recognised in the financial statements on a recurring basis, the Group determines whether transfers have occurred between levels in the hierarchy by reassessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

本集團使用適用於不同情況且具備足夠可用數據以計量公平值的估值方法，以盡量使用相關可觀察輸入數據及盡量減少使用不可觀察輸入數據。

於財務報表計量或披露公平值的所有資產及負債均根據對公平值計量整體而言屬重大的最低級別輸入數據在下述公平值等級內進行分類：

第一級	—	基於在活躍市場中相同資產或負債的報價 (未經調整)
第二級	—	基於對公平值計量而言屬重大的可觀察 (直接或間接) 最低級別輸入數據的估值方法

#### Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, investment properties, deferred tax assets, financial assets and non-current assets classified as held for sale), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to the statement of profit or loss in the period in which it arises.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to the statement of profit or loss in the period in which it arises.

#### 非財務資產減值

倘一項資產(存貨、投資物業、遞延稅項資產、財務資產及分類為持作出售之非流動資產除外)存在減值跡象,或需要進行年度減值測試,則會估計資產的可收回金額。資產可收回金額按該資產或現金產生單位的使用價值及其公平值減出售成本兩者中的較高金額計算,並按個別資產釐定,除非該資產不能產生大體上獨立於其他資產或資產組別產生之現金流入,在該情況下可收回金額將按該資產所屬現金產生單位釐定。

減值虧損僅於資產賬面值超過其可收回金額時方會確認。評估使用價值時,估計未來現金流量採用反映當前市場對資金時間價值及資產特定風險的評估之稅前貼現率貼現至其現值。減值虧損於產生期間的損益表內扣除。

於各報告期末,已就是否有跡象顯示先前確認的減值虧損可能已不存在或可能減少作出評估。倘存在上述跡象,則會估計可收回金額。就先前確認的資產減值虧損僅於用以釐定該資產可收回金額的估計出現變動時方予撥回,惟撥回金額不得超過在過往年度並無就該資產確認減值虧損的情況下原應釐定的賬面值(扣除任何折舊)。該減值虧損撥回計入產生期間的損益表。

#### Related parties

A party is considered to be related to the Group if:

- (a) the party is a person or a close member of that person's family and that person
  - (i) has control or joint control over the Group;
  - (ii) has significant influence over the Group; or
  - (iii) is a member of the key management personnel of the Group or of a parent of the Group;

or

- (b) the party is an entity where any of the following conditions applies:
  - (i) the entity and the Group are members of the same group;

#### Property, plant and equipment and depreciation

Property, plant and equipment, other than construction in progress, are stated at cost less accumulated depreciation and any impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to the statement of profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Depreciation is calculated on the straight-line basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. The principal annual rates used for this purpose are as follows:

Leasehold land and buildings	2.2% to 4%
Leasehold improvements	33 $\frac{1}{3}$ %
Plant and machinery	9% to 18%
Furniture, fixtures and equipment	9% to 33 $\frac{1}{3}$ %
Motor vehicles	30% to 33 $\frac{1}{3}$ %

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property, plant and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in the statement of profit or loss in the year the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

Construction in progress mainly represents buildings and leasehold improvements under construction, which are stated at cost less any impairment losses, and are not depreciated. Cost comprises the direct costs of construction and capitalised borrowing costs on related borrowed funds during the period of construction. Construction in progress is reclassified to the appropriate category of property, plant and equipment when completed and ready for use.

#### 物業、廠房及設備和折舊

物業、廠房及設備(在建工程除外)乃按成本減累計折舊及任何減值虧損後列賬。物業、廠房及設備項目成本包括其購入價及任何令該項資產達致運作狀態及將其運往擬定用途地點之直接應計成本。

物業、廠房及設備項目投入運作後產生之開支,例如維修及保養費用,一般於該等開支產生之期間於損益表內扣除。在符合確認條件的情況下,大型檢驗的開支於資產的賬面值資本化為重置資產。倘物業、廠房及設備的主要部份須分段重置,則本集團將該等部份確認為獨立資產,並設有特定的可使用年期及作出相應折舊。

折舊以直線法於各項物業、廠房及設備之估計可使用年期撇銷其成本至其剩餘價值。就此目的而採用之主要年利率如下:

租賃土地及樓宇	2.2% 至 4%
租賃裝修	33 $\frac{1}{3}$ %
廠房及機器	9% 至 18%
傢俱、固定裝置及設備	9% 至 33 $\frac{1}{3}$ %
汽車	30% 至 33 $\frac{1}{3}$ %

倘一項物業、廠房及設備各部分之可使用年期並不相同,則該項目各部分之成本將按合理基準分配,而各部分將作個別折舊。剩餘價值、可使用年期及折舊方法至少會於各財政年度末進行審閱及調整(如適用)。

一項物業、廠房及設備(包括任何初步已確認之重大部分)於出售或預計日後其使用或出售不再產生經濟利益時,將終止確認。於資產終止確認年度因其出售或報廢並在損益表確認之任何收益或虧損,乃有關資產之出售所得款項淨額與賬面值之差額。

在建工程主要指在建樓宇及租賃物業裝修,其按成本扣除任何減值虧損列賬,且不計算折舊。成本包括直接建築成本及建築期內產生之相關借貸之資本化借貸成本。在建工程於落成及可供使用時重新分類至物業、廠房及設備之適當類別。

#### Investment properties

Investment properties are interests in land and buildings (including the leasehold property held as a right-of-use asset which would otherwise meet the definition of an investment property) held to earn rental income and/or for capital appreciation, rather than for use in the production or supply of goods or services or for administrative purposes; or for sale in the ordinary course of business. Such properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are stated at fair value, which reflects market conditions at the end of the reporting period.

Gains or losses arising from changes in the fair values of investment properties are included in the statement of profit or loss in the year which they arise.

Any gains or losses on the retirement or disposal of an investment property are recognised in the statement of profit or loss in the year of the retirement or disposal.

#### Non-current assets and disposal groups held for sale

Non-current assets and disposal groups are classified as held for sale if their carrying amounts will be recovered principally through a sales transaction rather than through continuing use. For this to be the case, the asset or disposal group must be available for immediate sale in its present condition subject only to terms that are usual and customary for the sale of such assets or disposal groups and its sale must be highly probable. All assets and liabilities of a subsidiary classified as a disposal group are reclassified as held for sale regardless of whether the Group retains a non-controlling interest in its former subsidiary after the sale.

Non-current assets and disposal groups (other than investment properties and financial assets) classified as held for sale are measured at the lower of their carrying amounts and fair values less costs to sell. Property, plant and equipment classified as held for sale are not depreciated.

#### 投資物業

投資物業指以獲得租金收入及／或達致資本升值為目的而持有之土地及樓宇權益(包括將在其他方面符合投資物業定義的持作使用權資產的租賃物業)，其非用作生產或提供貨品或服務，或用作行政用途，或用作在日常業務中出售之用途。該等物業初次以成本(包括交易成本)計量。於初次確認後，投資物業乃按反映各報告期末的市場狀況之公平值列賬。

投資物業公平值變動所帶來的盈虧於產生的年度計入損益表。

報廢或出售投資物業的任何盈虧於報廢或出售之年度在損益表確認。

#### 持作出售非流動資產及出售組別

倘非流動資產及出售組別的賬面值將主要通過銷售交易而非持續使用收回，則其將分類為持作出售。要達至此情況，該資產或出售組別須可於現況下即時出售而僅受出售有關資產或出售組別的常規性及習慣性條款制約，且其很可能售出。分類為出售組別的附屬公司所有資產及負債均獲重新分類為持作出售(不論本集團是否於銷售後保留其前附屬公司的非控股權益)。

分類為持作出售的非流動資產及出售組別(投資物業及金融資產除外)按其賬面值及公平值減出售成本兩者間的較低者計量。分類為持作出售的物業、廠房及設備不計提折舊。

#### Leases

The Group assesses at contract inception whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

#### Group as a lessee

The Group applies a single recognition and measurement approach for all leases. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

#### (a) Right-of-use assets

Right-of-use assets are recognised at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Right-of-use assets are depreciated on a straight-line basis over the lease terms.

If ownership of the leased asset transfers to the Group by the end of the lease term or the cost reflects the exercise of a purchase option, depreciation is calculated using the estimated useful life of the asset.

#### 租賃

本集團於合約開始時評估合約是否為租賃或包含租賃，即倘合約為換取代價而給予在一段時間內控制可識別資產使用的權利，則該合約為租賃或包含租賃。

#### 本集團作為承租人

本集團已就所有租賃應用一項單一確認及計量方法。本集團確認租賃負債以作出租賃付款，而使用權資產指使用相關資產的權利。

#### (a) 使用權資產

使用權資產於租賃開始日期(即有關資產可供使用日期)予以確認。使用權資產按成本減任何累計折舊及任何減值虧損，並就任何重新計量租賃負債作出調整。使用權資產成本包括已確認租賃負債款項、已產生初步直接成本及於開始日期或之前作出之租賃付款減任何已收取租賃獎勵。使用權資產乃按租期以直線基準折舊。

倘於租期結束時租賃資產的擁有權轉讓至本集團或成本反映購買權的行使，折舊則根據資產的估計可使用年期計算。

###### (b) Lease liabilities

Lease liabilities are recognised at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate the lease. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset.

##### Group as a lessor

When the Group acts as a lessor, it classifies at lease inception (or when there is a lease modification) each of its leases as either an operating lease or a finance lease.

Leases in which the Group does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. When a contract contains lease and non-lease components, the Group allocates the consideration in the contract to each component on a relative stand-alone selling price basis. Rental income is accounted for on a straight-line basis over the lease terms and is included in revenue in the statement of profit or loss due to its operating nature. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income. Contingent rents are recognised as revenue in the period in which they are earned.

Leases that transfer substantially all the risks and rewards incidental to ownership of an underlying asset to the lessee are accounted for as finance leases.

##### 本集團作為承租人 (續)

###### (b) 租賃負債

租賃負債於租賃開始日期按租期內將予支付租賃付款的現值確認。租賃付款包括固定付款(包括實質固定付款)減任何租賃獎勵應收款項、取決於指數或利率之可變租賃款項以及預期根據剩餘價值擔保支付之金額。租賃付款亦包括本集團合理確定行使之購買選擇權之行使價及在租賃期反映本集團行使終止租賃選擇權時,有關終止租賃之罰款。並非取決於指數或利率之可變租賃付款在出現觸發付款之事件或條件之期間內確認為開支。

於計算租賃付款之現值時,由於租賃隱含利率不易釐定,本集團使用租賃開始日期之增量借款利率計算。於開始日期後,租賃負債金額之增加反映利息之增長,並會因支付租賃付款而減少。此外,倘出現修訂、租賃期有所變更、租賃付款出現變動(如因指數或利率變動而變更為未來租賃付款),或購買有關資產之評估出現變動,租賃負債之賬面值將會重新計量。

##### 本集團作為出租人

倘本集團為出租人,則其在租賃開始時(或發生租賃變更時)將其各項租賃分類為經營租賃或融資租賃。

所有本集團並未轉讓資產所有權所附帶的絕大部分風險及回報的租賃歸類為經營租賃。倘一項合約包含租賃組成部分,本集團根據相對獨立價格基準將合約代價分配至各項租賃組成部分。由於經營性質,租金收入於租期內按直線法列賬並計入損益表之收益。於磋商及安排經營租賃時產生的初始直接成本乃計入租賃資產的賬面值,並於租期內按相同方法確認為租金收入。或然租金乃於所賺取的期間內確認為收益。

將與相關資產所有權所附帶的絕大部分風險及回報轉讓予承租人的租賃歸類為融資租賃。

#### Investments and other financial assets

##### Initial recognition and measurement

Financial assets of the Group are classified, at initial recognition, as subsequently measured at amortised cost and fair value through other comprehensive income.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value, plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under HKFRS 15 in accordance with the policies set out for "Revenue recognition" below.

In order for a financial asset to be classified and measured at amortised cost or fair value through other comprehensive income, it needs to give rise to cash flows that are solely payments of principal and interest ("SPPI") on the principal amount outstanding. Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

The Group's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortised cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows, while financial assets classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace.

##### 初步確認及計量

本集團的財務資產於初步確認時分類，其後按攤銷成本及按公平值計入其他全面收益。

於初步確認時，財務資產分類取決於財務資產的合約現金流量特點及本集團管理該等財務資產的業務模式。除並無重大融資成分或本集團已應用不調整主要融資組成部分影響的可行權宜方法的貿易應收款項外，本集團初步按公平值加上（倘財務資產並非按公平值計入損益）交易成本計量財務資產。並無重大融資成分或本集團已根據下文「收益確認」所載政策應用可行權宜方法的貿易應收款項按香港財務報告準則第15號釐定的交易價格計量。

為使財務資產按攤銷成本或按公平值計入其他全面收益進行分類及計量，需產生就未償還本金的純粹本息付款（「SPPI」）的現金流量。具有並非SPPI之現金流量之財務資產分類為按公平值計入損益計量，而不論業務模式。

本集團管理財務資產的業務模式指其如何管理其財務資產以產生現金流量。業務模式確定現金流量是否來自收集合約現金流量、出售財務資產，或兩者兼有。按攤銷成本分類及計量的財務資產乃在為持有財務資產以收取合約現金流量的業務模式中持有，而按公平值計入其他全面收益分類及計量的財務資產在為持有財務資產以收取及出售合約現金流量的業務模式中持有。未於上述業務模式中持有的財務資產按公平值計入損益分類及計量。

所有正常途徑的財務資產買賣乃於交易日期確認，交易日期即本集團承諾收購或出售資產的日子。正常途徑買賣指需要於一般由法規或市場慣例確定的期間內交付資產的財務資產買賣。

The subsequent measurement of financial assets depends on their classification as follows:

##### *Financial assets at amortised cost (debt instruments)*

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in the statement of profit or loss when the asset is derecognised, modified or impaired.

##### *Financial assets designated at fair value through other comprehensive income (equity investments)*

Upon initial recognition, the Group can elect to classify irrevocably its equity investments as equity investments designated at fair value through other comprehensive income when they meet the definition of equity under HKAS 32 *Financial Instruments: Presentation* and are not held for trading. The classification is determined on an instrument-by-instrument basis.

Gains and losses on these financial assets are never recycled to the statement of profit or loss. Dividends are recognised as other income in the statement of profit or loss when the right of payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably, except when the Group benefits from such proceeds as a recovery of part of the cost of the financial asset, in which case, such gains are recorded in other comprehensive income. Equity investments designated at fair value through other comprehensive income are not subject to impairment assessment.

財務資產的其後計量視乎其如下分類而定：

##### *按攤銷成本計量的財務資產(債務工具)*

按攤銷成本計量的財務資產其後使用實際利率法計量，並可能受減值影響。當資產終止確認、修訂或減值時，收益及虧損於損益表中確認。

##### *指定按公平值計入其他全面收益的財務資產(股權投資)*

於初步確認時，本集團可選擇於股權投資符合香港會計準則第32號財務工具：呈報項下的股本定義且並非作買賣時，不可撤回地將其股權投資分類為指定按公平值計入其他全面收益的股權投資。分類乃按個別工具基準釐定。

該等財務資產的收益及虧損概不會被重新計入損益表。當確立支付權且與股息有關的經濟利益將可能流入本集團及股息金額能可靠計量時，股息於損益表中確認為其他收入，惟當本集團於作為收回財務資產一部分成本的所得款項中獲益時則除外，於此情況下，該等收益於其他全面收益記錄。指定按公平值計入其他全面收益的股權投資不受減值評估影響。

#### Derecognition of financial assets

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e., removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risk and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

一項財務資產(或(如適用)一項財務資產的部分或一組同類財務資產的部分)主要在以下情況被終止確認(即自本集團的綜合財務狀況表中剔除):

- 從資產取得現金流量的權利已過期;或
- 本集團已轉移其從資產取得現金流量的權利或已於一個「轉付」安排下承擔將取得的現金流量全部向第三方支付義務,且不得有重大延誤;及(a)本集團已轉移該資產的絕大部分風險及回報,或(b)本集團既無轉移亦無保留該資產的絕大部分風險及回報,但已轉移該資產的控制權。

倘本集團已轉移其從資產取得現金流量的權利或已訂立轉付安排,其評估有否保留資產擁有權的風險及回報,以及相關程度。倘並無轉移或並無保留資產的絕大部分風險與回報,亦無轉移資產的控制權,則本集團按其持續參與程度繼續確認被轉移資產。在該情況下,本集團亦確認一項相關債務。被轉移資產及相關債務乃根據反映本集團已保留的權利與義務的基礎計量。

以對已轉讓資產作出擔保之形式進行之持續參與,按以下兩者中較低者計量:該資產之原賬面值及本集團須償還之最高代價。

#### Impairment of financial assets

The Group recognises an allowance for expected credit losses (“ECLs”) for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

#### General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information. The Group considers that there has been a significant increase in credit risk when contractual payments are more than 120 days past due.

#### 財務資產減值

本集團確認對並非按公平值計入損益的所有債務工具預期信貸虧損(「預期信貸虧損」)的撥備。預期信貸虧損乃基於根據合約到期的合約現金流量與本集團預期收取的所有現金流量之間的差額而釐定，並以原實際利率的近似值貼現。預期現金流量將包括出售所持抵押的現金流量或組成合約條款的其他信貸提升措施。

#### 一般法

預期信貸虧損分兩個階段進行確認。就自初始確認起未有顯著增加的信貸風險而言，預期信貸虧損提供予由未來12個月內可能發生違約事件而導致的信貸虧損(12個月預期信貸虧損)。就自初始確認起經已顯著增加的信貸風險而言，不論何時發生違約，於餘下風險年期內的預期信貸虧損均須計提虧損撥備(全期預期信貸虧損)。

於各報告日期，本集團評估財務工具的信貸風險是否自初次確認後大幅提高。於作出該評估時，本集團比較報告日期財務工具產生的違約風險及於初步確認時財務工具產生的違約風險，並考慮在毋須付出不必要成本或努力而可獲得合理及支持資料，包括過往及前瞻性資料。本集團認為，倘合約付款逾期超過120日，信貸風險則大幅增加。

##### General approach (continued)

The Group considers a financial asset in default when contractual payments are 120 days past due. The Group has rebutted the 90 days past due presumption of default based on reasonable and supportable information, including the Group's credit risk control practices and the historical recovery rate of financial assets over 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade and bills receivables which apply the simplified approach as detailed below.

##### Simplified approach

For trade and bills receivables that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

##### 一般法(續)

本集團將合約還款逾期120日的金融資產視作違約。本集團已根據合理及可靠的資料，包括本集團的信用風險控制常規及逾期90日以上的金融資產的歷史回收率，推翻逾期90天的違約假定。倘內部或外部資料反映，在計及本集團持有的任何信貸提升措施前，本集團不大可能悉數收到未償還合約款項，則本集團亦可認為金融資產違約。倘無法合理預期收回合約現金流量，則撇銷金融資產。

按攤銷成本計量的財務資產根據一般方法減值及於下列計量預期信貸虧損的各階段分類，惟貿易應收款項及應收票據使用下文詳述的簡化法除外。

##### 簡化法

就不包含重大融資組成部分的貿易應收款項及應收票據或當本集團使用不調整重大融資組成部分影響的可行權宜方法時，本集團計算預期信貸虧損時應用簡化法。根據簡化法，本集團並無追蹤信貸風險的變化，但於各報告日期根據全期預期信貸虧損確認虧損撥備。本集團已根據過往信貸虧損經驗，建立撥備矩陣，並就債務人及經濟環境的特定前瞻性因素作出調整。

#### Financial liabilities

##### Initial recognition and measurement

Financial liabilities of the Group are classified, at initial recognition, as loans and borrowings, or payables, as appropriate.

All financial liabilities are recognised initially at fair value and net of directly attributable transaction costs.

##### Subsequent measurement of financial liabilities at amortised cost (loans and borrowings)

After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in the statement of profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in the statement of profit or loss.

##### Derecognition of financial liabilities

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in the statement of profit or loss.

##### Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

##### Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the weighted average basis and, in the case of work in progress and finished goods, comprises direct materials, direct labour and an appropriate proportion of overheads. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to completion and disposal.

##### 初步確認及計量

本集團的財務負債在初步確認時分類為貸款及借款或應付款項(如適用)。

所有財務負債初步均按公平值確認並扣除直接應佔交易成本。

##### 按攤銷成本計量之財務負債(貸款及借款)其後計量

於初步確認後，計息貸款及借款其後按攤銷成本使用實際利率法計量，除非貼現的影響並不重大，在該情況下則按成本列賬。當終止確認負債及透過實際利率攤銷程序時，則於損益表確認收益及虧損。

攤銷成本的計算已計及任何收購折讓或溢價以及為實際利率整體一部分的費用或成本。實際利率攤銷計入損益表。

##### 終止確認財務負債

當負債的責任被解除或取消或屆滿，財務負債將終止確認。

倘現有財務負債由同一放債人以條款極為不同的負債所取代，或現有負債的條款經大幅修訂，該等交換或修訂視作終止確認原有負債及確認新負債處理，有關賬面值的差額於損益表確認。

##### 抵銷金融工具

倘有現行可予執行之法律權利以抵銷確認金額及有意按淨額基準償付，或變現資產與償還負債同時進行，則抵銷財務資產及財務負債，並於財務狀況表內呈報淨額。

##### 存貨

存貨按成本及可變現淨值之較低者列賬。成本按加權平均基準釐定，對在製品及成品而言，包括直接物料、勞工成本及適當比例的經常性開支。可變現淨值乃基於估計售價減任何因完成交易及出售而產生的估計成本計算。

#### Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the consolidated statement of financial position, cash and cash equivalents comprise cash on hand and at banks, including term deposits, and assets similar in nature to cash, which are not restricted as to use.

#### Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in the statement of profit or loss.

#### Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries/jurisdictions in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

#### 現金及現金等價物

就綜合現金流量表而言，現金及現金等價物包括手頭現金、活期存款及可隨時轉換為已知數額現金並於短期內(一般在購入後三個月內)到期，且並無重大價值變動風險的短期高流通量投資，再扣除須按要求償還及構成本集團現金管理一個必要部分的銀行透支。

就綜合財務狀況表而言，現金及現金等價物包括手頭及銀行現金(包括定期存款及與現金性質類似的資產)，而其用途不受限制。

#### 撥備

倘因過往事件導致現時承擔責任(法定或推定責任)，且日後可能須流失資源以履行責任，並能可靠估計有關責任之數額，則確認撥備。

倘若貼現影響重大，則所確認之撥備數額為預計履行責任所需之未來開支於報告期末之現值。隨時間流逝使貼現現值增加之款項計入損益表。

#### 所得稅

所得稅包括即期及遞延稅項。與於損益以外確認項目相關之所得稅於損益以外之其他全面收益或直接於權益內確認。

即期稅項資產及負債乃按預期可收回的數額或支付予稅務機關的數額計算，其根據於報告期末已頒佈或實質上已頒佈的稅率(及稅務法例)計算，並考慮到本集團經營所在國家/司法權區的現行詮釋及慣例。

遞延稅項就於報告期末資產及負債的稅項基準及其於財務報告中的賬面值的所有暫時性差額以負債法撥備。

#### Income tax (continued)

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- when the deferred tax liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of taxable temporary differences associated with investments in subsidiaries, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax assets are recognised for all deductible temporary differences, and the carryforward of unused tax credits and any unused tax losses. Deferred tax assets are recognised to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carryforward of unused tax credits and unused tax losses can be utilised, except:

- when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of deductible temporary differences associated with investments in subsidiaries, deferred tax assets are only recognised to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

所有應課稅暫時性差額均被確認為遞延稅項負債，惟：

- 倘若遞延稅項負債來自在一宗屬非業務合併的交易中初步確認商譽或資產或負債，而且在交易時對會計溢利或應課稅溢利或虧損均無影響，則屬例外；及
- 就於附屬公司的投資的相關應課稅暫時性差額而言，倘若撥回暫時性差額的時間可以控制，以及暫時性差額不太可能在可見將來撥回，則屬例外。

就所有可扣減暫時性差額、結轉的未動用稅項抵免及任何未動用稅項虧損而言，遞延稅項資產一律確認入賬。若日後有可能應課稅溢利，可用以抵銷該等可扣減暫時性差額、結轉的未動用稅項抵免及未動用稅項虧損產生，則遞延稅項資產確認入賬，惟：

- 倘若有關可扣減暫時性差額的遞延稅項資產來自在一宗屬非業務合併的交易中初步確認資產或負債，而且在交易時對會計溢利或應課稅溢利或虧損均無影響，則屬例外；及
- 就於附屬公司的投資的相關可扣減暫時性差額而言，僅在暫時性差額有可能在可見將來撥回，而且日後有可能出現應課稅溢利，可用以抵銷該等暫時性差額時，方會確認遞延稅項資產。

遞延稅項資產的賬面值在每個報告期末予以審閱。若不再可能有足夠應課稅溢利用以抵扣全部或部分遞延稅項資產，則扣減遞延稅項資產賬面值。未確認的遞延稅項資產於每個報告期末重新評估，並於可能有足夠應課稅溢利用以收回全部或部分遞延稅項資產時確認。

遞延稅項資產及負債按預期應用於該期間(當變現資產或償還負債時)的稅率計量，根據於報告期末已頒佈或實質上已頒佈的稅率(及稅法)計算。

#### Income tax (continued)

Deferred tax assets and deferred tax liabilities are offset if and only if the Group has a legally enforceable right to set off current tax assets and current tax liabilities and the deferred tax assets and deferred tax liabilities relate to income taxes levied by the same taxation authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

#### Government grants

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, for which it is intended to compensate, are expensed.

Where the grant relates to an asset, the fair value is credited to a deferred income account and is released to the statement of profit or loss over the expected useful life of the relevant asset by equal annual instalments.

#### Employee benefits

##### Pension scheme

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Hong Kong Mandatory Provident Fund Schemes Ordinance for those employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries and are charged to the statement of profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

The employees of the Group's subsidiaries which operate in Mainland China are required to participate in a central pension scheme operated by the local municipal government. These subsidiaries are required to contribute a certain percentage of their payroll costs to the central pension scheme. The contributions are charged to the statement of profit or loss as they become payable in accordance with the rules of the central pension scheme.

#### 所得稅(續)

僅於本集團具有可依法強制執行的權利，可以即期稅項資產抵銷即期稅項負債，及僅於遞延稅項資產與遞延稅項負債是關於同一稅務機關就同一應課稅實體所徵收的所得稅或就計劃於各段未來期間(而預期在有關期間內將結清或收回大額的遞延稅項負債或資產)以淨額基準結算即期稅項負債與資產或同時變現資產及結清負債之不同應課稅實體所徵收的所得稅時，則遞延所得稅資產及遞延所得稅負債可相互抵銷。

#### 政府補貼

如能合理確保將獲得政府補貼，且所有附帶條件將得到遵守，則政府補貼按公平值確認。如補貼與開支項目有關，則會有系統地於擬用作補償的成本支銷期間確認為收入。

倘補貼與資產有關，則其公平值會計入遞延收入賬，並按有關資產的預計可使用年期以每年等額分期款項撥入損益表。

#### 僱員福利

##### 退休金計劃

本集團根據香港強制性公積金計劃條例為其符合參加強制性公積金退休福利計劃(「強積金計劃」)資格之僱員營運定額供款強積金計劃。供款乃按僱員基本薪金之某一百分比計算，並根據強積金計劃之規則於應付時在損益表中扣除。強積金計劃之資產與本集團之資產分開存放，由獨立管理之基金持有。本集團一經向強積金計劃供款，有關僱主供款即全數歸僱員所有。

本集團於中國內地經營的附屬公司的僱員須參與地方市政府營運的中央退休金計劃。該等附屬公司須就中央退休金計劃作出供款，金額為其工資成本的若干百分比。供款於根據中央退休金計劃的規則須予支付時自損益表扣除。

#### Revenue recognition

##### Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

Revenue from the sale of printed circuit boards is recognised at the point in time when control of the asset is transferred to the customer, generally on delivery of the printed circuit boards.

##### Revenue from other sources

Rental income is recognised on a time proportion basis over the lease terms. Variable lease payments that do not depend on an index or a rate are recognised as income in the accounting period in which they are incurred.

##### Other income

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

##### Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

##### Dividends

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting. Proposed final dividends are disclosed in the notes to the financial statements.

Interim dividends are simultaneously proposed and declared, because the Company's memorandum and articles of association grant the directors the authority to declare interim dividends. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared.

#### 收益確認

##### 來自客戶合約之收益

當向客戶轉移貨物或服務的控制權，獲取金額反映本集團預期就交換該等貨物或服務有權獲得的代價，客戶合約收益即獲確認。

銷售印刷电路板的收益在資產控制權轉移給客戶的時間點確認，通常在交付印刷电路板時確認。

##### 其他來源的收益

租金收入於租期內按時間比例基準確認。並非取決於指數或利率之可變租賃付款於產生之會計期間內確認為收入。

##### 其他收入

利息收入以應計基準，採用實際利率法按估計於財務工具的預計年期或於適當時按更短期間內所得未來現金收入準確折現至該財務資產賬面淨值的折現率計算。

##### 借款成本

收購、興建或生產合資格資產(即須經一段長時間作準備方可作擬定用途或銷售的資產)直接產生的借款成本，撥充資本作為該等資產之部分成本。當有關資產大致可作擬定用途或銷售時，即終止將該等借款成本撥充資本。所有其他借款成本均於其產生期間支銷。借款成本包括利息及與實體因借取資金而產生的其他成本。

##### 股息

末期股息於股東大會獲股東批准時確認為負債。建議末期股息於財務報表附註中披露。

中期股息於建議同時宣派，此乃由於本公司的章程大綱及細則已授權董事宣派中期股息。因此，中期股息於建議及宣派時即時確認為負債。

#### Foreign currencies

These financial statements are presented in Hong Kong dollars, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

The functional currencies of certain overseas subsidiaries are currencies other than the Hong Kong dollar. As at the end of the reporting period, the assets and liabilities of these entities are translated into Hong Kong dollars at the exchange rates prevailing at the end of the reporting period and their statements of profit or loss are translated into Hong Kong dollars at the exchange rates that approximate to those prevailing at the dates of transactions. The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve. On disposal of a foreign operation, the component of other comprehensive income relating to that particular foreign operation is recognised in the statement of profit or loss.

For the purpose of the consolidated statement of cash flows, the cash flows of overseas subsidiaries are translated into Hong Kong dollars at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of overseas subsidiaries which arise throughout the year are translated into Hong Kong dollars at the weighted average exchange rates for the year.

#### 外幣

財務報表以本公司的功能貨幣港元列示。本集團旗下各公司自行選擇功能貨幣，而各公司的財務報表項目均以各自的功能貨幣計量。本集團轄下實體錄得的外幣交易初次按交易日的匯率以有關實體的功能貨幣列賬。以外幣計值的貨幣資產及負債按功能貨幣於呈報期末的匯率換算。貨幣項目結算或換算產生的差額於損益表確認。

以外幣按歷史成本計算的非貨幣項目以首次交易日的匯率換算，以外幣按公平值計量的非貨幣項目以計量公平值當日的匯率換算。換算按公平值計量的非貨幣項目產生的收益或虧損與該項目公平值變動產生的收益或虧損確認方式一致，即公平值收益或虧損於其他全面收益或損益確認之項目之匯兌差額亦相應於其他全面收益或損益確認。

若干海外附屬公司的功能貨幣並非港元。於報告期末，該等實體的資產與負債，按報告期末通行的匯率換算為港元，其損益表則按與交易日期現行匯率相若之匯率換算為港元。因此而產生的匯兌差額於其他全面收益確認並於匯兌波動儲備累計。出售海外業務時，與該項海外業務有關之其他全面收益的組成部份，會在損益表中確認。

就綜合現金流量表而言，海外附屬公司之現金流量乃以現金流量日期之適用匯率換算為港元。海外附屬公司於年內產生之經常性現金流量乃按年度加權平均匯率換算為港元。

### 3. SIGNIFICANT ACCOUNTING JUDGEMENTS AND ESTIMATES

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

#### Judgements

In the process of applying the Group's accounting policies, management has made the following judgements, apart from those involving estimations, which have the most significant effect on the amounts recognised in the financial statements:

#### Determination of functional currency

In determining the functional currency of each entity of the Group, judgement is required to determine and consider the currency that mainly influences sales prices of goods; the currency that mainly influences costs of providing goods; the currency in which funds from financing activities are generated; and the currency in which receipts from operating activities are usually retained, etc. The functional currency of each entity is determined based on management's assessment of the primary economic environment in which the entities operate. When the indicators are mixed and the functional currency is not obvious, management uses its judgement to determine the functional currency that most faithfully represents the economic effects of the underlying transactions, events and conditions.

#### Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

編製本集團的財務報表時要求管理層作出影響收益、開支、資產及負債呈報金額及其附帶披露的判斷、估計及假設，並須披露或然負債。該等假設及估計的不明朗因素可能導致須於未來對受影響的資產或負債的賬面值作出重大調整。

#### 判斷

於應用本集團的會計政策過程中，除涉及估計數額的判斷外，管理層作出以下對在財務報表中已確認數額有重大影響的判斷：

#### 釐定功能貨幣

在釐定本集團各實體的功能貨幣時，需判斷釐定及考慮主要影響貨品的銷售價格的貨幣；主要影響提供貨品成本的貨幣；融資活動資金的貨幣；及營運活動通常所收取的貨幣。各實體的功能貨幣取決於管理層對實體營運所在的主要經濟環境的評估。倘各指示混合及功能貨幣不明顯，則管理層利用判斷釐定最能準確代表基本交易、事件及條件的經濟效果的功能貨幣。

#### 估計不明朗因素

涉及將來及報告期末的其他主要估計不確定性來源並很有可能引致資產及負債賬面值於下一財政年度內大幅調整的主要假設在下文闡述。

#### Estimation uncertainty (continued)

##### Measurement of an unlisted equity investment at fair value

The fair value of an unlisted equity investment that is not traded in an active market is estimated by management with reference to valuation performed by an independent professionally qualified valuer by using valuation technique that requires various sources of information and assumptions. The carrying amount of the Group's unlisted equity investment at 31 December 2022 was HK\$4,019,000 (2021: HK\$4,440,000).

##### Estimation of fair value of investment properties

In the absence of current prices in an active market for similar properties, the Group considers information from a variety of sources, including:

- (a) current prices in an active market for properties of a different nature, condition or location, adjusted to reflect those differences; and
- (b) recent prices of similar properties on less active markets, with adjustments to reflect any changes in economic conditions since the date of the transactions that occurred at those prices.

The carrying amount of investment properties at 31 December 2022 was HK\$26,868,000 (2021: HK\$29,293,000). Further details, including the key assumptions used for fair value measurement are given in note 14 to the financial statements.

##### Write-down of inventories to net realisable value

The Group performs regular review of the carrying amount of inventories to determine whether any write-down of inventories to net realisable value is required after considering, inter alia, the ageing analysis of the Group's inventories, current market conditions and the expected future sales of goods and usage of materials. Write-down of inventories will be made when the estimated net realisable values of inventories decline below their carrying amounts. Net realisable values of inventories are based on estimated selling prices less any estimated costs to be incurred to completion and disposal. These estimates are made with reference to the current market conditions and the historical experience of manufacturing and selling products of a similar nature. Actual selling prices and saleability/usage of goods/materials might be different from estimations and profit or loss could be affected by differences in the estimations.

#### 估計不明朗因素(續)

##### 按公平值列賬的非上市股權投資的計量

並無於活躍市場買賣的非上市股權投資的公平值由管理層參考獨立專業合資格估值師使用涉及多項資料來源及假設之估值技巧進行的估值進行估計。本集團非上市股權投資於二零二二年十二月三十一日的賬面值為4,019,000港元(二零二一年：4,440,000港元)。

##### 投資物業的公平值估計

倘若類似物業並無活躍市場的現行價格可作參考，本集團會考慮來自不同來源的資料，包括：

- (a) 不同性質、狀況或地點的物業在活躍市場上的現行價格，並作出調整以反映上述差異；及
- (b) 類似物業於活躍程度稍遜市場的最近期價格，並作出調整以反映自交易按有關價格進行的日期起出現的任何經濟狀況變動。

於二零二二年十二月三十一日，投資物業的賬面值為26,868,000港元(二零二一年：29,293,000港元)。進一步詳情(包括用作公平值計量的主要假設)載於財務報表附註14。

##### 撇減存貨至可變現淨值

本集團定期審閱其存貨賬面值，當中經考慮(其中包括)本集團的存貨的賬齡分析、當前市況及產品預期未來銷售及材料用途，以釐定是否撇減存貨至可變現淨值。倘存貨可變現價值淨值下降到其賬面值以下，則會撇減存貨。存貨的可變現淨值乃根據估計售價減任何估計完成及出售將會產生的成本計算。該等估計乃參照當前市況以及製造及銷售相似性質產品的歷史經驗作出。貨品/物料實際售價及銷售能力/使用可能異於估計，而損益可能受估計差異影響。

##### Leases — Estimating the incremental borrowing rate

The Group cannot readily determine the interest rate implicit in a lease, and therefore, it uses an incremental borrowing rate (“IBR”) to measure lease liabilities. The IBR is the rate of interest that the Group would have to pay to borrow over a similar term, and with a similar security, the funds necessary to obtain an asset of a similar value to the right-of-use asset in a similar economic environment. The IBR therefore reflects what the Group “would have to pay”, which requires estimation when no observable rates are available (such as for subsidiaries that do not enter into financing transactions) or when it needs to be adjusted to reflect the terms and conditions of the lease (for example, when leases are not in the subsidiary’s functional currency). The Group estimates the IBR using observable inputs (such as market interest rates) when available.

##### Provision for expected credit losses on trade and bills receivables

The Group uses a provision matrix to calculate ECLs for trade and bills receivables. The provision rates are based on days past due for groupings of various customer segments that have similar loss patterns.

The provision matrix is initially based on the Group’s historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

The assessment of the correlation among historical observed default rates, forecast economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forecast economic conditions. The Group’s historical credit loss experience and forecast of economic conditions may also not be representative of a customer’s actual default in the future. The information about the ECLs on the Group’s trade and bills receivables is disclosed in note 18 to the financial statements.

#### 估計不明朗因素(續)

##### 租賃 — 估算增量借款利率

本集團無法輕易釐定租賃內所隱含的利率，因此使用增量借款利率（「增量借款利率」）計量租賃負債。增量借款利率為本集團於類似經濟環境中為取得與使用權資產價值相近之資產，而以類似抵押品與類似期間借入所需資金應支付之利率。因此，增量借款利率反映了本集團「應支付」的利率，當無可觀察的利率時（如就並無訂立融資交易之附屬公司而言）或當須對利率進行調整以反映租賃之條款及條件時（如當租賃並非以附屬公司之功能貨幣訂立時），則須作出利率估計。當可觀察輸入數據可用時，本集團使用可觀察輸入數據（如市場利率）估算增量借款利率。

##### 貿易應收款項及應收票據的預期信貸虧損撥備

本集團使用撥備矩陣以計算貿易應收款項及應收票據的預期信貸虧損。撥備率乃基於不同客戶分部組別的欠款逾期日數而定，該等客戶分部的虧損模式相似。

撥備矩陣乃初始基於本集團的過往可觀察違約比率。本集團將按經前瞻性資料調整的過往信貸虧損經驗調節該矩陣。於各報告日期，本集團更新過往可觀察違約比率及分析前瞻性估計的變動。

##### Deferred tax assets

Deferred tax assets are recognised for unused tax losses to the extent that it is probable that taxable profits will be available against which the tax losses can be utilised. Recognition of deferred tax assets primarily involves management judgement and estimations regarding the taxable profits of the entities in which the losses arose. Significant management judgement is required to determine the amount of deferred tax assets that can be recognised, based upon the likely timing and level of future taxable profits together with future tax planning strategies.

Hong Kong profits tax has been provided at the rate of 16.5% (2021: 16.5%) on the estimated assessable profits arising in Hong Kong during the year, except for one subsidiary of the Group which is a qualifying entity under the two-tiered profits tax rates regime. The first HK\$2,000,000 (2021: HK\$2,000,000) of assessable profits of this subsidiary are taxed at 8.25% (2021: 8.25%) and the remaining assessable profits are taxed at 16.5% (2021: 16.5%). Taxes on profits assessable elsewhere have been calculated at the rates of tax prevailing in the jurisdictions in which the Group operates.

The provision for land appreciation tax has been estimated according to the requirements set forth in the relevant PRC laws and regulations. Land appreciation tax has been provided at ranges of progressive rates of the appreciation value, with certain allowable deductions.

All subsidiaries of the Group established in the PRC are subject to PRC corporate income tax at a standard rate of 25% (2021: 25%) during the year, except for a subsidiary of the Group which qualified as a High and New Technology Enterprise in Mainland China and a lower PRC corporate income tax rate of 15% (2021: 15%) has been applied for the year.

### 21. ASSETS CLASSIFIED AS HELD FOR SALE

Yan Tat (HK) Industrial Limited (“YT Industrial”) is an indirect wholly-owned subsidiary of the Company. On 8 May 2020, the Group entered into, amongst others, a cooperation agreement (the “Cooperation Agreement”) with certain independent third parties, pursuant to which the relevant parties have conditionally agreed to cooperate in connection with an urban renewal project, which comprises of certain arrangements involving certain target land parcels and related premises currently owned by the Group. The Cooperation Agreement and the transactions contemplated thereunder (the “Transactions”) were approved by the shareholders of the Company at an extraordinary general meeting held on 14 July 2020. Further details of the Cooperation Agreement and the Transactions are also set out in the Company’s announcements dated 15 May 2020, 14 July 2020, 24 June 2022, 14 October 2022 and 1 December 2022, and the Company’s circular dated 24 June 2020 (the “circular”).

Pursuant to the Cooperation Agreement, in respect of one of the target land parcels and the buildings erected thereon (the “Target Land and Buildings”) currently owned by a subsidiary of YT Industrial, the Group shall sell the entire equity interest in YT Industrial (the “Disposal of YT Industrial”). As at 31 December 2022, as Urban Renewal Approval (as defined in the circular) has not yet been obtained, the Disposal of YT Industrial has not been materialised. In the opinion of the directors, notwithstanding certain delays, the Disposal of YT Industrial, including the relevant underlying assets in accordance with terms of the Cooperation Agreement (the “Relevant Assets”), is expected to be completed within one year from 31 December 2022. Accordingly, the Relevant Assets (including the Target Land and Buildings) were classified as held for sale as at 31 December 2022.

The Company operates a share option scheme (the "Scheme") for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group's operations. The Scheme became effective on 18 November 2014 and, unless otherwise cancelled or amended, will remain in force for ten years from that date.

Any grant of share options to a director, chief executive or substantial shareholder of the Company or any of their respective associates, is required to be approved by the independent non-executive directors. In addition, any grant of share options to a substantial shareholder or an independent non-executive director of the Company or any of their respective associates, in excess of 0.1% of the shares of the Company in issue at any time or with an aggregate value (based on the closing price of the Company's shares at the date of grant) in excess of HK\$5 million, within any 12-month period, is subject to shareholders' approval in advance in a general meeting.

The offer of a grant of share options may be accepted within the date as specified in the offer letter issued by the Company, upon payment of a nominal consideration of HK\$1 in total by the grantee. The exercise period of any option granted under the Scheme is determined by the board of directors in its absolute discretion, save that no option may be exercised more than ten years after it has been granted.

The exercise price of share options is determinable by the board of directors at its absolute discretion, but may not be less than the higher of (i) the closing price of the Company's shares on the date of grant; (ii) the average of the closing prices of the Company's shares for the five business days immediately preceding the date of grant; and (iii) the nominal value of the shares on the date of grant.

#### Foreign currency risk

The Group has transactional currency exposures. Those exposures arise from sales or purchases by operating units in currencies other than the units' functional currencies. The Group's main operating subsidiaries are located in Hong Kong and Mainland China and the Group's sales and purchases were mainly conducted in HK\$, RMB and US\$.

The RMB is not a freely convertible currency. Future exchange rates of the RMB could vary significantly from the current or historical exchange rates as a result of the changes in the PRC foreign currency policy. The exchange rates may also be affected by economic developments and political changes domestically and internationally, and the demand and supply of the RMB. The appreciation or devaluation of RMB against HK\$ and US\$ may have an impact on the operating results of the Group.

The following table demonstrates the sensitivity at the end of the reporting period to a reasonably possible change in the RMB exchange rates, with all other variables held constant, of the Group's profit before tax (arising from US\$ and HK\$ denominated financial instruments). There is no impact on the Group's equity except on the retained profits.

The Group's policies are to regularly monitor the current and expected liquidity requirements, and to ensure that it maintains sufficient reserves of cash and available banking facilities to meet its liquidity requirements in the short and longer term.

#### Capital management

The primary objectives of the Group's capital management are to safeguard the Group's ability to continue as a going concern and to maintain healthy capital ratios in order to support its business and maximise shareholders' value.

The Group manages its capital structure and makes adjustments to it in light of changes in economic conditions. To maintain or adjust the capital structure, the Group may adjust the dividend payment to shareholders or raise new capital from its investors. The Group is required to comply with certain externally imposed capital requirements set out in certain of its bank loan agreements/bank facility letters. No changes were made in the objectives, policies or processes for managing capital during the years ended 31 December 2022 and 31 December 2021.

The Group monitors capital using a gearing ratio, which is total debt divided by total equity. Total debt includes interest-bearing bank borrowings.
