**POS**<sup>(1)</sup> in 33 cities in the Greater China Region<sup>(2)</sup>





### CHAIRMAN'S STATEMENT

I am pleased to present to shareholders (the "Shareholders") the annual report of Casablanca Group Limited (the "Company") and its subsidiaries (together the "Group") for the year ended 31 December 2023 (the "Year" or the "Review Period").

In 2023, we celebrated the 30th anniversary of the Group. We are grateful to the continuous support from our customers in the past three decades, having our products of its proprietary "Casablanca", "Casa Calvin" and "CASA-V" brands become an important part of their lives in many households in Hong Kong, and we thrived together. During the Review Period, we launched different campaigns for our anniversary and new TV commercials and bus body promotions themed "DREAM CASA LOVE CASA - 30 Years of Art and Crafts" to spotlight the Group's image and its brand positioning. 2023 also marked the 10th anniversary of us moving our production base into the Casablanca Industrial Park in Huizhou, the PRC, complemented by the opening of our long-awaited new building B under phase II of Casablanca Industrial Park. The new building B now serves as the base of the Group's new livestream sales business, and was named the "Huizhou, Hong Kong, Macao, Taiwan and Overseas Chinese Digital Entrepreneurship Livestreaming Base" (惠州港澳台僑數字創 業直播基地) by the United Front Work Department of the Huizhou Municipal Committee of the Communist Party of China (中共惠州市委統一戰線工作部) for contributing to the development of technologically innovative industries of the opportunities arising from the return to normalcy and resumption of economic development in the Greater China Region (for the purpose of this report, comprising Mainland China, Hong Kong and Macau) after the novel coronavirus disease pandemic ("COVID-19").

It has been about 20 years since the Group entered the Mainland China market. During that period, we have seen various complex and rapid changes in the market, such as the consumption upgrades and transformation of shopping habits of consumers. Understanding deeply to the operating difficulties in the Mainland China market, the Group will strive to enhance its competitiveness to effectively adapt to the ever-changing operating environment. With livestream sales gaining popularity fast in Mainland China in recent years, the Group has timely commenced its livestream sales business and made revenue from it in 2023.

The global economy, however, was overshadowed by uncertainties in 2023. Consumer confidence in the Greater China Region was low, presenting an operating environment no easier than that when COVID-19 was raging. During the Review Period, operating revenue of the Group decreased by approximately 5.4% to approximately HK\$284.1 million compared to HK\$300.2 million for the corresponding period of 2022. Loss attributable to owners of the Company for the Year amounted to approximately HK\$4.6 million, as compared to the profit attributable to owners of the Company of HK\$5.4 million for the corresponding period of 2022. Since it will take time for the retail market to recover and taking into account the Company's plan to increase capital investment in livestream sales business and in developing technological sleeping products, the board of directors of the Company (the "Board") does not recommend payment of a final dividend for the Year, for the purpose of maintaining an adequate cash reserve for coping with unanticipated requirements ahead and meeting future business development needs.

Although the COVID-19 pandemic had ended, the overall Hong Kong economy and local retail sentiment have not revived as expected. Together with the trend for Hong Kong citizens to travel to and consume in Mainland China, the flow and consumer market in Hong Kong were markedly affected. Apart from offering high-quality products and attentive services to maintain customers' trust of our brands, we are pleased to have grasped the opportunities of Hong Kong residents shopping up north in the beginning of 2024 and collaborate with a renowned Hong Kong travel agency to offer group tours to Mainland China tying in with visits to the Casablanca Industrial Park in Huizhou. During the visit, members of the tour group can appreciate the brand and the high-quality products it stands for, plus understand related manufacturing and quality control processes. The initiative is expected to help improving the loyalty of Hong Kong customers to our brand and also attract new customer groups, conducive ultimately to raising our brand image in the long run. We will pay close attention to changes in consumption habits and adjust our sales channels and promotional strategies timely, so as to grasp the opportunities brought by every challenge.

"Contemporary, Innovative and Functional" are what we insist on in product design. What's more is the Group's commitment to provide quality products and attentive customer services. We endeavour to become the "Healthy Sleeping Expert" for every customer, and to do so, we have been tireless in developing products that embody green concepts and health enhancing functions. As a leading company in the home textile industry, we have been striving to look for materials that can improve the sleep quality of our customers to use in our products. With the elderly population growing in the Greater China Region, the market is paying more attention to the booming "silver economy". Heeding that and consumers' growing crave for health technology-embedded products, the Group has established the "Peprobio - Casablanca Health Research Centre" jointly with China Peprobio Institute of Life Science at the beginning of 2024 to embark on research, development and applications of healthy sleeping, sleep and anti-aging related products, planning to launch a collection of sleep-related innovative products and other home accessories in the future.

The Group will stay alert to the changes in the market and consumer preferences and needs, and respond by developing, with innovation and the help of technologies, more products that can improve sleep quality of people, while also promoting environmentally friendly lifestyle for the good of the global environment that it cares about. We will work hard to provide consumers with more bedding products of fashionable designs, fine craftsmanship and with health enhancing functions through diverse sales channels, both online and offline.

On behalf of the Board, I would like to extend my sincere gratitude to our valued customers, business partners and Shareholders for their unwavering support and trust in the Company. My appreciation also goes to the management team and our employees for their contribution to the development of the Group. Lastly, I wish all stakeholders of the Group good health.

### **Overview**

In 2023, while the Russia-Ukraine war dragged on, an armed conflict broke out between Israel and Palestine in the second half of the Year. Geopolitical tensions together with interest rate hike, inflation, steeper prices of energy and food, and other unfavourable factors weighed heavily on consumer confidence in the Greater China Region. Although the COVID-19 pandemic had come to an end, the global economy did not improve notably in the Year, with exports from the Greater China Region dropping. In addition, the recovery of Mainland China economy, which was intended to be driven by domestic demand, was happening slower than expected, which further dampened consumer confidence in the Greater China Region. As for the Hong Kong market, after the inbound and outbound quarantine measures were lifted, the number of visitors from Mainland China to Hong Kong rebounded slowly, while the number of Hong Kong citizens travelling to and consuming overseas or in Mainland China markedly increased. Customer traffic and retail business at shopping malls in Hong Kong did not return as originally anticipated. Although various measures were introduced by the government to promote local consumption and attract tourists to the city, shopping mall patronage and business of department stores did not rebound to pre-pandemic levels. Moreover, with the government stopping to give enterprises COVID-19 related subsidies in 2023 as it did for the past two years, retail enterprises in Hong Kong were facing serious operational pressure.

#### **Business Review**

There was no material change in the Group's operational and segmental information since it announced interim results for the six months ended 30 June 2023. During the Review Period, total sales revenue of the Group amounted to approximately HK\$284.1 million, representing a decrease of approximately 5.4% as compared to HK\$300.2 million for the corresponding period of 2022. Loss attributable to owners of the Company for the Review Period amounted to approximately HK\$4.6 million, as compared to profit attributable to owners of the Company of HK\$5.4 million for the corresponding period of 2022. The turnaround from profit to loss attributable to the Shareholders was mainly attributable to (a) the increase in selling and distribution costs, which was primarily due to the increase in staff costs and promotion fees incurred for the development and operation of livestream sales business in Mainland China; (b) decreases in other income/gains including the absence of COVID-19 related grants in the wake of the Hong Kong government terminating the Employment Support Scheme launched in 2022, and the decrease in gain on disposal of property, plant and equipment in 2023; and (c) the impairment loss on investment properties, despite the decrease in exchange losses and the reversal of provisions for inventories and trade receivables in 2023.

The non-wholly owned subsidiary of the Group, namely, Casa Living New Retail (Guangdong) Co., Ltd. \* (卡撒生活新 零售(廣東)有限公司 and "Casa Living") formed in 2022 for livestream sales business, was at loss for the Year and not in satisfaction of the performance targets as anticipated.

#### **Optimised Sales Channels**

For online retail business, themed promotional offers were launched from time to time in the Group's Hong Kong official online store during the Review Period, which were very well received by customers. In Mainland China, on top of putting most of its resources on managing self-operated online stores on well-known platforms as TMall and JD.com, the Group also organised several large-scale livestream sales activities during the Review Period via Casa Living. Such activities were also well-received by consumers in Mainland China. During the Review Period, revenue from e-sales significantly increased by 53.9% as compared to that of 2022.

As at 31 December 2023, the Group had a total of 156 physical points-of-sale ("POS") (31 December 2022: 205), of which 114 were self-operated and 42 were operated by distributors, covering a total of 33 cities in the Greater China Region. During the Review Period, sales of the Group's self-operated retail operation declined by 6.3% year-on-year due to consumers in Hong Kong and Mainland China becoming more cautious in spending in the weak retail market. There were 61 less distributor-operated POS for the Review Period mainly because some less capable distributors were ousted in the difficult business environment. At the same time, the Group sought to improve distributor business by consolidating resources and adjusting relevant strategies. As the Group continuing to cooperate with adept distributors and arrange effective promotional events, sales from distribution for the Review Period was down by 13.9% year-on-year.

During the Review Period, the Group supplied items to various commercial customers in Hong Kong, including convenience stores, electrical appliance chain stores, public utility companies and personal care products brands, for their giveaway campaigns and point redemption schemes. In addition, the Group provided original equipment manufacturing (OEM) products to various customers. During the Review Period, sales to wholesale customers decreased by 29.4% year-on-year, due to the absence of large wholesale orders in Hong Kong as in the corresponding period last year. Export business was affected by geopolitical situations and interest rate hike, thus revenue from other countries decreased by 93.9% as compared to the corresponding period last year.

#### **Enhanced Product Mix**

At the beginning of 2023, the Group launched the "AI Ecological Pillow" that has "HarmonyOS Connect Ecological Product Technology Certification" in the Mainland China market. Equipped with an intelligent monitoring module for 24-hour sleep status tracking and an adjustable airbag, the product can transmit data collected to mobile applications via NFC to allow users to adjust the height of the pillow to suit their personal needs. In July 2023, with guests of a hotel in Huizhou invited to take part in a product trial, the "AI Ecological Pillow" gained greater popularity.



For the mattress business, the Group actively participated in various exhibitions in department stores and shopping malls in Hong Kong during the Review Period to enhance brand awareness of its "Casa Sleep-Lab Earth Mantle Series" mattress products and received positive market response. During the Review Period, the Group also launched three pillow products under the "Casa Sleep-Lab" brand to meet different needs of consumers.

Being aware of the strong appeal of products featuring cartoon characters to consumers in the Greater China Region, the Group has worked hard on designing such products, seeing it as a key business to develop. For the Review Period, sales of licensed and authorised brand products decreased by 16.7% year-on-year due to the decrease in sales in Hong Kong and Macau. In addition to launched new products with pet cartoons designed in-house by the Group for "The Beloved Series", the Group owns bedding product licences for a number of popular cartoons. New licensed cartoon bedding products launched during the Review Period included "Kakao Friends", "BT21", "Chibi Maruko Chan", "Pokemon", "PEANUTS", "LuLu the Piggy" and "Crayon Shin-chan". Apart from "Chubby Ojisan", a well-loved cartoon character from Taiwan, the Japanese anime character "Chiikawa", the internationally renowned cartoon series "SPY×FAMILY" were added to the authorised cartoon product portfolio, and the licences for "The Moomins" and "Fumeancats", popular among consumers, were again secured.

#### **30th Anniversary Brand Promotion**

To celebrate the 30th anniversary of the Casablanca brand in Hong Kong and show support to young people in developing their creativity, the Group jointly organised a bedding product pattern design competition with the School of Fashion and Textiles of the Hong Kong Polytechnic University and Cotton Incorporated in the first quarter of 2023. The winning pattern design named "Technology in Nature" ingeniously integrated the themes of technology and environmental protection, which not only coincided with the "Innovative, Contemporary and Functional" product design concept the Group embraces, but also let people appreciate the Group's effort to promote environmental technology-embedded sleeping space. The winning design has been used in products launched to market since the third quarter of 2023. During the Review Period, the Group mounted different online and offline promotional campaigns tying in with its anniversary and launched new TV commercials and bus body promotions themed "DREAM CASA LOVE CASA - 30 Years of Art and Crafts", relaying the message of how the fashionable and high-quality bedding products of the Group had accompanied Hong Kong consumers in every important stage of their lives in the past three decades.

The Group supports sustainable development and has been earnestly shouldering its corporate social responsibility. During the Review Period, it was awarded the "Supply Chain Partner Award" by its long-term cooperation partner Cotton Incorporated. Additionally, the pure cotton products manufactured by the Group were given the "Seal of Cotton™" and "Cotton LEADS<sup>SM</sup>" trademarks, proofs of its products being made with high-quality and sustainably produced cotton to offer comfortable and environmental-friendly sleeping experience to consumers. The Group also received the "Outstanding Partner in China Award" and the "Zero Carbon Piloting Award" from its long-term partner Lenzing Group, a world-leading wood-based fibres and yarns manufacturer in Austria. The Group has been using extensively the sustainably produced TENCEL<sup>™</sup> fibres of its partner in production, and supportive of TENCEL<sup>™</sup> brand's vision of realising net zero emissions by 2025, it encourages consumers to practise environmental protection in their home.

#### **Prospects**

In 2024, the war in Israel and its surrounding areas continues, and the US presidential election and the European Parliament election will be held subsequent to the Russian presidential election in mid-March. The global economic and political uncertainty is expected to continue and affect consumer confidence in the Greater China Region. Although the three-year-long COVID-19 pandemic had come to an end, the Mainland China economy has been recovering rather slowly and the people are more inclined to save money. Early this year, the National Development and Reform Commission issued a document stating that different relevant macro policies will be implemented in the future, with the aims of synchronising residents' income and economic growth, and restoring consumption confidence. Thus, the Company is cautiously optimistic about the release of consumption power in the Greater China Region in the future.

#### **Mainland China**

For its physical self-operated retail sales, the Group will focus on expanding the Shenzhen market, primarily via opening stores in shopping centres or street stores at suitable locations, to achieve the goal of adding 10 to 15 self-operated POS in 2024. It will also focus on growing distributor business in Guangdong by inviting business partners to set up more distributor-operated POS in the province. It will continue to identify opportunities for cross-industry alliance or brand cooperation, like setting up co-branded stores, that can bring synergistic benefits to the Group and its brand partners. In 2024, the Group will proactively enhance wholesale business in Mainland China to bolster related revenue, including grasping opportunities to supply products to corporations with nationwide presence and providing bedding products of unique designs and with health enhancing functions to corporate customers.

As for online business, the Group will continue to optimise its retail business on traditional e-commerce platforms, including retrieving some of the online stores to manage and operate by itself, while commencing sales business on more e-commerce platforms. Livestream sales business will be operated in Mainland China with adjusted strategies in 2024. The Group plans to leverage popular social media platforms like "Douyin in the South and Kuaishou in the North" to foster growth of livestream sales business.

On the product front, at the start of 2024, the Group has jointly established the "Peprobio - Casablanca Health Research Centre" with China Peprobio Institute of Life Science to pursue research and development and application of healthy sleeping and anti-aging related products, targeting to transform relevant research and development achievements into healthy sleeping-related products in 2024.

#### Hong Kong

In Hong Kong, since the government lifted COVID-19 related inbound and outbound quarantine measures in 2023, more and more Hong Kong citizens are making trips to Mainland China to spend. At the beginning of 2024, Wing On Travel, an established travel agency in Hong Kong, organised tour groups in Huizhou and provided Hong Kong tourists in the groups with products of the Company as gifts for trying out, and they also visited the Casablanca Industrial Park in Huizhou to learn about the development history of both the Casablanca brand and healthy sleeping products, and purchase the Group's products on the spot. As the group tours have been well-received, Wing On Travel will continue to organise them till the end of April 2024. The initiative is expected to contribute positively to the sales revenue and brand image of the Company, as well as attract to it new customer groups.

Upholding the core concept of "Innovative, Contemporary and Functional" in product design, the Group has been providing customers with comfortable sleeping products with health enhancing functions. It plans to launch new products made of new technological materials in the first half of 2024 to match the need of consumers to replace home accessories before Hong Kong starts charging for disposal of municipal solid waste on 1 August 2024. Additionally, authorised cartoon products as one of major revenue stream the Group will continue to optimise the relevant product portfolio, so as to offer consumers not only choices of products featuring classic cartoon characters, but also those of latest popular cartoon icons. The Group has plans to launch promotional activities of different cartoon themes through diverse sales channels in 2024 to drive sales growth.


Adhering to its "Contemporary, Innovative and Functional" design concept, the Group strives to integrate sustainable growth, environmental protection and social responsibility, in its business strategies to provide consumers with quality bedding products of fashionable designs and at reasonable prices, and home accessories that are trendy yet practical and beneficial to society. It will also continue to broaden its revenue streams and enhance its brand value so as to bring satisfactory returns to Shareholders in the long run.



### Financial Review Revenue

For the Year, the Group recorded revenue of HK\$284.1 million (2022: HK\$300.2 million), representing a decrease of 5.4%. The decrease in revenue was primarily attributable to the decline of sales in Hong Kong and Macau as result of the weak consumer sentiment under the slow post-pandemic recovery of economy, despite the improvement in sales in Mainland China.



Self-operated retail sales for the Year accounted for 71.3% of the total revenue and represented a decrease of 6.3% as compared to 2022. The decrease in self-operated retail sales was attributable to the weak consumer sentiment in Hong Kong under the slow post-pandemic recovery of economy. With a few successful livestream sales activities held in Mainland China during the Year, e-sales increased significantly by 53.9% as compared to 2022. The decrease in sales to distributors by 13.9% for 2023 was mainly attributable to the reduction in number of distributor-operated POS in Mainland China and the decrease in sales to distributors in Macau. With the lack of a one-off large scale wholesales in Hong Kong and the decrease in export sales during the Year, sales to others for 2023 recorded a significant decrease of 44.0% as compared to 2022.





Casablanca, Casa Calvin and CASA-V are our major proprietary brands. With the contribution by livestream sales of products with proprietary brands in Mainland China, the sales of proprietary brands during the Year was slightly decreased by 3.4% as compared to 2022. The decrease of 16.7% in sales of our licensed and authorized brands for 2023 was mainly attributable to the decrease in sales in Hong Kong and Macau.



Bed linens and duvets and pillows are major products of the Group. The decrease in sales of bed linens and duvets and pillows for 2023 was primarily due to the decrease in overall sales during the Year. The increase in sales of others for 2023 was attributable to more home accessories and other products being sold under livestream sales during the Year.

Revenue from Hong Kong and Macau for 2023 decreased by 13.8% as compared to 2022, which was primarily due to the decreases in retail sales and wholesales in Hong Kong. The increase in revenue from Mainland China by 41.6% for 2023, when compared to 2022, was attributable to increases in sales through self-operated retail sales and e-sales, especially livestream sales, in Mainland China. Revenue from others for 2023 significantly decreased due to lack of purchase orders from some of our export customers.



#### Gross Profit and Gross Profit Margin

Gross profit increased by 2.9% to HK\$192.1 million for 2023 as compared to HK\$186.8 million for 2022. The gross profit margin for 2023 was 67.6% which was higher than 62.2% for 2022. The higher gross profit margin for 2023 was mainly due to the reversal of allowance for inventories amounted to HK\$4.1 million (2022 allowance: HK\$4.2 million) included in cost of goods sold with improvement in stock aging status at 31 December 2023 and the increase in proportion of e-sales for 2023 which were at higher margin.

#### **Other Income**

Other income for the Year significantly decreased by 37.4% to HK\$4.1 million (2022: HK\$6.5 million). The decrease during the Year was mainly due to the absence of subsidies of about HK\$4.5 million received from governments of Hong Kong and Mainland China primarily in relation to COVID-19 as in 2022 despite increases in interest income by HK\$0.6 million and rental income by HK\$1.2 million for the Year.

#### **Other Losses**

Other losses for the Year amounted to HK\$3.8 million (2022: HK\$2.3 million), mainly representing net exchange loss of HK\$0.9 million (2022: HK\$5.8 million), net loss on disposal of property, plant and equipment of HK\$0.2 million in total (2022 net gain on disposal: HK\$4.0 million), impairment loss of HK\$2.5 million (2022: nil) and net loss on FVTPL of HK\$1.3 million (2022: HK\$0.1 million) offsetting against reversal of loss allowance on trade receivables of HK\$1.0 million (2022 loss allowance: HK\$0.4 million).

#### **Operating Expenses**

Selling and distribution costs for the Year increased by 13.5% to HK\$153.6 million (2022: HK\$135.3 million). The increase was mainly due to the increased staff costs and promotional expenses incurred in the course of developing and conducting the livestream sales business in Mainland China.

Administrative expenses for the Year were HK\$46.7 million (2022: HK\$46.7 million) at similar level as 2022.

#### Taxation

The Group's effective tax rate for 2023 was -4.9% as compared to 40.9% for 2022. The negative effective tax rate for 2023 was mainly due to operating losses of subsidiaries in the PRC exceeding operating profit of subsidiaries in Hong Kong, while the effective tax rate was calculated with non-taxable subsidies and gains offsetting against operating losses of subsidiaries in the PRC and other non-tax deductible expenses. Had these subsidies, operating losses, the loss allowances on trade and other receivables and inventory, the non-deductible share-based payments and the exchange loss for 2023 and 2022 been excluded, the adjusted effective tax rate would be approximately 15.7% for 2023 and 16.4% for 2022.

#### Loss for the Year

The Group recorded loss of HK\$9.5 million for 2023 (2022 profit: HK\$4.6 million). By excluding the loss attributable to non-controlling interests, the Group's loss attributable to the Shareholders for 2023 was HK\$4.6 million (2022 profit: HK\$5.4 million) which included the loss of Casa Living amounted to approximately HK\$5.0 million (2022: HK\$0.8 million) attributable to the Shareholders. The loss for the Year, as compared to the profit-making position for 2022, was primarily attributable to (a) the increase in selling and distribution costs which was mainly due to the increased staff costs and promotional expenses incurred in the course of developing and conducting the livestream sales business in Mainland China; (b) decreases in other income/gains including, among others, the unavailability of COVID-19-related subsidies in 2023 following the cessation of the 2022 Employment Support Scheme launched by the Hong Kong government and less gain on disposal of property, plant and equipment recorded for 2023; and (c) the increase in other losses including, among others, the impairment loss on investment properties, despite the decrease in exchange loss and the reversal of provisions for inventories and trade receivables in 2023.

The Company disclosed EBITDA (as adjusted), which represented by gross profit less selling and distribution costs and administrative expenses adding back depreciation, amortization and share-based payments (if any), in its financial reports in the past. As EBITDA or adjusted EBITDA is not a financial measure under the HKFRS, there are not many listed companies in Hong Kong to disclose EBITDA or adjusted EBITDA in their financial reports. Furthermore, the formulae for calculating EBITDA or adjusted EBITDA can vary. The Company determines not to disclose EBITDA or adjusted EBITDA any more for the Year and in future financial reports because the HKFRS financial measures presented are sufficient to the Shareholders and potential investors for analyzing the Group's performance and it may not be comparable to other listed companies in Hong Kong even with EBITDA or adjusted EBITDA of the Group being disclosed.

#### Inventory turnover

The inventory turnover is equal to the average of opening and closing inventory divided by total cost of sales for the year and multiplied by 365 days. The inventory at 31 December 2023 slightly increased by 2.5% to HK\$59.9 million (2022: HK\$58.5 million). The reason for inventory turnover for 2023 increased to 235.0 days from 232.2 days for 2022 was due to the increase in inventory and the decrease in cost of sales.

#### Trade receivables turnover

The trade receivables turnover is equal to the average of opening and closing trade receivables divided by total sales for the year and multiplied by 365 days. The trade receivables at 31 December 2023 slightly decreased by 5.7% to HK\$34.7 million (2022: HK\$36.8 million) net of loss allowance of HK\$0.9 million (2022: HK\$6.1 million). The decrease in loss allowance at 31 December 2023 was due to the write-off of long-aged trade receivables and the reversal of loss allowance recognised in prior years. With the decrease in sales for 2023 and the lower closing trade receivables at 31 December 2023, the trade receivables turnover for 2023 decreased to 45.9 days (2022: 50.8 days).



#### Trade and bills payables turnover

The trade and bills payables turnover is equal to the average of opening and closing trade and bills payables divided by total cost of sales for the year and multiplied by 365 days. The trade and bill payables at 31 December 2023 increased by 14.9% to HK\$44.4 million (2022: HK\$38.6 million). The trade and bills payables turnover for 2023 increased to 164.7 days (2022: 152.1 days) was attributable to the increase in trade and bills payables at 31 December 2023 for purchases of more raw materials in the fourth quarter of 2023, and the decrease in cost of sales for 2023.

The Group has been adhering to the principle of prudent financial management in order to minimise financial and operational risks. The Group generally finances its operations with internally generated cash flows. Bank borrowings were primarily for settlement of payables for the construction of the new building B under phase II of Casablanca industrial Park in Huizhou in order to improve the working capital of the PRC subsidiary.

The decrease in bank balances and cash at 31 December 2023 was primarily attributable to loss for the Year and settlements of bank borrowings and outstanding payables for interior decorations of the new building B under phase II of Casablanca Industrial Park in Huizhou during the Year. The Group still had available net cash about HK\$132.4 million as at 31 December 2023 which would be sufficient for its present operations in absence of unforeseen circumstances.

#### Pledged bank deposits and bank balances and cash

As at 31 December 2023, the pledged bank deposits of the Group were approximately HK\$9.2 million (2022: HK\$6.4 million), which were denominated in HKD and RMB, and the bank balances and cash of the Group were approximately HK\$123.2 million (2022: HK\$139.2 million), which were denominated in HKD and RMB except for about 0.5% in United States dollars and Euro.

#### **Bank borrowings**

As at 31 December 2023, there was no bank borrowings of the Group (2022: HK\$5.3 million). Despite loss for the Year, the financial position of the Group was healthy during the Year.

#### **Current ratio**

The Group's total current assets and the total current liabilities at 31 December 2023 decreased to HK\$252.2 million (2022: HK\$268.6 million) and HK\$77.6 million (2022: HK\$80.2 million) respectively. As a result, the current ratio decreased to 3.3 as at 31 December 2023 from 3.4 as at 31 December 2022. The decrease in current ratio was mainly due to the decrease in current assets more than that in current liabilities.

#### **Gearing ratio**

Gearing ratio is calculated as total borrowings divided by total equity at the end of the year. As at 31 December 2023, the gearing ratio was 0% (2022: 1.3%) without bank borrowings. The Group was at net cash position at 31 December 2023 as well as 31 December 2022.

#### **Pledge of assets**

As at 31 December 2023, no leasehold land and buildings or investment properties were pledged to banks as securities for banking facilities granted to the Group (2022: nil). The Group had pledged only its fixed deposits with an aggregate value of HK\$9.2 million (2022: HK\$6.4 million) to certain banks in Hong Kong and Mainland China to secure banking facilities granted to the Group at 31 December 2023.

#### **Capital expenditures**

During the Year, the Group invested HK\$27.9 million (2022: HK\$10.1 million) mainly for acquisition of properties, leasehold improvements and equipment and the decoration for the new building B under phase II of Casablanca Industrial Park in Huizhou, the PRC.

#### **Capital commitments**

As at 31 December 2023, the Group had capital commitments of only HK\$0.2 million as compared to approximately HK\$9.5 million at 31 December 2022 of which mainly related to the decoration for the new building B under phase II of Casablanca Industrial Park.

#### **Share Capital**

The total number of issued ordinary shares of the Company ("Shares") as at 31 December 2023 was 257,854,000 Shares (2022: 257,854,000 Shares). As at 31 December 2023, the total issued share capital of the Company was HK\$25,785,400 (2022: HK\$25,785,400).

In order to provide incentive or reward to eligible persons for their contribution to the Group and to enable the Group to recruit and retain human resources that are valuable to the Group, the Company adopted a new share option scheme which had been approved upon the termination of the one adopted before the listing at the annual general meeting held on 6 June 2022.

#### **Foreign Exchange Exposure**

The Group carries on its business mainly in Hong Kong and Mainland China. The Group is exposed to foreign exchange risk principally in RMB which may affect the Group's performance. RMB depreciated by about 2.7% against HKD in 2023 (2022: 7.8%). The management is aware of the possible exchange rate exposure due to the continuing fluctuation of RMB and will closely monitor its impact on the performance of the Group to see if any hedging arrangement is necessary. The Group currently does not use derivative financial instruments to hedge against the volatility associated with foreign currency transactions and other financial assets and liabilities arising in the ordinary course of business.





#### **Employee and Remuneration Policy**

As at 31 December 2023, the employee headcount of the Group was 531 (2022: 519) and the total staff costs, including directors' emoluments, for the Year amounted to HK\$91.6 million (2022: HK\$89.6 million). The increase of number of staff and thus the increase in total staff costs for 2023 was mainly due to the expansion of livestream sales business in Mainland China.

The Group offers competitive remuneration packages commensurate with industry practice and provides various fringe benefits to employees including medical benefits, social insurance, provident funds, bonuses and a share option scheme.

#### Material Acquisitions and Disposals of Subsidiaries and Associates

The Group did not have any material acquisitions and disposals of subsidiaries, associates and joint ventures in the course of the Year.

#### **Significant Investments**

The Group did not hold any significant investments during the Year save as those disclosed in this annual report.

As at 31 December 2023, the Company had total investments in shares of companies listed on the Stock Exchange with fair value of HK\$6.3 million (2022: HK\$7.7 million) which were not more than 5% of the Group's total assets. The decrease in financial assets at FVTPL by about HK\$1.3 million (2022: HK\$0.1 million) was mainly derived from decreases in prices of shares as held at 31 December 2023. Dividend income for the Year from these investments in shares of companies listed on the Stock Exchange was HK\$0.4 million (2022: HK\$0.5 million). As the Group's investments are constituents of Hang Seng Index as listed on the Stock Exchange, they are expected to bring returns to the Group in the long run.

#### **Future Plans for Material Investments or Capital Assets**

The Group is actively identifying and exploring suitable investments with potential and synergy effect to its existing businesses. Only potential investments, which are in the interests of the Company and the Shareholders as a whole, will be considered.

For medium to long-term investment purposes, the Group may consider to invest in shares of companies listed on the Stock Exchange to strive for better return in the medium to long-term from surplus cash on hand. As at 31 December 2023, the Group had investments in shares of companies listed on the Stock Exchange as disclosed for financial assets at FVTPL above.

The Group will review its business strategy in respect of its capital assets (including but not limited to properties owned by the Group) from time to time. With a view to optimising the overall benefits of the Group, adjustments may be made or new initiatives may be undertaken as regards the business plans formulated for properties owned by the Group having regard to the operational needs of the Group, actual circumstance and the interest of the Group as a whole. As at 31 December 2023, the Group leased out investment properties with total carrying amount of HK\$20.4 million (2022: HK\$10.2 million) under operating leases which run for two to five years.

The construction of complex with four floors for the new building B under phase II of the Casablanca Industrial Park in Huizhou, the PRC was duly completed in April 2022 with a total construction area of 25,255.09 square metres. To cope with the business development, the interior designs of the new building B under phase II of the Casablanca Industrial Park had been modified into a complex comprising research and development centre, office, conference rooms, training rooms, showroom, livestreaming centres, and catering facilities.

References are made to the announcements of the Company dated 1 September 2022 and 5 September 2022 in relation to the Showroom Decoration for the phase II of Casablanca Industrial Park. The Group entered into a construction agreement on 1 September 2022 with an independent third party contractor for a consideration of RMB4.8 million (equivalent approximately to HK\$5.3 million) to carry out the Showroom Decoration. Including the Showroom Decoration, the Group finally incurred a total consideration of RMB24.4 million (equivalent approximately to HK\$27.0 million) in interior works and decorations for the new building B under phase II of the Casablanca Industrial Park. The new building B under phase II of the Casablanca Industrial Park has been in use since March 2023.

Other than those disclosed above, there was no plan authorised by the Board for material investments or additions of capital assets at the date of this annual report.

### Update on Discloseable Transaction involving the Formation of Joint Venture Company and Details of Performance Guarantee

Reference is made to the announcement of the Company dated 5 October 2022 in relation to discloseable transaction – formation of joint venture company. On 5 October 2022, Jollirich Investment Limited (an indirect wholly-owned subsidiary of the Company) entered into a joint venture agreement (the "JV Agreement") with 湖南螞蟻星球科技有限 公司 (Hunan Ant Star Technology Co., Ltd.\*) ("Hunan Ant Star") and 杭州丁元投資管理有限公司 (Hangzhou Dingyuan Investment Management Co., Ltd.\*) ("Hangzhou Dingyuan"), pursuant to which the parties agreed to establish Casa Living.



At the date of this annual report, Hunan Ant Star has not paid the first instalment of its committed capital contribution in the amount of RMB1,000,000, which was due and payable on 30 September 2023. On 26 January 2024, Casa Living as plaintiff filed a claim with 惠州市惠城區人民法院 (Huicheng District People's Court of Huizhou Municipality\*) (the "Huicheng District Court") against Hunan Ant Star as defendant, seeking (i) order compelling Hunan Ant Star to forthwith fulfil its capital contribution obligations and pay RMB1,000,000 to Casa Living as capital contribution; (ii) liquidated damages and penalty at 6% per annum accruing on RMB1,000,000; and (iii) related costs (the "Claim"). The Claim is subject to acceptance by the Huicheng District Court. The Board considers that the Claim is not expected to have any material adverse effect on the operation and financial positions of the Group. The Group is currently seeking legal advice in respect of the Claim and will rigorously enforce its rights and defend its interest, including but not limited to taking appropriate actions and seeking appropriate remedies in respect of all current and future rights and interests under the JV Agreement.

For the year ended 31 December 2023, Casa Living recorded a turnover and a loss of approximately RMB16.3 million (equivalent to HK\$18.0 million) and RMB8.9 million (equivalent to HK\$9.8 million) respectively, based on its audited financial statements, which accounted for approximately 6.3% and 104.0% of the Group's consolidated turnover and loss for the year respectively. As Casa Living is a subsidiary of the Group, the relevant loss has been reflected in the Group's consolidated financial statements for the year ended 31 December 2023. In view of the Claim, Casa Living is currently run by the management team of Hangzhou Dingyuan. The Group has also adjusted its strategies for development of livestream sales business in Mainland China. The Group will closely monitor the operations and development of Casa Living.

Pursuant to the JV Agreement, Hunan Ant Star guaranteed the satisfaction of the turnover targets and after-tax profit targets by the Casa Living for each of the three financial years ending 31 December 2023, 2024 and 2025 (the "Performance Targets"). The Performance Targets for the year ended 31 December 2023 were turnover of RMB150 million and net profit after tax of RMB15 million. As the audited results of Casa Living for the year ended 31 December 2023 fell short of the turnover target and after-tax profit target for the same year, pursuant to the JV Agreement, the operating and management team of Casa Living was not entitled to any performance incentives or bonuses in accordance with the JV Agreement.

The Performance Targets were recorded in the JV Agreement as a mutual intent of the vision for and business projection of Casa Living, and were intended to serve as evaluation indicators for performance incentives and bonuses. The Performance Targets in the JV Agreement were in nature an illustration of the commitment of Hunan Ant Star (which is contractually responsible for the operation and management of Casa Living), which do not create any obligation on the part of Hunan Ant Star to make up for any shortfall in respect thereof. The JV Agreement does not contain any provision which would give rise to a put option for the Company to sell its equity interest in Casa Living to Hunan Ant Star by reason of the failure to satisfy any Performance Targets.

The Company will make further announcement(s) to inform Shareholder and potential investors in respect of further material developments in connection with the Claim and/or the JV Agreement in accordance with the Listing Rules as and when appropriate.

#### **Contingent Liabilities**

As at 31 December 2022, the Company and two of its subsidiaries in Hong Kong were defendants in a litigation involving a copyright dispute in Hong Kong which was regarded as contingent liabilities. The parties of the litigation have reached a full and final settlement in March 2023, thereby resolved the dispute in lieu of trial. The settlement (including the terms thereof) had no material adverse effect to the business operation and financial position of the Group. As at 31 December 2023, the Group did not have any significant contingent liabilities.

**Mr. Cheng Sze Kin (鄭斯堅)**, aged 63, is one of the founders of the Group to establish the Group's business in May 1993. He was appointed as a Director on 2 April 2012 and re-designated as an Executive Director and the Chairman of the Board on 22 October 2012. He is currently a director of all the subsidiaries of the Company incorporated in Hong Kong and the British Virgin Islands ("BVI"). He is responsible for strategic planning of the Group, in particular product development and production. He has over 30 years of experience in the production of bedding products and textile trading. He is the spouse of Ms. Wong Pik Hung (王碧紅) and the brother of Mr. Cheng Sze Tsan (鄭斯燦), both of whom are also Executive Directors. Mr. Cheng Sze Kin is a director of World Empire Investment Inc. ("World Empire"), which is interested in the Shares which would fall to be disclosed under the provisions of Divisions 2 and 3 of Part XV of the Securities and Futures Ordinance.

**Mr. Cheng Sze Tsan (鄭斯燦)**, aged 51, is one of the founders of the Group to establish the Group's business in May 1993. He was appointed as a Director on 2 April 2012 and re-designated as an Executive Director and Vice-chairman of the Board on 22 October 2012. He is currently a director of all the subsidiaries of the Company incorporated in Hong Kong and BVI. He has been appointed as the Chief Executive Officer of the Company since 1 September 2016 and is responsible for strategic planning of the Group, in particular product development and sales management. He has over 30 years of experience in the bedding products industry. He is the brother of Mr. Cheng Sze Kin (鄭斯堅) and the brother-in-law of Ms. Wong Pik Hung (王碧紅), both of whom are also Executive Directors. He was awarded by the Federation of Hong Kong Industries as "Young Industrialists of Hong Kong" in 2013. He has taken up a variety of roles, including a vice president of the Hong Kong Young Industrialists Council, a vice president of Federation of Hong Kong Huangpu Community and a committee member of Chinese People's Political Consultative Conference Guangzhou Committee (Huangpu District). Mr. Cheng Sze Tsan is a director of World Empire, which is interested in the Shares which would fall to be disclosed under the provisions of Divisions 2 and 3 of Part XV of the Securities and Futures Ordinance.

**Ms. Wong Pik Hung (王碧紅)**, aged 57, has been a Director of a subsidiary of the Company since August 1993. She was appointed as a Director on 2 April 2012 and re-designated as an Executive Director on 22 October 2012. She is currently a director of all the subsidiaries of the Company incorporated in Hong Kong and BVI. She is responsible for strategic planning of the Group, in particular procurement and sales management in Hong Kong. She has about 30 years of experience in the bedding products industry. She obtained a diploma in international economic cooperation at the University of International Business and Economics (對外經濟貿易大學) in Beijing. Ms. Wong is the spouse of Mr. Cheng Sze Kin (鄭斯堅) and the sister-in-law of Mr. Cheng Sze Tsan (鄭斯燦), both of whom are also Executive Directors. Ms. Wong is a director of World Empire, which is interested in the Shares which would fall to be disclosed under the provisions of Divisions 2 and 3 of Part XV of the Securities and Futures Ordinance.



### **DIRECTORS AND SENIOR MANAGEMENT**

### **Independent Non-executive Directors**

**Mr. Lo Siu Leung** (盧紹良), aged 45, was appointed as an Independent Non-executive Director on 9 April 2018. He has over 20 years of experience in auditing, accounting, tax and finance. Mr. Lo is a Chartered Financial Analyst. He holds a master's degree in Business Administration from The Hong Kong Polytechnic University.

**Dr. Cheung Wah Keung (張華強)**, aged 62, was appointed as an Independent Non-executive Director on 26 May 2017. He is currently the chairman of each of Shinhint Group and Tai Sing Industrial Company Limited. He has more than 30 years of experience in trading and manufacturing of consumer electronic products. Dr. Cheung is currently an independent non-executive director of PanAsialum Holdings Company Limited (stock code: 2078), Activation Group Holdings Limited (stock code: 9919) and Sinomax Group Limited (stock code: 1418), respectively. He was also the independent non-executive chairman of PanAsialum Holdings Company Limited (stock code: 2078) during the period from 2 August 2019 to 30 June 2022 and an independent non-executive director of Sky Light Holdings Limited (stock code: 3882) during the period from 12 June 2015 to 28 February 2023. The shares of above companies with stock code indicated are listed on the Stock Exchange.

Dr. Cheung holds a bachelor's degree in business administration, a master's degree in global political economy from The Chinese University of Hong Kong and a master's degree in corporate governance, and a doctorate degree in business administration from The Hong Kong Polytechnic University. He was awarded by the Federation of Hong Kong Industries as "Young Industrialist of Hong Kong" in 2005 and "Certificates of Merit in Directorship" by the Hong Kong Institutes of Directors in 2006. He has taken up a variety of roles, including the president of the Hong Kong Young Industrialists Council from 2015 to 2016, the chairman of the Advisory Board for Master of Corporate Governance of The Hong Kong Polytechnic University and a committee member of the Council of The Hang Seng University of Hong Kong.

**Mr. Chow On Wa** (周安華), aged 62, was appointed as an Independent Non-executive Director on 26 May 2017. He is currently the director of JTF Development Limited which provides professional management and investment consulting services to various clients. Mr. Chow has over 20 years of experience in management of retail business of home accessories in the PRC. During 1986 to 2001, he worked for IKEA Group for 15 years. He was a general manager for India and Pakistan regional office of IKEA and subsequently stationed in the PRC. During 1995 to 2001, Mr. Chow was responsible for IKEA's retail and operational management in the PRC and opened the first retail shopping mall in the PRC for IKEA Group in 1997. He established Amfield Consultants Limited, which engaged in consultancy on management and strategic planning in business and retailing in the PRC, in 2001. Mr. Chow established New Concept International Enterprise Limited, in 2004, which was engaged in retailing of home accessories across the PRC focusing on shopping malls and department stores, and mainly distributed internationally renowned brands, including Frette, Trussardi-home and Esprit-home etc., until its business was sold in 2013 to Li & Fung Limited. From 2013 to June 2016, Mr. Chow was a senior vice president of Global Brands Group Holding Limited and was responsible for management of its multi-branded home accessory business covering all over Asia. Mr. Chow holds a bachelor's degree in engineering from University of Manchester in the United Kingdom.

#### **Senior Management**

**Mr. Ho Yiu Leung (何耀樑)**, aged 57, joined the Group as the Financial Controller and Company Secretary in January 2012. He is responsible for the Group's overall financial reporting, finance and company secretarial matters. He has over 30 years of experience in auditing, accounting and financial management. He is a fellow member of each of the Hong Kong Institute of Certified Public Accountants, the Association of Chartered Certified Accountants, The Hong Kong Chartered Governance Institute and The Chartered Governance Institute. He holds a master's degree in business administration from the University of Strathclyde.

**Dr. Lin Yi Kai (林奕凱)**, aged 54, joined the Group in May 2007. He is currently the Deputy General Manager of Casablanca Home (Shenzhen) Limited. He is responsible for the financial management of the Group's operations in the PRC. Dr. Lin has over 25 years of experience in audit, tax and accounting. He was awarded Qualification Certificate of International Association of Accounting Professionals, qualifications of certified internal control specialist from Internal Control Institute, senior international finance manager from International Financial Management Association and certified financial planner from The Chinese Institute of Certified Financial Planners, and is a member of Institute of Public Accountants, and an associate member of each of Institute of Financial Accountants and The Association of International Accountants. He was conferred qualification of assistant accountant in accounting (corporate) speciality and intermediate level in accounting speciality from Ministry of Finance of the PRC and qualification of senior accountant from Human Resources and Social Security Department of Guangdong Province. Dr. Lin holds an executive doctor's degree in business administration from EuroPort Business School.

### DIRECTORS' REPORT

The Directors present their annual report and the audited consolidated financial statements for the year ended 31 December 2023 (the "Year").

#### **Principal Activities**

The Company acts as an investment holding company. The activities of its principal subsidiaries are set out in note 1 to the consolidated financial statements.

#### **Business Review**

A review of the Group's business for the Year and a discussion on the Group's future business development are set out in the sections headed "Chairman's Statement" and "Management Discussion and Analysis" on pages 6 to 22 of this annual report. Discussion and information therein forms part of this Directors' Report.

#### **Principal Risks and Uncertainties**

The Group's results of operations and prospects may be exposed to a number of risks and uncertainties. The following are key risks that are considered to be of most significance to the Group at this time. They are not exhaustive or comprehensive and there may be other risks which are not known by the Group or which may not be material now but could turn out to be material in the future.

#### (i) Business Risk

The Group's sales and results significantly depend on economic conditions, consumer habits and competition of operating markets in Hong Kong and Mainland China.

The economic recovery of both Hong Kong and Mainland China during the Year was slower than expected after the lifting of pandemic measures. In addition, there was a material change in consumer habits in Hong Kong as people tended to go travelling around Mainland China or overseas during weekends and holidays, which resulted in the Group's drop in revenue from Hong Kong for the Year.

Furthermore, the Group operates in markets subject to pricing and other competitive pressures such as advertising, designs, product innovations and technological advances. Changes in economic conditions, consumer habits and competition are uncertain such that the Group cannot accurately predict any material adverse effect of these changes on the current or future business and results of operations of the Group. However, the Group has strengthened its business in sales of products with health enhancing functions or technology features, increased its investment in the development of new channels of sales (including new media), strengthened its advertising and marketing, and enhanced its research and development of new products in order to mitigate the impact.

#### (ii) Operational Risk

In view of over-reliance on physical retail businesses in Hong Kong and Mainland China, the Group has endeavoured to develop sales through new media and wholesale businesses during the recent years. At the same time, the Group also strives in building strong and long term relationships with different wholesale customers and exploring export business opportunities in order to mitigate the risk. In addition, the Group strives to extend its reach to consumers who prefer to shop online by opening shops on different online shopping platforms, exposing its presence on new media and increasing its online advertising resources.

The Group's success and growth also depend on skilled and experienced managers, sales and marketing personnel and front-line sales promoters. It is important to attract, train, motivate and retain employees in support of the future growth of the Group. The risk of the loss of key personnel or the inability to attract qualified personnel is mitigated by regular reviews of retention and recruitment practices, remuneration packages and succession planning within the Group.

#### (iii) Financial Risk

The Group's results are subject to interest rate risk, foreign currency risk, credit risk and liquidity risk. The financial risk management objectives and policies of the Group in managing these financial risks are set out in note 33 to the consolidated financial statements. These discussions form part of this Directors' Report.

#### **Financial Key Performance Indicators**

An analysis of the Group's performance for the Year using financial key performance indicators (the "KPIs") is set out in the section headed "Financial Highlights and Summary" on pages 4 and 5 of this annual report. Such KPIs are selected on basis of their effectiveness in measuring the performance of Group's business with nature in manufacturing and trading.

#### **Environmental Policies and Performance**

The Group is committed to build an environmentally-friendly corporation that pays close attention to conserving natural resources and protecting environment. The Group strives to minimise the impact on environment by saving paper, electricity and water and has implemented internal recycling programmes on a continuous basis for office consumables such as carbon toners, cartridges and papers.

The Company follows the latest Listing Rules to disseminate corporate communication, including but not limited to this annual report, the circular and the proxy form, by electronic means and only send corporate communication in printed form to the Shareholders upon written request. We also arrange tablet computers at our self-operated POS to show product catalogues to customers in order to reduce printed versions of the product catalogues. Casablanca Hong Kong Limited, the principal subsidiary of the Company in Hong Kong, was awarded the certificate under the CarbonSmart Programme organised by the Hong Kong Productivity Council in collaboration with the Federation of Hong Kong Industries, Hong Kong General Chamber of Commerce and Business Environment Council. The Company participated in the Onsite Improvement Assessment Projects of Cleaner Production Partnership Programme organised by Environmental Protection Department of Hong Kong Limited had been awarded "U Green Awards – Excellence of Environmental Contribution Award (Bedding Products)" by U Magazine for six years consecutively from 2016 to 2021.



### DIRECTORS' REPORT

In contribution to the environment, the Group uses environmentally-friendly raw materials for its products such as milk protein fibres and soybean protein fibres for the fill materials in our duvets and pillows. In addition, the Group has also introduced new products with health enhancing functions such as products under "CASA-V" brand with "5A Features" as well as mosquitos and insects repellent functions. In addition to "5A Features", users of these products can avoid being disturbed by insects and enjoy good sleep. The Group intends to make "CASA-V" a brand for healthy and environmentally-friendly home living. The pure cotton products manufactured by the Group are awarded with the "Seal of Cotton<sup>TM</sup>" trademark and the "Cotton LEADS<sup>SM</sup>" label in recognition of its contribution to the environment by utilising sustainable cotton in its products.

The Company has published an Environmental, Social and Governance Report separately on the websites of the Company and the Stock Exchange for the year ended 31 December 2023 on the same date as publishing this annual report.

#### **Compliance with Laws and Regulations**

The Group's operations are mainly carried out by the Company's subsidiaries in Hong Kong and Mainland China. The Directors are not aware of any material changes in relevant laws and regulations in Hong Kong and Mainland China with significant potential impacts on the Group's operations. During the Year, the Group has complied, to the best knowledge of the Directors, in material aspects with the relevant laws and regulations that have a significant impact on the operations of the Group.

#### Key Relationships with Employees, Customers, Distributors and Suppliers

Human resources are one of the valuable assets of the Group. The Group intends to be an attractive employer for competent employees. The objective of the Group's human resource management is to provide employees with competitive remuneration packages and to promote career development and progression of employees by appropriate training and providing opportunities within the Group for career advancement. The Group has also adopted share option schemes to reward, motivate and retain Directors and employees for contributions to the growth and development of the Group.

We are committed to offer a broad and diverse range of innovative, value-for-money and good-quality bedding products with our various brands to our customers. We also stay connected with our customers by maintaining database of VIP members to have ongoing communications with them and offer special benefits to them such as favourable prices and private sales. A customer complaint handling mechanism is in place to collect, analyse and study complaints from customers and make recommendations on remedies with the aim of improving service quality.

We also sell our products to end customers through distributors. We regard our distributors as business partners and share views for upholding the brand value and customer services, specifically focusing on attracting and retaining customers in order to drive sales growth. We require our distributors to comply with our retail policies, including but not limited to unified product retail selling price, standard store images and promotional activities.

We have developed long and good relationships with a number of suppliers to maintain steady supplies of raw materials and outsourced products with good qualities. We carefully select our suppliers and require them to satisfy certain criteria including track record, experience, reputation, ability to produce high-quality products and quality control effectiveness in order to ensure that our suppliers share our commitments to quality and ethics.

#### **Results and Appropriations**

The results of the Group for the Year are set out in the consolidated statement of profit or loss and other comprehensive income on page 65 of this annual report.

The Directors do not recommend the payment of a final dividend for the Year (2022: Nil).

As at the date of this annual report, the Board was not aware that any shareholders of the Company had waived or agreed to any arrangement to waive dividends.

#### **Distributable Reserves**

The Company may pay dividends out of share premium and retained earnings provided that immediately following the payment of such dividends the Company will be in a position to pay off its debts as they fall due in the ordinary course of business.

The Company's reserves available for distribution to Shareholders as at 31 December 2023 calculated in accordance with the Companies Act of the Cayman Islands, amounted to approximately HK\$172,830,000, comprising share premium of approximately HK\$166,376,000 and retained earnings of approximately HK\$6,454,000.

There was no change to information which is required to be disclosed and has been disclosed by the Directors pursuant to Rule 13.51B of the Listing Rules up to the date of this annual report, save as disclosed in this annual report and that Dr. Cheung Wah Keung was appointed as an independent non-executive director of Sinomax Group Limited (stock code: 1418), the shares of which are listed on the Stock Exchange, with effect from 16 June 2023.

#### **Confirmation of Independence**

The Company has received from each of the Independent Non-executive Directors an annual confirmation of his independence pursuant to Rule 3.13 of the Listing Rules. The Company considers all of the Independent Non-executive Directors to be independent.

#### **Directors' Service Contracts**

No Director proposed for re-election at the forthcoming annual general meeting has a service contract which is not determinable by the Group within one year without payment of compensation, other than statutory compensation.

#### **Share Option Schemes**

The Group adopted a share option scheme which was approved by the sole Shareholder's resolution passed on 22 October 2012 with a life for 10 years until 21 October 2022 (the "2012 Share Option Scheme"). Share options to subscribe for a total of 5,250,000 Shares, which had been granted by the Group on 2 July 2020 with the exercise price of HK\$0.48 per Share and the exercisable period from 2 July 2020 to 1 July 2023, remained unexercised under the 2012 Share Option Scheme as at 1 January 2023.

At the annual general meeting of the Company held on 6 June 2022, a new share option scheme had been approved and adopted as the Company's share option scheme with a life for 10 years until 5 June 2032 (the "2022 Share Option Scheme") and the 2012 Share Option Scheme had been terminated and ceased to have any further effect save for and except that the 2012 Share Option Scheme remained in force to the extent necessary to give effect to the exercise of the options granted thereunder prior to the termination thereof and any such options (to the extent not already exercised) continued to be valid and exercisable in accordance with the terms of the 2012 Share Option Scheme. As at 1 January 2023 and 31 December 2023, no share options under the 2012 Share Option Scheme were available for grant to subscribe or exercise for any Share. All the outstanding share options of 5,250,000 Shares under the 2012 Share Option Scheme at 1 January 2023 were lapsed on 1 July 2023.

As at 1 January 2023, the number of Shares available for grant(s) under the 2022 Share Option Scheme and the number of Shares that might be issued under the 2022 Share Option Scheme were 25,785,400 Shares. The Group granted share options under the scheme mandate limit of the 2022 Share Option Scheme to Directors and employees on 6 July 2023 to subscribe for a total of 6,200,000 Shares, representing 2.4% of the weighted average number of issued Shares for the Year, with the exercise price of HK\$0.37 per Share and the exercisable period from 6 July 2024 to 5 July 2028. There was no performance target attached to the share options granted. Details of the grant of share options on 6 July 2023 are set out in the announcement of the Company on 6 July 2023. As at 31 December 2023 as well as the date of this annual report, the number of options available for future grant(s) under the 2022 Share Option Scheme was 25,785,400 Shares, representing 10% of the issued Shares of the Company as at the date of this annual report.

Based on the valuation report of an independent valuer, the aggregate estimated fair value of the options granted on 6 July 2023 under the 2022 Share Option Scheme was approximately HK\$921,000, of which HK\$633,000 and HK\$288,000 represented the estimated fair value of the share options granted to Directors and employees respectively.

Save for the 2022 Share Option Scheme, the Company does not have other share schemes (as defined in Chapter 17 of the Listing Rules) nor other outstanding share option/award.

The Company has arranged appropriate directors' and officers' liability insurance which provides coverage for the Directors and officers of the Group throughout the Year.

#### **Connected Transactions**

Casablanca Hong Kong Limited, a subsidiary of the Group in Hong Kong, had entered into lease agreements ("Lease Agreements") on 18 December 2020 with Gain Harvest Investment Limited ("Gain Harvest") and Wealth Pine Asia Limited ("Wealth Pine") which are wholly-owned by Mr. Cheng Sze Kin, Mr. Cheng Sze Tsan and Ms. Wong Pik Hung, for the two properties located as House No. 29, Kensington Path, The Royal Oaks, 8 Kam Tsin Nam Road, Kwu Tung, Sheung Shui, New Territories, Hong Kong and House No. A25, Constellation Cove, 1 Hung Lam Drive, Tai Po, New Territories, Hong Kong, respectively (the "Leased Properties"). The Lease Agreements were for 3 years with expiry on 31 December 2023. Related party transactions disclosed in note 31 to the consolidated financial statements were one-off connected transactions of the Company under Chapter 14A of the Listing Rules in relation to the Lease Agreements as disclosed in the announcement of the Company dated 18 December 2020.

Reference is made to the announcement "Discloseable and Connected Transaction – Renewal of Lease Agreements" published by the Company on 15 December 2023, the Board considered and passed a resolution, in which Mr. Cheng Sze Kin, Mr. Cheng Sze Tsan and Ms. Wong Pik Hung as Directors having material interest therein abstained from voting, in relation to the renewal of Lease Agreements for 3 years from 1 January 2024 to 31 December 2026. Accordingly, the Group entered into the renewed Lease Agreements (the "Renewed Lease Agreements") with Gain Harvest and Wealth Pine on 15 December 2023 in respect of the Leased Properties respectively at monthly rentals of HK\$110,000 and HK\$78,000 (both inclusive of Government rent, rates and management fee) determined by the parties on an arm's length basis with reference to (i) the conditions of Leased Properties; (ii) the availabilities of properties with similar sizes; and (iii) the prevailing market rents of comparable properties in the vicinity of the Leased Properties.

The Directors, including the Independent Non-executive Directors, were of the view that the Renewed Lease Agreements and the transactions contemplated thereunder were entered into (i) in the ordinary and usual course of business of the Group; and (ii) on normal commercial terms; and are fair and reasonable and in the interests of the Company and its Shareholders as a whole.

In accordance with HKFRS 16, the Group recognized rental payments under the Renewed Lease Agreements as right-ofuse assets with an estimated value of approximately HK\$6,074,000 as at 1 January 2024. The transactions contemplated under the Renewed Lease Agreements were recognized as the acquisitions of right-of-use assets which constituted one-off connected transactions of the Company in 2023 under Chapter 14A of the Listing Rules. The Company complied with the disclosure requirements in 2023 in accordance with Chapter 14A of the Listing Rules.

Gain Harvest and Wealth Pine are ultimately beneficially owned by Mr. Cheng Sze Kin, Mr. Cheng Sze Tsan and Ms. Wong Pik Hung, each of whom is an Executive Director and a substantial Shareholder of the Company. Each of Gain Harvest and Wealth Pine is therefore an associate of Mr. Cheng Sze Kin, Mr. Cheng Sze Tsan and Ms. Wong Pik Hung and a connected person of the Company under Chapter 14A of the Listing Rules. Accordingly, the transactions contemplated under the Renewed Lease Agreements constituted connected transactions of the Company in 2023 under Chapter 14A of the Listing Rules.

Save for the Lease Agreements and the Renewed Lease Agreements disclosed above, there was no related party transaction which constitutes any connected transaction or continuing connected transaction which should be disclosed pursuant to the Listing Rules during the Year.

### **Management Contract**

The Company has not entered into any contract with any individual, firm or body corporate to manage or administer the whole or any substantial part of any business of the Group during the Year.

#### **Directors' Remunerations and the Five Highest Paid Individuals**

Details of the Directors' remunerations and those of the five highest paid individuals in the Group are set out in note 10 to the consolidated financial statements.

#### **Emolument Policy**

The Group offers competitive remuneration packages commensurate with industry practice and provides various fringe benefits to all employees of the Group including social insurance coverage, provident funds, bonus and share option schemes. The Group mainly determines staff remuneration on basis of the competence, qualifications and performance of individual employee and the salary trends in Hong Kong and Mainland China. The staff remuneration will be reviewed regularly.

The emoluments of the Directors of the Company are decided by the Remuneration Committee, having regard to the emolument policy of the Company taking into account the Group's operating results, individual performance and attributes (such as qualifications and experience), duties and responsibilities within the Group and comparable market statistics.

The Company has adopted a share option scheme as an incentive to Directors and eligible employees, details of the scheme are set out in note 26 to the consolidated financial statements.

#### Audit Committee

The audit committee of the Company (the "Audit Committee") comprises three Independent Non-executive Directors, namely, Mr. Lo Siu Leung, Dr. Cheung Wah Keung and Mr. Chow On Wa. Mr. Lo Siu Leung is the chairman of the Audit Committee.

The Audit Committee is primarily responsible for the review of the Group's financial reporting process and risk management and internal control systems. It has reviewed the accounting principles and practices adopted by the Group and the audited annual results of the Group for the Year.

#### **Events After the Reporting Period**

There is no material subsequent event undertaken by the Group up to the date of this annual report after 31 December 2023.

#### **Major Customers and Suppliers**

For the Year, sales to the Group's five largest customers and the largest customer accounted for approximately 3.4% and 1.3%, respectively of the Group's total turnover for the Year.

For the Year, the Group's purchases attributable to the five largest suppliers and the largest supplier accounted for approximately 43.8% and 20.3%, respectively of the Group's total purchases for the Year.

At no time during the Year, did a Director, a close associate of a Director, or a Shareholder (which to the best knowledge of the Directors owns more than 5% of the Company's issued share capital) have an interest in any of the Group's five largest suppliers or customers.

#### **Changes in Memorandum and Articles of Association**

In order to update the Company's memorandum and articles of association (the "Memorandum and Articles") so as to, among other things, (i) reflect the current requirements of the Listing Rules (in particular the core standards set out in Appendix A1 thereto); (ii) provide greater flexibility to the Company in relation to the conduct of general meetings as a hybrid meeting where the Shareholders might attend by electronic means in addition to a physical meeting where Shareholders attended in person; and (iii) make other housekeeping improvements to the Memorandum and Articles, certain amendments to the Memorandum and Articles and the amended and restated Memorandum and Articles (the "Amended and Restated Memorandum and Articles") were approved by the Shareholders by way of a special resolution at the annual general meeting on 15 May 2023.

The Amended and Restated Memorandum and Articles was also adopted by the Company on 15 May 2023. Details of the amendments to the Memorandum and Articles were set out in the circular to the Shareholders sent on 13 April 2023.

There have been no changes in the Company's Amended and Restated Memorandum and Articles up to the date of this annual report since its adoption on 15 May 2023.

#### **Annual General Meeting**

The forthcoming annual general meeting of the Company for the year ended 31 December 2023 (the "AGM") is scheduled to be held on Friday, 24 May 2024. A notice convening the AGM will be issued and disseminated to Shareholders of the Company in due course.

#### **Closures of Register of Members**

The Board and the management of the Company are committed to the maintenance of good corporate governance practices and procedures which emphasise transparency, accountability and independence. The Company believes that good corporate governance provides a framework that is essential for effective management, a healthy corporate culture, sustainable business growth and enhancing Shareholders' value.

This corporate governance report ("Corporate Governance Report") is to outline the major principles of the Company's corporate governance. Shareholders are encouraged to make their views known to the Group if they have issues with the Company's corporate governance and to directly raise any matters of concern to the chairman of the Board (the "Chairman").

#### **Corporate Governance Practices**

The Company has adopted the code provisions of the CG Code as set out in Appendix C1 to the Listing Rules as its own code of corporate governance. The Directors consider that the Company has complied with the code provisions of the CG Code during the year ended 31 December 2023. Save as disclosed herein, the Company considers that there has been no deviation from the code provisions of the CG Code during the year ended 31 December 2023.

#### **Board of Directors**

The Board provides leadership, guidance and strategic decisions to the Group's activities and oversees its financial performances. The Board has delegated its powers to the management for the Group's daily management and operations.

#### **Business Strategies and Corporate Culture**

The Board has established the Company's mission and values to integrate sustainable growth, environmental protection and social responsibility in business strategies for providing consumers with quality bedding products of fashionable designs and at reasonable prices, as well as home accessories that are trendy yet practical and driving benefits to the communities. It will also continue to broaden revenue streams and enhance the Group's brand value so as to bring satisfactory returns to Shareholders in the long run and avoid short term gains with undue risks at the expense of long term objectives.

A healthy corporate culture across the Group is vital for the Company to achieve its mission and value. The Board's role is to foster a corporate culture with integrity and innovation to guide the behaviours of its employees, and ensure that the Company's mission, values and business strategies are aligned to it.

#### Division of Responsibilities between the Board and Management

The management team of the Group has a wide range of skills, knowledge and experience necessary to govern the Group's day-to-day management and operations. All management team members are required to report directly to the Chairman on a regular basis to report business performance and operational and functional issues of the Group. This will allow the Group's management to allocate resources more efficiently for its decision-making and facilitate its daily operations. Approval has to be obtained from the Board prior to any significant transactions entered into by the Company or decisions which may have a significant impact on the Company.



The Board is responsible for overseeing the processes by which the management team identifies business opportunities and risks. The Board has set up formal procedures for the Board's decisions. Matters of which the Board considers suitable for delegation to its committees (the "Board Committees") are contained in the specific terms of reference of Board Committees. The terms of reference clearly define the powers and responsibilities of the Board Committees. In addition, the Board will receive reports and/or recommendations from time to time from the Board Committees on any matter significant to the Group.

#### **Chairman and Chief Executive Officer**

Code Provision C.2.1 of the CG Code stipulates that the roles of Chairman and Chief Executive Officer should be separate and not be performed by the same individual. The Chairman is responsible for the leadership and effective running of the Board and ensuring that all material issues are discussed by the Board in a timely and constructive manner. The Chief Executive Officer is responsible for the management of the day-to-day operations and the implementation of the approved strategies of the Group.

To ensure a balance of power and authority, the Company has appointed Mr. Cheng Sze Kin as the Chairman of the Company and Mr. Cheng Sze Tsan as the Chief Executive Officer of the Company for the Review Period. Mr. Cheng Sze Kin and Mr. Cheng Sze Tsan are also Executive Directors of the Company.

#### **Board Composition**

The Board currently comprises three Executive Directors and three Independent Non-executive Directors. The Board has at least one-third of its membership comprising Independent Non-executive Directors in accordance with Rule 3.10A of the Listing Rules. Save as disclosed in the section headed "Directors and Senior Management" to this annual report, the Directors have no other financial, business, family or other material/relevant relationships with one another.

#### **Appointment and Re-election of Directors**

Each of Mr. Cheng Sze Kin, Mr. Cheng Sze Tsan and Ms. Wong Pik Hung renewed his/her service agreement with the Company as an Executive Director for a term of three years commencing from 1 April 2021. All of such service agreements may only be terminated by either party giving to the other not less than three months' prior notice in writing.

Each of the Independent Non-executive Directors has been re-appointed by a letter of re-appointment for a term of 1 year commencing from 1 April 2023 and ending on 31 March 2024 in compliance with the Listing Rules and the CG Code. Upon the expiry of the term, the re-appointment shall be subject to the approval by the Board and compliance with the Listing Rules and the CG Code. The letter of re-appointment shall be terminable by either the Independent Non-executive Director or the Company by giving the other party not less than one month's prior notice in writing. As at the date of this annual report, no Independent Non-executive Director has served the Company for more than nine years.

Directors appointed to fill casual vacancies should be subject to retirement and re-election by Shareholders at the first annual general meeting after appointment and every Director, including those appointed for a specific term, should be subject to retirement by rotation and re-election at least once every three years.

Appointments and re-appointments of Directors by the Board are subject to recommendations from the Nomination Committee of the Company, after having reviewed and assessed their suitability by reference to the board diversity policy and the nomination policy adopted by the Company.

#### **Board Diversity Policy**

The Board has established a board diversity policy. The Company recognises the benefits of Board diversity and endeavours to ensure that the Board has the balance of skills, experience and diversity of perspectives appropriate to the Company's business. Diversity of Board members can be achieved through consideration of a number of factors, including but not limited to gender, age, cultural and educational background, race, professional experience, skill, knowledge and length of service. All Board appointments will be based on merits, and candidates will be considered against objective criteria for their potential contribution to the Board and the Company, having due regard to the benefits of diversity on the Board. No measurable objective was set as at the date of this annual report. The implementation and effectiveness of board diversity policy have been reviewed by the Board during the Review Period and will be reviewed annually.



As at the date of this annual report, the Board comprises six Directors. One of them is female. The age of the Directors ranges from 45 to 63 representing, in the opinion of the Board, an appropriate balance of refreshment of ideas and experience. All the Executive Directors possess extensive experience in management, design, production and marketing of bedding products while the Independent Non-executive Directors possess professional knowledge and broad experience in accounting, management and retail business respectively. The Directors believe that the composition of the Board reflects the necessary diversity, whether considered in terms of gender, professional knowledge, skills and experience, appropriate to the requirements of the business development of the Group and effective leadership. The Directors are of the opinion that the present structure of the Board can ensure the independence and objectivity of the Board and provide a system of checks and balances to safeguard the interests of the Shareholders and the Company. As at the date of this annual report, the Board has not set any numerical targets and timelines for achieving gender diversity on the Board. The Nomination Committee will discuss periodically and when necessary, agree on further measurable objectives and plans for achieving diversity, including gender diversity, on the Board and recommend them to the Board for adoption.

The Board is mindful of the objectives for the factors as set out in the diversity policy for assessing the candidacy of the Board members and will ensure that any successors to the Board shall follow the diversity policy.

The Company understands and recognizes the benefits of diversified staff structure and regards it as one of the important elements in sustaining a long-term competitive advantage of the Company. A multicultural company should be comprised of employees with different gender, age, religion, skills, educational background, industry experience and other qualities so as to achieve the most appropriate structure and balance. As at 31 December 2023, the total number of employees (including the senior management) of the Group was 531 (2022: 519) with 119 male staff and 412 female staff. The male to female ratio in the workforce was about 1:3 and had been stable for last five years. The Company deemed this gender ratio as adequate and appropriate for a company with major business in retail and trading of bedding products and home accessories.

#### **Nomination Policy**

The Company has adopted a nomination policy. The Nomination Committee invites nominations of candidates from members of the Board and may also put forward other candidates when vacancies on the Board exist. Before making recommendations to the Board, the Nomination Committee reviews and assesses the suitability of candidates for directorship, according to certain assessment criteria, including but not limited to reputation for integrity, experience in the relevant industry, contributions to the Board and time commitments, and by making reference to the board diversity policy, the Company's needs and the current composition of the Board. The Board will also consider the independence of Independent Non-executive Directors before making appointments or recommendations. The Board may consider engaging an external recruitment agency to carry out the recruitment and selection process when necessary. A Shareholder can serve a notice, at least 7 days prior to the date of the general meeting with candidates standing for election as Directors, to the Company of intention to propose a person as a Director without nomination by the Nomination Committee or recommendation by the Board.

#### **Independent Views and Input**

In order to ensure independent views and input are available to the Board, the Board has developed the following mechanisms, including but not limited to:

- (i) at least one-third of Board members are Independent Non-executive Directors;
- (ii) every Independent Non-executive Director is appointed for a specific term and subject to retirement by rotation at least once every three years;
- (iii) Independent Non-executive Directors possess professional knowledge and broad experience;
- (iv) no Independent Non-executive Director has served the Company for more than nine years;
- (v) no Independent Non-executive Director holds more than six listed company directorships to make sure that each of Independent Non-executive Directors has sufficient time to make contributions to the Board;
- (vi) every Independent Non-executive Director has made an annual confirmation of his independence to the Company; and
- (vii) the Board, each of its Committees or every Director is able to seek professional advice in appropriate circumstances at the Company's expenses.

The implementation and effectiveness of relevant mechanisms have been reviewed by the Board during the Review Period and will be reviewed annually.

#### **Directors' Training and Continuing Professional Development**

Upon appointing a new Director, each new Director receives an induction package so as to ensure that the new Director has appropriate understanding of the Group's business and of a director's duties and responsibilities under the Listing Rules and the relevant statutory and regulatory requirements.

The Directors are continually updated on the latest development regarding the Listing Rules and relevant statutory requirements from time to time, to ensure compliance and enhance their awareness of good corporate governance practices. All Directors are encouraged to participate in continuous professional development courses and seminars to develop and refresh their knowledge and skills. During the Review Period, a training regarding updates on Listing Rules had been provided to the Directors by the legal adviser of the Company. The Company provided all Directors as well as the management with a training about anti-corruption by the Independent Commission Against Corruption (the "ICAC") in 2021 and updated anti-corruption materials of the ICAC and other organisations during the Review Period. The Company will invite the ICAC to provide updated trainings to Directors and the management of the Company from time to time.

#### **Functions and Duties of the Board**

The main functions and duties conferred on the Board include:

- (i) overall management of the business and strategic development;
- (ii) deciding business plans and investment plans;
- (iii) convening general meetings and reporting to the Shareholders; and
- (iv) exercising other powers, functions and duties conferred by the Shareholders in general meetings.

The Board is also responsible for performing the corporate governance duties as set out in Code Provision A.2 of the CG Code. However, the Company has established four Board Committees, namely the Audit Committee, the Remuneration Committee, the Nomination Committee and the Investment Committee, to assist the Board in discharging its duties and responsibilities. The Board Committees are provided with sufficient resources to discharge their duties and are able to obtain outside independent professional advice in connection with their duties at the Company's expenses.

#### **Board and Board Committees Meetings**

During the Review Period, the Board held five meetings. Apart from the adhoc meetings, the Board met regularly to monitor the operation as well as the financial performance of the Group and review and approve, among other things, the annual results, the interim results and the overall strategy of the Group. The Board considers that all meetings have legally and properly been convened during the Review Period.

With the assistance of the Company Secretary, the Chairman of the Board took the lead to ensure that Board and Board Committee meetings were convened in accordance with the requirements set out in the Articles of Association of the Company, the terms of reference of the respective Board Committees and the Listing Rules.

Prior notices convening the Board and Board Committees meetings were despatched to the Directors setting out the matters to be discussed. Before the meetings, the Directors were provided with the relevant documents to be discussed and approved for review in advance. The Company Secretary was responsible for keeping the minutes of Board and Board Committees meetings.

The minutes of Board and Board Committees meetings recorded in sufficient details the matters considered by Directors, including all concerns raised by the Directors and dissenting views expressed. The minutes of all Board and Board Committees meetings and written resolutions signed, if any, are kept by the Company Secretary and are available for inspection by any Directors, auditors or any relevant eligible parties who can have access to such minutes.

#### **Audit Committee**

The Company has established the Audit Committee with specific written terms of reference in compliance with the CG Code. The primary duties of the Audit Committee are to review the Group's financial reporting process, risk management and internal control systems and maintain an appropriate relationship with external auditors.

Mr. Lo Siu Leung is the Chairman of the Audit Committee. The Audit Committee comprises the following Independent Non-executive Directors:

Reference is made to the announcement "Grant of Share Options" published by the Company on 6 July 2023, there was no performance target attached to the share options granted by the Company under the 2022 Share Option Scheme on 6 July 2023 (the "Share Options") to certain eligible participants, including Executive Directors and senior managers of the Group, (the "Grantees"). The Remuneration Committee reviewed the grant of Share Options with the view that performance target was not necessary as the grant of Share Options (1) aligned the interests of the Grantees with those of the Company and the Shareholders; (2) motivated the Grantees to commit themselves to the continued competitiveness, operating results and future development and expansion of the Group; and (3) reinforced their commitment to the long-term services within the Group, which was therefore consistent with the purpose of the 2022 Share Option Scheme (i.e. to provide incentive or reward to eligible participants for their contributions to future development and expansion of, and continuing efforts to promote the interests of, the Group), after taking into account the following factors:

- the Share Options would be vested in tranches over a period of two years and subject to the clawback mechanism and the value of the Share Options was linked to the future Share price which was in turn linked to the operational and financial performance of the Company;
- (ii) the Grantees were either Executive Directors or other employees of the Group having direct contributions to and were responsible for the operation, growth and corporate governance of the Group and being in charge of the management of the Group; and

#### **Confirmation of Independence**

In compliance with Rule 3.10(1) of the Listing Rules, the Company has appointed three Independent Non-executive Directors. The Board considers that all Independent Non-executive Directors have appropriate and sufficient industry or finance experience and qualifications to carry out their duties so as to protect the interests of the Shareholders.

The Company has received a written annual confirmation from each of the Independent Non-executive Directors in respect of their independence in accordance with Rule 3.13 of the Listing Rules. The Board considers that all Independent Non-executive Directors are considered to be independent by reference to the factors stated in the Listing Rules.

#### **Directors' Securities Transactions**

The Company has adopted its own code of conduct for the Directors in their dealings in the Company's securities on terms no less exacting than the required standard set out in the Model Code. Having made specific enquiry to all the Directors of the Company, all the Directors confirmed that they had complied with the required standard of dealings as required by the Company's code of conduct and the Model Code throughout the Review Period. Save as disclosed herein, the Company considers that there has been no deviation from the Company's code of conduct and the Model Code during the Review Period.

#### **Directors' and Officers' Liability Insurance**

The Company has subscribed an insurance policy with an aim to indemnify its Directors and senior executives from any losses, claims, damages, liabilities and expenses arising from, including but not limited to, any proceedings brought against them during the performance of their duties pursuant to their respective service agreements or letters of re-appointment entered into with the Company.

#### **Procedure for Seeking Independent Professional Advice by Directors**

The Directors are able, upon reasonable request to seek professional advice in appropriate circumstances at the Company's expenses. The Board shall resolve to provide separate appropriate independent professional advice to the Directors to assist the relevant Directors to discharge their duties.

#### **Corporate Governance Function**

The Board is responsible for the overall oversight of corporate governance policies (with the aid of the Audit Committee). The primary corporate governance duties are to develop and review the Company's policies and practices on corporate governance; to review and monitor the training and continuous professional development of Directors and senior management; to review and monitor the Company's policies and practices on compliance with legal and regulatory requirements; to develop, review and monitor the code of conduct and compliance manual applicable to employees and Directors; and to review the Company's compliance with the CG Code and disclosures in the Corporate Governance Report.

#### Accountability and Audit

The Company provides the annual budget and monthly updates on the business performance with explanatory information to the Directors for them to understand the position, development and prospects of the Group.

The Directors acknowledge their responsibilities for preparing the financial statements of the Group in accordance with the statutory requirements and accounting standards and other financial disclosure requirements under the Listing Rules. The Directors also acknowledge their responsibilities to ensure that the financial statements of the Group are published in a timely manner as required by the Listing Rules.

The external auditor's statement about reporting responsibility is set out on pages 59 to 64.





#### **Risk Management and Internal Control**

During the Review Period, the Group has complied with the Principle D.2 of the CG Code by establishing appropriate and effective risk management and internal control systems. The management is responsible for the design, implementation and monitoring of such systems, while the Board oversees the management in performing its duties on an ongoing basis. Main features of the risk management and internal control systems are described in the sections below.

#### **Risk Management System**

The Group adopts a risk management system which manages the risk associated with its business and operations. The system comprises the following phases:

- *Identification*: Identify ownership of risks (including, amongst others, material risks relating to environment, social and governance ("ESG")), business objectives and risks that could affect the achievement of objectives.
- *Evaluation*: Analyse the likelihood and impact of risks and evaluate the risk portfolio accordingly.
- *Management*: Consider the risk responses, ensure effective communication to the Board and on-going monitor the residual risks.

#### **Internal Control System**

The Company has in place an internal control system which is compatible with the Committee of Sponsoring Organizations of the Treadway Commission ("COSO") 2013 framework. The framework enables the Group to achieve objectives regarding effectiveness and efficiency of operations, reliability of financial reporting and compliance with applicable laws and regulations. The components of the framework are shown as follows:

- *Control Environment*: A set of standards, processes and structures that provide the basis for carrying out internal control across the Group.
- *Risk Assessment*: A dynamic and iterative process for identifying and analysing risks to achieve the Group's objectives, forming a basis for determining how risks should be managed.
- *Control Activities*: Action established by policies and procedures to help ensure that management directives to mitigate risks to the achievement of objectives are carried out.
- *Information and Communication*: Internal and external communication to provide the Group with the information needed to carry out day-to-day controls.
- *Monitoring*: Ongoing and separate evaluations to ascertain whether each components of internal control is present and functioning.

The Group's risk management and internal control systems have been designed to mitigate significant risks in achieving its strategic objectives, safeguard its assets, maintain proper accounting records, execute appropriate limits of authority and ensure compliance with relevant laws and regulations. Such systems are to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable but not absolute assurance against material misstatement or loss.

#### **Disclosure of Inside Information**

The Group acknowledges its responsibilities to ensure potential inside information being captured and confidentiality of such information being maintained until consistent and timely disclosure are made in accordance with the Listing Rules. The Group has an inside information policy with the procedures and internal controls for the handling and dissemination of inside information as follows:

- the Group conducts its affairs with close regard to the disclosure requirements under the Listing Rules as well as the "Guidelines on Disclosure of Inside Information" published by the Securities and Futures Commission of Hong Kong in June 2012;
- the Group has implemented its policy on fair disclosure by pursuing broad, non-exclusive distribution of information to the public through public announcements and the Company website;
- the access of information is restricted to a limited number of employees on a need-to-know basis such that employees who are in possession of inside information are fully conversant with their obligations to preserve confidentiality; and
- the Group has established and implemented procedures for responding to external enquiries about the Group's affairs and only designated persons are authorised to speak on behalf of the Company when communicating with external parties such as the media, analysts or investors.

#### Whistle-blowing Policy and Anti-corruption Measures

The Company has established a whistle-blowing policy for employees and those who deal with the Company, including customers and suppliers, to raise concerns, in confidence and anonymity, (1) first to the management and then to the Audit Committee, if dissatisfied with the process handled by the management; or (2) direct to the Audit Committee, if deemed appropriate, about possible improprieties in any matter related to the Company. The management are required to refer serious cases to the Audit Committee for handling in order to ensure that proper arrangements are in place for fair and independent investigations of the matters.

With integrity and innovation as the core element of the Company's corporate culture, all employees of the Company are required to abide by the code of conduct of the Company, which strictly prohibits any form of corruptions, crimes or other immoral events that are detrimental to the Group or illegal and requires employees to declare any conflict of interests on business and work-related situations if arisen. Incidents and allegations or suspicions of fraud will be assessed and investigated by the management and would be escalated to the Audit Committee, where appropriate.





#### Effectiveness of the Risk Management and Internal Control Systems

The Board is responsible for maintaining and reviewing the effectiveness of the Group's risk management (including ESG risks) and internal control systems and ensuring review of the effectiveness of these systems is conducted annually (which has been done by the Board for the Review Period). While the Company does not have an internal audit function, it has appointed SHINEWING to carry out the internal audit function such as the analysis and independent appraisal of the adequacy and effectiveness of the Group's risk management and internal control systems covering financial, operational and legal compliance controls.

For the Review Period, the Audit Committee had a meeting with SHINEWING to review findings on the Group's risk management and internal control systems and respective corrective actions done on an on-going basis. The Board, through its review and the reviews by Audit Committee, concluded that the Group's risk management (including ESG risks) and internal control systems were adequate and effective and the Company had complied with the code provisions on risk management and internal control of the CG Code during the Review Period. The Board also considered that the resources, staff qualifications and experience of the Group for accounting, internal audit, financial reporting functions as well as those relating to ESG performance and reporting were adequate and the training programs and budget provided were sufficient.

#### **Company Secretary**

The Company Secretary of the Company is Mr. Ho Yiu Leung who fulfils the requirements under Rules 3.28 and 3.29 of the Listing Rues. His biography is set out in the "Directors and Senior Management" section of this annual report.

As an employee of the Company, the Company Secretary supports the Board, ensures good information flow within the Board and Board policy and procedures being followed, advises the Board on corporate governance matters, facilitates induction to each new Director and monitors the training and continuous professional development of Directors. He attained not less than 15 hours of relevant professional training during the Review Period.

#### **Dividend Policy**

The Company has adopted a dividend policy setting out the principles for the Board to determine appropriate amount of dividends to be distributed by way of interim dividends and/or final dividend to the Shareholders after taking into consideration of the factors stated in the policy, inter alia, (i) the actual and expected financial results of the Group; (ii) economic conditions and other factors with impacts on the business or financial performance and position of the Group; (iii) current and future operations, liquidity position and capital requirements; (iv) future development and investment needs; and (v) any other factors that the Board deems appropriate. The declaration of dividends or recommendation on such payment shall be subject to all applicable laws, rules and regulations including but not limited to the Listing Rules, the Companies Ordinance (Chapter 622 of the Laws of Hong Kong), the applicable laws of Cayman Islands and the Memorandum and Articles of the Company.

#### **Communications with Shareholders and Investors**

The Company has established a shareholders communication policy. The Company engages professional public relation consultancy companies to organise various investor relations programs (including regular briefing meetings with the media and analysts), whenever necessary, aiming at increasing the transparency of the Company, enhancing communication with Shareholders and investors, increasing their understanding of and confidence in the Group's businesses.

The general meetings of the Company provide a forum for communication between the Board and the Shareholders. The Chairmen of the Board as well as Board Committees and other Board members are available to answer questions at the general meeting of the Shareholders. The Company recognises the importance of maintaining on-going communications with the Shareholders and encourages them to attend Shareholders' meetings to stay informed of the Group's businesses and convey any concerns they may have to the Directors and senior management.

The Company maintains a website at http://www.casablanca.com.hk where extensive information and updates on the Company's financial information, corporate governance practices and other useful information are posted and available for access by public investors.

The Board reviewed the implementations and effectiveness of the shareholders communication policy during the Year. After review, the Board considered that the shareholders communication policy remained effective and was properly implemented given the multiple channels of communication in place during the Year.

The Board proposed to amend the Memorandum and Articles during the Year so as to, among other things, (i) reflecting the current requirements of the Listing Rules (in particular the core standards); and (ii) providing greater flexibility to the Company in relation to the conduct of general meetings by allowing (but not requiring) general meetings to be held as a hybrid meeting where the Shareholders may attend by electronic means in addition to as a physical meeting where Shareholders attend in person. The proposed amendments to the Memorandum and Articles and adoption of the new Memorandum and Articles were approved by the Shareholders at the annual general meeting of the Company held on 15 May 2023.

## How Shareholders can convene an extraordinary general meeting and putting forward proposals at Shareholders' meetings


Pursuant to Article 12.3 of the Articles of Association, any one or more Shareholders holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition deposited at the principal office of the Company in Hong Kong specifying the objects of the meeting and signed by the requisitionist(s), to require an extraordinary general meeting to be convened by the Board. If the Board does not within 21 days of such deposit of the requisition proceed duly to convene the meeting to be held within a further 21 days, the requisitionist(s) himself (themselves) representing more than one-half of the total rights of all of them may do so in the same manner as that in which meetings may be convened by the Board provided that any meeting so convened shall not be held after three months from the date of deposit of the requisition. All reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

In respect of proposing a person for election as a Director at general meetings, the period during which a written notice of intention to propose a person for election as a Director and a written notice by that person of his willingness to be elected are to be given to the Company shall be at least 7 days, such period shall commence on the day after the date when the notice of the general meeting convened for such election is dispatched and end no later than 7 days prior to the date of such meeting.

#### Procedures by which enquiries may be put to the Board

Shareholders may send their enquiries and concerns to the Board by addressing them to the Company Secretary by mail to the principal office of the Company in Hong Kong. The Company Secretary forwards communications relating to matters within the Board's purview to the Board and communications relating to ordinary business matters, such as suggestions, inquiries and consumer complaints, to the Chief Executive Officer.

#### Opinion

We have audited the consolidated financial statements of Casablanca Group Limited (the "Company") and its subsidiaries (collectively referred to as "the Group") set out on pages 65 to 128, which comprise the consolidated statement of financial position as at 31 December 2023 and the consolidated statement of profit or loss and other comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows for the year then ended and notes to the consolidated financial statements, including material accounting policy information and other explanatory information.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 December 2023 and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

#### **Basis for Opinion**

#### Estimated allowance for finished goods

Refer to notes 4 and 17 to the consolidated financial statements

At 31 December 2023, the carrying amount of finished goods is HK\$47,837,000 (net of allowance for finished goods of HK\$12,274,000).

We identified the estimated allowance for finished goods as a key audit matter due to the use of judgment and estimates by the management in identifying aged or obsolete, or out-of-season finished goods and estimating the allowance for finished goods.

Aged or obsolete, or out-of-season finished goods were identified by the management based on aging, conditions and marketability of finished goods.

Allowance is applied to finished goods based on assessment of net realisable value by the management, by considering the current market conditions, product life cycle, marketing and promotion plans, historical sales records, aging analysis and subsequent selling prices of the finished goods. Our procedures in relation to assessing the appropriateness of the estimated allowance for finished goods included:

- Obtaining an understanding of how allowance for finished goods is estimated by the management.
- Discussing with the management and evaluating the basis of identification of aged or obsolete, or out-ofseason finished goods by the management, based on the current market conditions, product life cycle and marketing and promotion plans.
- Testing the aging analysis of finished goods, on a sample basis, to the goods received notes or the warehouse receipts.
- Assessing the reasonableness of allowance for finished goods with reference to historical sales records, current market conditions, product life cycle, marketing and promotion plans, aging analysis and subsequent selling prices of the finished goods.
- Tracing of finished goods with subsequent selling prices to the sales invoices, on a sample basis.
- Evaluating the historical accuracy of the allowance estimation by the management by comparing historical allowance made to the actual selling prices and actual loss incurred, and tracing the selling prices, on a sample basis, to the sales invoices.

#### Key audit matter

#### How our audit addressed the key audit matter

#### Estimated loss allowance for trade receivables due from distributors

Refer to notes 4, 18 and 33 to the consolidated financial statements

As at 31 December 2023, included in the trade receivables of HK\$34,656,000, HK\$6,938,000 were due from distributors (net of loss allowance of HK\$857,000).

We identified the estimated loss allowance for trade receivables due from distributors as a key audit matter due to the use of judgment and estimates by the management on the recoverability of trade receivables due from distributors.

In general, the credit terms granted by the Group to distributors ranged between 30 to 90 days. Management performed periodic assessment on the recoverability of the trade receivables due from distributors and the sufficiency of provision for impairment based on information including credit profile of different distributors, aging of the trade receivables due from distributors, historical settlement records, expected timing and amount of realization of outstanding balances, and on-going trading relationships with the relevant distributors. Management also considered forward looking information that may impact the distributors' ability to repay the outstanding balances in order to estimate the expected credit losses ("ECL") for the impairment assessment. Our procedures in relation to assessing the appropriateness of the estimated loss allowance for trade receivables due from distributors included:

- Reviewing and assessing the Group's policy for calculating the ECL.
- Assessing the reasonableness of management's loss allowance estimates by examining the information used by management to form such judgements, including testing the accuracy of the historical default data, evaluating whether the historical loss rates are appropriately adjusted based on current economic conditions and forward-looking information and examining the actual losses recorded during the current financial year and assessing whether there was an indication of management bias when recognising loss allowances.
- Evaluating techniques and methodology in the ECL model against the requirements of HKFRS 9.
- Evaluating the design, implementation and operating effectiveness of key internal controls which govern credit control, debt collection and estimation of ECL.
- Testing the aging analysis of the trade receivables due from distributors, on a sample basis, to the sales invoices.
- Discussing with the management and evaluating the basis of identification of distributors with distribution agreements early terminated or not renewed or distributors who delayed settlements and their assessment on the recoverability of trade receivables due from these distributors.
- Tracing of the subsequent settlements to the bank receipts, on a sample basis.

## NOTES TO THE CONSOLIDATED FINANCIAL STATEMENTS

For the year ended 31 December 2023

#### 1. General

The Company is a public limited company incorporated in the Cayman Islands and its shares are listed on the Stock Exchange. Its parent company is World Empire Investment Inc., a company incorporated in the British Virgin Islands (the "BVI"), and its ultimate controlling parties are Mr. Cheng Sze Kin, who is the Chairman of the Company, Mr. Cheng Sze Tsan and Ms. Wong Pik Hung (the "Ultimate Beneficial Owners"). The addresses of the registered office and principal place of business of the Company are disclosed in the "Corporate Information" section in the annual report.

The principal activity of the Company is investment holding. The principal activities of its subsidiaries are manufacture and trading of bedding products and trading of home accessories and furniture.

The consolidated financial statements are presented in Hong Kong dollars ("HK\$"), which is also the functional currency of the Company.

The Group is in the process of making an assessment of what the impact of these developments is expected to be in the period of initial application. So far it has concluded that the adoption of them is unlikely to have a significant impact on the consolidated financial statements.

#### 3. Material Accounting Policies

The consolidated financial statements have been prepared in accordance with HKFRSs issued by the HKICPA. For the purpose of preparation of the consolidated financial statements, information is considered material if such information is reasonably expected to influence decisions made by primary users. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on the Stock Exchange ("Listing Rules") and by the Hong Kong Companies Ordinance.

The consolidated financial statements have been prepared on the historical cost basis except for financial instruments that are measured at fair values at the end of each reporting period, as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 Share-based Payment, leasing transactions that are accounted for in accordance with HKFRS 16, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 Inventories or value in use in HKAS 36 Impairment of Assets.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

The principal accounting policies are set out below.

### **Basis of consolidation**

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Group. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

#### Basis of consolidation (continued)

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies in line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

Non-controlling interests in subsidiaries are presented separately from the Group's equity therein, which represent present ownership interests entitling their holders to a proportionate share of net assets of the relevant subsidiaries upon liquidation.

#### **Revenue from contracts with customers**

The Group recognises revenue when (or as) a performance obligation is satisfied, i.e. when "control" of the goods or services underlying the particular performance obligation is transferred to the customer.

A performance obligation represents a good or service (or a bundle of goods or services) that is distinct or a series of distinct goods or services that are substantially the same.

The Group's revenue is recognised at a point in time when the customer obtains control of the distinct good or service.

For retail customers, including e-sales, sales are recognised when the customers accept and take the control of the products.

For the distributor customers and wholesale customers, sales are recognised when control of the products has transferred, being when the products are delivered and the customers has inspected and accepted the products. Distributors have full discretion over the channel and price to sell the products, and there is no more unfulfilled obligation that could affect the acceptance of the products. Delivery occurs when the products have been shipped to the specific location. The risks of obsolescence and loss have been transferred to the customers when either the customer has accepted the products in accordance with the sales contract, or the Group has objective evidence that all criteria for acceptance have been satisfied.

A contract liability represents the Group's obligation to transfer goods or services to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer.

Property, plant and equipment are tangible assets that are held for use in the production or supply of goods or services, or for administrative purposes other than properties under construction as described below. Property, plant and equipment are stated in the consolidated statement of financial position at cost less subsequent accumulated depreciation and accumulated impairment losses, if any.

Buildings in the course of construction for production, supply or administrative purposes are carried at cost, less any recognised impairment loss. Costs include any costs directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management. Depreciation of these assets, on the same basis as other property assets, commences when the assets are ready for their intended use.

When the Group makes payments for ownership interests of properties which includes both leasehold land and building elements, the entire consideration is allocated between the leasehold land and the building elements in proportion to the relative fair values at initial recognition.

To the extent the allocation of the relevant payments can be made reliably, interest in leasehold land is presented as "right-of-use assets" in the consolidated statement of financial position. When the consideration cannot be allocated reliably between non-lease building element and undivided interest in the underlying leasehold land, the entire properties are classified as property, plant and equipment.

Depreciation is recognised so as to write off the cost of assets other than properties under construction less their residual values over their estimated useful lives, using the straight-line method. The estimated useful lives and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the net disposal proceeds, if any, and the carrying amount of the asset and is recognised in profit or loss.

### **Investment properties**

Investment properties are properties held to earn rentals and/or for capital appreciation.

Investment properties are initially measured at cost, including any directly attributable expenditure. Subsequent to initial recognition, investment properties are stated at cost less subsequent accumulated depreciation and any accumulated impairment losses. Depreciation is recognised so as to write off the cost of investment properties over their estimated useful lives and after taking into account of their estimated residual value, using the straight-line method.

An investment property is derecognised upon disposal or when the investment property is permanently withdrawn from use and no future economic benefits are expected from its disposal. Any gain or loss arising on derecognition of the property (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in profit or loss in the period in which the property is derecognised.

#### Leases

#### **Definition of a lease**

A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

For contracts entered into or modified on or after the date of initial application or arising from business combinations, the Group assesses whether a contract is or contains a lease based on the definition under HKFRS 16 at inception, modification date or acquisition date, as appropriate. Such contract will not be reassessed unless the terms and conditions of the contract are subsequently changed.

#### Allocation of consideration to components of a contract

For a contract that contains a lease component and one or more additional lease or non-lease components, the Group allocates the consideration in the contract to each lease component on the basis of the relative standalone price of the lease component and the aggregate stand-alone price of the non-lease components.

Non-lease components are separated from lease component and are accounted for by applying other applicable standards.

As a practical expedient, leases with similar characteristics are accounted on a portfolio basis when the Group reasonably expects that the effects on the consolidated financial statements would not differ materially from individual leases within the portfolio.

#### Short-term leases and leases of low-value assets

The Group applies the short-term lease recognition exemption to leases of rented premises and department store counters that have a lease term of 12 months or less from the commencement date and do not contain a purchase option. It also applies the recognition exemption for lease of low-value assets. Lease payments on short-term leases and leases of low-value assets are recognised as expense on a straight-line basis or another systematic basis over the lease term.

#### Right-of-use assets

The cost of right-of-use asset includes:

- the amount of the initial measurement of the lease liability;
- any lease payments made at or before the commencement date, less any lease incentives received;
- any initial direct costs incurred by the Group; and
- an estimate of costs to be incurred by the Group in dismantling and removing the underlying assets, restoring the site on which it is located or restoring the underlying asset to the condition required by the terms and conditions of the lease.

Right-of-use assets are measured at cost, less any accumulated depreciation and impairment losses, and adjusted for any remeasurement of lease liabilities other than adjustments to lease liabilities resulting from COVID-19-related rent concessions in which the Group applied the practical expedient.

Right-of-use assets in which the Group is reasonably certain to obtain ownership of the underlying leased assets at the end of the lease term are depreciated from commencement date to the end of the useful life. Otherwise, right-of-use assets are depreciated on a straight-line basis over the shorter of its estimated useful life and the lease term.

#### Right-of-use assets (continued)

The Group presents right-of-use assets as a separate line item on the consolidated statement of financial position, except for certain leasehold land that the allocation of the relevant payments cannot be made reliably.

#### Refundable rental deposits

Refundable rental deposits paid are accounted under HKFRS 9 and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments and included in the cost of right-of-use assets.

#### Lease liabilities

At the commencement date of a lease, the Group recognises and measures the lease liability at the present value of lease payments that are unpaid at that date. In calculating the present value of lease payments, the Group uses the incremental borrowing rate at the lease commencement date if the interest rate implicit in the lease is not readily determinable.

The lease payments include:

- fixed payments (including in-substance fixed payments) less any lease incentives receivable;
- variable lease payments that depend on an index or a rate, initially measured using the index or rate as at the commencement date;
- amounts expected to be payable by the Group under residual value guarantees;
- the exercise price of a purchase option if the Group is reasonably certain to exercise the option; and
- payments of penalties for terminating a lease, if the lease term reflects the Group exercising an option to terminate the lease.

Variable lease payments that do not depend on an index or a rate are not included in the measurement of lease liabilities and right-of-use assets, and are recognised as expense in the period in which the event or condition that triggers the payment occurs.

After the commencement date, lease liabilities are adjusted by interest accretion and lease payments.

The Group remeasures lease liabilities (and makes a corresponding adjustment to the related right-of-use assets) whenever the lease term has changed or there is a change in the assessment of exercise of a purchase option, in which case the related lease liability is remeasured by discounting the revised lease payments using a revised discount rate at the date of reassessment.

The Group presents lease liabilities as a separate line item on the consolidated statement of financial position.

#### Lease modifications

Except for COVID-19-related rent concessions in which the Group applied the practical expedient, the Group accounts for a lease modification as a separate lease if:

- the modification increases the scope of the lease by adding the right to use one or more underlying assets; and
- the consideration for the leases increases by an amount commensurate with the stand-alone price for the increase in scope and any appropriate adjustments to that stand-alone price to reflect the circumstances of the particular contract.

For a lease modification that is not accounted for as a separate lease, the Group remeasures the lease liability based on the lease term of the modified lease by discounting the revised lease payments using a revised discount rate at the effective date of the modification.

The Group accounts for the remeasurement of lease liabilities by making corresponding adjustments to the relevant right-of-use asset. When the modified contract contains a lease component and one or more additional lease or non-lease components, the Group allocates the consideration in the modified contract to each lease component on the basis of the relative stand-alone price of the lease component and the aggregate stand-alone price of the non-lease components.

#### COVID-19-related rent concessions

In relation to rent concessions that occurred as a direct consequence of the COVID-19 pandemic, the Group has elected to apply the practical expedient not to assess whether the change is a lease modification if all of the following conditions are met:

- the change in lease payments results in revised consideration for the lease that is substantially the same as, or less than, the consideration for the lease immediately preceding the change;
- any reduction in lease payments affects only payments originally due on or before 30 June 2022; and
- there is no substantive change to other terms and conditions of the lease.

A lessee applying the practical expedient accounts for changes in lease payments resulting from rent concessions the same way it would account for the changes applying HKFRS 16 if the changes are not a lease modification. Forgiveness or waiver of lease payments are accounted for as variable lease payments. The related lease liabilities are adjusted to reflect the amounts forgiven or waived with a corresponding adjustment recognised in the profit or loss in the period in which the event occurs.

#### Classification and measurement of leases

Leases for which the Group is a lessor are classified as finance or operating leases. Whenever the terms of the lease transfer substantially all the risks and rewards incidental to ownership of an underlying asset to the lessee, the contract is classified as a finance lease. All other leases are classified as operating leases.

Rental income from operating leases is recognised in profit or loss on a straight-line basis over the term of the relevant lease. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset, and such costs are recognised as an expense on a straight-line basis over the lease term except for investment properties measured under fair value model.

#### **Inventories**

Inventories are stated at the lower of cost and net realisable value. Costs of inventories are determined on a weighted average method and, in case of finished goods, comprises direct materials, direct labour and an appropriate proportion of overheads. Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale.

#### **Provisions and contingent liabilities**

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, it is probable that the Group will be required to settle that obligation, and a reliable estimate can be made of the amount of the obligation.

The amount recognised as a provision is the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation. When a provision is measured using the cash flows estimated to settle the present obligation, its carrying amount is the present value of those cash flows (where the effect of the time value of money is material).

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events, are also disclosed as contingent liabilities unless the probability of outflow of outflow of economic benefits is remote.

Financial assets and financial liabilities are recognised when a group entity becomes a party to the contractual provisions of the instruments.

Financial assets and financial liabilities are initially measured at fair value except for trade receivables arising from contracts with customers which are initially measured in accordance with HKFRS 15. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets or financial liabilities at fair value through profit or loss ("FVTPL")) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction cost directly attributable to the acquisition of financial liabilities at FVTPL are recognised immediately in profit or loss.

The effective interest method is a method of calculating the amortised cost of a financial asset or financial liability and of allocating interest income and interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts and payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial asset or financial liability, or, where appropriate, a shorter period, to the net carrying amount on initial recognition.

Financial assets that meet the following conditions are subsequently measured at amortised cost:

- the financial asset is held within a business model whose objective is to collect contractual cash flows; and
- the contractual terms give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

Financial assets that meet the following conditions are subsequently measured at fair value through other comprehensive income ("FVTOCI"):

- the financial asset is held within a business model whose objective is achieved by both selling and collecting contractual cash flows; and
- the contractual terms give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

All other financial assets are subsequently measured at FVTPL, except that at initial recognition of a financial asset the Group may irrevocably elect to present subsequent changes in fair value of an equity investment in other comprehensive income if that equity investment is neither held for trading nor contingent consideration recognised by an acquirer in a business combination to which HKFRS 3 Business Combinations applies.

A financial asset is classified as held for trading if:

- it has been acquired principally for the purpose of selling in the near term; or
- on initial recognition it is a part of a portfolio of identified financial instruments that the Group manages together and has a recent actual pattern of short-term profit-taking; or
- it is a derivative that is not designated and effective as a hedging instrument.

In addition, the Group may irrevocably designate a financial asset that are required to be measured at the amortised cost or FVTOCI as measured at FVTPL if doing so eliminates or significantly reduces an accounting mismatch.

#### Amortised cost and interest income

Interest income is recognised using the effective interest method for financial assets measured subsequently at amortised cost. Interest income is calculated by applying the effective interest rate to the gross carrying amount of a financial asset, except for financial assets that have subsequently become credit-impaired (see below). For financial assets that have subsequently become credit-impaired, interest income is recognised by applying the effective interest rate to the amortised cost of the financial asset from the next reporting period. If the credit risk on the credit-impaired financial instrument improves so that the financial asset is no longer credit-impaired, interest income is recognised by applying the effective interest rate to the gross carrying amount of the financial asset from the beginning of the reporting period following the determination that the asset is no longer credit impaired.

#### Financial assets at FVTPL

Financial assets that do not meet the criteria for being measured at amortised cost or FVTOCI or designated as FVTOCI are measured at FVTPL.

Financial assets at FVTPL are measured at fair value at the end of each reporting period, with any fair value gains or losses recognised in profit or loss. The net gain or loss recognised in profit or loss excludes any dividend or interest earned on the financial asset and is included in the "other losses" line item.

#### Impairment of financial assets

The Group performs impairment assessment under expected credit loss ("ECL") model on financial assets (including trade receivables) which are subject to impairment assessment under HKFRS 9. The amount of ECL is updated at each reporting date to reflect changes in credit risk since initial recognition.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of the relevant instrument. In contrast, 12-month ECL ("12m ECL") represents the portion of lifetime ECL that is expected to result from default events that are possible within 12 months after the reporting date. Assessment are done based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current conditions at the reporting date as well as the forecast of future conditions.

The Group always recognises lifetime ECL for trade receivables.

#### Impairment of financial assets (continued)

For all other instruments, the Group measures the loss allowance equal to 12m ECL, unless when there has been a significant increase in credit risk since initial recognition, in which case the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increases in the likelihood or risk of a default occurring since initial recognition.

#### (i) Significant increase in credit risk

In assessing whether the credit risk has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk, e.g. a significant increase in the credit spread, the credit default swap prices for the debtor;
- existing or forecast adverse changes in business, financial or economic conditions that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations;
- an actual or expected significant deterioration in the operating results of the debtor;
- an actual or expected significant adverse change in the regulatory, economic, or technological environment of the debtor that results in a significant decrease in the debtor's ability to meet its debt obligations.

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

(ii) Definition of default

For internal credit risk management, the Group considers an event of default occurs when information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group).

Irrespective of the above, the Group considers that default has occurred when a financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

#### (iii) Credit-impaired financial assets

A financial asset is credit-impaired when one or more events of default that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- (a) significant financial difficulty of the issuer or the borrower;
- (b) a breach of contract, such as a default or past due event;
- (c) the lender(s) of the borrower, for economic or contractual reasons relating to the borrower's financial difficulty, having granted to the borrower a concession(s) that the lender(s) would not otherwise consider; or
- (d) it is becoming probable that the borrower will enter bankruptcy or other financial reorganization.

#### (iv) Write-off policy

The Group writes off a financial asset when there is information indicating that the counterparty is in severe financial difficulty and there is no realistic prospect of recovery, for example, when the counterparty has been placed under liquidation or has entered into bankruptcy proceedings, whichever occurs sooner. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. A write-off constitutes a derecognition event. Any subsequent recoveries are recognised in profit or loss.

(v) Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward-looking information. Estimation of ECL reflects an unbiased and probability-weighted amount that is determined with the respective risks of default occurring as the weights.

(v) Measurement and recognition of ECL (continued)

Generally, the ECL is the difference between all contractual cash flows that are due to the Group in accordance with the contract and the cash flows that the Group expects to receive, discounted at the effective interest rate determined at initial recognition.

Lifetime ECL for certain trade receivables are considered on a collective basis taking into consideration past due information and relevant credit information such as forward looking macroeconomic information.

For collective assessment, the Group takes into consideration the following characteristics when formulating the grouping:

- Nature of financial instruments (i.e. the Group's trade and other receivables are each assessed as a separate group);
- Past-due status;
- Nature, size and industry of debtors; and
- External credit ratings where available.

The grouping is regularly reviewed by management to ensure the constituents of each group continue to share similar credit risk characteristics.

The Group recognises an impairment gain or loss in profit or loss for all financial instruments by adjusting their carrying amount, with the exception of trade receivables where the corresponding adjustment is recognised through a loss allowance account.

#### **Financial liabilities and equity instruments**

Debt and equity instruments issued by a group entity are classified as either financial liabilities or as equity in accordance with the substance of the contractual arrangements and the definitions of a financial liability and an equity instrument.

#### **Equity instruments**

An equity instrument is any contract that evidences a residual interest in the assets of an entity after deducting all of its liabilities. Equity instruments issued by the Company are recognised at the proceeds received, net of direct issue costs.

Financial liabilities including trade and bills payables, other payables and bank borrowings are subsequently measured at amortised cost using the effective interest method.

#### Derecognition

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity.

On derecognition of a financial asset in its entirety, the difference between the asset's carrying amount and the sum of the consideration received and receivable is recognised in profit or loss.

The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable is recognised in profit or loss.

#### Share options granted to employees

For grants of share options that are conditional upon satisfying specified vesting conditions, the fair value of services received is determined by reference to the fair value of share options granted at the date of grant and is expensed on a straight-line basis over the vesting period, with a corresponding increase in equity (share options reserve).

At the end of the reporting period, the Group revises its estimates of the number of options that are expected to ultimately vest. The impact of the revision of the original estimates, if any, is recognised in profit or loss such that the cumulative expense reflects the revised estimate, with a corresponding adjustment to share options reserve.

When share options are exercised, the amount previously recognised in share options reserve will be transferred to share premium. When the share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in share options reserve will be transferred to accumulated profits.

# Impairment losses on right-of-use assets, tangible and intangible assets

At the end of the reporting period, the Group reviews the carrying amounts of its right-of-use assets, tangible and intangible assets with finite useful lives to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss, if any.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset (or a cash-generating unit) for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or a cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or a cash-generating unit) is reduced to its recoverable amount. In allocating the impairment loss, the impairment loss is allocated first to reduce the carrying amount of any goodwill (if applicable) and then to the other assets on a pro-rata basis based on the carrying amount of each asset in the unit or the group of cash-generating units. The carrying amount of an asset is not reduced below the highest of its fair value less costs of disposal (if measurable), its value in use (if determinable) and zero. The amount of the impairment loss that would otherwise have been allocated to the asset is allocated pro rata to the other assets of the unit or the group of cash-generating units. An impairment loss is recognised immediately in profit or loss.

Where an impairment loss subsequently reverses, the carrying amount of the asset (or cash-generating unit or a group of cash-generating units) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or cash-generating unit or a group of cash-generating units) in prior years. A reversal of an impairment loss is recognised immediately in profit or loss.

### **Foreign currencies**

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlements of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. HK\$) using exchange rates prevailing at the end of each reporting period. Income and expenses items are translated at the average exchange rates for the year. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of translation reserve.

### Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets until such time as the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

### **Government** grants

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received.

Government grants are recognised in profit or loss on a systematic basis over the periods in which the Group recognises as expenses the related costs for which the grants are intended to compensate.

### **Retirement benefit costs**

Payments to state-managed retirement benefit schemes and the Mandatory Provident Fund Scheme (the "MPF Scheme") are recognised as an expense when employees have rendered service entitling them to the contributions.

## Short-term benefits

Short-term employee benefits are recognised at the undiscounted amount of the benefits expected to be paid as and when employees rendered the services. All short-term employee benefits are recognised as an expense unless another HKFRS requires or permits the inclusion of the benefit in the cost of an asset.

A liability is recognised for benefits accruing to employees (such as wages and salaries, annual leave and sick leave) after deducting any amount already paid.

Liabilities recognised in respect of other long-term employee benefits are measured at the present value of the estimated future cash outflows expected to be made by the Group in respect of services provided by employees up to the reporting date. Any changes in the liabilities' carrying amounts resulting from service cost, interest and remeasurements are recognised in profit or loss except to the extent that another HKFRS requires or permits their inclusion in the cost of an asset.

#### Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from "profit before taxation" as reported in the consolidated statement of profit or loss and other comprehensive income because of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax base used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary difference to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit and at the time of the transaction does not give rise to equal taxable and deductible temporary differences. In addition, deferred tax liabilities are not recognised if the temporary differences arise for the initial recognition of goodwill.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rate (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

Current and deferred tax are recognised in profit or loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively.

## 4. Key Sources of Estimation Uncertainty

The followings are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets within the next financial year.

### Estimated allowance for finished goods

Aged or obsolete, or out-of-season finished goods were identified by the management based on aging, conditions and marketability of finished goods. Allowance is applied to finished goods based on assessment of net realisable value by the management, by considering the current market conditions, product life cycle, marketing and promotion plans, historical sales records, aging analysis and subsequent selling prices of the finished goods.

As at 31 December 2023, the carrying amount of finished goods is HK\$47,837,000 (2022: HK\$45,690,000) (net of allowance for finished goods of HK\$12,274,000 (2022: HK\$16,388,000)).

### Provision of ECL for trade receivables

The Group uses provision matrix to calculate ECL for the trade receivables. The provision rates are based on debtors' aging as groupings of various debtors that have same credit periods and similar payment patterns. The provision matrix is based on the Group's historical default rates taking into consideration forward-looking information that is reasonably and supportably available without undue costs or effort. At every reporting date, the historical observed default rates are reassessed and changes in the forward-looking information are considered. In addition, trade receivables with significant balances and credit impaired are assessed for ECL individually.

As at 31 December 2023, the carrying amount of trade receivables due from distributors is HK\$6,938,000 (2022: HK\$5,372,000) (net of loss allowance of HK\$857,000 (2022: HK\$5,906,000)).

The provision of ECL is sensitive to changes in estimates. The information about the ECL and the Group's trade receivables are disclosed in notes 18 and 33 respectively.

## 5. Revenue and Segment Information

The Group's operating activities are attributable to a single operating segment focusing on manufacture and sales of bedding products. This operating segment has been identified on the basis of internal management reports prepared in accordance with accounting policies conform to HKFRSs, that are regularly reviewed by the executive directors of the Company, the chief operating decision maker of the Group. The executive directors of the Company review revenue analysis by (i) self-operated retail sales; (ii) e-sales; (iii) sales to distributors and (iv) others. However, other than revenue analysis, no operating results and other discrete financial information is available for the assessment of performance of the Group as a whole to make decision about resources allocation. No analysis of segment assets or segment liabilities is presented as they are not regularly provided to the executive directors of the Company. Accordingly, no analysis of this single operating segment is presented.

• Self-operated retail sales: Sales through the self-operated retail sales channel refer to retail sales to end-user consumers at the self-operated concession counters in department stores and self-operated retail stores.

- E-sales: E-sales refer to retail sales to end-user consumers through online platforms on internet or mobile devices operated by the Group or third parties, but not by distributors or wholesale customers.
- Sales to distributors: Sales to distributors refer to the sales to distributors who resell the products to end-user consumers, typically at concession counters in department stores and retail stores operated by distributors.
- Others: Other sales include sales to wholesale customers located in the PRC and Hong Kong and Macau, and sales made to overseas customers.

- (iii) the exercise price of the share option will be determined at the highest of the closing price of the Company's shares on the Stock Exchange on the date of grant and the average of closing prices of the Company's shares on the Stock Exchange on the five business days immediately preceding the date of grant of the option;
- (iv) the maximum number of shares in respect of which options may be granted shall not exceed 20,000,000 shares representing 10% of the total number of shares in issue at the date of listing of the shares of the Company on the Main Board of the Stock Exchange (representing 7.76% of the issued shares of the Company as at the date of this annual report);
- any offer of share options may be accepted in writing received by any director or the secretary of the Company on the date specified in the offer and the grantee shall pay HK\$1.00 to the Company by way of consideration for the grant upon acceptance of the options;
- (vi) the maximum entitlement of each eligible participant in any 12-month period up to the date of offer to grant shall not exceed 1% of the shares in issue as at the date of offer to grant; and
- (vii) the Board of Directors may, at its discretion, fix any minimum period for which an option must be held, any performance targets that must be achieved and/or any other conditions (including the exercise price) that must be fulfilled before an option can be exercised.

During the year ended 31 December 2022, a share option scheme (the "2022 Share Option Scheme") was adopted pursuant to the ordinary resolution by the shareholders of the Company passed on 6 June 2022 for the primary purpose of providing incentives or rewards to directors, other than independent non-executive directors, or eligible employees, motivating the eligible participants to optimize their performance efficiency for the benefit of the Company and tracking and retaining with the eligible participants. The principal terms of the 2022 Share Option Scheme are as follows:

- (ii) options may be exercised at any time during a period commencing on or after the date on which the option is accepted and granted and expiring on a date to be notified by the Board of Directors to each grantee which shall not be more than 10 years from the date on which the option is accepted and granted;

## 27. Retirement Benefit Schemes

The Group participates in a MPF Scheme for all qualifying employees in Hong Kong. The assets of the MPF Scheme are held separately from those of the Group in funds under the control of trustees. Mandatory benefits are provided under the MPF Scheme. The Group contributes the lower of 5% of the relevant payroll costs and HK\$1,500 per employee per month to the MPF Scheme.

Employees of subsidiaries in the PRC are members of the state-managed retirement benefit schemes operated by the PRC government. The subsidiaries are required to contribute a certain percentage of their payroll to the retirement benefit schemes to fund the benefits. The only obligation of the Group with respect to the statemanaged retirement benefit schemes is to make the required contributions.

At 31 December 2023, the Group had no forfeited contributions available to reduce its contributions to the MPF Scheme in Hong Kong and the stated-managed retirement benefit schemes in the PRC in future years (2022: Nil).

#### **Credit risk**

The Group's maximum exposure to credit risk in the event of the counterparties failure to perform their obligations as at 31 December 2023 in relation to each class of recognised financial assets is the carrying amount of these assets as stated in the consolidated statement of financial position.

In order to minimise the credit risk, the management of the Group has delegated a team responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts.
