CHAIRMAN'S STATEMENT

Dear Shareholders,

On behalf of the Board of Directors of Honliv Healthcare Management Group Company Limited, I have the honour to present to you the annual report of the Company for the year ended 31 December 2023.

In 2023, the Hong Kong stock market was inevitably affected by the frequent occurrence of major international political events and the volatility of the international financial markets. Benefiting from the full support of our shareholders as in the past, the strict and efficient corporate governance of the management and the hard work of all staff, the Group's operating results had steadily increased, our social responsibilities had been strengthened and we had been recognized in the capital market. On behalf of the Board of Directors of the Group, I would like to extend our sincerest greetings and best wishes to the shareholders, all staff and all investors.

In 2023, the Group, in line with the attitude of being responsible for shareholders, investors, the community and staff, expanded the scope of its main business services to build an elderly-friendly hospital; enhanced the ability of nursing care services to align with international nursing care services, and achieved honours in international academic conferences for its nursing care scientific research work; and carried out medical scientific publicity in a variety of forms, contributing to the realization of the goal of a healthy China; spared no effort to carry out medical scientific research, forming a good situation in which scientific research empowered medical treatment and medical treatment boosted scientific research; comprehensively practiced the ESG development concept and realized high-quality green development.

The Group strictly complies with the relevant laws and regulations for listed companies, diligently performs its duties, has statutory rights and responsibilities, transparent rights and responsibilities, co-ordinated operation, effective controls and balances, and the corporate governance mechanism has been continuously improved. It has laid a solid institutional foundation for ensuring the legitimate rights and interests of investors.

Based on strict and efficient corporate governance, the Group achieved promising results in 2023. Consolidated revenue for the year ended 31 December 2023 amounted to RMB760.5 million, representing an increase of 4.5% as compared with the corresponding period, with inpatient visits totalling 54,795, representing a year-on-year increase of 7.6%, and outpatient visits totalling 1,400,791, representing a year-on-year increase of 8.9%.

Looking ahead, there are both opportunities and challenges for the healthcare services industry.

The State has issued opinions on promoting the development and growth of the private economy, affirming that the private economy is an important force in promoting Chinese-style modernization, accelerating the cultivation of new-quality productive forces, and vigorously developing new types of consumption such as health consumption. At present, China's per capita GDP has exceeded 12,000 US dollars, and the middle-income group has more than 400 million people, which is the largest in the world and still increasing, forming a super-large and growing domestic market, which provide strong support for the high-quality development of healthcare services; Meanwhile, the market access of the healthcare services will be further expanded and opened up, and the competition in the market of the healthcare services will be more active.

The Group will follow the trend of the times, grasp the favourable time for development, ride on the momentum, continue to strive for further remarkable success.

The tide is flat and the wind is blowing. May we join hands to create a bright future.

MARKET OVERVIEW AND PROSPECTS

China's population health data shows that the number of sub-healthy groups is huge, the incidence of various diseases is on the rise. The strong demand for health has created new requirements for the technical level, service environment, process, capacity and convenience of medical and health service institutions, and county medical institutions will take on more and more health service tasks.

Socially-run medical institutions are an important parts of the health care system, and the government has successively issued a number of policies to support and encourage the development of socially-run medical institutions. These policies point out the direction for the development and growth of socially-run medical institutions in terms of the setting up of medical institutions, training and use of talents, the content of medical services and healthcare insurance payment, etc.

For example, in January 2022, the National Health Commission issued the "Guidelines for the Planning of the Setting Up of Medical Institutions" (2021–2025), which clearly states that: to expand the space for socially-run medical care, the total number of areas and space for socially-run medical care will not be restricted by planning. Medical institutions run by social forces are encouraged to take the lead in establishing or joining medical consortia. Social forces are encouraged to hold medical laboratory laboratories, pathology diagnostic centres, medical imaging diagnostic centres, haemodialysis centres, rehabilitation medical centres and other independently established medical institutions.

The state has also put forward higher requirements for medical quality and safety, taken a high-pressure stance against unethical practices in the medical industry, and put forward practical opinions on the further improvement of the medical and healthcare service system, and issued normative documents one after another, such as the "Opinions on Further Improving the Medical and Healthcare Service System" jointly issued by the General Office of the Central Committee of the Communist Party of China and the State Council, and the "Action Plan for Comprehensively Improving the Quality of Medical Care (2023–2025)", jointly issued by the National Health Commission and the National Administration of Traditional Chinese Medicine. These policies and measures will have a far-reaching impact on the healthy development of the medical industry in the future.

The Group believes that with the support of various state and government policies, socially-run medical care will continue to develop and grow. The Group will keep pace with the times, seize the opportunities and continue to expand its scale of operation and business network in order to meet the growing demand for medical services from the people.

BUSINESS REVIEW

In 2023, the Group's consolidated revenue for the year ended 31 December 2023 was RMB760.5 million, representing an increase of RMB32.7 million or 4.5% from the consolidated revenue of RMB727.8 million for the year ended 31 December 2022. This was mainly due to the increase in revenue generated from treatment and general medical services and the sale of pharmaceutical products.

The main driving factor is that on the basis of the existing relatively well-established medical system, with the help of efficient Internet + technology, from the depth and breadth of the two aspects of the force, the Group not only uses the high-precision to build a brand, but also continues to expand the scope of services, the breadth of services to lay a solid foundation for the integration of various disciplines to embark on the fast track to steady development.

Hospital Services

Henan Honliv Hospital provides hospital services on behalf of the Group. During the Reporting Period: (i) the total number of inpatient visits amounted to 54,795 (for the year ended 31 December 2022: 50,920), representing a year-on-year increase of 7.6%; (ii) the average cost of inpatient visits amounted to RMB6,394.4 (for the year ended 31 December 2022: RMB6,385.2), representing a year-on-year increase of 0.1%; (iii) the average cost of outpatient visits amounted to RMB287.4 (for the year ended 31 December 2022: RMB312.7), representing a year-on-year decrease of 8.1%; and (iv) the total number of outpatient visits amounted to 1,400,791 (for the year ended 31 December 2022: 1,286,815), representing year-on-year increase of 8.9%.

Pharmaceutical Sales

Revenue from sales of pharmaceutical for the reporting period was RMB294.9 million (RMB264.6 million for the year ended 31 December 2022), representing a year-on-year increase of 11.5%. Such increase was mainly attributable to the growth in outpatient sales of pharmaceutical, of which the outpatient pharmaceutical sales revenue increased significantly in the outpatient department, paediatrics, emergency department, haematology, obstetrics and gynaecology, dermatology, neurology, nails and breasts and preventive healthcare.

Business Development

The Group's operating efficiency improved steadily in 2023 as compared with the corresponding period of last year, and the key revenue-driving strategies for the Group's hospital services were:

- (i) The Group has been continuously upgrading the overall level of medical services. Through the passing on of skills by the old, middle-aged and young technicians, a group of young and highly educated technicians have grown to become the backbone of the Group and have achieved remarkable results in professional development, medical science and service model.
- (ii) The Group endeavours to create an elderly-friendly hospital to improve and enhance the medical experience of the elderly through various measures such as setting up outpatient clinics for chronic diseases and providing home nursing services.
- (iii) The Group has continued to explore the potential of quality nursing services and has made efforts in optimizing clinical nursing services and nursing scientific research. The Group has made efforts in the smallest details and taken various measures to create a warm and comfortable medical environment for patients; it has continuously learnt from advanced international and domestic nursing experiences and refined them in the light of actual practice, and its nursing scientific research has gained a higher honor in the international arena and has continuously fed into the clinical nursing services, thus forming a benign circle of development in which the nursing scientific research and the clinical nursing services have promoted each other and improved together.
- (iv) The Group has continued to leverage on its strengths in medical information technology by continuously upgrading and optimizing its software systems in conjunction with clinical practice and responding quickly to clinical needs, and has completed the development and application of dozens of software applications.
- (v) The Group actively participates in various medical competitions at the national level to demonstrate to the society the positive energy of being positive, helping the dying and healing the injured, and contributing to the society.
- (vi) The Group is actively practising the ESG development concept to achieve high-quality green development.
- (vii) The Group has fully adapted to various policies, such as the reform of healthcare insurance payment methods, to increase revenue and reduce expenditure.

Continuous improvement of academic research

As a medical institution dedicated to ensuring human health, the Group has been exploring the field of medical scientific research and hospital management. In 2023, the medical research activities of the Group's hospital achieved a favourable situation in which research empowers medical treatment and medical treatment promotes research:

- (i) "Development and Application of Intelligent Nursing Information System for Extended Home Nursing Based on Clinical Nursing Classification System" was approved as a joint project of Henan Provincial Health Commission;
- (ii) The Group participated as a sub-centre in the Xinxiang Medical University's project "Single-arm multicentre clinical study on the application and management of the simple mode of hydromorphone PCA pump in patients with severe or critical cancer pain";
- (iii) "Clinical efficacy of capecitabine maintenance therapy after first-line XP regimen chemotherapy for advanced esophageal squamous carcinoma" won the Second Prize of Xinxiang Natural Science Academic Achievement Award;
- (iv) The CCC project team has consistently published SCI articles in the international nursing informatics journal CIN;
- (v) Ten information systems, including "Settlement Management System Bedside Ward V1.0", "Trauma Centre Management System V1.0" and "Research and Development of Fully Intelligent Nursing Information System Based on International Standard Nursing Terminology CCC", were confirmed as scientific and technological achievements by the Science and Technology Department of Henan Province;
- (vi) Obtained 6 software copyright certificates.

The Group's hospital also invites renowned experts in the medical field to conduct case discussions and special lectures. This not only allows patients to enjoy quality medical resources, but also gives technical staff from the Group's hospitals a good opportunity to learn and further enhance the hospital's precise treatment capabilities. The Group will provide better services to patients by improving its research capabilities.

Actively taking social responsibility to warm the hearts of people with medical care

Adhering to the ideology of green development, the Group regards sustainable management and the fulfilment of social responsibility as an integral part of its corporate culture, and is committed to becoming an enterprise that is loved by its employees, praised by the society and developed in the long run. In order to detect the increasingly high incidence of lung lesions at an early stage, the Group has been going to villages and households to continuously carry out free screening activities for lung nodules; it has adopted a variety of technical measures to achieve energy conservation, emission reduction and green development, and was awarded the "Advanced Collective in Energy Conservation, Emission Reduction and Green Development Competition for Key Industries in Henan Province" by the Henan Provincial Federation of Trade Unions, the Development and Reform Commission of Henan Province, and the Department of Ecology and Environment of Henan Province in August 2023. In order to improve the health literacy of the public, the Group adopts an easy-to-understand and lively form to carry out popular science education on medical knowledge, and many people have won awards in various medical knowledge competitions at provincial and national levels.

FUTURE OUTLOOK

The Group will continue its efforts in the following areas in the future:

- The Group will continue to focus on its main business, adhere to the work policy of "promoting reform through evaluation, promoting construction through evaluation and combining evaluation and construction", further strengthen the internal construction of hospitals, actively prepare for the accreditation of hospital grades and realize the high quality and sustainable development of the hospital;
- 2. The Group will continue to intensify its efforts in talent cultivation and strengthen the mechanism of joint cultivation of talents by the hospital and universities, so as to create a medical team with reasonable composition of talents, high professionalism and strong sense of service, to better serve the ever-growing number of patient groups, and to lay a good foundation for the sustained and healthy development of the hospital;
- 3. Relying on the information technology team, the Group will continue to deepen the analysis and application of data across the hospital and steadily improve the level of application of electronic medical records in the hospital;
- 4. The Group will continue to improve the three-tier medical quality management system, continuously strengthen the management of medical quality and safety, and focus on fostering awareness of scientific research and improving scientific research output;
- 5. The Group will respond to the requirements of the times and continue to do a good job in analysing medical record data under the reform of the DIP payment method. We will study the characteristics of the demand for medical services in an ageing society, expand our business scope and improve our service chain;
- 6. The Group will enhance its compliance awareness, comply with various regulatory regimes in the industry, comply with the code of conduct for listed companies, optimize corporate governance and ensure medical quality and safety;
- 7. The Group will actively seek investment targets to expand the scale of the Group's business through various means, such as exogenous growth and export of management, in order to achieve the goal of group development.

FINANCIAL REVIEW

Revenue and Cost

We generated our revenue from: (i) the provision of treatments and general healthcare services, including the sales of medical consumables and the provision of hospital ancillary services; and (ii) the sales of pharmaceuticals to our patients, including both inpatients and outpatients. The following table sets forth a breakdown of our revenue for the periods indicated:

Our combined revenue from treatment and general hospital services and pharmaceutical sales increased by 4.5% from RMB727.8 million for the year ended 31 December 2022 to RMB760.5 million for the year ended 31 December 2023. This was mainly due to the increase in revenue as a result of the increase in the number of outpatient and inpatient visits.

Our revenue from outpatient medical services increased from RMB402.4 million for the year ended 31 December 2022 to RMB402.6 million for the year ended 31 December 2023. This was mainly due to the slight increase in outpatient medical services revenue as a result of the increase in the number of outpatient visits while a decrease was recorded in the average spending per visit.

Our revenue from inpatient medical services increased by 10.0% from RMB325.4 million for the year ended 31 December 2022 to RMB357.9 million for the year ended 31 December 2023. This was mainly due to the increase in inpatient medical services revenue as a result of the increase in the number of inpatient visits while a decrease was recorded in the average spending per visit.

Cost of sales

Our cost of sales consists primarily of employee benefit expenses for doctors and other medical professionals, the cost of pharmaceuticals, the cost of medical consumables, depreciation and amortization, utility fees, maintenance costs, office expenses and other costs.

Our cost of sales increased by 4.5% to RMB615.7 million for the year ended 31 December 2023 from RMB589.4 million for the year ended 31 December 2022, primarily due to (i) an increase in pharmaceutical costs of RMB18.9 million for the year ended 31 December 2023 as compared with the year ended 31 December 2022; (ii) an increase in employee benefit expenses of RMB20.0 million for the year ended 31 December 2023 as compared with the year ended 31 December 2023, (iii) an increase in depreciation and amortisation of RMB5.2 million for the year ended 31 December 2023 as compared with the year ended 31 December 2022; and (iv) a decrease in medical consumables costs of RMB14.7 million for the year ended 31 December 2023 as compared with the year ended 31 December 2022.

Gross profit and gross profit margin

Our gross profit increased by 4.6% from RMB138.4 million for the year ended 31 December 2022 to RMB144.8 million for the year ended 31 December 2023 and our gross profit margin for the year ended 31 December 2023 is the same as for the year ended 31 December 2022, both at 19.0%.

Other expenses

Our other expenses include depreciation of our investment properties. Our other expenses remained stable during the Reporting Period.

Administrative expenses

Our administrative expenses consist primarily of employee benefit expenses for administrative personnel, depreciation and amortization, utility fees, maintenance and office expenses and other costs.

Our administrative expenses decreased by 1.3% from RMB73.3 million for the year ended 31 December 2022 to RMB72.4 million for the year ended 31 December 2023, primarily due to an increase in employee benefit expenses of RMB4.5 million, a decrease in office expenses of RMB3.0 million and a decrease in other costs of RMB2.4 million.

Net finance costs

Our net finance costs decreased from a gain of RMB1.5 million for the year ended 31 December 2022 to an expense of RMB6.0 million for the year ended 31 December 2023, due to a decrease in foreign exchange gain during the Reporting Period.

Income tax expense

Our income tax expense decreased by 7.0% to RMB12.7 million for the year ended 31 December 2023 from RMB13.7 million for the year ended 31 December 2022, mainly due to a decrease in our profit before tax.

Profit for the year and net profit margin

For the foregoing reasons, our profit for the period decreased by 21.6% from RMB49.3 million for the year ended 31 December 2022 to RMB38.7 million for the year ended 31 December 2023. Our net profit margin stood at 6.8% and 5.1% for the year ended 31 December 2022 and the year ended 31 December 2023, respectively.

Funds and Financing

We adopt a prudent treasury management policy to maintain a solid and healthy financial position. The Group funds its operations principally from cash generated from its operations and bank facilities. Its cash requirements relate primarily to operating activities, repayment of liabilities as they become due, capital expenditures and interest payments.

As at 31 December 2023, the Group's consolidated cash and cash equivalents totalled approximately RMB239.8 million (31 December 2022: RMB255.2 million) which were denominated mainly in RMB. The Company had bank loan of RMB138.0 million as at 31 December 2023 and obtained a loan facility from one of its existing banks with an amount of RMB60.0 million on 5 March 2024. Application of one year loan drawdown can be made under this facility until 5 March 2025 subject to the approval and conditions imposed by the bank. As at the date of this report, the Group has not used this loan facility.

Net current liabilities

Our net current liabilities increased from RMB44.2 million as at 31 December 2022 to RMB59.7 million as at 31 December 2023. The increase was mainly due to the decrease of RMB15.7 million in trade receivables during the Reporting Period.

Inventories

Our inventories increased by 8.0% from RMB29.5million as at 31 December 2022 to RMB31.9 million as at 31 December 2023. This was mainly due to the changes in the amount of Chinese New Year reserve inventories.

Trade receivables

Our trade receivables decreased by 33.2% from RMB47.4 million as at 31 December 2022 to RMB31.6 million as at 31 December 2023. This was mainly due to the settlement of receivables from the Healthcare Security Administration and provision for bad and doubtful debt.

Other receivables and prepayments

Our other receivables and prepayments increased from RMB1.2 million as at 31 December 2022 to RMB2.1 million as at 31 December 2023, representing an increase of RMB0.9 million in the balance for the Reporting Period. This was mainly due to an increase in tax to be deducted.

Indebtedness

Our borrowings increased from RMB141.0 million as at 31 December 2022 to RMB176.5 million as at 31 December 2023, representing an increase of RMB35.5 million in the balance for the Reporting Period. This was mainly due to new loans raised during the Reporting Period.

Trade and notes payable

Our trade payables increased from RMB101.9 million as at 31 December 2022 to RMB124.5 million as at 31 December 2023, representing an increase of RMB22.6 million in the balance for the Reporting Period. This was mainly due to the increase in notes payable of RMB30.0 million during the Reporting Period.

Accrued expenses, other payables and provisions

Our accrued expenses and other payables decreased from RMB122.3 million as at 31 December 2022 to RMB99.8 million as at 31 December 2023. This was mainly due to the decrease in advance receipts for medical insurance.

Contingent liabilities

As at 31 December 2023, we had no contingent liabilities or guarantees that would have a material impact on the financial position or operations of the Group.

Lease liabilities

As of 31 December 2023, our lease liabilities in respect of our leased properties amounted to approximately RMB4.2 million.

Net cash generated from operating activities

Our net cash generated from operating activities decreased from RMB118.5 million for the year ended 31 December 2022 to RMB91.6 million for the year ended 31 December 2023, mainly due to the decrease in operating profit during the Reporting Period.

Net cash used in investing activities

Our net cash used in investing activities surged from RMB19.2 million for the year ended 31 December 2022 to RMB88.8 million for the year ended 31 December 2023, which was primarily attributed to an increase of RMB89.3 million in payments for renovation of factory and purchases of equipment.

Net cash used in financing activities

Our net cash used in financing activities decreased to RMB19.1 million for the year ended 31 December 2023 from RMB117.8 million for the year ended 31 December 2022. The decrease was mainly due to (i) the new borrowings of RMB183.0 million during the Reporting Period; (ii) the repayment of borrowings and the related interest of RMB147.5 million during the Reporting Period; (iii) the expenditure of RMB45.9 million for purchasing existing shares in light of the 2023 Restricted Share Unit Scheme.

Financial instruments

Our financial instruments include trade receivables, other receivables, cash and cash equivalents, bank borrowings, trade and notes payables and other payables. The Company's management manages and monitors these risks to ensure that effective measures are taken in a timely manner.

Exchange rate fluctuation risk and other risks

We hold certain financial assets in foreign currencies, which primarily involve exposure to exchange rate fluctuations between the HKD and the USD against the RMB, and the Group is therefore exposed to foreign exchange risk.

During the year ended 31 December 2023, we did not use any derivative financial instruments to hedge our exchange rate risk. Our management manages exchange rate risk by closely monitoring movements in foreign exchange rates and considers hedging significant foreign exchange exposure should the need arise.

Gearing ratio

As of 31 December 2023, our gearing ratio (total liabilities divided by total assets) was 43.5% (as of 31 December 2022; 40.7%).

PLEDGE OF ASSETS

As of 31 December 2023, details of the pledge of assets to secure bank loans granted to the Group are set out in note 12 to the consolidated financial statements in this annual report.

The Group did not make any material acquisitions or disposals of subsidiaries, associated companies or joint ventures and significant investment during the year ended 31 December 2023.

As of the date of this annual report, there were no material events subsequent to the year ended 31 December 2023.

LITIGATION

The Group was not involved in any material legal proceeding during the year ended 31 December 2023.

EMPLOYEES AND REMUNERATION POLICY

As at 31 December 2023, the Group had a total of 1,969 full-time employees (31 December 2022: 1,847). For FY2023, the staff cost (including Directors' remuneration in the form of salaries and other benefits) was approximately RMB217.5 million (FY2022: RMB193.0 million).

The Group ensured that the remuneration packages of employees remain competitive and the remuneration level of its employees was determined on the basis of performance with reference to the profitability of the Group, industry remuneration standards and market conditions within the general framework of the Group's remuneration system.

ADOPTION OF 2023 RSU SCHEME

The Company has adopted the 2023 RSU Scheme on 9 May 2023 (further details of which are set forth in the Company's announcements dated 9 May 2023). During the Reporting Period, no restricted share units had been awarded under the 2023 RSU Scheme.

USE OF PROCEEDS

In connection with the Company's Global Offering ("Global Offering"), 150,000,000 Shares with a nominal value of HK\$0.0001 each were issued at a price of HK\$2.10 per Share, raising net proceeds of approximately HK\$264.8 million, after deduction of the underwriting fees and related expenses by the Company in connection with the Global Offering. Such proceeds were allocated and used in accordance with the use of proceeds set out in the prospectus dated June 24, 2020 and the announcement on the change of use of proceeds from the Global Offering dated August 25, 2023 (the "Announcement") of the Company.

PRINCIPAL BUSINESS

The Group is mainly engaged in providing integrated medical services and pharmaceutical services to the society in Mainland China.

BUSINESS REVIEW

The Directors are satisfied that, during the period under review, the Group has compiled with the relevant laws and regulations, which have a significant impact on the business and operations of the Group. During the reporting period, no non-compliance with laws and regulations occurred.

The Group is committed to a high level ESG performance, and strives to improve the Group's ability of sustainable development, and compiles with national, provincial and local laws and regulations relating to ecological and environmental protection. The emissions and waste generated by the Group in the course of its operations manly Include medical waste, medical wastewater exhaust gas and domestic waste. The Group has established a compliant pollutant control system to meet the requirements of relevant laws and regulations, and has taken various measures to reduce the waste generated during its operation and the pollutants discharged into the environment. Compliant and harmless treatment methods are adopted for different types of waste, and qualified suppliers are entrusted to handle medical waste. During the year under review, the Group was not subject to any administrative penalties or litigation arising from environmental pollution.

The Group is committed to fulfilling its social responsibility and giving back to the society. We provide high quality medical care services and a comfortable environment for patients, make full use of internet technology to improve the medical treatment experience of patients and strictly obey government regulation of medical service prices. The Group strictly enforces the relevant pandemic prevention policies, optimizes medical procedure, improves the medical environment and cuts off the transmission, thus effectively safeguarding the medical safety of patients.

The Group regularly reviews the performance of its employees so as to provide them with reasonable remuneration and access to various benefits, including medical check-ups, housing, various types of insurance, etc. The Group provides different forms of professional training for its employees to enhance their skills and social values and to give them a sense of belonging; and increases the employees' understanding of different professions within the Group to improve productivity. The Group attaches importance to the production safety and personal safety of its employees, and all employees are required to receive the necessary safety training and education to equip them with the necessary safety knowledge and safety skills; the Group regularly educates its employees on compliance to ensure the healthy and compliant development of its business.

The Group's customers include patients and suppliers. The Group attaches importance to the legitimate rights of patients and provides them with quality and accessible services in all aspects such as medical technology, medical environment, medical prices, service processes and safety and security, and regularly seeks the views of patients to improve our services. The Group adopts the strictest professional ethics and professional conduct in working with suppliers, conducts regular assessments of suppliers, eliminates unqualified suppliers and enters into anticorruption and anti-commercial bribery agreements.

The Group values the interests of the community and regards the community as our key stakeholder and community responsibility as our obligation. The Group often reaches out to the community to conduct voluntary medical consultations, health education and medical check-ups, to guide the community to correct incorrect lifestyles, and to provide financial assistance to the underprivileged.

According to the dividend policy of the Group, the Company will declare dividends to shareholders in compliance with applicable rules and regulations (including the Cayman Islands laws) and the Company's Memorandum and Articles of Association. The payment and the amount of any dividends will be at the discretion of the Directors and will depend upon the Company's future operations and earnings, capital requirements and surplus, general financial condition, contractual restrictions and other factors that the Directors deem relevant.

Future dividend payments will also depend upon the availability of dividends received from the operating subsidiaries of the Company in the PRC.PRC laws require that dividends can be paid only out of the net profit calculated according to PRC accounting principles, which differ in many aspects from generally accepted accounting principles in other jurisdictions, including HKFRS. PRC laws also require the Company's subsidiaries in the PRC to set aside part of their net profit as statutory reserves, which are not available for distribution as cash dividends. Distributions from the Company's operating subsidiaries may also be restricted if they incur debt or losses or in accordance with any restrictive covenants in bank credit facilities, convertible bond instrument or other agreements that the Company or its subsidiaries may enter into in the future.

The relevant dividend policy will continue to be reviewed from time to time and there can be no assurance that dividends will be paid in any particular amount for any given period.

SHARE INCENTIVE SCHEMES

Share Option Scheme

The Company has conditionally approved and adopted a share option scheme on 17 June 2020 (the "Share Option Scheme"), and the Share Option Scheme will remain in force for a period of 10 years commencing on the date on which the Share Option Scheme is adopted. The following is a summary of the principal terms of the Share Option Scheme".

(a) Purpose

The purpose of the Share Option Scheme is to enable the Group to grant options to selected participants as incentives or rewards for their contribution to the Group. The Directors consider the Share Option Scheme, with its broadened basis of participation, will enable the Group to reward the employees, the Directors and other selected participants for their contributions to the Group. Given that the Directors are entitled to determine the performance targets to be achieved as well as the minimum period that an option must be held before an option can be exercised on a case by case basis, and that the exercise price of an option cannot in any event fall below the price stipulated in the Listing Rules or such higher price as may be fixed by the Directors, it is expected that grantees of an option will make an effort to contribute to the development of the Group so as to bring about an increased market price of the Shares in order to capitalize on the benefits of the options granted.

(b) Who may join

The Directors may, at their absolute discretion, invite any person belonging to any of the following classes of participants, who the Board considers, in its sole discretion, have contributed or will contribute to the Group, to take up options to subscribe for Shares:

- (i) any directors (including executive Directors, non-executive Directors and independent non-executive Directors) and employees of any member of the Group; and
- (ii) any advisers, consultants, distributors, contractors, customers, suppliers, agents, business partners, joint venture business partners, service providers of any member of the Group.

For the purposes of the Share Option Scheme, the options may be granted to any company wholly-owned by one or more persons belonging to any of these classes of participants. For the avoidance of doubt, the grant of any options by the Company for the subscription of Shares or other securities of the Group to any person who falls within any of these classes of participants shall not, by itself, unless the Directors otherwise so determine, be construed as a grant of option under the Share Option Scheme.

The eligibility of any of these class of participants to the grant of any option shall be determined by the Directors from time to time on the basis of the Directors' opinion as to the participant's contribution to the development and growth of the Group.

(c) Maximum number of Shares

- (i) The maximum number of Shares which may be issued upon the exercise of all outstanding options granted and yet to be exercised under the Share Option Scheme and any other share option scheme of the Group shall not in aggregate exceed 30% of the issued share capital of the Company.
- (ii) The total number of Shares which may be issued upon exercise of all options to be granted under the Share Option Scheme and any other share option scheme of the Group shall not in aggregate exceed 10% of the Shares in issue on the day on which trading of the Shares commence on the Stock Exchange, such 10% limit representing 60,000,000 Shares (the "General Scheme Limit"), but excluding any Shares which may be issued upon the exercise of the Over-allotment Option.

- (iii) Subject to paragraph (i) above and without prejudice to paragraph (iv) below, the Company may issue a circular to its Shareholders and seek approval of its Shareholders in a general meeting to extend the General Scheme Limit provided that the total number of Shares which may be issued upon exercise of all options to be granted under the Share Option Scheme and any other share option scheme of the Group shall not exceed 10% of the Shares in issue as of the date of approval of the limit and, for the purpose of calculating the limit, options (including those outstanding, cancelled, lapsed or exercised in accordance with the Share Option Scheme and any other share option scheme of the Group) previously granted under the Share Option Scheme and any other share option scheme of the Group will not be counted. The circular sent by the Company to its Shareholders shall contain, among other information, the information required under Rule 17.02(2)(d) of the Listing Rules and the disclaimer required under Rule 17.02(4) of the Listing Rules.
- (iv) Subject to paragraph (i) above and without prejudice to paragraph (iii) above, the Company may seek separate Shareholders' approval in a general meeting to grant options beyond the General Scheme Limit or, if applicable, the extended limit referred to in paragraph (iii) above to participants specifically identified by the Company before such approval is sought. In such event, the Company must send a circular to its Shareholders containing a general description of the specified participants, the number and terms of options to be granted, the purpose of granting options to the specified participants with an explanation as to how the terms of the options serve such purpose and such other information required under Rule 17.02(2)(d) of the Listing Rules and the disclaimer required under Rule 17.02(4) of the Listing Rules.

(d) Maximum entitlement of each participant

The total number of Shares issued and which may fall to be issued upon exercise of the options granted under the Share Option Scheme and any other share option scheme of the Company (including both exercised and outstanding options) to each participant in any 12-month period shall not exceed 1% of the issued share capital of the Company for the time being (the "Individual Limit"). Any further grant of options in aggregate in excess of the Individual Limit in any 12-month period up to and including the date of such further grant shall be subject to the issue of a circular to the Shareholders and the Shareholders' approval in general meeting of the Company with such participant and his close associates (or his associates if the participant is a connected person) abstaining from voting. The number and terms (including the exercise price) of options to be granted to such participant must be fixed before Shareholders' approval and the date of Board meeting for proposing such further grant should be taken as the date of grant for the purpose of calculating the exercise price under note (1) to Rule 17.03(9) of the Listing Rules.

(e) Grant of options to connected persons

Any grant of options under the Share Option Scheme to a director, chief executive or substantial shareholder of the Company or any of their respective associates must be approved by the independent non-executive Directors (excluding any independent non-executive Director who is the proposed grantee of the options).

Where any grant of options to a substantial Shareholder of the Company or an independent non-executive Director or any of their respective associates would result in the Shares issued and to be issued upon exercise of all options already granted and to be granted (including options exercised, cancelled and outstanding) to such person in the 12-month period up to and including the date of such grant:

- (i) representing in aggregate over 0.1% (or such other higher percentage as may from time to time be specified by the Stock Exchange) of the Shares in issue; and
- (ii) having an aggregate value, based on the closing price of the Shares as stated in the Stock Exchange's daily quotations sheet the date of the offer of grant, in excess of HK\$5 million (or such other higher amount as may from time to time be specified by the Stock Exchange);

such further grant of options must be approved by the Shareholders in a general meeting. The Company must send a circular to its Shareholders. The grantee, his associates and all core connected persons of the Company must abstain from voting in favor of the relevant resolution at such general meeting. Any vote taken at the general meeting to approve the grant of such options must be taken on a poll. Any change in the terms of options granted to a substantial shareholder or an independent non-executive Director or any of their respective associates must be approved by the Shareholders in a general meeting.

(f) Subscription price for Shares and consideration for the option

The subscription price per Share under the Share Option Scheme will be a price determined by the Directors, but shall not be less than the highest of:

- (i) the closing price of the Shares as stated in the Stock Exchange's daily quotations sheet on the date of the offer of grant, which must be a Business Day;
- (ii) the average closing price of the Shares as stated in the Stock Exchange's daily quotations for the five Business Days immediately preceding the date of the offer of grant (provided that in the event that any option is proposed to be granted within a period of less than five Business Days after the trading of the Shares first commences on the Stock Exchange, the new issue price of the Shares for the Global Offering shall be used as the closing price for any Business Day falling within the period before Listing); and
- (iii) the nominal value of a Share on the date of grant.

A nominal consideration of HK\$1.00 is payable upon acceptance of the grant of an option.

As of 31 December 2023, no options had been granted or agreed to be granted, exercised, cancelled or lapsed by the Company under the Share Option Scheme. As at 1 January 2022, 31 December 2023, and as at the date of this annual report, 60,000,000 Shares are available for grant under the Share Option Scheme, being 10% of the Company's total issued share capital as of the date of this annual report. As of 31 December 2023, the remaining life of the scheme is 6.46 years.

2022 RSU Scheme

The Company has adopted the 2022 RSU Scheme by a board resolution on 22 August 2022. The following is a summary of the principal terms of the 2022 RSU Scheme. Defined terms herein is only applicable to this "2022 RSU Scheme" section of this annual report.

As of 31 December 2023, no RSUs had been granted under the 2023 RSU Scheme.

Its primary duties include reviewing and supervising financial reporting procedures, including proposing on appointing or changing the external auditors; supervising the Company's internal audit system and risk management system and their implementation; facilitating communication between the internal auditors and external auditors; auditing the financial information and its disclosure; reviewing the Company's internal control system and auditing significant connected transactions; nominating the heads of the internal audit department; and other matters that the Board has authorised it to deal with.

As at 31 December 2023 and up to the publication date of this annual report, the audit committee comprises three independent non-executive Directors (Mr. Sun Jigang, Mr. Zhao Chun and Mr. Jiang Tianfan).

Remuneration Committee

The Company established the remuneration committee in accordance with Rule 3.25 of the Listing Rules and the CG Code on 13 July 2020. Its primary duties include formulating the criteria for and conducting assessment on our Directors and senior management as well as determining and reviewing the remuneration policies and plans for our Directors and senior management; reviewing the performance of our Directors and senior management and conducting annual assessment on their performance and results; supervising the implementation of the remuneration policies of the Company; and other matters that the Board has authorised it to deal with.

As at 31 December 2023 and up to the publication date of this annual report, the remuneration committee comprises three independent non-executive Directors (Mr. Jiang Tianfan, Mr. Sun Jigang and Mr. Zhao Chun).

Nomination Committee

The Company established the nomination committee in accordance with Rule 3.27A of the Listing Rules and the CG Code on 13 July 2020. Its primary duties include preparing the procedures and criteria for determining candidates of the Directors and general managers of the Company; reviewing the procedures and criteria for determining candidates for the Directors and general managers of the Company and making proposals to the Board; looking widely for the qualified candidates for the directors and general managers; reviewing and making proposals on the candidates for the other senior management on which the Board needs to resolve; and other matters that the Board has authorised it to deal with.

As at 31 December 2023 and up to the publication date of this annual report, the nomination committee comprises three independent non-executive Directors (Mr. Zhao Chun, Mr. Jiang Tianfan and Mr. Sun Jigang).

PRE-EMPTIVE RIGHTS

There are no provisions for pre-emptive rights under the Memorandum and Articles of Association or the laws of the Cayman Islands, being the jurisdiction in which the Company was incorporated, which would oblige the Company to offer new Shares on a pro-rata basis to existing Shareholders.

MODEL CODE

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers set out in Appendix C3 to the Listing Rules as its code of conduct for securities transactions by the Directors.

Having made specific enquiry, all Directors confirmed that they have complied with the required requirements as set out in the Model Code throughout the period from the Listing Date to 31 December 2023.

DEED OF NON-COMPETITION

The Controlling Shareholders, Henan Honliv Group and Mr. Qin Zili entered into the Deed of Non-competition in favour of the Company, pursuant to which they have irrevocably given certain non-competition undertakings to the Company. Details of the Deed of Non-competition are set out in the section headed "Relationship with our Controlling Shareholders — Non-competition Undertakings" in the Prospectus.

During the year ended 31 December 2023, no written notice of any New Business Opportunity (as defined in the Deed of Non-competition) had been received by the Company. Mr. Qin Yan, Mr. Qin Hongchao, Sunny Rock Capital Limited, Rubrical Investment Limited, Henan Honliv Group and Mr. Qin Zili confirmed that they have complied with the Deed of Non-competition for the year ended 31 December 2023 (the "Confirmation"). Upon receiving the Confirmation, the independent non-executive Directors of the Company have reviewed the same as part of the annual review process. In view of the above, the independent non-executive Directors have confirmed that, as far as they can ascertain, there is no breach by any of the parties therein of the non-competition undertakings in the Deed of Non-competition given by them.

CONTINUING DISCLOSURE OBLIGATIONS PURSUANT OT THE LISTING RULES

BOARD OF DIRECTORS

Executive Directors

Mr. Qin Yan (秦岩), aged 36, is an executive Director, the chairman of the Board, and the president of the Company, mainly responsible for overall strategic planning and business development of the Group. Mr. Qin Yan has over 12 years of experience in corporate management. In June 2007, Mr. Qin Yan joined Henan Honliv Hospital as an associate office manager and participated in the management of Henan Honliv Hospital and stayed in this position. Since April 2014, Mr. Qin Yan has served as a supervisor of Henan Honliv Hospital, mainly responsible for supervising the business conduct of the directors and senior management.

Mr. Qin Yan obtained a master's degree in philosophy from the University of Cambridge in the United Kingdom in October 2014.

Mr. Oin Yan has served as the legal representative of Honliv Yishenghuo since September 2014.

Mr. Qin Yan is the younger brother of Mr. Qin Hongchao and cousin of Ms. Wang Xiaoyang.

Dr. Teng Qingxiao (滕清曉), aged 58, is an executive Director, the Chief Operating Officer, and a senior vice president of the Company, mainly responsible for hospital healthcare management and human resources of the Group and currently serve as the president of Henan Honliv Hospital. Dr. Teng joined the Group in June 2007. On the administration front, he served as the deputy director and director of the department of otolaryngology in Henan Honliv Hospital from June 2007 to November 2010. Dr. Teng then served as the deputy president of Henan Honliv Hospital from December 2010 to May 2013, mainly responsible for assisting the president in the management of the hospital. In May 2013, Dr. Teng became the president of Henan Honliv Hospital and since then has been presiding over all aspects of hospital management, in particular finance, promotion and marketing. In addition, Dr. Teng had been an associate professor of Xinxiang Medical University (新鄉醫學院) from November 2005 to June 2007 specializing in the field of clinical medicine. Prior to joining the Group, Dr. Teng had practiced as a doctor in the department of otolaryngology at the Third Affiliated Hospital of Xinxiang Medical University (新鄉醫學院) from December 1996 to November 2005.

Dr. Teng graduated from Xinxiang Medical University (新鄉醫學院) in the PRC with a bachelor's degree of medicine specializing in clinical medicine in July 2002. He later obtained a master's degree of medicine specializing in pathology and pathophysiology from Xinxiang Medical University in June 2008. In November 2013, Dr. Teng completed the postgraduate course in medical and health management convened by the School of Continuing Education, Tsinghua University (清華大學繼續教育學院) in the PRC. Dr. Teng has been licensed by the Health Bureau of Henan Province (河南省衛生廳) to practice as a doctor since May 1999. He obtained the qualifications to practice as an associate chief doctor and a chief doctor in May 2005 and February 2012, respectively, from the People's Government of Henan Province.

Mr. Wang Zhongtao (主忠濤), aged 45, is an executive Director and financial controller of the Company, mainly responsible for overall accounting management and financing of our Group. Mr. Wang joined the Group as a Director in March 2018 and also assumed the role of the financial controller of Henan Honliv Hospital in June 2019. Mr. Wang has over 20 years of experience in finance management and accounting. Prior to joining the Group, Mr. Wang served as an accountant at Henan Honliv Group from July 1997 to June 2010, and then as the deputy finance manager from July 2009 to August 2017, mainly responsible for management and control of all aspects of accounting, finance and audit matters. From August 2017 to May 2019, Mr. Wang served as the finance manager of Henan Honliv Group, mainly responsible for supervision of Henan Honliv Group's operational results, as well as improving internal systems.

In July 1999, Mr. Wang graduated from Henan Xinxiang of Business School (河南新鄉商業學校) in the PRC, specializing in finance and accounting. In July 2017, Mr. Wang obtained a diploma from the Xinxiang College (新鄉學院), specialized in architectural engineering technology. He has been licensed by the Ministry of Finance to practice as an accountant (intermediate) since May 2007, and a non-practicing member of the Chinese Institution of Certified Public Accountants since February 2013.

Non-executive Director

Mr. Qin Hongchao (秦紅超), aged 38, joined the Company in January 2016 as a non-executive Director. Since February 2006, Mr. Qin Hongchao served as the deputy manager of the corporate management department at Henan Honliv Group, mainly responsible for strategic planning and management. Since October 2012, Mr. Qin Hongchao has been the vice chairman of Henan Honliv Group, mainly responsible for assisting the chairman with overall corporate governance.

Mr. Qin Hongchao obtained a diploma in hospitality management from American Hotel & Lodging Educational Institution in the United States in March 2009, and completed the practicum in hospitality management program at Prospect College of Business and Language⁽¹⁾ in Canada in July 2009.

Mr. Qin Hongchao is the elder brother of Mr. Qin Yan and cousin of Ms. Wang Xiao Yang.

Mr. Sun Jigang (孫冀剛), aged 56, was appointed as an independent non-executive Director of the Company on 5 July 2017. Mr. Sun has more than 11 years of experience in financial management. Between December 2008 and December 2010, he served as the chief financial officer of Gongda Chemical Industry Equipment Co., Ltd.* (石家莊工大化工設備有限公司); between January 2011 and August 2011, he was the chief financial officer of Beijing Puhua International Hospital Co., Ltd.* (北京天壇普華醫院有限公司). In both positions, he was responsible for matters concerning corporate finance, financial planning and budgeting, and financial reporting, in particular the preparation, review and analysis of financial statements. From September 2011 to May 2016, Mr. Sun served as the chief financial officer and the chief investment officer of Concord Medical Services Holdings Limited ("CMS Holdings") (a company listed on the New York Stock Exchange with stock code: CCM), mainly responsible for its finance, compliance and disclosure of financial information. From August 2009 to November 2016, Mr. Jiang worked as an executive director in China Resources Medical Holdings Company Limited (華潤醫療控股有限公司, previously known as Phoenix Healthcare Group Co. Ltd. (鳳凰醫療集團有限公司), a company listed on the Stock Exchange with the stock code of 1515), and as the chief financial officer from November 2011 to November 2016.

Dr. Hua joined the Group in September 2003. He served as the manager of the equipment department at Henan Honliv Hospital from April 2004 to January 2006, and as the assistant to the president of Henan Honliv Hospital from January 2006 to March 2006. From March 2006 to December 2010, he served as a vice president of Henan Honliv Hospital, mainly responsible for the healthcare operation of the hospital. Since December 2010, Dr. Hua has served as the deputy general manager of Henan Honliv Hospital, mainly responsible for expansion of the healthcare business of the Group. Prior to joining the Group, Dr. Hua practiced as a doctor of clinical medicine at People's Hospital of Changyuan County (長垣縣人民醫院) from September 1991 to September 2003.

Dr. Hua graduated from Henan Medical University (河南醫科大學) in the PRC (currently known as Zhengzhou University School of Medicine (鄭州大學醫學院)), in July 1991, with a bachelor's degree in medicine, specializing in preventive medicine. Dr. Hua obtained the qualification certificate as a doctor from the Health Bureau of Henan Province (河南省衛生廳) in May 1999, and has been licensed by the same bureau to practice as a doctor since April 2001.

Since September 2017, Dr. Hua has served as the legal representative of Yexian Honliv Hospital Co., Ltd.* (葉縣宏力 醫院有限公司) ("Yexian Honliv"). Yexian Honliv is an indirectly majority controlled company of Mr. Qin Zili and therefore a connected person of the Company under Rule 14.12(2)(b) of the Listing Rules.

Dr. Qian Feng (錢峰), aged 54, was appointed as vice president of the Company on 10 December 2019, mainly responsible for healthcare service quality control of the Group. Dr. Qian serves as a vice president and the associate chief physician of Henan Honliv Hospital since December 2010. Dr. Qian served as a gastroenterologist of the gastroenterology department in Henan Honliv Hospital from October 2006 to July 2009, and the director of the same department and the endoscopy center from July 2009 to December 2010. Prior to joining the Group, Dr. Qian served as gastroenterologist in the Fifth People's Hospital of Shangqiu City (商丘市第五人民醫院) from October 1992 to October 2006. In addition, Dr. Qian is the alliance director and an expert of the National Early Gastrointestinal Cancer Prevention & Treatment Center Alliance ("GECA") (國家消化道早癌防治中心). He is currently a member of Hospital Management Branch of Chinese Non-government Medical Institutions Association ("CNMIA") (中國非公立醫療機構協會醫院管理分會委員).

Dr. Qian graduated from Henan Medical University (河南醫科大學) in the PRC with a bachelor's degree in medicine specializing in clinical medicine in July 1992. He also obtained the certificate of completion of graduate coursework in psychology from Xinxiang Medical University (新鄉醫學院) in the PRC in July 2014.

Ms. Wang Xiaoyang (王曉陽), aged 37, was appointed as the assistant of the Chairman on December 10, 2019 and a joint company secretary of the Company on 7 June 2016, mainly responsible managing for investor relations of the Group. Ms. Wang joined the Group in February 2011 and has served as the assistant manager of human resources department of Henan Honliv Hospital, mainly responsible for recruitment, staffing, training and development. Ms. Wang obtained a bachelor's degree of science in mathematics with business management from the University of Birmingham in July 2009, and a master's degree of science in analysis, design and management of information systems from London School of Economics and Political Science in November 2010.

Ms. Hui has over 19 years of experience in the corporate secretarial field. She has been providing professional corporate services to Hong Kong listed companies as well as multinational, private and offshore companies. Ms. Hui has been the company secretary or joint company secretary of several listed companies on the Hong Kong Stock Exchange.

Ms. Hui graduated from The Hong Kong Polytechnic University and is a Chartered Secretary and an Associate Member of both The Hong Kong Chartered Governance Institute (formerly known as The Hong Kong Institute of Chartered Secretaries) and The Chartered Governance Institute (formerly known as The Institute of Chartered Secretaries and Administrators) in the United Kingdom.

The Company is committed to ensuring that its affairs are conducted in accordance with high ethical standards. This reflects its belief that, in the achievement of its long-term objectives, it is imperative to act with probity, transparency and accountability. By so acting, the Company believes that Shareholder wealth will be maximised in the long term and that its employees, those with whom it does business and the communities in which it operates will all benefit.

Corporate governance is the process by which the Board instructs management of the Group to conduct its affairs with a view to ensuring that its objectives are met. The Board is committed to maintaining and developing robust corporate governance practices that are intended to ensure:

The Board believes that Mr. Qin Yan can provide the Company with strong and consistent leadership that allows for effective and efficient planning and implementation of business decisions and strategies.

The Board considers that this structure will not impair the balance of power and authority between the Board and the management of the Group. The Board will review the corporate governance structure and practices from time to time and shall make necessary arrangement when the Board considers appropriate.

The Company will review and commit in making necessary arrangement to comply with all code provisions set out in the CG Code and in rising expectations of Shareholders and investors.

Independent Non-executive Directors

During the year ended 31 December 2023, the Board at all times met the requirements of the Listing Rules relating to the appointment of at least three independent non-executive Directors representing one-third of the Board with one of whom possessing appropriate professional qualifications or accounting or related financial management expertise.

Each of the independent non-executive Directors has made an annual confirmation of independence pursuant to Rule 3.13 of the Listing Rules. The Company is of the view that all independent non-executive Directors are independent in accordance with the guidelines set out of in the Listing Rules.

Appointment and Re-election of Directors

According to the Memorandum and Articles of Association, at every annual general meeting, one-third of the Directors (or if their number is not a multiple of three, the number nearest to but no less than one-third) are subject to retirement by or rotation at least once every three years and any new Director appointed to fill casual vacancy as an addition to the Board shall hold office until the next following general meeting of the Company. The retiring Directors shall be eligible for re-election.

Any other appointment, resignation, removal or re-designation of Directors will be timely disclosed to the Shareholders by announcement and shall include in such announcement, the reasons given by the Director for his resignation. Each Director (including non-executive Director) has entered into a service contract or letter of appointment with the Company for an initial term of 3 years commencing from the Listing Date, and has renewed their service contract or letter of appointment in June 2023 for a term of 3 years, and shall be subject to retirement by rotation once every three years.

Responsibilities, Accountabilities and Contributions of the Board and Management

The Board should assume responsibility for leadership and control of the Company; and is collectively responsible for directing and supervising the Company's affairs.

The Board directly, and indirectly through its committees, leads and provides direction to management by laying down strategies and overseeing their implementation, monitors the Group's operational and financial performance, and ensures that sound internal control and risk management systems are in place.

All Directors, including non-executive Directors and independent non-executive Directors, have brought a wide spectrum of valuable business experience, knowledge and professionalism to the Board for its efficient and effective functioning. The independent non-executive Directors are responsible for ensuring a high standard of regulatory reporting of the Company and providing a balance in the Board for bringing effective independent judgement on corporate actions and operations.

The Company has arranged appropriate insurance coverage to protect Directors from possible legal action against them. The insurance coverage would be reviewed on an annual basis.

The Board reserves for its decision all major matters relating to policy matters, strategies and budgets, internal control and risk management, material transactions (in particular those that may involve conflict of interests), financial information, appointment of directors and other significant operational matters of the Company. Responsibilities relating to implementing decisions of the Board, directing and coordinating the daily operation and management of the Company are delegated to the management.

Board Diversity and Workforce Diversity

The Company has adopted a board diversity policy (the "Board Diversity Policy") pursuant to which the Company aims to build and maintain a Board with a diversity of Directors. The Nomination Committee will review at least annually the structure, size and composition of the Board and where appropriate, make recommendations on changes to the Board to complement the Company's corporate strategy. In relation to reviewing and assessing the Board composition, the Nomination Committee will consider a number of aspects, including but not limited to skills, professional experience, educational background, knowledge, expertise, culture, independence, age and gender.

As at the date of this annual report, our Board consists of seven male members and no female members with two Directors of age 31 to 40 years old, two Directors of age 41 to 50 years old, two Directors of age 51 to 60 years old and one Director of age 71 years old. The Company has reviewed the membership, structure and composition of the Board, and is of the opinion that the structure of the Board is reasonable, and the experiences and skills of the Directors in various aspects and fields can enable the Company to maintain a high standard of operation. The Company will appoint a female Director no later than 31 December 2024.

The total gender diversity of the Group is balanced at 67.5%, representing 1,329 female out of 1,969 employees (including senior management) as at 31 December 2023. To support diversity across all facets, the Group is enhancing diversity and inclusion efforts through employee networks, mentoring programmes, equitable hiring practices, policies and awareness raising events and training for all employees to support inclusive behaviors.

Continuous Professional Development of Directors

On appointment to the Board, each Director receives a comprehensive induction package to ensure that he/she has a proper understanding of the business and operations of the Company and if fully aware of the responsibilities and obligations as being a Director as well as the compliance practice under the Listing Rules and other relevant regulatory requirements.

All Directors are encouraged to participate in continuous professional development to develop and refresh their knowledge and skills. Directors are kept updated on the statutory and regulatory development and changes in the business and the market so as to facilitate the discharge of their responsibility. Directors shall keep abreast of regulatory developments and changes in order to effectively perform their responsibilities and to ensure that their contribution to the Board remains informed and relevant. All Directors have participated in the courses relating to the roles, functions and duties of a director of a listed company or further enhanced their professional development.

BOARD COMMITTEES

Audit Committee

The Audit Committee consists of three independent non-executive directors, namely Mr. Sun Jigang, Mr. Zhao Chun and Mr. Jiang Tianfan. Mr. Sun Jigang is the chairman of the Audit Committee.

The terms of reference of the Audit Committee are of no less exacting terms than those set out in the CG Code. The main duties of the Audit Committee are reviewing the financial information and reporting process, risk management and internal control systems, effectiveness of the internal audit function, scope of audit and appointment of external auditors, and arrangements to enable employees of the Company to raise concerns about possible improprieties in any matters of the Company.

If within twenty-one days of such deposit the Board fails to proceed to convene such meeting to be held within a further 21 days, the requisitionist(s) themselves or any of them representing more than one-half of the total voting rights of all of them may do so in the same manner, provided that any meeting so convened shall not be held after the expiration of three months from the date of deposit of the requisition, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

OPINION

What we have audited

The consolidated financial statements of Honliv Healthcare Management Group Company Limited (the "Company") and its subsidiaries (the "Group"), which are set out on pages 55 to 115, comprise:

- the consolidated balance sheet as at 31 December 2023;
- the consolidated statement of comprehensive income for the year then ended;
- the consolidated statement of changes in equity for the year then ended;
- the consolidated statement of cash flows for the year then ended; and
- the notes to the consolidated financial statements, comprising material accounting policy information and other explanatory information.

Our opinion

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 December 2023, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

BASIS FOR OPINION

We conducted our audit in accordance with Hong Kong Standards on Auditing ("HKSAs") issued by the HKICPA. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Consolidated Financial Statements section of our report.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Independence

We are independent of the Group in accordance with the HKICPA's Code of Ethics for Professional Accountants ("the Code"), and we have fulfilled our other ethical responsibilities in accordance with the Code.

KEY AUDIT MATTERS

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

The key audit matter identified in our audit is related to expected credit losses assessment of trade receivables.

Key Audit Matter

Expected credit losses assessment of trade receivables

Refer to note 3.1.2, note 4 (a) and note 20 to the consolidated financial statements

As at 31 December 2023, the net carrying amount of the Group's trade receivables amounted to RMB31.6 million, among which, a loss allowance of RMB22.0 million was recognised as at the same date.

The Group applies the simplified approach under HKFRS 9 to measure expected credit losses, which requires expected lifetime losses to be recognised from initial recognition of the trade receivables.

Loss allowance of trade receivables reflected management's best estimate on the expected credit losses. The estimates require significant management judgments in making assumptions about the expected credit loss rates based on historical credit records and external credit rating information of customers and adjusted by forwardlooking adjustment factors taking into consideration of macroeconomic parameters. For trade receivables which have significant changes in credit risk, management assessed their expected credit losses on an individual basis. For trade receivables that share same risk characteristics with others, management assessed the expected credit losses on a collective basis. Management identified macroeconomic conditions, industry risks and probabilities of default to which it sells its services to be the most relevant factors, and accordingly adjusts the probabilities of default based on expected changes in these factors.

How our audit addressed the Key Audit Matter

Our procedures in relation to management's assessment on the expected credit losses of trade receivables include:

We obtained an understanding of the management's internal control and assessment process of expected credit losses of trade receivables and assessed the inherent risk of material misstatement by considering the degree of estimation uncertainty and level of other inherent risk factors such as complexity, subjectivity, changes and susceptibility to management bias or fraud

We evaluated and tested the key controls over management's expected credit losses assessment of trade receivables

We evaluated the outcome of prior period assessment of expected credit losses of trade receivables to assess the effectiveness of management's estimation process.

With the support of internal experts, we assessed the reasonableness of assumptions used and judgments made by management by (1) analysing the historical payment pattern, actual credit losses of customers and the external credit rating information, (2) evaluating the rationality of the groups of trade receivables whose expected credit losses are assessed on a collective or individual basis by reference to the credit risk characteristics of respective customer, and (3) evaluating the reasonableness of management's forward-looking adjustment factors by comparing with the relevant macroeconomic parameters and comparable industry information.

We tested the aging of trade receivables, on a sample basis, by checking to underlying accounting records and supporting documents.

Key Audit Matter

We focused on auditing the expected credit losses assessment of trade receivables because the estimation of expected credit losses is subject to high degree of estimation uncertainty. The inherent risk in relation to expected credit losses assessment of trade receivables is considered significant due to the subjectivity of significant assumptions used in expected credit losses assessment of trade receivables.

How our audit addressed the Key Audit Matter

We checked the accuracy, on a sample basis, of the key data inputs including trade receivables balances as at 31 December 2023 by requesting external confirmations.

We considered whether the judgements made in selecting significant assumptions and data would give rise to indicators of possible management bias.

We tested the mathematical accuracy of the calculation of the expected credit losses.

We assessed the adequacy of the disclosures related to the expected credit losses in note 3.1.2, note 4 (a) and note 20 to the consolidated financial statements.

Based on the above procedures performed, we considered that management's judgments and assumptions adopted in the expected credit losses assessment of trade receivables were supported by the evidences obtained and procedures performed.

OTHER INFORMATION

The directors of the Company are responsible for the other information. The other information comprises all of the information included in the annual report other than the consolidated financial statements and our auditor's report thereon.

Our opinion on the consolidated financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the consolidated financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the consolidated financial statements or our knowledge obtained in the audit, or otherwise appears to be materially misstated.

If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

RESPONSIBILITIES OF DIRECTORS AND THE AUDIT COMMITTEE FOR THE CONSOLIDATED FINANCIAL STATEMENTS

The directors of the Company are responsible for the preparation of the consolidated financial statements that give a true and fair view in accordance with HKFRSs issued by the HKICPA and the disclosure requirements of the Hong Kong Companies Ordinance, and for such internal control as the directors determine is necessary to enable the preparation of consolidated financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the consolidated financial statements, the directors are responsible for assessing the Group's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the directors either intend to liquidate the Group or to cease operations, or have no realistic alternative but to do so.

The Audit Committee is responsible for overseeing the Group's financial reporting process.

Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with HKSAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these consolidated financial statements.

As part of an audit in accordance with HKSAs, we exercise professional judgment and maintain professional scepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the consolidated financial statements, whether due
 to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence
 that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material
 misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion,

1 GENERAL INFORMATION

Honliv Healthcare Management Group Company Limited (the "Company") was incorporated in the Cayman Islands on 6 January 2016 as an exempted company with limited liability under the Companies Act, Cap.22 (Act 3 of 1961, as consolidated and revised) of the Cayman Islands. The address of the Company's registered office is Campbells Corporate Services Limited, Floor 4, Willow House, Cricket Square, Grand Cayman KY1-9010, Cayman Islands.

The Company is an investment holding company and together with its subsidiaries (the "Group"), are principally engaged in the ownership, operation and management of hospitals in the People's Republic of China (the "PRC").

The ordinary shares of the Company have been listed on the Main Board of The Stock Exchange of Hong Kong Limited on 13 July 2020.

The consolidated financial statements are presented in Renminbi ("RMB") and rounded to nearest thousand yuan, unless otherwise stated.

2 BASIS OF PREPARATION AND CHANGES IN ACCOUNTING POLICIES

2.1 Basis of preparation

2.1.1 Compliance with HKFRS and HKCO

The consolidated financial statements of the Group have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRS") as issued by the Hong Kong Institute of Certified Public Accountants and requirements of the Hong Kong Companies Ordinance Cap. 622.

2.1.5 Going concern

As at 31 December 2023, the Group's current liabilities exceeded its current assets by RMB59,735,000. The Group had cash and cash equivalents of RMB239,755,000 as at 31 December 2023.

Management has given careful consideration to the future liquidity and performance of the Group and its available sources of financing in assessing whether the Group will have sufficient funds to fulfil its financial obligations and continue as a going concern. A number of measures have been put in place by management to improve the financial position and alleviate the liquidity pressure including:

- Management has been communicating with the banks which are providing existing banking facilities to the Group with a view to proactively managing the renewal of the Group's banking facilities upon maturity and securing additional credit facilities. Subsequent to 2023 year end date, Henan Honliv Hospital Co., Ltd. ("Honliv Hospital"), a subsidiary of the Group, had renewed RMB29 million bank borrowings upon maturity as of the date of this report; and
- On 5 March 2024, Honliv Hospital further obtained an additional loan facility of RMB60 million from one of its existing banks. Application of one-year loan drawdowns can be made under this facility until 5 March 2025 subject to the approval and conditions imposed by the bank. As at the reporting date, the Group has not utilized this additional loan facility.

2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

2.1 Basis of preparation (Continued)

2.1.5 Going concern (Continued)

Management has prepared cash flow projections of the Group covering a period of not less than twelve months from 31 December 2023. Taking into account the Group's future operational performance and the expected future operating cash inflows; and the continuous availability of banking facilities, management concluded that the Group will have sufficient financial resources to support its operations and to meet its financial obligations and commitments as and when they fall due in the coming twelve months from 31 December 2023.

The directors have reviewed the Group's cash flow projections and have made due and careful enquiry and considered the basis and assumptions of management's projections. According to the measures above, the directors are satisfied that it is appropriate to prepare the financial information on a going concern basis.

3 FINANCIAL RISK MANAGEMENT

3.1 Financial risk factors

The Group's activities expose it to a variety of financial risks: market risk (including foreign exchange risk and cash flow interest rate risk and fair value interest rate risk), credit risk and liquidity risk. The Group's overall risk management program focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

Risk management is carried out by the senior management of the Group and approved by the executive directors.

3.1.1 Market risk

(i) Foreign exchange risk

Foreign currency risk is the risk that the value of a financial instrument fluctuates because of the changes in foreign exchange rates.

The Group mainly operates in the PRC with most of the transactions settled in RMB. Foreign exchange rate risk arises when recognised assets and liabilities are denominated in a currency that is not the entity's functional currency.

As at 31 December 2023, the Group's assets and liabilities are primarily denominated in RMB, except for certain cash and cash equivalents denominated in USD or HKD (note 23).

The Group is primarily exposed to change in RMB/HKD exchange rate. As at 31 December 2023, if RMB had weakened/strengthened by 5% against the HKD with all other variables held constant, pre-tax profit for the year would have been approximately RMB175,000 (2022: RMB1,959,000) higher/lower, mainly as a result of foreign exchange gains/losses on translation of HKD denominated cash and cash equivalents at banks or financial institutions.

The Group will constantly review the economic situation and its foreign exchange risk profile, and will consider appropriate hedging measures in the future, as may be necessary.

3 FINANCIAL RISK MANAGEMENT (Continued)

3.1 Financial risk factors (Continued)

3.1.1 Market risk (Continued)

(ii) Cash flow and fair value interest rate risk

The Group's interest rate risk arises from short-term borrowings. Borrowings obtained at variable rates expose the Group to cash flow interest rate risk. Bank borrowings obtained at fixed rates expose the Group to fair value interest rate risk. The Group has not entered into interest rate swaps to hedge against the exposure to changes in fair values of the borrowings. The Group will, however, continue to monitor interest rate risk exposure and will consider hedging significant interest rate risk exposure should the need arise.

As at 31 December 2023, the Group's interest-bearing borrowings at variable rates was RMB79,000,000 (2022: RMB56,000,000) (note 29(b)).

For the year ended 31 December 2023, if interest rates on borrowings had been one percent higher/lower with all other variables held constant, the post-tax profit for the year would have decreased/increased by RMB593,000 (2022: RMB420,000), mainly as a result of higher/lower interest expense on floating rate borrowings.

3.1.2 Credit risk

Credit risk mainly arises from cash and cash equivalents and other financial assets at amortised cost, as well as credit exposures to customers and government's social insurance schemes. The maximum exposure to credit risk is represented by the carrying amounts of each financial asset in the consolidated balance sheet.

(i) Risk management

The credit risk of cash and cash equivalents is limited because the counterparties are state-owned or public listed commercial banks or financial institution which are relatively high-credit-quality financial institutions located in the PRC.

The Group, being a provider of healthcare services to customers, has a highly diversified customer base, without any single customer contributing material revenue. However, the Group has concentrated debtors' portfolio, as majority customers will claim their medical bills from governments' social insurance schemes. The reimbursement from these organisations mainly take within one year. The Group has policies in place to ensure the treatments and medicines prescribed and provided to such insured customers are in line with respective organisations' policies, provided those treatments and medicines fulfilling all ethics and moral responsibilities as healthcare provider. The Group also has controls to closely monitor the organisations' reimbursements schedule to minimize the credit risk.

3 FINANCIAL RISK MANAGEMENT (Continued)

3.1 Financial risk factors (Continued)

3.1.2 Credit risk (Continued)

(ii) Impairment of financial assets

The Group has three types of financial assets that are subject to the expected credit loss model:

- cash and cash equivalents
- trade receivables, and
- other financial assets at amortised cost.

Cash and cash equivalents

While cash and cash equivalents are also subject to the impairment requirements of HKFRS 9, the identified impairment loss was immaterial.

Trade receivables

The Group applies the HKFRS 9 simplified approach to measure expected credit losses which uses a lifetime expected loss allowance for trade receivables.

For trade receivables which have significant changes in credit risk, management assessed their expected credit losses on an individual basis. For trade receivables that share same risk characteristics with others, management assessed the expected credit losses on a collective basis. Management identified macroeconomic conditions, industry risks and probabilities of default to which it sells its services to be the most relevant factors, and accordingly adjusts the probabilities of default based on expected changes in these factors.

Trade receivables are written off when there is no reasonable expectation of recovery. Indicators that there is no reasonable expectation of recovery include, amongst others, the failure of a debtor to engage in a repayment plan with the Group, and a failure to make contractual payments for a period of greater than one year past due.

Impairment losses on trade receivables are presented as net impairment losses within operating profit. Subsequent recoveries of amounts previously written off are credited against the same line item.

Other financial assets at amortised cost

Other financial assets at amortised cost mainly include other receivables. The directors of the Company have assessed that other receivables have not had a significant increase in credit risk since initial recognition. Thus, a 12-month expected credit loss approach that results from possible default event within 12 months of the reporting period of the Group is adopted by management. The directors of the Company do not expect any losses from non-performance by the counterparties of other receivables. Thus, no loss allowance provision for other receivables was recognized.

The Group aims to maintain sufficient cash and cash equivalents to meet operating capital requirements.

3.2 Capital management

The Group's primary objectives when managing capital are to safeguard the Group's ability to continue as a going concern in order to provide returns to the shareholders and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital.

The Group actively and regularly reviews and manages its capital structure to maintain a balance between the higher equity shareholders returns that might be possible with higher levels of borrowings and the advantages and security afforded by a sound capital position, and makes adjustments to the capital structure in light of changes in economic conditions.

In order to maintain or adjust the capital structure, the Group may adjust the amount of dividends paid to shareholders, return capital to shareholders, issue new shares or sell assets to reduce debt.

The Group monitors its capital structure on the basis of liability-to-asset ratio, which is calculated as total liabilities divided by total assets. The liability-to-asset ratio of the Group as at 31 December 2023 and 2022 was as follows:

3.3 Offsetting financial assets and financial liabilities

Financial assets and liabilities are offset and the net amount is reported in the consolidated balance sheet where the Group currently has a legally enforceable right to offset the recognised amounts, and there is an intention to settle on a net basis or realise the asset and settle the liability simultaneously. The legally enforceable right must not be contingent on future events and must be enforceable in the normal course of business and in the event of default, insolvency or bankruptcy of the company or the counterparty.

4 CRITICAL ACCOUNTING ESTIMATES AND JUDGEMENTS

The preparation of financial statements requires the use of accounting estimates which, by definition, will seldom equal the actual results. Management also needs to exercise judgement in applying the Group's accounting policies.

Estimates and judgements are continually evaluated. They are based on historical experience and other factors, including expectations of future events that may have a financial impact on the entity and that are believed to be reasonable under the circumstances.

(a) Impairment of trade receivables

The loss allowances for financial assets are based on assumptions about risk of default and expected loss rates. The Group uses accounting estimates and judgements in making these assumptions and selecting the inputs to the impairment calculation, based on the Group's past history, existing market conditions as well as forward looking estimates at the end of each reporting period. Details of the key assumptions and inputs used are disclosed in the tables in note 3.1.2.

4 CRITICAL ACCOUNTING ESTIMATES AND JUDGEMENTS (Continued)

(b) Useful lives of property, plant and equipment

The estimate of useful lives of property, plant and equipment is made by the management with reference to the established industry practices, technical assessments made on the durability of the assets, as well as the historical magnitude and the trend of repair and maintenance expenses incurred by the Group. It could change significantly as when the actual useful life is different with the one previously estimated.

(c) Estimation of variable consideration

The estimation of variable consideration made by the management is the most likely amount that the Group will be entitled from medical service, and which is the best estimation based on all reasonably available information (historical, current and forecast). The Group includes the portion of variable consideration that will not result in a significant revenue reversal in the transaction price when the uncertainty associated with the variable consideration is subsequently resolved. At the end of each reporting period, the Group revaluates the estimation of variable consideration by reference to the changes in circumstances during the reporting period and reflects changes. Management exercises judgement when interpreting the relevant policies or regulations to apply the variable consideration constraints.

5 SEGMENT INFORMATION

The Group has only one operating segment for the year ended 31 December 2023 and 2022, so no segment information was presented.

(i) Accounting policies of revenue recognition

The Group's revenue is primarily derived from providing treatments and general healthcare services to customers and sales of pharmaceuticals.

Revenues are recognised when, or as, the control of the goods or services is transferred to the customer. Depending on the terms of the contract and the laws applicable, control of the goods and services may be transferred over time or at a point in time. Control of the goods and services is transferred over time if the Group's performance:

- Provides all of the benefits received and consumed simultaneously by the customer;
- Creates and enhances an asset that the customer controls as the Group performs; or
- Does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

If control of the goods and services transfers over time, revenue is recognised over the period of the contract by reference to the progress towards complete satisfaction of that performance obligation. Otherwise, revenue is recognised at a point in time when the customer obtains control of the goods and services.

The progress towards complete satisfaction of performance obligation, depending on the nature of the good and service to be transferred, is measured based on one of the following methods that best depicts the Group's performance in satisfying the performance obligation:

- Direct measurements of the value of individual services transferred by the Group to the customer; or
- The Group's efforts or inputs to the satisfaction of the performance obligation.

The following is a description of the accounting policy for the principal revenue streams of the Group.

Treatments and General healthcare service

Revenue from provision of treatments and general hospital services is recognised when related services have been rendered to customers. Majority customers of the Group has entered into governments' social insurance schemes which are run by government organisations. The Group claims the consideration in relation to treatments and general healthcare services provided by the Group with relevant government organisations. The subsequent agreement on the government approved annual quota for the medical fees to be recovered from the relevant government's social insurance scheme has been treated as changes in variable considerations. The Group estimates the variable considerations based on the most likely amount, which is based on historical practice and all reasonably available information and adjusts to the actual amount for the satisfied medical services in the period when the annual quota is agreed.

6 REVENUE (Continued)

(i) Accounting policies of revenue recognition (Continued) Treatments and General healthcare service (Continued)

(a) Outpatient services

For outpatient services, the customers mainly receive consultation services. For provision of consultation services for which the control of services is transferred at a point in time, revenue is recognised when the customers obtain the control of the completed services and the Group has satisfied its performance obligations with present right to payment and the collection of the consideration is probable.

(b) Inpatient services

For inpatient services, the customers mainly receive the inpatient healthcare services. The corresponding revenue is recognised over the services period when customers simultaneously receive the services and consume the benefits provided by the Group to the customers.

The Group usually receives the payment from governments' social insurance schemes or prepaid cards paid by bank card or cash from customers in advance before the hospital services are rendered. The balance amounts of the prepaid cards are presented in the consolidated balance sheet within "Accruals, other payables and provisions".

Pharmaceutical Sales

Revenue from pharmaceutical sales is recognised when control of the inventories has transferred, being when the inventory is delivered to the customers, the customers have full discretion to use the inventory, and there is no unfulfilled obligation that could affect the customers' acceptance of the inventory.

Contributions to these plans are expensed as incurred. Assets of the plans are held and managed by government authorities and are separate from those of the Group. The Group did not have any forfeited contribution for the years ended 31 December 2023 and 2022 in connection with the defined contribution scheme. The Group did not have defined benefit plan for the years ended 31 December 2023 and 2022.

37 SUMMARY OF OTHER POTENTIALLY MATERIAL ACCOUNTING POLICIES

This note provides a list of other potentially material accounting policies adopted in the preparation of these consolidated financial statements. These policies have been consistently applied to all the years presented, unless otherwise stated. The financial statements are for the Group consisting of the Company and its subsidiaries.

37.1 Principles of consolidation and equity accounting

37.1.1 Subsidiaries

Subsidiaries are all entities over which the Group has control. The Group controls an entity where the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the activities of the entity. Subsidiaries are fully consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date that control ceases.

Inter-company transactions, balances and unrealised gains on transactions between group companies are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the transferred asset. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

Non-controlling interests in the results and equity of subsidiaries are shown separately in the consolidated statement of comprehensive income, consolidated statement of changes in equity and consolidated balance sheet respectively.

37.1.2 Changes in ownership interests

The Group treats transactions with non-controlling interests that do not result in a loss of control as transactions with equity owners of the Group. A change in ownership interest results in an adjustment between the carrying amounts of the controlling and non-controlling interests to reflect their relative interests in the subsidiary. Any difference between the amount of the adjustment to non-controlling interests and any consideration paid or received is recognised in a separate reserve within equity attributable to owners of the Group.

37.2 Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker, who are responsible for allocating resources, assessing performance of the operating segment and making strategic decisions. The chief operating decision-maker has been identified as the executive director.

37.3 Foreign currency translation

37.3.1 Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates ("the functional currency"). Since the majority of the assets and operations of the Group are located in the PRC, the consolidated financial statements are presented in RMB, which is the Group's functional and presentation currency.

37.3 Foreign currency translation (Continued)

37.3.2 Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation of monetary assets and liabilities denominated in foreign currencies at year end exchange rates are generally recognised in profit or loss. They are deferred in equity if they relate to qualifying cash flow hedges and qualifying net investment hedges or are attributable to part of the net investment in a foreign operation.

Foreign exchange gains and losses that relate to cash and cash equivalents are presented in the consolidated statement of comprehensive income, within finance income or costs. All other foreign exchange gains and losses are presented in the consolidated statement of comprehensive income on a net basis within other losses — net.

37.3.3 Group companies

The results and financial position of foreign operations (none of which has the currency of a hyper inflationary economy) that have a functional currency different from the presentation currency are translated into the presentation currency as follows:

- assets and liabilities for each balance sheet presented are translated at the closing rate at the date
 of that balance sheet.
- income and expenses for each statement of comprehensive income are translated at average exchange rates (unless this is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the dates of the transactions), and
- all resulting exchange differences are recognised in other comprehensive income.

37.4 Property, plant and equipment

Property, plant and equipment are stated at historical cost less accumulated depreciation. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of any component accounted for as a separate asset is derecognised when replaced. All other repairs and maintenance are charged to the consolidated statement of comprehensive income during the reporting period in which they are incurred.

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

37.4 Property, plant and equipment (Continued)

Gains and losses on disposals are determined by comparing the proceeds with the carrying amount and are recognised within other losses-net in the consolidated statement of comprehensive income.

Construction in progress (the "CIP") includes the costs of construction and acquisition and capitalized borrowing costs. No provision for depreciation is made on CIP until such time as the relevant assets are completed and ready for intended use. When the assets concerned are available for use, the costs are transferred to property, plant and equipment and depreciated in accordance with the policy as stated above.

37.5 Intangible assets

Computer software

Acquired computer software is capitalised on the basis of the costs incurred to acquire and bring the specific software into usage. Costs associated with maintaining computer software programs are recognised as an expense as incurred. These costs are amortised using the straight-line method over their estimated useful lives of 3 years.

37.6 Impairment of non-financial assets

Assets are tested for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs of disposal and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash inflows which are largely independent of the cash inflows from other assets or groups of assets (cash-generating units). Non-financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at the end of each reporting period.

37.7 Financial assets

37.7.1 Classification

There is only one type of the Group's financial assets which are measured at amortised cost. The classification depends on the entity's business model for managing the financial assets and the contractual terms of the cash flows.

The group reclassifies debt investments when and only when its business model for managing those assets changes.

37.7.2 Recognition and derecognition

Regular way purchases and sales of financial assets are recognised on trade-date, the date on which the Group commits to purchase or sell the asset. Financial assets are derecognised when the rights to receive cash flows from the financial assets have expired or have been transferred and the Group has transferred substantially all the risks and rewards of ownership.

37.7 Financial assets (Continued)

37.7.3 Measurement

At initial recognition, the group measures a financial asset at its fair value plus, in the case of a financial asset not at fair value through profit or loss (FVPL), transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at FVPL are expensed in profit or loss.

Debt Instruments

Subsequent measurement of debt instruments depends on the Group's business model for managing the asset and the cash flow characteristics of the asset. The Group adopted measurement below in which was classified as debt instruments:

• Amortised cost: Assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are measured at amortised cost. Interest income from these financial assets is included in finance income using the effective interest rate method. Any gain or loss arising on derecognition is recognised directly in the consolidated statement of comprehensive income and presented in "other losses — net" together with foreign exchange gains and losses.

37.7.4 Impairment

The Group assesses on a forward-looking basis the expected credit losses associated with its debt instruments carried at amortised cost. The impairment methodology applied depends on whether there has been a significant increase in credit risk.

For trade receivables, the Group applies the simplified approach permitted by HKFRS 9, which requires expected lifetime losses to be recognised from initial recognition of the receivables, see note 3.1.2 for further details.

37.8 Inventories

Inventories are stated at the lower of cost and net realisable value. Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs necessary to make the sale.

37.9 Trade receivables

Trade receivables are recognised initially at the amount of consideration that is unconditional unless they contain significant financing components, when they are recognised at fair value. The Group holds the trade receivables with the objective of collecting the contractual cash flows and therefore measures them subsequently at amortised cost using the effective interest method. See note 20 for further information about the Group's accounting for trade receivables and note 3.1.2 for the description of the Group's impairment policies.

37.10 Cash and cash equivalents

For the purpose of presentation in the consolidated statement of cash flows, cash and cash equivalents includes cash on hand and deposits held at call with financial institutions.

37.11 Share capital and shares held for employee share scheme

Ordinary shares are classified as equity.

Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

Where any group company purchases the Company's equity instruments, for example as the result of a share buy-back or a share-based payment plan, the consideration paid, including any directly attributable incremental costs (net of income taxes) is deducted from equity attributable to the owners of the Company as treasury shares until the shares are cancelled or reissued. Where such ordinary shares are subsequently reissued, any consideration received, net of any directly attributable incremental transaction costs and the related income tax effects, is included in equity attributable to the owners of the Company.

37.12 Trade and other payables

These amounts of trade and other payables represent liabilities for goods and services provided to the Group prior to the end of financial year which are unpaid. Trade payables and other payables are classified as current liabilities if payment is due within one year or less after the reporting period. If not, they are presented as non-current liabilities.

Trade and other payables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method.

37.13 Borrowings

Borrowings are initially recognised at fair value, net of transaction costs incurred. Borrowings are subsequently measured at amortised cost. Any difference between the proceeds (net of transaction costs) and the redemption value is recognised in the consolidated statement of comprehensive income over the period of the borrowings using the effective interest method.

Fees paid on the establishment of loan facilities are recognised as transaction costs of the loan to the extent that it is probable that some or all of the facilities will be drawn down. In this case, the fee is deferred until the draw-down occurs. To the extent there is no evidence that it is probable that some or all of the facility will be drawn down, the fee is capitalised as a prepayment for liquidity services and amortised over the period of the facility to which it relates.

Borrowings are removed from the balance sheet when the obligation specified in the contract is discharged, cancelled or expired. The difference between the carrying amount of a financial liability that has been extinguished or transferred to another party and the consideration paid, including any non-cash assets transferred or liabilities assumed, is recognised in the consolidated statement of comprehensive income as finance costs.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the end of the reporting period.

37.14 Borrowing costs

General and specific borrowing costs that are directly attributable to the acquisition, construction or production of a qualifying asset are capitalised during the period of time that is required to complete and prepare the asset for its intended use or sale. Qualifying assets are assets that necessarily take a substantial period of time to get ready for their intended use or sale.

Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

Other borrowing costs are expensed in the period in which they are incurred.

37.15 Current and deferred income tax

The income tax expense or credit for the period is the tax payable on the current period's taxable income based on the applicable income tax rate for each jurisdiction adjusted by changes in deferred tax assets and liabilities attributable to temporary differences and to unused tax losses.

37.15.1 Current income tax

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the end of the reporting period in the countries where the Company's subsidiaries operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation. It establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

37.15.2 Deferred income tax

Deferred income tax is provided in full, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial statements. However, deferred income tax liabilities are not recognised if they arise from the initial recognition of goodwill. Deferred income tax is also not accounted for if it arises from initial recognition of an asset or liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit or loss. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantially enacted by the end of the reporting period and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

Deferred income tax assets are recognised only if it is probable that future taxable amounts will be available to utilise those temporary differences and losses.

Deferred income tax assets and liabilities are offset when there is a legally enforceable right to offset current income tax assets and liabilities and where the deferred income tax balances relate to the same taxation authority. Current income tax assets and tax liabilities are offset where the entity has a legally enforceable right to offset and intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously.

37.15.2 Deferred income tax (Continued)

Current and deferred income tax is recognised in the consolidated statement of comprehensive income, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, respectively.

37.16 Employee benefits

37.16.1 Short-term obligations

Liabilities for wages and salaries are recognised in respect of employees' services up to the end of the reporting period and are measured at the amounts expected to be paid when the liabilities are settled. The liabilities are presented as current employee benefit obligations in the balance sheet.

37.16.2 Pension obligations

The Group's companies incorporated in the PRC contribute based on certain percentage of the salaries of the employees to a defined contribution retirement benefit plan organised by relevant government authorities in the PRC on a monthly basis. The government authorities undertake to assume the retirement benefit obligations payable to the existing and future retired employees under these plans and the Group has no further obligation for post-retirement benefits beyond the contributions made. Contributions to these plans are expensed as incurred. Assets of the plans are held and managed by government authorities and are separate from those of the Group.

There were no forfeited contributions (by employers on behalf of employees who leave the scheme prior to vesting fully in such contributions) to offset existing contributions under the defined contribution schemes.

37.17 Share-based payments

Share-based compensation benefits are provided to employees via the Employee Share Scheme. A management committee appointed by the board of directors of the Company will make shares grant to employees with specified cash consideration.

The cost of Employee Share Scheme is recognised in expense, together with a corresponding increase in reserves, over the period in which all of the specified vesting conditions are fulfilled if any. The total amount to be expensed is determined by reference to the number of shares and the fair value of the shares granted as at grant date less the cash consideration.

37.18 Provisions

Provisions for legal claims are recognised when the Group has a present legal or constructive obligation as a result of past events, it is probable that an outflow of resources will be required to settle the obligation and the amount can be reliably estimated. Provisions are not recognised for future operating losses.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Provisions are measured at the present value of management's best estimate of the expenditure required to settle the present obligation at the end of the reporting period. The discount rate used to determine the present value is a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability. The increase in the provision due to the passage of time is recognised as interest expense.

37.19 Earnings per share

37.19.1 Basic earnings per share

Basic earnings per share is calculated by dividing:

- the profit attributable to owners of the Company, excluding any costs of servicing equity other than ordinary shares, and
- by the weighted average number of ordinary shares outstanding during the financial year, adjusted for bonus elements in ordinary shares issued during the year and excluding treasury shares.

37.19.2 Diluted earnings per share

Diluted earnings per share adjusts the figures used in the determination of basic earnings per share to take into account:

- the after-income tax effect of interest and other financing costs associated with dilutive potential ordinary shares, and
- the weighted average number of additional ordinary shares that would have been outstanding assuming the conversion of all dilutive potential ordinary shares.

37.20 Leases

Assets and liabilities arising from a lease are initially measured on a present value basis. Lease liabilities are the net present value of the following lease payments:

- fixed payments (including in-substance fixed payments), less any lease incentives receivable
- variable lease payments that are based on an index or a rate, initially measured using the index or rate as at the commencement date
- amounts expected to be payable by the Group under residual value guarantees
- the exercise price of a purchase option if the Group is reasonably certain to exercise that option, and
- payments of penalties for terminating the lease, if the lease term reflects the Group exercising that option.

Lease payments to be made under reasonably certain extension options are also included in the measurement of the liability.

Lease payments are allocated between principal and finance cost. The finance cost is charged to profit or loss over the lease period so as to produce a constant periodic rate of interest on the remaining balance of the liability for each period.

Right-of-use assets are measured at cost comprising the following:

- the amount of the initial measurement of lease liability
- any lease payments made at or before the commencement date less any lease incentives received
- any initial direct costs, and
- restoration costs.

Lease income from operating leases where the Group is a lessor is recognised in income on a straight-line basis over the lease term. Initial direct costs incurred in obtaining an operating lease are added to the carrying amount of the underlying asset and recognised as expense over the lease term on the same basis as lease income. The respective leased assets are included in the consolidated balance sheet based on their nature.

Entity-specific details about the group's leasing policy are provided in note 13(b).

37.21 Dividend distribution

Provision is made for the amount of any dividend declared, being appropriately authorised and no longer at the discretion of the entity, on or before the end of the reporting period but not distributed at the end of the reporting period.

37.22 Government grants

Grants from the government are recognised at their fair value where there is a reasonable assurance that the grant will be received and the Group will comply with all attached conditions.

Government grants relating to costs are deferred and recognised in the consolidated statement of comprehensive income over the period necessary to match them with the costs that they are intended to compensate.

Government grants relating to the purchase of property, plant and equipment are included in non-current liabilities as deferred income and they are credited to the consolidated statement of comprehensive income on a straight-line basis over the expected lives of the related assets.

37.23 Interest income

Interest income is presented as finance income where it is earned from financial assets that are held for cash management purposes.
