## BUSINESS REVIEW AND OUTLOOK

### Overview

In the year of 2023, the Group continued to adhere to its multi-brand and multi-concept strategy and explored new business opportunities, aiming to further expand its market share and maintain its market position as a leading Chinese cuisine restaurant brand manager and operator in the PRC. Following the relaxation of anti-pandemic measures against the Pandemic and border reopening in early 2023, the Group adopted an active expansion strategy and opened 180 new restaurants in 2023, comprising 134 Tai Er restaurants, 35 Song Hot Pot restaurants, four Jiu Mao Jiu restaurants, six Lai Mei Li Grilled Fish restaurants and one Fresh Wood restaurant. As of December 31, 2023, the Group self-operated 726 restaurants, covering 142 cities in the PRC, Singapore, one city in Canada, one city in Malaysia, one city in Thailand and two cities in the United States.

The Group strives to optimize its portfolio of restaurant brands and focus on brands with greater growth potential. In 2023, the Group accelerated the restaurant network expansion of Tai Er brand and Song Hot Pot brand, while optimized the operation of Lai Mei Li Grilled Fish brand by restaurant renovation and menu upgrades. Meanwhile, in July 2023, the Group introduced its Fresh Wood brand, positioned as a high-end brand, to offer customers beef hot pot dishes using natural and premium food ingredients.

## 業務回顧及前景

### 概覽

於2023年，本集團繼續遵循多品牌及多概念策略，並探索新業務機會，旨在進一步擴大市場份額，並保持作為中國領先的中餐廳品牌管理商及營運商的市場地位。隨著2023年初針對疫情的防疫措施放寬及重新開關，本集團採取積極擴張策略，於2023年新開180間餐廳，包括134間太二餐廳、35間撻火鍋餐廳、四間九毛九餐廳、六間賴美麗烤魚餐廳及一間賞鮮悅木餐廳。截至2023年12月31日，本集團在中國142個城市、新加坡、加拿大1個城市、馬來西亞1個城市、泰國1個城市和美國2個城市自主經營726間餐廳。

本集團竭力優化餐廳品牌組合，並專注於具有更大增長潛力的品牌。於2023年，本集團加快太二品牌及撻火鍋品牌的餐廳網絡擴張，同時通過翻新餐廳及改良菜單優化賴美麗烤魚品牌的營運。此外，於2023年7月，本集團推出以高端品牌為定位的賞鮮悅木品牌，為顧客提供使用天然及優質食材的牛肉火鍋菜餚。

In view of the diminishing impact of the Pandemic, total revenue of the Group increased by 49.4% from RMB4,005.7 million for the year ended December 31, 2022 to RMB5,985.9 million for the year ended December 31, 2023, and its net profit for the year increased significantly by 763.3% from RMB55.6 million for the year ended December 31, 2022 to RMB480.0 million for the year ended December 31, 2023.

The Board is committed to increasing returns for the Shareholders. For the year ended December 31, 2023, apart from utilizing approximately HKD150.0 million for share repurchases on market, the Board also proposes to distribute a final dividend of HKD0.15 per ordinary share (totalling approximately HKD215.5 million), which represents a payout ratio of approximately 43.1% of profit for the year attributable to equity shareholders. Going forward, after a thorough reevaluation of the Group's financial performance, financial position, and strategic development plans for the future, the Board intends to maintain a dividend payout ratio of no less than 40% of profit for the year attributable to equity shareholders.

## 2023 Business and Financial Performance Review

### Restaurant network

In 2023, the Group opened 180 new restaurants, comprising 134 Tai Er restaurants, 35 Song Hot Pot restaurants, four Jiu Mao Jiu restaurants, six Lai Mei Li Grilled Fish restaurants and one Fresh Wood restaurant. Among restaurants of the Group, ten restaurants were closed in 2023 primarily due to (i) the termination of the relevant lease agreements upon expiry, and (ii) unsatisfactory performance of some restaurants.

鑒於疫情的影響日漸減少，本集團的總收入從截至2022年12月31日止年度的人民幣4,005.7百萬元增加49.4%至截至2023年12月31日止年度的人民幣5,985.9百萬元，而年度純利則從截至2022年12月31日止年度的人民幣55.6百萬元大幅增加763.3%至截至2023年12月31日止年度的人民幣480.0百萬元。

董事會致力為股東增加回報。截至2023年12月31日止年度，除動用約150.0百萬港元於市場上購回股份外，董事會亦建議派發末期股息每股普通股0.15港元（合計約215.5百萬港元），派息率約為權益股東應佔年度溢利的43.1%。展望未來，經全面重新評估本集團的財務表現、財務狀況及未來戰略發展計劃後，董事會擬維持不少於權益股東應佔年度溢利40%的派息率。

Restaurant performance of most of the Group's brands improved in 2023. In particular, revenue contribution from Tai Er, Song Hot Pot and Lai Mei Li Grilled Fish increased by 44.3%, 210.4% and 272.3%, respectively. Moreover, the table turnover rates of Tai Er, Song Hot Pot, Jiu Mao Jiu and Lai Mei Li Grilled Fish also increased, which were mainly attributable to the increase in customer traffic following the relaxation of anti-pandemic measures against the Pandemic and border reopening in early 2023. The decrease in average spending per customer of Tai Er in mainland China and Song Hot Pot was a result of the Group's adjustment to menu offerings and food prices, taking into account both internal and external factors such as the market condition and competitive landscape in the industry.

## Outlook

The Group remains fully devoted to providing marvelous dining experience to customers through exquisite dishes, high-quality services and unique dining ambience, and with a view to maintaining a strong market position and enhancing its competitiveness, it will continue to implement the following growth strategies:

- **Replicate the Group's success through further expansion.** The Group has been closely monitoring the post-Pandemic environment in the PRC and adjusting the timeline of its restaurant network expansion plan for different brands as and when appropriate. In 2024, the Group will focus on the development of its existing brands. In particular, the Group plans to further promote the brand image and recognition of Tai Er and Song Hot Pot by continued expansion of their restaurant network as both brands have displayed greater growth potential compared with the Group's other brands. In 2024, the Group targets to open 80 to 100 new Tai Er restaurants and 35 to 40 new Song Hot Pot restaurants in mainland China, and 15 to 20 new Tai Er restaurants outside mainland China. The Group will also continue to refine the business model of Lai Mei Li Grilled Fish brand until it is ready for restaurant network expansion.

## 前景

本集團繼續致力於通過精緻的菜品、優質的服務和獨特的用餐氛圍為顧客提供美妙的用餐體驗，為保持強勢的市場地位及提升競爭力，其將繼續實施以下發展戰略：

- **通過進一步擴張去複製本集團的成功。**本集團一直密切監察中國的後疫情環境，並適時調整其不同品牌的餐廳網絡擴張計劃時間表。於2024年，本集團將專注於發展其現有品牌。具體而言，由於太二及愆火鍋相較本集團其他品牌展示更大增長潛力，本集團計劃通過持續擴張它們的餐廳網絡，進一步提升它們的品牌形象及知名度。於2024年，本集團的目標是在中國內地開設80至100間新太二餐廳及35至40間新愆火鍋餐廳，以及在中國內地以外開設15至20間新太二餐廳。本集團亦將繼續完善賴美麗烤魚品牌的商業模式，直至其為餐廳網絡擴張做好準備。

- **Continue to expand into more market segments by pursuing a multi-brand and multi-concept strategy.** The Group continues to closely track the dining trend and preference of customers and adjust the brand portfolio to focus on brands which it believes to have greater growth potential. For example, the Group introduced Song Hot Pot in 2020 and Lai Mei Li Grilled Fish in 2021, and disposed the Double Eggs brand in 2022 in order to maintain an optimal portfolio of restaurant brands. The Group has upgraded its Lai Mei Li Grilled Fish restaurants to serve grilled fish dishes in sour soup. In addition, in February 2024, the Group launched another new brand, namely Shanwaimian, offering Guizhou style sour soup hot pots. The Group will also invest in companies in the catering service industry. The Group intends to identify targets which adopt innovative business models and possess development and growth potential, or whose business models can create synergies with the Group's business and fit into the multi-brand development strategy of the Group. The Group continues to look for potential targets. The Group believes its multi-brand and multi-concept strategy allows it to further expand into more market segments, capture market opportunities, broaden its customer base and ultimately increase its market share. The collaboration with various young and innovative brands would enable the Group to stay attuned to market trends. The Group will keep exploring potential opportunities and may further adjust and/or expand its brand portfolio to maintain its competitive advantage.
- **Continue to strengthen the Group's supply and support capabilities.** The Group has commenced the construction of its supply chain centers in Southern China, a production plant of hot pot base and compound condiments and a central kitchen in Southwest China, to enhance its supply chain capabilities in support of its future expansion plan. As announced on September 29, 2023, the Group further acquired a parcel of land use rights for the construction of a central kitchen in Songjiang District of Shanghai to better support the restaurant network expansion in Eastern China. In addition, the Group will continue its cooperation with suppliers of key ingredients by way of joint ventures or other means to secure stable supply of key ingredients as well as to better mitigate risks concerning food safety.
- **遵循多品牌及多概念策略，持續向更多細分市場擴張。**本集團繼續密切追蹤顧客的用餐趨勢及喜好，並調整品牌組合以專注於其認為具有更大增長潛力的品牌。舉例而言，本集團於2020年及2021年分別推出愆火鍋及賴美麗烤魚，以及於2022年出售2顆雞蛋煎餅品牌，以維持餐廳品牌的最優組合。本集團已升級賴美麗烤魚餐廳以供應酸湯烤魚菜餚。此外，本集團於2024年2月推出另一個新品牌，即山外面，提供貴州酸湯火鍋。本集團亦將投資於從事餐飲服務業的公司。本集團擬識別採納創新業務模式並具備發展與增長潛力的目標，或物色其業務模式能與本集團業務產生協同效應並符合本集團多品牌發展策略的目標。本集團繼續物色潛在目標。本集團相信，多品牌及多概念策略令其能夠進一步向更多細分市場擴張、把握市場機遇及拓寬顧客群，從而最終提升其市場份額。與各種年輕及創新品牌合作將使本集團能夠緊貼市場趨勢。本集團將繼續探索潛在機會，並可能進一步調整及／或擴充品牌組合以保持競爭優勢。
- **持續增強本集團的供應及支持能力。**本集團已在華南開展建設供應鏈中心，及在中國西南部開展建設一個火鍋底料及複合調味料的生產廠房及一間中央廚房，從而增強供應鏈能力以支持其未來擴張計劃。誠如2023年9月29日所公佈，本集團進一步收購一幅土地的使用權，以於上海市松江區建設一間中央廚房從而更好地支持華東的餐廳網絡擴張。此外，本集團將繼續與主要食材供應商以合營公司的方式或其他方式合作，確保主要食材供應穩定及更好地減低食品安全風險。



## CHAIRMAN'S STATEMENT 主席報告

- **Expand into the global markets to gain international presence.**  
The Group currently operates Tai Er restaurants in Canada, Malaysia, Singapore, Thailand and the United States as well as one Lai Mei Li Grilled Fish restaurant in Singapore. The Group will continue to carry out comprehensive research into potential overseas target markets and carefully evaluate and select appropriate locations for its expansion to gain international presence. The Group will prioritize countries and cities with high population of Chinese people, such as North America, Southeast Asia, Oceania, and other overseas Chinese communities, for its future expansion.
- **Introduce franchise and cooperative model for regional and international expansion.** Following its expansion in the year of 2023, the Group has determined to further expand its restaurant network through diversified business models, i.e. the franchise and cooperative models for, Tai Er and Shanwaimian, as announced on February 3, 2024. This strategic move is designed to fast-track the regional and international expansion of Tai Er, with franchising opportunities springing forth across Xinjiang, Xizang and Taiwan region of China, transportation hubs within mainland China, and extending to the shores of Australia and New Zealand. Simultaneously, Shanwaimian will embark on a cooperative model within designated Chinese shopping malls, setting the stage for a full franchise rollout from February 3, 2025.
- **向全球市場擴張以獲得國際市場份額。**本集團目前在加拿大、馬來西亞、新加坡、泰國及美國經營太二餐廳，同時在新加坡經營一間賴美麗烤魚餐廳。本集團將繼續對潛在海外目標市場開展全面調查，審慎評估及選擇適合其擴張的地點，以獲得國際市場份額。本集團的未來擴張將優先考慮華人眾多的國家及城市，例如北美、東南亞、大洋洲及其他海外華人社區。
- **引進加盟及合作模式進行區域及國際擴張。**繼本集團於2023年的擴張後，其於2024年2月3日公佈決定通過多元化的商業模式（即太二及山外面的加盟及合作模式），進一步擴張其餐廳網絡。此策略舉措旨在通過將加盟機會開放至中國新疆、西藏及台灣地區、中國內地的交通樞紐以及延伸至澳大利亞及新西蘭的海岸線，加快太二的區域及國際擴張。同時，山外面將在中國指定購物中心內開展合作模式，為2025年2月3日起全面開放加盟模式奠定基礎。

# MANAGEMENT DISCUSSION AND ANALYSIS

## 管理層討論與分析

### REVENUE

The Group's revenue increased by 49.4% from RMB4,005.7 million for the year ended December 31, 2022 to RMB5,985.9 million for the year ended December 31, 2023.

#### Revenue by brand

The Group generates revenue from four segments classified by brands, including Tai Er, Song Hot Pot, Jiu Mao Jiu and all other brands. The following table sets forth a breakdown of the Group's revenue by brand for the years indicated:

## MANAGEMENT DISCUSSION AND ANALYSIS

### 管理層討論與分析

Revenue from Tai Er increased by 44.0% from RMB3,108.3 million for the year ended December 31, 2022 to RMB4,476.9 million for the year ended December 31, 2023, primarily due to (i) the restaurant network expansion of Tai Er from 450 restaurants as of December 31, 2022 to 578 restaurants as of December 31, 2023, (ii) the increase in the number of operating days in 2023 compared with that in 2022 amid the recovery of its business operation from the Pandemic and (iii) the increase in table turnover rate of Tai Er restaurants from 3.5 in 2022 to 4.1 in 2023. Revenue from Tai Er as a percentage of total revenue decreased from 77.6% in 2022 to 74.8% in 2023 primarily due to the expansion of other brands of the Group.

Revenue from Song Hot Pot increased significantly by 210.4% from RMB259.8 million for the year ended December 31, 2022 to RMB806.5 million for the year ended December 31, 2023, primarily due to (i) the restaurant network expansion of Song Hot Pot from 27 restaurants as of December 31, 2022 to 62 restaurants as of December 31, 2023 and (ii) the increase in table turnover rate of Song Hot Pot restaurants from 3.6 in 2022 to 3.8 in 2023. As a result, revenue from Song Hot Pot as a percentage of total revenue increased from 6.5% in 2022 to 13.5% in 2023.

Revenue from Jiu Mao Jiu remained relatively stable at RMB605.5 million and RMB629.6 million for the years ended December 31, 2022 and 2023, respectively. Revenue from Jiu Mao Jiu as a percentage of total revenue decreased from 15.1% in 2022 to 10.5% in 2023, primarily due to the continuous expansion of other brands' restaurant network, especially Tai Er and Song Hot Pot.

Revenue from other brands increased by 127.1% from RMB32.1 million for the year ended December 31, 2022 to RMB72.9 million for the year ended December 31, 2023, primarily attributable to revenue contribution from Lai Mei Li Grilled Fish brand due to its restaurant network expansion. As a result, revenue from other brands as a percentage of total revenue increased from 0.8% in 2022 to 1.2% in 2023.

來自太二的收入由截至2022年12月31日止年度的人民幣3,108.3百萬元增加44.0%至截至2023年12月31日止年度的人民幣4,476.9百萬元，乃主要由於(i)太二的餐廳網絡由截至2022年12月31日的450間餐廳擴張至截至2023年12月31日的578間餐廳，(ii)其業務經營從疫情中恢復，使得2023年的經營天數較2022年有所增加及(iii)太二餐廳的翻檯率由2022年的3.5增加至2023年的4.1。來自太二的收入佔總收入的比例由2022年的77.6%下降至2023年的74.8%，此乃主要由於本集團旗下其他品牌的擴張。

來自愆火鍋的收入由截至2022年12月31日止年度的人民幣259.8百萬元大幅增加210.4%至截至2023年12月31日止年度的人民幣806.5百萬元，乃主要由於(i)愆火鍋的餐廳網絡由截至2022年12月31日的27間餐廳擴張至截至2023年12月31日的62間餐廳及(ii)愆火鍋餐廳的翻檯率由2022年的3.6增加至2023年的3.8。因此，來自愆火鍋的收入佔總收入的比例由2022年的6.5%上升至2023年的13.5%。

來自九毛九的收入於截至2022年及2023年12月31日止年度分別為人民幣605.5百萬元及人民幣629.6百萬元，維持相對平穩。來自九毛九的收入佔總收入的比例由2022年的15.1%下降至2023年的10.5%，此乃主要由於其他品牌餐廳網絡的持續擴張，尤其是太二及愆火鍋。

來自其他品牌的收入由截至2022年12月31日止年度的人民幣32.1百萬元增加127.1%至截至2023年12月31日止年度的人民幣72.9百萬元，乃主要由於賴美麗烤魚品牌因其餐廳網絡擴張而貢獻的收入。因此，來自其他品牌的收入佔總收入的比例由2022年的0.8%上升至2023年的1.2%。

## MANAGEMENT DISCUSSION AND ANALYSIS

### 管理層討論與分析

Revenue from restaurant operations increased by 58.2% from RMB3,203.2 million for the year ended December 31, 2022 to RMB5,066.5 million for the year ended December 31, 2023, primarily due to (i) the Group's restaurant network expansion from 556 restaurants as of December 31, 2022 to 726 restaurants as of December 31, 2023 and (ii) the growth in same store sales as the number of days of operation and table turnover rates of the Group's restaurants increased in 2023 amid the recovery of business operation of the Group from the Pandemic. As a result, revenue from restaurant operations as a percentage of total revenue increased from 80.0% for the year ended December 31, 2022 to 84.6% for the year ended December 31, 2023.

Revenue from delivery business increased by 14.5% from RMB787.1 million for the year ended December 31, 2022 to RMB901.2 million for the year ended December 31, 2023, primarily due to an increase in the number of restaurants that offered delivery services along with the Group's restaurant network expansion. Revenue from delivery business as a percentage of total revenue decreased from 19.7% for the year ended December 31, 2022 to 15.1% for the year ended December 31, 2023, primarily due to the moderate increase in customer demand on delivery services comparatively in view of the recovery of restaurant operations from the Pandemic.

Revenue from others increased by 18.2% from RMB15.4 million for the year ended December 31, 2022 to RMB18.2 million for the year ended December 31, 2023, primarily due to the increase in revenue generated from sales of goods. Revenue from others as a percentage of total revenue remained stable at 0.3% and 0.3% for the years ended December 31, 2022 and 2023, respectively.

### OTHER REVENUE

The Group's other revenue increased by 77.7% from RMB71.3 million for the year ended December 31, 2022 to RMB126.7 million for the year ended December 31, 2023, primarily due to (i) an increase in interest income on bank deposits attributable to the increased interest rates and (ii) an increase in income from value-added tax super deduction and exemption granted by government authorities in the PRC.

餐廳經營收入從截至2022年12月31日止年度的人民幣3,203.2百萬元增加58.2%至截至2023年12月31日止年度的人民幣5,066.5百萬元，主要由於(i)本集團的餐廳網絡由截至2022年12月31日的556間餐廳擴張至截至2023年12月31日的726間餐廳及(ii)本集團業務從疫情中恢復經營，本集團餐廳的經營天數及翻檯率於2023年有所增加，使得同店銷售有所增長。因此，餐廳經營收入佔總收入的比例由截至2022年12月31日止年度的80.0%上升至截至2023年12月31日止年度的84.6%。

外賣業務收入從截至2022年12月31日止年度的人民幣787.1百萬元增加14.5%至截至2023年12月31日止年度的人民幣901.2百萬元，主要由於提供外賣服務的餐廳數目隨著本集團擴張餐廳網絡而有所增加。外賣業務收入佔總收入的比例由截至2022年12月31日止年度的19.7%下降至截至2023年12月31日止年度的15.1%，此乃主要由於餐廳從疫情中恢復經營，顧客對外賣服務的需求相對適度增加。

其他收入從截至2022年12月31日止年度的人民幣15.4百萬元增加18.2%至截至2023年12月31日止年度的人民幣18.2百萬元，主要由於商品銷售所得收入增加。其他收入佔總收入的比例於截至2022年及2023年12月31日止年度維持穩定，分別為0.3%及0.3%。

### 其他收入

本集團的其他收入從截至2022年12月31日止年度的人民幣71.3百萬元增加77.7%至截至2023年12月31日止年度的人民幣126.7百萬元，主要由於(i)利率增加致使銀行存款利息收入增加及(ii)中國政府機關授出的增值稅加計抵減及豁免的收入增加。

## RAW MATERIALS AND CONSUMABLES USED

The Group's raw materials and consumables used increased by 48.0% from RMB1,447.1 million for the year ended December 31, 2022 to RMB2,142.2 million for the year ended December 31, 2023 as a result of its revenue growth. Raw materials and consumables used as a percentage of revenue remained relatively stable at 36.1% and 35.8% for the years ended December 31, 2022 and 2023, respectively.

## STAFF COSTS

The Group's staff costs increased by 36.2% from RMB1,133.9 million for the year ended December 31, 2022 to RMB1,544.1 million for the year ended December 31, 2023, primarily due to an increase in the number of store level employees of the Group arising from its restaurant network expansion. Staff costs as a percentage of revenue decreased from 28.3% for the year ended December 31, 2022 to 25.8% for the year ended December 31, 2023, primarily due to the improvement in the Group's operational efficiency.

## DEPRECIATION OF RIGHT-OF-USE ASSETS

Depreciation of right-of-use assets increased by 20.4% from RMB403.0 million for the year ended December 31, 2022 to RMB485.3 million for the year ended December 31, 2023, primarily due to an increase in the number of restaurants of the Group. Depreciation of right-of-use assets as a percentage of revenue decreased from 10.1% for the year ended December 31, 2022 to 8.1% for the year ended December 31, 2023, primarily because the increase in total revenue outpaced the increase in depreciation of right-of-use assets as a result of the recovery of restaurant operations from the Pandemic.

## OTHER RENTALS AND RELATED EXPENSES

The Group's other rentals and related expenses increased by 66.8% from RMB83.2 million for the year ended December 31, 2022 to RMB138.8 million for the year ended December 31, 2023, primarily due to an increase in variable rent payments as a result of the Group's revenue growth. Other rentals and related expenses as a percentage of revenue remained relatively stable at 2.1% and 2.3% for the years ended December 31, 2022 and 2023, respectively.

## 所用原材料及耗材

本集團的所用原材料及耗材從截至2022年12月31日止年度的人民幣1,447.1百萬元增加48.0%至截至2023年12月31日止年度的人民幣2,142.2百萬元，此乃由於其收入增長。所用原材料及耗材佔收入的比例於截至2022年及2023年12月31日止年度維持相對穩定，分別為36.1%及35.8%。

## 員工成本

本集團的員工成本從截至2022年12月31日止年度的人民幣1,133.9百萬元增加36.2%至截至2023年12月31日止年度的人民幣1,544.1百萬元，主要由於本集團擴張餐廳網絡，導致其店舖層面的僱員數目增加。員工成本佔收入的比例由截至2022年12月31日止年度的28.3%下降至截至2023年12月31日止年度的25.8%，主要由於本集團的營運效率有所改善。

## 使用權資產折舊

使用權資產折舊從截至2022年12月31日止年度的人民幣403.0百萬元增加20.4%至截至2023年12月31日止年度的人民幣485.3百萬元，主要由於本集團的餐廳數目增加。使用權資產折舊佔收入的比例由截至2022年12月31日止年度的10.1%下降至截至2023年12月31日止年度的8.1%，主要由於餐廳從疫情中恢復經營，導致總收入的增速超過使用權資產折舊的增速。

## 其他租金及相關開支

本集團的其他租金及相關開支從截至2022年12月31日止年度的人民幣83.2百萬元增加66.8%至截至2023年12月31日止年度的人民幣138.8百萬元，主要由於本集團的收入增長導致可變租金付款增加。其他租金及相關開支佔收入的比例於截至2022年及2023年12月31日止年度維持相對穩定，分別為2.1%及2.3%。

## DEPRECIATION AND AMORTIZATION OF OTHER ASSETS

Depreciation and amortization of other assets increased by 23.8% from RMB190.3 million for the year ended December 31, 2022 to RMB235.6 million for the year ended December 31, 2023, primarily due to an increase in restaurant decoration expenditures and purchases of kitchen and other equipment along with the restaurant network expansion of the Group. Depreciation and amortization of other assets as a percentage of revenue slightly decreased from 4.7% for the year ended December 31, 2022 to 3.9% for the year ended December 31, 2023, primarily because the increase in total revenue outpaced the increase in depreciation and amortization of other assets as a result of the recovery of restaurant operations from the Pandemic.

## UTILITY EXPENSES

The Group's utility expenses increased by 47.3% from RMB148.7 million for the year ended December 31, 2022 to RMB219.0 million for the year ended December 31, 2023, primarily due to the expansion of restaurant network of the Group. Utility expenses as a percentage of revenue remained stable at 3.7% and 3.7% for the years ended December 31, 2022 and 2023, respectively.

## TRAVELLING AND RELATED EXPENSES

The Group's travelling and related expenses increased by 52.2% from RMB25.5 million for the year ended December 31, 2022 to RMB38.8 million for the year ended December 31, 2023, primarily because the Group's staff traveled more frequently for daily operations as a result of the expansion of restaurant network of the Group. Travelling and related expenses as a percentage of revenue remained stable at 0.6% and 0.6% for the years ended December 31, 2022 and 2023, respectively.

## ADVERTISING AND PROMOTION EXPENSES

The Group's advertising and promotion expenses increased by 52.3% from RMB55.5 million for the year ended December 31, 2022 to RMB84.5 million for the year ended December 31, 2023, primarily due to an increase in advertisement placement. Advertising and promotion expenses as a percentage of revenue remained stable at 1.4% and 1.4% for the years ended December 31, 2022 and 2023, respectively.

## 其他資產的折舊及攤銷

其他資產的折舊及攤銷從截至2022年12月31日止年度的人民幣190.3百萬元增加23.8%至截至2023年12月31日止年度的人民幣235.6百萬元，主要由於隨著本集團擴張餐廳網絡，餐廳裝修支出以及廚房及其他設備的採購有所增加。其他資產的折舊及攤銷佔收入的比例由截至2022年12月31日止年度的4.7%輕微下降至截至2023年12月31日止年度的3.9%，主要由於餐廳從疫情中恢復經營，導致總收入的增速超過其他資產的折舊及攤銷的增速。

## 水電開支

本集團的水電開支從截至2022年12月31日止年度的人民幣148.7百萬元增加47.3%至截至2023年12月31日止年度的人民幣219.0百萬元，主要由於本集團擴張餐廳網絡。水電開支佔收入的比例於截至2022年及2023年12月31日止年度維持穩定，分別為3.7%及3.7%。

## 差旅及相關開支

本集團的差旅及相關開支從截至2022年12月31日止年度的人民幣25.5百萬元增加52.2%至截至2023年12月31日止年度的人民幣38.8百萬元，主要由於本集團擴張餐廳網絡，導致員工為日常營運而出差的頻次增加。差旅及相關開支佔收入的比例於截至2022年及2023年12月31日止年度維持穩定，分別為0.6%及0.6%。

## 廣告及推廣開支

本集團的廣告及推廣開支從截至2022年12月31日止年度的人民幣55.5百萬元增加52.3%至截至2023年12月31日止年度的人民幣84.5百萬元，主要由於廣告投放增加。廣告及推廣開支佔收入的比例於截至2022年及2023年12月31日止年度維持穩定，分別為1.4%及1.4%。



## OTHER EXPENSES

The Group's other expenses increased by 38.8% from RMB316.1 million for the year ended December 31, 2022 to RMB438.6 million for the year ended December 31, 2023, primarily due to (i) an increase in expenses for opening new restaurants of RMB31.7 million, (ii) an increase in transportation and related expenses of RMB31.0 million, (iii) an increase in professional service fees of RMB16.3 million, and (iv) an increase in maintenance expenses of RMB14.6 million.

## OTHER NET LOSSES

The Group's other net losses decreased by 63.2% from RMB87.8 million for the year ended December 31, 2022 to RMB32.3 million for the year ended December 31, 2023, primarily due to a decrease in net foreign exchange losses of RMB56.0 million.

## FINANCE COSTS

The Group's finance costs increased by 14.5% from RMB81.1 million for the year ended December 31, 2022 to RMB92.9 million for the year ended December 31, 2023, primarily due to an increase in interest on lease liabilities recognized in accordance with IFRS 16 associated with the Group's increased number of leases as a result of the expansion of its restaurant network.

## IMPAIRMENT LOSSES OF PROPERTY, PLANT AND EQUIPMENT AND RIGHT-OF-USE ASSETS

Impairment losses of property, plant and equipment and right-of-use assets increased by 202.8% from RMB7.2 million for the year ended December 31, 2022 to RMB21.8 million for the year ended December 31, 2023, primarily because the Group had prudently made provisions for impairment of assets considering the unsatisfactory performance of some restaurants.

## INCOME TAX

The Group's income tax increased significantly by 304.1% from RMB38.7 million for the year ended December 31, 2022 to RMB156.4 million for the year ended December 31, 2023, primarily due to an increase in taxable income.

## 其他開支

本集團的其他開支從截至2022年12月31日止年度的人民幣316.1百萬元增加38.8%至截至2023年12月31日止年度的人民幣438.6百萬元，主要由於(i)開設新餐廳的開支增加人民幣31.7百萬元，(ii)運輸及相關開支增加人民幣31.0百萬元，(iii)專業服務費增加人民幣16.3百萬元，及(iv)維護開支增加人民幣14.6百萬元。

## 其他虧損淨額

本集團的其他虧損淨額從截至2022年12月31日止年度的人民幣87.8百萬元減少63.2%至截至2023年12月31日止年度的人民幣32.3百萬元，主要由於外匯虧損淨額減少人民幣56.0百萬元。

## 融資成本

本集團的融資成本從截至2022年12月31日止年度的人民幣81.1百萬元增加14.5%至截至2023年12月31日止年度的人民幣92.9百萬元，主要由於就本集團因擴張餐廳網絡而增加的租賃而根據國際財務報告準則第16號確認的租賃負債利息增加。

## 物業、廠房及設備以及使用權資產的減值虧損

物業、廠房及設備以及使用權資產的減值虧損從截至2022年12月31日止年度的人民幣7.2百萬元增加202.8%至截至2023年12月31日止年度的人民幣21.8百萬元，主要由於本集團經考慮部分餐廳表現未如理想後審慎地就資產減值計提撥備。

## 所得稅

本集團的所得稅從截至2022年12月31日止年度的人民幣38.7百萬元大幅增加304.1%至截至2023年12月31日止年度的人民幣156.4百萬元，主要由於應課稅收入增加。

#### PROFIT FOR THE YEAR

As a result of the foregoing, profit for the year significantly increased by 763.3% from RMB55.6 million for the year ended December 31, 2022 to RMB480.0 million for the year ended December 31, 2023.

#### OTHER COMPREHENSIVE INCOME FOR THE YEAR

The Group holds equity investments in several entities in the PRC. The entities are mainly engaged in the catering industry. The Group recorded loss resulting from equity investments at fair value through other comprehensive income – net movement in fair value reserve (non-recycling) of RMB8.9 million for the year ended December 31, 2023, primarily due to the relatively low valuation of its investments as a result of challenging macroeconomic environment in 2023, as compared with RMB126.4 million for the year ended December 31, 2022 as a result of the adverse impact of the Pandemic in 2022.

The Group recorded exchange differences on translation of financial statements of operations outside the mainland China of RMB33.3 million for the year ended December 31, 2023 as other comprehensive income, as compared with RMB213.3 million for the year ended December 31, 2022, primarily due to the exchange rate fluctuation.

#### NON-IFRS MEASURES

The Group adopts the store level operating profit and adjusted net profit, which are not required by or presented in accordance with IFRS as important financial measures to supplement its consolidated financial statements.

#### Store Level Operating Profit and Store Level Operating Profit Margin

The Group believes that store level operating profit helps Shareholders and investors better understand its multi-brand and multi-concept strategy by directly illustrating the profitability of its different brands at store level, and that it is frequently used by analysts, investors and other interested parties in the evaluation of companies in the industry.

#### 年度溢利

由於上述因素，年度溢利從截至2022年12月31日止年度的人民幣55.6百萬元大幅增加763.3%至截至2023年12月31日止年度的人民幣480.0百萬元。

#### 年度其他全面收益

本集團持有若干中國實體的股權投資。該等實體主要從事餐飲行業。本集團於截至2023年12月31日止年度錄得按公平值計入其他全面收益的股權投資－公平值儲備變動淨額（不可撥回）產生的虧損人民幣8.9百萬元，主要由於受2023年宏觀經濟環境挑戰重重所影響，其投資估值相對偏低，而於截至2022年12月31日止年度則因2022年疫情的不利影響而錄得人民幣126.4百萬元。

截至2023年12月31日止年度，本集團將中國內地以外業務財務報表換算所產生的匯兌差額人民幣33.3百萬元入賬列為其他全面收益，對比截至2022年12月31日止年度則為人民幣213.3百萬元，主要由匯率波動所致。

#### 非國際財務報告準則計量

本集團採用店舖層面經營利潤及經調整純利作為重要的財務衡量指標以補充其綜合財務報表，而此並非國際財務報告準則所規定或根據國際財務報告準則所呈列的財務衡量指標。

#### 店舖層面經營利潤及店舖層面經營利潤率

本集團認為，店舖層面經營利潤能夠直接說明其不同品牌於店舖層面的盈利能力，有助於股東及投資者更了解其多品牌及多概念策略，且為分析師、投資者及其他利益相關人士在評估行業公司時所頻繁使用。

The Group defines store level operating profit as revenue for the year deducting the following expenses at store level: (i) raw materials and consumables used, (ii) staff costs, (iii) depreciation of right-of-use assets, (iv) other rentals and related expenses, (v) depreciation and amortization of other assets, (vi) utility expenses, (vii) advertising and promotion expenses and (viii) other expenses, excluding unallocated headquarter expenses. The following table illustrates the Group's store level operating profit and store level operating profit margin by brands for the years indicated:

#### Adjusted Net Profit and Adjusted Net Profit Margin

The presentation of adjusted net profit facilitates comparisons of operating performance from period to period and company to company, by eliminating potential impacts of items that the management does not consider indicative of the Group's operating performance. Equity-settled share-based payment expenses are non-operational expenses arising from granting restricted stock units and share options to selected executives and employees, the amount of which may not directly correlate with the underlying performance of the Group's business operations. The Group believes that the adjusted net profit is frequently used by other interested parties when evaluating the performance of a company.

The Group defines adjusted net profit as profit for the year adding equity-settled share-based payment expenses, which are non-recurring charges. The following table illustrates a reconciliation from profit for the year to adjusted net profit for the years indicated:

The Group's inventories increased by 11.9% from RMB118.1 million as of December 31, 2022 to RMB132.1 million as of December 31, 2023, primarily due to the expansion of restaurant network of the Group.

The Group's inventory turnover days in 2022 and 2023, being the average of the beginning and ending inventories for that year divided by raw materials and consumables used for the same year and multiplied by 365 days, was 23.8 days and 21.3 days, respectively. The decrease in its inventory turnover days was primarily due to the faster consumption of food ingredients as a result of the recovery of restaurant operations of the Group from the Pandemic.

本集團的存貨由截至2022年12月31日的人民幣118.1百萬元增加11.9%至截至2023年12月31日的人民幣132.1百萬元，主要由於本集團擴張餐廳網絡。

本集團於2022年及2023年的存貨周轉天數（即該年度的年初和年末存貨平均值除以同一年度所用原材料及耗材再乘以365天）分別為23.8天及21.3天。存貨周轉天數減少乃主要由於本集團的餐廳從疫情中恢復經營，加快了食材消耗。

#### RIGHT-OF-USE ASSETS

The Group's right-of-use assets, which represented the leases for its restaurant premises, headquarters offices, central kitchens and certain kitchen equipment, increased by 27.8% from RMB1,571.0 million as of December 31, 2022 to RMB2,007.9 million as of December 31, 2023, primarily due to the increase in the number of Tai Er restaurants and Song Hot Pot restaurants.

#### TRADE DEBTORS

Trade debtors of the Group primarily consisted of (i) bills settled through third party payment platforms such as Alipay or WeChat Pay, which were normally settled within a short period of time, (ii) bills for its delivery business settled through third party delivery service platforms, which were settled within three calendar days, and, to a lesser extent, (iii) bills received by shopping malls on behalf of the Group for certain restaurants, which were normally settled within one month. Trade debtors of the Group increased by 82.5% from RMB20.6 million as of December 31, 2022 to RMB37.6 million as of December 31, 2023, primarily due to the expansion of restaurant network of the Group. The Group's trade debtors turnover days, being the average of the beginning and ending balances of trade debtors for that year divided by revenue for the same year and multiplied by 365 days, remained relatively stable at 1.5 days and 1.8 days in 2022 and 2023, respectively.

#### TRADE PAYABLES

Trade payables of the Group primarily consisted of payables to suppliers. Trade payables of the Group increased by 11.2% from RMB188.2 million as of December 31, 2022 to RMB209.3 million as of December 31, 2023, primarily due to the expansion of restaurant network of the Group. The Group's trade payables turnover days, being the average of the beginning and ending balances of trade payables for that year divided by raw materials and consumables used for the same year and multiplied by 365 days, decreased from 41.5 days in 2022 to 33.9 days in 2023, primarily due to the timely settlement of the Group's purchases.

#### LOANS AND ADVANCES TO ASSOCIATES

As of December 31, 2023, the Group's loans and advances to associates amounted to RMB142.6 million (as of December 31, 2022: RMB139.1 million). Such loans and advances were mainly provided to associates that supplied food ingredients to the Group to secure stable supply of key food ingredients.

#### 使用權資產

本集團的使用權資產(指其餐廳場所、總部寫字樓、中央廚房及若干廚房設備的租賃)由截至2022年12月31日的人民幣1,571.0百萬元增加27.8%至截至2023年12月31日的人民幣2,007.9百萬元,主要由於太二餐廳及燉火鍋餐廳數目增加。

#### 貿易應收款項

本集團的貿易應收款項主要包括(i)透過支付寶或微信支付等第三方支付平台結算的賬單,一般於短期內結算;(ii)透過第三方外賣服務平台結算的外賣業務賬單,於三個曆日內結算;及較少的(iii)購物商場代本集團的若干餐廳收取的賬單,一般於一個月內結算。本集團的貿易應收款項由截至2022年12月31日的人民幣20.6百萬元增加82.5%至截至2023年12月31日的人民幣37.6百萬元,主要由於本集團擴張餐廳網絡。本集團的貿易應收款項周轉天數(即該年度的貿易應收款項的期初及期末結餘的平均值除以同一年度的收入再乘以365天)於2022年及2023年維持相對穩定,分別為1.5天及1.8天。

#### 貿易應付款項

本集團的貿易應付款項主要包括應付予供應商的款項。本集團的貿易應付款項由截至2022年12月31日的人民幣188.2百萬元增加11.2%至截至2023年12月31日的人民幣209.3百萬元,主要由於本集團擴張餐廳網絡。本集團的貿易應付款項周轉天數(即該年度的貿易應付款項的期初及期末結餘的平均值除以同一年度所用原材料及耗材再乘以365天)由2022年的41.5天減少至2023年的33.9天,主要由於本集團採購的及時結算。

#### 向聯營公司提供貸款及墊款

截至2023年12月31日,本集團向聯營公司提供的貸款及墊款為人民幣142.6百萬元(截至2022年12月31日:人民幣139.1百萬元)。該等貸款及墊款主要提供予向本集團供應食材的聯營公司以確保主要食材供應穩定。

## EQUITY SECURITIES DESIGNATED AT FAIR VALUE THROUGH OTHER COMPREHENSIVE INCOME (NON-RECYCLING)

The Group holds unlisted and listed equity investments in several entities. The Group designated its investments in unlisted and listed equity securities at fair value through other comprehensive income. As of December 31, 2023, the fair values of the Group's unlisted and listed equity investments were RMB48.5 million and RMB6.7 million, respectively (as of December 31, 2022: RMB54.0 million and RMB11.4 million, respectively). The fair value loss of the Group's equity investments for the year ended December 31, 2023 was primarily because the valuations of equity investments held by the Group, which were mainly companies in the catering industry, remained at a relatively low level in 2023 due to challenging macroeconomic environment.

## CAPITAL STRUCTURE

The Group's total assets increased from RMB5,407.1 million as of December 31, 2022 to RMB6,520.9 million as of December 31, 2023. The Group's total liabilities increased from RMB2,207.9 million as of December 31, 2022 to RMB3,163.9 million as of December 31, 2023. Liabilities-to-assets ratio increased from 40.8% as of December 31, 2022 to 48.5% as of December 31, 2023.

The current ratio, being current assets divided by current liabilities as of the respective date, decreased from 2.71 as of December 31, 2022 to 2.00 as of December 31, 2023.

## 指定為按公平值計入其他全面收益(不可撥回)的股本證券

本集團持有若干實體的非上市及上市股本投資。本集團指定其非上市及上市股本證券投資為按公平值計入其他全面收益計量。截至2023年12月31日，本集團非上市及上市股本投資的公平值分別為人民幣48.5百萬元及人民幣6.7百萬元（截至2022年12月31日：分別為人民幣54.0百萬元及人民幣11.4百萬元）。於截至2023年12月31日止年度，本集團股權投資的公平值虧損乃主要由於宏觀經濟環境充滿挑戰，以致本集團所持股權投資（主要為餐飲業公司）的估值於2023年仍然處於相對低的水平。

## 資本結構

本集團的總資產由截至2022年12月31日的人民幣5,407.1百萬元增加至截至2023年12月31日的人民幣6,520.9百萬元。本集團的總負債由截至2022年12月31日的人民幣2,207.9百萬元增加至截至2023年12月31日的人民幣3,163.9百萬元。資產負債率由截至2022年12月31日的40.8%上升至截至2023年12月31日的48.5%。

流動比率（即截至相關日期的流動資產除以流動負債）由截至2022年12月31日的2.71下降至截至2023年12月31日的2.00。

## LIQUIDITY, CAPITAL RESOURCES AND GEARING

The Group adopts a prudent funding and treasury policy with a view to optimize its financial position. The Group regularly monitors its funding requirements to support its business operations and perform ongoing liquidity review. For the year ended December 31, 2023, the Group financed its operations primarily through cash generated from operations, proceeds from the Global Offering in connection with the Listing and proceeds from the Subscription (as defined in the announcement of the Company dated July 16, 2020 in relation to the subscription for new Shares under the general mandate). The Group mainly used Renminbi and Hong Kong dollars to make borrowings and loans and to hold cash and cash equivalents. The Group mainly utilized its cash on procurement of food ingredients, consumables and equipment, supply chain construction and restaurant renovations. The Group's cash and cash equivalents increased by 20.7% from RMB1,098.9 million as of December 31, 2022 to RMB1,326.9 million as of December 31, 2023, primarily attributable to cash inflows from its restaurant operations.

The Group's gearing ratio, being interest-bearing bank loans divided by total equity as of the respective dates and multiplied by 100%, increased from 0.9% as of December 31, 2022 to 7.3% as of December 31, 2023, primarily due to the increase in the balance of bank loans.

## CAPITAL EXPENDITURES

The Group's capital expenditures, which refer to the payment for purchases of property, plant and equipment and right-of-use assets are incurred primarily for opening new restaurants, procuring property, plant and equipment for new restaurants, renovating existing restaurants and purchasing furniture and equipment used in the Group's restaurant operations and construction of supply chain. The Group's total capital expenditures increased by 55.7% from RMB370.1 million for the year ended December 31, 2022 to RMB576.2 million for the year ended December 31, 2023.

## 流動資金、資本資源及資本負債比率

本集團採納審慎的融資及庫務政策，務求優化其財務狀況。本集團定期監察其資金需求，以支持業務營運及進行持續的流動性審查。截至2023年12月31日止年度，本集團主要通過經營所得現金、就上市而進行的全球發售所得款項，以及認購事項（定義見本公司日期為2020年7月16日有關根據一般授權認購新股份的公告）所得款項為其營運提供資金。本集團主要使用人民幣及港元進行借貸以及持有現金及現金等價物。本集團主要就採購食材、耗材及設備、建設供應鏈以及餐廳翻新動用其現金。本集團的現金及現金等價物由截至2022年12月31日的人民幣1,098.9百萬元增加20.7%至截至2023年12月31日的人民幣1,326.9百萬元，主要歸因於來自其餐廳經營的現金流入。

本集團的資本負債比率（即截至相關日期的計息銀行貸款除以權益總額再乘以100%）由截至2022年12月31日的0.9%增加至截至2023年12月31日的7.3%，此乃主要由於銀行貸款餘額增加。

## 資本支出

本集團的資本支出指購買物業、廠房及設備以及使用權資產所支付的款項，主要用於開設新餐廳、為新餐廳採購物業、廠房及設備、翻新現有餐廳及購買本集團經營餐廳所用的家具及設備以及建設供應鏈。本集團的資本支出總額由截至2022年12月31日止年度的人民幣370.1百萬元增加55.7%至截至2023年12月31日止年度的人民幣576.2百萬元。

#### PLEDGE OF ASSETS

As of December 31, 2023, bank deposits of RMB10.7 million were pledged as securities for a currency forward contract (as of December 31, 2022: RMB10.6 million) and bank deposits of RMB220.8 million were pledged as securities for bank loans (as of December 31, 2022: nil).

Save as disclosed above, as of December 31, 2023, the Group did not have any pledge on its assets.

#### SIGNIFICANT EVENTS AFTER THE REPORTING PERIOD

Except for the recommendation of a final dividend of HKD0.15 per ordinary share for the year ended December 31, 2023, as of the date of this annual report, there is no material event subsequent to December 31, 2023 which could have a material impact on the Group's operating and financial performance.

#### FOREIGN EXCHANGE RISK AND HEDGING

The Group mainly operates in the PRC with most of the transaction denominated and settled in Renminbi. However, the Group has cash and deposits denominated in other currencies which are exposed to foreign currency exchange risks. The Group has not hedged its foreign currency exchange risks, but will closely monitor the exposure and take additional measures when necessary to make sure the foreign exchange risks are manageable.

## MATERIAL ACQUISITIONS, DISPOSALS AND FUTURE PLANS FOR MAJOR INVESTMENT

During the year ended December 31, 2023, the Group did not conduct any material investments, acquisitions or disposals. In addition, save for the expansion plans as disclosed in the sections headed “Business” and “Future Plans and Use of Proceeds” in the Prospectus and the intended use of proceeds from the Subscription as disclosed in the Company’s announcements dated July 16, 2020, July 23, 2020 and July 30, 2020, the Group has no specific plan for major investment or acquisition for major capital assets or other businesses. However, the Group will continue to identify new opportunities for business development.

## EMPLOYEES

As of December 31, 2023, the Group had 22,467 employees, including 10,650 outsourced personnel. For the year ended December 31, 2023, staff costs (including Directors’ emoluments) of the Group amounted to RMB1,544.1 million (for the year ended December 31, 2022: RMB1,133.9 million).

The Group’s success depends on its ability to attract, retain and motivate qualified personnel. The remuneration package for employees of the Group generally includes salary and bonuses. The Group determines employee remuneration based on factors such as qualifications and years of experience. Employees also receive welfare benefits, including medical care, retirement benefits, occupational injury insurance and other miscellaneous items. The Group makes contributions to mandatory social security funds for employees to provide for retirement, medical, work-related injury, maternity and unemployment benefits.

He joined our Group in 2013 and has served as the general manager of Tai Er Catering, a subsidiary of our Company since November 2017. ## 企業管治報告

### CORPORATE GOVERNANCE PRACTICES

The Board recognizes the importance of good corporate governance to the Company's healthy growth and has devoted considerable efforts to formulating and implementing corporate governance practices appropriate to the Company's needs. The Company has adopted the principles and code provisions of the CG Code as the basis of the Company's corporate governance practices.

During the year ended December 31, 2023, the Company has complied with all applicable code provisions as set out in the CG Code save for the deviations from code provision C.2.1 which are explained in the relevant paragraphs of this Corporate Governance Report.

The Company will continue to review and monitor its corporate governance practices to ensure compliance with the CG Code. Key corporate governance principles and practices of the Company are summarized below.

### THE BOARD

#### Responsibilities, Accountabilities and Contributions of the Board

Direction and control of Company business are vested in the Board. The Board establishes policies, strategies and plans for the development of Company business, and provides leadership in the creation of value for Shareholders. All Directors have carried out their duties in good faith, have been in compliance with applicable laws and regulations, have taken decisions objectively and have acted in the interests of the Company and its shareholders at all times. The Directors shall disclose to the Company details of other offices held by them.

The Board takes responsibility for all major matters of the Company, including approval and monitoring of all policy matters, overall strategies and budgets, risk management and internal control systems, material transactions (particularly those involving conflict of interests), financial information, appointment of Directors and other significant financial and operational matters.

The Board regularly reviews the contribution required from a Director to perform his/her responsibilities to the Company, and whether the Director is spending sufficient time performing them.

### 企業管治常規

董事會深知良好的企業管治對本公司穩健發展的重要性，並致力制訂及實施配合本公司需要的企業管治常規。本公司已採納企業管治守則的原則及守則條文作為本公司企業管治常規的基礎。

#### 董事會責任、問責及貢獻

董事會定期檢討董事就履行其對本公司的責任所需作出的貢獻及是否付出足夠時間履行責任。

The day-to-day management, administration and operation of the Company are led by the Board and senior management of the Company. The Board has delegated a schedule of responsibilities to the management for implementing Board decisions, and directing and coordinating the daily operation and management of the Company. The Board reviews the delegated functions and work tasks regularly. The management has to obtain Board approval prior to entering into any significant transactions.

If a substantial shareholder or a Director has a potential conflict of interest in a matter to be considered by the Board which the Board has determined to be material, the relevant Director shall abstain from voting and a Board meeting attended by independent non-executive Directors who, and whose close associates, have no material interest in the matter shall be held to discuss and vote on the same.

The Company has arranged appropriate insurance coverage on Directors' liabilities in respect of any legal actions taken against Directors arising out of corporate activities. The insurance coverage would be reviewed on an annual basis.

The biographical details of the Directors and the relationships among the members of the Board are disclosed in the section headed “Directors and Senior Management” in this annual report. To the best knowledge of the Company, there is no other financial, business, family or other material/relevant relationship among the members of the Board.

During the year ended December 31, 2023, the Board at all times met the requirement of the Listing Rules of having a minimum of three independent non-executive Directors (representing at least one-third of the Board) with one of them possessing appropriate professional qualifications or accounting or related financial management expertise.

The composition of the Board reflects the necessary balance of skills and experience appropriate for the business requirement and objectives of the Group and for the exercise of independent judgement.

The Company has received a written annual confirmation from each independent non-executive Director of his/her independence pursuant to the requirements of the Listing Rules. The Company considers all independent non-executive Directors to be independent in accordance with the independence guidelines set out in Rule 3.13 of the Listing Rules.

The Company has implementable and effective mechanisms to ensure independent views and input are available to the Board. All Directors have timely access to all relevant information as well as the advice and services of the joint company secretaries and senior management of the Company, with a view to ensuring that Board procedures and all applicable laws and regulations are followed. Any Director may seek independent professional advice in appropriate circumstances at the Company’s expenses, upon reasonable request made to the Board. During the year ended December 31, 2023, the Board has reviewed the board independence mechanisms and considered that the implementation of the mechanisms was effective.

本公司設有可執行及有效的機制，以確保董事會獲得獨立意見及建議。全體董事可及時地查詢所有相關資料，以及取得聯席公司秘書及本公司高級管理層的意見及獲得其服務，務求確保遵從董事會程序以及所有適用法例及規例。任何董事均可透過向董事會提出合理要求，在適當的情況下尋求獨立專業意見，費用由本公司支付。於截至2023年12月31日止年度，董事會已檢討董事會獨立性機制，並認為該機制已有效實施。



### Chairman and Chief Executive

Code provision C.2.1 of the CG Code stipulates that the roles of chairman and chief executive should be separate and should not be performed by the same individual.

Mr. Guan Yihong is the chairman of the Board and has served as the chief executive officer of the Company up to February 29, 2024. Since the founding of the Group in 2005, Mr. Guan Yihong has been responsible for formulating the overall business development strategies and leading the overall operations, and therefore has been instrumental to the growth and business expansion of the Group. Mr. Guan Yihong's vision and leadership have played a pivotal role in the Group's success and achievements to date, and therefore the Board considers that vesting the roles of chairman and chief executive officer in the same person is beneficial to the management of the Group. The long-serving and outstanding senior management team of the Company and the Board, which comprises experienced and high-caliber individuals, provides a check on the balance of power and authority. The Board comprises four executive Directors (including Mr. Guan Yihong) and three independent non-executive Directors, and therefore has a fairly strong independence element in its composition.

The chairman provides leadership to the Board by ensuring the Board works effectively and discharges its responsibilities in time. The chairman himself, or a Director or a joint company secretary delegated by him, is responsible for drawing up and approving the agenda for each Board meeting. The chairman ensures that good corporate governance practices and procedures are established. The chairman encourages all Directors to make a full and active contribution to the Board's affairs and take the lead to ensure that it acts in the best interests of the Company. The chairman ensures that all Directors receive adequate information to fulfill their duties, which must be accurate, clear, complete and reliable in a timely manner. The chairman ensures effective communication with Shareholders and that views of Shareholders are communicated to the Board as a whole. The chairman promotes a culture of openness and debate by facilitating the effective contribution of non-executive Directors in particular and ensures constructive relations between executive and non-executive Directors.

In order to comply with code provision C.2.1 of the CG Code, with effect from March 1, 2024, Mr. He Chengxiao, an executive Director, has been appointed as the new chief executive officer of the Company. Mr. Guan remains as an executive Director, the chairman of the Board and the chairman of the nomination committee of the Company. For details, please refer to the announcement of the Company dated February 29, 2024.

### 主席及行政總裁

企業管治守則的守則條文第C.2.1條規定主席與行政總裁的角色應有區分，並不應由一人同時兼任。

管毅宏先生為董事會主席及擔任本公司行政總裁至2024年2月29日。自2005年本集團成立以來，管毅宏先生負責制定整體業務發展策略及領導整體營運，因此對本集團的業務增長及業務拓展起到了重要作用。管毅宏先生的遠見卓識及領導能力對本集團迄今為止取得的成功及成就起著至關重要的作用，因此董事會認為將主席及行政總裁的角色歸屬於同一人有利於本集團的管理。本公司資深優秀的高級管理團隊及董事會由經驗豐富的高素質人才組成，能夠實現權力及授權的制衡。董事會由四名執行董事（包括管毅宏先生）及三名獨立非執行董事組成，因此其組成擁有較強的獨立元素。

主席透過確保董事會有效運作並及時履行其職責，為董事會提供領導。主席本人或其授權的董事或聯席公司秘書負責起草及批准每次董事會會議的議程。主席確保建立良好的企業管治常規及程序。主席鼓勵全體董事對董事會事務作出全面而積極的貢獻，並帶頭確保董事會行事符合本公司的最佳利益。主席確保全體董事均能及時獲得足夠的信息以履行其職責，有關信息須準確、清晰、完整及可靠。主席確保與股東進行有效溝通，並將股東意見告知董事會整體。主席透過促進非執行董事的有效貢獻，促進開放及辯論的文化，並確保執行董事與非執行董事之間的建設性關係。

為符合企業管治守則的守則條文第C.2.1條的規定，自2024年3月1日起，執行董事何成效先生已獲委任為本公司新任行政總裁。管先生繼續擔任本公司執行董事、董事會主席及提名委員會主席。詳情請參閱本公司日期為2024年2月29日的公告。

## Appointment and Re-election of Directors

Each of the executive Directors has entered into a service contract with the Company for a term of three years. The Company has also issued a letter of appointment to each of the independent non-executive Directors for a term of three years. Under the Articles of Association, at each annual general meeting, one-third of the Directors for the time being, or if their number is not three or a multiple of three, the number nearest to but not less than one-third shall retire from office by rotation provided that every Director shall be subject to retirement by rotation at least once every three years. The retiring Directors shall be eligible for re-election.

Pursuant to the provisions of the Articles of Association, Mr. He Chengxiao and Mr. Su Danman shall retire at the AGM and, being eligible, will offer themselves for re-election at the AGM. The Board recommended the re-election of Mr. He Chengxiao and Mr. Su Danman as executive Directors at the AGM. Mr. Deng Tao will retire as an independent non-executive Director at the conclusion of the AGM in order to devote more time to pursue his other work commitments.

The Company's circular, sent together with this annual report, contains detailed information of such retiring Directors as required by the Listing Rules.

## Training and Continuing Professional Development of Directors

The Directors keep abreast of regulatory developments and changes and of the conduct, business activities and development of the Company in order to effectively perform their responsibilities.

Every newly appointed Directors has received a comprehensive, formal and tailored induction on his/her appointment to ensure appropriate understanding of the business and operations of the Group and full awareness of Director's responsibilities and obligations under the Listing Rules and relevant statutory requirements. Such induction is normally supplemented with meetings with the senior management of the Company.

The Directors should participate in appropriate continuous professional development to develop and refresh their knowledge and skills to ensure that their contribution to the Board remains informed and relevant. Continuing briefings and professional development for the Directors are arranged whenever necessary. In addition, reading materials relating to the Company's business or Directors' duties and responsibilities, updates on salient laws, corporate governance, regulations applicable to the Group are provided to the Directors from time to time for their studying and reference. All Directors are encouraged to attend relevant training courses at the Company's expenses.

## 委任及重選董事

各執行董事均與本公司訂有為期三年的服務合約。本公司亦已向各獨立非執行董事發出為期三年的委任函。根據組織章程細則，於每屆股東週年大會上，當時三分之一（或如董事的人數並非三或三的倍數，則為最接近但不少於三分之一的人數）的董事須輪值退任，而每名董事至少每三年輪值告退一次。退任董事有資格膺選連任。

根據組織章程細則的條文，何成效先生及蘇淡滿先生須於股東週年大會上退任，並符合資格且願意於股東週年大會上膺選連任。董事會建議於股東週年大會上重選何成效先生及蘇淡滿先生為執行董事。鄧濤先生將於股東週年大會結束時退任獨立非執行董事，以投入更多時間於其他工作。

與本年報一同寄發的本公司通函根據上市規則規定載有該等退任董事的詳細資料。

## 董事的培訓及持續專業發展

董事為有效履行其職責，需時刻了解監管發展與變化以及本公司的行為、業務活動及發展。

本公司於每名新委任董事獲委任時向其作出全面、正式及特設的就任導引，確保其適當了解本集團的業務及營運以及完全知悉上市規則及相關法定規定項下的董事責任及義務。有關就任導引一般亦輔以與本公司高級管理層的會議。

董事應參與適當的持續專業發展以建立和更新自身的知識及技能，以確保其對董事會作出有依據並切合需要的貢獻。本公司會在必要時為董事安排持續性簡報及專業發展。此外，董事不時獲提供有關本公司業務或董事職責及責任的閱讀材料、適用於本集團的重要法律、企業管治及法規的最新資料，以供其學習及參考。本公司鼓勵所有董事參加相關培訓課程，費用由本公司承擔。



The Directors are required to submit to the Company details of the training they received in each financial year for the Company's maintenance of proper training records of the Directors. During the year ended December 31, 2023, Mr. Guan Yihong, Mr. He Chengxiao, Ms. Cui Longyu, Mr. Su Danman, Mr. Li Zhuoguang, Mr. Deng Tao, Ms. Tang Zhihui and Ms. Zhu Rui attended training sessions on regulatory development, directors' duties or other relevant topics. In addition, relevant reading materials have been provided to the Directors for their studying and reference.

### Model Code for Securities Transactions

The Company has adopted the Model Code as the code of conduct regarding the Directors' dealings in the securities of the Company. Having made specific enquiry of all the Directors, all Directors confirmed that they have complied with the provisions of the Model Code during the year ended December 31, 2023.

The Company has also established written guidelines for securities transactions by employees who are likely to be in possession of inside information of the Company (the "**Guidelines for Securities Dealings by Relevant Employees**") on terms no less exacting than the Model Code. No incident of non-compliance with the Guidelines for Securities Dealings by Relevant Employees by the employees has been noted by the Company.

In case the Company is aware of any restricted period for dealings in the Company's securities, the Company will notify its directors and relevant employees in advance.

### Board Practices and Conduct of Meetings

Annual meeting schedules and draft agenda of each meeting are normally made available to the Directors in advance. Notice of a regular Board meeting is served on all the Directors at least 14 days before the meeting. For other Board and committee meetings, reasonable notice is generally given.

Board papers together with all appropriate, complete and reliable information are sent to all Directors at least three days before each Board meeting or committee meeting to keep Directors apprised of the latest development and financial position of the Company and to enable them to make decisions. The Board and each Director also have separate and independent access to the senior management where necessary.

The senior management normally will attend regular Board meetings and where necessary, other Board and committee meetings, to advise on business development, financial and accounting matters, statutory and regulatory compliance, corporate governance and other major aspects of the Company.

The Articles of Association contain provisions requiring Directors to abstain from voting and not to be counted in the quorum at the meetings for approving transactions in which such Directors or any of their associates have a material interest.

The secretary of the meetings is responsible for taking and keeping minutes of all Board meetings and committee meetings. Minutes of Board meetings and committee meetings record in sufficient detail the matters considered and decisions reached, including any concerns raised by Directors or dissenting views expressed.

Draft minutes are normally circulated to all the Directors for comment within a reasonable time after each meeting. Final versions of the minutes are sent to the Directors for their records and are open for their inspection.

The Board committees have sufficient resources to execute their requisite duties. All the Board committees should report to the Board on their decisions or recommendations made.

### Audit Committee

As of December 31, 2023, the Audit Committee comprised three independent non-executive Directors, namely, Mr. Deng Tao (Chairman), Ms. Tang Zhihui and Ms. Zhu Rui. Mr. Deng Tao possesses the appropriate professional qualifications as required under Rule 3.10(2) of the Listing Rules. None of the members of the Audit Committee is a former partner of the Company's existing external auditors.

The main duties of the Audit Committee are to (i) review the financial statements and reports and consider any significant or unusual items raised by the financial officers of the Group or external auditors before submission to the Board; (ii) review and monitor the relationship with the external auditors by referencing to the work performed by the external auditors, their fees and terms of engagement, and make recommendations to the Board on the appointment, re-appointment and removal of external auditors; (iii) review the Company's financial controls, internal control and risk management systems; and (iv) establish a whistleblowing policy and system for employees and those who deal with the Company to raise concerns in confidence about possible improprieties in any matter related to the Company.

審核委員會的主要職責為(i)審閱財務報表及報告並考慮由本集團財務管理人員或外聘核數師提出的任何重大或異常項目，並在之後向董事會呈報；(ii)根據外聘核數師的工作、費用及聘用條款，檢討及監督與外聘核數師的關係，並就外聘核數師的委聘、續聘及免職向董事會提出推薦建議；(iii)檢討本公司財務控制、內部監控及風險管理制度；及(iv)制定舉報政策及系統，讓僱員及與本公司有往來者可在保密的情況下就與本公司有關的任何事宜中的可能不當行為提出關注。

The written terms of reference of the Audit Committee are available on the websites of the Stock Exchange and the Company.

During the year ended December 31, 2023, the Audit Committee held two meetings to review the annual financial results and report for the year ended December 31, 2022, the interim financial results and report for the six months ended June 30, 2023, major audit findings, significant issues on the financial reporting and compliance procedures, internal control and risk management systems, the effectiveness of the Company's internal audit function, scope of works and re-appointment of external auditors and arrangements for employees to raise concerns about possible improprieties.

The external auditors were invited to attend the Audit Committee meetings without the presence of executive Directors to discuss with the Audit Committee issues arising from the audit and financial reporting matters. There is no disagreement between the Board and the Audit Committee regarding the re-appointment of external auditors.

### Remuneration Committee

As of December 31, 2023, the Remuneration Committee comprised two independent non-executive Directors and one executive Director, namely, Ms. Tang Zhihui (Chairman), Mr. Deng Tao and Mr. Su Danman.

The main duties of the Remuneration Committee are to (i) assess performance of executive Directors and approve the terms of executive Directors' service contracts; (ii) review and approve performance-based remuneration by referencing to corporate goals and objectives; (iii) make recommendations to the Board on the Company's remuneration policy and structure and the remuneration packages of Directors and senior management (i.e. the model described in the code provision E.1.2(c)(ii) of the CG Code is adopted); and (iv) establish a formal and transparent procedure for developing such remuneration policy and structure to ensure that no Director or any of his/her associates will participate in deciding his/her own remuneration, which will be determined with reference to the performance of the individual and the Group as well as market practice and conditions.

The written terms of reference of the Remuneration Committee are available on the websites of the Stock Exchange and the Company.

The main duties of the Nomination Committee are to (i) review the structure, size and composition (including the skills, knowledge and experience) of the Board on a regular basis and recommend any changes to the Board to complement the Company's corporate strategy; (ii) identify qualified and suitable individuals to become Board members and select or make recommendations to the Board on the selection of individuals nominated for directorships; (iii) assess the independence of independent non-executive directors of the Company, having regard to the requirements under the Listing Rules; and (iv) make recommendations to the Board on relevant matters relating to the appointment or re-appointment of Directors and succession planning for Directors, in particular the chairman and the chief executive of the Company.

The Company also recognizes and embraces the benefits of having a diverse Board to enhance its performance and has adopted a Board Diversity Policy aiming to set out the approach to achieve diversity on the Board. The implementation of the policy is monitored by the Nomination Committee. In designing the Board's composition, board diversity has been considered from a number of measurable objectives, including but not limited to gender, age, cultural and educational background, and professional experience. The Nomination Committee shall report its findings and make recommendation to the Board, if any. Such policy and objectives will be reviewed from time to time and at least on an annual basis to ensure their appropriateness in determining the optimum composition of the Board. As of December 31, 2023, the Board has 3 female Directors out of 7 Directors, representing 42.9% of the Board; and the Group has 2 female senior management, representing 25.0% of the senior management. As of December 31, 2023, the Group had a total of 7,379 female staff out of 22,467 employees, representing 32.8% of the employees of the Group. The Group will continue to take opportunities to increase the proportion of female board members and workforce over time as and when suitable candidates are identified. For further details, please refer to the Environmental, Social and Governance Report of the Company.

During the year ended December 31, 2023, the Board has reviewed the Board Diversity Policy and considered that the implementation of the policy was effective.

The Board believes that the defined selection process is good for corporate governance in ensuring the Board continuity and appropriate leadership at Board level, and enhancing better Board effectiveness and diversity as well as in compliance with the applicable rules and regulations.

In identifying and selecting suitable candidates for directorship, the Nomination Committee would consider the candidate's character including integrity, honesty and fairness, backgrounds and qualifications including professional qualifications, skills, knowledge, experience, independence and other relevant criteria necessary to complement the corporate strategy and achieve board diversity, where appropriate, before making recommendation to the Board. The Nomination Committee and/or the Board may select candidates for directorship from various channels, including but not limited to internal promotion, re-designation, referral by other members of the management and external recruitment agents.

The written terms of reference of the Nomination Committee are available on the websites of the Stock Exchange and the Company.

During the year ended December 31, 2023, the Nomination Committee reviewed the structure, size and composition of the Board to ensure that it has a balance of expertise, skills and experience appropriate to the requirements for the business of the Group and reviewed the Board Diversity Policy; considered and recommended the re-election of the retiring Directors standing for re-election at the 2023 annual general meeting; assessed the independence of the independent non-executive Directors; and considered and recommended the appointment of Mr. Su Danman as an executive Director.

During the year ended December 31, 2023, the Board has reviewed the Company's corporate governance policies and practices, the training and continuous professional development of Directors and senior management, the Company's policies and practices on compliance with legal and regulatory requirements, the compliance with the Model Code and the Guidelines for Securities Dealings by Relevant Employees, and the Company's compliance with the CG Code and the disclosure in this Corporate Governance Report.

### DIRECTORS' RESPONSIBILITIES FOR FINANCIAL REPORTING IN RESPECT OF THE FINANCIAL STATEMENTS

The Directors acknowledge their responsibilities for preparing the financial statements of the Company for the year ended December 31, 2023.

The Board is responsible for presenting a balanced, clear and understandable assessment of annual and interim reports, inside information announcements and other disclosures required under the Listing Rules and other statutory and regulatory requirements. The management has provided to the Board such explanation and information as are necessary to enable the Board to carry out an informed assessment of the Company's financial statements, which are put to the Board for approval. The management provides all members of the Board with monthly updates on the Company's performance, positions and prospects.

The Directors are not aware of any material uncertainties relating to events or conditions that may cast significant doubt on the Company's ability to continue as a going concern.

The statement of the independent auditor of the Company about their reporting responsibilities on the consolidated financial statements is set out in the Independent Auditor's Report of this annual report.

## RISK MANAGEMENT AND INTERNAL CONTROLS

The Board acknowledges its responsibility for the risk management and internal control systems and reviewing their effectiveness on an ongoing basis. Such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

The Board is fully responsible for evaluating and determining the nature and extent of the risks it is willing to take to achieve the Company's strategic objectives, and for establishing and maintaining appropriate and effective risk management and internal control systems to safeguard Shareholders' investments and the Group's assets.

The Audit Committee assists the Board in overseeing the design and implementation of the risk management and internal control systems. The Company has developed and adopted different risk management procedures and guidelines. Self-evaluation would be conducted each year to confirm that the Company has properly complied with the risk management and internal control policy. All divisions would conduct internal control assessment to identify risks factors with potential impact on the Group's business. The management would assess the likelihood of risk occurrence, monitor the progress of risk management and report to the Board and the Audit Committee on the findings and effectiveness of the systems.

The Group has developed its disclosure policy to provide a general guide to the Company's directors, officers, senior management and relevant employees in handling confidential information, monitoring information disclosure and responding to enquiries.

The Company has recruited experienced personnel for providing the internal audit function and performing independent review of the adequacy and effectiveness of the risk management and internal control systems. The internal audit function examined key issues in relation to the accounting practices and all material controls and provided its findings and recommendations for improvement to the Audit Committee. The Company has also engaged an external professional firm to provide an ongoing review of the Group's execution and launch of its procurement system in order to identify, evaluate and manage significant risks, including ongoing review of the segregation of duties, enhancement of the organizational structures, fine-tuning of the standard operating procedures, goal settings, KPI management as well as provide training and updates to shape the continuing improvements.

## 風險管理及內部監控

董事會深明其對風險管理及內部監控系統以及持續檢討其有效性的責任。有關系統旨在管理而非消除與未能達致業務目標相關的風險，且僅會就避免重大錯誤陳述或損失作出合理保證而非絕對保證。

董事會全面負責評估及釐定為達成本公司戰略目標所願承擔的風險性質及程度，以及制訂及維持適當有效的風險管理及內部監控系統，以保障股東的投資及本集團的資產。

審核委員會協助董事會監督風險管理及內部監控系統的設計及執行。本公司已制定及採納不同的風險管理程序及指引。本公司每年進行內部評估，確定本公司已妥善遵守風險管理及內部監控政策。所有部門將進行內部監控評估，以發現對本集團業務存在潛在影響的風險因素。管理層將評估發生風險的可能性、監察風險管理進度以及向董事會及審核委員會報告有關結果及系統的成效。

本集團已制定其披露政策，向本公司董事、職員、高級管理層及相關僱員提供處理機密資料、監察信息披露及回應查詢的一般指引。

本公司已聘請有經驗人士提供內部審核職能並就風險管理及內部監控系統是否足夠及其成效進行獨立審閱。內部審核職能已審查與會計常規及所有重大監控相關的關鍵事宜，並向審核委員會提供其審查發現及改進建議。本公司亦已委聘外部專業公司持續審查本集團採購系統的執行及推行，以識別、評估及管理重大風險，包括持續審查權責分工、完善組織架構、完善標準營運程序、設立目標、主要表現指標管理，以及提供培訓及最新資料，以作持續改進。

The Board, as assisted by the Audit Committee and the management, has reviewed the report from the management and the internal audit findings, and reviewed the effectiveness of the risk management and internal control systems of the Group, including the financial, operational and compliance controls for the year ended December 31, 2023. The Board considered that such systems are adequate and effective and ongoing review of the same nature would be conducted in subsequent years.

All resolutions put forward at general meetings will be voted on by poll pursuant to the Listing Rules and the poll voting results will be posted on the websites of the Stock Exchange and the Company immediately after the relevant general meetings.

### Procedures for Shareholders to Convene an Extraordinary General Meeting

Pursuant to the Articles of Association, any one or more Shareholders holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Board or either of the joint company secretaries of the Company, to require an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition.

### Procedures for Shareholders to Put Forward Proposals at General Meetings

There is no provision allowing the Shareholders to move new resolutions at general meetings under the Companies Act or the Articles of Association. Shareholders who wish to move a resolution may request the Company to convene a general meeting following the procedures set out in the preceding paragraph.

The Board is pleased to present its report together with the audited consolidated financial statements of the Group for the year ended December 31, 2023.

### GENERAL INFORMATION

The Company was incorporated in the Cayman Islands on February 1, 2019 as an exempted company with limited liability under the Companies Act. The Shares were listed on the Main Board of the Stock Exchange on January 15, 2020.

### PRINCIPAL ACTIVITIES

The Company is an investment holding company. The Group is principally engaged in managing and operating Chinese cuisine restaurant brands in the PRC. Details of the principal activities of the significant subsidiaries of the Company are set out in note 13(a) to the consolidated financial statements.

### BUSINESS REVIEW

The business review and performance analysis of the Group for the year ended December 31, 2023 as required by Schedule 5 to the Companies Ordinance are set out in the section headed "Chairman's Statement" from pages 14 to 24 and "Management Discussion and Analysis" from pages 25 to 43 of this annual report which constitute part of this directors' report.

### OUTLOOK FOR 2024

For the year ending December 31, 2024, the Group will continue to pursue the following: (i) replicate the Group's success through further expansion; (ii) continue to expand into more market segments by pursuing a multi-brand and multi-concept strategy; (iii) continue to strengthen the Group's supply and support capabilities; (iv) expand into the global markets to gain international presence; and (v) introduce franchise and cooperative model for regional and international expansion. ## KEY RELATIONSHIPS

### Relationship with Suppliers

We typically have at least three suppliers for each of our main ingredients to minimize any potential disruption in our operations, maintain sourcing stability, avoid over-reliance risk, and secure competitive prices from suppliers. To safeguard food quality, our comprehensive requirements cover reputable large suppliers both domestically and overseas. In order to facilitate cooperation with our suppliers and secure a stable supply of key ingredients, we have established co-operative relationships with two suppliers of our key ingredient (i.e. bass) by forming joint venture companies with them. Further, our Company has entered into cooperation agreements with certain sauerkraut suppliers to obtain early payment discounts and secure stable and quality supply of sauerkraut.

## 主要關係

### 與供應商的關係

我們的各類主要食材通常有至少三名供應商以盡量減少我們業務中斷的可能，保持供應源的穩定，避免過度依賴的風險以及確保自供應商獲取優惠價格。為保障食物質量，我們對國內外知名的大型供應商設有全面規定。為促進與供應商的合作及確保主要食材的穩定供應，本公司通過與兩間主要食材（即鱸魚）的供應商成立合營公司方式建立合作關係。此外，本公司已與若干酸菜供應商訂立合作協議以獲得提前付款折扣，並保障穩定及高質量的酸菜供應。



For the year ended December 31, 2023, the total purchases from our five largest suppliers in aggregate accounted for 31.2%, and our purchases from our largest supplier accounted for 17.2%, of our total purchases. On average, we have over six years of business dealings with our major suppliers. We did not experience any interruption in our supply of food ingredients, early termination of supply agreements, or failure to secure sufficient quantities of irreplaceable food ingredients that had any material adverse impact on our business or results of operations during the year ended December 31, 2023.

### Relationship with Customers

In pursuit of our philosophy of serving delicacies at affordable prices (“好吃不貴”), we are fully devoted to providing marvelous dining experience to our customers through exquisite dishes, high-quality services and unique brand culture. We have a large and diverse customer base. Revenue derived from our largest customer and five largest customers both accounted for less than 1.0% of our total revenue for the year ended December 31, 2023.

All of our top five largest customers and suppliers are independent third parties. None of our Directors, their close associates or any of our Shareholders (who, to the knowledge of our Directors, own more than 5% of the issued share capital of our Company) had any interest in any of our top five largest customers or suppliers that is required to be disclosed under the Listing Rules for the year ended December 31, 2023.

我們所有五大顧客及供應商均為獨立第三方。截至2023年12月31日止年度，概無董事、彼等之緊密聯繫人或任何股東（據董事所知，擁有本公司已發行股本超過5%）於任何五大顧客或供應商中擁有根據上市規則須予披露的任何權益。

## Relationship with Employees

Our success, to a considerable extent, depends upon our ability to attract, motivate and retain a sufficient number of qualified employees. The remuneration package for our employees generally includes salary and bonuses. We determine employee remuneration based on factors such as qualifications and years of experience. Employees also receive welfare benefits, including medical care, retirement benefits, occupational injury insurance and other miscellaneous items. We make contributions to mandatory social security funds for our employees to provide for retirement, medical, work-related injury, maternity and unemployment benefits. We also granted restricted stock units as share incentives to qualified directors and employees, details of which are set out in the section headed "Restricted Stock Unit Scheme and Share Option Scheme" in this directors' report. In order to incentivize Directors, senior management and employees for their contribution to our Company and to attract, motivate and retain skilled and experienced personnel, we have granted share options under the Share Option Scheme, details of which are set out in the section headed "Restricted Stock Unit Scheme and Share Option Scheme" in this directors' report.

Uncertainty to successfully enter into new markets

In obtaining new restaurant sites, we may face intense competition from our competitors in the catering service industry. We may also encounter delays when applying for relevant material licenses during the approval process from the government authorities, for which the timeline is beyond our control. Even if we are able to open additional restaurants as planned, these new restaurants may neither be profitable nor have results comparable to our existing restaurants for a period of time.

We adopt a prudent approach in entering into new markets and conduct a detailed and comprehensive due diligence exercise which includes researches on the overall market trend, development schedule for new shopping malls and information in relation to the regulations, policies and taxation system of the cities where we intend to open our new restaurants. We have strong preference for top commercial districts in a city with convenient transportation and high pedestrian flow. We deploy at least one restaurant staff for each key operational function from our existing restaurants to the new restaurant to ensure an efficient transfer of our operational procedures and best practices to the new restaurant.

Uncertainty to maintain and increase the sales and profitability of our existing restaurants

Our ability to increase existing restaurant sales depends in part on our ability to successfully implement our initiatives to increase customer traffic, seat turnover and spending per customer. There can be no assurance that we will be able to achieve our targeted sales growth and profitability for our existing restaurants. Also, we cannot ensure that existing restaurant sales will not decrease. If we are unable to achieve our targeted sales and profitability goals in our existing markets, our business, financial condition and results of operations may be materially adversely affected.

We endeavor to offer tasty cuisines with optimal presentation to our customers by constantly improving the quality and flavor of our dishes which cater to the specific tastes of local customers. For example, we review and update three to five menu items for our Tai Er and Jiu Mao Jiu menu on a quarterly basis, taking into account customer evaluations and seasonality factors. Further, we increased the variety of dishes for our Tai Er and Song Hot Pot brand restaurants, as we aim to broaden the customer base. We also strive to provide our customers with superior services and distinctive dining experience. For example, Tai Er and Song Hot Pot pursues unique and interesting dining culture and builds rapport with customers through eye-catching and off-the-rail slogans. Further, we introduce a variety of interesting and interactive activities carefully designed by our dedicated team for our online members to boost our sale of featured products on our online platforms and increase their frequency of visits to our restaurants. We build our brand image through a combination of online and offline promotional campaigns.

我們致力於透過不斷提高菜餚的質量及風味，為顧客提供最上乘的美味佳餚，以迎合當地顧客的特定口味。例如，我們按季度於考慮顧客的評價及季節性因素後審視及更新太二及九毛九菜單中的三至五項菜式。此外，為了擴大顧客群，我們增加太二及愆火鍋品牌餐廳的菜式種類。我們亦努力為顧客提供優質的服務和獨特的用餐體驗。例如，太二及愆火鍋追求獨特而有趣的餐飲文化，透過搶眼且出人意料的標語與顧客建立融洽關係。此外，我們向線上會員推出專業團隊精心設計的多樣有趣的互動活動以促進線上平台銷售特色產品，從而可增加顧客到餐廳用餐頻次。我們結合線上及線下宣傳活動建立品牌形象。

Risks related to changes in consumer taste and discretionary spending

The catering service industry is affected by consumer taste and preference. We cannot assure you that we can continue to maintain our menu to develop new products and maintain an attractive menu to suit changing customer demands.

To a significant extent, our success also depends on discretionary customer spending, which is influenced by general economic conditions. Accordingly, we may experience declines in sales during economic downturns or prolonged periods of high unemployment rates. Any material decline in the amount of discretionary spending in the PRC may have a material adverse effect on our business, results of operations and financial condition.

We closely monitor changes in consumer taste and preference. We conduct customer surveys to collect feedback from customers so that we update our menus as necessary to maintain a degree of freshness. We also monitor customer satisfaction through consumer review websites and through our frontline staff who interact with our customers to collect feedback.

When experiencing material declines in sales, we will review and adjust our strategies on a case by case basis to counter their effect on our business. For example, in response to the changes in the external environment, in Q4 2023, Jiu Mao Jiu, Tai Er and Song Hot Pot each had their debut live streams based on their respective styles, and the results were impressive. The live streams attracted a large number of customer attention and recorded a combined Gross Merchandise Volume of over RMB200 million. We may adopt a more prudent restaurant opening strategy and freeze non-essential hiring to minimize expenditures.

We introduced three new brands, namely Song Hot Pot in 2020, Lai Mei Li Grilled Fish in 2021 and Fresh Wood in 2023 and disposed the Double Eggs brand in 2022 in order to maintain an optimal portfolio of restaurant brands.

很大程度上，我們的成功亦取決於顧客的可支配支出，該支出受整體經濟狀況影響。因此，我們可能於經濟衰退期間或高失業率持續期內遭遇銷售額減少。中國可支配支出金額的任何重大減少均會對我們的業務、經營業績及財務狀況產生重大不利影響。

我們密切關注消費者口味及偏好的變化，並進行顧客調查，收集顧客反饋，以便對菜單進行必要的更新，從而維持新鮮度。我們亦會通過消費者點評網站及通過我們的前線員工（彼等通過與客戶的溝通收集反饋）監測顧客滿意度。

在銷售發生嚴重下滑時，我們將會根據個別個案審視及調整自身策略以抵銷其對我們業務的影響，例如，因應對外部環境變化，於2023年第4季度，九毛九、太二以及愆火鍋三個品牌基於各自調性進行直播首秀，成績單十分亮眼。直播吸引了大量顧客關注，錄得GMV累計人民幣200百萬元。我們可能採取更加審慎的開店策略並暫停非必要的招聘以降低開支。

我們分別於2020年、2021年及2023年推出三個新品牌，即愆火鍋、賴美麗烤魚及賞鮮悅木，並於2022年出售2顆雞蛋煎餅品牌，藉以維持最佳的餐廳品牌組合。

Risks related to quality control and food safety

The catering service industry in the PRC as a whole is subject to concerns over food safety and quality related issues. The catering service industry as a whole can be negatively impacted by reports and negative publicity related to food safety and quality incidents. Our prospects, business, results of operations and financial condition can be negatively impacted if the catering service industry experiences slower growth from concerns over food safety and quality related issues even if such concerns are through no fault of our own or are not related to our business.

We have implemented a comprehensive set of stringent food safety and quality control standards and measures covering different aspects of our operations, including (i) procurement, (ii) food processing, (iii) storage, (iv) logistics and (v) restaurant operations. In particular, our quality control department conducts, or engages third parties to conduct, regular and ad hoc spot-checks on our restaurants from time to time to identify and rectify potential quality and food safety issues. We also continuously provide training programs to our restaurant staff to ensure that they have clear understanding on operating procedures and quality standards.

我們已實施全面而嚴格的食品安全及品質監控標準及措施，涵蓋我們營運的不同範疇，包括：(i)採購；(ii)食品加工；(iii)儲藏；(iv)物流；及(v)餐廳營運。特別需要指出，我們的品質監控部門親自或委聘第三方對我們的餐廳進行定期或臨時安排的抽查，以找出及糾正潛在的品質及食品安全問題。我們亦持續為餐廳員工提供培訓課程，確保他們清楚了解營運程序及品質標準。

Risks related to events that disrupt the operations of any of our restaurants or our central kitchens

Our operations are vulnerable to interruption by fires, floods, earthquakes, other natural or man-made disasters and other events beyond our control. Our business is also dependent on prompt delivery and transportation of our food ingredients and raw materials. Certain events, such as adverse weather conditions, natural disasters, severe traffic accidents and delays and labor strikes, could also lead to delayed or lost deliveries of food supplies to our processing plants, logistics facilities and our restaurants. In addition, fires, floods, earthquakes and terrorist attacks may lead to evacuations and other disruptions in our operations, which may also prevent us from providing quality food and service to customers, thereby affecting our business and damaging our reputation.

We are determined to mitigate the impact on our business caused by events which are beyond our control. We have implemented several cost-saving initiatives to reduce costs on rentals, raw materials and consumables used as well as other operating expenses.

We have continued to adopt the set of internal protection measures handbook covering prevention controls of sterilization standards over restaurants, delivery, logistics, storage, central kitchens and functional departments. Additionally, we have diligently monitored the risks associated with potential events that could have a significant impact on the global economy, including the economy of the PRC. Such vigilance enables us to adapt and adjust our restaurant network expansion plans accordingly, ensuring they align with the evolving circumstances as needed.

我們的運營容易受到火災、洪水、地震、其他自然或人為災害以及我們無法控制的其他事件的干擾。我們的業務亦依賴於我們的食材和原材料的及時交付及運輸。若干事件，例如惡劣的天氣狀況、自然災害、嚴重的交通事故以及延誤和勞工罷工，亦可能導致我們的加工廠、物流設施及餐廳的食品供應延遲或無法交付。此外，火災、洪水、地震及恐怖襲擊可能導致我們的人員疏散及運營中斷，亦可能阻止我們向顧客提供優質食品及服務，從而影響我們的業務並損害我們的聲譽。

我們決心將我們無法控制的事件對業務造成的影響降低。我們已實施若干節省成本措施，以減少租金、所用原材料及耗材及其他經營開支的成本。

我們繼續採用一套內部保護措施手冊，涵蓋對餐廳、配送、物流、倉儲、中央廚房及職能部門進行消毒標準的防控。此外，我們已認真監察可能對全球經濟（包括中國經濟）造成重大影響的潛在事件的風險。這種警覺性使我們能夠相應地改變和調整我們的餐廳網絡擴張計劃，確保其符合不斷變化的情況（如需要）。

In November 2023, the Company utilized an aggregate of approximately HKD150.0 million (equivalent to approximately RMB137.3 million, including commissions and transaction costs) to repurchase 17,944,000 Shares on market at prices ranging from HKD7.77 to HKD9.15 per Share. The Shares repurchased during such period represented 1.2% of issued Shares as of December 31, 2023. All of the Shares repurchased during the year ended December 31, 2023 were subsequently cancelled by the Company on December 8, 2023. The repurchase was based on the Company's operational growth outlook while acknowledging market conditions and macroeconomic performance indicators. Given the strong showing of the Group's financial performance, the Board believes that the repurchase demonstrates the Company's confidence in its long-term business prospects and would ultimately benefit the Company and create value for the Shareholders as a whole. Details of the Shares repurchased are also set out in note 27(a)(iii) to the consolidated financial statements.

Save as disclosed above, neither the Company nor any of its subsidiaries purchased, sold or redeemed any of the listed securities of the Company for the year ended December 31, 2023.

## RESTRICTED STOCK UNIT SCHEME AND SHARE OPTION SCHEME

### Restricted Stock Unit Scheme

The Group's controlling shareholder, Mr. Guan Yihong, operated a share-based incentive scheme (the "Old RSU Scheme") under which the restricted stock units ("RSUs") of Guangzhou Jiumaojiu were granted as share incentives to qualified directors and employees of Guangzhou Jiumaojiu and its subsidiaries (the "RSU grantees") through an employee shareholding platform (the "RSU platform"), Guangzhou Maixuan Investment Center (Limited Partnership), which was a shareholder of Guangzhou Jiumaojiu prior to the Reorganization. The principal terms of the restricted stock units scheme (the "RSU Scheme"), approved and adopted by the Board to govern the RSUs granted under the Old RSU Scheme, approved and adopted by the board of directors of Guangzhou Jiumaojiu on December 3, 2014, largely mirror that of the Old RSU Scheme. All RSUs granted under the Old RSU Scheme were converted into the shares of MT BVI and MX BVI upon the completion of the Reorganization on June 14, 2019. No restricted stock units have been granted or will be granted under the RSU Scheme. No more RSUs will be granted under the Old RSU Scheme. If any RSU lapses, the corresponding Shares will be transferred to Mr. Guan Yihong or his wholly-owned investment vehicle after the Listing. The RSU Scheme will terminate as soon as all the RSUs granted under the Old RSU Scheme lapse or vest.

Persons eligible to receive RSU(s) under the RSU Scheme are employees, senior management, directors (whether executive or non-executive, but excluding independent non-executive directors) or officers who have worked in Guangzhou Jiumaojiu or any of its subsidiaries for two years or more (the "RSU Eligible Persons"). The board of directors or the sole director (as the case may be) of Guangzhou Jiumaojiu selects and approves the RSU Eligible Persons, and the chairperson of the board of directors or the sole director (as the case may be) of Guangzhou Jiumaojiu reserves the final right to confirm the RSU Eligible Persons at his/her own discretion.

## 受限制股份單位計劃及購股權計劃

### 受限制股份單位計劃

本集團的控股股東管毅宏先生運作一項股份激勵計劃(「舊受限制股份單位計劃」)，據此廣州九毛九的受限制股份單位(「受限制股份單位」)作為股份激勵透過一個僱員持股平台(「受限制股份單位平台」)廣州市麥旋投資中心(有限合夥)(於重組前為廣州九毛九的股東)授予廣州九毛九及其附屬公司的合資格董事及僱員(「受限制股份單位承授人」)。經董事會批准並採納以規管根據廣州九毛九董事會於2014年12月3日批准及採納的舊受限制股份單位計劃授出的受限制股份單位的受限制股份單位計劃(「受限制股份單位計劃」)的主要條款，與舊受限制股份單位計劃的主要條款大致相同。所有根據舊受限制股份單位計劃授出的受限制股份單位均已於2019年6月14日重組完成時轉換為MT BVI股份及MX BVI股份。概無根據受限制股份單位計劃已授出或將授出受限制股份單位。舊受限制股份單位計劃項下將不再授出受限制股份單位。倘任何受限制股份單位失效，相應股份於上市後將轉讓予管毅宏先生或其全資擁有的投資工具。受限制股份單位計劃將於所有根據舊受限制股份單位計劃授出的受限制股份單位失效或歸屬後終止。

根據受限制股份單位計劃有資格接受受限制股份單位的人士為僱員、高級管理層、董事(不論是執行董事或是非執行董事，惟不包括獨立非執行董事)或已於廣州九毛九或其任何附屬公司任職兩年或以上的管理人員(「受限制股份單位合資格人士」)。廣州九毛九之董事會或唯一董事(視情況而定)挑選及核准受限制股份單位合資格人士，且廣州九毛九董事會之主席或唯一董事(視情況而定)保留酌情確認受限制股份單位合資格人士的最終權利。

Each participant in the RSU Scheme (the “**RSU Participant**”) shall remain in service with Guangzhou Jiumaojiu or any of its subsidiaries for five years from the date of granting the RSUs (the “**Service Period**”) and the RSUs shall vest at the end of the Service Period. Once the vesting conditions underlying the respective RSUs are met, the RSUs are considered duly and validly issued to the holder, and free of restrictions on transfer. The RSUs granted pursuant to the RSU Scheme are personal to each RSU Participant, and are not assignable during the Service Period, unless otherwise permitted under the RSU Scheme.

There are certain circumstances the occurrence of which during the Service Period will result in the lapse of the RSUs granted to the RSU Participant, including, among others, (i) the RSU Participant ceases to be an employee of Guangzhou Jiumaojiu or any of its subsidiaries; (ii) serious breach of employment contract or any other internal guidelines by the RSU Participant; and (iii) serious acts of misconduct committed by the RSU Participant leading to loss suffered by Guangzhou Jiumaojiu.

受限制股份單位計劃的各參與者（「**受限制股份單位參與者**」）須自授出受限制股份單位之日起於廣州九毛九或其任何附屬公司任職五年（「**服務期間**」），而受限制股份單位將於服務期間結束後歸屬。一旦有關受限制股份單位的相關歸屬條件達成，受限制股份單位即被視為正式及有效發行予持有人，且並無轉讓限制。根據受限制股份單位計劃授出的受限制股份單位屬各受限制股份單位參與者個人所有，於服務期間不得出讓，惟受限制股份單位計劃另有允許的情況除外。

於服務期間發生若干情況將導致已授出給受限制股份單位參與者的受限制股份單位失效，其中包括(i)受限制股份單位參與者不再為廣州九毛九或其任何附屬公司的僱員；(ii)受限制股份單位參與者嚴重違反僱用合約或任何其他內部準則；及(iii)受限制股份單位參與者嚴重失職，導致廣州九毛九遭受損失。

The purpose of the Share Option Scheme is to provide our Company with a means of incentivising any director or any employee or officer of any member of our Group who in the sole discretion of our Board has contributed or will contribute to our Group (the “**Eligible Persons**”) and retaining any employee or officer of any member of our Group (the “**Employees**”), and to encourage Employees to work towards enhancing the value of our Company and promote the long-term growth of our Company. The Share Option Scheme will link the value of our Company with the interests of the Eligible Persons, enabling the Eligible Persons and our Company to develop together and promoting our Company’s corporate culture.

### 購股權計劃

於2019年12月6日，購股權計劃獲當時股東批准及採納。購股權計劃的目的在於給予本公司一個途徑獎勵董事會全權酌情認為已對或將對本集團作出貢獻的本集團任何成員公司的任何董事或任何僱員或高級職員（「**合資格人士**」）及留聘本集團任何成員公司的任何僱員或高級職員（「**僱員**」），以及鼓勵僱員致力於提升本公司的價值及推動本公司長遠發展。購股權計劃將本公司的價值與合資格人士的利益連繫起來，讓合資格人士與本公司共同發展，並提升本公司的企業文化。

Subject to the terms of the Share Option Scheme, our Board shall be entitled at any time within the period of ten years after the Adoption Date to grant options to any Eligible Person as our Board may in its absolute discretion select. As at December 31, 2023, the remaining life of the Share Option Scheme is approximately five years and eleven months. No offer shall be made and no option shall be granted to any Eligible Persons in circumstances prohibited by the Listing Rules at a time when the Eligible Persons would or might be prohibited from dealing in the Shares by the Listing Rules or by any applicable rules, regulations or law. In particular, no options may be granted during the period commencing one month immediately preceding the earlier of: (i) the date of the Board meeting (as such date is first notified to the Stock Exchange in accordance with the Listing Rules) for the approval of our Company's results for any year, half-year, quarterly or other interim period; and (ii) the deadline for our Company to publish its interim or annual results announcement under the Listing Rules, and ending on the date of actual publication of such results announcement.

The maximum number of Shares which may be issued upon exercise of all options to be granted under the Share Option Scheme and all other share schemes existing at such time of our Company shall not in aggregate exceed 133,340,000 Shares, being 10% of the total number of Shares in issue as at the Listing Date (the "Scheme Mandate Limit"), which represents approximately 9.28% of the total number of Shares in issue as at the date of this annual report. Options or awards lapsed in accordance with the terms of the Share Option Scheme and (as the case may be) such other share schemes of our Company will not be counted for the purpose of calculating the Scheme Mandate Limit. Our Company may renew the Scheme Mandate Limit at any time subject to prior Shareholders' approval but in any event, the total number of Shares which may be issued upon exercise of all options to be granted under the Share Option Scheme and any other share schemes of our Company under the limit as refreshed must not exceed 10% of the Shares in issue as at the date of approval of the renewal of the Scheme Mandate Limit.

The maximum number of Shares issued and to be issued upon exercise of the options granted and to be granted to each Eligible Person under the Share Option Scheme and any other share option schemes of the Company (including exercised, cancelled and outstanding options) in any twelve-month period shall not at the time of grant exceed 1% of the Shares in issue, unless otherwise separately approved by Shareholders in general meeting with such Eligible Person and his associates abstaining from voting.

An offer made to the Eligible Person is open for acceptance by the Eligible Person for a period of 28 days from the date of the offer made. The Eligible Persons shall accept the offer by returning the duly signed duplicate letter clearly stating the number of Shares in respect of which the offer is accepted, with payment of HK\$1.00 as consideration for the acceptance of an option granted to them.

Subject to such terms and conditions as our Board may determine, there is no minimum period for which an option must be held before it can be exercised and no performance target needs to be achieved by the grantee before the options can be exercised.

Subject to the terms of grant of any option, an option may be exercised by the grantee of the option at any time during the option period and in accordance with the vesting schedule and other terms specified in the offer. No option may be vested more than ten years after the date of the offer made. Subject to early termination by the Company in general meeting or by the Board, the Share Option Scheme shall be valid and effective for a period of ten years commencing on the Adoption Date.

- (iii) the nominal value of a Share on the date of the offer made.

With effect from March 1, 2024, the Board has approved the recommendation of the Remuneration Committee to increase of the basic annual salary of Mr. HE Chengxiao to RMB1,200,000 per annum. Other applicable benefits and the criteria for determining his discretionary bonuses and other applicable incentives remain unchanged.

Mr. He Chengxiao has also been appointed as the president of the Group.

Save as disclosed above, there is no other change which is required to be disclosed pursuant to Rule 13.51B(1) of the Listing Rules since the date of 2023 interim report of the Company up to the date of this annual report.

### Directors' Service Contracts and Letters of Appointment

Each of our executive Directors entered into a service contract with our Company on December 6, 2019, except for Mr. He Chengxiao and Mr. Su Danman who entered into a service contract with our Company on July 2, 2020 and June 9, 2023, respectively.

We have issued letters of appointment to each of our independent non-executive Directors. The service contract with each of our executive Directors and the letter of appointment with each of our independent non-executive Directors were for an initial fixed term of three years commencing from December 6, 2019 and were expired on December 5, 2022, except for the service contracts of Mr. He Chengxiao and Mr. Su Danman which are for an initial fixed term of three years commencing from July 2, 2020 and June 9, 2023, respectively, and except for Ms. Tang Zhihui's and Ms. Zhu Rui's letters of appointment which are for an initial fixed term of three years commencing from April 16, 2021. Mr. He Chengxiao's service contract which had expired on July 2, 2023, was renewed with the same terms. The service contracts and the letters of appointment are subject to termination in accordance with their respective terms.

We made contributions to mandatory employee benefit plans (including pension, work-related injury benefits, maternity insurance, medical and unemployment benefit plans and housing fund). We also granted restricted stock units and share options as share incentives to qualified directors and employees under the RSU Scheme and the Share Option Scheme, respectively, details of both schemes are set out under the section headed "Restricted Stock Unit Scheme and Share Option Scheme" in this directors' report, to motivate our employees. In addition, our brand managers and their team members hold certain equity interests in the brands they manage, details of which are set out in "Business – Organizational Structure – Brand-specific Management" in the Prospectus. Our Group has established a remuneration committee to review the policy and structure of the remuneration for our Directors and senior management and make recommendations on the remuneration packages of individual Directors and senior management. In general, our Group determines the emolument payable to our Directors based on each Director's time commitment and responsibilities, salaries paid by comparable companies as well as the employment conditions elsewhere in our Group.

Pursuant to the Articles of Association, the Directors, auditors and other officers of the Company shall be entitled to be indemnified and secured harmless out of the assets of the Company from and against all actions, costs, charges, losses, damages and expenses which they or any of them shall or may incur or sustain by reason of any act done, concurred in or omitted in or about the execution of their duty or supposed duty in their respective offices. Such provisions were in force throughout the year ended December 31, 2023 and are currently in force.

The Company has arranged for appropriate insurance cover for Directors' liabilities in respect of legal actions that may be brought against the Directors during the year ended December 31, 2023.

## USE OF PROCEEDS FROM THE GLOBAL OFFERING AND THE TOP-UP PLACING

Our shares were listed on the Main Board of the Stock Exchange on January 15, 2020. A total of 333,400,000 ordinary shares comprising the Global Offering with nominal value of US\$0.0000001 each of the Company were issued at HK\$6.60 per Share for a total of approximately HK\$2,200 million. The net proceeds raised by the Company from the Global Offering is approximately HK\$2,057.9 million. On February 7, 2020, the Joint Global Coordinators exercised the Over-allotment Option granted by the Company under the Global Offering in full and pursuant to which the Company issued and allotted an aggregate of 50,010,000 additional Shares at HK\$6.60 per Share for a total of approximately HK\$330 million. The net proceeds raised by the Company from the issue of Shares pursuant to the exercise of the Over-allotment Option in full is approximately HK\$315 million. Details of the Group's use of proceeds from the Global Offering and the exercise of the Over-allotment Option in full as at March 10, 2023 are set out in the section headed "Management Discussion and Analysis – Use of Proceeds – Use of Proceeds from the Global Offering" in this annual report.

To supplement the Group's long-term funding of its expansion plan and growth strategies, the Company entered into a placing and subscription agreement with GYH BVI, three placing agents and certain other parties on July 16, 2020. The Company successfully raised total net proceeds of approximately HK\$829.5 million through the top-up placing of 70,000,000 Shares to not less than six professional, institutional and/or individual investors at the placing price of HKD11.99 per Share on July 30, 2020 (a discount of approximately 5.44% to the closing price of HKD12.68 per Share as quoted on the Stock Exchange on July 15, 2020, being the last trading day on which the terms of the placing were fixed). The net placing price after the deduction of expenses was approximately HK\$11.85 per placing Share. Details of the Group's use of proceeds from the top-up placing as at March 10, 2023 are set out in the section headed "Management Discussion and Analysis – Use of Proceeds – Use of Proceeds from the Subscription" in this annual report.

為本集團擴張計劃及增長策略補充長期資金，本公司於2020年7月16日與GYH BVI、三名配售代理及若干其他訂約方訂立配售及認購協議。本公司已於2020年7月30日成功按每股股份11.99港元的配售價(較股份於2020年7月15日(即釐定配售條款之最後交易日)在聯交所所報收市價每股股份12.68港元折讓約5.44%)，向不少於六名專業、機構及/或個人投資者以先舊後新配售方式配售70,000,000股股份，從而籌集所得款項淨額合共約829.5百萬港元。經扣除開支，淨配售價約為每股配售股份11.85港元。有關本集團截至2023年3月10日的先舊後新配售所得款項用途之詳情載於本年報「管理層討論與分析 – 所得款項用途 – 認購事項所得款項用途」一節。

## CONNECTED TRANSACTIONS

### Provision of Financial Assistance

On January 5, 2023, Guangzhou Pin Xin Yue Gu Enterprise Management Co., Ltd., (廣州品芯悅谷企業管理有限公司) (the “**Lender**”), an indirect wholly-owned subsidiary of the Company, and Guangzhou Yanshang Investment Co., Ltd. (廣州言上投資有限公司) (the “**Borrower**”), a company ultimately owned by Mr. Guan Yihong, entered into the entrusted payment agreement, pursuant to which the Lender settled payment for premises on behalf of the Borrower in an aggregate amount of RMB80.7 million. Such payment was accounted for as an advance (the “**Advance**”) to an entity owned by the ultimate controlling shareholder in the Group’s consolidated financial statements. The Advance bore an interest rate at 2.6% per annum and was repayable on demand. The Advance constituted a financial assistance under Chapter 14A of the Listing Rules.

The Advance and the interest on the Advance had been fully repaid to the Group as of October 6, 2023. For further details, please refer to the announcement of the Company dated October 6, 2023.

### Acquisition of 3.24% Equity Interest in a Non-Wholly Owned Subsidiary

On November 1, 2023, Tai Er Investment (the “**Purchaser**”), which is an indirect wholly-owned subsidiary of the Company, and Guangzhou Chunsi (the “**Vendor**”), which is a limited partnership owned by the Company’s employees, entered into an equity transfer agreement, pursuant to which the Vendor agreed to sell and the Purchaser agreed to purchase 3.24% of the equity interest in Tai Er Catering (the “**Acquisition**”), which is an indirect non-wholly owned subsidiary of the Company, at a total consideration of RMB199,494,000, which was determined after arm’s length negotiations between the Purchaser and the Vendor based on the valuation of the entire equity interest in Tai Er Catering as of September 7, 2023, i.e., RMB6,157,842,000, with reference to the valuation (the “**Valuation**”) conducted by an independent valuer using market approach. The consideration was close to the value of 3.24% equity interest in Tai Er Catering derived from the Valuation.

## 關連交易

### 提供財務資助

於2023年1月5日，廣州品芯悅谷企業管理有限公司（本公司的一間間接全資附屬公司（「**貸款人**」）與廣州言上投資有限公司（由管毅宏先生最終擁有的公司（「**借款人**」）訂立委託付款協議，據此，貸款人代表借款人就物業結付款項合共人民幣80.7百萬元。有關付款於本集團的綜合財務報表內入賬為向最終控股股東擁有的實體作出墊款（「**墊款**」）。墊款按年利率2.6%計息，並須按要求償還。墊款構成上市規則第14A章項下的財務資助。

於2023年11月1日，太二投資（本公司的一間間接全資附屬公司（「**買方**」）與廣州純思（由本公司員工擁有的有限合夥企業（「**賣方**」）訂立股權轉讓協議，據此，賣方同意出售而買方同意購買本公司間接非全資附屬公司太二餐飲的3.24%股權（「**收購事項**」），總代價為人民幣199,494,000元，此乃買方與賣方參考由獨立估值師使用市場法進行的估值（「**估值**」）得出太二餐飲截至2023年9月7日全部股權的價值（即人民幣6,157,842,000元），並以此為基礎經公平磋商後釐定。代價接近太二餐飲經估值後的3.24%股權價值。

As (i) the Vendor was a substantial shareholder holding 12% of the equity interest in Tai Er Catering and hence a connected person of the Company at the subsidiary level under Chapter 14A of the Listing Rules; (ii) the Board had approved the Acquisition; and (iii) the independent non-executive Directors had confirmed that the Acquisition is on normal commercial terms and its terms are fair and reasonable and in the interests of the Company and the Shareholders as a whole, the Acquisition constituted a transaction with a connected person at the subsidiary level and was subject to the reporting and announcement requirements but exempt from the circular, independent financial advice and independent shareholders' approval requirements under Rule 14A.101 of the Listing Rules.

For further details, please refer to the announcement of the Company dated November 1, 2023.

Save as disclosed above, there was no other connected transaction or continuing connected transaction undertaken by the Company during the year ended December 31, 2023 and up to the date of this annual report which was required to be disclosed pursuant to Chapter 14A of the Listing Rules. The related party transaction disclosed in note 30 to the consolidated financial statements did not constitute connected transactions or continuing connected transactions of the Company. The Company confirms that it has complied with the disclosure requirements in accordance with Chapter 14A of the Listing Rules.

## OPINION

We have audited the consolidated financial statements of Jiumaojiu International Holdings Limited ("the Company") and its subsidiaries ("the Group") set out on pages 117 to 248, which comprise the consolidated statement of financial position as at 31 December 2023, the consolidated statement of profit or loss, the consolidated statement of profit or loss and other comprehensive income, the consolidated statement of changes in equity and the consolidated cash flow statement for the year then ended and notes, comprising material accounting policy information and other explanatory information.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 December 2023 and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with International Financial Reporting Standards ("IFRSs") issued by the International Accounting Standards Board ("IASB") and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

### 1 MATERIAL ACCOUNTING POLICIES

#### (a) Statement of Compliance

These financial statements have been prepared in accordance with all applicable International Financial Reporting Standards (“IFRSs”) which collective term includes all applicable individual International Financial Reporting Standards, International Accounting Standards and Interpretations issued by the International Accounting Standards Board (“IASB”) and the disclosure requirements of the Hong Kong Companies Ordinance. These financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited. Material accounting policies adopted by the Group are disclosed below.

The IASB has issued certain amendments to IFRSs that are first effective or available for early adoption for the current accounting period of the Group. Note 1(c) provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current accounting period reflected in these financial statements.

#### (b) Basis of preparation of the financial statements

The consolidated financial statements for the year ended 31 December 2023 comprise the Company and its subsidiaries (together referred to as the “Group”) and the Group’s interest in associates.

Item included in the financial statements of each entity in the Group are measured using the currency that best reflects the economic substance of the underlying events and circumstances relevant to the entity (the “Functional Currency”). The financial statements are presented in Renminbi (“RMB”), rounded to the nearest thousand except for earnings per share information. The measurement basis used in the preparation of the financial statements is the historical cost basis except that financial assets measured at fair value through other comprehensive income (FVOCI) and financial assets measured at fair value through profit or loss (FVPL) are stated at their fair value as explained in note 1(f).

### 1 重要會計政策

#### (a) 合規聲明

本財務報表乃根據國際會計準則理事會頒佈的所有適用的國際財務報告準則(該統稱包含所有適用的個別國際財務報告準則、國際會計準則及詮釋)及香港公司條例的披露規定編製。本財務報表亦符合香港聯合交易所有限公司證券上市規則的適用披露規定。本集團所採納的重要會計政策披露如下。

國際會計準則理事會已頒佈若干於本集團當前會計期間首次生效或可提前採納的國際財務報告準則修訂本。在與本集團有關的範圍內首次應用這些準則修訂本所引致當前會計期間的任何會計政策變動，已於本財務報表內反映，有關資料載列於附註1(c)。

#### (b) 財務報表編製基準

截至2023年12月31日止年度的綜合財務報表包括本公司及其附屬公司(統稱「本集團」)及本集團於聯營公司的權益。

本集團各實體的財務報表所包括的項目乃使用最能反映與該實體相關的潛在事件及情況的經濟實質的貨幣(「功能貨幣」)計量。財務報表以人民幣呈報，有關金額均四捨五入至最接近的千位數，惟每股盈利資料除外。編製財務報表所採用的計量基準為歷史成本基準，惟按公平值計入其他全面收益計量的金融資產及按公平值計入損益計量的金融資產按其公平值列賬(誠如附註1(f)所闡釋)。

#### (b) Basis of preparation of the financial statements (continued)

The preparation of financial statements in conformity with IFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgements made by management in the application of IFRSs that have significant effect on the financial statements and major sources of estimation uncertainty are discussed in note 2.

編製符合國際財務報告準則的財務報表需要管理層作出判斷、估計及假設，而該等判斷、估計及假設會影響政策的應用及所申報的資產、負債、收入及開支的金額。該等估計及有關假設乃根據歷史經驗及管理層相信於該等情況下乃屬合理的各項其他因素而作出，所得結果構成了管理層在無法依循其他來源輕易得知資產與負債的賬面值時作出判斷的基礎。實際結果或會有別於該等估計。

管理層會不斷審閱該等估計及相關假設。如果會計估計的修訂僅影響修訂估計的期間，則該修訂會在該期間內確認；如果修訂對當前和未來期間均有影響，則該修訂在修訂期間和未來期間確認。

管理層應用國際財務報告準則時所作對財務報表造成重大影響的判斷及估計不確定性的主要來源於附註2論述。

The amendments narrow the scope of the initial recognition exemption such that it does not apply to transactions that give rise to equal and offsetting temporary differences on initial recognition such as leases and decommissioning liabilities. For leases and decommissioning liabilities, the associated deferred tax assets and liabilities are required to be recognised from the beginning of the earliest comparative period presented, with any cumulative effect recognised as an adjustment to retained earnings or other components of equity at that date. For all other transactions, the amendments are applied to those transactions that occur after the beginning of the earliest period presented.

Prior to the amendments, the Group did not apply the initial recognition exemption to lease transactions and had recognised the related deferred tax, except that the Group previously determined the temporary difference arising from a right-of-use asset and the related lease liability on a net basis on the basis they arise from a single transaction. Following the amendments, the Group has determined the temporary differences in relation to right-of-use assets and lease liabilities separately. The change primarily impacts disclosures of components of deferred tax assets and liabilities in note 25(b), but does not impact the overall deferred tax balances presented in the consolidated statement of financial position as the related deferred tax balances qualify for offsetting under IAS 12.

#### (d) Subsidiaries and non-controlling interests

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The financial statements of subsidiaries are included in the consolidated financial statements from the date on which control commences until the date on which control ceases.

Intra-group balances and transactions, and any unrealised income and expenses (except for foreign currency transaction gains or losses) arising from intra-group transactions are eliminated. Unrealised losses resulting from intra-group transactions are eliminated in the same way as unrealised gains but only to the extent that there is no evidence of impairment.

該等修訂本收窄初始確認豁免的範圍，使其不適用於在初始確認時產生等值而互相抵銷暫時性差異的交易，例如租賃及清拆負債。就租賃及清拆負債而言，相關遞延稅項資產及負債須自所呈列的最早比較期間開始時確認，而在該日的任何累計影響則確認為保留盈利或其他權益組成部分的調整。就所有其他交易而言，該等修訂本適用於所呈列的最早期間開始後進行的交易。

於修訂前，本集團並無對租賃交易應用初步確認豁免，並已確認相關遞延稅項，惟本集團先前按淨額基準釐定使用權資產及相關租賃負債所產生的暫時性差異除外（基於其產生自單一交易）。於修訂後，本集團已單獨釐定與使用權資產及租賃負債有關的暫時性差異。該變動主要影響附註25(b)遞延稅項資產及負債組成部分的披露，但由於相關遞延稅項結餘符合資格根據國際會計準則第12號進行抵銷，故不會影響綜合財務狀況表呈列的整體遞延稅項結餘。

#### (d) 附屬公司及非控股權益

附屬公司為本集團所控制實體。本集團若對來自其所參與實體的可變回報承擔風險或享有權利，且有能力透過其對實體的權力影響該等回報，則為對實體擁有控制權。附屬公司的財務報表自開始控制當日起至失去控制權當日止計入綜合財務報表。

集團內公司間的結餘及交易以及集團內公司間交易所產生的任何未變現收入及開支（外幣交易收益或虧損除外）予以抵銷。集團內公司間交易所產生的未變現虧損的抵銷方法與未變現收入相同，惟僅限於無減值證據出現的情況下方可予以抵銷。

For each business combination, the Group can elect to measure any non-controlling interests (“NCI”) either at fair value or at the NCI’s proportionate share of the subsidiary’s net identifiable assets. NCI are presented in the consolidated statement of financial position within equity, separately from equity attributable to the equity shareholders of the Company. NCI in the results of the Group are presented on the face of the consolidated statement of profit or loss and consolidated statement of profit or loss and other comprehensive income as an allocation of the total profit or loss and total comprehensive income for the year between NCI and the equity shareholders of the Company. Loans from holders of NCI and other contractual obligations towards these holders are presented as financial liabilities in the consolidated statement of financial position in accordance with notes 1(q) or (r) depending on the nature of the liability.

Changes in the Group’s interests in a subsidiary that do not result in a loss of control are accounted for as equity transactions.

When the Group loses control of a subsidiary, it derecognises the assets and liabilities of the subsidiary, and any related NCI and other components of equity. Any resulting gain or loss is recognised in profit or loss. Any interest retained in that former subsidiary is measured at fair value when control is lost.

In the Company’s statement of financial position, an interest in a subsidiary is stated at cost less impairment losses (see note 1(k)(ii)), unless it is classified as held for sale (or included in a disposal group classified as held for sale).

就各業務合併而言，本集團可選擇按公平值或非控股權益（「控股權益」）所佔附屬公司的可識別資產淨值的比例計量任何非控股權益。非控股權益在綜合財務狀況表的權益部分內，與本公司權益股東應佔權益分開呈列。在本集團業績中，非控股權益於綜合損益表以及綜合損益及其他全面收益表呈列為本年度的總溢利或虧損及全面收益總額於非控股權益與本公司權益股東之間的分配。來自非控股權益持有人的貸款及對該等持有人的其他合約責任根據附註1(q)或(r)（視乎負債性質而定）於綜合財務狀況表呈列為金融負債。

本集團於附屬公司的權益變動，如不會導致喪失控制權，則以權益交易入賬。

當本集團喪失對附屬公司的控制權，其終止確認附屬公司的資產及負債，以及任何相關非控股權益及權益的其他組成部分。所產生的任何收益或虧損於損益確認。任何仍保留的該前附屬公司的權益於喪失控制權時以公平值計量。

於本公司的財務狀況表中，於附屬公司的權益按成本減減值虧損列賬（見附註1(k)(ii)），除非其歸類為持作出售（或計入歸類為持作出售的出售組別內）。

#### (e) Associates

An associate is an entity in which the Group or Company has significant influence, but not control or joint control, over the financial and operating policies.

An investment in an associate is accounted for using the equity method, unless it is classified as held for sale (or included in a disposal group classified as held for sale). They are initially recognised at cost, which includes transaction costs. Subsequently, the consolidated financial statements include the Group's share of the profit or loss and other comprehensive income ("OCI") of those investees, until the date on which significant influence ceases.

When the Group's share of losses exceeds its interest in the associate, the Group's interest is reduced to nil and recognition of further losses is discontinued except to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the investee. For this purpose, the Group's interest is the carrying amount of the investment under the equity method, together with any other long-term interests that in substance form part of the Group's net investment in the associate, after applying the ECL model to such other long-term interests where applicable (see note 1(k)(i)).

Unrealised gains arising from transactions with equity-accounted investees are eliminated against the investment to the extent of the Group's interest in the investee. Unrealised losses are eliminated in the same way as unrealised gains, but only to the extent there is no evidence of impairment.

#### (e) 聯營公司

聯營公司是指本集團或本公司對其財務及經營政策具有重大影響但並非控制或共同控制的實體。

於聯營公司的投資，除已歸類為持作出售（或計入歸類為持作出售的出售組別內）外，乃使用權益法入賬。其初步按成本確認，包括交易成本。其後，綜合財務報表包括本集團應佔該等被投資公司的損益及其他全面收益（「其他全面收益」），直至重大影響力終止當日為止。

當本集團應佔聯營公司的虧損超過其應佔權益，則本集團的權益將減至零，並會終止確認進一步虧損，惟本集團已產生法律或推定責任或已代表投資對象作出償付除外。就此而言，本集團的權益為按權益法計算的投資賬面值，連同實質上構成本集團於聯營公司的投資淨值的任何其他長期權益（在對該等其他長期權益應用預期信貸虧損模式後（如適用））（見附註1(k)(i)）。

與按權益法入賬的被投資公司進行交易而產生的未變現收益，乃以本集團於被投資公司的權益為限與投資抵銷。未變現虧損的抵銷方法與未變現收益相同，惟僅限於無減值證據出現的情況下方可予以抵銷。

#### (f) Other investments in securities

The Group's policies for investments in equity securities, other than investments in subsidiaries and associates, are set out below.

Investments in securities are recognised/derecognised on the date the Group commits to purchase/sell the investment. The investments are initially stated at fair value plus directly attributable transaction costs, except for those investments measured at FVPL for which transaction costs are recognised directly in profit or loss. For an explanation of how the Group determines fair value of financial instruments, see note 28(e). These investments are subsequently accounted for as follows, depending on their classification.

#### (i) Non-equity investments

Non-equity investments are classified into one of the following measurement categories:

- amortised cost, if the investment is held for the collection of contractual cash flows which represent solely payments of principal and interest. Expected credit losses, interest income calculated using the effective interest method (see note 1(v)(iv)), foreign exchange gains and losses are recognised in profit or loss. Any gain or loss on derecognition is recognised in profit or loss.
- FVOCI – recycling, if the contractual cash flows of the investment comprise solely payments of principal and interest and the investment is held within a business model whose objective is achieved by both the collection of contractual cash flows and sale. Expected credit losses, interest income (calculated using the effective interest method) and foreign exchange gains and losses are recognised in profit or loss and computed in the same manner as if the financial asset was measured at amortised cost. The difference between the fair value and the amortised cost is recognised in OCI. When the investment is derecognised, the amount accumulated in OCI is recycled from equity to profit or loss.

#### (f) 其他證券投資

本集團股本證券投資(於附屬公司及聯營公司的投資除外)的政策載列於下文。

本集團在承諾購入／出售投資當日確認／終止確認證券投資。投資初步按公平值加直接應佔交易成本列報，惟按公平值計入損益計量的投資除外，該等投資的交易成本直接於損益確認。有關本集團釐定金融工具公平值的方法的解釋，請參見附註28(e)。該等投資其後根據其分類入賬如下。

#### (i) 非股本投資

非股本投資分類為以下其中一個計量類別：

- 攤銷成本，倘持有投資的目的為收取合約現金流量，即純粹為獲得本金及利息付款。預期信貸虧損、使用實際利率法計算的利息收入(見附註1(v)(iv))、匯兌收益及虧損於損益確認。終止確認的任何收益或虧損於損益確認。
- 按公平值計入其他全面收益 – 可撥回，倘投資的合約現金流量僅包括本金及利息付款，且投資乃按其目的為同時收取合約現金流量及出售的業務模式持有。預期信貸虧損、利息收入(使用實際利率法計算)及匯兌收益及虧損於損益確認，並按與金融資產按攤銷成本計量相同的方式計算。公平值與攤銷成本之間的差額於其他全面收益確認。當投資終止確認時，於其他全面收益累計的金額由權益撥回至損益。

##### (i) Non-equity investments (continued)

- FVPL if the investment does not meet the criteria for being measured at amortised cost or FVOCI (recycling). Changes in the fair value of the investment (including interest) are recognised in profit or loss.

##### (ii) Equity investments

An investment in equity securities is classified as FVPL, unless the investment is not held for trading purposes and on initial recognition the Group makes an irrevocable election to designate the investment at FVOCI (non-recycling) such that subsequent changes in fair value are recognised in OCI. Such elections are made on an instrument-by-instrument basis, but may only be made if the investment meets the definition of equity from the issuer's perspective. If such election is made for a particular investment, at the time of disposal, the amount accumulated in the fair value reserve (non-recycling) is transferred to retained earnings and not recycled through profit or loss. Dividends from an investment in equity securities, irrespective of whether classified as at FVPL or FVOCI, are recognised in profit or loss as other income (see note 1(v)(iii)).

#### (g) Derivative financial instruments

The Group holds derivative financial instruments to manage its foreign currency risk exposures.

Derivatives are initially measured at fair value. Subsequently, they are measured at fair value with changes therein recognised in profit or loss.

##### (i) 非股本投資 (續)

- 按公平值計入損益，倘投資不符合按攤銷成本或按公平值計入其他全面收益(可撥回)計量的標準。投資(包括利息)的公平值變動於損益確認。

##### (ii) 股本投資

股本證券投資會被分類為按公平值計入損益，除非該項投資並非持作買賣，且本集團在初步確認時不可撤回地選擇將投資指定為按公平值計入其他全面收益(不可撥回)，以致後續公平值變動於其他全面收益確認。有關選擇乃按工具個別作出，惟僅在發行人認為投資符合權益定義的情況下方可作出。倘就某項投資作出有關選擇，則於出售時，於公平值儲備(不可撥回)累計的金額會轉撥至保留盈利，而非透過損益轉撥。來自股本證券投資(不論分類為按公平值計入損益或按公平值計入其他全面收益)的股息，乃於損益確認為其他收益(見附註1(v)(iii))。

#### (g) 衍生金融工具

本集團持有衍生金融工具以管理其外幣風險。

衍生工具初步按公平值計量。其後，彼等按公平值計量，其變動於損益確認。

#### (h) Property, plant and equipment

Property, plant and equipment, including construction in progress, are stated at cost, which includes capitalised borrowing costs, less accumulated depreciation and any accumulated impairment losses (see note 1(k)(ii)). No depreciation is provided for in respect of construction in progress until it is completed and ready for its intended use.

If significant parts of an item of property, plant and equipment have different useful lives, then they are accounted for as separate items (major components).

Any gain or loss on disposal of an item of property, plant and equipment is recognised in profit or loss.

Depreciation is calculated to write off the cost of items of property, plant and equipment, less their estimated residual values, if any, using the straight-line method over their estimated useful lives, and is generally recognised in profit or loss.

The estimated useful lives for the current and comparative periods are as follows:

Research and development costs comprise all costs that are directly attributable to research and development activities or that can be allocated on a reasonable basis to such activities.

Expenditure on research activities is recognised in profit or loss as incurred. Development expenditure is capitalised only if the expenditure can be measured reliably, the product or process is technically and commercially feasible, future economic benefits are probable and the Group intends to and has sufficient resources to complete development and to use or sell the resulting asset. Otherwise, it is recognised in profit or loss as incurred. Capitalised development expenditure is subsequently measured at cost less accumulated amortisation and any accumulated impairment losses.

Other intangible assets, including brand name, that are acquired by the Group and have finite useful lives are measured at cost less accumulated amortisation and any accumulated impairment losses (see note 1(k)(ii)).

Expenditure on internally generated brands, is recognised in profit or loss as incurred.

Amortisation is calculated to write off the cost of intangible assets less their estimated residual values using the straight-line method over their useful lives, if any, and is generally recognised in profit or loss.

The estimated useful lives for the current and comparative periods are as follows:

Amortisation methods, useful lives and residual values are reviewed at each reporting date and adjusted if appropriate.

This is the case if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

##### As a lessee

Where the contract contains lease component(s) and non-lease component(s), the Group has elected not to separate non-lease components and accounts for each lease component and any associated non-lease components as a single lease component for all leases.

At the lease commencement date, the Group recognises a right-of-use asset and a lease liability, except for leases that have a short lease term of 12 months or less and leases of low-value items such as apartments and electronic devices. When the Group enters into a lease in respect of a low-value item, the Group decides whether to capitalise the lease on a lease-by-lease basis. If not capitalised, the associated lease payments are recognised in profit or loss on a systematic basis over the lease term.

Where the lease is capitalised, the lease liability is initially recognised at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. After initial recognition, the lease liability is measured at amortised cost and interest expense is recognised using the effective interest method. Variable lease payments that do not depend on an index or rate are not included in the measurement of the lease liability and are charged to profit or loss as incurred.

In such cases, the Group has taken advantage of the practical expedient not to assess whether the rent concessions are lease modifications, and recognised the change in consideration as negative variable lease payments in profit or loss in the period in which the event or condition that triggers the rent concessions occurred.

In the consolidated statement of financial position, the current portion of long-term lease liabilities is determined as the present value of contractual payments that are due to be settled within twelve months after the reporting period.

ECLs are a probability-weighted estimate of credit losses. Generally, credit losses are measured as the present value of all expected cash shortfalls between the contractual and expected amounts.

The maximum period considered when estimating ECLs is the maximum contractual period over which the Group is exposed to credit risk.

ECLs are measured on either of the following bases:

- 12-month ECLs: these are the portion of ECLs that result from default events that are possible within the 12 months after the reporting date (or a shorter period if the expected life of the instrument is less than 12 months); and

###### *Write-off policy*

The gross carrying amount of a financial asset is written off to the extent that there is no realistic prospect of recovery. This is generally the case when the Group otherwise determines that the debtor does not have assets or sources of income that could generate sufficient cash flows to repay the amounts subject to the write-off.

Subsequent recoveries of an asset that was previously written off are recognised as a reversal of impairment in profit or loss in the period in which the recovery occurs.

At each reporting date, the Group reviews the carrying amounts of its non-financial assets (other than inventories and deferred tax assets) to determine whether there is any indication of impairment. If any such indication exists, then the asset's recoverable amount is estimated.

The recoverable amount of an asset or CGU is the greater of its value in use and its fair value less costs of disposal. Value in use is based on the estimated future cash flows discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset or CGU.

An impairment loss is recognised if the carrying amount of an asset or CGU exceeds its recoverable amount.

Impairment losses are recognised in profit or loss. They are allocated first to reduce the carrying amount of any goodwill allocated to the CGU, and then to reduce the carrying amounts of the other assets in the CGU on a pro rata basis.

An impairment loss in respect of goodwill is not reversed. For other assets, an impairment loss is reversed only to the extent that the resulting carrying amount does not exceed the carrying amount that would have been determined, net of depreciation or amortisation, if no impairment loss had been recognised.

##### (iii) Interim financial reporting and impairment

Under the Rules Governing the Listing of Securities on the Stock Exchange of Hong Kong Limited, the Group is required to prepare an interim financial report in compliance with IAS 34, Interim financial reporting, in respect of the first six months of the financial year. At the end of the interim period, the Group applies the same impairment testing, recognition, and reversal criteria as it would at the end of the financial year (see note 1(k)(i) and (ii)).

Impairment losses recognised in an interim period in respect of goodwill are not reversed in a subsequent period. This is the case even if no loss, or a smaller loss, would have been recognised had the impairment been assessed only at the end of the financial year to which the interim period relates.

##### (iii) 中期財務報告及減值

根據香港聯合交易所有限公司證券上市規則，本集團須就財政年度首六個月編製符合國際會計準則第34號中期財務報告的中期財務報告。於中期結束時，本集團應用與財政年度結束時所應用的相同減值測試、確認及撥回條件（見附註1(k)(i)及(ii)）。

就商譽於中期確認的減值虧損並無於之後期間撥回。即使減值僅於有關中期相關的財政年度結束時評估，因而並無確認虧損，或所確認虧損較少，上述原則亦適用。

#### (l) Inventories

Inventories are measured at the lower of cost and net realisable value.

Cost is calculated using the weighted average cost formula and comprises all costs of purchase, costs of conversion and other costs incurred in bringing the inventories to their present location and condition.

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

#### (m) Contract liabilities

A contract liability is recognised when the customer pays non-refundable consideration before the Group recognises the related revenue (see note 1(v)). A contract liability is also recognised if the Group has an unconditional right to receive non-refundable consideration before the Group recognises the related revenue. In such latter cases, a corresponding receivable would also be recognised (see note 1(n)).

When the contract includes a significant financing component, the contract balance includes interest accrued under the effective interest method (see note 1(v)).

#### (n) Trade and other receivables

A receivable is recognised when the Group has an unconditional right to receive consideration and only the passage of time is required before payment of that consideration is due.

Trade receivables that do not contain a significant financing component are initially measured at their transaction price. Trade receivables that contain a significant financing component and other receivables are initially measured at fair value plus transaction costs. All receivables are subsequently stated at amortised cost (see note 1(k)(i)).

存貨乃按成本與可變現淨值兩者中的較低者計量。

成本乃按加權平均成本法計算，並包括所有購貨成本、轉換成本及其他使存貨達致現時所在地點及狀況所產生的成本。

可變現淨值是在日常業務過程中的估計售價減去完成銷售的估計成本及進行銷售所需估計成本後所得金額。

#### (m) 合約負債

倘顧客於本集團確認相關收入之前支付不可退回的代價，則確認合約負債（見附註1(v)）。倘本集團擁有無條件權利可於本集團確認相關收入前收取不可退回的代價，亦將確認合約負債。在後一種情況下，亦將確認相應的應收款項（見附註1(n)）。

倘合約包含重大融資部分，合約結餘包括按實際利率法計算的應計利息（見附註1(v)）。

#### (n) 貿易及其他應收款項

在本集團擁有無條件權利收取代價時且該代價到期付款前僅需時間推移，則確認應收款項。

不包含重大融資組成部分的貿易應收款項初步按其交易價格計量。包含重大融資組成部分的貿易應收款項及其他應收款項初步按公平值另加交易成本計量。所有應收款項隨後按攤銷成本列賬（見附註1(k)(i)）。

#### (o) Software-as-a-service (SaaS) arrangement costs

A SaaS arrangement is a service arrangement where the Group has a right to access to the supplier's application software running on the supplier's cloud infrastructure during the term of the arrangement, but not control over the underlying software asset.

Costs to implement a SaaS arrangement, including those incurred in configuring or customising the access to the supplier's application software, are evaluated to determine if they give rise to a separate asset that the Group controls. Any resulting asset is recognised and accounted for in accordance with the policy for intangible assets as set out in note 1(i). Implementation costs that do not give rise to an asset are recognised in profit or loss as incurred, which may be over the period the configuration or customisation services are received to the extent that such services are distinct from the SaaS, or over the term of the SaaS arrangement to the extent the configuration or customisation services are not distinct from the SaaS.

Payment made in advance of receiving the related services is recognised as prepayment.

#### (p) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions and other short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Cash and cash equivalents are assessed for ECL (see note 1(k)(i)).

#### (q) Trade and other payables

Trade and other payables are initially recognised at fair value. Subsequent to initial recognition, trade and other payables are stated at amortised cost unless the effect of discounting would be immaterial, in which case they are stated at invoice amounts.

#### (r) Interest-bearing borrowings

Interest-bearing borrowings are measured initially at fair value less transaction costs. Subsequently, these borrowings are stated at amortised cost using the effective interest method. Interest expense is recognised in accordance with note 1(x).

SaaS安排為一項服務安排，據此，本集團有權於安排期限內存取供應商於供應商雲基礎設施上運行的應用軟件，惟對相關軟件資產並無控制權。

實施SaaS安排的成本(包括設定或定制供應商應用軟件的存取所招致的成本)會被評估，以釐定其有否產生由本集團控制的獨立資產。由此產生的任何資產根據附註1(i)所載的無形資產政策確認及入賬。並無產生資產的實施成本於招致成本時(即可能於獲得設定或定制服務期間(倘有關服務與SaaS不同)或於SaaS安排期限內(倘設定或定制服務與SaaS並無不同))在損益確認。

於獲得相關服務前預先作出的付款確認為預付款項。

#### (p) 現金及現金等價物

現金及現金等價物包括銀行及手頭現金、於銀行及其他金融機構的活期存款，以及可隨時轉換為已知金額現金及價值變動風險甚微且於購入後三個月內到期的其他短期高流通性投資。現金及現金等價物就預期信貸虧損進行評估(見附註1(k)(i))。

#### (q) 貿易及其他應付款項

貿易及其他應付款項初步按公平值確認。於初步確認後，貿易及其他應付款項按攤銷成本列賬，惟倘貼現影響並不重大，則按發票金額列賬。

#### (r) 計息借款

計息借款初始按公平值減交易成本計量。其後，該等借款使用實際利率法按攤銷成本列賬。利息開支根據附註1(x)確認。

##### (i) Short term employee benefits and contributions to defined contribution retirement plans

Short-term employee benefits are expensed as the related service is provided. A liability is recognised for the amount expected to be paid if the Group has a present legal or constructive obligation to pay this amount as a result of past service provided by the employee and the obligation can be estimated reliably.

Pursuant to the relevant laws and regulations of the PRC, the Group participates in a defined contribution basic pension insurance in the social insurance system established and managed by government organisations. The Group makes contributions to basic pension insurance plans based on the applicable benchmarks and rates stipulated by the government. The local government authorities are responsible for the pension obligations payable to the retired employees covered under the defined contribution basic pension insurance. There are no forfeited contributions for the defined contribution basic pension insurance in the PRC social insurance system as the contributions are fully vested to the employees upon payment to the scheme.

Obligations for contributions to defined contribution retirement plans are recognised as part of the cost of assets or expensed as the related service is provided.

##### (ii) Share-based payments

The grant-date fair value of equity-settled shares or share options granted to employees is measured using the income approach model, in case of shares granted, or the binomial option pricing model, in case of share options granted. The amount is generally recognised as an expense, with a corresponding increase in equity, over the vesting period of the awards. The amount recognised as an expense is adjusted to reflect the number of awards for which the related service conditions are expected to be met, such that the amount ultimately recognised is based on the number of awards that meet the related service conditions at the vesting date.

##### (i) 短期僱員福利及定額供款退休計劃供款

短期僱員福利於提供相關服務時列作支出。倘本集團因僱員過往提供的服務而須承擔現時法律或推定責任支付該金額，且該責任能可靠估計，則就預期支付的金額確認負債。

根據中國的相關法律及法規，本集團參與一項由政府機關設立及管理，屬社會保險制度下的定額供款基本退休金保險。本集團按適用基準及政府規定的比率，對基本退休金保險計劃作出供款。地方政府機關負責向受定額供款基本退休金保險保障的退休僱員發放退休金。中國社會保險制度下的界定供款基本退休金保險並無已沒收供款，原因為供款於支付予計劃時悉數歸屬予僱員。

對定額供款退休計劃作出供款的責任乃作為資產成本的一部分確認，或於提供相關服務時列作支出。

##### (ii) 以股份為基礎的付款

授予僱員的以權益結算的股份或購股權的授出日期公平值使用收入法模型（就已授出股份而言）或二項式期權定價模型（就已授出購股權而言）計量。該金額一般於獎勵的歸屬期內確認為開支，並相應增加權益。確認為開支的金額會作出調整，以反映預期將符合相關服務條件的獎勵數目，因此最終確認的金額乃基於歸屬日期符合相關服務條件的獎勵數目。

Termination benefits are expensed at the earlier of when the Group can no longer withdraw the offer of those benefits and when the Group recognises costs for a restructuring.

#### (t) Income tax

Income tax expense comprises current tax and deferred tax. It is recognised in profit or loss except to the extent that it relates to a business combination, or items recognised directly in equity or in OCI.

Current tax comprises the estimated tax payable or receivable on the taxable income or loss for the year and any adjustments to the tax payable or receivable in respect of previous years. The amount of current tax payable or receivable is the best estimate of the tax amount expected to be paid or received that reflects any uncertainty related to income taxes. It is measured using tax rates enacted or substantively enacted at the reporting date. Current tax also includes any tax arising from dividends.

Current tax assets and liabilities are offset only if certain criteria are met.

Deferred tax is recognised in respect of temporary differences between the carrying amounts of assets and liabilities for financial reporting purposes and the amounts used for taxation purposes. Deferred tax is not recognised for:

- temporary differences on the initial recognition of assets or liabilities in a transaction that is not a business combination and that affects neither accounting nor taxable profit or loss and does not give rise to equal taxable and deductible temporary differences;
- temporary differences related to investment in subsidiaries, associates and joint venture to the extent that the Group is able to control the timing of the reversal of the temporary differences and it is probable that they will not reverse in the foreseeable future;

#### (t) 所得稅

所得稅開支包括即期稅項及遞延稅項。其於損益確認，惟與業務合併或直接於權益或其他全面收益確認的項目有關者除外。

即期稅項包括年內應課稅收入或虧損的估計應付或應收稅項及過往年度應付或應收稅項的任何調整。即期應付或應收稅項金額為預期將支付或收取的稅項金額的最佳估計，反映與所得稅相關的任何不確定性。其使用於報告日期已頒佈或實質上已頒佈的稅率計量。即期稅項亦包括股息產生的任何稅項。

即期稅項資產及負債只有在滿足若干條件下方予以抵銷。

The Group recognised deferred tax assets and deferred tax liabilities separately in relation to its lease liabilities, provisions and right-of-use assets.

Deferred tax assets are recognised for unused tax losses, unused tax credits and deductible temporary differences to the extent that it is probable that future taxable profits will be available against which they can be used. Future taxable profits are determined based on the reversal of relevant taxable temporary differences. If the amount of taxable temporary differences is insufficient to recognise a deferred tax asset in full, then future taxable profits, adjusted for reversals of existing temporary differences, are considered, based on the business plans for individual subsidiaries in the Group. Deferred tax assets are reviewed at each reporting date and are reduced to the extent that it is no longer probable that the related tax benefit will be realised; such reductions are reversed when the probability of future taxable profits improves.

The measurement of deferred tax reflects the tax consequences that would follow from the manner in which the Group expects, at the reporting date, to recover or settle the carrying amount of its assets and liabilities.

Deferred tax assets and liabilities are offset only if certain criteria are met.

Generally provisions are determined by discounting the expected future cash flows at a pre-tax rate that reflects current market assessment of the time value of money and the risks specific to the liability.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

Where some or all of the expenditure required to settle a provision is expected to be reimbursed by another party, a separate asset is recognised for any expected reimbursement that would be virtually certain. The amount recognised for the reimbursement is limited to the carrying amount of the provision.

#### (v) Revenue and other income

Income is classified by the Group as revenue when it arises from the sale of goods and the provision of services.

Further details of the Group's revenue and other income recognition are as follows:

##### (i) Revenue from contracts with customers

The Group is the principal for its revenue transactions and recognises revenue on a gross basis. In determining whether the Group acts as a principal or as an agent, it considers whether it obtains control of the products before they are transferred to the customers. Control refers to the Group's ability to direct the use of and obtain substantially all of the remaining benefits from the products or services.

Revenue is recognised when control over a product or service is transferred to the customer at the amount of promised consideration to which the Group is expected to be entitled, excluding those amounts collected on behalf of third parties such as value added tax or other sales taxes.

一般情況下，撥備乃透過按反映當前市場對貨幣時間價值及負債特定風險的評估的稅前利率折現預期未來現金流量而釐定。

倘不可能需要流出經濟利益，或未能可靠估計有關金額，則有關責任會披露為或然負債，除非經濟利益流出的可能性極低則作別論。僅於發生或不發生一件或多件未來事件方能確認其存在與否的可能產生責任亦披露為或然負債，除非經濟利益流出的可能性極低則作別論。

The Group principally generates revenue from restaurant operations and delivery business.

For restaurant operations and delivery business for which the control of services is transferred at a point in time, revenue is recognised when the related services have been rendered to customers.

##### (ii) Management and service fee income

Management and service fee income is recognised when related services are rendered.

##### (iii) Dividends

- Dividend income is recognised in profit or loss on the date on which the Group's right to receive payment is established.

##### (iv) Interest income

Interest income is recognised using the effective interest method. The "effective interest rate" is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the gross carrying amount of the financial asset. In calculating interest income, the effective interest rate is applied to the gross carrying amount of the asset (when the asset is not credit-impaired). However, for financial assets that have become credit-impaired subsequent to initial recognition, interest income is calculated by applying the effective interest rate to the amortised cost of the financial asset. If the asset is no longer credit-impaired, then the calculation of interest income reverts to the gross basis.

管理及服務費收入於提供有關服務時確認。

##### (iii) 股息

- 股息收入在本集團收取派發的款項的權利確立當日於損益確認。

##### (iv) 利息收入

利息收入使用實際利率法確認。「實際利率」為將預期金融資產使用年內估計未來收取的現金，準確貼現至金融資產賬面總值的利率。在計算利息收入時，實際利率適用於資產的賬面總值 (當資產並無信貸減值時)。然而，就於初步確認後出現信貸減值的金融資產而言，利息收入透過對金融資產的攤銷成本採用實際利率計算。倘資產不再出現信貸減值，則利息收入的計算將恢復至總額基準。

Government grants are recognised in the statement of financial position initially when there is reasonable assurance that they will be received and that the Group will comply with the conditions attaching to them.

Grants that compensate the Group for expenses incurred are recognised as income in profit or loss on a systematic basis in the same periods in which the expenses are incurred.

Grants that compensate the Group for the cost of an asset are deducted from the carrying amount of the asset and consequently are effectively recognised in profit or loss over the useful life of the asset by way of reduced depreciation expense.

#### (w) Translation of foreign currencies

Transactions in foreign currencies are translated into the respective functional currencies of Group companies at the exchange rates at the dates of the transactions.

Monetary assets and liabilities denominated in foreign currencies are translated into the functional currency at the exchange rate at the reporting date. Non-monetary assets and liabilities that are measured at fair value in a foreign currency are translated into the functional currency at the exchange rate when the fair value was determined. Non-monetary assets and liabilities that are measured based on historical cost in a foreign currency are translated at the exchange rate at the date of the transaction. Foreign currency differences are generally recognised in profit or loss.

However, foreign currency differences arising from the translation of the following items are recognised in OCI:

- an investment in equity securities designated as at FVOCI (except on impairment, in which case foreign currency differences that have been recognised in OCI are reclassified to profit or loss);

政府補助於可合理確保本集團將收取政府補助且將遵守其所附帶條件時於財務狀況表初步確認。

用於補償本集團已產生開支的補助於開支產生的同一期間有系統地於損益確認為收入。

補償本集團資產成本的補助乃於資產賬面值中扣除，其後於該項資產的可使用期間以減少折舊開支的方式於損益中實際確認。

#### (w) 外幣換算

外幣交易按交易日期的匯率換算為本集團成員公司各自的功能貨幣。

以外幣計值的貨幣資產及負債按報告日期的匯率換算為功能貨幣。按公平值以外幣計量的非貨幣資產及負債採用釐定公平值的匯率換算為功能貨幣。按歷史成本以外幣計量的非貨幣資產及負債按交易日期的匯率換算。外幣差額一般於損益確認。

The income and expenses of foreign operations are translated into RMB at the exchange rates at the dates of the transactions.

Foreign currency differences are recognised in OCI and accumulated in the exchange reserve, except to the extent that the translation difference is allocated to NCI.

When a foreign operation is disposed of in its entirety or partially such that control or significant influence is lost, the cumulative amount in the exchange reserve related to that foreign operation is reclassified to profit or loss as part of the gain or loss on disposal. On disposal of a subsidiary that includes a foreign operation, the cumulative amount of the exchange differences relating to that foreign operation that have been attributed to the NCI shall be derecognised, but shall not be reclassified to profit or loss. If the Group disposes of part of its interest in a subsidiary but retains control, then the relevant proportion of the cumulative amount is reattributed to NCI. When the Group disposes of only part of an associate while retaining significant influence, the relevant proportion of the cumulative amount is reclassified to profit or loss.

#### (x) Borrowing costs

Borrowing costs that are directly attributable to the acquisition, construction or production of an asset which necessarily takes a substantial period of time to get ready for its intended use or sale are capitalised as part of the cost of that asset. Other borrowing costs are expensed in the period in which they are incurred.

Property, plant and equipment, and right-of-use assets, are depreciated on a straight-line basis over the estimated useful lives of the assets. The Group reviews the estimated useful lives of the assets regularly in order to determine the amount of depreciation expense to be recorded during any reporting period. The useful lives are based on the Group's historical experience with similar assets. The depreciation expense for future periods is adjusted if there are material changes from previous estimates.

Any increase or decrease in the provision would affect profit or loss in future periods.

#### (d) Determining the lease term

As explained in policy note 1(j), the lease liability is initially recognised at the present value of the lease payments payable over the lease term. In determining the lease term at the commencement date for leases that include renewal options exercisable by the Group, the Group evaluates the likelihood of exercising the renewal options taking into account all relevant facts and circumstances that create an economic incentive for the Group to exercise the option, including favourable terms, leasehold improvements undertaken and the importance of that underlying asset to the Group's operation. The lease term is reassessed when there is a significant event or significant change in circumstance that is within the Group's control. Any increase or decrease in the lease term would affect the amount of lease liabilities and right-of-use assets recognised in future years.

Certain subsidiaries met the criteria required for preferential income tax rate granted to small and low profit-making enterprise in the PRC, and were entitled to a preferential income tax rate of 5% on taxable income for the first RMB3,000,000.

A subsidiary met the criteria required for preferential income tax rate granted to the encouraged industry that operates in Nansha district, Guangzhou in the PRC, and was entitled to a preferential income tax rate of 15% from 2023 to 2026.

A subsidiary met the criteria for software enterprises encouraged in the PRC, and was entitled to be exempted from income tax from 2022 to 2023.

- (iv) The Company's subsidiaries incorporated overseas, other than Hong Kong and the BVI, are subject to overseas profits tax at 12% to 29.84% on estimated assessable profit for the year ended 31 December 2023 (2022: 3% to 28%).

##### Impairment loss

As at the end of each reporting period, in view of the unfavourable future prospects of certain restaurants, the Group's management estimated the recoverable amount of each such restaurant (cash-generating unit ("CGU")) with indication of impairment. The recoverable amount of each CGU is determined based on the value-in-use calculations by preparing cash flow projections of the relevant CGU derived from the most recent financial forecast approved by the management covering the remaining lease term. Based on the result of the assessments, the management of the Group determined that the recoverable amounts of certain CGUs are lower than the carrying amounts. The impairment amount has been allocated to each category of property, plant and equipment and right-of-use assets such that the carrying amount of each category of asset is not reduced below the highest of its fair value less cost of disposal, its value in use and zero. The cash flows are discounted using a discount rate ranging from 12.91% to 18.19% as at 31 December 2023 (31 December 2022: 13.34% to 25.54%). The discount rate used is pre-tax and reflects specific risks relating to the relevant CGU.

As at 31 December 2023, an impairment loss of RMB21,819,000 (31 December 2022: RMB7,167,000) was recognised in profit or loss to write down the carrying amounts of respective property, plant and equipment to their recoverable amounts of RMB106,477,000 (31 December 2022: RMB39,681,000). The above impairment loss was allocated to the assets including leasehold improvement and other equipment within the CGU on a pro rata basis.

The Group's primary objectives when managing capital are to safeguard the Group's ability to continue as a going concern, so that it can continue to provide returns for shareholders and benefits for other stakeholders, by pricing products and services commensurately with the level of risk and by securing access to finance at a reasonable cost.

The Group actively and regularly reviews and manages its capital structure to maintain a balance between the higher shareholder returns that might be possible with higher levels of borrowings and the advantages and security afforded by a sound capital position, and makes adjustments to the capital structure in light of changes in economic conditions.

The Group's overall strategy remains unchanged throughout the years ended 31 December 2023 and 2022. The Group monitors its capital structure with reference to its debt position. The Group's strategy is to maintain the equity and debt in a balanced position and ensure there are adequate working capital to service its debt obligations. The Group's debt to asset ratio, being the Group's total liabilities over its total assets, as at 31 December 2023 was 48.5% (31 December 2022: 40.8%).

Neither the Company nor any of its subsidiaries are subject to externally imposed capital requirements.

Exposure to credit, liquidity, interest rate and currency risks arises in the normal course of the Group's business.

The Group's exposure to these risks and the financial risk management policies and practices used by the Group to manage these risks are described below.

#### (a) Credit risk

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in a financial loss to the Group. The Group's credit risk is primarily attributable to trade and other receivables. The Group's exposure to credit risk arising from cash and cash equivalents and restricted deposits is limited because the counterparties are banks and financial institutions with high-credit-quality, for which the Group considers to have low credit risk. The Group's exposure to credit risk arising from refundable rental deposits is considered to be low, taking into account (i) the landlords' credit rating and (ii) the remaining lease term and the period covered by the rental deposits.

The Group's trade receivables in connection with bills settled through payment platforms such as Unionpay, Alipay or WeChat Pay are with high credit rating and no past due history. The management of the Group considers these assets are short-term in nature and the probability of default is negligible on the basis of high-credit-rating issuers during the years ended 31 December 2023 and 2022, and accordingly, no provision for impairment of trade receivables is considered necessary by management for the years ended 31 December 2023 and 2022.

本集團與通過銀聯、支付寶或微信支付等支付平台結算的票據有關的貿易應收款項具有較高的信貸評級且無逾期歷史。於截至2023年及2022年12月31日止年度，本集團管理層認為該等資產屬短期性質且違約概率在高信貸評級發行人的基礎上可忽略不計，因此管理層認為無須於截至2023年及2022年12月31日止年度就貿易應收款項減值作出撥備。

We have concentration of credit risk on amounts due from related parties as of each reporting period with details set out in note 30. Our management has made periodic assessments as well as individual assessment on recoverability based on historical settlement records and adjusts for forward-looking information. In view of the strong financial capability of these related parties and considered the future prospects of the industry these related parties operate, our management does not consider there is a risk of default and does not expect any losses from non-performance by these related parties, and accordingly, no impairment was recognised in respect of the amounts due from related parties.

In determining the ECL for other receivables (excluding rental deposits and amounts due from related parties), the management of the Group has taken into account the historical default experience and forward-looking information, as appropriate. The management of the Group has assessed that other receivables have not had a significant increase in credit risk since initial recognition and risk of default is insignificant, and therefore, no provision for impairment of other receivables is considered necessary by management for the years ended 31 December 2023 and 2022.

The expected credit loss rate is insignificant and close to zero.

The Group does not provide any guarantee which would expose the Group to credit risk.

#### (b) Liquidity risk

In management of liquidity risk, the Group's policy is to regularly monitor its liquidity requirements and its compliance with lending covenants, to ensure that it maintains sufficient reserves of cash, readily realisable marketable securities and adequate committed lines of funding from major financial institutions to meet its liquidity requirements in the short and longer term.

在釐定其他應收款項（不包括租金按金及應收關聯方款項）的預期信貸虧損時，本集團管理層已計及歷史違約經驗及前瞻性資料（視情況而定）。本集團管理層已評估其他應收款項自初步確認後信貸風險並無顯著增加且違約風險微不足道，因此管理層認為無須於截至2023年及2022年12月31日止年度就其他應收款項減值作出撥備。

預期信貸虧損率微不足道，接近於零。

本集團並無提供任何可能令本集團面臨信貸風險的擔保。

#### (b) 流動資金風險

於管理流動資金風險時，本集團政策是定期監察其流動資金需求及其遵守貸款保證契約的情況，以確保其維持充足的現金儲備，易於變現的有價證券以及主要金融機構提供足夠的承諾資金，以滿足短期及較長期的流動資金需求。

At 31 December 2023, it is estimated that a general increase/decrease of 100 basis points in interest rates, with all other variable held constant, would have decreased/increased the Group's profit after tax and retained profits by approximately RMB1,381,000 (31 December 2022: Nil) in response to the general increase/decrease in interest rates.

The sensitivity analysis above indicates the instantaneous change in the Group's profit after tax and retained profits that would arise assuming that the change in interest rates had occurred at the end of the reporting period and had been applied to re-measure those financial instruments held by the Group which expose the Group to fair value interest rate risk at the end of the reporting period. In respect of the exposure to cash flow interest rate risk arising from floating rate non-derivative instruments held by the Group at the end of the reporting period, the impact on the Group's profit after tax and retained profits is estimated as an annualised impact on interest expense or income of such a change in interest rates.

#### (d) Currency risk

As the Group's principal activities are carried out in the PRC, the Group's transactions are mainly denominated in RMB, which is not freely convertible into foreign currencies. All foreign exchange transactions involving RMB must take place through the People's Bank of China or other institutions authorised to buy and sell foreign exchange. The exchange rates adopted for the foreign exchange transactions are the rates of exchange quoted by the People's Bank of China that are determined largely by supply and demand.

The Group is exposed to currency risk primarily from cash and cash equivalents, trade and other receivables and trade and other payables that are denominated in a foreign currency, i.e. a currency other than the functional currency of the operations to which the transactions relate. The Group's currency risk mainly arises from transactions denominated in RMB and United States Dollars ("USD") that are entered by operations with a functional currency risk of HKD. As HKD is currently pegged to USD, it is assumed that there would be no material currency risk exposure of HKD to USD.
