## Chairman's Statement 主席報告

### To Our Shareholders:

On behalf of the Board (the "Board") of Directors (the "Directors"), I am pleased to present the annual report of Pan Asia Environmental Protection Group Limited ("Pan Asia" or the "Company") and its subsidiaries (collectively referred to as the "Group") for the year ended 31 December 2024.

During the year, the Group stepped up its efforts to expand its business operations and achieving a net profit of RMB17.5 million. Looking ahead, China's environmental protection engineering industry will maintain its rapid development trajectory. With the continuous advancement of the "Dual Carbon" strategy, the ongoing battle against pollution, and the progress in environmental technology, the industry will embrace even broader development prospects. The Group will actively respond to national policies, keep pace with industry trends and improve comprehensive service capabilities. We will provide customers with high-quality, efficient environmental protection engineering solutions, contributing to green development and the construction of a beautiful China.

### FINANCIAL REVIEW

During the year under review, the Group generated total revenue of RMB251.5 million, an increase of 14.1% compared with RMB220.3 million recorded in 2023, which was attributable to the Group's business development efforts as well as the continuous growth in demand for eco-friendly and low-carbon solutions. Gross profit increased by 27.4% to RMB36.2 million (2023: RMB28.4 million) with the gross profit margin of 14.4% (2023: 12.9%) on the back of continuous portfolio management.

Profit attributable to owners of the Company amounted to RMB17.2 million for the year ended 31 December 2024, turning around from a net profit of RMB1.5 million for the year ended 31 December 2023. Basic and diluted earnings per share was RMB1.76 cents (2023: basic earnings per share of RMB0.17 cents).

### 致各位股東：

本人謹代表董事(「董事」)會(「董事會」)提呈泛亞環保集團有限公司(「泛亞環保」或「本公司」)及其附屬公司(統稱「本集團」)截至二零二四年十二月三十一日止年度之年度報告。

年內，本集團加大業務拓展力度，錄得淨利潤人民幣1,750萬元。展望未來，中國環保工程行業仍將保持快速發展態勢。隨著「雙碳」戰略的深入推進、污染防治攻堅戰的持續開展，以及環保科技的不斷進步，環保工程行業將迎來廣闊的發展空間。本集團將積極響應國家政策，緊跟行業發展趨勢，不斷提升綜合服務能力，為客戶提供更加優質、高效的環保工程解決方案，為推動綠色發展、建設美麗中國貢獻力量。

### 財務回顧

回顧年內，本集團實現總收入人民幣2.515億元，較二零二三年錄得的人民幣2.203億元增長14.1%，主要由於本集團大力開拓業務，以及環保和低碳解決方案的需求持續增長所致。毛利增長27.4%至人民幣3,620萬元(二零二三年：人民幣2,840萬元)，毛利率提高至14.4%(二零二三年：12.9%)，得益於加強項目組合管理，效率提升。

於截至二零二四年十二月三十一日止年度，本集團錄得本公司擁有人應佔溢利人民幣1,720萬元，而截至二零二三年十二月三十一日止年度淨收益為人民幣150萬元。每股基本及攤薄盈利為人民幣1.76分(二零二三年：每股基本盈利為人民幣0.17分)。

# Management Discussion and Analysis

## 管理層討論與分析

### INDUSTRY REVIEW

In 2024, China's environmental protection engineering industry achieved steady and healthy development against the backdrop of the ongoing "Dual Carbon" strategy and the deepening of ecological civilization construction, overcoming adverse factors such as increasing global economic downward pressure. With increasing national emphasis on environmental protection and growing public awareness, the demand for environmental protection engineering continued to grow steadily, expanding the industry's scale.

### FINAL DIVIDEND

The Board does not recommend the payment of a final dividend for the year ended 31 December 2024 (2023: Nil).

### BUSINESS REVIEW

The Group is principally engaged in the development, manufacture and sale of EP products and equipment, and the provision of EP construction engineering solutions and services. In 2024, the sale of EP products and equipment contributed revenue of RMB251.5 million (2023: RMB220.3 million), accounting for 100% (2023: 100%) of the Group's total revenue. The Group completed five water treatment projects and one flue gas treatment projects.

As at 31 December 2024, the Group had 4 projects on hand with an aggregate value of work to be completed of approximately RMB113.2 million (tax inclusive). The Group expects the above projects on hand to be completed by the end of 2025.

In addition, there was a change in the management of the Group during the year as Mr. Guo Jiannan resigned as Chief Executive Officer. Mr. Zhu Duke Li was appointed as an Executive Director and Chief Executive Officer on 12 April 2024.

### 行業回顧

二零二四年，中國環保工程行業在「雙碳」戰略持續推進、生態文明建設持續深化的背景下，克服了全球經濟下行壓力加大等不利因素影響，實現了平穩健康發展。隨著國家對環保重視程度的不斷提高，以及公眾環保意識的增強，環保工程市場需求穩步增長，行業規模持續擴大。

### 末期股息

董事會不建議派付截至二零二四年十二月三十一日止年度的末期股息（二零二三年：無）。

### 業務回顧

本集團主要從事環保產品及設備的開發、製造及銷售，以及提供環保建設工程解決方案及服務。於二零二四年，環保產品及設備的銷售貢獻收入為人民幣2.515億元（二零二三年：人民幣2.203億元），佔本集團總收入的100%（二零二三年：100%）。本集團完成了5個水處理項目及1個煙氣處理項目。

於二零二四年十二月三十一日，本集團手頭上有4個項目，尚待完成工程總值約人民幣1.132億元（含稅）。本集團預期將於二零二五年底前完成上述手頭項目。

此外，年內，本集團管理層有所變動，郭建南先生辭任行政總裁。Zhu Duke Li先生於二零二四年四月十二日獲委任為執行董事兼行政總裁。

### LIQUIDITY AND FINANCIAL RESOURCES

As at 31 December 2024, the Group's total assets amounted to RMB1,315.9 million, an increase of RMB23.2 million compared with RMB1,292.7 million in 2023. The Group's total liabilities as at 31 December 2024 amounted to RMB151.0 million, an decrease of RMB4.2 million compared with RMB155.2 million in 2023. The Group's total equity as at 31 December 2024 was RMB1,164.9 million (2023: RMB1,137.5 million), and the gearing ratio, calculated on the basis of total borrowings (including corporate bonds and amount due to a related party) to equity (including all capital and reserves), was 6.4% (2023: 8.3%). The Group's cash and cash equivalents amounted to RMB1,256.9 million as at 31 December 2024 (2023: RMB1,235.8 million).

### EXPOSURE TO FLUCTUATIONS IN FOREIGN EXCHANGE RATES

The majority of the Group's business transactions and liabilities are denominated in Renminbi and Hong Kong dollars. The Group has adopted a conservative financial policy, and the majority of its bank deposits are in Renminbi and Hong Kong dollars. As at 31 December 2024, the Group did not have any foreign currency bank liabilities, foreign exchange contracts, interest or currency swaps or other financial derivatives for hedging purposes. Nevertheless, the management continues to monitor the Group's foreign exchange exposure and will take prudent measures as and when appropriate. As at 31 December 2024, the Group did not hold any derivatives for hedging against interest rate or foreign exchange risks.

### 流動資金及財務狀況

於二零二四年十二月三十一日，本集團的資產總值為人民幣13.159億元，較二零二三年人民幣12.927億元增加人民幣2,320萬元。本集團於二零二四年十二月三十一日的負債總值為人民幣1.510億元，較二零二三年的人民幣1.552億元減少人民幣420萬元。本集團於二零二四年十二月三十一日的權益總額為人民幣11.649億元(二零二三年：人民幣11.375億元)，以借貸總額(包括公司債券及應付一名關聯人士款項)除以權益(包括所有資本及儲備)計算的權益負債比率為6.4%(二零二三年：8.3%)。於二零二四年十二月三十一日，本集團的現金及等同現金項目為人民幣12.569億元(二零二三年：人民幣12.358億元)。

### 承受匯率波動風險

本集團絕大多數營業交易與負債均以人民幣及港元計值。本集團奉行保守的財務政策，大部分銀行存款為人民幣及港元。於二零二四年十二月三十一日，本集團無任何外幣銀行負債、外匯合同、利息或貨幣掉期或其他對沖用途之金融衍生工具。然而，管理層將繼續監察本集團之外匯風險，並在適當時採取審慎措施。於二零二四年十二月三十一日，本集團並無持有對沖利率及外匯風險的任何衍生工具。

### CAPITAL COMMITMENTS AND CONTINGENT LIABILITIES

As at 31 December 2024, the Group did not have any capital expenditure commitments for the acquisition of property, plant and equipment (2023: Nil). The Group has issued product warranties to its customers for certain of its EP products and equipment sold for a warranty period ranging from six months to two years after installation. At the same time, the Group has also received product warranties for such EP products and equipment supplied from its suppliers. The Directors believe that the amount of crystalized warranty liabilities will not be significant at the end of the reporting period.

### PLEDGE OF ASSETS

There was no pledge of assets by the Group as at 31 December 2024.

### RELATIONSHIP WITH EMPLOYEES AND KEY STAKEHOLDERS

As at 31 December 2024, the Group had approximately 89 employees. Employee salaries are maintained at competitive levels and are reviewed annually, with close reference to the relevant labor markets and economic situations. Directors' remuneration is determined based on a variety of factors such as market conditions and the specific responsibilities shouldered by the individual directors. In addition to providing the basic remuneration and statutory benefits as required by the law, the Group provides discretionary bonuses based on its results and the performance of the individual employee. The Group also has an employee share option scheme in operation. Total remuneration costs, including Directors' remuneration, for the year ended 31 December 2024 was RMB14.6 million (2023: RMB12.9 million). During the year under review, the Group organized professional and vocational training for its employees. The Directors believe that the Group has an admirable relationship with its employees.

### 資本承擔及或然負債

於二零二四年十二月三十一日，本集團概無任何就採購物業、廠房及設備之資本開支承擔(二零二三年：無)。本集團就其售出之若干環保產品及設備為其客戶提供產品保修服務，保修期由安裝後計六個月至兩年不等。同時，本集團亦享有其供應商就所提供之環保產品及設備之產品保修服務。董事相信，於報告期末，保修負債實際金額並不重大。

### 資產抵押

於二零二四年十二月三十一日，本集團概無資產抵押。

### 與僱員及主要持份者的關係

於二零二四年十二月三十一日，本集團僱用約89名僱員。僱員之薪酬維持在一個具競爭力之水平，並參考相關人力市場及經濟情況，每年進行檢討。董事之酬金乃根據一系列因素而釐定，包括市場狀況及每位董事之職責。除法律規定之基本薪酬及法定福利外，本集團亦根據本身之業績及個別員工之表現，酌情發放花紅。本集團亦已採納僱員購股權計劃。截至二零二四年十二月三十一日止年度，薪酬成本總額(包括董事酬金)為人民幣1,460萬元(二零二三年：人民幣1,290萬元)。回顧年內，本集團為其員工舉辦專業及職業培訓。董事相信本集團與僱員關係良好。

The Board of Directors of the Company (the “Board”) is pleased to present the Corporate Governance Report in the Group’s annual report for the year ended 31 December 2024.

### CORPORATE GOVERNANCE CULTURE AND STRATEGY

The Company is committed to ensuring that its affairs are conducted in accordance with high ethical standards. This reflects its belief that, in the achievement of its long-term objectives, it is imperative to act with probity, transparency and accountability. By so acting, the Company believes that Shareholder wealth will be maximised in the long term and that its employees, those with whom it does business and the communities in which it operates will all benefit.

Corporate governance is the process by which the Board instructs management of the Group to conduct its affairs with a view to ensuring that its objectives are met. The Board is committed to maintaining and developing robust corporate governance practices that are intended to ensure:

- satisfactory and sustainable returns to Shareholders;
- that the interests of those who deal with the Company are safeguarded;
- that overall business risk is understood and managed appropriately;
- the delivery of high-quality products and services to the satisfaction of customers; and
- that high standards of ethics are maintained.

### 企業管治文化及策略

本公司致力確保以崇高的道德標準營運業務，反映本公司堅信如要達到長遠的目標，必須以誠信、透明和負責的態度行事。本公司相信這樣做長遠可為股東取得最大的回報，而其僱員、業務夥伴及本公司經營所在社區亦可受惠。

企業管治是董事會指導本集團管理層營運業務以達到業務目標的過程。董事會致力維持及建立完善的企業管治常規，以確保：

- 保障與本公司有業務往來者的利益；
- 理解並適當地管理整體業務風險；
- 提供令客戶滿意的優質產品與服務；及

### CORPORATE GOVERNANCE PRACTICES

The Board was committed to achieving high corporate governance standards.

The Board believes that high corporate governance standards are essential in providing a framework for the Group to safeguard the interests of shareholders (the “Shareholders”), enhance corporate value, formulate its business strategies and policies, and enhance its transparency and accountability.

The Company’s corporate governance practices are based on the principles and code provisions as set out in the Corporate Governance Code (the “CG Code”) contained in Appendix C1 to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) (the “Listing Rules”).

The Company has in place a corporate governance framework and has established a set of policies and procedures based on the CG Code contained in Appendix C1 to the Listing Rules. Such policies and procedures provide the infrastructure for enhancing the Board’s ability to implement governance and exercise proper oversight on business conduct and affairs of the Company.

In the opinion of the Directors, throughout the year ended 31 December 2024 the Company has complied with all applicable code provisions of the CG Code, except for CG Code provisions C.2.1, C.5.1 and D.2.5, which provides that the roles of Chairman and Chief Executive Officer should be separate and should not be performed by the same individual, regular Board meetings should be held at least four times a year, and the Group should have an internal audit function, details of which are set out in the sections headed “Attendance Records of Directors”, “Board of Directors”, “Board Meetings” “Communication with Shareholders and Investors” and “Risk Management and Internal Control” of this Corporate Governance Report.

### 企業管治常規

董事會致力於達致高水平的企業管治。

董事會認為，高水平的企業管治對於為本集團提供保障股東（「股東」）權益、提升其企業價值、制定其業務策略和政策以及提高其透明度及問責性的框架而言至關重要。

本公司的企業管治常規乃根據香港聯合交易所有限公司（「聯交所」）證券上市規則（「上市規則」）附錄C1所載的企業管治守則（「企業管治守則」）所載列的原則及守則條文編製。

本公司已基於上市規則附錄C1所載的企業管治守則設立企業管治框架及一套政策及程序。該等政策及程序作為基礎，提升董事會執行管治及妥為監督本公司的業務活動及事務的能力。

董事認為，於截至二零二四年十二月三十一日止整個年度內，本公司一直遵守企業管治守則的所有適用守則條文，惟守則條文第C.2.1條、第C.5.1條及第D.2.5條除外（該等條文訂明，主席及行政總裁角色應予區分，不應由同一人擔任，每年應舉行至少四次常規董事會會議，以及本集團應設有內部審核功能），有關詳情載於本企業管治報告「董事出席記錄」、「董事會」、「董事會會議」、「與股東及投資者的溝通」及「風險管理及內部監控」等節內。

### DIRECTORS' SECURITIES TRANSACTIONS

The Company has adopted its own code of conduct regarding Directors' dealings in the Company's securities (the "Company's Securities Dealing Code") on terms no less exacting than the Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") as set out in Appendix C3 to the Listing Rules.

Specific enquiry has been made of all the Directors and the Directors have confirmed that they have complied with the Company's Securities Dealing Code throughout the year ended 31 December 2024.

The Company's Securities Dealing Code, no less exacting than the Model Code, for securities transactions also applies to all employees who, because of such office or employment, are likely to possess inside information in relation to the Company or its securities. No incident of non-compliance of the Company's Securities Dealing Code by the employees was noted by the Company.

### BOARD OF DIRECTORS

The Company is headed by an effective Board which assumes responsibility for its leadership and control and be collectively responsible for promoting the Company's success by directing and supervising the Company's affairs. Directors takes decisions objectively in the best interests of the Company.

The Board has a balance of skills, experience and diversity of perspectives appropriate to the requirements of the Company's business and regularly review the contribution required from a Director to perform his responsibilities to the Company, and whether the Director is spending sufficient time performing them that are commensurate with their role and the Board responsibilities. The Board includes a balanced composition of Executive Director and Non-executive Directors (including Independent Non-executive Directors) so that there is a strong independent element on the Board, which can effectively exercise independent judgement.

### Chairman and Chief Executive Officer

Pursuant to code provision C.2.1 of the CG Code as set out in Appendix C1 to the Listing Rules, companies listed on the Stock Exchange are expected to comply with, but may choose to deviate from the requirement that the responsibilities between the Chairman and the Chief Executive Officer should be segregated and should not be performed by the same individual. Mr. Guo Jiannan, an Executive Director of the Company, has been appointed as the Chairman of the Board with effect from 27 November 2023. Upon appointment of Mr. Guo as Chairman, he assumes both the roles as the Chairman and the Chief Executive Officer of the Company in deviation from the aforesaid code provision. The Board believes that vesting the roles of both Chairman and Chief Executive Officer in the same person has the benefit of ensuring consistent leadership within the Group and enables more effective and efficient overall strategic planning for the Group. The Board considers that the balance of power and authority for the present arrangement will not be impaired and this structure will enable the Company to make and implement decisions promptly and effectively.

On 12 April 2024, Mr. Guo Jiannan resigned as Chief Executive Officer and the Company appointed Mr. Zhu Duke Li as Chief Executive Officer of the Company, upon the change of the Chief Executive Officer, the Company comply with code provision C.2.1 of the CG Code.

### Independent Non-executive Directors

During the year ended 31 December 2024, the Board at all times met the requirements of the Listing Rules relating to the appointment of at least three Independent Non-executive Directors representing at least one-third of the Board. The chairman of the Audit Committee is Mr. Leung Shu Sun, Sunny, who possesses the appropriate professional qualification, and accounting and financial management expertise as required under Rule 3.10(2) of the Listing Rules.

The Company has received written annual confirmation from each of the Independent Non-executive Directors in respect of his independence in accordance with the independence guidelines set out in Rule 3.13 of the Listing Rules. The Company is of the view that all Independent Non-executive Directors are independent.

During the year ended 31 December 2024, the Board reviewed the implementation and effectiveness of the Board Independence Evaluation Mechanism and the results were satisfactory.

### Appointment and Re-election of Directors

Each of the Independent Non-executive Directors of the Company is appointed under a letter of appointment which is terminable by either party with 3 months' notice in writing served on the other side.

Under the Articles of Association of the Company, at each annual general meeting, one-third of the Directors for the time being, or if their number is not three or a multiple of three, the number nearest to but not less than one-third shall retire from office by rotation provided that every Director, including those appointed for a specific term, shall be subject to retirement by rotation at least once every three years. The Company's Articles of Association also provides that all Directors appointed to fill a casual vacancy or as addition Director shall hold office only until the first general meeting of the Company after his appointment and shall then be eligible for re-election at the meeting but shall not be taken into account in determining the Directors or the number of Directors who are to retire by rotation at such meeting.

### Responsibilities, Accountabilities and Contributions of the Board and Management

The Board should assume responsibility for leadership and control of the Company, and is collectively responsible for directing and supervising the Company's affairs.

The Board directly, and indirectly through its committees, leads and provides direction to management by laying down strategies and overseeing their implementation, monitors the Group's operational and financial performance, and ensures that sound internal control and risk management systems are in place.

All Directors, including Independent Non-executive Directors, have brought a wide spectrum of valuable business experience, knowledge and professionalism to the Board for its efficient and effective functioning.

### 委任及重選董事

The Independent Non-executive Directors are responsible for ensuring a high standard of regulatory reporting of the Company and providing a balance in the Board for bringing effective independent judgement on corporate actions and operations.

All Directors have full and timely access to all the information of the Company and may, upon request, seek independent professional advice in appropriate circumstances, at the Company's expenses for discharging their duties to the Company.

The Directors shall disclose to the Company details of other offices held by them and the Board regularly reviews the contribution required from each Director to perform his responsibility to the Company.

The Board reserves for its decision all major matters relating to policy matters, strategies and budgets, internal control and risk management, material transactions (in particular those that may involve conflict of interests), financial information, appointment of Directors and other significant operational matters of the Company. Responsibilities relating to implementing decisions of the Board, directing and co-ordinating the daily operation and management of the Company are delegated to the management.

The Company has arranged appropriate insurance coverage on Directors' and officers' liabilities in respect of any legal actions taken against Directors and senior management arising out of corporate activities. The insurance coverage would be reviewed on an annual basis.

During the year ended 31 December 2024, the Audit Committee held two meetings to review the annual financial results and reports in respect of the year ended 31 December 2023 and the interim financial results and reports for the period ended 30 June 2024 and significant issues on the financial reporting, operational and compliance controls, the effectiveness of the risk management and internal control systems and internal audit function, appointment of external auditor, engagement of non-audit services and relevant scope of works, amendments of the terms of reference in light of the amendments to the Corporate Governance Code and arrangements for employees to raise concerns about possible improprieties.

The Audit Committee also met the external auditor twice without the presence of the Executive Directors.

The Company's remuneration policy is to ensure that the remuneration offered to employees, including Directors and senior management, is based on skill, knowledge, responsibilities and involvement in the Company's affairs. The remuneration package of Executive Director is also determined with reference to the Company's performance and profitability, the prevailing market conditions and the performance or contribution of the Executive Director. The remuneration for the Executive Director comprises basic salary, pensions and discretionary bonus. Executive Director shall receive options to be granted under the Company's share option scheme. The remuneration policy for Independent Non-executive Directors is to ensure that Independent Non-executive Directors are adequately compensated for their efforts and time dedicated to the Company's affairs, including their participation in Board committees. The remuneration for the Non-Executive Director and Independent Non-executive Directors mainly comprises Director's fee which is determined with reference to their duties and responsibilities by the Board. Independent Non-executive Directors shall not receive options to be granted under the Company's share option scheme. Individual Directors and senior management have not been involved in deciding their own remuneration.

### Nomination Committee

The Nomination Committee consists of four members, including one Executive Director, namely Mr. Guo Jiannan, and three Independent Non-executive Directors, namely Mr. Chen Xuezheng, Mr. Hu Jianjun and Mr. Leung Shu Sun, Sunny. Mr. Chen Xuezheng is the chairman of the Nomination Committee.

本公司的薪酬政策旨在確保向僱員(包括董事及高級管理層)提供的薪酬乃基於技能、知識、責任及參與本公司事務。執行董事的薪酬待遇亦經參考本公司的表現及盈利能力、現行市況以及執行董事的表現或貢獻後釐定。執行董事的薪酬包括基本薪金、退休金及酌情花紅。執行董事將收取根據本公司購股權計劃授出的購股權。獨立非執行董事的薪酬政策旨在確保獨立非執行董事在本公司事務上所付出的努力及時間(包括彼等參與董事委員會)獲得充分補償。獨立非執行董事的薪酬主要包括董事袍金,其乃經董事會參考彼等的職務及職責後釐定。獨立非執行董事不得收取根據本公司購股權計劃授出的購股權。個別董事及高級管理層並未參與決定其自身薪酬。

### 提名委員會

提名委員會由四名成員組成,包括一名執行董事,即郭建南先生,及三名獨立非執行董事,即陳學政先生、胡建軍先生及梁樹新先生。陳學政先生為提名委員會主席。

提名委員會的職權範圍不限於企業管治守則所載條款。

提名委員會主要負責檢討董事會組成,發展及制訂提名及委任董事的有關程序,就董事的委任及繼任計劃向董事會提供推薦意見,審閱董事會成員多元化政策及董事提名政策,以及評估獨立非執行董事的獨立性。

In assessing the Board composition, the Nomination Committee would take into account various aspects as well as factors concerning Board diversity as set out in the Company's Board Diversity Policy. The Nomination Committee would discuss and agree on measurable objectives for achieving diversity on the Board, where necessary, and recommend them to the Board for adoption.

In identifying and selecting suitable candidates for directorships, the Nomination Committee would consider the candidate's relevant criteria as set out in the Director Nomination Policy that are necessary to complement the corporate strategy and achieve Board diversity, where appropriate, before making recommendation to the Board.

During the year ended 31 December 2024, the Nomination Committee held one meeting to review the structure, size and composition of the Board and the independence of the Independent Non-executive Directors, to consider the qualifications of the retiring Directors standing for re-election at the annual general meeting, to review the Board Diversity Policy and Director Nomination Policy. The Nomination Committee considered an appropriate balance of diversity perspectives of the Board is maintained.

### Board Diversity Policy

The Company has adopted a Board Diversity Policy which sets out the approach to achieve diversity of the Board. The Company recognizes and embraces the benefits of having a diverse Board and sees increasing diversity at the Board level as an essential element in maintaining the Company's competitive advantage.

Pursuant to the Board Diversity Policy, the Nomination Committee will review regularly the structure, size and composition of the Board and where appropriate, make recommendations on changes to the Board to complement the Company's corporate strategy and to ensure that the Board maintains a balanced diverse profile. In relation to reviewing and assessing the Board composition and the nomination of Directors, the Nomination Committee is committed to diversity at all levels and will consider a number of aspects, including but not limited to gender, age, cultural and educational background, professional qualifications, skills, knowledge and regional and industry experience.

於評估董事會組成時，提名委員會將考慮本公司董事會成員多元化政策所載董事會多元化的若干方面以及因素。提名委員會將討論及協定達致董事會多元化的可計量目標(倘必要)並向董事會推薦以供採納。

在物色及甄選合適的董事候選人時，提名委員會在向董事會提出推薦意見前，會考慮董事提名政策所載之候選人相關標準就補充公司策略及達致董事會成員多元化而言屬必要(倘適用)。

截至二零二四年十二月三十一日止年度，提名委員會舉行了一次會議，檢討董事會的架構、規模及組成，以及獨立非執行董事的獨立性，以考慮擬於股東周年大會上重選的退任董事的資格，以審閱董事會成員多元化政策及董事提名政策。提名委員會認為，董事會組成在多元化方面維持適當平衡。

### 董事會成員多元化政策

本公司已採納董事會成員多元化政策，其中載列達成董事會多元化的方法。本公司意識到並接納多元化董事會的好處，並認為董事會層面日益多元化乃是維持本公司競爭優勢不可或缺的因素。

根據董事會成員多元化政策，提名委員會將定期檢討董事會的架構、規模及組成，並就任何為配合本公司的公司策略而對董事會作出的變動提出建議(倘適用)，以確保董事會維持均衡的多元化形象。在檢討及評估董事會組成及董事提名方面，提名委員會致力於各層面的多元化，並會考慮多個方面，包括但不限於性別、年齡、文化及教育背景、專業資格、技能，知識以及區域及行業經驗。

The Company aims to maintain an appropriate balance of diversity perspectives that are relevant to the Company's business growth and is also committed to ensuring that recruitment and selection practices at all levels (from the Board downwards) are appropriately structured so that a diverse range of candidates are considered.

The Board will consider setting measurable objectives to implement the Board Diversity Policy and review such objectives from time to time to ensure their appropriateness and ascertain the progress made towards achieving those objectives.

For the purpose of implementation of the Board Diversity Policy, the following measurable objectives were adopted:

- (A) at least one of members of the Board shall be female;
- (B) at least 40% of the members of the Board shall be non-executive Directors or independent non-executive Directors;
- (C) at least one-third of the members of the Board shall be independent non-executive Directors;
- (D) at least one of the members of the Board shall have obtained accounting or other professional qualifications;
- (E) at least 15% of the members of the Board shall have more than 3 years of experience in the industry he/she is specialised in;
- (F) at least one of the members of the Board shall have China-related work experience.

The Nomination Committee and the Board are of the view that the current composition of the Board has achieved the objectives set in the Board Diversity Policy.

The nomination process set out in the Director Nomination Policy is as follows:

### Appointment of New Director

- (i) The Nomination Committee and/or the Board should, upon receipt of the proposal on appointment of new Director and the biographical information (or relevant details) of the candidate, evaluate such candidate based on the criteria as set out above to determine whether such candidate is qualified for directorship.
- (ii) If the process yields one or more desirable candidates, the Nomination Committee and/or the Board should rank them by order of preference based on the needs of the Company and reference check of each candidate (where applicable).
- (iii) The Nomination Committee should then recommend to the Board to appoint the appropriate candidate for directorship, as applicable.
- (iv) For any person that is nominated by a Shareholder for election as a Director at the general meeting of the Company, the Nomination Committee and/or the Board should evaluate such candidate based on the criteria as set out above to determine whether such candidate is qualified for directorship.
- (v) Where appropriate, the Nomination Committee and/or the Board should make recommendation to Shareholders in respect of the proposed election of Director at the general meeting.

### Re-election of Director at General Meeting

- (i) The Nomination Committee and/or the Board should review the overall contribution and service to the Company of the retiring Director and the level of participation and performance on the Board.
- (ii) The Nomination Committee and/or the Board should also review and determine whether the retiring Director continues to meet the criteria as set out above.

The Director Nomination Policy sets out the criteria for assessing the suitability and the potential contribution to the Board of a proposed candidate, including but not limited to the following:

- Character and integrity;
- Qualifications including professional qualifications, skills, knowledge and experience that are relevant to the Company's business and corporate strategy;
- Diversity in all aspects, including but not limited to gender, age (18 years or above), cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service;
- Requirements of Independent Non-executive Directors on the Board and independence of the proposed Independent Non-executive Directors in accordance with the Listing Rules; and
- Commitment in respect of available time and relevant interest to discharge duties as a member of the Board and/or Board committee(s) of the Company.

During the year ended 31 December 2024, there was no change in the composition of the Board.

The Nomination Committee will review the Director Nomination Policy, as appropriate, to ensure its effectiveness.

The Board is responsible for performing the functions set out in the code provision A.2.1 of the CG Code.

During the year ended 31 December 2024, the Board had reviewed the Company's corporate governance policies and practices, training and continuous professional development of Directors and senior management, the Company's policies and practices on compliance with legal and regulatory requirements, the compliance of the Company's Securities Dealing Code and the Model Code, and the Company's compliance with the CG Code and disclosure in the Corporate Governance Report.

### BOARD MEETINGS

Regular Board meetings should be held at least four times a year involving active participation, either in person or through electronic means of communication, of a majority of Directors. During the year ended 31 December 2024, the Board held eight meetings with active participation of majority directors, either in person or through electronic means of communication. The Company does not announce its quarterly results and hence not consider the holding of quarterly meetings as necessary.

### RISK MANAGEMENT AND INTERNAL CONTROLS

The Board acknowledges its responsibility for the risk management and internal control systems and reviewing their effectiveness. Such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

The Board has the overall responsibility for evaluating and determining the nature and extent of the risks it is willing to take in achieving the Company's strategic objectives, and establishing and maintaining appropriate and effective risk management and internal control systems.

The Audit Committee assists the Board in leading the management and overseeing their design, implementation and monitoring of the risk management and internal control systems.

The Company has developed and adopted various risk management procedures and guidelines with defined authority for implementation by key business processes and office functions, including project management, sales and leasing, financial reporting, human resources and information technology.

An on-going process has been established for identifying, evaluating and managing the significant risks faced by the Group. The process involves:

- (i) Risk Identification: identify risks that may potentially affect the Group's businesses and operations;
- (ii) Risk Evaluation: consider the impact on the business and the likelihood of their occurrence; and
- (iii) Risk Management: perform on-going and periodic monitoring of the risks and ensure that appropriate internal control processes are in place.

每年應舉行至少四次常規董事會會議，且大多數董事須積極參與（無論親身或通過電子通訊方式）。於截至二零二四年十二月三十一日止年度，董事會舉行八次會議，且大多數董事積極參與（無論親身或通過電子通訊方式）。本公司不公佈其季度業績，故不認為舉行季度會議為必要。

### 風險管理及內部監控

董事會確認知悉其負責風險管理及內部監控系統並檢討其成效之責任。該等系統旨在管理而非消除未能達成業務目標的風險，而且只能就不會有重大的失實陳述或損失作出合理而非絕對的保證。

董事會全面負責評估及釐定本公司達成策略目標時所願意接納的風險性質及程度，並設立和維持合適而有效的風險管理及內部監控系統。

審核委員會協助董事會開展管理工作並監督董事會設計、實施及監管風險管理及內部監控系統。

本公司已制定及採納多項風險管理程序及指引，並通過明晰關鍵業務流程及部門職能（包括項目管理、銷售及租賃、財務匯報、人力資源及信息技術）訂明操作權責。

本集團已建立可持續識別、評估及管理其面對的重大風險之程序。該程序包括：

- (i) 風險識別：識別可能潛在影響本集團業務及營運的風險；
- (ii) 風險評估：考慮風險對業務的影響及其發生的可能性；及
- (iii) 風險管理：持續及定期監控風險，並確保設有適當的內部控制程序。

All divisions conducted internal control assessment regularly to identify risks that potentially impact the business of the Group and various aspects including key operational and financial processes, regulatory compliance and information security. Self-evaluation has been conducted annually to confirm that control policies are properly complied with by each division.

The management, in co-ordination with division heads, assessed the likelihood of risk occurrence, provide treatment plans, and monitor the risk management progress, and reported to the Audit Committee and the Board on all findings and the effectiveness of the systems.

The management has reported to the Board and the Audit Committee on the effectiveness of the risk management and internal control systems for the year ended 31 December 2024.

Under Code Provision D.2.5 of the CG Code, the Group should have an internal audit function. During the year, the Group conducted a review on the need for setting up an internal audit department. Given the Group's simple operating structure and the potential cost burden, it was decided that the Group would not set up an internal audit department for the time being and the Board would be directly responsible for risk management and internal control systems of the Group.

The Company has engaged external professional firm for providing the internal audit function and performing independent review of the adequacy and effectiveness of the risk management and internal control systems. The internal audit function examined key issues in relation to the accounting practices and all material controls and provided its findings and recommendations for improvement to the Audit Committee.

The Board, as supported by the Audit Committee as well as the management report and the internal audit findings, conducted an annual review of the risk management and internal control systems, including the financial, operational and compliance controls, for the year ended 31 December 2024, and considered that such systems are effective and adequate. The annual review also covered the financial reporting and internal audit function and staff qualifications, experiences and relevant resources.

各部門均定期進行內部監控評測，以識別可能影響本集團業務及包括主要營運及財務流程、監管合規及信息安全在內多個方面的潛在風險。各部門亦每年進行自我評估，以確保妥當遵守控制政策。

管理層與各部門領導相互配合，評估發生風險事件的可能性並提供應對計劃及監控風險管理程序，並就一切有關結果及該系統的效能向審核委員會及董事會作出報告。

管理層已就風險管理及內部監控系統於截至二零二四年十二月三十一日止年度之成效向董事會及審核委員會作出報告。

根據企業管治守則的守則條文第D.2.5條，本集團應設有內部審核職能。年內，本集團就設立內部審核部門的需要進行檢討。考慮到本集團營運架構精簡及潛在的成本負擔，本集團決定暫時不會設立內部審核部門，而董事會將直接負責本集團的風險管理及內部監控系統。

本公司已委聘外部專業公司提供內部審核功能並就風險管理及內部監控系統是否足夠及其成效進行獨立審核。內部審核功能已就有關會計常規及所有重大控制審核重大問題，及向審核委員會提供其審核結果及改進推薦意見。

董事會參考管理層報告以及內部審核結果，在審核委員會的協助下就截至二零二四年十二月三十一日止年度之風險管理及內部監控系統（包括財務、營運及合規控制）作出年度審核，並認為此等系統有效及足夠。年度審核亦已涵蓋財務申報及內部審核功能以及員工資歷、經驗及相關資源。

Arrangements are in place to facilitate employees of the Company to raise, in confidence, concerns about possible improprieties in financial reporting, internal control or other matters of the Company.

The Company has in place the Whistleblowing Policy for employees of the Company and those who deal with the Company to raise concerns, in confidence and anonymity, with the Audit Committee about possible improprieties in any matters related to the Company.

The Company has also in place the Anti-Corruption Policy to safeguard against corruption and bribery within the Company. The Company has an internal reporting channel that is open and available for employees of the Company to report any suspected corruption and bribery. Employees can also make anonymous reports to the internal audit function, which is responsible for investigating the reported incidents and taking appropriate measures. The Company continues to carry out anti-corruption and anti-bribery activities to cultivate a culture of integrity, and actively organizes anti-corruption training and inspections to ensure the effectiveness of anti-corruption and anti-bribery.

During the year ended 31 December 2024, the Company held anti-corruption training regularly and briefing to all employees. There were no non-compliance cases in relation to bribery and corruption.

The Company has developed its disclosure policy which provides a general guide to the Company's Directors, officers, senior management and relevant employees in handling confidential information, monitoring information disclosure and responding to enquiries.

Control procedures have been implemented to ensure that unauthorized access and use of inside information are strictly prohibited.

In addition, the Group has formulated risk management plan to ensure the identification, assessment, management, control and reporting of all significant risks of the Group are carried out according to a unified guideline, and are reported to the senior management, the Audit Committee and the Board when necessary. Such guideline stipulates the Group's risk management policies and procedures which are carried out with the common risk management methods.

According to the Code Provision D.2.1, the Board should review the effectiveness of the issuer's risk management and internal control systems has been conducted at least annually and report to shareholders that it has done so in its Corporate Governance Report.

The Board has reviewed the internal control and risk management systems during the year, including the Company's resources in accounting and financial reporting functions, staff qualifications and experience, as well as the adequacy of training courses and budget. Save as disclosed below, the Board believes that the Company's internal control and risk management systems are effective and adequate. The Board confirms that the Group has complied with the Code Provisions on risk management and internal control as set out in the CG Code throughout the year ended 31 December 2024.

### DIRECTORS' RESPONSIBILITY IN RESPECT OF THE FINANCIAL STATEMENTS

The Directors acknowledge their responsibility for preparing the financial statements with the support of the accounting and finance team.

The Directors have prepared the financial statements in accordance with the Hong Kong Financial Reporting Standards issued by the Hong Kong Institute of Certified Public Accountants. Appropriate accounting policies have also been used and applied consistently except the adoption of revised standards, amendments to standards and interpretation.

The Directors are not aware of any material uncertainties relating to events or conditions that may cast significant doubt upon the Company's ability to continue as a going concern.

The statement of the external auditor of the Company (the "Auditor") about their reporting responsibilities on the financial statements is set out in the Independent Auditor's Report of this Annual Report.

### THE BOARD'S VIEWS ON THE QUALIFIED OPINION

In respect of the qualified opinion made by the Auditor on pages 58 to 66 of this report, the Board has the following views:

The Auditor requested the Company to provide the information and supporting documents of Turing AI Technologies Group USA LLC ("Turing AI") for the period from 5 March 2024 (the date of incorporation) to 31 December 2024 as set out in the note 25 to the consolidated financial statements. As the Group disposed of 51% equity interest in Turing AI (the "Disposal") and ceased its control of Turing AI upon completion of the Disposal on 31 December 2024 (the "Disposal Date"), the Company was unable to provide all the books and records of Turing AI, including but not limited to the management accounts, ledgers and sub-ledgers accounts, vouchers, bank statements, agreements and other documentations, which were transferred to the purchaser of the 51% equity interest in Turing AI ("Purchaser"). Despite the continuous effort and repeated requests made by the management of the Group to the Purchaser, the Auditor was unable to access to the relevant books and records of Turing AI after completion of the Disposal.

董事並不知悉有關可能會令本公司按持續基準經營的能力備受質疑的事件或狀況的任何重大不確定因素。

本公司外聘核數師(「核數師」)有關其對財務報表的申報責任的聲明載於本年報獨立核數師報告內。

### 董事會有關保留意見之看法

就核數師於本報告第58至66頁提出的保留意見，董事會有以下看法：

如綜合財務報表附註25所載，核數師要求本公司提供Turing AI Technologies Group USA LLC(「Turing AI」)自二零二四年三月五日(註冊成立日期)至二零二四年十二月三十一日期間的資料及證明文件。由於本集團出售Turing AI的51%股本權益(「出售事項」)，並於出售事項於二零二四年十二月三十一日(「出售日期」)完成時終止其對Turing AI之控制，本公司未能提供Turing AI之所有賬冊及記錄，包括但不限於管理賬目、總賬及分類賬賬目、憑證、銀行結單、協議及其他文件，而上述所有文件已轉讓予Turning AI 51%股本權益之買方(「買方」)。儘管本集團管理層不斷努力及多次向買方提出要求，核數師仍未能於出售事項完成後取得Turing AI之有關賬簿及記錄。

Turing AI was a non-wholly owned subsidiary of the Company and was consolidated into the consolidated financial statements of the Group for the year ended 31 December 2024. Consequently, the Auditor was unable to determine whether any adjustments were necessary in respect of (i) the results and cash flows of Turing AI for the period from 1 January 2024 to the Disposal Date which were included in the consolidated statement of profit or loss and other comprehensive income and consolidated statement of cash flows of the Group for the year ended 31 December 2024; (ii) the carrying amounts of the assets and liabilities of Turing AI as at the Disposal Date as disclosed in note 25 to the consolidated financial statements; and (iii) the gain on disposal of Turing AI which was calculated based on the carrying amounts of the assets and liabilities of Turing AI as at the Disposal Date (the "Audit Issue"). Any adjustments that might have been found to be necessary in respect of the above may have consequential effects on the profit and cash flows of the Group and the related disclosures in the consolidated financial statements for the year ended 31 December 2024. The Disposal did not result in any impact on the figures of the Group's the consolidated statement of financial position as at 31 December 2024.

Given that the Disposal did not result in any impact on the figures of the Group's the consolidated statement of financial position as at 31 December 2024, and that the Company does not foresee any impact resulting from the Disposal on the Group's profit or loss figures or the Group's balance sheet figures in the forthcoming financial year(s), the management of the Company is of the view that the Audit Issue has been addressed.

The Audit Committee has the same view as the management of the Company, and considers that the Purchaser's refusal of providing requested information and supporting documents was beyond the control of the management of the Company. Given that the Disposal will not have any impact on the Group's profit or loss figures or the Group's balance sheet figures in the forthcoming financial year(s), the Audit Committee is of the view that the Audit Issue has been addressed. It is confirmed that there is no unresolved Audit Issue in the next financial year.

Turing AI為本公司的非全資附屬公司，並已綜合入賬本集團截至二零二四年十二月三十一日止年度的綜合財務報表。因此，核數師無法執行我們認為必要的審計程序，以令我們信納Turing AI於二零二四年一月一日至出售日期期間的業績、現金流量及所進行其他交易的性質、完整性、準確性、存在及估值，以及附註25中所列Turing AI於出售日期的資產及負債，因此，我們無法釐定有關下列各項的調整是否屬必要：(i)本集團於截至二零二四年十二月三十一日止年度的綜合損益及其他全面收益表及綜合現金流量表中所列Turing AI於二零二四年一月一日至出售日期期間的業績及現金流量；(ii)綜合財務報表附註25所披露Turing AI於出售日期的資產及負債的賬面值；及(iii)出售Turing AI的收益，乃根據Turing AI於出售日期的資產及負債的賬面值計算（「審計事宜」）。就上述事項可能需要作出的調整可能會對本集團截至二零二四年十二月三十一日止年度的溢利及現金流量以及綜合財務報表中的相關披露產生相應影響。出售事項對本集團於二零二四年十二月三十一日的綜合財務狀況表數字並無造成任何影響。

鑑於出售事項並無對本集團於二零二四年十二月三十一日的綜合財務狀況表數字造成任何影響，且本公司預期出售事項不會對本集團下一個財政年度的損益數字或本集團資產負債表數字造成任何影響，本公司管理層認為審計議題已獲解決。

審核委員會與本公司管理層持相同意見，並認為買方拒絕提供所要求的資料及證明文件並非本公司管理層所能控制。鑑於出售事項不會對本集團下一個財政年度的損益數字或本集團的資產負債表數字造成任何影響，審核委員會認為審計議題已獲解決。已確認下一個財政年度並無尚未解決的審計議題。

### Internal Control Measures Taken by the Company in Light of the Audit Modification

According to the Code Provision D.2.4, it requires the Company to disclose how they have complied with the risk management and internal control code provisions, in particular the process used to review the effectiveness of the risk management and internal control systems and to resolve material internal control defects.

As mentioned on page 32 of this Corporate Governance Report, the Auditor was not provided with appropriate audit evidence mainly due to the disposed subsidiary's Purchaser's refusal of providing requested information and supporting documents.

The Company acknowledges deficiency in the Company's internal control system that led to the inability to access to the relevant books and records of Turing AI after the completion of the Disposal.

The Company will adopt the following remedial measures to strengthen the relevant internal control procedures of the Group:

- (1) ensure the obtaining of sufficient documents and information for Auditors' preparation of the financial statements before proceeding to any disposal of its subsidiaries;
- (2) incorporate legal terms in the relevant contracts to extend the counterparty's legal obligation to provide any documents and information requested by the Company after completion of any disposal of its subsidiaries; and
- (3) engage an independent internal control consultant to conduct a review on the internal control procedures of the Company in respect of obtaining materials of disposed subsidiaries for the preparation of audited financial statements and, subject to the result of such review, provide recommendations to enhance the Company's internal control procedures, with a view to ensuring an effective and sufficient internal control system.

本公司將採取以下補救措施，以加強本集團的相關內部監控程序：

- (1) 於出售其任何附屬公司之前，確保取得足夠的文件及資料以供核數師編製財務報表；
- (2) 在相關合約中納入法律條款，以延長交易對手於完成任何出售其附屬公司後提供本公司所要求的任何文件及資料的法律責任；及
- (3) 委聘獨立內部監控顧問就本公司有關取得已出售附屬公司的資料以編製經審核財務報表的內部監控程序進行審閱，並視乎審閱結果就加強本公司的內部監控程序提出建議，以確保內部監控系統有效及充分。

誠如綜合財務報表附註25所披露，貴集團已出售 Turing AI Technologies Group USA LLC(「Turing AI」)51%的股權(「出售事項」)，並於二零二四年十二月三十一日(「出售日期」)完成出售事項後，貴集團已不再控制 Turing AI。所有有關 Turing AI 的賬簿及記錄，包括但不限於管理賬目、總賬、分賬賬項、憑證、銀行結單、協議及其他文件均已轉交至買方。

Despite the continuous effort and repeated requests made by the management of the Group to the purchaser, we were unable to access to the books and records of Turing AI after the completion of the Disposal. As a result, we were unable to carry out audit procedures that we considered necessary to satisfy ourselves as to the nature, completeness, accuracy, existence and valuation of the results, cash flows and other transactions undertaken by Turing AI during the period from 1 January 2024 to the Disposal Date as well as the assets and liabilities of Turing AI as at the Disposal Date as set out in the note 25. Consequently, we were unable to determine whether any adjustments were necessary in respect of (i) the results and cash flows of Turing AI for the period from 1 January 2024 to the Disposal Date which were included in the consolidated statement of profit or loss and other comprehensive income and consolidated statement of cash flows of the Group for the year ended 31 December 2024; (ii) the carrying amounts of the assets and liabilities of Turing AI as at the Disposal Date as disclosed in note 25 to the consolidated financial statements; and (iii) the gain on disposal of Turing AI which was calculated based on the carrying amounts of the assets and liabilities of Turing AI as at the Disposal Date.

Any adjustments that might have been found to be necessary in respect of the above may have consequential effects on the profit and cash flows of the Group and the related disclosures in the consolidated financial statements for the year ended 31 December 2024. The matters which were the subject matters of the scope limitation referred to above do not have impact on the figures presented in the consolidated statement of financial position of the Group as at 31 December 2024, and it shall not have carried forward effect to the consolidated financial statements of the year ending 31 December 2025, except the effect of comparability of the relevant financial information presented as comparative figures.

We conducted our audit in accordance with Hong Kong Standards on Auditing ("HKSAs") issued by the HKICPA. Our responsibilities under those standards are further described in the "Auditor's Responsibilities for the Audit of the Consolidated Financial Statements" section of our report. We are independent of the Group in accordance with the HKICPA's Code of Ethics for Professional Accountants (the "Code"), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified opinion on the consolidated financial statements.

儘管 貴集團管理層向買方不斷作出努力及提出要求，本核數師仍無法於出售事項完成後全面查閱Turing AI的賬簿及記錄。因此，本核數師無法執行信納以下事項被認為必要的審計程序，Turing AI於二零二四年一月一日至出售日期期間的業績、現金流量及所進行其他交易的性質、完整性、準確性、存在及估值，以及附註25中所列Turing AI於出售日期的資產及負債，因此，本核數師無法釐定有關下列各項的調整是否屬必要：(i) 貴集團於截至二零二四年十二月三十一日止年度的綜合損益及其他全面收入表及綜合現金流量表中所列Turing AI於二零二四年一月一日至出售日期期間的業績及現金流量；(ii)綜合財務報表附註25所披露Turing AI於出售日期的資產及負債的賬面值；及(iii)出售Turing AI的收益，乃根據Turing AI於出售日期的資產及負債的賬面值計算。

就上述事項可能作出的調整可能會對 貴集團的溢利及現金流量、截至二零二四年十二月三十一日止年度綜合財務報表中的相關披露產生相應影響。屬上文所提述之範圍限制的主體事項之事宜不再對 貴集團於二零二四年十二月三十一日的綜合財務狀況表中呈列之數字產生影響，且除作為比較數字呈列之相關財務資料的可比較性影響外，其不對截至二零二五年十二月三十一日止年度的綜合財務報表產生結轉影響。

The carrying amount of the Group's trade receivables and contract assets was approximately RMB26,186,000 and RMB26,367,000 as at 31 December 2024, net of impairment losses of approximately RMB2,614,000 and RMB1,809,000. 於二零二四年十二月三十一日，貴集團之應收貿易款項及合同資產賬面值（經扣除減值虧損約人民幣2,614,000元和人民幣1,809,000元）約為人民幣26,186,000元和人民幣26,367,000元。

The assessment of impairment of trade receivables and contract assets under the expected credit loss ("ECL") model requires the application of significant judgement and estimates by management. The ECL on trade receivables and contract assets are assessed individually for debtors which are credit impaired and collectively using a provision matrix. 預期信貸虧損（「預期信貸虧損」）模式下的應收貿易款項及合同資產減值評估須由管理層應用重大判斷及估計。應收貿易款項及合同資產的預期信貸虧損乃就具有信貸減值的債務人個別及運用撥備矩陣集體予以評估。

Management also considered forward-looking information that may impact the customers' ability to repay the outstanding balances in order to estimate the expected credit losses for the impairment assessment.

The directors of the Company are responsible for the preparation of the consolidated financial statements that give a true and fair view in accordance with HKFRSs issued by the HKICPA and the disclosure requirements of the Hong Kong Companies Ordinance, and for such internal control as the directors determine is necessary to enable the preparation of consolidated financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the consolidated financial statements, the directors of the Company are responsible for assessing the Group's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the directors of the Company either intend to liquidate the Group or to cease operations or have no realistic alternative but to do so.

The directors of the Company are assisted by the Audit Committee in discharging their responsibilities for overseeing the Group's financial reporting process.

### 1. GENERAL INFORMATION

Pan Asia Environmental Protection Group Limited (the “Company”) was incorporated as an exempted company and registered in the Cayman Islands with limited liability and its shares are listed on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”). The addresses of the registered office and principal place of business of the Company are disclosed in the “Corporate Information” section to this annual report.

The Company and its subsidiaries (collectively referred to as the “Group”) are principally engaged in the sales of environmental protection (“EP”) products and equipment, and undertaking of EP construction engineering services in the People’s Republic of China (the “PRC”), and investment holding.

### 2. MATERIAL ACCOUNTING POLICIES

#### (a) Statement of compliance

These consolidated financial statements have been prepared in accordance with all applicable individual Hong Kong Financial Reporting Standards (“HKFRSs”), which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards (“HKASs”) and Interpretations issued by the Hong Kong Institute of Certified Public Accountants (“HKICPA”) and the disclosure requirements of the Hong Kong Companies Ordinance (“CO”). These consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on the Stock Exchange of Hong Kong Limited. Material accounting policies adopted by the Group are disclosed below.

The HKICPA has issued certain new and amended HKFRSs that are first effective or available for early adoption for the current accounting period of the Group. Note 3 provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current and prior accounting periods reflected in these consolidated financial statements.

### 1. 一般資料

泛亞環保集團有限公司(「本公司」)於開曼群島註冊成立為一間獲豁免有限公司，其股份於香港聯合交易所有限公司(「聯交所」)上市。本公司之註冊辦事處及主要營業地點地址披露於本年報「公司資料」一節。

本公司及其附屬公司(以下統稱「本集團」)主要從事環境保護(「環保」)產品及設備之銷售、在中華人民共和國(「中國」)承接環保建設工程服務及投資控股。

### 2. 重大會計政策

#### (a) 守規聲明

此等綜合財務報表已根據香港會計師公會(「香港會計師公會」)頒佈之所有適用之個別香港財務報告準則(「香港財務報告準則」)(此乃包括所有適用之個別香港財務報告準則、香港會計準則(「香港會計準則」)及詮釋之統稱)及香港公司條例(「公司條例」)之披露規定而編製。此等綜合財務報表亦遵守香港聯合交易所有限公司證券上市規則之適用披露規定。本集團採納之重大會計政策披露如下。

香港會計師公會已頒佈若干新訂及經修訂香港財務報告準則，均於本集團之本會計期間首次生效或可供提早採納。附註3提供了有關首次應用該等發展而導致的此等綜合財務報表內所反映的本集團於本會計期間及過往會計期間的任何會計政策變動的資料。

#### (b) Basis of preparation of the consolidated financial statements

The consolidated financial statements for the year ended 31 December 2024 comprise the Company and its subsidiaries.

The measurement basis used in the preparation of the consolidated financial statements is the historical cost basis except for certain financial instruments, which are stated at their fair value as explained in the accounting policies set out below.

The preparation of consolidated financial statements in conformity with HKFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about the carrying amounts of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgements made by management in the application of HKFRSs that have a significant effect on the consolidated financial statements and major sources of estimation uncertainty are discussed in note 32.

截至二零二四年十二月三十一日止年度綜合財務報表包括本公司及其附屬公司之財務報表。

綜合財務報表之編製乃以歷史成本作計量基準，惟若干金融工具以公平值計量除外（見下文會計政策所闡釋）。

編製符合香港財務報告準則之綜合財務報表時，管理層需作出判斷、估計和假設，該等判斷、估計及假設對會計政策之應用以及所呈報資產、負債、收入和支出之金額構成影響。該等估計及有關假設乃根據過往經驗及被認為在該情況下屬合理之多項其他因素而作出，其結果便成為判斷未能透過其他來源確定之資產及負債之賬面值之基礎。實際結果可能有別於該等估計。

該等估計及相關假設會按持續基準進行檢討。對會計估計進行修訂時，倘修訂僅影響該期間，則修訂會於修訂估計之期間確認；或倘有關修訂同時影響當前及未來期間，則會於修訂期間及未來期間確認。

管理層在應用對本綜合財務報表構成重大影響之香港財務報告準則時所作出之判斷，以及估計不確定性之主要來源，將在附註32內討論。

### (c) Subsidiaries and non-controlling interests

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The financial statements of subsidiaries are included in the consolidated financial statements from the date that control commences until the date that control ceases.

Intra-Group balances, transactions, and any unrealised income and expenses (except for foreign currency transaction gains or losses) arising from intra-Group transactions, are eliminated. Unrealised losses resulting from intra-Group transactions are eliminated in the same way as unrealised gains but only to the extent that there is no evidence of impairment.

For each business combination, the Group can elect to measure any non-controlling interests ("NCI") either at fair value or at the NCI's proportionate share of the subsidiary's net identifiable assets. NCI are presented in the consolidated statement of financial position within equity, separately from equity attributable to the equity shareholders of the Company. NCI in the results of the Group are presented on the face of the consolidated statement of profit or loss and other comprehensive income as an allocation of the total profit or loss and total comprehensive income for the year between NCI and the equity shareholders of the Company.

### (c) 附屬公司及非控股權益

附屬公司指受本集團控制之實體。當本集團承受或享有由參與實體所得不定回報時，且有能力透過其對實體之權力影響該等回報時，則本集團控制該實體。附屬公司之財務報表將由控制權開始至控制權終止之期間計入綜合財務報表。

集團內部往來之餘額、交易以及由集團內部交易產生之任何未變現收入及開支（惟外幣交易損益除外）均抵銷。集團內部交易所產生之未變現虧損，其抵銷方法與抵銷未變現收益之方法相同，但抵銷額只限於沒有證據顯示已出現減值之部分。

就各業務合併而言，本集團可選擇按公平值或按佔附屬公司可識別淨資產之非控制性權益之比例而計量任何非控制性權益（「非控股權益」）。非控股權益在綜合財務狀況表中的權益項下列示，與歸屬於本公司權益股東的權益分列。本集團業績中的非控股權益在綜合損益及其他全面收益表中呈列為非控股權益與本公司權益股東之間的年度損益總額與全面收益總額的分配。

Changes in the Group's interests in a subsidiary that do not result in a loss of control are accounted for as equity transactions.

When the Group loses control of a subsidiary, it derecognises the assets and liabilities of the subsidiary, and any related non-controlling interests and other components of equity. Any resulting gain or loss is recognised in profit or loss. Any interest retained in that former subsidiary is measured at fair value when control is lost.

In the Company's statement of financial position, an investment in a subsidiary is stated at cost less impairment losses (see note 2(f)(ii)), unless it is classified as held for sale (or included in a disposal group classified as held for sale).

Property, plant and equipment are stated in the consolidated statement of financial position at cost less any accumulated depreciation and any accumulated impairment losses (see note 2(f)(ii)).

Depreciation is calculated to write off the cost of items of property, plant and equipment, less their estimated residual value, if any, using the straight-line method over their estimated useful lives.

### (e) Leased assets

At inception of a contract, the Group assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

#### *As a lessee*

Where the contract contains lease component(s) and non-lease component(s), the Group has elected not to separate non-lease components and accounts for each lease component and any associated non-lease components as a single lease component for all leases.

At the lease commencement date, the Group recognises a right-of-use asset and a lease liability, except for short-term leases that have a lease term of 12 months or less and leases of low-value assets. When the Group enters into a lease in respect of a low-value asset, the Group decides whether to capitalise the lease on a lease-by-lease basis. The lease payments associated with those leases which are not capitalised are recognised as an expense on a systematic basis over the lease term.

Where the lease is capitalised, the lease liability is initially recognised at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. After initial recognition, the lease liability is measured at amortised cost and interest expense is calculated using the effective interest method. Variable lease payments that do not depend on an index or rate are not included in the measurement of the lease liability and hence are charged to profit or loss in the accounting period in which they are incurred.

#### *作為承租人*

倘合同包含租賃部分及非租賃部分，則本集團選擇不區分非租賃部分，且將各租賃部分及任何相關非租賃部分入賬列為所有租賃的單一租賃部分。

於租賃開始日期，本集團確認使用權資產及租賃負債（除租期為十二個月或以下的短期租賃及低價值資產租賃外）。於本集團就低價值資產訂立租賃時，本集團決定是否按逐項租賃基準將租賃資本化。與該等未資本化租賃相關之租賃款項在租賃期內按系統基準確認為開支。

倘租賃資本化，於租賃期，租賃負債以應付租賃款項現值初步確認，並按租賃中所隱含的利率貼現或，倘該利率難以釐定，則採用相關增量借款利率計算。於初步確認後，租賃負債按攤銷成本計量且利息開支則採用實際利率法計算。租賃負債的計量並不包括取決於一項指數或比率之浮動租賃款項，因此按照所產生之金額於會計期間計入損益。

The right-of-use asset recognised when a lease is capitalised is initially measured at cost, which comprises the initial amount of the lease liability plus any lease payments made at or before the commencement date, and any initial direct costs incurred. Where applicable, the cost of the right-of-use assets also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, discounted to their present value, less any lease incentives received. The right-of-use asset is subsequently stated at cost less accumulated depreciation and impairment losses (see note 2(f)(ii)).

Refundable rental deposits are accounted for separately from the right-of-use assets in accordance with the accounting policy applicable to investments in non-equity securities carried at amortised cost. Any excess of the nominal value over the initial fair value of the deposits is accounted for as additional lease payments made and is included in the cost of right-of-use assets.

The lease liability is remeasured when there is a change in future lease payments arising from a change in an index or rate, or there is a change in the Group's estimate of the amount expected to be payable under a residual value guarantee, or there is a change arising from the reassessment of whether the Group will be reasonably certain to exercise a purchase, extension or termination option. When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the right-of-use asset, or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

In the consolidated statement of financial position, the current portion of long-term lease liabilities is determined as the present value of contractual payments that are due to be settled within twelve months after the reporting period.

可退還租賃按金按照按攤銷成本計量的非權益證券投資適用的會計政策與使用權資產分開入賬。任何超過按金初始公平值的面值作為已作出的額外租賃付款入賬，並計入使用權資產成本。

倘指數或利率變化引致日後租賃款項出現變動，或本集團剩餘價值擔保之預期支付金額的估計金額出現變動，或就本集團是否合理確定將會行使購買權、續租或終止權的重新評估變更，則租賃負債將重新計量。倘以此方式重新計量租賃負債，則對使用權資產賬面值作出相應調整，而倘使用權資產賬面值已調減至零，則計入損益。

於綜合財務狀況表內，長期租賃負債的即期部分釐定為應於報告期後十二個月內結算的合同付款的現值。

##### Measurement of ECLs

ECLs are a probability-weighted estimate of credit losses. Generally, credit losses are measured as the present value of all expected cash shortfalls between the contractual and expected amounts.

- fixed-rate financial assets, trade and other receivables and contract assets: effective interest rate determined at initial recognition or an approximation thereof; and

Loss allowances for trade receivables and contract assets are always measured at an amount equal to lifetime ECLs. ECLs on these financial assets are estimated using a provision matrix based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors and an assessment of both the current and forecast general economic conditions at the reporting date.

For all other financial instruments, the Group recognises a loss allowance equal to 12-month ECLs unless there has been a significant increase in credit risk of the financial instrument since initial recognition, in which case the loss allowance is measured at an amount equal to lifetime ECLs.

###### Significant increases in credit risk

When determining whether the credit risk of a financial instrument has increased significantly since initial recognition and when measuring ECLs, the Group considers reasonable and supportable information that is relevant and available without undue cost or effort. This includes both quantitative and qualitative information and analysis, based on the Group's historical experience and informed credit assessment, that includes forward-looking information.

The Group assumes that the credit risk on a financial asset has increased significantly if it is more than 30 days past due.

The Group considers a financial asset to be in default when:

ECLs are remeasured at each reporting date to reflect changes in the financial instrument's credit risk since initial recognition. Any change in the ECL amount is recognised as an impairment gain or loss in profit or loss. The Group recognises an impairment gain or loss for all financial instruments with a corresponding adjustment to their carrying amount through a loss allowance account.

#### Credit-impaired financial assets

At each reporting date, the Group assesses whether a financial asset is credit-impaired. A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of the financial asset have occurred.

Subsequent recoveries of an asset that was previously written off are recognised as a reversal of impairment in profit or loss in the period in which the recovery occurs.

If any such indication exists, the asset's recoverable amount is estimated.

#### Calculation of recoverable amount

The recoverable amount of an asset is the greater of its fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. Where an asset does not generate cash inflows largely independent of those from other assets, the recoverable amount is determined for the smallest group of assets that generates cash inflows independently (i.e. a cash-generating unit).

###### Recognition of impairment losses

An impairment loss is recognised in profit or loss if the carrying amount of an asset, or the cash-generating unit to which it belongs, exceeds its recoverable amount. Impairment losses recognised in respect of cash-generating units are allocated first to reduce the carrying amount of any goodwill allocated to the cash-generating unit (or group of cash-generating units) and then, to reduce the carrying amount of the other assets in the unit (or group of cash-generating units) on a pro rata basis, except that the carrying value of an asset will not be reduced below its individual fair value less costs of disposal (if measurable) or value in use (if determinable).

###### Reversals of impairment losses

An impairment loss is reversed if there has been a favourable change in the estimates used to determine the recoverable amount.

A reversal of an impairment loss is limited to the asset's carrying amount that would have been determined had no impairment loss been recognised in prior years. Reversals of impairment losses are credited to profit or loss in the year in which the reversals are recognised.

Inventories are carried at the lower of cost and net realisable value. Cost is calculated using the weighted average cost formula and comprises all costs of purchase, and other costs incurred in bringing the inventories to their present location and condition.

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

When inventories are sold, the carrying amount of those inventories is recognised as an expense in the period in which the related revenue is recognised. The amount of any write-down of inventories to net realisable value and all losses of inventories are recognised as an expense in the period the write-down or loss occurs. The amount of any reversal of any write-down of inventories is recognised as a reduction in the amount of inventories recognised as an expense in the period in which the reversal occurs.

### (h) Contract assets and contract liabilities

A contract asset is recognised when the Group recognises revenue (see note 2(q)) before being unconditionally entitled to the consideration under the payment terms set out in the contract. Contract assets are assessed for ECL in accordance with the policy set out in note 2(f)(i) and are reclassified to receivables when the right to the consideration has become unconditional (see note 2(i)).

A contract liability is recognised when the customer pays non-refundable consideration before the Group recognises the related revenue. A contract liability would also be recognised if the Group has an unconditional right to receive non-refundable consideration before the Group recognises the related revenue. In such cases, a corresponding receivable would also be recognised (see note 2(i)).

存貨按成本及可變現淨值兩者之較低者列賬。成本以加權平均成本方程式計算，包括使存貨達致目前地點及狀況而產生之購買成本及其他成本。

可變現淨值乃按日常業務過程中之估計售價減完成之估計成本及進行銷售所需之估計成本計算。

所出售存貨的賬面值在相關收入獲確認的期間內確認為支出。存貨撇減至可變現淨值的金額及存貨的所有虧損，均在出現撇減或虧損的期間內確認為支出。存貨撇減的任何撥回之金額在出現撥回期間內確認為扣除已確認為開支的存貨金額。

#### (i) Trade and other receivables

A receivable is recognised when the Group has an unconditional right to receive consideration and only the passage of time is required before payment of that consideration is due.

Trade receivables that do not contain a significant financing component are initially measured at their transaction price. Trade receivables that contain a significant financing component and other receivables are initially measured at fair value plus transaction costs. All receivables are subsequently stated at amortised cost (see note 2(f)(i)).

#### (j) Interest-bearing borrowings

Interest-bearing borrowings (including corporate bonds) are measured initially at fair value less transaction costs. Subsequently, interest-bearing borrowings are stated at amortised cost using the effective interest method. Interest expense is recognised in accordance with note 2(s).

#### (k) Trade and other payables

Trade and other payables are initially recognised at fair value and are subsequently stated at amortised cost unless the effect of discounting would be immaterial, in which case they are stated at cost.

### (l) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Bank overdrafts that are repayable on demand and form an integral part of the Group's cash management are also included as a component of cash and cash equivalents for the purpose of the consolidated statement of cash flows. Cash and cash equivalents are assessed for ECL in accordance with the Group's accounting policy set out in note 2(f)(i).

### (m) Share capital

Ordinary shares are classified as equity. Incremental costs directly attributable to the issue of new ordinary shares or options are shown in equity as a deduction from the proceeds.

### (n) Employee benefits

#### (i) Short term employee benefits

Short-term employee benefits are expensed as the related service is provided. A liability is recognised for the amount expected to be paid if the Group has a present legal or constructive obligation to pay this amount as a result of past service provided by the employee and the obligation can be estimated reliably.

#### (ii) Retirement benefit costs

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the “MPF Scheme”) under the Mandatory Provident Fund Schemes Ordinance for all eligible employees. Contributions are made based on a percentage of the employees’ salaries, allowances and other benefits and are charged to the statement of profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group’s employer contributions vest fully with the employees when contributed into the MPF Scheme, except for the Group’s employer voluntary contributions, which are refunded to the Group when the employee leaves employment prior to the contributions vesting fully, in accordance with the rules of the MPF Scheme.

The employees of companies in the PRC participate in the basic pension plan set up and administered by local authorities of Ministry of Human Resource and Social Security. Monthly payments of premiums on the basic pensions are calculated according to prescribed bases and percentage by the relevant local authorities. When employees retire, the relevant local authorities are obliged to pay the basic pensions to them. The amounts based on the above calculations are recognised as liabilities in the accounting period in which the service has been rendered by the employees, with a corresponding charge to the income statement for the current period or the cost of relevant assets.

本集團根據強制性公積金計劃條例，為其所有合資格僱員設立一項既定供款之強制性公積金退休保障計劃（「強積金計劃」）。按強積金計劃條例規定，供款須按僱員薪金、津貼及其他福利之百分比作出，並於應付時在損益表中列賬。強積金計劃之資產與本集團之資產乃分開處理，並由獨立管理基金負責管理。本集團之僱主供款全數與僱員供款歸屬於強積金計劃內，惟根據強積金計劃之規則，屬本集團之僱主自願性供款則除外，該等供款乃僱員於供款全數歸屬前離職之情況下退還本集團。

中國境內公司職工參加了由當地人力資源和社會保障部門組織實施的社會基本養老保險。本集團以當地規定的社會基本養老保險繳納基數和比例，按月繳納養老保險費。職工退休後，當地有關部門有責任向已退休員工支付社會基本養老金。本集團在職工提供服務的會計期間，將根據上述社保規定計算應繳納的金額確認為負債，並計入當期損益或相關資產成本。

Termination benefits are expensed at the earlier of when the Group can no longer withdraw the offer of those benefits and when the Group recognises costs for a restructuring.

### (o) Income tax

Income tax expense comprises current tax and deferred tax. It is recognised in profit or loss except to the extent that it relates to a business combination, or items recognised directly in equity or in OCI.

Current tax comprises the estimated tax payable or receivable on the taxable income or loss for the year and any adjustments to the tax payable or receivable in respect of previous years. The amount of current tax payable or receivable is the best estimate of the tax amount expected to be paid or received that reflects any uncertainty related to income taxes. It is measured using tax rates enacted or substantively enacted at the reporting date. Current tax also includes any tax arising from dividends.

Current tax assets and liabilities are offset only if certain criteria are met.

Future taxable profits are determined based on the reversal of relevant taxable temporary differences. If the amount of taxable temporary differences is insufficient to recognise a deferred tax asset in full, then future taxable profits, adjusted for reversals of existing temporary differences, are considered, based on the business plans for individual subsidiaries in the Group. Deferred tax assets are reviewed at each reporting date and are reduced to the extent that it is no longer probable that the related tax benefit will be realised; such reductions are reversed when the probability of future taxable profits improves.

### (p) Provisions and contingent liabilities

Provisions are recognised when the Group has a legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

Income is classified by the Group as revenue when it arises from the sale of goods, the provision of services or the use by others of the Group's assets under leases in the ordinary course of the Group's business.

#### (i) Revenue from contracts with customers

The Group is the principal for its revenue transactions and recognises revenue on a gross basis, including the sale of electronic products that are sourced externally. In determining whether the Group acts as a principal or as an agent, it considers whether it obtains control of the products before they are transferred to the customers. Control refers to the Group's ability to direct the use of and obtain substantially all of the remaining benefits from the products.

Revenue is recognised when control over a product or service is transferred to the customer at the amount of promised consideration to which the Group is expected to be entitled, excluding those amounts collected on behalf of third parties such as value added tax or other sales taxes.

#### (a) Sale of EP products and equipment

Revenue is recognised when the customer takes possession of and accepts the products. Payment terms and conditions vary by customers and are based on the billing schedule established in the contracts or purchase orders with customers, but the Group generally provides credit terms to customers within six months upon customer acceptance. The Group takes advantage of the practical expedient in paragraph 63 of HKFRS 15 and does not adjust the consideration for any effects of a significant financing component as the period of financing is 12 months or less. For sales contracts that had an original expected duration of one year or less, the Group has not disclosed the information related to the aggregated amount of the transaction price allocated to the remaining performance obligations in accordance with paragraph 121(a) of HKFRS 15.

The Group offers warranties for its products for ranging from six months to two years from the date of sale. A related provision is recognised in accordance with note 2(p).

##### (a) Interest income

Interest income is recognised using the effective interest method. The “effective interest rate” is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the gross carrying amount of the financial asset. In calculating interest income, the effective interest rate is applied to the gross carrying amount of the asset (when the asset is not credit-impaired). However, for financial assets that have become credit-impaired subsequent to initial recognition, interest income is calculated by applying the effective interest rate to the amortised cost of the financial asset. If the asset is no longer credit-impaired, then the calculation of interest income reverts to the gross basis.

- (c) Net income from provision of decentralised disaster recovery storage solution

The Group recognises income from provision of decentralised disaster recovery storage solution within digital currency blockchains (commonly termed “cryptocurrency mining”), net of the necessary costs incurred. As the consideration for these services, the Group receives cryptocurrencies (i.e. Filecoins) from each specific blockchain in which the Group’s joint operation participated. Income is measured based on the fair value of the cryptocurrencies earned and received by the Group at which time the economic benefit is received and can be reliably measured. The fair value is determined by using the spot price of the cryptocurrency on the date of cryptocurrency earned and received by the Group.

Transactions in foreign currencies are translated into the respective functional currencies of Group companies at the exchange rates at the dates of the transactions.

Monetary assets and liabilities denominated in foreign currencies are translated into the functional currency at the exchange rate at the reporting date. Non-monetary assets and liabilities that are measured at fair value in a foreign currency are translated into the functional currency at the exchange rate when the fair value was determined. Non-monetary assets and liabilities that are measured based on historical cost in a foreign currency are translated at the exchange rate at the date of the transaction. Foreign currency differences are generally recognised in profit or loss.

However, foreign currency differences arising from the translation of the following items are recognised in OCI:

- an investment in equity securities designated as at FVOCI;
- a financial liability designated as a hedge of the net investment in a foreign operation to the extent that the hedge is effective; and
- qualifying cash flow hedges to the extent that the hedges are effective.

The assets and liabilities of foreign operations, including goodwill and fair value adjustments arising on acquisition, are translated into Hong Kong dollars at the exchange rates at the reporting date. The income and expenses of foreign operations are translated into Hong Kong dollars at the exchange rates at the dates of the transactions.

Foreign currency differences are recognised in OCI and accumulated in the exchange reserve, except to the extent that the translation difference is allocated to NCI.

#### 9. RETIREMENT BENEFIT COSTS

The Group has arranged for its Hong Kong employees employed under the jurisdiction of the Hong Kong Employment Ordinance to join the MPF Scheme under the Hong Kong Mandatory Provident Fund Schemes Ordinance and Hong Kong Employment Ordinance. The MPF Scheme is a defined contribution retirement plan managed by independent trustees. Under the MPF Scheme, the Group (the employer) and its employees make monthly contributions to the scheme at 5% of the employees' relevant income as defined under the Mandatory Provident Fund Schemes Ordinance. The contributions from each of the employer and employees are subject to a cap of HK\$1,500 per month and thereafter contributions are voluntary. Contributions to the plan vest immediately.

The employees of the Company's subsidiaries established in the PRC are members of a state-sponsored retirement plan operated by the local government in the PRC and these subsidiaries make mandatory contributions to the state-sponsored retirement plan to fund the employees retirement benefits. The retirement contributions paid by these subsidiaries are based on a certain percentage of the relevant portion of the payroll of all qualifying employees in accordance with the relevant regulations in the PRC and are charged to profit or loss as incurred. The Group discharges its retirement obligations upon payment of the retirement contributions to the state-sponsored retirement plan operated by the local governments in the PRC. Contributions to the plan vest immediately.

The Group's contributions to retirement benefits schemes amounted to RMB746,000 (2023: RMB642,000) for the years ended 31 December 2024.

During the years ended 31 December 2024 and 2023, the Group had no forfeited contributions under its retirement benefit scheme in the PRC and under the MPF Scheme in Hong Kong which may be used to reduce the existing level of contributions as described in paragraph 26(2) of Appendix D2 to the Rules Governing the Listing of Securities on the Stock Exchange.

#### 9. 退休福利成本

#### 21. CORPORATE BONDS

##### Corporate bonds issued during the year ended 31 December 2017

During the year ended 31 December 2017, the Company issued five tranches corporate bonds with aggregate principal amount of HK\$25,000,000.

Two tranches of 4 years corporate bonds were subscribed by Mr. Jiang Xin, a former director of the Company, and his father, Mr. Jiang Quanlong, with principal amount of HK\$10,500,000 each which were matured in October 2021. In October 2021, the mature dates of these two tranches corporate bonds were extended to October 2031. In October 2024, Mr. Jiang Xin, Mr. Jiang Quanlong, and the Company entered into an agreement that the Company early redemption of these two tranches of corporate bonds by fully settle the principal and the accrued interest up to 8 October 2024.

Three tranches of 3 years to 7.5 years corporate bonds with aggregate principal amount of HK\$4,000,000 were subscribed by three independent third parties, in which, two tranches of corporate bonds with aggregate principal amount of HK\$2,000,000 had been settled in previous years.

##### Corporate bonds issued during the year ended 31 December 2018

During the year ended 31 December 2018, the Company issued one tranche corporate bond of 6 months with a principal amount of HK\$30,000,000 to an independent third party. The bond matured in May 2019 and the mature date was further extended to November 2024.

On 14 December 2023, the Company issued 88,679,245 ordinary shares of the Company to capitalise part of the corporate bond of HK\$18,800,000 (equivalent to RMB17,048,000) in accordance with the debt capitalisation agreement. On 22 February 2024, the Company issued 61,320,755 ordinary shares of the Company to capitalise remaining part of the corporate bond, including outstanding interest of HK\$13,000,000 (equivalent to RMB11,806,000) in accordance with the debt capitalisation agreement. After the completion of two tranches of debt capitalisation, the corporate bond was fully settled by the Group during the year ended 31 December 2024.

Under the PRC Enterprise Income Tax Law with effect from 1 January 2008 onwards, non-resident enterprises without an establishment or place of business in the PRC or which have an establishment or place of business but the relevant income is not effectively connected with the establishment or a place of business in the PRC, will be subject to withholding income tax at the rate of 10% on various types of passive income such as dividends derived from sources in the PRC. On 22 February 2008, the Ministry of Finance and State Administration of Tax approved Caishui (2008) No. 1, pursuant to which dividend distributions out of retained profits of foreign investment enterprises prior to 31 December 2007 will be exempted from withholding income tax.

As at 31 December 2024, the Group has unrecognised deferred tax liabilities of approximately RMB39,283,000 (2023: RMB36,626,000) in relation to withholding tax on undistributed earnings of approximately RMB392,825,000 (2023: RMB366,257,000) due to the retention of undistributed earnings by the subsidiaries established in the PRC as determined by the directors of the Company.

There are no income tax consequences to the Company attaching to the payment of dividends by the Company to its shareholders.

##### (d) Deferred tax assets not recognised

As at 31 December 2024, deductible temporary differences in respect of tax losses not recognised in these consolidated financial statements were approximately RMB20,000 (2023: RMB124,000). No deferred tax asset has been recognised in respect of such deductible temporary differences due to the unpredictability of future profit streams. Included in the above are tax losses of approximately RMB20,000 (2023: RMB124,000) which can only be carried forward for a maximum period of five years.

Statutory surplus reserve and enterprise expansion reserve are set up by the Company's subsidiaries established in the PRC by way of appropriation from the profit for the year in accordance with the relevant laws and regulations in the PRC. These subsidiaries are required to allocate certain percent of its net profit for the year as reported in their PRC statutory accounts to the statutory surplus reserve and enterprise expansion reserve until such reserves reach 50% of registered capital. These reserves are non-distributable. The statutory surplus reserve can be used to make up prior year losses of these subsidiaries, if any, and can be applied in conversion into capital by means of capitalisation issues. The enterprise expansion reserve is used for expanding the capital base of these subsidiaries by means of capitalisation issue.

### 29. CAPITAL MANAGEMENT

The Group's primary objectives when managing capital are to safeguard the Group's ability to continue as a going concern, and to generate sufficient profit to maintain growth and provide a satisfactory return to its shareholders.

The management actively and regularly reviews and manages its capital structure to maintain a balance between the higher shareholder returns that might be possible with higher levels of borrowings and the advantages and security afforded by a sound capital position, and makes adjustments to the capital structure through the amount of dividend payment to shareholders or raise new debt financing. No changes were made in the objectives or policies during the year.

The management monitors the Group's capital structure on the basis of a net debt-to-equity ratio. For this purpose, the Group defines net debt as total debt (which includes trade and other payables, lease liabilities and corporate bonds) minus cash and bank balances.

There was no net debt for the Group as at 31 December 2024 and 2023.

Neither the Company nor any of its subsidiaries are subject to externally imposed capital requirements.

The Group estimates the loss allowances for trade receivables and contract assets by assessing the ECLs. This requires the use of estimates and judgements. ECLs are based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors, and an assessment of both the current and forecast general economic conditions at the end of reporting period. Where the estimation is different from the original estimate, such difference will affect the carrying amounts of trade receivables and contract assets and thus the impairment loss in the period in which such estimate is changed. The Group keeps assessing the expected credit loss of trade receivables and contract assets during their expected lives. As at 31 December 2024, the carrying amount of trade receivables and contract assets was approximately RMB26,186,000 (2023: RMB30,106,000) and RMB26,367,000 (2023: RMB22,263,000). ###### (ii) Warranty provisions

The Group does not make provision for product warranties arising from sales of EP products and equipment, taking into account the Group's recent claim experience and past experience of the level of repairs. In addition, the Group has also received product warranties in respect of those products and equipment supplied from its suppliers, and the scope of the product warranties (including warranty periods) are the same as those the Group offered to its customers. It is not indicative of future claims that it will receive in respect of past sales.

In determining the carrying amounts of certain assets and liabilities, the Group makes assumptions for the effects of uncertain future events on those assets and liabilities at the end of each reporting period. In addition to assumptions and estimations of future events, judgements are also made during the process of applying the Group's accounting policies.

The Group is subject to income tax in Hong Kong and various taxes in the PRC. Significant judgement is required in determining the provision for taxation. (ii) *Withholding tax on the distributable profits of the Company's subsidiaries established in the PRC*

On 16 March 2007, National People's Congress approved the New EIT Laws which was effective from 1 January 2008. According to the relevant regulations of the New EIT Laws, when a foreign investment enterprise distributes dividends out of the profits earned from 1 January 2008 onwards to its foreign investors, they are subject to the PRC Enterprise Income Tax. The applicable income tax rate varies with the origin of the overseas investors.

The Group's determination as to whether to accrue for withholding tax from distribution of dividends from its subsidiaries established in the PRC according to the relevant tax law and regulations is subject to judgement on the timing of the payment of the dividends. The estimation process is highly based on assumptions, which are influenced by projected future market and economic conditions and future financing requirements of the Group, and it is not probable that these subsidiaries will distribute dividends in the foreseeable future.

###### (iii) Accounting for cryptocurrencies

HKFRSs do not specifically address accounting for cryptocurrencies. Accordingly, for the preparation of the consolidated financial statements, management needs to apply judgement in determining appropriate accounting policies based on the facts and circumstances of the Group's holding of cryptocurrencies.

Given the Group's purpose for holding cryptocurrencies, management considered that cryptocurrencies held by the Group should be accounted for as indefinite-lived intangible assets accounted for under the cost model.

As disclosed in note 7(c), in determining fair values used for impairment tests, management needs to apply judgment to identify the relevant available markets for trading of cryptocurrencies, and to consider accessibility to and activity within those markets in order to identify the principal cryptocurrency markets to ascertain the respective fair market values.

(iv) *Income from provision of decentralised disaster recovery storage solutions*

The Group recognised income from provision of decentralised disaster recovery storage solution within digital currency blockchains (commonly termed as "cryptocurrency mining") through a joint arrangement. As consideration for these services, the Group receives cryptocurrencies from digital currency blockchains which the Group's joint operation participates. Income is measured based on the fair value of the cryptocurrencies earned and received by the Group. The fair value is determined by using the spot price of the cryptocurrency on the date of cryptocurrency earned and received by the Group.

There is currently no specific definitive guidance in HKFRSs for the accounting for the mining of cryptocurrencies, and management has exercised significant judgement in determining appropriate accounting treatment for the recognition of income from provision of decentralised disaster recovery storage solutions. Management has examined various factors surrounding the substance of the Group's operations, addition of cryptocurrencies to a blockchain and the reliability of the measurement of the cryptocurrencies received. In the event authoritative guidance is enacted by the HKICPA, the International Accounting Standards Board or the International Financial Reporting Interpretations Committee, the Group may be required to change its policies which could result in a change in the Group's financial position and performance.

本集團通過合營安排確認於數字貨幣區塊鏈(通常稱作「加密貨幣開採」)內提供分散式災難恢復存儲解決方案之收入。作為該等服務的代價，本集團自本集團共同經營實體參與的數字貨幣區塊鏈中收取加密貨幣。收入乃按本集團所賺取及收取的加密貨幣之公平值計量。公平值乃採用加密貨幣於本集團賺取及收取加密貨幣日期之現貨價釐定。

香港財務報告準則現時並無有關加密貨幣開採之會計處理之具體明確指引，且管理層於釐定適當的會計處理方法以確認提供分散式災難恢復存儲解決方案之收入時已作出重大判斷。管理層已審查圍繞本集團營運實質的各項因素、區塊鏈的新增加密貨幣以及所取得加密貨幣之計量的可靠性。倘香港會計師公會、國際會計準則理事會或國際財務報告解釋委員會頒佈權威指引，本集團或須變更其政策，相關政策會導致本集團財務狀況及表現發生變化。

The Group entered into several agreements with PowerMeta to carry out provision of decentralised disaster recovery storage solution within digital currency blockchains (i.e. decentralised disaster recovery storage network in Web 3.0 ("DR network")) through a joint arrangement. PowerMeta is the Group's related company of which Mr. Lucas Wu Perez is the sole and ultimate beneficial owner of PowerMeta, and Mr. Lucas Wu Perez is also the minority shareholder of the Company's former subsidiary.

In accordance with the agreements, the Group is responsible for providing a maximum of 1,820,000 Filecoins which will be used as collateral in the DR network. PowerMeta is responsible for the construction, operation and technical maintenance of the DR nodes and the DR network. PowerMeta is also responsible for providing Filecoins as network Gas fees, Datacap real data acquisition costs and other operational costs required for the operation and maintenance of the DR network. This joint operation has a duration limit of 540 days.

After reimbursing PowerMeta for the Filecoins provided for the operation and maintenance of the DR network, the Group and PowerMeta shall share the Filecoins to be awarded equally.

Under the joint arrangement with PowerMeta, income derived from the joint operation, and the costs and expenses from the joint operation are recognised and assumed by each party independently; while the assets provided by each party and the related liabilities are also recognised and assumed by each party respectively.

On 31 December 2024, the Group's joint operation was disposed of through the disposal of a subsidiary (see note 25).

#### 36. 已頒佈但於截至二零二四年十二月三十一日止年度尚未生效之修訂本、新準則及詮釋之可能影響(續)

本集團正就預期首次應用此等變動期間造成之影響進行評估。迄今本集團認為，採納該等修訂本對本集團之綜合財務報表造成重大影響的可能性並不大。

#### 37. 合營安排

##### 共同經營

本集團通過合營安排與PowerMeta訂立若干協議，以於數字貨幣區塊鏈內提供分散式災難恢復存儲解決方案(即Web 3.0分散式災難恢復存儲網絡「DR網絡」)。PowerMeta為本集團的關聯公司，Lucas Wu Perez先生為PowerMeta的唯一及最終實益擁有人，故Lucas Wu Perez先生亦為本公司前附屬公司的少數股東。

根據該等協議，本集團負責提供最多1,820,000個菲樂幣，該等菲樂幣將作為DR網絡之抵押品。PowerMeta負責DR節點及DR網絡的建設、運營及技術維護。PowerMeta亦負責提供菲樂幣作為網絡Gas費、Datacap實時數據獲取成本及DR網絡運營和維護所需的其她運營成本。該共同經營有540天的持續期限。

於償還PowerMeta為DR網絡的運行及維護所提供的菲樂幣後，本集團及PowerMeta將平分將獲得的菲樂幣。

根據與PowerMeta訂立的合營安排，共同經營所得收入以及共同經營產生的成本及開支由各訂約方獨立確認及承擔；而由各訂約方提供的資產及相關負債亦由各訂約方各自確認及承擔。

於二零二四年十二月三十一日，本集團的共同經營已透過出售一間附屬公司予以出售(見附註25)。
