

CORPORATE PROFILE 公司簡介

Veson Holdings Limited ("Veson" or the "Company", together with its subsidiaries, the "Group"), focuses on lithium-ion technology applications and is a leading provider of lithium battery solutions for consumer electronics and smart hardware, as well as a manufacturer of lithiumion battery module integration in the PRC. The Group's operations are primarily divided into ODM (Original Design Manufacturing) and battery cell businesses, supplying lithium batteries for renowned domestic and international communication product brands, including mobile phone batteries, tablet batteries, notebook batteries, and power banks. In response to the increasing demand for batteries in emerging consumer electronics, the Group is adjusting its development strategy to respond to market changes by actively exploring new markets for wearable device batteries, automotive batteries and energy storage batteries, striving to offer diversified and professional module solutions. Veson was listed on the Main Board of the Stock Exchange of Hong Kong Limited (the "Stock Exchange") in December 2006.

Supported by its self-developed power management system with high reliability as well as advanced technology in battery module packaging, the Group's lithium-ion battery products are renowned for their high safety and quality. The core business of the Group is mainly the supply of high quality lithium-ion battery modules for mobile telecommunication, digital products, and smart hardware through integration into the supply chain systems of well-known domestic and international mobile communication and internet technology enterprises. The high-quality customer groups served by the Group have strong competitiveness and stable market shares, laying a foundation for the Group's sustainable and stable growth. The high reliability of the Group's product, mass delivery capabilities and standardised and efficient operating systems give the Group a competitive edge.

The Group's main production base is located in Fuzhou, the PRC, adhering to stringent international standards throughout the entire process, from supplier selection to quality control. Leveraging advanced automation equipment and precise processes, the Group ensures the demands of large-scale production are met with consistent product quality. Through years of experience in research, development, and manufacturing, the Group has established an efficient and streamlined modern manufacturing system, enhancing market competitiveness and solidifying its position as a key domestic hub for consumer lithium battery research and manufacturing.

Upholding the corporate spirit of "Efficiency, Innovation, Excellence and Integrity", the Group will continue to provide exceptional products and services to its clients, and contribute to a world powered by intelligent interconnectivity. 銳信控股有限公司(「鋭信」或「本公司」,連同其附屬 公司為「本集團」)專注於鋰離子技術應用,是中國領 先的消費電子和智能硬件產品鋰電池解決方案提供商 和模組封裝集成製造商。本集團的業務主要分為ODM (原始設計製造)業務與電芯業務,為國內外知名通訊 產品品牌製造商供應手機電池、平板電池、筆記本電 池及移動電源等產品。因應新興消費電子產品電池需 求的不斷增長,本集團正在調整發展戰略應對市場變 化,積極拓展包括穿戴設備電池、車載電池及儲能電 池在內的新市場,致力於提供多元化和專業化的模組 解決方案。鋭信於2006年12月在香港聯合交易所有限 公司(「聯交所」)主板上市。

憑籍自主研發的電源管理系統的高可靠性及先進的電 池模組封裝技術支持,本集團的鋰離子電池產品以高 安全性及高質量聞名。本集團核心業務主要是通過進 入國內外知名移動通訊企業及互聯網科技企業的供應 鏈體系,為移動通訊、數碼產品及智能硬件提供高質 量電池解決方案。本集團所服務的優質客戶群體於終 端市場擁有強大的競爭力和穩定的份額,為本集團持 續穩定增長奠定了基礎。產品品質的高可靠性、大規 模交付能力及規範高效的運營體系形成本集團的競爭 優勢。

CHAIRMAN'S STATEMENT 主席報告書

On behalf of the board (the "Board") of directors (the "Directors") of Veson Holdings Limited ("Veson" or the "Company", together with its subsidiaries, the "Group"), I am pleased to present the annual results of the Company for the full year from 1 January 2024 to 31 December 2024 (the "Review Period").

During the Review Period, the Group's main business revenue was derived from the ODM business, which mainly provided lithium-ion battery solutions for well-known mobile communication and Internet technology companies, covering the production and sales of mobile phone batteries, tablet batteries, and laptop batteries. The continuous slowdown of the global economy have posed challenges to the Group's ODM business. With the rapid popularisation of artificial intelligence (AI), AI-enabled mobile phones, driven by both technological innovation and market demand, will become an important growth pole in the smartphone industry, and bring users a more intelligent experience. It is expected that the AI-enabled mobile phone market will grow rapidly in the next few years, and the demand for high-performance lithium-ion batteries will increase significantly, which will drive the further upgrading of battery technology, such as increasing the energy density to extend the battery life, optimising the fast charging technology to shorten the charging time, and improving the heat dissipation design to deal with the heat generated by high-performance computing. The popularisation of Al-enabled mobile phones has had various impacts on the consumer lithium-ion battery market, so that the overall demand for the consumer battery industry will continue to remain stable.

Given that the Group's core business is the manufacturing and sales of 3C consumer lithium-ion battery products, in order to mitigate the risk that sales changes of individual products may have a significant impact on the Group's overall business, the Group has actively adjusted its development strategy in recent years to cope with market changes and taken measures to diversify business risks, actively explored new power supply product markets, applied the Group's expertise and experience in producing lithium-ion batteries and designing battery protection circuits to a wider range of mobile devices, developing new energy storage intelligent hardware battery products with higher profit margins, so as to diversify its revenue and profit sources, thereby reducing its dependence on the mobile phone battery segment.

本人謹代表鋭信控股有限公司(「鋭信」或「本公司」, 連同其附屬公司為「本集團」)董事(「董事」)會「董事 會」)欣然提呈本公司由2024年1月1日至2024年12月 31日全年(「回顧期間」)的年度業績。

於回顧期間,本集團主營業務收入來源於ODM業 務,主要為知名移動通訊和互聯網科技企業提供鋰 電池解決方案,涵蓋手機電池、平板電池及筆記本 電池的生產與銷售。全球經濟持續放緩,為本集團 ODM業務帶來了挑戰,隨著人工智能(AI)的快速普 及,AI手機將在技術創新和市場需求的雙重推動下, 將成為智能手機行業的重要增長點,為用戶帶來更 智慧化的使用體驗。預期AI手機市場將在未來幾年快 速增長,對高性能鋰電池的需求將顯著增加,這將 推動電池技術的進一步升級,例如提高能量密度以 延長續航時間、優化快充技術以縮短充電時間以及 改善散熱設計以應對高性能運算帶來的熱量。AI手機 的普及對消費類鋰電池市場帶來了多方面的影響, 令整體消費電池行業需求將繼續保持平穩的勢態。

鑑於本集團的核心業務為3C消費類鋰電池的生產及 銷售,為了緩解個別產品之銷售變化對本集團整體 業務造成重大影響的風險,本集團近年積極地調整 發展戰略應對市場變化及採取措施分散業務風險, 積極開拓新的電源產品市場,將本集團生產鋰電池 以及設計電池保護電路的技術和經驗應用至更多不 同的移動終端,開發利潤較高的新型智能硬件電池 產品,令收入及盈利來源多樣化,從而減輕其對於 手機電池分部的依賴。

CHAIRMAN'S STATEMENT 主席報告書

During the Review Period, approximately 60% of the Group's ODM sales revenue was derived from the mobile phone battery business, with its sales volume and revenue decreasing by approximately 15% and 22% year-on-year respectively. In contrast, the sales revenue of tablet batteries and new power supply products increased by 11% and 24% year-onyear respectively, becoming the main drivers of the growth of the ODM business in 2024. However, in the face of fierce market competition and uncertain economic environment, although the overall shipment of the Group's ODM business showed an upward trend compared to 2023, the price reduction pressure from customers and the low-price strategies of competitors posed challenges to the Company's gross profit margin and further squeezed the profit margin. To address the above challenges, the Group will focus on improving operational efficiency and product development capabilities, and expanding the versatility of equipment to reduce the equipment investment costs of production lines and meet the flexibility requirements of new products and technologies in the production process. The Group will shorten the cycle of the research and development and manufacturing processes to more efficiently launch products that meet market demands and respond quickly to market needs. The Group will focus on niche markets and establish differential advantages in various consumer lithium-ion battery product fields to create unique competitiveness. The Group will strive to seize market growth opportunities, and further accelerate the deployment of new products by maintaining its leading position in the mobile phone battery market to broaden new sources of revenue and profit, thus supporting the long-term sustainable development of the Group.

During the Review Period, the Group decided to terminate its investment project in India and disposed all the equity interests in the Indian joint venture, resulting in a book loss of approximately RMB20.4 million. The Group's investment project in India was launched in 2019, initially aiming to provide ODM services for the mobile phone and other consumer electronics manufacturing businesses of existing customers in India. However, in recent years, the business environment in India has undergone significant changes, there are geopolitical tensions between China and India, and investment risks and uncertainties have increased remarkably. After assessment, the Group believes that the potential risks of continuing to invest in the project have exceeded the possible returns. Therefore, the Group terminated the operation of its Indian factory in 2023, and completed the disposal of the equity interests in the joint venture in 2024. Although the disposal resulted in a certain amount of book loss, the decision helped the Group exit the Indian market in a timely manner and avoid the risks that may arise from market uncertainties, geopolitical tensions, and the changing business environment in the region. The Group has reallocated relevant resources to commercial projects with higher returns and greater growth potential to further improve resource efficiency and drive future profitability growth.

回顧期間,本集團約六成ODM銷售收入來源於手 機電池業務,其銷量與收入分別同比下降約15%和 22%。相比之下,平板電池及新電源產品的銷售收 入分别實現同比增長11%及24%,成為2024年ODM 業務增長的主要驅動力。然而,面對激烈的市場競 爭和不確定的經濟環境,儘管本集團ODM業務整 體出貨量相較2023年呈現增長趨勢,客戶的降價壓 力以及競爭對手的低價策略對公司毛利率構成了挑 戰,進一步壓縮了盈利空間。為應對上述挑戰,本 集團將專注於提升營運效率和產品開發能力,通過 提高裝備的通用性以降低生產線的設備投入成本, 滿足新產品和新工藝對生產環節的靈活性要求。在 研發及製造環節中縮短週期,以更高效地推出滿足 市場需求的產品,快速響應市場需求。聚焦細分市 場,在各消費鋰電池產品領域建立差異化優勢,打 造專屬競爭力。本集團將努力抓住市場增長機遇, 通過保持在手機電池市場的領先地位,進一步加快 新產品的佈局,拓展新的收入及盈利來源,從而支 持集團的長期可持續發展。

於回顧期間,本集團決定終止印度投資項目,將持 有的印度合營公司所有股權予以出售,因而錄得賬 面虧損約人民幣20,400,000元。本集團的印度投資 項目自2019年啟動,最初旨在為現有客戶在印度的 手機及其他消費電子製造業務提供ODM服務。然 而,近年來印度的營商環境已經發生重大變化,中 印之間地緣政治局勢緊張,投資風險與不確定性顯 著增加。本集團評估後認為,繼續投資該項目的潛 在風險已超過可能收益。因此,本集團於2023年終 止印度廠房的營運,並於2024年完成合營公司股權 的出售交易。儘管本次出售導致一定的賬面虧損, 但該決定有助於本集團及時退出印度市場,免受該 地區市場不確定性、地緣政治緊張局勢以及不斷變 化的營商環境可能帶來的風險。本集團將這部分資 源重新分配至回報更高、更具增長潛力的商業項 目,以進一步提升資源使用效率並推動未來盈利能 力的增長。

Looking ahead, the Group's management will closely monitor the business needs of core customers and continuously improve the quality of products and services to consolidate its order share and ensure the gradual recovery and continuous growth of the revenue scale. On this basis, the Group will take various measures to control operating costs, including strictly managing fixed expenses and material procurement costs, and at the same time improving operational efficiency to stabilise the gross profit and net profit, thus effectively reducing the operational risk brought by the external market environment. In addition, the Group will maintain its cooperative relationship with core customers through a stable and efficient operation system to expand its market penetration. The management will strengthen its ability to respond guickly to new demands, provide more comprehensive product and service support to customers, further deepen the penetration into high-margin product categories while strengthening existing businesses, increase its market share in niche markets, further expand business areas, actively cultivate new projects and customers, focus on high-margin product segments, proactively develop new product layouts, optimize product structures, enhance market competitiveness, and improve the Group's profitability.

On behalf of the Board and the management team, I would like to take this opportunity to express my sincere gratitude to all staff, directors, customers, suppliers, shareholders and institutions providing professional services to the Group for all your support to the Group throughout these challenging times.

展望未來,本集團管理層將緊密關注核心客戶的業 務需求,並持續提升產品和服務品質,以鞏固訂單 份額,確保營收規模的逐步恢復與持續增長。在此 基礎上,本集團將採取多方位措施控制運營成本, 包括嚴格管理固定費用支出和材料採購成本,同時 提升運營效率,以穩定毛利和淨利水準,從而有效 降低外部市場環境帶來的經營風險。此外,本集 團將以穩健而高效的運營體系維繫與核心客戶的合 作關係,擴大市場滲透範圍。管理層將強化對新增 需求的快速反應能力,為客戶提供更全面的產品與 服務支持,在鞏固現有業務的同時,進一步深化對 高毛利產品品類的滲透,提升在細分市場中的佔有 率,進一步拓展業務領域,積極培育新項目、新客 戶,著眼於高利潤的產品領域,積極進行新產品佈 局,優化產品結構,增強市場競爭力,提高集團的 盈利能力。

本人謹藉此機會代表董事會和管理層團隊, 衷心感 謝全體員工、董事、客戶、供應商、股東及向本集 團提供專業服務的機構, 在充滿挑戰的時刻一直對 本集團給予支持。

INDUSTRY REVIEW

According to preliminary data released by IDC, a market research agency, global smartphone shipments increased by 2.4% year-over-year to 331.7 million units in the fourth quarter of 2024. This marks the sixth consecutive quarter of shipment growth, closing the whole year with 6.4% growth and 1.24 billion shipments, marking a strong recovery after two challenging years of decline. IDC expects the market to continue growing in 2025, albeit at a slower pace, as refresh cycles continue growing and pent-up demand is fulfilled. IDC believes that the two key factors driving the overall market recovery are the device update cycle and the growth of demand from emerging markets, and smartphones equipped with generative artificial intelligence (AI) functions will also drive the market growth in the future.

Based on the growth data in 2024, the global smartphone market has been steadily recovering from the past fluctuations, and it indicates that the smartphone industry is about to usher in a new round of growth cycle. Despite the overall positive trend, demand in some markets has not yet fully recovered, and the market still faces many challenges. The rapid penetration of AI technology has become a key driving force for market growth, and AI will constantly drive the demand for smartphone replacement in next few years. Leading mobile phone brands are rapidly promoting their high-end product strategies focusing on AI functions to improve user experience and product competitiveness by introducing advanced AI technologies.

Looking ahead, with the gradual recovery of the global economy and the continued improvement of consumer confidence, the smartphone market is expected to resume growth. At the same time, with the acceleration of technological innovation and product upgrading, market competition will also become more intense. The entire mobile phone industry still needs more innovations and breakthroughs to sustain the current good trend. In recent years, the proportion of mobile phone lithium-ion batteries in the consumer lithium-ion battery market has declined, but lithium-ion batteries have been widely applied in the fields of new energy vehicles and energy storage, and the application scenarios of lithium-ion battery energy storage have been integrated into production and living in an accelerated manner. With the increasing popularity of 5G and AI technology, the broad application prospects will lead the rapid growth of the market scale of new intelligent products, driving the demand for consumer lithium-ion batteries and battery protection circuits.

行業回顧

市場調查機構IDC發佈的初步數據顯示,2024年第四 季度全球智能手機出貨量同比增長2.4%,達到3.317 億台。出貨量連續第六個季度實現增長,全年增長 6.4%,出貨量達12.4億台,標誌著在經歷了兩年充 滿挑戰的下滑後強勁復甦。IDC預計,隨著換機週 期的持續延長及被抑制的需求得到滿足,市場將在 2025年繼續增長,儘管增速會放緩。IDC認為推動整 體市場復甦的兩個關鍵因素是設備更新週期和新興 市場需求的增長,此外,今後配備生成式人工智能 (AI)功能的智能手機將拉動市場增長。

從2024年的增長數據來看,全球智能手機市場已 從過去的波動中穩步復甦,更預示著智能手機行業 即將迎來新一輪的增長週期。儘管整體趨勢向好, 但部分市場需求尚未完全恢復,市場仍面臨諸多挑 戰。AI技術的快速滲透成為推動市場增長的重要動 力,AI將會在未來幾年持續拉動智能手機換機需求。 各領先手機品牌正迅速推進聚焦AI功能的高端產品戰 略,通過引入先進的AI技術提升用戶體驗和產品競爭 力。

展望未來,隨著全球經濟的逐步復甦和消費者信心 的持續提升,智能手機市場有望恢復增長態勢。同 時,隨著技術創新和產品升級的加速推進,市場競 爭也將更加激烈。整個手機行業還需要更多的創新 和突破來延續目前的良好趨勢。近年來,手機鋰電 池在消費鋰電池市場的佔比呈下降趨勢,但鋰電池 仍廣泛應用於新能源汽車及儲能領域,鋰電儲能應 用場景加速融入生產生活。隨著5G及AI技術應用日 趨普及,巨大的應用前景將引領新型智能產品市場 規模迅速增長,帶動消費鋰電池以及電池保護電路 的需求。

BUSINESS REVIEW

During the period from 1 January 2024 to 31 December 2024 (the "Review Period"), more than 90% of the Group's revenue was derived from the ODM business, the majority of which came from the smartphone and tablet segment in the consumer electronics market. The Group mainly deploys its production facilities in the PRC, which has the advantages of large-scale production and excellent industrial design capabilities, and the customer portfolio and product mix of the ODM business did not change significantly during the Review Period. As the mobile phone market has matured and the room for development has gradually narrowed, although the overall sales volume of the Group's ODM battery products during the Review Period increased as compared with the same period last year, the sales revenue and gross profit contributed by mobile phone batteries during the Review Period decreased as compared with the same period last year due to the general decline in the sales volume and the selling prices, which affected the overall profit margin and operating results of the ODM business. Due to the weak global economy, the replacement cycle of mobile phones eventually became longer, resulting in a sharp overcapacity of the mobile phone industry chain, coupled with the general overcapacity of lithium-ion battery materials leading to a continuous decline in prices, and the relatively fierce domestic price competition, the gross profit margin of mobile phone products and related accessories contracted. In order to reduce the impact of a single product on the overall business, the Group is constantly broadening its product and technology platforms to diversify its sources of revenue and profit, thereby reducing its dependence on the mobile phone battery segment. The Group believes that for a long time to come, smartphones will still be the most important carrier for personal entertainment, consumption and social networking, the light productivity characteristics of smartphones are also constantly strengthening, and there is no new technology terminal that can really replace smartphones. Smartphones themselves are also constantly evolving and upgrading, and the high-end mobile phone market represented by foldable mobile phones has brought users differentiated applications, content and operation experience while enriching product modality.

業務回顧

於2024年1月1日至2024年12月31日期間(「回顧期 間」),本集團超過90%的銷售收入來自於ODM業 務,當中大部分收入來自消費電子市場的智能手 機及平板電腦市場。本集團主要在中國設有生產 設施,具備大規模生產的優勢及卓越的工業設計能 力,回顧期間內ODM業務的客戶組合及產品組合並 未有出現重大變化。隨著手機市場趨於成熟,其發 展空間逐漸收窄,儘管本集團ODM電池產品的整體 銷量與去年同期比較有所上升,但由於手機電池的 銷量及銷售價格普遍下跌,手機電池於回顧期間貢 獻的銷售收入及毛利均低於去年同期,對ODM業務 的整體利潤及經營業績產生不利影響。此外,全球 經濟疲軟最終導致手機換機週期變長,進一步加劇 了手機產業鏈的產能過剩問題。與此同時,鋰電材 料普遍產能過剩亦導致價格持續下跌,國內市場的 價格競爭相對激烈,壓縮了手機產品及相關配件的 毛利空間。為降低單一產品對整體業務的影響,本 集團正持續拓寬其產品及技術平台,實現收入及盈 利來源的多樣化,從而減輕其對於手機電池業務的 依賴。本集團相信在未來很長一段時間裡,智能手 機仍將是個人娛樂、消費和社交的核心載體,其輕 生產力屬性也在不斷強化,目前尚未出現能夠真正 替代智能手機的新的科技終端。同時,智能手機自 身也不斷演化和升級,以摺疊屏為代表的高端手機 市場不僅豐富了產品形態,還為用戶帶來了差異化 的應用、內容和操作體驗。

The Group is adjusting its development strategy to respond to market changes and taking measures to diversify business risks by actively exploring new power supply product markets, and developing new energy storage intelligent hardware battery products with higher profits. As the large-scale application of 5G technology will bring vast application basis for a variety of new energy storage intelligent hardware battery products, the new energy storage intelligent hardware battery market is expected to maintain rapid growth and continuous increment, and the demand for the entire consumer battery industry will continue to show a steady growth trend. The Group will focus its future business plan on improving profit rather than operating income growth, and will constantly monitor market competition to make appropriate responses. The Group will continue to invest in the research and development of new technologies, and the research and development team will continuously strive for innovation in industrial design and AI technology application to ensure that the Company can gain momentum for future business development, and better identify and respond to the changing needs of customers, industry trends and competitiveness.

Facing the complex external environment, the Group will continue to focus on the improvement of its own operating efficiency and re-development capabilities, further enhance the versatility of equipment to reduce the equipment input cost of production lines, quickly respond to the new requirements of new products and new technologies for production process, and establish the competitive advantage of various lithium-ion battery product segments. During the Review Period, the Group made continuous efforts to optimise product development processes, redesign and retrofit equipment to improve production efficiency, maintain a streamlined and flexible structure through business restructuring, and ensure good business relationships with the customers to meet their production needs. Cost of sales and operating expenses were generally reduced through optimisation and restructuring related to assets and labour. The Group will closely manage and control production costs and capital resources to enable the Group to respond promptly to environmental changes. In addition, the Group will actively pay attention to talent development, product quality, environmental awareness promotion and supplier management, explore value by paying more attention to details, and strive to provide customers and consumers with safe green energy products, so as to achieve sustainable development.

本集團正在調整發展戰略以應對市場變化,同時採 取措施分散業務風險,積極開拓新的電源產品市 場,專注於開發利潤較高的新型智能硬件電池產 品。隨著5G技術的大規模應用將為各式各樣的新型 智能硬件電池產品帶來大規模應用基礎,新型智能 硬件電池市場有望保持高速增長及持續增量,整體 消費電池行業需求將繼續呈現穩定增長的趨勢。本 集團的未來業務計劃將聚焦於提升盈利能力,而非 單純追求營業收入的增長。同時,本集團將密切關 注市場競爭狀況以作出適當回應。本集團會繼續投 資於研發新技術,研發團隊將不斷在工業設計及AI 技術應用等方面進行創新,以確保本公司取得未來 業務發展動力,更可識別和滿足客戶不斷變化的需 求,跟上行業發展趨勢並保持市場競爭力。

面對複雜的外部環境,本集團將持續專注於提升營 運效率及再開發能力,進一步提高裝備的通用性, 降低生產線裝備投入成本,快速響應新產品和新工 藝對生產環節的要求,建立各鋰電池產品細分領域 的競爭優勢。本集團於回顧期間都不斷努力優化 產品開發流程,對設備進行設計改造以提升生產效 率,通過業務重組令集團架構保持精簡靈活,確保 與客戶維持良好的業務關係,以滿足其生產需求。 資產及勞力的優化及重組有效降低了銷售成本及經 營開支。本集團會密切管理及控制生產成本及資本 資源,以快速應對市場變化。此外,本集團將更加 關注人才發展、產品品質、環境意識推廣和供應商 管理,通過專注細節挖掘價值,致力於為客戶及消 費者提供安全的綠色能源產品,實現可持續發展。

During the Review Period, the Group's consolidated turnover amounted to approximately RMB5,344.9 million (2023: RMB6,145.2 million), decreased by approximately 13.0% compared with 2023. The Group recorded loss for the year attributable to owners of the Company of approximately RMB12.0 million (2023: profit for the year attributable to owners of the Company of RMB20.1 million). Basic and diluted loss per share of approximately RMB1.10 cents (2023: Basic and diluted earnings RMB1.84 cents). The ODM business recorded a turnover of approximately RMB4,994.6 million (2023: 93.5%) of the Group's consolidated turnover. The bare battery cell business recorded a turnover of approximately RMB110.3 million (2023: RMB141.1 million), accounting for approximately 2.1% (2023: 2.3%) of the Group's consolidated turnover.

ODM Business

The lithium-ion battery products supplied by the ODM business mainly consist of mobile phone batteries, tablet batteries, notebook batteries and power banks. During the Review Period, turnover of mobile phone batteries represented approximately 66.8% (2023: 74.5%) of turnover of the ODM business and the sales volume of mobile phone batteries decreased by approximately 15.2% to approximately 93.4 million pieces (2023: 110.1 million pieces) and recorded a turnover of approximately RMB3,334.3 million (2023: RMB4,264.0 million), which decreased by approximately 21.8% year-on-year. In terms of product mix, mobile phone batteries, tablet batteries, notebook batteries and power banks contributed approximately 66.8%, 16.6%, 4.7% and 3.5% (2023: 74.5%, 13.0%, 4.4% and 3.7%) of the Group's ODM turnover respectively. Since the Group is adjusting its development strategy to respond to market changes by actively exploring new power supply product markets, including wearable device batteries, automotive batteries and energy storage batteries, the aggregate sales of the new power supply products contributed approximately RMB262.6 million (2023: RMB212.2 million) to the turnover of the ODM business during the Review Period, which represented approximately 5.3% (2023: 3.7%) of the turnover of the ODM business. As a result, the ODM business segment recorded a segment profit of approximately RMB107.3 million (2023: RMB108.8 million).

Bare Battery Cell Business

During the Review Period, the bare battery cell business recorded consolidated turnover of approximately RMB110.3 million (2023: RMB141.1 million), representing a decrease of approximately 21.8% year-on-year. During the Review Period, bare battery cell business recorded segment loss of approximately RMB12.6 million (2023: segment profit RMB3.2 million).

於回顧期間,本集團綜合營業額約人民幣 5,344,900,000元(2023年:人民幣6,145,200,000 元),較2023年減少約13.0%。本集團錄得本公司擁 有人應佔本年度虧損約人民幣12,000,000元(2023 年:本公司擁有人應佔本年度溢利人民幣20,100,000 元)。每股基本及攤薄虧損約人民幣1.10分(2023 年:基本及攤薄盈利人民幣1.84分)。ODM業務錄得 營業額約人民幣4,994,600,000元(2023年:人民幣 5,745,800,000元),佔本集團綜合營業額約93.4% (2023年:93.5%)。電芯業務分部錄得營業額約人 民幣110,300,000元(2023年:人民幣141,100,000 元),佔本集團綜合營業額約2.1%(2023年:2.3%)。

ODM業務

ODM業務所供應的鋰離子電池產品主要包括手機 電池、平板電池、筆記本電池及移動電源。於回顧 期間,手機電池營業額約佔ODM業務營業額66.8% (2023年:74.5%)以及手機電池銷售量減少約15.2% 至約9,340萬顆(2023年:1億1,010萬顆)及錄得營 業額約人民幣3,334,300,000元(2023年:人民幣 4,264,000,000元),同比减少約21.8%。按產品組合 計,手機電池、平板電池、筆記本電池及移動電源 的營業額分別約佔本集團ODM業務營業額66.8%、 16.6%、4.7%及3.5%(2023年:74.5%、13.0%、 4.4%及3.7%)。由於本集團正在調整發展戰略應對 市場變化,積極開拓新的電源產品市場,包括穿戴設 備電池、車載電池及儲能電池,於回顧期間,新電 源產品的總銷售額為ODM業務營業額貢獻約人民幣 262,600,000元(2023年:人民幣212,200,000元), 佔ODM業務營業額約5.3%(2023年:3.7%)。因此, ODM業務分部錄得分部溢利約人民幣107,300,000元 (2023年:人民幣108,800,000元)。

電芯業務

於回顧期間,電芯業務錄得綜合營業額約人民幣 110,300,000元(2023年:人民幣141,100,000元), 同比減少約21.8%。於回顧期間,電芯業務錄得分部 虧損約人民幣12,600,000元(2023年:分部溢利人民 幣3,200,000元)。

FINANCIAL REVIEW

During the Review Period, the Group recorded consolidated turnover of approximately RMB5,344.9 million (2023: RMB6,145.2 million), representing a decrease by approximately 13.0% as compared to that in 2023. Gross profit for the Group was approximately RMB378.8 million (2023: RMB418.8 million), representing a decrease by approximately 9.5% as compared to that in 2023. The loss for the year and loss for the year attributable to owners of the Company were approximately RMB9.9 million (2023: the profit for the year RMB14.2 million) and approximately RMB12.0 million (2023: profit for the year attributable to owners of the Company RMB20.1 million) respectively, representing a decrease by approximately 169.9% and 159.6% year-on-year respectively. The Group recorded EBITDA of approximately RMB162.4 million (2023: RMB205.6 million) for the year, representing a decrease by approximately 21.0% as compared to 2023. Basic and diluted loss per share was approximately RMB1.10 cents (2023: Basic and diluted earnings RMB1.84 cents).

Turnover by segments

During the Review Period, turnover of approximately RMB4,994.6 million (2023: RMB5,745.8 million) was generated from the ODM business segment, which accounted for approximately 93.4% (2023: 93.5%) of the Group's consolidated turnover. The revenue derived from the ODM business segment recorded a drop of 13.1% was mainly attributable to the decrease in the volume of mobile phone batteries sold as a result of the decrease in the demand from the smartphone manufacturing clients. A turnover of approximately RMB110.3 million (2023: RMB141.1 million) was contributed by the bare battery cell business segment, which accounted for approximately 2.1% (2023: 2.3%) of the Group's consolidated turnover. The revenue derived from the bare battery cell business segment recorded a decline of 21.8% as compared with 2023.

財務回顧

於回顧期間,本集團錄得綜合營業額約人民幣 5,344,900,000元(2023年:人民幣6,145,200,000 元),較2023年減少約13.0%。本集團的毛利約人 民幣378,800,000元(2023年:人民幣418,800,000 元),較2023年減少約9.5%。本年度虧損及本公 司擁有人應佔本年度虧損分別約人民幣9,900,000 元(2023年:本年度溢利人民幣14,200,000元)及 約人民幣12,000,000元(2023年:本公司擁有人應 佔本年度溢利人民幣20,100,000元),同比分別減 少約169.9%及159.6%。本集團錄得本年度未計利 息、税項、折舊及攤銷前盈利約人民幣162,400,000 元(2023年:人民幣205,600,000元),較2023 年減少約21.0%。每股基本及攤薄虧損約人民幣 1.10分(2023年:基本及攤薄盈利人民幣1.84分)。

各分部營業額

於回顧期間,ODM業務分部產生營業額約人民幣 4,994,600,000元(2023年:人民幣5,745,800,000 元),佔本集團綜合營業額約93.4%(2023年: 93.5%)。ODM業務分部的收益下降13.1%,主要 是由於智能手機製造客戶的需求減少導致手機電池 銷量減少所致。電芯業務分部產生營業額約人民幣 110,300,000元(2023年:人民幣141,100,000元), 佔本集團綜合營業額約2.1%(2023年:2.3%)。電 芯業務分部的收益較2023年減少21.8%。

Sales by major products

During the Review Period, sales of approximately RMB3,334.3 million (2023: RMB4,264.0 million) were generated from the sale of mobile phone batteries, which accounted for approximately 62.4% (2023: 69.4%) of the Group's consolidated turnover. Sales of tablet batteries and notebook batteries amounted to approximately RMB831.0 million (2023: RMB746.5 million) and RMB233.7 million (2023: RMB252.9 million) respectively, accounted for approximately 15.5% (2023: 12.1%) and 4.4% (2023: 4.1%) of the Group's consolidated turnover. Sales of power banks amounted to approximately RMB175.9 million (2023: RMB211.9 million), which accounted for approximately 3.3% (2023: 3.5%) of the Group's consolidated turnover. Sales of new power supply products amounted to approximately RMB262.6 million (2023: RMB212.2 million), which accounted for approximately 4.9% (2023: 3.5%) of the Group's consolidated turnover. Sales of approximately RMB110.3 million (2023: RMB141.1 million) were generated from the sale of bare battery cells, which accounted for approximately 2.1% (2023: 2.3%) of the Group's consolidated turnover.

Segment Results

The ODM business segment recorded a segment profit of approximately RMB107.3 million (2023: RMB108.8 million) during the Review Period, represented a decline of 1.4% as compared with 2023. The turnover and segment profit of the ODM business both declined as compared with 2023 because the global smartphone shipments were impacted by the market slowdown in the first half of 2024. The smartphone industry was going through a period of inventory clearing and adjustment. Throughout the first three quarters of 2024, both the global and domestic mobile phone markets experienced an overall decline in sales volume; however, this decline significantly narrowed down in the fourth quarter of 2024.

The bare battery cell business segment recorded a segment loss of approximately RMB12.6 million (2023: segment profit RMB3.2 million) during the Review Period.

各主要產品銷售額

於回顧期間,約人民幣3,334,300,000元(2023年: 人民幣4,264,000,000元)的銷售額來自手機電池 之銷售額,佔本集團綜合營業額約62.4%(2023) 年:69.4%)。平板電池及筆記本電池的銷售額 分別為約人民幣831,000,000元(2023年:人民幣 746,500,000元)及人民幣233,700,000元(2023年: 人民幣252,900,000元),分別佔本集團綜合營業 額約15.5%(2023年:12.1%)及4.4%(2023年: 4.1%)。移動電源的銷售額約人民幣175,900,000 元(2023年:人民幣211,900,000元),佔本集團綜 合營業額約3.3%(2023年:3.5%)。新電源產品的 銷售額約為人民幣262,600,000元(2023年:人民 幣212,200,000元),佔本集團綜合營業額約4.9% (2023年:3.5%)。約人民幣110,300,000元(2023 年:人民幣141,100,000元)的銷售額來自電芯之 銷售額,佔本集團綜合營業額約2.1%(2023年: 2.3%)。

分部業績

於回顧期間,ODM業務分部錄得分部溢利約人民幣 107,300,000元(2023年:人民幣108,800,000元), 較2023年下降1.4%。ODM業務的營業額及分部溢利 均較2023年下降,乃由於2024年上半年全球智能手 機出貨量受市場下滑影響。智能手機行業經歷清庫存 及調整期。2024年前三季度,全球及國內手機市場銷 量均出現整體下滑;但降幅於2024年第四季度顯著收 窄。

於回顧期間,電芯業務分部錄得分部虧損約人民幣 12,600,000元(2023年:分部溢利人民幣3,200,000 元)。

Cost of Sales

The Group's cost of sales amounted to approximately RMB4,966.1 million during the Review Period (2023: RMB5,726.5 million), representing an a decrease of approximately 13.3% as compared to 2023. The decrease in cost of sales in 2024 was in line with the decrease in sales revenue during the Review Period. Direct materials, direct labour and other production costs accounted for approximately 92.2% (2023: 92.9%), 4.9% (2023: 3.9%) and 2.9% (2023: 3.2%) of the cost of sales respectively.

Gross Profit and Gross Profit Margin

Gross profit for the Group was approximately RMB378.8 million (2023: RMB418.8 million), representing a decrease by approximately 9.5% as compared to that in 2023. The Group recorded a gross profit margin of 7.1% (2023: 6.8%) for the Review Period. For the ODM business, the overall gross profit margin for the Review Period was approximately 7.1% (2023: 7.0%). For the bare battery cell business, the overall gross profit margin for the Review Period was approximately 3.4% (2023: 6.5%). The decline in gross profit margin was mainly due to the reduction in production volume during the Review Period.

Other revenue of approximately RMB43.5 million (2023: RMB40.5 million) in 2024 mainly comprised of bank interest income, insurance compensation, government grants and revenue from sales of moulds. The increase on other revenue was mainly due to the recording of an insurance compensation of approximately RMB17.3 million in respect of the property losses caused by Typhoon "Hai Kuai" in 2023.

Selling and distribution expenses of approximately RMB66.2 million (2023: RMB83.2 million) accounted for approximately 1.2% (2023: 1.4%) of the Group's consolidated turnover in 2024. The selling and distribution expenses mainly comprised of entertainment expenses, repair fee, transportation expenses, commercial expenses and staff salaries and welfare. Selling and distribution expenses decreased as a result of the decrease in repair fee and commercial expenses, which was in line with the decrease in sales revenue during the Review Period.

銷售成本

於回顧期間,本集團的銷售成本約人民幣 4,966,100,000元(2023年:人民幣5,726,500,000 元),較2023年減少約13.3%。於2024年的銷售成 本減少與回顧期間的銷售收入減少一致。直接材 料、直接人工及其他生產成本分別佔銷售成本約 92.2%(2023年:92.9%)、4.9%(2023年:3.9%) 及2.9%(2023年:3.2%)。

毛利及毛利率

本集團的毛利約人民幣378,800,000元(2023年:人 民幣418,800,000元),較2023年減少約9.5%。於回 顧期間,本集團錄得毛利率7.1%(2023年:6.8%)。 ODM業務於回顧期間的整體毛利率約為7.1%(2023 年:7.0%)。電芯業務於回顧期間的整體毛利率則約 為3.4%(2023年:6.5%)。毛利率下降主要是由於 於回顧期間產量減少所致。

於2024年,其他收益約人民幣43,500,000元(2023 年:人民幣40,500,000元),主要包括銀行利息收 入、保險賠償、政府津貼及銷售模組收益。其他收 益增加乃主要由於錄得一筆涉及2023年颱風「海葵」 造成財產損失的保險賠償約人民幣17,300,000元。

於2024年,銷售及分銷開支約人民幣66,200,000元 (2023年:人民幣83,200,000元),佔本集團的綜合 營業額約1.2%(2023年:1.4%)。銷售及分銷開支 主要包括招待費用、返修費、運輸費、業務費及員 工薪金及福利。銷售及分銷開支減少乃由於返修費 及業務費減少所致,其與回顧期間的銷售收益減少 一致。

Administrative expenses of approximately RMB245.7 million (2023: RMB265.7 million) accounted for approximately 4.6% (2023: 4.3%) of the Group's consolidated turnover in 2024. Administrative expenses mainly comprised of R&D expenses, staff training expenses, staff salaries and welfare, depreciation and amortisation expenses and technical support fees. The decrease in administrative expenses was mainly attributable to the decrease in technical support fee, depreciation expenses and staff salaries and welfare during the Review Period.

Other operating expenses of approximately RMB11.1 million (2023: RMB24.8 million) mainly represented the write-off of inventories and loss on disposal of property, plant and equipment. Other operating expenses decreased was mainly due to the decrease in write-off of inventories by approximately RMB15.1 million as compared with 2023.

A loss on disposal of a subsidiaries amounted to approximately RMB20.4 million was recognised during the Review Period. The one-off loss arising from the disposal was related to the termination of the Group's joint venture investment project in India.

During the Review Period, the Group recorded an impairment recognised on trade and notes receivables, net of approximately RMB11.9 million as compared to a reversal of impairment recognised on trade and notes receivables, net in 2023 of approximately RMB2.8 million. The Group also recorded an impairment loss recognised on prepayments, deposits and other receivables, net of approximately RMB5.9 million, as compared to an impairment recognised on prepayments, deposits and other receivables, net in 2023 of approximately RMB6.2 million.

Finance costs of approximately RMB65.9 million (2023: RMB71.3 million) mainly represent interest on bank borrowings. The decrease in finance costs was mainly due to the decrease in notes receivable received during the Review Period, resulting in a corresponding decrease in interest expenses on discounted notes receivable as compared with 2023.

於2024年,行政開支約人民幣245,700,000元(2023 年:人民幣265,700,000元),佔本集團的綜合營業 額約4.6%(2023年:4.3%)。行政開支主要包括研 發費用、員工培訓費用、員工薪金及福利、折舊及 攤銷費用及技術支援費用。行政開支減少乃主要由 於於回顧期間技術支援費用、折舊費用、員工薪金 及福利減少所致。

其他經營開支約人民幣11,100,000元(2023年:人民 幣24,800,000元),主要包括存貨撇銷及出售物業、 廠房及設備之虧損。其他經營開支減少主要是由於 存貨撇銷較2023年減少約人民幣15,100,000元所致。

於回顧期間,本集團確認出售附屬公司之虧損約人 民幣20,400,000元。該出售事項所產生的一次性虧 損與本集團終止其印度合營投資項目有關。

於回顧期間,本集團錄得就應收貿易款項及應收票 據確認之減值淨額約人民幣11,900,000元,而2023 年錄得就應收貿易款項及應收票據確認之減值撥回 淨額約人民幣2,800,000元。本集團亦錄得就預付款 項、按金及其他應收款項確認之減值虧損淨額約人 民幣5,900,000元,而2023年錄得就預付款項、按金 及其他應收款項確認之減值淨額約人民幣6,200,000 元。

融資成本約人民幣65,900,000元(2023年:人民幣 71,300,000元)主要指銀行借款利息。融資成本減少 主要是由於回顧期間內收到的應收票據減少,導致 應收票據貼現利息支出較2023年相應減少。

(Loss)/Profit Attributable to Owners of the Company

During the Review Period, the Group's overall performance in its ODM business was affected by the slowdown in smartphone sales in the global market. Despite the Group's high quality customer base has remained stable, the sales of mobile phone battery recorded revenue of approximately RMB3,334.3 million, representing a decrease of 21.8% as compare with 2023 and accounting for 62.4% of the Group's total revenue. ODM business segment recorded a segment profit amounted to approximately RMB107.3 million (2023: RMB108.8 million), representing a decrease of approximately 1.4% as a result of the reduction in sales volume during the Review Period. As a result, the Group recorded a loss for the year attributable to owners of the Company amounting to approximately RMB12.0 million (2023: profit for the year attributable to owners of the Company RMB20.1 million), declined by 159.6% as compared with 2023.

Treasury Management and Cash Funding

The Group's funding and treasury policy is designed to maintain a diversified and balanced debt profile and financing structure. The Group continues to monitor its cash flow position and debt profile, and to enhance the cost-efficiency of funding initiatives by its centralised treasury function. In order to maintain financial flexibility and adequate liquidity for the Group's operations, potential investments and growth plans, the Group has built a strong base of funding resources and will keep exploring cost-efficient ways of financing.

Liquidity and Financial Resources

Cash and cash equivalents held by the Group as at 31 December 2024 was approximately RMB333.0 million (2023: RMB133.8 million), principally denominated in Renminbi, representing an increase by approximately RMB199.2 million year-on-year. The Group recorded a net cash inflow from operating activities of approximately RMB256.0 million (2023: net cash outflow from operating activities RMB102.1 million) and a net cash inflow from investing activities of approximately RMB89.2 million (2023: net cash outflow from investing activities of approximately RMB89.2 million (2023: net cash outflow from investing activities of approximately RMB10.1 million) and a net cash outflow from financing activities of approximately RMB10.7 million) and a net cash outflow from financing activities of approximately RMB140.6 million (2023: net cash inflow from financing activities RMB42.1 million) for the year ended 31 December 2024.

庫務管理及融資

本集團的融資及庫務政策旨在維持債務狀況及融資 架構多元化及平衡。本集團持續監控其現金流狀況 及負債組合,並由本集團的庫務政策統籌以提升融 資活動的成本效益。本集團已建立雄厚的資金來源 基礎並將持續尋求符合成本效益的融資途徑為本集 團的營運、潛在投資及發展計劃,維持充足及靈活 的流動資金狀況。

流動資金及財務資源

本集團於2024年12月31日持有的現金及現金等價 項目約為人民幣333,000,000元(2023年:人民幣 133,800,000元)(主要以人民幣計值),同比增加約人 民幣199,200,000元。截至2024年12月31日止年度, 本集團錄得來自經營活動的現金流入淨額約人民幣 256,000,000元(2023年:來自經營活動的現金流出淨 額人民幣102,100,000元)、來自投資活動的現金流入 淨額約人民幣89,200,000元(2023年:來自投資活動 的現金流出淨額人民幣11,700,000元)及來自融資活 動的現金流出淨額約人民幣140,600,000元(2023年: 來自融資活動的現金流入淨額人民幣42,100,000元)。

The Group's borrowings, principally denominated in Renminbi, which were outstanding as at 31 December 2024 amounted to approximately RMB1,222.2 million (2023: RMB1,299.8 million). Bank borrowings amounting to approximately RMB319.0 million (2023: RMB306.8 million) and approximately RMB903.2 million (2023: RMB993.0 million) were carried at floating interest rate and fixed interest rate respectively. A total of approximately RMB1,003.1 million (2023: RMB1,036.8 million) of the interest-bearing borrowings will fall due during the 12 months after the end of the Review Period. There was no particular seasonality of the Group's borrowing requirements. Please refer to Note 29 to the consolidated financial statements for details on the maturity profile of the Group's borrowings. The Group monitored capital using a gearing ratio, which is total debt of the Group divided by total equity of the Group. Total debt to equity ratio of the Group expressed as a percentage of interest bearing borrowings over the total equity of approximately RMB1,087.8 million (2023: RMB1,086.1 million) was approximately 112.4% (2023: 119.7%) as at 31 December 2024. Bank deposits pledged for banking facilities as at 31 December 2024 was approximately RMB597.8 million (2023: RMB709.1 million).

As at 31 December 2024, the Group's current ratio was approximately 1.2 times (2023: 1.1 times) based on current assets of approximately RMB3,582.3 million (2023: RMB4,001.3 million) and current liabilities of approximately RMB3,056.5 million (2023: RMB3,511.1 million). Trade receivable turnover days were approximately 127 days for the year ended 31 December 2024 as compared to approximately 121 days for the year ended 31 December 2023. Inventory turnover days were approximately 41 days for the year ended 31 December 2024 as compared to approximately 43 days for the year ended 31 December 2024 as compared to approximately 43 days for the year ended 31 December 2024. Trade payable turnover days were approximately 67 days for the year ended 31 December 2024 as compared to approximately 75 days for the year ended 31 December 2023.

Net Current Assets and Net Assets

The Group's net current assets as at 31 December 2024 was approximately RMB525.9 million, representing an increase by approximately 7.3% from the balance of approximately RMB490.2 million recorded as at 31 December 2023. Net assets as at 31 December 2024 was approximately RMB1,087.8 million, representing an increase by approximately 0.2% from the balance of approximately RMB1,086.1 million as at 31 December 2023.

The Group's capital commitments outstanding as at 31 December 2024 amounting to approximately RMB29.3 million (2023: RMB41.0 million) was mainly attributed to acquisition of property, plant and equipment.

Contingent Liabilities

As at 31 December 2024, no provision for contingent liabilities was required.

Capital Structure

During the Review Period, there had been no change in the share capital of the Company.

Foreign Exchange Exposure

For the year 2024, the Group conducted its business transactions principally in Renminbi. The Group has not experienced any material difficulties or negative impacts on its operations as a result of fluctuations in currency exchanges rates. Although the Group has certain bank balances denominated in United States Dollars, Japanese Yen, Indian Rupee and Hong Kong Dollars, their proportion to the Group's total assets is insignificant. The Directors considered that no hedging of exchange risk is required and no financial instruments, currency borrowings or other hedging instruments were used for hedging purposes during the Review Period. Nevertheless, the management will continue to monitor the Group's foreign exchange exposure and will take prudent measures against currency exchange risks as and when it is appropriate.

Significant Investment Held and Material Acquisition and Disposal

Significant Investment Held

The Group did not hold any significant investment during the Review Period.

The salaries of the Group's employees were determined by reference to the personal performance, professional qualification and industry experience of the relevant employee and relevant market trends. The Group ensures all levels of employees are paid according to market standard and employees are rewarded on a performancerelated basis within the framework of the Group's salary, incentives and bonus scheme. The management reviews the remuneration policy of the Group on a regular basis and evaluates the working performance of the employees. The remuneration of the employees includes salaries, allowances, year-end bonus and social insurance. In accordance with the relevant prevailing laws and regulations of the PRC, the Group has participated in the social insurance plans set up by the relevant local government authorities, including pension funds, medical insurance (including maternity insurance), unemployment insurance and workrelated injury insurance. The Group has also participated in the mandatory provident fund scheme for its Hong Kong employees in accordance with the Mandatory Provident Fund Scheme Ordinance (Chapter 485 of the Laws of Hong Kong). The Company also adopted a share option scheme on 17 June 2019 to reward eligible participants (including directors and employees of the Group) for their contributions to the Group.

CORPORATE GOVERNANCE PRACTICE

Veson Holdings Limited (the "Company") together with its subsidiaries (the "Group") are committed to maintaining and ensuring a high level of corporate governance standards and continuously review and improve the Group's corporate governance and internal control practices. Save as otherwise specified, set out below are the principles of corporate governance as adopted by the Company during the financial year from 1 January 2024 to 31 December 2024 (the "Review Period"). The Company has adopted the code provisions set out in Part 2 of the Corporate Governance Code (the "Corporate Governance Code") in Appendix C1 of The Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited ("Listing Rules"). The Company complied with all the applicable code provisions of the Corporate Governance Code during the Review Period.

ROLES OF CHAIRMAN AND CHIEF EXECUTIVE OFFICER ("CEO")

During the Review Period, Mr. Feng Ming Zhu served as the Chairman (the "Chairman") since 19 May 2020. The Chairman is responsible for leading the Board in protecting the interest of the shareholders of the Company (the "Shareholders") as a whole and for overseeing the Group, whilst Ms. Lian Xiu Qin served as the Chief Executive Officer ("CEO") of the Company and is responsible for managing the overall business operations of the Group, proposing strategies to the Board and monitoring the effective implementation of the strategies and policies adopted by the Board.

Save for their business relationships as a result of their respective directorships and positions in the Group, there are no financial, business, family or other material or relevant relationships between Mr. Feng Ming Zhu and Ms. Lian Xiu Qin.

THE BOARD

As of 31 December 2024, there were seven members on the Board, which comprised of three executive Directors, one non-executive Director ("NED") and three independent non-executive Directors ("INEDs"), whose names are shown in the table on page 60. The INEDs are considered by the Board to be independent of the management and free of any relationship that could materially interfere with the exercise of their independent judgments. The Board considered that each of the INEDs brings his own relevant expertise to the Board and its deliberations. The term of appointment of Mr. Heng Ja Wei Victor, Mr. Cheung Wai Kwok Gary and Mr. Lam Yau Yiu, the INEDs, commenced on 30 May 2024 and

The appointment letter of the NED can be terminated by the Company or the NED giving at least 3 months' prior written notice. Save for the Directors' business relationships as a result of their respective directorships and positions in the Group and save that Mr. Heng Ja Wei Victor is a nephew-in-law of Dr. Loke Yu, there are no financial, business, family or other material or relevant relationships among members of the Board and they are independent from each other.

The Board met regularly during the Review Period on an ad hoc basis as required by business needs. The Board's primary purpose is to set and review the overall strategic development of the Group and to oversee the achievement of its business plans to enhance Shareholders' value as a whole. Daily operational decisions are delegated to the executive Directors and the senior management. Management is entrusted with the task of implementing and executing business plans set by the Board. Such Board meetings involved the active participation, either in person or through other electronic means of communication, of the Directors. During the Review Period, the Board met 5 times and the Directors' attendance record is shown in the table on page 60. In advance of the Board meetings, appropriate notices, meeting agenda and other relevant information were given to all Directors. All Directors were consulted to include additional matters (if any) in the agenda for Board meetings. Draft and final versions of the Board meeting minutes were sent to all Directors for their comment and record respectively. The original minutes of Board meetings are kept by the company secretary of the Company and such minutes are open for inspection at any reasonable time on reasonable prior notice by any Director. The Company has put in place appropriate insurance cover in respect of Directors' liability.

The Company's overall management is vested in its Board, which accepts that it is ultimately accountable and responsible for the performance and affairs of the Group. The Board's role is to provide entrepreneurial leadership, set the Company's strategic aims and the Company's values and standards, and to ensure that its obligations to its stakeholders and others are understood and met. To facilitate the operations, the Board has established a schedule of matters reserved for its approval. The Company provides all members of the Board with monthly updates on the Company's performance, position and prospects. Directors are encouraged to participate in continuous professional development courses and seminars to develop and refresh their knowledge and skills, including updates to laws and regulations applicable to the Company and its Directors as well as any amendments thereto. During the Review Period, the Company provided regular updates to the Directors on material changes to regulatory requirements applicable to the Directors and the Company and on the latest business development of the Group on a timely basis. Mr. Feng Ming Zhu, Ms. Lian Xiu Qin, Mr. Ni Chen Hui, Dr. Loke Yu, Mr. Heng Ja Wei Victor, Mr. Lam Yau Yiu and Mr. Cheung Wai Kwok Gary confirmed that they have complied with code provision C.1.4 of the Corporate Governance Code in relation to continuous professional development during the Review Period. As at 31 December 2024, the Audit Committee comprised three INEDs, namely Mr. Heng Ja Wei Victor, Mr. Lam Yau Yiu and Mr. Cheung Wai Kwok Gary, and the chairman of the Audit Committee was Mr. Heng Ja Wei Victor. Each committee member can bring to the Audit Committee his valuable experience in reviewing financial statements and evaluating significant control and financial issues of the Group, who among themselves possess a wealth of management experience in the accounting profession or commercial sectors. The Audit Committee was established on 3 December 2006 and held 3 meetings during the Review Period. The committee members' attendance is shown on page 60.

The main duties of the Audit Committee are as follows:

- to review the half-year and annual financial statements of the Group before they are submitted to the Board for approval;
- to make recommendations to the Board on the appointment, reappointment and removal of the external auditor, and to approve the remuneration and terms of engagement of the external auditor, and any questions of its resignation or dismissal of that auditor;

NOMINATION POLICY FOR DIRECTORSHIP

The Board has approved and adopted a nomination policy for directorship with effect from 1 January 2019 (the "Nomination Policy"). The Nomination Policy aims at setting out the processes and criteria for the nomination of a candidate for directorship in the Company. The Nomination Committee shall consider the following factors in assessing the suitability of a proposed candidate:

- (a) reputation for integrity;
- (b) accomplishment and professional knowledge and industry experience which may be relevant to the Company;
- (c) commitment in respect of available time;
- (d) merit and potential contributions that such candidate could bring to the Board with reference to the Company's Board Diversity Policy, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, independence, skills, knowledge and length of service;
- (e) in case of a candidate for an independent non-executive director of the Company, to assess the independence of such candidate; and
- (f) board succession planning considerations and the long-term needs of the Company.

The Nomination Committee has the discretion to consider any other factors and matters and nominate any person, as it considers appropriate. After reaching its decision, the Nomination Committee nominates such candidates to the Board for approval and appointment.

BOARD MEMBERS AND DIVERSITY POLICY

In August 2013, the Board adopted a board diversity policy setting out the approach to achieve diversity in the Board to ensure that the Board has the balance of skills, experience and diversity of perspectives appropriate to the requirements of the Company's business. With a view to achieving a sustainable and balanced development, the Company sees increasing diversity at the Board level as an essential element in supporting the attainment of its strategic objectives and its sustainable development. In designing the Board's composition, the Company will consider its own business model and specific needs. In selecting candidates, the Company will consider a range of diversity perspectives, including but not limited to gender, age, cultural and educational background, professional experience, skills, knowledge and length of service. All Board appointments will be based on merit and contribution that the candidates will bring to the Board, and candidates will be considered against objective criteria, having due regard for the benefits of diversity on the Board. The Board reviews the implementation and effectiveness of the board diversity policy on an annual basis and has reviewed the board diversity policy during the Review Period.

The Nomination Committee of the Company is responsible for reviewing the structure, size, diversity profile and skills matrix of the Board, selecting individuals to be nominated as directors, reviewing succession planning for directors, and making recommendation on such matters to the Board for adoption. The Nomination Committee will review the composition of the Board annually and set a diversity target for the Board for the ensuing year.

As of 31 December 2024, the Board of the Company comprises a total of seven members, including three independent non-executive Directors and one non-executive Director, whose professional areas cover finance and accounting, electronics and electrical machinery, financial service, and corporate management, etc. More than half of the Board members are non-executive Directors to ensure the independence of the Board, only three of the Board members are responsible for specific management affairs. Among the three independent non-executive Directors, two has a tenure of more than five years, and one have a tenure of less than five years. The Company has always paid attention to gender diversity among the Board members, and has committed to maintaining an appropriate level of female representation in the Board, which shall be no less than 10%. As of 31 December 2024, female directors make up 14.3% of the Board and 33.3% of executive Directors.

董事會成員及多元化政策

於2013年8月,董事會採納了董事會多元化政策, 當中載列實現董事會多元化的方針,以確保董事會 具備適合本公司業務需求的技能、經驗及多樣性觀 點。為達致可持續的均衡發展,本公司視董事會層 面日益多元化為支援其達到戰略目標及維持可持 續發展的關鍵元素。本公司在設定董事會成員組合 時按本公司的業務模式及特定需要而訂定,甄選人 選時將按一系列多元化範疇為基準,包括但不限於 性別、年齡、文化及教育背景、專業經驗、技能、 知識及服務任期。董事會所有委任最終將按人選的 長處及可為董事會提供的貢獻而作決定,並在考慮 人選時以客觀條件充分顧及董事會成員多元化的裨 益。董事會每年會審查董事會多元化政策的實施情 況及成效,並已於回顧期間內審查董事會多元化政 策。

本公司提名委員會負責檢討董事會之架構、規模、 多元化概況及才能組合、甄選個別人士提名為董 事、檢討董事的繼任計劃,並就此等事宜向董事會 提出建議,供其採納。提名委員會將每年檢討董事 會組成,並訂定來年董事會成員多元化的目標。

於2024年12月31日,本公司董事會成員共有7名, 含3名獨立非執行董事及1名非執行董事,專業領 域涵蓋財務會計、電子電機、金融服務及公司管理 等。董事會過半數成員為非執行董事,以確保董事 會之獨立性,董事會成員中只有3名董事負責具體管 理事務。3名獨立非執行董事中有2名任期年資在5年 以上、1名任期年資在5年以下。本公司向來關注董 事會成員性別多元化,並承諾於董事會維持適當比 例的女性代表,該比例不得小於10%。於2024年12 月31日,女性董事佔董事會的14.3%及執行董事的 33.3%。

EMPLOYMENT FIGURES

As at 31 December 2024, the Group had a total of 2,406 full-time employees (2023: 2,534) and 1 (2023: 1) senior management members. The Group adheres to the principle of equality and non-discrimination in its business operations. All employees are entitled to equal opportunities regardless of their gender, age, nationality, ethnic background, religion, political background, marital status, pregnancy status, military service status and physical disability. The Group has always paid attention to gender equality among employees. At present, the ratio of male and female employees is 65.1% (2023: 64.1%) and 34.9% (2023: 35.9%) respectively, among which the ratio of male and female senior management members is 100% (2023: 100%) and 0% (2023: 0%) respectively. The gender ratio of the Group is in line with industry norm. The Group is committed to maintaining the current level of female employees in its workforce.

DIVIDEND POLICY

The Board has approved and adopted a dividend policy with effect from 1 January 2019 (the "Dividend Policy"). It is the policy of the Board, in considering the payment of dividends, to allow shareholders of the Company to participate in the Company's profits whilst retaining adequate reserves for the Group's future growth. The Board shall consider the following factors before declaring or recommending any dividends:

- (a) the Company's actual and expected financial performance;
- (b) the Group's liquidity position;
- (c) retained earnings and distributable reserves of the Company and each of the members of the Group;
- (d) the level of the Group's debts to equity ratio, return on equity and the relevant financial covenants;
- (e) any restrictions on payment of dividends that may be imposed by the Group's lenders;

僱傭數字

截至2024年12月31日,本集團共有2,406名全職 僱員(2023年:2,534名)及1名(2023年:1名)高 級管理人員。本集團在其業務營運中秉持平等及無 歧視原則,不論性別、年齡、國籍、種族背景、宗 教、政治背景、婚姻狀況、懷孕狀況、兵役狀況及 身體殘疾,僱員均享有平等機會。本集團向來關注 僱員性別平等,現階段男性員工及女性員工比率分 別為65.1%(2023年:64.1%)及34.9%(2023年: 35.9%),當中男性高級管理人員及女性高級管理人 員比率分別為100%(2023年:100%)及0%(2023 年:0%)。本集團的性別比率符合行業慣例。本集 團承諾將其員工中的女性僱員維持在現有水平。

股息政策

董事會已批准並採納一項股息政策(「股息政策」), 該政策自2019年1月1日起生效。董事會考慮派付 股息時所採納之政策准許本公司股東分享本公司溢 利,同時預留足夠儲備以供本集團日後發展之用。 董事會與宣派及建議股息前須考慮以下因素:

- (a) 本公司之實際及預期財務表現;
- (b) 本集團之流動資金狀況;
- (c) 本公司及本集團各成員公司之保留盈利及可分 派儲備;
- (d) 本集團之債務權益比率水平、股權回報率及相 關財務契諾;
- (e) 本集團貸方或會施加的任何派息限制;

- (f) the Group's expected working capital requirements and future expansion plans;
- (g) general economic conditions and other internal or external factors that may have an impact on the business or financial performance and position of the Company; and
- (h) any other factors that the Board deem appropriate.

The declaration, recommendation and payment of any dividends are also subject to compliance with applicable laws, regulations and the articles of association of the Company. The Board will continually review the Dividend Policy from time to time and there can be no assurance that dividends will be paid in any particular amount for any given period.

CORPORATE GOVERNANCE COMMITTEE

The Company established a corporate governance committee (the "Corporate Governance Committee") on 27 September 2018 and held 3 meetings during the Review Period. The committee members' attendance is shown on page 60. As at 31 December 2024, the Corporate Governance Committee comprised Mr. Lam Yau Yiu (an INED), Mr. Cheung Wai Kwok Gary (an INED), Mr. Heng Ja Wei Victor (an INED), Dr. Loke Yu (a NED), Mr. Feng Ming Zhu (an executive Director) and Mr. Ni Chen Hui (an executive Director). Dr. Loke Yu had resigned as a member of the Corporate Governance Committee with effect from 17 March 2025. The chairman of the Corporate Governance Committee was Mr. Lam Yau Yiu. All of the committee members have significant experience in the internal control, corporate governance, legal and/or accounting areas. The committee is primarily responsible for performing corporate governance functions and risk management and internal control functions in accordance with the Corporate Governance Code. Mr. Feng Ming Zhu and Mr. Ni Chen Hui, executive Directors, who are responsible for the daily operations of the Group are the key members of the committee. Mr. Feng Ming Zhu and Mr. Ni Chen Hui play a key role in experiencing the actual implementation status and/or progress of various internal control and ongoing monitoring policies, and therefore can identify key issues as and when they arise and interact with the staff and the operational systems in order to identify any such issues on a timely basis.

企業管治委員會

本公司於2018年9月27日設立企業管治委員會(「企 業管治委員會」),企業管治委員會於回顧期間曾舉 行3次會議,該委員會成員之出席情況載於第60頁。 於2024年12月31日,企業管治委員會由林友耀先 生(獨立非執行董事)、張為國先生(獨立非執行董 事)、邢家維先生(獨立非執行董事)、陸海林博士 (非執行董事)、馮明竹先生(執行董事)及倪晨暉先 生(執行董事)組成。陸海林博士已自2025年3月17日 起辭任企業管治委員會成員。企業管治委員會主席 為林友耀先生。該委員會成員皆於內部控制、企業 管治·法律及/或會計領域擁有豐富經驗。該委員 會主要負責根據企業管治守則履行企業管治職能及 風險管理及內部控制職能。執行董事馮明竹先生及 倪晨暉先生負責本集團日常營運,為委員會主要成 員。馮明竹先生及倪晨暉先生在體驗各項內部控制 及持續監督政策的實際執行情況及/或進展方面發 揮關鍵作用,因此於問題出現時能及時發現,並與 員工及業務系統進行互動,以便及時發現任何該等 問題。

The main duties of the Corporate Governance Committee are as follows:

- to develop, review and monitor the Company's policies and practices on corporate governance and make recommendations to the Board;
- (b) to review and monitor the training and continuous professional development of the Directors and senior management of the Company;
- (c) to review and monitor the Company's policies and practices on compliance with legal and regulatory requirements;
- (d) to develop, review and monitor the code of conduct and compliance manual (if any) applicable to employees and the Directors;
- (e) to review the Company's compliance with the Corporate Governance
 Code and disclosure in the Company's corporate governance report;
- (f) to oversee the Company's risk management and internal control systems on an ongoing basis (including reviewing the Company's risk management and internal control systems, which includes assessing the effectiveness of the Company's internal control system), evaluate and determine the nature and extent of the risks the Company is willing to take in achieving the Company's strategic objectives, and ensure that the Company establishes and maintains appropriate and effective risk management and internal control systems; and
- (g) to conduct an annual review of the effectiveness of the risk management and internal control systems, covering all material controls, including financial, operational and compliance controls.

GOING FORWARD

The Group will keep on reviewing its corporate governance standards on a regular basis and the Board endeavors to take the necessary actions to ensure compliance with the provisions of the Corporate Governance Code.

INDEPENDENCE OF INDEPENDENT NON-EXECUTIVE DIRECTORS

The Company has received from each of the INEDs an annual written confirmation of his independence, and the Company considers such Directors to be independent in accordance with each and every guideline set out in Rule 3.13 of the Listing Rules.

During the Review Period, the Board has reviewed the mechanisms for ensuring independent views and input are available to the Board, including the proportion, and independence of INEDs, their contributions and the channels for obtaining internal appropriate information and seeking external independent professional advice, and considered such mechanism to be effectively implemented.

CORPORATE GOVERNANCE FUNCTIONS

The Corporate Governance Committee is responsible for performing the corporate governance functions as set out in its terms of reference, the main duties of which are set out above.

During the Review Period, the Corporate Governance Committee reviewed the Company's compliance with the Corporate Governance Code.

COMPLIANCE WITH THE CORPORATE GOVERNANCE CODE OF THE LISTING RULES

In the opinion of the Directors, the Company has complied with the code provisions set out in the Corporate Governance Code as set out in Part 2 of Appendix C1 of the Listing Rules during the Review Period.

展望

RISK MANAGEMENT AND INTERNAL CONTROL

Risk Management Structure of the Group

The Corporate Governance Committee is responsible for overseeing the risk management and internal control systems of the Group and assessing their effectiveness. The risk management and internal control systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

Risk Management Department

The Group has set up a risk management department which is responsible for the design and implementation of the risk management system, assisting the Board in monitoring and supervising the implementation and effectiveness of the risk management framework and process and reviewing the measures on dealing with risks. The risk management department performs an internal audit function and is responsible for performing review of the adequacy and effectiveness of the internal control systems of the Group.

The Corporate Governance Committee reports to the Board after review of the effectiveness of the Group's risk management and internal control system. Upon consideration of the work and results of review of the Corporate Governance Committee, the Board forms its view on the effectiveness of the risk management and internal control systems.

風險管理及內部控制

本集團的風險管理構架

企業管治委員會負責監督本集團的風險管理及內部 控制系統,以及評估其有效性。風險管理及內部控 制系統旨在管理而非消除未能達成業務目標的風 險,而且只能就不會有重大的失實陳述或損失作出 合理而非絕對的保證。

風險管理部門

本集團已設立了一個風險管理部門,其負責設計及 執行風險管理制度、協助董事會監察及監督風險管 理構架及程序的執行及有效性,以及檢討風險應對 措施。風險管理部門執行內部審計職能和負責對本 集團內部控制系統的充分性和有效性進行檢討。

企業管治委員會在檢討本集團風險管理及內部控制 系統的成效後向董事會報告。董事會考慮審核委員 會的工作及檢討結果後,再就風險管理及內部控制 系統的成效得出自己的意見。

The Board ensures that a review of the risk management and internal control systems of the Group is conducted annually in respect of the relevant financial year.

During the Review Period, the Corporate Governance Committee and the risk management department conducted a review of the internal control systems and procedures of the Group and to make recommendations accordingly ("Internal Control Review").

The scope of work of the risk management department included an independent assessment of the internal control systems of the major subsidiaries of the Group. During the Review Period, the risk management department performed reviews on the internal control systems of the major subsidiaries of the Group which involved collecting relevant information and conducting walkthrough tests.

The Internal Control Review has been completed. Having reviewed the findings and results of the report on the Internal Control Review prepared by the risk management department, and having taken into consideration the improvements and/or remedial measures implemented in accordance with the risk management department's recommendations, the Board is of the view that the Company has put in place adequate internal control system and financial reporting procedures to meet its obligations under the Listing Rules. In view of the above, the Board considers that a review of the effectiveness of the risk management and internal control systems was conducted during the Review Period and the risk management and internal control systems of the Group are effective and adequate.

董事會確保每年就有關財政年度對本集團風險管理 及內部控制系統進行檢討。

於回顧期間,企業管治委員會及風險管理部門對本 集團的內部控制系統和程序進行審閱,並提出相應 的建議(「內部控制審閱」)。

風險管理部門之工作範圍包括獨立評估本集團主要 附屬公司之內部控制系統。於回顧期間,風險管理 部門對本集團主要附屬公司之內部控制系統進行檢 討,其包括收集相關資料及運行測試。

內部控制審閱已完成。經審閱風險管理部門編製之 內部控制審閱報告的發現及結果,及經考慮根據風 險管理部門之建議實施的改善及/或補救措施後, 董事會認為,本公司已建立充足的內部控制系統及 財務報告程序,以履行上市規則項下之責任。鑒於 上述情況,董事會認為,經於回顧期間內對風險管 理及內部控制系統的有效性進行檢討,本集團的風 險管理及內部控制系統屬有效且充足。

Major Risks and Uncertainties of the Group

The Group is exposed to different risks and uncertainties. Some of the Group's major risks are set out below and appropriate mitigation measures have been devised to manage such risks.

(A) OPERATIONAL, STRATEGIC AND FINANCIAL RISKS

The smart electronic products industry advances at a tremendous pace. Lithium-ion battery module, being the Company's main product, is mostly used in smartphones, notebooks, tablets and wearable devices. The sales of consumer smart electronics may change rapidly in response to consumer demand or taste. As a supplier of lithium-ion battery modules for a number of PRC smartphone brands, the drastic fluctuation in customers' sales of smartphones will have significant effect on the sales of the Group's lithium-ion battery modules.

Actions taken by the Group to address these issues include the following:

- (i) investment of resources in development of new products and application of lithium-ion battery in new industries and new fields in response to changes in market demands;
- diversification of product portfolios in order to reduce the impact of a reduction in sales of individual products on the Group's overall business; and
- (iii) proactive recruitment and training of skilled and experienced technicians to enhance the Group's R&D capability.

本集團主要風險及不確定性

本集團面臨不同風險及不確定性。本集團某些主要 風險載列如下並已採取適當緩解措施以管理該等風 險。

(A) 經營、戰略及金融風險

智能電子產品行業發展一日千里,本公司主要 產品鋰離子電池模組多應用於智能手機、筆記 本及平板及可穿戴設備。消費類智能電子產品 的銷售量或會因應消費者的需求或口味而急速 改變,作為多家中國智能手機品牌的鋰離子電 池模組供應商,客戶的智能手機銷售量大幅波 動將對本集團的鋰離子電池模組銷售造成重大 影響。

本集團已採取以下措施解決該等問題:

- (i) 投資資源開發新產品,因應市場需求變 化,將鋰離子電池應用於新行業及新領 域;
- (ii) 多元化產品組合,以減少個別產品之銷售變化對本集團整體業務之影響;及
- (iii) 積極招聘及培訓有技術和經驗的技術人員,以增強本集團的研發能力。

For lithium-ion battery products, great importance is attached to their quality and safety. The performance and safety of lithiumion battery is very sensitive to ambient environment. The safety of lithium-ion battery lies in effective use of external circuit design to ensure battery's operation is normal and safe. However, the efficiency and reliability of these safety devices are closely connected with good and consistent manufacturing quality. Various different circumstances or causes may also lead to short circuit and other risks.

Actions taken by the Group to address these issues include the following:

- (i) in the pursuit of higher efficiency and endurance for batteries, the Group conducted more rigorous review of the safety of batteries to ensure that all the batteries delivered by the Group meet high safety standards;
- the Group ensures it purchases sufficient product liability insurance for protection. Product liability insurance covers the liability arising from a defective product that causes personal injury, property damage or other losses; and
- (iii) the raw materials and other auxiliary materials used for the Company's products shall be certified by authorities before being used. In the process of production, the Company's quality control department shall conduct inspection at each stage throughout the whole production process to ensure the quality of the Company's product and safeguard the interests of consumers with a quality monitoring system.

In 2024, more than 90% of the Group's turnover was derived from its ODM business. Over 60% of the sales of its ODM business was to three smartphone brand manufacturers. If the Group loses one of these top customers, it may have adverse effects on the operation and financial results of the Group's ODM business. 鋰離子電池產品十分著重其質量及安全性。鋰 離子電池的性能及安全性受環境溫度的影響很 大。鋰離子電池的安全性在於是否有效利用外 在電路設計確保電池在正常且安全的狀態下運 作。然而,這些安全裝置的效能及可靠度,與 良好且一致的製造質量緊密相關。各種不同情 況或原因亦可能會引發不同程度的短路及其他 風險。

本集團已採取以下措施解決該等問題:

- (i) 在追求電池的高效能與續航力之下,本集 團開展更嚴謹檢視電池的安全性,確保所 有出廠的電池符合高安全性的標準;
- (ii) 本集團確保有購買足夠的產品責任保險作 保障。產品責任保險涵蓋由於不合格產品 導致人身傷害、財產損失或其他損失產生 的責任;及
- (iii) 本公司產品所採用的原材料及其他原輔 料,在使用前需獲得權威機構給予認證方 可使用。在生產的過程中,本公司質量控 制部門應於整個生產過程中的每個階段開 展檢測,確保以質量監控體系保證本公司 產品質量以及保護廣大消費者權益。

於2024年,本集團逾90%的營業額來自其ODM 業務。ODM業務的銷售當中有60%以上為售予 三家智能手機品牌製造商。倘本集團流失該等 大客戶之一,可能對本集團的ODM業務營運及 財務業績構成不利影響。

Actions taken by the Group to address these issues include the following:

- look for more potential customers to reduce its dependence on top customers;
- strengthen after-sales services for customers, pay regular visits to customers and conduct customer satisfaction survey to continuously improve the quality of products and services, consolidate the Group's competitiveness in the industry and increase customer loyalty; and
- (iii) develop more new products to meet customers' needs.

The vast majority of the Group's sales revenue is from operating units in the PRC. Adverse events in the PRC's operation and political environment may result in material adverse effects on the Group's business, financial position and operation results.

Actions taken by the Group to address these issues include the following:

- (i) development of overseas markets to increase revenue from overseas operations; and
- continuous monitoring of PRC's operations and political environment, anticipation of possible problems, and establish quick strategic response to changing business environment.

Overdue payments by customers granted with credit by the Group will increase the financial risk to the Group and affect the Group's financial performance and operating cash flow. 本集團已採取以下措施解決該等問題:

- (i) 尋找更多潛在客戶,減少對大客戶的依賴度;
- (ii) 加強客戶的售後服務工作,定期走訪客戶 和進行客戶滿意度調查,不斷提升產品及 服務質量,鞏固本集團於行業的竟爭力及 增加客戶忠誠度;及
- (iii) 開發更多新產品以滿足客戶需求。

本集團銷售收益絕大部分來自中國的營運單 位。中國營運及政治環境發生的不利事件可能 導致本集團的業務、財務狀況及經營業績受到 重大不利影響。

本集團已採取以下措施解決該等問題:

- (i) 開拓海外市場以增加海外業務的收益;及
- (ii) 持續監察中國的營運及政治環境,預判可 能出現的問題,快速對任何不斷變化的業 務環境作出策略應對。

獲授予本集團信貸期的客戶如逾期付款,將會 增加本集團的金融風險,並會影響本集團的財 務表現及經營現金流量。

Actions taken by the Group to address these issues include the following:

- (i) regular review of the amount of accounts receivable from key customers to control it at an appropriate level; and
- (ii) implementation of strict internal control measures and increase collection efforts for overdue accounts receivable.

The main raw material for lithium-ion battery modules (being the Group's main product) is lithium-ion bare battery cell. The Group purchases lithium-ion bare battery cells from many well-known international manufacturers. In recent years, lithium-ion bare battery cell has been widely used in smartphones, notebooks, tablets, wearable devices, power tools, electric bicycles, energy storage and other fields. Any increase in the price or shortage of supply of lithium-ion bare battery cells will have a material impact on the profitability and production costs of the Group.

Actions taken by the Group to address these issues include the following:

- (i) regular research on and evaluation of suppliers to ensure stable supply of raw materials; and
- (ii) through automation upgrade of production lines, the Group solves the problem with human resources and effectively controls production costs, which have positive effects on improvement of the Group's profitability and control of production costs.

(B) ACCIDENT RISKS

Major accidents including fires, natural disasters or serious infectious diseases will affect the Group's assets and operations, thus affecting the Group's operational capacity and reducing profitability.

本集團主要產品鋰離子電池模組的主要原材料 為鋰離子電芯。本集團向眾多國際知名電芯製 造商採購鋰離子電芯。近年來,鋰離子電芯被 廣泛地應用於智能手機、筆記本、平板、可穿 戴設備、電動工具、電動自行車、儲能及其他 領域。鋰離子電芯價格有任何上升或出現供應 短缺,將對本集團的盈利及生產成本造成重大 影響。

本集團已採取以下措施解決該等問題:

- (i) 定期對供應商進行調研及評估以確保原材 料的穩定供應;及
- (ii) 通過產線的自動化升級,本集團解決人力 的問題以及有效控制生產成本,對改善本 集團的盈利及控制生產成本有正面幫助。
- (B) 事故風險

重大事故,例如火災、自然災難或嚴重傳染病 會影響本集團資產及營運,進而影響集團的經 營能力及降低盈利。

Actions taken by the Group to address these issues include the following:

- ensure comprehensive insurance coverage over the Group's properties and business is purchased;
- provision of regular education and training sessions on safety for all staff to strengthen staff's awareness of production safety;
- training on fire safety, fire emergency evacuation and fire drill at workplace are organised at least twice a year to ensure staff have a solid understanding of the significance and necessity of production safety and improve their own awareness of safety protection; and
- (iv) organise physical examination for the benefit of its staff to help in assessing possible occupational and serious infectious diseases.

(C) INDUSTRY RISKS

The possible slowdown of the Chinese economy, the possible drop in global shipment of smartphones and the possible substantial decrease in consumers' demands for replacement of smartphones will have material adverse effects on the Group's business, financial position and operation results.

Actions taken by the Group to address these issues include the following:

- proactively pay attention to the application of lithium-ion batteries in new industries and new fields, grasp opportunities for access to the market and adjust the development strategy in response to changes in the market; and
- proactively build a platform for communication with consumers, pay close attention to consumers' demands, timely listen to consumers' opinions, and provide good products and aftersales services to increase customer loyalty.

本集團已採取以下措施解決該等問題:

- (i) 確保已為本集團財產及業務購買全面的保 險保障;
- (ii) 定期為全體員工提供安全教育及培訓課 程,強化員工安全生產意識;
- (iii) 每年至少組織兩次消防安全教育的培訓, 消防應急疏散及實地操作滅火演練,確保 員工深刻認識到安全生產重要性及必要 性,提高自身的安全防範意識;及
- (iv) 對其員工組織健康檢查,防止職業病及嚴 重傳染病的發生,以保障職工的健康安 全。
- (C) 行業風險

中國經濟可能放緩,智能手機的國際運送量可 能下降,且消費者對智能手機的更換需求可能 大幅減少,這將對本集團的業務、財務狀況及 經營業績產生重大不利影響。

本集團已採取以下措施解決該等問題:

- (i) 積極關注鋰離子電池在新行業及新領域的 應用,抓住市場機遇,調整發展戰略應對 市場變化;及
- (ii) 積極構建與消費者溝通的平台,密切關注 消費者的需求,及時聽取消費者的意見, 以及提供良好的產品及售後服務,提高客 戶忠誠度。

INSIDE INFORMATION

- is aware of its obligations under the Securities and Futures Ordinance and the Listing Rules;

- has implemented procedures for responding to external enquiries about the Group's affairs; and
- requires all employees of the Group to abide by the Code of Conduct and Inside Information Disclosure Policy to keep inside information in strict confidence and refrain from accepting personal benefits through the power or authority derived from their positions.

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers as set out in Appendix C3 of the Listing Rules (the "Model Code"). Having made specific enquiries of all Directors, the Company confirmed that all Directors have complied with the required standard as set out in the Model Code for the financial year ended 31 December 2024.

AUDITOR'S REMUNERATION

The Audit Committee is responsible for considering the appointment of the external auditor and reviewing any non-audit functions performed by the external auditor, including whether such non-audit functions could lead to any potential material adverse effect on the Company. During the Review Period, the Group paid approximately RMB1,368,000 to its external auditors, namely BDO Limited, and approximately RMB462,000 to its PRC auditor for their audit services. The Group paid approximately RMB246,000 to BDO Limited for their non-audit services in respect of the review of the interim financial information of the Group for the six months ended 30 June 2024.

If within 21 days of such deposit of the written requisition, the Board fails to proceed to convene such meeting, the requisitionist(s) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

CONSTITUTIONAL DOCUMENTS

There was no change to the constitutional documents of the Company during the year ended 31 December 2024.

STAKEHOLDERS

The continuing development and present scale of the Group were benefited from the trust and support of the stakeholders. We have been dedicating efforts not only to maximise the present value of the Group but also to maximise the interest and return for all parties so as to achieve harmonious development and collaboration with mutual benefits in the long run.

1. INVESTORS

The Group has always paid much attention to communication and interaction with investors, and continues to improve communication channels with shareholders and investors, so as to enhance governance transparency. The Group's management regularly meets with investors, and proactively announces the latest information and business development plans.

2. CONSUMERS

PRODUCT SAFETY

The Group has placed emphasis on the safety of products, especially on mobile phone batteries, and has implemented strict quality control such as the ISO standards so as to meet safety requirements. With our product testing centres, we administer stages of tests, including crash, high-temperature, damp and long period recharging, on our battery products. We also invest resources in product R&D to develop more reliable products. The battery products of the Group have also passed the stringent requirements on quality control and safety set by the relevant government authorities.

3. EMPLOYEES

OCCUPATIONAL SAFETY

The Group has focused on factory production safety, strived to enhance employees' safety knowledge and training, and increased factory fire prevention facilities and safety patrols, so as to ensure unobstructed fire passages and the availability of water in case of fire. In addition, the Group has regularly held fire drills and increased investments in fire prevention facilities in factories, so as to ensure the sufficiency of fire prevention equipment and facilities.

The Group has proactively taken and implemented various measures, including:

- increase factory fire prevention facilities and safety patrols (once a week), resolve problems in a timely manner and ensure unobstructed fire passages and the availability of water in case of fire;
- (ii) hold regular safety seminar and training for employees, especially for new staff, striving to enhance employees' hazard prevention and safety awareness;
- (iii) conduct at least two large scale fire drills every year and conduct general safety checks on such days;

- (iv) enhance factory management and divide it into safety responsibility districts, appoint safety examiners at the workshops with routine patrols, and eliminate potential problems in a timely manner; and
- (v) improve and formulate storage, safe keeping, transportation and processing procedures for flammables, and provide training for staff frequently in contact with such flammables.

ESTABLISHMENT OF OWN SKILL TRAINING INSTITUTE

Apart from occupational safety, the Group has also placed emphasis on providing on-the-job training for its staff. The Group started a comprehensive talent training programme, which is tied to the establishment of its own skill training institute. Talents are cultivated at the skill training institute and made available to the production pipeline to resolve the labour shortage issue faced by industry participants. After a period of training, the Group will allocate labour resources directly to various departments, which will shorten the time for staff replacement and reduce labour cost. Automated production will also be implemented at different phases. Moreover, in the training process, participating staff can understand the practical operation issues arising from the course of production, which will effectively enhance production efficiencies and gualities. The Group invites talents from society and selects personnel with the required management and technical expertise through professional and rigorous training processes. At the same time, this also brings to society a new generation of trained talents in fulfillment of the Company's social responsibilities.

- (iv) 加強廠房管理並劃分安全責任分區,於各 車間設安全檢查員進行日常巡視,一旦發 現隱患會及時消除;及
- (v) 改善並制定易燃物品的存放、保管、搬運 及處理流程,並對於在生產過程中經常接 觸該等易燃物品的員工展開培訓。

除注重職業安全外,本集團亦重視對員工提供 的在職培訓。本集團已全面啟動專才培訓計 劃,通過興辦自有技能培訓學校為本集團輸送 人才,從而解決行業內面臨的勞工短缺問題。 在經過一段時間的培訓之後,本集團將勞動力 直接輸送至本集團各部門,這不僅縮短了員工 更換的時間,降低了勞動力成本,更有助逐步 推行自動化的生產模式。此外,在培訓過程 中,參與員工可從生產過程中了解到實際操作 上的困難,有效地提高生產效率及質素。本集 團將廣納人才,通過專業嚴格的培訓,選拔出 本集團需要的管理和技術人才,同時也為社會 培育新生人才力量,盡企業之社會責任。

PROTECTION OF EMPLOYEES' LEGAL RIGHTS

The Group promotes and undertakes a fair and non-discriminative employment policy. Employees are employed on contract basis and employment contracts are signed based on principles of fairness and on employees' own volition, with clear provisions on contractual terms such as scope of work, remuneration, social insurance and working hours, among others. The legal rights and obligations of the employer and employee are clearly defined. We also strictly comply with the relevant laws and regulations in relation to national social insurance to set up insurance scheme for basic pension, medical, work-related injuries, unemployment and maternity for employees and cover the various insurance expenses. Meanwhile, to further protect the interests of individual employees, the Company has taken out a commercial accident insurance scheme for all employees. The Group has complied with the Labor Contract Law of the PRC since 1 January 2008 and established a labor union. We hold an employees' meeting every two weeks, in support of the construction and development of a harmonious and stable employee and employer relationship.

4. COMMUNITY

ENVIRONMENTAL PROTECTION

As a responsible enterprise, the Group has always put emphasis on supporting environmental protection. We strictly control the production procedures and reduce waste generation. Although small amounts of waste are generated during the packaging process, some of them are delivered to qualified recycling plants for treatment.

KEY AUDIT MATTER

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, we do not provide a separate opinion on these matters.

1. Impairment assessment of trade and notes receivables (Refer to notes 4(f), 5(iii), 21 and 42(a)(iv) to the consolidated financial statements)

As at 31 December 2024, the Group had trade and notes receivables with net carrying amount of approximately RMB1,665 million and a net impairment loss of approximately RMB11.9 million was recognised in profit or loss for the year ended 31 December 2024.

The directors of the Company have performed an impairment assessment on the trade and notes receivables in accordance with the Group's accounting policies which required the exercise of significant management judgement in considering factors such as the credit history including default or delay in payments, ageing analysis, settlement records during the year and subsequent settlements after the year end.

Our response

Our key procedures in relation to the directors' impairment assessment included:

- Understanding the Group's relationship and transaction history with the customers;
- Reviewing the ageing analysis of the trade and notes receivables;
- Reviewing payment patterns during the year and amount of subsequent settlements after the year end made by the customers;
- Assessing the reasonableness of the Group's estimation of recoverability of trade and notes receivables with reference to factors considered by the directors.
- Assessing the appropriateness of the expected credit loss provisioning methodology, examining the key data inputs on a sample basis to assess their accuracy and completeness, and challenging the assumptions, including both historical and forward-looking information, used to determine the expected credit losses.

關鍵審計事項

根據本核數師的專業判斷,關鍵審計事項為我們審 計於本期間的綜合財務報表中最重要的事項。我們 在審計綜合財務報表及就此達致意見時處理該等事 項,而不會就該等事項單獨發表意見。在這方面, 我們並無任何報告。

1. 應收貿易款項及應收票據的減值評估(請參閱 綜合財務報表附註4(f)、5(iii)、21及42(a)(iv))

於2024年12月31日,貴集團應收貿易款項及應收 票據的賬面淨值約為人民幣1,665,000,000元及截至 2024年12月31日止年度於損益確認減值虧損淨額約 人民幣11,900,000元。

貴公司董事已根據貴集團會計政策對應收貿易款項 及應收票據進行減值評估,其要求於考慮如信貸歷 史(包括付款違約或延遲、賬齡分析、年內結付記錄 及年後的後續回款)等因素時進行重大管理層判斷。

我們的應對措施

我們有關董事減值評估的關鍵程序包括:

- 了解貴集團與客戶的關係及交易歷史;
- 審閱應收貿易款項及應收票據的賬齡分析;
- 審閲客戶年內的付款方式及年後作出的後續回款金額;
- 經參考董事考慮的因素,評估貴集團對應收貿易款項及應收票據可收回性估計的合理性。
- 評估預期信貸虧損撥備方法之合理性、按樣品 基準檢測關鍵輸入數據以評估彼等之準確性及 完整性,及論證用於釐定預期信貸虧損之假設 (包括歷史及前瞻性資料)。

2. Impairment assessment of non-financial assets (Refer to notes 4(m) and 5(iv) to the consolidated financial statements)

As at 31 December 2024, the Group had property, plant and equipment, intangible assets, investment properties and right-ofuse assets with carrying amount of approximately RMB562 million, RMB2 million, RMB93 million and RMB9 million respectively. As the Group incurred a loss for the year, this has increased the risk that the carrying amounts of these assets may be impaired. Further, the market capitalisation of the Company of approximately RMB204 million fell below the net asset value of the Group of approximately RMB1,088 million as at 31 December 2024. These conditions constitutes impairment indicators on the Group's non-financial asset in accordance with International Accounting Standard 36. The directors of the Company have performed an impairment assessment on the cash-generating units in which these assets belonged to in accordance with the Group's accounting policies and concluded that, there was no impairment loss required for the year ended 31 December 2024.

Estimation of the recoverable amounts of the cash-generating units required the exercise of significant management judgement.

Our response

Our key procedures in relation to the directors' impairment assessment included:

- Assessing the appropriateness of methodology used for assessing the recoverable amounts; and
- Assessing the reasonableness of the underlying key assumptions used.

2. 非金融資產的減值評估(請參閱綜合財務報 表附註4(m)及5(iv))

於2024年12月31日,貴集團的物業、廠房及設備、無形資產、投資物業及使用權資產的賬面值分別約為人民幣562,000,000元、人民幣2,000,000元。 由於貴集團年內產生虧損,其增加了該等資產的賬 面值可能減值的風險。此外,貴公司市值約人民幣 204,000,000元低於貴集團於2024年12月31日的資 產淨值約人民幣1,088,000,000元。根據國際會計準 則第36號,該等狀況構成貴集團非金融資產減值指 標。貴公司董事已根據貴集團的會計政策對該等資 產所屬的現金產生單位進行減值評估,並認為截至 2024年12月31日止年度無需計提任何減值虧損。

估計現金產生單位的可收回金額須進行重大管理層 判斷。

我們的應對措施

我們有關董事減值評估的關鍵程序包括:

- 評估用於評估可收回金額的方法之適當性;及
- 評估所用相關關鍵假設的合理性。

In connection with our audit of the consolidated financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the consolidated financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

Share premium

The share premium account represents the excess of the issue price net of any issuance expenses over the par value of the shares issued and has been credited to the share premium account of the Company. The application of the share premium account is governed by Section 34 under the Companies Law of the Cayman Islands.

Capital reserve

The capital reserve of the Group represents the difference between the nominal amount of the shares issued by the Company and the aggregate amount of the paid-in capital of subsidiaries acquired plus the consideration received by the Company pursuant to the Group Reorganisation in preparation of the listing of the Company's shares.

Statutory reserve fund and enterprise expansion fund

Pursuant to relevant laws and regulations in the People's Republic of China (the "PRC") applicable to foreign investment enterprises and the Articles of Association of the PRC subsidiaries of the Company, these PRC subsidiaries are required to maintain two statutory reserves, namely a statutory reserve fund and an enterprise expansion fund which are non-distributable.

Scud (Fujian) Electronics Co., Ltd. ("Scud Electronics"), Scud Battery Co., Ltd. ("Scud Battery"), Shenzhen Hongde Battery Co., Ltd. ("Shenzhen Hongde"), Dongguan Hongde Battery Co., Ltd. ("Dongguan Hongde"), Scud Intelligent Technology Co., Ltd. ("Scud Intelligent Technology") (together the "PRC Subsidiaries") are required to transfer 10% of their respective profit after income tax as reported in the PRC statutory financial statements to the statutory reserve fund until the balance reaches 50% of their respective registered capital. Pursuant to the Articles of Association of the PRC Subsidiaries, they are also required to make appropriation from their respective profit after income tax as reported in the PRC statutory financial statements to the enterprise expansion fund at rates determined by their respective boards of directors.

The statutory reserve fund may be used to make up prior year losses incurred and, with the approval from the relevant government authorities, to increase capital for expansion of production of the PRC Subsidiaries. The enterprises expansion fund, subject to the approval by the relevant government authorities, may also be used to increase capital of the PRC Subsidiaries.

Translation reserve

Gain/loss arising on translating the net assets of foreign operations into presentation currency.

Retained profits

No dividend is proposed for the year ended 31 December 2024 and 2023. As at 31 December 2024, the balance of retained profits of the Group was RMB15,300,000 (2023: RMB29,014,000).

1. GENERAL

Veson Holdings Limited (the "Company"), is a public limited company incorporated in the Cayman Islands on 20 July 2006 as an exempted company with limited liability and its shares were listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") on 21 December 2006.

The Company's principal activity is investment holding and its subsidiaries are principally engaged in manufacture and sale of lithium-ion battery modules and related accessories for mobile phones, notebooks, tablets and digital electronic appliances, while also engaging in manufacture and sale of lithium-ion bare battery cells.

2. BASIS OF PRESENTATION

(a) Statement of compliance

The financial statements have been prepared in accordance with all applicable International Financial Reporting Standards, International Accounting Standards as issued by the International Accounting Standards Board ("IASB") and Interpretations issued by the International Financial Reporting Interpretations Committee of the IASB (hereinafter collectively referred to as the "IFRS Accounting Standards") and the disclosure requirements of the Hong Kong Companies Ordinance. In addition, the financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

(b) Basis of measurement

The financial statements have been prepared under the historical cost basis, except for notes receivables, and financial assets at fair value through other comprehensive income that have been measured at fair value. The measurement bases are fully described in the accounting policies below.

(c) Functional and presentation currency

The financial statements are presented in Chinese Renminbi ("RMB"), which is the same as the functional currency of the Company.

Inter-company transactions and balances between group companies together with unrealised profits are eliminated in full in preparing the consolidated financial statements. Unrealised losses are also eliminated unless the transaction provides evidence of impairment on the asset transferred, in which case the loss is recognised in profit or loss.

(b) Property, plant and equipment

Property, plant and equipment are stated at cost less accumulated depreciation and accumulated impairment losses.

The cost of property, plant and equipment includes its purchase price and the costs directly attributable to the acquisition of the items.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised.

Property, plant and equipment are depreciated so as to write off their cost net of expected residual value over their estimated useful lives on a straight-line basis. The useful lives, residual value and depreciation method are reviewed, and adjusted if appropriate, at the end of each reporting period. The useful lives are as follows:

Construction in progress is stated at cost less accumulated impairment losses. Cost comprises direct costs of construction as well as borrowing costs capitalised during the periods of construction and installation. Capitalisation of these costs ceases and the construction in progress is transferred to the appropriate class of property, plant and equipment when substantially all the activities necessary to prepare the assets for their intended use are completed. No depreciation is provided for in respect of construction in progress until it is completed and ready for its intended use.

An asset is written down immediately to its recoverable amount if its carrying amount is higher than the asset's estimated recoverable amount.

The gain or loss on disposal of an item of property, plant and equipment is the difference between the net sale proceeds and its carrying amount, and is recognised in profit or loss on disposal.

(c) Investment property

Investment property is property held either to earn rentals or for capital appreciation or for both, but not held for sale in the ordinary course of business, use in the production or supply of goods or services or for administrative purposes. Investment property is measured at cost on initial recognition less accumulated depreciation and accumulated impairment losses, if any.

Under the cost model, the Group measures the right-to-use at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liability.

Fair value through other comprehensive income ("FVTOCI"): Assets that are held for collection of contractual cash flows and for selling the financial assets, where the assets' cash flows represent solely payments of principal and interest, are measured at FVTOCI. Debt investments at FVTOCI are subsequently measured at fair value. Interest income calculated using the effective interest method, foreign exchange gains and losses and impairment are recognised in profit or loss. Other net gains and losses are recognised in other comprehensive income. On derecognition, gains and losses accumulated in other comprehensive income are reclassified to profit or loss.

The Group recognises loss allowances for ECLs on trade receivables, financial assets measured at amortised cost and debt investments measured at FVTOCI. The ECLs are measured on either of the following bases: (1) 12-months ECLs: these are the ECLs that result from possible default events within the 12 months after the reporting date; and (2) lifetime ECLs: these are ECLs that result from all possible default events over the expected life of a financial instrument.

ECLs are a probability-weighted estimate of credit losses. For other debt financial assets, the ECLs are based on the 12-months ECLs. However, when there has been a significant increase in credit risk since origination, the allowance will be based on the lifetime ECLs.

When determining whether the credit risk of a financial asset has increased significantly since initial recognition and when estimating ECLs, the Group considers reasonable and supportable information that is relevant and available without undue cost or effort. This includes both quantitative and qualitative information analysis, based on the Group's historical experience and informed credit assessment and including forward-looking information.

The Group assumes that the credit risk on a financial asset has increased significantly if it is more than 30 days past due.

Inventories are initially recognised at cost, and subsequently at the lower of cost and net realisable value. Cost comprises all costs of purchase, costs of conversion and other costs incurred in bringing the inventories to their present location and condition. Cost is calculated using the weighted average method. Net realisable value represents the estimated selling price in the ordinary course of business less the estimated costs necessary to make the sale.

(h) Revenue recognition

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services, excluding those amounts collected on behalf of third parties. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts.

Depending on the terms of the contract and the laws that apply to the contract, control of the goods or service may be transferred over time or at a point in time. Control of the goods or service is transferred over time if the Group's performance:

- provides all of the benefits received and consumed simultaneously by the customer;
- creates or enhances an asset that the customer controls as the Group performs; or
- does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

If control of the goods or services transfers over time, revenue is recognised over the period of the contract by reference to the progress towards complete satisfaction of that performance obligation. Otherwise, revenue is recognised at a point in time when the customer obtains control of the goods or service.

Deferred tax is recognised in respect of temporary differences between the carrying amounts of assets and liabilities for financial reporting purposes and the corresponding amounts used for tax purposes. Except for goodwill and recognised assets and liabilities that affect neither accounting nor taxable profits and does not give rise to equal taxable and deductible temporary differences, deferred tax liabilities are recognised for all taxable temporary differences. Deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences can be utilised. Deferred tax is measured at the tax rates appropriate to the expected manner in which the carrying amount of the asset or liability is realised or settled and that have been enacted or substantively enacted at the end of reporting period.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future.

Income taxes are recognised in profit or loss except when they relate to items recognised in other comprehensive income in which case the taxes are also recognised in other comprehensive income or when they relate to items recognised directly in equity in which case the taxes are also recognised directly in equity.

Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the translation of monetary items, are recognised in profit or loss in the period in which they arise.

On consolidation, income and expense items of foreign operations are translated into the presentation currency of the Group (i.e. RMB) at the average exchange rates for the year, unless exchange rates fluctuate significantly during the period, in which case, the rates approximating to those ruling when the transactions took place are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity as foreign exchange reserve (attributed to minority interests as appropriate). The preparation of consolidated financial statements in conformity with IFRS Accounting Standards requires the directors to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

The directors have considered the development, selection and disclosure of the Group's critical accounting policies and estimates. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets or liabilities are as follows:

(i) Useful lives and depreciation of property, plant and equipment and investment properties

The Group determines the estimated useful lives and related depreciation charges of its property, plant and equipment and investment properties. These estimates are based on the historical experience of the actual useful lives of property, plant and equipment and investment properties of similar nature and functions. The Group will increase the depreciation charge where useful lives are less than previously estimated lives, and will write-off or writedown technically obsolete or non-strategic assets that have been abandoned or sold. Actual economic lives may differ from estimated useful lives. Periodic review could result in a change in depreciable lives and therefore depreciation charges in future periods.

(ii) Net realisable value of inventories

Net realisable value of inventories is the estimated selling price in the ordinary course of business, less estimated costs of completion and variable selling expenses. These estimates are based on the current market condition and the historical experience of manufacturing and selling products of similar nature. It could change significantly as a result of changes in customer taste and competitor actions in response to any industry downturn. The directors reassess the estimations at the end of each reporting period.

(iii) Allowances for trade receivables and notes receivables

The Group uses a provision of matrix to calculate ECLs for trade and notes receivables. The provision rates are based on days past due for groupings of various debtors that have similar loss patterns. The provision matrix is based on management's estimate of the lifetime expected credit losses to be incurred, which is estimated by taking into account the credit loss experience, ageing of overdue fee receivables, customers' repayment history and customers' financial position and an assessment of both the current and forecast general economic conditions, all of which involve a significant degree of management judgement. The provision of ECLs is sensitive to changes in circumstances and of forecast general economic conditions. The information about the ECLs and the Group's trade and notes receivables are disclosed in Notes 21 and 42. If the financial condition of the customers or the forecast economic conditions were to deteriorate, actual loss allowance would be higher than estimated.

The Group assesses whether there are any indicators of impairment for property, plant and equipment, investment properties, intangible assets and right-of-use assets at the end of each reporting period. These assets are tested for impairment when there are indicators that the carrying amounts may not be recoverable. An impairment exists when the carrying value of an asset or a cash-generating unit exceeds its recoverable amount, which is the higher of its fair value less costs of disposal and its value in use. The calculation of the fair value less costs of disposal is based on available data from binding sales transactions in an arm's length transaction of similar assets or observable market prices less incremental costs for disposing of the asset. When value in use calculations are undertaken, the directors estimate the expected future cash flows from the asset or cash-generating unit and choose a suitable discount rate in order to calculate the present value of those cash flows.

(v) Deferred tax assets

Deferred tax assets are recognised for all unused tax losses to the extent that it is probable that taxable profit will be available against which the losses can be utilised. Significant judgement is required to determine the amount of deferred tax assets that can be recognised, based upon the likely timing and the level of future taxable profits together with future tax planning strategies.

During the year ended 31 December 2024, the Group transferred certain properties with an aggregate carrying amount of RMB2,390,000 (2023: RMB56,431,000) from property, plant and equipment to investment properties due to change in use of the properties from owner-occupation to leasing out.

The Group leased out certain buildings located in the PRC under operating lease to Scud Stock, where Mr. Fang Jin is the common controlling shareholder and has beneficial interest. The fair value of the building at 31 December 2024 amounted to RMB99,400,000 (2023: RMB109,900,000).

The fair value of the Group's investment properties at 31 December 2024 and 31 December 2023 has been arrived at on market value basis carried out by Ascent Partners Valuation Service Limited, an independent valuer who holds a recognised and relevant professional qualification and has recent experience in the location and category of the investment property being valued.

The fair value was determined based on the market comparison approach by reference to recent sales price of comparable properties on a price per square metre basis.

The fair value measurement of the Group's investment properties has been categorised into the three-level fair value hierarchy as defined in IFRS 13 "Fair value measurement". All of the fair values of the investment properties as at 31 December 2024 and 2023 is a level 3 recurring fair value measurement, which uses significant unobservable inputs in arriving at fair value. During the year ended 31 December 2024 and 2023, there were no transfers between level 1 and level 2, or transfers into or out of level 3.

Under the Arrangement between the Mainland China and Hong Kong Special Administration Region ("HKSAR") for the Avoidance of Double Taxation and the Prevention of Fiscal Evasion, or Mainland China/HKSAR Double Taxation Agreement, Hong Kong tax residents which hold 25% or more of a PRC enterprise are entitled to a reduced dividend withholding tax rate of 5%.

In addition, according to Cai Shui [2008] No.1, a circular jointly issued by the Ministry of Finance and State Administration of Taxation on 22 February 2008, distribution of dividends out of pre 2008 retained profits by a foreign investment enterprise to its foreign investor in or after 2008 is exempted from Enterprise Income Tax, whereas distribution of dividends out of profits generated by a foreign investment enterprise in or after 2008 shall be subjected to Enterprise Income Tax in accordance with the relevant articles of the PRC Enterprise Income Tax Law and its Detailed Implementation Rules as described above. Accordingly, dividends receivable from certain subsidiaries in respect of profits earned since 1 January 2008 is subject to 5% withholding tax.

(a) Financial risk management

The Group's activities expose it to a variety of financial risks, which include market risk (including foreign currency risk, interest rate risk and price risk), credit risk and liquidity risk. Details of the policies on how to mitigate these risks are set out below. The directors manage and monitor these exposures to ensure appropriate measures are implemented on a timely and effective manner.

(i) Interest rate risk management

Interest-bearing financial assets are mainly pledged bank deposits and bank balances which are all shortterm in nature and carry fixed interest rates. Interestbearing financial liabilities are mainly bank loans with fixed interest rates; therefore, the Group is not exposed to significant fair value interest rate risk due to the short maturity of the items. The Group currently does not have an interest rate hedging policy and will consider enter into interest rate hedging should the need arise.

Interest rate sensitivity analysis

The sensitivity analysis below has been determined assuming that a change in interest rates had occurred at the end of the reporting period and had been applied to the exposure to interest rates for financial instruments in existence at that date. A 1% increase or decrease is used when reporting interest rate risk internally to key management personnel and represents management's assessment of the reasonably possible change in interest rates.

This is mainly attributable to the Group's exposure, to interest rates on its variable rate bank balances, pledged bank deposits and bank loans.

The Group's bank balance also expose it to cash flow interest rate risk due to the fluctuation of the prevailing market interest rate on the bank balances. The directors consider the Group's exposure on the bank deposits is not significant as interest-bearing deposits are within short maturity periods in general.

The Group's sensitivity to interest rates has not changed significantly from prior year.

Foreign currency risk refers to the risk that movements in foreign currency exchange rates which will affect the Group's financial results and its cash flows. Although the Group has certain bank balances and bank loans denominated in United States dollars, Japanese Yen, Indian Rupee and Hong Kong dollars, the proportion of these foreign currency balances to the Group's total assets is insignificant. Furthermore, the Group carries out majority of its transactions in Chinese Renminbi. Accordingly, in the opinion of the directors, the Group is not exposed to any significant foreign currency risk.

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in financial loss to the Group. The Group's credit risk primarily relates to the Group's bank balances, trade and notes receivables, and other receivables. The maximum exposure to credit risk in the event that the counterparties fail to perform their obligations as at end of the financial year in relation to each class of recognised financial assets is the carrying amount of those assets as stated in the statement of financial position. In order to minimise the risk, management of the Group closely monitors overdue debts. The recoverable amount of each individual debt is reviewed at each of the reporting period and adequate allowance for doubtful debts has been made for irrecoverable amounts. In this regard, the directors of the Company consider that credit risk associated with the Group's trade and notes receivables, and other receivables is significantly reduced.

At the end of the reporting period, the Group has a certain level of concentration of credit risk as approximately 8.0% (2023: 22.7%) and approximately 73.8% (2023: 76.8%) of the total trade and notes receivables, arising from the Group's largest customer and the five largest customers, respectively.

The credit risk on bank balances is minimal because the counterparties are banks with high credit-rating.

The Group's concentration of credit risk by geographical location is mainly in the PRC.
