CHAIRMAN'S STATEMENT 主席報告

Dear Shareholders,

On behalf of the board (the "Board") of directors (the "Directors") of China Ever Grand Financial Leasing Group Co., Ltd. (the "Company"), I hereby present the annual report of the Company and its subsidiaries (collectively referred to as the "Group") for the year ended 31 December 2024 ("2024").

During 2024, the Group's revenue from continuing operations increased by 91.6% to HK\$101.0 million as compared to that of HK\$52.7 million for the year ended 31 December 2023 ("2023"). The Group's gross profit from continuing operations increased by 20.0% to HK\$21.3 million in 2024 as compared to that of HK\$17.8 million in 2023 and net loss from continuing operations increased by 100.0% to HK\$80.8 million in 2024 as compared to that of HK\$40.4 million in 2023.

The Group operated four segments during the year: Distribution Segment, Manufacturing Segment, Investment Segment and Financial Leasing Segment in the PRC and Hong Kong.

RESULTS OF OPERATIONS

The distribution segment recorded a net loss of HK\$19.3 million in 2024 (2023: HK\$5.0 million). The manufacturing segment recorded a net loss of HK\$4.7 million in 2024 (2023: HK\$4.6 million). The investment segment recorded a net loss of HK\$20.5 million in 2024 (2023: HK\$8.5 million). The financial leasing segment recorded a net loss of HK\$14.3 million (2023: profit of HK\$2.4 million). After accounted for (i) the corporate and other expenses and finance costs of HK\$19.9 million in 2024 (2023: HK\$25.8 million), (ii) a loss arising from share of results of certain associates of HK\$2.1 million in 2024 (2023: profit of HK\$0.5 million), (iii) a net loss from certain unallocated other income, gains and losses of HK\$85,000 in 2024 (2023: net gain of HK\$66,000), and (iv) income tax expense of HK\$19,000 in 2024 (2023: credit of HK\$0.5 million), the Group recorded a net loss from continuing operations of HK\$80.8 million (2023: HK\$40.4 million) and a net loss from continuing and discontinued operations of HK\$80.8 million in 2024 (2023: HK\$37.3 million). The increase in net loss was mainly due to the shared losses from associates, fair value loss on investment properties in the PRC, and impairment loss on goodwill.

致各位股東:

本人謹代表中國恒嘉融資租賃集團有限公司(「本公司」)董事(「董事」)會(「董事會」)提呈本公司及其附屬公司(統稱「本集團」)截至二零二四年十二月三十一日止年度(「二零二四年」)之年度報告。

於二零二四年,本集團持續經營業務收入為101,000,000港元,較截至二零二三年十二月三十一日止年度(「二零二三年」)的52,700,000港元增加91.6%。本集團二零二四年持續經營業務毛利為21,300,000港元,較二零二三年的17,800,000港元增加20.0%,而二零二四年持續經營業務淨虧損為80,800,000港元,較二零二三年的40,400,000港元增加100.0%。

本集團於本年度在中國及香港經營四個分部:分銷 分部、生產分部、投資分部及融資租賃分部。

經營業績

分銷分部於二零二四年錄得淨虧損19.300.000港元 (二零二三年:5,000,000港元)。生產分部於二零 二四年錄得淨虧損4,700,000港元(二零二三年: 4,600,000港元)。投資分部於二零二四年錄得淨虧 損20,500,000港元 (二零二三年:8,500,000港元)。融 資租賃分部錄得淨虧損14.300.000港元(二零二三 年:溢利2,400,000港元)。經計及(i)二零二四年企 業及其他支出以及財務成本19,900,000港元(二零 三年:25,800,000港元)、(ii)二零二四年分攤若干 聯營公司業績所得虧損2,100,000港元(二零二三 年:溢利500,000港元)、(iii)二零二四年若干未分配 其他收入、收益及虧損之淨虧損85,000港元(二零 二三年: 淨收益66,000港元) 及(iv)二零二四年所得稅 開支19,000港元(二零二三年:抵免500,000港元), 本集團於二零二四年錄得持續經營業務淨虧損 80,800,000港元 (二零二三年:40,400,000港元) 以及 持續及非持續經營業務淨虧損80.800.000港元(二零 L三年:37,300,000港元)。有關淨虧損增加乃主要 由於聯營公司分佔虧損、中國的投資物業之公平值 虧損及商譽減值虧損所致。

FUTURE OUTLOOK

Looking ahead, the Group will steadily expand its existing business, especially the distribution segment and the manufacturing segment . The Group continue to adopt a prudent approach to cautiously and diligently look for new potential growth opportunities and business expansion in order to diversify the income sources and attain a long-term growth.

MANAGEMENT DISCUSSION AND ANALYSIS

管理層討論及分析

BUSINESS REVIEW

During 2024, the Group's revenue from continuing operations increased by 91.6% to HK\$101.0 million as compared to that of HK\$52.7 million for 2023. The Group's gross profit from continuing operations increased by 20.0% to HK\$21.3 million in 2024 as compared to that of HK\$17.8 million in 2023 and net loss from continuing operations increased by 100.0% to HK\$80.8 million in 2024 as compared to that of HK\$40.4 million in 2023.

The Group operated four segments during the year: Distribution Segment, Manufacturing Segment, Investment Segment and Financial Leasing Segment in the PRC and Hong Kong.

Distribution Segment

Distribution Segment includes production, wholesale, distribution and trading of daily necessities, medical products, health products and hygiene products in Hong Kong. Its revenue increased by 105.7% to HK88.4 million in 2024 as compared to that of HK\$42.9 million in 2023. Such increase was mainly due to the fact that (i) sales of health and wellness products under our own brand increased; and (ii) sale of traditional Chinese medical products was driven by stabilised supply from the manufacturer. This segment recorded a net loss of HK\$19.3 million in 2024, representing an increase of 288.7% as compared to that of HK\$5.0 million in 2023. The loss increase was mainly due to an impairment loss on goodwill of HK\$15.0 million recognised in 2024. The goodwill impairment loss was primarily driven by a decline in the averaged profit margins projected in the approved five-year financial forecasts for 2024 (2024: 6.6%; 2023: 12.7%). This decline reflects the impact of rising operating costs - such as those associated with the sales of health products - and slower-than-anticipated market growth influenced by shifting consumer preferences, intensified competition, and broader economic factors. These challenges reduced the recoverable amount as determined by the value-in-use assessment, resulting in a deficit when compared to the carrying value of the relevant cash-generating unit (CGU).

Manufacturing Segment

Manufacturing Segment includes manufacturing and sale of food products and nutrient enhancers such as meal replacements partly made of Chlamydomonas Reinhardtii and other nutrient enhancers. A brand-new production line of healthy food products launched in the fourth quarter of 2024. During 2024, it recorded revenue of HK\$6.4 million (2023: HK\$2.9 million) and a net loss of HK\$4.7 million (2023: HK\$4.6 million). The increase in its revenue was mainly due to broaden product diversity and customer base.

業務回顧

於二零二四年,本集團持續經營業務收入為101,000,000港元,較二零二三年的52,700,000港元增加91.6%。本集團二零二四年持續經營業務毛利為21,300,000港元,較二零二三年的17,800,000港元增加20.0%,而二零二四年持續經營業務淨虧損為80,800,000港元,較二零二三年的40,400,000港元增加100.0%。

本集團於本年度在中國及香港經營四個分部:分銷分部、生產分部、投資分部及融資租賃分部。

分銷分部

分銷分部包括於香港進行生產、批發、分銷及買 賣日用品、醫療保健及衛生產品。二零二四年, 該分部的收入為88,400,000港元,較二零二三年的 42.900.000港元增加105.7%。有關增加主要由於(i) 我們自有品牌旗下的健康及保健產品的銷售額增 加;及(ii)製造商的穩定供應推動傳統中醫藥產品的 銷售。二零二四年,該分部錄得淨虧損19,300,000港 元,較二零二三年的5.000.000港元增加288.7%。虧 損增加主要由於二零二四年確認的商譽減值虧損 15.000.000港元所致。商譽減值虧損主要由於經批 准二零二四年五年財務預測的預計平均利潤率(二 零二四年:6.6%;二零二三年:12.7%)下降所致。 該下降反映了經營成本(如與銷售保健產品有關的 成本)不斷上漲、受消費者偏好轉變影響市場增長 低於預期、競爭加劇及更廣泛的經濟因素的影響。 利用使用價值評估釐定的可收回金額因該等挑戰 而有所減少,導致較相關現金產生單位的賬面值出 現虧絀。

生產分部

生產分部包括食品產品及營養強化劑生產及銷售,例如部分由萊茵衣藻及其他營養強化劑製成的代餐食品。於二零二四年第四季度推出一條健康食品產品的全新生產線。該分部於二零二四年錄得收入6,400,000港元(二零二三年:2,900,000港元)及淨虧損4,700,000港元(二零二三年:4,600,000港元)。該分部的收入增加主要由於拓寬產品多樣性及客戶基礎所致。

Investment Segment

Revenue from the Investment Segment decreased by 9.7% to HK\$6.2 million in 2024 as compared to that of HK\$6.8 million in 2023. This segment recorded a net loss of HK\$20.5 million in 2024 as compared to that of HK\$8.5 million in 2023. Such increase in loss of HK\$11.9 million was mainly due to the fair value loss on PRC investment properties of HK\$21.0 million in 2024 (2023: HK\$8.0 million).

Financial Leasing Segment

In 2024, Beijing Ever Grand International Financial Leasing Co. Ltd. ("BJEG") and its subsidiaries ("BJEG Group"), responsible for the Financial Leasing Segment, continued as an associate of the Group for the first seven-month period ended 31 July 2024, following its deconsolidation on 31 July 2023. However, it was subsequently reclassified as equity investments at fair value through other comprehensive income ("FVTOCI") due to Director, who held the board seat in BJEG, was no longer served for and acting for the Group on 1 August 2024. Accordingly, the Financial Leasing Segment only reflected its results for the first seven-month period of 2024, whereas it covered the period from 1 August 2023 to 31 December 2023 in the comparative figures for last year. This segment recorded a net loss of HK\$14.3 million in 2024 as compared to profit of HK\$2.4 million in 2023. The loss from this associate in 2024 was mainly arising from interest costs from finance lease and the fair value loss on financial assets at FVTPL.

After taking into account of the corporate and other expenses and finance costs of HK\$19.9 million in 2024 (2023: HK\$25.8 million), a loss arising from share of results of associates (excluding the associate under Financial Leasing Segment) in 2024 of HK\$2.1 million (2023: profit of HK\$0.5 million), a net loss from certain unallocated other income, gains and losses of HK\$85,000 in 2024 (2023: the net gain of HK\$66,000), income tax expense of HK\$19,000 in 2024 (2023: credit of HK\$0.5 million), the Group recorded a net loss from continuing operations attributable to the owners of the Company of HK\$80.8 million (2023: HK\$40.4 million) and a net loss from continuing and discontinued operations of HK\$80.8 million in 2024 (2023: HK\$37.3 million). The increase in net loss from continuing operations was mainly due to significant increase in fair value loss on investment properties in the PRC, the poor operating performance of associates in 2024 compared with 2023 and the impairment loss on goodwill recognised in 2024 whereas no such impairment in 2023.

投資分部

二零二四年,投資分部收入為6,200,000港元,較二零二三年的6,800,000港元減少9.7%。二零二四年,該分部錄得淨虧損20,500,000港元,而二零二三年則為8,500,000港元。有關虧損增加11,900,000港元乃主要由於二零二四年中國的投資物業之公平值虧損21,000,000港元(二零二三年:8,000,000港元)所致。

融資租賃分部

於二零二四年,負責融資租賃分部的北京恒嘉國際 融資租賃有限公司(「北京恒嘉」)及其附屬公司(「北 京恒嘉集團」)於二零二三年七月三十一日終止綜合 入賬後於截至二零二四年七月三十一日止首七個 月期間仍為本集團聯營公司。然而,其隨後於二零 二四年八月一日因擁有北京恒嘉董事會席位的董 事不再於本集團任職及為本集團行事,所以被重新 分類為按公平值透過其他全面收入列賬 (「按公平值 透過其他全面收入列賬」)之股權投資。因此,融資 租賃分部僅反映其於二零二四年首七個月期間的 業績,而上一年度之比較數字覆蓋自二零二三年八 月一日起至二零二三年十二月三十一日止期間。該 分部於二零二四年錄得淨虧損14,300,000港元,而 二零二三年則為溢利2,400,000港元。二零二四年來 自該聯營公司之虧損主要由於融資租賃的利息成 本及按公平值透過損益列賬之金融資產之公平值 虧損所致。

經計及二零二四年企業及其他支出以及財務成本 19,900,000港元 (二零二三年:25,800,000港元)、二 零二四年分攤聯營公司(不包括融資租賃分部項 下的聯營公司)業績所得虧損2,100,000港元(二零 二三年:溢利500,000港元)、來自二零二四年若干 未分配其他收入、收益及虧損的淨虧損85,000港元 (二零二三年:淨收益66,000港元)、二零二四年所 得稅開支19,000港元 (二零二三年:抵免500,000港 元),本集團於二零二四年錄得本公司擁有人應佔 持續經營業務淨虧損80,800,000港元(二零二三年: 40,400,000港元) 及持續及非持續經營業務淨虧損 80,800,000港元 (二零二三年:37,300,000港元)。持 續經營業務淨虧損增加乃主要由於二零二四年中 國的投資物業之公平值虧損大幅增加、聯營公司經 營業績較二零二三年不佳及於二零二四年確認商 譽減值虧損,而於二零二三年並無該等減值所致。

MANAGEMENT DISCUSSION AND ANALYSIS 管理層討論及分析

Revenue and gross profit

The Group's revenue from continuing operations increased by 91.6% to HK\$101.0 million in 2024 as compared to that of HK\$52.7 million in 2023. The revenue from the sale of daily necessities, medical products, health products and hygiene products increased by 105.7% to HK\$88.4 million in 2024 as compared to that of HK\$42.9 million in 2023. Such increase was mainly due to the increase in sales of a traditional Chinese medical product and the own brand healthcare products. Sales of food products and nutrient enhancers increased by 119.8% to HK\$6.4 million in 2024 as compared to that of HK\$2.9 million in 2023. Rental income from investment properties in the PRC was increased by 6.8% to HK\$6.2 million in 2024 as compared to that of HK\$5.8 million in 2023.

The Group's gross profit from continuing operations increased by 20.0% to HK\$21.3 million in 2024 as compared to that of HK\$17.8 million in 2023. The gross profit margin, however, was dropped from 33.7% in 2023 to 21.1% in 2024, because of increase in sale of products with lower gross profit margin.

Other income

Other income from continuing operations of HK\$166,000 in 2024 (2023: HK\$1.8 million) was mainly from interest income from fixed bank deposits.

Other gains and losses

Other gains and losses from continuing operations in 2024 were a net loss of HK\$25.6 million (2023: HK\$12.9 million), mainly comprising of the fair value loss on investment properties of HK\$21.0 million (2023: HK\$8.0 million), a gain on the disposal of Shanghai property of HK\$1.1 million and a loss on deemed disposal of associates of HK\$3.4 million (2023: HK\$0.7 million).

Administrative expenses and other operating expenses

The Group's administrative and other operating expenses from continuing operations decreased by 7.3% to HK\$44.7 million in 2024 as compared to that of HK\$48.2 million in 2023. These mainly included staff costs (including directors' and chief executive's emoluments) from continuing operations of HK\$22.0 million (2023: HK\$24.5 million), legal and professional fees, depreciation of property, plant and equipment and various administrative expenses.

收入及毛利

二零二四年,本集團持續經營業務收入為101,000,000港元,較二零二三年的52,700,000港元增加91.6%。二零二四年,銷售日用品、醫療保健及衛生產品收入為88,400,000港元,較二零二三年的42,900,000港元增加105.7%。有關增加乃主要由於傳統中醫藥產品及自有品牌保健產品的銷售額增加所致。二零二四年,食品產品及營養強化劑的銷售額為6,400,000港元,較二零二三年的2,900,000港元增加119.8%。二零二四年,來自中國的投資物業租金收入為6,200,000港元,較二零二三年的5,800,000港元增加6.8%。

二零二四年,本集團來自持續經營業務的毛利為 21,300,000港元,較二零二三年的17,800,000港元增 加20.0%。然而,毛利率自二零二三年的33.7%跌至 二零二四年的21.1%,乃因較低毛利率產品的銷量 增加。

其他收入

二零二四年,來自持續經營業務的其他收入為 166,000港元(二零二三年:1,800,000港元),主要來 自銀行定期存款的利息收入。

其他收益及虧損

二零二四年,來自持續經營業務的其他收益及虧損為淨虧損25,600,000港元(二零二三年:12,900,000港元),主要包括投資物業之公平值虧損21,000,000港元(二零二三年:8,000,000港元)、出售上海物業之收益1,100,000港元及視作出售聯營公司之虧損3,400,000港元(二零二三年:700,000港元)。

行政開支及其他經營開支

二零二四年,本集團來自持續經營業務之行政及 其他經營開支為44,700,000港元,較二零二三年的 48,200,000港元減少7.3%。其主要包括來自持續經 營業務的員工成本(包括董事及主要行政人員薪酬) 22,000,000港元(二零二三年:24,500,000港元)、法 律及專業費用、物業、廠房及設備折舊以及各項行 政開支。

Share of associates' results

The share of results of associates amounted to a loss of HK\$13.0 million in 2024 as compared with a profit of HK\$2.9 million in 2023. The Group shared a loss of BJEG of HK\$11.0 million (2023: profit of HK\$2.4 million), a loss of Top Insight Holdings Limited of HK\$2.2 million (2023: profit of HK\$0.9 million) and a profit of Simagi Finance Company Limited of HK\$118,000 (2023: loss of HK\$0.5 million) in 2024.

Investment in BJEG Group was reclassified as equity investments at FVTOCI on 1 August 2024 due to loss of significant influence over BJEG on that date. For more details, please refer to note 3 to the consolidated financial statements.

Income taxation

Income tax expense from continuing operations in 2024 was HK\$19,000 (2023: credit of HK\$479,000), mainly comprising of provision for current tax of HK\$22,000 in the PRC and over-provision for tax in 2023 of HK\$3,000 in Hong Kong.

Discontinued operation

The results of BJEG Group were classified as discontinued operation upon deconsolidation and presented as a single line item in the consolidated statement of profit or loss for 2023. Net profit from discontinued operation amounted to HK\$3.1 million in 2023.

FINANCIAL POSITION

The total assets of the Group as at 31 December 2024 amounted to HK\$392.5 million, representing a decrease of HK\$110.3 million or 22.0% as compared with HK\$502.8 million as at 31 December 2023. The decrease in total assets was mainly due to the fact that the fair value loss on investment properties in the PRC, the poor operating performance of associates and an impairment loss on goodwill in 2024. The total liabilities of the Group as at 31 December 2024 amounted to HK\$51.6 million, representing an increase of HK\$1.7 million or 3.4% as compared with HK\$49.9 million as at 31 December 2023. There was no material change in total liabilities in 2024.

The gearing ratios (which is calculated from total liabilities over total assets) sightly increased from 9.9% as at 31 December 2023 to 13.1% as at 31 December 2024. The current ratios (which is calculated from total current assets over total current liabilities) decreased from 2.0 as at 31 December 2023 to 1.4 as at 31 December 2024.

分攤聯營公司業績

二零二四年,分攤聯營公司業績為虧損13,000,000港元,而二零二三年為溢利2,900,000港元。本集團於二零二四年分攤北京恒虧損11,000,000港元(二零二三年:溢利2,400,000港元),分攤Top Insight Holdings Limited虧損2,200,000港元(二零二三年:溢利900,000港元)及分攤Simagi Finance Company Limited溢利118,000港元(二零二三年:虧損500,000港元)。

由於於二零二四年八月一日喪失對北京恒嘉的重大影響力,於北京恒嘉集團的投資於該日期重新分類為按公平值透過其他全面收入列賬之股權投資。 更多詳情請參閱綜合財務報表附註3。

所得稅

二零二四年,來自持續經營業務之所得稅開支為19,000港元(二零二三年:抵免479,000港元),主要包括中國即期稅項撥備22,000港元及二零二三年於香港的稅項超額撥備3,000港元。

非持續經營業務

北京恒嘉集團的業績於終止綜合入賬後分類為非 持續經營業務且於二零二三年的綜合損益表中 單獨呈列。二零二三年非持續經營業務的純利為 3,100,000港元。

財務狀況

本集團於二零二四年十二月三十一日之總資產為392,500,000港元,較二零二三年十二月三十一日的502,800,000港元減少110,300,000港元或22.0%。總資產減少乃主要由於二零二四年中國的投資物業之公平值虧損、聯營公司經營業績不佳及商譽減值虧損所致。本集團於二零二四年十二月三十一日之總負債為51,600,000港元,較二零二三年十二月三十一日的49,900,000港元增加1,700,000港元或3.4%。二零二四年的總負債並無重大變動。

資本負債比率(按總負債除以總資產計算)由二零二三年十二月三十一日之9.9%微幅增加至二零二四年十二月三十一日之13.1%。流動比率(按流動總資產除以流動總負債計算)由二零二三年十二月三十一日之2.0減少至二零二四年十二月三十一日之1.4。

LIQUIDITY AND FINANCIAL RESOURCES

As at 31 December 2024, the Group had cash and cash equivalents and deposits placed with non-bank financial institutions totalling of approximately HK\$13.2 million (2023: HK\$28.4 million). As at 31 December 2024, the Group had the short-term bank borrowing amounting to HK\$2.8 million (2023: Nil).

For the year under review, the Group has financed its operations with facilities provided by banks and other non-bank financial institutions and internally generated cash flows.

FOREIGN EXCHANGE EXPOSURE

In the both reporting periods, the Group had no material exposure to fluctuation in exchange rates in foreign currency as material transactions such as revenue and cost of revenue were denominated in local currencies in which the relevant entities operated. The Group did not enter into any foreign exchange hedging transactions or instruments during both years.

CREDIT EXPOSURE

The Group's major credit risk is primarily attributable to loan receivables. It is mostly derived from money lending services, namely the loan financing services carried out by TF Advances Limited ("TF Advances") in Hong Kong.

The loan financing services in Hong Kong

Business model

TF Advances is a company incorporated in Hong Kong and a licenced money lender under the Money Lender Ordinance (Chapter 163 of the Laws of Hong Kong), which principally engages in the provision of loan financing service in Hong Kong by providing unsecured or secured loan to its customers. TF Advances generally utilises its internal working capital as the loan principal. TF Advances's target customers in Hong Kong include individuals and institutional clients. Most loan transactions of TF Advances in Hong Kong are sought after through (a) referrals from its existing customers or business partners, and (b) business connections of the Group's senior management.

流動資金及財務資源

於二零二四年十二月三十一日,本集團之現金及 現金等值物以及存放於非銀行金融機構之存款合 共約為13,200,000港元(二零二三年:28,400,000港元)。於二零二四年十二月三十一日,本集團之短期 銀行借款為2,800,000港元(二零二三年:無)。

於回顧年內,本集團以銀行及其他非銀行金融機構 提供之融資及內部產生現金流量為其業務營運撥 付資金。

外匯風險

於兩個報告期間,本集團並無重大外幣匯率波動風險,乃由於重大交易如收入及收入成本乃以相關實體營運所在之當地貨幣計值。本集團於兩個年度並無訂立任何外匯對沖交易或工具。

信貸風險

本集團的主要信貸風險主要由應收貸款而引致。該 風險主要源自放貸服務,即TF Advances Limited (「TF Advances」) 在香港開展的貸款融資服務。

香港境內的貸款融資服務

業務模式

TF Advances為一家於香港註冊成立的公司,並為香港法例第163章放債人條例項下的持牌放債人,主要通過向客戶提供無抵押貸款或有抵押貸款於香港從事提供貸款融資服務。TF Advances通常將其內部營運資金用作貸款本金。TF Advances在香港的目標客戶包括個人和機構客戶。TF Advances在香港的大部分貸款交易乃透過以下方式獲得:(a)現有客戶或業務合作夥伴推薦及(b)本集團高級管理層的商業網絡。

Internal control procedures

Credit risk assessment of customers

TF Advances has taken the following internal control measures in carrying out the loan financing business:

(i) An eligible client could be a corporate or an individual whose creditworthiness and loan collateral are evaluated and approved by the finance department, legal department and the chief executive officer of TF Advances (collectively, the "Management Team"). All the loans will be required to be further approved by the Board if an applied loan amount is over HK\$25 million or an amount that would trigger the disclosure or shareholder's approval obligation of the Company under the Chapter 13, 14 or 14A of the Rules Governing the Listing of Securities (the "Listing Rules") on The Stock Exchange of Hong Kong Limited (the "Stock Exchange"), whichever is the lower (collectively, the "Threshold").

Upon receiving the applicant's particulars and loan terms documented in a loan application form, TF Advances will obtain proof of identity, background and contact details from the applicant for verification. TF Advances will also conduct background search and credit search against the applicants and guarantor (in case of any personal or corporate guarantee). TF Advances will also follow the anti-money laundering and terrorist financing prevention procedures in the course of collection and verification of information about their backgrounds. If there is any collateral such as pledge of real estate property, TF Advances will perform preliminary valuation and validity check on the legal titles of the collateral to be pledged. In case of low liquidity of the collateral, we may consider engaging independent surveyor or valuer to conduct a valuation.

Mechanism in determining loan terms

- (ii) The operation team of TF Advances will determine the offer terms of the loan such as the amount and the interest rate of the loan and the period of repayment, on a case-by-case basis considering the applicant's background and other factors (if applicable) such as the following:
 - a) Tenor of the loan;
 - b) Any personal or corporate guarantee;
 - Any encumbrances on the collateral and its liquidity and marketability;
 - d) Valuation of the mortgaged real estate (if any);
 - e) Salary income proof, duration of current employment, personal net worth for individual customers;

內部控制程序

客戶信貸風險評估

在開展貸款融資業務過程中,TF Advances已採取如下內部控制措施:

(i) 合資格客戶可為公司或個人,TF Advances的 財務部、法務部和行政總裁(統稱「管理層團 隊」)會對其信譽和貸款抵押品進行評估和 審批。若所申請貸款金額超過25,000,000港 元或會觸發香港聯合交易所有限公司(「聯 交所」)證券上市規則(「上市規則」)第十三、 十四或十四A章項下本公司之披露或股東 批准責任的金額,以較低者為準(統稱「閾 值」),則所有貸款均須通過董事會的進一步 審批。

在接獲貸款申請表中記錄的申請人詳細資料和貸款條款後,TF Advances將取得申請人的身份證明、背景和聯繫方式以進行核實。TF Advances亦將對申請人和擔保人(若涉及任何個人或公司擔保)展開背景調查和信用調查。在收集和核實有關彼等背景的資料過程中,TF Advances亦會遵循防止洗錢和恐怖主義融資的程序。若存在不動產質押等抵押品,TF Advances會對被質押的抵押品的法定權屬進行初步估值和有效性核查。倘抵押品流動性較低,我們可能會考慮委聘獨立測量師或估值師進行估值。

貸款期限釐定機制

- (ii) TF Advances的營運團隊會逐一釐定貸款的 要約條款,例如貸款金額、利率及還款期限 等,在此過程中會考慮申請人背景及其他 一些因素(如適用),諸如以下各項:
 - a) 貸款年期;
 - b) 任何個人或公司擔保;
 - c) 抵押品是否存在任何產權負擔以及 其流動性和可銷性;
 - d) 所抵押不動產的估價(如有);
 - e) 個人客戶的工資收入證明、當前受 僱期、個人淨資產;

- Financial position and performance on the latest auditor's report/management accounts;
- g) Proposed use of proceeds; and/or
- h) Benchmarking performed by obtaining quotations of the prospective loans in kind by other peers.

After collecting all necessary information about the applicants and the loans, a credit assessment form will be completed and submitted to the Management Team for approval.

Approval process for granting loans

(iii) The Management Team will approve the application if they think fit based on the results of the background checks, borrower's/guarantor's repayment ability, and legal searches and valuation of collateral. Prior to the approval of the application, the Management Team may also consult the independent non-executive directors of the Company ("INEDs") for their independent view and professional judgement on the loan application. In addition, the financial controller of the Company will assess the cash position of the Company to ensure the sufficiency of working capital of the Company.

It is a policy of TF Advances that the loan amount should normally not be more than 100% of the market value of the collateral and/or not be more than 5-years of total forecasted salary income/net profits. Should there be any shortfall, TF Advances may request personal guarantees from the borrower's directors and/or ultimate beneficial shareholders (in case the borrower is a company). Additional approval from the Board is required when the applied loan amount exceeds the Threshold.

After obtaining the internal approval, TF Advances will enter into the loan agreements with the borrowers and/or guarantors. TF Advances may also instruct it external legal consultant for the preparation and execution of the required legal documents.

在收集齊有關申請人和貸款的一切必要資料後,將填寫信用評估表並提交至管理層 團隊,以供審批。

貸款審批流程

(iii) 管理層團隊會根據背景調查、借款人/擔保人還款能力評估以及對抵押品的法律搜索和估值的結果在認為合適的情況下批准貸款申請。於申請獲批前,管理層團隊亦可就貸款申請向本公司獨立非執行董事(「獨立非執行董事」)徵詢獨立意見及專業判斷。此外,本公司財務總監會對本公司的現金狀況進行評估,以確保本公司具備充足營運資金。

TF Advances的政策是,一般情況下,貸款金額不超過抵押品市值的100%及/或不超過5年的預計工資收入/純利總額。若有任何不足,TF Advances可要求借款人的董事及/或最終實益股東(若借款人為公司)提供個人擔保。當所申請貸款金額超過閾值時,需要獲得董事會的額外批准。

於獲得內部批准後,TF Advances會與借款人 及/或擔保人簽訂貸款協議。TF Advances亦 可授意其外部法律顧問擬備及簽立所需法 律文件。

Monitoring loan repayment and recovery

(iv) Upon the loan agreements being entered into, the finance department of TF Advances will mark the date of repayments of each loan. One week before the payment due date, a notice for demand is served to borrower. When it is overdue, an overdue notice will be brought to the attention of senior management of TF Advances for further consideration.

At each year end, a valuation of collateral is performed to ensure the sufficiency of loan-to-value ratio at least reaching 100%. At each end date of the bi-annual reporting period on 30 June and 31 December of each year, the finance department of TF Advances will obtain an updated statement of collaterals or financial statements of borrower and guarantors (if any) for evaluation of credit worthiness.

Taking actions on delinquent loans

(v) When the loan is overdue, the finance department of TF Advances will contact the borrower and guarantor (if any) to remind them of the possible enforcement action(s) and timing of repayment and seeking reasons for the delay in payment. Depending on the reasons given by the borrower, TF Advances may at its discretion grant some time extension for a period usually not exceeding 3 months.

When the loan is overdue for more than 1 month, a written notice for demanding repayment will be served to the borrower and guarantor (if any).

When the loan is overdue for more than 3 months, a demand letter will be served to the borrower and guarantor (if any). If no concrete response is received, legal proceedings may be commenced against the borrower and guarantor (if any). TF Advances may also apply to court for freezing and/or disposing of the collaterals.

Normally settlement proposals like rescheduling the repayment schedule would be negotiated between the defaulted customer and TF Advances. However, such repayment schedule shall be approved by the director(s) of TF Advances. Further approval from the Board will be required, if the repayment proposal involves a change in principal terms of any transaction which exceeds the Threshold or triggers any other requirements under the Listing Rules.

監察貸款償還及收回情況

(iv) 於簽訂貸款協議後,TF Advances的財務部會標記每筆貸款的還款日期。借款人會在還款到期日前一週收到催款通知。若還款逾期,逾期通知將被提交至TF Advances高級管理層以供進一步考慮。

抵押品每年年末會進行估值,以確保貸款價值比率充足,至少達到100%。於每年六月三十日及十二月三十一日的各半年度報告期結算日,TF Advances的財務部會取得最近期的抵押品報表或借款人及擔保人(如有)的財務報表,以評估信用度。

對拖欠貸款採取行動

(v) 貸款若遭拖欠,TF Advances的財務部會聯繫借款人及擔保人(如有),提醒彼等可能採取強制執行行動以及還款時間,並追問延遲還款的原因。根據借款人給出的理由,TF Advances可酌情授予緩衝期,惟通常不超過3個月。

逾期1個月以上的貸款,將會書面通知借款 人及擔保人(如有)要求還款。

逾期3個月以上的貸款,將向借款人及擔保人(如有)送達催款函。若未能得到明確答覆,可對借款人及擔保人(如有)提起法律訴訟。TF Advances亦可向法院申請凍結及/或處置抵押品。

通常情況下,違約客戶與TF Advances之間會 磋商還款展期之類的和解方案。然而,還款 展期須通過TF Advances董事的審批方可作 實。若還款方案涉及變更任何交易的主要 條款,以致超出閾值或觸發上市規則項下 的任何其他規定,則須取得董事會的進一 步批准。

Basis of Assessment of ECL

ECL assessment on receivables are performed individually based on probability-weighted expected credit losses of multiple possible events ("PWECL") model adopted in accordance with HKFRS 9, which involves 5 key parameters, namely (i) exposure at default ("EAD"); (iii) probability of default ("PD"); (iii) loss given default ("LGD") or 100% minus recovery rate upon default ("Recovery Rate"); (iv) forward-looking factor; and (v) discount factor. The depth of PWECL model depends on the year end status of recoverability of each receivables which are classified into 3 stages from the lowest stage 1 to the highest stage 3 summarised as below and further set out in note 34 to the consolidated financial statements. References are made to the Company's announcement dated 3 September 2021 for capital terms used and further details.

CHARGE OF ASSETS

As at 31 December 2024, there was no charge on the asset (2023: Nil).

CONTINGENT LIABILITIES

As at 31 December 2024, the Group had no significant contingent liabilities (2023: Nil).

CAPITAL COMMITMENTS

As at 31 December 2024, the Group had capital commitments of HK\$134,000 (2023: HK\$1.1 million) for the acquisition of property, plant and equipment.

PROSPECT

The Group primarily focuses on its operations in the PRC and Hong Kong, making the economic, political, and social aspects of these jurisdictions crucial to its overall performance. As of 2025, Hong Kong's economy faces significant challenges, including weak domestic consumption and a sluggish property market. However, the local stock market has shown signs of recovery, and the unemployment rate remains stable at around 3%. These mixed signals highlight the need for cautious optimism in navigating the local economic landscape.

Similarly, the PRC continues to grapple with weak domestic consumption and a persistently sluggish property market, although exports remain a promising driver of growth. The Sino-US geopolitical tensions and global protectionism pose substantial risks to China's economy. In response, the Chinese government has introduced various supportive measures, such as subsidies for replacing old electronic appliances and loosening fiscal policies, to counteract external threats, stimulate domestic demand and nurturing the high-end technology sector. These present thrilling opportunities amidst the uncertainties and the market turbulence.

The Distribution Segment aims to increase volume by diversifying products, expanding distribution channels, and broadening its customer base across various territories.

資產抵押

資本承擔

於二零二四年十二月三十一日,本集團就收購物業、廠房及設備作出資本承擔134,000港元(二零二三年:1,100,000港元)。

前景

本集團主要專注於中國及香港的營運,故該等司法管轄區的經濟、政治及社會狀況對本集團的整體表現至關重要。截至二零二五年,香港經濟面臨重大挑戰,包括當地消費疲軟及房地產市場低迷。然而,當地股票市場呈現復甦跡象,失業率維持穩定在3%左右。該等複雜信號表明須以審慎樂觀的態度展望當地的經濟前景。

同樣,儘管出口仍是可靠的增長動力,中國繼續面臨國內消費疲軟及房地產市場持續低迷的問題。中美地緣政治緊張及全球貿易保護主義令中國經濟面臨重大風險。為此,中國政府出台多種支持措施,如家電以舊換新補貼以及放寬財政政策,以抵禦外部威脅,拉動內需並扶持高端科技行業。該等措施在不確定性及市場波動中帶來振奮人心的機會。

分銷分部旨在透過多樣化產品、拓展分銷渠道以及 擴大不同地區的客戶群體來提升銷量。 As to the Manufacturing Segment, the Group has successfully established and is now steadily operating a new production line for healthy instant noodles. These noodles incorporate Chlamydomonas Reinhardtii Nutrition Powder as a key ingredient. The powder is rich in essential plant-based protein, dietary fiber, vitamins, omega-3 fatty acid, polycarbohydrate and some indispensable minerals that humans may not absorb enough through diets such as Selenium and iron. It brings significant health values to customers who are concerned about blood sugar, blood pressure, lipid levels, cardiovascular and cerebrovascular health, as well as immunity issues. Moreover, it can aid in addressing common concerns such as bad low bowel, constipation, dry eyes, etc. The segment has been carefully expanding its distribution channels and enhancing market exposure for its proprietary brand of healthy noodles. Additionally, it has been actively working to diversify its range of nutrient enhancers that demonstrate resilience, even in a challenging economic climate. Part of the products will be sold through our own platform in the Distribution Segment.

在生產分部方面,本集團已成功建設且正穩定運營一條健康方便面的新生產線。該等麵條的主要成分是萊茵衣藻營養粉。該粉末富含人體必需的植物性蛋白質、膳食纖維、維生素、歐米伽-3脂肪酸、多碳水化合物以及硒及鐵等一些人類可能無法通過飲食充分吸收的必要礦物質。其為關注血糖、血壓、血脂水平、心腦血管健康以及免疫問題的客戶帶來了重要的健康價值。此外,其亦能幫助解決腸胃好、便秘、眼睛乾澀等常見問題。該分部穩步拓展分銷渠道並增加健康方便麵自主品牌的市場曝光率。此外,該分部一直積極致力於豐富營養強化劑的品類,即使在經濟形勢嚴峻時期,該產品仍展現出極強的韌性。部分產品將通過我們分銷分部的自有平台進行銷售。

In the Investment Segment, the Group adheres to a conservative strategy for its portfolio, which includes equity, debt, and real estate. With the robust risk management and control policies, the Group will closely assess its performance and optimise its composition. In light of the current property market in the PRC, the Group may offload some of real estate properties in the PRC in order to replenish the required liquidity of the Group and address the increasing market risk of the properties.

Having initiated multiple litigations against BJEG and its management, who are closely linked to another shareholder, the Group will continue to work closely with its PRC legal counsel to assess and implement legal strategies aimed at safeguarding and asserting shareholders' rights in BJEG.

CORPORATE GOVERNANCE REPORT

The Board and the management of the Group are committed to achieving and maintaining high standards of corporate governance, which they consider to be critical in safeguarding the integrity of the Company's operations and maintaining investors' trust in the Company. It is of utmost importance to conduct business with accountability, transparency and fairness. The Group's interests as well as those of its shareholders will be maximised in the long run by adhering to these principles. The management of the Group also actively observes the latest corporate governance developments in Hong Kong and overseas.

CORPORATE GOVERNANCE PRACTICE

The Company had complied with all the code provisions as set out in the Corporate Governance Code and Corporate Governance Report (the "CG Code") contained in Appendix C1 of the Listing Rules of the Stock Exchange throughout the year ended 31 December 2024, except the following deviations:

Code Provision C.2.1

The roles of the chairman and chief executive should be separate and should not be performed by the same individual. Under the current management structure of the Company, Mr. Wong Lik Ping ("Mr. Wong") is the chairman of the Board (the "Chairman") and chief executive officer of the Company (the "CEO"). Upon the resignation of former CEO, Mr. Lai Ka Fai on 31 July 2023, Mr. Wong took up the function of CEO while the Company has been in the course of nominating suitable candidates for the vacancy of CEO. In addition, under the supervision of the Board which is comprised of four executive Directors, one non-executive Director and three independent non-executive Directors, the Board is appropriately structured with balance of power to provide sufficient checks to protect the interests of the Company and its shareholders as a whole. Therefore, the Board considers that the deviation from Code Provision C.2.1 of the CG Code is appropriate in this circumstance and will be addressed in the future.

Code Provision E.1.2

The remuneration committee's terms of reference should include reviewing and making recommendations to the board on the issuer's policy and structure for senior management remuneration and the remuneration packages of senior management. The terms of reference of the remuneration committee of the Company exclude review of and making recommendations to the Board in relation to senior management remuneration, as in the Board's opinion, it was more appropriate for the executive Directors to perform these duties.

All Directors are regularly updated on governance and regulatory matters. There is an established procedure for Directors to obtain independent professional advice at the expense of the Company in discharge of their duties.

Mr. Ng Kwok Sang was appointed as an independent non-executive Director on 3 April 2024. Mr. Ng has obtained the legal advice as referred to in Rule 3.09D of the Listing Rules before his appointment became effective, and he has confirmed that he understood his obligations as a Director.

The Board held meetings from time to time whenever necessary. Notice of at least 14 days has been given to all Directors for all regular board meetings and the Directors can include matters for discussion in the agenda if necessary. Agenda and accompanying board papers in respect of regular board meetings are sent out in full to all directors within reasonable time before the meeting. Draft minutes of all board meetings are circulated to Directors for comment within a reasonable time prior to confirmation.

Minutes of board meetings and meetings of Board Committees are kept by duly appointed secretaries of the respective meetings and all Directors have access to board papers and related materials, and are provided with adequate information on a timely manner, which enable the Board to make an informed decision on matters placed before it.

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

Under Code Provision C.2.1 of the CG Code, the roles of chairman and chief executive officer should be separate and should not be performed by the same individual. Upon the resignation of former CEO, Mr. Lai Ka Fai on 31 July 2023, Mr. Wong Lik Ping has been the Chairman and CEO. The Company has been in the course of nominating suitable candidates for the vacancy of CEO. The Board believes that the current measure is interim in nature. Therefore, the Board considers that the deviation from provision C.2.1 of the CG Code is appropriate in this circumstance. The Chairman provides leadership to management in respect of operational issues. The CEO has overall chief executive responsibility for the Group's business development and day-to-day management generally. The segregation of duties ensures a clear distinction between the Chairman's responsibility to manage the Board and the CEO's responsibility to manage the Group's business on behalf of the Board in the operational management of the Company. With the support of executive Directors and the company secretary of the Company (the "Company Secretary"), the Chairman seeks to ensure that all Directors are properly briefed on issues arising at Board meetings and receive adequate and reliable information in a timely manner.

All INEDs have been appointed for a specific term and are subject to retirement by rotation and re-election in accordance with the Articles. The composition of the Board has complied with Rule 3.10A of the Listing Rules that the INEDs represented at least one-third of the Board.

Each of the INEDs has given the Company an annual confirmation of independence pursuant to Rule 3.13 of the Listing Rules. The Company considers that all INEDs are independent and meet the independence guidelines set out in Rule 3.13 of the Listing Rules.

DIRECTORS' CONTINUOUS TRAINING AND DEVELOPMENT

Directors should participate in continuous professional development to develop and refresh their knowledge and skills. This is to ensure that their contribution into the Board remains informed and relevant.

The Directors are committed to complying with the Code Provision C.1.4 on Directors' training. All Directors have participated in continuous professional development activities by reading regulatory updates, and/or attending seminars/workshops relevant to the business/Directors' duties.

當董事會將其管理及行政職能方面之權力轉授予 管理層時,已同時就管理層之權力給予清晰規定, 尤其是管理層須向董事會匯報後方可作出決定或 代表本集團作出任何承諾之情況。 Principal functions that are specifically delegated by the Board to the management include (i) implementation of corporate strategy and policy initiatives; (ii) provision of management reports to the Board in respect of Group's performance, financial position and prospects; and (iii) day-to-day management of the Group.

董事會特定授權予管理層之主要職責包括(i)實施企業策略及政策措施;(ii)向董事會提交有關本集團之表現、財務狀況及前景之管理報告;及(iii)本集團之日常管理。

BOARD DIVERSITY POLICY

The Board has adopted a diversity of board members policy of the Company (the "Board Diversity Policy") and discussed all measurable objectives set for implementing the policy.

The Company recognises and embraces the benefits of diversity of Board members. It endeavours to ensure that the Board has a balance of skills, experience and diversity of perspectives appropriate to the requirements of the Company's business. All Board appointments will be based on merit and the candidates will be considered against measurable objectives, taking into account the Company's business and needs. Selection of candidates will be based on a range of diversity criteria, including but not limited to gender, age, cultural and educational background, knowledge, professional experience and skills. The Company will also take into account factors based on its specific needs from time to time. The ultimate decision will be based on merit and the contribution that the selected candidates may bring to the Board.

Pursuant to the amendments to corporate governance requirements, the Company is required to have a board with different gender as at 31 December 2024. The Company has one female board member and will aim to gradually increase in the number of female board members thereafter.

The Nomination Committee is responsible for monitoring and periodically reviewing the Board Diversity Policy. Any revisions to the policy as recommended by the Nomination Committee will be submitted to the Board for consideration and approval.

DIRECTOR NOMINATION POLICY

The Company adopted the director nomination policy of the Company (the "Director Nomination Policy") on 14 December 2018 which set out the criteria and process in the appointment and nomination of directors, in order to ensure the Board has a balance of skills, experience and diversity of perspectives appropriate to the Company and ensure the Board continuity and appropriate leadership.

According to the Director Nomination Policy, the Nomination Committee will carry out evaluation on candidates by considering their skills, professional qualification, experience, independence (for INEDs), gender, time commitment and make recommendation to the Board based on the nomination procedure. The Director Nomination Policy will also be reviewed from time to time in order to satisfy the business needs and ensure compliance with the regularity requirements as well as maintain good corporate governance practice.

On 22 January 2025, the Nomination Committee reviewed the Director Nomination Policy and the Board Diversity Policy, and considered that the said policies were appropriate and effective.

董事會多元化政策

董事會已採納本公司之董事會成員多元化政策(「董事會多元化政策」),並就政策實施討論了所有重要目標。

本公司認同及相信董事會成員多元化所帶來的裨益。其致力確保董事會擁有適合本公司業務所需的技能、經驗及多元化的意見。所有董事會成員的委任將以甄選優秀人才為基準,並根據可計量目標及本公司的業務和需要考慮候選人。甄選候選人將按多方面作考慮,包括但不限於性別、年齡、文化及教育景、知識、專業經驗及技能。本公司亦將根據其不時的具體需求考慮各種因素。最終決定乃按照獲甄選候選人將會為董事會帶來的價值及貢獻而作出。

根據企業管治規定的修訂,本公司須於二零二四年 十二月三十一日設立擁有不同性別的董事會。本公 司擁有一名女性董事會成員,且此後將逐步增加女 性董事會成員的人數。

提名委員會負責監控及定期審閱董事會多元化政策。提名委員會建議對該政策的任何修訂,將提交 予董事會審批。

董事提名政策

本公司已於二零一八年十二月十四日採納本公司之董事提名政策(「董事提名政策」),其載列任命及提名董事的準則及程序,以確保董事會成員具備切合本公司的技能、經驗及多元化觀點及確保董事會的持續性及維持其領導角色。

根據董事提名政策,提名委員會將透過考慮候選人的技能、專業資格、經驗、獨立性(就獨立非執行董事而言)、性別、所付出的時間對其進行評估並根據提名程序向董事會作出推薦意見。董事提名政策亦將不時予以檢討以滿足其業務需要、確保遵守監管規定以及維持良好的企業管治常規。

於二零二五年一月二十二日,提名委員會檢討董事 提名政策及董事會多元化政策,並認為該等政策為 合適及有效。

REMUNERATION COMMITTEE

The Company has set up a Remuneration Committee to ensure that there are formal and transparent procedures for setting policies on the remuneration of Directors. For the year ended 31 December 2024, the Remuneration Committee comprises the Board's Chairman, Mr. Wong Lik Ping, and two INEDs, namely Mr. Ng Kwok Sang and Mr. Wu Kai Tang. The Remuneration Committee is chaired by Mr. Ng Kwok Sang.

The terms of reference of the Remuneration Committee are of no less exacting terms than those set out in the CG Code. Pursuant to the amendments to Chapter 17 of the Listing Rules with effect from 1 January 2023, the terms of reference of the Remuneration Committee were adopted, amended and approved by the Board on 30 December 2022.

During the year, Remuneration Committee held one meeting to review the remuneration packages of the Directors. The Remuneration Committee ensures that no Director is involved in deciding his own remuneration. The terms of reference of the Remuneration Committee, a copy of which is posted on the Company's website, are consistent with the terms set out in the relevant section of the CG Code.

NOMINATION COMMITTEE

The Company has set up a Nomination Committee to ensure fair and transparent procedures for the appointment, re-election and removal of Directors to the Board. For the year ended 31 December 2024, the Nomination Committee comprises the Board's Chairman, Mr. Wong Lik Ping, and two INEDs, namely Mr. Wu Kai Tang and Mr. Ng Kwok Sang. The Nomination Committee is chaired by Mr. Wong Lik Ping.

During the year, Nomination Committee held one meeting to review the structure, size, composition of the Board, existing Nomination Policy and discuss re-election of directors. In selecting and recommending candidates for directorship, the committee will consider the background, experience, qualification and suitability of the candidates as well as the Board Diversity Policy. The Board will approve the recommendations based on the same criteria. The terms of reference of the Nomination Committee, a copy of which is posted on the Company's website, are consistent with the terms set out in the relevant section of the CG Code.

AUDIT COMMITTEE

For the year ended 31 December 2024, the Audit Committee comprises three INEDs, namely Mr. Wu Kai Tang, Mr. Ng Kwok Sang and Mr. Leung Yiu Ming David. The Audit Committee is chaired by Mr. Wu Kai Tang.

本年度內提名委員會已召開一次會議,審閱董事會的結構、規模及組成、現行提名政策及討論董事重選連任事宜。挑選及推薦董事候選人時,委員會會考慮候選人的背景、經驗、資歷、適合程度及董事會多元化政策。董事會將根據相同準則批准推薦建議。提名委員會的職權範圍與企業管治守則有關部分所載之條款一致。提名委員會的職權範圍已刊登在本公司網站內。

審核委員會

截至二零二四年十二月三十一日止年度,審核委員會由三名獨立非執行董事組成(即胡啟騰先生、吳國生先生及梁耀鳴先生)。胡啟騰先生為審核委員會之主席。

The principal duties of the Audit Committee are to review and provide supervision over the financial reporting process and internal controls of the Group, and perform the corporate governance duties. During the year, Audit Committee held two meetings to review and approved the interim and annual results of the Company, reviewed and recommended risk management, internal control matters and internal audit function of the Group, considered and recommended the reappointment and the remuneration of the external auditors and discussed audit planning and issues with the external auditors. The terms of reference of the Audit Committee, a copy of which is posted on the Company's website, are consistent with the terms set out in the relevant section of the CG Code.

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") as set out in Appendix C3 of the Listing Rules as its code of conduct for dealings in securities of the Company by the Directors. Having made specific enquiries, all Directors confirmed that they have complied with the required standards set out in the Model Code throughout the year ended 31 December 2024.

The Company has also adopted the Model Code as the code of conduct for securities transactions by Relevant Employees (as defined in the Listing Rules) to regulate the dealings in the securities of the Company by certain employees of the Group who are considered to be likely in possession of unpublished price sensitive information of the Company.

ACCOUNTABILITY AND AUDIT

Financial Reporting

The Board is responsible for presenting a balanced, clear and comprehensible assessment of the Group's performance, position and prospects.

Management shall provide sufficient explanation and information to the Board as will enable the Board to make an informed assessment of the financial and other information presented before board meeting for approval.

The Directors acknowledge their responsibility for preparing the Group's consolidated financial statements and ensuring that the preparation of the Group's consolidated financial statements is in accordance with the relevant requirements and applicable standards.

The statement of the auditor of the Company regarding their reporting responsibilities on the financial statements is set out in the Independent Auditor's Report on pages 49 to 53.

The Board will present a balanced, clear and understandable assessment to annual and interim reports, other price-sensitive announcements and other financial disclosures required under the Listing Rules, and reports to regulators as well as to information required to be disclosed pursuant to statutory requirements.

Risk Management and Internal Controls

The main features of the risk management and internal control systems of the Group are to provide a clear governance structure, policies and procedures, as well as reporting mechanism to facilitate the Group to manage its risks across business operations. The Group has established a risk management framework, which consists of the Board, the Audit Committee and the functional responsible management of the Group ("Senior Management"). The Board determines the nature and extent of risks that shall be taken in achieving the Group's strategic objectives, and has the overall responsibility for monitoring the design, implementation and the overall effectiveness of risk management and internal control systems. The risk management and internal control systems of the Group are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss. Its improvement is an ongoing process and the Board maintains a continuing commitment to strengthen the Company's control environment and processes. The Board, through the Audit Committee, conducts reviews of the effectiveness of such systems once annually, covering all material controls including financial, operational and compliance controls. The Group has formulated and adopted risk management policy in providing directions in identifying, evaluating and managing significant risks. At least on an annual basis, the Senior Management identifies risks that would adversely affect the achievement of the Group's objectives, and assesses and prioritizes the identified risks according to a set of standard criteria. Risk mitigation plans and risk owners are then established for those risks considered to be significant. In addition, the Group has engaged an internal control consultant to assist the Board and the Audit Committee in ongoing monitoring of risk management and internal control systems of the Group, which fulfil the internal audit functions of the Group. The annual review plan of the Group covers major activities and material controls including operational, financial and compliance of the Group's business units. It also covers the changes, since the last annual review, in the nature and extent of significant risks, and the Group's ability to respond to changes in its business and the external environment.

風險管理及內部監控

本集團風險管理及內部監控系統的主要特徵是提 供清晰的管治架構、政策及程序以及匯報機制以協 助本集團管理其各類業務營運的風險。本集團已建 立由董事會、審核委員會及本集團的職能責任管理 層(「高級管理層」)組成的風險管理框架。董事會釐 定在達致本集團策略目標過程中將承擔的風險性 質及程度,並整體負責監察風險管理及內部監控系 統的設計、實施及整體有效性。設立本集團的風險 管理及內部監控系統旨在管理而非消除未能達致 業務目標的風險,且僅可對重大失實陳述或損失提 供合理而非絕對保證。其改進乃為持續過程,而董 事會將繼續致力於加強本公司的監控環境及程序。 董事會透過審核委員會每年一次檢討有關系統的 有效性,範圍涵蓋所有重大控制措施,包括財務、營 運及合規控制措施。本集團亦已制定及採納風險管 理政策,提供識別、評估及管理重大風險的指示。 高級管理層至少每年一次識別對實現本集團目標 造成不利影響的風險,並根據一套標準準則評估及 排列所識別風險的優先次序。屆時對認為屬重大的 該等風險制定風險緩解計劃及指定風險負責人。此 外,本集團已委聘內部監控顧問協助董事會及審核 委員會持續監督本集團的風險管理及內部監控系 統,以履行本集團的內部審計職能。本集團的年度 審閱計劃涵蓋了主要業務及重大監控(包括本集團 業務單位的營運、財務及合規)。其亦涵蓋了自上次 年度審閱以來重大風險的性質及程度的變化以及 本集團應對其業務和外部環境變化的能力。

A report on the result of risk management and internal control review report from internal control consultant was provided to the Audit Committee and the Board in March 2025. The Board, through the Audit Committee, had performed annual review on the effectiveness of the Group's risk management and internal control systems, including but not limited to (i) corporate level controls (such as information and communication, including the handling and dissemination of inside information); and (ii) certain operation level controls. In the course of internal control review, internal control consultant identified internal control deficiencies and weaknesses, proposed recommendations for improvements and remedial actions with management and process owners. The management has taken certain remedial actions accordingly. The results of the internal control reviews and the management's remedial actions have been reported to the Audit Committee. The Board concluded that there are no material irregularities nor areas of concern that would have significant adverse impact on the Group's state of affair, and that the Group's risk management and internal control systems were effective and adequate (including the resources, staff qualifications and experience, training programmes and budget of the Company's accounting, internal audit and financial reporting functions) and, save as discussed in elsewhere in this report, have complied with the CG code provisions on risk management and internal control during the year. There was also no material breach of procedures and internal controls for the handling and dissemination of inside information during the year. The Company regularly reminds the directors and the relevant staff about due compliance and latest regulatory updates with the insider information and other relevant regulations.

SHAREHOLDERS' RIGHTS

Convening an extraordinary general meeting by shareholders

Pursuant to Article 58 of the Articles, any one or more shareholders holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Board or the Secretary of the Company, to require an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition; and such meeting shall be held within two (2) months after the deposit of such requisition. If within twenty-one (21) days of such deposit the Board fails to proceed to convene such meeting the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

Putting forward proposals at general meetings

A shareholder shall make a written requisition to the Board or the Company Secretary at the Company's office in Hong Kong at Room 2203, 22/F., Kwan Chart Tower, No. 6 Tonnochy Road, Wanchai, Hong Kong, specifying the shareholding information of the shareholder, his/her contact details and the proposal he/she intends to put forward at general meeting regarding any specified transaction/business and its supporting documents.

As regards proposing a person for election as a Director, please refer to the procedures available on the websites of the Company and the Stock Exchange.

With reasonable but not pre-determined dividend distribution ratio, the proposed amount of dividends will be made at the discretion of the Board and will depend on the Company's operational results, cash flow situation, financial conditions, capital expenditure requirements, general business conditions and strategies, future economic environment, statutory and regulatory restrictions and any other factors that the Board may deem relevant. The policy will be reviewed from time to time so as to keep in line with the change of market conditions and other factors as the Board may deem relevant.

INVESTOR RELATIONS

The Company considers that effective communication with shareholders is essential for enhancing investor relations and investor understanding of the Group's business performance and strategies. The Company has established a range of communication channels between itself, its shareholders and investors, including answering questions through the annual general meeting ("AGM"), the publications of annual and interim reports, notices, announcements and circulars on the website of the Company at www.egichk.com.

WHISTLEBLOWING POLICY

In compliance with the Code Provision D.2.6 of the CG Code, the Board adopted a whistle blowing policy of the Company (the "Whistleblowing Policy") on 31 March 2022. It provides employees and the relevant third parties who deal with the Group (e.g. customers, suppliers, creditors and debtors) with guidance and reporting channels on reporting any suspected improprieties in any matters related to the Group directly addressed to the designated person. An email account (ac.hk@egichk.com.hk) has been set up for this purpose. All reported matters will be investigated independently and, in the meantime, all information received from a whistleblower and its identity will be kept confidential. The Board and the Audit Committee will regularly review the Whistleblowing Policy and mechanism to improve its effectiveness.

ANTI-FRAUD AND ANTI-CORRUPTION POLICY

In compliance with the Code Provision D.2.7 of the CG Code, the Board adopted an anti-fraud and anti-corruption policy of the Company (the "Anti-Fraud and Anti-Corruption Policy") on 31 March 2022. It outlines guidelines and the minimum standards of conducts, all applicable laws and regulations in relation to the anti-corruption and anti-bribery, the responsibilities of employees to resist fraud, to help the Group defend against corrupt practices and to report any reasonably suspected case of fraud and corruption or any attempts thereof, to the management or through an appropriate reporting channel. The Group would not tolerate all forms of fraud and corruption among all employees and those acting in an agency or fiduciary capacity on behalf of the Group, and in its business dealing with third parties. The Board and the Audit Committee will review the Anti-Fraud and Anti-Corruption Policy and mechanism periodically to ensure its effectiveness and enforce the commitment of the Group to the prevention, deterrence, detection and investigation of all forms of fraud and corruption.

Dan Dan Group, comprised of Dan Dan Mall Limited and Dan Dan Mall (HK) Limited, being one of the Group's five largest customers, is owned by a substantial shareholder, Mr. Lam Tsun On.

The aggregate purchases attributable to the Group's largest supplier and five largest suppliers represented 67.9% and 88.0% of the Group's purchases in 2024 respectively. Top Empire International Limited, being the Group's largest supplier, is jointly owned by a Director and substantial shareholder, Mr. Ng Tin Shui and his spouse.

Save as disclosed above, none of the Directors, their associates, or any shareholder (which to the knowledge of the Directors owns more than 5% of the Company's share capital) has any interest in the Group's five largest customers and suppliers.

1. GENERAL INFORMATION

China Ever Grand Financial Leasing Group Co., Ltd. (the "Company") is a public limited company incorporated in the Cayman Islands as an exempted company with limited liability and its shares are listed on The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). The addresses of the registered office and principal place of business of the Company are disclosed in the corporate information section on the annual report.

During the year, the principal activities of the Group were sale of daily necessities, medical, health and hygiene products, manufacturing and sale of food products and nutrient enhancers, the trading of equity securities, investment in properties, investment holdings, money lending business, and provision of finance lease and related consulting services in the People's Republic of China ("PRC").

Items included in the financial statements of each of Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "Functional Currency"). The Functional Currency of operating subsidiaries in Hong Kong and the PRC are Hong Kong Dollars ("HK\$") and Renminbi ("RMB"), respectively. The consolidated financial statements are presented in HK\$ as the directors of the Company (the "Director") consider that it is a more appropriate presentation for a company listed on the Stock Exchange and for the convenience of the shareholders of the Company.

3. BASIS OF PREPARATION OF CONSOLIDATED FINANCIAL STATEMENTS AND MATERIAL ACCOUNTING POLICIES

The consolidated financial statements have been prepared in accordance with HKFRSs issued by the HKICPA, accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance and applicable disclosure requirements of the Rules Governing the Listing of Securities on the Stock Exchange (the "Listing Rules").

These consolidated financial statements have been prepared under the historical cost convention, except for certain financial instruments and investment properties which have been measured at fair value.

With reference to the Company's announcement date 8 February 2024, the Group no longer had control over the group of companies comprised of Beijing Ever Grand International Financial Leasing Co. Limited ("BJEG") and its subsidiaries ("BJEG Group") on 31 July 2023. As a result, the financial results of BJEG Group for the period from 1 January to 31 July 2023 were deconsolidated from the consolidated financial statements for the year ended 31 December 2023 (the "Deconsolidation") and have been accounted for as associates of the Company thereafter.

BJEG Group is engaged in the financial leasing segment of the Group. In accordance with HKFRS 5 *Non-current Assets Held for Sale and Discontinued Operations*, the operating results of BJEG Group for the period from 1 January to 31 July 2023 (the "Date of the Deconsolidation") and its results, through investment in associates, for the remaining five months were presented under discontinued operation and continuing operations in the consolidated statement of profit or loss for the year ended 31 December 2023 respectively.

On 1 August 2024, the Director, who held the board seat in BJEG, was no longer served for and acting for the Group (the "Event"). The Group lost its seat on the board of directors of BJEG, resulting in the loss of its ability to exercise significant influence over BJEG in accordance with HKAS 28, and thus BJEG ceased to be an associate of the Group. The Group has therefore discontinued the use of the equity method under HKAS 28 accounting for its investment in BJEG. Henceforth, the Group's investment in BJEG has been accounted for as equity investments at FVTOCI since 1 August 2024.

北京恒嘉集團從事本集團融資租賃分部業務。根據香港財務報告準則第5號持作出售的非流動資產及非持續經營業務,北京恒嘉集團自二零二三年一月一日起至七月三十一日(「終止綜合入賬日期」)止期間之經營業績及其餘下五個月的業績(通過投資聯營公司)於截至二零二三年十二月三十一日止年度之綜合損益表中分別呈列於非持續經營業務及持續經營業務項下。

於二零二四年八月一日,擁有北京恒嘉董事會席位的董事不再於本集團任職並為本集團行事(「該事件」)。根據香港會計準則第28號,本集團喪失北京恒嘉董事會席位導致失去其對北京恒嘉行使重大影響力之能力,因此北京恒嘉不再為本集團聯營公司。因此,本集團已停止使用香港會計準則第28號項下的權益法入賬其於北京恒嘉的投資。而從此以後本集團於北京恒嘉的投資自二零二四年八月一日起入賬列為按公平值透過其他全面收入列賬之股權投資。

The preparation of consolidated financial statements in conformity with HKFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates. The estimates and assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimates is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

The preparation of these consolidated financial statements in conformity with HKFRSs requires the use of key assumptions and estimates. It also requires the Directors to exercise their judgements in the process of applying the accounting policies. The areas involving critical judgements and areas where assumptions and estimates are significant to these consolidated financial statements are disclosed in note 4.

The material accounting policies applied in the preparation of these consolidated financial statements are set out below.

Material accounting policies

Consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries made up to 31 December. Subsidiaries are entities over which the Group has control. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The Group has power over an entity when the Group has existing rights that give it the current ability to direct the relevant activities, i.e. activities that significantly affect the entity's returns.

When assessing control, the Group considers its potential voting rights as well as potential voting rights held by other parties, to determine whether it has control. A potential voting right is considered only if the holder has the practical ability to exercise that right.

Subsidiaries are consolidated from the date on which control is transferred to the Group. They are de-consolidated from the date the control ceases.

The gain or loss on the disposal of a subsidiary that results in a loss of control represents the difference between (i) the fair value of the consideration of the sale plus the fair value of any investment retained in that subsidiary and (ii) the Company's share of the net assets of that subsidiary plus any remaining goodwill relating to that subsidiary and any related accumulated exchange fluctuation reserve.

Intragroup transactions, balances and unrealised profits are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

Non-controlling interests represent the equity in subsidiaries not attributable, directly or indirectly, to the Company. Non-controlling interests are presented in the consolidated statement of financial position and consolidated statement of changes in equity within equity. Non-controlling interests are presented in the consolidated statement of profit or loss and other comprehensive income as an allocation of profit or loss and total comprehensive income for the year between the non-controlling shareholders and owners of the Company.

Profit or loss and each component of other comprehensive income are attributed to the owners of the Company and to the non-controlling shareholders even if this results in the non-controlling interests having a deficit balance.

Changes in the Company's ownership interest in a subsidiary that do not result in a loss of control are accounted for as equity transactions (i.e. transactions with owners in their capacity as owners). The carrying amounts of the controlling and non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiary. Any difference between the amount by which the non-controlling interests are adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to the owners of the Company.

Business combination and goodwill

The acquisition method is used to account for the acquisition of a subsidiary in a business combination. The cost of acquisition is measured at the acquisition-date fair value of the assets given, equity instruments issued, liabilities incurred and contingent consideration. Acquisition-related costs are recognised as expenses in the periods in which the costs are incurred and the services are received. Identifiable assets and liabilities of the subsidiary in the acquisition are measured at their acquisition-date fair values.

The excess of the cost of acquisition over the Company's share of the net fair value of the subsidiary's identifiable assets and liabilities is recorded as goodwill. Any excess of the Company's share of the net fair value of the identifiable assets and liabilities over the cost of acquisition is recognised in consolidated profit or loss as a gain on bargain purchase which is attributed to the Company.

In a business combination achieved in stages, the previously held equity interest in the subsidiary is remeasured at its acquisition-date fair value and the resulting gain or loss is recognised in consolidated profit or loss. The fair value is added to the cost of acquisition to calculate the goodwill.

If the changes in the value of the previously held equity interest in the subsidiary were recognised in other comprehensive income (for example, equity investments at fair value through other comprehensive income), the amount that was recognised in other comprehensive income is recognised on the same basis as would be required if the previously held equity interest were disposed of.

Goodwill is tested annually for impairment or more frequently if events or changes in circumstances indicate that it might be impaired. Goodwill is measured at cost less accumulated impairment losses. The method of measuring impairment losses of goodwill is the same as that of other assets as stated in the accounting policy below. Impairment losses of goodwill are recognised in consolidated profit or loss and are not subsequently reversed. Goodwill is allocated to cashgenerating units that are expected to benefit from the synergies of the acquisition for the purpose of impairment testing.

The non-controlling interests in the subsidiary are initially measured at the non-controlling shareholders' proportionate share of the net fair value of the subsidiary's identifiable assets and liabilities at the acquisition date.

Investments in associates

An associate is an entity over which the Group has significant influence and that is neither a subsidiary nor a joint arrangement. Significant influence is the power to participate in the financial and operating policy decisions of the investee but not control or joint control over those policies.

Associates are accounted for using the equity method whereby they are initially recognised at cost and thereafter, their carrying amount are adjusted for the Group's share of the post-acquisition change in the associates' net assets except that losses in excess of the Group's interest in the associate are not recognised unless there is an obligation to make good those losses. Any premium paid for an associate above the fair value of the Group's share of the identifiable assets, liabilities and contingent liabilities acquired is capitalised and included in the carrying amount of the associate. Where there is objective evidence that the investment in an associate has been impaired, the carrying amount of the investment is tested for impairment in the same way as other non-financial assets.

Profits and losses arising on transactions between the Group and its associates are recognised only to the extent of unrelated investors' interests in the associate. The investor's share in the associate's profits and losses resulting from these transactions is eliminated against the carrying value of the associate. Where unrealised losses provide evidence of impairment of the asset transferred, they are recognised immediately in profit or loss.

The Group discontinues the use of the equity method from the date when the investment ceases to be an associate. When the Group retains an interest in the former associate and the retained interest is a financial asset, the Group measures the retained interest at fair value at that date and the fair value is regarded as its fair value on initial recognition in accordance with HKFRS 9.

The difference between the carrying amount of the associate at the date the equity method was discontinued, and the fair value of any retained interest and any proceeds from disposing a part interest in the associate is included in the determination of the gain or loss on disposal of the associate. In addition, all amounts previously recognised in other comprehensive income in relation to that associate are recognised on the same basis as would be required if that associate had directly disposed of the related assets or liabilities.

When the Group reduces its ownership interest in an associate but the Group continues to use the equity method, the Group reclassifies to profit or loss the proportion of the gain or loss that had previously been recognised in other comprehensive income relating to that reduction in ownership interest it that gain or loss would be reclassified to profit or loss on the disposal of the related assets or liabilities.

In the Company's statement of financial position, investments in associates are carried at cost less impairment losses, if any. The results of associates are accounted for by the Company on the basis of dividends received and receivable during the year.

Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker. The chief operating decision-maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the Executive Directors that make strategic decisions.

Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services, excluding those amounts collected on behalf of third parties. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts.

A performance obligation represents a good or service (or a bundle of goods or services) that is distinct or a series of distinct goods or services that are substantially the same.

Depending on the terms of the contract and the laws that apply to the contract, control of the goods or service may be transferred over time or at a point in time. Control of the goods or service is transferred over time if the Group's performance:

- provides all of the benefits received and consumed simultaneously by the customer;
- the Group's performance creates and enhances an asset that the customer controls as the Group performs; or
- does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

If control of the goods or services transfers over time, revenue is recognised over the period of the contract by reference to the progress towards complete satisfaction of that performance obligation. Otherwise, revenue is recognised at a point in time when the customer obtains control of the goods or service.

A contract asset represents the Group's right to consideration in exchange for goods or services that the Group has transferred to a customer that is not yet unconditional. It is assessed for impairment in accordance with HKFRS 9. In contrast, a receivable represents the Group's unconditional right to consideration, that is only the passage of time is required before payment of that consideration is due.

A contract liability represents the Group's obligation to transfer goods or services to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer.

A contract asset and a contract liability relating to the same contract are accounted for and presented on a net basis.

Existence of significant financing component

When the contract contains a financing component which provides the customer a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amounts receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. Where the contract contains a financing component which provides a significant financing benefit to the Group, revenue recognised under that contract includes the interest expense accreted on the contract liability under the effective interest method. For contracts where the period between the payment and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15.

Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the entity's functional currency (foreign currencies) are recognised at the rates of exchange prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing on the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's entities are translated into the presentation currency of the Group (i.e. HK\$) at the rate of exchange prevailing at the end of the reporting period, and their income and expenses are translated at the average exchange rates for the year. Exchange differences arising, if any are recognised in other comprehensive income and accumulated in equity under the heading of the translation reserve (attributed to non-controlling interests as appropriate).

Retirement benefit costs

Payments to defined contribution retirement benefit plans are recognised as an expense when employees have rendered service entitling them to the contributions.

Short-term employee benefits are recognised at the undiscounted amount of the benefits expected to be paid as and when employees rendered the services. All short-term employee benefits are recognised as an expense unless another HKFRS requires or permits the inclusion of the benefit in the cost of an asset.

A liability is recognised for benefits accruing to employees (such as wages and salaries, annual leave and sick leave) after deducting any amount already paid.

Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax.

Current tax

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit before tax, as reported in the consolidated statement of profit or loss and other comprehensive income because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary differences arise from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit. In addition, deferred tax liabilities are not recognised if the temporary differences arise from the initial recognition of goodwill.

Financial assets are recognised and derecognised on a trade date basis where the purchase or sale of an asset is under a contract whose terms require delivery of the asset within the timeframe established by the market concerned, and are initially recognised at fair value, plus directly attributable transaction costs except in the case of investments at fair value through profit or loss. Significant increase in credit risk

When determining whether the credit risk of a financial asset has increased significantly since initial recognition and when estimating ECL, the Group considers reasonable and supportable information that is relevant and available without undue cost or effort. This includes both quantitative and qualitative information analysis, based on the Group's historical experience and informed credit assessment and including forward-looking information. Credit risk means the risk of loss in respect of a financial instrument when the counterparty to the financial instrument cannot execute its obligations.

The Group assumes that the credit risk on a financial asset has increased significantly if it is more than 30 days past due.

Depending on the nature of the financial instruments, the assessment of a significant increase in credit risk is performed on either an individual or a collective basis. When the assessment is performed on a collective basis, the financial instruments are grouped based on shared credit risk characteristics, such as past due status and credit risk ratings.

Definition of default

The Group considers an event of default occurs when information obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group).

In the application of the Group's accounting policies, which are described in note 3, the Directors are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and underlying assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Critical judgements in applying accounting policies

The following are the critical judgements, apart from those involving estimations (see below), that the Directors have made in the process of applying the Group's accounting policies and that have the most significant effect on the amounts recognised in the consolidated financial statements.

Significant influence over associates

Note 18 describes that Simagi Finance Company Limited ("Simagi"), in which the Group has 6.82% (2023: 6.82%) ownership interest and voting rights, is an associate of the Group as the Group has the right to appoint at least one director in the board of directors of Simagi. As at 31 December 2024 and 2023, the Group considered it had the power to exercise significant influence over Simagi by virtue of its contractual right appointed one out of two directors in the board of directors of Simagi.

Note 18 describes that BJEG, in which the Group has 51.39% ownership interest, is an associate of the Group. As at 31 December 2023, the Group considered it had the power to exercise significant influence over BJEG as one of the executive Directors remained in the board of directors of BJEG.

As at 31 December 2024, there was no director nominated and represented by the Group in the board of directors of BJEG due to the Event. Given the disagreement of another shareholder of BJEG, the Group is not able to appoint any new director or replace any existing director in the board of directors of BJEG. Accordingly, the Group considered that there was no significant influence over BJEG and BJEG ceased to be an associate of the Group as at 1 August 2024.

Key sources of estimation uncertainty

The following are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that may have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

Impairment loss on goodwill

The value in use is determined based on the cash flow projection for the cash generating units ("CGUs"), discounted to their present values and requires the use of key assumptions, including the discount rate, terminal growth rate, budgeted sales and profit margin, taking into account the financial budget approved by the Directors based on the management's experience from the distribution business and also management's expectations for the market development. As at 31 December 2024, the carrying amount of goodwill was approximately HK\$10,543,000 (2023: HK\$25,556,000) and impairment loss on goodwill of approximately HK\$15,013,000 (2023: Nil) has been recognised to consolidated statement of profit or loss. Details of the recoverable amount calculation are disclosed in note 17.

Provision of ECL

The measurement of impairment losses under HKFRS 9 across all categories of financial assets requires significant judgment and estimation, in particular, the assessment of a significant increase in credit risk and credit-impaired financial assets as well as the estimation of the amount and timing of future cash flows and collateral values when determining impairment losses. These estimates are driven by a number of factors, changes in which can result in different levels of allowances. At each reporting date, the Group assesses whether there has been a significant increase in credit risk for exposures since initial recognition by comparing the risk of default occurring over the expected life between the reporting date and the date of initial recognition. The Group considers reasonable and supportable information that is relevant and available without undue cost or effort for this purpose. This includes quantitative and qualitative information and also forward-looking analysis. Details of the key assumptions and inputs used are set out in note 34.

Fair value of equity investments at FVTOCI

The fair value of equity investments at FVTOCI that are not traded in an active market is determined by using valuation techniques. The Group uses its judgement to select a variety of methods (such as market approach and asset-based approach) and makes assumptions that are mainly based on market conditions existing at each statement of financial position date. The key assumptions adopted on valuation techniques and key inputs are based on management's best estimates with assistance of the independent professional valuer.

Fair values of investment properties

The Group appointed an independent professional valuer to assess the fair values of the investment properties. In determining the fair values, the valuer has utilised a method of valuation which involves certain estimates. The Directors have exercised their judgement and are satisfied that the method of valuation is reflective of the current market conditions.

The operating subsidiaries in Hong Kong joined the mandatory provident fund scheme ("MPF Scheme") for all employees in Hong Kong. The MPF Scheme is registered with the Mandatory Provident Fund Scheme Authority under the Mandatory Provident Scheme Ordinance. The assets of the scheme are held separately from those of the Group in funds under the control of an independent trustee. Under the rules of the MPF Scheme, the employer and its employees are each required to make contributions at 5% of the relevant payroll of the employees to the MPF Scheme, capped at HK\$1,500 per employee per month. The obligation of the Group with respect of MPF Scheme is to make the required contribution under the MPF Scheme. The retirement benefits costs charged to the consolidated statement of profit or loss represent contributions paid and payable to the MPF Scheme by the Group.

Interest rate risk

The Group does not use derivative financial instruments to hedge its interest rate risk. As at 31 December 2023, the Group was not exposed to significant interest rate risk. However, the management closely monitors its exposure to future cash flow risk as a result of change on market interest rate and will consider hedging changes in market interest rates should the need arise.

The Group's cash flow interest rate risk as at 31 December 2024 was mainly concentrated on the fluctuation of People's Bank of China Rate arising from the Group's bank borrowing with floating interest rates.

The sensitivity analysis was prepared assuming the relevant financial instruments outstanding as at 31 December 2024 were outstanding for the year ended 31 December 2024. Currency risk

The Group's credit risk is primarily attributable to trade receivables, loan receivables, other receivables and deposits, deposits placed with non-bank financial institutions, and cash and cash equivalents.

The Group's maximum exposure to credit risk in the event of the counterparties failure to perform their obligations as at 31 December 2024 and 2023 in relation to each class of recognised financial assets is the carrying amount of those assets as stated in the consolidated statement of financial position.

In order to minimise the credit risk, the management of the Group has delegated a team responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In addition, the Group reviews the recoverable amount of each individual debt at the end of the reporting period to ensure that adequate impairment losses are made for irrecoverable amounts.

Loan receivables

The Group has closely monitored the recoverability of loan receivables from the loan borrowers, including but not limited to timely review loan borrower's financial performance, follow up action if become default, etc. In this regards, the Directors consider that the Group's credit risk is low.

Trade receivables

The Group measures impairment loss of trade receivables based on HKFRS 9 simplified approach at an amount equal to lifetime ECLs. Before accepting any new customer, the Group assesses potential customer's credit quality and defines credit limits by customer. Limits attributed to customers are reviewed regularly. The Group has establish a provision matrix that is based on the Group's historical credit losses experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

Other receivables and deposits (other than deposit at bank)

Other receivables and deposits (other than deposit at bank) are classified as financial assets at amortised cost. For other receivables and deposits, the management of the Group makes periodic collective assessment as well as individual assessment on the recoverability of other receivables and deposits based on historical settlement records and past experience. For the years ended 31 December 2024 and 2023, the Group individually assessed the ECL for other receivable amounting to HK\$9,794,000 (2023: HK\$12,804,000). Bank balances and deposited with non-bank financial institutions

The Group's bank balances and deposits are deposited with banks and non-bank financial institutions in Hong Kong and the PRC and the Group has limited the exposure to any single financial institution. The credit risk on liquid funds is limited because the counterparties are banks and non-bank financial institution with good credit-rating.

Concentration of credit risk

Among these receivables, the Directors specifically identify considerable credit risk primarily arising from trade receivables and loan receivables. The concentration risk associated with these assets is further analysed in the following paragraph.

As at 31 December 2024, the Group had certain concentration of credit risk as 0.2% (2023: 34%) and 43% (2023: 47%) of the aggregate carrying amount of trade receivables from the Group's largest and the five largest customers respectively, while that as 53% (2023: 50%) and 100% (2023: 100%) of the aggregate carrying amount of loan receivables from the Group's largest and top five borrowers.

The management exercises due care in granting credit and checking the background of these counterparties on a regular basis and closely monitors the subsequent settlement of the customers. In this regard, the directors of the Company consider that the Group's credit risk is significantly reduced.

Measurement of ECL

The Group measures loss allowance for trade receivables based on lifetime ECLs. For other financial assets, the Group assessed the loss allowance for receivables that are not credit-impaired collectively based on 12 months ECL and lifetime ECL, and assessed receivables that are credit-impaired individually based on lifetime ECL.

The management monitors the utilisation of borrowings and ensures compliance with loan covenants.

In order to safeguard the interests of the Group, a legal case has also been filed with the PRC Court requesting the Court to order the judicial dissolution of BJEG.
