SUSPENSION OF TRADING

At the request of Many Idea Cloud Holdings Limited (the “**Company**”), trading of the shares of the Company on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) will be suspended with effect from 9:00 a.m. on Tuesday, 31 March 2026, in the light of the following development of the Company:

- (1) Pending the release of an announcement on a material strategic cooperation in a digital fintech industry with a shareholder of the Company, which constitute inside information of the Company; and
- (2) The possible delay in results announcement as referred in the announcement of the Company dated 30 March 2026. At the request of the auditors of the Company, the Company’s audit committee requires additional time to review on internal control measures of the Company, arising from the receipt of an enquiry regarding the internal control measures of the Company for the use of funds with proper authorisations. Certain internal review procedures have been conducted and, at the request of the Company’s auditors, the Company is in the process of engaging an independent consultant to conduct additional review.

Pursuant to Rule 13.50 of the Rules Governing the Listing of Securities on the Stock Exchange, the Stock Exchange will normally require suspension of trading in an issuer's securities if an issuer fails to publish periodic financial information in accordance with the Listing Rules, and the suspension will normally remain in force until the issuer publishes an announcement containing the requisite financial information. Accordingly, trading in the shares of the Company on the Stock Exchange is currently expected to be suspended pending the publication of the 2025 annual results by the Company. The Company will use its best endeavours to publish the 2025 annual results as soon as possible and will publish further announcement(s) to inform the shareholders of the Company and its potential investors of any updates on (i) the date of the Board meeting to consider and approve the 2025 annual results and (ii) the publication of the 2025 annual results and the despatch of the 2025 annual report as and when appropriate.
