- Due to Fundwatch Holdings Ltd's shareholding restructuring in Logic Int'l Holdings Ltd ("LIH"), a total of 20,956,860 shares of LIH were transferred to Chaplet Investment Services Ltd.
- NZ 219,881,785 shares are share interests in a unit trust and a discretionary trust.
- N3 : Bonus Issue
- N4 700,000,000 shares were subscribed at \$0.80 per share pursuant to a subscription agreement dated 29th June, 1995; and 840,835,966 shares were acquired at \$1.20 per share under a cash offer (the "Cash Offer"), the details of which have been set out in the circular addressed to the shareholders of Kong Wah Holdings Limited ("Kong Wah") dated 2nd August,
- Under the Cash Offer, a convertible loan note (the "Convertible Note") for an aggregate nominal amount of \$118,800,000 issued by Kong Wah was acquired at \$12,582,523.20 per \$10,800,000 nominal amount outstanding under the Convertible Note. The Convertible Note carrys the right to convert into shares of Kong Wah at \$1.03 per share.
