- N2 Pursuant to an agreement between Mr. Lee Siu Fung, Siegfried and Mr. Gunter Alfred Halex dated October 7, 1993, Mr. Lee Siu Fung, Siegfried agreed to transfer or procure the transfer to Mr. Gunter Alfred Halex a total of 24,084,000 shares in Siu-fung Ceramics Holdings Limited (the "Company"), of which 10,704,000 shares have been transferred to Mr. Halex and the remaining 13,380,000 shares are to be transferred to Mr. Halex during the remaining part of the period of 24 months from the date of the agreement, subject to the terms of the agreement. On February 28, 1995, Mr. Lee Siu Fung, Siegfried and Mr. Gunter Alfred Halex entered into a deed whereby Mr. Gunter Alfred Halex agreed to absolutely release Mr. Lee Siu Fung, Siegfried from all obligations to transfer or to procure the transfer of shares in the Company under the agreement.
