- N6 The transfer was caused by the restructure of King Strike Limited (the "Company"), the holding company of Kingmaker Footwear Holdings Limited ("Kingmaker"), which Mr. Chen Hing Hsiung, Mickey (the "Director") is one of the shareholders.
The transaction date of the transfer was 21 November 1995, however, the stamping procedure only completed on 28 November 1995. Before the transfer, the Company owned 72% of Kingmaker's issued shares and the Director owned 45.96% of Company's issued shares. After the transfer, the Company owns 57.80% of Kingmaker's issued shares and the Director owns 57.25% of the Company's issued shares. That means the transfer leave the beneficial interest of the Director against Kingmaker unchanged.
