N1 Revised

N2 Pursuant to a trust deed dated 6 February 1996, 416,000,000 shares were charged by Glaser Holdings Limited, a wholly-owned subsidiary of Paliburg Holdings Limited ("PHL"), in favour of BT Trustees (Hong Kong) Limited, the trustee for holders of the US\$130 million Exchangeable Guaranteed Bonds due 2001 (the "Bonds") issued by Paliburg International Finance Limited, also a wholly-owned subsidiary of PHL, and initially comprised the exchange property covering the exchange rights under the Bonds, exercisable during the period from, and including, 6 April 1996 up to, and including, 23 January 2001, at an initial effective exchange price of HK\$2.4173 per share.

N3 Exercise of share options

N4 The increase in interest in shares in Consolidated Electric Power Asia Limited arises as a result of the sale on 9 February 1996 of 8,000,000 put options. The put options entitle the buyer thereof, upon exercise, to sell a total of 8,000,000 shares in Consolidated Electric Power Asia Limited at a strike price of HK\$14.80 per share. The put options were sold at a premium of HK\$1.054 per option.

N5 As associates of Chen Tseng Tao, Thomas ceased to be one of the beneficiaries of The Pasture Trust on 18 December 1995, Chen Tseng Tao, Thomas also ceased to have deemed interests in shares of Amoy Properties Ltd and Grand Hotel Holdings Ltd on 18 December 1995 (these shares were held by subsidiaries of Hang Lung Development Co Ltd).
