**NOTES:**

- N1 On 20 March 1996, Far Eastern Holdings Ltd transferred all shares of Kwong Hing Investment Co Ltd ("Kwong Hing") registered in its name to its wholly-owned subsidiary, Kwong Hing Investment Holdings Ltd.
- N2 On 21 March 1996, Kwong Hing transferred Townsend Int'l Ltd ("Townsend") to Dansun Enterprises Ltd ("Dansun"). Therefore, (i) Kwong Hing was no longer interested in 28,626,783 shares of Furama which were held by Townsend; (ii) Dansun became interested in 28,626,783 shares of Furama which were held by Townsend.
- N3 On 22 March 1996, Kwong Hing transferred the 64,821,268 shares of Furama registered in its name to Townsend. Therefore on 22 March 1996, Kwong Hing was no longer interested in 64,821,268 shares of Furama. Dansun and Townsend became interested in an additional 64,821,268 shares of Furama.
- N4 Acquisitions were made from 19/03/96 to 22/03/96 at prices ranging from \$1.45 to \$1.53/share.
