- a) Pine Asset Management Limited ("Pine Asset") has sold 93,239,759 shares in Pico Far East Holdings Limited ("Pico") pursuant to a Stock Purchase and Shareholders Agreement dated 12 June 1994 and entered into between Pine Asset and BAC Investments Limited ("BAC")(the "Agreement").
 - b) By virtue of Section 9 of the SDI Ordinance and the Agreement, BAC is deemed to be interested in both Pine Asset's remaining shareholding interests of 188,434,030 shares in Pico in addition to the 93,230,759 shares acquired, giving a total interest in 281,663,789 shares in Pico.
