- N1 The completion of the conditional agreement dated 22/01/98 as amended by memorandum of agreement dated 26/02/98 and a supplemental memorandum of agreement dated 06/03/98 in respect of the sale and purchase of approximately 25.28% of the issued share capital of Capital Asia Limited ("Company") took place on 30th March 1998. Goldstream Group Limited ("Goldstream") acquired from Track Record Limited, Bright Mark Investments Limited and Mr. Wong Ching Ping, Alex (together the "Vendors") 336,192,758 shares representing 24% of the issued share capital of the Company only as the Vendors were unable to deliver 17,862,970 shares for completion. The Vendors agreed to procure to sell 17,712,970 shares to Goldstream before 06/04/98 and both the Vendors and Goldstream agreed not to proceed with the sale and purchase of the remaining 150,000 shares. The 105,726,626 shares in the Company pledged by Track Record Limited to Emperor Finance Limited were released on 30/03/98.
