- N1** Out of the 681,359,515 shares, 631,359,515 shares in China Everbright Technology Ltd ("CET") are held by Kenco Investments Ltd, a wholly-owned subsidiary of Datten Investments Ltd ("Datten"). Datten is a wholly-owned subsidiary of China Everbright Holdings Co Ltd ("CEBH"). The remaining 50,000,000 shares in CET are deemed to be interested by CEBH by way of a second charge created by Profitable Enterprises Ltd ("PEL") in favour of CEBH pursuant to a Second Charge of Shares dated 16 June 1998 entered into between, inter alia, PEL and CEBH for the purposes of securing the due and punctual observance by Mr. Yiu Kin Wai of all his obligations and liabilities due to CEBH under a Deed of Indemnity and a Supplemental Deed both entered into between Mr. Yiu Kin Wai and CEBH and dated 16 June 1998.
- N2** With effect from 29 June 1998, the Company's shares were consolidated on the basis of every ten issued existing shares of HK\$0.10 each being consolidated into one share of HK\$1.00 each.
- N3** Acquisitions were made from 22/06/98 to 26/06/98 at prices ranging from \$24.20 to \$26.05 per share.
- N4** Acquisitions were made from 30/06/98 to 06/07/98 at prices ranging from \$0.56 to \$0.69 per share.
