- N1** A share acquisition agreement relating to Pelota (the "Agreement") was entered into on 21st September, 1998 between Yeoman International Limited (the "Company") as the seller and Mr. So Sik as the purchaser, pursuant to which the company agreed to sell and Mr. So Sik agreed to purchase 49% interest in the issued share capital of Pelota held by the Company. The disposal was completed on 21st September 1998 upon the execution of the Agreement. In this connection, from now on the Company ceases to have any notifiable interest required to be disclosed under the SDI Ordinance, as the Company does not own any interest in Pelota and therefore does not have any deemed interest in the relevant share capital of Fujian Group.
