N1 Date of Transaction : 03/08/98 - 30/10/98

N2 Mr. Andrew Yao Cho Fai is the sole shareholder of Perfect Capital International Corp. ("PCI"). Mr. Yao individually holds 10 shares of Huge Top Industrial Ltd ("Huge Top"). PCI acquires 40 shares of Huge Top from Mr. Yao Shu Sheng, so that Mr. Andrew Yao Cho Fai through PCI directly and indirectly holds 50% of the issued share capital of Huge Top. Huge Top holds 195,624,00 shares in Van Shung Chong Holdings Ltd, representing 65.86% of the issued share capital of VSC, Mr. Andrew Yao Cho Fai, together with PCI, is therefore deemed to have a corporate interest in 195,624,000 shares in VSC through their shareholding in Huge Top.
