- Join Truth Limited is interested in 430,124,400 shares in the listed company. The entire issued share capital share capital of Join Truth Limited is, in turn, owned by Silver Grant International Holdings Limited, China Nonferrous Metals Group (Hong Kong) Limited, Oriental Pearl Holdings Limited and Asia Like Securities Holdings Limited as to 41.84%, 25.10%, 8.37% and 24.69% respectively.
