- N1 On 16 November 1998, Prosperous Merchant Ltd held 780,000,000 shares in Mansion Holdings Ltd ("Mansion Shares") after disposing of 100,000,000 Mansion Shares at HK\$0.10 per Mansion Share on the same day. Royal Pacific Ltd owned the entire issued share capital of Prosperous Merchant Ltd.  
On 16 November 1998, Symphony Holdings Ltd ("Symphony") distributed Mansion Shares to its shareholders as special dividend on the basis of one Mansion Share for every five shares of Symphony held by its shareholders on the record date, i.e. 16 November 1998. Accordingly, First Place Ltd entitled to receive 154,065,282 Mansion Shares.  
Pacific Rim Capital Ltd, a company wholly owned by Ms. Ng Shuk Fong, my spouse, entitled to receive 4,000,000 Mansion Shares pursuant to the Distribution.  
Royal Pacific Ltd held more than one-third of the issued share capital of First Place Ltd.  
Chan Ting Chuen was interested in the entire issued share capital of Royal Pacific Ltd and was deemed to be interested in the 938,065,282 Mansion Shares by virtue of my interest in Royal Pacific Ltd and Ng Shuk Fong's interest in Pacific Rim Capital Ltd.
