Appointment of Receiver

This announcement is made by Celebrate International Holdings Limited (the “**Company**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong).

The Company received a notice from its creditor, Citizens Money Lending Corporation Limited (the “**Creditor**”) on 3 July 2019 that events of default have occurred under the debenture granted by the Company to the Creditor dated 25 January 2019 (the “**Debenture**”), and thereby the Creditor has appointed Mr. Tang Shing Tung (a member of the Association of Chartered Certified Accountants) as the Receiver (the “**Receiver**”) to all of the property and assets of the Company on 3 July 2019.

The Receiver is appointed by the Creditor to enforce and preserve the assets charged under the Debenture.

The Company and the Receiver will keep the public informed by making further announcements on any material development as appropriate.

Trading in the shares of the Company has been suspended since 6 June 2019 and will remain suspended until further notice.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
