

# NOTES TO THE UNAUDITED CONDENSED CONSOLIDATED FINANCIAL INFORMATION

For the three months and the nine months ended 31 March 2023

#### 1. GENERAL INFORMATION

The Company was incorporated as an exempted company with limited liability in the Cayman Islands on 31 May 2012. The registered office of the Company is located at Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman, KY1-1111, Cayman Islands. The principal place of business is located at Office A, 12/F, Tower A, Capital Tower, No. 38 Wai Yip Street, Kowloon Bay, Hong Kong.

The Company had its primary listing on the GEM of the Stock Exchange on 17 June 2013. The Company's principal activity is investment holding and the principal activities of its principal subsidiaries are (i) the provision of environmental cleaning services in Hong Kong and People's Republic of China (the "PRC"); and (ii) provision of money lending services in Hong Kong and the PRC.

#### 1. 一般資料

本公司於二零一二年五月三十一日在開曼群島註冊成立為獲豁免有限公司。本公司的註冊辦事處位於Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman, KY1-1111, Cayman Islands。本公司的主要營業地點位於香港九龍灣偉業街38號富臨中心A座12樓A室。

本公司於二零一三年六月十七日首次在聯交所GEM上市。本公司的主要業務為投資控股,旗下主要附屬公司的主要業務為(1)於香港及中華人民共和國(「中國」)提供環境清潔服務;及(i)於香港及中國提供放債服務。

#### 2. BASIS OF PREPARATION

The unaudited condensed consolidated results have been prepared in accordance with accounting principles generally accepted in Hong Kong which include Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards and Interpretations (collectively, "HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA") and the applicable disclosures required by the GEM Listing Rules. The principal accounting policies used in the first quarterly unaudited condensed consolidated results are consistent with those adopted in the preparation of the Group's annual financial statements for the year ended 30 June 2022. In current period, the Group has adopted all the new and revised HKFRSs that are relevant to its operations and effective for its accounting year beginning on or after 1 July 2022. The adoption of these new and revised HKFRSs did not have any significant impact on the unaudited condensed consolidated results.

The Group has not applied the new and revised HKFRSs which have been issued but are not yet effective. The Group is currently in the process of making an assessment of the impact of these new and revised HKFRSs but is not yet in a position to state whether they would have a material impact on the Group's results and financial position.

The unaudited condensed consolidated results have not been audited by the Company's auditors, but have been reviewed by the Company's audit committee.

#### 2. 編製基準

未經審核簡明綜合業績已根據香港 公認會計原則(包括香港會計師公 會(「香港會計師公會」)頒佈之香港 財務報告準則、香港會計準則及詮 釋(統稱為「香港財務報告準則」)) 及GEM上市規則之適用披露規定編 製。第一季度未經審核簡明綜合業 績所用之主要會計政策與編製本集 團截至二零二二年六月三十日止年 度之年度財務報表所採納者一致。 於本期間,本集團已採納所有與其 業務有關及於二零二二年七月一日 或之後開始的會計年度生效的新訂 及經修訂香港財務報告準則。採納 該等新訂及經修訂香港財務報告準 則對未經審核簡明綜合業績並無任 何重大影響。

本集團並無應用已頒佈但尚未生效 之新訂及經修訂香港財務報告準 則。本集團現正評估該等新訂及經 修訂香港財務報告準則之影響,惟 尚未能說明該等新訂及經修訂香港 財務報告準則會否對本集團業績及 財務狀況造成重大影響。

未經審核簡明綜合業績並未由本公司核數師審核,但已由本公司審核 委員會審閱。

Hong Kong profits tax is calculated at the rate of 8.25% for the first HK\$2,000,000 estimated assessable profits and 16.5% for estimated assessable profits above HK\$2,000,000 for the group entity qualified for the two-tiered profits tax rates regime introduced pursuant to the Inland Revenue (Amendment) (No. 7) Bill 2017. For group entities not qualifying for the two-tiered profits tax rates regime, the provision for Hong Kong profits tax is calculated at the rate of 16.5%.

PRC Enterprise Income Tax ("EIT") is calculated at 25% for the estimated assessable profits of PRC subsidiaries of the Group.

根據二零一七年稅務(修訂)(第7號)條例草案引入利得稅兩級制,合資格集團實體的首2,000,000港元估計應課稅溢利按稅率8.25%計算香港利得稅,2,000,000港元以上的估計應課稅溢利按稅率16.5%計算香港利得稅。就未符合利得稅兩級制資格的集團實體而言,香港利得稅撥備以稅率16.5%計算。

中國企業所得税(「企業所得税」)乃 就本集團中國附屬公司的估計應課 税溢利按25%計算。

# 7. INCOME TAX EXPENSES/(CREDIT) (CONTINUED)

Under the PRC tax law, profits of the Group's subsidiaries in the PRC (the "PRC subsidiaries") derived since 1 January 2008 is subject to withholding income tax at rates of 5% or 10% upon the distribution of such profits to foreign investors or companies incorporated in Hong Kong or for other foreign investors, respectively.

At 31 March 2023 and 31 March 2022, no deferred tax liabilities have been recognised in respect of tax that would be payable on the unremitted profits of the PRC subsidiaries derived since 1 January 2008 as the directors of the Company is in a position to control the dividend policies of the PRC subsidiaries and no distribution of such profits is expected to be declared from the PRC subsidiaries in the foreseeable future.

#### 8. DIVIDENDS

The Board does not recommend the payment of any dividend for the nine months ended 31 March 2023 (nine months ended 31 March 2022; HK\$Nii).

### 7. 所得稅開支/(抵免)(績)

根據中國稅法,本集團中國附屬公司(「中國附屬公司」)自二零零八年一月一日產生的溢利須於分派有關溢利予外國投資者或於香港註冊成立的公司或其他海外投資者時分別按稅率5%或10%預扣所得稅。

於二零二三年三月三十一日及二零 二二年三月三十一日,並無就自二 零零八年一月一日產生的中國附屬 公司未匯出溢利應付税項確認遞延 税項負債,原因為本公司董事可控 制中國附屬公司的股息政策及預期 中國附屬公司不會於可見未來宣派 分配有關溢利。

#### (a) Share premium

Under the Companies Law, Chapter 22 of the Cayman Islands, the funds in the share premium account of the Company are distributable to the shareholders of the Company provided that immediately following the date on which the dividend is proposed to be distributed, the Company will be in a position to pay off its debts as they fall in the ordinary course of business.

#### (b) Other reserve

The amount represents the difference between the nominal amount of shares issued by the Company and the aggregate amount of share capital of subsidiaries acquired under common control pursuant to the group reorganisation in preparation of the listing of the Company's shares on GEM of the Stock Exchange on 17 June 2013.

#### (c) Contribution surplus

The amount represents the amounts due to shareholders capitalised before the listing of the Company's shares on GEM of the Stock Exchange.

#### (d) Exchange reserve

The exchange reserve comprises all foreign exchange differences arising from the translation of the financial statements of foreign operations.

#### (e) Statutory surplus reserve

The statutory surplus reserve cannot be reduced except either in setting off the accumulated losses or increasing capital.

# MANAGEMENT DISCUSSION AND ANALYSIS

#### **BUSINESS OVERVIEW**

#### **Environmental and Cleaning Services**

The Group is principally engaged in the provision of environmental services in Hong Kong and the PRC, which include the provision of cleaning and related services for (i) public area and office cleaning services which involve cleaning of public areas, carpets, floors, toilets, changing rooms, lifts and escalators and emptying of garbage bins at commercial buildings and their tenants, residential complexes, shopping arcades, hotels and public transport facilities such as airport, ferries, ferry terminal, cargo and logistics centre and depots: (ii) overnight kitchen cleaning services mainly at private club and hotels: (iii) external wall and window cleaning services; (iv) stone floor maintenance and restoration services; (v) pest control and fumigation services: (vi) waste management and disposal solutions which mainly involve collection, transportation and disposal of household waste, construction waste and trade waste and sales of recyclable waste such as paper, metal and plastic waste collected during our operations; (vii) housekeeping services where we provide housekeeping services to carry out professional daily housekeeping and cleaning services at local boutique hotels, hostels and serviced apartments; (viii) secure and confidential waste destruction for commercial clients; (ix) sanitation solution for yacht; (x) cleaning and waste management solution for renovated apartment; and (xi) airline catering support services.

#### **Money Lending Business**

The Group conducted its money lending business under the money lenders licences granted by the licensing court pursuant to the Money Lenders Ordinance (Chapter 163 of the Laws of Hong Kong) in Hong Kong since 2017. The Group also conducted its money lending business in the PRC since 2019.

#### **Investments in Financial Assets**

During the period, the Group invested in financial assets classified as the financial assets at fair value through profit or loss which composed of only the shares of companies listed on the Stock Exchange.

### 管理層討論及分析

#### 業務概覽

#### 環境及清潔服務

本集團的主要業務為於香港及中國提供環 境服務,包括提供下列各項清潔及相關服 務:(i)公眾地方及辦公室清潔服務,其涉 及清潔公眾地方、地氈、地板、廁所、更 衣室、升降機及自動梯,以及在商業大廈 及其租戶、住宅屋苑、購物商場、酒店及 公共運輸設施(如機場、渡輪、渡輪碼頭、 貨物及物流中心及車廠)等地方收集掏空垃 圾箱;(ii)通宵廚房清潔服務,有關服務主 要提供予私人會所及酒店;(iii)外牆及玻璃 清潔服務; (iv)石材地板保養及翻新服務; (v)滅蟲及焗霧處理服務;(vi)廢物管理及處 置解決方案,其主要涉及收集、運輸及處 置住戶廢物、建築廢物及商貿廢物及出售 在本公司業務過程中收集所得的可循環再 用廢物,例如:廢紙、金屬及塑膠;(vii)房 務服務,我們為本地精品酒店、賓館及服 務式公寓提供房務服務,每日進行專業的 房務及清潔服務; (viii)為商業客戶提供敏感 及保密文件銷毀服務;(ix)為遊艇提供衞生 解決方案;(x)為翻新公寓提供清潔及廢物 管理解決方案;及(xi)航空餐飲支持服務。

#### 放債業務

自二零一七年起,本集團獲香港牌照法庭根據香港法例第163章放債人條例授予放債人牌照,據此開展放債業務。自二零一九年起,本集團亦於中國開展放債業務。

#### 投資金融資產

於期內,本集團投資分類為按公平值計入 損益之金融資產,其僅包括於聯交所上市 公司之股份。

#### **BUSINESS REVIEW**

# **Environmental and Cleaning Services in Hong Kong**

Compared to the revenue of approximately HK\$251.1 million for the nine months ended 31 March 2022, the environmental and cleaning services in Hong Kong contributed revenue of approximately HK\$274.6 million for the nine months ended 31 March 2023. The increase is mainly attributable to several new services contracts in the residential sector awarded.

#### Results

During the nine months ended 31 March 2023, the Group was granted by the HKSAR Government an one-off subsidy amounting to approximately HK\$0.8 million under the ESS for part of the monthly salaries of our employees under the environmental and cleaning services in Hong Kong which was included in the "Other income" for the period.

For the nine months ended 31 March 2023, the environmental and cleaning business in Hong Kong achieved a net profit of approximately HK\$5.7 million (excluding the one-off subsidy from the ESS) as compared to the net profit of approximately HK\$5.7 million for the nine months ended 31 March 2022. The net profit growth for the period remained sluggish is mainly due to increasing manpower services costs due to intense labor supply, decline in the prices from some customers upon renewal of their services contracts and increase in employees injury and public liabilities claims.

#### 業務回顧

#### 香港環境及清潔服務

與截至二零二二年三月三十一日止九個月的收益約251,100,000港元相比,香港環境及清潔服務於截至二零二三年三月三十一日止九個月貢獻收益約274,600,000港元。該增加乃主要由於取得住宅分部若干新服務合約。

#### 業績

截至二零二三年三月三十一日止九個月,本集團獲得香港特別行政區政府授予保就業計劃項下的一次性補貼約800,000港元,以用於香港環境及清潔服務分部的僱員的部分月薪,而有關補貼計入期內「其他收入」。

截至二零二三年三月三十一日止九個月,香港環境及清潔業務錄得純利約5,700,000港元(不包括保就業計劃的一次性補貼),而截至二零二二年三月三十一日止九個月則錄得純利約5,700,000港元。期內純利增長保持低迷乃主要由於勞工供應緊張導致人力服務成本不斷增加,部分客戶續簽服務合約後價格下跌,以及僱員工傷及公開債務索償增加所致。

# **Environmental and Cleaning Services in Shanghai, the PRC**

The Shanghai Operations recorded a decrease in the revenue by approximately HK\$6.3 million to approximately HK\$14.1 million for the nine months ended 31 March 2023 (2022: approximately HK\$20.4 million). And the Shanghai Operations recorded a net loss of approximately HK\$0.5 million for the nine months ended 31 March 2023 as compared to the net profit of approximately HK\$0.8 million for the nine months ended 31 March 2022. The significant downturn of the financial performance of the Shanghai Operations is mainly due to (i) lost of several service contracts due to fierce competition in pricing; (ii) decline in the prices and services volume from existing customers of which the businesses were severely affected by the city-wide lockdown of Shanghai in 2022; and (iii) continuing increasing manpower services costs due to intense labor supply.

#### **Money Lending Business**

The economy in Hong Kong and the PRC have been challenging for all businesses with the prolonged Sino-US trade tensions and the worldwide spreading of COVID-19. Amid such negative factors, some of our borrowers under the money lending business have been severely affected and are in financial difficulties, and therefore have defaulted on repayment of their loans and interests on schedules. Therefore, the Group already recognized the total impairment loss of approximately HK\$46.0 million (the "Impairment Loss") on part of these past due loans and interests receivables from such borrowers as at 31 March 2023. Nevertheless, the Group has been taking actions, including but not limited to legal proceedings against these borrowers, to recover the loan principals, interests and all other related recovery costs incurred.

#### 中國上海環境及清潔服務

上海業務於截至二零二三年三月三十一日止九個月錄得收益減少約6,300,000港元至約14,100,000港元(二零二二年:約20,400,000港元)。上海業務於截至二等二三年三月三十一日止九個月錄得淨虧損約500,000港元,而截至二零二二年三月三十一日止九個月則為純利約800,000港元。上海業務的財務表現嚴重下滑乃主要由於(i)價格競爭激烈導致失去若干服務合約;(ii)現有客戶的價格及服務量下降,該等客戶的業務因二零二二年上海全市封鎖而受到嚴重影響:及(iii)勞工供應緊張導致人力服務成本持續增加。

#### 放債業務

由於中美貿易關係持續緊張及COVID-19 在全球蔓延,香港及中國經濟形勢對於所 有企業而言富有挑戰性。鑒於有關不利因 素,放債業務項下的若干借款人已受到嚴 重影響及陷入財務困難,故延遲按計劃償 還貸款及利息。因此,本集團已就二零 二三年三月三十一日部分應收有關借款人 的該等逾期貸款及利息確認減值虧損總額 約46,000,000港元(「減值虧損」)。然而, 本集團持續採取行動(包括但不限於針對該 等借款人提出法律訴訟)以收回貸款本金、 利息及產生的所有其他相關收回成本。 The interest income from the money lending business for the nine months ended 31 March 2023 amounted to approximately HK\$3.8 million (2022: approximately HK\$9.4 million). The decrease in the interest income is mainly due to the decrease in the average loans balance and the average loan interest rates granted during the period.

The money lending business recorded a net operating profit of approximately HK\$0.8 million (excluding the reversal of impairment loss of approximately HK\$1.4 million recognized for the period) for the nine months ended 31 March 2023 (2022: approximately HK\$5.7 million). The decrease is primarily due to the decrease in the interest income during the nine months ended 31 March 2023.

#### **Properties in Hong Kong**

The market prices and sentiment of the commercial properties in Hong Kong has been gradually and slightly declining since mid of 2022. As a result, a revaluation loss of approximately HK\$1.9 million (2022: revaluation gain of approximately HK\$4.4 million) on the Group's commercial properties is recorded for the nine months ended 31 March 2023 based on the independent valuation as at 31 December 2022.

#### **Investments in Financial Assets**

The Group's investment strategy is to review the investment portfolio continuously and make appropriate adjustments (by acquisition or disposal) according to the market situation, with an aim to generate reasonable returns. During the nine months ended 31 March 2023, the Group recorded net unrealised fair value gain amounting to approximately HK\$165,860 (2022: fair value loss of approximately HK\$9,000) and net realised gain on disposals amounting to HK\$Nil (2022: HK\$30,000) from the investments in the financial assets.

截至二零二三年三月三十一日止九個月,放債業務的利息收入為約3,800,000港元 (二零二二年:約9,400,000港元)。利息收入減少乃主要由於期內授出的平均貸款結餘及平均貸款利率減少。

放債業務於截至二零二三年三月三十一日止九個月錄得經營純利約800,000港元(不包括於期內確認的減值虧損撥回約1,400,000港元)(二零二二年:約5,700,000港元)。該減少乃主要由於截至二零二三年三月三十一日止九個月利息收入減少。

#### 香港物業

位於香港的商業物業市場價格及信心自二零二二年年中以來已逐步小幅下跌。因此,根據於二零二二年十二月三十一日的獨立估值,截至二零二三年三月三十一日止九個月本集團商業物業錄得重估虧損約1,900,000港元(二零二二年:重估收益約4,400,000港元)。

#### 投資金融資產

本集團的投資策略為持續審閱投資組合並根據市況作出適當調整(透過收購或出售),旨在產生合理回報。截至二零二三年三月三十一日止九個月,本集團錄得投資金融資產之未變現公平值收益淨額約165,860港元(二零二二年:公平值虧損約9,000港元)及已變現出售收益淨額零港元(二零二二年:30,000港元)。

#### **OUTLOOK**

# **Environmental and Cleaning Services in Hong Kong**

Labor market competition in Hong Kong has intensified with the implementation of the SMW which would be adjusted upward in May 2023. The Group is also facing higher labor turnover rate in the environmental and cleaning services industry as more labor tend to work in other less laborious industries such as the security guard service industry under the same SMW rate. To offset the increase in labor costs, the Group is striving to transfer most of the increased labor costs to our customers and implement more efficient working flows and stringent cost control procedures. The Group is closely monitoring the labor turnover rate and regularly reviews our remuneration package in order to maintain sufficient labor force and cope with the changing environment. We would continue to enhance the quality of services by providing training to our front line staff.

#### 前景

#### 香港環境及清潔服務

隨著實施法定最低工資(其將於二零二三年五月上調),香港勞動力市場的競爭加劇。本集團亦正面對環保及清潔服務業的高勞工流失率,乃由於更多勞工在相同法定工資比率下傾向於其他較輕鬆的行業工作,例如保安護衛服務業。為抵銷勞工於本的增加,本集團力求將大部分已增加對工成本轉嫁予客戶並實施更有效的工作流程及嚴格的成本控制程序。本集團密切監控勞工流失率及定期檢討我們的薪酬計劃,以維持充足的勞動力並應對不斷變化的環境。我們將繼續通過向前線員工提供培訓提高服務質量。



The businesses in the transportation and the hotel sectors still have been recovering from the end of the worldwide spreading of COVID-19 since the fourth guarter of 2022. Our customers from the transportation and the hotel sectors have been reducing their service requests and asking for the prices reduction. Both of our service income and profit margin from these two sectors have seen affected. To mitigate such downturn effect, we would strengthen our marketing effort in hope to expand our market shares in the commercial and the residential sectors and continue to consolidate our resources to focus on high value customers to bring in additional revenue by cross-selling other cleaning and waste management services to our existing customers. We believe this strategy may not only improve our revenue per customer but also increase our profit margin as we could leverage our existing manpower to perform services at location where we already have presence. We would explore other new environmental and cleaning services to expand our service scope to enable customers to use the Group as a one-stop cleaning contractor. We would continue to streamline our operations in order to simplify and improve our operation efficiency. We believe that our success in serving different sectors will further build up the confidence for new clients to select our cleaning services in the coming future.

自二零二二年第四季度起,運輸及酒店行 業的企業仍在從COVID-19在全球蔓延結束 後復甦。我們來自運輸業及酒店業的客戶 一直減少其服務需求,並要求減價。我們 來自該兩個行業的服務收入及利潤率均受 到影響。為減輕有關衰退影響,我們將增 強營銷工作,以期擴大於商業及住宅領域 的市場份額,並繼續整合資源專注高價值 客戶,诱過向現有客戶交叉銷售其他清潔 及廢物管理服務,帶來額外收益。由於我 們可以發揮現有人力優勢在我們已進駐的 地點開展服務,故此我們相信,這項策略 不單可提高來自每位客戶的收益,亦可提 升我們的利潤率。我們將探索其他新的環 境及清潔服務,以擴大我們的服務範圍, 使客戶將本集團作為一站式清潔承包商。 我們將繼續精簡我們的業務,以簡化及提 升經營效率。我們深信,我們在服務於各 行業方面的成功,將進一步為新客戶日後 選用我們的清潔服務建立信心。

#### **Environmental and Cleaning Services in the PRC**

The Shanghai Operations has been facing difficulties in its operations and services contracts bidding process due to intense labor supply and fierce competition in the pricing of the cleaning services contracts bidding. To mitigate such downturn effect, the management of the Shanghai Operations has been strictly monitoring its operations capacity and efficiency to reduce all necessary expenditures and refining its marketing strategies in order to attract more new customers to utilize our cleaning services.

#### 中國環境及清潔服務

由於勞工供應緊張,以及清潔服務合約投標定價的競爭激烈,上海業務的經營及服務合約投標流程面臨困難。為緩解低迷影響,上海業務的管理層一直嚴格監控其運營能力及效率,以減少所有必要開支,並完善其營銷策略,以吸引更多新客戶使用我們的清潔服務。

#### **Money Lending Business**

With the increasing threat of a downturn of the economy in Hong Kong and the PRC as a result of the above-mentioned negative factors, the Group continues its effort in strengthening its risk management policy and streamlining our existing loan portfolio mix with an aim to reduce our exposure on high risk loans. A cautious and prudent approach is the key direction of our money lending strategies that only borrowers with sound financial abilities would be considered and approved by the Group in the future.

#### Investments in Financial Assets

A cautious and prudent approach is continued to be the key direction of our investment strategies that only companies listed on the Stock Exchange with valuable prospects would be considered and invested by the Group in the future.

#### **FINANCIAL REVIEW**

#### Revenue

For the nine months ended 31 March 2023, the Group reported a total revenue of approximately HK\$292.6 million (2022: approximately HK\$281.0 million), representing a increase of approximately 4.1%. The increase is mainly due to the net effect of (i) increase in the contribution of the revenue of approximately HK\$23.5 million from the environmental and cleaning services in Hong Kong as several new services contracts awarded in the residential sector; (ii) decrease in the contribution of the revenue of approximately HK\$6.3 million from the Shanghai Operations as several cleaning service contracts were lost and decline in the prices and services volume from existing customers during the period; and (iii) decrease in the interest income of approximately HK\$5.6 million from the money lending business after decrease in the average loans balances and average loan interest rates granted by the Group during the period.

#### 放債業務

由於上述不利因素導致香港及中國經濟衰退的威脅越來越大,本集團繼續努力加強其風險管理政策及精簡現有貸款組合,以降低高風險貸款的風險。我們的放債策略的主要指示為採取審慎保守態度,日後本集團僅會考慮及批准具有良好的財務能力的借款人。

#### 投資金融資產

管理層將於實施投資策略時持續採取審慎 保守態度,本集團於日後僅會考慮及投資 價值可觀的聯交所上市公司。

#### 財務回顧

#### 收益

截至二零二三年三月三十一日止九個月,本集團錄得總收益約292,600,000港元(二零二二年:約281,000,000港元),增加約4.1%。該增加主要由於(i)取得住宅分部若干新服務合約導致香港環境及清潔服務的收益貢獻增加約23,500,000港元:(ii)期內失去若干清潔服務合約及現有客戶的價格及服務量下跌令上海業務帶來之收益貢獻減少約6,300,000港元:及(iii)本集團於期內授出的平均貸款結餘及平均貸款利率減少後,放債業務帶來的利息收入減少約5,600,000港元的淨影響。



# Selling, Marketing Expenses and Administrative Expenses

The Group's selling, marketing and administrative expenses increased by approximately HK\$3.0 million to approximately HK\$18.8 million (2022: approximately HK\$15.8 million) for nine months ended 31 March 2023. The increase was mainly due to increase in the selling, marketing and administrative expenses, including but not limited to staff costs, rental expenses, entertainment expenses, advertising and promotion expenses, travelling expenses, exchange loss and general office expenses, of the Group's headquarters.

#### **DIVIDEND**

The Board does not recommend the payment of any dividend for the nine months ended 31 March 2023.
