NOTES TO THE UNAUDITED CONDENSED CONSOLIDATED FINANCIAL STATEMENTS

For the nine months ended 30 September 2023

1. GENERAL INFORMATION

The Company was incorporated in the Cayman Islands on 4 November 2016 as an exempted company with limited liability under the Companies Law (as revised) of the Cayman Islands, as amended, supplemented or otherwise modified from time to time. The address of its registered office is Windward 3, Regatta Office Park, P.O. Box 1350, Grand Cayman, KY1-1108, Cayman Islands.

The Company is an investment holding company. The Group is principally engaged in (1) the provision of visual display solution services for concerts and events primarily in Hong Kong, Macau, and the People's Republic of China, excluding Hong Kong, Macau and Taiwan for the purpose of this report (the "PRC"), (2) the provision of information technology consulting services in the PRC and (3) the provision of hotel reservation and convention planning services in the PRC.

The Company's shares (the "Shares") were listed on GEM of the Stock Exchange (the "Listing") on 14 June 2017 (the "Listing Date").

On 20 June 2023, a special resolution was passed by the shareholders of the Company in the annual general meeting to change the English name of the Company from "In Technical Productions Holdings Limited" to "Brightstar Technology Group Co., Ltd" and adopt "耀星科技集團股份有限公司" as the dual foreign name in Chinese of the Company. The Certificate of Incorporation on Change of Name was issued by the Registrar of the Companies in the Cayman Islands on 27 June 2023 certifying that the English name of the Company has been changed and the dual foreign name in Chinese of the Company has been adopted accordingly.

1. 一般資料

本公司於二零一六年十一月四日根據開曼群島公司法(經修訂)(經不時修訂、補充或以其他方式修改)在開曼群島註冊成立為獲豁免有限公司。其註冊辦事處地址為Windward 3, Regatta Office Park, P.O. Box 1350, Grand Cayman, KY1-1108, Cayman Islands。

本公司為一間投資控股公司。本集團主要從事(1)主要為香港、澳門及中華人民共和國(就本報告而言不包括香港、澳門及台灣)(「中國」)的演唱會及活動提供視像顯示解決方案服務、(2)在中國提供資訊科技諮詢服務及(3)在中國提供酒店預訂及會議規劃服務。

本公司股份(「**股份**」)於二零一七年六月十四日(「**上市日期**」) 於聯交所GEM上市(「**上市**」)。

The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 21 July 2023 confirming the registration of the new English and Chinese names of the Company in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

The unaudited condensed consolidated financial statements are presented in Hong Kong dollars ("HK\$"), unless otherwise stated.

2. BASIS OF PREPARATION

The unaudited condensed consolidated financial information of the Group for the nine months ended 30 September 2023 has been prepared in accordance with accounting policies which conform with Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") applicable to interim periods and the applicable disclosure provisions of the GEM Listing Rules. However, the unaudited condensed consolidated financial information does not contain sufficient information to constitute an interim financial report as defined in HKFRSs. The unaudited condensed consolidated financial information should be read in conjunction with the consolidated financial statements of the Group for the period from 1 June 2022 to 31 December 2022 included in the annual report of the Company dated 22 March 2023, which has been prepared in accordance with HKFRSs issued by the HKICPA

The unaudited condensed consolidated financial statements have been prepared on the historical cost basis.

2. 編製基準

本集團截至二零二三年九月三 十日止九個月的未經審核簡明 綜合財務資料乃根據符合香 港會計師公會(「香港會計師公 會」) 所頒佈適用於中期期間的 香港財務報告準則(「香港財務 報告準則I)的會計政策及GEM 上 市 規 則 的 適 用 披 露 條 文 編 製。然而,未經審核簡明綜合財 務資料並無載有足夠資料構成 香港財務報告準則所界定之中 期財務報告。未經審核簡明綜 合財務資料應與本集團於二零 二二年六月一日至二零二二年 十二月三十一日期間的綜合財 務報表一併閱讀,該綜合財務 報表已載列於本公司日期為二 零二三年三月二十二日的年度 報告內,該報告乃根據香港會 計師公會頒佈的香港財務報告 準則編製。

3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies that have been used in the preparation of these unaudited condensed consolidated financial information are consistent with those followed in the preparation of the Group's consolidated financial statements for the period from 1 June 2022 to 31 December 2022.

The Group has adopted and applied the new standards, amendments to standards and interpretations that have been issued and effective for the accounting periods beginning on 1 January 2023. The adoption of these new standards and amendments to standards has no material impact on the Group's results and financial position.

The Group has not early adopted those new standards, amendments to standards and interpretations which have been issued by the HKICPA but are not yet effective. The Group is in the process of assessing their impact on the Group's results and financial position.

3. 主要會計政策概要

本集團已採納及應用已頒佈並 於二零二三年一月一日開始的 會計期間生效的新準則、準則 修訂本及詮釋。採納該等新準 則及準則修訂本對本集團業績 及財務狀況並無重大影響。

本集團並未提前採納香港會計師公會已頒佈但尚未生效的新 準則、準則修訂本及詮釋。本集 團現正評估其對本集團業績及 財務狀況的影響。

4. REVENUE

Revenue is recognised to the extent that it is probable that the economic benefits will flow to the Group and the amount of revenue can be measured reliably. Revenue from visual display solution services, information technology consulting services and hotel reservation and convention planning services is recognised after each show or event of a project is performed, while revenue from equipment rental is recognised on a straight-line basis over the term of the lease.

An analysis of the Group's revenue for the reporting period is as follows:

5. INCOME TAX EXPENSE

Pursuant to the enactment of two-tiered profit tax rates issued by the Inland Revenue Department ("IRD") from the year of assessment 2018/19 onwards, the Group's first HK\$2 million of assessable profits under Hong Kong profits tax for the nine months ended 30 September 2023 is subject to a tax rate of 8.25%, while the remaining assessable profits are subject to a tax rate of 16.5%. During the nine months ended 30 September 2023, no Hong Kong profit tax has been provided for as the Group did not generate any estimated assessable profit.

All PRC subsidiaries of the Company are subject to the PRC Enterprise Income Tax at the rate of 25.0% for the nine months ended 30 September 2023 and 30 September 2022.

The Macau subsidiary of the Company was subject to Macau complementary tax at the rate of 12.0% on the estimated assessable income exceeding Macau Patacas ("MOP") 600,000 for the nine months ended 30 September 2023 and 30 September 2022.

There was nil effective income tax of the Group for the nine months ended 30 September 2023 (30 September 2022: Nil).

5. 所得税開支

For the nine months ended 30 September 2023 and the same corresponding period for the nine months ended 30 September 2022, the basic loss per share is calculated based on (i) the loss attributable to owners of the Company and (ii) the weighted average number of shares issued during the period.

MANAGEMENT DISCUSSION AND ANALYSIS

BUSINESS REVIEW

The Group is principally engaged in (1) the provision of visual display solution service for concerts and events primarily in Hong Kong, Macau and the PRC, (2) the provision of information technology consulting services in the PRC and (3) the provision of hotel reservation and convention planning services in the PRC.

Visual display solutions

During the nine months ended 30 September 2023, the Group was engaged in 361 pop concert shows for Hong Kong and non-Hong Kong artists/bands (30 September 2022: 84).

The Group derived approximately 83.8% of its total revenue during the nine months ended 30 September 2023 from pop concerts (30 September 2022: 37.0%), the majority of which took place in Hong Kong. The remainder of the Group's revenue of visual display solutions business was attributable to other live events, including corporate events, exhibitions, sports and recreational events and other live performances, as well as equipment rental.

管理層討論及分析

業務回顧

本集團主要從事(1)主要為香港、澳門及中國的流行音樂演唱會及活動提供 視像顯示解決方案服務,(2)於中國提供資訊科技諮詢服務及(3)於中國提供 酒店預訂及會議規劃服務。

視像顯示解決方案

截至二零二三年九月三十日止九個月內,本集團獲委聘為香港及非香港藝人/樂隊的361場流行音樂演唱會(二零二二年九月三十日:84場)提供服務。

截至二零二三年九月三十日止九個月內,本集團約83.8%的總收益來自 流行音樂演唱會(二零二二年九月三十日:37.0%),其中大部分在香港 舉行。本集團餘下來自視像顯示解決 方案業務的收益則來自企業活動、展 覽、體育及休閒活動以及其他現場表 演等其他現場活動以及設備租賃。

Information technology consulting

During the nine months ended 30 September 2023, the revenue of provision of information technology consulting services amounted to approximately HK\$2.5 million (representing 3.9% of the total revenue) (30 September 2022: 25.7%) which was mainly contributed by an information technology project of a customer in the PRC.

Hotel reservation and convention planning

In March 2023, the Group started hotel reservation and convention planning services. During the nine months ended 30 September 2023, the revenue of provision of hotel reservation and convention planning services amounted to approximately HK\$2.1 million (representing 3.4% of the total revenue) (30 September 2022: Nil).

FINANCIAL REVIEW

Revenue

The Group generates revenue from providing (i) visual display solutions to its customers in relation to pop concert shows and various other live events; (ii) information technology consulting services; (iii) hotel reservation and convention planning services; and (iv) equipment rental.

資訊科技諮詢

截至二零二三年九月三十日止九個月內,提供資訊科技諮詢服務的收益約為2.5百萬港元(佔總收益的3.9%)(二零二二年九月三十日:25.7%),主要由一名中國客戶的資訊科技項目貢獻。

酒店預訂及會議規劃

於二零二三年三月,本集團開始提供 酒店預訂及會議規劃服務。截至二零 二三年九月三十日止九個月內,提供 酒店預訂及會議規劃服務的收益約為 2.1百萬港元(佔總收益的3.4%)(二零 二二年九月三十日:無)。

During the nine months ended 30 September 2023, the Group principally derived its revenue from the provision of visual display solutions, the provision of information technology consulting services and the provision of hotel reservation and convention planning services, which accounted for 92.3% of the Group's total revenue (nine months ended 30 September 2022: approximately 72.3%), 3.9% of the Group's total revenue (nine months ended 30 September 2022: 25.7%) and 3.4% of the Group's total revenue (nine months ended 30 September 2022: Nil) respectively. The Group's revenue increased by approximately 142.6% from approximately HK\$25.8 million for the nine months ended 30 September 2022 to approximately HK\$62.5 million for the nine months ended 30 September 2023.

The increase in revenue from pop concerts was mainly attributable to (i) the increase in the average revenue per show for pop concerts from approximately HK\$91,000 for the nine months ended 30 September 2022 to approximately HK\$145,000 for the nine months ended 30 September 2023; and (ii) the increase in the number of pop concert shows undertaken by the Group from 105 for the nine months ended 30 September 2022 to 361 for the nine months ended 30 September 2023.

Information technology consulting

During the nine months ended 30 September 2023, the revenue of provision of information technology consulting services amounted to approximately HK\$2.5 million (representing 3.9% of the total revenue) (30 September 2022: 25.7%) which was mainly contributed by an information technology project of a customer in the PRC.

Hotel reservation and convention planning

In March 2023, the Group started hotel reservation and convention planning services. During the nine months ended 30 September 2023, the revenue of provision of hotel reservation and convention planning services amounted to approximately HK\$2.1 million (representing 3.4% of the total revenue) (30 September 2022; Nil).

資訊科技諮詢

Gross profit/(loss) and gross profit/(loss) margin

The gross profit of the Group for the nine months ended 30 September 2023 amounted to approximately HK\$24.5 million (2022: gross loss of approximately HK\$3.0 million), representing a gross profit margin of approximately 39.3% (2022: gross loss margin of approximately 11.7%). The change from the gross loss margin to gross profit margin was mainly attributable to the increase in revenue.

Income tax expense

The Group is subject to income tax on an enterprise basis on profits arising in or derived from the jurisdictions in which members of the Group are domiciled and operate.

During the nine months ended 30 September 2023 and 30 September 2022, all PRC subsidiaries of the Company were subject to the PRC Enterprise Income Tax at the rate of 25.0%.

Pursuant to the implementation of the two-tiered profit tax rates issued by the IRD from the year of assessment 2018/19 onwards, the Group's first HK\$2 million of assessable profits under Hong Kong profits tax for the nine months ended 30 September 2023 is subject to a tax rate of 8.25%, while the remaining assessable profits are subject to a tax rate of 16.5%. During the nine months ended 30 September 2023, no Hong Kong profits tax has been provided for as the Group did not generate any estimated assessable profit (nine months ended 30 September 2022: same).

The Macau subsidiary of the Company was subject to Macau complementary tax at the rate of 12.0% on the estimated assessable income exceeding MOP600,000 during the nine months ended 30 September 2023 and the nine months ended 30 September 2022.

There was no effective income tax of the Group for the nine months ended 30 September 2023 and 30 September 2022.

Our income tax expenses changed from approximately HK\$0.6 million of income tax credit for the nine months ended 30 September 2022 to approximately no income tax expense for the nine months ended 30 September 2023.

毛利/(毛損)及毛利/(毛損)率

截至二零二三年九月三十日及二零二 二年九月三十日止九個月,本集團並 無實際所得稅。

我們的所得税開支由二零二二年九月 三十日止九個月的約0.6百萬港元的所 得税抵免轉換為截至二零二三年九月 三十日止九個月的約無所得税開支。

Loss for the period

As a result of the foregoing, the Group's loss was approximately HK\$7.8 million for the nine months ended 30 September 2023, as compared with a loss of approximately HK\$16.1 million for the corresponding period in 2022, excluding the gain on bargain purchase recorded for the nine months ended 30 September 2022. The loss was mainly due to the revenue for the nine months not being able to cover the relatively high cost of services and administrative expenses (including the high equipment depreciation cost). Although the revenue for the nine months ended 30 September 2023 has increased by HK\$36.7 million compared with the corresponding period in 2022, the increment was still not able to compensate the cost of services and administrative expenses during the period.

LIQUIDITY AND CAPITAL RESOURCES

Financial Resources, Liquidity and Capital Structure

The Group finances its operations primarily through cash generated from operating activities and interest-bearing bank borrowing, overdrafts and finance leases. The Group recorded net current assets of approximately HK\$126.6 million as at 30 September 2023 (31 December 2022: net current assets of approximately HK\$120.7 million).

As at 30 September 2023, the Group's current ratio was approximately 2.41 (31 December 2022: approximately 2.14) and the Group's gearing ratio calculated based on the total debt (including shareholder's loans) at the end of the period divided by total equity at the end of the period was approximately 5.6% (31 December 2022: approximately 23.5%). The decrease of the Group's gearing ratio in the nine months ended 30 September 2023 was mainly due to the issue of Shares to set off the shareholder loans.

流動資金及資本資源

財務資源、流動資金及<mark>資本架</mark> 構

本集團主要通過經營活動產生的現金 及計息銀行借款、透支及融資租賃為 其經營提供資金。本集團於二零二三 年九月三十日錄得流動資產淨值約為 126.6百萬港元(二零二二年九月三十 日:流動資產淨值約120.7百萬港元)。

於二零二三年九月三十日,本集團的流動比率約為2.41(二零二二年十二月三十一日:約2.14)及本集團的資產負債比率以期末債務(包括股東貸款)總額除以期末權益總額計算約為5.6%(二零二二年十二月三十一日:約23.5%)。本集團資產負債比率於截至二零二三年九月三十日止九個月減少乃主要由於發行股份以抵銷股東貸款所致。

As at 30 September 2023, the maximum limit of the banking facilities available to the Group amounted to HK\$13 million. The bank borrowings were denominated in Hong Kong dollars, repayable within one year or on demand and interest-bearing at floating rates from 3.5% to 7.7% per annum (31 December 2022: 3.4% to 6.6% per annum).

As at 30 September 2023, the capital structure of the Group consisted of equity attributable to owners of the Company of approximately HK\$144.6 million, comprising issued share capital and reserves.

The Shares were listed on GEM of the Stock Exchange on 14 June 2017. There has been no change in the capital structure of the Group since then.

FOREIGN CURRENCY EXPOSURE RISKS

The Group operates mainly in the PRC and Hong Kong and is exposed to foreign exchange risk arising from various currency exposures, primarily with respect to certain purchases with United States dollars ("US\$") and MOP. Foreign exchange risk arises when future commercial transactions, recognised assets and liabilities are denominated in a currency that is not the group entities' functional currency. The Group however did not engage in any derivatives agreements and did not commit to any financial instrument to hedge its foreign exchange exposure during the nine months ended 30 September 2023

TREASURY POLICIES

The Group has adopted a prudent financial management approach towards its treasury policies and thus maintained a healthy liquidity position throughout the nine months ended 30 September 2023. The Group strives to reduce exposure to credit risk by performing ongoing credit assessments and evaluations of the financial status of its customers. To manage liquidity risk, the Board closely monitors the Group's liquidity position to ensure that the liquidity structure of the Group's assets, liabilities and other commitments can meet its funding requirements from time to time.

庫務政策

本集團對其庫務政策採取審慎的財務 管理方法,因此,截至二零二三十日止九個月整段期間保持了通 康的流動資金狀況。本集團力財務狀 持續的信貸評估及對其客戶財務狀況 進行評估以降低信用風險。為管理別 動性風險,董事會密切監察事 資金狀況,確保本集團資產、 債及其他承諾的流動性結構不時滿足 其資金需求。

SIGNIFICANT INVESTMENTS, MATERIAL ACQUISITIONS AND DISPOSALS OF SUBSIDIARIES

On 23 May 2023, Guangzhou Yiciyuan Technology Company Limited* (廣州異次元科技有限公司), an indirect wholly-owned subsidiary of the Company (as the purchaser) and Guangzhou Lingjing Smart Technology Company Limited* (廣州靈境智慧科技有限公司) (as the vendor) entered into a sale and purchase agreement, pursuant to which the purchaser has conditionally agreed to acquire, and the vendor has conditionally agreed to acquire, and the vendor has conditionally agreed to acquire, and the vendor has conditionally agreed to sell 10% of the registered capital of Shenzhen Evolution Equation Technology Company Limited* (深圳市進化方程科技有限公司) at a consideration of RMB50,000,000 in cash. Employees' salary and relevant benefits are determined on the basis of performance, qualification, experience, positions and the Group's business performance.

The Directors are not aware of any significant event requiring disclosure that has taken place subsequent to 30 September 2023 and up to the date of this report.

AUDIT COMMITTEE

The Company has established an audit committee on 19 May 2017 (the "Audit Committee") with written terms of reference in compliance with Rules 5.28 to 5.29 of the GEM Listing Rules. The primary duties of the Audit Committee are to review the Company's draft annual, interim and quarterly financial reports and accounts and to provide advice and comments thereon to the Board. The Audit Committee is also responsible for reviewing and supervising the financial reporting process and internal control procedures of the Group. The Audit Committee currently comprises five independent non-executive Directors, namely Mr. Cui Hai Bin, Ms. Jiang Yu E, Mr. Ji Gui Bao, Mr. Jiang Peiyan and Mr. Li Xiao Hua. Mr. Ji Gui Bao is the chairman of the Audit Committee.

The Audit Committee has reviewed this report and the unaudited condensed consolidated results of the Group for the nine months ended 30 September 2023 and the effectiveness of internal control system of the Group.
