## CHAIRMAN'S STATEMENT 主席報告

Dear Shareholders,

On behalf of the Board of Directors (the "**Board**") of the Company, I am pleased to present the annual report of the Company for the year ended 31 March 2025.

#### **Review**

As a well-established contractor in the car park flooring industry in Hong Kong and Macau, we provide (i) flooring services, which involve the application of proprietary floor coating products for the purpose of providing a colourful, slip-resistant, hard-wearing surface that is resistant against water and petrochemicals; (ii) ancillary services, which include specialised texture painting and waterproofing works; and (iii) sales of flooring and waterproofing materials. Our target segment ranges from mid to high end projects in the relevant markets.

During the year ended 31 March 2025, the revenues from Hong Kong and other Asian regions were approximately HK\$166.8 million (2024: approximately HK\$145.6 million) and approximately HK\$122,000 (2024: approximately HK\$2.0 million), respectively. The other Asian region includes Macau where there was no sales recorded for the year ended 31 March 2025 (2024: approximately HK\$1.6 million).

As a result of the global economic slowdown and ongoing uncertainties in the property markets of Hong Kong and Macau, the Group anticipates facing a number of challenges in the years ahead. These challenges may include, but are not limited to, diminished demand in both the commercial and residential real estate sectors, increased competition in the market, and rising global inflation.

#### **Looking Forward**

In spite of these challenges, the Group continues to be agile and responsive to the changing market dynamics. We are actively implementing (i) diversification strategies to reduce business risks and enhance revenue by exploring investment opportunities globally, with a particular focus on emerging economies in Asia; and (ii) measures to manage operating costs and streamline administrative expenses. These initiatives are designed to protect the interests of the shareholders of the Company and ensure favourable returns on investments during periods of economic volatility.

Additionally, the Group is committed to sustaining its competitive advantage and market leadership in the car park flooring and waterproofing sectors, which have consistently been the foundational elements of our business.

#### 回顧

作為一間於香港及澳門停車場地坪鋪設行業內根 基穩固的承建商,我們提供:(i)地坪鋪設服務, 涉及塗裝專利地坪鋪設塗層產品,以提供色彩豐 富、防滑以及具防水及不易受石油化工產品破壞 特性的耐磨表面:(ii)配套服務,包括專業紋理塗 裝及防水工程:及(iii)銷售地坪鋪設及防水材料。 我們的目標業務分部為相關市場之中高端項目。

截至二零二五年三月三十一日止年度,來自 香港及其他亞洲地區市場的收益分別約為 166,800,000港元(二零二四年:約145,600,000 港元)及約122,000港元(二零二四年:約 2,000,000港元)。其他亞洲地區包括澳門,而澳 門於截至二零二五年三月三十一日止年度並無錄 得銷售額(二零二四年:約1,600,000港元)。

由於全球經濟放緩及香港及澳門房地產市場持續 不明朗,本集團預期未來數年將面對多項挑戰。 該等挑戰包括但不限於商業及住宅房地產需求減 少、市場競爭加劇及全球通脹升溫。

#### 前景

儘管面對該等挑戰,本集團仍會繼續靈活應對不 斷變化的市場局勢。我們正積極推行(i)多元化策 略,透過在全球範圍內發掘投資機遇,特別是在 亞洲新興經濟體的投資機遇,以減低業務風險及 增加收益;及(ii)以控制營運成本及精簡行政開支 的措施。該等措施旨在保障本公司股東利益,並 確保在經濟波動期內仍享有理想投資回報。

此外,本集團致力維持其在停車場地坪鋪設及防 水領域的競爭優勢及市場主導地位,這兩個領域 一直是我們業務的基礎部分。

Mr. Kwong has accumulated over 20 years of experience in the car park flooring industry.

**Mr. Yip Kong Lok (**葉港樂), aged 49, is an executive Director and chief executive officer of the Group and is principally responsible for the business development, overall management and business operations of the Group. Mr. Yip first joined the Group in November 2003 on a part time basis to promote the Group's business. In August 2015, Mr. Yip took up the position of manager of KMK on a full time basis. Mr. Yip has accumulated over 20 years of experience in the car park flooring industry. Mr. Yip is a Director of all subsidiaries of the Group except Victor Ease Limited.

Mr. Choi has over 30 years of experience in financial management, financial control, auditing, treasury, taxation as well as various projects regarding mergers and acquisitions and initial public offerings. During the course of his professional career, he had the opportunity to hold various senior accounting and finance positions in company listed on the Main Board of the Stock Exchange, international corporation and other well-established companies in various industries.

We provide (i) flooring services, which involve the application of proprietary floor coating products for the purpose of providing a colorful, slip-resistant, hard-wearing surface that is resistant against water and petrochemicals; (ii) ancillary services, which include specialised texture painting and waterproofing works; and (iii) sales of flooring and waterproofing materials. Our target segment ranges from mid to high end projects in the relevant markets.

During the year ended 31 March 2025, the revenues from Hong Kong and other Asian regions were approximately HK\$166.8 million (2024: approximately HK\$145.6 million) and approximately HK\$122,000 (2024: approximately HK\$2.0 million), respectively. The other Asian region includes Macau where there was no sales recorded for the year ended 31 March 2025 (2024: approximately HK\$1.6 million).

For the year ended 31 March 2025, the Group recorded total revenue of approximately HK\$166.9 million, or an increase by approximately 13.1% as compared with approximately HK\$147.6 million for the same period ended 31 March 2024, and the Group's profit attributable to owners of the Company decreased from approximately HK\$13.9 million for the year ended 31 March 2024 to approximately HK\$8.2 million for the year ended 31 March 2025.

In May 2025, the Group entered into a supplemental agreement with Zephyr Group, Inc. ("**ZGI**") to further extend the maturity date of the convertible promissory note with principal sum of US\$500,000 from 1 July 2025 (the maturity date of the supplemental agreement entered in September 2024) to 31 July 2027 (new maturity date). Save as amended, the other terms of the convertible promissory note remain unchanged and shall continue in full force. ZGI was incorporated in the United States of American and is a plant-based biotech Company focusing on health, wellness and unique nutraceutical products.

#### Revenue

The flooring services segment were the focus among our business segments for the year ended 31 March 2025. It involves the application of proprietary floor coating products for the purpose of providing a colorful, slip-resistant, hard-wearing surface that is resistant against water and petrochemicals. During the year ended 31 March 2025, the revenue from the floor services increased by approximately HK\$8.3 million to approximately HK\$132.1 million (2024: approximately HK\$123.8 million).

The ancillary services segment includes specialised texture painting and waterproofing works. During the year ended 31 March 2025, the revenue from ancillary services increased by approximately HK\$11.1 million to approximately HK\$34.0 million (2024: approximately HK\$23.0 million).

#### 業務及財務回顧

本集團主要從事香港停車場地坪鋪設行業。我們 提供:(i)地坪鋪設服務,涉及塗裝專利地坪鋪設 塗層產品,以提供色彩豐富、防滑以及具防水及 不易受石油化工產品破壞特性的耐磨表面:(ii)配 套服務,包括專業紋理塗裝及防水工程;及(iii) 銷售地坪鋪設及防水材料。我們的目標業務分部 為相關市場之中高端項目。

截至二零二五年三月三十一日止年度,來自 香港及其他亞洲地區市場的收益分別約為 166,800,000港元(二零二四年:約145,600,000 港元)及122,000港元(二零二四年:約2,000,000 港元)。其他亞洲地區包括澳門,而澳門於截至 二零二五年三月三十一日止年度並無錄得銷售額 (二零二四年:約1,600,000港元)。

截至二零二五年三月三十一日止年度,本集團錄 得總收益約166,900,000港元,較截至二零二四 年三月三十一日止同期約147,600,000港元增加 約13.1%。本公司擁有人應佔的本集團溢利由截 至二零二四年三月三十一日止年度約13,900,000 港元減少至截至二零二五年三月三十一日止年度 約8,200,000港元。

於二零二五年五月,本集團與Zephyr Group, Inc.(「ZGI」)訂立補充協議,將本金額為500,000 美元之可轉換承兑票據的到期日由二零二五年七 月一日(於二零二四年九月訂立的補充協議的到 期日)進一步延長至二零二七年七月三十一日(新 到期日)。除經修訂的條款外,可轉換承兑票據 的其他條款維持不變,並將繼續完全有效。ZGI 在美國註冊成立,為一間主要研究植物的生物科 技公司,主營健康、保健及獨特的營養食品。

#### 收益

截至二零二五年三月三十一日止年度,地坪鋪 設服務分部為我們業務分部的重點。該分部涉 及塗裝專利地坪鋪設塗層產品,以提供色彩豐 富、防滑以及具防水及不易受石油化工產品破壞 特性的耐磨表面。截至二零二五年三月三十一 日止年度,地坪鋪設服務收益增加約8,300,000 港元至約132,100,000港元(二零二四年:約 123,800,000港元)。

配套服務分部包括專業紋理塗裝及防水工程。 截至二零二五年三月三十一日止年度,配套服務 收益增加約11,100,000港元至約34,000,000港元 (二零二四年:約23,000,000港元)。

The sales of materials segment include the sales of flooring and waterproofing materials. During the year ended 31 March 2025, the revenue from the sales of materials increased by approximately HK\$56,000 to approximately HK\$852,000 (2024: approximately HK\$796,000).

In total, the revenue, principally generated from the provision of car park flooring services for construction projects, increased by approximately HK\$19.4 million or approximately 13.1% from approximately HK\$147.6 million for year ended 31 March 2024 to approximately HK\$166.9 million for year ended 31 March 2025. The increase in revenue was principally attributed to increase in projects awarded.

A breakdown of the revenue is listed below:

#### Gross profit and gross profit margin

The Group's gross profit dropped by approximately HK\$1.6 million, or approximately 3.0% from approximately HK\$53.3 million for the year ended 31 March 2024 to approximately HK\$51.7 million for the year ended 31 March 2025. The gross profit margin of the Group decreased from approximately 36.1% for the year ended 31 March 2024 to approximately 31.0% for the year ended 31 March 2025. Such decrease was primarily due to the implementation of pricing strategy with lower profit margin by the Group in order to remain competitive and secure construction contracts in the flooring market.

#### Other income and other gains or losses, net

For the year ended 31 March 2025, the Group incurred net losses over the other income and gains of approximately HK\$2.1 million as compared with other income and gains of approximately HK\$561,000 for the year ended 31 March 2024. The net losses for the year ended 31 March 2025 were primarily due to (i) the net fair value losses of approximately HK\$1.6 million on the financial assets at fair value through profit or loss with reference to the valuation performed by an independent professional valuer and (ii) loss of approximately HK\$504,000 on deregistration of a subsidiary during the year ended 31 March 2025.

#### 毛利及毛利率

本集團的毛利由截至二零二四年三月三十一日止 年度約53,300,000港元減少約1,600,000港元或 約3.0%至截至二零二五年三月三十一日止年度 約51,700,000港元。本集團的毛利率由截至二零 二四年三月三十一日止年度約36.1%減少至截至 二零二五年三月三十一日止年度約31.0%。有關 減少主要是由於本集團實施降低邊際利潤的定 價策略,以保持競爭力及取得地坪市場的建築合 約。

#### 其他收入及其他收益或虧損淨額

截至二零二五年三月三十一日止年度,本集團於 其他收入及收益中產生虧損淨額約2,100,000港 元,而截至二零二四年三月三十一日止年度為其 他收入及收益約561,000港元。於截至二零二五 年三月三十一日止年度產生虧損淨額主要是由 於(i)參考獨立專業估值師所進行的估值而產生 的以公平值計入損益之金融資產公平值虧損淨 額約1,600,000港元;及(ii)截至二零二五年三月 三十一日止年度撤銷一間附屬公司的註冊而產生 的虧損約504,000港元。

## (Provision for)/reversal of impairment loss on trade and retention receivables and contract assets

For the year ended 31 March 2025, the impairment loss on trade and retention receivables and contract assets of approximately HK\$4.5 million was recognised (2024: reversal of impairment loss of approximately HK\$723,000) which were mainly due to (i) trade receivable due from customers with significant doubt on collection that are individually assessed to be fully impaired and (ii) adoption of a higher expected credit loss rates under the prevailing weak economy.

Impairment loss is calculated under expected credit loss model with reference to the expected credit loss rates, which were determined based on the Group's internal and historical credit loss data, the days past due and the probability of default of customers, and also taking into account the forward-looking information. The details of the measurement are set out in Note 3.1(c) to the consolidated financial statements in this report.

#### General and administrative expenses

General and administrative expenses of the Group slightly decreased from approximately HK\$33.1 million for the year ended 31 March 2024 to approximately HK\$32.7 million for the year ended 31 March 2025. General and administrative expenses consist primarily of staff cost, depreciation, professional fee and other general administrative expenses.

#### Impairment loss of an associate

Impairment loss of an associate relates to the Group's 40% equity interest in an associate providing a car-sharing platform and motor beauty service in Hong Kong and China, respectively.

For the year ended 31 March 2025, the Group conducted an impairment review of its investment in the associate with reference to its recoverable and carrying amounts. Consequently, an impairment loss of the associate was recognised in profit and loss as approximately HK\$497,000 for the year ended 31 March 2025 (2024: approximately HK\$3.2 million).

An impairment loss is recognised when the carrying amount of an asset exceeds its recoverable amount. The recoverable amount is determined as the higher of the asset's fair value less costs of disposal and its value in use.

#### Income tax expense

Income tax expense for the Group was approximately HK\$3.2 million for the year ended 31 March 2025 as compared with income tax expense of approximately HK\$3.7 million for the year ended 31 March 2024. The decrease of income tax expense was mainly due to the decrease in profit before income tax from approximately HK\$18.5 million for the year ended 31 March 2024 to approximately HK\$12.3 million for the year ended 31 March 2025.

#### 應收貿易賬款及應收保留金以及合約資產的減值 虧損(撥備) / 撥回

截至二零二五年三月三十一日止年度,應收貿易 賬款及應收保留金以及合約資產的減值虧損約 4,500,000港元已予確認(二零二四年:減值虧損 撥回約723,000港元),乃主要由於(i)應收存在重 大收款疑慮的客戶的應收貿易賬款經個別評估為 全數減值;及(ii)在當前疲弱經濟下採用較高預期 信貸虧損率。

減值虧損是根據預期信貸虧損模型及參照預期信 貸虧損率計算,而預期信貸虧損率是根據本集團 內部及過往信貸虧損記錄、逾期日數及客戶違約 概率釐定,當中亦考慮前瞻性資料。有關計量的 詳情載於本報告綜合財務報表附註3.1(c)。

#### 一般及行政開支

本集團的一般及行政開支由截至二零二四年三月 三十一日止年度約33,100,000港元輕微減少至截 至二零二五年三月三十一日止年度約32,700,000 港元。一般及行政開支主要包括員工成本、折 舊、專業費用及其他一般行政開支。

#### 聯營公司之減值虧損

聯營公司之減值虧損與本集團所持有的一間於香 港及中國分別提供汽車共享平台及汽車美容服務 的聯營公司的40%股權有關。

截至二零二五年三月三十一日止年度,本集團參 照其可收回金額及賬面值,對其於聯營公司的投 資進行減值審查。由此,於截至二零二五年三月 三十一日止年度於損益內確認聯營公司之減值虧 損約497,000港元(二零二四年:約3,200,000港 元)。

當資產的賬面值超過其可收回金額時,會確認減 值虧損。可收回金額按資產的公平值減出售成本 與其使用價值兩者中的較高者釐定。

#### 所得税開支

本集團於截至二零二五年三月三十一日止年度 的所得税開支約為3,200,000港元,而截至二零 二四年三月三十一日止年度的所得税開支約為 3,700,000港元。所得税開支減少,主要是由於 除所得税前溢利由截至二零二四年三月三十一日 止年度約18,500,000港元減少至截至二零二五年 三月三十一日止年度約12,300,000港元。

#### Profit for the year attributable to owners of the Company

As a result of the foregoing, the profit attributable to owners of the Company decreased from approximately HK\$13.9 million for the year ended 31 March 2024 to approximately HK\$8.2 million for the year ended 31 March 2025.

#### OUTLOOK

As a result of the global economic slowdown and ongoing uncertainties in the property markets of Hong Kong and Macau, the Group anticipates facing a number of challenges in the years ahead. These challenges may include, but are not limited to, diminished demand in both the commercial and residential real estate sectors, increased competition in the market, and rising global inflation.

In spite of these challenges, the Group continues to be agile and responsive to the changing market dynamics. We are actively implementing (i) diversification strategies to reduce business risks and enhance revenue by exploring investment opportunities globally, with a particular focus on emerging economies in Asia; and (ii) measures to manage operating costs and streamline administrative expenses. These initiatives are designed to protect the interests of the shareholders of the Company and ensure favorable returns on investments during periods of economic volatility.

Additionally, the Group is committed to sustaining its competitive advantage and market leadership in the car park flooring and waterproofing sectors, which have consistently been the foundational elements of our business.

#### LIQUIDITY AND FINANCIAL RESOURCES

As at 31 March 2025, the Group had cash and cash equivalents of approximately HK\$33.4 million (2024: approximately HK\$46.2 million). The Group's current ratio was approximately 2.8 times as at 31 March 2025 compared to approximately 2.6 times at 31 March 2024.

The total interest-bearing borrowings (including bank borrowings and lease liabilities) of the Group as at 31 March 2025 were approximately HK\$9.1 million (2024: approximately HK\$15.5 million). The borrowings were secured by the Group's certain assets with carrying amount of approximately HK\$32.5 million as at 31 March 2025 (2024: approximately HK\$33.8 million).

As at 31 March 2025, the Group had total assets of approximately HK\$179.9 million (2024: approximately HK\$181.3 million) which were financed by total liabilities and total equity of approximately HK\$50.1 million (2024: approximately HK\$54.8 million) and approximately HK\$129.8 million (2024: approximately HK\$126.5 million). The Board considers that the Group has sufficient financial resources to meet its funding requirements at all times.

#### 本公司擁有人應佔年度溢利

#### 前景

由於全球經濟放緩及香港及澳門房地產市場持續 不明朗,本集團預期未來數年將面對多項挑戰。 該等挑戰包括但不限於商業及住宅房地產需求減 少、市場競爭加劇及全球通脹升溫。

儘管面對該等挑戰,本集團仍會繼續靈活應對不 斷變化的市場局勢。我們正積極推行(i)多元化策 略,透過在全球範圍內發掘投資機遇,特別是在 亞洲新興經濟體的投資機遇,以減低業務風險及 增加收益;及(ii)以控制營運成本及精簡行政開支 的措施。該等措施旨在保障本公司股東利益,並 確保在經濟波動期內仍享有理想投資回報。

此外,本集團致力維持其在停車場地坪鋪設及防 水領域的競爭優勢及市場主導地位,這兩個領域 一直是我們業務的基礎部分。

#### 流動資金及財務資源

於二零二五年三月三十一日,本集團擁有現金 及現金等價物約33,400,000港元(二零二四年: 約46,200,000港元)。本集團於二零二五年三月 三十一日的流動比率約為2.8倍,而於二零二四 年三月三十一日則約為2.6倍。

於二零二五年三月三十一日,本集團的計息借貸 總額(包括銀行借貸及租賃負債)約為9,100,000 港元(二零二四年:約15,500,000港元)。該等借 貸以本集團於二零二五年三月三十一日賬面值約 32,500,000港元(二零二四年:約33,800,000港 元)的若干資產作抵押。

於二零二五年三月三十一日,本集團的總 資產約為179,900,000港元(二零二四年:約 181,300,000港元),而總負債及總權益分別約 為50,100,000港元(二零二四年:約54,800,000 港元)及約129,800,000港元(二零二四年:約 126,500,000港元)。董事會認為,本集團擁有充 裕財政資源,足以隨時滿足資金需求。

#### **CHARGES ON THE GROUP'S ASSETS**

As at 31 March 2025, certain assets included in property, plant and equipment and right-of-use assets with carrying amounts of approximately HK\$8.9 million and approximately HK\$22.1 million (2024: approximately HK\$9.3 million and approximately HK\$23.1 million), respectively, and investment in an insurance contract with a carrying amount of approximately HK\$1.4 million (2024: approximately HK\$1.4 million), were charged to secure a banking facilities of approximately HK\$24.5 million (2024: approximately HK\$25.5 million). As at 31 March 2025, approximately HK\$17.5 million of the banking facilities were unutilised (2024: approximately HK\$12.5 million).

#### **GEARING RATIO**

The gearing ratio of the Group as at 31 March 2025 was approximately 6.6% (2024: approximately 10.9%).

The gearing ratio is calculated based on the total interest-bearing borrowings divided by the total capital of approximately HK\$138.9 million as at 31 March 2025 (2024: approximately HK\$142.0 million). The total capital of the Group is calculated as total equity plus total borrowings.

#### **CAPITAL STRUCTURE**

The shares of the Company were listed on GEM of the Stock Exchange on 13 October 2016. The share capital of the Company only comprises of ordinary shares.

As at 31 March 2025 and 2024, the Company's issued share capital was HK\$5,974,440 and the number of its issued ordinary shares was 597,444,000 of HK\$0.01 each.

As at 31 March 2025, KMK has paid to the Vendor's Solicitor the Initial Deposit in the sum of HK\$1,000,000 and a Further Deposit in the sum of HK\$830,000. The balance of the Consideration was paid in June 2025. The Directors of the Company consider that it is in the interests of the Group to acquire the Property as a self-owned warehouse. The acquisition shall secure storage space for the goods of the Group, save rental, goods storage, and renovation expenses in the long run, and improve the efficiency of the Group's operations.

As at 31 March 2025, the size of the acquisition relative to the Group's total assets was approximately 10.2%.

For further details in relation to the above acquisition, please refer to the announcements of the Company dated 24 March 2025 (where the capitalised terms hereinabove shall have the same meaning as those defined in the announcement) and Note 31 to the consolidated financial statements.

## FUTURE PLANS FOR MATERIAL INVESTMENTS OF CAPITAL ASSETS

Save as disclosed in this report, the Group did not have other plans for material investments or capital assets as of 31 March 2025.

#### **RISK OF FOREIGN EXCHANGE FLUCTUATIONS**

The Group's assets, liabilities, revenues and expenses are mainly denominated in Hong Kong dollars ("**HK\$**"), United States dollars ("**US\$**"), Macau Pataca ("**MOP**") and Malaysian Ringgit ("**MYR**"). Under the Linked Exchange Rate System of Hong Kong, HK\$ is pegged to US\$. Hence, the risk of the exchange rate fluctuation of US\$ against HK\$ is very limited. The exchange rates fluctuations of MOP and MYR against HK\$ are primarily arising from the operations of the Group's subsidiaries in Macau and Malaysia. In considering of their size of the operations, the Group considers the risk of foreign exchange fluctuations of MOP and MYR against HK\$ are insignificant to the Group.

The Group does not have foreign currency hedging arrangement but will closely monitor the exposure and take measures when necessary.

#### **TREASURY POLICY**

The Group adopted a prudent financial management approach towards its treasury policies and maintained a healthy liquidity position throughout the reporting year. To manage liquidity risk, the Board closely monitors the Group's liquidity position to ensure that the liquidity structure of the Group's assets, liabilities and commitments can meet its funding requirements from time to time. 於二零二五年三月三十一日, 鄭文記已向賣方 律師支付初始訂金1,000,000港元及進一步訂金 830,000港元。代價餘款已於二零二五年六月支 付。董事認為收購物業作為其自置貨倉符合本集 團的利益。收購事項可保障本集團的貨物儲存 空間,長遠而言可節省租金、貨物儲存及裝修開 支,並提高本集團的營運效率。

#### 外匯波動風險

本集團的資產、負債、收益和開支主要以港元 (「港元」)、美元(「美元」)、澳門元(「澳門元」) 和馬來西亞令吉(「令吉」)計值。根據香港聯繫匯 率制度,港元與美元掛鈎。因此,美元兑港元匯 率波動的風險非常有限。澳門元和令吉對港元的 匯率波動主要來自本集團於澳門和馬來西亞的附 屬公司的業務。考慮到其業務規模,本集團認為 澳門元和令吉兑港元的匯率波動風險對本集團而 言並不重大。

本集團並無外幣對沖安排,但將密切監察有關風 險並於必要時採取措施。

#### 庫務政策

本集團在庫務政策上採納審慎的財務管理方針, 並於報告年度內一直維持穩健的流動資金狀況。 為管理流動資金風險,董事會密切監察本集團的 流動資金狀況,以確保本集團的資產、負債及承 擔的流動資金結構能符合其不時的資金需求。

#### **EMPLOYEES AND REMUNERATION POLICIES**

As at 31 March 2025, the Group had 64 employees in total (2024: 54 employees). The employee costs of the Group (including directors' emoluments and management, administrative and operational staff costs) for the year ended 31 March 2025 were approximately HK\$30.3 million (2024: approximately HK\$27.1 million).

As at 31 March 2025, the gender ratio for the Group's employees was approximately 78% male and approximately 22% female. The Company promotes a fair employment policy, and the recruitment has been merit-based in order to produce a more diverse pool of skilled and experienced team of staff. The Company plans to gradually achieve a higher proportion of female staff across the workforce. Further details relating to the Group's diversity approach can be found in the Company's 2025 ESG report.

The Group remunerates its employees based on their performance, working experience and with reference to the prevailing market conditions. On top of basic remuneration, discretionary bonus may be granted to senior management and staff members by reference to the Group's performance as well as individual's performance. Other staff benefits include medical benefits, mandatory provident fund and sponsorship of training courses. Share options may also be granted to eligible employees as incentives or rewards for their contribution to the Group.

#### **CONTINGENT LIABILITIES**

As at 31 March 2025 and 2024, the Group did not have any significant contingent liabilities.

#### COMMITMENT

Save as disclosed in Note 31 to the consolidated financial statements, the Group had no other material commitment as at 31 March 2025 and 2024.

The Company has made continued efforts to incorporate the key elements of sound corporate governance in its management structures and internal control procedures. The Company is committed to maintaining a high standard of corporate governance, the principles of which serve to uphold a high standard of ethics, transparency, responsibility and integrity in all aspects of business, and to ensure that affairs are conducted in accordance with applicable laws and regulations.

The Board believes that good and effective corporate governance practices are keys to obtaining and maintaining the trust of the shareholders of the Company (the "**Shareholders**") and other stakeholders, and essential for encouraging accountability and transparency so as to sustain the success of the Group and to create long-term value for the Shareholders.

#### **CORPORATE GOVERNANCE PRACTICE**

The Board is responsible for performing the corporate governance duties set out in the Corporate Governance Code (the "**CG Code**") as set out in Appendix C1 of the GEM Listing Rules, which includes developing and reviewing the Company's policies and practices on corporate governance, training and continuous professional development of Directors, and reviewing the Company's compliance with the code provision in the CG Code and disclosures in this report.

The Company has complied with the principles and applicable code provisions of the CG Code for the year ended 31 March 2025.

#### DIRECTORS' SECURITIES TRANSACTIONS

The Company has adopted Rules 5.48 to 5.67 of the GEM Listing Rules as the code of conduct for securities transactions by the Directors in respect of the Shares (the "**Code of Conduct**"). - To focus on matters affecting the Company's overall strategic policies, finances and interest of the Shareholders;
- To consider and approve disclosable transaction(s);
- To consider dividend policy and dividend amount; and
- To review and monitor the corporate governance policies and practices of the Group to ensure compliance with the legal and regulatory requirements.

The Company has taken out director and officer liability insurance to cover liabilities arising from legal action against the Directors.

Ms. To Yee Man, an existing independent non-executive Director of the Company, has been appointed with effect from 1 October 2024 as the chairman of the Audit Committee and a member of the Legal Compliance Committee.

The Company has received an annual confirmation of independence from each of the INEDs pursuant to Rule 5.09 of the GEM Listing Rules. The Company considers the INEDs to be independent as at the date of this report.

#### TERMS OF APPOINTMENT AND RE-ELECTION OF DIRECTORS

Each executive Director has entered into a service agreement with the Company for a fixed term of three years and will continue thereafter until terminated by either party giving not less than three months' written notice to the other party.

The service agreements and/or letters of appointment of the Directors are subject to termination in accordance with their respective terms. They can be renewed in accordance with the articles of association of the Company ("**Articles**") and the applicable GEM Listing Rules.

As required under the Articles, all Directors are subject to election by the Shareholders at the Company at the first general meeting after their appointment. At every annual general meeting of the Company at least one-third of the Directors for the time being shall retire from office by rotation, provided that every Director (including those appointed for a specific term) shall be subject to retirement by rotation at least once every three years. A retiring Director shall be eligible for re-election thereat.

The Remuneration Committee regularly reviews and determines, with delegated responsibilities from the Board, the remuneration and compensation packages of individual Directors and senior management by reference to, among other things, market level of remuneration and compensation paid by comparable companies, the respective responsibilities of the Directors and the performance of the Group.

Details of the remuneration of the Directors and senior management by band are set out in Notes 23 and 28 to the consolidated financial statements in this report.

#### **Nomination Committee**

The nomination committee of the Company (the "**Nomination Committee**") was established on 24 September 2016 with its written terms of reference in compliance with Rule 5.36A of the GEM Listing Rules and code provision B.3.1 of the CG Code. The primary duties of the Nomination Committee are to make recommendations to the Board regarding candidates to fill vacancies on the Board and/or in senior management of the Company.

The Nomination Committee should consider a number of factors in assessing, evaluating and selecting candidates for the directorships based on the Group's nomination policy. These factors include (i) character and integrity; (ii) qualifications and experience that are relevant to the Company's business and strategy; (iii) commitment to devote sufficient time to discharge the duties as a member of the Board and other directorship; (iv) diversity in all aspects in order to achieve the diversity of the Board; (v) independence requirement with reference to the independence guidelines set out in Rule 5.09 of the GEM Listing Rules when evaluating the suitability of the candidates to be INEDs; and (vi) such other factors which are appropriate to the Company's business and strategy.

The Nomination Committee consists of three members, being Mr. Kwong Chi Man, Ms. Yu Wan Wah Amparo and Mr. Wat Danny Hiu Yan. #### **DIVERSITY OF THE BOARD**

In order to ensure the balanced composition and effectiveness of the Board, the Company has accordingly adopted a Board diversity policy (the "**Board Diversity Policy**"), which sets out the approach to achieve diversity on the Board. The Company seeks to achieve Board diversity through the consideration of a number of factors, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skill, knowledge and length of service. The Board appointments will be based on the performance and competence of the candidates, and the merit and contribution to be brought to the Board by the selected candidates.

The Board will review such objectives from time to time to ensure their appropriateness and ascertain the progress made towards achieving those objectives. The Nomination Committee will review the Board Diversity Policy from time to time to ensure its continued effectiveness. The existing Board members are coming from a variety of business and professional background, the Company considers that the Board possesses a balance of skills, experience, expertise and diversity of perspectives appropriate to the requirements of the Company's business.

The Nomination Committee will report annually on the Board's composition under diversified perspectives in the Corporate Governance Report, and monitor the implementation of the diversity policy to ensure its effectiveness and compliance with the CG Code. The Nomination Committee will consider any revisions that may be required and propose recommendation to the Board for consideration and approval.

Through the Company's Board Diversity Policy and the annual review of the Board's structure by the Nomination Committee under the Board, the Company will establish a pipeline of potential director successors that can achieve gender diversity. The Board is responsible for the Group's internal control and has conducted a review of the effectiveness of the internal control of the Group, including financial, operational and compliance controls and risk management functions. No material inadequacy of internal controls has been revealed in terms of risk management in the Group's decision-making process. The Board is of the opinion that the Company has fully complied with the code provisions regarding risk management and internal control in the CG Code. The risk management and internal control systems are effective and adequate.

A staff in the finance department was assigned to perform the internal audit functions as part of her job and she reports the audit's findings to the Audit Committee. She mainly reviews and tests the control of the Group's major operational, financial, compliance and risk management based on the Group's policies. She communicates the findings, control deficiencies and remedial actions with the management and Audit Committee for improvement of the Group's internal control system.

During the year ended 31 March 2025, the Group has reviewed and tested the internal control of the procedure of (i) sales and receivable cycle; (ii) procurement and payable cycle; (iii) human resource and payroll processes; and (iv) cash and treasury management. The internal audit staff reported that the Group consistently complied with relevant policies and procedures. Suggestions were made to the Audit Committee and the management has implemented certain follow-up measures based on the internal audit findings.

The Directors continue to adopt the going concern approach in preparing the consolidated financial statements and are not aware of any material uncertainties relating to events or conditions that may cast significant doubt upon the Company's ability to continue as a going concern.

The responsibilities of the external auditors about their financial reporting are set out in the independent auditor's report attached to the Company's consolidated financial statements for the year ended 31 March 2025 in this report.

#### AUDITOR'S REMUNERATION

For the year ended 31 March 2025, the remuneration paid or payable to Baker Tilly Hong Kong Limited (as the auditors of the Company) and its affiliate companies in respect of audit and non-audit services were HK\$650,000 and HK\$58,000 respectively.

#### **DIVIDEND POLICY**

The Group has established its dividend policy in compliance with code provision F.1.1 of the CG Code, which aims to provide a transparency of the mechanism used for determination of the dividend amount and payment as well as to notify Shareholders and other persons concerned of the dividend policy of the Group. It broadly specifies the external and internal factors, including financial parameters, that shall be considered while declaring dividend and the circumstances under which the Shareholders of the Group may or may not expect dividend and how the retained earnings shall be utilized.

The Board will review and monitor the implementation of the Group's dividend policy from time to time.

#### **COMPANY SECRETARY**

Mr. Choi Wai Hung ("**Mr. Choi**"), an employee of the Company, was appointed by the Board as the secretary of the Company on 15 December 2017. The biographical details of Mr. Choi are set out under the section headed "Profile of Directors and Senior Management" in this report. Mr. Choi is principally responsible for supervision of the Group's financial reporting, financial planning, treasury, financial control and company secretarial matters.

## Convening of Extraordinary General Meeting on Requisition by Shareholders

Pursuant to Article 12.3 of the Articles, the Board may, whenever it thinks fit, convene an extraordinary general meeting ("**EGM**"). EGMs shall also be convened on the requisition of two or more Shareholders holding, at the date of deposit of the requisition, not less than one-tenth of the paid-up capital of the Company having the right of voting at general meetings. Such requisition shall be made in writing to the Board or the company secretary of the Company for the purpose of requiring an EGM to be called by the Board for the transaction of any business specified in such requisition, and such meeting shall be held within 3 months after the deposit of such requisition. If, within 21 days of such deposit, the Board fails to proceed to convene such meeting within a further 21 days, the requisitionists themselves may convene a meeting in accordance with the Articles and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisition(s) by the Company.

#### Right to put enquiries to the Board

For putting forward any enquiries to the Board, Shareholders may send their written enquiries or requests in respect of their rights to the Company's principal place of business in Hong Kong.

## Procedure for shareholders to put forward proposals at shareholders' meetings

There are no provisions allowing Shareholders to move new resolutions at the general meetings of the Company under the Companies Law (Revised) of Cayman Islands. However, pursuant to the Articles, Shareholders who wish to move a resolution may by means of requisition convene an EGM following the procedures set out above.

#### **PRINCIPAL ACTIVITIES**

The Company is the investment holding company of the Group. The Group is principally engaged in car park flooring industry in Hong Kong and Macau. We provide (i) flooring services, which involve the application of proprietary floor coating products for the purpose of providing a colorful, slip-resistant, hard-wearing surface that is resistant against water and petrochemicals; (ii) ancillary services, which include specialised texture painting and waterproofing works; and (iii) sales of car park flooring and waterproofing materials.

For further particulars of the subsidiaries of the Group, details of which are set out in Note 32(a) to the consolidated financial statements in this report.

#### **BUSINESS REVIEW**

The Group's operation is not subject to any environmental requirements in Hong Kong, except the Dangerous Goods Ordinance (Chapter 295 of the Laws of Hong Kong) (the "**Dangerous Goods Ordinance**"), and that some of the works conducted by the Group are subject to environmental compliance examination under the Hong Kong Green Building Council's "BEAM Plus" scheme. The Group has established effective environmental management system in conformity with the international standard requirements, for the provision of design, construction, installation and maintenance services to the customers.

An environmental policy and manual of procedures have been effective upon listing of the shares of the Company on GEM, which demonstrate the Group's commitment to environmental protection. All staff, subcontractors and suppliers are required to diligently implement the policy and the manual, which will be reviewed regularly in light of experience, feedback from staff, business development, current regulations and legislation.

#### (B) Compliance with laws and regulations with a significant impact on the Group

Apart from the licensing requirement under the Dangerous Goods Ordinance, the Group is not subject to any requirement to obtain any particular approval or permit for carrying out the car park flooring business in Hong Kong. The Dangerous Goods Ordinance controls the usage, storage, manufacturing and conveyance of the dangerous goods and sets out the relevant licensing requirements in relation to these activities.

The Group's operations are mainly carried out by its subsidiaries in Hong Kong and Macau with the Company itself incorporated in the Cayman Islands.

To the best knowledge and belief of the Directors, the Group's operations in Hong Kong and Macau have complied with the applicable laws and regulations in the above jurisdictions in all material respects during the year ended 31 March 2025, and up to the date of this report.

## (C) Key relationships with employees, customers, suppliers and subcontractors

The Directors are of the view that the Company has maintained good relationships with its employees, customers, suppliers and subcontractors. The Company will hold the AGM on 29 August 2025. Notice of the AGM will be published and dispatched to the Shareholders in accordance with the articles of association of the Company and the GEM Listing Rules in due course.

#### **CLOSURE OF REGISTER OF MEMBERS**

For determining the entitlement to attend and vote at the AGM, the register of members of the Company will be closed from 26 August 2025 to 29 August 2025, both dates inclusive, during which period no transfer of Shares will be registered. In order to be eligible to attend and vote at the AGM, unregistered holders of shares of the Company should ensure that all transfer documents accompanied by the relevant share certificates must be lodged with the Company's branch share registrar and transfer office in Hong Kong, Tricor Investor Services Limited, at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong for registration not later than 4:30 pm on 25 August 2025.

For determining the entitlement to the proposed final dividend, the register of members of the Company will be closed from 9 September 2025 to 12 September 2025, both dates inclusive, during which period no transfer of Shares will be registered. Only Shareholders whose names appear on the register of members of the Company on 12 September 2025 are entitled to the proposed final dividend payable on or about 2 October 2025. #### SHARE OPTION SCHEME

The Company conditionally adopted a share option scheme (the "Share Option Scheme") on 24 September 2016 (the "Adoption Date"). The terms of the Share Option Scheme are in accordance with the provisions of Chapter 23 of the GEM Listing Rules. The following is a summary of the principal terms and conditions of the Share Option Scheme.

#### (i) Purpose of the Share Option Scheme

The purpose of the Share Option Scheme is to attract and retain the best available personnel, to provide additional incentive to employees (full-time and part-time), directors, consultants, advisers, distributors, contractors, suppliers, agents, customers, business partners and services providers of the Group and to promote the success of the business of the Group.

#### (ii) Who may join and basis of eligibility

The Board may, at its absolute discretion and on such terms as it may think fit, grant any employee (full-time or part-time), director, consultant or adviser of the Group, or any substantial shareholder of the Group, or any distributor, contractor, supplier, agent, customer, business partner or service provider of the Group, options to subscribe at a price calculated in accordance with paragraph (iii) below for such number of Shares as it may determine in accordance with the terms of the Share Option Scheme. The basis of eligibility of any participant to the grant of any option shall be determined by the Board (or as the case may be, the INEDs) from time to time on the basis of his contribution or potential contribution to the development and growth of the Group.

#### (iii) Price of Shares

The subscription price of a Share in respect of any particular option granted under the Share Option Scheme shall be a price solely determined by the Board and notified to a participant and shall be at least the highest of: (i) the closing price of the Shares as stated in the Stock Exchange's daily quotations sheet on the date of grant of the option, which must be a business day; (ii) the average of the closing prices of the Shares as stated in the Stock Exchange's daily quotations sheets for the five business days immediately preceding the date of grant of the option; and (iii) the nominal value of a Share on the date of grant of the option.

#### 購股權計劃

#### (iii) 股份價格

#### (iv) Grant of options and acceptance of offers

An offer for the grant of options must be accepted within seven days inclusive of the day on which such offer was made. The amount payable by the grantee of an option to the Company on acceptance of the offer for the grant of an option is HK\$1.00.

#### (v) Maximum number of Shares

- Subject to sub-paragraphs (2) and (3) below, the maximum number of Shares issuable upon exercise of all options to be granted under the Share Option Scheme and any other share option schemes of the Company as from the Adoption Date (excluding, for this purpose, Shares issuable upon exercise of options which have been granted but which have lapsed in accordance with the terms of the Share Option Scheme or any other share option schemes of the Company) must not in aggregate exceed 10% of all the Shares in issue. Therefore, the Company may grant options in respect of up to 60,000,000 Shares (or such numbers of Shares as shall result from a sub-division or a consolidation of such 60,000,000 Shares from time to time) to the participants under the Share Option Scheme.
- 2. The 10% limit as mentioned above may be refreshed at any time by obtaining approval of the Shareholders in general meeting provided that the total number of Shares which may be issued upon exercise of all options to be granted under the Share Option Scheme and any other share option schemes of the Company must not exceed 10% of the Shares in issue as at the date of approval of the refreshed limit. Options previously granted under the Share Option Scheme and any other share option schemes of the Company (including those outstanding, cancelled or lapsed in accordance with the terms of the Share Option Scheme or any other share option schemes of the Company) will not be counted for the purpose of calculating the refreshed 10% limit. A circular must be sent to the Shareholders containing the information as required under the GEM Listing Rules in this regard.

#### (iv) 授出購股權及接納要約

In such event, the Company must send a circular to the Shareholders containing a generic description of such grantees, the number and terms of such options to be granted and the purpose of granting options to them with an explanation as to how the terms of the options will serve such purpose, such other information required under the GEM Listing Rules.
- 4. The aggregate number of Shares which may be issued upon exercise of all outstanding options granted and yet to be exercised under the Share Option Scheme and any other share option schemes of the Company must not exceed 30% of the Shares in issue from time to time. No options may be granted under the Share Option Scheme or any other share option schemes of the Company if this will result in such 30% limit being exceeded.

#### (vi) Maximum entitlement of each participant

The total number of Shares issued and to be issued upon exercise of options granted to any participant (including both exercised and outstanding options) under the Share Option Scheme, in any 12-month period up to the date of grant shall not exceed 1% of the Shares in issue. Any further grant of options in excess of such limit must be separately approved by Shareholders in general meeting with such grantee and his close associates (or his associates if the grantee is a connected person) abstaining from voting. In such event, the Company must send a circular to the Shareholders containing the identity of the grantee, the number and terms of the options to be granted (and options previously granted to such grantee), and all other information required under the GEM Listing Rules. The number and terms (including the subscription price) of the options to be granted must be fixed before the approval of the Shareholders and the date of the Board meeting proposing such further grant should be taken as the date of grant for the purpose of calculating the subscription price.

The Share Option Scheme will remain in force for a period of ten years commencing on the date on the Adoption Date and shall expire at the close of business on the business day immediately preceding the tenth anniversary thereof unless terminated earlier by the Shareholders in general meeting.

#### (ix) Number of options and awards available for grant

The number of options available for grant under the Share Option Scheme was 60,000,000 Shares, and 60,000,000 Shares respectively at the beginning and the end of the financial year ended 31 March 2025. There is no applicable service provider sublimit at the beginning and the end of the financial year ended 31 March 2025.

No share option has been granted or exercised under the Share Option Scheme during the year ended 31 March 2025. No share option was outstanding as at 31 March 2025.

#### PURCHASE, SALE OR REDEMPTION OF THE SHARES

Neither the Company nor any of its subsidiaries had purchased, sold or redeemed any of the Company's shares during the year ended 31 March 2025.

# NOTES TO THE CONSOLIDATED FINANCIAL STATEMENTS 综合財務報表附註

#### **1 GENERAL INFORMATION**

Kwong Man Kee Group Limited (the "Company") was incorporated in the Cayman Islands on 30 May 2016 as an exempted company with limited liability under the Companies Law, Cap. 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands. The address of the Company's registered office is P.O. Box 309, Ugland House, Grand Cayman, KY1-1104, Cayman Islands and its principal place of business is 21/F, The Bedford, 91-93 Bedford Road, Kowloon, Hong Kong.

The Company is an investment holding company. The Company and its subsidiaries (together, the "Group") are principally engaged in the provision of engineering services in flooring, screeding, anti-skid surfacing, specialised texture painting and waterproofing works. The controlling shareholder of the Company is Mr. Kwong Chi Man ("Mr. Kwong") and the parent company of the Company is Sage City Investments Limited ("Sage City").

The consolidated financial statements are presented in Hong Kong dollars ("HK\$"), unless otherwise stated.

The Company listed its shares on GEM of The Stock Exchange of Hong Kong Limited on 13 October 2016 (the "Listing").

### 2 BASIS OF PREPARATION AND CHANGES IN ACCOUNTING POLICIES

#### 2.1 Basis of preparation

The consolidated financial statements of the Company have been prepared in accordance with HKFRS Accounting Standards issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and disclosure requirements of the Hong Kong Companies Ordinance (Cap. 622). The consolidated financial statements have been prepared under the historical cost convention, except for investment in an insurance contract and financial assets at fair value through profit or loss which are carried at cash surrender value and fair value, respectively.

#### **3 FINANCIAL RISK MANAGEMENT**

#### 3.1 Financial risk factors

The Group's activities expose it to a variety of financial risks: foreign exchange risk, interest rate risk, credit risk and liquidity risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

Management regularly manages the financial risks of the Group. Because of the simplicity of the financial structure and the current operations of the Group, no hedging activities are undertaken by management.

#### (a) Foreign exchange risk

The Group mainly operates in Hong Kong and is exposed to immaterial exchange risk from various currency exposures.

As the assets and liabilities of each company within the Group are mainly denominated in the respective company's functional currency, the directors are of the opinion that the Group's volatility of its profits against changes in exchange rates of foreign currencies would not be significant.

#### (b) Interest rate risk

The Group's interest rate risk arises from bank deposits, bank borrowings and lease liabilities. Bank borrowings issued at variable rates expose the Group to cash flow interest rate risk which is partially offset by the bank deposits. Lease liabilities issued at fixed rates expose the Group to fair value interest rate risk. The interest rate profile of bank borrowings is disclosed in Note 20. The bank deposits generate interest at the prevailing market interest rates.

As at 31 March 2025, if interest rates had been 25 basis points higher/lower with all other variables held constant, the Group's profit for the year would have increased/ decreased by approximately HK\$55,000 (2024: HK\$69,000), mainly as a result of higher/lower interest income over expense on floating rate bank deposits and bank borrowings.

本集團的業務面對不同財務風險:外 匯風險、利率風險、信貸風險及流動 資金風險。本集團的整體風險管理計 劃集中處理金融市場的不可預測性, 並尋求盡力減輕對本集團財務表現的 潛在不利影響。

管理層定期管理本集團之財務風險。 由於本集團的財務結構及目前營運較 為簡單,故管理層並無進行任何對沖 活動。

#### (a) 外匯風險

本集團主要在香港經營,並面臨 各種貨幣所產生的外匯風險,有 關風險並不重大。

由於本集團內各公司的資產及負 債主要以各公司之功能貨幣計 值,董事認為,本集團之溢利不 會因外幣匯率變動而出現重大波 動。

#### (b) 利率風險

本集團的利率風險來自銀行存 款、銀行借貸以及租賃負債。以 浮動利率計息的銀行借貸令本集 團面對現金流量利率風險,而該 風險部份獲銀行存款抵銷。以固 定利率計息的租賃負債令本集團 面對公平值利率風險。銀行借貸 的利率概況於附註20披露。銀行 存款按現行市場利率產生利息。

於二零二五年三月三十一日,倘 利率上升/下降25個基點而所有 其他變數維持不變,本集團年度 溢利將增加/減少約55,000港元 (二零二四年:69,000港元),主 要由於浮動利率銀行存款和銀 行借貸的利息收入高於/低於支 出。

#### (c) Credit risk

Credit risk of the Group mainly arises from trade and retention receivables, contract assets, deposits, other receivables and cash and cash equivalents. The carrying amounts of these balances except cash on hand in the consolidated statement of financial position represent the Group's maximum exposure to credit risk in relation to its financial assets.

#### Cash and cash equivalents

The majority of the Group's bank balances are placed in financial institutions which are independently rated with high credit ratings. Management does not expect any losses from non-performance by these financial institutions as they have no default history in the past.

#### Other receivables

Other receivables are also subject to the impairment requirements under HKFRS 9. It is measured as either 12-month expected credit losses or lifetime expected credit loss, depending on whether there has been a significant increase in credit risk since initial recognition. If a significant increase in credit risk of a receivable has occurred since initial recognition, impairment is measured as lifetime expected credit losses. As at 31 March 2025 and 2024, the identified impairment loss for other receivables is assessed to be minimal.

#### Deposits

Deposits are mainly rental deposit and utilities and management fee deposits. The credit quality of deposits has been assessed with reference to historical information about the counterparties such as default rates and financial position of the counterparties. Given there is no history of defaults from these counterparties, the directors of the Company are of the opinion that the risk of default is not significant and does not expect any losses from non-performance by the counterparties. Therefore, expected credit loss for the deposits is assessed to be minimal.

本集團的大部分銀行結餘均存放 在獲獨立評定為具有高信貸評級 的財務機構內。由於該等財務機 構過往並無違約記錄,故管理層 預料不會發生因該等機構未能履 約而造成的任何虧損。

#### 其他應收款項

其他應收款項亦須遵守香港財 務報告準則第9號的減值規定。 減值按12個月預期信貸虧損計量,視乎自 初步確認以來信貸風險是否顯著 增加。如應收款項的信貸風險自 初步確認後顯著增加,則按全期 預期信貸虧損計量減值。於二零 二五年及二零二四年三月三十一 日,其他應收款項的已確定減值 虧損經評估為甚低。

#### *按金*

按金主要為租金按金及公用設施 及管理費按金。按金的信貸質素 已參考交易對手的過往資料(如 違約率及交易對手的財務狀況) 進行評估。鑑於該等交易對手過 往並無違約記錄,本公司董事認 為違約風險不大,且預期交易對 手不會因不履約而造成任何損 失。因此,按金的預期信貸虧損 被評估為最低。

#### Trade and retention receivables and contract assets

For trade and retention receivables and contract assets, the Group applies the HKFRS 9 simplified approach to measuring expected credit losses which uses a lifetime expected credit loss allowance for all trade and retention receivables and contract assets without financing components.

Receivable relating to customers with known financial difficulties or significant doubt on collection of receivables are assessed individually for provision for impairment allowance. The following table presents the balances of gross carrying amounts and the loss allowance in respect of the individually assessed trade receivables by due date as at 31 March 2025 and 2024.

For category 1, the Group considers that these customers have a good credit profile and no default history. Also, these customers are financially capable of settling the outstanding amount. The expected credit loss for these customers are assessed individually.

For category 2, the expected credit loss rates for the trade and retention receivables is determined according to a provision matrix where balances that are less than 18 months overdue are provided for at expected credit loss rates per below and trade and retention receivables more than 18 months overdue are 100% provided for.

On that basis, the loss allowance as at 31 March 2025 and 2024 was determined as follows for trade and retention receivables.

# Category 1: Customers have a relatively low credit risk and no default history

Trade and retention receivables, contract assets and other receivables are written off when there is no reasonable expectation of recovery. Indicators that there is no reasonable expectation of recovery include the failure of a debtor to engage in a repayment plan with the Group. Impairment losses on trade and retention receivables and contract assets are presented as net impairment losses within operating profit. Subsequent recoveries of amounts previously written off are credited against the same line item.

#### (d) Liquidity risk

Prudent liquidity risk management implies maintaining sufficient cash and the availability of funding from external parties.

The Group's primary cash requirements have been for payments for capital expenditures, loan repayment, trade payables, other creditors, accrued liabilities and operating expenses. Accordingly, the directors are of the opinion that the Group does not have significant liquidity risk.

The table below analyses the Group's financial liabilities into relevant maturity groupings based on the remaining period at the date of the consolidated statement of financial position to the contractual maturity date. The amounts disclosed in the table are the contractual undiscounted cash flows. Fair values of balances due on demand or less than 1 year approximate their carrying balances as the impact of discounting is not significant.

The Group's objectives when managing capital are to safeguard the Group's ability to continue as a going concern in order to provide returns for shareholders and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital.

In order to maintain or adjust the capital structure, the Group may adjust the amount of dividends paid to shareholders, return capital to shareholders, issue new shares or sell assets to reduce debt.

#### 3.3 Fair value estimation

This section explains the judgements and estimates made in determining the fair values of the financial instruments that are recognised and measured at fair value in the consolidated financial statements. To provide an indication about the reliability of the inputs used in determining fair value, the Group has classified its financial instruments into the three levels prescribed under the accounting standards:

Level 1: The fair value of financial instruments traded in active markets (such as publicly traded derivatives and equity securities) is based on quoted market prices at the end of the reporting period.

Level 2: The fair value of financial instruments that are not traded in an active market (for example, over-the-counter derivatives) is determined using valuation techniques which maximise the use of observable market data and rely as little as possible on entity-specific estimates. If all significant inputs required to fair value an instrument are observable, the instrument is included in level 2.

Level 3: Inputs for the asset or liability that are not based on observable market data (unobservable inputs).

#### 3.3 公平值估計

All of the Group's financial assets at fair value through profit or loss ("FVPL") were classified into Level 3 as they do not have a quoted price in active markets. The Group's policy is to recognise transfers into and out of fair value hierarchy levels as at the end of the reporting period. There were no transfers between level 1, 2 and 3 during the years ended 31 March 2025 and 2024.

In terms of valuation techniques, the Group uses a variety of methods depending on the availability of information and makes assumptions that are based on market conditions existing at the end of each reporting period. Independent external valuer has been involved in determining the fair values, when appropriate. The unlisted preference shares were valued with reference to recent subscription price of the investee's equity interests, which is a significant unobservable input. Other unobservable inputs include movement of market comparable, probability of conversion scenario, risk-free interest rates and expected volatility. Other unlisted investment was valued using discounted cashflow method, in which the discount rate is considered the significant unobservable input. Higher discount rate will result in lower fair value.

Other than the financial assets at FVPL, the carrying amounts of the Group's financial instruments carried at amortised cost approximate their fair values as at the reporting date since either the instrument are with short maturities or the interest rate is close to the current market rate.

除以公平值計入損益之金融資產外, 本集團以攤銷成本計值的金融工具因 到期日很短或利率與當前市場利率接 近,故其賬面值與其於報告日期的公 平值相近。

#### 4 CRITICAL ACCOUNTING ESTIMATES AND JUDGEMENTS

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below.

#### (a) Construction contracts

The Group reviews and revises the estimates of contract revenue, contract costs, variation orders and contract claims prepared for each construction contract as the contract progresses. Budgeted construction costs are prepared by the management on the basis of quotations from time to time provided by the major subcontractors, suppliers or vendors involved and the experience of the management. In order to keep the budget accurate and up-to-date, management conducts periodic reviews of the budgets of contracts by comparing the budgeted amounts to the actual amounts incurred. Such significant estimates may have an impact on the profit recognised in each year.

# (b) Impairment of trade and retention receivables and contract assets

The Group follows the guidance of HKFRS 9 to determine when trade and retention receivables and contract assets are impaired. Significant judgement is exercised on the customer segmentation of portfolios sharing similar credit risk characteristics, assessment of the risk of default and expected credit losses from each customer. In making the judgement, management considers a wide range of factors such as results of follow-up procedures, customer payment trends including subsequent payments, customers' financial positions and expected future change of credit risks, including consideration of factors such as general economy measure, changes in macro-economic indicators, etc. Details of assumptions and inputs used are discussed in Note 3.

隨著合約工程進度,本集團審查及修 訂每一份建築合約的合約收益、合約 成本、工程變更指令及合約索償撥備 的估計。預算的建築成本由管理層參 考所涉主要分包商、供應商或賣方不 時提供的報價加上管理層的經驗為基 礎而編製。為確保預算準確及更新, 管理層對合約預算進行定期審查,比 較預算金額及實際金額的差別。有關 重大估計可能對於各年度內確認的溢 利產生影響。

# (b) 應收貿易賬款及應收保留金以及合約 資產減值

本集團遵循香港財務報告準則第9號的 指引以釐定應收貿易賬款及應收保留 金以及合約資產何時出現減值。於將 具有類似信貸風險特徵的客戶組合分 類、評估各客戶的違約風險及預期信 貸虧損時,須作出重大判斷。於作出 判斷時,管理層考慮多項因素,例如 跟進程序的結果、客戶付款趨勢(包括 期後付款)及客戶財務狀況以及預計信 貸風險的未來變動(包括考慮一般經濟 措施及宏觀經濟指標變化等因素)。 所用假設和輸入數據的詳情見附註3。

The corresponding revenue did not contribute over 10% of the Group's total revenue.

Revenue is measured at the fair value of the consideration received or receivable and represents amounts receivable for services rendered in the normal course of business.

#### (a) Construction contracts

Revenue from the construction services is recognised over time as the Group's performance creates or enhances an asset or work in progress that the customer controls as the asset is created or enhanced.

The Group has applied the input method in recognising the revenue from construction contracts by reference to the Group's efforts or inputs to the satisfaction on a performance obligation relative to the total expected inputs to the satisfaction of the performance obligation. Accordingly, the Group uses the "percentage-of-completion method" to determine the appropriate amount of revenue to recognise in a given period. The stage of completion is measured by reference to costs incurred to date as a percentage of total contract costs.

The Group considers the input method better depicts the Group's performance in transferring control of goods or services to their customers.

#### (a) Construction contracts (Continued)

When the outcome of a construction contract cannot be estimated reliably, contract revenue is recognised only to the extent of contract costs incurred that are likely to be recoverable.

Variations in contract work, claims and incentive payments are included in contract revenue to the extent that may have been agreed with the customer and are capable of being reliably measured.

Estimates of revenues, costs or extent of progress toward completion are revised if circumstances change. Any resulting increases or decreases in estimated revenues or costs are reflected in profit or loss in the period in which the circumstances that give rise to the revision become known by management.

The customer pays the fixed amount based on a payment schedule. If the services rendered by the Group exceed the payment, a contract asset is recognised. If the payments exceed the services rendered, a contract liability is recognised.

All construction contracts by the Group are warranted to be free of defects for a period of one year. Expected cost for warranty repairs are accrued when necessary.

No element of financing is deemed present as payments are in accordance with the typical payment terms of the relevant industry.

Companies within the Group in Hong Kong have participated in the Mandatory Provident Fund Scheme under the Mandatory Provident Fund Scheme Ordinance (the "MPF Scheme"), a defined contribution scheme managed by an independent trustee.

Under the MPF Scheme, each of the Group companies and its employees make monthly contributions to the scheme at a minimum of 5% of the employee's relevant income as defined under the MPF Scheme, with the maximum mandatory contribution by each of the Group companies and its employees limited to HK\$1,500 per month, and further contributions are voluntary.

The mandatory contributions are fully and immediately vested in the employees as accrued benefits. The employees are entitled to receive their entire voluntary contributions and 100% of the Group's employer voluntary contributions upon retirement or leaving the Group after completing one year of service.

Any forfeited voluntary contributions made by the Group are used to reduce the Group's employer voluntary contributions. ## 33 SUMMARY OF MATERIAL ACCOUNTING POLICIES

# 33.1 Subsidiaries

#### Consolidation

Subsidiaries are all entities (including a structured entities) over which the Group has control. The Group controls an entity when the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the activities of the entity. Subsidiaries are fully consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date that control ceases.

Intra-group transactions, balances and unrealised gains on transactions between group companies are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the transferred asset. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

Non-controlling interests in the results and equity of subsidiaries are shown separately in the consolidated statement of comprehensive income and consolidated statement of changes in equity and, consolidated statement of financial position, respectively.

# 33 重大會計政策概要33.1 附屬公司

#### 綜合賬目

附屬公司為本集團對其具有控制權的 實體(包括結構性實體)。當本集團承 受或享有參與實體所得之可變回報, 且有能力透過其權力指導實體的活動 而影響該等回報時,則本集團控制該 實體。附屬公司的賬目自控制權轉讓 予本集團之日起綜合入賬,並自該控 制權終止之日起停止綜合入賬。

本集團內公司之間的交易、結餘及未 變現收益會予以對銷。除非交易提供 轉讓資產減值的證據,否則未變現虧 損亦予以對銷。附屬公司的財務報表 已按需要作出調整,以確保其會計政 策與本集團採用的會計政策一致。

附屬公司業績及權益中的非控股權益 分別於綜合全面收益表、綜合權益變 動表及綜合財務狀況表中單獨呈列。

#### 33.2 Investment in an associate

Associates are all entities over which the Group has significant influence but not control or joint control. This is generally the case where the Group holds between 20% and 50% of the voting rights. Investment in an associate is accounted for using the equity method of accounting, after initially being recognised at cost.

Under the equity method of accounting, the investment is initially recognised at cost and adjusted thereafter to recognise the Group's share of the post-acquisition profits or losses of the investee in profit or loss, and the Group's share of movements in other comprehensive income of the investee in other comprehensive income. Dividends received or receivable from the associate are recognised as a reduction in the carrying amount of the investment.

Where the Group's share of cumulative losses in an equity-accounted investment equals or exceeds its interest in the entity, including any other unsecured long-term receivables, the Group does not recognise further losses, unless it has incurred obligations or made payments on behalf of the other entity.

Unrealised gains on transactions between the Group and its associate are eliminated to the extent of the Group's interest in the associate. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of equity-accounted investee have been changed where necessary to ensure consistency with the policies adopted by the Group.

The carrying amount of equity-accounted investment is tested for impairment in accordance with the policy described in Note 33.8.

#### 33 重大會計政策概要(續)

#### 33.2 於聯營公司之投資

聯營公司指本集團對其有重大影響但 無控制權或共同控制權的實體,一般 情況下本集團擁有其20%至50%投票 權。於聯營公司之投資初步按成本確 認後,以權益會計法入賬。

根據權益會計法,投資初步按成本確 認後再作調整,以於損益中確認本集 團應佔投資對象的收購後溢利或虧 損,以及於其他全面收益中確認本集 團應佔投資對象的其他全面收益變 動。已收或應收聯營公司的股息乃確 認為投資賬面值扣減。

倘本集團於以權益入賬之投資中應佔 的累計虧損相等於或超過其於該實體 的權益(包括任何其他無抵押長期應 收款項),則本集團不會確認進一步虧 損,除非其已代另一實體承擔責任或 作出付款。

本集團與其聯營公司之間的交易所產 生的未變現收益按本集團於該等聯營 公司的權益金額抵銷。除非有關交易 能證明所轉移資產出現減值,否則未 變現虧損亦予以抵銷。以權益入賬之 投資對象的會計政策已作出必要變 更,以確保與本集團所採納之政策一 致。

權益入賬投資的賬面值乃根據附註 33.8所述政策進行減值測試。

#### 33.3 Separate financial statements

Investments in subsidiaries are accounted for at cost less impairment. Cost includes direct attributable costs of investment. The results of subsidiaries are accounted for by the Company on the basis of dividend received and receivable.

Impairment testing of the investments in subsidiaries is required upon receiving a dividend from these investments if the dividend exceeds the total comprehensive income of the subsidiary in the period the dividend is declared or if the carrying amount of the investment in the separate financial statements exceeds the carrying amount in the consolidated financial statements of the investee's net assets including goodwill.

#### 33.4 Foreign currency translation

#### (a) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in HK\$, which is the Company's functional currency and presentation currency.

#### (b) Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions or valuation where items are re-measured. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation of monetary assets and liabilities denominated in foreign currencies at year-end exchange rates are generally recognised in profit or loss.

Non-monetary items that are measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was determined. Translation differences on assets and liabilities carried at fair value are reported as part of the fair value gain or loss. For example, translation differences on non-monetary assets and liabilities such as equities held at fair value through profit or loss are recognised in profit or loss as part of the fair value gain or loss and translation differences on non-monetary assets such as equities classified as fair value through other comprehensive income are recognised in other comprehensive income.

#### 33.3 獨立財務報表

於附屬公司的投資按成本扣除減值列 賬。成本包括直接應佔投資成本。附 屬公司的業績乃由本公司按已收及應 收股息基準入賬。

倘股息超出於宣派股息期間內附屬公 司的全面收益總額,或倘獨立財務報 表中投資賬面值超出投資對象於綜合 財務報表所示資產淨值(包括商譽)的 賬面值,則須於自該等投資收取股息 時,對該等投資進行減值測試。

#### 33.4 外幣換算

(a) 功能及呈列貨幣 本集團每個實體的財務報表中所

列的項目均以該實體營運所在的 主要經濟環境的貨幣計量(「功能 貨幣」)。綜合財務報表以港元呈 列,港元為本公司的功能貨幣及 呈列貨幣。

(b) 交易及結餘

外幣交易均按交易或估值(倘項 目予以重新計量)日期的現行匯 率換算為功能貨幣。因結算該等 交易及按結算日的匯率兑換以外 幣計值的貨幣資產及負債而產生 的匯兑損益一般於損益確認。

以外幣計量公平值的非貨幣項目 使用確定公平值當日的匯率換 算。以公平值列賬的資產和負債 的換算差額列為公平值收益或虧 損的一部分。例如,以公平值計 量且其變動計入損益的股票等非 貨幣資產和負債的換算差額在損 益中確認為公平值收益或虧損的 一部分,而分類為以公平值計量 日其變動計入其他全面收益的股 票等非貨幣資產的換算差額在其 他全面收益中確認。

#### 33.4 外幣換算(續)

(c) Group companies

The results and financial position of foreign operations (none of which has the currency of a hyperinflationary economy) that have a functional currency different from the presentation currency are translated into the presentation currency as follows:

- (i) assets and liabilities for each statement of financial position presented are translated at the closing rate at the date of that statement of financial position;
- (ii) income and expenses for each statement of comprehensive income are translated at average exchange rates (unless this is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the rate on the dates of the transactions); and
- (iii) all resulting exchange differences are recognised in other comprehensive income.

On consolidation, exchange differences arising from the translation of any net investment in foreign entities are recognised in other comprehensive income. When a foreign operation is sold or any borrowings forming part of the net investment are repaid, the associated exchange differences are reclassified to profit or loss, as part of the gain or loss on sale.

#### 33.5 Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker. The chief operating decision-maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the Executive Directors of the Group who make strategic decisions.

#### 33.5 分部報告

經營分部的呈報方式與提供予主要經 營決策者的內部報告的方式一致。主 要經營決策者(負責分配資源及評估 經營分部的表現)已被識別為本集團 作出策略決定的執行董事。

#### 33.6 Investment in an insurance contract

The Group invests in a key management life insurance contract. The insurance contract is initially recognised at the amount of premium paid, and subsequently measured at its cash surrender value. Changes to the cash surrender value are recognised in profit or loss and presented net within "other income and other gains or losses, net". In the event of death of the insured person, the surrender of the policy, or the policy matures, the investment will be derecognised and any resulting gains or losses will be recognised in profit or loss.

#### 33.7 Property, plant and equipment

The property, plant and equipment is stated at historical cost less accumulated depreciation and impairment. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other repairs and maintenance costs are charged in the consolidated statement of comprehensive income during the financial period in which they are incurred.

Depreciation on property, plant and equipment is calculated using the straight-line method to allocate their cost over their estimated useful lives, as follows:

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

#### 33.6 於保險合約之投資

本集團投資於一份主要管理層人壽保 險合約。該保險合約初步按已付保費 金額確認,其後按合約的現金退保價 值計量。現金退保價值的變化於損益 中確認,並於「其他收入及其他收益或 虧損淨額 中以淨額呈列。倘受保人離 世、保單退保或保單到期,投資將被 取消確認,而任何由此產生的收益或 虧損將於損益中確認。

#### 33.7 物業、廠房及設備

物業、廠房及設備按歷史成本扣除累 計折舊及減值入賬。歷史成本包括於 購置有關項目時直接應佔的開支。

後續成本只有在與該項目有關聯的未 來經濟利益很可能會流入本集團,而 項目的成本能可靠計量時,才計入資 產的賬面值或確認為一項單獨資產(視 適用情況而定)。所有其他維修保養費 用在其產生的財政期間內於綜合全面 收益表扣除。

物業、廠房及設備的折舊乃採用直線 法按其估計可使用年期分攤其成本值 而計算,情況如下:

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount (Note 33.8).

Gains and losses on disposals are determined by comparing proceeds with carrying amount and are recognised in profit or loss.

#### 33.8 Impairment of non-financial assets

Non-financial assets that have an indefinite useful life are not subject to amortisation and are tested annually for impairment, or more frequently if events or changes in circumstances indicate that they might be impaired. Other assets are tested for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs of disposal and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash inflows which are largely independent of the cash inflows from other assets or groups of assets (cash-generating units). Non-financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at the end of each reporting period.

#### **33.9 Inventories**

Inventories are stated at the lower of cost and net realisable value. Cost is determined using the first-in, first-out (FIFO) method. The cost comprises costs of purchase and other costs incurred in bringing the inventories to the construction sites to be consumed in the provision of construction services. Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

#### 33.7 物業、廠房及設備(續)

倘資產賬面值高於其估計可收回金額 (附註33.8),則會立即將該資產的賬 面值撇減至其可收回余額。

#### 33.8 非金融資產減值

具有無限可使用年期的非金融資產 毋須攤銷,惟每年須進行一次減值測 試,或於有事件或情況變化顯示其可 能減值時須更頻繁進行測試。其他資 產會於有事件或情況變化顯示資產賬 面值可能無法收回時進行減值測試。 減值虧損按資產賬面金額超過其可收 回金額部分確認。可收回金額為扣除 出售成本後的資產公平值與資產使用 價值中的較高者。就減值評估而言, 資產按基本上獨立於其他資產或資產 組別之現金流入的可單獨辨認的最小 現金流入產生單位(現金產生單位)予 以分類。經減值的非金融資產(不包括 商譽)於各報告期末檢討撥回減值的 可能性。

#### 33.9 存貨

存貨按成本與可變現淨值兩者的較低 者列賬。成本乃按先入先出法釐定。 成本包括購買成本以及將存貨帶往建 築地盤以用作提供建築服務所產生的 其他成本。可變現淨值為日常業務過 程中的估計售價減去完成的估計成本 以及銷售所需的估計成本。

#### 33.10 Financial assets

#### (a) Classification

The Group classifies its financial assets in the following measurement categories:

- those to be measured subsequently at fair value (either through other comprehensive income or through profit or loss), and
- those to be measured at amortised cost.

The classification depends on the Group's business model for managing the financial assets and the contractual terms of the cash flows.

For assets measured at fair value, gains and losses will either be recorded in profit or loss or other comprehensive income. For investments in equity instruments that are not held for trading, this will depend on whether the Group has made an irrevocable election at the time of initial recognition to account for the equity investment at fair value through other comprehensive income (FVOCI).

The Group reclassifies debt investments when and only when its business model for managing those assets changes.

#### (b) Recognition and derecognition

Regular way purchases and sales of financial assets are recognised on trade-date, the date on which the Group commits to purchase or sell the asset. Financial assets are derecognised when the rights to receive cash flows from the financial assets have expired or have been transferred and the Group has transferred substantially all the risks and rewards of ownership.

#### (c) Measurement

At initial recognition, the Group measures a financial asset at its fair value plus, in the case of a financial asset not at FVPL, transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at FVPL are expensed in profit or loss.

#### Debt instruments

Subsequent measurement of debt instruments depends on the Group's business model for managing the asset and the cash flow characteristics of the asset. There are three measurement categories into which the Group classifies its debt instruments:

- (a) Amortised cost: Assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are measured at amortised cost. Interest income from these financial assets is included in finance income using the effective interest rate method. Any gain or loss arising on derecognition is recognised directly in profit or loss and presented in other gains/(losses) together with foreign exchange gains and losses. Impairment losses are presented as separate line item in the consolidated statement of comprehensive income.
- (b) FVPL: Assets that do not meet the criteria for amortised cost or FVOCI are measured at FVPL. A gain or loss on a debt investment that is subsequently measured at FVPL is recognised in profit or loss and presented net within other gains/ (losses) in the period in which it arises.

#### (c) 計量

#### Equity instruments

The Group subsequently measures all equity investments at fair value. Where the Group's management has elected to present fair value gains and losses on equity investments in other comprehensive income, there is no subsequent reclassification of fair value gains and losses to profit or loss following the derecognition of the investment. Dividends from such investments continue to be recognised in profit or loss as other income when the Group's right to receive payments is established.

Changes in the fair value of financial assets at FVPL are recognised in other gains/(losses) in the consolidated statement of comprehensive income as applicable.

Repurchase of the Company's own equity instruments is recognised and deducted directly in equity. No gain or loss is recognised in profit or loss on the purchase, sale, issue or cancellation of the Company's own equity instruments.

#### (d) Impairment

The Group assesses on a forward-looking basis the expected credit losses associated with its debt instruments at amortised cost. The impairment methodology applied depends on whether there has been a significant increase in credit risk.

(d) 減值

本集團按前瞻性基準評估其按攤 銷成本計量的債務工具的相關預 期信貸虧損。所應用的減值方法 取決於信貸風險是否顯著增加。

#### 33.11 Trade, retention and other receivables

Trade, retention and other receivables are amounts due from customers for services performed in the ordinary course of business. Trade receivables are recognised initially at the amount of consideration that is unconditional. The Group holds the trade receivables with the objective of collecting the contractual cash flows and therefore measures them subsequently at amortised cost using the effective interest method.

The carrying amount of the asset is reduced through the use of an allowance account, and the amount of the loss is recognised in the impairment loss on trade and retention receivables in the consolidated statement of comprehensive income. When a trade, retention and other receivable is uncollectible, it is written off against the allowance account for trade, retention and other receivables. Subsequent recoveries of amounts previously written off are credited against the impairment loss on trade and retention receivables in the consolidated statement of comprehensive income.

If collection of trade, retention and other receivables is expected in one year or less (or in the normal operating cycle of the business if longer), they are classified as current assets. If no, they are presented as non-current assets.

#### 33.12 Cash and cash equivalents

Cash and cash equivalents include cash in hand and deposits held at call with banks with original maturities of three months or less.

For the purpose of presentation in the consolidated statement of cash flows, cash and cash equivalents includes cash on hand, deposits held at call with banks with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

#### 33.11 應收貿易賬款、應收保留金及其他應 收款項

應收貿易賬款、應收保留金及其他應 收款項為於日常業務過程中執行服務 而應收客戶之款項。應收貿易賬款初 步按代價的無條件金額確認。本集團 以收取合約現金流量為目的持有應收 貿易賬款,故其後採用實際利率法按 攤銷成本計量該等應收貿易賬款。

資產的賬面值乃透過使用撥備賬戶進 行抵減,而虧損金額於綜合全面收益 表內的應收貿易賬款及應收保留金之 減值虧損中確認。倘應收貿易賬款、 應收保留金及其他應收款項不可收 回,則以應收貿易賬款、應收保留金 及其他應收款項的撥備賬戶撇銷。其 後收回的先前已撇銷金額,則計入綜 合全面收益表的應收貿易賬款及應收 保留金之減值虧損內。

倘應收貿易賬款、應收保留金及其他 應收款項預期於一年或以內(或倘業 務正常經營週期較長,則於正常經營 週期內)收回,則分類為流動資產;否 則分類為非流動資產。

#### 33.12 現金及現金等價物

現金及現金等價物包括手頭現金及原 到期日為三個月或更短時間以內的銀 行通知存款。

就呈列綜合現金流量表而言,現金及 現金等價物包括庫存現金、原到期日 為三個月或更短並可隨時轉換為已知 數額的現金的銀行活期存款,其價值 變動的風險極微。

#### 33.13 Share capital

Ordinary shares are classified as equity.

Incremental costs directly attributable to the issue of new share or options are shown in equity as a deduction, net of tax, from the proceeds.

#### 33.14 Trade and other payables

These amounts represent liabilities for goods and services provided to the Group prior to the end of financial year which are unpaid. Trade and other payables are presented as current liabilities unless payment is not due within 12 months after the reporting period. They are recognised initially at their fair value and subsequently measured at amortised cost using the effective interest method.

#### 33.15 Borrowings

Borrowings are recognised initially at fair value, net of transaction costs incurred. Borrowings are subsequently measured at amortised cost; any difference between the proceeds (net of transaction costs) and the redemption value is recognised in the consolidated statement of comprehensive income over the period of the borrowings using the effective interest method.

Fees paid on the establishment of loan facilities are recognised as transaction costs of the loan to the extent that it is probable that some or all of the facility will be drawn down. In this case, the fee is deferred until the draw-down occurs. To the extent there is no evidence that it is probable that some or all of the facility will be drawn down, the fee is capitalised as a pre-payment for liquidity services and amortised over the period of the facility to which it relates.

Borrowings are derecognised from the consolidated statement of financial position when the obligation specified in the contract is extinguished, cancelled or expired. The difference between the carrying amount of a financial liability that has been extinguished or transferred to another party and the consideration paid, including any non-cash assets transferred or liabilities assumed, is recognised in profit or loss as finance costs.

#### 33.13 股本

普通股分類為權益。

發行新股份或購股權應佔的遞增成本 乃於權益中呈列為所得款項的扣減(扣 除税項)。

#### 33.14 應付貿易賬款及其他應付款項

此等款項為於財務年末前提供貨物及 服務而尚未收款所產生的負債。除非 於報告期後12個月內付款,否則應付 貿易賬款及其他應付款項乃呈列為流 動負債,其初步按公平值確認,其後 以實際利率法按攤銷成本計量。

#### 33.15 借貸

借貸初步以公平值(扣除所產生交易成 本)確認。借貸其後以攤銷成本計量; 所得款項(扣除交易成本)與贖回價值 之間的差額,乃以實際利息法於借貸 期間在綜合全面收益表確認。

在有關融資將很有可能部分或全部 提取的情況,就設立貸款融資支付的 費用乃確認為貸款交易成本。在此情 況,該費用將遞延至提取貸款發生 時。在並無憑證顯示有關融資將很有 可能部分或全部提取的情況,該費用 將被資本化以作為流動資金服務的預 付款項,並於其相關融資期間內予以 攤銷。

倘合約所規定的責任獲解除、取消或 屆滿,則借貸自綜合財務狀況表終止 確認。償清或轉讓予另一方的金融負 債的賬面值與已付代價(包括任何已 轉讓的非現金資產或已承擔的負債)之 間的差額於損益內確認為財務成本。

#### 33.15 Borrowings (Continued)

Borrowings are classified as current liabilities unless, at the end of the reporting period, the Group has an unconditional right to defer settlement of the liability for at least 12 months after the end of the reporting period. Covenants that the Group is required to comply with, on or before the end of the reporting period, are considered in classifying loan arrangements with covenants as current or non-current. Covenants that the Group is required to comply with after the end of the reporting period do not affect the classification at the reporting date.

#### 33.16 Current and deferred income tax

The income tax expense for the period is the tax payable on the current period's taxable income based on the applicable income tax rate for each jurisdiction adjusted by changes in deferred tax assets and liabilities attributable to temporary differences and to unused tax losses. Current and deferred tax is recognised in profit or loss, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, respectively.

#### (a) Current income tax

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the end of the reporting period in the countries where the Company and its subsidiaries and associate operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation and considers whether it is probable that a taxation authority will accept an uncertain tax treatment. The Group measures its tax balances either based on the most likely amount or the expected value, depending on which method provides a better prediction of the resolution of the uncertainty.

#### 33.15 借貨(續)

除非本集團有權於報告期末無條件將 負債延長至報告期末後最少12個月後 清償,否則借貸歸類為流動負債。本 集團須於報告期結束時或之前遵守的 契諾,會在將附有契諾的貸款安排分 類為流動或非流動時予以考慮。本集 團須於報告期結束後遵守的契諾不影 響於報告日期的分類。

#### 33.16 即期及遞延所得税

期內所得税開支為根據各司法權區適 用所得税税率計算的期內應課税收入 的應付税項,並根據暫時性差異及未 動用税項虧損所導致的遞延税項資 及負債變動進行調整。即期及遞延税 項乃於損益中確認,惟倘該等税項與 於其他全面收益或直接於權益內確認 的項目有關則除外。在此情況下,該 等税項亦分別於其他全面收益內或直 接於權益內確認。

#### (a) 即期所得税

#### (b) Deferred income tax

Deferred income tax is provided in full, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial statements. However, deferred tax liabilities are not recognised if they arise from the initial recognition of goodwill. Deferred income tax is also not accounted for if it arises from initial recognition of an asset or liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit or loss and does not give rise to equal taxable and deductible temporary differences. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantively enacted by the end of the reporting period and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

Deferred tax assets are recognised only if it is probable that future taxable amounts will be available to utilise those temporary differences and losses.

Deferred tax liabilities and assets are not recognised for temporary differences between the carrying amount and tax bases of investments in foreign operations where the company is able to control the timing of the reversal of the temporary differences and it is probable that the differences will not reverse in the foreseeable future.

Deferred tax assets and liabilities are offset where there is a legally enforceable right to offset current tax assets and liabilities and where the deferred tax balances relate to the same taxation authority. Current tax assets and tax liabilities are offset where the entity has a legally enforceable right to offset and intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously.

#### 33.16 即期及遞延所得税(續)

#### (b) 遞延所得税

遞延所得税採用負債法就資產及 負債的税基與其在綜合財務報表 中的賬面值之間的暫時差額予以 全數計提。然而,倘遞延税項負 倩來自對商譽的初步確認,其將 不予確認。遞延所得税來自於交 易(不包括業務合併)中對資產 或負債的初步確認,而在交易時 不影響會計損益或應課税損益, 且不會導致應課税與可扣減暫時 差異相同,其亦將不予入賬。遞 延所得税採用在報告期末前已頒 佈或實質上已頒佈,並在有關遞 延所得税資產變現或遞延所得税 負債結算時預期將會適用的税率 (及法例)而釐定。

與按公平值計量的投資物業有關 的遞延税項負債乃假設該物業將 可透過銷售而全數收回而釐定。

遞延税項資產僅於未來應課税金 額將有可能與可動用該等暫時差 異及虧損時方予確認。就於外國 業務投資的賬面值與其税基之間 的暫時差異而言,倘本公司能夠 控制該暫時差異的撥回時間,且 該差異很可能於可見未來不會撥 回,則不會確認遞延税項負債及 資產。

當有法定可執行權力將即期税項 資產與負債抵銷,且遞延税項結 餘涉及同一税務機關,則遞延税 項資產與負債將互相抵銷。當實 體有法定可執行權力進行抵銷, 並有意以淨額基準結算或同步變 現資產與結算負債,則即期税項 資產與税項負債將互相抵銷。

Current and deferred tax is recognised in profit or loss, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, respectively.

#### 33.17 Provisions

Provisions are recognised when the Group has a present legal or constructive obligation as a result of past events; it is probable that an outflow of resources will be required to settle the obligation; and the amount has been reliably estimated. Provisions are not recognised for future operating losses.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole.

A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Provisions are measured at the present value of management's best estimate of the expenditure required to settle the present obligation at the end of the reporting period. The discount rate used to determine the present value is a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the obligation. The increase in the provision due to passage of time is recognised as interest expense.

#### 33.16 即期及遞延所得税(續)

(b) 遞延所得税(續) 即期及遞延税項於損益中確認, 除非其與於其他全面收益或直接 於權益中確認的項目有關。在此 情況下,税項亦分別於其他全面 收益或直接於權益中確認。

#### 33.17 撥備

當本集團因過往發生的事件而須承擔 現有的法律或推定責任;可能需要使 用資源以履行該責任;且有關金額能 可靠估計時,則會確認撥備。其概不 就未來營運虧損確認撥備。

倘出現多項類似責任,則需诱過資源 外流以履行責任的可能性乃於考慮整 體責任類別後釐定。

即使就同一類別的責任中的任何一個 項目而流出資源的可能性不大,仍會 確認撥備。

撥備按管理層對於報告期末清俏償現 有責任所需支出的最佳估計的現值計 量。用以釐定現值的貼現率乃反映當 前對金錢時間價值及該責任特有風險 的市場評估的税前比率。因時間流逝 而增加的撥備確認為利息開支。

#### 33.18 Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable and represents amounts receivable for services rendered in the normal course of business.

#### (a) Sales of goods

Revenue from the sale of goods is recognised when the control of the products has transferred, being when the products are delivered to the customer, the customer has full discretion over the channel and price to sell the products, and there is no unfulfilled obligation that could affect the customer's acceptance of the products.

A receivable is recognised when the goods are delivered as this is the point in time that the consideration is unconditional because only the passage of time is required before the payment is due. Contract liabilities are recognised when payments are received from customers in advance but the relevant performance obligation has not been performed.

#### 33.19 Interest income

Interest income is presented as finance income where it is earned from financial assets that are held for cash management purposes. Any other interest income is included in other income.

Interest income is calculated by applying the effective interest rate to the gross carrying amount of a financial asset except for financial assets that subsequently become credit-impaired. For credit impaired financial assets, the effective interest rate is applied to the net carrying amount of the financial asset (after deduction of the loss allowance).

#### 33.20 Employee benefits

(a) Employee leave entitlements

Employee entitlements to annual leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave as a result of services rendered by employees up to the reporting date.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

#### 33.18 收益確認

- 收益按已收或應收代價的公平值計 量,是指在正常業務過程中提供服務 的應收金額。
- (a) 貨物銷售

銷售貨物的收益於產品的控制權 轉移(即產品交付予客戶)、客戶 可全權酌情決定銷售產品的渠道 及價格,且概無未履行的責任可 影響客戶接受該產品時確認。

應收款項於貨物交付時確認,乃 由於因該時間點為代價僅因付款 到期前所需的時間過去而成為無 條件。當預收客戶付款但尚未履 行相關履行責任時,則確認合約 負債。

#### 33.19 利息收入

當利息收入來自為現金管理目的而持 有的金融資產,則列作財務收入。任 何其他利息收入均包括在其他收入中。

利息收入乃對金融資產總賬面值採用 實際利率予以計算,惟其後出現信貸 減值的金融資產除外。就信貸減值金 融資產而言,實際利率應用於金融資 產賬面淨值(扣除虧損撥備後)。

#### 33.20 僱員福利

(a) 僱員應享假期

僱員的年假權益在僱員應享時確 認,並會就僱員截至報告日期止 所提供服務而產生的年假的估計 負債作出撥備。

僱員的病假及產假權益於休假時 方確認。

#### (b) Pension obligations

The Group participates in a defined contribution plan in Hong Kong and pays contributions to privately administered pension insurance plans on a mandatory, contractual or voluntary basis. The Group has no further payment obligations once the contributions have been paid. The contributions are recognised as employee benefit expense when they are due.

(c) Bonus plan

The Group recognises a liability and an expense for bonuses based on a formula that takes into consideration the profit attributable to the Company's owners. The Group recognises a provision where contractually obliged or where there is a past practice that has created a constructive obligation.

#### 33.21 Leases

An arrangement, comprising a transaction or a series of transactions, is or contains a lease if the Group determines that the arrangement conveys a right to control the use of an identified asset for a period of time in exchange for consideration. Such determination is made on an evaluation of the substance of the arrangement, regardless of whether the arrangements take the legal form of a lease.

The Group enters into lease agreements as a lessee with respect to certain premises, motor vehicles and equipment.

Leases are initially recognised as right-of-use assets and corresponding liabilities at the date of which the leased asset is available for use by the Group. Each lease payment is allocated between the liability and finance cost. The finance cost is charged to profit or loss over the lease period so as to produce a constant periodic rate of interest on the remaining balance of the liability for each period. The right-of-use asset is depreciated on a straight-line basis over the shorter of the asset's estimated useful life and the lease term.

#### (b) 退休金責任

本集團於香港參與定額供款計 劃,並以強制性、合約性或自願 性方式向私人管理的退休保險計 劃作出供款。一旦已作出供款, 本集團並無進一步付款的責任。 供款在應付時確認為僱員福利開 支。

#### (c) 花紅計劃

本集團根據計及本公司擁有人應 佔溢利的公式確認花紅的負債及 開支。本集團按合約規定或過往 慣例所產生的推定性責任確認撥 備。

#### 33.21 租賃

倘本集團釐定一項安排(包括一項交易或一系列交易)為轉讓一項已識別 資產在一段期間內的使用控制權,以 換取代價,則該項安排即為或包含租 賃成分。有關決定乃根據評估該項安 排的實質內容,不論該項安排是否採 用租賃的法律形式。

本集團(作為承租人)就若干處所、汽 車及設備訂立租賃協議。

於租賃資產可供本集團使用當日,租 賃會初步確認為使用權資產及相應負 債。各租賃付款在負債和財務成本之 間進行分配。財務成本在租賃期內於 損益扣除,以就各期間負債餘額得出 固定的週期性利率。使用權資產以直 線法按資產之估值可用年期及租期的 較短者折舊。

#### 33.21 Leases (Continued)

Assets and liabilities arising from a lease are initially measured on a present value basis. Lease liabilities include the net present value of the following lease payments:

- fixed payments (including in-substance fixed payments), less any lease incentives receivable;
- variable lease payment that are based on an index or a rate initially measured using the index or rate at the commencement date;
- amounts expected to be payable by the lessee under residual value guarantees;
- the exercise price of a purchase option if the lessee is reasonably certain to exercise that option;
- payments of penalties for terminating the lease, if the lease term reflects the lessee exercising that option.

The lease payments are discounted using the interest rate implicit in the lease. If that rate cannot be readily determined, which is generally the case for leases in the Group, the lessee's incremental borrowing rate is used, being the rate that the individual lessee would have to pay to borrow the funds necessary to obtain an asset of similar value to the right-of-use asset in a similar economic environment with similar terms, security and conditions.

#### 33.21 租賃(續)

- 租賃所產生的資產及負債初步按現值 基準計量。租賃負債包括以下租賃付 款的淨現值:
  - 固定付款(包括實質固定付款)減
     任何應收租賃優惠;
  - 基於運用開始日期的指數或利率 初步計量的指數或利率的可變租 賃付款:
  - 剩餘價值擔保下的承租人預期應 付款項;
  - 購買選擇權的行使價(倘承租人 合理確定行使該選擇權);
  - 支付終止租賃的罰款(倘租期反 映承租人行使權利終止租約)。

租賃付款採用租賃所隱含的利率予以 貼現。倘無法輕易釐定該利率(本集團 的租賃一般如此),則使用承租人的 增量借款利率,即個別承租人在類似 的經濟環境中以類似的條款、抵押品 及條件借入必要資金以取得與使用權 資產類似價值的資產所支付的借款利 率。

#### 33.21 Leases (Continued)

Right-of-use assets are measured at cost comprising the following:

- the amount of the initial measurement of lease liabilities;
- any lease payments made at or before the commencement date, less any lease incentive received;
- any initial direct costs; and
- restoration costs, if any.

Payments associated with short-term leases of equipment and vehicles and all leases of low-value assets are recognised on a straight-line basis as an expense in profit or loss. Short-term leases are leases with a lease term of 12 months or less without a purchase option. Low-value assets comprise IT equipment and small items of office furniture.

#### 33.22 Government grants

Government grants are recognised at their fair value when there is reasonable assurance that the grant will be received and the Group will comply with all attached conditions.

Government grants relating to costs are deferred and recognised in the consolidated statement of comprehensive income over the period necessary to match them with the costs that they are intended to compensate.

#### 33.23 Dividend distribution

Dividend distribution to the Company's shareholders is recognised as a liability in the Company's consolidated financial statements in the period in which the dividends are approved by the Company's shareholders or directors, as appropriate.

#### 33.21 租賃(續)

使用權資產按成本計量,包括以下各 項:

- 初始計量租賃負債的金額;
- 在開始日期或之前作出的任何租 賃付款減任何已收租賃優惠;
- 任何初始直接成本;及
- 復原成本(如有)。

與設備及汽車的短期租賃及所有低價 值資產租賃相關的付款按直線基準於 損益確認為開支。短期租賃指租期為 12個月或以下且並無購買權的租賃。 低價值資產為資訊科技設備及體積細 小的辦公室設備。

#### 33.22 政府補貼

政府補貼在有合理保證會收到補貼且 本集團會遵守所有附加條件時,按其 公平值確認。

與成本有關之政府補貼被遞延,並在 必要時期內於綜合全面收益表中確 認,以與其擬補償之成本相配對。

#### 33.23 股息分派

向本公司股東分派股息於本公司股東 或董事批准股息期間之本公司綜合財 務報表內確認為一項負債(如適用)。
