Summary

- Revenue for the six months ended 30 June 2026 (the “**Period**”) amounted to approximately HK\$83.48 million (six months ended 30 June 2025: approximately HK\$54.06 million), representing an increase of approximately 54.42% as compared with that for the corresponding period in 2025.
- Profit attributable to owners of the Company for the Period amounted to approximately HK\$2.05 million (six months ended 30 June 2025: approximately HK\$1.06 million).
- Basic earning per share for the Period amounted to approximately HK0.83 cents (six months ended 30 June 2025: approximately HK0.43 cents).

Notes to the Condensed Consolidated Financial Statements

1. CORPORATE INFORMATION

The Company was incorporated in the Cayman Islands on 12 June 2017 as an exempted company with limited liability under the Companies Act, Cap.22 (Law 3 of 1961 as consolidated and revised) of the Cayman Islands. The registered office of the Company is located at Cricket Square, Hutchins Drive PO Box 2681, Grand Cayman KY1-1111, Cayman Islands. The principal place of business of the Company is located at Unit 3, 5 and 6, 15th Floor, Tower One, Ever Gain Plaza, No. 88 Container Port Road, Kwai Chung, New Territories, Hong Kong. Its ultimate holding company and immediate holding company are Million Easy Enterprises Limited, a company incorporated in the British Virgin Islands.

The Company is an investment holding company and its subsidiaries are principally engaged in the design and development, manufacturing and distribution of watch products on original design manufacturing (“ODM”) basis for watch manufacturers, brand owners and watch importers across the global.

The shares of the Company have been listed on the GEM of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) since 12 July 2018 (the “**Listing Date**”).

The unaudited condensed consolidated financial statements are presented in (“**HK\$**” or “**HKD**”) which is also the functional currency of the Company and its subsidiaries. All values are rounded to the nearest thousand (“**HK\$’000**”), except where otherwise indicated.

2. BASIS OF PREPARATION AND ACCOUNTING POLICIES

This unaudited condensed consolidated interim financial statements for the six months ended 30 June 2026 are prepared in accordance with Hong Kong Financial Reporting Standard (“**HKFRSs**”) which collective term includes all applicable individual HKFRSs, Hong Kong Accounting Standards and interpretations issued by the Hong Kong Institutes of Certified Public Accountants (“**HKICPA**”). The unaudited condensed consolidated financial statements also include the applicable disclosure requirements of the Hong Kong Companies Ordinance and the GEM Listing Rules.

The interim report does not include all the notes of the type normally included in an annual financial report. Accordingly, this report is to be read in conjunction with the audited financial statements of the Group for the year ended 31 December 2025 (the “**2025 Financial Statements**”).

The accounting policies adopted are consistent with those of the financial statement for the year ended 31 December 2025, as described in the Accountant’s Report. The adoption of the new and revised HKFRSs that are relevant to the Group and effective from the current period had no significant effects on the results and financial position of the Group.

3. REVENUE AND SEGMENT INFORMATION

Information reported to the chief executive officer of the Company, being the chief operating decision makers (“**CODMs**”) for the purpose of resource allocation and assessment of segment performance focuses on types of goods or services delivered or provided. The Group currently operates in the manufacturing and trading business of watches. A single management team reports to the CODMs who comprehensively manages the entire business. The segmentations are based on the information about the operation of the Group that management uses to make decisions and regularly reviewed by the CODMs of the purpose of allocating resources to segments and assessing their performance. For the six months ended and 30 June 2026, the Group only engaged operating segment in (“**ODM**”) Original Design Manufacturer.

No segment assets and liabilities are presented as they were not regularly provided to the CODMs of the purpose of resource allocation and performance assessment.

During the current interim period, the Group paid approximately HK\$1.14 million (for the six months ended 30 June 2025: HK\$0.13 million) for acquisition of property, plant and equipment.

Management Discussion and Analysis

BUSINESS REVIEW

Hanvey Group Holdings Limited (the “**Company**”), and its subsidiaries (collectively refer to as the “**Group**”) are principally engaged in the design and development, manufacturing and distribution of watch products on original design manufacturing (“**ODM**”) basis for watch manufacturers, brand owners and watch importers across the globe.

The Group derives revenue mainly from the sale of: (i) finished watches, (ii) semi-knocked-down kit, and (iii) watch parts, and provision of assembly services relating to sales of finished watches.

For the six months ended 30 June 2026 (the “**Period**”), the Group’s revenue amounted to approximately HK\$83.48 million, increased by approximately 54.42% when compared with that of the corresponding period in 2025.

The Hong Kong Trade Development Council (“**HKTDC**”) used to conduct a survey every quarter, which involves interviewing 500 local exporters from six major industries that include machinery, electronics, jewellery, watches and clocks, toys and clothing to gauge their business confidence on near-term export prospects. According to the HKTDC’s research entitled “HKTDC Export Confidence Index 2Q26: Improved Sentiment Going into 2H” dated 29 June 2026, the HKTDC Export Index (the “**Index**”) increased from 49.6 in the second quarter of 2025 (“**2Q25**”) to 51 in the second quarter of 2026 (“**2Q26**”).

For 2Q26, the findings of the HKTDC Export Confidence Index have boosted optimism among Hong Kong exporters as they head into the second half of the year. Significantly, this upbeat sentiment has been maintained despite the lingering geopolitical uncertainties in the Middle East. In the timepieces sector the index dropped to 51.3 (down 0.8) in 2Q26 from 52.1 in 2Q25.

The Group will continue to adopt a prudent approach, and continue exercising stringent control over operating costs, aiming to enhance operating efficiency and improve profitability.

PROSPECTS

The U.S.-China trade war has introduced challenges to the watch industry, including supply chain disruptions, rising costs, and shifting demand. Despite these obstacles, luxury watches remain resilient thanks to their premium status and investment value. To adapt, brands must diversify risks, embrace innovation, and focus on emerging markets.

While growth in Europe is expected to slow amid high inflation, Southeast Asia offers strong opportunities with robust demand for automatic and quartz watches. By aligning designs with market trends and customer preferences, the watch industry can capitalise on this potential.

With continued investment in high-tech advancements and personalized services, the watch industry is poised for steady growth, maintaining its relevance and value in an evolving global market.

We intend to continue to focus on the core business, take efforts in strengthening our product design and development capability to maximise the long term returns of the shareholders of the Company.

Management Discussion and Analysis

FINANCIAL REVIEW

For the six months ended 30 June 2026 (the “**Period**”), the Group recorded a gross profit of approximately HK\$21.90 million, representing an increase of approximately 18.89% when compared with that for the same period in 2025, mainly due to the increase of sale. The selling and distribution expenses decreased by approximately HK\$0.15 million or approximately 10.71% from approximately 1.40 million for the six months ended 30 June 2025 to approximately HK\$1.25 million for the Period. The decrease was mainly due to the decrease in commission paid. The administrative expenses decreased by approximately HK\$0.55 million or approximately 2.99% from approximately HK\$18.40 million for the six months ended 30 June 2025 to approximately HK\$17.85 million for the Period. The decrease was mainly due to decrease of depreciation charge for the period. The finance costs decreased by approximately HK\$0.49 million or approximately 24.38% from approximately HK\$2.01 million for the six months ended 30 June 2025 to approximately HK\$1.52 million for the Period. The decrease was mainly due to the decrease in bank borrowings.

INTERIM DIVIDENDS

The Board does not declare the payment of an interim dividend for the Period (2025: Nil).

CAPITAL STRUCTURE

There has been no change in the Company’s capital structure during the Period. The capital structure of the Group comprises of issued share capital and reserves. The Directors review the Group’s capital structure regularly.

LIQUIDITY AND FINANCIAL RESOURCES

As at 30 June 2026, the Group had cash and bank balances of approximately HK\$14.68 million (as at 30 June 2025: HK\$7.15 million). The current ratios (current assets divided by current liabilities) of the Group were approximately 1.10 times and 0.88 times as at 30 June 2026 and 30 June 2025 respectively.

The Directors are of the view that at the date of this interim report, the Group’s financial resources are sufficient to support its business and operations.

As at 30 June 2026, the gearing ratio of the Group calculated by total borrowings (including bills payables, bank overdrafts, bank borrowings, liabilities associated with assets classified as held for sale and lease liabilities) less cash and bank balances as a percentage of total equity was approximately 256.00% (30 June 2025: 969.31%).

COMMITMENTS

The Company has entered into a non-legally binding memorandum of understanding (the “**MOU**”) with Yangshuo County Xingyuan Lead-Zinc Mining Co. Ltd.* (陽朔縣興源鉛鋅礦有限責任公司) in relation to the acquisition of a nonferrous metal mining business. Please refer to the announcement of the Company dated 3 March 2025 for further details.

SHARE OPTION SCHEME

The Company has a share option scheme (the "**Share Option Scheme**") which was approved and adopted by the shareholders of the Company (the "**Shareholder(s)**") by way of written resolutions passed on 20 June 2018. The Share Option Scheme shall be valid and effective for a period of 10 years commencing on the date it was adopted. The purpose of the Share Option Scheme is to provide incentives or rewards to participants for their contribution to our Group and/or to enable our Group to recruit and retain high-calibre employees and attract human resources that are valuable to our Group and any entity in which our Group holds any equity interest ("**Invested Entity**").

Management Discussion and Analysis

Under the Scheme, the Board of Directors of the Company may grant options to eligible employees, including directors of the Company and its subsidiaries, to subscribe for shares in the Company. The total number of shares in respect of which options may be granted under the Scheme is not permitted to exceed 10% of the shares in issue at any point in time, without prior approval from the Company's shareholders. The Company may not grant any options if the number of shares which may be issued upon exercise of all outstanding options granted and yet to be exercised under the Scheme and other schemes exceeds 30% of the Shares in issue from time to time. Options granted to substantial shareholders or Independent Non-executive Directors of the Company in excess of 0.1% of the Company's share capital or with a value in excess of HK\$5,000,000 must be approved in advance by the Company's shareholders. The option will be offered for acceptance for a period of not less than five trading days from the date on which the option is granted. Upon acceptance of the option, Directors and eligible employees of the Company shall pay HK\$1.00 to the Company by way of consideration for the grant.

Options may be exercised at any time from the date of grant of the share option to the tenth anniversary of the date of grant. The exercise price is determined by the board of directors of the Company, and will not be less than the highest of (i) the nominal value of the Company's share; (ii) the closing price of the Shares on the date of grant; and (iii) the average closing price of the Shares for the five business days immediately preceding the date of grant. No share options have been granted since the adoption of the Scheme on 20 June 2018. As at 30 June 2026, the Company has no outstanding share option under the Share Option Scheme. The total number of shares available for grant under the Share Option Scheme as at 1 January 2026 and 30 June 2026 were 100,000,000 shares. As at the date of this interim report, the total number of shares of the Company available for issue under the Share Option Scheme was 100,000,000 shares, representing 10% of the issued shares of the Company.

COMPETITION AND CONFLICT OF INTERESTS

None of the Directors, the management shareholders or substantial shareholders of the Company or any of its respective associates has engaged in any business that competes or may compete, either directly or indirectly, with the businesses of the Group, as defined in the GEM Listing Rules, or has any other conflict of interests with the Group during the Period.

CORPORATE GOVERNANCE CODE

The Board is of the view that the Company has met the code provisions set out in the Corporate Governance Code (the "**Corporate Governance Code**") contained in Appendix C1 to the GEM Listing Rules throughout the Period, except for the deviation as specified and explained below with considered reasons for such deviations.

Code Provision C.2.1 of the Corporate Governance Code stipulates that the roles of Chairman and Chief Executive Officer should be separate and should not be performed by the same individual. Mr. Cheuk Sin Cheong Clement is currently both the chairman of our Board and the chief executive officer of our Company. In view of the fact that Mr. Cheuk has been assuming the day-to-day responsibilities in operating and managing our Group since 1986 and the rapid development of our Group, the Board believes that with the support of Mr. Cheuk's extensive experience and knowledge in the business of the Group, vesting the roles of both the Chairman of our Board and the Chief Executive Officer of our Company in Mr. Cheuk strengthens the solid and consistent leadership and thereby allows for efficient business planning and decision which is in the best interest to our Group.

The Directors consider that the deviation from Code Provision C.2.1 of the Corporate Governance Code is appropriate in such circumstances. Notwithstanding the above, the Board is of the view that this management structure is effective for our Group's operations, and sufficient checks and balances are in place.

The members of the Audit Committee comprise Mr. Yu Sau Ning Homer M.H., Ms. Yee Wai Fong Wendy and Mr. Yip Yat Lam. The chairperson of the Audit Committee is Mr. Yu Sau Ning Homer M.H..

The primary duties of the Audit Committee are mainly to make recommendations to our Board on the appointment and removal of the external auditor, review the financial statements and related materials and provide advice in respect of the financial reporting process and oversee the internal control procedures of our Group.

The financial information in this interim report has not been audited by the Auditor of the Company, but the Audit Committee has reviewed the unaudited consolidated results of the Group for the Period, which the Audit Committee is of the opinion that such results have been prepared in compliance with the applicable accounting standards and the GEM Listing Rules, and that adequate disclosures have been made.
