#### B. THE COMPANY

## 1. History

The Company is a joint stock limited company established by Beiren Group Corporation ("BGC") as the sole promoter. On 13 July 1993, the Company was registered with the Administration Bureau of Industry and Commerce. The Company was approved to become a joint stock limited company established by public offer of shares in the PRC and in Hong Kong vide the approval document Ti Gai Sheng (1993) No. 118 dated 16 July 1993 from the State Commission for Restructuring the

Economic System. Pursuant to the approval of the China Securities Regulatory Commission of the State Council and other relevant authorities, the Company issued H Shares (Hong Kong public shares) in Hong Kong in 1993 and A Shares (PRC public shares) in Shanghai in 1994. The H Shares were listed on the Stock Exchange of Hong Kong Limited in 1993 and the A Shares were listed on the Shanghai Stock Exchange in 1994.
