## **Executive Directors**

**Mr Qian Yong Wei**, aged 38, was appointed an Executive Director of the Company on 15 September 1998 and is Chairman of the Company. Mr Qian graduated with an MBA in management from the China Europe International Business School, Shanghai, the People's Republic of China (the "PRC"). **Mr He Hui Min**, aged 44, was appointed as an Executive Director of the Company on 1 March 2001 and is Deputy Chief Executive Officer of the Company.
