In 2000, there was no change in its shareholdings of the Company's unlisted and uncirculated shares nor were they pledged.
  - (b) HKSCC Nominees Limited has confirmed that the H Shares registered in its name were held by it on behalf of their clients and that none of them held interests of 5% or more of the Company's H Shares in issue.
- (2) After the issuance of additional new shares in May 2000, 重慶成長實業有限公司,Shanghai Huayuan Joint Stock Company Limited, Nanjing Textile Industry (Group) Company Limited, Hangzhou Textile Machinery Group Factory, Guotou Water and Electricity Company, 北航城鄉科技實業有限公司 and 武漢香烟伴侶生物工程有限公司 became strategic investors of the Company.
