3. Remuneration during the year

- 1. The remuneration of directors, supervisors and senior management had been determined in accordance with the remuneration and appraisal system established by the Company. Directors, supervisors and senior management receiving remuneration from the Company are subject to the yearly remuneration package system. Pursuant to the relevant provisions in the Articles of Association of the Company, the remuneration of directors and supervisors are determined by general meetings while those of the senior management had been determined by the Board. The Company's board implements an annual appraisal policy for senior managers and its production and business operations are monitored by the Supervisory Committee. The Human Resources Department of the Company administers the appraisal policy.
- During the year, the eight directors, supervisors and senior managers had received from the Company a total remuneration of approximately RMB400,000, of which approximately a total of RMB170,000 was given to the three highest paid directors. The remuneration to the three highest paid senior managers totalled approximately RMB160,000. Individuals' annual salaries fell within the range from RMB40,000 to RMB60,000.
- 3. Messrs. Lu Yunliang, Liu Hong, Li Shaoping, Yin Shouen, Tu Kelin and Yan Fuquan received remunerations from the controlling shareholder, China National Textile Machinery (Group) Company Limited. Mr. Liu Haitao, Mr. Gong Enqing, Mr. Liu Xianming, Mr. Zhang Jianguo, Mr. Wang Weizhi, Ms. Wu Manju, Mr. Bao Weiguo and Mr. Zhao Wenjie received remuneration from their respective serving companies.
- 4. Independent directors did not receive any allowances from the Company.

4. Changes in directors, supervisors and senior management

With the approval of Extraordinary General Meeting on 15th August 2001, Messrs. Yin Shouen and Liu Shitong ceased to be the Chairman and Vice-chairman of the Company due to age limit. Subject to rotation and reshuffling of duties, Mr. Lu Yunliang ceased to be the Chairman of the Supervisory Committee and Messrs. Bao Shanjun, Yang Enchang and Cong Yongfa ceased to be the Supervisors representing the staff of the Company.

Section 2. Staff

As at 31st December 2001, the total staff strength of the Group was 9,323, in which the number of senior, middle and junior level staff were 219, 736 and 575 respectively, 1,952 staff had tertiary education. Amongst them, 977 were deployed to technical, scientific research and development, 363 in sales and marketing, 323 in operations management, 162 in finance, 6,600 in production and 898 in others. In addition, the number of retired staff was 1,543 as at 31st December 2001.

Wage level was determined on the basis of individual performance.
