Holders of H Shares in the Company kindly note that the registers of members will be closed for 30 days (from 24th April to 23rd May 2002, both days inclusive) prior to the Annual General Meeting, during which period transfers of H Shares will not be effected. To qualify for the payment of final dividend of this year, all transfer documents accompanied by share certificates must be lodged with the Company's share registrar and transfer office for H Shares, Hong Kong Registrars Limited at 2nd Floor, Vicwood Plaza, 199 Des Voeux Road Central, Hong Kong at or before 4:00 p.m. on 23rd April 2002. The book close dates, method and date of payment of dividend for holders of A Shares will be announced separately.
