EXECUTIVE DIRECTORS

TONG Nai Kan, aged 43. Mr Tong was appointed as Chairman and Managing Director of the Company in May 2000. He is an active investor in the property market and is principally engaged in property investment and development in residential properties. Mr Tong is actively involved in developing high-tech business in the recent years, including a sizeable business websites in PRC.
