(II) Emoluments of Directors, Supervisors and Senior Management

The emoluments of Directors of the third term of the Board of Directors and the third term of the Supervisory committee in the Company are paid on the basis of the annual emolument scheme for the Directors and the Supervisors, which was approved at the 1998 Annual General Meeting. The emolument of senior managers was decided by the Board of Directors.

As at 31st December 2001, the aggregate remuneration paid by the Company to its executive Directors was RMB205,300, non-executive Directors and independent Directors amonted to RMB456,300, Supervisors amonted to RMB328,600 and Senior Managers RMB373,300. Apart from the above-mentioned emoluments, the Company did not offer further allowances or bonuses to the Directors, Supervisors and Senior Management, nor payments to Directors, Supervisors and Senior Managers as an inducement to join the Company, nor any compensation to Directors, Supervisors and Senior Management for their loss of office. The Directors, Supervisors and Senior Management are liable to pay their respective individual income taxes to the responsible government departments directly. During the year, the pension schemes for executive Directors, Supervisors and Senior Management were combined with the staff pension scheme of the Company, with total pension contributed by the Company for Directors and ex-directors amounted to RMB 44,200, and there was no other special arrangement. The emoluments of Directors, Supervisors and Senior Management paid by the Company are listed in the above-mentioned "(I) Basic Information".

(III) Resignation of Directors and Supervisors

During the period under review, Mr.Li Guanghui, deputy general manager and Director, submitted a resignation on his own accord. The Board of Directors agreed his resignation which will be passed at the 2001 Annual General Meeting.
